#### **India reports** 2,109 new **Covid cases**; active infections dip to 21,406

NEW DELHI, May 10 (Agencies): India has recorded 2,109 fresh COVID-19 infections. while the number of active cases have come down to 21,406 from 22,742, according to the Union Health Ministry data on

Wednesday. The COVID-19 tally now stands at 4.49 crore (4,49,74,909).

The death toll climbed to 5,31,722 with eight fatalities which includes those reconciled by Kerala, the data updated at 8 am stated. At 21,406, the active cases comprise 0.05 per cent of the total infections.

The national COVID-19 recovery rate was recorded at 98.77 per cent, the ministry said.

The number of people who have recuperated from the disease surged to 4,44,21,781, while the case fatality rate stood at 1.18 per

According to the mincrore doses of COVID-19 vaccines have been administered so far under the nationwide vaccination drive.

#### **Night** temperature remains below normal amid dry weather in J&K

SRINAGAR, May 10 (Agencies): Weather likely to remain dry on Wednesday even as night temperature still remains below normal in Jammu and Kashmir, officials said.

The Meteorological department predicts that weather will remain dry in Jammu and Kashmir during the next 24 hours. Bright sun appeared

in Srinagar and other parts of Kashmir valley with pleasant weather conditions prevailed. Tourists, mostly attired in warm clothes, were seen basking under the sun on the fashionable Boulevard road on the banks of Dal Lake in Srinagar. The maximum temperature although shows gradual increase at most of the places, but still remained below normal similarly the night temperature dips further at various places in

#### Same sex marriage: Indian laws permit individual to adopt child, says SC

NEW DELHI, May 10 (Agencies):Indian laws permit an individual to adopt a child irrespective of marital status, the Supreme Court said on Wednesday while asserting that the law recognises there may be situations apart from an "ideal family" having its own biological children.

In its submission to the apex court, which is hearing pleas seeking legal validation for same-sex marriages, child rights body NCPCR argued that the concept of gender may be "fluid" but not mother and motherhood.

Highlighting the legal position in different stat-

utes that the welfare of a child is paramount, the National Commission for Protection of Child Rights (NCPCR) told a five-judge Constitution bench headed by Chief Justice D Y Chandrachud that it has been held in several judgements that adoption of a child is not a fundamental right.

## Government to examine Whatsapp's breach of privacy: Rajeev Chandrasekhar

NEW DELHI, May 10 (Agencies): The Government will investigate a claim that WhatsApp accessed the microphone of smartphone users while the phone was not in use, Minister of State for Elec-Technology Rajeev Chandrasekhar said on Wednesday.

In a tweet, the minister said the government will examine the alleged breach of privacy even as the new Digital Personal Data Protection Bill was being readied.

This followed a claim that WhatsApp accessed a user's microphone while he was sleeping.

"WhatsApp has been the background, while I was asleep and since I woke up at 6 AM," Foad Dabiri, an engineering director at Twitter said on Saturday. "What's going on?"

Replying to Dabiri's tweet, Chandrasekhar said, "This is an unacceptable breach and violation of privacy."

"We will be examining this immediately and will act on any violation of privacy even as the new Digital Personal Data Protection bill is being readied," he added.

An official said that the property in the form of six shops constructed pora Awantipora was

attached by the NIA. He said the property belongs to Fayaz Ahmad Magray, who is an accused in NIA case no. Rc-10/2018/NIA/Dli lodged into the attack on CRPF Group Centre in December 2017.

Five CRPF personnel lost their lives and three others were injured in the attack carried out by three terrorists who were also killed in the retaliatory fire.

SIT against Kataruchak is a joke to mislead **Punjab:** Chugh



JAMMU. May 10 (Agencies): BJP national general secretary Tarun Chugh today said that the SIT formed to look into the charges against the Punjab cabinet minister Lal Chand Karataruchak is a hoax and an eyewash to protect the minister.

Chugh said the fact that the SIT is headed by a DIG serving under the Bhagwant Mann government is a complete joke being played on the people of Punjab."This is a way to protect him", he said.

Chugh reiterated his demand to get the matter investigated by CBI or any other central agency, a request that he had made to the Punjab Governor earlier.

He said it is the biggest mockery in democracy that a junior police officer would conduct an inquiry into charges against a cabinet minister.

#### **Destabilised Pakistan dangerous for** all Countries: Farooq Abdullah

SRINAGAR, May 10 (Agencies): A destabilised Pakistan is dangerous for all countries, including India, former Jammu and Kashmir chief minister Farooq Abdullah said here on Wednesday.

The remarks of the former Union minister came a day after Pakistan Tehreek-e-Insaf chairman Imran Khan was arrested in a corruption case.

"A destabilised Pakistan is dangerous for all countries including our own country. We want



a stronger and a democratic Pakistan where democracy flourishes, which will also improve its relations with India," Abdullah, the president of the National Conference (NC) told reporters. Abdullah said the internal situation in Pakistan was "very dangerous" and its economic condition was also very bad.

"Heavy floods hit the region last year, and many areas are still impacted by that. The people there are still suffering. In such circumstances, the situation turning like this is more dangerous," he said.

The three-time chief minister of J-K said while the situation in the neighbouring country was dangerous, it had a history of such events.

## Man sentenced to life imprisonment after decade long Trial

SRINAGAR, May 10 (Agencies): In a tragic incident that took place more than a decade ago, a man was sentenced to life imprisonment by Principal Sessions Judge Reasi R N Wattal for killing his wife and 10-year-old child. The case had been under trial for years, and the verdict was delivered on Monday.

According to the prosecution, the police received information from reliable sources on March 7, 2010, that the body of Shiv Devi, the wife of Kuldeep Singh, was found on the road leading from Shikari to Thuroo in the Dubri forest. A short distance away, the body of their 10-year-old child, Sachin, and the weapon used in the crime were also discovered

During the investigation, it was revealed that the accused and the deceased had been

married for 13 to 14 years and had two children. The accused, who was working in Kangra Himachal Pradesh, used to quarrel with his wife over suspicions of her having an illicit relationship. Due to the strained relations, Shiv Devi was living with her parents at Bathoi.

On the day of the incident, the accused called his wife to the Dubri forest and administered some drug to her





## Popular govt alone is panacea for ills afflicting J&K: Harsh Dev

CHENANI, May 10: Accusing the present regime for its indifference and neglect of the common masses facing denial of even the basic amenities, both in urban and rural areas, Harsh Dev Singh, Former Minister and State President JKNPP said that a democratically elected govt alone was the panacea for the ills afflicting the centrally ruled UT of J&K.

## **EDITORIAL**

#### **MSME- A BOON FOR NEW TALENTS**

he Micro, Small and Medium Enterprises (MSME) sector is a part of India's legacy economic model and a vital supply chain for products and services. This sector is considered to be an employment creator and plays a vital role in providing large scale employment and industrialization of rural and backward areas.

According to the 73rd round of National Sample Survey (NSS) in 2015-2016, there were about 633.8 lakh non-irrigated non-agricultural enterprises in the country, working in various economic activities providing employment to 11.10 crore workers. In this article, we will focus on the importance of MSME. You can also register MSME online with the legal route.

MSME has introduced in the year 2006 in India. There are still some service sectors which were not included in this sector till now, making a historic change in the definition of micro, small and medium-sized enterprises in this act. So taking advantage of the scope of the sector, now the government has simplified the MSME registration online with paperless work.

It generates large scale employment: Enterprises joining this sector require less capital to start new businesses. Moreover, it creates a vast opportunity for the unemployed people to avail. India produces about 1.2 million graduates every year, of which the total number of engineers is about 0.8 million.

As of now there is no such economy which can provide huge number of freshers in just one year. MSME is a boon for new talents in India.

It is the most important driver in India contributing 8% to the GDP. Given the contribution of MSMEs in manufacturing, exports and employment, other sectors are also getting its benefits. Nowadays, multinational companies are buying semi-finished and ancillary products from small enterprises, for example, buying clutches and brakes by automobile companies.

It is helpful in making relation between MSME and big companies, even after GST implementation 40% MSME sector also implemented GST registration which plays a vital role in increasing the revenue of the government by 11%.

Inclusive growth of medium, and small and medium size has been at the top of the ministry's agenda for many years. On the other hand, poverty and deprivation is a hindrance to the development of India. Moreover, it comprises of marginalized sections of a society which is a significant challenge before the Ministry of MSME. Whereas in large scale organizations, one of the main challenges is to maintain the human resource through an effective human resource management professional manager. But, when it comes to MSMEs, the labor requirement is less and it does not require highly skilled labor. Therefore, the indirect cost incurred by the owner is also less.

MSME can start with limited resources under the control of the owner. This decision making becomes easy and efficient. In contrast, a large corporation requires a specialist for each departmental function because it has a complex organizational structure whereas a small enterprise does not need to hire any outside expert for its management. ## **PAKISTAN IN TURMOIL**

mran Khan's arrest by the National Accountability Bureau (NAB) in Islamabad today from within the High Court premises has created an unprecedented law and order situation in Pakistan, already reeling under the massive economic downturn that has created huge difficulties for its teeming multitudes. The circumstances of his arrest as reported by the media appear anything but normal. It seems Imran Khan had gone to the High Court to seek bail in one of the many cases lodged against him since he was deposed as the Prime Minister in April last. While going for his bio-metrics, the Rangers forced their way into the court premises and dragged him out and bundled him into a waiting vehicle, that then drove to Rawalpindi, the GHQ of all-powerful Pakistan Army. The media reports further said that a helicopter was waiting at Rawalpindi to take him to an undisclosed place in Baluchistan. The fact that it was the Rangers who executed the act of arresting Imran Khan from court premises underscores the fact that Pakistan Army was on board in this mission.

Having visualized the possibility of his arrest, Imran Khan had recorded a video which was imme-

diately released to his supporters. In this video, which became viral quickly, Imran is heard exhorting his supporters to come out on the streets at this critical hour to save Pakistan.

It is apparent that the arrest by the NAB has the full backing of the Pakistan Army or rather the whole thing was orchestrated by it. Ever since Imran Khan's troubles began in the Senate during the first quarter of the previous year, Imran Khan has been at loggerheads with the allpowerful Army. He is the first Prime Minister, in fact the first important politician, to take on the Pakistan Army openly. Besides taking on the former Chief, Gen Qamar Javed Bajwa, Imran adopted a confrontationist posture against the then Army chief over the selection of the next ISI Chief. While Imran wanted Lt Gen Faiz Hameed to continue in the post, Gen Bajwa wanted Lt Gen Naveed Anjum to replace him. Eventually, as always, the Pakistan Army Chief had his way.

But the avoidable confrontation created distrust between the two individuals as also the two important institutions.

It is a well- known fact of Pakistan politics that no Prime Minister has ever completed his full five-year term. However, it was widely accepted that Imran Khan may not fall in that category as he was believed to have been 'selected' by the Pakistan Army rather having got fairly elected during the general elections. Then, what went wrong in this cozy relationship which appeared to be mutually beneficial to both. It appears that Imran Khan took his status as the elected Prime Minister rather too seriously, forgetting that the levers of power in Pakistan have remained and are firmly in the hands of the Army. His desire to exercise autonomy in certain cru-

cial policy matters of the state, outreach to Russia and the existing international power play created a serious situation for Pakistan, particularly when it was reeling under an economic crisis of unparalleled dimensions, led to the Army deciding to replace him through a Senate coup. The PML Supremo, the redoubtable Nawaz Sharief, too played his intrigues from London. However, unlike other deposed Prime Ministers, Imran Khan hit back.

After his deposition, Imran rallied his supporters in an effective manner. Millions of people thronged to his rallies which were held throughout Pakistan, from Karachi to Khyber and Quetta to Sialkot. Acting with a degree of political finesse, Imran asked his legislators to resign from the Assemblies in Khyber Pakhtunkhwa and Punjab where his party, the Pakistan Tehreek i Insaf (PTI) was running the governments. This led to the dissolution of the assemblies, for which the elections, as per the existing constitutional norms, were bound to be held before May 2023.

Having created a wave of sympathy in his favour, Imran was sure of returning to power in these two states with a larger majority. However, the central government, now in the hands of his sworn enemies, the PML (N), had different ideas. Taking shelter under the compulsions imposed by a deep economic crisis, the Central Government was in no mood to please Imran.

However, it did not merely involve the former P.M., it also needed to satisfy the constitutional norms which mandated the holding of elections within six months of the dissolution of the State assemblies. Imran's plea in the apex court got a favorable verdict which directed the Federal Government to provide 21 billion

rupees to the Election Commission (EC) immediately so that the elections could be held in May 2023 to abide by the constitutional provisions. However, the Federal Government got a resolution passed in the senate to the effect that due to the huge economic crisis through which Pakistan was passing, it was not possible to provide the required

funds to the EC to conduct the elections. This created a constitutional crisis, However, while all this was still being resolved, Imran upped the ante by repeatedly attacking the Army, something unheard of in Pakistan. Perhaps, he also crossed the red line when he accused Maj Gen Faisal Naseer, the head of the Counterintelligence department of Pakistan's ISI, of having tried to kill him twice while addressing a rally in Lahore. Therefore, the Army decided to strike before the damage to the reputation of the institution that holds Pakistan together had reached irreversible level.

Surprisingly, Imran Khan was not arrested on one of the over hundred cases lodged against him, but on completely different grounds. The NAB has said that Imran Khan had got a huge parcel of govt land allotted to Al Qadir Trust, of which Imran and his third wife, Bushra Bibi, are the sole trustees.

In my opinion, despite the huge support enjoyed by Imran Khan across the length and breadth of Pakistan, it will be difficult for him to regain the trust of the powerful Army, without whose support he cannot ever think of regaining his lost post of Pakistan's premiership. In fact, I will be surprised if he will even survive his incarceration. In Pakistan, senior and most popular leaders have paid with their lives. I wonder if Imran will escape a similar fate.

## The Fear of Mathematics

any people enjoy maths at school and out of school as ably use mathematical language comfortably. Many parents will teach children to understand basic concepts such as counting numbers and simple fractions at a young age. Many children do enjoy Maths like anything. And some have problems when Maths graduates to complex fractions. But Unfortunately, a large section of the population found school maths so confusing and so distressing, that they avoid anything remotely mathematical. Though fear of maths can affect anyone, a certain research found that especially women and people of colour tend to drop out of maths or even opt out of careers that would involve having to do a minimum of maths, such as the mandatory maths or stats courses in science, medicine, commerce and even social sciences. Mathematics is more often widely recognized as a problem area. In many parts of India, maximum failures at matriculation are in mathematics. And mathematics is compulsory for matriculation. As a consequence, every child who enters the educational system has to study it till the matriculation level.

What is Mathematics? Simply put, Mathematics is a discipline which deals with the logic of quantity and shape and arrangement. Moreover, it is the underlying structure of the world, which we see in patterns, shapes, quantities and intelligent guesses. Maths when presented in the classroom or in a textbook, is often a formal, precise, and disciplined step by step progression to a logical conclusion. But according to Experts, these are completely artificial, complex methods compounded to give students practice in applying the algebraic code. The reason they are artificial is the difficulty in finding actual problems in everyday living

that require algebra. Why is Mathematics Needed?

We need to understand the concepts of numbers and quantities because we require it for our daily routines. Our lives are governed by Time and to understand Time we need Maths. Maths is all around us. We see patterns in art and music. Businesses need to make intelligent guesses or estimates of how much something is going to cost, how many people need their products, how fast it is going to sell. We need to keep track of our bank accounts and ensure we do not spend more than our income. Our activities like baking cakes, decorating a room etc. are based on the Quantity and Time required which again requires maths.

What are the Causes of Fear of Maths?

Inherited Trait: In an observation, students assimilated more complex concepts and skills that they used in daily life and they simultaneously failed to assimilate relatively simple concepts which they encountered in formal mathematics. It was clear that this is concerned with the absence of opportunities to learn formal mathematics in a natural way at home of the child. In fact, the interactions within the family and members tend to prepare a child to dislike mathematics as either one or both or some family member itself hated maths. This trait gets picked up by the child even though he may be good at maths.

Community Influence: Most of us look at mathematics as a subject which is too formal, it is required for calculations or for taking higher courses. This negative repute makes the subject appear dry and utilitarian for children. We do talk of neighbours and other relationships between individuals but do not describe number work as finding relationships between numbers. Social interactions in society tend to prepare the child to dislike mathematics through assigning, time and again, a variety of negative adjectives like dry, difficult, boring, etc. to describe mathematics in general.

Low Self Esteem: A student's brain makes a high-speed microsecond evaluation of the word problem and declares it as "nonsense." It does not make sense. Then the brain makes a secondary evaluation - The Teacher and the other students are comfortable. They seem convinced that the problem is relevant and worthwhile. It must be something wrong with me. I don't understand. I guess I'm no good at maths. Another myth causing this low self-esteem is the math gene - some have and others do not. Hence, only geniuses are capable of creating or understanding formulas and equations

Lack of Analogies: Analogies play to the right brain and are exciting because they enable understanding in the very first exposure of any concept in any field. For example is this question - How long have dinosaurs been on earth? The left brain answer is 100 million years. The student can memorize the answer and get a perfect score on a test with absolutely no understanding. To actually communicate to students how long dinosaurs have been on earth, we use this analogy that plays to the right brain: If the age of One - Day & Night is 24 hours, dinosaurs were here for one or two hours and we have been on earth one or two minutes. If an abstraction can be converted into an analogy, any student can "catch the instructional ball when the instructor pitches it." Most students can get it in the first exposure without memorization and without stress. In mathematics, analogies are rare in print and even more

The absence of analogies means that students are confined to using half the brain, and usually, it is the wrong half. By imprisoning students in their left brain, we mystify them with one abstraction after another. Since there is almost no brain switching from one side of the brain to the other, the result is Negative brain instruction. All of this produces an understandable avoidance reaction

Fictitious Fear: The Image students have of mathematics and mathematicians is most certainly fictitious. Math textbooks and classes represent a "homogenized" view of mathematics that in no way showcases the exciting stories of how discoveries are made. The stories are the romance of mathematics which should come first to inspire students so they are ready and eager to continue exploring the mysteries of mathematics. Students watching mathematicians perform in the classroom come away with the illusion that mathematicians are precise, formal, and accurate dispensers of absolute truth. The reality is that professional mathematicians are imprecise, indefinite game players who draw with numbers and relish exploring

Learning Disorder: Dyscalculia is a learning disorder that afflicts about 6 per cent of the population. Those afflicted with it have difficulty visualizing number sequences and even the passage of time. A part of the brain called the intraparietal Siculus, or IPS, is known to be important for number processing. The IPS is important for determining how many things are perceived, as opposed to how much of something there is. For such people, distinguishing between the bigger of two numbers can be difficult. Dyscalculics can learn to count, but where most people can immediately tell that nine is bigger than seven, anyone with dyscalculia may have to count the objects to be sure

How to Overcome Maths Phobia? Parents Guidance: Parents have a greater role in the child's education and they try to provide support to their children in a variety of ways. Most of the Parents find it difficult to help the child with mathematics As a part of the treatment of their kids to improve mathematics learning and performance, the parents need counselling that will change their attitude and perspective of formal mathematics as well as an improvement in formal mathematical skills. A certain amount of time is needed in problem-solving in moderation will keep your child mathematically healthy. Five to ten minutes of problem-solving a day for a month is far better than 2hrs for three days in terms of output. Or solving 20 problems in one day gives less learning than solving 3 problems daily for one week. This change is needed in the work method. Also needed is to integrate formal school mathematics within home and community and make efforts to better the perception of mathematics so that positive adjectives will be used to describe mathematics and learning of mathematics.

Make it Exciting: Maths needs to be enjoyable for children. Certain activities and games are adapted which can be played normally. The activities involved jumping, running, playing cards, puzzles, creating as well as listening to rhymes and stories etc. Running or jumping along the number line or number grid to reach a called out number is one such activity which parents can get their children to do. To make this more interesting, enjoyable and easy for the card games have been designed. Similar card games have been designed for fractions and number operations.

Means of Teaching: There are a huge number of books and workbooks available for school and home use. If one lacks confidence, they can always use one of these. There are people who will undertake private maths coaching if your child wants to know more than you can cope with, and there are Internet resources and CD-Roms that do the direct teaching.

Catch Them Young: To make sure that a kid doesn't develop Maths Phobia introduce Maths at an early age. A good and colourful maths workbooks teach basic numeracy. Exposure to Numbers graphically creates curiosity. At some point your child may ask about the number symbols: perhaps spots them in a book, or see them on houses. Talk about why we use numbers and what they mean, but make sure you explain that the numbers are just shorthand for the concept, not anything mystical in themselves.

Variation in Approach: If you introduce the arithmetic symbols, explain that '2+2=4' is simply an easier way of writing 'If we have two elephants and then another two elephants arrive to join them, there will be four elephants altogether'. Some children like to invent their own arithmetic symbols - encourage this. If your child wants to draw a little picture to represent the apples or elephants after each number, this is fine. This is actually algebra, which needs to be understood at a basic level before pure arithmetic can make sense. Too many teachers particularly in previous years - introduce the counting numbers and their symbols before most of the children have begun to grasp the algebraic concepts behind numbers and the reasons we use them.



#### **IT Minister Chandrasekhar** NEW DELHI, May 10 (Agencies): The govern-

ment will investigate a claim that WhatsApp accessed the microphone of smartphone users while the phone was not in use, Minister of State for Electronics and Information Technology Rajeev Chandrasekhar said on Wednesday.

In a tweet, the minister said the government will examine the alleged breach of privacy even as the new Digital Personal Data Protection Bill was being readied.

This followed a claim that WhatsApp accessed a user's microphone while he was sleeping.

"WhatsApp has been using the microphone in the background, while I was asleep and since I woke up at 6 AM," Foad Dabiri, an engineering director at Twitter said on Saturday. "What's going on?" Replying to



Dabiri's tweet, Chandrasekhar said, "This is an unacceptable breach and violation of privacy."

"We will be examining this immediately and will act on any violation of privacy even as the new Digital Personal Data Protection bill is being readied," he added.

Dabiri's tweet went viral, attracting over 65 million views.

WhatsApp responded saying it has been in touch with the Twitter engineer over the last 24 hours, who posted an issue with his Pixel

phone and WhatsApp.

"We believe this is a bug on Android that misattributes information in their Privacy Dashboard and have asked Google to investigate and remediate." WhatsApp said in a tweet.

The company also claimed that users have full control over their mic

"Once granted permission, WhatsApp only accesses the mic when a user is making a call or recording a voice note or video - and even then,

these communications are protected by endto-end encryption so WhatsApp cannot hear them," it added.

The engineer working with Twitter shared screenshots of his phone which showed WhatsApp accessing and using his handset's microphone at various times even as he was

screenshots prompted several users, including Twitter and Tesla Inc chief Elon Musk, to raise concerns.

"WhatsApp cannot be trusted," Musk tweeted on the screenshot shared by Dabiri. "Or that WhatsApp founders left Meta/Facebook in disgust, started #deletefacebook campaign & made major contributions to building Signal. What they learned about Facebook & changes to WhatsApp obviously disturbed them greatly." WhatsApp has been

under scrutiny in India over various issues. In October last year, the Meta-owned messaging app saw a twohour service disruption, prompting the Ministry of Electronics and Information Technology (MeitY) to ask the platform to share reasons for the disruption.

Separately, WhatsApp users in India have reported a massive surge in incoming international spam calls over the past few days. Many users complained on Twitter that a major chunk of these spam calls had country codes belonging to Indonesia (+62), Vietnam (+84), Malaysia (+60), Kenya (+254) and Ethiopia (+251)

According to a Statista report, there are ove 487 million WhatsApp users in India, making it the biggest market for the company.

## Situation in strife-torn Manipur improving; curfew relaxed in 11 districts

IMPHAL, May 10 (Agencies): The situation in Manipur, where ethnic violence has claimed at least 60 lives and rendered thousands homeless, is gradually improving with no fresh incident of violence reported in the last two days, officials said on Wednesday.

Curfew was relaxed in 11 affected districts, including Imphal West, Bishnupur, Churachandpur and Jiribam, for six hours from 5 am.

The curfew relaxation was for four hours in these affected districts on Tuesday.

A total of 2,500 more affected

people from Churachandpur and 500 people stranded in the border town of Moreh were brought to Imphal on Tuesday, they said.

Chief Minister N Biren Singh had on Monday said that 60 people were killed, 231 injured and 1,700 houses, including religious places, burnt in the ethnic violence that rocked the northeastern state for the past few days.

the northeastern state after a 'Tribal Solidarity March' was organised in the 10 hill districts on May 3 to protest against the Meitei community's demand for Scheduled Tribe (ST) status.

The clashes were preceded by tension over eviction of Kuki villagers from reserve forest land, which had led to a series of smaller agitations.

Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley. Tribals—Nagas and Kukis—constitute another 40 per cent of the population and reside in the hill districts.

#### failure: Kerala High Court KOCHI, May 10 (Agencies): The Kerala High Court on Wednesday slammed the state government and the police

over the killing of a 23-year-old doctor at a taluk hospital in Kottarakkara area of Kollam district by a man she was treating, saying it indicated their "failure" to protect doctors.

A special bench of Justices Devan Ramachandran and Kauser Edappagath said the police were trained and expected to protect women and children, but they failed to protect the young doctor.

"It is a complete failure of the system. Having an aid post in a hospital is not enough. When you (police) knew the man was acting abnormally, you should

have restrained him. "You should be able to anticipate the unanticipated. Else there is no need for the police. Over time, we have become casual. Did you not fail this girl?" the bench asked, adding that it had on several occasions in the past warned that such an incident would occur if nothing was done.

"This is what we were scared of. We had said in the past that something like this could happen," the bench said.

The court said the incident

has created a "fear psychosis" among the doctors, medical students and their parents.

"Doctors have gone on strike. What excuse would you give for denial of treatment to thousands of patients as a result? Can you blame the doctors for any problem caused to any patient today due to the strike?" the court asked the state government.

The doctor was stabbed to death allegedly by a man, a schoolteacher under suspension, who was brought there by police after being involved in a fight with his family.

According to an officer of Kottarakkara police, while a wound on the leg of the man -- identified as Sandeep -- was being dressed by doctor Vandana Das, he suddenly got provoked and attacked everyone standing there using a scissor and scalpel The incident occurred during

the early hours of Wednesday and Das succumbed to her hours later.

The brunt of the attack was borne by the young doctor while the police personnel who accompanied the man were also injured. The doctor was rushed to a private hospital in Thiruvananthapuram but could not be saved.

## Jury finds Trump liable for sexual abuse, awards accuser USD 5 million

Jurors reject Carroll's claims that she was raped, but find Trump liable for sexually abusing her

NEW YORK May 10 (Agencies): A jury found Donald Trump liable for sexually abusing advice columnist E. Jean Carroll in 1996, awarding her USD 5 million in a judgment that could haunt the former President as he campaigns to regain the White House.

The verdict was announced in a federal courtroom in New York City on the first day of jury deliberations. Jurors rejected Carroll's claims that she was raped, but found Trump liable for sexually abusing her.

Hours earlier, US District Judge Lewis A. Kaplan read instructions on the law to the nine-person jury before the panel began discussing Carroll's allegations of battery and defamation shortly before noon.

Trump, who did not attend the trial, has insisted he never sexually assaulted Carroll or even knew her.

Kaplan told jurors that the first question on the verdict form was to decide whether they think there is more than a 50 per cent chance that Trump raped Carroll inside a store dressing room. If they answered yes, they would then decide whether compensatory and punitive damages should be awarded.

If they answered no on the rape question, they could then decide if Trump subjected her to lesser forms of assault involving sexual contact without her consent or forcible touching to degrade her or gratify his sexual desire. If they answered yes on either of those questions,

Carroll, 79, testified that she had a chance encounter with Trump at the Bergdorf Goodman store across the street from Trump Tower. She said it was a lighthearted interaction in which they teased each other about trying on a piece of lingerie before Trump became violent inside a dressing room.

Tacopina told jurors there was no reason to call Trump as a witness when Carroll can't even recall when her encounter with Trump happened.

He told the jury Carroll made up her claims after hearing about a 2012 "Law and Order" episode in which a woman is raped in the dressing room of the lingerie section of a Bergdorf Goodman store.

"They modelled their secret scheme on an episode of one of the most popular shows on television," he said of Carroll.

Two of Carroll's friends testified that she told them about the encounter with Trump shortly after it happened, many years before the "Law and Order" episode aired.

## **Imran Khan's supporters** plan march to capital to protest against his arrest

Khan will not be brought to court and his scheduled hearing will take place at the location where he is being held in custody



ISLAMABAD, May 10 (Agencies): Supporters of Imran Khan were planning to march to Islamabad on Wednesday where the former Pakistan prime minister is in custody in a corruption case, raising fears of more clashes with security forces.

Khan was arrested from the Islamabad High Court on Tuesday by Pakistan's anti-corruption agency. Police said a court hearing would take place at the police guest house where he is being held.

The arrest came a day after the country's powerful military rebuked

Khan for repeatedly accusing a senior military officer of trying to engineer his assassination and the former armed forces chief of being behind his removal from power last year.

In response, his Pakistan Tehreek-e-Insaf party called for a "shutdown" across the country, with Khan's supporters clashing with police in many cities and storming military buildings in Lahore and Rawalpindi, according to witnesses and videos

shared by his party. Supporters in northwestern Khyber Pakhtunkhwa province were asked to gather early on Wednesday in Swabi city to leave for Islamabad as part of a convoy, the party wrote on Twitter.

Party leaders asked workers to continue protests but not take the "law in their hands". according to messages shared on Twitter on Wednesday.

A police spokesman told Reuters on Wednesday that Khan would not be brought to court and his scheduled hearing wouldl take place at the location where he is being held in custody.

#### Man Stabbed To Death In Malaysia **After Making Lewd Remarks About** 26-Year-Old Woman

A preliminary postmortem report indicated that the death was caused by stab wounds.

MELAKA, May 10 (Agencies): A 35-year-old manager of a scrap metal dealer in Malaysia's Melaka state was allegedly stabbed to death over a lewd remark at a 26-year-old woman, South China Morning Post reported.

According to the police, the victim who was supposedly drunk, made a sarcastic comment about the woman's breast size when she entered a stall in Taman Kenanga, Tengkera at about 4 am on Tuesday to have a meal with her boyfriend and bodyguard. Enraged at the lewd comment, a heated argument soon erupted between him and the woman's 27-year-old bodyguard.

The argument then escalated into a brawl involving the victim, his friends, the woman's bodyguard, and her boy-

"This was when a fierce fistfight sparked between the bodyguard that was later joined by the woman's 36-year-old boyfriend. The deceased was allegedly stabbed several times with a sharp object," Christopher Patit, an officer in charge of the Melaka



Tengah police district.

A police team rushed to the scene upon receiving a call from a member of the public at 4.15 am and found the victim unconscious. He was taken to the Malacca Hospital for treatment but died from his injuries.

A preliminary postmortem report indicated that the death was caused by stab wounds. The police have since arrested nine suspects connected to the case, which is currently being investigated under Section 302 of the Penal Code for murder. All nine suspects are aged between 25 and 38, said Mr Patit.

A knife and an iron rod, believed to have been used in the fight have also been recovered by the police.

## Pakistan Tehreek-e-Insaf party to challenge Imran Khan's arrest in Supreme Court: Report

ISLAMABAD, May 10 (Agencies): The Pakistan Tehreek-e-Insaf party on Wednesday announced that it will challenge in the Supreme Court the ruling of the Islamabad High Court which termed the arrest of its chief and former prime minister Imran Khan as legal, according to a media report.

Khan, 70, was arrested by the paramilitary Rangers in a corruption case from the IHC and bundled into a prison van, sparking massive protests across the country by supporters of his PTI party.

Following Khan's arrest, PTI vice chairman Shah Mehmood Qureshi summoned an emergency meeting of the seven-member committee to review the situation and devise a comprehensive strategy



to secure the safe and early release of the party chair, the Geo News reported.

Qureshi interacted with the committee members Senators Saifullah Khan Nyazee, Azam Swati, Ijaz Chaudhry, Murad Saeed, Ali Amin Khan Gandapur, and Hassan

## 3 Indian-origin men jailed in UK for smuggling cannabis worth 1 million pounds

LONDON, May 10 (Agencies): Three Indian-origin members of an organised crime group have been jailed for smuggling cannabis worth around 1 million pounds into the UK from Canada, police said.

Kuran Gill, Jag Singh and Govind Bahia, all in their 30s, pleaded guilty to conspiracy to import a 'class B' drug and were sentenced at Woolwich Crown Court, the Kent Police said.

The Border Force officers discovered two pallet-loads of cannabis within a shipment of computer casing at Heathrow airport in February 2021.

Valued at around 1 million pounds, the drugs had been flown across from Canada and were due to be delivered to

a business address in Dartford.

The detectives were able to link the shipment to members of a criminal network who had been arranging the importation of cannabis over an illegally-encrypted mobile phone platform, which international law enforcement agencies cracked in the spring of 2020, according to the Kent Police.

"The cracking of the EncroChat mobile phone platform has led to countless criminals being caught red-handed and brought to justice," Investigating officer, Detective Constable Steve Brown of the Kent and Essex Serious Crime Directorate, said

in a release last week. Kuran Gill, 32, of Sun Marsh Way, Gravesend,



organised the importation and onward distribution of the cannabis and also facilitated the sale of a kilogram of cocaine.

Officers seized around 1,05,000 pound cash from his home address following his arrest in April 2021.

Gill pleaded guilty to conspiracy to import a 'class B' drug, conspiracy to supply cocaine and possession of criminal property, and was sentenced to seven years' imprisonment.

Jag Singh, 32, of The Boulevard, southwest London, was also involved in organising the importation and distribution of the cannabis.

Using the chat handle

of 'Real Crocodile' he exchanged multiple messages with Gill in which they openly discussed routes into the country, ways in which the drugs could be concealed and how much it would cost.

Singh pleaded guilty to conspiracy to import a class B drug and was jailed for four years and nine months.

Govind Bahia, 30, of Tennyson Walk, Gravesend, assisted Gill with advice and direction on the type and quantity of cannabis to purchase.

He pleaded guilty to conspiracy to import a class B drug and was jailed for three years. The drugs were seized as part of an investigation by the Kent and Essex Serious Crime Directorate

"Organised gangs across Europe thought they could openly discuss their criminal activity, oblivious to the fact the system was not as secure as they thought and that every message they sent was bringing them a step closer to prison," Brown said.

### Israel kills 2 Palestinian gunmen in new West Bank violence

JERUSALEM, May 10 (Agencies): The Israeli military said it killed two Palestinian gunmen who fired on troops in the occupied West Bank early on Wednesday, the latest in near-daily violence roiling the region.

The shooting came as tensions are at a fever pitch following a series of Israeli airstrikes in the Gaza Strip that killed three senior Islamic Jihad militants and 10 others — most of them women and children — on Tuesday. Palestinian militants have pledged to retaliate and Israel says it is prepared for a further escalation of hostilities.

The Israeli military has instructed residents of southern Israel to remain near bomb shelters, and schools were still closed for a second day as a precaution against attacks by Palestinian militant groups in the Gaza Strip.

In the West Bank, the military said that Palestinian gunmen opened fire at troops in the Palestinian town of Qabatiya in the northern West Bank during an army raid. Troops returned fire, killing the two men, and confiscated their firearms, it said.

The Palestinian Health Ministry identified the slain men as Ahmed Assaf, 19, and Rani Qatanat, 24. No militant group immediately claimed the men as its members.

Israel has been conducting near-daily raids for over a year to detain suspected Palestinian militants, including many from Islamic Jihad. The northern West Bank city of Jenin and its environs have been the frequent target of such raids as it has emerged as a hub of Palestinian militant activity.

Israel says the raids in the West Bank are meant to dismantle militant networks and thwart future attacks.

At least 107 Palestinians, around half of them militants, have been killed by Israeli fire in the occupied West Bank since the start of 2023, according to an Associated Press tally. At least 20 people have been killed in Palestinian

attacks targeting Israelis. Israel captured the West Bank in the 1967 war and the Palestinians seek the territory, along with east Jerusalem and the Gaza Strip, for a future independent

## 'No decision yet on diesel-run vehicle ban in major cities'



NEW DELHI, May 10 (Agencies): The petroleum ministry clarified that it had not taken any decision on the recommendations of a government committee on diesel car ban in the cities with population of over 10 lakh by 2027.

The government said the suggestions of Energy Transition Advisory Committee (ETAC), formed under the direction of the Ministry of Petroleum and Natural Gas, relate to multiple ministries and a range of stakeholders including states.

"Consultation with various stakeholders on the report is yet to be initiated. No decision has yet been taken on ETAC recommendations," tweeted the ministry. The report of the ETAC, headed by former petroleum secretary Tarun Kapoor, also suggested blending of liquid petroleum gas with compressed biogas made from urban waste, use of methanol and ethanol as cooking fuel, and electric or solar-based cooking.

The panel recommended to phase out scooter, motorcycle and threewheelers with internal combustion engine by 2035 as India aims to achieve net zero emissions by 2070. The ministry said the committee has made wide ranging and forward-looking recommendations for shift to low-carbon energy and it has a futuristic outlook.

#### as platform sees more users BENGALURU, May 10 (Agencies): From just 1,000 transactions a day in March, last week, the food and grocery domain on the Open Network for Digi-

tal Commerce (ONDC) has witnessed 20,000 transactions. ONDC CEO T Koshy

"We are operating in two cities- Bengaluru and Kochi- in the mobility domain, and we are already seeing 35,000 rides a day," he said. According to him,

these are early stages and that whenever seller applications join the network, there will be huge transactions. Recently, Magicpin joined the network and became the largest restaurant aggregator with many restaurants being onboarded.

With more sellers joining the food and grocery space, the price war is

continuing, and it is expected that this will continue in ecommerce and other domains in the coming months. When asked about it. Koshy said it is an open network and that each one-buyers and sellers will have different strategies. "ONDC brings efficiency and innovation," he said.

The platform now has over 35,000 merchants and of which about 65% are operating in the food space. Rural fintech company Spice Money is one of the early buyer side apps to join the network. Its co-founder, ED and CEO Sanjeev Kumar told TNIE that this is a big opportunity for small players as ONDC is democratising e-commerce.

"Consumers will have a bigger price range to choose from and in the long-term, hyperlocal logistics prices will reduce, "Kumar said. With huge opportunities in the ecommece space, there is space for both big and small merchants. According to industry experts, ONDC is not charging right now but might do so in future. Meesho integrated with ONDC in November last year to help connect buyers with hyperlocal sellers.

## NCLT admits Go First's insolvency plea

NEW DELHI, May 10 (Agencies): The Delhi bench of National Company Law Tribunal (NCLT) on Wednesday admitted Go Airlines India Itd's (Go First) plea for voluntary insolvency and for initiation of Corporate Insolvency Resolution Process (CIRP) proceedings.

NCLT has granted Go First protection under moratorium from recovery by lessors and lenders. The NCLT has appointed Abhilash Lal, backed by Alvarez and Marsel, as the interim resolution professional (IRP) to run the airline.

The tribunal directed the company's suspended board of directors to cooperate with Lal and to ensure there are no layoffs. The management was also asked to deposit 5 crores with the IRP to meet immediate expenses

Go First CEO Kaushik Khona called NCLT's order a historic judgment in terms of pace of



proceedings. He added that it will ensure that the airline remains viable as the airline still have 27 aircraft in operation.

The moratorium order of NCLT, according to Khona, will prevent lessors from taking back aircraft.

Go First has now announced that its flights will remained cancelled till May 19 "due to operational reasons."

The low-cost carrier had filed for voluntary insolvency proceedings last week, blaming faulty Pratt & Whitney engines for the grounding of about half its 54 Airbus A320neo planes.

The order is favourable for the Wadia family-promoted airline as aircraft lessors are seeking to take back their planes.

According to the latest figures, various lessors have reached out to aviation regulator DGCA for the deregistration of 42 planes.

Go First owes financial creditors Rs 6,521 crore. The filing lists Central Bank of India Ltd, Bank of Baroda Ltd. IDBI Bank Ltd, Axis Bank Ltd and Deutsche Bank among Go First's financial creditors.

Go First claims that its promoters have infused Rs 3,200 crores in the last three years, Rs 2400 crores of which were injected in the last 24 months, and Rs 290 crores in April 2023 alone. This brings the total promoter investment in the airline since its inception to approximately Rs 6,500 crores.

The grounding of close to 50% of its A320neo fleet has led to Rs 10.800 crores in lost revenues and additional expenses for the airline, said the airline.

## New breathalyser test can 'sniff out' Covid in real-time

Breathalyser test consists of a complex array of lasers and mirrors about the size of banquet table



NEW DELHI, May 10 (Agencies): Scientists have developed a new laser-based breathalvser test powered by artificial intelligence (AI) that they say can detect COVID-19 in real-time

with excellent accuracy. The team from the University of Colorado (CU) Boulder in the US hopes that the frequency comb breathalyseressentially using laser light to distinguish one molecule from another-could revolutionise medical diagnostics.

"Our results demonstrate the promise of breath analysis as an alternative, rapid, non-invasive test for COVID-19 and highlight its remarkable potential for diagnosing diverse conditions and disease states," said study first author Qizhong Liang, a PhD candidate at CU Boulder.

"There is a real, foreseeable future in which you could go to the doctor and have your breath measured along with your height and weight...Or you could blow into a mouthpiece integrated into your

phone and get information about your health in real-time," said Jun Ye, adjoint professor at CU Boulder and senior author of the study published in the Journal of Breath Research.

Between May 2021 and January 2022, the research team collected breath samples from 170 CU Boulder students who had, in the previous 48 hours, taken a polymerase chain reaction (PCR) test, either by submitting a saliva or a nasal sample.

Half had tested positive, half negative. Overall, the process took less than one hour from collection to result.

When compared to PCR, the gold standard COVID test, breathalyser results matched 85 per cent of the time. For medical diagnostics, accuracy of 80 per cent or greater is considered "excellent".

The researchers noted that the accuracy would likely have been higher if the breath and saliva/ nasal swab samples were collected at the same time.

Unlike a nasal swab, the breathalyser is noninvasive. And unlike a saliva sample, users are not asked to refrain from eating, drinking or smoking before using it, the researchers said.

The test doesn't require costly chemicals to break down the sample. And the test could, conceivably, be used on individuals who are not conscious, they said.

The breathalyser test consists of a complex array of lasers and mirrors about the size of a banquet table.

A breath sample is piped in through a tube as lasers fire invisible mid-infrared light at it at thousands of different frequencies. Dozens of tiny mirrors bounce the light back and forth through the molecules so many times that the light travels about 1.5 miles.

Because each kind of molecule absorbs light differently, breath samples with a different molecular make-up cast distinct shadows.

The machine can distinguish between those different shadows or absorption patterns, boiling millions of data points down to-in the case of COVID-a simple positive or negative, in a matter of seconds.

The researchers are working to miniaturise such systems to a chip scale, allowing for what Liang imagines as "realtime, self-health monitoring on the go".

## India leads list of 10 countries with 60% of global maternal deaths, stillbirths, newborn deaths: UN study

The latest published estimate in the progress tracking report by the WHO, UNICEF, and the UNFPA was launched at the ongoing 'International Maternal Newborn Health Conference'

CAPE TOWN, May 10 (Agencies): Owing to its large birth cohort, India leads a list of 10 countries that together account for 60 per cent of global maternal deaths, stillbirths and newborn deaths, and 51 per cent of live births globally, according to a United Nations report released.

The latest published estimate in the progress tracking report by the WHO, UNICEF, and the UNFPA was launched at the ongoing 'International Maternal Newborn Health Conference' (IMNHC 2023) here. It shows there were a combined 4.5 million deaths -- maternal deaths (0.29 million), stillbirths (1.9 million) and newborn deaths (2.3 million) -- in 2020-2021.

Sub-Saharan Africa and central and Southern Asia are the regions experiencing the largest number of deaths, although across all regions, there is variation regarding the pace at which countries are progressing in their efforts to achieve the global 2030 targets.

According to the first-ever joint Every Newborn Action Plan (ENAP) and Ending Preventable Maternal Mortality (EPMM) progress tracking report, the global progress in reducing deaths of pregnant women, mothers and babies has flatlined for eight years due to decreasing investments in maternal and newborn health.

"Pregnant women and newborns continue to die at unacceptably high rates worldwide, and the coronavirus pandemic has created further setbacks to providing them with the health care they need," Dr Anshu Banerjee, Director of Maternal, Newborn, Child and Adolescent Health and Ageing at the World Health Organisation (WHO), said.

"If we wish to see different results, we must do things differently. More and smarter investments in primary health care are needed so that every woman and baby - no matter where



they live - has the best chance of health and survival," Banerjee said. India saw 7,88,000 maternal deaths, still-

births and neonatal deaths in 2020, of the total 4.5 million deaths globally.

The country also accounts for 17 per cent of global live births

which could be a factor for the large number of maternal deaths, stillbirths and neonatal deaths.

It is followed by Nigeria, Pakistan, Democratic Republic of the Congo, Ethiopia, Bangladesh and China for maternal deaths, stillbirths and neonatal deaths.

Surya hammers 83 as MI climb to third with win

MUMBAI, May 10 (Agencies): Suryakumar Yadav's stunning 35-ball 83 and Nehal Wadhera's unbeaten 52 handed Mumbai Indians a comprehensive six-wicket win over Royal Challengers Bangalore in the IPL here.

A fourth century stand of the season between Faf du Plessis (65 off 41) and Glenn Maxwell (68 off 33) took Bangalore to 199/5 after Mumbai put them in to bat. Du Plessis also extended his lead at the top of the list for the highest run-getters this year, reaching 576 runs in 11 matches at an average of 64.

Chasing 200, Mumbai raced to victory in 16.3 overs and maintained their impeccable record of not losing to Bangalore at the Wankhede Stadium since 2015

The victory lifted Mumbai to



the third spot in the points table with 12 points from 11 games, while Bangalore slipped to the seventh spot with 10 points from 11 matches.

Suryakumar struck six sixes

and seven fours in his sensational effort while adding 140 runs for the third wicket in only 66 balls with Wadhera. Promoted at No. 4, Wadhera, who was dropped on 16 on a tough return

chance by Wanindu Hasaranga (2/53), went on to raise his second fifty of the season. The left-handed batter struck four fours and three sixes to make 52 not out off 34 balls.

After their bowlers sparked a comeback of sorts in the first half of the game, Mumbai never looked under any pressure with their reshuffled batting order clicking together, despite Rohit Sharma's lean patch continuing.

Sharma was dismissed for only seven, but a brisk start provided by Ishan Kishan (42) and a sturdy stand for the third wicket shut Bangalore out of the

### Real Madrid, City draw 1-1 in Champions League semifinals

MADRID, May 10 (Agencies): Real Madrid's Vinícius Júnior and Manchester City's Erling Haaland were relaxed and laughing as they embraced after the final whistle at the Santiago Bernabeu Stadium. They both seemed satisfied following an even first leg that ended in a 1-1 draw and left the Champions League semifinal wide open going into next week's return match in Manchester. Vinícius and Kevin de Bruyne scored with long-range strikes in a match in which Madrid's defence successfully kept Haaland — the Champions League's leading scorer — from being decisive. "I think both teams have the feeling that it was a good result," said Madrid coach Carlo Ancelotti, who took charge of his 190th Champions League match as coach. "Maybe we played a bit better to deserve a victory, but it's a series that will be even until the last minute.

Madrid beat City in last year's semifinals and went on to win a recordextending 14th Champions League title while the English club again fell short of European success. "It was an even match," City coach Pep Guardiola said. "They scored when we were better and we equalized when they were better. It will all be decided in Manchester."

The first leg of the other semifinal between Italian rivals Inter Milan and AC Milan is on Wednesday. "Both teams played well. It's a good draw," Madrid goalkeeper Thibaut Courtois said. "There's everything to play for next week." City controlled possession but couldn't translate it into significant scoring opportunities. Haaland wasted a few chances early but wasn't much of a threat throughout the game at the Santiago Bernabeu Stadium. The Norwegian came into the match having scored 12 of City's 26 goals in

the Champions League this season and was five short of Cristiano Ronaldo's single-season record of 17 for Madrid in 2013-14.

Vinícius created problems for the City defense and opened the scoring in with a shot into the top corner in the 36th minute for his seventh Champions League goal this season. The Brazil forward picked up a pass by Eduardo Camavinga and used one touch to set up his right-footed shot from outside the area. City struggled to come close to Madrid's goal but De Bruyne found the net in the 67th with a powerful one-timer from outside the area after Madrid lost possession because of a poor pass across the field by Camavinga.

Madrid complained that it was not awarded a corner in the buildup of City's goal. "It was a shame that we conceded that goal," Madrid midfielder Luka Modric said. "I think we deserved more. They had more possession but didn't create a lot of chances. It's still 50-50 and we will go into the second match with confidence." Haaland had not yet joined City when it lost 6-5 on aggregate to Madrid in last year's semifinals. Vinícius, Rodrygo and Karim Benzema combined for all of Madrid's goals that time. Madrid is making its 11th semifinal appearance in 13 seasons and is trying to win its sixth title in 10 years. City played in its first Champions League final two seasons ago, losing to Chelsea.

Madrid, which won the Copa del Rey title this past weekend, is virtually out of contention in the Spanish league and can fully focus on the semifinal against City. The English side remains in the middle of a tight title race in the Premier League.

"Manchester will be like a final in front of our own fans," Guardiola said.

## IPL 2023: CSK face resurgent DC in push for play-offs spot

CHENNAI, May 10 (Agencies): Chennai Super Kings enter the final lap of the ongoing Indian Premier League's preliminary phase, looking to beat back the challenge of a resurgent Delhi Capitals here on Wednesday and get closer to a playoff berth.

CSK returned to winning ways with a convincing victory over Mumbai Indians -- a bogey team at their fortress Chepauk -- and would be hoping to pick up two more points against the Capitals, who have struggled in the tournament for the most part.

The Super Kings trumped MI in a low-scoring game last Saturday with the bowlers, Matheesha Pathirana in particular, doing a good job to restrict the opposition. The chase was wrapped up without much ado, with contributions from Ruturaj Gaikwad, Devon Conway and Shivam Dube.

While the top-order batters (Conway 457 runs, Gaikwad 292 runs and Ajinkya Rahane (245 runs) have been doing a great job, the middle-order hasn't fired as much as the think-tank would have hoped for.

The experienced Ambati Rayudu (95 runs in 11 games) and Ravindra Jadeja (92 in 11 games) haven't got going, making for a floundering middle-order. Skipper MS Dhoni has managed the cameos expected of him whenever he



has got in.

The team will be hoping that the middle order is not put to the test in a crunch game. Dhoni and the CSK fans will be praying for the likes of Rayudu, Moeen Ali and Jadeja to rise to the occasion when it matters the most.

The big-hitting Shivam Dube has so far collected 290 runs (from 9 innings) and will be eyeing bigger contributions in key games. Tushar Deshpande with 19 wickets so far has done a fine job but his economy rate of 10.33 and giving away runs at crucial junctures has hurt CSK at times. The captain would like him to be more thrifty with the ball

Jadeja, as always, has struck crucial blows while slinger Pathirana will be keen to continue the good run, like against MI. Pathirana will be one bowler the Capitals, including the aggressive Phil Salt, who shone in

the team's last game, would be wary of.

The DC batters have underperformed but Salt has expressed confidence that they can turn it around in the remaining games. Skipper David Warner has not been his usual ebullient self and the batting line-up which includes Mitchell Marsh and Rovman Powell among others has flattered to deceive.

As the season winds down, DC managed to keep their chances alive by winning four of their last five matches. Whether the team can sneak into the top four remains to be seen. They will need to perform very well if they aim to surprise CSK in their den, which is easier said than done.

For that, the DC batters need to come to grips with the spin challenge expected to be posed by CSK and the bowling department needs to find ways to contain the methodical Conway and

Gaikwad first before dealing with the others.

## South Africa Qualify For Cricket World Cup After Ireland-Bangladesh Washout

Even if Ireland now take the series 2-0, they cannot surpass South Africa in eighth place in the World Cup Super League (WCSL) standings.

BENGALURU, May 10 (Agencies): South Africa secured direct qualification for the 50-over Cricket World Cup in India later this year after the first one-day international between Ireland and Bangladesh ended in a no-result washout. Ireland had to win all three matches in a series against Bangladesh taking place at Chelmsford, the headquarters of English county Essex, if they were to move up from 11th place in the points table. Even if Ireland now take the series 2-0, they cannot surpass South Africa in eighth place in the World Cup Super League (WCSL) stand-

Ireland will now have to compete in the June 18-July 9 qualifying tournament in Zimbabwe, that also includes former champions West Indies and Sri Lanka.

The Irish were 65-3 in the 17th over, chasing Bangladesh's 246-9, made from a full 50 overs, when bad light and rain halted play at 4:34pm local time (1534 GMT).

A minimum of 20 overs had to be bowled in Ireland's innings for a result to be declared under the Duckworth-Lewis-Stern method for rain-affected matches.

But the fixture was called off at 1800 GMT when the umpires



deemed conditions too wet to restart play.

Josh Little -- fresh from starring in the Indian Premier League -- led Ireland's attack with 3-61, with two wickets apiece for Graham Hume and Mark Adair as Bangladesh were restricted to a seemingly modest total on a good pitch.

Mushfiqur Rahim celebrated his 36th birthday by top-scoring for the Tigers with 61 in front of a crowd of some 3,000 at Chelmsford, mainly consisting of Rangladosh fans.

consisting of Bangladesh fans. Najmul Hossain Shanto made Ireland, however, soon found themselves in trouble at 27-2 following the loss of experienced opener Paul Stirling and captain Andrew Balbirnie.

The series continues on Friday. The first spots in the 10-team World Cup go to the top eight finishers of the WCSL, a competition that has run over the last three years.

Reigning champions England, India, New Zealand, Australia, Bangladesh, Pakistan and Afghanistan have already guaranteed their places.

KOLKATA, May 10 (Agencies): Kolkata Knight Riders' all-rounder Shardul Thakur has shunned any rumours about his injury ahead of the World Test Championship Final, set to be played right after the Indian Premier League. Concerns about Shardul Thakur' injuries came from the all-rounder not bowling a lot in the KKR set-up. In fact, Shardul Thakur has bowled just 14.5 overs from his 8 matches in the 2023 edition of the tournament, in sharp contrast to his workload in the previous seasons. In fact, Shardul bowled 48.3 overs in 2022, and over 60 overs in 2021 edition of the tourna-

Speaking about his reduced bowling work-load, Shardul said that KKR was a team full of all-rounders, and hence he was only called up



when it was absolutely necessary.

"We have a side full of

we have a side full of all-rounders with (Andre) Russell, Sunil (Nairne)... We have got maximum of eight bowling options that also includes Nitish (Rana) who also bowls an over or two nowadays," Thakur told news agency.

"It also depends on the situation of the game, if the captain feels the need to bowl me or not bowl me completely depends on him. As far as teams' strategy decision-making is concerned, I would not pay attention to it a lot," Shardul Thakur spoke about KKR's strategy.

"I had a small niggle, so I didn't play a few games, when I came back, I didn't bowl as I was not bowling-fit. But yes, now I'm back to bowling and hopefully, whenever I get the ball, I will get the job done," he further added.

Thakur is likely to be called up for the playing XI against Australia in the World Test Championship Final, due to injuries to several pacers in

the Indian side. While Jasprit Bumrah has been ruled out from the game, Umesh Yadav and Jaydev Unadkat have concerns with their fitness. Shardul Thakur spoke about his own workload and said that it was not easy for the allrounder in the modern game.

"It is difficult and not easy. It's difficult in the sense of body-wise because when you go in for practice, you literally have to do everything --fielding practice, bowling and batting. On top of that, you have to do a bit of running around to stay fit," Shardul Thakur said.

"Overall, it's not easy but yeah that's the challenge in modern day's cricket that you have to manage your body to stay fit and keep going," Shardul concluded.
