2 Pakistani drones downed by **BSF** along International **Border** in **Punjab**

JALANDHAR, May 20 (Agencies): Two suspected Pakistani drones were shot down by the Border Security Force (BSF) on Friday night as the UAVs attempted to enter India crossing the International Border in Punjab, a spokesperson of the force said.

Both incidents were reported from the forward areas of the Amritsar district.

The first drone, a black quadcopter of "DJI Matrice 300 RTK" make, was recovered from Udhar Dhariwal village in Amritsar district, the BSF spokesperson said on Saturday.

BSF troops intercepted this unmanned aerial vehicle (UAV) by firing around 9 pm on Friday, he said.

The second drone, a quadcopter of the same "DJI Matrice RTK 300" make, was recovered from Rattan Khurd village in the same district after troops fired at it around 9:30 pm. the spokesperson said.

In the second case, two packets attached to the drone containing 2.6 kg of suspected heroin were also recovered, he added.

China calls J&K "Disputed Territory," opposes holding G20 meeting in region

BEIJING [China], May 20 (Agencies): China on Friday said that it will not attend the next week's G20 Tourism Working Group meeting in Jammu and Kashmir, stating that it is "firmly" opposed to holding any such meetings in the "disputed territory."

Under India's presidency, the third G20 **Tourism Working Group** meeting is scheduled to take place in Srinagar, the summer capital of Jammu and Kashmir from May 22-24.

"China firmly opposes holding any form of G20 meetings on disputed territory. We will not attend such meetings,



Chinese Foreign Ministry Spokesperson Wang Wenbin said in a regular press conference when asked about several reports doing the rounds that China will boycott G20 meetings planned in the Indian state of Jammu and Kashmir.

Incidentally, China is a close ally of Pakistan and relations between India and Pakistan have

been precarious for many years with regard to cross-border terrorism emanating from Pakistan.

The tourism industry has played a crucial role in the development of the Union Territory. However, years of instability have impacted the tourism industry, leading to a decline in the number of visitors.

Tourism players in Kashmir believe that the G20 meeting can attract investors and tourists from across the globe.

India assumed the presidency of the G20 grouping on December 1, 2022, and will hold the

Kot Bhalwal holding over 10 Pc more prisoners than normal capacity

JAMMU, May 20 (Agencies): With as many as 999 inmates lodged in, the high-security Kot Bhalwal jail here is currently overcrowded as it is holding over 10 per cent more prisoners than its normal capacity, an official said on Saturday.

The information was given by the jail superintendent to the high court judge and executive chairman, J&K legal services authority, Justice Tashi Rabstan during an inspection of the premises, the official said.

The official said a six-member team led by Justice Ranbstan visited the Central Jail on Friday and inquired about undertrial prisoners and the number of convicts serving their sentences.

The team was informed that against a total capacity of 903 persons, currently 999 inmates are lodged in the jail. They were also intimated about the shortfall in the sanctioned strength of the staff.

"There are 579 undertrials, 353 detenues and 67 convicts in the jail. Among these, 17 are foreign nationals but no female inmate was lodged in the jail," the official said.

Highlighting the lack of certain healthcare facilities due to a shortage of staff and equipment, the officials said the jail authorities



had to shift the ailing inmates to government hospitals for dental and eye treatment.

The medical officer informed Justice Tashi that out of the four sanctioned posts, three medical officers are available round the clock, whereas, one post was lying vacant.

She also informed that an X-Ray technician is posted in the jail, whereas, no X-Ray

machine was installed, the official said.

She said the dental setup was established but no dental surgeon is posted and there is no facility for eye checkups as well. So the jail inmates are referred to a dental hospital and government medical college for dental and eye treatment.

The Delhi branch of the NIA filed one of the two cases in 2021, and the Jammu branch of the NIA filed the other

These searches are being directed in close coordination with Central Reserve Police Force and Jammu and Kashmir Police since early Saturday morning.

"Searches are underway in over 15 locations in RC 3/21/NIA/ DLI & RC 5/22/NIA/ JMU in seven districts of Srinagar, Pulwama, Avantipora, Anantnag, Shopian, Poonchh, and Kupwara," said sources privy to the development.

In a case involving a criminal conspiracy to carry out terrorist and subversive activities, the NIA conducted searches at 13 locations in five districts of Jammu and Kashmir almost five days earlier. The cadres and Overground Workers (OWGs) of various



ILLEGAL IMMIGRATION

he continued illegal immigration of Rohingyas into India and their continued stay in India has serious implications for national security and poses a serious security threat. This affects the interests of local populations in areas that face large-scale illegal entry of immigrants. It also increases political instability when leaders start mobilizing the perception of the country's citizens against the migrants by the elite in order to grab political power. Recent decades have seen a significant increase in the incidence of women and human trafficking across borders.

The law and order and integrity of the country is undermined by illegal immigrants indulging in illegal and anti-national activities.

The Center had issued directions to state governments and union territory administrations, advising them to sensitize law enforcement and intelligence agencies to take appropriate steps for speedy identification of illegal immigrants. Consolidated instructions have also been issued to deal with the problem of overstay of foreign nationals and illegal migra-

Passport (Entry into India) Act, 1920 empowered the government to make rules for persons entering India to carry passports with them. It also gave the government the power to deport from India anyone who entered without a passport. Foreigners Act, 1946 replaced the Foreigners Act, 1940 with comprehensive powers to deal with all foreigners. The Act empowered the government to take necessary steps to stop illegal immigrants, including the use of

The concept of 'burden of proof' lies with the person and not with the officers given by this Act which is still in force in all the states and union territories. This concept has been upheld by the Constitution Bench of the Supreme Court.

The Act empowered the government to set up tribunals, which would have the same powers as civil courts. The recent amendment (2019) to the Foreigners (Tribunals) Order, 1964 empowered district magistrates of all states and union territories to set up tribunals to decide whether a person living illegally in India is a foreigner

Registration under FRRO is a mandatory requirement under which all foreign nationals (except Overseas Citizen of India) must present themselves before a registering officer within 14 days of arrival in India on a long-stay visa (exceeding 180 days). Registering is required.

Pakistani nationals arriving in India are required to register within 24 hours of arrival, regardless of the period of stay.

However if India had a domestic law regarding refugees, it could deter any oppressive government in the neighborhood from persecuting their population and preventing them from coming to India.

Furthermore, the absence of national refugee laws has blurred the distinction between refugees and economic migrants, often leading to denial of assistance even to genuine asylum seekers.

Karnataka: Maine Pyaar Kiya! The 'G-Factor' wins big...

// We fought the polls with love", declared a beaming Rahul Gandhi after his party's spectacular win in Karnataka. It was Rahul Baba's Mother's Day gift to la madre Sonia Gandhi, as fans of the "Famiglia-G" ooh-ed and aah-ed over cuddly pics of ma-beta hugging each other. It was one of those rare candid pics of Sonia Gandhi which caught her cracking a smile, which btw, suits her far more than the trademark scowl. Beti Priyanka Gandhi Vadra posted her own Mother's Day selfie with mumsie, showing both clad in winter gear, and grinning rapturously. Why not? Millions of Bharatwaasis were doing the same... exulting at the numbers which gave the Congress a staggering 135 seats in a 224member Assembly. Best to see it as a triumph of the voter. And not read too much into the big win. I mean... why not learn the lyrics of 'Çalm Down', the super-hit single of Selena Gomez and Rema (real name Divine Ikubor), the Nigerian singer, who was in India at the same time, wowing fans and winning the Internet with his effortless people skills and charm.

Those words — people skills and charm - that's what did it in Karnataka. Rahul Gandhi's ambitious Bharat Jodo Yatra played a big role in spreading positivity in an ocean of hate and suspicion. It's possible Rahul himself may not have fully comprehended the monumental impact of the 150-day Long Walk, when he began it in Kanyakumari in September. Agreed, politics is a dirty, cynical game largely peopled by thugs, but just one simple idea of walking across the vast country in the name of unity and meeting thousands of citizens face to face,

led to a major transformation: one that may see further amplification in the months ahead. Karnataka could well be the tipping point, the game-changer, in what may be the most savage general election India has seen. Rahul does not hold a magic wand, nor does he possess a success mantra. But as a leader of his dysfunctional, fragmented political party, with all its inbuilt weaknesses and absurdities, he demonstrated what it takes to touch people's lives and extend hope for a better tomorrow: love.

Caste and corruption were the two main hurdles in Karnataka. Rahul can neither eliminate nor contain these deeply entrenched issues, that often bewilder the most learned political gurus. Each state of India comes with a specific DNA. Caste and corruption form the main strands of its composition. The open and avoidable fight for the chief minister's post has unsettled many voters and disheartened the party leadership sufficiently for Sonia to step in and make a late-night call to the sulking and furious D.K. Shivakumar, in a successful bid to break the deadlock, after five days of suspense. He reluctantly agreed to play second fiddle to Siddaramaiah, who claims to have more MLAs with him. Sidda has got the CM's job and been rewarded for successfully delivering Karnataka to his political maa-baap. Deft and timely handling of the impasse could have spared everyone the embarrassment of having to listen to sidelined DKS cribbing about the lack of gratitude and courtesy extended to him - he seethed nobody "acknowledged" him for being the main man behind the win. Making matters still more awkward, D.K. Suresh, the designated deputy CM's brother,

declared they were "not happy" with Madam's decision, but willing to make the "sacrifice" in the larger interests of the party and Karnataka.

This is where even the most astute political leaders like Sonia Gandhi go horribly wrong. They fail to read the ambitions of their own trusted people, and end up losing them to rivals (think "24carat traitor" Jyotiraditya Scindia). Instead of gloating over the victory, the party leadership should have prioritised placating a disgruntled man (DKS). They didn't. the University campus and made all present aware about the faculty, students and infrastructure of the Department of Cross Cultural Learning Centre, University of Jammu.


More than 150 students took advantage of the session where they were given a chance to ask questions to the experts in the interactive session by having proper guidance.

Nine years of hard work and rock band Indian Ocean has come up with the album Tu Hai. The members talk about their journey of music...



Speaking to Japanese media Modi, who also chairs the G20, emphasised his commitment to leading the international community in resolving the challenges of the "Global South," including developing and emerging countries.

The Indian prime minister flagged the geopolitical tensions causing disruptions in food and energy supply chains, stressing the need for collaboration with Japan and like-minded countries to continuously address the core concerns of developing countries.

On a question about Russia's invasion of Ukraine, Modi batted for an international order based on respect for national sovereignty and territorial integrity, underlining the significance of the UN Charter and international

Strengthening collaboration between the G7 and G20 is vital in addressing global challenges like climate change, supply chain disruptions, economic recovery, energy instability, healthcare, food security, and contribute constructively within the UN and beyond," he said. Commenting on India's role in

Ukraine crisis and is ready to

easing growing rivalries among major powers and promoting global peace and stability, Modi said the world faces challenges like the Covid-19 pandemic, disruptions in supply chains, terrorism, and climate change, disproportionately affecting the developing world. India prioritises addressing these concerns and emphasises human-centric development through collaboration with Japan and other partners. "India aims to serve as a bridge between different voices, promoting a constructive agenda focused on achieving shared objectives for the betterment of humanity," he said.

Services row: Centre's ordinance 'unconstitutional', attempt to snatch power from Delhi govt, says AAP



NEW DELHI, May 20 (Agencies): The AAP on Saturday said the Centre's ordinance on the transfer of bureaucrats in Delhi is "unconstitutional" and a move to snatch the power given to the Delhi government by the Supreme Court in services matters.

Addressing a press conference, Delhi minister Atishi said the Centre deliberately chose to bring the ordinance at a time when the Supreme Court has closed for summer vacation.

The Centre promulgated an ordinance on Friday to create a National Capital Civil Service Authority for transfer of and disciplinary proceedings against Group-A officers from the DANICS cadre.

This came a week after the Supreme Court handed over the control of services, excluding those related to police, public order and land, in Delhi to the elected government.

Atishi said the Centre's ordinance shows that "Prime Minister Narendra Modi is scared of Chief Minister Arvind Kejriwal" and the power of honest poli-

"They are scared that if he (Kejriwal) gets power, he will do extraordinary work for Delhi. The ordinance is an attempt to snatch the power given to the AAP dispensation by the apex court on May 11," she said.

Even if Delhi's people voted for Kejriwal, this ordinance says he will not run Delhi, the minister said.

The ordinance is "unconstitutional" and will be struck down by the Supreme Court, she said.

"The Centre deliberately chose to bring this ordinance yesterday night. The Supreme Court has closed for vacation for six weeks and this is a deliberate attempt to hamper work," she charged.

Atishi said the Supreme Court gave the powers to the Delhi government after an eight-year-long battle.

"But the Centre could not tolerate this. The ordinance provides for the creation of a National Capital Civil Service Authority with three members -- CM as its chairman and chief secretary and principal home secretary as its members. But it is to be noted that the chief secretary and the principal home secretary will be appointed by the Centre.

"The authority will take decisions by majority. That means decisions will be taken by the Centre's bureaucrats. If it takes any decision that the Centre doesn't like, then the LG will have the power to reverse the decision," she

Army rescues 500 stranded tourists from landslide-hit Sikkim

GANGTOK, May 20 (Agencies): The Army rescued 500 stranded tourists, including 54 children, in Sikkim as torrential rain in parts of the Himalayan state caused landslides and roadblocks, a defence official said on Satur-

Heavy rain was witnessed in Lachen. Lachung and Chungthang on Friday and as a result, approximately 500 tourists, who were travelling to Lachung and Lachen Valley, were stranded at Chungthang due to landslides and roadblocks en route, he

"On request from SDM



Chungthang, troops of Trishakti Corps, Indian Army, swung into action and rescued the stranded tourists to safety.

"The stranded tourists included 216 men, 113 women and 54 children and they were moved to three different army

They were provided with hot meals and warm clothing," the defence spokesperson

The troops vacated their barracks to accommodate the tourists and make them comfortable for the night, he said.

Three medical teams were formed, to check the health condition of all the travellers, the official added.

PM Modi and Japan's Kishida discuss cooperation in green hydrogen, semiconductors

NEW DELHI/ HIROSHIMA, May 20 (Agencies): Prime Minister Narendra Modi and his Japanese counterpart Fumio Kishida on Saturday held talks focusing on boosting bilateral cooperation in areas of green hydrogen, high technology, semiconductors and digital public infrastructure.

In the nearly 50-minute talks on the sidelines of the G7 summit in Hiroshima, Modi and Kishida also deliberated on ways to synergise efforts to combat pressing global challenges under India's G20 presidency and Japan's leadership of the G7 advanced economies.

the Ministry of External Affairs (MEA) said the two prime ministers exchanged views on a wide range of issues,



including development finance, food security, climate change and energy among others.

"The leaders discussed ways to synergise efforts of their respective G-20 and G-7 presi-

dencies. The prime minister stressed the need to highlight the concerns and priorities of the Global South," the Ministry of External Affairs (MEA) said.

The group of seven, comprising the US, France, the UK, Italy, Germany, Canada and Japan, represent the world's richest democracies. Under its G7 presidency, Japan invited India and seven other countries to the summit.

In a tweet, Modi described his meeting with Kishida as "excellent". "We reviewed the full range of India-Japan relations and also discussed the focus areas of India's G-20 Presiden cy and Japan's G-7 Presidency towards making our planet better," the prime minister said.

CBI files charge sheet against Congress leader Jagdish Tytler in 1984 anti-Sikh riots case

NEW DELHI, May 20 (Agencies): The CBI on Saturday filed a charge sheet against Congress leader Jagdish Tytler in the Pul Bangash case connected to the 1984 anti-Sikh riots, officials

Three people were killed and a gurdwara

was torched in the Pul Bangash area here on November 1, 1984, a day after then-Prime Minister Indira Gandhi was assassinated.

In its charge sheet filed before a special court here, the CBI said Tytler "incited, instigated and provoked the mob

assembled at Pul Bangash Gurdwara Azad Market" on November 1, 1984, that resulted in burning down of the gurdwara and killing of three Sikhs-Thakur Singh, Badal Singh and Guru Charan Singh.

The agency has invoked charges under



Sections 147 (rioting), 109 (abetment) read with 302 (murder) of the Indian Penal Code (IPC), among others, against Tytler, the officials said.

The court will consider the charges on June 2, they said.

Tussle for control over bureaucracy in Delhi: Centre seeks review of Constitution Bench verdict

NEW DELHI, May 20 (Agencies): The Centre on Saturday filed a petition in the Supreme Court seeking review of its May 11 Constitution Bench verdict that declared that the Delhi government has "legislative and executive power over services", in the national capital, except those relating to public order, police and

The move came a day after the Centre promulgated an ordinance to create a 'National Capital Civil Service Authority' with powers to recommend transfers and postings of Group A and DANICS officers serving

The Authority comprising Delhi chief minister, chief secretary and home secretary of Delhi would make recommendations to the Delhi Lt Governor regarding matters concerning transfers, postings, vigilance and other incidental matters.

According the ordinance, all matters will be decided by the Authority majority of votes of the members present and voting and in case of any difference of opinion, the Lt Governor's decision shall be final.

The Arvind Kejriwalled AAP government - which described the

promulgation of the ordinance as an act of treachery and attempt to snatch power from the Delhi government -- is likely to challenge its constitutional validity before the Supreme Court.

The ordinance came amid a raging controversy over the Delhi government's decision to transfer Services Secretary Ashish More after a five-judge Constitution Bench led by CJI DY Chandrachud purportedly ruled in favour of the elected government of Delhi.

"If a democratically elected government is not provided with the

power to control the officers posted within its domain, then the principle underlying the triple-chain of collective responsibility would become redundant.

That is to say, if the government is not able to control and hold to account the officers posted in its service, then its responsibility towards the legislature as well as the public is

The principle of collective responsibility extends to the responsibility of officers, who in turn report to the ministers," the Constitution Bench had ruled in a unanimous verdict.

"If the officers stop reporting to the ministers or do not abide by their directions, the entire principle of collective responsibility is affected.

A democratically elected government can perform only when there is awareness on the part of officers of the consequences which may ensue if they do not perform. If the officers feel that they are insulated from the control of the elected government which they are serving, then they become unaccountable or may not show commitment towards their perfor-

mance," it had said.

Over 2.31 crore, 1kg gold found in basement of Yojana Bhawan in Jaipur



JAIPUR, May 20 (Agencies): More than Rs 2.31 crore in cash and one kg of gold was recovered from a locked almirah in the basement of Yojana Bhawan here, police said.

According to officials, seven employees of the Yojana Bhawan having access to the basement have been detained for questioning.

The trolley suitcase kept in the almirah contained Rs 2,000 and Rs 500 denomination notes, police said, adding that the recovery took place on the day when the RBI withdrew Rs 2,000 currency notes from circulation.

After the cash was seized, Chief Minister Ashok Gehlot was briefed about the matter following which Chief Secretary Usha Sharma, DGP Umesh Mishra, ADGP Dinesh MN and Jaipur Commissioner Anand Srivastava held a joint press conference at the Secre-

tariat on Friday night. "Files were found from one almirah and the trolley suitcase full of cash and gold from another, following which the employees informed the Ashok Nagar police station," Srivastava said, adding that the cash amounted to Rs 2.31 crore

and gold weighed 1 kg. "The files are being scanned and digitised under the e-filing project. Two

locked cupboards were also opened today after their keys were found," he

Seven employees have been detained and are being interrogated. The investigation has started, Srivastava said.

The Jaipur Police Commissioner said he would disclose the entire matter soon. The cupboard from which the cash and gold were recovered was locked for months. The basement from where the cash was found was accessed by Aadhaar-UID-linked staff, the police will question the staff having access to the shelves in the basement.

"Whose money is it, how did it come, investigation is being done. CCTV footage is being scanned. It seems like this wardrobe has been closed for long but is not even two or three years old," he

The opposition BJP has targeted the Congress government over the issue.

Leader of Opposition Rajendra Rathore said in a tweet, "The recovery of crores of rupees in cash and gold from the Rajasthan secretariat, where Chief Minister Ashok Gehlot sits and runs the government, is proof that the Gehlot government is in the role of a protector of corruption.'

He said the chief minister should answer how such a large amount of cash and gold reached the Yojana Bhawan.

The BJP leader said no officers from departments like Information Technology, Enforcement Directorate and Anti-Corruption Bureau were involved in the press conference called in a hurry to hide their "black deeds".

World leaders warn China, North Korea on nukes as Ukraine's **Zelenskyy travels to G7 summit**

G7 includes US, UK, Japan, France, Germany, Canada and Italy, as well as the European Union

HIROSHIMA, May 20 (Agencies): Leaders of the world's most powerful democracies warned China and North Korea against building up their nuclear arsenals, pivoting to major northeast Asian crises ahead of the arrival later Saturday of Ukrainian President Volodymyr Zelenskyy.

The focus on Asia at the Group of Seven summit comes as leaders tighten sanctions meant to punish Moscow and change the course of its 15-month invasion of Ukraine. Japan confirmed that Zelenskyy's decision to visit Hiroshima stemmed from his "strong wish" to participate in talks that will influence his nation's defence against Russia.

US national security adviser Jake Sullivan said that President Joe Biden and Zelenskyy would have direct engagement at the summit. a day after Biden announced his support for training Ukrainian pilots on US-made F-16 fighter jets, a precursor to eventually providing those aircraft to Ukraine's Air Force.

World leaders have faced a high-stakes balancing act at the G7 in Hiroshima as they look to address a raft of global worries demanding urgent attention, including climate change, AI, poverty and economic instability, nuclear proliferation and, above all, the war in Ukraine.

China, the world's No. 2 economy, sits at the nexus of many of those concerns.

There is increasing anxiety in Asia that Beijing, which has been steadily building up its nuclear weapons program, could try to seize Taiwan by force, sparking a wider conflict. China claims the self-governing island as its own and regularly sends ships and warplanes near it.

The G7 leaders issued a statement warning that China's "accelerating build-up of its nuclear arsenal without transparency (or) meaningful dialogue poses a concern to global and regional stability."

"We do seek to cooperate with China on matters of mutual interest," Sullivan said of the statement. "We will work to address our significant concerns that we have with China in a range of areas.'

North Korea, which has been testing missiles at a torrid pace in an attempt to perfect a nuclear program meant to target the mainland United States, must completely abandon its nuclear bomb ambitions, the leaders' statement said, "including any further nuclear tests or launches that use ballistic missile technology. North Korea cannot and will never have the status of a nuclearweapon State under" international nuclear treaties.

The green light on F-16 training is the latest shift by the Biden administration

as it moves to arm Ukraine with more advanced and lethal weaponry, following earlier decisions to send rocket launcher systems and Abrams tanks. The United States has insisted that it is sending weapons to Ukraine to defend itself and has discouraged attacks by Ukraine into Russian territory.

"We've reached a moment where it is time to look down the road again to say what is Ukraine going to need as part of a future force, to be able to deter and defend against Russian aggression as we go forward," Sullivan

An EU official, speaking on condition of anonymity to brief reporters on the deliberations, said Zelenskyy will take part in two separate sessions Sunday. The first session will be with G7 members only and will focus

on the war in Ukraine. The second session will include the G7 as well as the other nations invited to take part in the summit, and will focus on "peace and stability."

The G7 leaders have rolled out a new wave of global sanctions on Moscow as well as plans to enhance the effectiveness of existing financial penalties meant to constrain President Vladimir Putin's war effort. Russia is now the most-sanctioned country in the world, but there are questions about the effectiveness.

"Our support for Ukraine will not waver," the G7 leaders said in a statement released after closed-door meetings. They vowed "to stand together against Russia's illegal, unjustifiable and unprovoked war of aggression against Ukraine."

"Russia started this war and can end this war," they

Zelenskyy has consistently called for Western fighter iets to bolster his country's defenses. As Ukraine has improved its air defenses with a host of Western-supplied anti-aircraft systems and prepares to launch a counteroffensive against Russia, officials believe the jets could become essential to the country's long-term security.

Biden's decisions on when, how many, and who will provide the fourth-generation F-16 fighter jets will be made in the months ahead while the training is underway, Biden told leaders.

Japanese Prime Minister Fumio Kishida separately held talks Saturday with Prime Minister Narendra Modi of India, which is hosting the gathering of G20 world leaders later this year.

During their meeting, Kishida emphasized that attempts to change by force shouldn't be tolerated anywhere in the world - a possible reference to Russia's invasion of Ukraine and a warning to China over Taiwan.

India, the world's largest democracy, has been measured in its comments on the war in Ukraine, and has avoided outright condemnation of Russia's invasion. While India maintains close ties with the US and its Western allies, it is also a major buyer of Russian arms and

The latest sanctions aimed at Russia include tighter restrictions on alreadysanctioned people and firms involved in the war effort. More than 125 individuals and organizations across 20 countries have been hit with U.S. sanctions.

In addition, new reporting requirements were issued for people and firms that have any interest in Russian Central Bank assets. The purpose is to "fully map holdings of Russia's sovereign assets that will remain immobilized in G7 jurisdictions until Russia pays for the damage it has caused to Ukraine," the U.S. Treasury Department said.

The G7 nations said that they would work to keep Russia from using the international financial system to prosecute its war, and they urged other nations to stop

providing Russia with support and weapons "or face severe costs.

The leaders began the summit with a visit to a peace park dedicated to the tens of thousands who died in the world's first wartime atomic bomb detonation. Kishida, who represents Hiroshima in parliament, wants nuclear disarmament to be a major focus of discussions.

Biden, who scrapped plans to travel on to Papua New Guinea and Australia after his stay in Japan so that he can get back to debt limit talks in Washington, arranged to meet Saturday on the G-7 sidelines with leaders of the so-called Quad partnership. made up of Japan, Australia, India and the United States.

The G7 leaders are also to discuss efforts to strengthen the global economy and address rising prices that are squeezing families and government budgets around the world, particularly in developing countries in Africa, Asia and Latin America.

A US official said the leaders on Saturday would issue a joint communique outlining new projects in the G7's global infrastructure development initiative, which is meant to offer countries an alternative to China's investment dollars.

The G7 includes Japan, the United States, the United Kingdom, France, Germany, Canada and Italy, as well as the European Union.

Barack Obama among '500 Americans' banned from entering Russia

WASHINGTON, May 20 (Agencies): Former US President Barack Obama is among 500 Americans banned by Russia from entering the country in response to sanctions imposed by America, CNN reported on Saturday.

Russia stated on Friday that it was banning "500 Americans," including several senior members of the US executive branch, from entering the country "in response to anti-Russian sanctions imposed by the Joe Biden administration," according to a statement from Russia's Ministry of Foreign

The list, apart from Obama, also includes former US Ambassador Jon Huntsman, several US senators and the next expected chairman of the joint chiefs Charles Q Brown Jr.

Famous American late-night TV show hosts Jimmy Kimmel, Colbert, and Seth Meyers have also been banned by Russia to enter the country.

According to CNN, the Russian Foreign Ministry in its statement said, "The attached 'list-500' also includes those in



government and law enforcement agencies who are directly involved in the persecution of dissidents in the wake of the so-called Storming the Capitol." On January 6, 2021, scores of supporters of former US President Donald Trump sought to stop Biden's certification as president and attacked the US Capitol.

As the relations between Washington and Moscow are at an all-time low in present times, the Russian ministry justified the prohibitions in a statement on its website, saying, "It is high time for Washington to learn that not a single hostile attack against Russia will go without a strong reaction."

Mother arrested for abandoning baby like 'trash' in US: Reports

NEW YORK, May 20 (Agencies): Police in the US state of Georgia have arrested a 40-year-old woman for attempting to commit murder and reckless abandonment for stuffing her newborn dubbed "Baby India" into a plastic bag in 2019 and throwing her in the woods like trash, according to media

Karima Jiwani was arrested on Thursday after she was identified as the baby's biological mother through DNA. Her nationality was not known.

A visibly emotional Forsyth County Sheriff Ron Freeman held a press conference on Friday to announce Jiwani's arrest on charges of attempted murder, cruelty to children, aggravated assault and reckless abandonment, The New York Post, a tabloid newspaper

reported. On June 6, 2019, a sheriff's deputy was called to the woods near the 1900 block of Daves

Creek Road in Cumming by a neighbour reporting that he and his children heard a baby crying.

The baby was believed to be just hours old when the family heard what they thought were animal noises coming from a wooded area, CNN reported.

Deputy Terry Roper came upon a tied-up plastic bag in the brush, which contained a baby girl with her umbilical cord still attached, as seen in a graphic body camera footage that was later released in the hope of generating leads in the case.

The newborn was taken to a local hospital. She was dubbed "Baby India" by nurses who cared for her.

Sheriff Freeman said Friday that his deputies have spent thousands of hours trying to identify the person responsible for abandoning the infant.

Freeman said that in his 33 years in law enforcement, he has never wanted to make an arrest more than he did in this

"This child was tied up in a plastic bag and thrown into the woods like a bag of trash," the sheriff said in a quivering voice. "It's literally one of the saddest

things I have ever seen." According to Freeman, the first

major break in the investigation happened 10 months ago, when detectives were able to identify "Baby India's" biological father through familiar DNA, which eventually led them to Jiwani.

Within the past week, county investigators, assisted by the FBI, again used DNA to confirm that the woman was "Baby India's" birth mom, according to the sheriff.

Freeman said that Jiwani, who has other children ranging from school-age to near-adults, knew that she was pregnant with "Baby India" in the summer of 2019 — and had a history of concealed pregnancies and "surprise" births.

She allegedly delivered the baby in a car and drove for a long time without making any effort to leave the infant at a place where she could be found and taken to safety.

"How a parent — and I happen to be one, too — can do such a callous thing is both incomprehensible to all of us and it's infuriating," Freeman said of Jiwani's alleged act.

"Baby India's" father did not know about Jiwani's pregnancy and is not facing any charges, he added.

Freeman declined to say what happened to "Baby India" in the intervening years, only saying that the girl - now approaching her fourth birthday — is "happy, healthy and in a safe place."

Jiwani was ordered held in the county jail without bond. She is scheduled to make her initial court appearance on Saturday.

Indian student gets bail in alleged hit and run case in Australia

MELBOURNE, May 20 (Agencies): An 18-year-old Indian student has been granted bail by an Australian court after allegedly hitting three schoolboys at a crossing and driving away from the crash scene in Sydney, a media report said.

Vansh Khanna, who arrived in Sydney earlier this year, was arrested on Fox Street in Lane Cove on Thursday evening and taken to Chatswood police station, The Sydney Morn-

ing Herald reported. He was granted bail at Manly Local Court on Friday on condition that he reports to police, not

drives a car and surrenders his passport. Emergency services

responded on Thursday to reports that three boys, aged 12 and 13, had been struck by a car as they were allegedly crossing the roadway whilst facing a green pedestrian signal.

The children were treated by New South Wales (NSW) paramedics and were later taken to hospital for serious but non-life-threatening injuries on leg and head.

Police were informed that after the crash the vehicle drove from the scene where the driver allegedly failed to stop or render assistance, an



NSW Police statement read.

A woman told 2GB radio she saw the incident and said the Khanna did not stop

after hitting the boys. "They just went through so fast, the noise of the boys hitting the car was

horrifying... A couple of people got his rego number," The Herald reported the woman as saying.

Khanna was slapped with seven offences, including dangerous driving occasioning grievous bodily harm,

negligent driving occasioning grievous bodily harm, and two counts of causing bodily harm by misconduct while in charge of a motor vehi-

He was also charged with failing to stop and assist after vehicle impact causing grievous bodily harm, failing to stop and assist after impact causing injury and proceeding through a red traffic light.

His Honda Accord has been seized for mechanical and forensic examination and police also issued him a licence suspension notice.

Khanna will face court for mention on June 8.

11 Indonesian sailors missing after ship catches fire in Indian Ocean



JAKARTA, May 20 (Agencies): A search operation for 11 Indonesian sailors, who went missing after their ship caught fire in the Indian Ocean, a rescuer said today.

The fire broke out on the sailor ship, KM Serba Prima 8, on Tuesday, but the incident was found out by the Indonesian rescuers on Friday after two other sailors, who were rescued by a sailor ship, arrived in a seaport in Cilacap city of Central Java province on Friday and reported the incident, said Fazzli A, head of Jakarta search and rescue office.

"We deployed our personnel to the scene and conducted coordination with the rescue offices situated in the areas where the victims might be found," he told Xinhua by phone.

"We have also coordinated with the joint rescue coordination centre of Australia," he

The fire occurred while all the sailors were sleeping and after they woke up, the fire had already become too big for them to put out, according to him, Xinhua news agency reported.

All the sailors jumped into the waters and two of them were rescued by a sailor ship on Wednesday, he added.

In Kupwara town, he said, the mercury settled at 8.3°C against 6.7°C on the previous night and it was 1.8°C below normal for the north Kashmir area.

Kokernag recorded a low of 8.3°C against 7.2°C on the previous night and it was 1.7°C below normal for the place, the officials said.

Gulmarg recorded a low of 4.8°C against 3.0°C on previous night and it was below normal by 2.0°C for the world famous skiing resort in north Kashmir's Baramulla district, he said.

Jammu recorded a low of 22.6°C against 21.0°C on the previous night and it was 1.5°C below normal for J&K's winter capital, he said.

Banihal recorded a low of 9.3°C (below normal by 2.4°C), Batote 13.0°C (1.1°C below normal), Katra 18.6°C (2.3°C below normal) and Bhaderwah 9.6°C (below normal by 0.8°C). Ladakh's Leh and Kargil recorded a low of 1.6°C and 6.2°C respectively, he said.

Regarding the forecast, he said, till May 22 weather is likely to be mainly clear. However, he said, a brief spell of rain/thunderstorm may occur at a few places towards late afternoon and evening.

No TCS on overseas payment via credit card up to Rs 7 lakh

Move aimed at removing ambiguity under liberalised remittance scheme

NEW DELHI, May 20 (Agencies): The government said no TCS will be levied on international spending of up to Rs 7 lakh a year by using debit or credit cards.

Facing backlash from a wide section of people, the Finance Ministry said the move is aimed at removing procedural ambiguity with regard to Liberalised Remittance Scheme (LRS) and the levying of Tax Collected at Source (TCS)

The ministry's decision earlier this week to bring international credit card spending under the RBI's liberalised remittance scheme (LRS) and the consequent levy of 20% TCS has evoked sharp reactions from experts and stakeholders.

"To avoid any procedural ambiguity, it has been decided that any



payments by an individual using their international debit or credit cards up to Rs 7 lakh per financial year will be excluded from the LRS limits and hence, will not attract any TCS," the ministry said in a statement.

Currently, payments of up to Rs 7 lakh for medical treatment abroad and towards education do not attract TCS. TCS on such expenditures is at the rate of 5%.

The decision was taken at the 602nd meeting of the Central Board of Directors of Reserve Bank of India held under the chairmanship of Governor Shaktikanta Das.

"The Board approved

the transfer of Rs 87,416 crore as surplus to the central government for accounting year 2022-23, while deciding to keep the Contingency Risk Buffer at 6 per cent," RBI said in a statement.

The Board also reviewed the global and domestic economic situation and associated challenges, including the impact of current global geopolitical developments.

The Board also discussed the working of RBI during 2022-23 and approved the annual report and accounts of the central bank for the

Corrugated box makers cut output as demand slips

CHANDIGARH, May 20 (Agencies): The slowdown in demand for corrugated boxes from industries has cast shadow over Rs 20,000crore packaging industry in the

The manufacturers said the demand has fallen by 30-40% in the past few months. It can be gauged from the fact that kraft paper mills in North India have stopped production for a week due to declining demand for kraft paper, which is a key raw material for the industry. Kraft paper accounts for 90% of the total input cost for corrugated box industry.

"There has been a decline in demand from almost all sectors. Be it FMCG (fast-moving consumer goods), white goods or pharmaceuticals," said Vishal Goel, managing director, Giriraj Industries.

Corrugated boxes are consumed across sectors in industries and trade for packaging purpose. But the decline in orders and exports from industries amid weakness in the domestic and global demand has led the corrugated box manufacturers to curtail production.

The manufacturers said capacity utilisation of corrugated box manufacturers is around 60-70% because of slowdown in certain sectors such as auto parts, home appliances and FMCG sectors.

There are around 2,000 corrugators spread across the northern region. The industry is fragmented and dominated by MSMEs and employs over 1 lakh workers.

"There is a shortage of demand globally and even inflation is on the higher side, affecting the productivity of the mills," said Rajat Malhotra, proprietor, Aakriti Pack-

Insiders say in May, the industry sees seasonal demand for apple and spirits packaging (wine and beer). "We normally receive high demand from Himachal Pradesh for the packing of apples in boxes, but owing to the delay in determining the size of the box, the industry is yet to commence production," said corrugators.

NPS as a viable post-retirement option

20 (Agencies): PLAN-NING for retirement can be a challenging task. As the clamour for the Old Pension Scheme (OPS) gains momentum among government employees across states, here's a look at what the New Pension System (NPS) offers.

The NPS was implemented for Central and state government employees (except for the armed forces) from January 1, 2004. Its scope was extended to all citizens, including self-employed and unorganised workers, in 2009. NPS is a voluntary retirement scheme. Subscribers can make a defined contribution towards planned savings, thereby securing the future in the form of a pension. The NPS contributions are invested in market-linked securities, and employees get 60 per cent of the accumulated corpus as a lumpsum on retirement. The remaining 40 per cent is given as monthly pension. It is administered and regulated by the Pension Fund Regulatory and Development Authority (PFRDA).

Who can open an NPS account

Any citizen of India, whether a resident or an NRI, between the ages of 18 and 70 years as on the date of submission of his/her application can open an account subject to the prescribed Know Your Customer (KYC) norms. Individuals already covered under any other pension scheme can also open an account.

Benefits of NPS

Low cost: NPS is considered to be the world's lowest cost pension scheme. Administrative charges and fund management fee are also the lowest.

Simple: An applicant can open an account with any Point of Presence (PoP) through all head post offices across the country or through

Flexible: Applicant can choose his/her own investment option and pension fund or select auto choice to get better returns.

Portable: Applicant can



operate an account from anywhere in the country and can pay contributions through any of the PoP, irrespective of the branch, even if he/ she changes his/her city, job, etc. He/she can also make contributions through eNPS. The account can also be shifted to any other sector like government or corporate model in case the subscriber gets the employment.

Tax benefit for selfemployed

A subscriber is eligible for tax rebate up to 10 per cent of gross income under Section 80CCD (1) within the overall ceiling of Rs 1.5 lakh under Section 80CCE. The subscriber is also allowed deduction for additional contribution in his NPS account subject to a maximum investment of Rs 50,000 under Section 80CCD 1(B). However, tax benefits would be applicable as per the Income Tax Act 1961 as amended from time to time.

Humour appreciation found to involve 'work' brain circuits


NEW DELHI, May 20 (Agencies): Scientists have found that highfrequency neural activity, seen in tasks that require a lot of cognitive engagement, such as work, is also a mark of humour appreciation.

The scientists from Institut Du Cerveau (Paris Brain Institute), France, and Bar-Ilan University in Tel Aviv, Israel, studied the cognitive and neuronal mechanisms on which appreciation of humour was based.

They have described their findings in the journal Neuropsychologia.

Previous studies have shown the involvement of the temporal lobe in the processing of droll stimuli, or stimuli associated with goof.

The scientists analysed intracerebral electrophysiological recordings of 13 epileptic patients, which made it possible to look at neuronal activity directly with a high spatial and temporal precision (at the millisecond scale) in several cortical areas.



technique for these studies was fMRI. However, the researchers of this study said, the signal obtained via fMRI does not allow the detection of the entire spectrum of electromagnetic waves generated by the brain: part of the information is lost.

The patients being studied had been implanted with deep brain electrodes as part of a pre-surgical assessment of refractory epi-

lepsy. The researchers asked the patients to watch a three-minute excerpt from Charlie Chaplin's

Circus (1928) while their

brain activity was measured live. Beforehand, the amusing nature of each sequence had been evaluated, frame by frame, by a group of healthy volunteers.

The team then compared the patients' neural activity recorded during the funniest scenes in the film with that recorded during the least funny scenes.

"We observed that the funniest sequences were associated with an increase in high-frequency gamma waves and a decrease in low-

frequency waves. "These results indicate that high-frequency neural activity, which is seen in tasks that require a lot of cognitive engagement, such as work, is also a mark of humour appreciation. "Conversely, scenes

that are not funny, such as transition sequences where the character moves from one place to another without doing anything, promote inattention and introspection... and a preponderance of low frequencies," explained Vadim Axelrod, who led the experiment.

More importantly, the scientists said, this inverse relationship between high and low frequencies was observed in temporal lobe regions but not in others. It seemed that humorous content was not processed in the same way throughout the cortex and depended on brain areas and functions.

According to a dominant theory, the treatment of humour is based on two complementary mechanisms and involve two neural circuits - cognitive and emotional.

Cognition is first employed to detect an incongruous element of reality. For example, in Charlie Chaplin's The Gold Rush (1925), the hero eats shoelaces like spaghetti.



"Conversely, the activation of its posterior parts could correspond to understanding the unusual and, therefore, amusing aspect of certain social interactions," said Vadim Axelrod.

Study suggests TB vax may reduce risk of Alzheimer's



NEW YORK, May 20 (Agencies): The 100-year-old tuberculosis vaccine Bacillus Calmette-Guerin (BCG) vaccine may likely reduce risk of Alzheimer's disease and related dementias, suggests a studv.

The BCG vaccine offers multiple beneficial effects, and it's currently a recommended therapy for non-muscle-

invasive bladder cancer. The findings, published in JAMA Network Open, revealed that treatment with the BCG vaccine was associated with a 20 per cent lower risk of Alzheimer's disease and related dementias.

The protective association was greater in patients aged 70 years or older, and also reduced risk of death.

Researchers from the Massachusetts General Hospital (MGH) and Brigham and Women's Hospital (BWH), followed 6,467 individuals for up to 15 years after they were diagnosed with non-muscle-invasive bladder cancer.

The group included 3,388 patients who underwent BCG vaccine treatment and 3,079 who served as controls. matched by factors such as age, sex, and medical comorbidities.

During follow-up, 202 patients in the BCG vaccine group and 262 in the control group developed Alzheimer's disease and related dementias.

The incidence was 8.8

per 1,000 person-years and 12.1 per 1,000 person-years in the respective groups.

In addition, 751 patients in the BCG vaccine group died while 973 people died in the control group. Thus, treatment with BCG vaccine was also associated with a 25 per cent lower risk of death.

"A vaccine like BCG, if proven effective, is a perfect example of a cost-effective, population-healtha"based solution to a devastating illness like Alzheimer's disease," Marc Weinberg, an Instructor in Psychiatry at MGH.

"We are shifting our focus towards studying the potential benefits of BCG vaccination of older adults in Alzheimer's disease-related clinical trials," he added.

If a causal link is found, it will be important to understand the mechanisms involved. Weinberg and his colleagues note that the BCG vaccine's effects on the immune system may play a role.

IPL 2023 Playoff Race Complete Scenario: How Can CSK, LSG, RCB, MI, KKR And RR Seal Top-4 Berth

NEW DELHI, May 20 (Agencies): Only the last two days of the IPL 2023 league phase remain, with three playoff spots still up for grabs. Only defending champions Gujarat Titans are assured of a top-two spot, while as many as six teams still have chance to enter the playoffs. MS Dhoni's Chennai Super Kings, Krunal Pandya's Lucknow Super Giants, Faf du Plessis' Royal Challengers Bangalore, Rohit Sharma's Mumbai Indians, Sanju Samson's Rajasthan Royals and Nitish Rana's Kolkata Knight Riders are the six teams which still have a chance to enter the playoffs. Punjab Kings, Sun-Risers Hyderabad and Delhi Capitals are already out of the playoffs race.

Here's the IPL 2023 Playoff Race Complete Scenario:

CSK (15 Points, 13 games, NRR +0.381) - To face DC on

The MS Dhoni-led side can seal a playoff berth with a win against DC on Saturday. However, they would want to win big to ensure a top-two finish as LSG are also on 15 points. In case of a loss too, CSK can still remain in the top-4 provided match results of either LSG, RCB or MI go in their favour. LSG (15 Points, 13 games,



NRR +0.304) - To face KKR on Saturday

They have almost the same scenario as CSK. A win against KKR will see them through, a big win will catapult them to a top-two finish. Even in case of a loss, they can still go through provided match results of CSK, RCB or MI go in their favour.

RCB (14 Points, 13 games, NRR +0.180) - To face GT on Sunday

The big wins in the last two games have ensured that RCB have a good run-rate. A win against GT will ensure them a spot in the top-4, provided MI does not beat SRH by a humongous margin. Both matches are on Sunday and RCB's run-rate is much better than MI's.

They can finish in the top two as well, provided one among CSK or LSG lose their respective games and RCB beat GT by a big margin.

Even if they lose and MI lose too, RCB will go through due to their much better run-rate. There is another scenario that KKR (currently on 12 points) defeat LSG by a massive margin both RCB and MI lose. In that case, run-rate will play a big part and RCB have the better run-rate among the three.

MI (14 Points, 13 games, NRR -0.128) - To face SRH on

The five-time champions are in a tricky spot as they are placed sixth in the points table. However, they face the bottom-placed SRH in their last game. They have to win their last game and hope that one team out of CSK, LSG and RCB lose their respective last matches. That will see MI (on 16 points in case of a win vs SRH) enter top-4.

They have a chance to finish in the top-two as well provided CSK, LSG and RCB lose their games and the Rohit Sharmaled side win big.

RR (14 Points, 14 games, NRR +0.148)

They now have to depend on other teams' results - more specifically on RCB's and MI's last matches. They will need both teams to lose their respective games to have the long shot of entering the top 4. RCB must lose big for RR to enter top 4. Royals beat Punjab by four wickets, keep playoffs hopes alive



DHARAMSALA, May 20 (Agencies): Devdutt Padikkal and Yashasvi Jaiswal hit crucial fifties as Rajasthan Royals kept their playoffs hopes alive with a four-wicket win over Punjab Kings in their final IPL league match here.

Sent in to bat, PBKS were reeling at 50/4 but Sam Curran (49 not out) and Jitesh Sharma (44 off 28 balls) revived the innings while M Shahrukh Khan (41 not out off) provided the late surge to power the side to 187/5. Playing in only his second match of the season, pacer Navdeep Saini (3/40) picked up the best figures of his IPL career.

A target of 188 was never going to be easy and RR needed to complete the chase in 18.3 overs to get ahead of Royal Challengers Bangalore's net run rate but they couldn't. But still RR got two points to stay afloat, with Jaiswal (50 off 36) scripting the chase, adding 73 off 49 balls with Padikkal (51 off 30) and another 47 off 22 balls with Shimron Hetmyer (46) as RR won in 19.4

With the win, RR moved to fifth spot with 14 points, same as RCB and Mumbai Indians, who both still have a match to play in the league stage. The loss meant, PBKS are officially out of

RR suffered an early setback during their chase with Kagiso Rabada getting Jos Buttler Ibw for his third duck. But Padikkal and Jaiswal batted with purpose to take RR to 85/1 in 9.4 overs. But RR lost Padikkal and skipper Sanju Samson (3) in quick succession to leave them at 90/3 in the 11th over.

Jaiswal then found a perfect partner in Hetmyer, who slipped into the role of the aggressor with three sixes early on. Jaiswal completed his fifty in 35 balls before falling to a reverse hit off Nathan Ellis. RR still needed 51 off 33 balls and it was Riyan Parag (20 off 12 balls) who slammed two successive sixes off Rabada to bring the equation down.

PBKS skipper Shikhar Dhawan pulled off a sensational catch to end Hetymer's stay but impact player Dhruv Jurel clobbered a six off the fourth ball of the last over to knock off the winning runs.

Brief scores: Punjab Kings: 187/5 (Curran 49*, Jitesh 44; Saini 3/40); Rajasthan Royals: 189/6 in 19.4 overs (Padikkal 51, Jaiswal 50, Hetmyer 46; Rabada 2/40).

After climbing into fifth place, Rajasthan Royals will now endure a nervous wait for the next couple of days. They will need both Mumbai Indians and Royal Challengers Bangalore to lose their final games. In RCB's case, the loss must be by six runs or more for Royals to jump ahead on net run rate.

IPL 2023: Listless KKR hoping against hope; LSG eyeing back-to-back playoff berth

KOLKATA, May 20 (Agencies): Set to be clad in local giants Mohun Bagan's iconic green and maroon jersey, Lucknow Super Giants would find themselves at home as they look to seal their playoff berth knocking out a hapless Kolkata Knight Riders in the final IPL game, here on Saturday.

The real home team in this case, KKR, have not only complained of being let down by the conditions but their problems go deeper, having struggled to find a perfect winning combination in a topsy-turvy season, enduring seven defeats. Out of those seven, four losses were at the Eden Gardens.

Be it the batting, which still seems to be a work in progress, the bowling, especially pace department, has also looked terribly short on experience.

In fielding, they have made a mockery of themselves with some of the efforts suggesting that the two-time champions have showed they do not 'belong' at this level.

KKR batters simply have not been able to adapt to the surface while batting first as they scored below-par totals of 179/7 and 149/8 against Gujarat Titans and Rajasthan Royals respectively.

Putting things into perspective, CSK and SRH scored 235/4 and 228/4 when they were put into bat by KKR at the same venue.

Courtesy, some individual brilliance from Rinku Singh and Varun Chakravarthy, the KKR still are lucky to have been able to keep their campaign alive in 'blow hot-n-cold' season.

With a heavy mid-table traffic, there is a possibility of four teams to be locked on 14 points with the one with a superior net run-rate making the



playoffs.

KKR with 12 points would not only need to win by a big margin, but they have to rely on Punjab Kings (vs Rajasthan Royals), Gujarat Titans (vs Royal Challengers Bangalore) and Sunrisers Hyderabad (Mumbai Indians) to win their respective

LSG however do not have to fret so much about the mathematical scenarios as a win would be enough for them to seal their backto-back playoff berth.

Marcus Stoinis is proving to be the crisis man for LSG and was the difference in their stunning win over MI.

He brought all his experience into count to score an 89 not out to revive their innings from being 35/3.

In bowling Mohsin Khan has been a revelation as he along with spinner Ravi Bishnoi would look to relish the

slow conditions of Eden. Hanging by the thread, LSG, who will be don-

ning a special edition Mohun Bagan colours. will further be bolstered by the support of the football heavyweights with both the teams have the same owner, RP Sanjiv Goenka Group.

Behind the scenes, LSG mentor Gautam Gambhir, who led KKR to their two triumphs in 2012 and 2014, will add all the valuable inputs.

Batting has been CSK's strong suit. Devon Conway, Ruturaj

Dhoni has managed some cameos in the fag end of the innings and the skipper is expected to continue doing so despite calls of him coming up the order.

But Delhi hasn't fared well at home, with skipper Warner conceding their batting unit has struggled to figure out what the best total is at the Feroz Shah Kotla this season because of slow and inconsistent pitches.

Apart from a few cameos by Axar Patel, Delhi's Indian batting line-up has failed miserably this season.

Prithvi Shaw has perhaps been the biggest letdown along with veteran Manish Pandey,

We thought Singh would resign in January: Bajrang Punia

NEW DELHI, May 20 (Agencies): The wrestlers who are sitting on a dharna in their fight against Brij Bhushan Sharan Singh in an alleged sexual harassment case have been saying that they are in for a long haul.

However, it was not the case when Bajrang Punia, Vinesh Phogat and Sakshi Malik first decided to start a sit-in protest back in January. They started the protest and

rocked the very foundation of Indian sports when they alleged that Singh had been abusing women wrestlers for a number of years. The feeling within the group was that since the allegations were of a grave nature, either Singh would resign or the government would seek his resignation forthwith to resolve the matter. The wrestlers first came

to Jantar Mantar on January 18 and called off their protest three days later after the Sports Ministry formed an oversight committee to probe the allegations.

However, the wrestlers have had to return to the site for a second time as they were not satisfied with the committee's workings. Subsequently, the wrestlers then filed a complaint with the Delhi Police and then got a favourable directive from the Supreme Court as FIRs were registered against the Wrestling Federation of India

"When we came here for the first time, we thought he would resign promptly and leave. We also thought our Government would seek his resignation and the wrestling body would be handed over to the right people," Bajrang told agency, which hap-



pened to be the 27th day of their protest.

"Now we are not thinking about days any more. We have thought that this is a fight to get justice and so we will fight till the end," added the Tokyo Olympics bronze medallist

Further, the wrestlers never wanted to file a police complaint or approach the courts as they wanted to hide the identities of the victims.

"We did not want a big fight because we wanted to save the girls. Already you can see when we sent in the complaints this time, those names were leaked. We wanted to keep their names confidential. They are all out in the open now. Those girls are being pressured now," Bajrang

"If any such incident happens to a girl in our society, it is remembered for eternity. However, if a boy does any such thing, people forget in two months or a year maximum. No girl will put forward such allegations for fun. These are serious allegations and these girls have to live their lives. Some of them will get married as well. No one plays with their honour to get political benefits," he added.

Impella Device gives new lease of life to 52-yr-old patient with heart blockages

JAMMU, May 20: The cardiology team at Fortis Mohali led by Dr R.K Jaswal, Head of Department and Director of Cardiology and Director-Cathlabs, has given a new lease of life to a 52-year-old Patient who had suffered a sudden cardiac arrest.

The patient was saved by using the most advanced technology-Impella Device in Left Ventricular Assist Device (LVAD).
