10 Vaishno Devi pilgrims dead, 57 injured as bus falls down from bridge in Jammu; Most were from Bihar Death of pilgrims in Jammu bus JAMMU, May 30 (Agen-"We were hoing to pay

cies): Ten Mata Vaishno Devi pilgrims, most of them from Bihar, were killed and 57 others were injured on Tuesday as their double-decker bus fell into a gorge after skidding off the road and ramming into the railing of a bridge in Jammu district, officials said Tuesday.

The death toll may go up as Government Medical College Hospital Principal Shashi Soodan said two of the injured admitted there are critical.

Officials said the bus, which was on its way to Katra from Amritsar, met with the accident in Jhajjar Kotli area. Katra is a base camp for the pilgrims visiting the famous shrine atop the Trikuta hills.

"The accident took place at Jhajjar Kotli bridge. Ten people have died. Rescue operation is almost compete," Jammu Senior Superintendent of Police Chandan Kohli told agency. "We are investigating the reasons behind the accident." Local residents, CRPF and police personnel rushed to the spot and launched the rescue

The fifty-seven injured have



been admitted to the GMC hospital in Jammu and two of them are critical. "Two persons were brought dead in the hospital while others have died on the spot," said Soodan, the principal.

A CRPF officer said 10 bodies have been recovered. The bus skidded off the Jammu-Srinagar National Highway and rolled down the bridge over a nallah at Jajjar Kotli between 6.30 and 7 am, the officials said.

They said most of the travellers were from Bihar's Lakhisarai and were on pilgrimage to Mata Vaishno Devi for a religious function of their child. They were members of an extended family.

Ravinder Panday, one of the travellers, said they felt that something hit the bus. "It lost balance and rolled down. The vehicle was on its way from Amritsar to Katra carrying people who were going for pilgrimage to the cave shrine of Mata Vaishno Devi," he said.

The accident site looked horrific with bodies trapped under the mangled remains of the bus.

Describing the accident, a witnesses said the bus was in the left lane, but it crossed over to the right side after the driver lost control, hit the railing of the bridge went down.

The front wheels came off and got stuck in the parapet of the bridge.

Over 2600 teachers in J&K have 'Below Secondary' level qualification

JAMMU, May 30 (Agencies): In Jammu and Kashmir more than 2600 teachers are having below secondary level qualification and are teaching students at all levels.

Ironically, among the total number of such teachers with below secondary level qualifications, over 1700 are teaching the primary level classes.

According to the news agency—Kashmir News Observer (KNO), the official figures reveal that a total of 2685 teachers with below secondary level qualification were teaching students at all levels.

The official figures reveal that at preprimary level across the Jammu and Kashmir, at least 276 such teachers were teaching the students.

It also states that at least 1773 such teachers that amount to more than 66 percent were teaching the students at primary level.

The official figures reveal that at upper primary level, a total of 540 teachers were teaching the students followed by 88 teachers at secondary level and eight teachers at higher secondary level.

Meanwhile, one of the government teachers wishing anonymity said, "As per government norms, a person should be at least graduate in order to be able to teach students regardless of levels, be it primary, upper primary or secondary level."

The teacher said that it doesn't matter as to whether such teachers are from

government or private schools, "I believe they should enhance their qualifications so that their teaching ability improves and students won't suffer."

In 2021, the Government of India (Gol) has said that in Jammu and Kashmir, over 2000 'untrained' teachers posted in Government Secondary Schools lack the requisite professional qualifications to teach the students,

Ministry of Education (MoE) for the Gol and officials of Jammu and Kashmir in an Project Approval Board Meeting (PAB) 2021-22 held earlier this year has said, "There are 2061 untrained teachers in Government Secondary Schools based on UDISE 2018-19 who do not

meet the requisite professional quali-

In the meeting, the Gol advised the Jammu and Kashmir government to roll out a policy to enroll such teachers in teacher's education institutions to complete the professional course without

having minimum qualifications. "All untrained teacher's need to professionally train so as to be compliant with National Council for Teacher Education

(NCTE) regulations," GoI has said. The Gol also informed the JK government that during the current year, all left out untrained teachers, masters and lecturers of the School Education Department shall be enrolled in the B.ed course through IGNOU.

Man held with heroin, cash in Rajouri; 31 phones seized

JAMMU, May 30 (Agencies): A man was arrested with 11 gram heroin in Rajouri district of Jammu and Kashmir on Tuesday, police said, adding 31 mobile phones and Rs 1.16 lakh in cash were also seized from him.

Aziz Ahmed alias Sonu Chinese, a notorious drug peddler, was nabbed during a raid on his house in Rajouri town in the presence of executive magistrate deployed by district civil administration, police said in a statement.

The statement said two electronic weighing machines, three cameras, three motors, four amplifiers, one inverter, one stabilizer and one speaker have also been recovered during the

"Some part of recovered property is suspected to be stolen in nature but exact use of mobile phones will be clear during investigation," the police said.

A case under relevant sections of the Narcotic Drugs and Psychotropic Substances (NDPS) Act has been registered against Ahmed, who was becoming notorious for peddling of narcotics in the town and was luring youth towards addiction. Rajouri Senior

ANANTNAG, May 30 (Agencies): A narrow street branching off from the main road in Hangalgund village of Anantnag's Kokernag area leads to Narupora, a hamlet dotted by lofty walnut trees.

Inside a newly constructed concrete shed in the village, one could see stacks of PE films, tissues, papers and all that jazz.

Donning white aprons, a knot of young women are working on small machines to manufacture the sanitary pads. In this outlying vil-

lage, ten young women



teamed up and established a sanitary manufacturing unit. "We formed a Self Help Group and applied for the unit in 2020," says Ridwana amidst a whirring sound of a machine.

napkin manufacturing unit since she was married in the village. "I originally hail from



Will new House symbolise our democratic freedoms?

rime Minister Narendra Modi and the ruling BJP-NDA are keen that the new Parliament building inaugurated on Sunday, with its own claims of grandiosity, should proclaim the Hindutva message of the rightwing party. It is a definite break from the politics of the past 100 years, 75 as Independent India and 25 of the freedom movement under Mahatma Gandhi's leadership of the Congress Party. In the last 100 years, India's people and its leaders struggled to embrace the 20th century democratic spirit of Europe and America. Mr Modi has declared quite loudly that India has its own democratic traditions and the placing of the "Sengol", or sceptre, next to the Speaker's chair in the new building does not symbolise the spirit of democracy as it does of rulership. A re-enactment of a meaningless ritual whose historicity is dubious has now been made the keystone of India's parliamentary democracy from Sunday. In Mr Modi's definition of democracy, there is very little room for different points of view, no room for concepts like liberty and freedom, no room for diversity.

Intellectual honesty requires that we accept democracy as a borrowing — and there is no shame in borrowing a good idea — from Europe and America, especially the revolutions of 1776 in America and 1789 France. These two revolutions opened the way for the rights of the people and the freedoms of the people. There can be no democracy without rights and liberties. Rights and freedom are, however, not a part of the vocabulary of Mr Modi and the BJP and

of the Rashtriya Swayamsevak Sangh (RSS). So, the question to be asked is: how did Indian democracy manage to enthrone a man and a party without faith in the principles of the rights and liberties of the people. This is a time, and for many it might appear a futile and self-lacerating, exercise to look back and detect the follies that brought Mr Modi and the BJP to power with an absolute majority. The right-wingers can undermine every democratic right through the legal means available to a party with a brute majority in Parliament. The remedy, of course, is when the people reject a leader who thinks that he is indispensable.

One of the odd things about Sunday's inauguration of the new Parliament building was that there was no other voice other than that of Mr Modi. Other members of Parliament belonging to different parties should have spoken on the occasion and spoken about the imperatives of democracy, so that it would have become clear that democracy is not what Mr Modi says it is, and that there are other views of democracy. But the function was arranged in such a way that it was a Modi monologue. Critics are sure to say that the Opposition should not have boycotted the function. But it is good that they did because Mr Modi anyway would not have allowed anyone else to speak.

Mr Modi has reduced democracy to the new building of Parliament with all the latest gadgets embedded in it. There is no talk about the modes of parliamentary democracy, where the representatives of the people who belong to different parties and who have different viewpoints debate issues of national importance. Mr Modi

did not speak about the quality of democracy or the content of democracy. A Parliament dominated by a single party and a single leader is not much of a democracy. And this was indeed the complaint of intellectuals from the 1950s to the 1970s when the Congress was in power, and Jawaharlal Nehru and Indira Gandhi were dominant. Looking back, we find that Nehru and Indira Gandhi faced stringent criticism not only from political opponents but also from the liberal media of the day. Today, political opponents find themselves helpless in Parliament

and their voice is marginalised by the pro-Modi mainstream media. The liberals in India (yes, the liberals are the guilty party for weakening of democracy by the likes of Mr Modi and the BJP) have to realise that their unthinking rhetoric of group rights and the socialist development model has silenced the notes of dissent in Indian democracy. Nehru and the Congress failed the democratic test when the government of the day banned Nirad C. Chaudhuri's Autobiography of an Unknown Indian and V.S. Naipaul's An Area of Darkness. The liberals' intolerance of those who did not subscribe to their version of liberalism had laid the foundation of authoritarianism in Indian democracy. The liberals should pick up the courage to read Chaudhuri's second volume of his autobiography Thy Hand, Great Anarch! written in 1987, in which he castigates Gandhi's mass movements, and calls Nehru and Subhas Chandra Bose as extremists, and condemns the proclivity of the Hindu and Muslim masses of passivity on the one hand, and brutal violence on the other. One can dismiss it all as mere drivel, but it would be a training exercise in listening to arguments that one does not agree with.

Mr Modi has followed the main paradigm of a weak Indian liberal democracy in silencing dissent inside and outside Parliament. Of course, the magic of democracy and the people's will is that at election time they have a way shaking a leader at a time when he thinks he is invincible. It seems that it is not so much a sense of invincibility as much as a sense of vulnerability that is driving Mr Modi's rhetoric these days. After defeats in the Assembly elections in Himachal Pradesh and then in Karnataka, where the Prime Minister had staked his personal prestige, the leader seems to be making a desperate attempt to find his form, to use a cricketing metaphor. But his overblown rhetoric suggests that he is still flailing his hands in the air, and he is not sure whether people are willing to vote for him and his party. It is also unlikely Mr Modi and the BJP will ever appreciate the value of liberal democracy as an end in itself. Though Mr Modi harps on the freedom struggle, he does not seem to value the idea of freedom all that much. India did not fight for freedom from the British only for the sake of the nation as a collective entity, but also for the freedom of Indians as individuals. That is why India's Constitution enshrines the Fundamental Rights, which concern individual freedoms. Mr Modi and the BJP have, however, shown a distinct aversion for the rights and freedoms of individuals.

New building will not solve the key problems India's Parliament faces

he problem that affects India's Parliament is the quality of debate, the lack of time spent discussing important legislation, the absence of quality for the most part in speeches, the chaos and anarchy, the horse-trading and the disregarding of the Opposition and minority opinion.

The new building that was inaugurated on Sunday will solve none of these problems, of course, but then it is not expected to. Like the Vande Bharat trains, it is a solution to problems that do not exist. And behind the introduction of new rituals and a new object is an absence of clarity or direction and the presence of theatre passing itself off as traditionalism. Let us see why.

Conservatism is described as the "commitment to traditional values and ideas with opposition to change or innovation".

What are these traditional values? Those which are orthodox, long-established and customary. The United Kingdom's Parliament is in a building that goes back 900 years. Fire destroyed a lot of the structure in 1263 in the reign of Henry III, then again in 1298 and again in 1512 and again in 1834. Each time the parts that were burnt down were rebuilt. This is traditionalism and conservatism and that is one reason why the House of Commons and the House of Lords is so respected.

If you have seen parliamentary debate in the UK, with its stiff formalism and insistence on protocols and the members'

discipline in following these, it is because both major parties accept traditionalism in these matters. This is why, truth be told, their debates are enjoyable, while ours are not.

India's Parliament House was opened only in 1927, but it has now been discarded in favour of something newer, though it is not clear why the new building was needed. The other buildings constructed around the same time, including the centres of administration and Rashtrapati Bhavan (built in 1929), are still occupied and being used.

The new Parliament's inauguration was accompanied by religious ritual as a sign of belief in tradition but the larger principle of traditionalism was abandoned with the previous building. We can see this elsewhere in New India as well.

Ideology must be rooted in principles. A focus on conservatism must then show itself across the spectrum of functioning. This is not easy to do because it puts tradition and values above immediate advantage.

Traditionalism acts as a restraining hand on the wrist of the person making decisions or one who has a say. It says "go slow", "do not disturb that which is working", respect what you have inherited and try to understand why it has worked.

Traditionalism also understands that there are boundaries, and traditionalism respects them by adhering to these boundaries himself. The often-unwritten rules of engagement between institutions are followed by the traditionalist through con-

vention and precedent, rather than innovation and invention. Again, it needs to be repeated that this shows itself particularly where and when there is tension between institutions. This is when the conservative, the traditionalist, steps back.

The radical individual knows all this and doesn't care for traditionalism or conservatism. The goal here is to undo the past and to break with it totally. Complete political and social reform is the call of the radical, also defined as extreme social and political change.

The current uncertainty with India's currency is not the result of an act of conservatism or traditionalism. It is a radical act, just like the one that inspired it in 2016. Experimentation of this sort is not to be found in traditional governments like the UK, or even the United States. In those countries, people holding bills of high denomination have the confidence that their money will be accepted today, tomorrow and in the future.

"This note is legal tender for all debts, public and private" - is what the dollar says. Shopkeepers do not refuse the note in the US or the pound in the UK because they are unsure of its future or concerned that accepting it will put them through difficulty. Traditionalism must extend to the Constitution and its values. If it espouses pluralism and freedom, then the traditionalist has to stress them. If it contains fundamental rights, meaning those which enjoy a high degree of protection from encroachment by the State, then it is this value that must be echoed. In constitutional democracies, the Opposition is legitimate and is a part of the legislature. To see it as the enemy and to try and get rid of it through convictions and expulsions is not traditionalist because it is not democratic.

The traditionalist treads carefully on laws that bring change. Especially change that is unclear. If there are safeguards in the law then these must give pause. Undoing parts of the Constitution for popular reasons or even those of nationalism is an act of radicalism. Consider where Jammu and Kashmir is today more than three years after executive action. If it is in a place of uncertainty, it is because the action was not conservative or traditionalist.

When it is said that the party governing India is "right wing" it is implied that it is traditionalist and conservative. It is opposed to liberalism, which wants to interpret laws based on the spirit of the time and not some eternal principles. But this traditionalism does not appear to show itself in either language or behaviour. It chases after the wrong things as it has shown consistently over the past decade. And there will always be another new thing to chase.






High Court denies bail to Manish Sisodia in Delhi excise policy scam

NEW DELHI, May 30 (Agencies): The Delhi High Court on Tuesday dismissed the bail plea of former deputy chief minister Manish Sisodia in the excise policy scam being probed by the CBI.

Justice Dinesh Kumar Sharma denied the relief to the AAP leader, who was arrested on February 26, saying the allegations against him are very serious in nature.

The high court, while pronouncing its verdict on the bail plea, said Sisodia is an influential man and the possibility that witnesses could be influenced if he is released on bail cannot be ruled out.

The CBI had arrested Sisodia for alleged cor-



ruption in the formulation and implementation of the now-scrapped Delhi Excise Policy 2021-22 following several rounds of questioning.

He has challenged the March 31 order of a trial court which had dismissed Sisodia's bail plea in the matter, saying he was "prima facie the architect" of the "scam" and had played the "most important and vital role" in the criminal conspiracy related to alleged payment of advance kickbacks of Rs 90 crore-100 crore meant for him and his

government.

NEW DELHI, May 30 (Agencies): A day after the horrific murder of a 16-year-old in Delhi's Shahbad Dairy area, Delhi Police sources on Tuesday revealed that Sahil, the 20-year-old accused, had after committing the gruesome killing switched off his mobile phone and changed two buses to reach Bulandshahr in Uttar Pradesh.

Sahil was arrested from Bulandhshahr by Delhi Police on Monday and will be taken on remand for questioning, sources added.

"After murdering the girl, accused Sahil went



to Rithala, dumped the weapon and changed two buses to reach Bulandshahr," police sources said.

In a CCTV grab of the incident, Sahil can be purportedly seen stabbing the girl multiple times with a knife and continued to stab her



even when she slumped to the ground. He kicked her and then took a concrete slab lying nearby and bludgeoned her head.

All this while the footage showed people watching the events unfold and walking past without intervening.

An initial police investigation concluded that at the time of the incident, the victim did not have a mobile phone.

Around 10 minutes after the incident, locals informed the beat police officer about the incident and police arrived at the spot.

As per the police

sources, the accused has not been able to give satisfactory answers during questioning and he attempted to mislead the police.

As per the police, the accused was in a relationship with the minor, but they had a quarrel on Sunday night after

which he killed her with multiple assaults.

The police said that it had registered FIR in the matter under section 302 of the Indian Penal Code (IPC) at Shahbad Dairy Police Station.

Also, the National Commission for Women Chairperson Rekha Sharma wrote to the Commissioner of Police, Delhi to conduct a fair and time-bound investigation into the matter and to arrest the accused at the earliest.

The Commission has formed a three-member team headed by Member Delina Khongdup to look into the matter.

Dhanorkar was 47 and is survived by wife Pratibha, an MLA, and two sons.

"He was admitted to a Nagpur-based hospital last week for the treatment of kidney stones. He was later shifted to New Delhi but could not survive," Congress leader Balasaheb Thorat said.

Dhanorkar, the Lok Sabha member from Chandrapur, underwent treatment for kidney stones at a hospital in Nagpur on May 26 and was rushed to Medanta Hospital in Gurugram neighbouring Delhi on Sunday after some complications.

Dhanorkar's mortal remains will be flown to his hometown, Warora, on Tuesday afternoon.



The last rites will be held on Wednesday morning.

Dhanorkar's 80-yearold father Narayan Dhanorkar passed away in Nagpur on Saturday evening after prolonged illness. The MP could not attend his father's last rites on Sunday.

China successfully launches new manned spaceship with first civilian on board

Once ready, China will be the only country to own a space station as the International Space Station of Russia is a collaborative project of several countries

BEIJING/JIUQUAN, May 30 (Agencies): China on Tuesday successfully launched the Shenzhou-16 manned spaceship, sending three astronauts, including the first civilian to its space station combination for a five-month mission.

The spaceship, atop a Long March-2F carrier rocket, blasted off from the Jiuquan Satellite Launch Centre in northwest China at 9.31 am (Beijing Time), according to the China Manned Space Agency (CMSA).

About 10 minutes after the launch, Shenzhou-16 separated from the rocket and entered its designated orbit. The crew members are in good shape and the launch is a complete success, the CMSA declared, it said.

The astronauts are expected to dock with the station's Tianhe core module about 400km above the ground – after a journey of less than seven hours.

For the first time, China has included a civilian in its rotating



crew for the space station which otherwise remained a domain of the military personnel.

Gui Haichao, a professor at Beihang University in Beijing, regarded as a payload specialist, was among the three astro-

The other two are mission's commander Jing Haipeng, who is also making history by becoming the first Chinese astronaut to go into space for a record fourth time.

The astronaut flight engineer

Zhu Yangzhu is also making his first journey into space.

The Shenzhou-16 will be the first crew mission after China's space station programme entered the stage of application and development, Lin Xiqiang, deputy director of the CMSA told the media on Monday.

The trio will stay in orbit for about five months, he said.

Once ready, China will be the only country to own a space station as the International Space Station (ISS) of Russia is a collaborative project of several countries. The ISS station is also set to be decommissioned by 2030.

The significant feature of China's space station is its two robotic arms, especially the long one which has the ability to grab objects, including satellites from space.

After entering orbit, the Shenzhou-16 spaceship will make a fast, automated rendezvous and docking with the space station combination.

The Shenzhou-16 astronauts will conduct large-scale in-orbit tests and experiments in various fields as planned.

They are expected to make high-level scientific achievements in the study of novel quantum phenomena, highprecision space-time-frequency systems, the verification of general relativity, and the origin of life.

The launch also marks the 475th flight mission of the Long March carrier rocket series.

LAHORE, May 30 (Agencies): A joint investigation team probing the violent attack on the historic Corps Commander House or the Jinnah House here on May 9 has summoned former Pakistan prime minister Imran Khan on Tues-

Khan, the chief of the Pakistan Tehreek-e-Insaf (PTI) party, has been asked to appear before the JIT at 4 pm at the Qilla Gujjar police headquarters in Lahore. He has been called for questioning in a case registered with the Sarwar Road police station against

Jinnah House (Corps Commander House) was torched by arsonists following the antigovernment protests against the arrest of Khan on May 9.

A large number of PTI party workers May 9 stormed the Jinnah House and set it on fire after vandalising it.

A joint investigation team (JIT) — formed by the Punjab interim government to probe arson attacks on Jinnah House and the Askari Corporate Tower in Lahore on May 9 summoned Khan on Tuesday, sources were quoted as saying by the Geo News.

Khan's arrest sparked days of street protests after which the PTI leaders' exodus started, as security forces launched a crackdown against the party following the attacks on civil and military institutions.

At least eight people were killed in the violent protests in the country.

Uganda enacts law to stop stealing of human organs

KAMPALA, May 30 (Agencies): Ugandan President Yoweri Museveni has approved a law to stop the stealing of human organs and tissues, the health minister said on Tuesday, in a nation where women have been reportedly duped into unnecessary surgeries.

Local media have in recent years reported cases of women recruited for domestic work in the Middle East being conned into medical procedures after which

their kidneys are sold in global trafficking rings.

In a tweet, Health Minister Jane Aceng thanked Museveni for signing the Uganda Human Organ Donation and Transplant Bill 2023 to better regulate the area. "The door is now open for #Uganda to begin a new chapter of Organ Transplant," she said.

That came a day after Museveni and government lawmakers drew widespread international condemnation for enact-



ing one of the world's harshest anti-LQBTQ laws, which included the death penalty for "aggravated homosexuality."

The donation and transplant law, the first

of its kind in Uganda, prohibits any commercial dealings in human organs and tissues. Punishments include life imprisonment and

9 injured in shooting near beach in Hollywood, Florida; some taken to children's hospital

FLORIDA, May 30 (Agencies): Nine people were injured on Monday evening when gunfire erupted along a beach boardwalk in Hollywood, Florida, sending people frantically running for cover along the crowded beach on Memorial Day.

Several of the victims were taken to a children's hospital, police spokesperson Deanna Bettineschi said. However, authorities have not yet released the ages of the victims.

The nine victims included three children, according to Yanet Obarrio Sanchez, a spokesperson for Memorial Healthcare System. All the victims were in stable condition, she said

injured people. Police said there would be a heavy presence of officers as the investigation continues. Officials were also setting up an area for family members to reunite.

Moscow Targeted By Drone Attacks, No Casualties

MOSCOW, May 30 (Agencies): The Russian capital and its surrounding were targeted by rare drone attacks on Tuesday morning, causing "minor" damage to buildings and no casualties, officials said.

Russian forces had fired a barrage of missiles at Kyiv on Monday, sending panicked residents running for shelter in an unusual daytime attack on the Ukrainian capital following overnight strikes.

"This morning, at dawn, a drone attack caused minor damage to several buildings. All the city's emergency services are on the scene ... No one has been seriously injured

so far," Moscow mayor Sergei Sobyanin said.

Andrei Vorobyov, the governor of the Moscow region, said many drones had been downed near the capi-

"This morning, the residents of certain districts in the Moscow region could hear explosions. it was our anti-air missile defence system," he wrote.

"Several drones were shot down while approaching Moscow." he wrote, urging residents to keep calm and adding that "all rescue services are doing their

Moscow, located more than 1,000 kilometres (620 miles) from Ukraine, has only

rarely been targeted by drone attacks since the start of the conflict in Ukraine, even though such attacks have become more common elsewhere in Russia.

Images posted on social media showed traces of smoke in the sky. Others showed a broken window.

Sobyanin said the residents of two buildings damaged in Tuesday's strikes had been evacuated and added that they "can return to their apartments once the special services have finished their work".

In early May, two drones were shot down over the Kremlin in an attack blamed on Ukraine.

Lebanon army frees kidnapped Saudi

The army said in a statement that they carried out "a special operation on the border [with Syria] to arrest the kidnappers and free the Saudi man."

BEIRUT, May 30 (Agencies): A Saudi national who had been kidnapped in Beirut has been freed in a "special operation" by the Lebanese army near the Syrian border, it said in a statement Tuesday.

"An army intelligence patrol managed to free kidnapped Saudi national Mashari al-Mutairi during a special operation on the Syrian border," the army said.

"A number of those involved in the kidnapping were also arrested," it added.

A senior Lebanese security source had told agency on Monday that, based on preliminary information, the



Saudi was kidnapped by unidentified assailants dressed as security personnel in a fourwheel drive vehicle on the Beirut seafront, where he had been in a restaurant.

Prime Minister Najib

Mikati congratulated the army on the "great effort deployed to release

him and arrest those involved in the kidnapping." According to the Saudi government-owned television channel Al-

Ekhbariya, the kidnappers had demanded a ransom. Kidnappings of Arab or foreign nationals in Lebanon have been rare in recent years.

> The last one occurred in July 2022, when a Saudi was abducted on

arrival at Beirut airport.

Since 2021, Saudi citizens have had to obtain their government's permission before travelling to Lebanon because of strained diplomatic ties between the two countries.

Saudi Arabia returned its ambassador to Beirut in April 2022, just over five months after recalling him amid a diplomatic dispute pitting Lebanon against several Gulf monarchies.

Relations between Beirut and the Gulf Arab states had become strained in the face of the growing influence in Lebanon of the pro-Iranian Shiite movement Hezbollah.

North Korea Confirms June Launch Of Military Spy Satellite

SEOUL, May 30 (Agencies): North Korea has confirmed it will launch a reconnaissance satellite in June, saying it is needed to monitor military movements of the United States and its partners in real time, state media reported Tuesday, citing a senior defence official.

Japan said Monday it had been informed by Pyongyang that a satellite launch could happen as early as this week, but Tokyo warned the North may in fact be planning a sanctions-defying ballistic missile test.

The North's state Korean Central News Agency cited Ri Pyong Chol, vice-chairman of the ruling party's central military commission, as saying the "military reconnaissance satellite No. 1" would be "launched in June".

That satellite, along with "various reconnaissance means due to be newly tested, are indispensable to tracking, monitoring... and coping with in advance in real time the dangerous military acts of the US and its vassal forces", the statement said.

Citing "reckless" acts by Washington and Seoul, Ri said North Korea felt "the need

to expand reconnaissance and information means and improve various defensive and offensive weapons" in an effort to bolster military preparedness. The official also accused the United

States of conducting "hostile air espionage activities on the Korean peninsula and in its vicinity", according to the KCNA dispatch.

North Korea informed Japan it would launch a rocket between May 31 and June 11, identifying waters near the Yellow Sea, the East China Sea and to the east of Luzon Island in the Philippines as warning areas, a Japanese coast guard spokesman told agency.

Such zones are usually designated for falling debris or rocket stages.

Japanese Prime Minister Fumio Kishida told officials to gather intelligence "on North Korea's notification about the launch of a ballistic missile that it describes as a satellite", his office said in a tweet.

"Even if it's described as a satellite, a launch using ballistic missile technology would be a violation of United Nations



Security Council resolutions" and would threaten people's safety, Kishida told

In 2012 and 2016, Pyongyang tested ballistic missiles that it called satellite launches. Both flew over Japan's southern Okinawa region.

North Korean leader Kim Jong Un this month inspected the country's first military spy satellite as it was prepared for launch, and gave the green light for its "future action plan".

'Cannot be justified'

In 2021, Kim had identified the development of such satellites as a key defence project for the North Korean military.

Because long-range rockets and space launchers share the same technology, analysts say developing the ability to put a satellite in orbit would provide Pyongyang with cover for testing banned intercontinental ballistic missiles (ICBMs).

Japan's defence ministry issued an order to shoot down any ballistic missile confirmed to be on course to fall into its territory.

South Korea's foreign ministry condemned the launch plan, but officials did not confirm to AFP if Seoul had been

directly notified of it. "North Korea's so-called 'satellite launch' is a serious violation of UN Security Council resolutions banning all launches using ballistic missile technology, and is a clearly illegal act that cannot be justified under

any pretext," the ministry said. South Korea and Japan have been working to mend long-frayed ties, including with greater cooperation on North Korea's military threats.

Unusual stance

Meanwhile, Kishida on Monday reiterated that Tokyo is open to talks with Pyongyang. North Korean state media on Monday published a statement from the country's vice-minister of foreign affairs, appearing to endorse a conciliatory approach to relations with Japan -- an unusual stance from

If Japan avoids "being shackled by the past, and seeks a way out for improving the relations, there is no reason for the DPRK and Japan not to meet", said the statement from Pak Sang Gil, using the initials of North Korea's official name.

Pak said, however, that Japan needs to move on from sticking points such as the

"abduction issue" for ties to improve. Japan suspects dozens of people who are still missing were abducted by North Korean agents in the 1970s and 1980s to train spies in the Japanese language and culture.

In 2020, when the world was caught in the throes of COVID-19 and the government imposed a protracted lockdown to stave off the transmission of deadly virus, Ridwana gave a serious thought to setting up a sanitary manufacturing unit in the village.

"I thought how even the women who are well aware about menstrual hygiene would be coping up during the lockdown", she

A post graduate in Urdu, Ridwana was aware of various government schemes. She formed a Self Help Group of nine young women in her village and applied for a sanitary manufacturing unit under 'My Pad, My Right' programme of NABARD's NABFoundation.

After initial hiccups due to pandemic, the manufacturing unit was finally inaugurated last month by District Magistrate, Anantnag Dr Basharat Qayoom.

Scores of women from the area were present at the inaugural function and were all ears when the speakers shed light on poor menstrual hygiene and the diseases associated with it.

Different surveys conducted by Ministry of Health between 2002 and 2012 revealed that around 60,000 cases of cervical cancer deaths are reported every year from India and two-third of them are due to poor menstrual hygiene, the speakers said.

Ridwana and her team not only manufacture the napkins but also move from village to village to generate awareness about menstrual hygiene. "We visited more than 20 villages since we launched our product

FROM PAGE 1 and made people aware about menstrual health," she says.

The team manufactures at least 800 pieces of sanitary pads each day, fetching them a good amount. The product named as Nissa has, according to Ridwana, outperformed the top-tier companies manufacturing the sanitary napkins.

"Our product completely locks the fluid inside and provides better and longer protection than other products", she said.

Now, talking about menstrual health is no longer a taboo at least in the village. The stigma attached to it is fast going away as the manufacturing unit has touched off a discussion among the inhabitants about menstrual hygiene.

"The women and young girls don't shy away from visiting our unit to purchase the product", she adds with a radiant smile on

"On the back of sound macroeconomic policies, softer com-



modity prices, a robust financial sector, a healthy corporate sector, continued fiscal policy thrust on quality of government expenditure, and new growth opportunities stemming from global realignment of supply chains, India's growth momentum is likely to be sustained in

2023-24 in an atmosphere of easing inflationary pressures, it said.

The RBI's Annual Report for 2022-23, a statutory report of its Central Board of Directors, further said its monetary policy remains focused on withdrawal of accommodation to ensure

that inflation progressively aligns with the target, while supporting growth.

"With a stable exchange rate and a normal monsoon -- unless an El Nino event strikes -- the inflation trajectory is expected to move down over 2023-24, with headline inflation edging down to 5.2 per cent from the average level of 6.7 per cent recorded last year," the report said.

In the external sector, it said the current account deficit (CAD) is expected to remain moderate, drawing strength from robust services exports and the salubrious impact of moderation in commodity prices of imports.

Delay in seeking treatment key reason behind deaths due to acute cardiac events: Study

NEW DELHI, May 30 (Agencies): Delay in seeking proper treatment is the key reason behind a large number of deaths due to acute cardiac events or stroke, according to a study published in the Lancet.

The study, conducted at the All India Institute of Medical Sciences (AIIMS) here, stated that only a small proportion of patients with cardiac and stroke emergencies reach health facilities early. It said addressing the reasons for delays at multiple levels in reaching the facilities could prevent such deaths.

"Lack of timely care is a predictor of poor outcomes in acute cardiovascular emergencies, including stroke. Delayed presentation leads to delay or failure to provide the most beneficial therapies like thrombolysis for myocardial infarction/ischemic stroke leading to poorer disease outcomes. It is estimated that interventions that reduce delays in care in patients with myocardial infarction (MI) could decrease risk of mortality by 30

per cent," the study funded by the Indian Council of Medical Research (ICMR) said

The doctors assessed the presence of delay in seeking appropriate care among those who died due to cardiac/stroke emergencies in a community in northern India and identified the reasons and determinants of this delay.

This descriptive study was conducted in two out of three tehsils (Badkhal and Ballabgarh) of Faridabad district of Haryana with an estimated population of 21 lakh in 2020-21.

A social audit was conducted among all civil-registered premature (30-69 years) deaths due to acute cardiac event or stroke in the district.

The three-delays model was used to qualitatively classify the delays in care seeking -deciding to seek care, reaching appropriate health facility (AHF) and initiating definitive treatment.

Based on the estimated time from symptom onset to reaching AHF, patients were classified as early (reached within one hour) or delayed arrivers.

Mixed-effect logistic regression with postal code was used as a random effect to identify determinants of delayed arrival. Findings showed that only 10.8 per cent of the deceased reached an AHF within one

"We noted level-1 delay in 38.4 per cent (60 per cent due to non-recognition of seriousness); level-2 delay in 20 per cent (40 per cent due to going to inappropriate facility) and level-3 delay in 10.8 per cent (57 per cent due to lack of affordability)," the study stated.

The primary reason for delay identified in all studies has been lack of awareness of the symptoms related to MI or stroke resulting in non-recognition of the severity of their illness, the study said.

As part of the study, 2,466 verbal autopsies were assessed, of which 761 (30.8 per cent) autopsies were classified as due to cardiovascular diseases (CVDs).

The delays identified in the study pointed to the need for interventions at population and health system levels. There have been many health system initiatives in India to reduce delays in cardiac and stroke

These health system interventions should be supplemented by efforts to create public awareness in recognising symptoms of heart attack and stroke and by improving insurance coverage for these life threatening conditions. Community educational campaigns to improve symptom awareness to promote early recognition and care-seeking and use of ambulances have been shown to be effective.

Training of formal and informal primary care providers to recognise these conditions and refer them to an appropriate hospital has also proved useful, the study added.

India may cut solar panel import tax to make up domestic shortfall



NEW DELHI, May 30 (Agencies): India may cut its import taxes on solar panels in half and is seeking a rollback in goods and services taxes on the devices to make up a shortfall in local output amid rising demand for renewable energy, three government sources said.

India's renewable energy ministry has held talks with the finance ministry to approve its request to cut the import tax on solar panels from 40% to 20%, said the three sources, who declined to be identified as the decision has not yet been finalised.

Also, the two ministries may make a recommendation to India's Good and Services Tax Council to lower the goods and services tax (GST) on solar panels to 5%, from the 12% imposed in 2021, the sources said.

India imposed the 40% solar panel import tax in April 2022 and a 25% tax on solar cells to discourage Chinese imports, in line with Prime Minister Narendra Modi's ambitious plan to become more self-reliant and cut emissions by scaling up renewable energy generation.

"However, domestic capacity is falling short ... imports are required to fill in the gap," said one of the sources.

The proposal comes as Modi looks at achieving a target of 365 gigawatts (GW) of installed solar capacity by 2031-32, part of a green energy push that extends from promoting electric cars to sustainable aviation fuel.

India's finance ministry did not immediately respond to emails seeking comment. A spokesperson for the renewable energy ministry said a comment would be made as soon

New genes associated with an increased risk of heart attacks in women identified

LONDON, May 30 (Agencies): An international team of researchers has identified new genes that are associated with an increased risk of a type of heart attack primarily affecting young to middleaged women.

The study, published in Nature Genetics, identified 16 genes that increased the risk of a SCAD -- or Spontaneous Coronary Artery Dissection -- which is most common in women under the age of 60 and is a leading cause of heart attacks around the time of preg-

SCAD occurs when a bruise or bleed occurs in the wall of a coronary artery, cutting off the blood to part of the heart. This leads to a heart attack

However, people who suffer from SCAD tend to be generally healthy happen more than once. To date, little is known about why a SCAD happens, often striking out of the blue, meaning that it is currently impossible to prevent.

In the study, the researchers present a genome-wide association meta-analysis involving a total of 1,917 cases of SCAD and 9,292 controls from European ancestry.

The identified 16 genes are involved in processes that determine how the cells and connective tissue hold together, and also how the blood clots when bleeding occurs in tissues.

Interestingly, the researchers found that, while many genes linked to a higher risk of SCAD are shared with risk genes for conventional coronary artery disease (CAD), they have an opposite effect.

This means patients with a SCAD have some genetic protection from the risk of CAD, and is further evidence that these diseases are very different. The only shared risk factor appeared to be genetically elevated blood pressure.

"This research confirms that there are multiple genes involved in determining the risk of a person having a SCAD," said lead author David Adlam, Associate Professor of Acute and Interventional Cardiology at the University of Leicester, UK.

"These genes give us the first key insight into the underlying causes of this disease and provide new lines of enquiry, which we hope will guide future new treatment approaches," he

Excessive salt consumption associated with cognitive disorders, high blood pressure, finds study

TOKYO, May 30 (Agencies): Dementia is described as a loss of cognitive functioning, which included thinking, remembering, and reasoning, and it is quite common in Japan. At the moment, treatment satisfaction for dementia is among the lowest, and no medication therapy to cure the condition is available. With the world's population increasingly ageing, the discovery of dementia prevention and treatment medications is crucial.

Cognitive impairment has been linked to the consumption of excess table salt, a ubiquitous food seasoning. High salt (HS) intake can also lead to hypertension. To prevent adverse health outcomes, the World Health Organization recommends limiting salt intake to less than 5 g per day. The involvement of angiotensin II (Ang II)--a hormone that plays a key role in regulating blood pressure and fluid balance--and its receptor "AT1", as well as that of the physiologically important lipid molecule prostaglandin E2 (PGE2 and its receptor "EP1" in hypertension and neurotoxicity



is well-recognized. However, the involvement of these systems in HS-mediated hypertension and emotional/cognitive impairment remains elusive.

To this end, a recent study published in the British Journal of Pharmacology thoroughly evaluated the aspects of HSmediated hypertension and emotional/cognitive impairment. The study was performed by a team of collaborating researchers from Japan, and has shown how hypertension, mediated by the crosstalk between Ang II-AT1 and PGE2-EP1 causes emotional and cognitive dys-

Author Hisayoshi Kubota from Fujita Health University's Graduate School of Health Science comments, "Excessive salt intake is considered a risk factor for hypertension, cognitive dysfunction, and dementia. However, studies focusing on the interaction between the peripheral and central nervous system have not sufficiently investigated this association." According to the published data, the addition of excessive phosphates to the protein "tau" is primarily responsible for this emotional and cognitive consequences. The findings are particularly noteworthy because tau is a key protein of the Alzheimer's disease.

The team first loaded laboratory mice with an HS solution (2 per cent NaCl in drinking water) for 12 weeks and monitored their blood pressure. "The effects of HS intake on emotional/cognitive function and tau phosphorylation were also examined in two key areas of the mouse brain--the prefrontal cortex and the hippocampus," explains Prof. Mouri. Next, they also studied the involvement of the Ang II-AT1 and PGE2-EP1 systems in the HS-induced hypertension and neuronal/ behavioral impairment.

The results were remarkable and encouraging: The brains of the experimental mice had several biochemical alternations. At the molecular level, besides the addition of phosphates to tau, the researchers also observed a decrease in the phosphate groups linked to a key enzyme called "CaMKII" -- a protein involved in brain signaling. Moreover, changes in the levels of "PSD95"--a protein that plays a vital role in the organization and function of brain synapses (connection between brain cells)--were also evident. Interestingly, the biochemical changes were reversed after the administration of the antihypertensive drug "losartan." A similar reversal was observed after knocking out the EP1 gene.

Overall, these findings suggest that angiotensin II-AT1 and prostaglandin E2-EP1 systems could be novel therapeutic targets for hypertension-induced

New low-cost smartphone attachment to monitor blood pressure at fingertip

NEW DELHI, May 30 (Agencies): Scientists have developed a simple, low-cost clip that uses a smartphone's camera and flash to monitor blood pressure at the user's fingertip.

The clip developed by researchers at the University of California (UC) San Diego, US, works with a custom smartphone app and currently costs about 80 cents (5.6 rupees) to make.

The researchers estimate that the cost could be as low as 10 cents (0.7 rupees)

apiece when manufactured at scale. The technology, described in the journal Scientific Reports, could help make regular blood pressure monitoring easy, affordable and accessible to people in resource-poor communities, they said.

It could benefit older adults and pregnant women, for example, in managing conditions such as hypertension, according to the researchers. "We have created an inexpensive solution to lower the barrier to blood pressure monitoring," said study first author Yinan Xuan, a Ph.D. student at UC San Diego. "Because of their low cost, these clips could be handed out to anyone who needs them but cannot go to a clinic regularly," said study senior author Edward Wang, a professor at UC San Diego and director of the Digital Health Lab.

Another key advantage of the clip is that it does not need to be calibrated to a cuff, the researchers said.

"This is what distinguishes our device from other blood pressure monitors," said

Other cuffless systems being developed for smartwatches and smartphones, he explained, require obtaining a separate set of measurements with a cuff so that their models can be tuned to fit these measurements. "Our is a calibration-free system, meaning you can just use our device without touching another blood pressure monitor to get a trustworthy blood pressure reading," Wang said.

To measure blood pressure, the user simply presses on the clip with a fingertip. A custom smartphone app guides the user on how hard and long to press during the measurement.

The clip is a 3D-printed plastic attachment that fits over a smartphone's camera and flash. It features an optical design similar to that of a pinhole camera. When the user presses on the clip, the smartphone's flash lights up the fingertip. That light is then projected through a pinhole-sized channel to the camera as an image of a red circle. A spring inside the clip allows the user to press with different levels of force.

The harder the user presses, the bigger the red circle appears on the camera.

The smartphone app extracts two main pieces of information from the red circle. By looking at the size of the circle, the app can measure the amount of pressure that

the user's fingertip applies.

By looking at the brightness of the circle, the app can measure the volume of blood going in and out of the fingertip.

An algorithm converts this information into systolic and diastolic blood pressure

The researchers tested the clip on 24 volunteers from the UC San Diego Medical Center. Results were comparable to those

taken by a blood pressure cuff. "Using a standard blood pressure cuff can be awkward to put on correctly, and this solution has the potential to make it easier for older adults to self-monitor blood pressure," said study co-author Alison Moore, from UC San Diego School of Medicine.

The win marks the Super Kings' fifth IPL title — equaling the record for most titles set by arch-rivals Mumbai Indians — in what could turn out to be the legendary Mahendra Singh Dhoni's final outing in the T20 league.

Chennai chased down their revised target of 171 in 15 overs with five wickets to spare in a rain-hit IPL final which went past 1.30 am local time on a reserve day following a washout on Sunday.

All-rounder Ravindra Jadeja stepped up to the plate to take Chennai home after the men in yellow required 10 from the last two deliveries of Titans' pacer Mohit Sharma. Jadeja hit a six off the penultimate ball and a boundary off the last ball to win it for Chennai.

CSK got off to a solid start with their openers Ruturaj Gaikwad (26 off 16 balls) and Devon Conway (47 off 25 balls) piling up the runs up to once again. Conway took the role of



an aggressor and took down Shami and Hardik in the powerplay.

Batters Ajinkya

Rahane (27 off 13 balls) and Ambati Rayudu (19 off 8 balls) played crucial cameos, striking in excess of 200, to guide Chennai through their run-chase. Rayudu, in particular, exploded on the 13th over as he lashed Mohit for 6, 4 and 6 to take Chennai closer to the target.

Promoted to no 3, Shivam Dube, who has been Chennai's most explosive batter this season, saw through his team's chase with an unbeaten 32 off 21 balls to see his side through

But a lot depends on the body. It would take 6-7 months to decide. It will be more like a gift from my side. It's not easy for me but the way they have shown their love and affection, that's something that I need to do," he said at the post-match presentation.

"My eyes were full of water, I needed to take some time off in the dugout. I

realised I need to enjoy this. I think they love me for what I am, they love that I am so grounded, I don't try to portray something I'm not. Just keep it simple. Every trophy is special, but what is special about IPL is every crunch game you need to be ready," he added.

Under the stewardship of Dhoni, Chennai Super Kings embellished their already fabulous record in the IPL with a fifth title triumph, beating Gujarat Titans by five wickets in a thrilling summit showdown.

Dhoni has been the cynosure of all eyes ever since the Indian Premier League began this year and in a fitting end to the finale, the captain finished with a record-levelling fifth trophy.

B Sai Sudharsan slammed 96 in 47 balls as Gujarat Titans posted 214 for four after being asked to bat first.

Set a revised target of 171 in 15 overs after rain interrupted play at the start of the second innings of a final that was pushed to the reserve day owing to heavy downpour, CSK completed the task in the last ball, in what could turn out to be Dhoni's final outing in the T20 league.

Ravindra Jadeja struck a six and a four off Mohit Sharma in the final two balls to win it for CSK and even as the players in the yellow jersey run onto the field, Dhoni remained in the dugout, his eyes closed.
