#### **Active Covid** cases in India dip to 3,343

NEW DELHI, Jun 4 (Agencies): India has recorded 202 new coronavirus infections, while the active cases have decreased to 3,343 from 3,502, according to the Union Health Ministry data updated on Sunday. The death toll has increased to 5,31,880 with two deaths, the data updated at 8 am stated.

The Covid case tally was recorded at 4.49 crore (4,49,91,582).

The active cases now comprise 0.01 per cent of the total infections, while the national COVID-19 recovery rate has been recorded at 98.81 per cent. according to the health ministry website.

The number of people who have recuperated from the disease surged to 4,44, 56,359 and the case fatality rate was recorded at 1.18 per cent.

According to the ministry's website, 220.66 crore doses of Covid vaccine have been administered in the country so far under the nationwide vaccin tion drive.

#### Body of Kashmiri youth found dead in West Bengal college reaches home

BUDGAM, Jun 4

(Agencies): The body of the Budgam youth who was found dead at a college hostel in West Bengal last week reached his native village in central Kashmir's Budgam district on Sunday afternoon. Quoting locals, news agency reported that on June 2, the family members received a call from college authorities that their son Muhammad Umar Ganai who was studying engineering at the Budge Budge Institute of Technology Kolkata was found dead at the college hostel.

However, two days later, on Sunday afternoon, the body of the deceased reached his native village of Debipora Yarikhah in Khansahab tehsil of Budgam where thousands of people were seen wailing over his

An official said they have started the investigation to ascertain the cause of the death.

## 28K J&K Govt employees under I-T Dept scanner for claiming bogus refunds

SRINAGAR, Jun 4 (Agencies): More than 28,000 government employees working in Jammu and Kashmir, including 8,000 police and paramilitary force personnel, are under the scanner of the Income-tax department for allegedly claiming bogus refunds worth a few crores of rupees while filing their ITRs, official sources said.

The taxman has found that this purported fraud took place during the Income Tax Returns (ITRs) filing seasons in 2020-21 and 2021-22 even as the department has registered two criminal FIRs against a Chartered Accountant (CA) and 404 other people, with the J-K Police crime branch after a similar fraud was

detected for the last few fiscals. The alleged irregularities came to light sometime back after the



Tax Deducted at Source (TDS) wing of the department located in Srinagar found that a number of people who are assessed in the Union Territory of J-K had claimed "excessive and ineligible deductions" under various heads leading to claim of bogus refunds, the sources said.

The Principal Director of I-T (J-K and Ladakh) M P Singh sanctioned filing of police FIRs against the CA and 404 other people that includes some dubious tax advisors and filers for

"entering into a conspiracy and

defrauding the exchequer of a sum of Rs 16.72 crore between the financial years 2017-18, 2018-19 and 2019-20."

The department found that many among these people had filed incorrect or false ITRs and had identically claimed around Rs 4 lakh in refunds, they said.

The department, as part of the complaints that resulted into two FIRs filed on May 25, has shared with the police the names, addresses, PAN and bank accounts of these 405 people after which the crime branch froze these bank deposits, the sources said.

The police has booked these people under various sections of the IPC like 420 (cheating), 468 (forgery), 471 (using a forged document as genuine), 120B

#### Former J&K CM Mehbooba Mufti issued Passport after 3 Years



SRINAGAR, Jun 4 (Agencies): PDP president and former Jammu and Kashmir chief minister Mehbooba Mufti has been issued a passport with 10-year validity, sources said here on Sunday.

After a prolonged legal battle in the Delhi High Court, the passport was delivered to Mehbooba. Her travel document expired in 2019 and since then she had been seeking its renewal.

It came barely two days ahead of a hearing in Jammu and Kashmir High Court where Menbooba's daughter Iltija's plea challenging the decision of the passport office to give her a countrv-specific passport is to come up.

The passport given to Mehbooba, who was the last chief minister of erstwhile Jammu and Kashmir state before it was bifurcated in 2019, is valid from June 1, 2023, till May 31, 2033.

## People of India are going to defeat **BJP: Rahul Gandhi**

NEW YORK, Jun 4 (Agencies): Congress leader Rahul Gandhi has said after the Karnataka election victory his party will "decimate" the BJP in Telangana and other state polls, emphasising that it is not just the Congress party but the people of India who are going to defeat its hate-filled ideology.

"We have shown in Karnataka that we can decimate the BJP... We did not defeat them, we decimated them. We smashed them in Karnataka," Gandhi said at a dinner event organised here Saturday by the Indian Overseas Congress-USA.

Gandhi arrived in New York after



visiting Washington and San Francisco and will address a community rally at the Javits Centre in Manhattan on Sunday.

He said in the Karnataka elections, the BJP "tried everything

in the book, they had the entire media, they had 10 times the amount of money we had, they had the government, they had the agency. They had everything and then we decimated them," Gandhi said. "And I want you to know that we are going to decimate them in Telangana next," he said to loud cheers and applause from the

"It will be hard to find the BJP in Telangana after this election." Election in the southern Indian state is scheduled to be held later

## Situation in Kashmir won't improve till India, Pak hold dialogue: Farooq Abdullah

SRINAGAR, Jun 4 (Agencies): National Conference president Farooq Abdullah on Sunday said holding the G20 event in Kashmir will not benefit tourism in the Valley till India and Pakistan resolve the "future" of the Union Territory through dialogue. He also said Jammu and Kashmir was suf-

fering heavy losses because of the lack of an elected government. "The question is wheth-

er we will benefit in terms of tourism arrivals from these countries? That cannot happen till the situation here does not improve and the situation will not improve till the two big countries do not hold dialogue on how to shape the future of this state," Abdullah told reporters here.

The NC president was responding to a question whether holding of the G20 meeting in Srinagar would benefit the union territory.

"We did. The roads which were in bad shape for many years were



repaired. The walls got a fresh coat of paint. The street lights started working. So we did benefit from it," he said.

Over lack of an elected government in J and K, Abdullah, "Democracy is when there is an elected government. One LG and his advisor cannot look after the entire state. There are MLAs who look after their respective areas as it is their duty. The bureaucracy is not bothered about these things as they do not retire till the age of 60 years. An MLA has to go back to the people every five years. If he does not work, he won't get the votes. Therefore,

it is very important that

elections should be held here," he said.

The Lok Sabha member from Srinagar said his party was ready for the elections any

Responding to the statement of Lieutenant Governor Manoj Sinha that a few parties in Kashmir had hijacked the elections in the past, Abdullah said, "Don't they have means to counter it? They can approach the high court or the election commission. Even Indira Gandhi was also ousted (by the High Court). There are avenues." On the Odisha train accident, he said it was one of the major disasters in the

### Mega nursery in J&K near Pakistan border all set to cater to local fruit growers this monsoon

JAMMU, Jun 4 (Agencies): Ahead of monsoon, a mega nursery of fruit plants set up by the Jammu and Kashmir horticulture department near the India-Pakistan border fence is all set to provide saplings of guava, mango, litchi and other fruits to the local farmers from next month.

The nursery spread over 100 acres in the Chakroi area of R S Pura was inaugurated in January by Lieutenant Governor Manoj Sinha. "It was set up in a record period of one

and a half years and was inaugurated in January by the lieutenant governor. We have sown 12,000 mother plants," district level subject specialist at the nursery Sandeep Kumar Sharma said.

According to locals, the border belt has witnessed a massive transformation with majority of plants in the nursery have grown 4 to 5 feets. "It is the biggest nurs-

ery of Jammu and Kashmir for sub-tropical plants. The capacity of this nursery is to produce 5 lakh saplings and we hope to add more to the existing capacity," Sharma said.

The nursery has so far produced over one lakh root stocks which will be transformed into highquality fruit plants.

The nursery has 14

diverse greenhouses. each serving a specific purpose. Among them, two state-of-the-art polygreenhouses offer cutting-edge technology, ensuring optimal conditions for plant growth, he said.

Besides, it has two insect-proof nethouses. two screen houses, four shade net houses and three naturally-ventilated polygreenhouses, he added.

## Amid dry weather temperature to rise in J&K

SRINAGAR, Jun 4 (Agencies): Meteorological Department forecast of dry weather with temperature to rise gradually in Jammu and Kashmir.

Mainly Clear weather with a brief spell of rain, thunder or lightning may occur at some places towards late afternoon or evening chances of 30-40 per cent, the MeT office said.

It said the weather is likely to remain dry but a brief spell of Shower or thunderstorms mainly towards evening can't be ruled out from June 5-12 and there would be a gradual increase in temperature that results in warmer days ahead.

There is no major forecast of any major rainfall till June 12, the MeT office added. It has also advised

farmers to carry out all farm operations today and onwards till June 12 and finish work before dusk sets in as rain can occur any time during the evening.

Srinagar recorded a low of 10.4 degree Celsius against 9.8 degree Celsius a day ago and it was 2.1 degree Celsius below normal for the summer capital of Jammu and Kashmir.

The maximum temperature though showed an increase but was still 2.3 degree Celsius below normal of 26.3 degree Celsius recorded on Sunday.





## Manjit demands curb on illegal mining in Samba

SAMBA, Jun 4: Apni Party Provincial President, Jammu, and Former Minister, S. Manjit Singh on Sunday has demanded a curb on illegal mining of minerals from the river beds in District Samba due to which the ground water level has reduced in many villages.

The Former Minister was addressing a meeting at village Koulpur during which the people appraised him about various developmental issues with the Apni Party leaders.

The meeting was organised by Block Vice President, Vijaypur, Sadar Wazir Singh Jangi.

Addressing the meeting, S. Manjit Singh extended support to the growing concern of the people with regard to the drop in ground water level following in planned and unscientific mining in the river beds by the mining mafia.

"The groundwater level has reduced to a drastic level in villages around Devak and Basantr rivers which has alarmed the locals and they have raised serious concern over the unabated mining by the mafia with the involvement of mining department and civil administration," he

said, expressing his displeasure over the situation which has caused uneasiness among the

villagers. He said that the villagers are mostly dependent upon groundwater for irrigation and drinking purposes but the inaction of the authorities against the mining mafia has posed threat to the ecosystem. and ground water level.

"If no action is taken against the mining mafia, the people will come on the road. Therefore, it is better for the authorities to take immediate steps to put a curb on the mining mafia who have dug deep over 20 to 25 ft in the river beds which has resulted in the reducing groundwater level," he added.

Meanwhile, he also referred to other developmental issues raised by the people with regard to the road connectivity, and unscheduled power cuts and demanded that the authorities should take steps for the revamp of developmental activities.

He criticized authorities that they can bring positive change in the lives of the people, but their inaction, and actions against the public will have developed a feeling of alienation from the LG administration.

Citing an example of ill planned policy of Agniveers for the youth aspiring to join Indian Army, he said that the number of youth joining Indian army has reduced because of poor chances of getting regularized for regular jobs after the completion of four years.

"Youth have failed to understand why the policy was introduced which has service tenure of four years, and what they will do after getting retired from the service. There is no future or sense of job protection for the educated youth. Otherwise, border areas would prefer joining the army as first priority," he said, and appealed to the Govt of India to look into the policy and make regular recruitments on a permanent basis so that the border youth of Jammu and Kashmir can be provided permanent jobs in the security forces.

He also demanded a special on spot recruitment drive for the border areas and kandi belt in the paramilitary and J&K Police. He said that the talented youth should be provided an appropriate platform to work for the nation, and protect its integrity.

He however, appealed to the people and the parents to play an important role in preventing their children from becoming drug addicted.

"The drug addiction has become a serious threat to the youth and the members of civil society, and family members have a bigger role to play," he

## **EDITORIAL**

## BLIND FAITH IS DANGEROUS

aith plays an important part in our everyday lives and in our interactions with people. It is impossible to live without faith. We need to have faith in our family members, the doctor we go to, our colleagues, employees, as well as in a higher Power. But what is faith? Is it blind belief? Or does faith need to be based on reason and understanding?

Blind faith is belief in a thing or person without any reasoning or basis. Unquestioned allegiance can be dangerous. Faith, on the other hand, is based on logic and rational thinking. You can approach a doctor just because your neighbour says he is good. Or you may accept the neighbour's recommendation but do a background check before going to him. Having decided to entrust your health to him you do not question his bona fides at every step. However, you question him if you do not understand or agree with him.

Your adherence to the treatment regimen depends on the extent to which you are convinced that he is right. Thereafter you follow your conviction. You cannot follow someone else's advice blindly, however right he may be. It is the same with a lawyer, chartered accountant or spiritual master. In all these cases, you are approaching a person who has knowledge while you are in ignorance. This puts you at a disadvantage straightaway. It is impossible for you to know what he knows. So you need to have faith.But not blind faith. Your approach must be in an environment of trust and confidence, the belief that here is a person who has the knowledge I need and who can help me. However, at every juncture, you must have the freedom to question, enquire and get answers to your queries. Only then will you be convinced and follow his guidance.

There may be some things that you do not understand. Set them aside for a later date and deal only with what you can comprehend and put into action. If you do not have basic faith in the person's competence and are constantly wondering if he will take you for a ride, there will be no meaningful relationship. However, if you do not use your own intellect and you follow a person unquestioningly, it will be detrimental for you even if he is right and well-meaning. And if he has ulterior motives, the result can be disastrous for you. With reference to a spiritual master, the role of faith is even more important.

There is no way of verifying the existence of God or even the efficacy of the path recommended. Hence, it is essential to have faith. However, the use of your intellect to analyse and assess the guru and the path is equally important.

You must first survey the spiritual field and look at the options available in terms of the approach, the guru and methods prescribed. See if it suits your personality. There are three broad paths in the spiritual field — the path of knowledge, path of devotion and path of action.

Most gurus emphasise one of the three. If you are a predominantly intellectual person and the path prescribed is that of devotion there is a mismatch and it will not help you. It is like going to a cardiologist with a fractured leg. So make sure the path suits your personality type.

The Bhagwad Gita gives three qualifications of a good student — pranipata, surrender; prasna, questioning; and seva, service. The starting point should be surrender or faith, an acknowledgement of your willingness to submit to the teachings of the guru. This must be followed by questioning. An active and alert intellect understands what the guru is recommending, reflects over it and questions where he fails to comprehend. Having learnt and grown with the help of the teachings, the student expresses his gratitude by way of service.

These days I feel like a dinosaur when I watch TV, and especially when people discuss phones or computers or modern cars or Artificial Intelligence and things like that. Here was a program that actually made me feel young. At the centre of the spectacle were and old couple in a horsedrawn carriage - something obsolete by even my standards. 


## JKTJAC holds monthly meeting, raises genuine issues of teaching fraternity

## Brad Pitt sues ex-wife Angelina Jolie for breach of **contract in Winery lawsuit**

Former couple Brad Pitt and Angelina Jolie's legal fight seems to be never-ending.

As per People, Pitt is now suing Jolie for selling her portion of their shared French vineyard without consulting him.

The Oscar-winning actor claimed in new court documents that amid the continued war in Ukraine -- the association presents an "existential threat to the business" due to the new part owner's ties to Russia.

The first amended complaint about the winery, filed in February 2022, sought damages for declaratory relief, disgorgement, and damages, along with pre and post-judgment interest for the defendants' alleged tortious interference with contractual

In legal documents obtained by People, the complaint alleged that Jolie sold her interests in the property to Tenute del Mondo, whose parent company is the spirits manufacturer Stoli



Group, which is "controlled by Russian oligarch Yuri Shefler."

"Shefler's Russia-affiliated spirits conglomerate has been the subject of repeated boycotts in connection with Vladimir Putin's invasion of Ukraine and homophobic legislative Agenda," the lawsuit stated.

"While Shefler may be seek-

ing to launder his reputation by forcing a partnership with one of the world's most well-known and popular actors, affiliation with Shefler and Stoli jeopardizes the reputation of the business that Pitt so carefully built with Perrin and with which Pitt has so closely and carefully associated himself and his image."

Pitt reportedly learned of Jolie's alleged putative sale via a press release.

The lawsuit claims the purported sale was "unlawful" due to "contractual agreement" breaches between Jolie and Pitt "to hold Miraval together and not sell their interests separately without the other's consent."

Pitt and Jolie gained a controlling interest in Miraval in 2008. They began selling their own rose in March 2013 and got married at the chateau in August 2014. Pitt alleges that when Jolie filed for divorce in 2016, they both agreed not to sell their Miraval shares without each other's permission, US Magazine reported.

However, in 2021, the Girl Interrupted star sold her portion of the business to Tenute del Mondo.

In September 2016, the Gia actress filed for divorce from Pitt after two years of marriage and 12 years together.



## **Odisha train accident: Teams working round the** clock to restore tracks

Work is on so that railway services on the main trunk line connecting eastern and southern India can be restored

BALASORE, Jun 4 (Agencies): Two days after one of India's worst train accidents at Bahanaga Bazar in Odisha's Balasore district, most railway tracks have been cleared of wrecked railway coaches overnight by a team of bulldozers and cranes so that railway services on the main trunk line connecting eastern and southern India can be restored, railway officials said on Sunday.

Work on repairing tracks and overhead electric cables which had snapped is also going on, said officials.

Union Ministers Ashwini Vaishnaw and Dharmendra Pradhan who have camped here visited the railway accident site in the early hours of the morning.

"Restoration work is going on at a fast pace ... single line track work, signalling system has almost been completed, overhead electricity work of one track is going on, it will be completed very soon," said Vaishnaw.

Pradhan added that "rescue work is over ... we are working with the local administration to send people affected back home." He also said that the big challenge is to restore tracks so that the railway link between two important wings of the country can start functioning

"Restoration work on tracks is on. We are also working on overhead cables and masts which were uprooted ... soon the down line will be restored and then the up line," the official said.

A thorough search is being conducted in the passenger coaches which have been removed to check for bodies which may still be in them trapped in crumbled steel parts of the coach.

The triple train pile-up near Balasore on Friday disrupted passenger and goods traffic between important industrial centres. Many of the patients initially admitted to Balasore and other local hospitals have been released or shifted to bigger cities with multi-speciality hospitals including Cuttack, Bhubaneswar and Kolkata.

Sources said that the number

of deaths in the triple train crash on Friday has also increased

from 288 to 295 but this could

not be confirmed as yet.

Most of the dead bodies too have been shifted to a facility in Bhubaneswar, said hospital administrators.

Three trains— Shalimar-Chennai Coromandel Express, Bengaluru-Howrah super fast and a goods train — were involved in the pile-up, now being described as one of India's worst train accidents.

The Coromandel Express crashed into a stationary goods train, derailing most of its coaches at around 7 pm on Friday. A few coaches of Coromandel toppled over the last few coaches of the Bengaluru-Howrah Express which was passing by at the same time.

Investigators are looking into possible human error, signal failure and other possible causes behind the three-train crash.

## 'Root cause of accident and people responsible for it have been identified', Railway Minister on Odisha train tragedy



BALASORE, Jun 4 (Agencies): Railway Minister Ashwini Vaishnaw who reviewed the restoration work at the Balasore triple train collision site on Sunday, said that the accident that claimed the lives of 288 passengers happened due to a change in electronic interlocking.

The Balasore train accident where two passenger trains and a goods carriage were involved claimed 288 lives so far while over 1,000 people sustained inju-

Ashwini Vaishnaw while speaking to ANI said that the commissioner of railway safety has investigated the matter and identified the cause of the incident and the people responsible for it.

"The commissioner of railway safety has investigated the matter and let the investigation report come but we have identified the cause of the incident and the people responsible for it... It happened due to a change in electronic interlocking," Vaishnaw told news

The Railway Minister further added the focus right now is on the restoration and the target is to finish the work by Wednesday morning.

"Prime Minister Narendra Modi

inspected the site yesterday. We will try to restore the track today. All bodies have been removed. Our target is to finish the restoration work by Wednesday morning so that trains can start running on this track," Vaishnaw added.

Earlier on Saturday, the Railways Ministry informed that the restoration work was ongoing at war footing in Odisha's Balasore.

In a tweet, the Ministry of Railways said that the officials are closely monitoring the restoration process at the accident site. "Restoration work is ongoing at Warfooting at the train accident site in Balasore, Odisha with 1000+ Manpower working tirelessly. At present, more than 7 Poclain Machines, 2 Accident Relief Trains, and 3-4 Railway and Road Cranes have been deployed for early restoration. Officials are closely monitoring the restoration process at the accident site," read the post on the official Twitter handle of the Railways ministry.

The Indian Air Force (IAF) deployed Mi-17 helicopters for the evacuation of the deceased and injured. According to the Eastern Command, IAF coordinated the rescue efforts with the civil administration and Indian Railways.

The preliminary report on the tragedy said the three-way accident involved Bengaluru-Howrah Superfast Express, the Coromandel Express and a goods train on three separate tracks at Bahanaga Bazar Station in Balasore district.

As many as 17 coaches of these two passenger trains were derailed and severely damaged in the accident on Friday evening.

## **IndiGo flight carrying Union** Minister makes emergency landing at Guwahati airport

GUWAHATI, Jun 4 (Agencies): Dibrugarh-bound IndiGo flight with Union Minister Rameshwar Teli on board experienced some mechanical issue and had to make an emergency landing at Lokpriya Gopinath Bordoloi International (LGBI) airport in Guwahati's Borjhar on Sunday.

Rameshwar Teli, the Union Minister for Petroleum and Natural Gas, Terash Gowalla, the MLA for Duliajan, and Prashanta Phukan, the MLA for Dibrugarh, were all on board flight 6E-2652 when it made the emergency landing at LGBI airport 12 minutes after take off.

According to sources, a team from the technical section was working to locate and resolve the problem.

In response to a reported technical



issue, IndiGo flight 6E2652 made an emergency landing at GNB International Airport, according to MLA Gowalla.

"It was travelling to Mohonbari (Dibrugarh) Airport. Along with MLA Prashanta Phukan and MoS Rameshwar Teli, I took the flight. By the grace of God, we are all safe right now," he added.

## Former NCB officer Sameer Wankhede claims of getting death threats in name of Dawood Ibrahim

MUMBAI, Jun 4 (Agencies): Former Narcotics Control Bureau (NCB) Mumbai zonal director Sameer Wankhede who was booked by the Central Bureau of Investigation (CBI) in alleged bribery probe in drugson-cruise case involving Bollywood actor Shah Rukh Khan's son Arvan Khan, has claimed that he and his family were receiving threats in the name of underworld don Dawood Ibrahim.

According to sources, Wankhede told Mumbai Police that he was receiving threats through fake Twitter



account and the threats were being made in the name of Dawood. He also apprised the police that who would be responsible if he or his family were attacked, said sources.

After receiving the

threat, sources said Wankhede informed senior officers of Mumbai Police.

Further investigation is underway

Sameer Wankhede has been booked by the CBI for allegedly demanding Rs 25 crore as a bribe for not framing Bollywood actor Shah Rukh Khan's son Aryan Khan in the drugs-oncruise case.

Earlier, the NCB sources said that Wankhede violated the conduct rules by producing conversations he had with actor Shah Rukh Khan over Aryan Khan's arrest in the drugs-on-cruise case

"Sameer Wankhade giving chats in the court is against the conduct rules of NCB. How an investigating officer can have such chats with the family of the accused?"

The NCB sources further claimed that Wankhede did not provide the phone through which he was chatting with Shahrukh Khan and along with this he also tried to scare a senior official of NCB when he took over the case.

sources in the NCB said

Wankhede approached the Bombay High Court against the CBI action against him, from where he was granted protection from arrest till May 22.

The High Court extends relief to Sameer Wankhede till June 8.

#### Railway Board Official Explains Sequence Of Events Leading To Odisha Crash

NEW DELHI, Jun 4 (Agencies): The Railway Board today detailed the events leading to the catastrophic triple train accident in Odisha's Balasore on Friday night that killed at least 288 people and left over 1.000 injured.

The Bahanaga Bazar station in Balasore, where the horrific crash took place, is a four-line station, the railways explained, adding that there are two main lines in the middle and two loop lines on either side. There were goods trains loaded with iron ore on both the loop lines.

The Shalimar-Chennai Central Coromandel Express was travelling from Chennai to Howrah and Bengaluru-Howrah Superfast Express was coming from Howrah. The signal was green on both the main lines. Coromandel Express was going at 128 kmph and the other passenger train was at a speed of 126 kmph. The limit is 130 kmph, hence none of them was overspeeding, Java Verma Sinha, Member, Operations & BD, Railway Board, said.

A signalling problem was detected, she said, adding that details will only emerge after further investigation. Ms Sinha said the reaction time was very less at such a high speed. "There was a signalling interference," she said, adding that



it would not be correct to call it a failure. The Railway Board repeatedly echoed the Railways Minister's assertion that these are iust initial findings, and nothing concrete can be said until the formal enquiry is over.

Ms Sinha repeatedly stressed that only one train, the Coromandel Express, and not three, as has been allegedly speculated, suffered an accident. "For some reason, that train met with an accident, and the engine and coach went over it," she said. It crashed into a goods train full of iron ore stationed on one of the loop lines, she explained, claiming that the goods train absorbed all the shock of the crash as it was very heavy. Coaches of the Coromandel Express got thrown off into the third track and rammed into a couple of coaches of the train approaching at high speed from Howrah, Ms Sinha said.

"There were Linke Hofmann Busch (LHB) coaches, they are very safe," she said, adding that damage was worse due to the iron ore.

## 2 teens swept away at Kozhikode beach, search launched

KOZHIKODE, Jun 4 (Agencies): Two teenagers went missing on Sunday from Kozhikode beach after going into the sea to retrieve their ball which had gone into the waters while playing there, police said.

The incident occurred between 7.30-8.00 AM, they said.

A group of teenagers were playing at the beach when their ball went into the sea and some of them went into the water to retrieve it. However, they appar-

ently got caught in the

discharged. Most of the injured patients are in stable condition, he added.

Currently, 382 passengers are now undergoing treatment in various government and private hospitals, the CM

informed. The Prime Minister thanked the chief minister for the prompt and efficient action during the crisis. "The Centre is ready to provide any kind of assistance if

required," the PM said.

The PM also praised the people of Odisha for the kind of support and timely help in this hour of crisis. The train crash, one of

the deadliest in India in recent times, happened near the Bahanaga Baazar station in Balasore district, about 250 km south of Kolkata and 170 km north of Bhubaneswar, around 7 pm on Friday. It is one of the deadliest train crashes in the history of the Indian Railways.

# China seeks dialogue, says clash with US would be 'unbearable disaster'

Chinese Defence Minister Li Shangfu said the world was big enough for China and the US to grow together

SINGAPORE, Jun 4 (Agencies): Chinese Defence Minister Li Shangfu told Asia's top security summit on Sunday that conflict with the United States would be an "unbearable disaster" but that his country sought dialogue over confrontation.

Speaking at the Shangri-La Dialogue in Singapore, Li said the world was big enough for China and the US to grow together - remarks made days after he refused to meet his US counterpart for direct talks.

"China and the US have different systems and are different in many other ways," he said in a speech that marked his first significant international address since he was named China's Minister of National Defence in March.

"However, this should not keep the two sides from seeking common ground and common interests to grow bilateral ties and deepen cooperation," he said. "It is undeniable that a severe conflict or confrontation between China and the US will be an unbearable disaster for the world."

Wearing the general's uniform of the People's Liberation Army, Li made his address on the 34th anniversary of the 1989 Tiananmen Square crackdown.

Ties between Washington and Beijing are badly strained over a range of issues, including democratically governed Taiwan, territorial disputes in the South China Sea and President Joe Biden's restrictions on semiconductor chip exports.

As delegates at the summit debated the risks of accidents and miscalculations amid those tensions, the US Navy said



a Chinese destroyer made "unsafe" manoeuvres near a US warship in the Taiwan Straits on Saturday, highlighting the dangers.

China's military criticised the United States and Canada for "deliberately provoking risk" after their warships staged a rare joint sailing through the sensitive strait.

US Indo-Pacific Command said US and Canadian ships were operating routinely and under high-seas freedoms.

Canadian defence minister Anita Anand said that Canada would continue to sail where international law allows, including the Strait, and that "actors in this region must engage responsibly".

In his speech, Li said China would not allow such freedom-of-navigation patrols by the United States and its allies to be "a pretext to exercise hegemony of navigation." After his remarks, regional scholars asked Li repeatedly about the incident as well as China's extensive maritime deployments in the disputed South China Sea. He did

not answer them directly, saying moves by countries outside the

region were raising tensions. Richard Marles, Australian deputy prime minister and defence minister, said his country's efforts to improve its military capabilities and presence in the region were aimed at "playing our part in contributing to the collective security of the Pacific and the maintenance of the rules-based order".

"It is a point I made that we have repeatedly made to the region and to the world since we announced the optimal pathway to acquiring nuclear powered submarine capability," he said on the sidelines of the security meeting, referring to the AUKUS pact with the United States and Britain.

US Secretary of Defense Lloyd Austin rebuked China in a speech at the summit on Saturday for refusing to hold military talks, leaving the superpowers deadlocked over their differ-

Austin said dialogue "is not a reward, but a necessity".
Li was more restrained in his

address, although he took thinly veiled digs at the United States, accusing "some countries" of intensifying an arms race and wilfully interfering in the internal affairs of others.

"A Cold War mentality is now resurgent, greatly increasing security risks," he said. "Mutual respect should prevail over bullying and hegemony."

Li, sanctioned by the United States in 2018 over weapons purchases from Russia, shook hands with Austin at a dinner on Friday but the two have not had a deeper discussion, despite repeated US demands for more military exchanges.

Alongside the speeches and panel discussions, senior intelligence officials from both sides attended a secret meeting of spy chiefs in Singapore on the fringes of the summit, Reuters reported on Sunday.

After Li's speech, retired veteran Chinese diplomat Cui Tiankai urged the United States to ease military deployments close to China in an act of "good faith" if high-level defence talks between the two superpowers are to resume.

Chong Ja Ian, a political scientist at the National University of Singapore, said that Li's approach and tone appeared gentler than that of Chinese positions stated at previous summits but that "the content was the same".

"It was a reflection of the distance between the US and the PRC, which also suggests that any hope that there will be some resolution is naive. US, PRC competition is here to stay," he

## 3 Chinese astronauts return home safely after a six month stint in space station



BEIJING/JIUQUAN, Jun 4 (Agencies): Three Chinese astronauts on Sunday returned safely to Earth on board the Shenzhou-15 manned spaceship after completing their six-month mission to build China's space station.

Shenzhou-15's return capsule carrying astronauts Fei Junlong, Deng Qingming and Zhang Lu, touched down at the Dongfeng landing site in north China's Inner Mongolia Autonomous Region at 6:33 am (Beijing Time), China Manned Space Agency (CMSA) said here.

The three completed their six-month space station mission, it announced.

The astronauts were in good shape, and the Shenzhou-15 manned mission was a success, the agency announced.

The three were replaced by three other astronauts, including China's first civilian who successfully flew to the space station on May

30.
The new set of astronauts will stay in the space station for five months.

Once ready, China will be the only country to own a space station as the International Space Station (ISS) of Russia is a collaborative project of several countries. The ISS station is also set to be decommissioned by 2030.

The significant feature of China's space station is its two robotic arms, especially the long one which can grab objects, including satellites from space.

"We have completed all the scheduled tasks and felt good after returning to the motherland," Fei, the mission commander, said.

Fei had also participated in the country's second crewed space mission, Shenzhou-6, in October 2005.

Deng, who finally got the chance to fly to space after 25 years of preparation, said: "I

always believe in the power of dreams and persistence. No matter how old I am, I feel so happy to be needed by the nation." "I'm now very excited, and when I was on the space station, I often watched through the window, trying to find my motherland and hometown," Xinhua news agency quoted Zhang, one of China's second batch of astronauts, as saying.

"We will adjust our bodies as soon as possible, go back into training, and be ready for space missions in the future," Zhang added.

The return capsule separated from Shenzhou-15's orbiting capsule at 5:42 am as per the flight procedure.

Soon after the return capsule landed, the ground search team arrived at the landing site. Medical personnel confirmed that the astronauts were in good health.

China launched the manned spaceship Shenzhou-15 on November 29, 2022.

The Shenzhou-15 crew, China's oldest mission crew in terms of average age, completed four extravehicular activities (EVAs), accomplishing the most EVAs of all Chinese crews to date.

The crew witnessed the completion of the country's space station construction, the Xinhua report said.

## Michigan wildfire burns more than 3 square miles, emergency evacuation suspended

GRAYLING TOWNSHIP, Jun 4 (Agencies): A wildfire in Michigan had burned more than 3 square miles (7.7 square km) by late Saturday but an emergency evacuation was halted, the state Department of Natural Resources said.

The Wilderness Trail Fire in Crawford County started around 1 pm about 4 miles (6.4 km) southeast of Grayling near Staley Lake in Grayling Township, the department said in a statement.

The wildfire moving west and southwest threatened multiple buildings and closed I-75 for most of the day, the statement said.

The fire had burned 2,400 acres (3.75 square miles) before midnight, natural resources department spokesperson Kathleen Lavey said in an email to news agency.

The evacuation order issued earlier was suspended late Saturday, Lavey said.

The Red Cross responded to assist those who were evacuated and a shelter was established at Beaver Creek



Township Hall.

Emergency personnel from the US Forest Service, federal Bureau of Land Management and Michigan police and fire departments continued working with the natural resources department to combat the fire with ground crews, airplanes, helicopters and heavy equipment, the statement said.

The cause of the wildfire was not immediately determined.

A temporary flight restriction was enacted for a 5-mile (8-km) perimeter around the fire below 5,000 feet (1,534 metres), the statement said.

Grayling Township is located about 150 miles (241 km) north of Lansing.

## Strike kills girl, injures 22 in Dnipro: Ukraine officials

KYIV, Jun 4 (Agencies): An airstrike hit a residential district in the central Ukrainian city of Dnipro, killing a two-year-old girl and injuring 22 others, officials said Sunday.

The attack, which President Volodymyr Zelensky blamed on Russia, partially destroyed a pair of two-storey buildings as well as 10 private homes, a shop and a gas pipeline, according to the region's governor.

Russian airstrikes over Ukraine have ratcheted up in recent weeks, as have incursions in the opposite direction.

Kyiv has for months said it is preparing a major counter-offensive against Moscow's occupation forces, hoping to reclaim territory lost since Russia invaded in February 2022.

After Saturday's strike, a girl's body was pulled from the wreckage.

age. "At night, a girl's body was



retrieved from under the rubble of a house in the Pidhorodnenska community," Serhiy Lysak, governor of the Dnipropetrovsk region, posted on Telegram early Sunday. "She just turned two." "22 people were injured, 5 of them were children," he added, having said earlier that three boys were in serious condition at the hospital. Zelensky blamed Russia for the strike, saying more people were

trapped beneath the wreckage. "The Russians attacked the city," Zelensky posted on Facebook on Saturday.

"Once again, Russia proves it is a terrorist state. The Russians will bear responsibility for everything committed against our state and people." Video posted by Zelensky showed rescue workers searching the destroyed building, to the sound of industrial drills.

In Kyiv, the head of the local military administration said the capital's air defences repelled several missiles and drones.

"According to preliminary information, not a single aerial target reached the capital," Serhiy Popko wrote on Telegram on Sunday.

"The air defence forces destroyed everything heading towards the city at long distance. For the second night in a row, the residents of Kyiv did not hear the sounds of explosions overhead."

On Saturday, Ukrainian shelling killed two people in Russia's Belgorod, a border region that has been hit by repeated attacks this week, the local governor said.

Belgorod villages have been targeted by unprecedented shelling, and the latest deaths bring the overall toll there to seven this week.

## Trump congratulates North Korea's 'Kim Jung Un', faces flak from own party

WASHINGTON, Jun 4 (Agencies): Former US President Donald Trump sparked controversy after he congratulated North Korean leader Kim Jong Un on the country's admission to the World Health Organization's executive board.

"Congratulations to Kim Jung Un!" the former president wrote on Truth Social, misspelling the North Korean leader's name while sharing news of the admission.

The post drew immediate condemnation from Republican presidential candidates and state party leaders.

Trump's former UN ambassador and 2024 opponent Nikki Haley took to Twitter and said, "Kim Jong Un starves his

own people.

It's a total farce that North

Korea has a leading role at the

World Health Organization".

Reacting to Trump's congratulatory message, Georgia Governor Brian Kemp said, "Taking our country back from Joe Biden does not start with congratulating North Korea's murderous dictator."

Trump's GOP rivals for the White House continued their criticism, including Florida Governor Ron DeSantis, who called the North Korean leader "a murderous dictator", reported The New York Post.

"Kim Jong Un is an enemy of America who threatens peace and freedom.

The fact that Trump delusionally believes otherwise makes him a useful idiot for China and unfit to be president," former GOP Maryland governor Larry Page also lashed out at Trump.



Trump famously enjoyed a "hot-and-cold relationship" with Kim during his one-term presidency.

The two leaders often traded insults, with Trump deriding Kim as "little Rocket Man" and the latter hitting back with epithets like "dotard" and "frightened dog".



However, after becoming the first sitting US president to visit the isolated communist country, Trump began warming up to and praising the 39-year-old autocrat.

In Trump's own words, he shares a "unique relationship and a special friendship" with Kim.


Dr Jong Min Pak this week became the first North Korean official to be appointed for a three-year term to the WHO's executive board.

#### 28K J&K Govt employees under I-T Dept scanner for claiming bogus refunds

(criminal conspiracy) and section 66D of the Information Technology Act (cheating by impersonation).

The department has also written to the Institute of Chartered Accountants of India (ICAI) seeking cancellation of the accused CA's licence, who runs a consultancy firm in Rajbagh area here and whom it considers the "prime accused" in the case, the sources said.

Alarmed by this development, the department ran a fresh check in November last year for the ITRs filed by salaried employees working in J-K and found similar instances of bogus claims of deduction made by them to seek refunds.

The employees, as per the sources, belong to the power development, health, tourism, education, bank, universities apart from personnel of the police and the Central Armed Police Forces (CAPFs) that are deployed in the UT for law and order and counter-terrorism duties.

The I-T Principal Commissioner wrote to the heads of these organisations in March informing them that there is a provision to correct or update such returns by filing an ITR-U and avoid getting into legal trouble. Over 9,000 employees filed their ITR-U in J-K by this March end and the department collected additional tax of more than Rs 56

crore, the sources said.

An ITR-U enables a taxpayer to update their returns (ITRs) using the e-filing portal anytime within two years from the end of the relevant assessment year.

However, many employees did not avail this opportunity of filing ITR-U and now they will be issued penalty notices and in some cases police FIRs will be filed like the one filed against the 405 people, the sources said.

According to an estimate, over 28,000 government employees have fraudulently claimed refunds for 2020-21 and 2021-22 and the department will soon initiate action against them after sending them notices for scrutiny of their ITRs, the sources said.

According to the law, if a person evades tax or mis-declares their income in the ITR they can be prosecuted and charge sheeted by the tax department under section 276C of the I-T Act that entails a rigorous imprisonment ranging from six months to seven years on a case-to-case basis.

In March 2021, Mehbooba and her mother were denied passports after the Jammu and Kashmir Police had cited an "adverse report".

He added that India "historically has given so much not only to the geographical boundaries of your country but what the Indian community historically has given to the globe is just remarkable and has yet to

truly be reflected in historical proportions. "All of the great Nobel peace prize winners have basically borrowed from the rich history of your society," he said, adding that they have drawn inspiration from the ancient Vedas and early writings.

Earlier in the day, Gandhi "had a thoughtprovoking fireside chat" with leading thinkers of New York at Roosevelt House, home of former US President, Franklin D Roosevelt.

Gandhi said the members of the diaspora in the US are "our ambassadors" and have shown America and the rest of the world "what it means to be Indian." He said there is a fight going on back home and a similar fight also in America about two different visions for India. "One vision which is our vision – accepts everybody, embraces everybody, respects everybody, loves everybody, and wants everybody to be a part of the future of our country regardless of their religion, their community, their caste, their language.

"We are fighting our friends in the BJP... they have a very limited view of our country," he said.

# Develop digital platform for customers' consent for promotional calls, sms: Trai directs service providers

Under prevalent system, consent is obtained and maintained by various principal entities such as banks, other financial institutions, insurance companies, trading companies, business entities, real estate companies, etc

NEW DELHI, Jun 4 (Agencies): In order to curb the menace of pesky calls and sms, telecom regulator Trai has directed service providers to develop a unified digital platform in two months to seek, maintain and revoke customers' consent for promotional calls and messages.

In the first phase, only subscribers will be able to initiate the process to register their consent for receiving promotional calls and sms, and later, business entities will be able to reach out to customers to seek their consent to receive promotional messages, Telecom Regulatory Authority of India (Trai) said in a statement.

"Trai has now issued a direction to all the access providers to develop and deploy the Digital Consent Acquisition (DCA) facility for creating a unified platform and process to register customers' consent digitally across all service providers and principal entities," Trai said.

At present, there is no unified system to show consent of cus-



tomers for getting promotional messages.

"Considering the volume of work involved, Trai has allocated two months' time to develop such facilities by all Access Providers and thereafter implement it in a phased manner. This direction has been issued by Trai under its Telecom Commercial Communication Customer Preference Regulations, 2018," Trai said.

Under the prevalent system, consent is obtained and main-

tained by the various principal entities such as banks, other financial institutions, insurance companies, trading companies, business entities, real estate

companies etc.
The absence of a unified digital platform makes it impossible for the telecom operators to check veracity of consents.

"The DCA process shall have facility to seek, maintain and revoke the consent of customers, as per the processes envisaged under TCCCP Regulation 2018. The consent data collected will be shared on the Digital Ledger Platform (DLT) for scrubbing by all access providers," Trai said.

Access providers, which include telecom players like Reliance Jio, Bharti Airtel, Vodafone Idea, have been further directed to use a common short code starting with 127 for sending consent seeking messages.

"The purpose, scope of consent and principal entity or brand name shall be mentioned clearly in the consent seeking message sent through the short code," the statement said.

Only whitelisted or approved web or app links, callback numbers etc will be allowed to be used in the consent seeking messages, it said.

"Further, access providers shall develop an SMS, IVR (interactive voice response), online facility to register unwillingness of the customers to receive any consent seeking messages initiated by any principal entity," the statement added.

## Twitter executive responsible for content safety resigns after Elon Musk criticism

SAN FRANCISCO, Jun 4 (Agencies): A top Twitter executive responsible for safety and content moderation has left the company, her departure coming soon after owner Elon Musk publicly complained about the platform's handling of posts about transgender topics.

The departure pointed to a fresh wave of turmoil among key officials at Twitter since Musk took over last year.

Ella Irwin, Twitter's head of trust and safety, confirmed her resignation in a pair of tweets. She did not say in the message why she was leaving, but her departure came shortly after Musk criticised Twitter's handling of tweets about a conservative media company's documentary that questions transgender medical treatment for children and teens. Musk was responding to complaints by Jeremy Boreing, co-CEO of the media company, the Daily Wire.

Boreing said in tweets and retweets of conservative commentators that Twitter was suppressing the movie by flagging posts about it as hate speech and keeping the movie off lists of trending topics.

Boreing tweeted that Twitter cancelled a deal to premiere "What is a Woman?" for free on the platform "because of two instances of misgendering." Twitter rules prohibit intentionally referring to transgender individuals with the wrong gender or name. "This was a mistake by many people at Twitter. It is definitely allowed," Musk tweeted back.

"Whether or not you agree with using someone's preferred pronouns, not

doing so is at most rude and certainly breaks no laws." Irwin tweeted Friday that "one or two people noticed" she left the company the day before, and she noted speculation about whether she was fired or quit. She teased that she would post 24 tweets to explain her departure. Then she posted that she was just kidding about the long narrative. "In all seriousness, I did resign but this has been a once in a lifetime experience and I'm so thankful to have worked with this amazing team of passionate, creative and hardworking people. Will be cheering you all and Twitter as you go!" Next to Musk, Irwin had been the most prominent voice of the company's ever-changing content policies in recent months.

Twitter has struggled to bring back advertisers turned off by Musk's drastic changes and loosening of rules against hate speech since he bought Twitter for \$44 billion in October.

Twitter also has an incoming CEO, Linda Yaccarino, known for decades of media and advertising industry experience, but she hasn't started yet.

Twitter has been in turmoil including mass layoffs and voluntary departures since the billionaire Tesla owner bought the San Francisco company and took it private.

The company's head of trust and safety left shortly after the takeover, and turnover in the top ranks has continued.

Last month, Twitter fired two more top managers.

### Yes or no to non-sugar sweeteners

NEW DELHI, Jun 4 (Agencies): The World Health Organisation has released new guidelines on non-sugar sweeteners (NSS), recommending against their use to control body weight or reduce the risk of noncommunicable diseases. The recommendation does not apply to diabetics and personal hygiene products containing NSS. Endocrinologist Dr R Muralidharan explains the facts and myths about NSS. What are non-sugar

Commonly called nonnutritive sweeteners or artificial sweeteners, these are low or nocalorie alternatives to the common table sugar (sucrose). Many times sweeter, these are high intensity sweeteners as they can mimic the taste of sugar at much less quantities and convey a sweet taste to the brain more strongly. Saccharin, aspartame, sucralose and steviol glycosides are commonly available.

sweeteners?

How are they zero or low calorie?

Most of these NSSs do not get absorbed in the digestive system and pass through the body with little modification. Is there a difference between chemical and plant-based NSSs?

Other than the source, there is no difference. The chemical structures and the intensity of sweetness vary. The closeness in taste to sucrose and stability at higher temperatures (for adding to hot beverages and sugar-free sweets) are the qualities that dictate our choice. There is no evidence that plant-based sweeteners are not harmful or less harmful.

What research says

There have been many studies exploring whether NSSs increase body weight after long-term use and raise the risk of cardiovascular disease. Studies in rats with saccharin showed an increase in appetite. People using NSSs may develop a false sense of security and overeat. Avoid giving aspartame to children and pregnant women.

Some studies also have shown that NSSs adversely affect the balance of the normal beneficial gut bacteria, leading to adverse metabolic effects and weight gain.

Options for health &

Eat a balanced diet and exercise. Avoid more absorbable carbohydrates like white rice. Opt for high-fibre foods, whole cereals, legumes, fruits and green vegetables. Avoid use of refined flour, carbonated drinks, concentrated fruit juices, foods with trans fat, processed and fast food.

Exotic diet plans, like low or no carbohydrate diets, work in the short term but cause rebound weight gain.

Even for diabetics, restrict the use of NSSs. The craving for sweets can be satisfied by having fruits.

Are jaggery and honey better?

There's a marginal difference in the calorie value and glycemic index (GI) of jaggery, shakkar (powdered jaggery), desi khand (brown sugar) and honey.

Brown sugar is derived by adding molasses to white sugar. Jaggery, though a good source of minerals, should be avoided by diabetics. Honey has a low Gl as it has more fructose (natural fruit sugar) and 15 per cent water. Still, use in moderation. Diabetics should eat dates, too, in moderation.

## The much cheaper generic medicines have emerged as a game-changer in healthcare, but quality control is key

NEW DELHI, Jun 4 (Agencies): In the realm of medicine, consensus is rare, but through persistent research and systematic synthesis of available data, a broad agreement can often be achieved. However, one topic that has remained controversial and unresolved is the debate between branded and generic medicines.

For decades, fish farmers have used chemicals like formalin and potassium permanganate to prevent infections. However, when antibiotics such as chloramphenicol and tetracycline became available, these became the preferred options. So, what does this have to do with the debate between generic and branded medicines?

Branded medications are developed and marketed by pharmaceutical companies under exclusive patent protection, while generic drugs offer cheaper alternatives with the same active ingredient, dosage form, safety, strength, route of administration, quality, performance characteristics, and intended use.

The issue of high prices for brand-name medicines has long been a concern. Governments and elected officials worldwide have addressed this matter, leading to increased competition from generic manufacturers. However, brand-name pharmaceutical companies often resist this competition.

In 1949, Parke-Davis, a USbased company, introduced Chloromycetin (branded chloramphenicol), a highly effective drug for treating typhoid. It became a blockbuster, generating annual sales exceeding \$100 million. Several generic versions were ready to enter the market once the patent expired in 1966. However, the company requested the USFDA (regulator) not to allow generics without clinical trial data, citing potential differences in raw materials and manufacturing processes that could affect the effectiveness of generic chloramphenicol compared to Chloromycetin.

Public opinion supported the need for generics, leading to their approval. Generic chloramphenicol was significantly cheaper, leading to its increased use. A dealer who had been using Chloromycetin for his fish decided to switch to generic chloramphenicol. To his surprise, the generic capsule did not dissolve as expected (failed dissolution test in today's parlance).

This observation led to fur-



ther tests conducted by Parke-Davis and later by the FDA. The results revealed that three generic versions of chloramphenicol were inadequately absorbed into the bloodstream, a critical finding considering the life-saving nature of the medication. Consequently, the FDA suspended the authorisation of generic chloramphenicol, granting the company extra time of market exclusivity.

This event led to enactment of the Hatch-Waxman Act in 1984. The legislation established regulatory requirements for generic drug approval, including the need for bioequivalence studies comparing the generic version to the branded product.

The Indian perspective

Many differences exist between branded and generic drugs, but in principle, a generic drug should work as well as a branded one. In India, we also see branded generics — different companies market their generics under their own brand names.

Struggling with high medicine prices, India passed the Drugs & Cosmetics Act in 1970, allowing domestic companies to manufacture drugs using different processes. This led to the growth of the generic drug industry. Originator companies, often multinational corporations, attempted to prevent generics from entering the market. A significant milestone was achieved when Cipla provided affordable anti-AIDS medicines to Africa, despite resistance from Big Pharma. Efforts to counter Indian generic drug-makers would ultimately lead India to shift to the "product-patent" regime under the WTO-GATT-TRIPS Agreement in 1995.

One argument against generic medicines is the perception of inferior quality. However, generics must demonstrate equivalence through clinical studies before entering the market. In India, the regulator (CDSCO) evaluates the quality, safety and efficacy of generics by review-

ing data on the active ingredient, manufacturing processes, formulation, and stability. The advantages of using generic medicines are many, and cost savings of up to 80 per cent have been reported.

While generic medigenerally safe and effective, concerns have been raised by the European Medicines Agency (EMA) about bioequivalence studies conducted by certain Contract Research Organisations (CROs), including those in India. Similarly, in 2021, the USFDA notified that studies conducted by certain CROs were deemed "not acceptable" due to concerns about data integrity. While Europe suspended the marketing authorisations of the products, the USFDA categorised them as "BX", meaning they are approved but not recommended as automatic substitutes for the brand-name drugs — a much softer penalty.

Similar issues have been raised in the past, accusing the USFDA of being too lenient with drug companies, failing to detect problems during inspections, withholding information about problematic drugs, and not banning such drugs. Building trust is of utmost importance. Quality control plays a vital role in the regulatory landscape.

An analysis of the past six months of CDSCO's findings on drugs of substandard quality reveals that about 4.5 per cent of medicines, all of which are generics, failed to meet one or more criteria. Several reasons contribute to these failures, including problems with assay, dissolution, sterility, and the presence of toxins. It remains unclear if branded products have been subjected to this testing by the regulator, as they do not appear in the lists published by the CDSCO.

A recent PGI study has shown that adequate drug levels of an antifungal drug itraconazole were achieved in only 29 per cent of patients receiving generic itraconazole, and in 73 per cent of those who received branded medicine. What's important to note is that even the branded product is not 100 per cent successful — such is the complexity of drug-patient interaction along with the multifaceted inter-play of various other factors.

Shortcuts taken by some organisations serve to enhance profits. However, the question of profiteering from the suffering of fellow human beings is no longer even debated, although examples exist where discoverers of significant drugs (e.g. insulin) have willingly given up patents for the betterment of society.

India not only has a large domestic market for generic drugs, valued at around \$25 billion, but also plays a significant role as a global supplier, with a substantial share in the \$400 billion global market. In 2008, the government launched the Jan Aushadhi scheme, aiming to provide quality generic medicines. In 2016, the Medical Council of India (now NMC) recommended that physicians prescribe generic drugs, which are typically 30-80 per cent cheaper than their brand-name counterparts.

While generic drugs are g

While generic drugs are generally considered safe and effective alternatives to branded drugs, there are certain situations where it may be advisable to avoid switching from a branded drug. It is important to note that healthcare providers make individualised decisions based on their clinical judgment and patient-specific factors. Open communication between healthcare providers and patients is crucial in determining the appropriateness of switching to generic drugs.

India, with its large and diverse population, faces unique challenges in providing accessible and affordable medications to its citizens. Generic drugs have emerged as a game-changer in the healthcare system. The CDSCO mandates adherence to Good Manufacturing Practices (GMP) for all manufacturers and conducts regular inspections. All stakeholders, including regulators, manufacturers, prescribers, civil society, and patient advocacy groups, must work together to achieve the goal of providing good-quality generic drugs to patients.

On paper, Indian laws are at par with the developed nations of the world. In implementation, there is scope for improvement.

# Government bans 14 fixed dose combination drugs, cites they may involve risk to people

NEW DELHI, Jun 4 (Agencies): The government has banned 14 fixed dose combination drugs, including Nimesulide and Paracetamol dispersible tablets and Chlopheniramine Maleate and Codeine syrup, citing there is "no therapeutic justification" for these medicines and that they may involve "risk" to people.

The Union Health Ministry issued a notification in this regard. The banned drugs included those used for treating common infections, cough and fever—combinations such as Nimesulide + Paracetamol dispersible tablets, Chlopheniramine Maleate + Codeine Syrup, Pholcodine +Promethazine, Amoxicillin + Bromhexine and Bromhexine + Dextromethorphan + Ammonium Chloride + Menthol, Paracetamol + Bromhexine+ Phenylephrine + Chlorpheniramine + Guaiphenesin and Salbutamol + Bromhexine. The move comes following recommendations by an expert committee.

The expert committee said that there is "no therapeutic justification for this FDC (fixed dose combination) and the FDC may involve risk to human beings. Hence, in the larger public interest, it is

necessary to prohibit the manufacture, sale or distribution of this FDC under section 26 A of the Drugs and Cosmetics Act, 1940. In view of the above, any kind of regulation or restriction to allow for any use in patients is not justifiable."

"And whereas, on the basis of the rec-

ommendations of the Expert Committee and the Drugs Technical Advisory Board, the Central Government is satisfied that it is necessary and expedient in public interest to regulate by way of prohibition the manufacture for sale, sale and distribution for human use of the said drug in the country," the notification stated. FDC drugs are those which contain a combination of two or more active pharmaceutical ingredients (APIs) in a fixed ratio. In 2016, the government had announced the ban on the manufacture, sale and distribution of 344 drug combinations after an expert panel, set up at the behest of the Supreme Court had stated they were being sold to patients without scientific data and the order was challenged by the manufacturers in court.

The currently banned 14 FDCs are part of those 344 drug combinations.

## "Whatever Has Happened, Good Or Bad...": Ajinkya Rahane Opens Up On Team India Return

LONDON, Jun 4 (Agencies): Back in India colours after nearly 18 months, senior batter Ajinkya Rahane doesn't want to have any "regrets" for the time lost and would like to bat in the upcoming World Test Championship final against Australia with the same "intent" like he did in the justconcluded IPL. "Coming back after 18-19 months, whatever has happened, good or bad, I don't want to think about my past. I just want to start afresh and keep doing whatever I have been doing," Rahane told BCCI. TV on the sidelines of India's training session.

"Personally enjoyed playing for CSK as I have been batting well throughout the season, even before IPL. I had a very good domestic season and I felt good. So this comeback was a bit emotional for me." Rahane, who was a part of CSK's fifth IPL title-winning side, has already received a lot of praise for his attacking batting and improved strike-rate in T20 cricket, and especially the 27-ball 61 against Mumbai Indians showed a shift in his intent

"I want to bat with the same mindset and show same intent



that I showed before coming here in IPL and Ranji Trophy. I would not like to think about format whether it is T20 or Tests. The way I am batting now, I don't want to complicate things and the more I keep it simple, better it is for me," the veteran of 82 Tests and 4,931 runs said.

The man, who led India to the most talked-about series triumph in Australia, back in 2021, also praised Rohit Sharma for leading the team admirably for the better part of this WTC cycle.

"I thought culture in team now is really good. Rohit is handling

the team really well and I am sure Rahul bhai is also handling the team really well. That helps as well and atmosphere is really good. Whatever I am seeing right now is that everyone is enjoying each other's company," he said.

Rahane thanked his family and friends for the support he got during his time away from the national team.

"It was (an) emotional moment for me. When I got dropped, the support I got from my family was massive and dream was to play for India and that was massive. Playing for India matters a lot for me and I worked hard on my fitness and went back to domestic cricket." "Thanks to BCCI and selectors and when I went back to domestic cricket, the goal was to play for India -- be it Ranji Trophy and Syed Mushtaq Ali Trophy or practice session, for me, every day that I was waking up, it was all about thinking that I can play for India again.

"What made my comeback possible was enjoying each and every moment, be it success or failure, and having no regrets. Learning from every individual in Mumbai Ranji team. You have to grow as a cricketer every single day, learning process shouldnt stop," he said.

Playing in England is challenging, feels Rahane, who had scored a match-winning hundred in a Test match at Lord's back in 2014.

"It's all about mindset and reading the situation well, staying in (the) moment and playing it session by session. In England, you just don't look at the pitch but also keep an eye on the weather. In England, you never feel that you are in even if you are batting on 70," he said.

## "Probably Owe It To Myself": David Warner Reveals Tentative Test Retirement Date



LONDON, Jun 4 (Agencies): Australian cricket team star David Warner stunned everyone by announcing that the Test series against Pakistan in January 2024 can be his final outing in red-ball cricket. Speaking to reporters ahead of the World Test Championship (WTC) Final against India starting June 7, Warner said that he wants to play his final Test match at the Sydney Cricket Ground (SCG) against Pakistan next year. Australia will play West Indies right after the Pakistan series but Warner made it clear that he will not be a part of that series and he wants to focus more on white-ball cricket.

"You've got to score runs," Warner told reporters, according to cricket.com.au.

When it comes to taking retirement from international cricket as a whole, Warner hinted at the 2024 World Cup to be his final outing. However, he will be playing franchise cricket around the world.

Earlier this year, Warner revealed that he and opening partner Usman Khawaja have decided to not retire at the same time.

"For us it's about not leaving this team with a big hole. I know through those five-year transition periods when a lot of the greats left, they're big holes to fill with the amount of games you play. We always talk about games played and how much that means into a team's performance and perspective with experience. You can't fill that void," he said.

## Man City beats Man United 2-1 in FA Cup final to complete second leg of treble bid

LONDON, Jun 4 (Agencies): Manchester City's mission to win a treble of major trophies stayed on track after beating Manchester United 2-1 in the FA Cup final, with the first of Ilkay Gundogan's two goals coming after a record 13 seconds.

With City having already retained the Premier League, now only a firstever Champions League title stands between Pep Guardiola's team and immortality in English soccer.

Gundogan, City's captain, scored the quickest goal in an FA Cup final — timed by British broadcaster BBC at 12.91 seconds — only for United midfielder Bruno Fernandes to convert a 33rd-minute penalty against the run of play after Jack Grealish was adjudged to have handled the ball.

If Gundogan's opener was probably his best goal for City, his 51st-minute winning goal might be one of his scrappiest as he met a cross from Kevin De Bruyne from a free kick with a left-foot volley that bobbled between two United defenders and past goalkeeper David

United was looking to protect its proud status as the only team to win the league-FA Cup-European Cup treble, in 1999, but needs a favor from Inter Milan in the Champions League final in

Istanbul on June 10.
It was the 142nd FA Cup final and the first between the two Manchester clubs, with Prince William and United great David Beckham among those in attendance at England's national stadium.

City's class of 2023 became the 13th team in English soccer history to clinch a league-and-cup double while the Abu Dhabi-controlled team won a 16th trophy since 2011, when City ended its 35-year title drought by winning the FA Cup.

-A Cup.
It was the 13th trophy in Guardiola's

seven years at the club and the 34th of his managerial career.

The latest haul of trophies comes in the same season that the club was charged by the Premier League with more than 100 breaches of financial rules. City denies the charges.

After the final whistle, City's players ran from the halfway line and jumped for joy in front of their fans waving blue and white flags.

Right at the heart of the celebrations was Gundogan, who might leave City after the Champions League final because he is out of contract. He would depart as a club great.

In City's final game of last season, he scored two late goals to complete a turnaround from 2-0 down against Aston Villa and clinch the Premier League with a 3-2 win.

The Germany midfielder has been arguably City's star performer in the final stretch of this season, too, and gave City that stunning start after taking the kickoff himself.

He passed the ball back to goalkeeper Stefan Ortega, who booted it forward for Erling Haaland to flick on. United defender Victor Lindelof could only partially clear to Gundogan, who volleyed in right-footed from the edge of the area.

United was looking to clinch a double of domestic trophies in Erik ten Hag's first year in charge, having won the League Cup in February, but more importantly ensure its class of 1999's legacy was preserved.

Ten Hag's team was dominated, though, until the last 10 minutes when substitute Alejandro Garnacho caused havoc down United's left wing. He instigated a chance in stoppage time that saw Raphael Varane bundle the ball onto the top of the crossbar before City cleared.

Ireland were effectively nine wickets down when Fionn Hand became Tongue's fifth victim and his exit meant England were able to extend the afternoon session by 30 minutes in a bid to force victory before tea. England were denied an

innings win, however, when

tailender Graham Hume hit two fours off successive deliveries from part-time off-spinner Joe Root -- shots greeted by huge cheers from a sun-drenched crowd.

With McBrine 85 not out at tea, the question was whether Hume could help get his partner to a hundred and a coveted place on the Lord's honours board

But McBrine was left stranded when Hume was bowled by Broad, leading the attack in the absence of the rested James Anderson and Ollie Robinson.

Zak Crawley then made short work of a victory target of 11 with three fours in four balls from Adair.

"I thought Ireland came out and showed grit and determination," said England captain Stokes at the presentation ceremony.

"It (the pitch) got flatter as it went on. Trying to take the game on in our own way allowed us to potentially bowl them out without batting again."

Ireland skipper Andrew Balbirnie praised a side with minimal first-class experience for the resilience they showed Saturday. "The character is not in doubt, we've got a tough group," he said. "Test cricket is very raw to us, yesterday was a tough day but to come back and make England bat again was a small win."

He added: "We're learning on the job and we've got to learn quickly. Hopefully next time we'll show the benefit."

Victory meant England had now won 11 of their 13 Tests under Stokes -- who didn't bat or bowl in this match -- and coach Brendon McCullum.

Stokes, battling a longstanding knee injury, neither batted nor bowled against Ireland.

England want to protect the allrounder's fitness ahead of the Ashes opener at Edgbaston on June 16, while still benefitting from his leadership skills.

But there was a worrying moment when he appeared to jar his leg when catching Curtis Campher on Saturday.

"I just landed on it quite awkwardly," Stokes told the BBC.

He added: "I wouldn't have bowled in this match anyway, unless everyone else went

"I'm happy with it, so I'll just keep building it up now before Edgbaston. I am definitely on course to bowl in the first Test."

England's win was built on an imposing first-innings total of 524-4 declared featuring player of the match Ollie Pope's 205 and Ben Duckett's 182.

"Batting at three is a big role in the team but I feel good about my game and nothing needs to change because it's an Ashes series," said player-of-thematch Pope.

## French Open: Unstoppable Iga Swiatek cruises to Round 4, Coco Gauff ends 16-year-old Mira Andreeva's fairytale

While Iga Swiatek lived up to the top billing with a 6-0, 6-0 decimation of Xinyu Wang in the 3rd round, Coco Gauff survived a scare against 16-year-old Russian wunderkind Mirra Andreeva in the third round

PARIS, Jun 4 (Agencies): World No. 1 Iga Swiatek continued her progress in her title defence at the French Open as she stormed into the women's singles fourth round. Swiatek double bageled (6-0, 6-0) here opponent Xinyu Wang, World No. 80 from China who was featuring in her maiden Grand Slam third-round match.

Iga Swiatek needed just 52 minutes at the Court Philippe-Chatrier

to get the sensational victory as the tournament organisers scheduled a doubles match at the iconic court to make use of the time before the night session biggie between Alexander Zverev and Frances Tiafoe.

Iga Swiatek, the top seed, has been in sensational form, having not dropped a set so far in the clay-court Grand Slam. After brushing aside injury concerns in the lead-up to the French Open, Swiatek has secured as many as 4 bagels in her run to the second week of the tournament.

Iga Swiatek has her first 6-0 6-0 scoreline at a Grand Slam event. It's the fourth in the women's singles at Roland-Garros in the past decade and the first since Caroline Wozniacki defeated Francoise Abanda in 2017, according to Opta Ace

Iga Swiatek will face the winner of anoth-



er 3rd-round match between Canada's Bianca Andreescu and Lesia Tsurenko. The Polish star seems unstoppable at the moment, making light work of her opponents one after the other. MIRRA'S FAIRYTALE ENDS!

Meanwhile, World No. 6 Coco Gauff prevailed in a 3-set battle in the third

round against 16-yearold Russian Wunderkind Mirra Andreeva in the third round.

Coco Gauff lost the opening set in a tie-breaker, but she raced through the next two sets to clinch a 6-7 (5), 6-1, 6-1 in 2 hours and 3 minutes. Coco Gauff, who reached the final last year, is slowly but surely hitting peak form at Roland Garros. Gauff along with Aryna Sabalenka are the major threats for the all-con-

quering Iga Swiatek in women's singles at the French Open this year.

The 16-year-old Andreeva, who burst onto the scene with two victories over top-20 players at the Madrid Open, looked in top form in the first round as she showed the hunger to win and put relentless pressure on Coco Gauff.

Gauff went up 5-4 and 30-0 but got broken again before a poor shot at the net in the tiebreak gifted Andreeva

the chance to take the advantage in the match.
