BSF guns down Pak drone near IB in Asr

CHANDIGARH, June 8 (Agencies): Border Security Force (BSF) personnel have shot down a Pakistani drone near the international border in Amritsar after it sneaked into the Indian territory, a spokesperson said on Thursday.

In a separate development, troops of the border guarding force seized more than two kilograms of heroin airdropped by another Pakistani drone in Tarn Taran district, the official said.

Around 9 pm on Wednesday, BSF personnel heard the buzzing sound of an unmanned aerial vehicle near Bhaini Rajputana village in Amritsar and opened fire on it, the spokesperson of the force said.

A joint search operation by the BSF and the Punjab Police was carried out, during which the drone was found in a damaged condition on a field adjacent to the Rajatal-Bharopal-Daoke tri-junction on the outskirts of the village, he said.

Modi Govt overhauled India's health infrastructure: Shah

NEW DELHI, Jun 8 (Agencies): Union Home Minister Amit Shah on Thursday said in the last nine years, the Modi government has overhauled the country's health infrastructure from primary to tertiary level while ensuring free treatment of up to Rs 5 lakh for the poor.

In tweets, Shah said under the leadership of Prime Minister Narendra Modi, India has embraced a future where healthcare is no longer a privilege.

"In #9YearsOfHealth-ForAll' India overhauled its health infrastructure from primary to tertiary level while ensuring free treatment up to ₹5 lakh for the poor," he said.

The home minister said the prime minister has harnessed the transformative power of technology making



healthcare accessible.

"Whether it is Covid Vaccination, telemedicine, hospital registration, or accessing health records, healthcare now is at the fingertips of citizens," he said.

The Modi government's major initiative for healthcare is implementation of the Ayushman Bharat scheme under which those eligible will have a defined benefit cover of Rs 5 lakh per family per year, officials said.

This cover takes care of almost all secondary care and most of tertiary care procedures.

To ensure that nobody is left out, especially women, children and elderly, there is no cap on family size and age in the scheme.

The benefit cover also includes pre- and posthospitalisation expenses and all pre-existing conditions are covered from day one of the policy, the officials said.

A defined transport allowance per hospitalisation is also paid to the beneficiary under the

Incest Rape Case: Jammu Crime Branch arrests two absconding siblings

JAMMU, Jun 8: The Economic Offences Wing of Jammu Crime Branch Jammu have arrested absconding siblings wanted in incest rape case.

The Crime Branch Spokesman on Thursday said that the Economic Offences Wing of Crime Branch Jammu arrested absconding criminal - Bittu Singh and Kewal Krishan both sons of Bali Ram R/o Nagali, Tehsil Basohli, District Kathua from Delhi and Surjan Mangyar, Bani, District Kathua in case FIR No. 30/2017 U/S 341, 376, 506/ RPC P/S Basohli. Both the accused are involved in incest rape and had been absconding for a long period of time to evade their arrest. They have been arrested after well coordinated and integrated efforts put in by a vigilant team of CB Jammu constituted for this purpose.

The case owes it origin to the complaint lodged by one Bali Ram S/O



Dewan Chand R/O Village Nagali Tehsil Basohli of District Kathua with Police Station Basohli on allegation of rape. The case being heinous and that of immense Public importance in nature was transferred to Crime Branch Jammu (Now Economic Offences Wing) for indepth Investigation. After conducting the investigation substantial evidence was collected including FSL opinion and allegations levelled against the accused among 02 other co-accused persons were proved. ACB recommends FIR in fake Medical **Bill Scam of Doda**

DODA, Jun 8: Unaccountability and lawlessness in Education Department Doda is costing Govt. exchequer in multiple dividends. The scam of drawl of medical reimbursement bill on fake vouchers of over Rs. 17 lakhs by then Zonal Education Officer Ghat of Doda in favour of wife and father a ReT teacher Shakir Hussain Beg,s on of Wazir Beg, resident of Udyanpur, Doda is its live proof. Sources reveal a complaint was received by Anti Corruption Bureau Jammu regarding drawl of medical bills on fake vouchers projected to be of SKIMS etc on the part of Shakir Hussain Beg ReT teacher UPS Dulyoge, Zone Ghat of Doda in the name of his wife and father during 2018-19 in criminal connivance with then Incharge ZEO Ghat Mohd Ayaz Mughal DEPO Doda.

The vouchers were forged by Mohd Aslam Balwan teacher retired who happens to be the brother in law of Shakir Hussain.

Accordingly enquiry was initiated by ACB Jammu vide verification No: DKR-11 of 2022.

After verification of record and state-

ments, Central Anti-Corruption Bureau Jammu established the scam and submitted to ADGP Jammu Zonal Police Headquarter Jammu requesting for FIR and initiation of legal action against the involved persons vide No: ACB/E-182713-Veri- DKR-11/2022-4622-24 dated: 31-03-2023 but till date after passage of more than 02 months nothing is known about the action taken for registration of FIR on the request of the Central Anti-Corruption Bureau Jammu and Kashmir.

It is pertinent to mention here that Shakir Hussain who managed drawl of over 17 lakhs as Medical Bill in the name of his wife and father has forged two Service Books in his name with variation in date of Birth 1-5-1963 and 1-5-1966 and his service book does not reflects any leave availed by him for the treatment of his wife and father in Srinagar Jammu except 02 months medical leave he obtained for his own treatment, reveals the record.

Delay in action is encouraging accused mafia involved in frauds and forgeries. Public demands early FIR and recovery of amount.

Close aide of Pro-Khalistan terrorists arrested: NIA

NEW DELHI, Jun 8 (Agencies): The National Investigation Agency (NIA) has arrested a close aide of two foreign-based operatives of the banned Khalistan Tiger Force (KTF) — Canada-based Arshdeep Singh alias "Arsh Dala" and Philippinesbased Manpreet Singh alias "Peeta".

Gagandeep Singh alias "Miti", who was nabbed by the NIA on Tuesday during raids in Haryana and Punjab, is the fifth person to be arrested as part of NIA's sustained crackdown on the organised crime

syndicate and network being operated by the two terrorists in Punjab, Haryana, Delhi and Rajasthan, a spokesperson of the federal agency

The official said Singh was arrested in a case related to the terror activities of chiefs and members of proscribed pro-Khalistan terrorist organizations. The case was registered suo-moto by the NIA on August 20 last year.

The NIA had earlier arrested Lucky Khokhar alias "Denis" from Ganganagar in February, Jassa Singh of Moga on May 18, as well as Amritpal Singh alias Ammy of Moga and Amrik Singh of Firozpur, who were picked up from the IGI Airport, New Delhi on May 19.

While Peeta has been living in the Philippines, Dala, currently based in Canada, was declared a Proclaimed Offender by the NIA Special Court, Mohali, on Monday in a priest murder conspiracy

According to NIA investigations, Singh had been working for Dala and Peeta and was supporting



Rajesh appeals LG to solve Issues of Hydraulic wing contractors

TOP NEWS REPORT

JAMMU, Jun 8: National Democratic Party Indian (NDPI) J&K UT Chief Rajesh Gupta listened the problems faced by the contractors of Hydraulic wing in Jammu today. Gupta said, according to the contractors they are facing a big problem by not able to participate in e-tendering due to non functional portal sites.

Even after several attempts made by groups representing Jammu contractors to bring the miscommunication and discrepancies in the system to the attention of the authorities, believes that all the efforts have so far been in vain said, Gupta, exasperatedly.

NDPI leader further said that contractors have paid their card renewal yearly fees



in advance even then they are facing the same problem. Gupta added the government has been ignoring them after taking the yearly fees. They are a community on the operations of which a government functions. Without them, there would be no one to build and establish all the schools, hospitals, infrastructure that the politicians promise the public. But they have been grossly ignored by the administration.

NDPI president said that one cannot hide behind the smokescreen

of 'anti-corruption' and delay processes. Issues must be solved on priority. I vouch for the contractors as I know their problems are real." There are around 10,000 contractors in Hydraulic wing and all are sitting idle since two months. Gupta further added not only this administration is also not serious. Whenever the tender is floated on online portal the server stops functioning. Resulting both parties suffered government exchequer go waste due to repeatedly advertising for tender invitations in newspapers and contractors suffered for not getting work.

Rajesh Gupta appeals LG Manoj Sinha to give instructions to the concerned authorities to sort out the contractors genuine issues on priority and at the earliest.

While modernising infra, let's focus on upkeep too

odernisation is not a bad word. In a fast-changing and ruthlessly competitive world, a country needs to modernise its infrastructure to survive and succeed. That said, one question leaps out -- what does modernisation of infrastructure mean in India in 2023?

The question is particularly relevant in the aftermath of the horrific crash recently involving three trains in Balasore, Odisha.

A country's transport network is its cardiovascular system -- the critical structure that enables the massive and continuous flow of people and goods through its arteries. This structure -- roads, highways, bridges, railways, ports, airports -- is about mobility. It is good for the economy, good for the citizens.

Unquestionably, it needs to be modernised to keep up with changing needs. But how much of the "modernisation" narrative in the political discourse is about maintenance and safety? While there is a relentless focus on the newest, the fastest, the grandest, how much attention is typically paid to sustaining what already exists, so that "safe travel" is just that.

As I write, the horrific train crash in Balasore with its gut-wrenching trail of deaths and devastation, is still on the front pages. It is also global news. At least 288 people have died. Many among the dead remain unidentified. Nearly 1,000 people have been injured. Many may become permanently disabled. Those who died were not rich. By now, everyone knows the basic facts. There were three trains -- the Coromandel Express, which derailed. Then, it crashed into a stationary goods train before being hit by another train -- the BengaluruHowrah Superfast Express, which was coming from another line. We also know that the Kavach Train Collision Avoidance System has been deployed only on 1,455 km of railway tracks, or about 2.13 per cent of India's 68,000-km railway network. It was absent on the route where the accident took place.

Till date, hundreds of thousands of words have been used to describe the grief, anxiety and anger over the wreck. There are theories and counter-theories, including one about possible "sabotage" swirling in the social media. Official investigations are going on. Initial reports point to a signalling error/malfunction as the probable cause. Now, the Central Bureau of Investigation has been roped in to probe the crash. Railway minister Ashwini Vaishnaw, who is also in charge of two other ministries, has announced compensation for the injured passengers and the families of those who were killed. The Narendra Modi government says that those responsible will be punished.

But as ordinary citizens who have a vital stake in safe travel, we must continue asking questions about the overall safety management system even when Balasore ceases to be "news". Because there is no getting away from the bald truth -- we do not talk and do enough about safety systems and basic accountability.

Undoubtedly, India's rail network, among the largest in the world, and built during the British colonial era, needs a major overhaul. But overhaul or modernisation is not just about new projects. It must take on board regular maintenance along with staff training and upgradation of their skills.

If investigations into the Balasore crash ultimately pin it down to human error at the lowest level, we need to ask a fundamental ques-

tion about why there is such poor perception of the precise risks that jugaad or shortcuts entail? Modernisation cannot co-exist with jugaad.

Our political class focuses on new, shiny projects. There is scant attention to how the old ones are faring. Report after report which point out maintenance and safety deficits are ignored.

In all the discussions about infrastructure, how many times did one hear any top political leader from the ruling side focus on the issues flagged by a 2022 report by the Comptroller and Auditor General of India? The 102-page report has been centre-stage ever since the Balasore tragedy. What prevented the political leadership from focusing as much on the rail safety issues flagged by the CAG as on Vande Bharat, the new high-speed trains? It is not either/or. It could have been both.

The 102-page CAG report, which focused on derailment in the Indian Railways for the period 2017-18 to 2020-21, points out that there were shortfalls ranging from 30-100 per cent in inspections by Track Recording Cars required to assess geometrical and structural conditions of railway tracks. It also says that the "audit analysis of the quantum of scheduled inspections conducted during 2019-20 and 2020-21 revealed considerable shortfalls in the various types of inspections". And that in "63 per cent cases, the 'inquiry reports' were not submitted to the accepting authority within the prescribed time schedule. In 49 per cent cases, there was a delay in the acceptance of the reports by the authori-

Significantly, the overall expenditure on Priority-I works from RRSK (Rashtriya Rail Sanraksha Kosh) showed a declining trend from 81.55 per cent in 2017-18 to 73.76 per cent

in 2019-20, and the allotment of funds for Track Renewal works has declined too from 2018-19 to 2019-20. Rashtriya Rail Sanraksha Kosh was created in 2017-18 with a corpus of Rs. 1 lakh crore over a period of five years for critical safety related works. The funds allocated to track renewal works were also not fully utilised, says the CAG report. Out of 1127 derailments during 2017-21, 289 derailments (26 per cent) were linked to track renewals.

And it is not just the Railways. The week in which the Balasore crash happened also witnessed a collision between a bus carrying injured survivors from the Balasore accident site and a van in Medinipur in West Bengal. There is more. An under-construction bridge in Bihar collapsed, for the second time. Bizarrely, while Bihar chief minister Nitish Kumar blamed "poor quality of work" for the collapse and pledged to act against those responsible, deputy chief minister Tejashwi Yadav described it as deliberate demolition due to significant design flaws detected by experts.

There have been train crashes earlier. Bridges have collapsed too. Remember Morbi?

The operative word is accountability -- then and now.

As we inch towards 2024 and the next general election, no surprise that even a deadly train wreck is fodder for political jousts. Which brings me to the issue of promises by politicians and public expectations when the country is investing millions to modernise its transport networks.

The public must not get bogged down by narratives which view train crashes, road accidents and bridge collapses solely through the prism of individual culpability. We need to insist on safety being the highest priority as the infrastructure modernisation saga unfolds. At stake is our lives.

The Changing Nature of Tribal Education

ribal people have played a big role in protecting the climate and saving the forests. A nostalgic folk festival is being celebrated in the tribal areas in the year of Amrit Mahotsav of Independence, because now the days have come to change the tone and status of tribal schools. Bangladesh, Pakistan and South Africa Similarly, the Madhya Pradesh government has also decided to hand over fifty-nine government schools in the tribal-dominated areas of the state to private hands for running them in public-private partnership (PPP) mode. This decision is important in many respects. It is estimated that like Madhya Pradesh, sooner or later the form of education of tribals will emerge in PPP form across the country. The question is whether this decision is a reflection of India's new education policy, that is, is there a future tribal education strategy? It is noteworthy that PPP in Gujarat and Odisha The format has been adopted long back. So what is the dawn of a new era of PPP based tribal education? The PPP format does not at all mean that private entities are handed over the ownership rights of school land, houses or other resources. The issue is not even the mere management, but the performance of the services. It cannot be denied that under the guise of PPP format, the failures of the government go behind the scenes. The same has been seen in Odisha. In fact, this form is not an idea, but a There is an ideology which promotes privatization as a means while reducing responsibilities. It is expected that by increasing the number of schools, the right to education can be fulfilled cent percent. There is widespread despair about education in the rural and forest areas of Madhya Pradesh. It may be recalled that in Jhabua district of the state, the news related to girls leaving studies and leaving in search of work came in

the headlines recently. In the advertising claims, repeated attempts are made to show that the development of the tribes Madhya Pradesh government is completely honest, huge amount is spent every year on welfare measures. But the condition of the results is well known. The system of the government has become dilapidated somewhere. The government says the initial contract will be for seven years to measure the progress of students from classes six to twelfth. Today, the sadlifeless atmosphere of the tribal school, the medium of education of tribals and the duality of accepting it, the situation of not getting education in their mother tongue raises many questions. operation or management of tribal school shad to be handed over to someone, then what was the problem in doing phased transfer as a sample? Why has the state government, which celebrates the implementation of PESA, shied away from including such transfers to gram sabhas? Tribal means the scope of understanding of Scheduled Tribe

is large. The tribal people have played a major role in protecting the climate and forests of the state. Does the government not trust the Gram Sabha? Then why in the PESA law there was talk of giving the Gram Sabha the right to protect and conserve forests? If the State Government has given the Gram Sabha the responsibility of forming Community Forest Management Committees, then what is the big deal for them to run schools? When gram sabhas in tribal areas are themselves making plans for their local development, then why schools cannot be managed? Then this decision related to education will have its own implications.can refuse? In Madhya Pradesh, a good atmosphere is being told about the tribals. Ashrams, hostels, schools, girls' education complexes are being run for tribal students across the state. Many types of incentive schemes are being operated for the training of competitive examinations. Skill development centers are also being operated for self-employment. Scholarship is also given by the state government to the tribal students for getting education. Sports complex for boys and girls in different districts has also been created. The rates of interest charged by the moneylenders have also been controlled now. If the government is so ready for the interests of the tribals, then why was there a need for PPP format? Should it be assumed that Madhya Pradesh is also not getting the expected results of tribal development on the lines of the country? The positive changes that have been claimed in the state, are they not an indication that even though there has been dynamism in the tribal society, it has not yet presented any example of achievements. your Successfully democracy, when the tribal class is below the poverty line, then why not consider all the achievements of the government as incomplete and half-baked. The PPP model of education has been reported to be successful

among tribal and urban populations in Bangladesh, Pakistan and South Africa. There is also the example of the Western Cape where schools and academies are both state funded but managed by the private sector and they often serve pupils from disadvantaged communities. Under these PPP agreements, the government retains overall responsibility for the school., but entrusts the day-to-day operation and management of the school to a number of partners, including private sector companies, donors and non-governmental organizations. There the project aimed to bring additional management skills and innovation to the public school system through non-profit partnerships, in order to improve the quality of teaching and learning in the no-fee schools. Tribals are people who believe in government and order. For the development of the tribes of Madhya Pradesh, it is necessary that each of their problems should be taken up on a national level. should be assessed as a problem and policies should be made keeping in mind the local conditions. It has to be kept in mind that no policy can be beneficial to all tribes unless it is aimed at solving local problems. The education system can be strengthened by forming self-help groups in villages or by associating youth from management background with these schools. The problem is that the responsibility of the welfare and upliftment of the tribals has been given to those people who have hardly ever interacted with the tribals. Th yearsix months have been spent together. The question is whether the PPP format is being implemented keeping in mind the tribal sentiments-beliefs and needs?

"The Govt has adopted different means of harassment against the daily wagers and does not listen to their genuine demands i.e., regularization, regularly release their monthly wages and implementation of Minimum Wage Act in J&K," he said, adding that the issue of daily wagers should be considered on humanitarian ground and they should be regularized without further delay.

Kundal questioned the LG administration for its inability to frame a proper policy for the regularization of the daily wagers and warned that if the Government continue to harass them for one reason or other, the daily wagers will be forced to intensify their agitation and AAP Party will leave no stone unturned to support them and join their protests in future.


The LGBTQIA+ community celebrates pride Month, here's look at the true representation of the community in reel and real

Every year June is celebrated as Pride Month. The LGBTQ-IA+ community celebrates it by organising parades, campaigns, talks, meetings to sensitize people about their movement.

We talk to members and supporters of the queer community from fashion, film and digital industry to know whether they see a change in the representation of the community globally.

Even though same-sex relationships are no longer illegal in India, a sizeable population still views them negatively. Also, the right to get married is still being fought in the Supreme Court. People find it extremely difficult to 'come out', especially if they are a part of the Indian society, where one holds their traditions and values dearly and accords them utmost importance.

Dhananjay Chauhan, the first transgender student of Panjab University, Chandigarh, is quite active in promoting LGBTQIA+ cause in tricity. She organised a pride walk in university in February. While a National Awardwinning documentary, Admitted, has been made on her life, she still holds an opinion that their representation may have increased in films or series, it's not always done with the right intent. She explains, "We have to go a long way to get fair representation and erase all that hatred and prejudices that many have about us. On such serious issue, in the name of awareness, family comedies are being made to make the topic palatable for all. There are a lot of misconceptions about us and it cannot be told in mere character representation in big ensemble cast of film or series. People call



us chakkas, hijadas and bacha chorr, they think that we all are sex workers."

But at the same time, Dhananjay acknowledges that June is no less than a moment of pride for her and others from the community. "My heart goes out for everybody who initiated this movement and fought for the rights or are still fighting," she beams.

On queer fashion

While fashion and entertainment industries contributed their bit, social media helped to spread awareness. Rahul Lakhanpal, a digital content creator and LGBTQIA+ ally, says, "The community undoubtedly contributes to the creation of more diverse and inclusive fashion environments, enabling a wider representation and acceptance of many aesthetics. It's important to remember that the queer community as a whole has a wide range of likes and their own distinct sense of style and fashion preferences." On the other hand, Coco Balwho is an out and proud gay, looks down upon brands reaching out to queer community only in the month of June. He says, "When Pride Month is near, only then you'll see most brands promoting pride because it's a great marketing strategy and now everything is business. But I am just very glad that there's a whole month in this universe for

our community." Filmy gyan

There has been a significant increase in the representation of the LGBTQIA+ community in cinema over the years. Coco Balluchi comments "Since childhood, we've seen gay characters in TV serials and movies in which they're used for 'comedy', they're girlish or are made to do some mischief and have a role that is restricted to just thus. Now, their representation is still few, but still, internationally, there is quality content, and it's inspirational. In India they should depict the seriousness of this issue is what I feel."

Movies like Chandigarh Kare Aashiqui and Shubh Mangal Zyada Saavdhan in Bollywood were recent movies that high-lighted the LGBTQIA+ community.

Influencers, the new activists Instagram influencers have become the new activists of queer community. Roshni Kumar is such an activist. Her content is primarily queer-centric, she focuses on it through her fashion and awareness posts. Male influencers like Karan Sareen, Vishnu Kaushal, Siddharth Batra and Ankush Bahuguna have often promoted queer fashion. Last year, a Delhi-based photographer Sumit Verma encouraged LGBTQ couples to came forward and break the taboo. He offered free wedding photo shoots for samesex couples.

The fourth season of Emily in Paris was initially set to start in late summer or early fall in the French capital that gives the show its name, but filming has been delayed by two months due to the writers' strike.

That could stretch longer if WGA members remain on the picket line. Streaming giant Netflix has declined to comment. The plan is

still to start shooting by the end of fall, according to a source close to the streamer.

Netflix announced the renewal of Darren Star's Emmy-nominated romantic comedy in January 2022. Season 3 dropped on the streamer on December 21 following a massive premiere event in Paris, which lured crowds of overjoyed fans and was attended by Star and

the entire cast, including Lily Collins, Ashley Park, Philippine Leroy-Beaulieu, Kate Walsh, Camille Razat, Lucas Bravo, Lucien Laviscount (who wore a shiny purple suit), Bruno Gouery and Samuel Arnold.

Philippine Leroy-Beaulieu, who plays Emily's boss, suggested that the next season of Emily in Paris could be affected by the writers' strike on the red carpet of Kering's Women in Motion gala dinner during the Cannes Film Festival. When asked if plans for Season 3 were put on hold, Leroy-Beaulieu said, "A little bit. We're waiting for it to be resolved. We'll see how it settles!'

Season 3 had a queer storyline, a love triangle and a cliffhanger involving a pregnancy. Within six days of launching, it garnered 117.6 million hours viewed and landed in the Top 10 in 93 countries.

Emily in Paris is one of the several shows with screenwriters in the guild that are due to film in France and are being impacted by the strike.

Another anticipated series that's partly set in Paris and has been delayed is Etoile, a ballet drama created by Amy Sherman-Palladino and Daniel Palladino, the team behind The Marvelous Mrs. Maisel.

Why Karan Johar did not direct Irrfan Khan? Filmmaker opens up

The fear of being a "blotch" in late actor Irrfan Khan's otherwise "beauteous career graph" kept filmmaker Irr Karan Johar from directing the "very sexy" star. In an interview with

In an interview with journalist-author Shubhra Gupta for her book "Irrfan: A Life in Movies", Johar admitted that he did not want to be the filmmaker who gave an actor of Irrfan's calibre a "substandard mainstream film".

"He (Irrfan) was way stronger than anything I could have ever offered him. I never arrived at a screenplay, a film, a thought or an idea that would warrant the presence of the magnitude that Irrfan Khan brought to the table.

"That's the reason I've never had a film with Irrfan because I've never wanted to be that filmmaker that gave him a substandard mainstream film. I didn't want to be the blotch in his otherwise beauteous career graph," said Johar, as quoted in the book.

The director remembered being stunned by Irrfan's performance in "Maqbool" and telling that to the film's director Vishal Bhardwaj.

"Because no other actor, I think, has a combination of the various characteristics that Irrfan brought to the table: charisma, cinema intellect, presence, performance, all in equal measure.

"You can slot many other actors into boxes. You can't generalize Irrfan Khan, you can't put him into a box. It's simply because he was so unique and individualistic," Johar said.

The filmmaker, known for directing blockbusters like "Kuch Kuch Hota Hai", "Kabhi Khushi Kabhie Gham", "My Name Is Khan" and "Ae Dil Hai Mushkil", said he did not have the ability to look beyond big stars and spectacle movies in the beginning of his career.

"So while Irrfan Khan had this trajectory that began properly in 1998, and he had all those movies that were breaking through, I was busy making these big spectacle entertainers; I didn't have the bandwidth or understanding of how to accommodate the magic and magnitude of Irrfan," he

explained.
Ironically, after Irrfan's death at least "five

scripts" landed on Johar's table that the director believed would have been perfect for the "Paan Singh Tomar" actor.

"There are at least five scripts that landed on my table after he passed away that were screaming Irrfan Khan. I just feel terrible. And you know why those scripts came to my table now? Because now is the time that cinema is ready for that material and that material was all Irrfan Khan," he explained.

The 51-year-old filmmaker counts not directing Irrfan and Sridevi among the two regrets of his life.

Recalling how he and his friend, fellow director Zoya Akhtar, agreed that there was "no other actor like Irrfan Khan", Johar also spoke about the late actor's little discussed but "tremendous sex appeal".

"It's very important to say that women found him sexy; he had tremendous sex appeal. You know, always, it's the actors who do the more cerebral, the more intellectual, the more critic-friendly cinema that you don't associate with sex appeal, somehow. I think Irrfan Khan

was very sexy, and it was a huge icing on his terrific talent cake," he said.

Taking solace in the fact that he has at least one of Irrfan's movies, "The Lunchbox", on his roster—even if he was just a presenter on that film—Johar, one of India's most bankable producer-director, said to him the actor's "real breakthrough moment commercially" came with the 2017 film "Hindi Medium".

"'Hindi Medium' did business of about seventy crores purely on account of a simple, high-concept, small film, and Irrfan did it entirely on his own... That's when I think everyone woke up to the fact that Irrfan Khan is a numbers man as well.

"Up to the point, everything else – Life in a... Metro and everything that you said – had a great actor, great idea, he worked very well. But when 'Hindi Medium' came out and it did the numbers, that's when the industry woke up to his commercial possibilities," he added.

Unfortunately, it was as late as that, Johar said.
"Irrfan: A Life in Movies", published by Pan Macmillan India, hit the stands on Wednes-

The book offers a compelling account of Irrfan's life and achievements — starting from his days at the NSD to his nearly a decade-long stint in television and his gradual ascent in the

film industry.

BHUBANESHWAR (ODISHA), Jun 8 (Agencies): New generation ballistic missile 'Agni Prime' was successfully flight-tested by the Defence Research and Development Organisation (DRDO).

Madhya Pradesh: Rescue op under way for 3rd day to save girl who fell into borewell, robotic experts join efforts

(Agencies): Rescue agencies were still making hectic efforts for the third day to save a two-and-a-half yearold girl who fell into a borewell in Madhya Pradesh's Sehore district, an official said on Thursday.

A team of robotic experts also joined the operation on Thursday morning to rescue the girl, who fell into the 300-feet deep borewell in a field at Mungavali village on Tuesday afternoon, he said.

Oxygen was being supplied to the girl in the borewell through a pipe, district administration officials said.

With more than 46 hours passing away since the incident, the task to pull the girl out of the borewell has become more difficult as she has slipped further down and got stuck at a



depth of nearly 100 feet, as per officials.

A three-member robotic rescue team from Gujarat reached the site on Thursday morning to join the operation, the official said.

"We have lowered a robot into the borewell to collect information and we are processing the data by scanning it to know the child's condition. After processing the data, we will decide

the next course of action on how to rescue the girl from the borewell," the robotic team in-charge Mahesh Arya told reporters at the site.

The girl, named Srishti, fell into the borewell at around 1 pm on Tuesday and since then efforts have been on to rescue her.

She was initially stuck at the depth of about 40 feet in the borewell, but due to vibrations caused

by machines engaged in the rescue operation, she has slipped further down to about 100 feet, making the task more difficult, Madhya Pradesh Chief Minister Shivraj Singh Chouhan said on Wednesday.

An Army team also joined the rescue operation, while teams of the National Disaster Response Force (NDRF) and the State Disaster Emergency Response Force (SDERF) have already been working to rescue the girl, officials said.

As many as 12 earthmoving and poclain machines are also currently engaged in the rescue operation, they said.

CM Chouhan and a team of officials are in touch with the district authorities to supervise the rescue operation, they said.

Mumbai Man Kills Live-In Partner, Chops Up **Body, Boils In Cooker: Police**

MUMBAI, Jun 8 (Agencies): Decomposing body parts carried out of a home near Mumbai in plastic bags and bedsheets brought back memories of the grisly Shraddha Walkar murder case, as police arrested a man for killing his live-in partner and chopping up her corpse and even boiling some pieces in a pressure cooker.

The victim, identified as 32-year-old Saraswati Vaidya, was found in her apartment on the seventh floor of a residential building in Geeta Nagar area of Mira Road, late Wednesday, according to a senior official at the Naya Nagar police station.

Vaidya was living with her partner, Manoj Sane, 56, in a live-in relationship for the past three years, the official said. The couple had been residing in the rented flat during that

Police were alerted to the gruesome scene by residents of the building, who complained of an unpleasant odour wafting from Vaidya

and Sane's apartment, the official said. Upon arrival, officers discovered Vaidya's



decomposed body, which had been severed into multiple pieces. "A preliminary investigation revealed that the woman was brutally killed," Deputy Commissioner of Police (DCP) of Mumbai, Jayant Bajbale, said.

Authorities have since arrested Sane over the horrifying incident. The potential motive for the crime is yet to be disclosed by inves-

The investigation is currently ongoing, as officials work to piece together the circumstances leading up to Vaidya's violent death.

The police said according to Sane, Vidya died by suicide.

"The situation is deeply troubling, and we are committed to finding justice for Ms Vaidya," Mr Bajbale said. "We urge the public to come forward with any information they may have to aid in our investigation."

The incident has uncanny similarities to the Shraddha Walkar murder case that stunned the country last year.

Walkar was a 27-year-old call centre employee who was strangled by her livein partner Aaftab Poonawala, who then chopped her body into 35 pieces and disposed of them in a forest over 18 days. He also stored some of the body parts in a fridge and charred her face to hide her identity.

Post a comment The case came to light only six months later, when Walkar's father filed a missing persons complaint after failing to contact her for months. Aaftab Poonawala was arrested

HOUSTON, Jun 8 (Agencies): The air quality of New York city has deteriorated as smoke from the Canadian wildfires poured into the US East Coast and Midwest, with data showing that the pollution level in the metropolitan city was highest among significant cities worldwide, even surpassing New Delhi.

Situation was such that the picturesque and renowned skyline of New York City became invisible on Wednesday behind a hazy veil of smoke from the Canadian wildfires flowing into the region.

According to IQAir, New York City had the highest levels of air pollution among significant cities worldwide on Wednesday morning, surpassing even New Delhi.

Recently in a global air quality report, India was ranked eighth on the list, with Chad, Iraq, Pakistan, Bahrain and Bangladesh being the five most polluted countries in 2022.

The weather forecasters expect hazy weather to continue in New York through the rest of the week

AccuWeather forecasters expect "very unhealthy" levels to continue through the rest of the week.

The air quality in New York City was listed as "unhealthy" as of Wednesday morning.

The haze across the city reduced visibility. Many weather stations in the Big Apple reported visibility of less than a mile.

A ground stop was issued at Newark Liberty International Airport in New Jersey and LaGuardia Airport in New York City on Wednesday afternoon due to low visibility from the smoke and haze, according to the Federal aviation Administration.

Some of the worst air quality levels were found in Delaware. Wilmington, Delaware, which is located about 24 miles southwest of Philadelphia, spiked an air quality index of 199, which is considered very unhealthy.

Photos and videos shared on social media captured the eerie glow of the sun as it rose above some of the most famous skyscrapers in the Big Apple.

The unusually poor air quality in the Northeast is "extremely rare in modern times," according to AccuWeather Chief Meteorologist Jonathan Porter, and is like the levels of air pollution frequently observed in other parts of the world without the same air pollution standards and restrictions, including China, India, Southeast Asia, and even into South America

"As bad as the smoke and air pollution was on Tuesday, the air quality can be even worse at times across parts of the Northeast on Wednesday and poor air quality is expected to linger in some areas into the weekend," Porter said.

Porter recommended that if one must spend time outside, to use a high-quality N95 or KN95 but "not offer any outdoor activities on Wednesday".

New Jersey officials urged residents to limit their time outside due to the poor air quality.

For those who must work outside, the state recommended that people wear an N95 mask, several schools in New Jersey cancelled recess and other outdoor activities, due to the air quality across the state.

"People should frequently check the AccuWeather exclusive Plume Labs air quality maps and limit their time outdoors," said Porter, who recommended that if one must spend time outside, to use a high-quality N95 or KN95 mask.

"Sleeping with the windows closed and using an air conditioner or fan can be helpful," he said, adding that a HEPA filter can reduce the number of these small particles in the air.

AccuWeather forecasters say the wildfire season in Canada got off to a devastatingly early

As of early June, more than 8 million acres of land have been scorched by wildfires across Canada, according to the Canadian Interagency Forest Fire Centre (CIFFC). The CIFFC was tracking more than 400 active fires across the nation Monday.

This alert means air pollution concentration in the region will be unhealthy for people with heart or lung disease, children, and adults over 65. The alert warned these people to limit their time outdoors.

"Exposure to elevated levels of fine particles such as wood smoke can increase the likelihood of respiratory symptoms in sensitive individuals and aggravate heart or lung disease," the National Weather Service alert

'Will evaluate each case': **Canadian PM Trudeau on Indian students** facing deportation

Says victims of fraud will have an opportunity to present evidence to support their case



OTTAWA, Jun 8 (Agencies): Assuring the 700 Indian students, who are facing deportation from Canada over fake admission letters, Prime Minister Justin Trudeau said they will evaluate each case and the victims of fraud will have an opportunity to demonstrate their situation and present evidence to support their

The remarks came as hundreds of Indian students, mostly from Punjab, have been taking on to the streets in Canada saying they were cheated by their immigration consultation agency in India that provided them fake documents, of which they were unaware of.

"We are deeply aware of cases of international students facing removal orders over fraudulent college acceptance letters. To be clear, our focus is on identifying the culprits not penalising the victims," Trudeau said during a Parliament debate on Wednesday.

"Victims of fraud will have an opportunity to demonstrate their situation and present evidence to support their case," the Prime Minister said, while responding to Sikh-origin NDP leader Jagmeet Singh's concerns on the state of defrauded students, who are set to be deported his month.

"We recognise the immense contributions international students bring to our country, and we remain committed to supporting victims of fraud as we evaluate each case," Trudeau said.

Singh's NDP is reportedly preparing to introduce a unanimous consent motion in Parliament to cancel removal orders to support these students while also facilitating a pathway to permanent residency for them.

It will also assist students who could face deportation due to bogus enrollment offers.

"So my question is... will the Prime Minister stay the deportation of all these students that are impacted and provide a pathway to permanent residency for these students?" Singh asked Trudeau, presenting the case of victims.

According to the Canadian Border Service Agency (CBSA), more than 700 Indian students are reportedly facing deportation after finding that their educational institution's admission offer letters were fake.

Most of these students had come to the country to study in 2018 and 2019.

The fraud was discovered when the students applied for permanent residency in Canada.

Brijesh Mishra, a Jalandhar-based agent, was responsible for providing fake admission letters, charging students thousands of dollars.

He charged more than Rs 16 lakh per student in addition to admission fees claiming to get them to prestigious colleges.

Meanwhile, students have been continuing with their sit-ins since May 29 at Airport Road of Mississauga, outside the CBSA's head office, holding banners saying, 'Unite against deportation', 'Stop deportation' and 'We want justice'.

Flooding Due To Dam Breach **Extends Over 600 Square Kilometres: Ukraine**

KYIV, Jun 8 (Agencies): Flooding from the Kakhovka dam breach extends over 600 square kilometres on the Ukrainian-held right bank of the Dnipro River and the Russian-held left bank, the region's governor said on Thursday.

"The average level of flooding is 5.61 metres. 600 square kilometres of the Kherson region are under water, of which 32 percent is the right bank and 68 percent is the left bank," Kherson region governor Oleksandr Prokudin said on social media.

"The average level of flooding is 5.61 metres,"



he said, adding that "despite the danger and heavy Russian shelling, the evacuation from the flooded area continues".

Prokudin said the situation in Russian-held areas was "extremely difficult".

The state emergency service of Ukraine said 1,995 people had been evacuated from flooded areas, including 103 children.

Many more have fled of their own accord.

The state emergency service said that on the Ukrainian-held side of the river "a total of 20 settlements and 2,629 houses" had been flood-

The floods have submerged parts of the regional capital, Kher-

37 Chinese Warplanes Breach Taiwan's **Defence Zone**

TAIPEI, Jun 8 (Agencies): More than 30 Chinese warplanes entered Taiwan's air defence zone over the course of about six hours, the island's defence ministry said Thursday, a sharp ramp-up in single-day incursions by China's military.

China claims self-ruled Taiwan as its territory and has vowed to take it one day -- by force if necessary.

In recent years, Beijing has intensified aerial incursions into the island's air defence identification zone -nearly doubling the air sorties in 2022 compared to the year before. Taiwan's Ministry of National Defence

spokesman Sun Li-fang announced Thursday that from 5 am local time (2100 GMT), "a total of 37 Chinese military aircrafts" entered Taiwan's southwestern ADIZ

"Some continued... towards the Western Pacific for long-range reconnaissance training," Sun said at around 11 am.

While not the largest number of incursions



this year -- that would be 45 sorties on April 9 -- Thursday's surge occurred over a much more compressed time frame. Taiwan's ADIZ is much

larger than its airspace, overlaps with part of China's ADIZ and even includes some of the mainland.

Taiwan's military is "monitoring the situation closely", the ministry said on Twitter, adding that patrol planes, naval vessels and land-based missile systems have been dispatched in response.

They did not clarify if the incursions were ongoing.

Analysts say China's increased probing of Taiwan's defence zone is part of wider "greyzone" tactics that keep the island pressured.

The incursions came a day after the United States, the Philippines and Japan completed their first-ever joint coastguard drills in the flashpoint South China Sea -- which Beijing claims almost entirely.

A surge in warplanes and naval exercises by China's military around Taiwan usually coincides with Taipei making diplomatic engagements with other countries.

China lashes out at any diplomatic action that appears to treat Taiwan as a sovereign nation and has reacted with growing assertiveness to any joint military exercises around the island or visits by Western politicians.

In April, Beijing conducted three days of military exercises simulating a blockade of the island in response to Republican House Speaker Kevin McCarthy and Taiwan's leader Tsai Ing-wen meeting in California.

Australia to ban swastika, SS sign citing rise of far-right

SYDNEY, Jun 8 (Agencies): Australia said on Thursday it would introduce laws to Parliament next week banning public displays and sales of Nazi hate symbols, citing a rise in far-right activities at home.

The swastika, one of the most recognisable symbols of Nazi propaganda, and the insignia of Schutzstaffel (SS), the paramilitary wing of the Nazi party, will be outlawed to be used as flags and armbands or printed on clothes.

"We've seen, very sadly, a rise in people displaying these vile symbols, which are symbols that have no place

in Australia, they should be repugnant," Federal Attorney-General Mark Dreyfus told Channel Seven television. "Regrettably, we have

seen violence associated with some of the public events that these people have put on." A ban on the Nazi salute will not be added to the federal law, the attorneygeneral said. He said state and territory governments can enforce that ban in a more effective wav.

"State governments have got more responsibility for what you might call street offences, and our law goes to public display and includes online ... the salute

we've left for the states." Australia's spy agency has been warning farright groups were on the rise in Australia and that they had become more organised and visible.

In March, a group of neo-Nazis clashed with transgender rights protesters in Melbourne and was seen raising their arms in a Nazi salute near the state parliament building. Last year, a soccer fan who gave the salute at the Australia Cup final was banned for life from any games sanctioned by

Phillipines Issues Alert As Mount Mayon **Volcano Spews Ash** There are "increased chances of

MANILA, Jun 8 (Agencies): Philippine scientists said that a "hazardous eruption" of a volcano in the archipelago could be days or weeks away, and urged the evacuation of nearby residents from their homes.

Hundreds of families living around Mount Mayon in central Albay province are expected to be moved to safer areas after the Philippine Institute of Volcanology and Seismology raised the alarm. Mayon, a near-perfect cone located about 330 kilometres (205 miles) southeast of the capital Manila, is considered one of the

active volcanoes. The seismology agency said it observed three fast-moving avalanches of volcanic ash, rock and gases, known as pyroclastic density currents (PDCs), on Mayon's slopes on Thursday.

lava flows and hazardous PDCs... and of potential explosive activity within weeks or even days", the agency said, raising the alert level from two to three on a scale of zero to five.

"All necessary preparations are being done," said Eugene Escobar, the Albay provincial disaster management agency's officer-incharge.

Rommel Negrete, an officer for the agency, said residents would be evacuated from Anoling village on the volcano's slopes.

Meanwhile, Taal volcano, located about 50 kilometres (31 miles) south of Manila, has been releasing sulphur dioxide this week, blanketing surrounding areas in smog and prompting warnings for

people to stay indoors. Steam-rich plumes have been recorded rising two kilometres (1.2 miles) into the sky, the seismology agency said on Thursday. It has left the alert level at one.

Earthquakes and volcanic activity are not uncommon in the Philippines due to its position on the Pacific "Ring of Fire", where tectonic plates collide deep below the Earth's surface.

Five years ago, Mayon displaced tens of thousands of people after spewing millions of tonnes of ash, rocks and lava.

The most powerful explosion in recent decades was the 1991 eruption of Mount Pinatubo, about 100 kilometres (62 miles) northwest of Manila, which killed more than 800 people.

It sent out an ash cloud that travelled thousands of kilometres in a matter of days and was blamed for damaging nearly two dozen aircraft.

Autoliv, world's biggest maker of airbags, seatbelts, to cut 8,000 jobs, close sites

STOCKHOLM, Jun 8 (Agencies): Autoliv, the world's biggest maker of airbags and seatbelts, plans to cut around 8,000 jobs, joining the growing ranks of companies speeding up cost savings in the face of high inflation.

The Swedish company, which counts many of the world's top automakers among its customers, said on Thursday it would cut around 6,000 direct jobs and up to 2,000 indirect positions.

The cuts, which equate to about 11% of direct jobs and the same proportion of indirect jobs at the company, will include the closure of several sites in Europe. and be fully implemented by 2025, it said.

"These initiatives will continue to optimise our geographic footprint for a more effective structure," CEO Mikael Bratt said in a statement. "We intend to simplify and consolidate how we operate in all areas."

AI outperforms standard risk model for predicting breast cancer: Study

NEW DELHI, Jun 8 (Agencies): Artificial intelligence (AI) algorithms outperformed the standard clinical risk model for predicting the five-year risk for breast cancer, according to a large study of thousands of mammograms.

A woman's risk of breast cancer is typically calculated using clinical models such as the Breast Cancer Surveillance Consortium (BCSC) risk model. This model uses self-reported and other information on the patient, including age, family history of the disease, and whether she has given birth, to calculate a risk score.

"Clinical risk models depend on gathering information from different sources, which isn't always available or collected," said lead researcher Vignesh A. Arasu, from Kaiser Permanente Northern California, US.

"Recent advances in Al deep learning provide us with the ability to extract hundreds to thousands of additional mammographic features," Arasu said in a statement.

The study, published in the journal Radiology, used data associated with negative-showing no visible evidence of cancer—screening 2D mammogrames performed at Kaiser Permanente Northern California in 2016.

Of the 324,009 women screened in 2016 who met eligibility criteria, a random group of 13,628 women was selected for analysis.

Additionally, all 4,584 patients from the eligibility pool who were



diagnosed with cancer within five years of the original 2016 mammogram were also studied. All the women were followed until 2021.

We selected from the entire year of screening mammograms performed in 2016, so our study population is representative of communities in Northern California," Arasu said.

The researchers divided the five-year study period into three time periods: interval cancer risk, or incident cancers diagnosed between 0 and 1 years, future cancer risk, or incident cancers diagnosed from between one and five years, and all cancer risk, or incident cancers diagnosed between 0 and 5 years. Using the 2016 screen-

ing mammograms, risk scores for breast cancer over the five-year period were generated by five Al algorithms, including two academic algorithms used by researchers and three commercially available algorithms. The risk scores were then compared to each other and to the BCSC clinical risk

"All five Al algorithms performed better than the BCSC risk model for predicting breast cancer risk at 0 to 5 years," Arasu said.

"This strong predictive

performance over the five-year period suggests AI is identifying both missed cancers and breast tissue features that help predict future cancer development. Something in mammograms allows us to track breast cancer risk. This is the 'black box' of AI," the researcher added.

Some of the Al algorithms excelled at predicting patients at high risk of interval cancer, which is often aggressive and may require a second reading of mammograms, supplementary screening or short-interval follow-up imaging.

When evaluating women with the highest 10 per cent risk as an example, Al predicted up to 28 per cent of cancers compared to 21 per cent predicted by BCSC.

Even Al algorithms trained for short time horizons—as low as 3 months—were able to predict the future risk of cancer up to five years when no cancer was clinically detected by screening mammogra-

phy. When used in combination, the AI and BCSC risk models further improved cancer prediction.

"We're looking for an accurate, efficient and scalable means of understanding a women's breast cancer risk," Arasu said.

"Mammography-based Al risk models provide practical advantages over traditional clinical risk models because they use a single data source: the mammogram itself," he added.

The researchers at Jawaharlal Institute of Postgraduate Medical Education and Research (JIPMER), Puducherry and All India Institute of Medical Sciences (AIIMS), New Delhi, reviewed numerous large multi-country and community-based randomised trials on the

They compared KMC with conventional care, starting the approach early (within 24 hours of the birth) with later initiation of KMC to see what effect this had on neonatal and infant mortality and severe illness among low birth weight and preterm infants.

Close contact between mother and premature

The review looked at 31 trials that included 15.559 infants collectively and of these, 27 studies compared KMC with conventional care, while four compared early with late initiation of KMC.

Analysis of the results showed that compared with conventional care, KMC appeared to reduce the risk of mortality by 32 per cent during birth hospitalisation or by 28 days after birth, while it seemed to reduce the risk of severe infection, such as sepsis, by 15 per cent, the researchers

It also emerged that the reduction in mortality was noted regardless of gestational age or weight of the child at enrollment, time of initiation, and place of initiation of KMC (hospital or community), they said.

The study found that the mortality benefits were greater when the daily duration of KMC was at least eight hours per day than with shorter duration KMC.

Studies that had compared early with lateinitiated KMC demonstrated a reduction in neonatal mortality of 33 per cent and a probable decreased risk of 15 per

cent in clinical sepsis until 28 days following early initiation of KMC.

The researchers acknowledged some limitations in that the studies looked at involved an intervention that was known about by participants so that it could be seen as biased, and very low birth weight, extremely preterm neonates, and severely unstable neonates were often excluded from studies.

However, the review authors said that the risk of bias in the included studies was generally low, and because their review had included a comprehensive and systematic search of existing studies, the certainty of the evidence for the primary outcomes was moderate to high.

Covid can fuse brain cells leading to brain fog, headaches: Researchers

SYDNEY, Jun 8 (Agencies): Viruses such as SARS-CoV-2, which caused Covid-19, can cause brain cells to fuse, initiating malfunctions that lead to chronic neurological symptoms, according to an international team of researchers.

This could explain brain fog, headaches, loss of taste and smell and other long-term neurological symptoms some patients experience as 'long Covid' months after their initial infection.

To understand, the teams from the universities of Queensland, Macquarie in Australia, and Helsinki in Finland explored how viruses alter the function of the nervous system.

Their research, published in the journal Sciences Advances, showed that Covid-19 causes neurons to undergo a cell fusion process, which has not been seen before.



"After neuronal infection with SARS-CoV-2, the spike S protein becomes present in neurons, and once neurons fuse, they don't die," said Professor Massimo Hilliard from the Queensland Brain Institute.

"They either start firing synchronously, or they stop functioning altogether." As an analogy, Professor Hilliard likened the role of neurons to that of wires connecting switches to the lights

in a kitchen and a bathroom. "Once fusion takes place, each switch either turns on both the kitchen and bathroom lights at the same time, or neither of them," he said.

"It's bad news for the two independent circuits." The discovery offers a potential explanation for persistent neurological effects after a viral infection.

"In the current understanding of what happens when a virus enters the brain, there are two outcomes - either cell death or inflammation," said Ramon Martinez-Marmol from the institute.

"But we've shown a third possible outcome, which is neuronal fusion." Martinez-Marmol said numerous viruses cause cell fusion in other tissues, but also infect the nervous system and could be causing the same problem there.

"These viruses include HIV, rabies, Japanese encephalitis, measles, herpes simplex virus

and Zika virus," he said. "Our research reveals a new mechanism for the neurological events that happen during a viral infection. This is potentially a major cause of neurological diseases and clinical symptoms that is still unexplored." For their study, the team relied heavily on 'mini-brains', which allowed researchers to experiment on complex human neuronal networks resembling a live human

Some of these mini-brains were infected with viruses, or viral surface fusogens -- including the SARS-Cov-2 virus -- and then compared with non-infected control mini-brains, using a remarkable breakthrough in brain experiment techniques.

This study is just one example of the huge research potential now possible thanks to the development of the mini-brains, which bridge the gap between non-living tissue and human subjects.

WTC final: Head leads Australia's charge with a 146 on Day 1


LONDON, Jun 8 (Agencies): Travis Head's counter-attacking hundred and his unbroken 251run stand with Steve Smith put Australia in charge on 327/3 after an absorbing opening day of the World Test Championship final against India.

Having reduced Australia to 76/3 soon after lunch, India's seam-heavy attack appeared to have put the 2021 runnersup in a position of strength at The Oval.

Head went on the attack, however, and Smith played second fiddle to perfection as Australia fought back hard.

Head smashed 22 fours and a six in his unbeaten 146 off 156 balls, the left-hander's sixth Test hundred and first outside Australia. Smith was unbeaten on 95 at the close after hitting 14

"After losing the toss this morning, we've done exceptionally well," Head said. "A lot of hard work to go tomorrow morning



but nice to make a really good start."

Early breakthrough

India made an early breakthrough after captain Rohit Sharma asked Australia to bat on a grassy wicket when Mohammed Siraj had Usman Khawaja caught behind for a duck in his second over.

David Warner shared a 69-run

partnership with Marnus Labuschagne to steady the innings, the 36-year-old opener cutting loose to hit Umesh Yadav for four fours in one over.

Siraj knocked the bat out of Labuschagne's hand with a rising delivery that hit the Australian on the thumb while Shardul Thakur had two lbw appeals against the batter turned down.

The seamer struck before the lunch break, however, when Warner, who made 43, gloved the ball trying to pull it and wicketkeeper KS Bharat dived to his right to take his second catch.

Warner was furious with himself having failed to convert the start into a big knock that could have been a timely boost ahead of his final Ashes campaign against England beginning on June 16 at Edgbaston.

Mohammed Shami struck soon after the lunch break by dismissing Labuschagne for 26 with a full-length delivery that pegged back the off-stump of the world's top-ranked Test batter.

Head decided attack was the best form of defence and hit Shami for a four and a six to race into the 90s before bringing up his hundred off 106 balls and he and Smith plundered 157 runs from the final session to press home Australia's advantage.

Gopichand not fretting over Sindhu's form

KOLKATA, Jun 8 (Agencies): Twotime Olympics medallist PV Sindhu's lack of consistency after coming back from an injury should not be a cause of "concern", feels chief national badminton coach Pullela Gopichand. Sindhu suffered yet another first-round exit on Tuesday when she lost to world No. 1 Akane Yamaguchi at the Singapore Open. "She's very young in saying that she's just 26-27. It's a good age, there is no reason for concern," Gopichand said.

Sindhu suffered an ankle injury in August last year to slip out of the top-10 in the BWF rankings. She remained out of action for four months because of the injury. Sindhu's final and semifinals finishes at the Spain Masters and Malaysia Masters, respectively, are her best results so far this season. She reached a low with a first-round exit at the Thailand Open when she lost to Canada's Michelle Li

But Gopichand, a former All England champion who has guided Sindhu since



she was 10, firmly believed she would bounce back stronger.

"She has come out on top in the sixeight months. She is starting to play well. I do expect her to play well in future. She is definitely one of India's bets for the future," Gopichand said.

Terming it a mixed season for Sindhu, Gopichand said: "It's the beginning of the season and beginning of the Olympics qualification. The results have been mixed so far. We have a lot of pressure on players to perform. We have to just back them up and hope that they are playing the big tournaments."

Code of conduct need of the hour

NEW DELHI, Jun 8 (Agencies): The allegations of sexual harassment levelled by female wrestlers against the Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh are not stray incidents in the world of sport in India.

Last year, a senior female cyclist had alleged that a chief coach entered her room forcefully and made suggestive gestures. Another case of sexual harassment — involving former India hockey player and Haryana Sports Minister Sandeep Singh — is being probed in Haryana.

Ironically, despite the rising cases of alleged sexual harassment, India still does not have



'Sports Code of Conduct' guidelines. This is unlike many other sporting nations. Under the US wrestling federation guidelines, for instance, no one-to-one interaction is allowed between coach and athlete behind closed doors.

In India, however, even the Sports Authority of India (SAI), which is responsible for the training of elite players, does not have any code of conduct guidelines. The academic wing of

Patiala — also does not have any section relating to guidelines while handling female players in the syllabus of its flagship diploma programme in coaching. Sources revealed that at one point, the SAI was mulling over formulating guidelines for male

coaches working with

the SAI — the National

Institute of Sports (NIS),

female athletes. However, the plan did not materialise. The guidelines which were planned to be introduced included no one-on-one coaching of female players and no one-to-one interaction with a coach, support staff or national federation official.

NIS produces hundreds of coaches in over 20 disciplines every year. Many of them train athletes in national camps. However, none has been taught any code of conduct, especially while training female athletes.

When asked about a sports code, a CWG medallist who recently passed out of the NIS diploma course said, "Even during the national camps when I was an active sportsperson, I never heard about any code of conduct. During the diploma course, we never studied any such stuff."

A senior coach attached to a national camp said, "There should be a code of conduct for coaches, supporting staff and federation officials. In technique demonstration — especially in combat sports that require a physical touch with the athlete — a code is required to avoid any instances of inappropriate touching."

"Athletes, coaches and sports federation members should be familiarised with the law of the land relating to sexual harassment," the coach added.

French Open 2023 Day 12: Iga Swiatek, Aryna Sabalenka favourites in semi-finals

PARIS, Jun 8 (Agencies): After some jaw-dropping matches in the quarters, the French Open 2023 is set to witness the women's singles semi-finals on Thursday, June 8 to be played at the Court Philippe Chatrier.

Karoline Muchova of Czech Republic will be up against Belarus' Aryna Sabalenka in the first semi-final of the day. It goes without saying that Sabalenka, who will go into the match as firm favourites. The Belarusian star will also look to keep alive her hopes of becoming the World No.1 in the WTA rankings.

Sabalenka will go into the match after beating Ukraine's Elina Svitolina in the quarter-



final. Muchova, on the other hand, is set to play her second Grand Slam semis after the Australian Open in 2021. The 26-year-old defeated Anastasia Pavlyuchenkova 7-5, 6-2 in the quarters on Thursday.

In the other match, World No.1 Iga Swiatek will lock horns with Brazil's Beatriz Haddad Maia in

the semis after the completion of the match between Muchova and Sabalenka.

Swiatek, on Wednesday, took a 7-0 lead over USA's Coco Gauff on the WTA circuit. The 22-year-old was challenged in the opening set, but she won the match 6-4, 6-2. The Polish star is looking to defend his World No.1 ranking.

Haddad Maia, on the other hand, will be high on confidence after beating World No.7 Ons Jabeur in the semis. She became the first Brazilian woman in the Open Era to advance to the Roland Garros semis. Haddad Maia lost the opening set, but went on to win the match 3-6, 7-6 (7-5), 6-1.

"India will be a bit disappointed. They had Australia at 76/3 and let them get off the hook. I know that partnerships happen in cricket. There will be a batting team who will come back and play well. I thought India started well just after Lunch but



lost the feel a bit as the game progressed," Ganguly said on Star Sports after tea was called on Day 1. "I thought they let Travis Head get off the hook very easily. I

know he has been in good form, he has scored a lot of runs, but still they were 76/3. I think Rohit Sharma with his field placements at that stage probably allowed some easy runs to happen and now Australia are in a good position," he added.

Head and Smith were batting on 146 and 95 respectively at close of play on Day 1 as Australia added 157 runs in the final session which had 34 overs without losing any wicket. The duo added 251 runs for the unbroken fourth wicket stand.

Australia, who were invited to bat, had added 97 runs in the post-lunch session in 28 overs for the loss of one wicket. They were 73 for 2 at lunch after opener David Warner made 43 off 60 balls. Mohammed Shami, Mohammed Siraj and Shardul Thakur took a wicket each on the day.

Kisan Sampark Abhiyan reaches out to over 2 lakh farmers in 1873 panchayats of UT

SRINAGAR, Jun 8: With just seven rounds completed, KISAN SAMPARK ABHIYAN has reached out to more than 2 lakh farmers of Jammu and Kashmir.

The programme, which still has 12 more rounds to go till 31st August 2023, has sprung surprising number of famers who are converging at the venues to listen and watch to what is going to be most pragmatic programme ever envisaged in agriculture and allied sectors not only the UT but in whole of the country.

A turning point in the history of agriculture sector is being witnessed in the UT of J&K

through two major initiatives. DAKSH KISAN and KISAN SATHI. DAKSH KISAN is a first of its kind online hybrid skilling programme designed exclusively for farming community. Over 27000 farmers have been registered under DAKSH KISAN PORTAL till now and around 8000 farmers have been enrolled in skilling course of their choice. To add to this, around 2000 farmers have already progressed to advance level of completion of the online skilling course.

DAKSH KISAN is a Learning Management System (LMS) for skill development of the farmers. A first of its kind in the coun-

try, DAKSH KISAN, has been developed by Agriculture Production Department, where 121 skilling courses as per the agro-climatic zones of the J&K UT are available for free to the farmers. A simple scan of the QR code at the back of pamphlet provided to farmers during Kisan Sampark abhiyan takes the farmer to DAKSH KISAN Portal where he can register for free and undertake any skilling course of his/her liking.

The video lectures under the LMS are available in Kashmiri, Urdu, Dogri and Hindi and textual material is available in Hindi Urdu and English. Besides, specialised modules on business development and financial manage-

ment have also been included to ensure that the farmers are not merely trained but become a skilful entrepreneur. After completion of online courses, the farmers shall be sent for 5-7 days to Krishi Vigyan Kendras in their respective districts for practical hands-on training in their chosen skilling course. On successful completion of the skilling course, the farmers shall be provided Certificates by SKUAST J/K.

Farmers have particularly shown great enthusiasm in KISAN SATHI- the IT Dashboard of the schemes under HADP, developed by APD. A simple scan of the QR codes on the pamphlets provided to

farmers during the kisan Sampark abhiyan takes the farmer to the KISAN SATHI Portal where he can register easily and there is no need for visiting any office for applying under any of the schemes. A total of 5735farmers have registered themselves under the KISAN SATHI PORTAL and more than 3000 online applications have been received till date from farmers under various schemes, of which, 11 applications already stand approved and rest are at various stages of processing.

A baseline survey/skill gap study of farmers is also being carried out simultaneously during the Kisan Sampark abhiyan. The data of around 1.92 lakh farm-

ers has been captured till date using IT tools. Baseline analytical tools are being deployed using AI to ascertain the state of agriculture in the UT, which shall be of immense help to planners to devise suitable interventions for having a holistic development of Agriculture and farmers in the UT.

All this has been made possible due to massive outreach of the Kisan Sampark abhiyan which was launched on 24th April 2023. A total of 1873 panchayats across all districts of the Union Territory have been covered till date under the abhiyan.

The Orientation programme is being organised simultaneously across all the districts of

has been designed to be conducted on first three days of every week. An exhaustive District specific Calendar has been issued by the Government. The Resource persons for the orientations are Officers and Officials drawn from the Agriculture, Animal/Sheep Husbandry, Horticulture, Sericulture and Fisheries Departments, who were trained beforehand during the 641 training sessions which were held across all districts during the months of January to April. An innovative tool of describing the different schemes/programmes using short films has been put in place. A total of 49 videos of schemes

under HADP and other Centrally Sponsored Schemes will be shown to the farmers across the venues in J&K.

Using audio visual aids in describing the schemes had a lasting and much more engaging, engrossing effect on the farmers. Besides, question answer session after each screening session of videos are being held to clear the doubt of farmers. The farmers are also being provided with pamphlets of all the schemes in the three languages (Hindi, Urdu and English) in the shape of a booklet, which also contains the information about the contact details of all the departments under the agriculture production department of the UT.
