9 CRPF **Troopers** injured in road accident in Ganderbal

SRINAGAR, Jul 16 (Agencies): Nine Central Reserve Police Force (CRPF) troopers were injured on Sunday in a road accident in J&K's Ganderbal dis-

trict. Police sources said that the CRPF troopers were injured in the accident in the Nilgrad area of Sonamarg when their vehicle rolled down into the Sindh stream.

"The accident took place near the helipad in the Nilgrad area. All the occupants of the vehicle sustained

Rusted mortar shell found in Kathua

JAMMU, Jul 16 (Agencies): A rusted mortar shell was found near the international Border in Kathua district of Jammu and Kashmir, officials said on Sunday.

The mortar shell was dugout by Border Security Force (BSF) personnel during some construction work in Border Outpost Chadwal area late Saturday evening, the officials said.

They said the shell was later destroyed by the bomb disposal squad in a controlled explosion without causing any damage.

Rains Lash J&K as MeT predicts more

SRINAGAR, Jul 16 (Agencies): Rains lashed Jammu and Kashmir since overnight with Pahalgam receiving highest precipitation during the last 24 hours, a meteorological department official here said on Sunday.

A meteorological department official here said that in the last 24 hours till 0830 hours, Pahalgam received 34.9mm followed by Bhaderwah 19.8mm, Jammu 14mm, Katra 12.8mm, Batote 6.6mm, Banihal and Kokernag 6.0mm each, Qazigund 1.6mm, Gulmarg 0.8mm and Srinagar traces.

Batch of over 6,600 pilgrims leaves for Amarnath from Jammu amid rain



JAMMU, Jul 16 (Agencies): Another batch of over 6,600 Amarnath pilgrims left the Jammu city early Sunday for Kashmir amid rain and tight security to embark on the annual pilgrimage, an official said.

Over 2.10 lakh devotees have so far visited the holy cave shrine of Amarnath, situated at a

height of 3,880 metres in south Kashmir Himalayas, since the beginning of the 62-day-long yatra on July 1.

"The 14th batch, comprising 6,684 pilgrims left Bhagwati Nagar base camp Jammu for the valley in a convoy of 241 vehicles between 3.30 am and 3.55 am," the official said.

The pilgrim convoy left for the two base camps, Pahalgam in Anantnag and Baltal in Ganderbal district, amid moderate rains which went on for hours drenching several parts of Jammu and leaving many roads waterlogged.

Baramulla Police launches major crackdown on narco terror, 318 held

BARAMULLA, Jul 16 (Agencies): Baramulla police on Sunday said it conducted a massive crackdown on narco terror at various locations from Uri along the Line of Control (LoC) to other parts of Baramulla district over the last few days, arresting 318 drug peddlers while recovering huge consigments of drugs.

Pakistan-based handlers, as part of a conspiracy, are using smugglers to push narcotics into Jammu and Kashmir



get the younger generation addicted to drugs, as per police.

Senior Superintendent of Police, Baramulla, Amod Ashok Nagpuri said, "Baramulla is a border district and cross-border drugs and weapons smuggling is big challenge for us.

Over the last six months,

Baramulla police registered 187 FIRs under the Narcotic Drugs and Psychotropic Substances (NDPS) Act."

"Around 284 drug peddlers were arrested and another 34 notorious peddlers booked under PIT NDPS/PSA. In total, 318 drug peddlers have been arrested, so far, and the law is taking its own course. The focus of this drive is to crack down on the drug culture in Baramulla district and our endeavour is to

Amarnath Yatra temporarily suspended due to inclement weather

SRINAGAR, Jul 16 (Agencies): Amarnath yatra has been temporarily suspended from both Pahalgam and Baltal routes due to inclement weather on Sunday, officials said.

They said no yatri was allowed to proceed from traditional Nunwan Pahalgam base camp in south Kashmir and Baltal in central Kashmir's Ganderbal district today due to inclement weather.

"It is still raining at sev-

eral places on both the routes and at the Cave shrine that has made the road condition slippery at places", they said. "Keeping in view the inclement weather conditions the authorities decided to suspend the yatra until the weather

improves", they added. Similarly no pugrim was allowed to proceed on foot or ponies from shortest Baltal route via Dumail to Cave shrine of Amarnath to pay

The woman succumbed to her injuries before being shifted to hospital while the injured

Police personnel were evacuated by army and private helicopter on Yatra duty, they said.

DGP J&K Dilbag Singh has condoled the "unfortunate" death of the Yatri and has also expressed sympathy with the bereaved family.

"The DGP appreciated the commitment of two policemen and expressed his thanks to everyone involved in the quick evacuation. He wished early recovery to Jawans."







Tony urges LG Sinha to rescue farmers in dying paddy bowl

RS PURA, Jul 16: Taranjit Singh Tony, Chairman of AAP J&K for Administrative Engagement and Minority Affairs and DDC Member Suchetgarh urged the Lt Governor to rescue farmers from the worsening situation faced by them in the dying paddy bowl. With the scarcity of water plaguing the tail end of border villages, Tony urged immediate intervention to rescue the farming community from this dire predicament.

In a statement issued here today, the senior AAP leader said that lack of a reliable water source at the zero line of the border villages has

created a severe crisis. The D-17 canal, which should have reached the tail end at Sae Devigarh Bullachak by now, remains incomplete. Astonishingly, the entire Irrigation Department appears to be in a state of dormancy, showing no urgency in addressing this pressing issue, he said.

Tony highlighted the distressing fact that over 50 tubewells in the border villages are out of order, awaiting minor repairs that remain pending. "Furthermore, the lift irrigation system, which should be a lifeline for farmers, is completely dysfunctional.

Despite repeated pleas

to the engineers, includ-



ing the Chief Engineer of the Irrigation Department, all requests have fallen on deaf ears," he said.

In a direct appeal to the Lt Governor, Tony sought immediate action, requesting him to direct the concerned authorities to visit the affected areas promptly. Expressing disappoint-

ment, he emphasized that the XEn (Executive Engineers), including the Chief Engineer, have confined themselves to the comfort of their air-conditioned offices, ignoring the distressing reality faced by farmers in the field.

"Adding to the farmers'

plight, prolonged power cuts have further exacerbated the situation. With their pump-sets rendered inoperative due to power shortages, farmers are unable to access any means of irrigation water, be it through canals, lift irrigation, or tubewells," he said.

Tony warned the administration, cautioning them about the dire

consequences if farmers are driven to the point of desperation, even contemplating suicide due to the unavailability of irrigation water. The gravity of the situation demands immediate attention and urgent measures to prevent such an unfortunate outcome, he added.

The AAP leader appealed to the Lt Governor to prioritize the well-being of farmers and take swift action by directing the concerned officials to address this crisis. He said that the survival of the paddy bowl and the livelihoods of countless farmers are at stake, requiring immediate intervention and long-term solutions.

The tide of natural disasters, pandemics, and social anarchy of the last few years has been a shock to us all. But there's been a different shock to my system that's grown insistent over time. And unlike the tremors we're all reeling from, this has been mostly delightful. I call it the shock of recognition, and it's pretty much taken over my life.

More and more, as they grow, I encounter myself in my children, but the persistence with which it happens doesn't make the jolt any less forceful. Last summer was the first time it really caught my eye, as I flicked through family holiday photos on the island of Jersey in the English Channel. I spotted a snap of me, striking a pose in the stern of a boat, of which I had absolutely no recollection. For a split-second I worried that my memory had deteriorated beyond redemption, only to realise that it wasn't my picture at all that I was examining, but one of my rapidly-changing, now-teenage daughter!

In my mind's eye, my daughter is still a child, and I look like I did a few years ago, before my newfound diabetes piled on the pounds. As a result, when I happen upon my daughter's new avatar, so strikingly similar to my previous self, I am fleetingly befuddled by it; am I looking

at a doppelganger or a mirror image? How can I be standing here and over there as well? That she borrows liberally from my wardrobe, and not always with my permission, only strengthens these surreal impressions.

That shock of recognition isn't always as heartwarming, however. At a rousing Bruce Springsteen concert in Birmingham last month, I was struck by a horrible thought—that the man I'd idolised for 40 years had begun to look like my late Dadu! I don't mean grandfatherly in general; none of us are getting any younger. I mean actually like my Dadu, with the same full head of silver hair and patrician facial features.

In the past, debating the evolutionary scientific premise that humans opt for partners who most resemble themselves (or their parents), I've laughed it off with a "Do I have a ginger beard, quill-sharp nose, and rosy skin like my husband?"

The fact, therefore, that a man I adore (Bruce) had metamorphosed into another beloved fella (Dadu) shook me up a little. Had that always been the appeal, I asked myself with horror. But then, I searched the net (strictly for research, ahem) and was reassured by the many gorgeous photos of Springsteen in his youth, where he looked more like himself and less like my Dadu (also handsome but disparately so). That the concert

was amazing reminded me as well that I'd always loved his passionate music as much as his appearance.

Yet, there's no denying how frequently these days I spot familiar features on a stranger's face, and speculate whether it's a trick of the light, a kink in my brain, or a measure of my time on this planet. Dining out with my husband recently, I pointed to a friend of my youth at a nearby table, perfectly aware that he couldn't be the man he so closely resembled. I knew from Facebook that my old friend no longer had the rippling hair, muscles, or enthusiasm for what was obviously a blind date, of our dead ringer of a neighbour.

Are there, I ruminated, only so many faces that get recycled again and again? In my nearly 50 years, have I seen every possible visage there is to see in this world, with each new face now a mere regurgitation?

Nor is this persistent feeling of déja vu only about people. A lifelong travel buff, recent trips have reminded me of other fabulous forays. Krakow in Poland last week, brought to mind Berlin, Zurich, even Paris, but was no less memorable for it. Similarly, fresh flavours today recall childhood favourites, and snatches of songs and scents can transport me to the beloved haunts of yesterday. Even stray moments can feel like a reliving, frame by splendid frame.

So, will everything in my future be a version of something that's already happened? Am I trapped in the eighties movie, Groundhog Day? Or, experiencing a commonplace, yet unpublicised, phenomenon amongst the middle-aged?

Of course, if the good in our lives feel great even when familiar, there can't be too many new terrors to fear either, only adaptations of what's come before. The coronavirus pandemic was only original to those (admittedly, the majority) who hadn't lived through other plagues, such as the Spanish Flu in the last century. Nor is the swing to the right around the world a surprise to those who've retained the lessons of history. But isn't that a relief? That we can plan for impending calamities, because they've already done the rounds?

Most of all, what's not to love in having what I've always cherished returned to me in contemporary packaging? What's not to prize in the plentiful comfort of the wellworn? Preloved it's called, in sync with our thoughtful new world, and life-affirming, rather than the opposite, in its thousand-fold increase. Nor is freshness lost; this constant 'been there, done that, got the t-shirt' sensation is itself a challenge to untangle and embrace.

Does the anti-defection law silence voice of democracy?

he ongoing tug-of-war between the National Congress Party's stalwarts, Mr Sharad Pawar and his nephew Mr Ajit Pawar, has once again shown the obsolete nature of the anti-defection law, and how it has completely lost its relevance.

In 1985, the Parliament amended the Constitution and introduced the 10th Schedule which codified the legislative mechanism pertaining to anti-defection laws in India. The intention behind the law was to combat and surmount the evils of political defection which would undermine the very foundation of our democracy, and the principles that sustain it.

However, the recent instances of mass defections in Maharashtra, Meghalaya and Goa engineered by the ruling dispensation at the Centre clearly demonstrate once again that the law has failed miserably to achieve its legislative intent. The anti-defection law epitomises a flawed legislation with noble intentions.

India's tryst with the anti-defection law commenced post the Fifty-Second Constitutional Amendment Act of 1985. According to this amendment to the Constitution, a member of a house shall be disqualified if he, or she: (1) Voluntarily gives up membership of such political party from which he was elected to the legislature or, (2) Votes or abstains against the directions of the political party, without the prior permission of the party. The law provided the exception that such disqualification shall not occur if one-third of the members of a House create a separate faction, or merge with any

other political entity. This exception was an attempt by the law to maintain equilibrium between the power of the representative to express dissent, and the powers of the political party to protect its political capital. However, this attempt was not sufficient to curb defection. Cases for defection continued, clearly showing that the law failed to achieve its objectives.

The Ninety-First Amendment Act of 2003 attempted to address the aforementioned issue. This attempt, however, also failed to address the issue of defection, and had the unintended consequence of further enhancing the powers of the almighty whip.

As a principled opponent of the 10th Schedule, my opposition is not just regarding its practical failure, but also regarding its jurisprudential incongruity with Indian law. Article 105(1) of the Indian Constitution safeguards the freedom of speech and expression in Parliament. This article was based upon the idea that a parliamentarian should have the freedom of speech to address the grievances of his constituency. However, anti-defection laws curtail this freedom of the representatives, if it is in dissonance with party lines. This is in stark violation to the very idea upon which Article 105(1) was envisaged.

Similarly, the Hon'ble Supreme Court, in its landmark judgment of Kesavananda Bharti vs Union of India, held that parliamentary democracy is a basic feature of the Indian Constitution. However, a party-dominated system that practically vassalises the parliamentarian, who was elected to represent the best interests of his constituency, violates this basic structure

doctrine.

It would perhaps be the understatement of our times even if it is articulated with full rigour that the Tenth Schedule of the Constitution has sucked the life breath of democracy out of the legislative institutions. While it has spectacularly failed to achieve its intended and stated objective, that is to curb the menence of the politics of Aya Rams and Gaya Rams, it has ended up turning the legislatures into plazas de toros of whip-driven tyranny. No longer can a parliamentarian exercise legislative freedom according to his conscience, common sense or even constituency.

While a representative is elected by the little person who stands in a long line in the blazing sun or pouring rain once in five years, the legislative life of that representative is run by the party that gave him the ubiquitous 'ticket' to run for elections.

When I entered the hallowed portals of the Parliament, the first private member's bill that I had moved was to relax the archaic and rigid nature of the 10th Schedule. The bill proposed to moderate the powers of the whip and ensure that the whip only be used as an instrument to prevent situations where the stability of government would get impacted.

I have again introduced another private member's bill: The Constitutional (Amendment) Bill, 2020. This bill also envisages disqualification of a member of a house on grounds that he or she votes, or abstains from voting in a confidence motion, no-confidence motion, adjournment motion, money bill, or financial matters contrary to directions issued by the party. This helps in ensuring

equilibrium between the freedom of a member of House to represent his interest, and the ability of the party to protect itself from any malafide political machinations. It is unfortunate that the government has failed to appreciate the reform, and on the contrary, is weaponising the 10th Schedule to satiate its incessant greed for power and prestige.

On the contrary, the developments in Maharashtra, Goa and various other places over the years, where governments have been toppled over the years using unjust and foul means, have once again underscored that the powers given to the presiding officers are not used in a fair, just and equitable manner to prevent political chicanery and manifest illegality that totally demolish the essence, substance and the very raison d'etre of the Tenth Schedule repeatedly. There is a need to seriously deliberate upon the role, nature and even the kind of person/persons who should occupy the chair of legislative institutions both in the Central and state legislatures. The recent disqualification of Mr Rahul Gandhi, despite Article 103 of the Constitution of India vesting the powers in the President of India and not the Speaker of the Lok Sabha, given that the ingrediants of Section 8(3) of Representation of People's Act, 1951, were far from complete, is legally untenable. No disqualification was possible, much less warranted.

The time has come to repeal the 10th Schedule of the Constitution of India and replace it with something that really works both to curb the menace of defections and ensure that the oxygen of democracy is pumped back into our legislative institutions.

Under hard economic condition, poor unable to afford exorbitant electricity bills: Rafiq

Expressing grave resentment over huge power bills being received by poor people of J&K after installation of smart meters in J&K, Lok Jan Shakti Party (Ramvilas) J&K President Rafiq Malik appealed the Lt Governor to ask the PDD authorities to address this grave public issue. He said the people of our state belong to middle class and below poverty line families and they cannot afford this system. This power is generated on our rivers. The government is sending it to outside states. Then they increase tariffs here to buy power. How can poor people pay ₹3,000- 4,000 bill of smart meters," Malik said. "A cooking gas cylinder costs ₹1,250, kerosene is ₹100 per litre. They can't afford to buy gas cylinders, from where they will bring money for huge power bills. Malik said poor people can't use fans for their children in this scorching heat in wake of huge power bills beyond their reach. "We are not against smart meters but the government needs



to check the ground reality. Poor people don't have the capacity to pay huge power fees. "They cannot afford the smart meter billing. Their income is very nominal as the majority of the people in our area are either working as salesmen, auto-rickshaw drivers or roadside vendors. They hardly manage the school fee of their children," said Malik.

Malik alleged that gov-

ernment is sucking the blood of poor people across JK by installing the Smart meters and by imposing large amount of power bills. While demanding free power and drinking water to people of Jammu Kashmir, he urged LG Administration to address this issue on priority basis. "We don't understand why the government is not listening to our grievances. Despite all

In just one month, prices of tomatoes, in various states, have jumped up by Rs

It is learnt that NCCF is also in the process of tying up with organisations with well-established retail outlets like Mother Dairy, and Kendriya Bhandara so that the outreach can be extensive and purchasing tomatoes would be easy for the consumers.

Flood situation improves in Delhi as Yamuna water level drops to 206.02 metres

NEW DELHI, Jul 16 (Agencies): The water level in Yamuna was recorded at 206.02 metres at 8 am on Sunday against 207.58 metres yesterday morning, the Delhi Flood Control Department

The situation of waterlogging in several lowlying areas of Delhi, including on roads from Kashmere Gate to Majnu Ka Tila, has improved today as the water level is slowly receding, it said. According to offi-



cials, the water level of Yamuna is likely to fall below the danger mark in the next few hours.

The Yamuna River in Delhi crossed the danger mark of 205.33 metres at 5 pm on July

Notably, the Yamuna water level was recorded at 207.58 metres at 8 am on Saturday. At 9 pm on Friday, the water level of Yamuna was recorded at 208.07 The Delhi Traffic Police

have issued a traffic alert restricting movement on the Bhairon Marg due to waterlogging under the Railway Bridge "Traffic Alert: Traffic

movement on Bhairon Marg is restricted due to waterlogging under Railway Bridge. Commuters are advised to avoid the stretch", the Delhi traffic police said in a tweet.

Meanwhile, National Disaster Response Force (NDRF) teams carried out a rescue operation in the lowlying areas near Pragati Maidan late on Saturday night as the Yamuna River continued to overflow, officials said, adding nearby areas and key roads remain affected due to waterlogging.

In a special night drive, New Delhi Municipal Council's (NDMC) workers flushed out water from the Mathura Road, near the Supreme Court area, as nearby key roads remain inundated due to heavy rain on Saturday.

Assam CM blames 'Miyas' for soaring vegetable prices; opposition hits out at 'communal politics'

GUWAHATI, Jul 16 (Agencies): Spiralling vegetable prices in Assam's largest city Guwahati has triggered a war of words between political opponents, with Chief Minister Himanta Biswa Sarma's blaming 'Miyas' for the escalating rates drawing sharp reactions from opposition parties.

While AIUDF chief Badruddin Ajmal said 'Miyas' have been 'hurt' by the CM's comment, Congress and other opposition parties sniffed a collusion between the BJP and the AIUDF in 'communal politics' ahead of next year's Lok Sabha elections.

Sarma, while responding to reporters' questions on high price of veggies in Guwahati, had said, "Vegetables are not priced so high in villages. Here the Miya vendors charge us more. Had it been Assamese vendors selling vegetables, they wouldn't have fleeced their own people."

"I will clear all the footpaths of Guwahati and I urge our Assamese people to come forward and start their businesses." he added.

Bengali-speaking Muslims are generally referred to as 'Miyas' in the state, with the community largely engaging in agricultural activities.

Reacting to Sarma's statement, Ajmal said such words are unbecoming of a chief minister, who is the head of a state, and the community has been 'feeling hurt and offended'

"This is creating a communal divide. If it triggers any incident, the government and Himanta Biswa Sarma will be responsible for it," the Lok Sabha MP added.

Ajmal also maintained that the prices of vegetables are not controlled by the Miyas.

Urging the Assamese youth to take up agriculture, he added, "We will welcome Assamese youth join in farming activities. But I don't think they will do it as it requires a lot of hard work." Congress president Bhupen

Kumar Borah alleged that both Sarma and Ajmal are together



in creating this 'Miya-Assamese' controversy to drive a communal divide between the people.

"As elections are coming closer, both of them want to divide the people along religious lines. BJP has failed to address core issues like unemployment, price rise, illegal migrants, etc. and to divert attention, they are indulging in such tactics." Raijor Dal president and MLA Akhil Gogoi also claimed that such communal statements by Sarma was a ploy to take away people's attention from important issues.

"There are three main reasons for such communal politics. The BJP wants to divert attention from the draft delimitation proposal as the opposition has been able to lay bare before the people that the document doesn't espouses the cause of the indigenous people. "It also wants to sail through

the elections through religious polarisation as it had failed to deliver on its promises. And also, to hide rift within old and new BJP members," the Sivasagar legislator added.

Aam Aadmi Party (AAP) spokesperson Hemanta Phukan also alleged communal politics is a tactic by the BJP to hide its

"The BJP has failed the people and to hide it, when elections are approaching, they are taking recourse to communal politics. Ajmal is also helping them in it. I urge the government to indulge in politics of development as people will reject such communal tactics," he added.

President Biden's election war chest trails Trump's in size, filings show

Disclosures filed to Federal Election Commission point to a competitive money race ahead of November 2024 presidential election

WASHINGTON, Jul 16 (Agencies): President Joe Biden's reelection campaign ended last month with about \$20 million in the bank, just trailing the \$22 million plus reported by leading Republican candidate Donald Trump, according to financial disclosures released.

The disclosures filed to the Federal Election Commission point to a competitive money race ahead of the November 2024 presidential election.

Biden has amassed a smaller war chest to past presidents at this point in recent re-election campaigns. Democrat Barack Obama had \$37 million at this point in 2011, while Trump had more over \$56 million in June

The funds detailed in the disclosures represent a significant chunk of the funding behind the campaigns, but do not include money gathered by allied super PACs, which typically raise massive sums from the wealthiest



donors and are due to disclose details on their finances later in

Biden's campaign announced that his re-election effort, when including the Democratic Party's accounts, had \$77 million in the

The President is not expected to face a serious challenge in

the Democratic nomination contest. One challenger, anti-vaccine activist Robert F. Kennedy Jr., reported raising just \$6 million through June, while another, self-help guru Marianne Williamson, took in less than \$1 million.

Trump's campaign, which was launched in November, reported spending about \$9 million in the three months through June, more than any other campaign, according to the disclosures wiled to election regulators. The spending included more than \$2 million paid to Campaign Inbox LLC, a digital fundraising firm.

Florida Governor Ron DeSantis, who ranks second to Trump in most opinion polls for the Republican nomination contest, had about \$12 million in his campaign account, considerably less than the \$21 million had by fellow Republican Tim Scott, a US Senator for South Carolina. DeSantis and Scott launched their campaigns in May.

Long-shot Republican candidates Doug Burgum and Vivek Ramaswamy disclosed putting millions of dollars of their own money into their campaigns. Burgum, the governor of North Dakota, lent about \$10 million to his campaign and Ramaswamy, a former biotechnology executive, lent his about \$15 million.

Rescuers retrieve six bodies from flooded South Korea underpass



CHEONGJU (SOUTH KOREA), Jul 16 (Agencies): The bodies of six people trapped in a tunnel submerged by heavy rains in central South Korea were retrieved on Sunday, firefighting authorities said, taking the death toll from days of torrential rains that have pounded the country to

Seo Jeong-il, head of the west Cheongju fire station, said some 15

vehicles, including a bus, are estimated to have been submerged in the flooded underpass in the city.

"We are focusing on the search operation as there's likely more people there," Seo told reporters. "We are doing our best to wrap it up today."

The death toll in the tunnel stands at seven, he said.

The Ministry of Interior and Safety said 10 people were missing as of 11 a.m. (0200 GMT) as heavy downpours caused landslides and floods across the countrv. with evacuations

covering 7,866 people. The ministry data does not include those in the flooded tunnel as it was not immediately clear how many people were trapped underwater.

Korea Railroad Corp has halted all slow trains and some bullet trains since Saturday due to safety concerns over landslides, track flooding and falling rocks.

President Yoon Suk Yeol, now on an overseas trip, ordered Prime Minister Han Duck-soo to mobilise all available resources to minimise the casualties, his office said, as more heavy rain was expected on the Korean peninsula on Sunday.

Magnitude 7.4 earthquake strikes Alaska Peninsula region, tsunami warning issued

ALASKA PENIN-SULA. Jul 16 (Agencies): An earthquake of magnitude 7.4 struck the Alaska Peninsula region early on Sunday, according to the United States Geological Survey (USGS).

The US Tsunami Warning System issued a tsunami threat after the earthquake.

The quake was at a depth of 9.3 km (5.78 miles), USGS said.



Russia says shot down eight Ukraine drones over Crimea's Sevastopol

MOSCOW, Jul 16 (Agencies): Russia's air defence forces and fleet in the Black Sea intercepted eight Ukrainian drones over the Crimean port of Sevastopol early on Sunday, a Moscow-installed official said.

"No objects, either in the city or in the water area were damaged," Mikhail Razvozhayev, the Moscow-installed governor of Sevastopol, said on the Telegram



messaging app.

One drone was shot down over the sea, five were intercepted by Russia's electronic warfare forces and two water surface drones were destroyed on the outer shore, he added.

The attacks were over the harbour of Sevastopol and the city's Balaklava and Khersones districts, Razvozhaev said earlier.

There was no imme-

diate comment from Ukraine on the attack on the Crimean Peninsula, which Russia annexed from Ukraine in 2014.

Ukraine almost never publicly claims responsibility for attacks inside Russia or on Russiancontrolled territory in Ukraine, but has been saying in recent months that destroying Russia's military infrastructure helps Kyiv's counterof-

US, South Korea, Japan hold missile defence drill after North's ICBM launch

SEOUL, Jul 16 (Agencies): The US, South Korea and Japan held a joint naval missile defence exercise on Sunday to counter North Korea's evolving nuclear and missile threats, the South's navy said, days after the North launched an intercontinental bal-

listic missile (ICBM). North Korea fired its latest Hwasong-18 missile, which Pyongyang describes as the core of its nuclear strike force, off the east coast on Wednesday in what it said was a "strong practical warning" to the adversaries.

Sunday's trilateral drill was conducted in international waters between South Korea and Japan, bringing together destroyers equipped with Aegis radar systems from the three countries, the navy

Washington and its Asian allies have been working to improve their information-sharing system on North Korea's missiles. South Korea and Japan are independently linked to US radar systems but not to each other's.

The exercise aimed at mastering the allies'



response to a North Korean ballistic missile launch with a scenario featuring a virtual target, the military said.

"We will effectively respond to North Korea's

nuclear and missile threats with our military's strong response system and the trilateral cooperation," a South Korean Navy officer said.

The North's ICBM

launch was denounced by the US, South Korea and Japan, though Pyongyang has rejected the condemnation, saying it was an exercise of its right to selfdefence.

The latest launch followed heated complaints from North Korea in recent days, accusing American spy planes of flying over its exclusive economic zone waters, condemning a recent visit to South Korea by an US nuclear-powered cruise missile submarine and vowing to take steps in reaction.

Putin says Russia has 'sufficient stockpile' of cluster bombs and will use them if necessary



MOSCOW, Jul 16 (Agencies): President Vladimir Putin said that Russia has a "sufficient stockpile" of cluster bombs and that Moscow reserves the right to use

them if such munitions

are used against Russian forces in Ukraine.

"Of course, if they are used against us, we reserve the right to take reciprocal action," Putin said in a state TV interview, excerpts of which were published on Sunday.

Ukraine has received cluster bombs from the United States, munitions banned in more than 100 countries. Kyiv has pledged to only use them to dislodge concentrations of enemy soldiers.

Family of Pakistani woman don't want her back, says she's no longer a Muslim

KARACHI, Jul 16 (Agencies): A Pakistani mother of four, who sneaked into India to live with a Hindu man whom she befriended through an online game platform, has been ostracised by her family and neighbours here for daring to defy the societal norms in this conservative Muslim country.

Seema Ghulam Haider and Sachin Meena got in touch while playing PUBG in 2019 and a dramatic love story unfolded between the two living more than 1,300 kms apart, in countries not too friendly to each other.

Seema, 30, and Sachin, 22, live in the Rabupura area of Greater Noida, near Delhi, where he runs a provision store, according to Uttar Pradesh Police.

While Seema was arrested on July 4 for illegally entering India without a visa via Nepal with her four children, all aged below seven years, Sachin was put behind bars for sheltering illegal immigrants.

While they were released from jail recently, the news from across

the border is not so positive. Seema's neighbours and a relative made it clear that they didn't want her back in Pakistan.

"She should just send her children back to Pakistan. She can stay there. Now she is no longer even a Muslim," said the 16-yearold son of the landlord in whose rented home Seema stayed with her children for the last three years before deciding to illegally enter India to be with her Hindu lover.

The story of how this largely uneducated mother of four and the wife of a husband working abroad could have the courage in Pakistan's largely conservative society to abandon everything and enter India illegally to be with a much younger man still fascinates everyone in her neighbourhood.

Her home is in the neighbourhood of Bhittaiabad, Katchi Abadi in the heart of Gulistan-e-Jauhar and is nothing much to talk about as it is a three-room portion of a building devoid of any paint and located in a narrow lane full of garbage and overflowing sewerage.

The stench of sewage is toxic in the air as one drives down the crowded un-constructed lane and broken road bustling with people and shops on both sides with flies aplenty and a general unsanitary

As soon as one reaches Seema's house, one myth is broken that her husband, Ghulam Haider, who

the house for Rs 1.2 million. "No, she was a tenant with us for three years with her children. She lived alone with her children. Her father-in-law lives some distance away from here," Nur Muhammad,

works in Saudi Arabia, brought her

the landlord's son, explained. Seema and Ghulam Haider had eloped 10 years back to Karachi and got married against the wishes of their parents.

"We saw her call a taxi and leave one day with her children and some bags and we thought she was going to her village in Jacobabad. But after nearly a month, when we heard about her escapade on TV channels, we were all shocked," adds Jamal Jakhrani, an elderly man, who was her neighbour.

Efforts to try to talk to women in the narrow lane failed as the area is mostly inhabited by tribal area Pashtuns, Sindhis and Seraikis from rural areas and the men don't allow their women to talk to

strangers and make them observe

But one noticed some women peeking out of their windows and main door inquisitive to know what was happening.

Jamal, who belongs to the same tribe that Seema and Ghulam Haider belong to, believes it is best Seema to remain in India now. "If ever she thinks of coming back,

she will not be forgiven by the tribe and secondly, her decision to stay with a Hindu has angered everyone now," Jamal said.

Mian Mithoo, a high-profile religious leader in rural Sindh, known for using his seminary to convert Hindu girls to Islam and even bandits, has openly threatened to punish Seema if she returns.

His supporters have also threatened to attack Hindu worship places in Seema's village, but SSP Kashmore-Kandhkot, Irfan Samoo, assured Hindus and Sikhs they would be protected.

Samoo, however, is puzzled by the whole case and has found anomalies in Seema's documents and tale.

"Her national identity card says

she was born in 2002. So, she should be 21 years of age now and yet she has four children all up to the age of 6 years," he said.

Samoo also said the police have asked Ghulam Haider to return from Saudi Arabia but he has been in touch with them only on video or phone calls.

Samoo is not convinced that a woman with a rural background would have the courage to plan her way to India via Dubai and Kathmandu.

An officer at the police station in Karachi where Seema's father-inlaw filed an FIR is also not convinced that it is a simple case as it looks.

"The husband also keeps changing his stories to the police. First, he said he bought the house. Now he says he paid one million rupees to Seema's family to settle a tribal decision when they first fled to Karachi," he said.

"One thing is clear, Seema was frustrated with her husband's absence and being forced to take care of four children by herself as she had no support even from her in-laws," he said.

Malik, a mobile shop owner, remembers how, after a year, Seema moved into the neighbourhood, she used to visit his shop to get her balance recharged fre-

"She always wore a chaddar over her head and had half of her face covered and also didn't talk much, so that is what surprised me when I learnt about her decision," Malik

Maulvi Samiuddin, a prayer leader in the neighbourhood mosque, was initially not even willing to talk about the incident but then said Seema was evil.

"Husbands should never leave their wives alone for years and parents need to constantly keep a watch on their daughters and sisters or we will have more such incidents in future as well, because most people, especially women, are not educated enough in such poor neighbourhoods to understand the consequences of their actions," he said.

"She has brought shame to Muslims and Pakistan. She will sooner or later face punishment for her actions," he said.

Number Games: The Jekyll and Hyde personality of statistics

The animosity towards official economic data has reached such a point that all official data, even when valid, is seen as a trick to pat the government's on its back.

NEW DELHI, Jul 16 (Agencies): The Indian Statistical Institute is 91 years old. Despite its near-century of existence, numbers from the Indian government's official statistical agency continues to be viewed with skepticism by many. In fact, the latest debate on our archaic statistical framework has ensued just weeks after the country celebrated the National Statistics Day on June 29.

Noted economists from the Left, the Right and the 'Centre' (government) are busy exchanging verbal volleys on how suboptimal methodologies and sampling errors can often lead to a failure to assess actual progress, or the lack of it. The animosity towards

official economic data has reached such a point that all official data, even when valid, is seen as a trick to pat on the government's back.

At the same time, there's no denying that India's statistical methods need a complete overhaul to improve accuracy and regain trust, despite the significant revisions they have undergone in the past decade.

A GLOBAL PHENOM-

Distrust of official data is not limited to India. Statistical manipulation or statistical crimes occur everywhere, and shockingly, some of them have even claimed lives. Below, The New Indian Express chronicles some of the infa-

mous ones

The pharmaceutical industry has been second to none when it comes to misrepresenting data. One of the biggest statistical disasters in the healthcare sector dates back to 1996 when Purdue Pharma launched its addictive drug OxyContin in the US, setting off one of the most debilitating health crises in the country and unleashing a wave of opioid addiction that has claimed thousands of lives. Advertised as a safe,

non-addictive drug that was highly effective for pain relief, Purdue's marketing strategy used an unethical and misleading graph to get FDA approval for the product. It went on to



convince doctors that the drug was non-addictive because it stayed in the patient's blood for longer, helping avoid symptoms of withdrawal. However, it was later found that the graph incorrectly showed the drug's efficacy to spur sales and Purdue was forced to pay a \$600 million fine for its criminal actions. Another famous catas-

trophe, where statistics played a part, was in 1986, when seven astronauts were killed as their space shuttle 'Challenger' exploded barely 73 seconds into the flight. A subsequent inquiry found a major flaw in statistical analysis by the solid rocket booster engineers, who had excluded flights with zero incidents from their analysis as they felt those flights didn't contribute any relevant information.

However, it was found

later that all flights with no incidents were launched at temperatures above 65 degrees, while the Challenger was launched on a cold day when temperature was 39 degrees Fahrenheit. The engineers believed that there was no relationship between launch temperature and the number of O-ring (a mechanical seal preventing gas or liquid leak) incidents on a flight, while the commissioned inquiry concluded that '...O-ring performance would have revealed the correlation of O-ring damage in low temperature.

While such fatal incidents may have declined over time thanks to advanced statistical methods, what hasn't stopped is the misuse of statistics. Despite the availability of technology and advanced

data analysis tools, one can still prove anything through data manipulation. Such mistakes could have been forgiven a few decades ago when statistical methods were still taking shape and survey errors could have been seen as the result of a lack of experience.

Talking of the wilful misinterpretation of data, Darrell Huff's 1954 book How to lie with statistics is a classic in its genre. The 129-pager has numerous examples of the rising trend of data abuse. Sample this:

A 1950 survey found that in Yale University, the class of 1924 had an average income of \$25,111 a year. But soon, it was realized that the survey presented a grossly inflated figure, as the sample omitted groups that would have depressed the average. Furthermore, it surveyed only people who bothered to respond and only those that Yale could find.

Then there's Literary Digest's infamous 1936 poll that stood out for its erroneous survey results. The magazine had run a poll on every US election since 1920 and even acquired authoritative status after accurately predicting the 1932 election However the subsequent survey saw irreparable cracks. The poll had a biased sample of Digest's 10 million subscribers (largely with a Republican tilt), and forecasted a landslide victory for the Republican Presidential candidate Alf Landon, while the actual election was won by the incumbent Franklin Roosevelt.

Darrell took delight in detailing the beauty of lying with statistics. If you are told that the average income in a

Viral caffeine-heavy soft drink raises concerns for **US kids**



WASHINGTON, Jul 16 (Agencies): With its extremely high levels of caffeine, a hip new soft drink is raising fears in the United States that it might be dangerous for children, who have been snapping up the beverage since it was launched by famous YouTube personalities.

Prime was created in 2022 by American Logan Paul and Briton KSI, two influential You-Tubers whose wacky -- and sometimes controversial -- videos are devoured by child-heavy audiences.

A first drink, Prime Hydration, did not contain caffeine. But this year, a second line was launched: Prime Energy.

A single can contains 200 milligrams of caffeine -- far more than the 30 milligrams in a can of Coca-Cola, for example, or the 80 milligrams in a can of Red Bull. A launch video showed

the two internet stars playing video games and table tennis, very slowly and without enthusiasm at first, then frantically after drinking the beverage. Since then, many

TikTok videos have featured children proudly brandishing the famous bottles, set to a musical background proclaiming "We got Prime, boys!"

However, medical experts warn about the risks of younger children consuming caffeine.

Children under the age of twelve should not consume the chemical at all, according to the American Academy for Child and Adolescent Psychiatry (AACAP).

And between the ages

of 12 and 18, a limit of 100 milligrams per day is recommended -- or half a can of Prime Energy.

In addition to restlessness, anxiety and headaches, too much caffeine can cause a child to vomit or to suffer from high blood pressure or heart rhythm problems, according to the AACAP. Some children may be more sensitive than others.

'Eye-popping levels of caffeine'

"This product has one true target market: children under the age of 18, and that is why I am sounding the alarm," said top Democratic Senator Chuck Schumer last week.

Prime Energy comes in flavors that might attract younger kids, such as orange-mango and raspberry-melon.

But the drink contains "eye-popping levels of caffeine for a child's body," the Senate majority leader said.

The refreshment is fashionable because "it is born from the reels of social media and the enigmatic world of influencers," the senator said in a statement. Schumer announced

he had written to the head of the Food and Drug Administration (FDA), demanding an investigation into the levels of caffeine the drink contains and the marketing strategy adopted.

The FDA responded this week that it is "reviewing the concerns" raised by the senator, and that it would respond to him directly.

"We encourage caregivers and families to read a product's label before giving the product to their child," an FDA spokesperson said in a statement.

The can does feature a discreet line indicating that the drink is not recommended for those under 18, though the warning may not be obvious to everyone planning to pop one

The FDA -- which has already issued warnings in the past against several companies marketing both alcoholic and caffeinated beverages -- noted that adults can generally consume up to 400 milligrams of caffeine per day without harmful effects, or four to five cups of coffee. **Expanding market**

Paul partially responded to the controversy in a video posted to social media on Thursday.

He said he was offended by articles in some media that reported that Canada had recalled Prime Energy cans, though the move was only an action against illegal imports, as the drink is not officially distributed there.

The energy drink market is buoyant and expanding, and US supermarket shelves are stocked with several brands.

In its first year of operations, Prime sold \$250 million worth of products, Paul had previously said in an interview.

Young professionals embracing AI upskilling for job market relevance: Report MUMBAI, Jul 16





can escalate if not diagnosed and treated early. Symptoms of complex regional pain syndrome The primary symptoms

of CRPS are severe pain, swelling, loss of range of motion, temperature changes, and changes in the skin. The pain experienced is often spontaneous or excessively greater than normal following something as mild as a touch.

Other symptoms include changes in skin colour, temperature, and swelling on the arm or leg below the site of injury.



Diagnosing CRPS can be challenging as there is no specific test to confirm it. Magnetic Resonance Imaging (MRI) cannot distinguish between CRPS and non-CRPS, making it a clinical diagnosis.

India in danger of losing No.1 Test ranking even with 2-0 series win vs West Indies. Here's how

India became the No.1 Test team after winning the Border-Gavaskar Trophy earlier this year, but Australia have a great chance of toppling them.

NEW DELHI, Jul 16 (Agencies): India started the World Test Championship (WTC) 2023-25 cycle as the No.1 ranked team in Test cricket. Rohit Sharma's men are currently in the West Indies where they are playing in a two-match series.

They are leading the series 1-0 after winning the opening Test by an innings and 141 runs at Windsor Park in Roseau in Dominica.

Given their current form, India will go into the second Test as favorites without much of a doubt.

The final Test is scheduled to get underway on July 20 at the Queen's Park Oval in Port of Spain Trinidad. It would not spring a surprise if India go on to win the match and the series

However, winning the series 2-0 would not guarantee them a spot at the top of the Test team rankings. Australia, who are taking part in the Ashes, have every chance of going past them. The Aussies are currently leading the five-match series 2-1. let's take a look at the

scenarios in the Test rankings:

India beat West Indies

If India win their Test series against the West Indies 2-0, then Australia have to win the Ashes by a minimum margin of 4-1. With two matches in Manchester and KIA Oval, Australia's win by that margin is on the

cards. In that scenario, India would lose their

No.1 ranking in Tests.

India beat West Indies

If the second Test between India and West Indies ends in a draw. then Australia have to win the Ashes by a minimum margin of 3-1. If that happens, Australia will become the new

No.1 Test team. The Aussies cannot afford to lose a Test in this case. India vs West Indies ends at 1-1

If India lose the second Test against West Indies, which seems highly unlikely for the time being, Australia have two ways by which they can reclaim the No.1 spot.

a) If the last two Tests of the Ashes end in draws and Australia win the series 2-1.

b) If Australia win the five-match Test series 3-2

Australia can afford to lose a Test and yet become No.1 in the rankings if India lose to the West Indies in the second Test. Otherwise, the Aussies cannot afford a defeat if they are to topple India in the rankings.

"Playing for India itself is really a proud feeling, and leading the side in such a big event, will be a great opportunity for me personally, and also all the team members who are alongside me."

Cricket is being played at the Asian Games for the first time since 2014 when India did not take part. This time, India will be fielding both men's and women's teams.

LONDON, Jul 16 (Agencies): Ons Jabeur broke down in tears of pain after losing to Marketa Vondrousova in the final of Wimbledon 2023. The Tunisian star, who knocked out defending champion Elena Rybakina and World No.2 Aryna Sabalenka on her way through to the final, lost 4-6, 4-6 to the unseeded Vondrousova.

Earlier in the tournament, the 28-year-old Jabeur also showed the door of elimination to two-time champion Petra Kvitova.

Jabeur said that the loss was a tough pill to swallow, but also vowed to make a strong comeback. It was her second final at SW19 on the trot, but both times, she ended on the losing side

"It's tough and it is the most painful loss of my career." Jabeur was quoted as saying after



the match.

"It is going to be a tough day for me, but I am not going to give up and come back strong." Apart from losing two

Wimbledon finals in 2022 and 2023, Jabeur had also lost to World No.1 Iga Swiatek in the US Open final last year.

"It is an amazing tournament and I wish I continued till the end. I want to thank my team for always believing in me and we are going to make it one day, I promise you," she said.

"It has been a tough journey, but that's tennis and I promise to come back one day and win this tournament," Jabeur added

Jabeur struggled with her serve as Vondrousova converted six of her seven break points. Jabeur was tentative with both her first and second serves, winning 48 percent points from both of them. Jabeur was a break up in the second set before Vondrousova hit back with a double break to eventually come up trumps.

Jabeur will now look to make amends when the US Open 2023 gets underway on Monday,

Tourist in 2022, champion in 2023: Marketa Vondrousova relishes 'crazy' Wimbledon triumph

On the eve of her first wedding anniversary, Marketa Vondrousova went on to win the Wimbledon women's singles crown. The 24-year-old defeated Ons Jabeur 6-4, 6-4 in the final in London

LONDON, Jul 16 (Agencies): Marketa Vondrousova did not play the Wimbledon last year but she was in London as a tourist. With her arms placed in a sling, the Czech Republic tennis player had turned up at the All England Club to cheer for her good friend, Swedish player Mirjam Bjorklund, who was playing in the qualifying for the first time.

Injuries have hampered Marketa Vondrousova's consistency ever since she won her first title at the senior level in 2017. She has spent 6 months on the sidelines as many as 3 times in her nascent career due to injuries on her left hand. It was a wrist injury and subsequent surgery that had kept her out of action from Wimbledon last year. She travelled to London with her sister and spent a week's time, rooting for her good friend.

However, cut to July 2023, millions were rooting for her as she became the first unseeded woman in the Open Era to reach the women's singles final at the prestigious grass-court Grand Slam. Marketa Vondrousova



had beaten Elina Svitolina to reach the summit clash where she took on last year's finalist Ons Jabeur.

On Saturday, she put on a show in front of thousands on the Center Court. She was watched on by her younger sister, her husband, and her team in the box as she outclassed Ons Jabeur in straight sets - 6-4, 6-4 - to become the first unseeded woman to win the Wimbledon title in the history of

Marketa Vondrousova did not play like someone who was featuring in her maiden Wimbledon final. She sprung back from setbacks, mixed aggression with deception wonderfully well to outclass 6th seed Jabeur, who was denied the Wimbledon title for the second time in 12

months.

"After everything I have been through it is amazing I can stand here and hold this. Tennis is crazy! The comebacks aren't easy you don't know what to expect, I was hoping I could get back to this level and now this is happening," Vondrousova said after lifting the trophy at SW19 on Saturday.

WEDDING GIFT TO HUS-

When she came as an unseeded player to Wimbledon, little did she know she would go on to win the whole thing. She had placed a bet with her coach that he would get a tattoo with her if she won Wimbledon. Her husband, Stepan, had to call a pet sitter to take care of their cat to leave for London and reach Wimbledon just in time to catch her in action in the final.

Her husband traveled to London with her sister for the final and it all turned worthwhile as Vondrousova, on the eve of their first wedding anniversary, won the biggest title of her

"Thank you to my box, my little sister. She is crying! I mean it is amazing. Tomorrow is our first wedding anniversary. It's great to have you guys here, I enjoyed the two weeks so much. I am so grateful and proud of myself.

"I made a bet with my coach, if I won a grand slam he was going to get a tattoo too - I think we are going to go tomorrow!" Vondrousova said on Saturday.

"Same As Yashasvi Jaiswal...": Ricky Ponting's Huge Comment On Star Who Did Not Get A Chance In 1st WI Test

Ricky Ponting believes a slew of other uncapped youngsters will be inspired by Yashasvi Jaiswal and perform similarly if given a chance at Test level.

SYDNEY, Jul 16 (Agencies): Australia great Ricky Ponting has identified a group of young India batters that can match the exploits of opener Yashavi Jaiswal and prosper at Test level if given the chance during the new ICC World Test Championship cycle. Jaiswal was one of two players given Test debuts for India in the present Test against the West Indies in Dominica, and the 21-year-old quickly proved he was up to the task, becoming only the 17th Indian player to make a century on Test

When speaking on the most recent episode of The ICC Review, Ponting was full of praise for Jaiswal, admitting that he was not surprised to see the left-hander make a strong impression after seeing him amass 625 runs for the Rajasthan Royals during the most recent season of the Indian Premier League (IPL).

"I mean (Yashasvi) Jaiswal's IPL was something special. He almost just flicked a switch and turned into a superstar overnight. Everyone knew that he was a talented youngster, but what I saw in this year's IPL, he's got all sorts of talent," Ponting told ICC.

Ponting believes a slew of other uncapped voungsters will be inspired by Jaiswal and perform similarly if given a chance at Test level.

Ponting nominated Ruturaj Gaikwad - who scored 590 runs during this year's IPL and is



also in India's touring party currently in the Caribbean - as another player who may shine in the coming years and Sarfaraz Khan and Prithvi Shaw as two other batters that could easily adjust quickly to the rigours of Test

cricket "There's a lot of those young Indian guys that

I can't wait to see play Test cricket and yet you look at their domestic records as well and you can't help but be impressed. I'm on record saying that I think (Ruturaj) Gaikwad's the same (as Jaiswal). I think he could be a very serious Test match player or all-format player really in the next

couple of years," Ponting said.

Shaw is another player who Ponting believes has the potential to flourish for India in the future if he works hard to make a comeback. Shaw made his international debut in 2018, but has not represented his country since 2021.

"So, yeah, I probably do think those two guys would be the standouts. I think just off the top of my head, batting-wise, they'd be the two. And as I said, well Sarfaraz is the other one that's got all sorts of talent that we might not see for a little while just yet," said the former Australia captain.

Notably, Gaikwad is in India's Test squad but didn't get the chance to play in the first Test
