#### Two held with 153 kg poppy husk bound for JK

SRINAGAR, Aug 3 (Agencies): : Pathankot police on Thursday apprehended two individuals in possession of 153 kg of poppy husk, being smuggled to Jammu and Kashmir (J&K). The incident took place at Kandrodi Morr Nangal village of Pathankot, reported Hindustan Times.

The arrested suspects have been identified as Sahil Bhatia and Taranjeet Singh from SBS Nagar.

The police, as per **Hindustan Times** revealed to that the accused were en route to J&K to carry out the drug smuggling operation under the instructions of the notorious jailed gangster, Preet Sekhon.

Notably, Preet Sekhon is involved in around 20 criminal cases, including one where an Akali leader and his aide were shot dead in Patti back in 2019. Despite being in iail. Sekhon was running the drug nexus and maintaining contact with some J&Kbased smugglers.

The arrest was made after the SHO Nangal Bhur, acting on a tip-off about a Canter with registration number PB-29-X-1105, suspected of carrying narcotics into Pathankot from Mukerian side, led his team to intercept the vehicle.

#### Five injured in JK Road accident

JAMMU, Aug 3 (Agencies): Five persons were injured in a road accident that took place in the Kotranka area of Rajouri district on Thursday, officials said.

They said that the driver of the car lost control over the vehicle following which the car fell into a ditch in the Rehan area of Kotranka. Soon after the accident, the team of police station Kandi and local people started the rescue operation and took all the injured to District Hospital Rajouri for treatment.

## 181 children go missing from J&K from July 2022 to June 2023: Ministry of **Women and Child Development**

SRINAGAR, Aug 3 (Agencies): A total of 181 children have gone missing from Jammu and Kashmir from July 1, 2022, to June 30, 2023, reveals an official data of the Ministry of Women and Child Development. As per the data, nearly 58,546 children went missing across India during the same period.

Earlier, National Crime Record Bureau (NCRB) data revealed that 627 children had gone missing in J&K by 2020 that included 350 boys and 277 girls.

In 2020 alone, 230 children including 167 girls and 63 boys went missing in Jammu and



Kashmir.

The NCRB data suggested that the recovery rate of the missing children in J&K was a mere 29.2 percent.

Under Mission Vatsalya Scheme, 817 children including child labourers had been rescued and rehabilitated by Child Welfare Committees in J&K.

In the last five years, government the revealed that 35 children were booked under drug-related offences including the Narcotic Drugs and Psychotropic

Substances Act, 1985. Child Welfare Committee Chairperson, Khairul-Nissa told Greater Kashmir that they had custody of seven miss-

ing children currently. She said that the reasons behind missing children cases involving locals and non-locals differ significantly.

"Local children often leave their homes due to familial conflicts while non-locals primarily come for work opportunities," Nissa said.

"We are receiving cases of missing children, but mostly these cases are non-locals. Earlier, we registered missing cases of locals as well but they had been traced out within hours and the matter was resolved," she said. "Similarly, we are

#### NIA moves HC to produce malik virtually in plea seeking death for **JKLF Chief in terror funding case**

NEW DELHI, Aug 3 (Agencies): The NIA Wednesday moved the Delhi High Court seeking permission to produce virtually from jail Kashmiri separatist leader Yasin Malik in a terror funding case in which it has sought death penalty for him.

The application is listed for hearing before a bench of Justices Siddharth Mridul and Anish Dayal on August 3.

The high court had on May 29 issued a warrant for production of Malik, who is serving life term in the case in Tihar jail,

on August 9 when NIA's plea for enhancement of sentence is listed for hearing.

In an application seeking modification of the order, the investigating agency said Malik was a "very high risk prisoner" and it was imperative to not physically produce him in court in order to maintain public order and safety.

It also said that as per an order passed by the Home Ministry, Malik cannot be "moved from the Tihar Jail" and shall "not be taken out of the jurisdiction of NCT of

Delhi".

"Respondent/Convict Yasin Malik has been lodged in the Tihar Jail, New Delhi under the category of very high risk prisoners and thus, the present Application is in relation to a heavy security issue. Therefore, it is imperative that the Respondent/Convict Yasin Malik is not physically produced before this Hon'ble Court in order to maintain public order and safety," the application said.





## Since 2018, CBI filed cases against 216 civil servants: Govt

NEW DELHI, Aug 3 (Agencies): The Central Bureau of Investigation (CBI) has registered cases against 216 civil servants in more than five years, Rajya Sabha was informed on Thursday.

Giving a state-wise break-up, the government said 39 civil servants were from Maharashtra, 22 from Jammu and Kashmir. 21 from Delhi. 17 from Uttar Pradesh and 14 from Karnataka among others.

"During the last five years viz. 2018, 2019, 2020, 2021, 2022 and 2023 (up to 30.06.2023), the CBI has registered cases against 216 number of civil service officers," Union Minister of State for Personnel Jitendra Singh said in a written reply.

Of the total civil servants facing cases, 12 were from Bihar, 11 from Tamil Nadu, nine each from Gujarat, Haryana and Kerala, and eight each from Punjab, Rajasthan and Telangana, according to the reply.

"The All India Services (Con-



duct) Rules, 1968, and the Central Civil Services (Conduct) Rules, 1964, lay down the code of conduct for central government employees to which every member of the service shall, at all times, follow," Singh said.

The Lal Bahadur Shastri National Academy of Administration, Mussoorie, imparts training to officer trainees through appropriate courses keeping in view national aspirations and constant feedback,

he said.

"This also inter alia includes imbibing the spirit of nationalism, citizen centricity and financial integrity," the minister said.

"The government of India had approved the National Programme for Civil Services Capacity Building - Mission Karmayogi – in September 2020 with the objective to create a professional, well-trained and future-looking civil service, that is imbued with a shared

understanding of India's developmental aspirations, national programs and priorities," Singh said.

In another reply, the minister said that the CBI has registered 135 cases — regular cases and preliminary inquiries — against various civil service officers during 2018 to June 2023.

"Out of these 135 cases, charge-sheets have been filed in 57 cases in the courts concerned for trial," he said.

Of these cases, sanction for prosecution is pending for more than two years in two cases, Singh said.

In the last five years (2018 to 2022), the Central Vigilance Commission has recommended action against 12,756 officers during first stage advice and 887 officers during second stage advice, he said.

"Out of this, grant of sanction of prosecution was advised in respect of 719 officers," the minister added.

## 1,365 vacant posts in IAS, 703 in IPS: Govt

NEW DELHI, Aug 3 (Agencies): There are 1,365 vacancies in the Indian Administrative Service (IAS) and 703 in the Indian Police Service (IPS), Rajya Sabha was informed on Thursday.

Besides these, 1,042 vacancies exist in the Indian Forest Service

(IFS) and 301 in Indian Revenue Service (IRS). Union Minister of State for Personnel Jitendra Singh said in a written reply.

"Occurrence and filling up of vacancies is a continuous process. It is the endeavour of the central government to fill up vacant posts expeditiously," he said. The Union Public Service Commission (UPSC) conducts the

Civil Services Examinations (CSE) for filling up of vacancies on direct recruitment basis in civil services, including IAS, IPS, IFS and IRS, every year, he said.

"To fill up vacancies in

IAS and IPS promotion quota, selection committee meetings are held by Union Public Service Commission with state governments," the minister said.

The government has increased the annual intake of IAS officers to 180 through the CSE till CSE-2022, Singh said.

"Intake of IPS through the CSE has been increased to 200 from CSE-2020.

Intake of IFS has been increased to 150 in 2022. Department of Revenue has reported 301 vacancies for filling through CSE-2023," he added.

#### Tomatoes and turbulence: Indians face harder times

There is no getting away from the stream of images of chilling violence. Toxicity, fuelled by the contagious hate virus, is spreading faster in a society with an immuno-compromised system and fast losing its natural defences. Meanwhile, for ordinary Indians, the hard times are set to get even harder. On top of everything else, incomes are not rising, while the prices of basic food items soar. The headline-grabbing pricey tomato is just another marker of turbulence as climate change and weather shocks add to the turmoil and uncertainties ahead.

By now, everyone is aware of the tale of the tomato in India. Tomato prices have risen sharply in recent months, triggering tales of tomato thieves and tomato millionaires.

As I write, the police in Kolar, Karnataka, has launched an investigation into the missing case of a local truck carrying 11 tonnes of tomatoes worth Rs 21 lakhs. The truck was bound for Jaipur in Rajasthan. On July 31, the price of tomatoes rose to an all-time high at Rs 170 per kg in the Solan-based Agriculture Produce Market Committee (APMC), with a 24-kg crate fetching Rs 4,100. Tomatoes are now part of the subsidy regime in many states. The Tamil Nadu government, for example, has decided to expand the sale of tomatoes at a subsidised rate of Rs 60 per kilo through 500 ration shops across the state. In mid-July, the Union government also put out an official statement flagging its intervention of selling tomatoes at concessional rates at several locations in the country where the prices had reached alarming levels. Tomatoes are off the menu in many fast-food outlets in the country.

But while the everyday tomato has emerged as a star newsmaker, it is no longer just about tomatoes. So, whataboutery will not work.

Today, the rise in food prices is being driven by a spike in a host of other items, including other vegetables, pulses, cereals, and now even spices. Erratic and extreme weather, leading to shortages in supply and hoarding, have cumulatively pushed up prices of turmeric and ginger, two widely used spices in Indian cuisine. With Onam, a major harvest festival, around the corner, there are anxious reports in newspapers in Kerala about the soaring prices of vegetables, pulses and other essential commodities disrupting household budgets in the state. Onions are the latest on the hit list. Retail prices of onions have started clambering up for the first time in nearly two years in the wake of reports of sluggish kharif sowing due to a delay in the arrival of the monsoon in Maharashtra and Karnataka, two key onion producing states.

"Weaker monsoon rains in parts of India and floods in other areas contributed to soaring prices of vegetables, cereals, and pulses. Food, which makes up about half of the CPI (consumer price index) basket, pushed inflation to a threemonth high of 4.81 per cent in June," noted Bloomberg, a leader provider of business news and insights.

Arguably, weather shocks jolting food prices is not a uniquely Indian phenomenon. It is a global trend. But in India, with most of the population working in informal jobs with scant social protection, the knocks are harder than many other places. The alarming rise in the cost of tomatoes in India is just the trailer. Climate change

is affecting agriculture and consequently food prices with implications for food security.

We need to be well-prepared. The recently released "Asia-Pacific Disaster Report 2023" offers

some important insights.

"Drought, intense rainfall, and floods are already contributing to decreasing agricultural produce and surging food prices. Those most impacted by a decline in agricultural productivity will be the many farming communities living on the brink of poverty and the urban poor who are vulnerable to food price inflation...", notes the report, brought out the United Nations Economic and

Social Commission for Asia and

the Pacific (ESCAP). "Climate change-induced disasters pose an increasingly serious threat to Asia and the Pacific. The region remains the most disasterprone region in the world where two million people have lost their lives to disasters since 1970. In 2022, over 140 disasters struck the Asia-Pacific region, leading to over 7,500 deaths, affecting over 64 million people, and causing economic damage estimated at \$57 billion. Climate change is already affecting agriculture, including fisheries and livestock, across various economies and farming systems," the report adds.

As many experts have pointed out, rice and wheat, the region's staple crops, are particularly vulnerable due to their high-water dependency and heat stress and water scarcity resulting from climate change increases the risk of drought and crop loss, leading to higher food prices. The ESCAP report also points out that the decline in agricultural productivity due to climate-related hazards will have severe consequences for

food security, particularly for vulnerable farming communities and urban poor populations already living in poverty.

For context, in 2021, 418 million Asians experienced extreme hunger, indicating a rise from the previous year.

Many would argue that India is not among the worst-off as far as domestic food inflation goes. Venezuela, Lebanon, Zimbabwe, Argentina and Suriname are among the hardest-hit countries. But that is no consolation for ordinary Indian families struck by scorching food prices.

How the monsoon plays out in the coming weeks would be crucial. Till date, there has been uneven distribution of rain -- some parts of India being ravaged by incessant rains and intense floods while there are drought-like conditions in other places. We are already seeing the impact. The government has imposed export bans on non-basmati white rice varieties, hoping to stave off inflationary pressures on a diet staple. A July 20 statement by the ministry of consumer affairs, food and public distribution noted that this was done "in order to ensure adequate availability of non-basmati white rice in the Indian market and to allay the rise in prices in the domestic market".

The bottom line -- weather shocks are here to stay. Climate change is affecting the food that we eat in India.Our policies must factor that in. Farmers must get early warnings and be equipped to adapt to erratic and extreme weather. Agriculture provides employment to over 40 per cent of India's labour force. India may be in a geoeconomic sweet spot for now, but the everyday life of ordinary Indians will get grimmer if food inflation does not slow down.

## Buzz in Bengal on ex-CBI man as Mamata's security adviser

he recent appointment of former Karnataka DGP Rupak Kumar Dutta as security adviser to West Bengal chief minister Mamata Banerjee has stirred much interest and debate. His illustrious career as an IPS officer, having served in different capacities, including as special director of the Central Bureau of Investigation (CBI), adds intrigue surrounding his new role in the state.

Sources have informed DKB, that Mr Dutta's impressive credentials apart, the appointment assumes even greater significance given the recent security breach near CM Ms Banerjee's residence. The arrest of an individual carrying weapons and narcotics, and possessing fake identity cards of multiple security agencies, has heightened concerns about the state of security preparedness in West Bengal.

Some critics, however, view Mr Dutta's appointment with scepticism. His sudden transfer to the ministry of home affairs as special secretary, just before the selection of the CBI director, followed by his return to his home state of Karnataka to assume the role of state DGP, they say, point to a likely political motivation behind the decision. Although Mr Dutta had been offering advisory services to

the West Bengal government even before the panchayat polls, his formal appointment comes at a critical juncture. It is hoped that given his extensive background in the CBI, Mr Dutta will bring a unique perspective that enables the state government to tackle security-related issues effectively.

Demographer pays price for busting Swachh Bharat propaganda

The suspended director of the International Institute for Population Sciences (IIPS), K.S. James, is the most highly rated demographer in the country and among the leading ones in the world. So, naturally, his suspension has become the talk of Delhi's babu corridors.

The official reason cited for the suspension of Mr James was his alleged involvement in unauthorised research activities and financial irregularities at the IIPS. But those in the know say that Mr James was already facing fire for 'unflattering' data. Under Mr James, the institute, which is an organisation of the ministry of health and family welfare, conducts the National Family Health Surveys (NFHSs) and other sensitive topics such as the impact of government policies on population dynamics, public health and socio-economic inequalities.

The NFHS-5 survey, the

cause of Mr James' ouster, showed that anaemia had risen, and open defecation was still prevalent in all states despite the Swachh Bharat boasting.

The survey also showed that more than 40 per cent of households did not have access to clean cooking fuel thus questioning the claims of success of the Ujjwala Yojana. It said in rural areas, more than half the population, 57 per cent, do not have access to LPG or natural gas. Clearly, none of these findings will bring cheer to the Centre, as they bring to light certain inconvenient truths. The discomfort within the government can be gauged from the fact that some recent reports say that it was mulling to drop the anaemia measurement for NFHS-6.

Mr James' suspension is being viewed by many as a message to those who may wish to challenge official narratives: rebel at your own risk. Point taken?

The importance of being S.K. Mishra

The Modi Sarkar has gone to unprecedented lengths to retain Sanjay Kumar Mishra as the director of the Enforcement Directorate (ED). The government moved a special application in the Supreme Court citing "extraordinary and unusual" circumstances to allow his continuation in the post. Although few

observers buy the excuse that Mr Mishra's continuation is needed for the ongoing Financial Action Task Force (FATF) review, the apex court obliged and extended Mr Mishra's tenure till September 15, citing "public and national interest" even though earlier it had noted that the previous extension of tenure was "illegal". Clearly, Mr Mishra is a special case, according to the government.

The thing is that under Mr Mishra's tight control, the ED has acquired more powers and its investigations of Opposition leaders and critics of the government have led to allegations of "indiscriminate use" of the agency by the government against its detractors, even if the conviction rate in money laundering cases probed by ED remains dismal.

But what perhaps makes Mr Mishra the "ideal" babu in the eyes of the ruling party is that he maintains a low profile while making himself indispensable to those in power. Observers noted this trait in the officer even during the UPA days when he was reportedly close to the late Congress leader Ahmed Patel and Pranab Mukherjee. Apparently, during Pranab's tenure as finance minister, Mr Mishra was more powerful than even the then revenue secretary. Since then, he's come a long way and the ED has never been the same.

## 'I am a married man for 45 years, mujhe gussa nahi aata': Jagdeep Dhankhar says Rajya Sabha

NEW DELHI, Aug 3 (Agencies): Amid continuous acrimony between ruling BJP and INDIA alliance parties in Rajya Sabha, Chairman of the House Jagdeep Dhankhar on Thursday tried to create a lighthearted moment in the House when he said, "I am married for 45 years, I do not get angry," while responding to a remark by Leader of Opposition Mallikarjun Kharge.

Kharge was insisting that the business of the House be set aside to prioritise Rule 267, which allows for the suspension of rules to debate an urgent matter with the Chairman's approval.

"You said that to accept it, there should be a reason. I stated the reason. Yesterday, I requested you the same, but maybe you were angry," Kharge told the Chairman.

This led Dhankhar to respond saying: "I am a married man for more than 45 years, main kabhi gussa nahi karta (I never get angry). Trust me," and the



House burst into laughter.

In the midst of the light-hearted banter, Dhankhar continued with a touch of humour, "Mr Chidambaram is a very distinguished senior advocate we know, as a senior advocate we have no right to show our anger, at least to authorities. You are an authority. Isko modify kardo thoda. (Please modify this statement)."

Then Kharge, too, responded in an equally lighter vein, saying: "You don't get angry, you don't

show anger, but you get angry from inside."

However, before this Dhankhar and Kharge exchanged barbs over the former's refusal to direct the Prime Minister to come to the House for a discussion over Manipur.

The Opposition and the Government agreed to hold a discussion on the violence in Manipur. Dhankhar stated that he will call the floor leaders of parties to his chambers at 1 pm and "accommodate a discussion on

Manipur irrespective of time and other constraints."

Following this, Kharge suggested that the House be adjourned till 1 pm. He went on to say, "Sir, you don't agree to such small requests. We asked for the Prime Minister to come, you didn't agree to that either. You are defending the PM so much...I don't understand."

On this Dhankhar said, "Our Prime Minister does not need to be defended by me. He has come to be recognised on global platforms — Senate and Congress in the US... Every Indian should be proud of him... Why are you shirking from the hard reality, India is rising as never before. The rise is unstoppable... Everyone has contributed to it. I am not required to defend anyone."

"After three decades of coalition government under the PM, I am not required to defend anyone. I am required to defend the Constitution. I am required to defend your rights," Dhankhar added

#### Allahabad High Court allows ASI survey at Gyanvapi mosque



PRAYAGRAJ, Aug 3 (Agencies): The Allahabad High Court on Thursday dismissed a petition filed by the Gyanvapi committee challenging a district court order directing the Archaeological Survey of India (ASI) to conduct a survey to determine if the mosque was built

upon a temple.
It said the district court order is just and proper, and no interference from this court is war-

ranted.

The Varanasi district court had on July 21 directed the ASI to conduct a "detailed scientific survey" – including excavations, wherever necessary — to determine if the Gyanvapi mosque located next to the Kashi Vishwanath temple is built upon a temple.

The Anjuman Intezamia Masjid committee, which manages the mosque, had moved the

high court on July 25, a day after the Supreme Court halted the ASI survey till 5 pm on July 26, allowing time for the committee to appeal against the lower court's order.

Allahabad High Court Chief Justice Pritinker Diwaker had reserved the order on the mosque committee's petition on July 27 after hearing arguments from both sides.

Dismissing the petition on Thursday, the high court said there is no reason not to believe the ASI's assurance that the survey would not cause any damage to the structure.

It asserted that no digging should be done at the mosque as part of the survey.

The order of the district court for a survey on the disputed premises is just and proper, and no interference from this court is warranted, it added.

#### 17 injured in clashes in Manipur's Bishnupur; day curfew reimposed in Imphal valley

IMPHAL, Aug 3 (Agencies): Seventeen people were injured in clashes as the Army and RAF personnel fired teargas shells at Kangvai and Phougakchao area in Bishnupur district on Thursday, officials said.

The district magistrates of Imphal East and Imphal West also withdrew curfew relaxations announced earlier, imposing the restrictions during the day as a precautionary measure, on top of the night curfew throughout the Imphal valley.

Hours before the clashes, a planned

mass burial of Kuki-Zomi people killed in Manipur's ethnic violence was stalled after the state's High Court on Thursday morning ordered status quo to be maintained at the

proposed burial site in

Churachandpur district. The ITLF, an apex tribal body, also said it was postponing the burial of 35 people at the site in Haolai Khopi village of Churachandpur district, on the border with Bishnupur.

Tension has been brewing since morning in Bishnupur district as thousands of locals

came out on the streets to block the movement of security forces.

Locals led by women tried to pass the barricade put up by the Army and RAF personnel, demanding that they be allowed to go to Tuibuong, the burial site.

During the day, the state government withdrew curfew relaxations in Imphal East and West districts as a precautionary measure.

The district magistrates of Imphal East and West issued separate orders reimposing the day curfew apprehending disturbance.

## 1 killed, 6 injured as girder launcher falls on workers in Gujarat's Vadodara

VADODARA, Aug 3 (Agencies): One worker was killed and six others injured after a girder launcher fell on them during the construction of a high-speed rail corridor for the upcoming bullet train project near Karjan town in Gujarat's Vadodara district on

Thursday, officials said.
The incident occurred near Kambola village in the morning, they said.

It took place two days after a girder launcher collapsed in neighbouring Maharashtra killing 20 persons, including 10 labourers, during the construction of a viaduct for the Samruddhi



Expressway in Thane district early on Tuesday.

"Construction work for the Mumbai-Ahmedabad bullet train corridor is currently under way at Kambola village of Karjan taluka. Due to some technical issues, a girder launcher fell on workers," Karjan MLA Akshay Patel, who rushed to the spot after the incident, told report"Of the total seven workers who got crushed under the metal structure, one died on the spot, while others were pulled out safely and referred to a hospital," he said.

Soon after being alerted, personnel of the local fire brigade as well as police rushed to the spot and started a rescue operation. In a statemen

In a statement, the National High Speed Rail Corporation Limited (NHSRCL), which is executing the Mumbai-Ahmedabad High Speed Rail Corridor, said one worker who was trying to check the wheelbase got trapped and died.

"Today, in the MAHSR C-4 package of Mumbai-Ahmedabad High Speed Rail Corridor construction site in Karjan near Vadodara, a girder launcher after successfully completing 14 km of girder launching had reached its new launching location near Vadodara," it said.

The launching gantry was shifted on top of the girder transporter to the launching location. While self-unloading from the girder transporter, the wheelbase of the front support got jammed and got inclined, thereby disturbing a part of the launching gantry, it said.

"One worker, who was trying to check the wheelbase, got trapped and died. Six other workers, who suffered minor injuries, were admitted to a nearby hospital. NHSRCL senior officials have already reached the site," it said.

#### Noted Marathi poet Namdeo Dhondo Mahanor passes away

PUNE, Aug 3 (Agencies): Noted Marathi poet and lyricist Namdeo Dhondo Mahanor, popularly known as Na Dho Mahanor, died in a hospital in Maharashtra's Pune city on Thursday morning due to old age-related ailments, a family member said.

#### 1 person killed, 2 injured as truck overturns on Mumbai-Pune Expressway; traffic affected

MUMBAI, Aug 3 (Agencies): A person was killed and two others received injuries when a speeding glassladen truck overturned after hitting another truck on Mumbai-Pune Expressway in Maharashtra's Raigad district in the wee hours of Thursday, police said.

Vehicular movement on a Mumbai-bound lane was affected for a few hours it was closed between 5.30 am to 8.30 am to remove the truck and the glass material scattered on the road, an official said The accident took place when the truck carrying the glass material rammed into another truck from its rear side and then overturned on the expressway in Khopoli area, he said.

Three persons received serious injuries and were taken to hospital. One of them, identified as Sadanand Patil (43), driver of the glassladen truck, succumbed to injuries during treatment, the official said.

The Mumbai-bound lane was opened for traffic after 8.30 am and the vehicular movement was slow, he said.

## Chhattisgarh man with mental health problems kills wife, 3 daughters

JANJGIR, Aug 3 (Agencies): A man with mental health issues allegedly killed his wife and three daughters with a hoe, an agricultural tool, in Chhattisgarh's Janjgir-Champa district, the police said on Thursday.

The incident took place on the night of July 31 at Devri village under Pantora police post but it came to light on Wednesday following which the suspect, Deshraj Kashyap, was arrested, Janjgir-Champa Superintendent of Police Vijay Agrawal said

The deceased were identified as Kashyap's wife Mongra Bai (40) and their daughters Puja, alias Kalyani (16), Bhagya Lakshmi (10) and Yachna (6), he said.

As per preliminary information, Kashyap lived with mental health problems and had been undergoing treatment for the last 10 years, he said.

Kashyap returned home on July 31 after visiting a doctor in neighbouring Bilaspur district.

The same night, he allegedly killed his wife

and three daughters with a hoe and left the house after locking the gate, he said.

Suspecting something was fishy as no one from the family was seen in the house for two days, the village head informed the police on Wednesday.

The police found four bodies in the house and shifted them for postmortem, he said.

The exact reason for the murders is yet to be ascertained, said the official, adding a case had been registered against Kashyap.

## Body of minor girl recovered from brick kiln in Rajasthan's Bhilwara; locals allege rape and murder

Locals allege that the girl was raped before she was thrown into the kiln

JAIPUR, Aug 3 (Agencies): The burnt body of a 14-year-old girl has been recovered from a brick kiln in Bhilwara district of Rajasthan, police said today.

Locals alleged that the girl was raped before she was thrown into the kiln.

Late on Wednesday night, while looking for the girl who went missing in the morning, her family spotted her footwear near a brick kiln. On peeping inside, they found her bangle and a few bones, the police said.

Locals caught hold of a few persons of the Kalbelia nomadic tribe, suspecting their involvement in the crime, and handed them over to the police, they said.

Around four to five people from the nomadic community who operate the kiln and live near it have been detained and are being interrogated at the Kotda police station, they added.



BJP leader Kalulal Gurjar who reached the village and met the victim's family alleged that the girl was raped and her body burnt in the

Gurjar alleged that the police did not act

promptly in the case and detained the suspected accused only after the villagers caught them.

Police said they had not yet ruled out the possibility of rape in the matter, adding that further probe is on.

## ED conducts fresh searches in money-laundering case against Tamil Nadu minister V Senthil Balaji

CHENNAI, Aug 3 (Agencies): The Enforcement Directorate on Thursday conducted fresh searches in connection with its ongoing money-laundering investigation against Tamil Nadu minister V Senthil Balaji and others, official sources said.

They said premises linked to some entities being probed in this case and alleged benamidars (in whose name a benami property is standing) were being raided in Coimbatore and Karur.

Balaji continues to be a minister without portfolio in the Tamil Nadu government even after his arrest by the ED on June 14 in a money-laundering case linked to an alleged cash-for-jobs scam in the



Tamil Nadu transport department. The federal probe agency told the Supreme Court on Wednesday that Balaji was preventing it from exercising its right of custodial interrogation and the apex court reserved its verdict on the pleas of the DMK leader and his spouse challenging his arrest. The top court had on July 21 sought the ED's response on the petitions filed by Balaji and his wife Megala challenging the July 14 order of the Madras High Court upholding his arrest by the probe agency in a money-laundering case.

The minister and his wife have filed two separate petitions in the top court challenging the high court order.

## Should Trump go to jail? 2024 election could become a referendum on that question

Critics have long alleged that Trump's fear of prosecution was a chief motivator for his decision to mount another campaign

NEW YORK, Aug 3 (Agencies): The 2024 election will determine whether former president Donald Trump returns to the White House. It could also decide if he will face time behind bars.

Now slapped with his third criminal indictment—this time for his efforts to overturn the 2020 election and block the transfer of presidential power for Trump, winning is about more than ego, redemption, score-settling or the future of the United States.

"This election may very well be about Donald Trump's personal freedom," said Ari Fleischer, a longtime Republican strategist. "It is not an exaggeration to say, if convicted, he could be sentenced to prison unless he wins and he uses the levers of justice to reverse it or stop it or drop it."

The deeply personal stakes for Trump add to what is already an election unlike any other in modern history. It is now not only a debate over the country's challenges, but a partisan fight over whether the 77-yearold former president and GOP frontrunner should spend time in prison. Putting that issue out front, Trump ally Rep. Marjorie Taylor Greene, R-Ga., tweeted that she "will still vote for Trump even if he's in jail".

Critics have long alleged that Trump's fear of prosecution was a chief motivator for his decision to mount another campaign. While Trump denies that insisting that charges never would have been brought had he decided against runningthe new indictment ensures his campaign and legal issues are now intertwined.

"The legal messaging is the political messaging and the political messaging is the legal messaging," Trump campaign spokesman Steven Cheung said of the new reality. "It is part of what we are running on. Trump has made the legal issues a big focus of his campaign and from our standpoint, it is messaging that works."

The combined 78 state and federal charges against Trump are already dominating his stump speeches as he seeks to portray himself as the victim of a politicised Justice Department bent on damaging the prospects of President Joe Biden's chief political rival. At his rallies, he tries to frame the charges as not



just an attack on him, but his supporters.

"They are not indicting me, they are indicting you," he told the crowd at a weekend rally in Erie, Pennsylvania.

On a more practical level, Trump is confronting an unprecedented balancing act, campaigning while facing possible trials in at least three different jurisdictions.

He will appear in federal court in Washington on Thursday to face the latest charges, before headlining an Alabama Republican Party dinner on Friday. He faces another arraignment next week in Florida after special counsel Jack Smith filed additional criminal charges against him there in the case related to his handling of classified documents. That will come between a campaign stop in New Hampshire and a possible trip to the Iowa State Fair.

Trump also faces the potential of new charges in Atlanta related to efforts to overturn the 2020 election results in Georgia and must also decide whether to attend the first Republican presi-

dential debate on August 23. Trump campaign officials said they were not worried about such logistical challenges.

"President Trump's campaign will not be impacted by the deep state's efforts at election interference no matter how hard they try," said Trump senior campaign adviser Jason Miller, who, like others, argued Trump and his team are well-practised at being on defence.

Cheung noted that, to date, no campaign events had been rescheduled or cancelled because of legal proceedings and that, if anything, more stops have been added.

"It is full speed ahead," he said before the latest indictment.

But the challenge for Trump goes beyond politics. Each of the cases against him—ranging from the classified documents case in Florida to allegations in New York of making

improper hush-money pay-

ments to women and the indict-

ment released on Tuesday—will

require intense preparation.

"Obviously, under normal circumstances, it is impossible to prepare for more than one criminal trial at a time," said Barry Boss, a leading white-collar criminal defence attorney. "Usually that is overwhelming in and of itself. So the notion of having multiple indictments that you are facing is just to me incon-In general, rules require defendants in federal cases to be present for major events like their initial appearances and when a verdict is returned, but give them leeway to decide when else to appear.

"There are some people who are very engaged in their defence and want to talk to you every day, and there are others that leave it to you and will be available if you need them," Boss said.

The investigations are also dominating Trump's campaign spending. So far this year, the former president's political operation has spent more on legal fees defending him, his staff and his allies than on travel, rallies and other campaign expenses combined, an AP analysis

Under Department of Justice guidelines, sitting presidents are generally shielded from indictment and criminal prosecution. But winning back the White House would not protect Trump indefinitely.

If he is elected anew, he could direct his attorney general to dismiss the federal cases, fire prosecutors or test the limits of presidential power by trying to pardon himself. But those efforts would only apply to the federal cases, not the state criminal charges he faces in New York or could face in Georgia.

Even if Trump does not end up the nominee, a different Republican president would likely face enormous pressure from Trump to drop the charges to placate his supporters—a type of pressure no president has faced since Gerald Ford pardoned his predecessor, Richard Nixon, for his Watergate crimes.

In all, "It is extraordinarily bad news and the impact internationally would be devastating. That is why people need to come to their senses," said John Bolton, Trump's former national security adviser and now critic, who believes the reality heightens the pressure on Republicans to find an alternative candidate. "Somebody better take the initiative and say we are heading off the edge of a cliff here."

But so far, Trump has faced little political fallout from his indictments, his big lead over Republican challengers even growing as they struggle to respond. At the same time, he has used the prospect of jail time to try to raise cash.

The "Department of Justice" he complained in a recent fundraising email, "is trying to put ME in JAIL for the rest of my life as an innocent man". Other solicitations have arrived with subject lines like "re: 400 YEARS in prison".

Fleischer said voters will begin to view Trump's legal triumphs and losses through the lens of the campaign.

If charges in one case are dismissed, for instance, "it will be like he won this legal primary", and if a judge rules against him, "people will feel like he lost the first day of the court primary".

Fleischer said that if Trump ends up having to spend significant time in court, he can imagine the former president holding forth on the courthouse steps, telling voters watching at home, "I am not on trial, you are on trial. And I am in this courtroom fighting for you.

"It can take him off the road, but he just has another platform on which to have his voice be heard. To him it is all one campaign."

#### 'No good options': Sudan's warring sides have committed 'extensive war crimes', says Amnesty

CAIRO, Aug 3 (Agencies): A leading human rights group said on Thursday Sudan's warring parties have committed "extensive war crimes" including mass killings of civilians, rape and sexual slavery of women in the ongoing conflict.

The east African country plunged into chaos in mid-April when monthslong tensions between the military and the paramilitary Rapid Support Forces exploded into open fighting in the capital of Khartoum, and elsewhere across the country.

Amnesty International's 56-page report said civilians were deliberately targeted and killed and wounded. Women were raped, with some of them held in conditions "amounting to sexual slavery" mostly in the capital, Khartoum, and the western region of Darfur.

"Sexual violence has been a defining element of this conflict since the beginning," Donatella Rovera, coauthor of the report, told The Associated Press. "Civilians really have no good options. It's difficult for them to leave. It's incredibly dangerous for them to stay.'

Almost all rape cases were blamed on the RSF and its allied Arab militias. The report said the RSF abducted 24 women and girls -- as young as 12-- and held them "for several days during which they were raped by several RSF members."

Rovera said that war crimes such as sexual assault are happening, "on what seems to be a large scale." While the RSF, which was born out of the notorious Janjaweed militias, was also blamed for most of the deliberate attacks and rape cases, some members of the military were accused of the crimes, Amnesty said.

Responding to the report, the military said they had established a unit to ensure targeted

decisions to minimise civilian harm while the RSF denied allegations of sexual violence, as well as carrying out violent acts in West Darfur.

The conflict has turned Khartoum and other urban areas into battlefields. Darfur — which had been the scene of genocidal war in the early 2000s - saw some of the worst bouts of violence with the current fighting turning into ethnic clashes.

The fighting forced about 4 million people to flee their homes either to safer areas inside Sudan or to neighbouring countries, according to the UN migration agency.

The violence in Darfur was mostly blamed on the RSF and its allied Arab militias who the group said targeted the African Masalit community in the region. The group, however, said armed men from the Masalit allegedly also targeted Arabs suspect-

ed of siding with militias. Amnesty detailed waves of violence in West Darfur province -one of five constituting the Darfur region — including the killing of civilians, looting and destruction of homes and facilities such as the main hospital and markets.

The killing of West Darfur Gov. Khamis Abdalla Abkar on June 14 — following his detention by the RSF - promoted an exodus of many members of the African Masalit community to eastern Chad, which turned into an open camp for those who fled the fighting in Darfur, Amnesty said.

"Civilians throughout Sudan are suffering unimaginable horror every single day," said Agnès Callamard, the group's secretary general. He called on the warring sides and their affiliated groups to "end their targeting of civilians, and guarantee safe passage for those seeking safety."

On April 20, an attack in Khartoum's southern neighbourhood of Kalakla killed three children from the same family as they tried to escape the gunfire, the group said, adding that it was not able to determine which side was responsible for the killing.

Amnesty quoted Kodi Abbas, a 55-year-old teacher, whose two sons and nephew were killed, as saying they "were small and couldn't run away fast enough... I don't know who shot them. The war killed them.'

The group said it also documented an attack by the RSF on the complex of the Mar Girgis Coptic church in Khartoum's Bahri district. RSF members in a pick-up vehicle stormed the church shooting five members of the clergy, and stole money and a gold cross, the report said citing witnesses.

"They were shouting and insulting us - saying things like, Egyptian dogs and sons of dogs' and asking for money and gold," an unnamed survivor was quoted by the human rights group.

Amnesty's report was the latest one documenting atrocities in Sudan's conflict.

Last month, Human Rights Watch called for the International Criminal Court to investigate atrocities in Darfur including "summary executions" of around three dozen of 28 non-Arab tribesmen in a Darfur town.

The United Nations Human Rights Office said a mass grave was found outside Geneina with at least 87 bodies, citing credible information. And the International Criminal Court's prosecutor, Karim Khan, told the UN Security Council in July they were investigating alleged new war crimes and crimes against humanity in Darfur.

"There are allegations that this could be ethnic cleansing," said Rovera, "the situation is a very difficult one, is a very dangerous one because it can escalate further."

## China proposes to limit children's smartphone time to a maximum of 2 hours a day

Restrictions are Beijing's latest efforts to attempt to limit internet addiction, a problem it views as widespread among its youth

BEIJING, Aug 3 (Agencies): China's internet watchdog has laid out regulations to curb the amount of time children spend on their smartphones, in the latest blow to firms such as Tencent and ByteDance, which run social media platforms and online games.

The Cyberspace Administration of China on Wednesday published the draft guidelines on its site, stating that minors would not be allowed to use most internet services on mobile devices from 10 p.m. to 6 a.m., and that children between the ages of 16 and 18 would only be able to use the internet for two hours a day

Children between the ages of 8 and 15 would be allowed only an hour a day, while those under 8 would only be allowed 40 minutes.

Only certain services,



such as apps or platforms that are deemed suitable to the physical and mental development of minors, will be exempted. The CAC did not specify which internet services would be allowed exemptions.

The restrictions are Beijing's latest efforts to attempt to limit internet addiction, a problem it views as widespread among its youth. In 2019, Beijing limited children's daily online game time to 90 minutes a day and tightened those restric-

tions in 2021, allowing children only an hour a day of online game play on Fridays, weekends and public holidays.

Short-video and

online video platforms like Douyin, Bilibili and Kuaishou have offered youth modes that restrict the type of content shown to minors and the length of time they can use the service. Children are also pushed educational content. such as science experi-

The latest restrictions

would impact firms like Tencent, China's largest online game company, and ByteDance, which runs popular shortvideo platform Douyin. Firms in China are often responsible for enforcing regulations.

"To effectively strengthen the online protection of minors, the CAC has in recent years pushed for the establishment of a youth mode on internet platforms, expanding its coverage, optimising its functions and enriching it with age-appropriate content," the CAC said.

"Since the mode was launched, there has been a positive impact in reducing youth internet addiction and the impact of undesirable information," it added.

The CAC said draft guidelines were open to public feedback until September 2. It did not say when the new rules would be into effect.

## Imran Khan's Pakistan Tehreek-e-Insaaf could be declared ineligible for election symbol, warns ECP

The top electoral body asks PTI Chairman Imran Khan to appear before it on Friday

ISLAMABAD, Aug 3 (Agencies): The Election Commission of Pakistan (ECP) has warned the former ruling party, Pakistan Tehreek-e-Insaaf (PTI) that it could be declared "ineligible" to obtain election symbol over its failure to hold intra-party elections, Geo News reported.

In a notice issued on Wednesday, the top electoral body summoned PTI Chairman Imran Khan to appear before it on Friday, "failing which the Commission under Section 215 (5) of the Elections Act, 2017, may declare your political party ineligible to obtain elec-Geo News reported. tion symbol for future election(s)".

The ECP referred to its earlier notices and said the PTI's intra-party elections were due on June 13 in 2021 under



the party's constitution. It added the PTI was "intimated/reminded" to conduct intra-party elections within the timeframe provided under sections 208, 209 and 215 of the 'Elections Act. 2017 but the party failed to "provide the requisite certificate to this effect",

The polls organising authority also said it issued final notice to the PTI in May last year for ensuring the conduct of intra-party elections "on or before June 13, 2022 (extended date) with the observation that no further extension shall be allowed".

After the notice, PTI submitted a copy of the amended party's constitution which was deemed "insufficient" by the electoral body.

The ECP referred to Section 209(1) of the Election Act saying every registered political party is bound to provide the ECP with a certificate regarding the conduct of the intraparty elections as provided by law, as per Geo News.

"(...) if any political party fails to comply with the provisions of the said section 209, this Commission is empowered to declare the said political party ineligible to obtain an election symbol," Geo News quoted the notice.

Last month, the ECP instructed political parties to submit their applications for the allotment of elections symbols ahead of general polls in the country scheduled for later this year.

The ECP had directed the parties to attach a list of symbols they prioritise along with their applications, adding that the signature of the party leader is a must.

In 2018, the PTI was allotted a "bat" symbol to contest the general elections, Geo News reported.

#### **NIA moves HC to produce** malik virtually in plea seeking death for JKLF Chief in terror funding case

caused to the State as well as the society if the request is not accepted, the application said, "Hon'ble Court may graciously be pleased to modify the Order dated 29.05.2023 passed by this Hon'ble Court to the effect that the Respondent Yasin Malik be produced through the video conferencing facility from Tihar Jail, New Delhi".

Recently, the presence of the jailed separatist leader in the Supreme Court had created a flutter, prompting Solicitor General of India Tushar Mehta to flag a "serious security lapse" to Union Home Secretary Ajay Kumar Bhalla.

Malik apparently appeared before the top court on July 21 in connection with the CBI's appeal against a September 20, 2022 order of a trial court in Jammu in the 1989 kidnapping of Rubaiya Sayeed, the daughter of then Union home minister Mufti Mohammad Sayeed.

He was brought to the high-security apex court premises in a prison van escorted by armed security personnel without the court's permission.

Later that week, the Department of Delhi Prisons suspended four officials over Malik's physical appearance before the top court and ordered an inquiry into the lapse. On May 29, the high court had issued notice to Malik on NIA's plea seeking death penalty for him in the terror funding case and said, "Let warrants of production be issued against Mr. Yasin Malik, before this Court on the next date of hearing. List on

On May 24, 2022, the trial court had awarded life imprisonment to the JKLF chief after holding him guilty of various offences under the stringent anti-terrorism law-the Unlawful Activities (Prevention) Act (UAPA), and the IPC.

Malik had pleaded guilty to the charges, including those under the UAPA, and was convicted and sentenced to life imprison-

Appealing against the sentence, the NIA as said a terrorist cannot be awa sentence only because he has pleaded guilty and chosen not to go through trial.

While seeking enhancement of the sentence to death penalty, the NIA has said if such "dreaded terrorists are not given capital punishment on account of pleading guilty, there would be complete erosion of the sentencing policy and terrorists would have a way out to avoid capital punishment".

A life sentence, the NIA has asserted, is not commensurate with the crime committed by terrorists when the nation and families of soldiers have suffered loss of lives, and that the trial court's conclusion that Malik's crimes did not fall within the category of the "rarest of the rare cases" for grant of death penalty is "ex-facie legally flawed and completely unsustainable".

The agency has emphasised that it has been proved beyond reasonable doubt that Malik spearheaded terrorist activities in the Kashmir Valley, and with the help of dreaded foreign terrorist organisations, had been "masterminding, planning, engineering and executing armed rebellion in the Valley in an attempt to usurp the sovereignty and integrity of a part of India".

"Not giving capital punishment to such dreaded terrorist will result in miscarriage of justice, as an act of terrorism is not a crime against society but it's a crime against the entire nation; in other words it's an act of 'external aggression', 'an act of war' and an 'affront to the sovereignty of nation'," the NIA plea said.

The trial court, which rejected the NIA's petition for capital punishment, said the crimes committed by Malik struck at the "heart of the idea of India" and were intended to forcefully secede Jammu and Kashmir from Union of India.

It had, however, noted the case was not the "rarest of rare" to warrant death penalty.

## India's services sector growth climbs to 13-year high in July on pick-up in international sales: PMI

The seasonally adjusted S&P Global India Services PMI Business Activity Index rises from 58.5 in June to 62.3 in July

NEW DELHI, Aug 3 (Agencies): India's services sector growth touched a 13-year high in July as a substantial improvement in demand conditions and pick-up in international sales induced the strongest increase in new business and output, a monthly survey said on Thursday.

The seasonally adjusted S&P Global India Services PMI Business Activity Index rose from 58.5 in June to 62.3 in July, signalling the sharpest increase in output since June 2010.

"The resilience of the service sector underscores its vital role in fuelling India's economy,

with the PMI results for July so far pointing to a notable contribution from the sector to overall GDP for the second fiscal quarter," Pollyanna De Lima, Econom-

ics Associate Director

at S&P Global Market

Intelligence, said. According to survey members, the upturn was largely attributed to demand strength and new business gains.

Demand for Indian services improved to the greatest extent in over

13 years during July, with around 29 per cent of survey participants reporting higher intakes of new business.

"The broad increases in sales across the domestic and international markets are particularly welcoming news, especially in light of the challenging global economic scenario.

Firms noted a widespread upturn in services exports to several nations including Bangladesh, Nepal, Sri Lanka and the UAE," Lima said.

On the inflation front, cost pressures intensified and monitored companies signalled greater food, labour and transportation costs. Despite the rise in cost pressures, charges were raised to a weaker extent as firms were cautious about their pric-

ing strategies. "Looking at PMI price indices in recent months, it seems that competitive advantage

continued to support demand for Indian services, with increases in output prices here modest relative to several other nations," Lima said.

Although input cost inflation ticked higher in July, service providers were again cautious in their price-setting decisions amid efforts to not deter sales, Lima added.

On the job front, companies continued to add to their workforces by hiring a combination of part-time, full-time, permanent and temporary staff. Service sector employment expanded at a slight pace that was broadly similar to those seen in the prior two months.

On the year-ahead outlook for business activity, service providers on average were optimistic. Growth expectations stemmed from forecasts of demand strength and marketing initiatives.

## Rupee falls 5 paise to 82.72 against US dollar

MUMBAI, Aug 3 (Agencies): The rupee depreciated 5 paise to 82.72 against the US dollar in early trade on Thursday as a negative trend in domestic equities and firm crude oil prices weighed on investor sen-

Sustained foreign fund outflows, strength of the American currency in the overseas market further dented sentiments, forex traders said.

At the interbank foreign exchange, the domestic unit opened at 82.71, then touched 82.72, registering a decline of 5 paise over its last close.

On Wednesday, the rupee had settled at 82.67 against the

dollar, registering a fall of 45 paise from its previous close.

This was the biggest singleday fall for the rupee in nearly six months.

The Indian currency had witnessed the steepest intra-day fall of 68 paise on February 6, when it had settled at 82.76 against the greenback.

The rupee was trading in a negative note on risk aversion in global markets and weak Asian currencies.

There was also downside pressure on the local unit due to strong dollar against major rivals overseas, traders said.

The dollar index, which gauges the greenback's strength against



a basket of six currencies, rose 0.10 per cent to 102.68.

#### **Hepatitis B and Liver Cancer: Strategies** for prevention and screening

NEW DELHI, Aug 3 (Agencies): Hepatitis B is a type of virus that can cause severe liver infection with serious complications such as liver cancer. Liver cancer, especially hepatocellular carcinoma (HCC), is the second most prevailing cause of cancerrelated deaths, wherein Hepatitis B is responsible for over 50% of HCC cases. However, with suitable preventative methods and timely screening, the effects of Hepatitis B-related liver cancer can be significantly reduced. Here is some valuable information from Dr. A Satya Srinivas, a Medical Oncologist and Consultant at the HCG Cancer Centre in Vijayawada.in Vijayawada.

Screening Strategies 1. Testing and Diagnosis: Hepatitis B screening includes blood tests to identify hepatitis B surface antigen (HBsAg), hepatitis B e antigen (HBeAg), and hepatitis B virus DNA. These tests help identify people with chronic hepatitis B infection and guide further treatment.

2. Regular Monitoring: Individuals with chronic hepatitis B should have their liver function tests, viral load, and alphafetoprotein (AFP) levels checked regularly to detect any signs of liver damage or progression



to liver cancer.

3. High-Risk Populations: Screening should be prioritised for people born in hepatitis B-endemic areas, those with a family history of liver cancer, and those with a history of injectable drug use or multiple sexual partners. Healthcare practitioners must also be diligent in recognising at-risk persons and prescribing appropriate screening proce-

4. Primary Care Integration: Integrating hepatitis B screening into routine primary care settings can enhance access and early detection. This can be accomplished by developing standardised screening techniques and ensuring proper follow-up for people who have chronic hepatitis B infection.

Comprehensive preventative services that involve early screening of pregnant women, antiviral medication for moms with high virus loads, and prompt vaccination of infants can greatly minimise mother-to-child transmission.

3. Safe Injection Practices and Blood Screening: Hepatitis B can be transmitted through infected needles, syringes, and blood products. Secure injection practices and blood screening are critical. To prevent

hepatitis B transmission, using sterile needles and syringes, promoting safe injection practices, and thoroughly screening blood and blood products are essential. 4. Awareness and

Education: It is critical to raise awareness about Hepatitis B transmission, preventative techniques, and the significance of regular screening. Educational initiatives aimed at high-risk communities, healthcare providers. and the public can help with hepatitis B identification and prevention.

### How exposure to toxic chemical products can impact reproductive health

NEW DELHI, Aug 3 (Agencies): Toxic chemicals are present everywhere around us and they enter our bodies through the air, water, food, and the consumer products used daily. Exposure to these sources that contain toxic materials not only has a detrimental effect on health but also

impairs a person's fertility. India Today spoke to Dr Sandeep Talwar, Fertility Specialist, Nova Southend Fertility and IVF, Delhi

to get more insight on this. A toxic material is one that can be dangerous or have negative health effects. Household cleaners, prescription and over-the-counter medications, petrol, alcohol, pesticides, motor oil, and cosmetics are all potentially harmful. Phthalates, a type of plastic-related chemical, are found in toys, bottles, and medical equipment.

It is also utilised to provide scent and is found in air fresheners and personal care goods. In addition, toxic chemicals such as PFAS (poly-fluoroalkyl substances) are found in a wide range of consumer products, such as menstruation products, canned foods, receipts, cosmetics, food containers, nonstick pans, and many others.

These supplies contaminate our food resources and leach into our water sources, posing a significant concern to human health.

Environmental pollutants can affect female reproduction directly (hormone disturbance) or indirectly (immune toxicant). If an environmental chemical is structurally close to an endogenous molecule and is capable of entering reproductive organs, it leads to a direct impact.

Indirect effects may arise if a substance requires metabolic conversion within the body before it may exert an adverse effect. For example, some phytoestrogens are not considered hazardous until they

are bioactivated in the gastrointestinal system or liver. Additionally, indirect effects can also be caused if a toxin interferes with natural hormones.

Natural hormones are essential for appropriate development, behaviour, puberty, sexual function, and gametogenesis. Some environmental pollutants may disrupt normal hormone action, thereby negatively affecting reproductive processes.

Particularly sensitive groups include developing fetuses, newborns, kids, preteens, and teenagers. With the help of experimental research, scientists have discovered that when pregnant rats are exposed to phthalates, it hampers the testosterone production in their male offspring, resulting in a variety of genital abnormalities and sperm issues.

Phthalates are a class of chemicals that are recognised endocrine disruptors but are commonly utilized as plastic softeners and lubricants in personal-care items. Phthalates exist in various household items, medications, cleansers, and personal care products in order to make them flexible, durable, and aromatic.

They easily escape as vapours or particles from these goods. Bio-monitoring has revealed that women of reproductive age have greater phthalate levels and thus are at a higher risk of fertility problems than the population, at large, as young women use more goods such as perfume, deodorant,

shampoo, and conditioners. PFAS substances are another compound detected in drinking water. Certain levels of PFAS exposure have been associated with a decrease in fertility and elevated blood pressure in pregnant

As pregnant women consume more water than normal people, it is assumed that they are at a higher risk of pollution.

Furthermore, several studies conducted on PFOS and PFOA, encompassing both human and animal studies, have revealed a broad spectrum of potential health consequences.

These include reduced fertility in women, decreased sperm count and penis size, diminished birth weight, and an increased risk of cancer. Bisphenols-A (BPA) function as endocrine disruptors, imitating estrogen in the body and potentially leading to detrimental health effects

In contrast to pharmaceuticals, the majority of environmental chemicals have been introduced into the market without thorough and standardised information regarding their potential long-term toxic effects, particularly on reproductive health.

It is crucial for the government to tackle this issue. At an individual level, exposure to phthalates can be minimised by adopting certain practices. These include using unscented lotions and laundry detergents, microwaving food in glass containers, choosing cleaning supplies that are scent-free, and avoiding air fresheners and

Additionally, adopting a diet that focuses on consuming more fruits and vegetables, washing hands before meals to prevent chemical ingestion of dust, removing shoes before entering the home, and vacuuming with a HEPA filter are effective precautionary measures for maintaining good health.

It is also important to be cautious when making purchasing decisions. There is a need to search for and buy things with less packaging. For cleaning purposes, vinegar or baking soda should be used instead of artificial, scented cleaning products.

Asian Champions Trophy: Eye final touches before big-ticket Asian Games

cies): Tournament favourites and three-time champions India will look to give final touches to their Asian Games preparation in the Asian Champions Trophy beginning here today.

World No. 4 India are the highest ranked side in the tournament and will open their campaign against China at the Mayor Radhakrishnan Stadium here, which is hosting a major event for the first time since 2007. It is also the first time that India are hosting the ACT since the tournament's inception in 2011.

For India, the primary objective in the tournament would be to test the players and get a fair bit of idea about their main rivals ahead of the Asian Games, to be held in Hangzhou, China, from September 23 to October

With the Asian Games providing a direct ticket to next year's Paris Olympics, India are expected to test their resources in the ACT while also playing a balancing act to keep their players fresh and free from injuries.

India captain Harmanpreet Singh has already clarified that the team will have to be smart in this tournament and will not go all-guns-blazing as its priority is the Asian Games.



India might have gained both in terms of ranking and respect in world hockey, but the Tokyo Games bronze medallists fared poorly in the FIH World Cup cohosted by Bhubaneswar and Rourkela earlier this year.

The Indians finished a disappointing ninth in the World Cup. But since then, the Harmanpreet-led team has played 16 games, winning nine and losing five, along with a couple of draws. India come into the tournament straight from a fournation tournament in Spain.

The one area India will be looking to address in the tournament is their penalty corner conversion rate. Despite boasting of potent drag-flickers in Harmanpreet, Varun Kumar, Amit Rohidas and Jugraj Singh, the conversion rate has been a topic of debate lately.

But coach Craig Fulton is not losing sleep over it. "We have a world-class penalty corner specialists. I think we can always improve. It's just how much detail we want to go into and how much time we put into improving it," he said.

India won the event in 2011, 2016 and 2018. They also won silver in 2012 and bronze in 2021. China, on the other hand, would be playing their first competitive tournament this year, having missed the World Cup.

India could travel to Pak if Asiad bid fails, says HI prez

Hockey India president Dilip Tirkey today said that the national men's team will travel to

Pakistan for the Olympics qualifiers in case it fails to secure a direct berth by winning gold at the Asian Games. "We will be trying to get the job done in Hangzhou," Tirkey said. "But, if for some reason, we fail to qualify, then there are a couple of venues that have been identified for the qualifiers — Pakistan and Spain. So, wherever it happens, we will definitely go," he added. Travelling to Pakistan requires government clearance. pti

Young Pakistan relishing India

Tasked with the duty of guiding his country's premier talents, Pakistan's assistant coach Rehan Butt cannot wait for the India game to start. Pakistan play India in a high-profile match on Ausgust 9. "I have heard that tickets have been sold out for the India-Pakistan clash. There is a lot of following for this game and it is time the bilateral hockey relations resumed between the two nations," he said. Pakistan have sent a young side for the ACT and their focus is to prepare the side for the Asian Games in September. "Since we have a young side facing world No. 4 India, pressure will of course be on the players," Butt said. "But India will be under pressure too, for they are playing on their turf."

## Moeen Ali reiterates retirement from Tests, not to travel to India next year



LONDON, Aug 3 (Agencies): Confirming that the fifth Ashes Test against Australia was the last traditional format match of his career, England all-rounder Moeen Ali said he will not travel to India next year for a Test series.

India will host England for a five-match Test series across January and March 2024.

"There is no way I am going (to India). It is nice to finish like this. Test cricket is the best cricket. I wish I could rewind time," Moeen was quoted as saying by the Guardian.

Moeen has played 68 Tests for England making 3,094 runs with five hundreds and 15 fifties. The off-spinner also has taken 204 wickets in

Despite the fine record, Moeen accepted the fact that his Test career would have hit a higher

Test cricket.

"Although my Test career has been a bit up and down, I wouldn't change it. I loved it. I would have regretted (not accepting England's recall) later in life. It was quite daunting because I've never done well against Australia. I had nothing to lose -- it

was a free hit," he said. The 36-year-old, though, has no plans to move away completely from cricket as he wants to concentrate on franchise cricket.

Moeen has done well for Chennai Super Kings in the IPL, while making his presence felt in other leagues like the PSL

and the Hundred. "White-ball (cricket) is great. I love the leagues, but there is nothing better than playing against the best attack with a new ball in their hand. It's a challenge," he said.

England gave a fitting send-off to Moeen as he led the side out of the Oval with Stuart Broad, who had also announced his retirement after the fifth Ashes Test. Moeen said it was indeed nice of Broad to allow him to walk beside him.

"It proves the man he is. I didn't want to do it and he said I had to. From the start, he was always amazing with me. I've always got on well with him and really pleased he's finished the way he has," he
