Does Sunak have no fashion sense...or is he simply behind the times?

edgie Sunak, his Tory Party still way behind Labour in the polls, is now announcing policies which he calculates will restore the Tory fortunes. He almost did when, in February, he renegotiated the deal with the EU on the BoJo-botched Northern Ireland Brexit Protocol. He negotiated his altered deal with the EU in Windsor and, using the presence of King Charles III, called it the Windsor Framework. It seemed popular but then the Democratic Unionist Opposition party of Northern Ireland refused to accept all of it. Its instrumentality in the Tory resurgence was therefore short-lived.

Nevertheless, this week Hedgie announced new policies. His government will go ahead with building new houses -- popular. It will also expand the exploitation of North Sea oil and gas -- some critics say that would be environmentally damaging, but does the voting populace care? Probably not, if it reduces gas prices.

And of course, the "Stop the Boats" bill which was passed in Parliament is still, however, nasty and impractical, but is being played as Hedgie's trump card. Critics say this "Illegal Immigration Bill" is a stunt that can't be practically implemented.

This week its stratagems suffered a setback. Cruella Cowardperson (Oh, OK... Suella Braverman), the home secretary, has requisitioned large ocean barges to house asylum-seekers while their claims are examined. This, she says, will save the taxpayer millions of pounds spent on the accommodation, etc, of these wretched exiles. Now the fire service has publicly declared that the recently hired barge is a death trap. Cruella has been thinking again (it's commonly accepted that thinking needs a brain) and is going to commandeer surplus Army tents.

Even with all this turmoil, effort at electoral redemption and debate, two items about Hedgie surfaced in the national news this week, one routine and the other one curious. The other item is, as national commentary, a bit strange but much more interesting.

Hedgie constantly prefers to wear expensively tailored trousers, the bottoms of which don't drape in small crumples over his shoes but hang a few inches above his ankles. When he sits down, the trouser-legs climb to reveal socks and half his shins.

But why? There is speculation that Hedgie, who is shortish, mistakenly believes that this trouserly-shortcoming makes him look taller. If he does, perhaps he should use a full-length mirror more often. The idea that the richest British PM in history is trying to save on a few inches of cloth to lower the price of his hand-tailored suits is patently absurd. Dismissed!

Now Derek Guy, a men's fashion expert, contends in The Times that Hedgie's fashion sense is stuck in the year 2000, when, for a brief time, short trousers were the vogue.

Guy contends that Hedgie is fashion-conscious, but 23 years out of date. As proof, he quotes the brand name of the shoes that Hedgie wears. Again, fashionable in 2000 (AD, that is). So is Hedgie's idiosyncrasy an oversight, following advice from some analyst of the voting intentions of the fashion freaks, or just that Hedgie is behind the times. Now, gentle reader, I don't know if all males have some shameful or embarrassing episode to do with trousers, but I certainly have had at least two in my short and happy existence. I was fourteen years old when I finished school in Poona -- now Pune -- and enrolled in college. I always wore shorts, as did most of my classmates, to school. The only occasions to wear long trousers, of which I must have had a single pair, was to go to the fire temple on Parsi New Year or perhaps to go to a Parsi wedding celebration and wear them instead of the dark velvet shorts.

I was a very odd man out and endured the embarrassment while I saved up for weeks to buy myself some nondescript, in-fashion trousers.

Beijing's 'wolf warriors' in fresh games: Watch out!

The abrupt replacement by the Communist Party of China (CPC) of its foreign minister Qin Gang, who had served just over six months, and around whose fate there had been considerable speculation before his late July ouster, should make New Delhi ponder on what's really going on in the Middle Kingdom. The return of longtime foreign minister Wang Yi, the tallest living Beijing "wolf warrior" diplomat with a history of abrasive and arrogant interactions with Indian and Western representatives, is reason enough for watchfulness. Mr Wang, previously a State Councillor as well, was "promoted" as head of CPC's Central Foreign Affairs Commission, a post that he continues to hold, making him a kind of "super foreign minister". India's national security adviser Ajit Doval, who met Wang Yi in South Africa in late July, on the sidelines of a Brics meeting, just a day before the latter returned as foreign minister, can testify to the nature of Mr Wang's doublespeak. The two have a long history -- they have had regular interactions as Special Representatives of their countries on the India-China boundary question, under a mechanism set up in 2003. And just prior to the Doval encounter, Mr Wang met external affairs minister S. Jaishankar in Jakarta, on sidelines of the Asean Regional Forum. At both meetings, Wang spelt out China's line: that both countries should find a mutually acceptable solution to the border problem, normalise ties on all other issues like trade, without letting "specific issues" define the overall relationship. This, of course, was completely unacceptable to New Delhi, especially after the betrayal, treachery and deception by the CPC's People's Liberation Army at Galwan in June 2020, and the unresolved aggressive stand by the CPC/PLA in eastern Ladakh for the past three years.

Just look at Mr Wang's record: It's not just New Delhi and Washington which have faced the brunt of Beijing's targeted lies and ire -he's audacious enough to sermonise Seoul and Tokyo with racial "nose and hair comparisons" alluding to those of Korean and Japanese ethnicity in comparison, of course, to the "superior" Han people! violation of sovereignty.

Mr Jaishankar, in Jakarta, made it clear that till there was "peace and tranquility" at the border, there couldn't be any progress in ties. India's NSA, in Johannesburg, too told Mr Wang that the PLA's incursions at the Line of Actual Control in Ladakh since 2020 had "eroded strategic trust and the public and political basis of the relationship' in India, and till this and other "impediments" were restored, there couldn't be any normalisation of ties. China, of course, wants its companies and citizens to do unhindered business in India, for Xiaomi, Oppo, Vivo, Huawei and Meizu to sell their telecom products and MG its cars and vehicles (that don't match up to their Japanese and Korean rivals), and a plethora of inferior consumer goods and be allowed to take locals for a ride, to defraud the Indian exchequer through non-payment of taxes and money-laundering and let Chinese nationals buy land next to India's military installations for 24/7 espionage. Contextually, one really wonders about the psyche and motivation of a section of unscrupulous traders in this country who virtually work as a pressure group for Beijing, against their own country's interests. Are they now so addicted to China's cheap goods to make high profits, almost like the Chinese were once addicted to the opium consumption thrust on them by the British Raj in India? Regrettably, most Indians can't read Chinese minds, see through their psyche, and anticipate the CPC's malice owing to their lamentable lack of knowledge about Chinese history and culture. Having been almost continuously betrayed by the Dragon since the 1950s, Delhi is inexorably digging its own grave. At a time when much of the world's finally woken up to China's unci-

vilised diplomacy and perfidy, the West's pushback has started crystallising, responding to complaints even from American farmers that China is quietly buying thousands of acres of rural farmland and building bases near military installations. Beijing is brutally bypassing diplomatic norms to directly approach Western corporations, offering morsels and urging them to betray their own governments and do business directly with Beijing. From the EU to the US, India to Africa, virtually every country is under malicious attack from the CPC. The United States, like India, is under pressure from its businessmen to avoid "unnecessary conflict" because of cash-for-profits. India must remember that it doesn't have the vast land mass of the US or Europe's 27-member EU. For India, it is 24/7 Chinese betrayal. Just last week, Chinese vice-premier He Lifeng celebrated the 10th anniversary of the China-Pakistan-Economic-Corridor (CPEC) in Pakistan, which together have been consistently trampling upon India's sovereignty. Can India compromise with its sovereignty for the sake of few unscrupulous traders and lopsided investments which bring substandard goods to Indian consumers? Understandably, the Dragon is gleefully exploiting India's sorry history of a love of all things foreign. Nevertheless, it must be remembered, India's Constitution doesn't have any provision to concede land to any foreign nation. If needed, it must amend the Constitution to do so. Delhi today, therefore, must bluntly tell CPC overlord Xi Jinping and his "new" foreign minister Wang Yi that India's sovereignty and territorial integrity remains non-negotiable. The days of "one-way" Chinese business is over. India cannot trade its territorial integrity, violating its own Constitution and sovereignty.

India's foreign minister and NSA have had the misfortune of bearing the brunt of hearing the "old tape recorded" cacophonic semantics of the irrational thoughts of "His Master's Voice". The same nagging, bragging and repetitive monologues faced (for years) by every Indian delegation to China or to multilateral meetings. Can Indians recall the condescending, choreographed and patronising words of previous Dragon "diplomats" in New Delhi's Chanakyapuri: Luo Zhaohui and Sun Weidong? "Let's forget the border dispute; Beijing and Delhi have more in common than a mere land dispute; let not our differences spill over into dispute; we should do more for convergence of interests rather than divergence, for our mutual benefit as Asian giants".

This is what Mr Wang told Mr Jaishankar in Jakarta in mid-July: "Our two sides should support, rather than suspect, each other. We must focus our energy and resources on development, and not let specific issues define the overall relationship". The parting shot was like a "warning" to India: Forget about the border: China was not going to relinquish control anytime soon. And "specific issues" related to border violations, the killing of Indian soldiers, the pitching of permanent PLA tents deep inside Indian territory and other cases of

Govt fails to give 27% reservation to OBCs, **implement Forest Rights Act on ground: Manjit**

JAMMU, Aug 5: Apni Party Provincial President, Jammu, and Former Minister, Manjit Singh has raised serious concern over unnecessary delay in complete implementation of Forest Right Act and granting of 27% reservation to the OBC community in Jammu and Kashmir even after four years after the abrogation of Art 370 and Art 35A from the erstwhile State.

Addressing a press conference here at Apni Party Office in Gandhi Nagar, Jammu; the Former Minister Manjit Singh the Govt had promised that the marginalized section of society, OBC, tribals, and other forest dwellers would get benefits under the constitution since they termed the special status of Jammu and Kashmir as an obstacle in the implement of all the central laws.

However, these laws were still not implemented in Jammu and Kashmir except those which were suitable to the Govt, he added.

"Before the abrogation



of special status, the people were promised that OBC will get 27% reservation in Jammu and Kashmir. However, four years have passed yet OBCs have yet to get 27% even after four years," he said, while criticizing the Govt. He said that these

promises remained unfulfilled and the OBC community which is spread in a vast area of Jammu and Kashmir has been deprived of what they deserve as per the constitution.

Therefore, the Govt should focus on the fulfilment of the promises made with the OBC community for their social, economic and

political upliftment. He also referred to the growing concerns of the Tribals, and other forest dwellers in J&K who were promised that they would be given right on the forest land under Forest Right Act in Jammu and Kashmir

following the abrogation of Art 370 and Art 35A. "With much pump and show, the Forest Right Act (FRA) was implemented on papers in J&K, and accordingly, the committees were constituted. Unfortunately, these commit-

tees did not implement the FRA on the ground because they did not give FRA rights to the tribals or the other forest

dwellers despite getting all the documentary records. Thus, the tribals and forest dwellers were deprived of their constitutional right to use the forest land for their livelihood and for their cattles," he said.

He further stated that the delaying tactics has given rise to the resentment among the OBCs, and Tribals/Forest Dwellers because the promises which were made to them before August 5, 2019 remained unfulfilled and these people feel cheated by the Govt."

He said that "The uneasiness and feeling of alienation among the people is growing

because the Govt implemented only those laws and schemes in J&K following the abrogation of Art 370 and Art 35A which were suitable to them and ignored other constitutional rights which could be beneficial for the people of Jammu and Kashmir." He questioned the Govt. what is stopping them from implementing the remaining central laws in Jammu and Kashmir which could be beneficial for all the people of Jammu and Kashmir. Therefore, he demand-

ed that the Govt should implement all the central laws in Jammu and Kashmir so that the people can get the benefits.

He also said that the people of J&K were desperately waiting for the holding of Assembly Elections and restoration of statehood in Jammu and Kashmir that was assured on the floor of the Parliament of India to the people of this state.

He said that the Punjabi language should also be recognized in J&K as one of the official languages by the Govt.

Bhargav Mishra's body was found hanging from the ceiling fan of his paying guest room in Mahaveer Nagar area here around 8.30pm on Friday, they added.

This is the eighteenth case of suspected suicide so far this year by coaching students preparing for competitive examinations here.

A resident of Champaran district in Bihar, Mishra came here in March this year. He was a student of Class 12



Mentally-ill man kills parents in Uttar Pradesh, relative says was PUBG addict

Delhi court accepts Jagdish Tytler's bail bond in 1984 anti-Sikh riots case

NEW DELHI, Aug 5 (Agencies): A Delhi court on Saturday accepted a bail bond furnished by Congress leader Jagdish Tytler in a case connected with the Pul Bangash killings during the 1984 anti-Sikh riots.

Tytler's wife, Jennifer Tytler, stood security for him in the case. The judge will now hear the matter on August 11. Trump, in fiery speech in Alabama, boasts he needs 'one more indictment to close out this election'

MONTGOMERY, Aug 5 (Agencies): Former US president Donald Trump, fresh off his third appearance in court as a criminal defendant, delivered a speech full of defiance and bluster on Friday night, insulting prosecutors and declaring that the charges he faces only help his 2024 presidential campaign.

"Any time they file an indictment, we go way up in the polls," Trump said at a Republican Party dinner in Alabama. "We need one more indictment to close out this election. One more indictment, and this election is closed out. Nobody has even a chance.'

Trump pleaded not guilty on Thursday to crimes related to his efforts to overturn the results of his 2020 election loss. Although it is his third criminal indictment this year, this case is the most serious, with the federal government he once ran charging him with orchestrating a scheme to block the peaceful transfer of power.

But Trump was characteristically unapologetic as he took the stage on Friday night to Lee Greenwood's "God Bless the USA", flashing a thumbs-up at the crowd, raising his fist and taking in a standing ovation of nearly three minutes.

"We are gonna be here for a little while," he joked, asking the crowd to take a seat.

The latest set of charges focuses on the two months between his November 2020 loss to Democrat Joe Biden and the January 6, 2021, insurrection at the US Capitol. Trump has denied wrongdoing and wedded his 2024 presidential campaign to his legal defence and his false claims of 2020 election fraud.

In a sign of that defiance, his campaign released an online ad on Friday attacking Justice Department special counsel Jack Smith, who led the inves-

The ad, which is expected to start airing on television next week, also attacks Manhattan District Attorney Alvin Bragg, who has charged Trump in a hush money case, and Fulton County District Attorney Fani Willis, who is believed to be close to filing charges in her investigation into efforts by Trump and his allies to overturn the 2020 election results in Georgia.

A Trump aide said the ad will start airing on Monday and Tuesday in Washington, DC, New York, Atlanta and on national cable. The ad was also shown to the crowd at the Alabama dinner on Friday night.

Trump has continued to receive endorsements from GOP elected officials throughout the investigations and criminal cases, including on Friday from all six of the state's Republican US House members.

Senator Tommy Tuberville of Alabama, who is waging an unprecedented campaign to try to change Pentagon's abortion policy by holding up hundreds of military nominations and promotions, introduced Trump at the dinner on Friday night.

"He has had a tough week. We need to stand behind him,' Tuberville said. "He needs been making a play for Super Tuesday states. In Alabama, though, one gauge of interest does not bode well for the governor: The state GOP sold about 1,000 fewer tickets for a similar dinner in March when DeSantis spoke.

Robin Rowan, the owner of a financial company, wore a button and sash with Trump's image and "NOT GUILTY" emblazoned in sequins as she waited on Friday to hear Trump speak.

Rowan, who does not believe the criminal accusations against Trump, said the charges have galvanised support for Trump rather than making voters doubt him.

"We know the truth. They are trying to wear us down. They are not going to wear us down," Rowan said.

Rich Foster, a retired police officer wearing a black "Bikers for Trump" T-shirt, said he believes some crimes were committed on January 6, such as the attacks on police officers defending the Capitol, but does not consider Trump responsible for the violence that happened. "I do not think Trump commit-

ted a crime that day," Foster said. He said he believed that Trump, as president, had a right to speak out about the election. Trump has not been charged

with inciting the attack, but prosecutors accused him of exploiting the violence and chaos at the Capitol to continue making false claims of election fraud and trying to halt the certification of the election results.

Foster said he and other Trump supporters viewed the charges as an attempt to keep Trump from winning in 2024. He said he would write in the former president's name if he had to.

"If they get him off the ballot somehow," he said, "I know how to write Donald J Trump on the ballot."

ISLAMABAD, Aug 5 (Agencies): A court in Pakistan on Saturday sentenced Imran Khan to three years in prison in a corruption case in which the embattled former prime minister is accused of profiting from selling expensive state gifts when he was in power.

Saudi Arabia urges its citizens to quickly leave Lebanon

BEIRUT, Aug 5 (Agencies): Saudi Arabia called on its citizens to guickly leave Lebanese territory and to avoid approaching areas where there have been armed clashes, the Saudi embassy in Lebanon said in a statement.

The kingdom did not specify which areas in Lebanon that it was advising its citizens to avoid. The embassy stressed "the importance of adhering to the Saudi travel ban to Lebanon," the statement added.

Kuwait also issued an advisory early on Saturday calling on Kuwaitis in Lebanon to stay vigilant and avoid "areas of security disturbances" but stopped short of asking them to leave the country, according to a statement by the

Kuwaiti Foreign ministry posted on X. On Aug. 1, the United Kingdom also updated its travel advice for Lebanon, advising against "all but essential travel" to parts of Lebanon's south near the Palestinian camp of Ain el-Hilweh.

At least 13 people, most of them militants, were killed in fighting that broke out in the camp on July 29 between mainstream faction Fatah and hardline Islamists, security sources in the camp said

Ain el-Hilweh is the largest of 12 Palestinian camps in Lebanon, hosting around 80,000 of up to 250,000 Palestinian refugees countrywide, according to the United Nations' agency for refugees from Palestine.

Blasts in Crimea, officials report Ukraine drone attack

MOSCOW, Aug 5 (Agencies): Explosions were heard near the bridge linking Russian-occupied Crimea to the Russian mainland early on Saturday, Russian-appointed officials reported, saying the blasts were linked to a Ukrainian drone attack on a Russian tanker. Russia's sea rescue service in the Black Sea port of Novorossiysk said tugboats were dispatched to help the tanker, which was damaged and unable to operate on its own. "We can say that the tanker is damaged in the (Kerch) strait, only on the south side," Russia's Tass news agency quoted the rescue centre as saving. "They will deal with it now on whether to take it under tow or not. It is standing at anchor for the moment. The machine room suffered some damage, not too badly.' Overnight a Russian warship was seriously damaged in a Ukrainian naval drone attack on Russia's navy base at Novorossiysk, the first time the Ukrainian navy has projected its power so far from the country's shores. Russia-installed officials in the Crimea peninsula, annexed by Moscow in 2014, said the latest explosions had nothing to do with the bridge, which has come under serious attack twice in the 17-month-old Russian invasion of Ukraine.

The 70-article draft law sets out a range of proposals, including much longer prison terms for women who refuse to wear the veil, stiff new penalties for celebrities and businesses who flout the rules, and the use of artificial intelligence to identify women in breach of the dress code.

Experts say the Bill, which is vet to be passed, is a reminder to Iranians that the regime will not back down from its stance on the hijab despite the country's enormous protests last year, according to CNN.

The Bill was submitted by the judiciary to the government for consideration earlier this year, then forwarded to Parliament and subsequently approved by the Legal and Judicial Commission. It is set to be submitted to the Board of Governors this Sunday before it is introduced on the floor of Parliament, statealigned news agency reported.

Iran's Parliament would work on finalising the text and voting on the Bill "in the next two months", Mehr said.

Amini, a 22-year-old Kurdish-Iranian woman, died last September after being detained by the regime's infamous morality police and taken to a "re-education centre", allegedly for not abiding by the country's conservative dress code, agency reported.

While not officially disbanded, the morality police had largely pulled back following last year's protests, which have gradually waned. But earlier this month, police spokesman General Saeed Montazerolmahdi said the morality police would resume

The hijab has long been a point of contention in Iran. It was barred in 1936 during leader Reza Shah's emancipation of women until his successor lifted the ban in 1941. In 1983 the hijab became mandatory after the last shah was overthrown in the Islamic Revolution of 1979, agency reported.

Iran has traditionally considered Article 368 of its Islamic penal code as the hijab law, which states that those in breach of the dress code face between 10 days to two months in prison, or a fine between 50,000 to 5,00,000 Iranian rials, what is

more severe offence, punishable by a five-to-ten-year prison sentence as well as a higher fine of up to 360 million Iranian rials (USD 8,508).

That fine is far beyond what the average Iranian could pay, as millions are below the poverty line, Hossein Raeesi, an Iranian human rights lawyer and adjunct professor at Carleton University in Ottawa, Canada, told agency.

Another section states that in order to enforce the new law, Iranian police must "create and strengthen AI systems to identify perpetrators of illegal behaviour using tools such as fixed and mobile cameras".

Earlier this year, state media reported that cameras would be installed in public places to identify women who violate the country's hijab law, CNN reported.

Under the new draft law, business owners, who do not enforce the hijab requirement, will face steeper fines, potentially amounting to three months of their business profit, and face bans on leaving the country or participating in public or cyberactivity for up to two years.

Australian court overturns law banning Sikhs from carrying kirpans in schools

MELBOURNE, Aug 5 (Agencies): A court in Australia's Queensland state has overturned a law that banned Sikh students to wear a kirpan, a religious article in Sikhism, on campus, calling the legislation "unconstitutional", according to media reports.

The ruling by the state's highest court came after

The spokesman also said that the roads leading to the PDP headquarters near Sher-e-Kashmir Park were sealed and no staffer was allowed to enter the office.

The National Conference (NC) also said that its party headquarter Nawa-i-Subah was "sealed" and no one was allowed to go inside.

"True to form and in keeping with the clampdown on mainstream democratic activities organised by parties opposed to 5th Aug 2019, the JKNC office has been sealed by the police. No one is being allowed in or out of the office," it said in a social media post.

Global food prices rise after India restricts rice exports and Russia ends grain deal

Local food prices are still rising in many developing countries because their currencies have weakened against the dollar, which is used to buy grain and vegetable oil.

LONDON, Aug 5 (Agencies): Global prices for food commodities like rice and vegetable oil have risen for the first time in months after Russia pulled out of a wartime agreement allowing Ukraine to ship grain to the world, and India restricted some of its rice exports, the UN Food and Agriculture Organization said.

The FAO Food Price Index, which tracks monthly changes in the international prices of commonly traded food commodities, increased 1.3 per cent in July over June, driven by higher costs for rice and vegetable oil. It was the first uptick since April when higher sugar prices bumped up the index slightly for the first time in a year.

Commodity prices have been falling since hitting record highs last year in the wake of Russia's invasion of Ukraine. Disrupted supplies from the two countries exacerbated a global food crisis because they're leading suppliers of wheat, barley, sunflower oil and other affordable food products, especially to nations in parts of Africa, the Middle East and Asia where millions are struggling with hunger.


The world is still rebounding from those price shocks, which have increased inflation, poverty and food insecurity in developing nations that rely on imports.



Now, there are new risks after Russia in mid-July exited a deal brokered by the UN and Turkey that provided protections for ships carrying Ukraine's agricultural products through the Black Sea.

Along with Russian attacks on Ukrainian ports and grain infrastructure, wheat and corn prices have been zigzagging on global markets. International wheat prices rose by 1.6 per cent in July over June, the first increase in nine months. FAO chief economist Maximo Torero said.

More worrying is India's trade ban on some varieties of non-Basmati white rice, prompting hoarding of the staple in some parts of the world. The restrictions imposed late last month came as an earlier-than-expected El Niño brought drier, warmer weather in some parts of Asia and was expected to harm rice



More expensive rice "raises substantial food security concerns for a large swath of the world population, especially those that are most poor and who dedicate a larger share of their incomes to purchase food," the organization said in a statement. It will be especially challenging for sub-Saharan Africa because it's a key importer of rice, Torero told reporters.

Even sharper was the jump in vegetable oil prices as tracked by the FAO, rising 12.1 per cent last month over June after falling for seven months in a row.

The organization pointed to a 15 per cent surge in sunflower oil prices following "renewed uncertainties" about supplies following the end of the grain deal.

"While the world has adequate food supplies, challenges to supplies from major producers due to conflict, export restrictions or weather-induced production shortfalls can lead to supply and demand imbalances across regions," said Torero, the FAO chief economist.

That will lead to a "lack of food access because of increasing prices and potential food insecurity."

He noted that global food commodity prices are different than what people pay at markets and grocery stores. Despite prices plunging on world markets since last year, that relief hasn't reached households.

Local food prices are still rising in many developing countries because their currencies have weakened against the dollar, which is used to buy grain and vegetable oil.

"That transmission from lower commodity prices to the final consumer prices, which include other components like logistics and other products we produce - bread, for example - is not yet happening in developing countries," Torero said.

Moving back to higher food commodity prices "could make this lack of transmission take longer than expected," he said.

Govt defers laptop import curbs till Nov 1

NEW DELHI, Aug 5 (Agencies): In a big relief to consumers and big laptop manufactures, the government has deferred import restrictions on laptops, all-in-one personal computers, and tablets. As per the guidelines provided by the Directorate General of Foreign Trade (DGFT), the import of these devices can be carried out without requiring a valid licence until October 31.

This means the mandatory requirement of licence for bulk imports of computers, laptops and tablets would come into effect from November 1, 2023. The government has announced restrictions on imports of computers, laptops and tablets in order to give a boost to local manufacturing. However, the decision created a lot of concerns over potential disruption in the supply of these goods during the festive season when significant sales of electronic items take place. There were also concerns that prices will shoot up ahead of the festive season.

Earlier, the officials from the Ministry of Electronics & Information Technology (Meity) had said there will be no disruption to goods in transit, and that tech companies will get sufficient time to apply for the license, and it can easily be applied online.

The Meity officials told media that companies will get the licence within 10-15 minutes after applying on the DGFT portal. The official said one company can apply for as many licenses with different branches and cities. "The prices of these goods - laptops, tablets, personal computers, etc won't rise and there will be no disruption to goods in transit," said the official

Meanwhile, experts are of the view that the abrupt decision to curb imports of personal computers, laptops, or tablets may have stemmed from the need to boost production-linked incentive (PLI) scheme 2.0, which has been a slow starter. After the successful implementation of the scheme for mobile manufacturing, the government launched a similar scheme for large hardware. However, it didn't achieve the same level of success as the mobile scheme. Therefore, in June 2023, the government re-launched the scheme doubling the incentives to Rs 17,000 crore.

As per Meity officials, only two companies have filed applications under the scheme as of July 31. Companies can file their application till August 30. Experts believe the decision to curb imports of these devices can pose challenges for companies, which do not opt for the PLI scheme for large electronics and fail to tie-up with Indian contract manufacturers.

Type 2: Diabetes on rise among children

NEW DELHI, Aug 5 (Agencies): Shubham was 16 when he was diagnosed with type 2 diabetes mellitus (T2DM), traditionally seen in adults. His weight had increased from 100 kg to 128 kg during the pandemic lockdown due to increased intake of junk food and decreased physical activity. He had breathing issues, darkening of skin and a family history of diabetes and heart disease.

Doctors are seeing a rising number of T2DM cases among adolescents in the last seven to eight years. Post pandemic, the number has increased manifold. Children as young as 10, mostly obese, are being diagnosed with T2DM. The number of pre-diabetes cases is also rising among adolescents and can



not show symptoms. So, it's best to be oactive and get an evaluation done if the child is overweight.

CHANDIGARH, Aug 5 (Agencies): Chandigarh-based skin specialist Dr SD Mehta feels perturbed when he sees his patients handing over mobile phones to their children as young as two. "This is leading to many problems such as obesity as well as behavioural and psychological issues. Parents may find it convenient to hand over mobiles but kids can get addicted and that's as bad as drug addiction. During Covid, it was unavoidable but now parents must wean their kids away." As childhood obesity cases in India record a sharp rise, increasing consumption and easy availability of junk food as well as lack of physical activity have emerged as the key reasons. Most experts

Obesity In children and adolescents, it has emerged as the primary factor. Excess weight leads to insulin resistance (in this condition, pancreas produce excess insulin to keep blood glucose levels normal), a precursor to T2DM. Eventually, the pancreas get exhausted and pre-diabetes develops. If not checked in time with lifestyle modifications and in some cases medication, it develops into type 2 diabetes.

Besides a sedentary lifestyle and unhealthy diet, other factors fuelling this rise in obesity in younger population include:

Family history Chances of obesity and diabetes are more in children and adolescents if parents have similar medical issues. Family history increases the chances of diabetes among adolescents or young.

Sleep As young people get by on less sleep due to various reasons, this has altered sleeping habits and disturbed sleep patterns, raising stress levels that cause altered hormonal response, and leads to weight gain.

Wrong Social perceptions In Indian society, thinness is equated with weakness and having some fat is considered healthy. We are genetically prone to accumulate fat. Most studies say Indians are predisposed to developing metabolic issues like T2DM or heart disease. Obesity acts as a catalyst and magnifies the underlying problems. The combination of diabetes and obesity, known as diabesity, is dangerous.

Symptoms

The usual diabetes symptoms in adults like increased thirst, dryness of mouth, frequent urination, fatigue, unexplained weight loss, skin infections and blurring of vision are present in adolescents, too, but not in all cases. Darkening of skin at back of neck, armpits and groin may be a sign of insulin resistance and may be present even before the onset of T2DM. Its presence should alarm parents. It's important to remember that sometimes children may

Related complications Untreated or poorly controlled diabetes can cause complications like retinopathy or eye disease, nephropathy or kidney disease, heart disease, stroke, etc. These complications can occur at a much earlier age than traditionally seen in older adults.

In young girls, PCOD is often a related complication; sometimes PCOD is present before type 2 diabetes. PCOD is integrally related to insulin resistance. Many studies have shown that girls with PCOD have a manifold risk of developing type 2 diabetes later in life. Regular screening of thyroid, lipid, insulin-resistance profile is advised in overweight children.

Diabesity and COVID-19

Experience during the pandemic has shown that in infectious illnesses, the outcomes are much worse in those having diabetes or obesity. As the lockdown led to a more sedentary life, obesity cases increased. In most obese persons, inflammatory markers in blood were more, there was less oxygenation of lungs, and a severe Covid. This led to more use of steroids as a life-saving measure. This, too, has precipitated and triggered diabetes in many young and adult people and subsequently impacted the body's metabolism. In most cases, blood sugar levels returned to normal later, but some remained affected.

Can it be reversed

Insulin levels can become normal or rather go into remission with proper medication, strict diet and proper exercise, but chances of relapse are always there if the patient is not careful with diet, exercise or medication. Clinicians and parents must motivate and support healthy eating and exercise habits. Obese kids should never be blamed or shamed.

Bariatric surgery

Bariatric surgery is considered in severe cases with BMI more than 35kg/ m2 or 30 kg/m2 with at least two obesity-related complications.

Dos and don'ts during dengue

NEW DELHI, Aug 5 (Agencies): Dengue is caused by a virus transmitted to humans by mosquitoes. The mosquito causing dengue (and chikungunya) breeds in stagnant water around habitations and bites in the daytime, particularly early morning, or late evening. The infection can evolve rapidly into an epidemic during the mosquito-breeding season

Not all infected patients develop symptoms of dengue. In fact, most are asymptomatic. Among those who do develop symptoms, many can mimic other viral infections i.e. fever, headache and body aches. Most improve within a few days without needing any aggressive treatment apart from feverlowering medicines, rest and a liberal intake of fluids.

febrile, critical and recovery. In the initial febrile phase, fever, headache and body pain are the major symptoms. Fever-reducing medicines (paracetamol) and plenty of fluids are required. Most patients usually go into recovery without developing an overt critical phase. Some patients, however, develop critical symptoms that require hospitalisation and close monitoring. The warning signs include vomiting, abdomen pain, severe headache, persisting body pain, bleeding from any site and the inability to have liquids. Presence of any of these indicates a critical situation and the patient needs close monitoring for 48-72 hours in a hospital setting. Monitoring haemo-

if symptoms persist or worsen. Sometimes, when the patient's fever breaks, often other

urgent blood transfusion. A slight decrease in these two parameters along with improvement in symptoms indicates recovery.

A falling platelet count alone (unless it is drastically low) usually doesn't need hospitalisation. Platelets need to be transfused only if the count is below 10,000/ cmm or there is evidence of active bleeding. For most critical patients, guarded intravenous fluids suffice to tide over the crisis.

No vaccine is available at present. Prevention of mosquito breeding and protection from mosquito bite are the only preventive steps. Simple measures can help. Do not let water collect in pots or discarded containers, remove mosquito breeding sites around houses, use repellents and wear appropriate clothing.

First ladies: Indian women compound archers defeat Mexico to win country's first-ever gold

BERLIN, Aug 5 (Agencies): The Indian women's compound team of Jyothi Surekha Vennam, Aditi Swami and Parneet Kaur clinched a gold medal in the World Archery Championships after beating Mexico in the final here.

The Indian trio won 235-229 for India's first-ever gold in any category of the World Championships since its inception.

"It is wonderful feeling. We are delighted to win the country's first-ever gold. Hope we can continue to win more gold medals," said the 27-year-old Jyothi. "We just focused on our shooting, and we were confident that we would win."

This was also India's fourth consecutive medal in the women's compound section at the Worlds, following their silver finishes in 2017 and 2021 and bronze in 2019. Jyothi has been a part of all four medal-winning teams.



Earlier, India had beaten Colombia 220-216 in the semifinals after a 228-226 win over Chinese Taipei in the quarterfinals.

Always a step ahead Up against Mexico, the second-seeded Indians dominated from the start as they shot 59 points out of 60 in the first three rounds to cruise to a 177-172 lead.

In the first round of the final, they drilled in two X (closer to the centre) in five perfect 10s to put early pressure on Mexico's Dafne Quintero, Ana Sofia Hernandez Jeon and Andrea Becerra who totalled 57. The second round saw Mexico

shoot 58 points as they trailed by three points. In the third round, Jyothi, Aditi

and Parneet had one X from five

10s en route 59, while Mexico managed 57 to give India a five-point cushion going into the decider, which the Indian trio sealed with a 58.

It was a big relief especially for Jyothi, who finally won gold after missing out on four occasions previously.

In the last edition in Yankton 2021, she lost out in the individual, team and mixed pair finals. Her maiden final appearance was with the team in the 2017 Mexico City edition when she was with Trisha Deb and Lily Chanu Paonam. Overall, Jyothi now has one gold, four silver and two bronze medals from the World Championships.

Jyothi, Aditi and Parneet are also in the hunt for individual medals after having progressed to the quarterfinals. While Parneet will be up against Jyothi in an all-Indian last-eight clash, Aditi will take on Sanne De Laat of the Netherlands.


Indian karate team set to miss Asian Games

NEW DELHI, Aug 5 (Agencies): A day after the Asian Games-bound wushu player tested positive, it is learnt that the karate team of India has not been accepted by the Asian Karate Federation. Despite India sending entries for the Games at Hangzhou, there might not be any team as of now.

The reason for the non-participation was apparently because the Asian Karate Federation has not accepted the entries of the Indian contingent. It held the Indian contingent ineligible because the names have not been approved by the National Sports Federation of karate which is recognised by the Asian and World Karate Federation.

That means the team selected by the Sports Authority of India has not been accepted by the AKF. Matters were complicated by the fact that the sports ministry did not give recognition to the Karate India Organisation (KIO) for violation of the National Sports Development Code of India.



that a communication dated 14th June, 2023 was received from President, WKF addressed to the President, IOA stating that KIO is the sole WKF representative Karate body in India to select the athletes for International events held under the auspices of IOC, WKF and their representative continental bodies. The giant of Gukesh keeps growing

Supreme self confidence, aggression and relentless pursuit of excellence behind the teenager's rise to top

CHENNAI, Aug 5 (Agencies): Just before the chess Olympiad in Mahabalipuram last year, India 'B', comprising D Gukesh, B Adhiban, R Praggnanandhaa, Nihal Sarin, Raunak Sadhwani and coach, RB Ramesh, met to decide the board order. All of them had legitimate arguments to play on the top board, such was their standing in the game. There was also an argument to play Gukesh, who had just broken 2680 in classical, in the 2nd or 3rd board. Unlike some of the others in that team, Gukesh is ultra-aggressive and proactive. While others like to be in control of the situation before planning skirmishes, Gukesh, 16 at the time, liked to create chaos, go for wins from the outset.

Wins, the debate went, may be hard to come by on the top board. The Tamil Nadu teen, though, refused to get along with the idea.

"When we were discussing board orders, there was a suggestion; should Gukesh play top board or 2nd or 3rd because he can score wins and scoring wins with the top board could be difficult," Ramesh tells this daily. "But he said 'I want to play top board'. He was supremely confident. By the time he was coming to the Olympiad, he was already displaying his self-belief."

Ramesh picks up the story.

At the Olympiad, he displayed that self-belief multiple times as he wiped the floor with Grandmasters twice his age and having 5x his experience. He began the tournament by winning eight on the trot before pocketing individual gold for top board. Judit Polgar, one of the legends of the board game, couldn't help but wonder at the teen phenom. The Hungarian, at the Olympiad as a pundit, was positively gushing whenever she

spoke about Gukesh. "He played amazingly," was how she summed up his tournament.

What also caught the eye during the tournament was the way he was moving across the board. None of the stealth that top GMs usually employ. It was all-action, front-foot go-big-or-go-home (he usually went big) tactics that yielded him results. Ramesh sings from the same hymn sheet. "Chess-wise, his style is very aggressive. He and (Argun) Erigaisi, both of them are very aggressive, they want to win every game," Ramesh explains. "Very proactive. Not reactive or conservative in approach and mindset. They believe in themselves that they can win. Very confident and they take a lot of risks. With most players, even if they are confident, they wouldn't take too many risks. But these two take a lot of risks.' When you consider all of

this, it's not really a surprise to note that the 17-year-old breached past Viswanathan Anand's mark to become the highest-rated Indian classical player at the ongoing FIDE World Cup on Thursday. Save for a brief while in 2016, Anand has had ownership of that title since July 1986. This kind of gives us a peek into two things; first, Anand married longevity with greatness so while other GMs kept coming, he was always better than them. Gukesh is still so young his parents were kids when Anand first climbed the ladder of greatness What has enabled Guke-

sh's rise and rise? Dedication to the cause. That dedication to the cause was visible in the way he put his head down and prepared for a post-pandemic future even during the initial lockdown. His coach Vishnu Prasanna, who has been with him for nearly the last half-a-dozen

years, isn't surprised by the path his ward is on. "He wasn't happy about that (the absence of over-the-board events)," Prasanna tells this daily. "But he was preparing himself for when the doors eventually opened. He reacted well after that. Whatever preparation he did during that time, it helped him when the tournaments started to happen."

What was it that he did? "Expand his repertoire, he had a narrow repertoire when the lockdown happened," Prasanna remembers. "He was working on his weaknesses, not really chilling ... working on these things when you have no tournaments to look forward to can be very challenging but he did it."

When he's not featuring in tournaments, Gukesh can spend as many as 10 hours doing something related to chess -- playing it, solving questions, working on openings, studying positions. That's before you take into account the mental and the physical -- yoga as well as spending time at the gym -- work he puts in. "He took an overall view of his game, mental, physical as well as chess. That is the secret to his discipline and consistency. I have worked mostly online with him since January, he has also received support from Vishy's (Viswanathan Anand) Academy. They handle most of the opening work. I send him questions to work on and we discuss it afterwards. He does meditation and yoga in the mornings before we start. After the Olympiad for a twomonth period, we worked between 10.00 AM to 4.00 PM. He would go to the gym after that. We would reconvene after that to exchange files. After that, we would work independently before

we touch base next morn-

ing," Saravanan adds.

The two also came to an understanding. Gukesh's bad days in tournaments should be good days for most players. "Early on, what we discussed was even if 'we have a bad day ... shouldn't be that bad. Your bad day should be somebody else's good day'. It's the kind of thinking we had. Now he doesn't have so many bad days as such. That is what has made him stay at the top, he's very consistent with results."

The soft-spoken Olympiad medallist, who plays card games like Avalon to wind down, has already achieved one of the two main targets they had discussed at the start of the year. Top 10. Next? Qualifying for the Candidates. He will begin his 3rd round at the FIDE World Cup on Saturday with the singular aim of achieving that within the next two weeks.
