

High Court Dismisses 'Deserter' **Paramilitary** Man's petition challenging termination

SRINAGAR, Aug 7 (Agencies): Justice Sanjay Dhar of the Jammu and Kashmir High Court has dismissed a writ petition challenging the termination order issued to an erstwhile Central Reserve Police Force (CRPF) member. Shahnawaz Ahmad, a resident of Chawlgam in Kulgam had challenged the termination order on the grounds of being unauthorisedly absent from duty.

The petitioner, serving CRPF since 1995. had applied for 15 days of casual leave with effect from September 18, 2000, which was sanctioned. However, during the leave period, he claimed he was kidnapped by unidentified masked gunmen from his native village and subjected to torture, impacting his nervous system. As a result, he was unable to return to duty and, subsequently, was declared a 'deserter' under the CRPF Act.

The petitioner contended that the termination order was arbitrary, passed without following due procedure and violating principles of natural justice. He asserted that there was no intention on his part to overstay the leave and that the order was passed without his knowledge or participation in the enquiry.

The CRPF, in response, stated that the petitioner had failed to report for duty despite being directed to do so, and thus, committed an act of disobedience amounting to misconduct under the CRPF Act. The respondents further explained that an enquiry was conducted, providing the petitioner ample opportunities to participate, but he failed to respond, leading to the issuance of the termination order.

Justice Sanjay Dhar, after hearing arguments from both sides, upheld the respondents' preliminary objection regarding the lack of territorial jurisdiction to entertain the writ petition. He clarified that the facts mentioned in the petition did not constitute a cause of action within the territorial limits of the Jammu and Kash-



KULGAM, Aug 7: Jammu and Kashmir's Lieutenant Governor Manoj Monday made a big announcement stating that the government will take care of poor man's power bill but those having palatial houses, I-Phones with 5-internet service and other gadgets have to pay power tariff as per their usage.

"Let me announce today that the government will take care of the poor who can't afford to



pay bills. But those who have palatial houses, I-Phones with 5-G internet data and other gadgets will have to pay power bills as per their

usage. They shouldn't at least make excuses in paying the power bills." the LG said addressing a gathering at Mini-Secretariat in Southern

however, did not elaborate further on this.

He said that in the last 70 years, 3400 MW power was generated locally in J&K and in the next three years equal MWs will be produced.

The LG said that wherever a feeder is 100 per cent metered, power disruption won't be just for a minute let alone an hour or so. "I urge people to cooperate with us in getting the smart meter installation process completed as soon

Rahul Gandhi's disqualification as Lok Sabha MP revoked

NEW DELHI, Aug 7 (Agencies): Ahead of the crucial no-confidence motion against the government on Tuesday brought by the Opposition parties on the Manipur issue. the Congress got a shot in the arm with the Lok Sabha secretariat on Monday restoring Rahul Gandhi's membership of the House.

Gandhi, who had earlier visited Manipur, is expected to open the debate when the no-confidence motion is taken up for discussion in the Lok Sabha on Tuesday.

The Lok Sabha Secretariat, in a notification issued on Monday, said that in view of the Supreme Court order dated August 4, the disqualification of Rahul Gandhi ordered on March 24 "has ceased to operate subject to further judicial pronouncements".

Rahul was disqualified from the Lok Sabha after a trial court at



Surat in Gujarat convicted him in a defamation case and sentenced him to two years in prison for his remark pertaining to people with Modi surname.

Citing that Gandhi was disqualified within 24 hours of the Surat court order, the Congress and its

allies were demanding that Gandhi's membership of the Lok Sabha be restored with equal promptitude following the relief given to him by the Supreme Court.

The apex court, in an order on Friday, had put a stay on Rahul Gandhi's

Editors Guild of India expresses concern over Press & Registration of Periodicals Bill, 2023

NEW DELHI, Aug 7 (Agencies): The Editors Guild of India has expressed concerns over certain provisions of the Digital Personal Data Protection (DPDP) Bill, saying they can have an adverse impact on press freedom.

In a statement issued on Sunday, the Guild said the DPDP Bill creates an enabling framework for the surveillance of citizens, including journalists and their sources.

The Guild has asked Lok Sabha Speaker Om Birla to refer the Bill to a parliamentary standing committee. It has also written about its

Prime Minister Narendra Modi, Rajya Sabha Chairman Jagdeep Dhankhar, IT Minister Ashwini Vaishnaw and leaders of political parties in Parliament. The government tabled

concerns on the Bill to

the DPDP Bill in Lok Sabha on August 3. The proposed legislation aims to protect the privacy of Indian citizens by suggesting a penalty of up to Rs 250 crore on entities for misusing or failing to protect digital data of individuals. The Bill comes six years after the Supreme Court held that right to privacy is a fundamental right.





Under present dispensation, tourism sector is getting ignored in Jammu region: Rattan Lal

UDHAMPUR, Aug 7: J&K National Conference today launched a scathing attack against the present dispensation for its hollow claims with regard to the unprecedented development witnessed in the tourism sector.

Addressing a meeting of party functionaries of District Udhampur Rural, Rattan Lal Gupta, Provincial President JKNC Jammu said tourism is an essential pillar of Jammu and Kashmir's economy, contributing significantly to its growth and employment opportunities. Hold three tier Panchayat elections simultaneously: Shafiq

SRINAGAR, Aug 7: Shafiq Mir chairman All J& K Panchayat Conference (an organization of Panchayat members of Jammu and Kashmir) has demanded the holding of simultaneous elections for all the three tiers in Jammu and Kashmir saying that it was the time to set the system once for all.

In this connection, large number of Panchayat members of Kashmir valley have already submitted a memorandum with State Election Commissioner at his office in Srinagar in which Panchayat members have demanded the simultaneous elections of all the three tiers

Mir said that it was the first time in the history of Jammu and Kashmir that three tiers PRI system was established here, but due to secu-

rity reasons all the three tier elections were not held in the same year as per PR act and there was gap one year in each tier.

The first tier elections were held in 2018 while the second tier elections were held in 2019 and the third tier elections were held in 2020. With this, there was a gap of one year in each tier. "We want system

Nigel Farage gets 'uncancelled'; no such hope for J.K. Rowling

The "cancel culture", dear readers, still prevails. And one wonders if it is a means to focus our attention on a long festering wound, or is it really a blow against free speech? Depends how you look at it, say the wise souls, ducking out of the debate. Because the fall out can seriously impact your life and work.

The issue of transgender rights has become a critical one in UK, even in politics – and one high profile author who has become a poster girl for the cancel culture which accompanies any contrary opinion is J.K. Rowling. For years she was the country's most celebrated author and the face of a publishing revolution while the Harry Potter series remains a bestseller. But now not only is she often reviled, trolled and ignored in UK, from across the pond, in the US, comes the news that the Seattle Museum of Pop Culture has maintained an exhibition on the Harry Potter series — but removed all mention of Rowling. Can this be possible? It would be like saying that we can have "Mona Lisa" on display but we cannot ever mention Leonardo Da Vinci actually painted it.

This is a new level for the 'cancel culture' which is now separating the work from the creator — saying that these are two separate enti-

ties. The exhibition curator is transgender, Chris Moore, who explained in a blog that all mention of J.K. Rowling was removed from the exhibits (which are all based on the Harry Potter series) to "reduce her impact".

Rowling had been present in the Science Fiction and Fantasy Hall of Fame previously — but as in the UK, the backlash against her has been severe as she has tried to express her opinion that "biological sex" is important and that it is not "people who menstruate" but women. She is unlikely to be a fan of the trend to use "them/us" instead of "he" or "she".

However, if this latest trend of the cancel culture becomes a global movement — then one wonders if, one day soon, her books can be even be published without her name?

But, the "cancel culture" has spread to banks as well. Coutts is an elite bank. You need to invest £1 million in it or have a balance of £3 million and more to be able to have an account there for a mere £900 annual charge. It is also known to be a Bank for the Royal family. It is just a short distance from Trafalgar Square along the Strand.

Nigel Farage was an unlikely customer of Coutts. His fame rests on being a populist politician identified with the middle classes. It was his campaign to 'Brexit' as chair of the UK Independence Party (UKIP) which made him a personality to be noted. His

campaign for UK to leave the European Community was well financed by donors and defeated David Cameron who had opposed Brexit.

Farage has cultivated a personal image of the hard drinking man of the people who hates "foreigners". He is popular with the tabloids and some recently opened radio stations. Anyway, as it happened, he complained to the media that Coutts had shut his account. Given that his name and deeds divide the country sharply, this caused surprise and mirth. His image was not that of a Coutts client.

Farage is not a man to take being bounced out by his Bank lightly. So he publicised his plight. Initially, it was thought that, like MPs and members of the House of Lords, he was considered a Politically Exposed Person (PEP) and the campaign against terrorism and money laundering was tightening up its rules to filter out the PEPs. Farage said this was an attack on his rights. The story took wings.

At a posh dinner hosted by the BBC, Alison Rose, the chief executive officer of Natwest, a bank that owns Coutts, said to her neighbour Simon Jack, a BBC correspondent, that Farage was booted out because he no longer had the money to be a Coutts client. This was a scoop for Jack so he broadcast it on BBC. Farage, undaunted, asked Coutts for details of his transactions with Coutts, as he was entitled to ask.

This is where the story began to get murky. Had Alison Rose broken the norms of banking etiquette and talked about a client's bank account? The Natwest Board, chaired by Sir Howard Davies, a former director of the LSE, consulted colleagues and decided Alison Rose had not broken any rules.

Meanwhile, Farage was able to find out that he had been kicked out not for his minimum balance but for his views. Coutts felt Farage was a controversial figure and bad for their image as a bank that embraces diversity (among its very rich clients, of course). When this got out, the story exploded. Natwest had to rely on government support during the 2008 crisis and government still owns 38 per cent of the bank. So the Treasury stepped in along with the Cabinet. Alison Rose, they said, had to go because she had broken rules. But the chairman of Coutts, Peter Pavell, also had to resign for what we Londoners call his 'woke' attitude. Bill Cosby faces lawsuit from singer alleging sexual assault



Comedian Bill Cosby has been accused of sexual assault by another woman, who claims he drugged and raped her in the late 1980s

According to a new lawsuit filed in New York City, singer Morganne Picard accused Cosby, 86, of inviting her to the sets of The Cosby Show in 1987, and alleges that he "insisted and encouraged" her to drink beverages that made her feel "extremely intoxicated" on "multiple occasions" between then and 1990.

Picard claimed that the disgraced comedian invited her to the sets of his The Cosby Show "under the pretence" of helping her career as an aspiring

"Upon information and belief, when Ms Picard was physically incapacitated by the unknown intoxicant, Cosby undressed and raped her, without her consent and when she did not have the capacity to consent," the lawsuit

The document also named Kaufman Astoria Studios, Astoria Studios LP II, the Carsey-Warner Company and NBCUniversal as defendants, as they did "not investigate, reprimand, supervise nor in any way try to stop Cosby from sexually abusing, assaulting and/ or battering women."

Picard is specifically suing Cosby for battery, assault and intentional infliction of emotional distress. She's suing the other defendants for negligent hiring and negligence.

Cosby has denied the accusations through rep Andrew Wyatt. "It is disappointing to see that these alleged distractors are able to monetise false allegations against Mr Cosby," Andrew Wyatt said in a statement.

Asking the Centre to respond to the petition filed by two women JAG aspirants in four weeks, a Bench led by Justice Hrishikesh Roy in its August 4 order said, "Considering the nature of the interim relief, we deem it appropriate to order to keep aside two of the notified vacan-



cies, until the returnable

The petitioners have challenged the January 18, 2023 notification reserving six out of nine JAG posts for male candidates on the grounds that it denied equal

opportunity to women aspirants.

On behalf of the petitioners, senior counsel Gopal Sankaranarayanan pointed out that the two petitioners had secured fourth and fifth ranks, respectively, but

they were deprived of their entitlement for appointment as JAG officer in the Judge Advocate General Branch as six of the nine vacancies were earmarked for male candidates.

He submitted that the top court had in the past entertained cases pertaining to gender discrimination in the Armed Forces in the matter of recruitment.

The petitioners sought to assail the notification, saying it not only unabashedly violated the non-discrimination guarantee embodied

Andhra teen dialled 100 while hanging from bridge, was pushed by mother's lover

VIJAYAWADA, Aug 7 (Agencies): A 13-yearold girl in Andhra Pradesh's Guntur district saved herself after being pushed off a bridge by her mother's live-in partner by clinching onto a plastic pipe.

The girl, Keerthana, was pushed off the bridge into Godavari river early morning on Sunday along with her mother Puppala Suhasini (36) and sister Jersey (1). The 13-year-old, however, held on to a plastic pipe and dialled 100 for police help.

The accused named Ulava Suresh was the mother's live-in partner. As he pushed them from the Ravulapalem Gautami bridge, Keerthana fell near a plastic cable



pipe next to the bridge and was able to grab it. She pulled out her cell phone from her pocket while hanging and dialled 100 as for from the police.

While both the mother and the one-year-old

baby went missing, the police were able to

rescue the girl.

"At around 3.50 am on Sunday, we got a call seeking help. We rushed to the spot by 4 am and as we saw, a girl was found clinging on to

the bridge pipe line in a dangerous situation," said Ravulapalem police today.

The Ravulapalem police along with highway mobile personnel rescued the girl.

"Suresh, who is living with my mother, took us to Rajamahendravaram. He stopped the car on Ravulapalem Bridge, on the pretext of taking a selfie, and pushed the three of us into the Godavari river," said Keerthana after the police rescued her.

The police formed two teams -- one to search for the missing 36-yearold Sahasini and oneyear-old Jersey and the other team to arrest accused Suresh.

China releases TV documentary showcasing army's ability to attack Taiwan

China claims Taiwan, a self-ruled democracy, as its own territory, to be conquered by force if necessary

TAIPEI, Aug 7 (Agencies): China has released a new documentary about the army's preparation to attack Taiwan and showcasing soldiers pledging to give up their lives if needed as Beijing continues to ramp up its rhetoric against the self-ruled island.

"Chasing Dreams," an eightpart docuseries aired by state broadcaster CCTV earlier this week to mark the People Liberation Army's 96th anniversary, features military drills and testimonials by dozens of soldiers, of which several express their willingness to die in a potential attack against Taiwan.

China claims Taiwan, a selfruled democracy, as its own territory, to be conquered by force if necessary.

State media and the PLA frequently release propaganda materials promoting the army's modernisation as well as sleek videos of military drills

The materials serve to fan rising Chinese nationalism and display military confidence against Taiwan and, implicitly,



its ties with the United States While the U.S. doesn't recognize Taiwan as a sovereign country, it has pledged to help the island defend itself in case of an invasion.

Last month, the White House announced a \$345 million military aid package for Taiwan. The move, which experts said drew on lessons from the U.S. military assistance to Ukraine, was criticized by Beijing.

The "Chasing Dreams" documentary showcased, among other things, the PLA's "Joint Sword" drills, which simulated precision strikes against Taiwan. The exercises were undertaken

around the self-governed island in April after a visit by Taiwanese President Tsai Ing-wen to

Among the more dramatic parts of the program are pledges by PLA soldiers from various divisions to relinquish life in a potential attack on Taiwan.


"If war broke out and the conditions were too difficult to safely remove the naval mines in actual combat, we would use our own bodies to clear a safe pathway for our (landing) forces," Zuo Feng, a frogman with the PLA Navy's minesweeper unit, said in a testimonial.

Li Peng, a pilot from Wang Hai Squadron under the PLA Air Force, echoed his statement, saying his "fighter jet would be the last missile rushing towards the enemy if in a real battle, I had used up all my ammunition." Fan Lizhong, a special tactics unit commander, said in the docuseries that while losing comrades is painful, he has to remain calm to respond to emergencies and always be ready to fight.

The documentary also features Shandong, one of China's three aircraft carriers, sailing in formation with several other warships.

The PLA has repeatedly dispatched Shandong to the Taiwan Strait over the past few months as a threat to Taiwan. PLA jets have also crossed the strait's median line, an informal demarcation zone between China and Taiwan, relatively often over the past couple of years, especially in reaction to exchanges between Taiwan and the U.S. that have angered

DAMASCUS, Aug 7 (Agencies): An Israeli missile attack targeting the vicinity of Syria's capital Damascus killed four soldiers, wounded four more and caused "some material damage", Syrian state media reported early on Monday, citing a military source.

"At about 2:20 in the morning today, the Israeli enemy launched an aerial aggression from the direction of the occupied Syrian Golan Heights, target-

ing some points in the vicinity of the city of Damascus," the military source said. Syrian air defences intercepted the Israeli missiles and shot down some of them, the source added.

Israel has for years been carrying out attacks against what it has described as Iran-linked targets in Syria, where Iran's influence has grown since it began supporting President Bashar al-Assad in the civil war that started in 2011.

Chinese Origin Singaporean Jailed And Fined For Assaulting Indian Woman

SINGAPORE, Aug 7 (Agencies): A Chineseorigin man was given three months in jail on Monday for having racially insulted and kicked a 57-year-old Indian-origin woman in the chest in May 2021.

Wong Xing Fong, 32, had attacked Madam Hindocha Nita Vishnubhai near the Northvale condominium in Choa Chu Kang housing estate on May 7, 2021, amid the Covid-19 pandemic.

Ordering Wong to pay the victim SGD13.20 as compensation, District Judge Shaiffudin Saruwan stressed that racial and religious hostility can have dire consequences in Singapore's society.

handing Before down the sentence on Monday, the Judge said that a deterrent sentence is paramount in this case and noted that Wong committed the offences in a brazen manner and had displayed a lack of remorse.

After a nine-day trial which started in January, Judge Shaiffudin convicted Wong in June of one count each of assault and wounding the victim's racial feelings.

During the trial, Wong denied using racial insults.

The prosecution had asked for a sentence of between six and nine months in jail, stressing the importance of community and racial harmony in multi-racial Singapore.

Nita testified on the first day of the trial that



on May 7, 2021, she was brisk walking to Choa Chu Kang Stadium, where she worked at a fast-food restaurant when she heard someone shouting.

She turned and saw Wong and his fiancee Chua Yun Han, whom she did not know. The couple told her to "mask up", as her mask had been pulled down.

Mask-wearing, due to COVID-19 spread, was then compulsory but people participating in sports including brisk walking were excused. Deputy Public Pros-

ecutors Marcus Foo and Jonathan Lee said in their submissions that Nita explained to the couple that she was brisk-walking, and gestured to show she was exercising and sweat-

The prosecution said, "The accused instead scolded the complainant (and verbally insulted her). To de-escalate the matter, the complainant responded: 'God bless you.' "The accused, however, kicked the complainant in her chest area. He and (his fiancee) then jogged off," The Straits Times reported the judgement, citing hearings from court proceedings.

Nita also testified in January that she would cry if she returned to the

site of the attack.

Her voice cracked at the time as she told the judge, "(The incident) affects me emotionally... I feel sad and scared. Is it wrong to be Indian? I didn't choose to be Indian... I wish this didn't happen.

"Till today, you (take) me to that road. I will cry. I was very scared." During earlier proceedings, she also testified that an eyewitness helped her to her feet after the attack and applied plaster to a wound on her left forearm.

She made a police report that evening.

The prosecution said the eyewitness, who was unrelated to either party, testified that she saw a man kicking Nita.

During the trial, Wong claimed that the victim was sarcastic and aggressive, and had hurled vulgarities at him. He also claimed she spat at him and Chua, and he reacted by pushing her.

While he accepted that he had used vulgarities, he denied they were racial insults.

For assaulting another person in a racially aggravated attack, an offender can be jailed for up to four years and six months, and fined up to SGD7,500.

project with Iran under pressure from US: Report ISLAMABAD, Aug 7 stan's notice of force

(Agencies): Pakistan has temporarily shelved the multi-billion dollar gas pipeline project to import cheap energy from neighbouring Iran, apparently under pressure from the US which has imposed sanctions against Tehran over its nuclear programme, according to a media report on Monday.

The development comes as Pakistan struggles to put its cashstrapped economy in order with the help of the International Monetary Fund, which agreed to provide USD 3 billion in loan.

The project was initially conceived as an India-Pakistan-Iran gas pipeline, but later, India left it and became a bilateral project between Pakistan and Iran.

The sanctions imposed by the US on Iran over its nuclear programme have deterred Pakistan from constructing the pipeline.

The Dawn newspaper reported that Pakistan had issued a notice of 'Force Majeure and Excusing Event' to Iran to suspend its contractual obligation on completion of the multi-billion-dollar Iran-Pakistan (IP) gas pipeline project because of external factors outside Islamabad's control.

has Pakistan expressed its inability

to pursue the project as long as US sanctions on Iran remain in place

or Washington tacitly green-lights Islamabad to go ahead with the project that has been in cold storage for almost a decade despite acute energy shortages in the South Asian nation of 240 million people, the paper reported. "Pakistan has issued

a Force Majeure and Excusing Event notice to Iran under the Gas Sales and Purchase Agreement (GSPA), which resultantly suspends Pakistan's obligations under the GSPA," according to a written testimony Minister of State for Petroleum Musadik Malik has given to the National Assem-

In a policy statement placed on the floor of the lower house of Parliament, the minister also put on record that Iran disputed the notice of force majeure and excusing event. The statement came in

response to questions from lawmaker Muhammad Jamal-ud-Din from Muttahida Majlis-e-Amal party, who wanted to know if the government of Pakistan had a target completion date for the cross-border energy project and whether fines were due in case of delays and if other regional nations were enhancing trade relations despite UN sanc-

"The Iran Pakistan Gas Pipeline Project is stalled due to international sanctions on Iran," said Malik clarifying the project activities will begin once sanctions on Iran are removed and there is no threat that State Owned Entities (SOEs) would be hit by sanctions.

"Given that, no date and deadline can be given for the completion of the Iran-Pakistan Gas Pipeline Project," he added.

At the same time, the petroleum minister also conceded that Pakimajeure and excusing event and Iran disputing its validity could only be finally settled through international arbitration, should Iran take this matter to arbitration.

As a consequence, "the exact amount of penalty, if any, is subject to the outcome of the arbitration to be determined by the arbitrators", he said.

Last week, Iranian Foreign Minister Hossein Amir Abdollahian, during his three-day visit to Pakistan, emphasised the need for the completion of the project, saying it would definitely serve the national interests of the two countries.

Tehran has been claiming to have completed its side of the 1,150-kilometre pipeline for which a groundbreaking ceremony was iointly conducted by then-presidents Asif Ali Zardari and Mahmoud Ahmadineiad on the Iranian site of Gabd, near Chabahar in March 2013 with then-estimated cost of USD 7.5 billion.

Pakistan had committed to complete its side of the project by January 2015. However, in February 2014, then petroleum minister Shahid Khaqan Abbasi told Parliament that the Iran-Pakistan project was "off the table" due to international sanctions.

Petroleum minister

Musadik Malik explained in its latest statement that despite being fully committed to its contractual obligations under the GSPA, the Government of Pakistan had been unable to start construction of the pipeline due to US sanctions on Iran.

"The Government of Pakistan is engaged with the US authorities, through diplomatic channels, to seek exemption for the project. All necessary actions are being taken to construct the gas pipeline at the earliest," he said.

Officials said Pakistan had requested Washington earlier this year for a way out to help overcome energy shortages but had not yet received any response. The Iranian pipeline was aimed to supply 750 million cubic feet per day (MMCFD) of gas, although it was vehemently opposed publicly and diplomatically by the US authorities, particularly when Pakistan and Iran signed framework agreements and GSPA in 2009 and 2010 respectively.

Malik also told the National Assembly that the indigenous gas supplies in Pakistan were depleting rapidly, whereas the demand for gas was increasing every year, thus widening the demand-supply gap, reported Dawn.

Typhoon In Japan Forces Nagasaki Bombing **Commemorations To Move Indoors**

TOKYO, Aug 7 (Agencies): Typhoon Khanun was on course Monday to dump prolonged, heavy rain on one of Japan's main islands this week, forecasters said, forcing commemorations of the Nagasaki atomic bombing to be held inside.

The typhoon last week reportedly killed at least two people, injured more than 100 and cut off power for several hundred thousand people in the southern Okinawa region before barrelling towards Taiwan.

The weather system has since swung back to the Okinawa area and was expected to rumble northwards to the west of Kyushu on Tuesday and Wednesday before veering



towards South Korea, the Japan Meteorological Agency said in a televised press briefing.

The typhoon "could bring significant rainfall in wide regions," an agency official told the briefing, adding that "heavy rainfall will increase the risk of disas-

The storm forced Nagasaki, one of the main cities on Kyushu, to scale down its annual commemoration ceremony of the 1945 bombing scheduled for Wednesday.

The ceremony is traditionally held outdoors at the city's Peace Park and is attended by government ministers, officials and thousands of quests including survivors of the bombing.

The typhoon was located east of the island of Amami Oshima on Monday afternoon, some 350 kilometres (220 miles) south of Kyushu, gusting up to 144 kilometres (90 miles) per hour, the agency said.

The slow-moving nature of the typhoon could mean rainfalls could become prolonged, increasing risks of disasters such as flooding and landslides, the agency said.

Centre's debt triples to Rs 155.6 lakh crore in nine years

The central government's debt had grown to Rs 105.1 lakh crore by March 2020 — at the beginning of the COVID-pandemic in India.

NEW DELHI, Aug 7 (Agencies): The last nine years have seen a near trebling of central government's debt to Rs 155.6 lakh crore, according to minister of state for finance Pankaj Chaudhary, who however termed the center's debt profit as "safe and prudent". The central government's debt had been at Rs 58.6 lakh crore in

However, as a percentage of India's gross domestic product — or the total value of goods and services produced in the country - central debt has not seen such a sharp increase. Instead, it has grown to 57.1% of the GDP as of March this year from 52.2% in 2014.

The deterioration in the central government's debt profile runs contrary to the target of reducing central debt to 40% of India's GDP by March 2025

The second biggest foreign currency lender to India was the Asian Development Bank with an outstanding of Rs 1.61 lakh crore as of March this year. In 2014, India owed ADB Rs 51,469 crore.

Other major lenders to India include International Development Association (Rs 1.54 lakh crore), International Bank for Reconstruction and Development (Rs 1.36 lakh crore), Russia (Rs 25,448 crore) and Germany (Rs 22,615 crore).

Reliance seeks shareholder nod to appoint Mukesh Ambani as head for another 5 years at nil salary

NEW DELHI, Aug 7 (Agencies): Reliance Industries Ltd, India's most valuable company, has sought shareholder's approval to give Mukesh Ambani another five-year term as chairman and managing director of the company till 2029 -- a period during which he has opted to draw nil salary.

Ambani, 66, will cross the company law-mandated 70 years age for the chief executive of the company and requires a special resolution by the shareholders for him to be appointed beyond that age bar.

In a special resolution, Reliance sought the nod of shareholders to appoint Ambani as the head of the company till April 2029.

Ambani has been on the board of Reliance since 1977 and was elevated as chairman of the company after the death of his father and group patriarch Dhiburhai Ambani in July 2002.

In the special resolution posted to shareholders, Reliance said its Board of Directors on July 21, 2023 approved "re-appointed Mukesh D. Ambani as Managing Director, for a period of 5 years from the expiry of his present term, i.e. with effect from April 19, 2024." Ambani, it said, had capped his annual remuneration at Rs 15 crore from financial year 2008-09 (April 2008 to March 2009) to FY20: and since FY21, he opted to forego his salary, due to COVID-19 pandemic, until the company and all its businesses were fully back to their earnings potential.

Accordingly, he has not been paid any salary and profit-based commission for three years in a row beginning FY21.

At the request of Ambani, "the Board has recommended that no salary or profit-based commission be paid to him for the proposed term from April 19, 2024 till April 18, 2029," the resolution said

"He shall, however, be entitled to reimbursement of expenses incurred for travelling, boarding and lodging including for spouse and attendant(s) during business trips and provision of car(s) for use on company's business and communication expenses at residence shall be reimbursed at actuals and not considered as perquisites," the special resolution said. "The company shall arrange to provide security to Ambani and his family members and the expenses borne by the company for the same shall not be considered as perquisites.' Reliance said Ambani will attain the age of 70 years on April 19, 2027. "The company has grown multifold under his leadership and it would be in the interest of the company that he continues to lead the company even after he attains the age of 70 years. Accordingly, approval of the members (shareholders) is sought for passing the resolution proposed (to give him another 5-year term) as a Special Resolution." Ambani, it said, satisfies all the conditions set out in company law and has not

Ambani has for a third year in a row drawn no salary from his flagship firm in the last fiscal as he voluntarily gave up remuneration in light of the pandemic hitting the business and economy.

In its latest annual report, Reliance said Ambani's remuneration for the financial year 2022-23 was "nil".

In June 2020, he voluntarily decided to forego his salary for the year 2020-21, in light of the COVID-19 outbreak in India, which exacted a huge toll on the societal, economic and industrial health of the nation.

He continued to forgo his salary in 2021-22 as well and now in 2022-23.

In these three years, Ambani did not avail of any allowances, perquisites, retiral benefits, commission or stock options from Reliance for his role as the Chairman and Managing

Prior to that, the Chairman and Managing Director had his salary capped at Rs 15 crore since 2008-09 in order to set a personal example of moderation in managerial compensation levels.

The Rs 15-crore salary in 2019-20 was the same as in the previous 11 years.

Ambani has kept salary, perquisites, allowances and commission together at Rs 15 crore since 2008-09, forgoing over Rs 24 crore per annum.

The remuneration of his cous-

ins Nikhil and Hital Meswani rose to Rs 25 crore each, including Rs 17.28 crore commission (unchanged from previous fiscal year).

Executive Directors P M S Prasad and Pawan Kumar Kapil saw their remuneration rise.

While Prasad drew Rs 13.50 crore in 2022-23 including performance linked incentives for 2021-22 which was paid in 2022-23. In 2021-22, he drew Rs 11.89 crore.

Kapil got Rs 4.40 crore, up from Rs 4.22 crore in 2021-22. He completed his 5-year term on May 15, 2023 and has since ceased to be a director of the company.


Ambani's wife Nita, a nonexecutive director on the company's board, earned Rs 6 lakh as a sitting fee (up from Rs 5 lakh in 2021-22) and another Rs 2 crore commission for 2022-23 (unchanged from previous fiscal). She had in 2020-21 got Rs 8 lakh sitting fee and another Rs 1.65 crore commission.

Besides Nita Ambani, other non-executive directors include Dipak C Jain, Raghunath A Mashelkar, Adil Zainulbhai, Raminder Singh Gujral, Shumeet Banerji, former SBI chairperson Arundhati Bhattacharya, former CVC K V Chowdary and Saudi sovereign wealth fund nominee Yasir Othman H Al Rumayyan.

While all independent directors got a Rs 2 crore commission and sitting fee.

Thymus plays an important role in cancer prevention: Study



BOSTON (US), Aug 7 (Agencies): According to a new study published in the New England Journal of Medicine, the thymus is important for adult health in general, as well as preventing cancer and possibly autoimmune disease.

The thymus gland, which produces immune T cells before birth and throughout childhood, is frequently thought to be nonfunctional in adults, and it is occasionally removed during cardiac surgery to allow easier access to the heart and major blood vessels.

The researchers compared the risk of death, cancer, and c in 1,146 adults who had their thymus removed during surgery to 1,146 demographically matched patients who underwent similar cardiothoracic surgery without thymectomy to see if the thymus benefits adults'

The researchers also measured T-cell production and blood levels of immune-related molecules in a subset of patients

"By studying people who had their thymus removed, we discovered that the thymus is absolutely required for health. If it isn't there, people's risk of dying and risk of cancer is at least double," said senior author David T. Scadden, MD, director of the Center for Regenerative Medicine at MGH and co-director of the Harvard Stem Cell Institute.

"This indicates that the consequences of thymus removal should be carefully considered when contemplating thymectomy.'

An additional analysis involving all thymectomy patients with more than five years of follow-up found that the overall mortality rate was tomy group than in the general US population as was cancer mortality.

Although Scadden and his colleagues discovered that the risk of autoimmune disease did not differ significantly between the thymectomy and control groups overall in their study, they did notice a difference when patients with infection, cancer, or autoimmune disease prior to surgery were excluded from the analysis.

T cell production and immune-related molecules were measured in a subset of patients (22 in the thymectomy group and 19 in the control group, with an average follow-up of 14.2 postoperative years), and those who had undergone thymectomy had consistently lower levels of new T cells and higher levels of proinflammatory molecules in the blood.

Scadden and his colleagues intend to investigate how different levels of thymus function in adults affect people's health.

"We can test the relative vigour of the thymus and define whether the level of thymus activity, rather than just whether it is present, is associated with better health," he said.

What is Eris? The new Covid variant spreading rapidly in the UK UNITED KINGDOM, Aug 7 (Agen-

cies): As the world continues to grapple with the Covid-19 pandemic, a new variant named Eris or EG.5.1 has emerged, causing alarm across the globe.

This strain of the Omicron variant was first identified on July 31, 2023, and has since become the second most prevalent variant in the United Kingdom, accounting for one in ten Covid cases. SYMPTOMS OF ERIS

Eris is a descendant of Omicron and shares some of its symptoms. According to the ZOE Health Study, the five most common symptoms associated with this variant are a runny nose, headache, fatigue (ranging from mild to severe), sneezing, and a sore throat.

However, it's important to note that these symptoms are not exclusive to Eris and can also be seen in other variants of the virus.

The rapid spread of Eris has raised concerns among health experts. Professor Christina Pagel, a member of Independent Sage, warned that the UK could potentially face another wave driven by these variants, waning immunity, and unfavourable weather conditions, as quoted by The National News. As people spend more time indoors

due to inclement weather, the risk of

transmission increases.

The UK Health Security Agency (UKHSA) said EG.5.1, which has been nicknamed Eris, makes up one in seven new COVID cases, as per news agency.

Eris was classified as a variant on July 31 after its prevalence was recorded in the country due to increasing cases internationally, particularly in Asia.

Dr Mary Ramsay, UKHSA's Head of Immunisation, said that regular washing of hands can help protect you from Covid-19 and other bugs and viruses. Dr Ramsay added that if a person is experiencing symptoms of respiratory illness then they should stay away from others where possible.

While Eris is designated as a variant under monitoring by the World Health Organisation (WHO), it is not currently classified as a variant of concern.

TREATMENT FOR ERIS In terms of treatment, it remains the same regardless of the infectious variant. Patients with mild to moderate illness are usually advised to remain home and self-isolate for up to 14 days to avoid spreading the virus. Vaccination continues to be the most effective way to build herd immunity and put an end to the pandemic.

death, reveals study WASHINGTON (US). Aug 7 (Agencies): Even after being cured of hepatitis C, those

who recover have a much higher chance of dying than the general populationâ€"between three and fourteen times higher, depending on the severity of their liver illness.

The study's findings were published in The BMJ

The findings, based on a database of over 20,000 people who have been cured of hepatitis C, show that drugand liver-related causes of death accounted for the majority of excess fatalities. This emphasises the importance of ongoing assistance in reaping the full benefits of a hepatitis C cure.

Hepatitis C is a virus that can infect the liver

and cause significant and potentially fatal liver damage over time if treatment is not received

Historically, interferon-based therapy was used to treat hepatitis C, which was frequently ineffective. However, new medications known as direct-acting antivirals (DAA) were developed in 2011. More than 95 per cent of DAAtreated patients now achieve a "virological cure" and have a significantly lower risk of death than untreated patients.

However, the question of what prognosis cured patients can expect in comparison to the general population is still being debated.

To investigate further, a team of UK and Canadian researchers set out to measure mortality

rates in people who had a hepatitis C cure and compare them to the general population.

People with hepatitis C cure still face risk of

They examined data from three population studies conducted in British Columbia (Canada), Scotland, and England involving 21,790 people who were cured of hepatitis C between 2014 and 2019. Individuals were divided into three groups based on the severity of their liver disease at the time of cure: pre-cirrhosis (only in the British Columbia and Scotland studies), compensated cirrhosis, and end-stage liver disease.

Over an average follow-up period of 2-4 years, data were linked to national medical registries and several causes of death were examined, including liver cancer, liver failure, drug-related death, external causes (primarily accidents, homicides, and suicides), and circulatory system diseases.

After age was taken into account, death rates were significantly higher than in the general population across all disease severity groups and settings.

In Scotland, for example, the rate for all patients was 4.5 times higher than the general population (442 deaths observed versus 98 expected), whereas rates in British Columbia were 3.9 times higher (821 deaths observed

versus 209 expected). Rates also increased significantly with the severity of the liver disease. In British Columbia, for example, rates were three times higher

in people without cirrhosis and fourteen times higher in patients with end-stage liver disease.

The leading cause of excess death in patients without cirrhosis was drug-related, whereas the two leading drivers in patients with cirrhosis were liver cancer and liver failure.

Older age, recent substance use, alcohol use, and pre-existing conditions (comorbidities) were all associated with higher death rates across all disease stages and settings.

These are preliminary findings, and the researchers acknowledge that they may not be applicable in all settings, particularly where injecting drug use is not the predominant mode of hepatitis C transmission.

Facundo Quignon, Bernard Kamungo and Alan Velasco scored for Dallas, which held leads of 3-1 and 4-2 before losing its grip on the match. Paxton Pomykal was the only penalty-taker to miss, skying FC Dallas' second kick over the crossbar.

Despite the tournament exit, Dallas is the first team to hold Miami to so much as a draw over 90 minutes since Messi debuted in the tournament's group

years in the country, people are quite excited and we can see the buzz already back home. I'll be looking forward to playing in all venues. They all have their own charm and speciality, so I would like to embrace that," Sharma was quoted as saying via an ICC release.

Recalling his experience from the 2019 ODI World Cup, Sharma said that every day it is a fresh start in a big tournament like this. Sharma was the top scorer in the previous edition of the tournament, hitting 648 runs from 9 matches. India were looking strong throughout the 2019 edition, but lost to New Zealand in the semi-finals, which also turned out to be the last international match for Mahendra Singh Dhoni.

"Yeah, I know every day is a fresh day. Every day is a fresh start, it's not like Test match cricket where you have the momentum with you and you carry the momentum to the next day," Sharma said.

Coco Gauff defeats Maria Sakkari in Washington for her 4th title

WASHINGTON, Aug 7 (Agencies): Away from a tennis court, Coco Gauff is still, in some ways, a typical teen, rolling her eyes at receiving FaceTime calls from a younger sibling - "I'm at press right now, Bro" — and her father — "Oh, my God" — while two versions of the DC Open trophy she earned Sunday sat on the table in front of her.

With a racket in her hand, Gauff is not typical at all, as her success so far shows. And after the disappointment of a first-round exit at Wimbledon last month, the 19-year-old from Florida appears back to her best as the start of the US Open approaches later this month.

Surging at the end of each set, Gauff defeated Maria Sakkari 6-2 6-3 in the Washington final for the fourth WTA Tour singles title of her career. Gauff is the youngest women's champion of the hard-court tournament in the nation's capital and the first player since Caroline Wozniacki in 2009 to win four WTA tournaments as a teenager.

"I would say," said Gauff, who is ranked No. 7 and was seeded No. 3, "I'm heading in the right direction." Well, there's an understatement.

"She's already near the top, but there is a lot of room to get better," said Gauff's new coach, Pere Riba, who was joined on her team by consultant Brad Gilbert in Washington.

"I'm happy, of course, that she won the tournament. I'm more happy about the way she did it. Her energy and attitude are more important for the long



term."

What a week it was, though. Gauff, the runner-up at the 2022 French Open, didn't drop at set and ceded just 19 total games across four matches.

At night, Dan Evans became, at age 33, the oldest men's champion in Washington since Jimmy Connors was 35 in 1988 by beating Tallon Griekspoor 7-5 6-3 in a final delayed by more than two hours in the second set because of a thunderstorm.

It was the second ATP Tour title for Evans, who was just 8-18 in 2023 before the DC Open and now will rise from No. 30 to a career-high No. 21 in the rankings Monday.

"I had to keep telling myself it was match-by-match and not so long ago I wasn't playing great," he said.

"It was a good effort mentally to just stay in the present and keep fighting for each point. And I did a great job of that this week."

This was the first year the

tournament was a combined ATP-WTA 500 event. Despite equal billing, the prize money wasn't the same — and won't be until 2027. Gauff earned USD 120,150; Evans received USD 353,445.

In addition to the No. 9-ranked Sakkari, Gauff eliminated defending champion Liudmila Samsonova and Tokyo Olympics gold medalist Belinda

"The caliber of players I have beat this week was probably the strongest out of all of the tournaments I've played," said Gauff, who hit seven aces Sunday while improving to 4-1 in singles

This was her second title of 2023, alongside one in Auckland, New Zealand, in January. One big key this time was an improved forehand, long considered a weak point. Pere focused on altering her footwork so she would be in a better position to strike that shot and use it to

"We all know that her forehand was always her weaker shot. I feel like now she's improving that. She's making more balls. She's working on that," said Sakkari, a 28-year-old from Greece who reached two Grand Slam semifinals in 2021. "Mentally she looks a lot more

mature. She knows what she's doing on the court." Sakkari, who beat top-seeded Jessica Pegula on Saturday, fell to 1-7 in finals.

"I'm not going to lie," Sakkari said, wiping away tears.

"It's pretty disappointing." Sakkari broke to open the second set when Gauff dumped a drop shot into the net. Gauff put her hands on her head, walked to the sideline and hit her equipment bag with her racket. Soon, it was 2-0.

But Sakkari double-faulted to get broken to 3-all, and her groundstroke errors kept coming, too, often followed by a glance at her coach, Tom Hill. Gauff noticed. She figured it was because she kept Sakkari from preying on her forehand.

"Consistently this week, I have beaten' that scouting report, and I think that's why the players tend to get a little more frustrated," Gauff said.

"Almost all week, every player that I played has been looking at their box, because I truly think that the plan that they had I was able to kind of combat. Today, she clearly had a plan, and I kind of just made that plan fizzle out a little bit."

A moment later, her phone buzzed. It was "Bro."

PCB gets government green light for **ODI World Cup**

KARACHI, Aug 7 (Agencies): The Pakistan government has provided the clearance the country's cricket body has been waiting for to travel for the upcoming 2023 ICC Men's ODI World Cup in India. The Pakistan Ministry of Foreign Affairs said in a statement that the government has decided to send the team to take part in the global

"Pakistan has consistently maintained that sports should not be mixed with politics. It has, therefore, decided to send its Cricket Team to India to participate in the upcoming ICC Cricket World Cup 2023," read the statement.

The ministry's statement said that the state of bilateral relations with India should not stand in the way of fulfilling international sports-related obligations before adding that unlike India's decision to travel to Pakistan for the Asia Cup, they have taken a "constructive and responsible approach".

The Asia Cup was initially supposed to be held in Pakistan entirely but it was later agreed that a hybrid model will be followed with Sri Lanka co-hosting the event. India will play all their matches in Sri Lanka starting from September 2 against Pakistan in Kandy.

The ministry's statement did express serious security concerns for the team, which will be led by Babar Azam, during their time in India for the World Cup. As reported by this daily, the board had been awaiting the government's decision on travelling to India even as the BCCI and ICC released the schedule on June 27.

The Pakistan government, while agreeing to send the team, said that they have written to the ICC and Indian authorities expressing their concerns. "We expect that full safety and security of Pakistan Cricket Team will be ensured during its visit to India," the statement read.

At this point, it is worth noting that as many as three matches, including the India-Pakistan one that is originally scheduled to be played in Ahmedabad on October 15 could be preponed. Initially, the Ahmedabad police had expressed security concerns over playing the



India-Pakistan match on the first day of Navratri, later the Kolkata police seem to have communicated similar concerns for the Pakistan-England clash on the day of Kali Puja (November 12).

To accommodate them, the Pakistan clash against Sri Lanka too might have to be moved from October 12 to 10. Whether the ICC and Pakistan will agree to all the changes is yet to be seen. The tournament, supposed to begin on October 5 (less than 60 days to go), does not have a final schedule as of this moment.

Mitchell Marsh Named Australia's **New T20 Captain**

SYDNEY, Aug 7 (Agencies): All-rounder Mitch Marsh will get the first chance of becoming Aaron Finch's successor as Australia's T20 captain after he was announced as skipper for the upcoming T20I series against South Africa. Finch retired from T20I cricket earlier this year after a successful 76-match stint as captain that was highlighted by guiding Australia to the ICC Men's T20 World Cup title in Dubai in 2021 and selectors have taken their time on settling on his replacement. Marsh will be given first crack on winning the top job, with the talented allrounder named captain for the T20 component of Australia's white-ball tour of South Africa that commences later this month.



While Marsh has only been named as skipper for the upcoming South Africa tour, chief selector George Bailey believes the 31-year-old is capable of holding the job on a full-time basis.

According to the official website of ICC, George Bailey said, "Mitch has long been a senior player within the whiteball structure, with this an opportunity for him to add to his leadership skills at the international level.We look forward to him taking that step in South Africa.

Marsh will lead a newlook squad for the threematch T20I component of the tour, with selectors naming a host of fresh faces among their squad for what will be their first 20-over matches since last year's T20 World Cup.

All-rounder Aaron Hardie, opening batter Matt Short and left-arm quick Spencer Johnson are all in line for an international debut during the three-match series, with Steve Smith, Marcus Stoinis, Glenn Maxwell, Adam Zampa and Marsh the only players in the squad that played at Australia's most recent T20I last vear. Marsh previously cap-

tained Australia to success at the ICC Men's Under-19 Cricket World Cup in New Zealand in 2010 and has experience leading his state Western Australia at the domestic level.
