#### Man found dead in Shopian village

SRINAGAR, Aug 22 (Agencies): A man was found hanging in an orchard in Zaipora area of south Kashmir's Shopian district on Tuesday.

Quoting an official, news agency-Kashmir News Observer (KNO) reported that the 30-year-old man from Zaipora was found hanging in the orchard in his native village. He said that police have taken cognisance of the matter.

#### Woman Dies, another injured in Kashmir **Road mishap**

SRINAGAR, Aug 22 (Agencies): A woman died, and another person was injured in a road mishap in Bijbehara, in south Kashmir's Anantnag district this afternoon, officials said.

They informed GNS that an accident occurred near the Petrol Pump in Sangam Bijbehara, resulting in injuries to two individuals identified as Khatija Begum, the wife of Abdul Aziz Awan, and Bilal Ahmad Awan, the son of Mohammad Sultan. Both were residents of Rajouri. The pair was swiftly evacuated from the scene to SDH Bijbehara, where Khatija Begum succumbed shortly after being admitted for treatment. Confirming this, a police official told GNS that a case has been registered in this regard for further investigations.

# **ISRO releases images of moon captured from** 70 km altitude by Lander camera

BENGALURU, Aug 22 (Agencies): ISRO on Tuesday released images of the Moon captured by the Lander Position Detection Camera (LPDC) of the Chandrayaan-3 mission from an altitude of about 70 km on August 19.

LPDC images assist the Lander Module (LM) of the mission, scheduled to make a soft-landing on the Lunar surface on Wednesday, in determining its position (latitude and longitude) by matching them against an onboard moon reference map, the Ben-

The ISRO on Monday released images of the Lunar far side area captured by the Lander

Hazard Detection and Avoidance Camera (LHDAC).

This camera that assists in locating a safe landing area -- without

boulders or deep trenches -- during the descent is developed by Ahmedabad-based Space Applications Centre (SAC), a major research and development center of ISRO.

According to ISRO, to achieve the mission objectives of Chandrayaan-3, several advanced technologies are present in the Lander such as LHDAC.

Chandrayaan-3, launched on July 14, is a follow-on mission to Chandrayaan-2 to demonstrate end-to-end capability in safe landing and roving on the lunar surface.

# Will not tolerate discrimination against Jammu, remove Sarore Toll Plaza: Sawhnev

#### **TOP NEWS REPORT**

JAMMU, Aug 22: J&K Pradesh Youth Congress on Tuesday in a statement demanded the removal of the Sarore Toll Plaza citing the excessive and unnecessary burden it is causing on the pockets of the daily passengers.

Amidst rising protest against the said toll plaza, JKPYC members also rose against the administration and asserted that this toll being levied is not valid at all. Anirudh Sawhney, State General Secretary JKPYC supported the people's demands for the removal of the Sarore Toll on the Jammu-Pathankot Highway in Samba district.

All sections of the people, such as the trade bodies, Rajput Yuva Sabha, common people have explicitly raised their concerns against the toll plaza and the government has paid no attention to this issue.

J&K Youth Congress appealed to the administration that the Sarore Toll is cancelled and passengers are not made to pay this toll anymore.

Further speaking on the issue, Anirudh Sawhney said that the Sarore toll is an unneeded hindrance for those who travel daily, from businessmen to employed people, and causing a burden on the pocket.

Such tax should not be levied. The

issue of toll taxes is also becoming more serious in J&K as the number of such instances is increasing.

The exploitative tax regime is a foundational feature of the BJP government, from heaviest tariffs to unnecessary toll taxes, it has deployed all mechanisms to essentially empty the pockets of the people. There is only one toll plaza in Srinagar, whereas there are multiple toll plazas in Jammu. We should not tolerate this kind of discrimination against Jammu and ignorance of the issues of Jammu from the government, he added. Sawhney added that the JKPYC urges the administration to consider the concerns of all the stakeholders, the trade bodies, the locals and the youth and accordingly decide on the matter of the toll plaza. The toll plaza has also been set up in violation of the rules and that must be looked into. The Sarore toll, particularly is invalid also because the roads are not developed properly, the road infrastructure is guite poor so that raises a question on why the people should pay the toll tax.

This is why people are extensively protesting against the Sarore toll as this toll tax is not justified. We appeal to the government to remove the Sarore Toll tax and decide in the favour of the people, he said.

# **AHD Jammu for enhancing** accessibility of veterinary services at farmer's doorsteps

Speaking on the occasion, the Director said that these MVUs have been procured under the scheme Establishment and Strengthening of Veterinary Hospitals and Dispensaries (ESVHD) and will operate in districts of Jammu, Udhampur, Kathua, Doda and Rajouri to cater the needs of farmers and livestock owners by providing veterinary health care to their animals at their doorsteps and shall especially benefit those areas which lack veterinary facilities or face shortage of manpower.

She further said that these units have been fabricated with state of art veterinary healthcare facilities for providing accurate diagnosis and quality treat-

ment on the spot to the ailing livestock. "Mobile Veterinary Units shall also provide artificial insemination services including sex-sorted semen technology for breed improvement in local cattle in addition to veterinary healthcare in the region of their operations", she added.

Elaborating upon the mode of operation of the MVUs she explained that these units shall be operated through call centres over helpline no. '1962' and farmer in case of any emergency will make calls to these call centres and treatment shall be provided by a team of a Veterinary Doctor and a Para-vet manning these MVUs operating nearest to the needy farmer.

CEO Livestock Development Board Jammu, Dr. Raman Kumar Gupta, senior officers and officials from the Directorate of Animal Husbandry office complex, officers from the Livestock Development Board Jammu besides representatives of various media agencies were also present on the occasion.

# NIA, CBI must probe into Hakikat Singh's shady past: Nantional Panthers Party

JAMMU, Aug 22: Pointing towards dozens of reports appearing in the media including the National media regarding the involvement of a retired Physical Education Teacher (PET) of Kashmir named Hakikat Singh in several shady deals during his service career; the NPP leaders have sought high level probes by NIA and CBI into the said reports at the earliest. The NPP leaders said that Hakikat Singh was accused of financing terror organizations through his NGO named J&K Humanitarian Service Organization (JKHSO) which he had floated while serving as a Physical Education Teacher (PET) in Shopian, Kashmir.

They said that by defying service norms and regulations, the said Hakikat Singh floated JKHSO and received funds from several controversial sources which were used for anti-national activities as widely reported in the media across the country. The statement was

jointly issued by senior leaders of JKNPP including Maqbool Malik, Rajinder Singh Manju, Parshotam Parihar, Rampaul Bhagat, Iftiaz Sohil, Balbir Singh, Ajay Jamwal, Shanker Singh, Mohit Mankotia, Rajesh Kanwal besides others. The NPP leaders

said that Hakikat Singh while serving as PET received huge grants from dubious sources

for his NGO and got himself registered as migrant employee through his political clout. He manoeuvred the running of the said NGO even while in service despite adverse reports from various intelligence agencies including the military agencies.

The NPP leaders disclosed that in one of such deals Hakikat Singh received Rs.2.38 crores from a controversial agency named Technical Services Division (TSD) in 2011 which amount was shared with a Kashmir based organization headed by a JKLF militant. The NGO of Hakikat Singh funded another NGO named "Yes Kashmir" which plotted against an Army Commander. The NPP leaders divulged that the head of "Yes Kashmir" funded by Hakikat Singh's NGO was subsequently jailed for his anti-national activities but Hakikat Singh evaded arrest due to his political connections. The JKNPP leaders maintained that

the notorious character had later claimed to have joined Panthers Party through some Kashmir based workers but the Party High Command had expelled him for his dubious credentials. Clarifying that Hakikat Singh was not even a Primary member of the Party as claimed by him, the NPP leaders sought immediate enquiry against the said mischievous character followed by his early arrest in view of threat posed by him to national security.

# Vikramaditya calls for suspension of toll collection at Sarore amidst damaged National Highway

#### **TOP NEWS REPORT**

JAMMU, Aug 22: Former MLC, Vikramaditya Singh has anguished over collection of toll charges at Sarore despite the severe damage caused to the national highway at Chadwal in district Samba.

In a statement released on Tuesday, the former MLC emphasized that the Tarnah Bridge in district Samba, which was

recently damaged in flash floods, will require months to resume traffic.

He stated that until the bridge is repaired and traffic flow is restored, the authorities responsible for toll collection should refrain from charging toll taxes at Sarore. Instead, they should allow free movement of vehicles on the highway from the toll plaza, sparing commuters from any form of harassment, he said.

Singh citied a similar incident of Himachal Pradesh, wherein toll collection was sus-

pended at Sanwara Toll Plaza due to the damage caused to National Highway No. 5 between Solan and Parwanoo in the Solan district during the recent flash floods. Acknowledging the similar situation in Himachal Pradesh, the former MLC stated, "We have no objection to paying toll, but the

condition of the national highway stretch from Jammu to Lakhanpur is not appropriate for toll collection at the moment."

He asserted that there is no issue on toll operations at Ban Toll Plaza, as the concerned road is in relatively good condition.

However, he urged the NAHI authorities to prioritize the repair work on the Jammu Lakhanpur National Highway. Once the

Jammu Lakhanpur National Highway is functional, they can resume the toll collection, he said.

The former MLC urged the authorities to prioritize the convenience of the people and refrain from harassing them under the guise of toll collection. He emphasized that the damaged national highway has caused significant inconvenience to commuters and should be addressed promptly.



# SMARTPHONE \_ADDICTION

n today's digital age, it can be quite difficult for parents to keep their kids away from a screen. The proximity of digital technology is growing daily. Each home now has two to three smart devices. The online world is extremely addictive and can have a negative impact on a child's overall development.

"Smartphone addiction can have a negative impact on your child's mental health, social relationships, school performance and sleep habits. But it doesn't have to be that way! The good news is that you can break your child's smartphone addiction with just a few simple strategies".

It's hard to understand how much time kids spend on their devices, but it's easy to spot the difference between kids who are just playing with their phones and those who are using them as a source of entertainment or distraction. One clear sign of smartphone addiction in children is increased temper and tantrums related to losing access to a phone or tablet. The first step to breaking smartphone addiction in kids is to recognize the symptom. Turning a blind eye may do more harm than acknowledging it exists and devising ways to tackle it.

Educate children on the side effects of too much screen time: You might have the urge to take away a smartphone from your child every time they are on it. Setting rules without explaining the reasons behind them rarely have the desired effect. Before setting the screen-time rules at home, explain to your child the negative effects of too much screen time in a language that they will understand.

Set screen time limits: Set a daily limit on the amount of time your child can use a smartphone. Setting a routine has been proven to be a great strategy to get kids to stick to rules and also reduce some of the stress associated with raising young children. It is advisable that children below the age of 18 months should not be exposed to screens. Children between 18-24 months of age can be briefly exposed to high-quality children's programs under parental supervision. Children between 2 to 5 years of age should be allowed screen time of no more than an hour per day. For children above 6 years, parents can decide on a suitable time limit while ensuring that the child has plenty of opportunities for engaging in other activities and healthy sleep habits. Digital-free zones at home: Try not to keep your child's phone in his or her bedroom when he or she goes to sleep. This can lead to bedtime struggles and maladaptive sleep patterns which, in turn, affect the overall growth and development of your child. Even in the absence of a set bedtime, make sure your child isn't spending excessive amounts of time staring at screens after dark. Additionally, no screen time around mealtimes, homework time and in public spaces. Even during tantrums, there is nothing wrong with being stern. Giving in to your kid's tantrums won't help them value rules because they will learn to get away with it. Encourage physical activities: Make sure your child is spending enough time away from technology at home to play outside or do other physical activities. If he or she is spending too much time on devices, consider limiting screen time at home. Joining the activities with kids are a great way to ensure that the physical games are enjoyable and stimulating enough to keep them engaged. While this sounds hard to implement, media fast can go a long way in breaking unhealthy smartphone relationships. Set aside a week of the day during which no smartphones and tablets can be used. On a no-device day, encourage your kids to participate in household chores, learn new activities or engage in arts and crafts activities. Before you expect your child to follow screen-time rules, ensure that you are setting a good example yourself. Kids learn more from what they see than what they hear. Keep track of your own smartphone usage and set rules for yourself as you do for your kids.

#### From secularism to communalism, and back: Varied paths in India & Pak

ew laws amending the Indian Penal Code should alert us to where we have come from and where we are headed. Pakistan wanted to be constitutionally communal, but in some ways has begun to secularise. India wanted to be secular but is communalising itself now. Both nations share a penal code given to them by Macaulay a century and a half ago. But they have amended some aspects to enable the State to target minorities. This is happening in India today and is something that Pakistan went through and is now exiting.

At Independence, Pakistan integrated religion into law because it felt it would lend a positive impulse. Pakistan's first PM Liaquat Ali Khan said material and scientific development had leapt ahead of the development of the human individual. The result was that man was able to produce inventions that could destroy the world and society. This happened only because man chose to ignore his spiritual side, and if he retained more faith in God, this problem wouldn't have come up.

It was religion, he said, that tempered the dangers of science and as Muslims, Pakistanis would adhere to Islam's ideals and contribute to the world. The State's enabling of Muslims to lead their lives in alignment with Islam didn't concern non-Muslims, so they shouldn't have a problem with the reference to that, he said. What happened instead was that laws concerning

Pakistan's Muslims fell away in time. Early Islam existed when there were no jails. Punishment for criminal offences was usually corporal, instead of detention. Pakistan introduced amputation of limbs as a punishment for theft and trained some terrified doctors to carry these out. But Pakistan's judges, trained in common law like India's, were reluctant to pass these sentences and so the laws remained frozen and unused. Pakistan introduced stoning as a punishment for adultery, but nobody was stoned to death. A brief period of enthusiasm for lashing those accused of drinking alcohol ended, and, in 2009, the Federal Shariat Court read down the lashing punishment, with the judges saying drinking was a lesser crime. Under President Pervez Musharraf, Pakistan changed the punishment for rape – which was conflated with fornication if the survivor couldn't produce witnesses to the act – from the Shariah back to the penal code. The law enforcing zakat by debiting 2.5 per cent from the bank accounts of Pakistan's Sunnis failed as people withdrew their money just before it was due to happen. The Shia, who have a hierarchical clergy to whom they give the money directly, had earlier objected and were exempted. The law enforcing fasting in Ramzan - quite needless because most subcontinental Muslims observe the fast anyway - ran into opposition after

successive governments.

The last major attempt to Islamise Pakistan was over two decades ago under Nawaz Sharif: The so-called 15th Amendment, which was defeated in the Senate. Pakistan remains insufficiently Islamic and, with no hierarchical clergy like Iran's, can never become theocratic. Unlike Saudi Arabia, it has never had a morality police as Pakistanis are culturally South Asians with local practices.

As Pakistan moved towards secularism, India has moved substantially in the other direction. Since 2014, laws have been introduced which have gone after India's minorities. In 2015, the BJP-ruled states began criminalising the possession of beef, triggering a series of beef lynchings. In 2019, India's Parliament criminalised the utterance of "triple talaq" in one sitting, punishing Muslim men for a non-event (as the Supreme Court had already invalidated triple talaq earlier). After 2018, BJP states criminalised inter-faith marriage by disallowing conversions and invalidating such marriages, including those which had children. Conversions to Hinduism – defined as "ancestral religion" – are exempt and not counted as conversions in BJP-run states of Uttarakhand and Madhya Pradesh. The Citizenship Amendment Act excluded Muslims in 2019. Under the BJP, Karnataka went after Christians through an anticonversion bill. Nobody has ever been convicted of forced conversion so this law was not required, but the intent is to harass. In 2019 and 2020, Gujarat tightened a law that keeps Muslims ghettoised by denying them access to purchase and lease of properties from Hindus. In effect, foreigners can buy and rent properties in Gujarat that Gujarati Muslims cannot. We need not get into the treatment of Kashmiris here because the collective punishment imposed on them no longer arouses interest in us.

The one thing India can claim is that it does not prevent Muslims from holding high office. Pakistan constitutionally restricts minorities from becoming President or Prime Minister. India has had Muslim Presidents but unlike Pakistan, India's Presidents are figureheads with no real authority. If they had the power to dismiss Parliament, such as Pakistan's Presidents had, it would be interesting to see how many Muslims India would have elevated.

Today, and we must keep repeating this, there is no Muslim chief minister in India, no Muslim minister in 15 states, in 10 states there is only one Muslim minister (usually in minority affairs) and of the majority 303 Lok Sabha MPs of the ruling party, none is a Muslim. There was no Muslim in the previous 282 Lok Sabha majority either.

Whether the exclusion is through law or through practice, the exclusion is real. In effect there is no real difference between India and Pakistan as they move towards each other from two sides. One began at the communal end but has edged towards secularism. The other began at the secular end and has now slipped into communalism.







# **PM Modi leaves for South Africa to attend BRICS** Summit; to meet Xi Jinping

NEW DELHI, Aug 22 (Agencies): Prime Minister Narendra Modi on Tuesday left for South Africa to attend the 15th BRICS Summit and hold several bilaterals, including an expected one with Chinese President Xi Jinping.

In his departure statement, the PM was confident that the BRICS Summit would provide a useful opportunity for its members to identify future areas of cooperation and review institutional development.

"We value that BRICS has become a platform for discussing and deliberating on issues of concern for the entire Global South, including development imperatives and reform of the multilateral system," he added.

This summit would provide a useful opportunity for BRICS to identify future areas of cooperation and review institutional

development, he said. "Leaving for South Africa to take part in the BRICS Summit being held in Johannesburg. I will also take part in the BRICS-Africa Outreach and BRICS Plus Dialogue events. The Summit will give the platform to discuss issues of concern for the Global



participate in this event. "I also look forward to holding bilateral meetings with some of the leaders present in Johannesburg," he said.

The PM is visiting Johannesburg from August 22 to 24. It will be the first in-person BRICS Summit comprising Brazil, Russia, India, China, and South Africa, since 2019.

The PM will then travel to Athens which, he noted, would be his first visit to this ancient land.

"I have the honour to be the first Indian Prime Minister to visit Greece after 40 years," he said. Cooperation in diverse sectors such as trade and investment, defence, and cultural and people-to-people contacts has been bringing our two countries closer, he added. He looked forward to visiting Greece and opening a new chapter in "our multifaceted relationship", saying he would also interact with the Indian community there.

#### Doubting her character, 17-year-old boy kills mother in Maharashtra's Palghar

PALGHAR, Aug 22 (Agencies): A 17-year-old boy allegedly axed his mother to death in Palghar district of Maharashtra after seeing her messaging someone from her mobile phone, police said on Tuesday.

The incident took place on the intervening night of Sunday and Monday in Parole area of Vasai township, they said.

The boy doubted the character of his mother, Sonali Gogra (35), and the two had frequent quarrels over it, inspector Ashok Kamble from Mandvi police station said.

While the boy was having dinner on Sunday night, he noticed his mother

messaging someone on the mobile phone and got annoyed. He then pulled out an axe and allegedly hit her with it, the official said.

The other family members were not present in the house at the time of the incident, he said.

The severely injured woman was rushed to the Indira Gandhi Memorial Hospital in Bhiwandi where doctors declared her brought dead, he said, adding the body was sent for postmortem

A case was registered under Section 302 (murder) of the IPC against the accused who is yet to be apprehended, the police said.

#### Men barge into minor's house, gang-rape her at knife-point after threatening her brother, three other children

HYDERABAD, Aug 22 (Agencies): A 16-year-old girl was allegedly gang-raped by three men at her house here, sources said on Tuesday.

The incident occurred on Monday at Nandanavanam Colony under the limits of Meerpet police station of Rachakonda Police Commissionerate.

The accused, who barged into the victim's house, allegedly sexually assaulted her at knife-point after threatening her brother and three other children. According to the police com-

plaint lodged by the victim, a group of eight youths barged into the house.

Four of the accused took the victim to the third floor of the building, while the remaining threatened her brother and

three other children present in the house.

Three of the four accused who had taken the victim upstairs took turns raping her. They fled after the girl cried for help.

The police registered a case and sent the victim to Sakhi centre for medical examination. Police have constituted seven teams to apprehend the accused. They were scanning the CCTV footage as part of their efforts to track the culprits. Rachakonda Police Commissioner DS Chauhan visited the crime scene and also the Meerpet police station.

Meerpet police were questioning four suspects in the case.

The accused were said to be under the influence of ganja. They included a couple of rowdv-sheeters.

The victim, a Dalit, is employed at a garment shop in Dilsukhnagar, while her younger brother works as a helper.

After losing their parents a few months ago, they had shifted to the colony and were living with a relative.

**BAGALKOT (KARNA-**TAKA), Aug 22 (Agencies): Actor Prakash Raj has been booked in a police station of Karnataka's Bagalkot district over a social media post, in which he allegedly mocked India's ambitious third lunar mission-- Chandrayaan-3, police said on Tuesday.

"A complaint has been filed against actor Prakash Raj for his post on the Chandrayaan-3 mission," police said.

"Hindu organisations leaders filed a complaint against the actor in Banahatti police station of Bagalkote district and have demanded action," they added.

The veteran actor on Sunday took to microblogging site X, sharing a caricature of a man in a shirt and lungi pouring tea.

Sharing the picture, he wrote, "First view just arrived from Chandrayaan .. #VikramLander #justasking."

# More than 200 former Afghan officials and security forces killed since Taliban takeover, UN says

The Taliban-led Afghan foreign ministry dismissed the report, saying it was unaware of any cases of human rights violations

UNITED NATIONS, Aug 22 (Agencies): More than 200 extrajudicial killings of former Afghan government officials and security forces have taken place since the Taliban took over the country two years ago, according to a UN report released on Tuesday.

The groups most targeted by the Taliban have been former army, police and intelligence forces, according to the United Nations Assistance Mission in Afghanistan.

UNAMA documented at least 800 human rights violations against former Afghan government officials and security forces between August 15, 2021, when the Taliban seized power, and the end of June 2023.

The Taliban swept across Afghanistan as US and NATO troops were in the final weeks of their withdrawal from the country after two decades of war. The US-trained and backed Afghan forces crumbled in the face of the Taliban advance and former Afghan President Ashraf Ghani fled the country.

"Individuals were detained by the de facto (Taliban) security forces, often briefly, before being killed. Some were taken to detention facilities and killed while in custody, others were taken to unknown locations and killed, their bodies either dumped or handed over to family members," the report said.

"Even more so, given they were assured that they would be not targeted, it is a betrayal of the people's trust," Turk said. He urged Afghanistan's Taliban rulers — the country's "de facto authorities" to uphold their "obligations under international human rights law by preventing further violations and holding perpetrators to account".

Since their takeover, the Taliban have faced no significant opposition and have avoided internal divisions.

The Taliban-led Afghan foreign ministry dismissed the report, saying it was unaware of any cases of human rights violations committed by Taliban officials or employees.

"Murder without trial, arbitrary arrest, detention, torture, and other acts against human rights by the employees of the security institutions of the Islamic than 424 arbitrary arrests and detentions of former government officials and members of the Afghan security forces while more than 144 instances of torture and ill-treatment were documented in the report, including beatings with pipes, cables, verbal threats and other abuse.

The Taliban initially promised a general amnesty for those linked to the former government and international forces, but those pledges were not upheld.

The failure of the Taliban authorities "to fully uphold their publicly stated commitment and to hold perpetrators of human rights violations to account may have serious implications for the future stability of Afghanistan", the report said.

While the Taliban announcement of a general amnesty in August 2021 "was a welcome step, it continues to not be fully upheld, with impunity for human rights violations prevailing", said Roza Otunbayeva, the head of the UN mission in Afghanistan. She urged the Taliban to show "a genuine commitment to the general amnesty. This is a crucial step in ensuring real prospects for justice, reconciliation and lasting peace in Afghanistan".

Despite initial promises of a moderate administration, the Taliban have enforced harsh rules, banning girls' education after the sixth grade and barring Afghan women from public life and most work, including for non-governmental organisations and the UN.

TORONTO, Aug 22 (Agencies): Canadian Prime Minister Justin Trudeau thanked Canadians for their support in his first public remarks about his family since he and his wife, Sophie, announced that they were separating after 18 years of marriage.

The two announced the decision in statements posted on Instagram early this month, adding they would vacation as a family. On Monday, as Trudeau returned from vacation, he was asked about how he was doing.

"First, I want to thank all the people who have reached out over the past few weeks with warm wishes, with personal messages, with personal stories that have been just wonderful and positive," Trudeau said at a news conference in Cornwall on Prince Edward Island.

It was his first press conference since the announcement.

"I got 10 days with the family to focus on the kids, to focus on being together and moving forward," he said.

Trudeau, the 51-yearold scion of one of Canada's most famous politicians, was sworn into office in 2015. Sophie Trudeau is a former model and TV host. The couple were married in 2005. Together, they brought star power to the prime minister's office and appeared

in the pages of Vogue magazine. They have three children, 15-year-old Xavier, 14-year-old Ella-Grace and nine-year-old Hadrien.

"I really, really, want to thank Canadians for having been so incredibly gracious and incredibly generous in respecting our privacy and our space. It really makes things easier," Trudeau said.

Sophie has played a less visible role in recent years, rarely travelling with the prime minister on official trips. The two were seen together publicly at Canada Day events in Ottawa last month.

Justin Trudeau and Sophie Gregoire met as children when she was a classmate of his youngest brother, Michel, and they reconnected as adults when they cohosted a 2003 charity gala.

### Pakistan President Arif Alvi sacked secretary amid controversy to clear his name: Report

ISLAMABAD, Aug 22 (Agencies): Pakistan President Arif Alvi's decision to sack his secretary after a controversy erupted about the signing of two key bills was made to clear his name, media reports said on Tuesday. as the dismissed official claimed innocence and sought an inquiry. President Alvi sacked his secretary Wagar Ahmed on Monday, a day after he said he did not personally sign the Official Secrets (Amendment) Bill, 2023, and the Pakistan Army (Amendment) Bill, 2023 and had instructed his staff to return them unsigned within the stipulated time to make them ineffective. The President's Secretariat said in a statement that Alvi asked for the replacement of Secretary Ahmed, whose services were "no more required". Ahmed's removal is being seen as a punishment for his alleged impudence, but there was no direct reference to his involvement in the matter, the Dawn newspaper reported. Meanwhile, Ahmed called his removal from the post "not based on justice" and, in a letter, asked Alvi to reconsider his decision to remove the secretary from his post.

# From new toilet to..., know the facilities ex-Pakistan PM Imran Khan would get in jail



PTI chairman's family meets him on Tuesdays, while his lawyers visit him on Thursdays

Khan's wife Bushra Bibi last week voiced concerns about the possibility of her husband being "poisoned" during incarceration at the Attock jail.

In a letter dated August 17 addressed to the Punjab home secretary, Khan's wife had sought the ex-premier be transferred from district jail in Attock to Rawalpindi's Adiala Jail, expressing fear that he could be poisoned in lock-up. According to the letter, the life of the ex-prime minister was in danger as "he was previously attacked twice whereby once he was hit by bullets shots (sic) on his body". In a related development, the PTI Core Committee meeting highlighted the observations of Additional District and Sessions Judge Shafqut Ullah Khan who "verified the bad treatment being meted out to him (Khan) in Attock Jail". The PTI said the judge's report subscribed to their assertions that the PTI chairman was being subjected to inhuman and illegal treatment in the Attock prison. Meanwhile, caretaker Interior Minister Sarfaraz Bugti said the PTI chief was allowed to meet visitors and provided facilities according to the prison class he applied for.

Ahmed also urged the president to initiate an investigation into the matter through the Federal Investigation Agency (FIA) or any other agency to uncover any misconduct, news agency reported.

"I want to set the record straight that I am not responsible for any irregularities regarding the bills," the former secretary stated in the confidential letter.

"The decision to surrender my services isn't based on justice," Ahmed stated, claiming that contrary to allegations of delay and insubordination, the documents pertaining to the bills are still present within the presidential chambers.

Ahmed said the files related to the Pakistan Army Act (Amendment) Bill were not returned to the secretary's office until August 21. Stressing that if any wrongdoing is proven, those responsible should be held accountable. Ahmed said, "I am prepared to testify before the Supreme Court or any other court. I will present a record to establish my innocence." Ahmed clarified that the Official Secrets (Amendment) Bill, 2023,

Speaking to reporters in London about the controversy, former prime minister and Pakistan Muslim League-Nawaz (PML-N) leader Shehbaz Sharif said an official inquiry should be launched into the incident.

Sharif said a transparent inquiry should be held into Alvi's conduct "to determine facts through a transparent probe", the report said. Meanwhile, Pakistan Tehreek-e-Insaf (PTI) leader Babar Awan, in a video message, requested Chief Justice Umar Ata Bandial to take suo moto action. He said that the president of the country was the head of state, a part of Parliament and the supreme commander of the armed forces, while the country's agreements were also made using his name.

"A very serious crime has taken place," he said, adding that this amounted to "constitutional insubordination" which would fall under Article 6 (high treason).

## Ukrainian drone hits apartments, cars in town near Moscow; explosions heard

LAHORE, Aug 22 (Agencies): A new washroom with a five-feet high wall with a door has been constructed at the Attock jail cell of Imran Khan after the former Pakistan prime minister complained to the court about the poor living conditions and lack of privacy, a senior Punjab government prison official said on Tuesday.

Khan is serving a three-year sentence after being convicted in the Toshakhana corruption case.

The Punjab Prisons Department's (PPD) spokesperson said all facilities available under 257 and 771 of the Pakistan Prisons Rules, 1978 have been made available to the Pakistan Tehreeke-Insaf (PTI) chief, Geo News reported.

The clarification by the spokesperson comes after Additional District and Sessions Judge, Attock, Shafquat Ullah Khan visited 70-year-old Khan's cell in the Attock jail and found his complaints and concerns regarding living conditions, including the lack of privacy in the washroom to be "genuine".

The judge in his observations on Monday said Khan on his visit had expressed "grave concerns" about the violation of his privacy and the prevailing living conditions within

Addressing the concerns that Khan did not have any privacy in the bathroom, the spokesperson said a new washroom was constructed in the PTI chairman's cell.

The cricketer-turned-politician, who has a massive following across Pakistan, is currently serving a three-year sentence in Attock Jail after being found guilty of corrupt practices in the Toshakhana case earlier this month.

Khan during his meeting with the judge raised significant concerns regarding a CCTV camera positioned in front of his prison bars, located at a distance of five to six feet, which covers an open bathroom-cum-latrine.

Regarding the CCTV cameras. the spokesperson said that they were installed outside the room.

"CCTV cameras have been installed outside Imran Khan's room for his and jail security. More than 4,000 CCTV cameras have been installed not only in district jail Attock but also in other jails of Punjab for security purposes," the statement added.

He further stated that amenities such as bath soap, perfume, air freshener, towels, and tissue papers had been provided, along with a bed, pillows, mattresses, tables, chairs, air conditioners, and exhaust fans.

Moreover, he added that five doctors had been appointed for Khan, of whom one was available at all times, and the PTI chief was only given "special" food after it was checked by doctors.

"Fruits, honey, dates, prayer mat, Quran and books have also been given," the spokesperson added. It was also reported Khan complained that his wife and lawyers

had no easy access to him; however, the spokesperson said the

Bugti said he would definitely enquire from the Punjab government and jail officials about other issues raised in the inspection report such as the CCTV camera.

"We will ensure that all those facilities and the prison class he (Imran) applied for and deserves as the ex-prime minister according to the law are provided to him. As far as I know, he has a bed and is provided with newspapers but he would get only the facilities that the relevant laws permit."

Khan is on Tuesday scheduled to appear before the Islamabad High Court for the hearing of his plea against his conviction and sentence in the Toshakhana corruption case, a verdict that could be crucial for his political future as well for his party ahead of the general elections.

#### **Court sentences two** persons to life imprisonment in 2014 acid attack case

considering mitigating circumstances. On Thursday last, the court held the accused duo-Irshad Ahmad Wani alias Sunny Wazirbagh Srinagar and Muhammad Umar Noor of Bemina Srinagarguilty of the offence under RPC's Sections of 326-A (Voluntarily causing grievous hurt by use of acid), 201 (destroying evidence) and 120-B (criminal conspiracy).

"I find that the prosecution has been able to establish the charges against the accused persons beyond any reasonable shadow of doubt. As such, this chargesheet is accepted and the accused persons namely Irshad Amin Wani and Mohammed Umer Noor (Accused No.2), are held guilty for the offences punishable under Sections 326-A, 201 &120- B RPC," the court said in the verdict.

The court said that it find "absolutely no material from the defence side to suggest any probable reason for falsely implicating the accused persons in this case.'

"The established facts, circumstances and the chain of evidence taken cumulatively are so complete and consistent that in all human probabilities the only hypoth-

esis is that the horrendous act of throwing acid on the victim has been committed by the accused No.2 in furtherance of the conspiracy hatched by accused No.1 with accused No.2," the court had said, adding, "The established facts and circumstances do not leave any reasonable ground for the conclusion consistent with the innocence of the accused persons.'

Notably, on 11 December 2014, a young law student was grievously injured in the acid attack near Nowshera on the city outskirts while she was on way to her college. Given the gravity of the offence which sent shock waves across the Valley, a Special Investigation Team, constituted by the then IGP Kashmir A.G. Mir under supervision of then SSP Srinagar Amit Kumar with then SP Ravees Mohammad Bhat (presently DIG South Kashmir) as incharge of SIT, arrested the two persons accused within a fortnight.

# India could face higher inflation in coming months, warns finance ministry

NEW DELHI, Aug 22 (Agencies): Retail inflation in India rose to a 15-month high of 7.4 per cent in July, and a new report released by the finance ministry suggests that it could remain elevated for the next few months.

The Department of Economic Affairs, in its July Monthly Economic Review report, highlighted that inflationary pressures have "re-emerged", driven primarily by global disruptions, along with domestic factors.

The report added that the evolving inflation trends call for greater vigilance by the government and the RBI.

"Going forward, while domestic consumption and investment demand are expected to continue driving growth, global and regional uncertainties and domestic disruptions may keep inflationary pressures elevated

for the coming months, warranting greater vigilance by Government and the RBI," it added.

"Monsoon rains in August have been deficient at the time of writing. The government has already taken pre-emptive measures to restrain food inflation which, along with the arrival of fresh stock, is likely to subside price pressure in the market soon. The external sector requires a closer watch to strengthen merchandise export growth in the face of slowing global demand," the report highlighted.

Food inflation likely to cool down

While the report suggests that retail inflation could remain high for the next few months, it indicates that the "uneasiness in food inflation is likely to subside"

It went on to highlight that disruptions on the global front

led to high inflation in India, with specific food commodities such as cereals, pulses and vegetables, mainly driving the increase. All these categories exhibited double-digit growth in July, compared to the corresponding period last year. "Disruption in domestic pro-

duction also aggravated the inflationary pressures. Interruption in the supply chain of tomatoes due to white fly disease in Kolar district, Karnataka and the swift arrival of the monsoon in northern India caused a surge in tomato prices. Tur dal price also inflated due to deficient production in Kharif season FY23," it said.

The report went on to suggest that the food inflation recorded in July was "perhaps the third highest since the new CPI series began in 2014", but added that only 48 per cent of food items

have inflation of above 6 per cent.

"Only items like tomato, green chilli, ginger and garlic witnessed inflation of more than 50 per cent. Hence, the abnormal increase in prices of certain specific items led to high food inflation in July 2023," the report said.

However, the report suggested that the price rise of certain food items is "expected to be transitory".

"Tomato prices are likely to decline with the arrival of fresh stocks by the end of August or early September. Further enhanced imports of tur dal are expected to moderate pulses inflation. These factors, along with the recent government efforts, can soon materialise moderation in food inflation in the coming months," the report added.

# Government not planning to restrict parboiled rice exports, says food secretary

NEW DELHI, Aug 22 (Agencies): India has clarified its stance on parboiled rice exports, with Food Secretary Sanjeev Chopra stating that the country has no plans to impose any restrictions on the export of non-basmati parboiled rice.

This announcement comes after India had previously banned the export of nonbasmati white rice last month, catching many buyers off guard. Currently, there are no limitations on the export of parboiled rice, which accounts for approximately one-third of India's total rice exports. Despite earlier reports suggesting the possibility of an export tax on parboiled rice, the government's position remains unchanged.

India's export ban on non-basmati white rice had led to global



concerns, triggering a sense of urgency among stakeholders and intensifying apprehensions about food security.

The move set off a chain reaction, prompting a race to secure supplies and raising concerns about the potential consequenc-

es of this disruption. The implications of this export ban, projected to curtail the availability of a vital staple food by approximately one-fifth in the global market, spurred a scramble among stakeholders to adapt to the changing land-

#### scape.

Importers, in particular, continue to face the prospect of constrained supplies and surging prices, leading to increased volatility in the market.

As the international community grapples with the fallout from India's decision, importers are increasingly exploring alternative strategies to manage the impact. Amidst these developments, concerns over food security have taken center stage. The ban's potential to disrupt the supply chain has raised alarms, particularly in regions heavily reliant on imports to meet their

#### **Centre to launch 'Mera Bill Mera** Adhikar' GST reward scheme in 6 states, UTs from September 1

NEW DELHI, Aug 22 (Agencies): The government will launch the 'Mera Bill Mera Adhikar' invoice incentive scheme, which offers cash prizes from Rs 10,000 to Rs 1 crore, from September 1, starting with six states and Union Territories.

The scheme, which is aimed at motivating customers to ask for a bill every time they make purchases, will be launched in the states of Assam, Gujarat and Haryana; and the UTs of Puducherry, Daman & Diu and Dadra & Nagar Haveli, Central Board of Indirect Taxes and Customs (CBIC) said.

Invoice incentive scheme allows to earn cash prizes on upload of GST invoices, CBIC tweeted.

All invoices issued by Goods and Services Tax (GST) registered suppliers to consumers will be eligible for the 'Mera Bill Mera Adhikar' scheme, under which monthly and quarterly draws of lots will be made and winners will be eligible for cash reward prizes beginning from Rs 10,000 to up to Rs 1 crore.

The minimum purchase value for the invoice to be considered for the lucky draw is Rs 200 and individuals can upload a maximum of 25 invoices in a month beginning September 1.

The 'Mera Bill Mera Adhikar' mobile app will be made available on both IOS and Android platforms.

The invoice uploaded on the app should have the GSTIN of the seller, invoice number, amount paid and tax amount

The scheme is conceptualised in a way to incentivise citizens and consumers to ask for genuine invoices from the seller when making business-toconsumer (B2C) purchases of goods or services.

# Simple blood test may predict future heart, kidney risk for diabetics

NEW YORK, Aug 22 (Agencies): A simple blood test may predict the risk of progressive heart and kidney disease in people with type 2 diabetes, according to new research.

An analysis of a clinical trial of more than 2,500 people with type 2 diabetes and kidney disease has found that high levels of four biomarkers in blood tests are strongly predictive for the development of heart and kidney issues, according to the study published in the American Heart Association's flagship journal Circulation.

"High levels of certain biomarkers are indicators of heart and kidney complications and may help predict future risk of disease progression," said lead author James Januzzi from Harvard Medical School, also a cardiologist at the Massachusetts General Hospital.

People who took canagliflozin, a sodium glucose co-transporter 2 inhibitor (SGLT2 inhibitor), had lower levels of the four biomarkers compared to those who took a placebo over the three-year study period.

Canagliflozin is a third-line medi-



cation to be tried after metformin, a first-line medication for type 2 diabetes.

Treatment with canagliflozin helped to substantially reduce the risk of hospitalisation for heart failure and other heart complications among patients considered to have the highest risk.

The researchers analysed biomarker data from the blood samples of 2,627 people to assess the effects of canagliflozin on concentrations of the four biomarkers. Patients were separated into low, medium and high risk categories. People at highest risk showed dramatically higher rates of progressive kidney failure and cardio-

vascular complications throughout the three-year study period.

The analysis found high concentrations of each biomarker at the beginning of the study were strongly predictive of the severity of the participant's heart and kidnev issues

The concentrations of each of the four biomarkers in people taking canagliflozin were lower after one year and three years compared to those taking the placebo.

After one year, the levels of all biomarkers in participants who took canagliflozin rose 3 per cent to 10 per cent, compared to an increase of 6 per cent to 29 per cent in those who took the placebo.

"It was reassuring to discover that canagliflozin helped reduce risks the most in people with the highest chances for complications. Future studies are needed to better understand how type 2 diabetes in conjunction with kidney disease develops and progresses so that we may initiate life-saving therapies earlier, before symptoms of heart and kidney disease have occurred." Januzzi said.

#### **Research reveals anxious people use less** suitable section of brain to control emotions

WASHINGTON DC, Aug 22 (Agencies): Anxious people use a less suitable section of the forebrain when choosing their behaviour in socially difficult situations than non-anxious persons. This can be detected in brain scans. according to research conducted by Bob Bramson and Sjoerd Meijer at Radboud University's Donders Institute.

For example, an anxious and a non-anxious person both run into someone whom they've been in love with for guite some time. Both of them find this tense and both would like to ask the person out on a date. But do you walk up to that person? Or do you pretend not to see them to avoid embarrassment? Whereas the non-anxious person can put aside this emotion and choose behaviour that allows them to approach the potential lover, this is much more difficult for an anxious person. Bramson: "Anxious people use a less suitable section of the forebrain for this control. It's more difficult for them to choose alternative behaviour, so they avoid social situations more often." Decisions like this demand a balancing act between



a possible threat and a reward, a decision that non-anxious people make in the prefrontal cortex. Researchers at Radboud University have now shown that socially anxious people use a different section in the forebrain for decisions like this.

#### Brain scans

Bramson and Meijer studied brain scans to see what happens in anxious and non-anxious people in a simulated social situation. "Our trial subjects were shown happy and angry faces and had to first move a joystick towards the happy face and away from the angry face. At a certain point they had to do the reverse: move towards an angry face and away from a happy face. This demands control over our automatic tendency to avoid negative situations." Anxious people proved to perform just as

well as non-anxious people in this simple task, but the scans showed that a completely different section of the brain was active. "In nonanxious people we often see that, during emotional control, a signal is sent from the foremost section of the prefrontal cortex to the motor cortex, the section of the brain that directs your body to act. In anxious people a less efficient section of that foremost section is used." Other scans showed that the reason for this is probably because the 'correct' section becomes overstimulated in anxious people. "This could explain why anxious people find it difficult to choose alternative behaviour and thus avoid social situations. The disadvantage of this is that they never learn that social situations aren't as negative as they think.'

#### Treating anxiety

For the first time, brain scans have now shown that the forebrain of anxious people works differently from that of non-anxious people with regard to control of emotional behaviour. The researchers think that the results could be used to develop new treatments for people with anxiety.

# High five for Sift: Shooter pockets Olympic quota for India

CHENNAI, Aug 22 (Agencies): Not so long ago, shooter Sift Kaur Samra was caught between the devil and the deep sea. The Punjab shooter, who is a first-year MBBS student in Faridkot, had to choose between a World Cup event in Bhopal and her medical exams. She had to sacrifice her studies for the former. Her choice said it all. Shooting was going to be her priority, at least until the 2024 Paris Olympics.

Her difficult call is now paying off, even though she still has a long road ahead. On Monday, Sift got a step closer to her aforementioned shooting target. The 21-year-old, who is part of the TOPS Scheme and also supported by Olympic Gold Quest, showed she has a great deal to offer to the sport with an Olympic quota-winning effort in the ongoing ISSF World Championships in Baku, Azerbaijan. Sift was in a spot of bother after a certain phase during the qualifications. But she recovered in an emphatic manner to finish fifth in the tricky phase. Before she could fire in the women's 50m rifle 3 positions final, the Olympic quota for India was already ensured as three of the other finalists had bagged a quota before the



ongoing world meet.

Apart from that, there were two Chinese shooters in the final; only one quota on offer per nation. In the final, Sift got off to a slow start but once again, showed her ability to fight back under pressure. Eventually, she finished fifth, just a spot behind Olympic champion Nina Christen. The Chinese duo of Zhang Qiongyue and Han Jiayu bossed the final and finished one-two, respectively. Ashi Chouksey and Manini Kaushik, the other Indians in the competition, finished 29th and 40th, respectively. Given what Sift and her family has been through recently, her father, Pawandeep Singh, is a relieved man. "You do tend to get proud of course. Happiness is there of course. She had a difficult start but she showed fighting qualities to make a good comeback. It's a good experience for her as this was the strongest competition she has faced so far, as far as I'm concerned," he said.

Recognising Sift's passion for the sport, Pawandeep had backed her to continue shooting and pursue her dreams. He is mindful that this is just the beginning and is hopeful that the difficult decision will pay off ultimately. "She had to drop (first-year). It was a very tough decision. If we had told her to opt for MBBS, she might have got disturbed. It was a very hard decision for all of us. Whatever God desires, she'll follow that just the opposite. "For MBBS, he left the sport. He's getting admitted this time. These decisions are really tough. There's no guarantee that the sport can help one set their lives. It's rare." Apart from her family's support, her coach Deepali Deshpande has also pushed her a great deal. She was confident about Sift and was expecting her to rise and shine. Three (out of six that India have earned so far) of Deepali's wards have now earned an Olympic quota. Deepali is obviously pleased for her ward but has taken notes in order to help elevate Sift's game.

"She shot two matches, elimination and qualification. She was in the second elimination round. I could see some tired-

SYDNEY, Aug 22 (Agencies): Former Australian cricketer Matthew Hayden has reacted to David Warner's plans to retire from international cricket in Sydney next year, saying that he does not think that the Australian selectors will make any decision on personal preferences. Notably, Warner has stated that he intends to retire from Test cricket in Sydney in the new year when Pakistan visits, and to retire from international cricket entirely at the 2024 T20 World Cup.

"Knowing Australian selectors and the Australian sporting culture, the selectors wouldn't sit around the table and say, 'oh, what does David Warner want in terms of his own playing career?' They would look at it in terms of is he performing and what is our plan as a nation around how it is we project this series, into the next series," Hayden said at an event in Mumbai. Hayden mentioned

that Australia will host India for a five-Test match series in 2024. With this series in mind, the selectors will take into account various factors and will be concerned about the limited options available to replace Warner.


