He further added that even the government has not released the members arrested which is a matter of serious concern, the whole Jammu is uniting to fight for the cause by organizing protest and Jammu Bandh call is also given in this regard. KARGIL, Aug 25 (Agencies): Congress leader Rahul Gandhi on Friday vowed to raise in Parliament the issues of the people of Ladakh as he alleged that their "political voice" was being suppressed and the promises of the central government on employment had turned out to be "false".

Gandhi has been touring the Union Territory of Ladakh for the past week.

"I went to every corner of Ladakh and talked to the youth, mothers and sisters and the poor. There are other leaders who only talk about their 'Mann Ki Baat'. I want to listen to your 'Mann Ki Baat'," the former Congress leader said in an apparent swipe at Prime Minister Narendra Modi's monthly radio broadcast.

"China has snatched away thousands of kilometers of India's land. The prime minister is lying by denying this and every person in Ladakh knows this." Gandhi said in a post in Hindi on X.

He said the main issues of Ladakh are that the political voice of the people here is being "suppressed", all the promises of the government on employment have turned out to be "false" and the lack of mobile network and air connectivity

"I will raise all these issues in Parliament in the next session," Gandhi said and thanked Ladakh for the welcome and love he had received. Congress general sec-

retary Jairam Ramesh,

in a post in Hindi on X, said that taking forward the Bharat Jodo Yatra, Gandhi met the people of Ladakh.

In the spirit of the foot march, he listened to their thoughts, he said. "It is clear after listening to these problems that the Modi government has left Ladakh to fend itself. Leaders who are only interested in their 'Mann Ki Baat' can never allow the people's voice to be heard," Ramesh said. Gandhi reached Ladakh on August 17,

his first visit to the region since it was granted UT status after being carved out from Jammu and Kashmir in August 2019. The erstwhile state of Jammu and Kashmir was also turned into a Union Territory with its special status under Article 370 revoked. Over the past week, Gandhi visited several parts of Ladakh, including Pangong lake, Nubra valley, Khardungla top, Lamayuru and Zanskar, on his motorcycle

accused in take DOB case

SRINAGAR, Aug 25 (Agencies): Economic Offences Wing (EOW) of Crime Branch Kashmir (CBK) has filed a chargesheet against 8 accused persons in the court of city Munsiff Srinagar for allegedly producing fake date of birth certificates (DOB).

According to a statement issued on Friday, the chargesheet was filed in case FIR No. 28/2021 of P/S Crime Branch Kashmir against eight accused individuals before the court of city Munsiff Srinagar for their alleged involvement in commission of offences punishable under Sections 420, 420/511, 202, 468 & 471 of RPC.

The statement reads that brief facts of the case are that Crime Branch Kashmir had received a complaint from the Agriculture Production Department (on the basis of a report generated by Director Agriculture Kashmir) alleging therein

that 12 officials of said department had submitted fake DOB certificates at the time of their initial appointment in Government service.

Accordingly, the instant case was registered in P/S Crime Branch Kashmir in 2021 and investigation was started. During the investigation, it has been established that 8 out of the 12 accused individuals have cheated the department by submitting fake and forged DOB certificates at the time of their initial appointment, as a result of the deceit they continued to remain in service and unlawfully derived the benefits of employment beyond their actual age of retirement on superannuation, the statements reads. It reads that the chargesheet has accordingly been presented against these eight accused persons in the court of competent jurisdiction for judicial determination.

MeT advises concerned authorities to be cautious against landslides, flash floods in J&K

JAMMU, Aug 25 (Agencies): The weather department on Friday advised concerned authorities to remain cautious till August 26 as "rain over higher reaches may generate landslides, flash floods in vulnerable spots at lower catchments

areas". A meteorological department official said that generally cloudy weather was expected with possibility of intermittent light to moderate rain at scattered places of J&K during next 24 hours.

On August 26, he said, weather is expected to be generally cloudy with possibility of "intermittent light to moderate rain at scattered places." "Although there's no forecast of heavy rain, still all concerned are advised to remain cautious during August 25-26th as rain over higher reaches may generate landslides, flash floods in vulnerable spots at lower catch-

ments areas," he said. From August 27-28, he said, weather is expected to be partly to generally cloudy.

54 Drug smugglers booked under **PITNDPS, PSA in Baramulla**

Srinagar, Aug 25 (Agencies): Police booked 54 most wanted and notorious drug smugglers under Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PIT NDPS) Act, and Public Safety Act (PSA) in Jammu Kashmir's Baramulla district during the current year.

Baramulla police in its ongoing operation against drug smuggling and in order to eradicate the menace of drugs from society, has booked 54 drug smugglers under PIT- NDPS Act and PSA in the district after obtaining formal detention orders from the competent authorities and lodged in different jails of Jammu and Kashmir during the current year, a police statement said on Friday.

These hard-core drug peddlers were operating in Uri, Pattan, Baramulla, Kreeri and Tangmarg sub divisions of the district.

Pertinent to mention that many cases are registered against these drug Smugglers and were involved in promoting drug abuse trade by supplying drugs to local youth of in the district, police said and added despite their involvement in many FIR's they did not mend their activities and were again involved in promoting drug abuse trade by supplying drugs to local youth.

Sustained action against drug peddlers has brought a visible change in the ground situation and drug abuse has seen a considerable downfall in Baramulla district.

STOP 3D EVILS

Completing drug addiction is a major and widespread problem in India. Where the family disintegrates due to this problem, the society gets infected, then the nation becomes weak. It is not only a social problem, but also a medical and psychological problem. There is such a quagmire, in which the person who sinks is not only destroyed, but also his whole family is also destroyed.

The side effects of drugs not only destroy the person who is addicted to it, but also destroy the family, society and nation. This is the reason why it is essential to keep the nation free from drugs in order to make it strong. Consumption of drugs, that is, intoxication is the result of 3D evils.

First 'darkness' means darkness in life, second 'destruction' means reaching the point of destruction and third 'devastation' means complete devastation. To save the family, society and nation from the evils and side effects of drugs, we have dreamed of a 'Drug Free India' and strong initiatives have been started to make this dream come true. The Prime Minister of the country Narendra Modi himself has shared his thoughts with the countrymen by calling for a 'drug free India'.

In a general sense, drugs refer to those chemical substances, which when taken have a chemical reaction on the brain and affect the normal functioning of the body and mind. The general meaning of drugs may be medicine or medicine, but in the social sciences this term is used for substances whose consumption is considered illegal.

The irony is that anyone who reaches this stage is often unable to lead a normal life. He destroys himself at the physical, mental and economic levels. To the moon and beyond: India at cusp of a new age

India is on the moon!"

declared Sreedhara Panicker Somnath, the unassuming chief of India's space agency Isro at 6.03 pm on Wednesday, August 23, when the Vikram lunar lander made a soft touchdown on the moon's surface. The scientists of the Indian Space Research Organisation monitoring the touchdown roared in joy while Indians across the country and overseas rose to applaud the event, their unbound elation a reflection of the momentousness of the event.

India had become the fourth country in the world to touch down on the moon, and the first to land near its southern pole. Millions watched the progress of the lunar landing craft, Vikram, as it detached from the orbiter Chandrayaan-3 which had carried it from earth across 384,400 km of empty space following its launch from Sriharikota more than a month ago on July 14, 2023. From 5.43 pm Indian time till the touchdown twenty minutes later, India held its breath. The previous attempt to soft land on the moon about four years ago had proved a disaster. This time around, though, the landing was perfect. The lander Vikram almost immediately began collecting and transmitting data while the robotic rover Pragyan inside it rolled out later to investigate the soil and minerals on the moon.

The lander Vikram houses three kinds of sensors while Pragyan has two. They will operate for one lunar day, which is equivalent to 14 earth days. Both are primarily powered by solar arrays and once night descends on the moon both will quietly shut down having completed the mission they were designed for. Up above the moon, two Indian spacecraft, Chandrayaan-3 and Chandrayaan-2, will continue orbiting and sending photographs of the lunar surface. The three main objectives of the lunar mission -- soft landing of the lander, demonstrating the rover's driving capabilities and conducting experiments on the lunar surface to better understand the composition of the moon -- have all been met.

This is the culmination of an amazingly successful programme carried out on a shoestring budget. "These are very cost-effective missions... No one in the world can do it like we do," Isro chief Sreedhara Panicker Somnath said. The New York Times reported that the "mission's budget of about \$75 million was less than the \$100 million budget of the Hollywood space film Gravity". Not surprisingly, the Indian government has given the green signal to a slew of space exploratory missions to follow, the first of which will be the Aditya-L1, which is schedule to lift off next month and get into an orbit suitable for studying the sun. There will be more probes sent out to Mars and a mission to ultimately land an Indian on the moon.

The successful moon landing marks a milestone in India's long association with its celestial partner. As far back as 3,500 years ago, long before civilisation had emerged in most other parts of the world, ancient Indians were already studying the moon. Precisely arranged megaliths (huge rock columns weighing a few tonnes) have been found in places such as Brahmagiri in Karnataka, Pokaria in Jharkhand, Arossim in Goa and elsewhere. Scientists believe these pre-historic arrangements of megaliths constitute observatories to record the movement of the moon and the sun.

"What is even more amazing is the scientific accuracy with which these arrangements of rocks are able to predict the lunar cycle", writes biochemist Pranay Lal, the author of the book Indica. He points out that these rock arrangements could even pinpoint occurrences such as the "lunar standstill", which occurs once every 18 and a half years when the moon dips below the horizon and remains put for a couple of weeks. The scientific demeanour of ancient Indians, their learning and discoveries gradually dimmed over the centuries, while other cultures took up that knowledge and further developed it. India sank into superstition, turning its back on scientific progress. Now, as the country seeks to get on to the world stage where science and technology dominate, it desperately needs to shed its baggage of outmoded mindsets and adopt new role models.

One of the most significant effects of Isro's lunar success this week will be its impact on the country's younger generation and a renewed focus on scientific learning and achievement. This, hopefully, will inevitably dent obscurantist tendencies in the country and restore scientific learning to its erstwhile glory.

At the same time, the government's moves to open up the space sector to private players, engage with global space programmes such as Artemis and the promotion of technology to solve everyday problems are certain to crank up the scientific temper in the country. This will perhaps prove to be the biggest dividend of the successful moon landing Wednesday. Suddenly, every bright kid in the country wants to be a rocket sci-

entist!

Unlike in the West, in India science and reason have never been considered antithetical to religion. In fact, Swami Vivekananda once said that "science and spirituality are two sides of the same coin". He, like the ancients of this country, did not believe that superstition and dogma could be the foundation of religion: "Is religion to justify itself by the discoveries of reason, through which every other science justifies itself? Are the same methods of investigation, which we apply to sciences and knowledge outside, to be applied to the science of religion? In my opinion, this must be so, and I am also of the opinion that the sooner it is done the better. If a religion is destroyed by such investigations, it was then all the time useless, unworthy superstition; and the sooner it goes the better."

This is the scientific spirit that imbued Indian culture in the distant past. In his 1896 lecture in London, Swami Vivekananda only reaffirmed what was accepted by the rishis of old: "Believing certain things because an organised body of priests tells him to believe, believing because it is written in certain books, believing because his people like him to believe, the modern man knows to be impossible for him."

It is this scientific spirit that was extinguished in India over the centuries which is poised to be revived. The successful moon landing, the pride and elation it evoked in millions of Indians, the fact that it was one of the most watched events in history, suggests that India has arrived at a cusp. India has touched the moon and inspired millions who are destined now to shape the future of the country. Bravo Isro!

India remains a diverse nation, but there's little sign of unity left

-n November 1949, a month before I was born, the **L**Indian Parliament adopted the Constitution, and it came into force two months later, in January 1950. The document laid down the ideals and modalities of how India, as a new nation, would function. Among these was the principle of "unity in diversity". In newly independent India, those were heady days. Jawaharlal Nehru, the first Prime Minister of India and the leader of the Indian National Congress party, promoted unity in diversity as an ideal essential to nation-building and progress. In his 1946 book, The Discovery of India, he wrote of the physical appearances and mental habits and traits of Indians, pointing to the physical difference between the Pathan of the North-West and the Tamil in the far South -- differences in their racial stock -- two extreme examples and all the others that lay in between. All had distinctive features, and still more, the distinguishing

longer separate. In 1947, a year after Nehru wrote about this oneness, the land experienced the Partition and India and Pakistan were created as two countries. Some 14 million to 18 million people moved between the newly and randomly created borders, Hindus to India and Muslims to Pakistan, accompanied by bloodshed, violence and unwarranted grief, the memory of which persists to this day. In 2023, what then is the "distinguishing mark" of India? What is the "oneness"? I believe it is notional. A decade ago, while travelling in the Northeast and chatting with a group of young people, I asked if they got to Delhi much. They smiled and said no, as people they met there asked them if they were from China or Korea. I was not surprised. As a people and government, we have not promoted oneness. It was assumed that by adding it in the Constitution it would happen, just like equality and justice. While the mechanisms were put into place for justice and equality, it was not so for oneness. Lost in the myth of diversity, we deluded ourselves that it was something to be proud of. Side by side, we steeped ourselves in our differences, clinging on to our religious beliefs, foods and customs, guarding them zealously, afraid they would be lost in the sea of diversity. And as a majority of Indians were Hindus, it was assumed that all the others were inconsequential. This is true till today.

Muslims living in Delhi talk about how Hindus will not rent out homes to them. The author Hansda Sowvendra Shekhar wrote a short story in which his Adivasi parents, both professionals, move to Gujarat, but find it hard to get housing as they are non-vegetarians. Examples abound. Questions about caste, gotra, class, gender and sexual orientation influence our lives after we check each other's complexion and features to determine origin. The recent incidents of violence in the states of Manipur and Haryana, spurred by false news on the social media but based on decades of conflict in the two states and communities, point to the inability of the government, both Central and state, to promote harmony and oneness. The roots of the conflict existed, aided and abetted by policies of ruling parties. But what about the citizenry? Let us start with institutions. The family is the first place where seeds of both oneness and differences are sown. When parents see differences as problematic, how can they pass on the notion of diversity as something positive to children? If differences based on caste, class, religion, language and sex are threatening, then how can oneness be promoted? Adult Indians are a product of their upbringing, besides their families, in institutions of education, and religion, which pay lip service to harmony, but practice discrimination. These biases are carried over to the workplace, where they are

reinforced.

Promoting the idea and practice of unity in diversity is a responsibility of all institutions.

It would not be inconsistent to say that the whole country is covered by this problem. This problem is not even related to any particular class. Drugs are prevalent in all classes, poor, middle and elite. For some it is a means of enjoyment and a symbol of status symbol, while for some it is a means of relieving fatigue. Some turn to drugs to drown out failure and frustration. Comparatively, the youth are somewhat more in the grip of drugs.

The youth enter the dark alley of drugs for many reasons. Sometimes the reason for this is loneliness of life, sometimes emotional insecurity or lack of love from parents. Domestic discord, life's failures, stress due to various reasons, wrong company, yearning to experience a unique pleasure, influence of western civilization, momentary feeling of relief from problems, pressure of friends or mis-motivation etc. And sometimes even minors are made addicted to drugs.

Apart from this, people involved in the network of drugs mafia spread at the international level also make youths addicted to drugs by misleading them to make their business shine.

There are many side effects of drug addiction. Not only does the addict suffer for them, his family also gets ruined. The society and the nation are also affected adversely. The quagmire of drugs is so dangerous that a person trapped in this quagmire does not live anywhere.

He gets devastated on physical, economic and psychological levels. Once addicted to drugs, this addiction does not go away and when the victim of this addiction becomes financially hollow, then to fulfill the addiction, he commits crimes like theft. mark of India. "Though outwardly there was diversity and infinite variety among our people, everywhere there was that tremendous impress of oneness, which had held all of us together for ages past, whatever political fate or misfortune had befallen us," wrote Nehru.

The Cambridge dictionary defines "oneness" as a state of being joined as one thing, and no

Central and state governments can practice and create and broadcast programmes addressing diversity and the importance of peace and harmony via their radio, television and social media platforms. Workplaces and educational institutions can create curricula on how our biases develop and are perpetuated. Families can inform themselves on how to be better examples for young children and raise them differently. It must start with each of us.

When the Constitution was adopted, there was little awareness how to inculcate these values in citizens. Today, with the advent of the Internet, knowledge and awareness are available to us. There is no excuse to be ignorant.

The India of 2023 is vastly different from the India that became independent in 1947. The Constitution is but a piece of paper to guide the nation. Nehru's vision of India was one where differences would be celebrated, and we would be unified. But no mechanisms were set in place, then and even now.

The conflict and violence in India today are not surprising. And it will get worse. The challenges of keeping 1.4 billion people together are huge and the task of building unity in diversity is for each of us, an urgent and compelling task. As in our diversity, there is little unity.



Manipur ethnic violence: Supreme Court transfers 27 cases probed by CBI to Assam

NEW DELHI, Aug 25 (Agencies): The Supreme Court on Friday transferred to Assam the trials of 27 cases of sexual violence relating to Manipur ethnic conflict being probed by the CBI.

A three-judge Bench led by Chief Justice of India DY Chandrachud asked the Chief Justice of the Gauhati High Court to designate one or more judicial magistrates and sessions judges in Guwahati to deal with these 27 cases being probed by the CBI.

The victims and witnesses in these cases will be at liberty to give evidence virtually through video-conferencing from their places in Manipur, instead of travelling to Assam to be physically present in the court in Guwahati.

The order came after Solicitor General Tushar Mehta suggested on behalf of the Manipur government that the trials in the CBI cases be transferred to Assam



as there were security concerns as also certain apprehensions about judges in Manipur belonging to particular communities. Senior counsel Colin Gonsalves opposed the transfer of CBI cases to Assam and suggested that instead these cases should be shifted to Mizoram.

As Gonsalves said trials should happen in the hills, the CJI said, "There have been victims in valleys, and in hills. It would be difficult for people who suffered in valleys to travel

to hills, and the other way round. We are not on... who suffered more...just the practical difficulty," the CJI said. The Bench went on to request

the Gauhati High Court Chief Justice to nominate one or more Chief Judicial Magistrate/ Sessions Judge in Guwahati conversant in one or more languages of Manipur.

It said, "All applications for the production of accused, remand,

judicial custody, extension of custody and other proceedings in connection with the investigation are allowed to be conducted in the online mode bearing in mind both the security and distance issues."

The judicial custody of the accused, when granted, shall be permitted in the state of Manipur to obviate transit and the statements of witnesses under Section 164 of the CrPC are permitted to be recorded in the presence of a local magistrate in Manipur, or as the case may be, the place where the witnesses reside outside Manipur, it ordered.

The top court also asked the Acting Chief Justice of Manipur to designate magistrates for these purposes. The test identification parades would take place in the presence of a Manipur-based magistrate and applications such as arrest and warrant would be made through the online mode, it added.

Sharad Pawar Makes Massive Claim, Says "No Split" In NCP. Explains Why

PUNE, Aug 25 (Agencies): Nationalist Congress Party (NCP) chief Sharad Pawar today asserted that there was no split in the party and Maharashtra Deputy Chief Minister Ajit Pawar continues to be its leader.

He also said that some leaders have left the NCP by taking a "different political stand", but it cannot be termed as a split.

Sharad Pawar was talking to reporters at his hometown Baramati in Pune district in the morning before leaving for Kolhapur, where he is scheduled to address a rally later in the day.

A day earlier, his daughter and party's working president Supriya Sule called Ajit Pawar a senior leader and MLA of the party. "Now, he



a stand that is against the party, and we have given a complaint to the assembly speaker

and are awaiting his response," Ms Sule, who is NCP's Baramati MP, told reporters. When asked about Ms Sule's statement that there is no split in the NCP and Ajit Pawar is a leader of the party, Sharad Pawar said, "Yes, there is no question about it."

"How can anybody say that there is a split in NCP? There's no question that Ajit Pawar is our party leader," he said.

"What does a split in a political party mean? Split occurs when a large group in a party is separated at the national level. But no such thing has happened here. Ajit Pawar and eight other NCP MLAs had joined the Eknath Shinde-led Shiv Sena-Bharatiya Janata Party (BJP) government in the

state on July 2. Replying to a query, Sharad Pawar also said that the Maha Vikas Aghadi (MVA), comprising the NCP, Uddhav Thackeray-led Shiv Sena (UBT) and Congress, will perform better than the BJP-led National Democratic Alliance (NDA) in Maharashtra in the 2024 Lok Sabha elections.

When asked about a survey that projected the opposition INDIA alliance getting a good response against the NDA in the Lok Sabha polls, Mr Pawar said, "I haven't seen the survey yet. But yes, we are talking with some survey organisations where we can clearly see that MVA will win maximum seats

in the upcoming Lok Sabha elections.'

Life convicts Amarmani Tripathi, wife set to be released after 16 years in UP jail

LUCKNOW/GORA-KHPUR, Aug 25 (Agencies): Former UP minister Amarmani Tripathi and his wife Madhumani, serving life term in poet Madhumita Shukla murder case, are likely to be released from the jail here later in the day, Gorakhpur jail superintendent Dilip Pandey said on Friday.

The prisons department had on Thursday issued an order for the premature release of Amarmani Tripathi, citing the state's 2018 policy on remission, since they have completed 16 years of imprisonment.

The department also cited their old age and good behaviour as Amarmani is 66 and Madhumani 61, the official said citing the order.

At present, both Amarmani and his wife are in BRD medical college. Gorakhpur district jailer AK Kushwaha said that

if the formalities get completed, they may be released later on Friday. Madhumita Shukla's sister, Nidhi Shukla, who had been in the forefront in this legal fight, said she has approached the Supreme Court against the decision and also fears for the life of her family.

Poet Madhumita, who was pregnant, was shot dead on May 9, 2003, in Paper Mill Colony, Lucknow. Amarmani Tripathi was arrested in September 2003 in connection with the murder of the poetess with whom he was allegedly in a relationship.

A Dehradun court had sentenced Amarmani Tripathi and wife Madhumani to life imprisonment for Madhumita's murder in October 2007. Later, the high court and the Supreme Court upheld the sentence of the couple. The case was probed by the CBI. "I have been telling

everyone that this is going to happen. I have procured the documents through an RTI which clearly state that 62 per cent of the jail term that the two are said to have served had been spent out of jail. I submitted documents to all

responsible persons telling them that between 2012 and 2023 he was not in jail.

The government documents, which I have got through the state information commission, after a long fight, bear this out," Nidhi Shukla told agency.

She alleged that Tripathis have misled the authorities to get a premature release.

Shukla also said she fears for her and her family's life in case the two are released. Amarmani Tripathi and his wife are currently admitted to the BRD Medical College, Gorakhpur, for health reasons.

Amarmani Tripathi, who was elected from Nautanva constituency, had been a minister in the BJP state government in 2001. He was with the Samajwadi Party during the Mulayam government and then switched to the Bahujan Samaj Party.

Japan Delays "Moon Sniper" Mission Launch To August 27 Due To Bad Weather

TOKYO, Aug 25 (Agencies): Hot on the heels of India's historic lunar landing, Japan's space programme is hoping to rebound from a string of setbacks next week with the launch of its own mission: "Moon Sniper".

The rocket will carry a lander expected to reach the Moon's surface in four to six months as well as an x-ray imaging satellite designed to investigate the evolution of the universe.

The launch is scheduled to take place Monday after bad weather pushed it back by a day, the Japan Aerospace Exploration Agency (JAXA) said Friday.

Japan's space programme is one of the world's largest, but its first attempt to put a lander on the Moon failed in November 2022, and a new type of rocket exploded during a test last month.

JAXA's hopes are now centred on the "Smart Lander for Investigating Moon".

As its acronym suggests, SLIM is small and light, standing 2.4 metres (7.9 feet) high, 2.7 metres wide and 1.7 metres long, and weighing around 700 kilogrammes (1,545 pounds).

Dubbed the "Moon Sniper" for its precision, JAXA is aiming to land it within 100 metres of a specific target on the Moon, far



less than the usual range of several kilometres.

Using a palm-sized mini rover that can change shape, the probe -- developed with a toy company -- aims to investigate how the Moon was formed by examining exposed pieces of the lunar mantle.

"Lunar landing remains a very difficult technology," Shinichiro Sakai from the SLIM project team told reporters on Thursday while paying homage to India's success

"To follow suit, we will do our best in our own operations," Sakai said.

India success On Wednesday, India landed a craft near the Moon's south pole, a historic triumph for the world's most populous nation

gramme. Previously, only the United States, Russia and China had

managed to put a spacecraft on the lunar surface, and none on the south pole. India's success came days

after a Russian probe crashed in the same region and four years after the previous Indian attempt failed at the last moment.

Japan has also tried before, attempting last year to land a lunar probe named Omotenashi, carried on NASA's Artemis 1, but the mission went wrong and communications were lost.

And in April, Japanese startup ispace failed in an ambitious attempt to become the first private company to land on the Moon, losing communication

after what the firm called a "hard landing".

Japan has also had problems with launch rockets, with failures after liftoff of the next-generation H3 model in March and the normally reliable solid-fuel Epsilon the previous October.

Last month, the test of an Epsilon S rocket, an improved version of the Epsilon, ended in an explosion 50 seconds after ignition.

- Plasma wind -The workhorse H2-A rocket launching from Tanegashima in southern Japan on Monday will also carry the X-Ray Imaging and Spectroscopy Mission (XRISM) developed by JAXA, NASA and the European Space Agency.

The satellite's high-resolution X-ray spectroscopic observations of the hot gas plasma wind that blows through the universe will help study the flows of mass and energy as well as the composition and evolution of celestial objects.

"There is a theory that dark matter is preventing galaxies from expanding," explained XRISM project manager Hironori Maejima.

"The question of why dark matter does not converge, and what are the forces that spread it, is expected to be clarified by measuring plasma with XRISM."

'Next level': Elon Musk on Donald Trump's mugshot post on X



WASHINGTON, Aug 25 (Agencies): Elon Musk on Friday termed Donald Trump's mugshot post on social media as "next level". The former US President, following his arrest in the Georgia elections case, on Thursday (US local time), took to X (formerly Twitter) and posted his police mugshot.

Trump, a Republican, also posted the same to Truth Social, both posts with the words "election interference" and "never surrender."

The former US President's post on X was reposted by Musk, who captioned it "next-level"

This came after the Fulton County Jail released a mugshot picture of him, which soon went viral.

The jail authorities recorded him as being 6 feet. 3 inches tall and weighing 215 pounds (97kg), with blond or strawberry hair and blue eyes. His inmate number was P01135809.

It marked Trump's first tweet since January 8, 2021, two days after the Capitol riots.

Donald Trump surrendered to authorities in Georgia at the Fulton County Jail on charges of plotting to overturn the state's 2020 election results in an unprecedented moment resulting in the first-ever mug shot of a former American president.

Trump, 77, spent about 22 minutes inside the jail where he was booked before his release on Thursday.

A massive motorcade and police presence accompanied him to the jail from the Atlanta airport and back.

His surrender in Georgia marks the fourth time this year the former president has turned himself in after criminal charges were brought against him by federal and state officials. But it's the first time he was subjected to a mugshot.

Released on a bail of USD 200,000 bond, Trump told reporters soon thereafter that he did nothing wrong.

Thousands of women and girls were sexually assaulted after peace deal in Ethiopia's Tigray, study shows

NAIROBI, Aug 25 (Agencies): Scores of women and girls in Ethiopia's northern Tigray region were sexually assaulted, often by multiple men alleged to be combatants, after a peace agreement last year ended the conflict there, according to a new study of medical records.

The youngest girl raped was 8 years old. The Tigray conflict killed hundreds of thousands of people and left untold thousands of women and girls with the trauma of sexual assault.

At least 128 sexual assaults occurred after the peace agreement was signed last November, according to the study, which looked at records from the start of the conflict in November 2020 through June.

With most health facilities destroyed or looted as Ethiopian forces battled Tigray fighters, many women and girls were left without treatment for months. Some now have HIV or are raising the children of their rapists. Others live with incontinence or chronic pain, along with the cultural stigma around such attacks.

The study by Physicians for Human

Rights and the Organization for Justice and Accountability in the Horn of Africa, along with a commentary in The Lancet medical journal, looked at more than 300 randomly selected medical records from Tigray health centers focused on helping survivors of sexual violence.

It is just a "small glimpse" of the toll, the authors say, and they fear the chance for justice will be lost if independent accountability efforts by the United Nations and others are shut down.

"All the community is a victim of sexual violence," a Tigray-based researcher into conflict-related sexual violence told The Associated Press. A collaborator on the study, he has spoken with hundreds of women and girls and said not one feels healed

"Rape survivors, they are suffering the most," he said. Like many Tigrayans, he spoke on condition of anonymity for fear of retaliation from Ethiopian authorities.

At least 128 sexual assaults occurred after the peace agreement was signed last November, according to the study, which looked at records from the start of the conflict in November 2020 through this June. Overall, 76% of the 304 women and girls whose cases were reviewed were sexually assaulted by multiple people, often three or more. One was assaulted by 19 men.

In 94% of all cases, no condom was used. Many perpetrators also wielded guns, sticks or knives. Some women and girls were abducted for repeated assaults.

"They took her to their camp and raped her for six months," one medical record cited by the study says.

Almost all the women and girls said their attackers appeared to be members of a military group, often from neighbouring Eritrea, whose soldiers fought alongside Ethiopian forces against Tigray fighters and allegedly remain in parts of western and northern Tigray.

The findings suggest that "these acts were neither isolated nor random but a systematic use of rape as a weapon of war," the study's authors write in The Lancet commentary.

Spokesmen for Ethiopia's and Eritrea's

governments did not respond to requests for comment.

"It is absolutely horrifying and devastating to even read the narratives of the patients,' Ranit Mishori, a senior medical adviser with Physicians for Human Rights, said in an interview. "The brutality didn't skip the children. Many were also raped by multiple perpetrators.

Mishori and her colleague, senior program officer Lindsey Green, expressed concern that independent efforts to understand the conflict's toll and bring accountability to the perpetrators are being weakened or shut down under pressure from authorities.

"Most disturbing to me is the lack of focus on these crimes," Green said.

Ethiopia's government is keen to reengage with key partners such as the United States, the European Union and global financial institutions after the conflict. On Thursday, Ethiopia was announced as an incoming member of the BRICS economic bloc.

But Ethiopia has sharply criticized outside efforts to promote justice and accountability. An African Union human rights inquiry was quietly terminated earlier this year. Now Ethiopia wants a United Nations inquiry ended, too, human rights experts say

After a conflict marked by the blockade of the Tigray region of more than 5 million people, with internet and phone links severed and human rights researchers and journalists barred, the lack of independent inquiry means that the civilian toll could remain largely in the shadows as Ethiopia's aovernment moves on.

"The world has accountability mechanisms, but almost everything is in the hands of diplomats and politicians, which is a recipe for failure," said Martin Witteveen, an international criminal law expert who worked with the government-created Ethiopian Human Rights Commission until early 2022. He says Ethiopia alone can hardly ensure accountability when its forces and allies committed most of the crimes.

Even now, the study says, survivors of sexual violence in Tigray are still coming forward, but others will never be known.

Some gut conditions may signal risk of Parkinson's disease: Study

Analyses indicated four gut conditions associated with higher risk of Parkinson's disease diagnosis, say researchers

NEW DELHI, Aug 25 (Agencies): Certain gastrointestinal problems, such as difficulty swallowing, constipation and irritable bowel syndrome (IBS), may be associated with the risk of developing Parkinson's disease, according to a study.

Parkinson's is a brain disorder that causes unintended or uncontrollable movements. such as shaking, stiffness, and difficulty with balance and coordination.

Previously, some gut problems have been linked to the development of diseases such as stroke or a brain aneurysm, or Alzheimer's disease, the researchers said.

The latest study, published in the journal Gut, used data from a US nationwide medical record network (TriNetX) of 24,624 people who had been diagnosed with Parkinson's disease of unknown cause.

They were compared with people who had been diagnosed with

other neurological conditions-Alzheimer's disease (19,046) or cerebrovascular disease (23,942)----or with none of these (24,624).

People with Parkinson's were matched with those in the other groups for age, sex, race and ethnicity, and length of diagnosis to compare the frequency of gut conditions included in their electronic health record for an average of 6 years before their Parkinson's disease diagnosis.

The team, including researchers from KU Leuven University Hospitals, Belgium and Johns Hopkins University Bloomberg School of Public Health, US, divided all the adults in the network who had been diagnosed with any of 18 gut conditions into separate groupsone for each condition of interest.

People in these groups were matched with those without the particular gut condition and monitored via their medical records for 5 years to see how



many of them developed Parkinson's disease or other neurological disorders.

Both analyses indicated that four gut conditions were associated with a higher risk of a Parkinson's disease diagnosis, the researchers said.

Gastroparesis (delayed stomach emptying), dysphagia (difficulty swallowing), and constipation were associated with over double

the risk of Parkinson's disease in the 5 years preceding the diagnosis, while IBS without diarrhea was associated with a 17 per cent higher risk, they said. However, appendix

removal seemed to be protective, prompting questions about its potential role in the disease processes leading to Parkinson's disease, the researchers said. Neither inflammatory bowel disease nor

vagotomy (removal of all or part of the vagus nerve to treat peptic ulcer) were associated with a heightened risk, they said.

Some other gut issues, including functional dyspepsia (burning sensation or fullness of the stomach with no obvious cause), IBS with diarrhea, and diarrhea plus fecal incontinence, were also more prevalent among people who developed Parkinson's disease.

However, these conditions were also more prevalent before the onset of Alzheimer's disease or cerebrovascular disease, according to the researchers. The team noted that this is an observational study, and as such, can't establish cause. They also highlight several limitations to their findings, including that the monitoring period was relatively short and that the diagnostic information captured in electronic health records might have been incomplete.

NEW DELHI, Aug 25 (Agencies): Despite the government revoking duty on steel exports in November 2022, the average monthly exports have not reached the preduty levels. As per the Numero Analytics data, the average monthly exports since December 2022 (till July 2023) have been 683,000 tonnes as against 1.089 million tonnes averaged in the first five months of 2022.

A 15% export duty was imposed in May 2022 on a range of finished steel products, which accounted for about 95% of India's overall finished steel exports. The duty was in effect realty crisis. exports is not a cause for concern as domestic demand is expected to strengthen from November onwards, feels Anil K Chaudhary, former Chairman of Steel Authority of India Ltd (SAIL) and the chief executive officer of Essar Capital's Metals and Mining Vertical.

"Domestic demand always gives better realization than in the international markets, making domestic demand more lucrative," he said.

"India's focus on infra spending and green energy will raise demand for steel. Exports are gradually picking up after removal of duty on certain products, but are range-bound due to softening global steel prices," said an industry expert, who didn't wish to be quoted.

Chess World Cup: Tie (Heart) breaker

Carlsen's experience reigns supreme as Pragg falls at final hurdle

NEW DELHI, Aug 25 (Agencies): Entering the chess World Cup, Indian prodigy R Praggnanandhaa never imagined he would get to play against world No. 1 Magnus Carlsen.

The only way for the world No. 31 to face Carlsen was if the Indian reached the final. The 18-year-old not only surprised the world but also himself when he became only the second Indian after the great Viswanathan Anand to reach the final of the prestigious tournament.

Beating world No. 2 Hikaru Nakamura and world No. 3 Fabiano Caruana to set up the title clash with Carlsen would have given Praggnanandhaa the belief that he could upset the Norwegian great. After all, it was not an impossible task for Praggnanandhaa, who had beaten Carlsen in an online tournament last year.

Forcing the final into the tiebreak after drawing the two classical games would have boosted Praggnanandhaa's confidence further. Notably, Carlsen, a five-time world champion in the classical format, had struggled with the aftereffects of a bout of



food poisoning in the opening two games. He had played for draws, giving himself more time to recover.

Praggnanandhaa would still have given himself a fair chance in the rapid games, having pulled off tie-break wins in the previous two rounds.

Understandably, Praggnanandhaa went into the first game of the tie-break with an attacking mindset. Playing with the white pieces, the Indian went on the offensive but failed to break Carlsen's defence. As the time pressure increased in the endgame, Carlsen's experience as a four-time rapid and six-time blitz world champion came into play. The Norwegian, realising that Praggnanandhaa was struggling with time, forced the pace to put pressure on the Indian. Praggnanandhaa faltered before resigning after 47 moves

Having lost the opening game, Praggnanandhaa faced an uphill battle. Playing with black, Praggnanandhaa could not trouble Carlsen, who forced exchanges in a better position before the two agreed for a draw after 22 moves.

Having come agonisingly close after finishing third in 2021, Carlsen succeeded in winning the only major trophy evading him.

For Praggnanandhaa, it was double delight as he also qualified for the Candidates tournament, which will be held in Canada next year to determine the challenger to world champion Ding Liren of China. Even though he could not emulate Anand in winning the World Cup title, Praggnanandhaa is only the second Indian after the fivetime world champion to qualify for the Candidates.


Praggnanandhaa is also the third-youngest player after the legendary Bobby Fischer and Carlsen to make it to the Candidates.

"Praggnanandhaa can come back with a candidates spot and a truly wonderful result," Anand posted online. "In the end, it's Magnus! His persistence is rewarded with a victory in the only tournament that eluded him so far."

Meanwhile, USA's Fabiano Caruana beat Azerbaijan's Nijat Abasov in a tie-break to clinch the third place and secure a ticket to the Candidates. However, with Carlsen reluctant to play in the Candidates, Abasov could get the Norwegian's spot.
