#### Two doctors suspended for unauthorised absence from duties in J&K

SRINAGAR, Sep 23 (Agencies): Jammu and Kashmir government has suspended two doctors for "unauthorized absence from their duties."

Dr. Asim Shameem Zaz and Dr. Kawaldeer Kour, both medical officers, had taken leave but failed to return to their duties after the leave period elapsed, officials said.

Dr. Zaz, who had been serving as a Medical Officer, had submitted a leave application to the CMO, Budgam for 89 days to attend a marriage function in Canada. However, after the leave period elapsed, he failed to return to his duties, leading to his termina-

In another case, Dr. Kour, also a Medical Officer, had applied for study leave lasting one year at GMC, Baramulla. She too did not rejoin her duties after the leave period ended, resulting in her termination.

The termination orders were issued by the Health & Medical **Education Depart**ment of the Jammu and Kashmir Government, citing violation of rules and regulations regarding unauthorized absence. The department found that both doctors had left their positions without obtaining prior approval.

As per the department, Dr. Kawaldeep Kour had been given a final opportunity to explain her continued absence but failed to Turn to page 9

## India slams Pakistan for raking up Kashmir at UNGA; calls for vacating occupied areas, action against terrorism

NEW YORK, Sep 23 (Agencies): India has hit out at Pakistan after the country's caretaker Prime Minister Anwaarul Haq Kakar predictably raised the Kashmir bogey in his speech at the United Nations General Assembly.

In its right of reply, the First Secretary at United Nations for the Second Committee of UNGA, Petal Gahlot said that Pakistan should vacate occupied areas of India and stop cross-border terrorism. She asked Pakistan to stop human rights violations against minorities in Pakistan.

Petal Gahlot said, "In order for there to be peace in South Asia, the actions that Pakistan needs to take are threefold first stop cross-border terrorism and shut down its infrastructure of terrorism immediately. Second,



vacate Indian territories under its illegal and forcible occupation. And third stop the grave and persistent human rights violations against the minorities in Pakistan."

Indian diplomat reiterated that union territories of Jammu and Kashmir as well as Ladakh are integral parts of India and Pakistan has no "locus standi" to make statements regarding India's domestic matters.

"We reiterate that the union territories of Jammu and Kashmir and Ladakh are an integral part of India. Matters pertaining to the UTs of Jammu and Kashmir and Ladakh are purely internal to India," Petal Gahlot said.

"Pakistan has no locus standi to comment on our domestic matters. As a country with one of the world's worst human rights records, particularly when it comes to minority and women's rights, pakistan would do well to put its own house in order before venturing to point a finger at the world's largest democracy," she

Indian diplomat slammed Pakistan for making "baseless and malicious propaganda" against India at the United Nations General Assembly.

In her remarks, Gahlot said, "Pakistan has become a habitual offender when it comes to misusing this august forum to





## J&K PCC Chief writes to LG to conduct ULB elections under SEC

**TOP NEWS REPORT** 

JAMMU, Sep 23: JK PCC Chief Shri Vikar Rasool Wani has written to the Lt. Governor Manoj Sinha demanding holding of Municipal Corporations and other ULBs elections under the State Election Commission (SEC) like those of Panchayats, as mandated by 74th amendment of the constitution.

In a letter to the Lt. Governor Manoj Sinha, the President of Jammu and Kashmir Pradesh Congress Committee has taken exceptions to the exercise for the conduct of ULB elections being undertaken without the superintendence and control of the commission (SEC), which is clear violation of the constitutional amendment 74th and is vitiated. Seeking holding of ULB elections, on time, under the SEC like that of rural Panchayats, as per the provisions of the constitution, in terms of 74th amendment read with Article 243ZA and Article 243K, without which the exercise is unconstitutional, since the constitutional provisions have to be implemented and enforced in letter and spirit. Surprisingly the elections to the rural Panchayats are being conducted under the State Election Commission (SEC), while the election exercise to the Urban Local Bodies is being conducted by the Chief Electoral Officer, without any jurisdiction of SEC, which is illegal and against the spirit of the Constitution while questioning the two norms being followed in the same UT, for the same set of the institutions of Panchayat Raj System, one for rural areas and other for the urban areas in J&K, he added.

JKPCC Chief referred to the contributions and struggle of the congress party in bringing 73rd and 74th amendments and their implementation in the J&K like other part of the country which guaranteed 33% representation to the women in all the three tiers of rural Panchayats and ULBs in J&K also, apart from proportional representation to the SCs and STs. Besides this, there is another important component of these amendments which mandated the holding of elections to these basic institutions of democracy under the superintendence and control of an independent State Election Commission (SEC), which though has been duly constituted but having powers and jurisdiction over the Panchayats elections only but not the urban local bodies so far. The congress party raised this issue repeatedly in the recent days but the Govt. is maintaining studied silence in the matter.

Urging the Lt. Governor, to immediately set right the constitutional wrong being committed, The JK Congress has demanded the holding of the elections to the Municipal Corporations and other Urban Local Bodies under the superintendence and control of an independent State Election Commission (SEC), on time, without any delay.

## Is 'trial by media' of sexual predator Russell Brand in Britain justified?

es, there are floods in Libya, earthquakes... trouble all over the world... but the British newspapers are obsessed with stories and reports about a sexual predator called Russell Brand.

And you know what, gentle reader? I think there is a case to be made for their decision to be thus obsessed. Because... because the story is not about this sexual predator -- we have had those before. This Russell Brand has been a TV presenter, stage comedian and has had several national shows on the BBC, Channel 4, with millions of followers on the social media. He has had columns in national newspapers; with reflected fame for being the onetime partner of Jemima Khan....

No, this story is about a notch in the pistol of human rights -- specifically the rights and ability of women victims of sexual abuse to come forward and be represented by the public institutions of Britain who have made it their business to collect evidence against the sexual predator and present it, even before any police investigation takes place.

Let's put this claim (or my ramblings) in context.

The statistics for 2022 show that there were 67,169 cases of rape reported to the police. Of these only 1,276 (2%?) were brought to court. The statistics also

demonstrate that most rape victims and rapists knew each other.

This familiarity goes for all the cases that Russell Brand is accused of. Two national newspapers and Channel 4 have, over the last three years, pursued these allegations by women of rape and "sexual overkill" -- by which I mean being forced to do things they don't want to do even though they are voluntarily in Russell Brand's presence or even in his bed.

I watched a part of the Channel 4 documentary outlining the cases, with the darkened victims speaking about their experiences of being forced into sexual activity with Brand who, in each case, was an elevated member of the programme team while his victims were juniors. For instance, he was the linchpin and presenter of Channel 4's programme Big Brother, which the company Endomol produced. His alleged victim was a junior on the production team.

So also, the victims of Brand's sexual assaults who are now treated as serious complainants by Channel 4 and the newspapers -- though not yet the courts -- all alleging that they were juniors in the programmes and stage and TV productions in which he was the star and were in some way fascinated by him. They say he took undue advantage of that subservient fascination and sexually vio-

lated them in one way or another, forcing himself on them or demanding activity from a presumed height of power which they absolutely didn't want. I won't, gentle reader, describe in graphic detail the stuff the documentary and other reports did.

Yes, it's national news and Russell Brand's current tours, stage shows and TV appearances have been suspended.

Frankly, I've never understood Russell Brand's attraction, to TV commissioners, the viewing public or his social media followers. Though I'm perhaps missing something, he always seemed to me a classic manic idiot with staring, glaring, frightening eyes, an unkempt haircut and beard (do look up the Internet and find his images to ascertain what I'm talking about) who talked the most awful gibberish disguised as philosophical musings or even guidance.

But then, as I read and watch this British obsession unfolding, I wonder whether this is a trial by media. Brand, of course, has hired, alleging libel, very famous right-wing lawyers, known to represent the "global elite" which, as a notorious and pathetic conspiracy theorist his blogs and tweets constantly denounced.

In Britain, one is innocent until proved guilty by a court. It now seems that Brand is guilty until a court proves him innocent. So, is this a trial by media? Or is it justified as an investigation into the "public interest" which is now, laudably, the national cause of female victims of abuse?

Years ago, I had been commissioned to write a TV drama about two British national footballers, Lee Bowyer and Jonathan Woodgate, who had assaulted and hospitalised some Asian students whom they believed had shown them some degree of contempt as meatheads in a Leeds pub. My title for the projected drama was "I Could Murder an Indian", which

is the phrase a certain class of British lads use when they want to eat a curry after ten pints of lager on a Friday evening.

I attended court each day to follow their prosecution, until one day a right-wing newspaper beguiled the father of the Asian victim to give them an interview about the entire assault incident. The paper published it prominently and immediately the defence lawyers pleaded that the evidence in the case had been exposed and would prejudice the jury. The trial was aborted and Bowyer and Woodgate were released. No TV play to write.

Will the publicity around Brand cause the dismissal of any case that the police launch? I doubt it.

The judge will think the prejudice justified.

## KCCI strongly refutes DGFT's contents of notice

SRINAGAR, Sep 23: The President, Kashmir Chamber of Commerce & Industry (KCCI), Javid Ahmad Tenga expressed shock over Director General of Foreign Trade( DGFT) Public Notice 31/2023 dated September 20, 2023 by virtue of which The Kashmir Chamber of Commerce has been de-listed from list of agencies authorized to issue certificates of Origin (Non - preferential).

The above referred Public Notice astonishingly states that a trade Notice No 22/2023 dated August 16, 2023 was given to those agencies enlisted under Appendix 2 E of FTB 2023 who have still not On-Boarded on the e-CoO platform for issuance of Certificate of Origin ( Non-Preferential) to complete their On-Boarding by 31st of August.

The notice further states that 32 agencies( KCCI included) failed to respond to the DGFT or initiate any action for On-Boarding on the e-CoO platform despite follow ups and remind-

The Kashmir Chamber of Commerce strongly of the notice. Wherein it states that it issued notices and reminders to the agencies mentioned in the Delisted Notice. Why such an important organisation resorts to reasons for de-listing is quite baffling. In fact KCCI never received any communication/ notification for on-boarding on DGFT Platform. Notably the first notification, as KCCI has now learnt, had been issued on 19-02-2021 vide

notice no 42/2022-2021

followed by a couple of

other extension notices.

But the 99 year and one

of the oldest Chambers

of India neither received nor had any knowledge about. In fact The KCCI learnt about it only after the delisting notice.

The KCCI is lead to believe that its delisting was pre-determined given the contents of the notice which is all but facts which the Chamber will strongly fight at all levels. It has already raised the matter with DGFT and other authorities. In the meantime, KCCI is facilitating exporters in obtaining Certificate of Origin, any exporter desirous of obtaining Certificate of Origin can visit KCCI for the purpose.

## Lack of doctors, basic facilities, ambulance at PHC Waltangoo irk local populace; Admin silent

KULGAM, Sep 23: The residents of Waltangoo and adjoining villages of Kund area of South Kashmiri's Kulgam district on Saturday complained about inadequate healthcare and lack of basic diagnostic facilities at the Primary Health Centre (PHC) Waltangoo Kund.

The residents said that the health centre was inadequately staffed due to which patient care had been badly hit.

They blamed the concerned authorities for their "insensitive attitude" towards the centre and alleged that the health centre lacks basic infrastructure required for its smooth functioning.

The residents said that only a few paramedics and a few doctors were posted here which was telling upon the smooth functioning of the Primary health centre (PHC) Waltangoo established in 1961

A local resident

Showkat Ahmad said that the PHC centre was of no use because of lack of facilities and dearth of staff which leaves residents to suffer. He also said that a handful of doctors and staff members were not sufficient for over 15 villages of Waltangoo kund. "I am unable to figure out how several paramedics and a doctor are drawing salary from this centre despite managing to attach themselves to different health centers," Showkat alleged. "The authorities are doing

accountable." Residents of Waltangoo alleged that in absence of X-ray and diagnostic testing facilities here, patients prefer to visit the District Hospital Kulgam or Qaaziaund.

"Due to non-availability of a gynecologist, pregnancy care is also hit badly and women of the area face severe hardships," said another local Mohd Yousuf of Waltangoo .

The residents also complained about nonavailability of a dental surgeon and paramedical staff.

The dental surgeon posted here but he was attached in other place, for last many years and his replacement had not been sent.

Primarily, the PHC was allotted with an ambulance but later after a couple of years that also was taken away, another PHC hospital "locals said that the residents are facing immense hardships due to lack of basic facilities in the PHC waltangoo.

"Deputing a sole doctor in the PHC is not enough to tackle the rush of villages. Thus more doctors should be deputed here so that the residents here could heave a sigh of relief,"

another resident said. The residents said that that people in the area are aware that the PHC doesn't have proper facilities and therefore

the patients avoid visiting the PHC.

Residents also said that number of posts is lying vacant in PHC including pharmacist. lab technician, paramedical staff, x-ray technician and others.

They requested Lieutenant Governor J&K Shri Manoj Sinha led district administration to look into the matter and redress their grievances so that people may heave a sigh of relief.

Despite repeated attempts Chief Medical Officer (CMO) Kulgam, Mohammad Rafiq could not be contacted for the comments as he didn't respond to the repeated phone calls of this reporter.

Meanwhile, When Contacted to Additional Deputy Commissioner (ADC) Kulgam Vikar Ahmad Giri, said that "he would take up the issue with the Chief Medical Officer (CMO) Kulgam and the issue will be sorted out as soon as possible", he said.

We have been with them through thick and thin and we will seek their support for the candidate where we feel that our candidate has a fair chance of winning. I am sure the people will support us and as such the strong bond of Kashmiriyat will be there forever.

Sikhs suffered huge economical losses after leaving villages and having to settle down in city, district headquarters and towns for safety in turmoil. Although, Sikhs were entitled to the packages, the other community which has been declared as a minority exploited the situation and got successive packages. It is extremely unfortunate that packages meant for minorities that did not migrate were manipulated and these were changed for the benefit of the favourite minority.

The Delimitation Commission that was set up to ensure that justice is meted out to the various groups and communities lost its relevance after the LG administration of Jammu & Kashmir recommended reservation of two seats for a particular community. # Haven't seen 'The Kashmir Files', 'The Kerala Story': Filmmaker Vishal Bhardwaj

The directed filmmaker says didn't watch these films consciously, wanted to stay out of such sensitive subjects

National award-winning filmmaker Vishal Bhardwaj says he didn't watch movies like "The Kashmir Files" and "The Kerala Story" as he wanted to stay out of such sensitive subjects.

Both "The Kashmir Files" (2022) and "The Kerala Story" (2023) were huge commercial hits but kicked up a political storm with many in the Opposition calling them propaganda films.

"I didn't see 'The Kashmir Files', 'The Kerala Story' and I didn't see them consciously. The kind of things I was hearing about these films, I didn't want to get impacted by it. I was hearing that they are propaganda films from my friends and people I know...

"So, I just wanted to stay out of it because, for me, it is a very sensitive subject. If there's so much negativity I want to remain out of this negativity, I love my peace. So, I didn't want to see them," the filmmaker, who won critical acclaim for depict-



ing the Kashmir conflict in his Shahid Kapoor and abu-starrer "Haider", told agency in an inter-

"The Kashmir Files", starring Anupam Kher, Darshan Kumar, Mithun Chakraborty, and Pallavi Joshi in major roles, revolved around the exodus of Kashmiri Pandits from the Valley in the 1990s. It was directed by Vivek Agnihotri

"The Kerala Story", helmed by Sudipto Sen, depicted how women from Kerala were forced to convert and recruited by the terror group Islamic State (IS).

Bhardwaj urged his fellow filmmakers to deal "sensitively" with stories that are inspired from real-life tragic incidents.

"I want my community of filmmakers to treat such stories sensitively and not use it as propaganda," he added.

Asked whether the objective of filmmaking has changed over the years in Hindi cinema, the

58-year-old writer-director said it is bound to as society is also changing.

"Cinema is such a thing that you can use it the way you want. If people are accepting it and seeing it, then we should accept that people are changing. We are changing as a society," he added.

Citing numerous tragic lynching incidents that have occurred in the country, Bhardwaj said people now don't seem as affected by them as they would earlier.

"Did we ever think that we will

get used to the news of lynching? Earlier, when it happened, we were like, 'How can this mobocracy happen? How can some people gather and kill someone? Where is law enforcement? Where is the law?' "Now, we are used to this. Now, it is like, 'Lynching has happened here or there'. It doesn't affect us because we are accepting it. We are not reacting to it anymore," he said.

## Language of laws and judicial proceedings key to ensuring access to justice: PM Modi

NEW DELHI, Sep 23 (Agencies): Noting that language plays an important role in ensuring access to justice, Prime Minister Narendra Modi on Saturday said laws should be in the language understood by the common man.

"If a doctor talks to the patient in the patient's language, half of his problems are gone even before his treatment begins," the Prime Minister said, inaugurating the Bar Council of India's two-day International Lawyers Conference on 'Emerging Challenges in Justice Delivery System' here. "There are two ways in which laws can be presented -- one, in the language you're used to; and second, the language which is understood by the common man of the country...The common man should feel that the law is his own. We are trying to find a solution to that. The language in which laws are written and the language in which judicial proceedings are conducted... it plays a huge role in ensuring access to justice." Modi said.

"I congratulate CJI DY Chandrachud for making available operative parts of judgments in litigants' languages...It took us 75 years for this small task," he said, terming it a big change in

the justice delivery. Talking about the problems faced by the international community, the PM said various countries should come together to find solutions. "We're fighting against many forces that don't care for borders and jurisdictions. Whether it's cyber terrorism, money-laundering, artificial intelligence or its misuse, we need a global framework to deal with these issues...When the dangers are global, the solutions also should be global,"

"It's not one government which can tackle them. Legal systems of different countries need to work together...Just like we work together for air traffic control we must also have global

Modi said.

frameworks in different areas," the PM said.

Organised in association with the Bar Council of England and Wales, the Law Society of England and Wales, and the Commonwealth Lawyers Association, the two-day conference will end on September 24.

## PM to flag off 9 Vande Bharat **Express trains on Sunday**



NEW DELHI, Sep 23 (Agencies): Prime Minister Narendra Modi will on Sunday flag off nine Vande Bharat trains connecting religious and tourist destinations across 11 states.

The nine trains will provide faster connectivity across 11 states -- Rajasthan, Tamil Nadu, Telangana, Andhra Pradesh, Karnataka, Bihar, West Bengal, Kerala, Odisha, Jharkhand and Gujarat.

The PM will flag off the trains through video conferencing.

The new Vande Bharat trains will run between: Udaipur - Jaipur; Tirunelveli-Madurai-Chennai; Hyderabad -Bengaluru; Vijayawada - Chennai (via Renigunta); Patna – Howrah; Kasaragod - Thiruvananthapuram; Rourkela - Bhubaneswar - Puri; Ranchi – Howrah; and Jamnagar-Ahmedabad. These trains are a step

towards realising Prime Minister's vision of improving connectivity across the country and providing world class facilities to rail passengers, an official state-

ment said. "The Vande Bharat trains will be the fastest train along the routes of their operation and will help save considerable time of the passengers," it said.

As compared to the current fastest train along the route, Rourkela- Bhubaneswar – Puri and Kasaragod - Thiruvananthapuram, the Vande Bharat trains will cut travel time between respective destinations by about three hours; Hyderabad – Bengaluru by more than 2.5 hours: Tirunelveli-Madurai-Chennai by more than 2 hours.

The travel time between Ranchi -Howrah and Patna -Howrah and JamnagarAhmedabad will be reduced by about one hour when compared with the fastest trains currently available between these destina-

The travel time between Udaipur -Jaipur will be reduced by about half an hour.

The Rourkela- Bhubaneswar - Puri and Tirunelveli-Madurai-Chennai trains will connect important religious towns of Puri and Madu-

Also, the Vijayawada – Chennai Vande Bharat Express will operate via the Renigunta route and will provide connectivity to Tirupati pilgrimage centre.

The introduction of these Vande Bharat trains will herald a new standard of rail service in the country, the statement said.

These trains, equipped with world class amenities and advanced safety features, including Kavach technology, will be a key step towards providing modern, speedy and comfortable means of travel to common people, professionals, businessmen, student community and tourists, it added.

She was assassinated there on 31 October 1984, by two of her bodyguards, while going towards the neighbouring 1, Akbar Road Congress office for an interview.


## Gujarat govt announces relief package for farmers in districts affected by Narmada river flooding

Several areas in Gujarat were inundated due to heavy rains in the upper reaches of Narmada and the release of a massive amount of water from the Sardar Sarovar dam last week.

AHMEDABAD, Sep 23 (Agencies): The Gujarat government Saturday announced a special relief package for farmers hit by an overflowing Narmada river in Bharuch, Narmada and Vadodara districts between September 16 and September 18.

Based on a report on the estimated damages caused to standing crops in the three districts due to flooding caused by the river, the government has decided to provide a special relief package from the state budget in addition to the State Disaster Response Fund (SDRF) to help farmers against their losses, it said.

The government said that the benefit of the package will be given to farmers who have incurred 33 per cent or more loss of agricultural and horticultural crops for the kharif season



For non-irrigated agricultural crops, affected farmers will get a relief package of Rs 8,500 per hectare as per the SDRF norms.

For irrigated agriculture and rainfed horticulture crops, they will get Rs 8,000 in addition to Rs 17,000 per hectare as per SDRF norms, it

For perennial crops, the assistance will be Rs 15,000 per hectare in addition to Rs 22,500 paid as per the SDRF

Similarly, for 33 per cent or more of perennial horticultural crops uprooted or fallen per hectare, the farmers will be eligible for an assistance of Rs 1,02,500 in addition to Rs 22,500 paid as per SDRF norms, it said.

Those affected farmers who want to avail of the assistance package have to apply online on the 'Digital Gujarat Portal' by October 31, 2023, the government

Assistance under this special relief package and other ancillary

payments will be made through direct benefit transfer (DBT) into the bank account of the beneficiaries, it said

## A K Antony's wife's video justifying son's BJP entry goes viral

THIRUVANAN-THAPURAM, Sep 23 (Agencies): A purported video in which veteran Congress leader A K Antony's wife Elizabeth is seen justifying their elder son's recent entry into the BJP has gone viral on social media platforms, putting the Congress party in a fix in Kerala.

In the video, released on the YouTube channel of a Christian meditation centre, an emotional Elizabeth could be seen admitting that she knew about the invitation Anil Antony received from the saffron party much

Claiming that her son got the new opportunity in politics because of the intercessory prayers, she said it had also helped resolve the issues that cropped up in the family due to his unexpected entry into the BJP.

She said though both her sons wanted to join politics, the resolution passed by the Congress party in its recent Chintan Shivir against dynasty politics was a setback.



She said she prayed intensely for the good future of her son and then she received a call from Anil.

"My son turned 39... He called me and said he got a call from the Prime Minister's Office, and they asked him to join the BJP," Antony's wife said in the video.

She said she and her family lived and believed in the Congress Party, but her son told her that he would get good opportunities if he joins the BJP.

She said though she had contempt for the BJP, it was later changed through prayers, and she didn't reveal Anil's decision to join the BJP to anyone in the family.

However, Elizabeth admitted that Anil's BJP entry became a shock to A K Antony when he came to know about it through TV channels four days later.

She said Antony admitted his son's decision later and asked him to come home whenever he wanted, on the condition that politics should not be discussed in the house.

In the video, she was also seen saying that Antony became

a member in the Congress Working Committee (CWC) due to her prayers.

Various news channels telecast Elizabeth's video, which went viral on social media platforms as well.

The Congress leadership, A K Antony or Anil Antony were yet to react to the matter.

Anil Antony, son of former Defence Minister A K Antony, had joined the BJP in April this year.

After joining the saffron party, he slammed a section of the Congress leadership for "serving the interests of a single family" instead of working for the country.

Anil, who headed the Kerala Congress' digital media cell before quitting the party earlier this year, was welcomed into the BJP by Union ministers Piyush Goyal and V Muraleedharan, as the ruling party seeks to increase its foothold in the southern state.

A K Antony, a close confidant of former Congress president Sonia Gandhi, had termed his son's action "wrong" and "very painful" for him.

## Taiwan factory fire leaves at least five dead, more than 100 injured

The fire began on Friday night at the factory in Pingtung County and raged overnight. Three firefighters were among the dead, authorities said.

TAIPEI, Sep 23 (Agencies): A fire and subsequent explosions at a golf ball factory in southern Taiwan killed at least five people and injured more than 100 others, and five people are still missing.

Rescuers were still looking for four factory workers and one firefighter who remained unaccounted for, officials said. More than 100 people were taken to the hospital with injuries.

Taiwanese news outlet Focus

Tsai said the Pingtung County government had set up an emergency operation centre to offer assistance to those impacted by the fire.

Chou Chun-mi, magistrate of Pingtung County, said in a Facebook post that the cause of the fire was still under investigation.

"Facing the grief of the family members, I could not say anything except to bow deeply, apologize, and express my deepest condolences," she said in the post, after visiting the funeral home and meeting with victims' families.

Authorities said that natural gas may have contributed to the explosions, which occurred as firefighters were attempting to put out the fire.

## Taiwan flags concerns over China's drills, says situation 'getting out of hand'

Taiwan expressed concerns about China's rising military drills around the island and said the situation was "getting out of hand". China claims democratically governed Taiwan as its territory.

TAIPEI, Sep 23 (Agencies): The increased frequency of China's military activities around Taiwan recently has raised the risk of events "getting out of hand" and sparking an accidental clash, the island's defence minister said on Saturday.

Taiwan has said the past two weeks has seen dozens of fighters, drones, bombers and other aircraft, as well as warships and the Chinese carrier, the Shandong, operating nearby.

China, which views democratically governed Taiwan as its own territory, has in recent years carried out many such drills around the island, seeking to assert its sovereignty claims and pressure Taipei.

Asked by reporters on the sidelines of Parliament whether there was a risk of an accidental incident sparking a broader conflict given the frequency of the Chinese activities, Taiwan Defence Minister Chiu Kuocheng said, "This is something we are very worried about.'

Warships from China's southern and eastern theatre commands have been operating together off Taiwan's east coast, he added.

"The risks of activities involving aircraft, ships, and weapons will increase, and both sides must pay attention," Chiu said.

China has not commented about the drills around Taiwan, and its defence ministry has not responded to requests for comment.

Chiu said that when the Shandong was out at sea, which Taiwan first reported on September 11, it was operating as the "opposing force" in the drills. Ministry spokesman Sun Li-fang added that China's Eastern Theatre Command forces were the "attacking force", simulating a battle scenario.

Taiwan's traditional military planning for a potential conflict has been to use its mountainous east coast, especially the



two major airbases there, as a place to regroup and preserve its forces, given it does not directly face China, unlike the island's west coast.

But China has increasingly been flexing its muscles off Taiwan's east coast, and generally displaying its ability to operate much further away from China's own coastline.

China normally performs large-scale exercises from July to September, Taiwan's defence ministry has said.

On Saturday, the ministry said China had largely dialled back its drills, reporting that it had only spotted two Chinese aircraft operating in its air defence zone over the previous 24 hour

Taiwan has frequently said that it would remain calm and not escalate the situation, but that it won't allow "repeated provocations" from China, whose forces have so far not entered Taiwan's territorial seas or airspace.

## China an existential threat to US: Nikki Haley



WASHINGTON, Sep 23 (Agencies): Describing China as an "existential threat" to the US and the world, Indian-American Republican presidential aspirant Nikki Haley has claimed Beijing is "preparing for war".

China has spent half a century plotting to defeat America and some respects, the Chinese military is already at par with the US armed forces, Haley said in a major policy speech on the economy in the key early primary State of New Hampshire.

Her speech comes two days after her India-American Republican rival Vivek Ramaswamy delivered a foreign policy speech on China in Ohio. Both Haley and Ramaswamy have emerged as popular GOP candidates after former US president Donald Trump.

"Strength and pride are essential to our national survival, especially in the face of Communist China. China is an existential threat. It has spent half a century plotting to defeat us," Haley said.

She alleged that China has taken America's manufacturing jobs.

"It's taken our trade secrets. Now it's taking control of critical industries, from medicines to advanced technology. In record time, China has gone from an economically backward country to the second biggest economy on earth," she said.

"It has every intention of being the first. And the Communist Party's motives are clear. They're building a massive, cuttingedge military, capable of threatening America and dominating Asia and beyond," the former two-term South Carolina governor said.

"In some respects, China's military is already equal to the US armed forces. In other areas, they're beating us. China's leaders are so confident, they're sending spy balloons into our skies and building a spy base just off our shores in Cuba.

"Make no mistake: The Communist Party is preparing for war. And China's leaders intend to win," she claimed.

Sharing her economic plan, Haley said it includes giving real relief and financial freedom to middle-class Americans. Every middle-class family will get thousands of dollars in tax relief, she said.

"No one knows how to use your money better than you, no one. When you make your own choices, you make our economy even stronger," she said.

"For starters, we'll completely eliminate the federal gas and diesel tax. That is 18 cents per gallon in savings on gas and 24 cents on diesel. That will help families struggling with record-high

gas prices.

"And we don't need a federal gas tax to fund our roads. We'll keep building our roads with the trillions Washington still has and we'll stop diverting money to green giveaways. Road money should build roads, not bike paths and hiking trails, she added.

If elected president of the country, Haley said, she would also cut income taxes for working families.

She said her administration would also eliminate President Joe Biden's USD 500 billion in green energy subsidies. "No more cash windfalls for China." she said.

The former US ambassador to the UN said she would veto any spending bill that doesn't take the US back to pre-Covid spending levels.

"We're not talking about 1950s spending levels, we're talking about just four years ago. We had a massive - and in many ways a foolish - explosion in spending during the pandemic. But the pandemic is over. It's absurd to keep spending at those same crazy levels," she said.

"Under my plan, we won't just have term limits for politicians, we will limit bureaucrats too. No bureaucrat should hold the same position for more than five years.

"This will make them better public servants and avoid the politics and power fiefdoms that corrupt our government. And we should be able to fire those who are not performing. Public service is a privilege, not a right. And no one has a right to roll back your freedom," Haley said.

# show support for Karabakh

YEREVAN, Sep 23 (Agencies): A US congressional delegation was meeting Armenia's leaders on Saturday to express support in the wake of protests rocking the small Caucasus nation after Azerbaijan reclaimed control over disputed Nagorno-Karabakh.

The US embassy said the group will meet Prime Minister Nikol Pashinyan and a handful of other officials "to discuss US-Armenian relations and the impact of Azerbaijan's recent military actions on the Armenian population of Nagorno-Karabakh".

The United States has

a large Armenian community that fervently supports Yerevan in its decades-long standoff with Baku over the ethnically Armenian enclave.

The visit comes as Pashinyan tries to survive the latest wave of protests against his tumultuous rule.

Pashinyan led Armenia when Azerbaijan first seized back large swathes of Nagorno-Karabakh in a six-week war three years ago.

That defeat sparked violent demonstrations in Yerevan that saw protesters ransack Pashinvan's office.

Armenia's parliament plans to launch impeachment hearings against Pashinyan over this week's military triumph by its arch-rival when it returns to session next month.

The US delegation is led by Senator Gary

The Democrat from Michigan this month accused Azerbaijan of launching "unprovoked" attacks against its neighbour.

President Ilham Aliyev's "regime is perpetrating a humanitarian disaster in Nagorno-Karabakh," he said on social media Friday.

## US delegation in Armenia to If US Has To Pick India Or Canada, It Will **Choose...: Ex Pentagon Official**

WASHINGTON. Sep 23 (Agencies): Stating that Justin Trudeau's allegations have led to "greater danger" for Canada than India, former Pentagon official Michael Rubin said that if the United States has to choose between Ottawa and New Delhi, it will surely choose the latter as the relationship is "too important".

He said that India is far more important strategically than Canada is and Ottawa picking up a fight with India is like "an ant picking up a fight against an elephant".

While referring to the poor approval ratings of Justin Trudeau, Mr Rubin added that he is not long for the premiership, and the US can rebuild the relationship after he is gone.

"Prime Minister Trudeau I think has made a huge mistake. He has made allegations in a manner which he hasn't been able to back. Either he was shooting from the hip and he doesn't have the evidence to support the accusations he made against the government. There is something there, in which case he needs to explain why this government was sheltering a terrorist," the former Pentagon official said.

Hardeep Singh Nijjar, a designated terrorist in India, was gunned down outside a Gurdwara, in a parking area in Canada's Surrey, British Columbia on June 18.

"I suspect that the United States doesn't want to be painted a corner to choose between two friends. But if we have to choose between two friends, increasingly we're going to choose India on this matter, simply because Nijjar was a ter-



rorist, and India is too important. Our relationship is too important," Michael Rubin said while speaking to news agency.

"Justin Trudeau probably isn't long for the Canadian premiership, and then we can rebuild the relationship after he's gone," he added.

Michael Rubin who is also a fellow at the American Enterprise Institute, where he specializes in Iran, Turkey, and South Asia, said: "As a former consumer of intelligence, I can say that oftentimes the intelligence we see whether it's a telephone intercept or something else, isn't as black and white, isn't as cut and dry. I mean, certainly, that was the case with regard to the Iraq War.'

He further added: "So when you have a situation like this, perhaps Prime Minister Trudeau raised the issue, but there wasn't necessarily consensus on what he meant. And regardless, let's not fool ourselves, Nijjar was not simply a plumber, any more than Osama bin Laden was a construction engineer. He had blood on his hands from multiple attacks.'

Responding to the possibility of whether the US will publicly

intervene in the matter, Mr Rubin said, "Frankly, there's a much greater danger for Canada than India. If Canada wants to pick a fight, frankly, at this point, it's like an ant picking a fight against an elephant and the fact that matter is India is the world's largest democracy. It's far more important strategically, arguably than Canada is, especially as concern grows with regard to China and other matters in the Indian Ocean basin, and in the Pacific." The India-Canada ties soured

further after Canadian PM Justin Trudeau alleged India's role behind the killing of Khalistani terrorist Hardeep Singh Nijjar. This was followed by both countries expelling a senior diplomat in a tit-for-tat move.

However, India has out-rightly denied such allegations calling them 'absurd' and 'motivated'.

Notably, the Canadian PM has failed to present any evidence to back his claims. Trudeau was repeatedly quizzed on the nature of the allegations but stuck to reiterating that there were "credible reasons" to believe that India was linked to the death of Nijjar.

The former Pentagon official further slammed Trudeau and

said that Hardeep Singh Nijjar - A khalistani terrorist allegedly killed by his erstwhile comrades - is not a model to use for "human rights" and he was a terrorist involved in multiple

"Justin Trudeau might want to make this a case of human rights. The fact of that matter is, that Nijjar isn't a model one wants to use for human rights. Nijjar may have been involved in the assassination of a rival Sikh leader, just a year ago. At the same time, he has blood on his hands through multiple attacks. He entered Canada with a fraudulent passport. And the fact of the matter is this is no Mother Teresa, we are talking about."

Mr Rubin added that many of the US security community and even from Canadian security understand that Trudeau has gone "too far".

On being asked if Trudeau converted a domestic political obstacle into a foreign policy issue, the former Pentagon official said that Trudeau was very "short-sighted" and was acting only as a "politician".

"Yes, I absolutely do think that that is the case. Justin Trudeau was playing domestic Canadian politics because as he struggles in his re-election campaign, many Sikh activists are in crucial swing districts. But again, this isn't something unique to Canada...I think Justin Trudeau was acting as a politician. He was very short-sighted, and no one should trade their shortterm political convenience for the long-term relationship with the world's largest democracy," he added.

The court questioned Bharat Patel's claim that he had received prior information about the alleged plan by the accused, as it was not noted down in the station diary, as per the laid judicial precedents.

The Ahmedabad court also pointed out procedural lapses, such as not recording a panch witness and not bringing any other witnesses on board for the trial when arresting Zabiuddin, who was in judicial custody in New Delhi at the time in relation to another offense.

The Ahmedabad court examined 30 prosecution witnesses, including the then ACP of Ahmedabad city police, GL Singhal, who had also investigated the case following the lodging of the FIR.

The DCB had filed two charge sheets, one in 2013 and another in 2021. There were 23 accused in the case, and the allegations against the accused included affiliation with the banned Students Islamic Movement of India (SIMI) and LeT, with plans to wreak havoc and "kill national dignitaries in Gujarat."

Two accused were acquitted by a sessions court in March 2021, while another was acquitted in April 2022.

The FIR filed at the DCB police station cites information received through "intelligence sourcing," as recorded in the court order, stating that "Muslim youths from Kashmir and other states were involved in terror activities, and their contacts and allies were active in Ahmedabad and elsewhere in Gujarat. Two LeT youth operatives named Imran Kashmiri and Bashir Kashmiri were sent to Kashmir, Pakistan, and Bangladesh to prepare Muslim youths in terror activities. They were making rounds in Ahmedabad to establish a network of a

terror organization."

According to the FIR, it was also alleged that Ilvas Memon, a resident of Shah Alam area in Ahmedabad, was in touch with Imran Kashmiri and was receiving terror training in Kashmir and Bangladesh.

# Gamechanger: Sodium ion batteries may make EVs far more affordable, says report

NEW DELHI, Sep 23 (Agencies): Sodium-ion batteries are slowly finding their way into the Electric Vehicle (EV) market as lithium-ion batteries have turned out to be too costly for lower-priced EVs due to the difficulty in mining the metal.

With an energy density profile similar to that of lithium iron phosphate or LFP batteries, several companies have started looking at this emerging technology as a cost effective and eco-friendly way of meeting the electrification needs of India.

This could add to the momentum that the Indian auto market has already seen in terms of electrification. India seeing a proliferation of EV models launched by both major automakers as well as start-ups and new entrants.

However, while government subsidies have helped make EVs successful in the scooter segment, in other segments, the high cost of batteries — which account for around 40% of the cost of an electric car — have proven to be a drag in other segments.

Limitations of lithium batteries Currently, automakers prefer lithium EV batteries due to their high energy density — basically, more stored-up power per kilogram. However, its adverse effect on the environment has always been a limitation.

Other than these two factors, lithium batteries can also be somewhat volatile.

There are two chemistries in lithium-ion batteries - Nickel Manganese Cobalt (NMC) and Lithium Iron Phosphate (LFP) - based on the other materials used in the battery.

"NMC has higher energy density but is more volatile and hence, unsafe. A needle test



is used to check battery safety. In this test, a long needle is inserted into the battery, shorting it. This simulates an electric vehicle or EV getting into an accident," said the analysts from Incred Equities.

"When this test is performed on NMC batteries, they explode. When the same test is applied to LFP batteries, they discharge a noxious gas but don't explode," it added.

Also, although the impacts of extracting lithium are considerably lower than for oil and gas, mining lithium does have environmental costs.

Another limitation with the increased need for lithium-ion batteries is the fact that the demand is outstripping supply.

"In 2020, 37% of lithium demand was from EV batteries. It is estimated that by FY2030, 80% of lithium demand will be from EV batteries," said the analysts.

"Global supply of mined lithium will be inadequate to service demand just from batteries alone. In the absence of mined lithium, lithium-ion batteries would witness an increase in prices. This would make lowend EVs unaffordable for customers and end up stifling the electrification of the transpor-

tation sector. Thus, adequate sodium-ion battery production is effectively a prerequisite for the EV boom to continue," it added.

Battery of the future?
The solution to this shortage could be identifying cheap and abundant chemicals that could serve as replacements for lithium in rechargeable batteries.

Two possible elements that fit the bill are sodium and potassium. Yet significant challenges remain for these alternatives.

Moreover, sodium-ion batteries address the concerns of geopolitical and supply-chain issues that are associated with Lithium-ion batteries.

On the downside, sodium-ion batteries can't provide the type of range for electric vehicles offered by lithium-ion batteries, but they do present some unique advantages.

In a sodium-ion battery, lithium ions are replaced with sodium ions in the battery's cathode, and lithium salts swapped for sodium salts in the electrolyte.

Sodium-ion batteries are finding their niche in smaller, lowrange EVs and stationary applications such as home energy storage systems. With their lower energy density, sodiumion batteries are better suited for vehicles that don't require a long driving range, such as city cars or mini vehicles.

"Na-ion EVs [Sodium-ion] would be cheaper and have a shorter range than their LFP counterparts. This makes them more suitable for the lower end of the EV market, which would have more EVs for fleet applications," noted the report.

Also, these batteries offer a major advantage in cold temperature storage, since they perform really well even at such low temperatures as -10°C or -20°C.

"Adequate sodium-ion battery production is effectively a prerequisite for the EV boom to continue," noted the report.

Sodium-ion batteries promise to be a viable alternative to lithium-ion batteries in a big way. Despite having made significant progress, sodium-ion batteries are yet to be easily available commercially.

Despite a lot of excitement in the media about sodium-ion batteries as a game-changer, there are certain vital drawbacks that should be considered.

In sodium-ion batteries, the energy densities are in the range of 100 wh/kg to 160 wh/kg and match the Lithium Iron Phosphate (LFP) performance at present.

The technology, however, is less mature compared to lithium-based technologies, and is undergoing heavy development. However, it promises to provide a cost-effective solution to the electrification needs of a massive market as such as

# Laptop, PC import licencing may go

Govt hints at 1-yr grace period, cos may need to register on a portal to import these items



NEW DELHI, Sep 23 (Agencies): The government may scrap its directive asking for a mandatory licence to import laptops, all-inone personal computers, and tablets. According to industry sources, during a meeting with industry stakeholders, the government said companies will only need to register on a portal to import these items. The government has also hinted at providing a one-year grace period for importing these items.

Industry players have been informed that the "import management system" portal, which will be managed by Directorate General of Foreign Trade (DGFT), will go live by the end of this month. "We raised concerns about the sudden import ban on these items. However, the government indicated that it may extend the deadline by another year. Now, we don't need to seek any licences but only need to register. During this period, companies can import as much quantity as they want," said a source.

On August 4, the government suddenly announced the ban on laptops, all-in-one personal computers, and tablets. Later in the day, it clarified that there was no ban, but electronic manufacturing companies needed a licence to import these items starting from November 1, 2023. Subsequently, the Minister of State, Rajeev Chandrasekhar, clarified that it was not licencing but an import management system, with the purpose of ensuring that equipment, servers, and laptops entering the digital India ecosystem

# Mahindra's Canada-based associate firm Resson Aerospace shuts down

NEW DELHI, Sep 23 (Agencies): Mahindra & Mahindra (M&M) recently said its associate company, Resson Aerospace Corporation, based in Canada, has officially ceased operations.

M&M held an 11.18 per cent stake in Resson, which had initiated voluntary winding-up procedures.

"With reference to the captioned subject, we would like to inform you that Resson Aerospace Corporation, Canada, which is an Associate of the Company ('Resson') wherein the Company

holds 11.18 per cent stake (on a fully diluted basis) through Class C preferred Shares, had filed for a voluntary winding-up," M&M said in a regulatory filing.

"Resson has received a Certificate of Dissolution from Corporations Canada dated September 20, 2023, which was informed to the company," it added.

As a result, Resson has ceased to exist and is no longer considered an associate of M&M, effective September 20, 2023

Furthermore, M&M stated, "Upon the liqui-



dation of Resson, the company is entitled to receive approximately 4.7 million Canadian Dollars (equivalent to Rs 28.7 crore) as a distribution of proceeds towards Class C Preferred Shares held by the company."

While M&M had stated in its exchange filing that its associate firm Resson Aerospace had filed for voluntary winding-up, the development comes at a time when diplomatic relations have soured between India and Canada.

LONDON, Sep 23 (Agencies): An eight-year-old Indian-origin girl was on Friday declared the first person in the UK's National Health Service (NHS) history to have a transplant without the need for lifelong drugs after medics reprogrammed her immune system.

Aditi Shankar, suffering from a rare genetic condition, received a stem cell transplant using bone marrow taken from her mother, Divya, who also donated her kidney.

The pioneering treatment at Great Ormond Street Hospital (GOSH) in London means that Aditi's new kidney works without the continued

need of immunosuppressant drugs to stop her body from rejecting it. "This is the first time

I have cared for someone in 25 years who has not required immunosuppression after kidney transplantation," said Professor Stephen Marks, Clinical Lead for Renal Transplantation at GOSH and Professor of Paediatric Nephrology and Transplantation at University College London Great Ormond Street Institute of Child

"We hope that our research will provide the option for more children, like Aditi, for whom kidney transplant was not previously an option, to have the opportunity to have a life-changing kidney transplant," he said.

According to the medics, this became possible because Aditi had an immune condition for which she received her mother's bone marrow six months before receiving a kidney transplant for severe irreversible kidney failure.

This reprogrammed her immune system to be the same as her donor kidney, so her transplanted organ would not attack Aditi's body.

"The past three years Aditi's energy had been lost to dialysis. After her kidney transplant,



almost instantly, we saw a big change in her energy levels. We take our organs for granted, but we all have such a

gift in us," said Uday Shankar, Aditi's father.

"The past three years she has been restricted with a Hickman line [a tube which delivers treatments and takes blood samples directly from a vein] and all she wanted to do was for her line to go away so she could go and splash in the water. She is now starting swimming lessons," he shared.

Usually, organ transplant recipients are on immunosuppressant medications for the life of their kidney transplant. Using the same donor for the bone marrow and kidney transplant means that the immune system is reprogrammed so that it becomes a match for the new kidney – reducing the problems associated with rejection as much as possible.

As the first in the UK,

it is hoped that Aditi's treatment success will lead to further investigations into how a bone marrow transplant followed by a kidney transplant from the same living donor could be used to treat more seriously ill children and adults with kidney failure and other conditions.

However, the experts said that this will only be for seriously ill patients who have no other alternative, as the risks associated with a double transplant are greater than that of a regular kidney transplant.

"The teams had to use all their expertise and some out-of-thebox thinking to sort the scientific, ethical and practical challenges that the case presented. We are absolutely delighted to see how well she is doing and are incredibly proud to share this success with Aditi and her family.

We are already working to see how this breakthrough can underpin further research to help more families," said Dr Giovanna Lucchini, the bone marrow transplant consultant, and Dr Austen Worth, immunology consultant.

Australia (111) remain third in the ODI list despite dropping two points.

India and Australia play the second of the three ODIs on Sunday.

left off, racing through the first game with a 11-3 win over Nabita. Mukherjee continued her onslaught and downed her opponent 11-7 in the second match. She went on to beat Nabita 11-2 to give India a 2-0 lead in the contest.

Sutirtha Mukherjee then took on Evana Thapa Magar in the third round with a dominant 11-1 win in the first game. She then went on to down Magar 11-5 to win the second game with ease.

Sutirtha wrapped up the match

with a comfortable 11-2 win to

send India into the next round with a 3-0 win.

The game on Friday had enough positives for India, mainly the performance of Mohammad Shami and Suryakumar Yadav, but a few questions still need to be answered ahead of the World Cup, beginning October 5.

India's designated number 4 lyer, whose fitness came under the scanner in the Asia Cup even though he was coming back from a long injury-lay off, has not been able to get time in the middle due to different reasons.

While a back spasm ruled him out of the business end of Asia Cup,



an avoidable run-out on Friday ended his nervy 8-ball stay in the centre. The right-hander will

be hoping for a bagful of runs in the coming two games which would make him and his team feel much better going into the global event.

Ashwin, on the other

hand, came up with a tidy bowling effort in his comeback game but was not able to put the Australian batters in much discomfort on a flat track. He was not able to generate much turn and his flatter deliveries were easily negotiated by the opposition.

The champion spinner could still make a last-minute entry into India's World Cup if Axar Patel doesn't get fit in time but the team management expects more from the 37-year-old than what he managed on Friday. It also remains to be seen if another off-spin-

ner Washington Sundar gets a game. If that happens on Sunday, Ashwin might have to warm the bench.

Shardul Thakur too would be looking for an improvement from the first game, having conceded 78 runs in 10 overs while all the other bowlers returned frugal figures.

He does have a knack of picking wickets and coming up with a useful cameo with the bat but he has not been able to do that consistently in the ODI format.

Thakur will only be

used sporadically in the World Cup and, therefore, he would be keen to make the most of the chances he gets in the ongoing series.

In the batting depart-

In the batting department, world's best T20 batter Suryakumar Yadav seems to have cracked the ODI code after a prolonged lean

patch.
The management

has told him to consume 45-50 balls every game, which is enough for someone like him to make a telling impact on the match. He just did that on Friday with a well-paced half-century. Like India, Australia, too, were missing some of their key players in the

too, were missing some of their key players in the opener, including Mitchell Starc, Glenn Maxwell and Josh Hazlewood. Skipper Pat Cummins hinted after the game in Mohali that they might only be ready by the third game in Rajkot on September 27.

Australia won the series in India earlier this year and find themselves in a must-win situation on Sunday. Josh Inglis showed promise with a run-a-ball 45 but the middle-order needs to be more consistent.

Veteran opener David Warner has carried his

good form from South Africa to India and would be looking to maintain it over the next couple of months.

Steve Smith and Marnus Labuschagne were guilty of throwing their starts in Mohali and a big hundred will be needed from either of them if Australia are to come back in the series.

The last ODI was played here in January when India amassed 385 against New Zealand with Rohit and Shubman Gill smashing hundreds.

Rohit will not be around but trust Gill to do an encore in front of a vibrant Indore crowd.

"He hit the perfect length and that's where he got the batsmen caught at the crease. So not too short or not too full. Just the perfect length where you get a little bit of movement. You're going to hit the stumps still, but the batsmen can't get a four. Shami was always threatening with that half-volley length. It's a

fine margin, but on this type of track, you need to be spot on," Waugh told JioCinema.

Meanwhile, former India cricketer Abhishek Nayar spoke about the decision that the Indian think-tank has to make regarding the playing XI and whether it'll be possible to accommodate both Shami and Mohammed Siraj together.

"It's going to be an interesting matchup between the two. There's going to be this thought process of picking wickets. You got to know the importance of picking wickets in today's game because India managed to bowl out a strong Australian batting line-up where you've got a Sean Abbott batting at No 10.

"So, it just tells you that when you have bowlers capable of picking up wickets, there may very well be a toss-up between a Shardul Thakur where you are thinking whether or not you are thinking of going with that all-rounder's slot or going with an out-and-out bowler who can pick you wickets in every phase of the game," he said.

#### No India Visa, No Dubai Trip. Hiccups For Pakistan Ahead Of World Cup: Report

KARACHI, Sep 23 (Agencies): The Pakistan cricket team's plans to travel to Dubai before arriving in Hyderabad for the ODI World Cup in India have been cancelled over visa issues. As per a report, Babar Azam and his men had planned to travel to Dubai for a pre-World Cup team bonding trip but it couldn't be materialised. The plan had to be cancelled as the Pakistan team is still waiting to get visas for their travel to India. Of the 9 teams that are participating in the tournament, alongside India, the Pakistan team is reportedly the only

one to have not received their visa yet. Pakistan were supposed to fly to the UAE next week and stay there for a couple of days before heading to Hyderabad for their first warm-up game against New Zealand on September 29.

But now those plans have been ruled out as the Pakistan team will head to Karachi and fly to Hyderabad next week, as per a report in ESPNCricinfo. Pakistan will be travelling to India for the first time since 2012-13.

It also has to be noted that neither team has travelled to the other's country for a bilateral series since 2012-13 when Pakistan had come to India for a white-ball series. In fact, only two players from the current Pakistan squad have travelled to India before for cricketing assignments.

Pakistan will open their World Cup campaign against The Netherlands on October 6 at the Rajiv Gandhi International Stadium in Hyderabad.

Pakistan named a 15-player squad for the World Cup with Babar Azam leading the squad. But they will be missing the presence of their star pacer Naseem Shah who picked up niggle injury during their Super Four clash against India at the Asia Cup. He was off the field during the middle of his over and later ruled out of the competition.

Hasan Ali has been named in the squad as Naseem's replacement. Pakistan's renowned pace attack will be led by Shaheen Shah Afridi. Backing him will be Haris Rauf, Mohammed Waseem, and Hasan Ali.
