SRS expresses serious concerns over Motor Vehicle Department's laxity in issuing driving licenses

TOP NEWS REPORT

JAMMU, Sep 28: Shri Ram Sena, a prominent socio-political organization, has raised grave concerns regarding the alarming apathy displayed by the Motor Vehicle Department in Jammu due to the unavailability of driving licenses. In a statement issued today, Rajiv Mahajan, President of Shri Ram Sena Jammu & Kashmir, highlighted a significant discrepancy in the department's performance.

Jammu and Kashmir have witnessed remarkable progress, transitioning from a conventional paper-based system to a seamless digital era. The administration's unwavering focus has been on delivering essential services to the public's doorstep. However, certain departments, including the Transport Department and its Regional Transport Offices (RTOs), appear to be out of sync with the LG administration's vision.

The current issue revolves around the issuance of driving licenses, specifically concerning the non-availability of



smart cards and colored films required for printing permanent licenses. Regrettably, over 10,000 individuals have endured official negligence for over six months.

Mahajan expressed his dismay, stating that it is disconcerting when a department designed for licensing cannot procure the necessary smart cards and colored films in a timely manner, and there seems to be a lack of accountability. This has left the public to fend for themselves. The situation escalates when individuals are stopped by traffic police officials who demand hard copies of their licenses, imposing fines on the spot for non-compliance.

The issue becomes further aggravated when residents of Jammu and Kashmir travel outside the Union Territory. Drivers find themselves in precarious situations

despite no fault of their own, as they face difficulties due to the unavailability of their licenses. Driving without a valid license is a punishable offense, and any resulting FIR or courtimposed penalties could detrimentally impact students' careers.

Mahajan emphasized that the relentless efforts of the administration to provide efficient online services within stipulated timeframes are being thwarted by the Transport Department's negligence. While the administration has successfully delivered more than 1,000 services online, the Transport Department has failed to address the issue of driving license printing and issuance for over half a year.

In light of these pressing concerns, Rajiv Mahajan earnestly appeals to LG Sinha to intervene and hold those responsible accountable for resolving this matter expeditiously. It is imperative that the Transport Department aligns its operations with the administration's commitment to providing seamless and efficient

ORGAN TRANSPLANTATION

rgan transplantation saves the lives of many people, but there is a big illegal trade hidden behind organ transplantation, which is known as organ trafficking. Integral organ transplantation is the process of transplanting body parts of people and from here people make needy people crazy and take advantage of their helplessness and take more money from them.

The practice of organ transplantation in humans and animals is increasing day by day. At present, awareness about organ transplantation is being spread in the country through media and many types of work are also being done by the government to stop organ trafficking. Continuous efforts are being made by the government to stop organ trafficking.

There is a high demand for healthy organs globally, which leads to crimes such as organ trafficking for commercial purposes. After death, many people want to donate their organs and many living people also donate their organs, but doctors sell those organs further. Doctors engage in organ trafficking, due to which most of the victims are poor, uneducated people who have to suffer losses.

In many such cases, we have often seen that doctors, in the name of money, make poor people victims of organ trafficking and mislead them. People's organs are sold for small amounts of money, other most vulnerable victims are those who go for treatment for illness and their organs are fraudulently removed without their knowledge.

Scientific advancements and advances in medicine have also given rise to organ trafficking.

Poverty and illiteracy are the main reasons for the rise of this crime, with victims receiving little or no payment for organ trafficking. Trafficking victims can be of any age group. Child trafficking and human trafficking victims have also become victims of organ trafficking. Victims of organ trafficking suffer from poor health conditions and immune systems due to surgeries.

Legal regulations can play an important role in preventing organ trafficking.

Be it India or any other country, doctors are mainly involved in organ trafficking, because without doctors, trafficking is not possible and the government also took strict action against doctors in 2007. A bulletin was issued by the World Health Organization in 2007, through which many guilty doctors were caught.

Taken by the World Health Organization, this step led to action against around 2000 doctors who were involved in kidney organ trafficking in the country and selling the kidneys to other countries. India's name has been included in the list of integral parts of the world by the World Health Organization. A huge problem is emerging in the country regarding organ transplantation. In the country, 4 to 5 thousand people require organ transplant every year, but the need of only 100 to 150 people is fulfilled, and the rest of the people have to lose their lives. To completely eradicate organ trafficking, the Human Organ Transplantation Amendment Bill was passed in the year 2009. Through this law, many types of guidelines were issued by the government, mainly it was told that if a person is caught doing organ trafficking, then that person will be sentenced to 10 years in jail and a fine of 2 1,00,00,000. The fine will have to be paid to the government. That person will never be forgiven through the court and that person will be ordered to suffer this fine and 10 years of imprisonment. Since then, fear has arisen among many people involved in organ trafficking, but even at present the work of organ trafficking is continuing, but the government is also making every effort to stop organ trafficking and in the coming time, it will become even stricter regarding organ trafficking. Steps can be taken. According to the guidelines of doctors, it is not possible to stop organ trafficking, because as long as the demand for organs increases, this trafficking will continue, for this the most important thing that the government should do is to spread awareness about organ donation among the people and organ donation will increase. So they will be easily available to the needy people and in such a situation the issue of organ trafficking will gradually end completely. The name of organ trafficking is becoming quite popular in the country. Lakhs of people are earning money through organ trafficking, but this work is very wrong and the government can also punish those caught doing organ trafficking. Many innocent people lose their lives because of organ traffickers.

Will a Doctor with zero percentile be trusted?

ecently, the Health Ministry announced Zero percentile for admission in NEET PG. In the counseling session held in July this year, MOC had kept it at 50 percentile. As the seats were not filled, many medical associations took interest in MS. Had requested. Now the government has also reduced the cost of bringing it to zero. The question arises that if only post graduation seats are to be filled then what was the need for NEET PG test? The arrangements for filling seats will be as per the marks of MBBS.Racking would be done. the system is collapsing Zero percentile means that it does not have minimum marks. Even those whose percentile is in minus, 1 or 15, can now take degrees like MD-MS etc. Those who have decided to make MD-AMS or DNB are at zero percentile. And if such people become doctors, then what will they do to the patients? people were in MBBSWhen we passed, our marks were kept at 50 percent. Our friends who were doing BA, BSc etc.,

their passing marks were 33 percent. In such a situation, we felt very proud. The challenge was also that if 50 percent did not come, how would the patient be treated? If someone who has done MBBS with 50% is given admission in PG at zero percentile, will he pass in PG at zero percentile? If someone knows that he will get admission in zero percentile then why would he get admission? Ants are kept only becauseWeak students should not get admission. But the arrangements that have been made now are not achieving this objective., This will paralyze the country's medical system. You don't say in Defense Services or DRDO. Will give admission on zero centile. Then why is this being allowed in medical? The story is not only this. There are many seats for post graduation in private colleges across the country which are going vacant. The annual fee for PG course in government medical colleges ranges from around Rs 10,000 to Rs 10,000. three bitThere is a L degree course, which can be largely settled for thirty-forty thousand rupees. In private colleges, the same fee ranges from one to one and a half crore rupees. Everyone knows that government medical colleges are everyone's first choice, so there are no seats left there. Seats are left in these private medical colleges; these colleges were incurring a loss of crores of rupees. To compensate for the same, the government has reduced the percentile to zero. But when seats start being sold in this manner, rockets are created and medical mafias start flourishing. Are. Government thinking is clear on this pointParadox [When NMC was formed, it said that we are setting quality standards, the doctors who come from abroad will have to undergo training for at least two to four years, only then they will get the license to practice in the country. But on the other hand, admissions are being given at zero percentile. Isn't this a contradiction? If the government really wants to improve NEET PG, then first of all it will have to set a limit on the fees of private medical colleges. If the government tells them that their seats are not being filled then reduce the fees, the number of doctors in the country There is shortage. But by not doing this it has done zero. This means that the quality will not be the same, but the income of private colleges will definitely increase. Zero percen-

Bring jobs back to the top of India's political agenda

n April 2022, while walking around Lal Gumbad Basti, La low-income neighbourhood, just beside tony, tree-lined Panchsheel Park in South Delhi, I met Angoori Devi, a 70-year-old widow. She sold parathas for a living. Words like "consumer food price inflation" or "retail inflation" were not part of her vocabulary. But she told me her regular customers were ordering much less. Many young mothers I met in the colony had cut down on milk for their children. They ate less vegetables. The Covid-19 pandemicinduced lockdown had shaved off household savings: many families told me they were in deep debt. Cut to September 2023. Amid the swirl of geopolitical stories about India's friends, foes, and frenemies, near and far, one thing leaps out again -- the long shadow of household debt. This month, the Reserve Bank of India revealed that Indian households were saving less and bor rowing more. According to the RBI, as a percentage of the gross domestic product, households' financial liabilities shot up to 5.8 per cent in 2022-23, up from 3.8 per cent in the previous year. Meanwhile, as Money Control, a leading financial portal, pointed out in its analysis of the latest RBI data: "Indian households saved 19 per cent less in 2022-23 compared to 2021-22 on a net basis, with the absolute amount of Rs 13.77 lakh crores falling to just 5.1 per cent of the economy's GDP." A recent visit to Greater Kailash-I M block, one of Delhi's most popular markets, was quite revealing. Several familiar stores had shut down. Every other salesperson spoke of falling footfalls. Many stores simply can no longer afford to pay the high rents.

You can slice and dice data in many ways. But to an ordinary citizen, much of what one sees around points to erosion of the spending power of Indian households. I am leaving out the super-rich.

The ministry of finance says there is no distress. "Critical voices have been raised about household savings and its overall effect on the economy. However, data indicates that changing consumer preference for different financial products is the real reason for the household savings and there is no distress as is being circulated in some circles," it said on X (formerly Twitter) on September 21 to rebut critics. tinues to be India's main challenge," the report notes.

The "J word" refuses to disappear.

We might gloat that India has overtaken the United Kingdom to become the fifth largest economy in the world but "economic growth remains weakly connected to job creation", as the report puts it. This is the stark reality which cannot be glossed over in a country with a population of 1.4 billion and whose median age is 28. We are a young nation; the vast majority are job-seekers. Encouragingly, the report points out, unemployment is lower post-Covid for all education levels. "But it remains above 15 per cent for graduates, and more worryingly, it touches a huge 42 per cent for young graduates. At the other extreme, among older, less educated workers, it is in the range of 2-3 per cent."

The "State of Working India 2023" report, just released by Azim Premji University, should be read against this backdrop.

After stagnating since the 1980s, the share of workers in India with regular wage or salaried work started going up in 2004, increasing from 18 per cent to 25 per cent for men and 10 per cent to 25 per cent for women. Between 2017 and 2019 this jumped to five million per year.

Since 2019, however, the pace of regular wage jobs creation has decreased due to the growth slowdown and the pandemic.

After falling or being stagnant since 2004, female employment rates have indeed risen since 2019 due to a distress-led increase in self-employment, according to the report. But here is the rub -- earnings from self-employment have declined in real terms over this period.

What is really worrying: even the good news about working women has a dark side.

The report says that districts where women experience less restrictions are also the ones where women are likely to underpartner violence due to challenging of established gender norms."

These are India's pain points. Even as we celebrate the country's triumphs in science and sports, it is vital that we spotlight these concerns. There are signs that the economy and job creation will be back again in the news as several states gear up for Assembly elections soon. Ruling parties in the poll-bound states (Madhya Pradesh, Telangana, Rajasthan and Chhattisgarh) are platforming their own schemes to address the employment situation. Rajasthan, for example, has passed the Rajasthan Minimum Guaranteed Income Bill 2023. Telangana has recently started a programme offering financial assistance of Rs 1 lakh to those engaged in community-based traditional occupations. The Chhattisgarh government has done away with the provision of stipend for government staffers appointed through the direct recruitment process and who were getting full salaries only from the fourth year of appointment.

This move is expected to benefit nearly 38,000 government officials and employees. Madhya Pradesh chief minister Shivraj Singh Chouhan has not talked much about jobs but the issue is not going away.

Bill Clinton's famous slogan --"it's the economy, stupid" resonated; it helped him become US President in the 1992 election.

In India, it is never just the economy, but could we bring jobs back to the top of the political agenda, for the sake of young Indians?

Love, pathos, beauty, patriotism, bhakti...there isn't a mood that does not have a Lata song. Timeless, a voice beyond mortal standards ... so how do we mark her birth anniversary? But then what more can be said about the rare gem in the galaxy of Indian music, who recorded her first song at age 13.



4-Year-Old Kidnapped In Mumbai, **Video Shows Man Walking Away** With Child

MUMBAI, Sep 28 (Agencies): A 4-yearold girl was kidnapped while playing outside her house in Navi Mumbai on Thursday. The police have arrested a 74-year-old man in connection with the case

According to the police, the incident took place near Nerul railway station area of Navi Mumbai. On Thursday, when the girl did not return home, her parents registered a complaint with the Nerul police.

The cops immediately launched an investigation and scanned CCTV footage of the area. One camera caught a person carrying the child in his arms and walking away. Senior police officer Tanaji Bhagat formed a team to track down the accused. The team checked about 150 CCTVs in and around the railway station.

Using the CCTV footage, the police were able to identify the man and laid a trap to arrest him. The accused was found to be in the Karave village area of Navi Mumbai. According to the police, the man, identified as Mani losing his first wife, Thomas remarried, but he and his new wife had no children. He told police that he kidnapped the girl because he wanted a child. A preliminary investigation revealed that he was planning to leave the state with her.

The girl was rescued unharmed and was reunited with her parents. The accused has been charged with kidnapping and is currently in police custody. The police are inves-

tigating whether the accused is involved in any other child trafficking cases.

Amit Shah, Nadda hold discussion with BJP's **Rajasthan leadership on upcoming assembly polls**

JAIPUR, Sep 28 (Agencies): Union Home Minister Amit Shah and BJP president J P Nadda held night-long discussions with the party's Rajasthan leadership here on a range of issues about the upcoming assembly elections.

The meeting began at a hotel late on Wednesday evening and continued till 2 am, party sources said on Thursday. The discussions were held amid a buzz that two central ministers might be asked to contest the upcoming polls. The speculation follows the BJP's decision to name three Union ministers and four MPs in its second list of candidates for poll-bound Madhya Pradesh.

Following the meeting, both Shah and Nadda left for Delhi on Thursday. A meeting with local RSS leaders was not held, party sources said.



"Discussions on election strategy were held in the meeting last night," Gajendra Singh Shekhawat told reporters at the hotel on Thursday. Shah and Nadda arrived in Jaipur on a special plane on Wednesday evening and headed to the hotel near the airport for the core committee meeting.

Party sources said that Shah and Nadda first held a meeting with former Rajasthan chief minister Vasundhara Raje for around 15 minutes. It was followed by a meeting with senior leaders in which the party's election strat-

egy was discussed. Feedback on the four 'Parivartan Yatras' that the BJP held recently was also discussed.

Union minister and the party's election incharge for Rajasthan Pralhad Joshi, co-incharge Nitin Patel, BJP's in-charge for Rajasthan Arun Singh, state unit president C P Joshi, Union Ministers Gajendra Singh, Arjun Meghwal, Kailash Chaudhary, leader of opposition in Assembly Rajendra Rathore, deputy leader of opposition Satish Poonia and other leaders were present at the meeting, the sources said

The meeting continued for around three hours. Poonia and MP Rajyavardhan Rathore were the first to leave the venue after the first round.

Nadda and Shah held the next round of meetings with the BJP's national general secretary (organisation) B L Santosh, Union minister Pralhad Joshi, Nitin Patel, Arun Singh, Kuldeep Vishnoi and Vijaya Rahatkar, among others, the party sources said.

"The leaders held discussions on the assembly constituencies and brainstormed on ways to win the maximum number of seats in Mewar, Vagad, Shekhawati, Hadauti and Marwar regions and in eastern Rajasthan in the assembly and Lok Sabha elections," a source said. During the meeting, a clear message was sent

isation is supreme and

to ensure the victory of the party" in the elections.

Some leaders said that ticket distribution and other poll-related issues were discussed in the meeting.

Parents of murdered Meitei Manipuri youths request govt to locate kids' remains for last rites

Both families hope that the CBI probe will help in finding the bodies of their children and reveal why they were murdered.

IMPHAL, Sep 28 (Agencies): Parents of both the murdered youths, viral pictures of whose bodies caused widespread protests in Imphal valley for two days, on Thursday pleaded with authorities to locate the remains of their children so that the last rights of the boy and the girl can be conducted "with the dignity they deserve.'

They hoped that with sleuths from the CBI joining the investigation into the kidnapping and death of the duo who went missing in July this year, the mystery of where their bodies lie will be solved.

The 18-year-old girl's father, Hijam Kulajit, in an interview with PTI said, "We just want to see our children one last time and conduct their last rites with the dignity they deserve. Nothing can substitute the loss. According to Meitei custom, at least a small portion of the clothes they wore is needed to perform the last rites and give them a farewell."



"Whenever I see her photo, it makes me completely restless and I can't find peace in my heart. Her mother has lost her senses and became bedridden while embracing a photo of our daughter," Kulajit said.

The two went missing on July 6. They were last seen on CCTV camera footage at Nambol in Bishnupur district. Their phones were tracked by police to Lamdan in Kuki-dominated Churachandpur district.

"For a day, we assumed they had eloped, but after contacting the boy's family,

we sensed something missing. I don't understand why they had to be killed," Kulajit asked. Meanwhile, the family of the 20-year-old boy continues to struggle to deal with the situation. Unable to believe that their son is no more, his mother continues to cook for him daily.

"It's been two-and-ahalf months now, but I haven't washed the blanket of my son as I can still smell him," she said.

In accordance with Meitei custom, both mothers offer incense sticks, candles and a small portion of food in

front of the photographs of their children daily till the last rites are conducted. Both families hope that the CBI probe will help in finding the bodies of their children and reveal why they were murdered. On Wednesday, Chief

Minister N Biren Singh said Union Home Minister Amit Shah assured him that those who had kidnapped and killed the two Manipuri youths will be arrested and punished.

A team of CBI officials, led by the agency's Special Director Ajay Bhatnagar, reached the state on Wednesday and started a probe into the crime which has rocked Imphal valley and led to two days of violent protests by students and youths on the streets of the state capital, leading to more than 60 people being injured.

Meanwhile, curfew relaxation had been cancelled in Imphal East and West districts from 4 pm on Wednesday till further orders.

More than 175 people have been killed and several hundreds injured since ethnic clashes broke out in the northeastern state on May 3, when a 'Tribal Solidarity March' was organised in the hill districts to protest against the majority Meitei community's demand for Scheduled Tribe status. Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal valley, while trib-

als, including Nagas and Kukis, constitute 40 per cent and reside mostly in the hill districts.

North Korean leader urges greater nuclear weapons production in response to a 'new Cold War'

SEOUL, Sep 28 (Agencies): North Korean leader Kim Jong Un called for an exponential increase in production of nuclear weapons and for his country to play a larger role in a coalition of nations confronting the United States in a "new Cold War," state media said Thursday.

The Korean Central News Agency said Kim made the comments during a two-day session of the country's rubber-stamp parliament which amended the constitution to include his policy of expanding the country's nuclear weapons programme.

The Supreme People's Assembly's session on Tuesday and Wednesday came after Kim traveled to Russia's Far East this month to meet with Russian President Vladimir Putin and visit military and technology sites.

The trip sparked Western concerns about a possible arms alliance in which North Korea would supply Putin with badly needed munitions to fuel his war on Ukraine in exchange for economic aid and advanced Russian technologies to enhance North Korea's nuclear and missile systems.

As North Korea slowly ends its



pandemic lockdown, Kim has been actively boosting his partnerships with Moscow and Beijing as he attempts to break out of diplomatic isolation and join a united front against Washington. He has described the world as entering a "new Cold War" and that North Korea should advance its nuclear capabilities in response.

KCNA's reports on Kim's comments came a day after North Korea c onfirmed the release of U.S. Army Pvt. Travis King, who is now being flown back to America, two months after he sprinted across the heavily fortified border into the North. King's relatively swift expulsion

defied speculation that North

Korea might drag out his detention to squeeze concessions from the United States, and possibly reflected the North's disinterest in diplomacy with Washington.

KCNA said members of the assembly gave unanimous approval to a new clause in the constitution to "ensure the country's right to existence and development, deter war and protect regional and global peace by rapidly developing nuclear weapons to a higher level."

North Korea's "nuclear forcebuilding policy has been made permanent as the basic law of the state, which no one is allowed to flout with anything," Kim said in a speech at the

assembly. He stressed the need to "push ahead with the work for exponentially boosting the production of nuclear weapons and diversifying the nuclear strike means," KCNA said.

Kim pointed to what he described as a growing threat posed by a hostile United States and its expanding military cooperation with South Korea and Japan, accusing them of creating the "Asian version of NATO, the root cause of war and aggression." "This is just the worst actual threat, not threatening rhetoric or an imaginary entity," he said.

Kim urged his diplomats to "further promote solidarity with the nations standing against the U.S. and the West's strategy for hegemony." Tensions on the Korean Peninsula are at their highest level in years as North Korea has test-fired more than 100 missiles since the start of 2022 and the U.S. has expanded its military exercises with its Asian allies, in tit-for-tat responses.

Last year, the assembly passed a new nuclear doctrine into law which authorises preemptive nuclear strikes if North Korea's leadership is perceived as under threat.

Nikki Haley slams Vivek Ramaswamy for joining TikTok

WASHINGTON, Sep 28 (Agencies): Republican presidential candidate Nikki Haley has slammed her fellow Indian-American rival in the Republican primary race Vivek Ramaswamy for joining Chineseowned TikTok, saying "every time I hear you, I feel a little bit dumber".

Haley, the former two-term governor from South Carolina and the former US Ambassador to the UN, was critical of the 38-year-old biotech entrepreneur and the two entered into a war of words during the second Republican presidential primarv debate at Reagan Library in Simi Valley in California.

"Every time I hear you, I feel a little bit dumber. This is infuriating because TikTok is one of the most dangerous social media apps we could have," Haley told Ramaswamy during the debate as the two entered into verbal duels multiple times during the two-hour-long debate boycotted by former US president Donald Trump and the current frontrunner. Haley, 51, jumped in when Ramaswamy was responding



to a question about him joining TikTok, a social media site that has been banned by many countries, including India.

Asked about his move to join the video-sharing app TikTok, despite it being banned on government-issued devices due to concerns about its parent

only going to ever get to declaring independence from China, which I favour if we actually win.'

Nagorno-Karabakh to dissolve, ending independence dream

ARMENIA, Sep 28 (Agencies): Nagorno-Karabakh's decades-long, bloody dream of independence ended on Thursday with a formal decree declaring that the ethnic Armenian statelet in Azerbaijan "ceases to exist" at the end of the year.

The dramatic decree issued by the separatist region's leader came moments after it was announced that more than half of the ethnic Armenian population had fled in the wake of last week's assault by arch-rival Azerbaijan.

Baku's lightning offensive ended with a September 20 truce in which the rebels pledged to disarm and enter "reintegration" talks.

Two rounds of talks were held as Azerbaijani forces methodically worked with Russian peacekeepers to collect separatist weapons silos and enter towns that had remained outside Baku's control since the sides first fought over the region in the 1990s.

Azerbaijani forces have now approached the edge of Stepanakert -- an emptying rebel stronghold where separatist leader Samvel Shakhramanyan issued his decree.

"Dissolve all state institutions and organisations under their departmental subordination



by January 1, 2024, and the Republic of Nagorno-Karabakh (Artsakh) ceases to exist," said the decree.

"The population of Nagorno-Karabakh, including those located outside the republic, after the entry into force of this Decree, familiarise themselves with the conditions of reintegration presented by the Republic of Azerbaijan."

'Ethnic cleansing'

The republic and its separatist dream have been effectively vanishing since Azerbaijan unlocked the only road leading to Armenia on Sunday.

Tens of thousands have since been piling their belonging on top of their cars and taking the winding mountain journey to Armenia every day.

Armenia said more than 65,000 had left by Thursday

morning -- more than half of the region's estimated 120,000strong population.

Armenian Prime Minister Nikol Pashinyan said Thursday that "in the coming days" all ethnic-Armenians will have left the region, where ethnic Armenians have been living for centuries.

"This is an act of ethnic cleansing of which we have been warning the international community (about for a long time."

Nagorno-Karabakh has been officially recognised as part of Azerbaijan since the Soviet Union's collapse in 1991.

No country -- not even Armenia -- recognised the statelet's independence claim.

But ethnic Armenian separatists have been running the region since winning a brutal war in the 1990s that claimed tens of thousands of lives.

The fighting was accompanied by allegations of massacres against civilians and gross violations of human rights that many

in the region recall to this day. But the bloody feud between the mostly Christian Armenian and predominantly Muslim Azerbaijan dates back to the years in the 1920s when the region was handed to Baku by the Soviets. Baku clawed back large parts

of the statelet and its surrounding areas in a six-week war in 2020 that significantly weakened rebel defences. Azerbaijan has agreed to allow rebel fighters who lay down their arms to withdraw to Armenia.

But Baku added that it reserved the right to detain and prosecute suspects of "war crimes"

Azerbaijani border guards on Wednesday detained Ruben Vardanyan -- a reported billionaire who headed the Nagorno-Karabakh government from November 2022 until February. Baku said on Thursday it had

charged Vardanyan with "financing terrorism".

ATHENS, Sep 28 (Agencies): Hundreds of people were rescued from floods in Greece overnight and early on Thursday, officials said, as a new storm hit the country just weeks after floods left 17 dead.

The fire service said it had assisted over 250 people in the region surrounding the central city of Volos, where a curfew was declared Wednesday as Storm Elias made landfall.

The storm also hit the island of Evia, prompting emergency traffic restrictions in the north of the island.

Much of Volos was without electricity and sections of the local hospital flooded, though the facility remained

Wednesday said cleanup crews had disposed of over 180,000 dead livestock and poultry, but were still unable to reach over a dozen chicken farms cut off from access roads.


Destroyed crops include cotton, corn, wheat, apples and kiwis, he said.

Facing a barrage of criticism at a perceived failure in cooperation between the army and civil protection in the hours following the disaster, the government has pledged over two billion euros (\$2.1 billion) in reconstruction funds.

EU Agriculture Commissioner Janusz Wojciechowski is scheduled to tour the central region of Thessaly on October 5, Avgenakis said Wednesday.

The heavy rains and flooding followed devastating fires in Greece this summer that killed at least 26 people, most of them migrants trapped in a forest near the northeastern border with Turkey.

Govt allows sharing of cable TV infrastructure with broadband service providers

Notifies amendments to Cable Television Network Rules-1994

NEW DELHI, Sep 28 (Agencies): The government has notified amendments to the Cable **Television Network Rules-1994** that grant registration for multisystem operators for a 10-year period and make the process online through the Broadcast Seva Portal.

The amended rules for MSO registration also enable the sharing of infrastructure by cable operators with broadband service providers to promote Internet penetration to the last mile.

Besides shifting the process of registration and renewal of MSOs to online mode through the Broadcast Seva Portal of the Ministry of Information and Broadcasting, the amended rules make it clear that registration shall be granted or renewed for a period of 10 years.



The processing fee of Rs 1 lakh is kept for the renewal of registration, the rules said. According to the rules, the application for registration renewal shall be made within a window of seven to two months before the expiry of the registration

"The renewal procedure is in line with the government's commitment to ease of doing business as it will provide certainty to cable operators to continue their services without interruption and therefore make the sector attractive for foreign investment," an official statement said The ministry has further said

that MSOs whose registration is expiring within seven months

are required to apply online through the Broadcast Seva Portal.

Earlier, only fresh MSO registrations were granted under the Cable Television Networks Rules, 1994.

The rules also did not specify the period of validity for MSO registrations, nor did they recognise the mandatory filing of online applications.

The inclusion of a provision related to the sharing of infrastructure by cable operators with broadband service providers will provide the twin benefits of enhanced internet penetration and efficient utilisation of resources.

It will also reduce the need for additional infrastructure for broadband services, the statement said.

Retrospective tax demand on gaming firms legally untenable, say experts

NEW DELHI, Sep 28 (Agencies): Legal experts are raising concerns about the demands placed on online gaming and gambling companies in India, totalling over Rs 1 lakh crore (1 trillion), for goods and services tax (GST).

They believe these notices may not withstand legal scrutiny due to several reasons including the retrospective nature of the tax demands.

Experts argue that demanding taxes for past periods raises doubts about the legality of such actions. Moreover, these demands are seen as disregarding the well-established legal distinction between games of skill and games of chance. This distinction has been recognized and upheld by Supreme Court and High Court judgments in the past.

Sudipta Bhattacharjee, a partner at Khaitan & Co, said affected gaming companies would challenge these notices in their jurisdictional high courts. He added that the entire legal basis of the demands appears to be questionable and in violation of previous court rulings.

The notices claim that players participating in games of skill for monetary stakes amount to gambling based on the presence of three elements: the



bling, even if the games played are purely skill-based, such as chess or cricket.

Experts highlight that the tax department seeks to collect GST amounts significantly higher than the total revenues earned by these companies, which appear legally inconsistent and arbitrary. As per Bhattacharjee, the companies may face challenges and delays in navigating through the litigation process, which in turn, would affect their funding and operations.

"Companies in receipt of such notices based on recent amendments, pertaining to past periods, will have to challenge the retrospective demands at the outset before the High Courts. The GST council and GoM took more than 2

India's external debt at USD 629.1 billion at June-end: RBI

MUMBAI. Sep 28 (Agencies): India's external debt rose marginally to USD 629.1 billion at June-end 2023, although the debt-GDP ratio declined, according to Reserve Bank data released on Thursday.

The debt rose by about USD 4.7 billion from USD 624.3 billion at March-end. "The external debt to GDP ratio declined to 18.6 per cent at end-June 2023 from 18.8 per cent at end-March 2023," RBI said.

The valuation effect due to the appreciation of the US dollar vis-à-vis the major currencies such as yen and SDR amounted to USD 3.1 billion. US dollardenominated debt remained the largest component of India's external debt, with a share of 54.4 per cent at end-June 2023, followed by debt denominated in the Indian rupee (30.4 per cent), SDR (5.9 per cent), yen (5.7 per cent), and the euro (3.0 per cent).

Excluding the valuation effect, external debt would have increased by USD 7.8 billion instead of USD 4.7 billion in end-June 2023 over end-March 2023, the central bank said.

According to the data, at end-June 2023, long-term debt (with original maturity of above one year) was placed at USD 505.5 billion, recording an increase of USD 9.6 billion over its level at end of the preceding guarter. The share of short-term debt (with original maturity of up to one year) in total external debt declined to 19.6 per cent at end-June 2023 from 20.6 per cent at end-March 2023. RBI further said the outstanding debt of the general government decreased, while non-government debt increased at end-June 2023. The share of outstanding debt of non-financial corporations in total external debt was the highest at 39.8 per cent, followed by deposit-taking corporations (except the central bank) (26.6 per cent), general government (21.1 per cent) and other financial corpora-

Asian Paints non-executive director Ashwin Dani dies at 79

Decoded: Why your face feels 'tight' after being washed

NEW YORK, Sep 28 (Agencies): Ever wondered why the skin on your face feels tight after washing with a cleanser? Research shows it is due to contraction of the stratum corneum, the outermost layer of our skin. Skin is the largest organ in the body and it's constantly exposed to the environment around us. The stratum corneum acts as a barrier to keep out unwanted chemicals and bacteria and to keep up the moisture. Researchers at Stanford University in the US show how mechanical changes in the outer surface of our skin translates into sensations and provides a quantitative approach for determining how people will perceive their skin after using a moisturiser or cleanser.

"This work provides a new understanding of how products affect the physical properties of our skin, which includes not just skin health, but also skin sensorial perception. That's a significant advance," said Reinhold Dauskardt, Professor in Stanford's Department of Materials Science and Engineering.

The team predicted that the mechanical forces created by this shrinking or swelling propagates through the skin to reach mechanoreceptors (a sense organ) below the epidermis, which then fire off signals to the brain that we interpret as a feeling of skin tightness.

In the study, published in 'PNAS Nexus' journal, researchers studied the effects of nine different moisturising formulas and six different cleansers on donor skin samples from three locations on the human body-cheek, forehead, and abdomen.

They measured changes in the stratum corneum in the lab and then fed that information into a sophisticated model of human skin to predict the signals that the mechanoreceptors would send.

The predictions from their analysis lined up almost perfectly with what people reported in human trials for each formula. Collaborators at L'Oréal Research and Innovation recruited 2,000 women in France to assess the nine moisturisers and 700 women in China to assess the six cleansers. The participants ranked their perceived feelings of skin tightness after using the formula they were given. "The ability to understand and predict how people will feel after using a skin treatment could help cosmetics companies improve their formulations before bringing in people to test them," said Dauskardt.

About 70 pc of premature cancer deaths in 2020 preventable, 30 pc treatable: Lancet study

NEW DELHI, Sep 28 (Agencies): About 70 per cent of the 5.3 million premature deaths from cancer globally in 2020 were preventable, while the remaining 30 per cent were treatable, according to a new The Lancet Global Health research.

Of the total deaths, 2.9 million were in men. while 2.3 million were in women, the study said, which had used the GLOBOCAN 2020 database on cancer mortality from the International Agency for Research on Cancer (IARC) for analysis.

The IARC conducts and coordinates research into the causes of cancer and is an intergovernmental agency under the World Health Organisation of the United Nations.

Tobacco, alcohol, obesity, and infections accounted for roughly 1.3 million deaths in women across all age groups in 2020, the study reported, acknowledging that the burden of cancer in women due to these risk factors was widely underrecognised.

Further, the study suggested that 1.5 million premature cancer deaths in women could be prevented each year through the elimination of exposures to key risk factors or via early detection and diagnosis, while a further 0.8 million lives could be saved each year if all women had access to optimal cancer care.

This study is a global estimation of the burden of premature, preventable, and treatable deaths from 36 cancer types in 2020 in 185 countries, by world region and Human Development Index (HDI).

"Discussion about cancer in women often focus on 'women's cancers', such as breast and cervical cancer, but about 3,00,000 women under 70 die each year from lung cancer, and 1,60,000 from colorectal cancer: two of the top three causes of cancer death among women, globally.

"Furthermore, for the last few decades in many high income countries, deaths from lung

cancer in women have been higher than deaths from breast cancer," said study author Isabelle Soerjomataram, Deputy Branch Head of Cancer Surveillance at IARC Greater scrutiny of the

causes and risk factors for cancer in women is also needed as they are less well understood compared with cancer risk factors for men, the study said.

Further, it said, growing evidence suggests links between commercial products predominantly used by women, including breast implants, skin lighteners and hair relaxers, and an enhanced cancer risk.

According to a new Lancet Commission report, gender inequality and discrimination influence women's rights and opportunities to avoid cancer risk factors and impede their ability to seek and obtain timely diagnosis and quality cancer care. Further, gender inequalities have resulted in an unpaid caregiver workforce that is predominantly female, and

hinder women's professional advancement as leaders in cancer research, practice, and policymaking, which in turn perpetuate the lack of women-centred cancer prevention and care, the report said.

"The impact of a patriarchal society on women's experiences of cancer has gone largely unrecognised. Globally, women's health is often focused on reproductive and maternal health, aligned with narrow anti-feminist definitions of women's value and roles in society, while cancer remains wholly under-represented," said study author Ophira Ginsburg, co-Chair of the Commission.

"There are important factors specific to women which contribute to this substantial global burden - by addressing these through a feminist approach we believe this will reduce the impact of cancer for all," said Verna Vanderpuye, senior consultant at the Korle Bu Teaching Hospital, Ghana, and co-chair of the Commission.

Air pollution may spur risk of stroke within 5 days: Study

NEW YORK, Sep 28 (Agencies): Short-term exposure to air pollution, defined as occurring within five days of the stroke, can significantly increase the risk of stroke, according to a new study.

In the study, researchers from University of Jordan in Amman looked at pollutants such as nitrogen dioxide, ozone, carbon monoxide and sulphur dioxide as well as different sizes of particulate matter, including PM1, which is air pollution that is less than 1 micron (µm) in diameter, as well as PM2.5 and PM10.

The team found higher concentrations of nitrogen dioxide were linked to a 28 per cent increased risk of stroke; higher ozone levels were linked to a 5 per cent increase; carbon monoxide had a 26 per cent increase; and sulphur dioxide had a 15 per cent increase.

Along with this higher concentration of PM1 was linked to a 9 per cent increased risk of stroke, with PM2.5 at 15 per cent and PM10 at 14 per cent.

Their findings, published in the journal Neurology, is based on a review of 110 studies that included more than 18 million cases of stroke.

The team also found that higher levels of air pollution were linked to higher risk of death from stroke.

Higher concentrations of nitrogen dioxide were linked to a 33 per cent increased risk of death from stroke, sulphur dioxide, a 60 per cent increase, PM2.5, a 9 per cent increase and PM10, a 2 per cent increase.

"There is a strong and significant association between air pollution and the occurrence of stroke as well as death from stroke within five days of exposure," said Ahmad Toubasi, study author, MD of the University of Jordan in Amman.

"This highlights the importance of global efforts to create policies that reduce air pollution. Doing so may reduce the number of strokes and their consequences," Toubasi added.

Not confused as a team, know our plans: Indian skipper Rohit Sharma

RAJKOT, Sep 28 (Agencies): Indian captain Rohit Sharma says he believes in giving opportunities to everyone before the big tournament as this will help them to win the ICC Men's Cricket World Cup. India lost their third ODI match against Australia by 66 runs on Wednesday. However, they sealed the series by 2-1.

Ahead of the World Cup, India in a three-match series made many changes and gave every player a match practice. In the post-match presentation, Rohit Sharma said that he wants to give opportunity to every play and this could make them win the World Cup.

"I'm pretty happy, of course I would like to go all the way along but if I'm hitting like that I'm happy. The last 7-8 ODIs we have played really well, we have been challenged under different conditions and different teams, I thought we responded to that challenge pretty well. Unfortunately not the result we wanted today. [On Bumrah] I'm pretty happy, more importantly how he feels body-wise, he has got so much skill, one bad game can



happen to anyone. How he feels mentally and body-wise is key for us and that's looking good for us" the Indian captain said. "When we talk about the 15 we are very clear what we want. We are not confused; we know where we are headed as a team. It's a team sport and we want everyone to come and play their part - that's how we win championships. It's about looking after the body and try and stay fresh for the next one and half months," Sharma said. In the match, Rohit tapping

into his prime form, taking on the bowlers, and dealing effectively with the left-arm pacers will be a major takeaway for the Indian team.

While chasing a mammoth target of 353, a major shuffle in the batting set-up saw the skipper opening with Washington Sundar who failed to impress with the ball in the first innings. Rohit looked dangerous right from the beginning, he stepped out of his crease, made room to open his arms and scored maximums.

His six sixes in his quick-fire 81 off 57 balls showcased his talent and raw hitting power. Unlike Mitchell Marsh, he didn't run out of steam, but Maxwell's blinder brought an end to his impactful innings.

Virat Kohli also announced his return with a bang as he swiftly put runs on the board, troubling the bowlers on each possible occasion.

But it was Maxwell once again who provided the muchneeded breakthrough with his unexpected off-breaks and dismissed Kohli for 56. Shreyas lyer looked in fine touch but fell to Maxwell for 48.

The rest of the game was a clinical bowling performance and impressive fielding from the Australian players at the boundary to break their 5-match losing streak and register a consolation win.

Earlier, opener David Warner's explosive fifty followed by outstanding batting by Mitchell Marsh, Marnus Labuschagne and Steve Smith powered Australia to score a mammoth total of 352/7 against India.

Sri Lankan cricketer Danushka Gunathilaka found not guilty of rape charges in Australian court case



SYDNEY, Sep 28 (Agencies): Sri Lankan cricket international Danushka Gunathilaka has been found not guilty of raping a woman he met on a dating site during the south Asian team's tour of Australia last November.

Judge Sarah Huggett acquitted the 32-year-old player as he sat at Sydney's Downing Centre District Court on Thursday listening to the decision.

Huggett found that the alleged victim, who cannot be legally named, was an intelligent witness who did not deliberately give false evidence about the use of a condom but was motivated by a desire to paint the cricketer in an unfavourable light.

"I find that the evidence regarding the complaint far from supports the complainant. Rather it undermines the reliability of her evidence," she said.

Gunathilaka and the woman met for drinks at a bar before having pizza together in downtown Sydney and catching a ferry to the woman's home in the city's eastern suburbs.

The woman accused him of various acts of aggression and violence. Police initially brought four charges against the 32-year-old, who was arrested at a city hotel just hours before Sri Lankan team was due to fly out home on November 6.

Prosecutors later dropped three of those charges.

Gunathilaka maintained his innocence, pleading not guilty to one count of sexual intercourse without consent. During the judge-alone trial, defence

lawyers attacked the credibility of the woman, claiming her story shifted over time and that she edited her version of events to paint Gunathilaka as an aggressive person.

Gunathilaka had been on bail during the trial, but was unable to play international cricket or return to his hometown of Colombo in Sri Lanka

He travelled to Australia with Sri Lanka's ICC T20 World Cup squad last year, but only played in the team's first game before being ruled out of the tournament with a hamstring injury.

Asian Games 2023: Roshibina Devi Naorem wins silver after losing to Xiaowei Wu in women's 60Kg final

HANGZHOU, Sep 28 (Agencies): India's Devi Roshibina Naorem, on Thursday, won the silver medal in the women's 60Kg event in wushu in the ongoing Asian Games 2023. Roshibina had a chance to win India's maiden gold medal in the sport in the history of the championship. However, India's wait prolonged after Roshibina lost 0-2 to China's Xiaowei Wu.

Earlier, India won seven medals in wushu in the Asian Games, but they lost in finals every other time. Back in 2010, Sandhyarani Devi Wangkhem was the last Indian to take part in the Asian Games final in wushu and lost to Iran's Azadpour Khadijeh in
