KPDCL announces Kashmir's winter power curtailment schedule

SRINAGAR, Oct 16 (Agencies): In preparation for the upcoming winter season, officials have released an updated power curtailment timetable for the Kashmir Valley.

As per the provided schedule, the Kashmir Power Development **Corporation Limited** (KPDCL) has specified a daily 4.5-hour power curtailment for metered areas. This curtailment will be distributed across three shifts; morning, afternoon,

and evening. Non-metered areas, on the other hand. are set to experience an 8-hour curtailment regularly.

Amit Shah attends Navratri Puja at Sharda Temple in Kashmir



NEW DELHI, Oct 16 (Agencies): Union Home Minister Amit Shah on Monday took part in the Navratri puia at the Sharda temple in Kashmir, where it was held for the first time since 1947, saying it signifies the return of peace in the Valley.

The minister said the puja at the temple marks the rekindling of the nation's spiritual and cultural flame under the leadership of Prime Minister Narendra Modi.

On Monday, Navratri Puja was held at the newly built Sharda temple located along the LoC in Teetwal in Kashmir. The temple was inaugurated by the home minister on March 23 this year on the same piece of land - and on the same pattern – where the temple existed in pre-partition

"It is a matter of profound spiritual significance that for the first time since 1947, the Navratri pujas have been held in the historic Sharda Temple in Kashmir this year.

"Earlier in the year the Chaitra Navratri Puja was observed and now the mantras of the Shardiya Navratri puja resound in the shrine. I was fortunate to reopen the temple on 23rd March 2023 after restoration," Shah said on X.

CB files chargesheet against father-son duo for forging school leaving certificate to secure Govt job

Economic Offences Wing - Crime Branch Jammu has officially filed charges against a father-son duo, Mukhtyar Ahmed and Bashir Ahmed, for their alleged involvement in a complex case of forging and preparing false school leaving certificates to obtain a government job within the Power Development Department of Jammu



and Kashmir. This fraudulent act has been said to cause significant losses to the Government Exchequer.

The case, registered under FIR No. 26/2023 U/S 420/467/468/471/120-B/RPC at the P/S Crime Branch Jammu, revolves around the intricate web of deceit spun by the accused individuals. It is believed that they conspired to create counterfeit school leaving certificates, ultimately leading to one of them securing a government job in the Power Development Department. This deceitful act not only jeopardizes the integrity of the

SC rejects woman's plea seeking termination of 26-week pregnancy

NEW DELHI, Oct 16 (Agencies): Ruling in favour of pro-life, the Supreme Court on Monday rejected a woman's plea, seeking medical termination of 26 weeks of pregnancy. A bench of Chief Jus-

tice of India DY Chan-

drachud, also comprising Justices JB Pardiwala and Justice Manoj Misra passed the order observing that there are no threats to the mother. not a case of foetal abnormality and doctors will face a viable foetus. The court directed the

government to bear all medical costs and the delivery to be conducted by AIIMS at the appropriate time. SC clarified the choice to give the child up for adoption depends on the parents.

The court noted that pregnancy has crossed over 24 weeks and termination of a 26-week pregnancy can not be allowed as it would violate the provisions under the Medical Termination of Pregnancy (MTP) Act. All India Institute of

11,000 old vehicles of Central Armed Police Forces Identified; To be scrapped

NEW DELHI, Oct 16 (Agencies): As many as 11,000 vehicles belonging to the Central Armed Police Forces such as the BSF, CRPF and CISF will be scrapped as part of a Central government policy to dispose of all automobiles older

than 15 years, officials said.

The Ministry of Home

Affairs has also requested all state governments and Union Territory administrations to take necessary steps for scrapping worn-out operational vehicles of state police organisations and to replace them with better technology and fuel-efficient vehicles

Agniveer Amritpal Singh committed suicide, Military honours not extended to his funeral as per rules: Army

NEW DELHI, Oct 15 (Agencies): The Army on Sunday said Agniveer Amritpal Singh committed suicide by shooting himself while on sentry duty and that military honours were not extended to his funeral as deaths arising out of self-inflicted injuries are

not given such honours. The Army asserted that it does not differentiate among soldiers based on whether they joined the force prior to or after the implementation of the Agnipath scheme.

There were allegations that the military honours were not extended to Singh's funeral as he was an Agniveer soldier.



The Army's Nagrotaheadquartered White Knight Corps on Saturday said that Singh died while on sentry duty in Rajouri sector due to a self-inflicted gunshot

injury. In a statement on Sunday night, the Army said there has been some "misunderstand-

ing and misrepresenta-

tion" of facts related to

the unfortunate death of Singh.

"It is a grave loss to the family and the Indian Army that Agniveer Amritpal Singh committed suicide by shooting himself while on sentry duty," the Army said.

"In consonance with the existing practice, the mortal remains, after conduct of medicolegal procedures, were transported under Army arrangements along with an escort party to the native place for the last rites," it said

The Army said the Armed Forces do not differentiate between the soldiers who joined ■Turn to page 9





Contractors raise serious concern over inordinate delay in release of security deposits

JAMMU, Oct 16: All Contractors Associations in Jammu Province raised serious concern over delay in the release of security deposits stands out as a pressing issue. Contractors have reported that security deposits, held by Divisions for more than three and a half years, have not been released for any completed projects. The absence of clear procedures for the release of these deposits by departmental staff has added to the frustration

of contractors. Furthermore, dissatisfaction with the categorization and handling of tenders has been expressed. Contractors are concerned that tenders were initially categorized under different heads and later shifted to the "languishing head." They argue that the department's changes to conditions after the fact have led to payment delays and disputes.

Additionally, inefficiencies in bill processing have been a source of contention. Some contractors submitted bills to the department over a



year ago, yet the department has not uploaded these bills for processing. This situation has left contractors in the precarious position of having to provide proof for work completed a year prior.

Issues related to NABARD (National Bank for Agriculture and Rural Development) funding were also highlighted. Contractors have completed works in accordance with NABARD guidelines but have not received payments for over a year. The funds allocated under the NABARD Head have not been disbursed, causing financial distress to contractors. There have also been instances where the department failed to acknowledge pend-

ing liabilities in favor of

contractors who executed NABARD-funded projects.

In the realm of pend-

ing payments for closed schemes, the contractors shed light on the fact that certain schemes have been officially closed by the department. However, payments for works executed by contractors following proper e-tendering procedures remain outstanding. Contractors emphasized that it is the duty of the department and government to release these pending payments.

Furthermore, contractors raised concerns about discrepancies between online and offline payments for works executed under the NRDWP (National Rural Drinking Water Programme). More

than 172 water supply schemes in the union territory still await payment, despite repeated engagements with the department.

The Contractors Associations have voiced concerns about a potential violation of contracts in the Jal Jeevan Mission. The department is attempting to alter the provision for GI Pipes in works allotted under the Jal Jeevan Mission by opting for HDPE pipes. Contractors argue that this constitutes a violation of existing contracts and raises questions about the integrity of the projects.

The Contractors Associations in Jammu Province have called for a transparent and efficient resolution of these issues. They emphasize the importance of honoring contractual agreements, ensuring timely payments, and safeguarding the rights of contractors engaged in critical infrastructure projects. The collective leadership of the Contractors Associations is committed to working collaboratively with government departments to address and rectify these critical matters.

NEW PRODUCT DEVELOPMENT

ew Product Development is the process of designing, building, operating, and maintaining a good or device.

Software and internet companies use a product development process to ensure that they are not just manufacturing a technology, but creating a product that people will want to buy and continue to use.

New product development is development of altogether new product so far as the company is concerned. There is a misconception that new product development is the sole responsibility of the production related departments of an industry. This must be actually done jointly by the production related departments and the marketing department.

New product development is absolutely necessary for any company. Any company which does not plan this will not only be able to succeed but also will find it difficult to survive. New product development however is not an easy affair. It is an expensive, painstaking, time consuming and risky affair. In spite of all these discouraging facts every company has to take it as a challenge and go about developing new products.

New Product Development ingenuity of the human mind which from the beginning of the time has invented innumerable products for the benefit of mankind. Imagine life without the wheel, led to horse carriages, trains, trams and cars? What about the phone, which led to cell phones, videophones, and satellite phones? However for every successful product there are dozens which could not see the light of day.

But the creative genius is not afraid of failures; he pushes ahead with new ideas, products and services. Each firm sells products needed by customers. Each product has a life of its own. It takes birth in the inventor's crucible; it is then engineered for manufacture, made and sold. As newer products enter the market the old ones give way to them.

This is usually done for products which have had a good run in the market in their introductory, growth and maturity stages. Innovations should not render the product so expensive as to make it out of reach of customers. However, the new products should appear different, should give extra benefits and still be value for money.

Firms selling shoes can take up the sale of sandals, boots and leather garments. This will help the firm to establish itself in the market as it already has the raw material sources and marketing channels in place.

If a firm making radios starts manufacturing television sets then it would be considered horizontal diversification. Such product extensions are cost effective as they use the same distribution channels, have several common components and similar technology. Sometimes the new product may overtake the old one in terms of sales.

In the 1960s and 1970s, technological developments took time to reach India. Today, many technological advances are available to India in almost real time, i.e. as soon as they are in the market in the country of their origin. Computer software is a classic example. In fact, software exports form a major chunk of India's total exports.

Cell phones or mobile phones were introduced in the Indian market several years after being invented and introduced elsewhere in the world. But India has caught up with the rest of the world quite fast.

Geographic diversification helps a firm in increasing sales and market share. Exporting can be one of the methods as well. Firms can also plan to diversify into different market segments, with minor changes in product offerings, if required.

Don't look Westward: The Sun still rises in the East

aybe one could dismiss it away as Kant cant. But the followers on the social media of India's G-20 sherpa, Amitabh Kant, were not so generous. Many reacted derisively to Mr Kant's supercilious tweet: "I have travelled to Europe a few times recently. In my view the Indian airports are far bigger and better, our road network is far more widespread with quality roads, our airlines deliver far better and more efficient service at lower price points and now Indian trains (Vande Bharat) will give us top class quality and connect India through its length and breadth." I recall that when New Delhi got its new airport terminal over a decade ago, many who flew Delhi-Frankfurt-New York (JFK or La Gaurdia) made that kind of comparison. Even today, the Delhi and Hyderabad airports outshine Frankfurt and JFK.

It's true that Europe has many rundown airports and many European cities have depressed neighbourhoods. It's also true that India has a few bright and shining airports and a few swank neighbourhoods. But one must not make much of a muchness about Indian infrastructure in general being superior to European. Not surprisingly, few of Mr Kant's followers on X (formerly Twitter) were willing to endorse his hyperbole. We still have some way to go and I am sure the young Mr Kant will still be around to see that happy day.

Whenever westward travelling Indians made the Kant kind of comparison between India's new infrastructure and Europe's old, I would always encourage them to look East. Travel to airports and drive on roads in Malaysia, Thailand, Vietnam, China, I would say to them, not to mention Japan, South Korea and Taiwan, to make the inter-country comparison that we ought to.

On any parameter of development, from school education, women's health and sanitation to manufacturing capability and infrastructure



development, the Asia to our East has marched well ahead of India over the past half century. Over the past couple of decades, India has been bridging the gap and will continue to do so, but the relevant comparison for India to make is with East and Southeast Asia. Not Europe.

The Sun still rises in the East. At a time when Europe is in the midst of a regional conflict and the Mediterranean is catching fire, the Asia to India's East remains relatively calm and stable. At the recently concluded annual meetings of the International Monetary Fund and the World Bank, the economic data presented show that apart from the United States, most of the economies performing well this year, 2023, and expected to perform reasonably well next year, are to India's East. China is slowing down, but with growth expected to be 5.0 per cent this year, it remains way ahead of the Euro Area's 0.7 per cent. Japan, the world's third largest economy, is bouncing back with output growth expected to be 2.0 per cent. India is catching up with its eastern neighbours, logging an average of around 6.0 per cent growth in the medium

Besides year-on-year growth, what sets the Asia to India's east apart is the quality of education, healthcare, urban infrastructure and manufacturing output. Each time I travel eastwards I return impressed not just by the physical indicators of development, roads and airports, but by the healthy

and happy look on the faces of young children as they pour out of well-provided schools. The optimism of young people is palpable.

The Indian post-colonial obsession with Europe makes many continue to compare oneself with the West, but it is the East that has set the standards of knowledgebased development over the past half century. It is not just the developed East -- Japan, South Korea, Taiwan, Hong Kong and Singapore -- but also the developing East --China, Malaysia, Indonesia and Vietnam -- that offer lessons in modernisation and development. It is perhaps for this reason that the far-sighted Prime Minister P.V. Narasimha Rao launched in 1992 what has been called a "Look East Policy" and Prime Minister Narendra Modi followed it up with an "Act East Policy".


At the end of a meeting with Prime Minister Manmohan Singh, in New Delhi in April 2005, and having concluded his official business, Japan's Prime Minister Junichiro Koizumi surprised Dr Singh with a question. India is in the middle of Asia, Mr Koizumi said to Dr Singh, there is to your East a "Rising Asia" and there is to your West an "Unstable Asia". In which direction will India move? In 2005, it was an extremely pertinent question to ask.

India was still beginning to record phenomenal growth rates, over 8.0 per cent per year during Dr Singh's first term in office, in a political framework of inclusive and liberal democracy. Dr Singh assured Mr Koizumi that India "looks East" and that a Rising India would be part of a Rising Asia.

In Mr Koizumi's view, it seemed, the Asia to India's East had resolved many issues and was focused on economic and social development. While the Asia to India's West was still battling the ghosts of a medieval era. The recent events in West Asia once again draw attention to the instability that has long characterised the region. While many worry that China may do to Taiwan what Russia did in Ukraine, I would discount such concerns for the simple reason that China, as much as its neighbours, remains focused on development. East and Southeast Asia will not risk conflict that will disrupt development. Europe can stew in its juice.

In recent years I have often reflected on the Koizumi question. Are we still on course to be a part of Rising Asia, or are we likely to be part of an "Unstable Asia"? As I travel within India, between the North and the South, and as one looks at news from the Hindi-speaking region and the South, this question constantly presents itself. The honest answer to the Koizumi question seems to be that South India is now certainly a part of "Rising Asia". The India between the metropolitan expanse of New Delhi and the Vindhyas is yet to join that journey. My advice to young Indians for a long time has been: Travel East to See the Future.

Medical - IIT competition

recent survey conducted on the instructions of the district administration in Kota city of Rajasthan, which has developed as a major coaching hub of the country, has confirmed that a large number of students there are suffering from severe depression

and other mental health problems. Have been. This survey was conducted between April and September this year. Keep in mind, during the same period there were reports of suicide of 19 students. If these are added, the number of students who committed suicide this year would be 25.She goes. Seeing the increasing number of suicides among students, the district administration started keeping their records from 2015 and since then this is the highest number of suicides in any one year. However, this survey is not just a part of efforts to understand the problem but to solve it as much as possible. During the survey, 83 such students were found who were victims of severe depression. Two students were found on the verge of suicide. They had begun the process of self-harm. Not only providing immediate counseling to all of themRather, necessary steps were

taken to provide relief to the coaching centers and parents by informing them. Thus, it can be assumed that these cases of possible suicide were stopped in time. But these efforts are not enough, this is clear from the fact that even when this survey was going on, there were reports of suicides of students and this was when other efforts to stop suicides were also going on simultaneously. Under these, steps were taken like installing spring ceiling fans in the rooms of hostels and PG centers and installing anti-suicide nets in the balconies. Went. As the survey report also indicates, the root of the problem lies elsewhere. When students come to Kota, they roam around the city for the first one or two months and have fun. Matters get worse when the coaching education comes to its full end. The feeling of not being able to keep pace with daily studies and

being left behind in the competition proves to be heavy for these teenagers living alone away from home and family. The problem is definitely seen in its most serious form in Kota, but its nature is national. After all for 1.25 lakh seatsIf 20 lakh students each compete, as is seen in NEET, then the fierce nature of the competition can be easily estimated. After all, why is it that even today middle class families in the country see their children's career becoming successful only after they get medical or IIT? Unless effective efforts are made to change this situation, measures like safety net, spring fans and counseling will give us only limited results.

Dimple questions BJP-RSS leaders on Accession Day

JAMMU, Oct 16: Sunil Dimple, President of Mission Statehood Jammu and Kashmir, has called upon BJP-RSS leaders to clarify their stance on the Accession Day and the conditions of the Instrument of Accession signed by Maharaja Hari Singh of J&K with India on October 26, 1947, as the approaching accession day is marked by significant discussions. Addressing media per-

sons here today, Dimple highlighted the discussions of nationalism and patriotism by BJP-RSS leaders during their visits to Jammu and Kashmir, with expectations of visits by the Prime Minister and Home Minister in the coming days. He urges these leaders to openly address their position on the Instrument of Accession.

Dimple alleged that BJP-RSS leaders have not upheld the Standstill Agreement and the conditions of the Instrument of Accession signed by Maharaja Hari Singh. He pointed out that BJP's actions on August 5, 2019, when they revoked Article 370, effectively broke the terms of the Instrument of Accession. Consequently, Dimple questions the legitimacy of celebrating the acces-



sion day by BJP.

Dimple asked where the conditions of the Instrument of Accession are being honored, as well as the laws that protect the lands and jobs of the people of Jammu and Kashmir.

He criticized what he deems to be empty statements by BJP-RSS leaders, describing them as further wounding the sentiments of the people of Jammu and Kashmir and making a mockery of the dogras, chinav valley, pier panial, pahadi, ladakhis, Kashmiris, and all religious communities in the region.

Dimple reaffirmed the commitment of "Mission Statehood" to reunite the people of all three regions of Jammu, Kashmir, and Ladakh, along with POK, GILGIT, and Baltistan, into a new map for Jammu and Kashmir.

He highlighted the resolution of liberation passed by the Government of India in the Indian Parliament, emphasizing that BJP has taken no steps towards the liberation of these regions and instead dismantled the J&K Dogra state into union territories.

Dimple declared that the mission will not allow any divisive efforts by groups or B-teams associated with BJP, with an intention to divide the princely Dogra state of Maharaja Hari Singh and the region's rich history on communal or regional

Dimple criticized the BJP and RSS for their lack of clarity and silence on issues related to statehood and special status, which he believes has erased the history, identity, and culture of the Dogra community. Advanced HIPEC Surgery for Ovarian Cancer Successfully Performed in Jammu

JAMMU, Oct 16: In a remarkable medical achievement, surgical oncologists Dr. Vikas Heer and Dr. Paras Khanna, in collaboration with Shankus Cancer Hospital and Aashna Oncology Association, have successfully conducted an advanced and complex cytoreductive surgery in the field of Gynae-oncology. The pioneering procedure, combined with Hyperthermic Intraperitoneal Chemotherapy (HIPEC), offers new hope for patients battling ovarian cancer.

The 47 years old woman from Rajouri presented with complaints fo abdominal

distension and vague abdominal pain. Subsequent investigations revealed a stage 3 ovarian cancer diagnosis, signifying that the cancer had spread to her upper abdomen. The recommended treatment protocol included both surgery and chemotherapy with the surgery sandwiched between chemotherapy .The patient underwent three cycles of chemotherapy prior to the surgical intervention.

The procedure was led by Dr Vikas Heer, Consultant Surgical Oncology and was complemented by the dedicated support of the anesthetic team, led by Dr. Jameel Hussain, a Consultant Oncoanesthesia. The

surgery encompassed a radical removal of the uterus, ovaries, pelvic and paraaortic lymph nodes, omentum, and total peritonectomy. Subsequently heated chemotherapy was infused directly into the abdomen using a specialized machine for a duration of 90 minutes. The entire surgical process lasted for about 1 0 hours. The patient had an uneventful recovery from this procedure and was discharged on the ninth yad after surgery.

Dr. Jameel Hussain, a proficient consultant in oncoanesthesia, played a critical role in the success of the procedure. both during surgery and in post-surgery ICU care. Dr. Jameel high-

lighted the challenges faced by the anesthesia team, particularly during the HIPEC phase, in maintaining the patient's hemodynamics

Ahead of 2024 general election, Supreme Court refers petitions against Electoral Bonds Scheme to Constitution Bench

The matter will be taken up on October 30

NEW DELHI, Oct 16 (Agencies): Ahead of the 2024 general election, the Supreme Court on Monday referred petitions challenging the Electoral Bonds Scheme to a five-judge Constitution Bench, saying it involved an important constitutional issue.

"In view of the importance of the issue raised, and having regard to Article 145(3) of the Constitution, the matter be placed before a Bench of at least five judges," a three-judge Bench led by CJI DY Chandrachud said.

The Bench said the matter would be taken up on October 30.

The top court had on March 21 this year said it would examine if petitions challenging the validity of the electoral bonds scheme for funding of political parties needed to be referred to a Constitutional Bench for an

"authoritative pronouncement".

An Electoral Bond is a bearer instrument like a Promissory Note which can be purchased by an Indian citizen or an Indian company whose identity would remain secret from everybody except the SBI from whom it has to be purchased. Once purchased, the buyer can give it to a political party, which can



encash it using its bank account. It was introduced through the Finance Act, 2017, which made amendments to several statutes, including RBI Act, Representation of People Act, Income Tax Act and Companies Act to facilitate the scheme which was notified on January 2, 2018.

In its PIL filed in 2017, Association for Democratic Reforms (ADR) alleged corruption and subversion of democracy through illicit and foreign funding of political parties and lack of transparency in their accounts.

Maintaining that several constitutional issues having a tremendous bearing on the sanctity of electoral process were involved in the petitions challenging the validity of Electoral Bonds Scheme, ADR had earlier urged the Supreme Court to refer the matter to a Constitution

The Centre maintained that the electoral bonds scheme was an "absolutely transparent" mode of political funding and it was impossible to get any black or unaccounted money through it.

The Supreme Court had on October 10 said it would take up petitions challenging the Electoral Bonds Scheme for final hearing after Dussehra vacation as the petitioners chose not to argue on the scheme being passed as a Money Bill.

Attorney General for India R Venkatramani had on the last date of hearing told the Bench that one of the issues raised in the petitions against the Electoral Bonds was the issue relating to Money Bill which was pending before a seven-judge Constitution Bench.

On behalf of the petitioners,

advocate Prashant Bhushan had said while Money Bill was one of the issues raised in the petitions, there were other issues to be decided independent of the Money Bill.

Contending that a corruptionfree society was a facet of right to life under Article 21 (right to life and liberty), Bhushan had said anonymous funding of political parties violated the Right to Information of the citizens as it promoted corruption by allowing companies benefiting from the government of certain parties to anonymously donate to those political parties.

After the petitioners' advocates, including Bhushan, said they would like the matter to be heard without arguing on the Money Bill issue in view of the 2024 general election, the CJI had posted the matter for final hearing on October 31 as the pre-hearing procedural formalities had already been completed.

On March 26, 2021, the Supreme Court had refused to stay the sale of electoral bonds ahead of the Assembly elections in West Bengal, Assam, Kerala, Tamil Nadu and Puducherry, saying "We do not see any justification for the grant of stay at this stage."

NewsClick founder Prabir Purkayastha, its HR head Amit Chakravarty move Supreme Court against arrest and remand



NEW DELHI, Oct 16 (Agencies): NewsClick founder Prabir Purkayastha and its human resources department head Amit Chakraborty on Monday moved the Supreme Court challenging a Delhi High Court verdict dismissing their petitions challenging their arrest and subsequent police remand in a case under the Unlawful Activities (Prevention) Act (UAPA) - an anti-terror law.

On behalf of Purkayastha and Chakravarty, senior counsel Kapil Sibal mentioned their petition before a three-judge Bench led by CJI DY Chandrachud who said he would look at the papers and list it.

Mentioning the petition out of turn, Sibal urged the CJI to list it for urgent hearing, saying, "He (Purkayastha) is a 70-plus man in custody."

Chakravarty were
arrested by the Special
Cell of the Delhi Police
on October 3 after a
case was lodged by
the Delhi Police against
the duo under UAPA
for allegedly receiv-

ing money to spread pro-China propaganda. According to the FIR, a large amount of funds to the news portal allegedly came from China to "disrupt the sovereignty of India" and cause disaffection against the country.

Purkayastha conspired with a group -- People's Alliance for Democracy and Secularism (PADS) -- to sabotage the electoral process during the 2019 general election, police alleged. On October 10, the trial court sent them to judicial custody for 10 days.

The Delhi High Court had on Friday dismissed petitions filed by Purkayastha and Chakravarty challenging their arrest and subsequent police remand under stringent provisions of the UAPA.

Holding that there was no "procedural infirmity" or violation of legal or constitutional provisions in relation to the arrest and the remand order was sustainable in law, Justice Tushar Rao Gedela had rejected their petitions for being "devoid of any merit".

Justice Gedela had

dismissed their contention that they ought to have been supplied with the grounds of arrest after being apprehended by police, saying the UAPA did not mandate furnishing the written grounds and only talked of the accused being "informed" about the reasons for arrest within 24 hours.

"After examining the entire issue in the right perspective, it appears as of now that the grounds of arrest were indeed conveyed to the petitioner, as soon as may be, after the arrest and as such, there does not appear to be any procedural infirmity or violation of the provisions of the Section 43B of the UAPA or the Article 22(1) of the Constitution and as such, the arrest is in accordance with law," it had noted.

However, in view of the recent Supreme Court verdict in Pankaj Bansal's case, the high court had said it would be "advisable" that the police henceforth provide the grounds of arrest in writing to an accused after redacting "sensitive material".

The high court had sought to emphasise that offences under the UAPA directly impacted the stability, integrity and sovereignty of the country and were of utmost importance since they affected national security.

ISRO 'very busy' with various exploration missions in pipeline: Chairman S Somanath

CHENNAI, Oct 16 (Agencies): ISRO has lined up a series of exploration missions including to Mars, Venus and to the Moon again, apart from the maiden human spaceflight programme, Chairman S Somanath said.

The space agency also has drawn up plans to launch missions for studying climate and weather conditions of the Earth, the space agency chief said, speaking to reporters.

Besides, ISRO is also working on regular scientific missions including communication, remote sensing satellites, Somanath, who is also the Secretary of the Department of Space, said here.

Speaking about the Gaganyaan programme, he said the maiden TV-D1 test flight is scheduled for October 21.

Elaborating about the upcoming missions undertaken by the Bengaluru-headquartered space agency, he said, "We have exploration missions. We have plans to go to Mars, Venus, again sometime to the Moon. We also have programmes to look at the climate and weather of Earth."

Stressing that the scientists at ISRO would be focused on taking up regular missions like launching satellites for communications and remote sensing, he said scientific missions are



also in the pipeline to look at issues like aeronomy, thermal imaging, and climate change impact assessment.

"So many things are there and we are very busy doing all of this," he said.

To a query about whether scientists were able to receive any kind of response from the Vikram lander of the Chandrayaan-3 spacecraft, which successfully made a soft-landing on the surface of the Moon on August 23, he said Vikram had done its job very well during the lunar day (equivalent of 14 Earth days) at which time it was programmed to perform its functions.

"It is happily sleeping on the Moon. It has done its job very well. Maybe if it wishes to wake up, let it wake up. Until then, we will wait," he said. ISRO made efforts to re-establish communication with rover Pragyan and

lander Vikram after they were put into sleep mode in September following the onset of night on the Moon.

"No signals have been received from them. Efforts to establish contact will continue," ISRO had said.

After the historic landing on August 23, lander Vikram and rover Pragyan performed different tasks on the lunar surface, including detecting the presence of sulphur and recording relative temperature.

About ISRO's maiden mission to study the Sun, Somanath said the spacecraft is 'very healthy' and is on a 110-day long journey to the Lagrange point L1 and is expected to reach the intended destination by "middle of January"

"It is a long journey. It is almost 110 days of journey and it has covered some distance now. We corrected a little bit of its trajectory, because early correction is important to reach the L1 point. After tracking, we find it is going in the right direction towards the L1 point," he said.

Observing that the rocket is on a 'complex travel', Somanath said, "It takes almost another 70-75 days further to reach. By the middle of January, it will reach there. After that, we will make some corrections to make it enter into the Halo orbit at the L1 point."

"After that instruments will be switched on and it will start doing the scientific data streaming. Currently, everything is very healthy on Aditya L1," he said.

Aditya-L1 was launched on September 2, and it is the first Indian space-based observatory that will study the Sun from a halo orbit around the first Sun-Earth Lagrangian point (L1), which is located roughly 1.5 million km from the Earth.

Earlier, Somanath visited the residence of renowned agricultural scientist M S Swaminathan, who passed away on September 28. He met the family members of the eminent plant geneticist known as the driving force behind India's 'Green Revolution', here in the city.

Revolution', here in the city.

"I am here today just to pay my tributes and my affection to his (M S Swaminathan's) contribution... Whoever works in whichever field whether it is space, agriculture or sustainability and many other domains, we all find a place to work together," he said

he said.

"Thank you so much for the opportunity. His (M S Swaminathan's) legacy will continue to inspire more young people in the country to work in science and technology." Somanath said.

Benin national, arrested in drugs case, escapes from Delhi police custody; nabbed later NEW DELHI, Oct 16 official said. bing him. A police official said.

NEW DELHI, Oct 16 (Agencies): A 31-year-old Benin national, arrested in connection with a case of illegal drug supply, escaped from police custody but was nabbed from Nihal Vihar here a few hours later, officials said on Monday.

Uche Uwadiegu was arrested on October 3 with 1 kg of heroin, an

official said.

He fled on Sunday while being taken to the Chander Vihar area for further investigation, the officer said, adding that after running some distance, he sat on the motorcycle of his associate and they both sped away.

Police personnel chased him but were unsuccessful in nab-

bing him. A police official suffered minor injuries in the chase, the officer said.

Uwadiegu was nabbed from the Nihal Vihar area after a seven-hour search. His associate, Nanso Rexfelison (42), a Nigerian national, was arrested later, the police officer said, adding both the accused are being interrogated.

Allahabad High Court acquits Maninder Pandher, Surender Koli in Nithari case; overturns death penalty



PRAYAGRAJ (UP), Oct 16 (Agencies): The Allahabad High Court on Monday acquitted Surender Koli and Maninder Singh Pandher in the infamous Nithari serial killings case in Noida for lack of evidence.

Both had been sentenced to death on charges of rape and murder.

A total 19 cases had been lodged

against businessman Pandher and his domestic help Koli in 2007. The CBI had filed closure reports in three of the 19 cases due to lack of evidence.

The sensational killings came to light with the discovery of the skeletal remains of eight children from the drain behind Pandher's house in Nithari, Noida, on December 29, 2006.


Further digging and searches of drains in the area around Pandher's house led to more skeletal remains being found. Most of these remains were that of poor children and young women who had gone missing from the area.

Within 10 days, the CBI took over the case and its search resulted in the recovery of more bones.

Several injured in shooting incident over alleged molestation in UP's Mahoba

MAHOBA, Oct 16 (Agencies): Seven people were referred to Mahoba District hospital after they sustained injuries in a shooting incident in Bendo village of UP's Mahoba district, said Mahoba SP Aparna Gupta.

The incident reportedly happened after a BA student protested against the alleged molestation by the accused, identified as Jitendra Tiwari.

Jitendra Tiwari and his father reached the victim's house and allegedly fired gunshots which resulted in injuries to 10 people, of which seven were referred to the district hospital. It is being said that the victim (BA student) had been troubled for a week on her way to college by the accused, Jitendra Tiwari.

Talking about the incident to media personnel, Mahoba SP Aparna Gupta said, "We received information from village Bendo regarding gunshots being fired and some people getting injured in the incident after which police reached the spot."

SP Gupta further informed that the injured were taken to a nearby health-care centre for treatment where their

condition was reported stable and for better treatment, the injured were later referred to Mahoba district hospital. All the injured are out of danger, she

All the injured are out of danger, she said.
"Senior officials also visited the spot

of the incident and an investigation is being carried on to figure out the cause of the incident," said SP Gupta. After the complaint, the case will be registered into the matter, she added.

She further said that four teams have been formed to look into the matter and soon the accused will be apprehended. Police force has also been deployed

Joe Biden considering trip to Israel in coming days, but travel isn't final

It would be a powerful symbol of sympathy and support following the brutal attack by Hamas

WASHINGTON, Oct 16 (Agencies): President Joe Biden is considering a trip to Israel in the coming days but no travel has been finalised, a senior administration official said.

It would be a powerful symbol of sympathy and support following the brutal attack by Hamas.

A trip would be a chance for Biden to personally affirm to the Israeli people that the US is standing firm behind them. But it would come amid growing fears that a looming Israeli move into Gaza could spark a wider war with devastating humanitarian consequences.

And Biden's presence could be seen as a provocative move by Hamas' chief sponsor, Iran, or potentially viewed as tone deaf by Arab nations as civilian casualties mount in Gaza.



Secretary of State Antony Blinken has already been travelling around the Mideast this past week trying to prevent the war with Hamas from igniting a broader regional conflict.

The official could not publicly discuss internal deliberations about the potential presidential travel and spoke to the Associ-

ated Press on condition of ano-

Biden also made his strongest public statements yet to restrain Israel after the October 7 attack that killed more than 1,400 people including at least 30 US citizens, warning in an interview with CBS' 60 Minutes that aired on Sunday that Israel should not

reoccupy Gaza.

"I think it'd be a big mistake," Biden said. "Look, what happened in Gaza, in my view, is Hamas, and the extreme elements of Hamas don't represent all the Palestinian people. And I think that it would be a mistake for Israel to occupy Gaza again."

Israel left Gaza in 2005; Hamas won the elections the next year.

Still, Biden said, "taking out the extremists ... is a necessary requirement".

Biden and his administration officials have refused to criticise Israel or its bombing campaign that has killed civilians in Gaza. But they've urged Israel, Egypt and other nations to allow for humanitarian aid and supplies into the worsening conflict zone.

"I'm confident that Israel is going to act under the rules of war." Biden said in the interview.

Muslim boy stabbed 26 times by US man in hate crime motivated by Israeli-Hamas war, police say



CHICAGOL, Oct 16 (Agencies): An Illinois man was charged with hate crimes for stabbing a six-year-old Muslim boy to death and wounding his mother in an attack that targeted them for their religion and as a response to the war between Israel and Hamas, officials and Muslim rights activists said.

The boy was stabbed 26 times with a military-style knife with a 7-inch (18-cm) serrated blade, the Will County Sheriff's Office said in a statement.

The 32-year-old woman had multiple stab wounds and is expected to survive the attack that occurred on Saturday in Plainfield Township, about 40 miles (64 km) southwest of Chicago.

US President Joe Biden said the boy's family were Palestinian Muslims who "came to America seeking what we all seek - a refuge to live, learn, and pray in peace".

"This horrific act of hate has no place in America," Biden said in a statement.

Joseph Czuba, 71, was charged with first-degree murder, attempted first-degree murder, two counts of hate crime and aggravated battery with a deadly weapon, the sheriff's office said.

"Detectives were able to determine that both victims in this brutal attack were targeted by the suspect due to them being Muslim and the on-going Middle Eastern conflict involving Hamas and the Israelis," the Will County Sheriff's Office said in a statement.

Agency could not identify an attorney for Czuba. He was in jail awaiting his initial court appearance, the office said.

Although Czuba did not make any statements to detectives, as is his constitutional right, police said they determined the charges hrough interviews and evidence.

When police arrived at the scene, they said they found Czuba sitting on the ground outside the home with a cut to his forehead. The victims were in a bedroom.

The Council on American-Islamic Relations (CAIR) identified the boy as Wadea Al-Fayoume and said the woman, Hanaan Shahin, was his mother.

"The Islamophobic rhetoric and anti-Palestinian racism being spread by politicians, media outlets, and social media platforms must stop," CAIR said on the social media platform X.

FBI Director Christopher Wray warned the International Association of Chiefs of Police conference to stay vigilant "in this heightened environment".

"There's no question we're seeing an increase in reported threats, and we've got to be on the lookout, especially for lone actors who may take inspiration from recent events to commit violence of their own," Wray told the conference in San Diego, according to the FBI website.

Free hostages, UN Chief tells Hamas, asks Israel to allow humanitarian aid in Gaza

GENEVA, Oct 16 (Agencies): UN chief Antonio Guterres has called on Hamas to immediately release all hostages without conditions and urged Israel to allow rapid and unimpeded access to humanitarian aid for civilians in the Gaza Strip.

The Hamas-ruled Gaza Strip, home to about 2.3 million people, is under a total blockade. Israel has cut off all supplies of food, water and fuel in the wake of ongoing hostilities with Palestinian militant group Hamas.

On Monday, Israel's Defence Minister Yoav Gallant said it would impose a "complete siege" on the territory.

"In this dramatic moment, as we are on the verge of the abyss in the Middle East, it is my duty as Secretary-General of the United Nations to make two strong humanitarian appeals," Guterres said here in a state-

ment on Sunday.

The UN Secretary-General appealed to Hamas that it must release all hostages immediately without conditions.

"To Israel, rapid and unimpeded access for humanitarian aid must be granted for humanitarian supplies and workers for the sake of the civilians in Gaza," Guterres said.

"Each one of these two objectives is valid in themselves. They should not become bargaining chips and they must be implemented because it is the right thing to do," he said.

The UN chief sounded a dire warning, saying: "Gaza is running out of water, electricity and other essential supplies."

He noted that the United Nations has stocks available of food, water, non-food items, medical supplies and fuel, located in Egypt, Jordan, the West Bank and Israel and these goods can be dispatched within hours.

"To ensure delivery, our selfless staff on the ground, along with NGO partners, need to be able to bring these supplies into and throughout Gaza safely, and without impediment to deliver to those in need," Guterres said.

The United Nations, along with other humanitarian agencies, has been working round the clock to preposition aid since the latest conflict between Israel and Hamas broke out following the militant group's October 7 assault on several locations inside Israel and Israel's subsequent declaration of war.

The UN Office for the Coordination of Humanitarian Affairs (OCHA) said on Sunday that heavy Israeli bombardments on Gaza, from the air, sea and land, have continued almost uninterrupted.

Over the past 24 hours, there have been 455 Palestinian fatal-



ities in Gaza and 856 injuries, according to the Palestinian Ministry of Health in Gaza.

Following Israel's ultimatum on Friday that Palestinians in Gaza should relocate to the strip's south, OCHA said that by Saturday afternoon, nearly 600,000 internally displaced people (IDPs) were hosted in the central and southern parts of Gaza alone, in increasingly dire conditions.

It added that since then, this figure has risen significantly. About 300,000 people are situated in the United Nations Relief and Works Agency's (UNRWA) designated emergency shelters, and the rest in public facilities and with host families.

The OCHA said an almost full evacuation of Sderot city, in southern Israel, was completed on Sunday. Smaller Israeli communities around Gaza have

6 injuries, alestinian days, while a large proportion of Ashqelon City's residents have also reportedly left.

The UN agency added that since the start of hostilities, 2,670 Palestinians have been killed and 9,600 have been injured.

the eight days of hostilities has already surpassed the total number of fatalities during the 2014 escalation, which lasted for over seven weeks (2,251 Palestinian fatalities).

Philippines calls out China for its 'unsafe actions' in South China sea



MANILA, Oct 16 (Agencies): The Philippine military has called out China to stop "unsafe actions" in the South China Sea, after a Chinese navy ship shadowed and attempted to cut off a Philippine navy vessel conducting a resupply mission late last week.

A Chinese People's Liberation Army Navy (PLAN) vessel came as close as 350 yards as it tried to cross in front of the Philippine ship near Thitu island, Manila's biggest and most strategically important outpost in the South China Sea, according to armed forces chief Romeo Brawner.

"These dangerous and offensive manoeuvres by China's PLAN not only risk collision but also directly endanger the lives of maritime personnel from both sides," Brawner said in a statement

The Chinese embassy in Manila did not immediately respond to a request for comment on Monday.

It was the latest in a series of attempts by China to monitor and block Philippine resupply missions to personnel in Manila-occupied features in the Philippines' exclusive economic zone in the South China Sea.

China's claims sovereignty to almost the entire South China Sea, through which more than \$3 trillion of trade passes each year.

Ties between Manila and Beijing have soured since Philippine President Ferdinand Marcos pursued closer ties with Washington, including increasing US access to more Philippine military

Israel evacuates communities along Lebanon border: Army



JERUSALEM, Oct 16 (Agencies): Israel's army said Monday it was evacuating residents living along its northern border with Lebanon amid rising tensions there 10 days into its war with Palestinian militant group Hamas in the Gaza Strip.

An Israeli civilian and an army officer were killed Sunday in missile attacks from Lebanon, and the army carried out retaliatory strikes and attacked infrastructure of the Hezbollah militant group.

The Israeli army Monday noted in a statement "the implementation of a plan to northern Israel who live in the area up to two kilometres from the Lebanese border to statefunded guesthouses".

The move affects thou-

sands of people living in 28 communities.

Many have already left the area after repeated cross-border fire in recent days has claimed lives on both sides of the UN-patrolled border between Lebanon and Israel which remain technically at war.

Israel's Defence Minister Yoav Gallant said his country had "no interest in a war in the north, we don't want to escalate

the situation".
"If Hezbollah chooses

the path of war, it will pay a very heavy price," he said on Sunday. "But if it restrains itself, we'll respect the situation and keep things the way they are".

Israel has been at war since Gaza's Hamas militants staged an unprecedented attack on October 7 in which its gunmen shot, stabbed and mutilated people in a surprise onslaught that shocked the nation.

The attack and fighting since have killed more than 1,400 in Israel which has vowed to destroy Hamas and responded with a heavy bombing campaign on Gaza that had killed more than 2,750.

In 6 Arab Countries AMMAN, Oct 16 (Agencies): US Secretary of State Antony Blinken was returning Monday

US Secretary of State Antony Blinken was returning Monday to Israel after talks in six Arab states, hoping to coordinate efforts against Hamas while finding ways to alleviate Gaza's looming humanitarian crisis.

Just four days after he paid a lightning visit to Tel Aviv to show solidarity, Blinken was expected to meet Israeli leaders in Jerusalem as Israel prepares a major ground operation in the Gaza Strip.

"I want an opportunity to share everything that I've heard -- that I've learned -- over the last few days visiting with our other partners and to talk about the way forward with our Israeli allies and friends," Blinken told reporters Sunday in Cairo.

The trip comes as President Joe Biden reportedly considers an invitation to visit Israel to demonstrate further what the US leader has described as unwavering solidarity.

Israel has declared war on Hamas after the Islamist group broke through the heavily fortified border and shot, stabbed and burned to death more than 1,400 people, most of them civil-

ians

Israel has responded with relentless bombing, killing at least 2,670 people, the majority ordinary Palestinians, in the blockaded and impoverished Gaza Strip.

US officials say Blinken heard wide opposition to Hamas from leaders during his tour -- but also concern on the plight of the Palestinians.

"I made clear that it cannot be -- must not be -- business as usual with Hamas going forward." Blinken said in Cairo.

"And at the same time, as I said, we're determined to do everything we can to address the needs of people in Gaza,"

he said.

"Civilians should not have to suffer for Hamas's atrocities."

- 'Mistake' to reoccupy Gaza - Under US pressure, Israel on Sunday resumed the supply of water to the southern Gaza Strip after earlier vowing to keep out all supply of food, water and energy to the densely populated territory.

The United States also named a coordinator to spearhead humanitarian relief into Gaza, retired ambassador David Satterfield, who was expected to arrive in Israel on Monday.

The Biden administration has said that Israel has a right to respond and has stopped

short of calling for restraint or a ceasefire.

But it has also warned against more extreme measures such as mass expulsion of Palestinians, a prospect feared by Palestinian Authority president Mahmud Abbas, a Hamas rival based in the West Bank.

Biden, in an interview aired Sunday with the CBS News show "60 Minutes," cautioned of dangers in any bid by Israel to reoccupy Gaza.

"I think it would be a mistake," Biden said.

Israel pulled out of Gaza in 2005. Two years later, Israel imposed an air, land and sea blockade of the territory after it came under the control of Hamas, considered a terrorist group by Israel and the United States.

Blinken held talks in four of the five Arab states with diplomatic relations with Israel -- Jordan, Egypt, the United Arab Emirates and Bahrain

He also visited Saudi Arabia, which put its own normalisation bid with Israel on hold after the violence, and Qatar, a US partner that maintains relations with Hamas.

SC rejects woman's plea seeking termination of 26-week pregnancy

on Monday apprised the Supreme Court that no abnormality has been detected in the foetus of a woman who had petitioned to seek the medical termination of her 26-week pregnancy and that with proper care and treatment under appropriate medical supervision, the mother and baby can be managed well during pregnancy and postpartum psychosis.

"It is felt that with proper care and treatment under appropriate medical supervision, the mother and baby can be managed well during pregnancy and postpartum as has been previously evidenced by her response to medications. In case of worsening of symptoms she may be admitted and treated," AIIMS report said.

The hospital's report was filed after the apex court directed it to do so in an order on October 13.

A bench of Chief Justice of India DY Chandrachud, also comprising Justices JB Pardiwala and Justice Manoj Misra said that it will try and pass the order on the petition post lunch today.

The woman has sought the termination of her 26-week pregnancy whereas the Centre has filed an application seeking a recalling of the top court's order by which the woman's petition has been allowed.

Additional Solicitor General Aishwarya Bhati submitted the AIIMS report that stated that the woman has a past history of postpartum psychosis, currently controlled on medications

AIIMS report also said that as per the assessment by ultrasonography and fetal Echo, the foetus did not present any struc-

AIIMS also said that the continuation of pregnancy to full term while the woman is on the revised medications is not likely to significantly increase the risk of adverse outcomes for the mother and foetus as

compared to other pregnant women. The court also took the note of AIIMS report.

ASG Bhati, appearing for the Centre, apprised the court about the Medical Termination of Pregnancy Act, 1971 and said that it is a liberal and pro-choice legisla-

the reproductive autonomy and health of the woman while balancing the rights of a viable unborn child.

She further added that now it is not a matter of choice but a choice between preterm delivery and full-term delivery.

She assured the court that the government would assist her and her husband with everything including medical counselling.

Senior Advocate Colin Gonsalves apprised the court on the issue related to the unborn child and said that in international law today there is no right to the unborn child and the right of the woman is absolute.

But the court remarked with a question whether the woman should be allowed to abort even at 33 weeks of pregnancy in those cases where the foetus is not abnor-

The court also said that the challenge to be law should be dealt with in some other proceedings as now the matter is limited to the woman and the state.

The matter was referred to a three-judge bench after a two-judge bench on October 11 gave a split order on the married woman's plea seeking termination of a 26-week pregnancy.

The Supreme Court on Wednesday gave a split order on the married woman's plea seeking termination of a 26-week pregnancy as one of the judges ruled against the termination while the other judge expressed disagreement and said that the woman's decision must be respected to undergo the procedure of termination of her pregnancy.

A two-judge bench of Justices Hima Kohli and BV Nagarathna gave the split decision while hearing the Centre's plea seeking the recalling of its earlier order allowing the woman to undergo the procedure of termination of her pregnancy.

Justice Hima Kohli said that her judicial conscience does not allow her to permit termination. Expressing disagreement, Justice BV Nagarathna said that the woman's decision to undergo termination of her pregnancy must be respected.

The woman has submitted an affidavit stating she does not wish to carry out her pregnancy due to her mental condition and ailments.

On October 9, a bench of justices Hima Kohli and BV Nagarathna directed the woman to visit the Obstetrics and Gynaecology Department, AIIMS, New Delhi on October 10.

The court had also directed the AIIMS to admit the petitioner for her to undergo the procedure of termination of her pregnancy at the earliest with follow-up as may be advised by the treating doctors.

CB files chargesheet against father-son duo for forging school leaving certificate to secure Govt

employment system but also has severe financial implications for the government. Subsequently, the case was registered for a thorough investigation. Relevant documents were obtained and seized from the concerned school and the Power Development Department of J&K. Statements of witnesses were recorded, and circumstantial and material evidence was collected to strengthen the case against the accused.

The investigation revealed that Mukhtyar Ahmed and his father, Bashir Ahmed, allegedly conspired to create fraudulent documentation to secure a government job. As a result, they now face charges under various sections of the Indian Penal Code, including 420, 467, 468, 471, and 120-B. The charge sheet has been presented in the Court of Law, where a judicial determination will decide the outcome of this complex case.

The Economic Offences Wing – Crime Branch Jammu remains committed to upholding the law and ensuring that individuals involved in such fraudulent activities are brought to justice. This case underscores the importance of maintaining the integrity of our government institutions and the consequences that those who seek to deceive will face.

Rice traders demand flat export duty on parboiled rice

Indian Rice Exporters Federation has also requested government to reconsider its export ban on white rice

KOLKATA, Oct 16 (Agencies): Rice exporters have requested the Centre for a flat export duty of USD 80 per tonne for parboiled rice instead of the current 20 per cent duty to smoothen trade, a top official of the rice exporters' umbrella body said.

The Indian Rice Exporters Federation (IREF) has also requested the government to reconsider its export ban on white rice which was imposed in July and reduction in the minimum export price for basmati rice to USD 850 per tonne to prevent negative impacts on both export volumes and farmers

The government had extended the 20 per cent duty on parboiled rice exports until March 24

"We request the government to replace the 20 per cent export duty with a fixed USD 80



per tonne export duty. This will eliminate ambiguity and invoicing issues in rice trade," IREF national president Prem Garg told agency.

The federation wants a dialogue with the government to reconsider the ban on white rice, he added.

IREF also expects the government to release a notification for basmati rice proposing a minimum export price of USD 850 per tonne in contrast to the current rate of USD 1,200 per tonne.

The annual non-basmati rice export value from India exceeds Rs 50.000 crore.

These export restrictions have been imposed by the government to ensure adequate stock of rice and to control food inflation

Garg noted that the export restrictions have led to a 30 per cent increase in rice prices in the international market, benefiting competing countries like Pakistan and Thailand.

IREF director general Sanjeev Ahuja said the world's largest rice exporter accounts for approximately 46 per cent of total rice exports, amounting to around 22 million tonnes annually.

However, only 6.9 million tonnes have been exported so far. he added.

Out of the 22 million tonnes, 5 million tonnes are basmati rice.

while the rest comprises white and parboiled rice.

The exporters' body expects that if the government restrictions continue, export volumes will be impacted this year.

Garg emphasised that farmers are under pressure due to reduced demand from exporters. The Bharatiya Kisan Sangh has criticised the timing of the export ban announcement, stating that it sends a negative signal to farmers during the current planting season.

IREF, which is just 100 days old and has 4,000 members, said they successfully resolved the issue with the government by clearing 90,000 tonnes of white rice in transit to export destinations after the ban announcement. These shipments were previously stuck at various ports, according to officials.

Domestic passenger vehicle sales up 2 per cent in September: SIAM

NEW DELHI, Oct 16 (Agencies): Passenger vehicle wholesales in India increased by 1.87 per cent year-on-year to 3,61,717 units last month, industry body SIAM said on Monday.

The passenger vehicle dispatches to dealers stood at 3,55,043 units in September 2022.

Similarly, two-wheeler sales increased to 17,49,794 units last month from 17,35,199 units in the year-ago period, Society of Indian Automobile Manufacturers (SIAM) said.

Total three-wheeler wholesales rose to 74,418 units last month from 50,626 units in September 2022.

Total dispatches last month were up at 21,41,208 units from 20,93,286 units in September 2022.



In the September quarter, overall sales rose to 61,16,091 units from 60,52,739 units in the second quarter of 2022-23.

Wholesale inflation remains in negative for sixth month at -0.26 pc in September



NEW DELHI, Oct 16 (Agencies): The wholesale price index-based inflation remained in the negative territory for the sixth straight month in September at (-)0.26 per cent, on easing prices of food articles.

The WPI-based inflation rate has been in the negative since April and was (-)0.52 per cent in August. In September last year, it was 10.55 per cent.

Inflation in food articles eased to 3.35 per cent in September, after remaining in double digits in the previous two months. It was 10.6 per cent in August.

"Deflation in September 2023 is primarily due to fall in prices of chemical and chemical products, mineral oils, textiles, basic metals and food products as compared to the corresponding month of the previous year," the commerce and industry ministry said on Monday.

Fuel and power basket inflation was at (-)3.35 per cent in September, against (-)6.03 per cent in August.

In manufactured products, inflation rate was (-)1.34 per cent, as against (-)2.37 per cent in August.

Data released last week showed that the annual retail or consumer price inflation was at 5.02 per cent in September, a three-month low level.

Pregnancy complications enhance short, long-term risk of heart disease for people with obesity: Study

'Study provides insight into potential timing for interventions for people with overweight or obesity who are thinking about pregnancy'

WASHINGTON, Oct 16 (Agencies): According to a study, obesity during early pregnancy appears to be a strong predictor of future cardiovascular disease and has been linked to adverse pregnancy outcomes such as high blood pressure, preeclampsia, and gestational diabetes.

The findings of the study, which was supported by the National Institutes of Health, were published in Circulation Research. Obesity has long been recognised as a risk factor for cardiovascular disease and pregnancy difficulties caused by high blood pressure. They didn't know which factors influenced a person's cardiovascular disease risk years after pregnancy - obesity or pregnancy problems.

While having adverse pregnancy outcomes was linked with increased cardiovascular disease risks during pregnancy, the complications accounted for a small percentage of increased cardiovascular disease risks in the years following pregnancy for people with obesity.

"We're finding that certain pregnancy complications are unmask-



ing and then increasing cardiovascular disease risks, such as obesity, that were already present. This study provides insight into potential timing for interventions for people with overweight or obesity who are thinking about pregnancy," said Victoria L Pemberton, RNC, a study author and researcher in the Division of Cardiovascular Sciences at the National Heart, Lung, and Blood Institute (NHLBI), part of NIH.

The researchers analysed data collected from the nuMoM2b Heart Health Study of more than 4,200 first-time mothers - about half of whom were overweight or obese. They compared the participants' pregnancy experience to their health two to seven years later.

They found mothers who were overweight or had obesity during the first trimester of pregnancy had about twice the risk of devel-

oping gestational diabetes or having a pregnancy complicated by high blood pressure, compared to participants with normal body weight. These mothers also had increased risks of developing cardiovascular disease risks after pregnancy.

In comparison, pregnancies complicated by high blood pressure explained just 13 per cent of future risks for developing high blood pressure if a person is obese. Likewise, gestational diabetes explained only 10 per cent of future risks for diabetes.

"We want to do everything we can to support a person's heart health, but especially around the time of pregnancy - before, during, and in early pregnancy," said Sadiya S Khan, MD, the study's lead investigator, a preventive cardiologist, and an associate professor of medicine at Northwestern Univer-

sity Feinberg School of

Medicine, Chicago.

"That includes achieving and maintaining a healthy body weight, knowing your heart health numbers, and finding ways to stay physically active." For some complications the researchers found body weight did not factor into risks. For example, people with overweight or obesity did not have increased risks of having a preterm birth or a baby with a low birthweight.

Additionally, researchers found among all participants, those experiencing preterm births had increased risks of having high blood pressure, high blood sugar, or high cholesterol a few years after pregnancy. Having a baby born with a low birth weight wasn't found to increase risks.

"Looking for ways to support and optimize a person's cardiovascular health is still of the utmost importance if someone has had an adverse pregnancy outcome," said Khan.

"However, if we really want to make a difference in improving cardiovascular health and preventing these pregnancy outcomes, we have to shift to the pre-pregnancy and early pregnancy space."

failure gets new lease of lifeNEW DELHI, Oct 16 (Agencies): A 7-year-old fraction of just 15% (the dilated cardiomyopathy

NEW DELHI, Oct 16 (Agencies): A 7-year-old girl diagnosed with dilated cardiomyopathy and advanced heart failure received a new lease on life through a successful heart transplant.

Her journey has been marked by the generosity of a 14-year-old donor, with the operation taking place at SPARSH Hospital in Bangalore on October 16.

The young patient, battling dilated cardiomyopathy, faced an increasingly dire situation with an ejection fraction of just 15% (the amount of blood that your heart pumps each time it beats).

Dilated cardiomyopathy is a type of heart muscle disease that causes the heart chambers (ventricles) to thin and stretch, growing larger. This condition makes it harder for the heart to pump blood to the rest of the body.

The condition had affected her health, making her eligible for a heart transplant. Remarkably, this was

the second instance of dilated cardiomyopathy affecting her family. Earlier, her elder sister had succumbed to the same disease in 2019.

After a thorough evaluation, the 7-year-old girl was placed on the waiting list for a heart transplant in November 2022. Her situation was further complicated by her small build, weighing only 17 kg, and having blood type O negative.

These factors pose significant challenges in finding a compatible donor.

The miracle came in the form of a 14-yearold boy who became the donor. The heart's transportation from the donor to the recipient was expedited with the help of a "green corridor."

The 14-kilometre distance between the locations was covered in 13 minutes, probably making it the fastest drive of its kind.

The success of the green corridor was made possible by the efforts of the Bangalore Traffic Police.

Skin diseases could cause sleep disturbances, finds study

NEW DELHI, Oct 16 (Agencies): People with skin diseases can suffer from sleep disturbances, a recent global study revealed. The findings of the study were presented at the European Academy of Dermatology and Venereology (EADV) Congress in Berlin.

The research showed the impact of skin diseases on patients' sleep quality and their overall well-being. The ALL PROJECT, an expansive international research initiative, surveyed over 50,000 adults across 20 countries to assess the repercussions of various skin conditions.

The study's most striking revelation was that 42% of patients with skin diseases suffer from sleep disturbances. These disturbances have far-reaching implications for the quality of life, with almost half (49%) of these patients experiencing reduced productivity at work, compared to a mere 19% of individuals without skin issues.

Itching (60%) and burning sensations or tingling (17%) were identified as the primary symptoms hindering the sleep of patients with skin diseases.

These patients also more commonly reported feelings of fatigue upon waking (81%), daytime drowsiness (83%), tingling sensations in the eyes (58%), and repeated yawning (72%) when compared to those without skin conditions.

Dr Charles Taieb, the lead author of the study, stressed the critical importance of early detection and effective management of sleep disturbances for patients with skin diseases, as these disturbances significantly affect their physical well-being.

Dr Bruno Halioua, another author of the study, called for healthcare providers to incorporate sleep disturbance inquiries into their examinations of patients with skin conditions.

The ALL PROJECT also studied the challenges faced by individuals living with hidradenitis suppurativa, a painful, long-term skin condition causing abscesses and scarring.

This condition affects roughly 1 in 100 people and is often difficult to manage. The study found that 77% of patients with hidradenitis suppurativa reported feeling stigmatised due to their condition.

Additionally, 58% experienced ostracism or rejection from others, with more than half of the patients reporting avoidance of physical contact (57%) and social interactions (54%).

These experiences had consequences on patients, affecting their self-esteem, relationships, and daily lives.

England will have to show lot of character and resilience from hereon: Jos Buttler

England suffer a 69-run defeat to the Hashmatullah Shahidi-led side

NEW DELHI, Oct 16 (Agencies): England will have to play some of their "best cricket" to come out of the hole they find themselves in following their shock defeat to Afghanistan in the ODI World Cup.

England suffered a 69-run defeat to the Hashmatullah Shahidi-led side with the defending champions faltering in their chase of the 285-run target at the Ferozeshah Kotla on Sunday.

The win was Afghanistan's second-ever in a World Cup match and lifted them to sixth position on the points table behind England.

On whether it was premature to say that England's World Cup defence was under threat, Jos Buttler, whose team is yet to face India, Australia and South Africa, said, "Yeah. As I mentioned just before, it's not been the way we wanted to start the competition, but this is the situation we find ourselves in and we're going to have to play some of our best cricket moving forward."

The skipper said he had full faith in his team to pull through this crisis.

"Yeah, it's a big setback obviously. Before the tournament starts you have a different idea of how the first three games would pan out. We've got to show a lot of character, a lot of

Afghanistan didn't lose a wicket till they had crossed the century mark. England, on the other hand, were 91/4 at one stage.

Asked if he could pinpoint where things started going wrong for England, Buttler said,

days you don't play as well as you want to. Though Afghanistan built good pressure on us, maybe the wicket didn't play exactly how we thought it would play and maybe the dew didn't come in as much as we thought as well."

England have played their best cricket when their backs are to the wall of late, with the fight-back during the Ashes this year being fresh in the mind.

Asked if the two losses in three World Cup matches will sharpen the team's focus a little bit more, Buttler added, "We've played some good cricket in all scenarios, whether we've been on top and frontrunners and fancied or whether we've had our backs against the wall.

"It's a position you find yourselves in, it's not the position you wanted to be in three games ago but the character is excellent as I've mentioned, there'll always be belief and we'll dust ourselves down and go again."

England's charismatic Test skipper Ben Stokes's fitness has been a cause for concern as the all-rounder has not played in any of the three World Cup matches so far. He was seen doing sprints before the Afghanistan match but did not play. "He wasn't fit for this game (against Afghanistan) but we'll see how he pulls up for the next one," said Buttler.

"You Can't Get Away With This": Wasim Akram's Sharp Attack At Mickey Arthur On 'BCCI Event' Remark

NEW DELHI, Oct 16 (Agencies): Pakistan's team director Mickey Arthur, under fire over his team's embarrassing show against India in the Cricket World Cup 2023 match on Saturday, left a few scratching their heads with his comments in the press conference after the match. Arthur's remark suggesting that the India vs Pakistan clash in Ahmedabad seemed like a BCCI event over ICC as he didn't hear 'Dil Dil Pakistan' enough in the stadium didn't go down well with fans and a few former cricketers. Wasim Akram, a legend of the game, took a swipe at Arthur, suggesting he should be talking more about what Pakistan's plans for the match were than diverting attention with such comments.

In a chat on A-Sports,



Akram fumed at Arthur, asking what his plan was for his batters to face the mystery spinner Kuldeep Yadav. For Akram, the comments Arthur made didn't make any sense.

"Bhaiya hame ye batao aap logo ne kya plan kiya tha? (Brother, tell me what was the plan?) Kuldeep Yadav ko kaese khelna hai? (How did you prepare to play Kuldeep Yadav?) That's what we want to hear. Not this random stuff. You think you can get away with this. No, you can't, unfortunately." he said.

Wasim Akram's former teammate Moin Khan also echoed his sentiments, saying Arthur is only trying to divert attention. For Moin, the BCCI should be praised for organising the event in a manner in a way that helped them make the most of the 'home advantage'.

"(He) diverting attention. A lot of people are disheartened and you're making them emotional. I think he should discuss what is his job as a professional rather than showing a new path. As a coach, he shouldn't have said that."

"We should praise them (BCCI or making the most of the home crowd). Hamare yahan event ho so ham bhi isi tarah utilize karen. (If we host such events, we should also utilize them). We should learn from them."

Spain beats Norway to reach Euro 2024 with Scotland

OSLO (NORWAY), Oct 16 (Agencies): Spain booked their place at Euro 2024 with a 1-0 win over Norway, also enabling Scotland to qualify from Group

Young midfielder Gavi fired home early in the second half to help the 2008 and 2012 European championship winners progress to the tournament in Germany next summer, with two games to spare.

Norway, who last appeared at a major tournament in Euro 2000, and their star striker Erling Haaland can now only potentially qualify through playoffs, but need to hold onto third and hope Serbia qualify from Group G to be eligible.

Spain barely allowed Haaland a sniff all night long on a frustrating night for Norway, who sit five points behind their opponents and Scotland, joint top, with only one match remaining.

"From front to back we were really compact, we practically didn't let (Haaland) receive a single ball comfortably," Spain defender Dani Carvajal told TVE.

"They barely created any chances against us, we're going home happy with a ticket for the Euros."

Gavi was made to wait for several minutes before finding out



whether his goal counted or not, as VAR analysed it slowly.

"I think today we were very good and in the end it bore fruit," said Gavi.

"(They were checking the goal) I think for (Alvaro) Morata being offside, I don't know if he was, but in the end they gave it and I'm happy for that."

Spain were on top throughout and thought they had taken the lead after 20 minutes when Stefan Strandberg diverted the ball towards his own net and Morata greedily hammered home from almost on the goal

However, the strike was ruled out for offside against Morata -- Carvajal's lofted ball forward was aimed at Fati before Strandberg's intervention and if he had left the ball it would have

been an own goal.

Gavi eventually fired Spain ahead in the 49th minute after a hectic scramble in Norway's area, pouncing when Mikel Oyarzabal's shot was deflected into his path.

After VAR finally ruled Gavi's strike valid the 19-year-old Barcelona midfielder was able to celebrate his fifth goal for his country in 25 appearances.

Arsenal playmaker Martin Odegaard sliced an effort wide at the other end as the hosts made a rare foray forward, and Spain goalkeeper Unai Simon saved comfortably from bright teenager Antonio Nusa.

Morata had a shot cleared off the line in the final stages but was offside anyway as Spain sought a second goal to clinch progress

progress.
It did not come but it did not

matter, as a flat Norway could not muster danger during eight minutes of added time, apparently resigned to their fate, while Spain broke into celebrations at the final whistle.

De la Fuente's side started their qualifying campaign with an early defeat by Scotland which called the coach's surprise appointment into question, but Nations League victory in June and straightforward qualification for the Euros since have convinced.

"It's one of the matches in which we've been most satisfied in general terms ... the team had great maturity," De la Fuente told a news conference.

"Today I was calmer because I saw the team was very sure of itself."

The coach said the result was what Spanish football needed after a tumultuous period, in which federation president Luis Rubiales resigned over his forcible kiss on the lips of Women's World Cup winner Jenni Hermoso.

"This is good for everyone so that we think more about football," added the coach.

"It sparks hope, it sparks joy, Spanish football is always in the elite and now we'll get our fans excited again."

"It's Not Just Cricket That Guys Are Playing For": Afghanistan Coach Jonathan Trott After Win Over England

NEW DELHI, Oct 16 (Agencies): Afghanistan coach Jonathan Trott hopes Sunday's World Cup win over England will "encourage boys and girls" to take up cricket even though the country's Taliban rulers ban women from playing sport. The 69-run victory will be regarded as one of the biggest shocks in the history of the tournament as Afghanistan ended a 14-match World Cup losing streak. "It's not just cricket that the guys are playing for," said Trott, who recognised the significance of a win for a nation reeling from recent earthquakes and the Taliban's fractious international relations.

"The guys are very knowledgeable of the things and the hardship that some people are going through because of the natural disaster and for various other reasons. "And so, if this can give

a smile to people's faces but also encourage boys and girls to pick up a cricket bat or a cricket ball and get playing cricket wherever they are in Afghanistan, then that's the sort of the goal that's been achieved."

Before Sunday, Afghanistan had only won one match at the World Cup when they defeated Scotland on their 2015 debut.

They lost all nine matches they played at the 2019 tournament in England, including a 150-run rout at the hands of the hosts.

But having scored 284 on Sunday thanks to dashing opener Rahmanullah Gurbaz's blistering 80 and Ikram Alikhil's 58, Afghani-



stan's bowlers set to work.

Only Harry Brook with 66 showed any real defiance while spinners Mujeeb Ur Rahman and Rashid Khan claimed three wickets each as England were dismissed for 215.

- 'Knock-on effect' -The result left both sides with a win and two losses each after three games of the 10-nation

tournament.
"This win is significant, certainly in the manner and by the margin as

well," added Trott.

"There's a lot of confidence that will hopefully come from this it'll

fidence that will hopefully come from this, it'll have a knock-on effect to all the other games, but not only in this World Cup, but for the future as well."

Trott knows all about World Cup shocks. In 2011, he was part of the England team humbled by Ireland in Bengaluru despite him scoring 92.

"That's the beauty of the World Cup, isn't it? That's what cricket's about, it pushes and pulls you so much emotionally as a player and as a coach.

"But we can compete with anybody in the world."

Next up for Afghanistan are New Zealand who have three wins from three games including seeing off England in the tourna-

ment opener.

New Zealand, runnersup at the last two World Cups, will be favourites. Trott, however,

Trott, however, believes that his players' exposure to the international game through Twenty20 franchise cricket has only served to bolster Afghanistan self-belief.

"I think the fact that a lot of our players have played with the English players in franchise cricket, they get to know the ins and outs of each player so there's that familiarity and also the confidence," he explained.

"Sometimes I think when you see big Test playing nations you sort of hold them in high regard. I think playing with players like that you see that they are human and you are just as entitled to win."

It was an emotional battle: Hubert Hurkacz holds nerve to win Shanghai Masters against Andrey Rublev

SHANGHAI, Oct 16 (Agencies): Hubert Hurkacz held his nerve in a dramatic tiebreak to defeat Andrey Rublev 6-3 3-6 7-6(8) in a thrilling final to win the Shanghai Masters, his second ATP Masters 1000 title.

Hurkacz served up 21 aces to Rublev's 13, but Rublev responded with some powerful shots and the final could have gone either way before the Pole came out on top in an enthralling final set tiebreak. "It was such a battle," Hurkacz said. "Especially emotionally. I had a match point and Andrey hit an amazing serve and then he had a match point and then I had some match points." Fifth seed Rublev came into the final without having dropped a set, but that quickly changed when Hurkacz broke the Russian's serve to go 4-2 up and finished off the opening set with an ace. Hurkacz has hit more aces than anyone on the ATP tour this season, and began in the same form in the first set, hitting seven aces to Rublev's two,

but the Russian roared back.
Rublev broke Hurkacz's serve early in the second set but it was in the final set where the match really came to life.
With Rublev serving at 5-4 down, and

the game at deuce, the Russian lost his temper.

A movement from a photographer when Rublev lost a point and Hurkacz now with advantage, saw the umpire reprimand the Russian for lashing out angrily. Rublev steadied himself to save match point and hold serve, and in the tiebreak, he snatched early control to take a 3-0 lead. Two aces from the Polish player kept him in touch and at 5-6 down he served another ace to save match point. "It was back and forth and such a tricky match. Andrey was playing some great shots. I was trying to respond," Hurkacz said.

Both players broke serve again in quick succession to level the tiebreak at 8-8, but it was Hurkacz who had the last word and broke Rublev's serve again to win the title. "It was one of those matches and I kept believing and I am super happy with how I managed at the end," Hurkacz said.

"It is such a big tournament and so much tradition. It is a huge event and I am really happy now." Hurkacz, who won the Miami Open in 2021, will now move up to 11th in the ATP world rank-


