on Sunday, police said. A police official told Greater Kashmir that a cab carrying gen passengers met with an accident in Bandi Chichian area, leaving 10 passengers injured. He said the vehicle bearing registration number JK02W 7601 was on to Islama Abad area from Poonch when the mishap took

place. The injured, he said, have been taken to the Poonch District Hospital for treatment.

Pneumococcal vaccine reduces pneumonia deaths: DAK on world pneumonia day

SRINAGAR, Nov 12: On world pneumonia day, Doctors Association Kashmir (DAK) on Sunday said pneumococcal vaccine reduces risk of dying from pneumonia.

"Pneumococcal vaccine prevents pneumonia deaths," said influenza expert and DAK President Dr Nisar ul Hassan.

Quoting a study, Dr Hassan said pneumococcal vaccine was found to reduce the risk of death from pneumonia by 59% among elderly people.

"The study also revealed that vaccine reduces the risk of getting pneumonia by 45%," he said.

"The benefits of pneumococcal vaccine are impressive in children too. The vaccine has been found to decrease the mortality among young children by up to 30%, DAK President quoted another study.

He said pneumonia is one of the leading causes of death. It is especially fatal in elderly, young children and those with underlying chronic medical conditions such as diabetes, heart, lung, liver and kidney disease.

"The most frequent cause of pneumonia in children and elderly is pneumococcus, a bacterial infection which is primarily transmitted

Gulmarg draws record 14 lakh tourists, including 9,000 foreign visitors

(Agencies): The worldrenowned ski resort of Gulmarg has emerged as the top choice for tourists, attracting nearly 14 lakh visitors in the first ten months of the year, including 9,000 foreigners and around four lakh local tourists.

Situated in the Pir Panjal range of the Western Himalayas at an altitude of 8,690 feet, Gulmarg, meaning 'Meadow of Flowers' in Kashmiri, is surrounded by snow-capped alps, lush green pastures, vibrant meadows, deep valleys, and pine-covered slopes.

The main draw for visitors is the Gulmarg Gondola, Asia's largest and highest cable car project, ranking as the



world's second-largest and second-highest. According to the Direc-

torate of Tourism, there has been a notable increase in tourist footfall from January to October, totalling 1,380,273 visitors, including 993,456 domestic tourists, 377,921 locals, and 8,896 foreign guests.

Local residents express optimism, citing a fruitful tourism season with expectations of continued growth due to upcoming events and cultural programs. Tourists, lured by the prospect of witnessing snowfall, have been flocking to Gulmarg and its adjacent areas, such as Tangmarg, Boothapathri, Kongdori fresh snowfall has been experienced.

Sajad Ahmad, a Gulmarg resident, acknowledges the improved tourism flow and anticipates further growth. Local hoteliers express gratitude to the tourism department for effective promotion, noting a positive trend in tourist influx.

Tourism sector representatives welcome the resurgence in local business after nearly three years, with Gulmarg hoteliers reporting high occupancy rates. Lateef Ahmed, a local hotelier, expresses satisfaction with the current season, stating that all hotels are fully booked, marking a successful period after

J&K: Over 20,000 pashmina shawls, 9000 carpets issued GI Tags



SRINAGAR, Nov 12 (Agencies): Jammu and Kashmir administration has achieved a milestone by issuing Geographic Indication labels to over 20,000 Pashmina shawls and 9000 carpets so far.

Kashmir's Pashmina shawls and carpet got GI tags in the years 2021 and 2022, respectively, to fight counter-brand-

As per the data available with news agency KNO, till October, a total of 20,126 Pashmina Shawls have been issued GI labels. During the same period as many as 9,700 carpets have been also GI Tag labelled.

GI tagging is a recognition granted to products that have a specific geographical origin and possess qualities, reputation, or characteristics that are essentially attributable to that place of origin. This recognition not only adds value to the products but also protects the traditional

Uttarakhand: 36 labourers feared trapped as under-construction tunnel collapses in Uttarkashi

UTTARKASHI (Uttarakhand), Nov 12 (Agencies): At least 36 workers are feared to be trapped inside an under-construction tunnel that collapsed on the Yamunotri National Highway here in Uttarakhand's Uttarakashi district, officials said on Sunday.

According to Uttarkashi Superintendant of Police, Arpan Yaduvanshi, a portion of the underconstruction tunnel connecting Silkyara to Dandalgaon collapsed on Saturday night. A part of the tunnel broke about 200 meters ahead of the starting point on the Silk-



hal-Polgaon. Yaduvanshi said that

according to the officials of Hyderoelecticity Investment and

Development Company Limited (HIDCL), which is looking after the construction work of the tunnel, about 36 people are trapped in the tunnel and efforts are being made to rescue them safely.

"Efforts are on to open the tunnel and the process of removing debris inside the tunnel is in progress," they said.

A team from the State Disaster Response Team (SDRF) and police revenue have relief and rescue operation. District Magistrate and Superintendents of





7-year jail 'high' for offence of causing death by negligence, says parliamentary panel

NEW DELHI, Nov 12 (Agencies): A parliamentary committee has noted that the seven years' imprisonment prescribed in the proposed new criminal law for causing death by negligence is "high" and it should be reduced to five years.

The Parliamentary Standing Committee on Home Affairs, headed by BJP MP Brijlal, also observed that the 10-year jail suggested in the Bharatiya Nyaya Sanhita (BNS) for those who cause death of a person by rash or negligent act and escape from the scene of the incident or fail to report the incident to police or a magistrate, needed to further be deliberated for whether the clause should be retained at all.

"The committee feels that the punishment provided under clause 104(1) is high as compared to the provision for the same offence under section 304A of IPC. The committee, therefore, recommends that the proposed punishment under clause 104(1) may be reduced from seven years to five years," the panel noted. According to the Section 104 (1) of the BNS, whoever causes the death of any person by any rash or negligent act, not amounting to culpable homicide, shall be punished with imprisonment of either description for a term that may extend up to

seven years, and shall

also be liable to a fine.

For the same offence. the Indian Penal Code (304A) says: whoever causes the death of any person by doing any rash or negligent act not amounting to culpable homicide, shall be punished with imprisonment of either description for a term which may extend to two years, or

with fine, or with both. The committee is of the view that the clause 104(2) of the BNS may be against the Article 20(3) of the Constitution of India which says "No person accused of an offence shall be compelled to be a witness against himself."

According to the clause 104(2) of the BNS, whoever causes the death of any person by any rash or negligent act, not amounting to culpable homicide, and escapes from the scene of the incident or fails to report the incident to a police officer or magistrate soon after the incident, shall be punished with imprisonment of either description of a term which may extend up to 10 years, and shall

also be liable to fine. The committee observed that the Supreme Court has widened the scope of the immunity given by the Article 20(3) of the Constitution of India by interpreting the word "witness" to include oral as well as documentary evidence so that no person can be compelled to be a witness to support a prosecution against himself.

"Hence, further contemplation is required, if the government still seeks to retain this new provision," the committee noted.

The committee also recommended that if this provision has to be retained, the government should limit the application of clause 104(2) of the BNS to motor vehicle accidents

In addition to that, the expression "or fails" should be replaced with "and fails" to provide for easier prosecution and less harsh punishment to a perpetrator who fulfils either of the duties mentioned in clause 104(2) of the BNS and the time period within which the perpetrator has to report the inci-

dent should be defined. "In view of the above, the committee recommends re-drafting this clause in consultation with the Ministry of Law and Justice," it said.

The proposed laws are Bharatiya Nyaya Sanhita (BNS-2023), Bharatiya Nagarik Suraksha Sanhita (BNSS-2023) and the Bharatiya Sakshya Adhiniyam (BSA-2023.

The three bills, which were introduced in the Lok Sabha on August 11, will replace the Indian Penal Code, 1860, Criminal Procedure Act, 1898, and the Indian Evidence Act, 1872.

The report of the parliamentary committee was submitted to Rajya Sabha on Friday.

Dal Lake Fire: Condolences Expressed for Loss of Lives

SRINAGAR, Nov 12 (Agencies): The Lieutenant Governor, Manoj Sinha, expressed deep sorrow for the loss of lives in a tragic fire incident at Dal Lake, Srinagar. "I am profoundly saddened by the loss of lives in the unfortunate fire incident at Dal Lake, Srinagar."

In a harrowing incident, a massive fire erupted during the wee hours on Saturday along Ghat No 09 in the Dal Lake area. wreaking havoc on the serene houseboats. The flames voraciously engulfed five iconic houseboats Safeena, Sabreena, Young Gulshan, Lala Rukh, and Khar Palace. The fire extended its destructive reach, reducing seven residential huts and neighbouring houses to

Regrettably, the devastating blaze claimed the lives of three tourists from Bangladesh — Anindaya Kowshal, Das Gupta, and Mohammad Moinud —who were residing in houseboat Safeena

LG Sinha expressed heartfelt condolences to the bereaved families. "I have directed the District Administration to provide all necessary assistance to the affected persons," the Lt Governor said, in a statement."

Meanwhile, the Jammu and Kashmir National Conference Chief Spokesperson and In Charge Zadibal Tanvir Sadiq today expressed profound anguish over the death of three Bangladeshi tourists and complete damage to several houseboats in a massive overnight blaze in Dal Lake. In a statement issued

to press, Tanvir said, "My heart goes out to the family members of the three Bangladeshi Nationals who lost their lives in the tragic incident. I pray that the bereaved families find strength to bear this colossal loss," adding, "The news of the massive fire incident that has turned seven houseboats into ashes has saddened me. The

plight of the house boat owners, who make their humble living by letting out the houseboats for tourists is incomprehensible. I hope that the administration would do utmost help to the affected houseboat owners to assist them pull through the unfortunate event."

Sadig further said that fire victims have borne losses worth crores that need to be adequately compensated by the administration in order to help them out.

"The district administration must dispatch its teams on ground zero to assess the losses incurred so that exgratia relief is disbursed to these families on a prompt basis. Besides paying an adequate compensation the concerned authorities should provide necessary clearance certificates to these fire victim families in order to repair their damaged houseboats without any impediments," he added.

Kashmir Chamber of Commerce & Industry (Inc) expressed grief and sorrow about the fire incident in Dal Lake that occurred On Saturday in the wee hours.

In a statement issued by President KCC&I, Javid Ahmad Tenga urged Lieutenant Governor, Manoj Sinha to extend necessary moral and monetary /compensation to the victims of the fire incident and help them rehabilitate on war footing basis.

"While the Kashmir Chamber of Commerce & Industry stand with the affected families in this hour of their grief, it has impressed upon the Government of Jammu & Kashmir to issue quick permission for reconstruction of these gutted houseboats and supply the required quantity of timber-suitable class at the earliest," reads the statement.

The Deputy Commissioner accompanied by Additional Deputy Commissioner Srinagar, Sved Ahmad Kataria. Tehsildar Khanyar, Aaliya Tabasum and other senior Officers of

District Administration visited the incident site and took spot review of post fire incident situa-

Interacting with the fire affected, the DC expressed support and sympathy with them on behalf of the District Administration Srinagar. He also assured that

every kind of possible support shall be provided from the District Administration for their immediate rehabilitation.

The DC also directed the concerned authorities to assess the losses and make a comprehensive report regarding the losses in the incident. Moreover, the District Administration Srinagar provided immediate assistance to the affected 8 families in the form of 80 blankets, 40 mattresses, 40-bed sheets and 8 kitchen sets, besides Rs 160000 to all 8 affected families each Rs 19000 as an interim relief.

Why the whole world needs to keep the AI genie bottled

umans have faced existential threats before **L**during the 300,000 years they have been around. Self-inflicted harm exceeds damage from natural calamities. Science has grown our understanding of how human progress itself seeds new existential threats. And yet, humans have proliferated and benefited from each scientific iteration that outsourced work to machines. Is Artificial Intelligence (AI) different, and if so, how much time do we have left?

Elon Musk is being quite honest when he warns that AI would eventually eat all human jobs, rendering us redundant, although a mite optimistic when claiming that universal, abundant wealth -- well beyond what Karl Marx and succeeding fellow romantics dreamed of -- could be ours.

He recognises a problem. How to retain a sense of purpose and self-worth in a life of leisure -- a conundrum familiar to the progeny of billionaires.

Humans are actually quite good at wasting time, as evidenced by America's \$600 billion sports industry, including the Olympics Games, where puny humans compete at jumping higher, running faster, throwing javelins further and wrestling each other, whilst machines and missiles outperform humans on the ground, in the air and in the water. Expect more of the same futile struggles for vanity trophies in the age of plenty.

The time horizon of the AI tipping point is uncertain. Given our experience with climate change, we are likely to wake up to reality too late. After all, a significant segment of the rich world still believes that climate change does not exist and even more believe that we are likely

to make the transition safely. Humans tend to be optimistic about the distant future but anxious about immediate outcomes -- like will my doctor see me on time -- and they are happy to be proven wrong when they survive despite the darkest predictions.

The median estimate at a 2015 conference of AI experts in Puerto Rico pegged 2045, with others assessing centuries, as the likely year by when generalised AI -- capable of acting autonomously of human management and therefore, potentially, harmful rather than beneficial for humanity -- could exist. This is about five decades earlier than the expected climate apocalypse in 2100 and serves to highlight the need for early, concerted global action.

The AI Safety Summit at Bletchlev Park, 80 km north of London, billed as the world's first, was organized by the UK recently. Another will follow, co-hosted by South Korea, about six months later, with France hosting the 2024 summit. It projects the UK as a nimble, pragmatic, technological lynchpin between the rumbustious free markets of the United States, the innovation unfriendly, rules-bound constraints of the European Union and the heavy hand of the State in China. To be sure, the UK has what it takes to walk the middle path independently and survive. According to a UK governmentsponsored AI sector study published in 2023, it has 3,170 active AI companies, of which 60 per cent are dedicated AI businesses. London, the southeast and the

east of England account for 75 per cent of registered AI office addresses. Elon Musk, prodded at the meeting by Prime Minister Rishi Sunak, said that the Bay Area in California and Greater London are the global drivers of innovation. Regional clusters

in the UK specialise in automotive, industrial automation and machinery; energy, utilities, and renewables; health, well-being and medical practice, and agricultural technology. Annual revenues are GBP 10.6 billion with 50,040 full time equivalent jobs. The contribution of AI to the national gross value (GVA) added is 1.3 per cent, or GBP 3.7 billion. Larger companies contribute more to GVA than smaller ones, illustrating the capital intensive, high R&D nature of deep technology.

The UK announced that it would establish the world's first AI Safety Institute to complement international efforts including at G-7, OECD, Council of Europe, United Nations and the Global Partnership on AI. The US has similarly decided on establishing an AI Safety Institute.

Clones are likely to proliferate. Twenty-eight nations, including the US, EU, China, India, Japan, Australia, Brazil, Germany, France, Israel, Ireland, Kenya, Saudi Arabia, Nigeria and the United Arab Emirates participated and endorsed the Bletchley Declaration.

The contents of the declaration are anodyne and designed to promote consensus. Motherhood and apple pie statements dominate. Savour this extract: "We welcome... the recognition that protection of human rights, transparency and explainability, fairness, accountability, regulation, safety, appropriate human oversight, ethics, bias mitigation, privacy and data protection needs to be addressed". This strategy to globalise the concerns around AI safety appears to replicate the non-binding nature of recent international agreements like the climate template. The risk here is that the longer the list of unfunded "concerns", the more difficult it becomes to arrive at a workable, efficient, meaningful agreement.

Consider the Bletchley resolve to build "risk-based policies across our countries to ensure safety in light of such (AI related) risks, collaborating as appropriate, while recognising our approaches may differ, based on national circumstances and applicable legal frameworks".

The "One Problem Many Solutions" template can become a cop out, which pursues a formal "agreement" doggedly on generalities, without any bite, somewhat like the climate action agreement.

China was invited to attend, and it did. That can only have good consequences. Excluding the second largest economy would have diminished the summit. But the fact that Rishi Sunak publicly sought and got Elon Musk's endorsement of this outreach shows the extent of our splintered geopolitics and the demise of global collaboration. Possibly, a proxy yes vote from the US tech industry was the best possible olive branch whilst the pre-US elections standoff with China continues.

Consider another rhetorical resolve to identify "AI safety risks of shared concern, building a shared scientific and evidencebased understanding of these risks". In a world, adrift with a war in the heart of Europe and another in West Asia, both partly to shore up the political interests of the concerned governments, and selective trade restrictions proliferating, a shared world view and common aspirations must precede meaningful scientific collaboration amongst the major AI capable countries We are far from there yet, and therein lies the real threat to humanity.

Amidst this dark reality, is the fact that myths surround AI and should be debunked. Robots are not killer machines unless they are programmed to be thus, like heatsensing missiles. The mess in Gaza: Will Israel's war create many more groups like Hamas?

Study finds 187 new genetic variants linked to prostate cancer



NEW YORK, Nov 12 (Agencies): Researchers have identified 187 new genetic variants linked to prostate cancer that can help predict who would or wouldn't develop the condition.

The team led by researchers at Keck School of Medicine of University of Southern California also found 150 genetic variants from earlier research that were replaced by variants in nearby spots on the DNA double helix that better correlated with prostate cancer risk through the lens of the larger, more diverse

sample. "It's an important refinement to find markers that are better at capturing risk across populations," said Haiman, who is also director of the USC Center for Genetic Epidemiology

"The idea of precision medicine and global medicine for all rely on including and integrating information across populations, because the best marker determined in whites might not be the best marker overall.

The variants, derived from genomic information from close to 9,50,000 men, can help even distinguish between the likelihood of aggressive and less serious cases

In the study, published in the journal Nature Genetics, the researchers compared genomic data from 156,319 prostate cancer patients with that of a control group totaling 788,443.

From the previous study, there was an 87

per cent increase in the number of prostate cancer cases included from men of African ancestry, 45 per cent from Latino ethnicity, 43 per cent from European ancestry and 26 per cent from Asian ancestry. Because many pros-

tate cancer cases diagnosed today might never reach the point where they are life-threatening -- leading to unnecessary treatment that can degrade quality of life -differentiating between risk for aggressive disease is key.

Up until now, the scientists' system for calculating risk scores has correlated with likelihood of developing prostate cancer, but lacked predictive value about how serious a given case may be.

"We'll continue to improve this risk score, and look for markers that help to distinguish aggressive from less aggressive disease," Haiman said.

"Clinical trials will be required to evaluate the effectiveness of the risk score in helping doctors and patients make decisions about screening."

Fluctuating BP a warning sign for dementia, heart disease: Study

SYDNEY, Nov 12 (Agencies): Fluctuating blood pressure can increase the risk of dementia and vascular problems in older people, a new study by Australian researchers has warned.

Short blood pressure (BP) fluctuations within 24 hours as well as over several days or weeks are linked with impaired cognition, according to University of South Australia (UniSA) researchers who led the study.

Higher systolic BP variations (the top number that measures the pressure in arteries when a heart beats) are also linked with stiffening of the arteries, associated with heart disease.

It is well known that high blood pressure is a risk factor for dementia, but little attention is paid to fluctuating blood

"Clinical treatments focus on hypertension, while ignoring the variability of blood pressure," lead author Daria Gutteridge said in the paper published in the journal Cerebral Circulation -

Cognition and Behaviour. '

Blood pressure can fluctuate across different time frames – short and long - and this appears to heighten the risk of dementia and blood vessel health," Gutteridge added.

To help explore the mechanisms that link BP fluctuations with dementia, the researchers recruited 70 healthy older adults aged 60-80 years, with no signs of dementia or cognitive impairment.

Their blood pressure was monitored, they completed a cognitive test, and their arterial stiffness in the brain and arteries was measured using transcranial doppler sonography and pulse wave analysis.

"We found that higher blood pressure variability within a day, as well as across days, was linked with reduced cognitive performance. We also found that higher blood pressure variations within the systolic BP were linked with higher blood vessel stiffness in the arteries," the authors wrote.

Malaria: How it turns fatal if left undiagnosed

CHENNAI, Nov 12 (Agencies): Malaria is a disease transmitted by the bite of mosquitoes that are infected by a plasmodium parasite. The intensity of the disease depends on the species of Plasmodium. The symptoms include rigour, fever and sweating, usually a few weeks after being bitten.

"The main symptom of malaria is fever with rigour. The fever is not continuous, but rather episodic. For example, the patient may have a fever for 30 minutes and won't have a fever for the rest of the day. The next episode may be within 24-48 hours. The gap between fever episodes depends on the species of the parasite." said Dr Shameer VK, assistant professor, of general medicine, at Government Medical College, Kozhikode.

Unlike seasonal flu, in which the patient experiences respiratory-related symptoms like sore throat, running nose and cough, in malaria such



symptoms are absent. "Dengue and chikungunya are similar to malaria, but the body pain is more specific. Joint pain is classical in chikungunya fever, while dengue fever is accompanied by headache and body pain. Except for the fever pattern, the symptoms are similar to dengue and malaria. Rashes on the skin are also a sign of dengue," he added. Getting treated early

will prevent any complications, but delaying it can cause severe complications like renal failure and even turn fatal. "One such complication is cerebal malaria which affects the brain. The symptoms will also

include seizures and altered behaviour. It is a life-threatening condition. Another danger is renal failure," meer said.

Malaria can also result in a drop in red blood cells (RBC) for an adequate supply of oxygen to your body's tissues. "This parasite grows inside RBC and destroys it. If too much RBC is destroyed, it will lead to a drop in platelet count and result in anaemia, jaundice and black water fever," he added.

The presence of the parasite can be examined through blood tests. "The most conventional method used is peripheral smear test. A small drop of blood is dropped on a glass slide to create a smear and it is examined under a microscope to check for the presence of the parasite. Only trained eyes can identify it and therefore sometimes small labs may not have the expertise for it." Dr Shameer

The disease is treated with anti-malarial drugs and based on the parasite you are infected with, the severity of the symptoms and other factors like age and whether you are preg-

Doctors have advised people to take preventive measures while travelling to or those living in areas endemic to malaria. Precautions include covering the skin to prevent mosquito bites, sleeping under a net, applying insect repellent and taking pre-

ventive medicine. Box: Transmission cvcle

Malaria spreads when a mosquito gets infected with the disease after biting an infected

person, and the infected mosquito then bites a non-infected person. The malaria parasites enter that person's bloodstream and travel to the liver. When the parasites mature, they leave the liver and infect red blood cells.

Infection: A mosquito becomes infected by feeding on a person who has malaria

Parasite transmission: An infected mosquito transmits malaria parasites to another person Liver: Once the para-

sites enter the body, they travel to the liver where some types can lie dormant for as long as a year. RBC attack: When

the parasites mature, they leave the liver and infect the red blood cells (RBC). This is when people develop malaria symptoms.

Medicine to reduce obesity approved NEW DELHI, Nov 12 (Agencies): The

US Food and Drug Administration has approved a new medication for weight loss called Zepbound (tirzepatide), which has been developed by pharmaceutical company Eli Lilly.

This injection will be used for the treatment of chronic weight management in adults grappling with obesity or showing at least one weight-related condition, such as high blood pressure, type 2 diabetes, or elevated cholesterol

"Obesity and overweight pose significant health risks, including associations with leading causes of mortality such as heart disease, stroke, and diabetes," said Dr John Sharretts, Director of the Division of Diabetes, Lipid Disorders, and Obesity at the FDA's Center for Drug Evaluation and Research, in a statement.

Tirzepatide, the active component in Zepbound, is already sanctioned under the trade name Mounjaro for enhancing blood sugar control in adults with type 2 diabetes mellitus when used alongside diet and exercise.

It is expected that this medication will be available in the United States within

Zepbound comes with a high list price of \$1,059.87 per month, which may limit the number of people who can receive it since insurance companies often do not cover weight loss medications, accord-

ing to the news agency. Medicare, the state subsidised insurance for the elderly, is barred from cov-

Zepbound operates by activating receptors for hormones secreted from the intestine, namely glucagon-like peptide-1 (GLP-1) and glucose-dependent insulinotropic polypeptide (GIP), which results in appetite and food intake reduction.

The efficacy of Zepbound for chronic weight management was validated through two randomised, double-blind, placebo-controlled trials involving adults with obesity or overweight and at least one weight-related condition.

In these trials, participants receiving Zepbound at all three dose levels experienced statistically significant reductions in body weight compared to those receiving a placebo, with a greater proportion achieving at least a 5% weight

One of the trials, which included adults without diabetes, demonstrated that those receiving the highest approved dosage of Zepbound (15 mg once weekly) experienced an average 18% reduction in body weight compared to the placebo group.

In the trial involving adults with type 2 diabetes, those receiving the highest approved dosage of Zepbound also saw a statistically significant average 12% reduction in body weight compared to the placebo group.

Zepbound, however, has potential side effects, including nausea, diarrhoea, vomiting, constipation, abdominal discomfort, pain, injection site reactions, fatigue, hypersensitivity reactions, burping, hair loss, and gastroesophageal reflux disease.



The accident took place around 12.30 am when the SUV carrying the four people rammed into a heavy-duty truck from behind near Hindoli town, Circle Inspector at Hindoli police station Manoj Sikarwal said.

The SUV was probably speeding and it seems that the truck ahead applied its brakes all of a sudden, causing the vehicle to ram into it, he said.

Three people died on the spot and the woman succumbed to injuries during treatment at a hospital on Sunday morning, the official

The truck driver fled the spot leaving his vehicle behind, Sikarwal said, adding that efforts were underway to nab

The bodies are at a mortuary and postmortem examinations will be conducted later in the day after their family members arrive, police said.

Delhi's air quality remains in 'poor' category despite rain

NEW DELHI, Nov 12 (Agencies): The Air Quality Index (AQI) was recorded in 'poor' category in the National Capital on Sunday morning.

Air quality across Delhi continues to be in the 'poor' category, the Central Pollution Control Board (CPCB) said.

As per the CPCB data, AQI in Anand Vihar was at 266, while at RK Puram it was recorded at 241 on Sunday morning at 07.00 am. Similarly, in Punjabi Bagh area it was at 233, and in ITO area it was recorded at 227.

Vehicles entering the National Capital are being checked by officials amid the pollution-related GRAP-4 regulations.

There was a slight improvement in Delhi's air quality on Saturday following rain on Friday. The air quality, which was previously categorised as 'very poor' by the Central Pollution Control Board (CPCB), improved to the 'poor' category.



However, despite rain offering a slight respite, Delhi's air quality continued to be a matter of concern for residents

A local resident and morning walker at Kartavya Path noted, "After the rain, pollution has slightly decreased but the bad air quality condition persists. We are still facing problems in breathing."

Delhi Environment Minister Gopal Rai had on Friday announced that the state government would delay the proposed implementation of the odd-even car-rationing scheme

There was also a dip in the levels of pollutants PM 2.5 and PM10 after 4 am across the National Capital and surrounding areas.

For the next two days post-Diwali on Sunday, the weather department has forecast a partly

cloudy sky with mist or shallow fog in the mornings and thereafter, for the subsequent two days, it has forecast a mainly clear sky with shallow fog in the mornings.

The Delhi Government is making efforts to execute antipollution measures, and it is also considering the idea of 'artificial rain' to curtail the pollution issue. Several ministers of the Aam Admi Party were also seen on the ground on Thursday night inspecting the execution of antipollution initiatives.

Currently, Stage-IV of the Graded Response Action Plan (GRAP) has been implemented in the National Capital.

The Supreme Court on Tuesday expressed grave concern over the hazardous air quality in the national capital and directed that farmers should stop stubble burning forthwith in Punjab, Haryana, and western Uttar Pradesh, saying it was one of the major contributors to air pollution.

Four of a family stabbed to death in Karnataka's Udupi, probe underway



MANGALURU, Nov 12 (Agencies): In a tragic incident, four members of a family were stabbed to death by an unidentified assailant at Kemmannu in Udupi district on Sunday morning,

police said. The deceased are Hasina (48) her children Afsan (23), Aseem (14), and Aynaz (20). Haseena's mother-in-law

suffered serious stab injuries and was admitted to the hospital.

Superintendent of Police Dr K Arun said that four were murdered by stabbing. An investigation is in progress to ascertain the cause of the murders. No valuables have been stolen from the house. The investigation will be carried out from all angles.

Sources said the victim's husband is working in the Gulf. Further investigations are underway in the case.

'Rs 25 lakh cause of dispute': Sisters die by suicide at Brahma Kumaris Ashram in Uttar Pradesh's Jagner

AGRA, Nov 12 (Agencies): Three people were arrested in connection with the suicide of two sisters, both inmates of Brahma Kumaris Ashram in Jagner, police said on Sunday.

The sisters, Ekta Singhal, 38, and Shikha Singhal, 34, allegedly killed themselves Friday night at the ashram and left behind a note naming four people responsible for their action, they said.

Besides the note, police also recovered their mobile phones from the ashram.

An FIR was filed in the matter under section 306 of Indian Penal Code at Jagner Police

Station in Agra district. "On Friday night, police got information about the suicide of two sisters associated with the Brahma Kumaris



Ashram," Assistant Commissioner of Police, Kheragarh, Mahesh Kumar, said

Kumar said both sisters had been living in the ashram for the past several years.

In the suicide note, the sisters accused Neerai. Tara Chand, Guddan, and Poonam of driving them to suicide, he said.

"Neeraj Singhal is a cousin of the sisters and Tara Chand is their uncle. Poonam is a member of the ashram. Guddan too is a relative of the Singhals," Kumar said.

According to the ACP, the accused together had set up the ashram in Jagner.

Later Poonam and Neeraj moved to its Gwalior centre.

"As per the suicide note, an amount of Rs 25 lakh was the cause of the dispute," Kumar

Jagner Police Station SHO Avneet Man said Tara Chand, Guddan, and Poonam have been arrested and a hunt is on for Neeraj Singhal.

Main accused in Mathura murder and robbery case killed in encounter with police

MATHURA, Nov 12 (Agencies): The main accused in the murder of a businessman's wife in Uttar Pradesh's Mathura during a robbery attempt, has been killed in an encounter with the police, officials said on Sunday.

According to the police, the accused, Farooq, who carried a bounty of Rs 50,000, was shot dead on Saturday night after he opened fire at the Special Operations Group (SOG).

Farooq and his accomplice, Mohsin, were accused of murdering an elderly woman, Kalpana Agarwal, in Mathura's Guru Kripa Colony on November 4. Her husband, Krishna Kumar Agarwal, a businessman, was injured in the incident when the accused robbed their home

A huge amount of money and jewellery was looted from the residence.

According to the police, Mohsin was the driver of the Agarwals. He had stolen a key to their house prior to the robbery. On the evening of November 3, he also secretly brought Farooq to the Agarwals' house, hiding him in the luggage compartment while dropping the businessman home.

When they reached home, Mohsin handed over the key to Farooq, who



used it to enter the house late at night. During the robbery, he attacked the elderly couple and the woman succumbed to her injuries. After the crime, Farooq fled the area with the same car.

Police officials identified the accused with the help of CCTV cameras and technical surveillance, and Mohsin was arrested a few days ago. The encounter happened when the officials tried to catch Farooq, who was shot in retali-

Officials also recovered Rs 21.8 lakh in cash, diamonds, gold jewellery and a Toyota Innova Krista car that was looted, along with weapons and cartridges.

Major fire broke out in an apartment building in Haryana's Sonipat, 15 persons rescued

CHANDIGARH, Nov 12 (Agencies): Fifteen people were rescued after a fire broke out on the seventh floor of a 14-floor residential apartment building in Haryana's Sonipat, police said on Sunday.

"Fifteen people were rescued. All are safe," SHO, Bahalgarh, Sonipat, Inspector Devender said over the phone.

The fire brigade team swiftly arrived at the scene and safely evacuated the residents. Upon receiving the information, a team of three fire tenders rushed to the location to douse the fire.

Atul Garg, a senior officer with the fire department, said, "Yesterday, a call was received from Sonipat reporting a fire in a high-rise building and requesting a skylift to rescue those trapped on the upper floor."

The fire was successfully brought under control through the joint efforts of the Sonipat Fire Department and the Delhi Fire Department.

Israel-Hamas conflict: Israel offers to evacuate babies from main Gaza hospital amid fierce fighting

Two babies died in intensive care, say Palestinian officials; WHO loses contact with Al Shifa hospital

GAZA/JERUSALEM, Nov 12 (Agencies): Israel's military said it was ready to evacuate babies from Gaza's largest hospital on Sunday, where Palestinian officials said two newborns died and dozens more were at risk after fuel ran out amid intense fighting in the

As the humanitarian situation worsened, Gaza's border authority said the Rafah crossing into Egypt would reopen on Sunday for foreign passport holders after closing on Friday.

Hamas said it had completely or partially destroyed more than 160 Israeli military targets in Gaza, including more than 25 vehicles in the past 48 hours. An Israeli military spokesperson said Hamas had lost control of northern Gaza.

At a news conference late on Saturday, Israeli Prime Minister Benjamin Netanyahu announced the deaths of five more Israeli soldiers in Gaza. The Israeli military said 46 had been killed since its ground operations there began.

Israel said rockets were still being fired from Gaza into southern Israel, where it has said about 1,200 people were killed and more than 200 taken hostage by Hamas last month.

Palestinian officials said on Friday that 11,078 Gaza residents had been killed in air and artillery strikes since October 7, around 40% of them children. REPORTS OF POSSIBLE HOSTAGE DEAL

Israel's three major TV news channels, without citing named sources, said there was some progress toward a deal to free hostages held by Hamas in

Netanyahu said he would not discuss details of any possible deal, which according to N12 News would involve 50 to 100 women, children and elderly being released in stages during a three to five day pause in fight-

According to the reports,



Israel would release women and minor Palestinian prisoners and consider letting fuel in to Gaza, while reserving the right to resume fighting.

In Tel Aviv, thousands joined a rally to support families of the hostages.

Gaza residents said Israeli troops, who went to war to eliminate Hamas after its deadly cross-border assault on Oct. 7, had been clashing with Hamas gunmen all night in and around Gaza City where the Al Shifa hospital, Gaza's largest, is located.

Ashraf Al-Qidra, who represents the health ministry in Hamas-controlled Gaza, said the hospital suspended operations after fuel ran out. He said two babies had died in an incubator as a result. He said there

were 45 babies in total. He said Israeli shelling killed a patient in intensive care and that Israeli snipers on rooftops fired into the medical complex from time to time, limiting people's ability to move.

The World Health Organisation expressed "grave concern" for the safety of everyone trapped in the hospital by the fighting and said it had lost communications with its contacts there. ISRAEL SAYS IT WILL HELP

EVACUATE BABIES Israel's chief military spokesperson, Rear Admiral Daniel Hagari, said the Israeli military would help evacuate babies from the hospital, at the request of the staff at Al Shifa.

Muhammad Abu Salmiya, the hospital's director, told Al Jazeera TV, that protecting patients was the priority.

"We contacted the Red Cross and informed them we ran out of water, oxygen, fuel, and everything," Abu Salmiya said.

"The premature babies, patients of the intensive care, and even wounded people couldn't survive with the lack of electricity... If the occupation forces want to evacuate the wounded people to any place in the world that is safer than the Gaza Strip, we are not against that."

Israel has said doctors, patients and thousands of evacuees who have taken refuge at hospitals in northern Gaza must leave so it can tackle Hamas gunmen who it says have placed command centres under and around them.

Hamas denies using hospitals this way. Medical staff say patients could die if they are moved and Palestinian officials say Israeli fire makes it dangerous for others to leave.

Israeli Agriculture Minister Avi Dichter called the evacuations "Gaza's Nakba" - a reference to mass dispossessions of Palestinians after Israel was founded

"Operationally there's no way to conduct a war the way the

IDF (Israel Defense Forces) wants to conduct it inside Gaza territories," Dichter said. "I don't know how it will end." 'TOTALLY A WAR ZONE'

Ahmed al-Mokhallalati, a senior plastic surgeon at Al Shifa, told Reuters there had been continuous bombardment for more than 24 hours. He said most hospital staff and people sheltering there had left, but 500 patients remained.

"It's totally a war zone. It's a totally scary atmosphere here in the hospital," he said.

The military wing of Hamas ally Islamic Jihad, the Al-Quds Brigades, said it was "engaged in violent clashes in the vicinity of Al Shifa Medical Complex. Al Nasr neighbourhood, and Al Shati camp in Gaza."

Al Nasr is home to several major hospitals.

Israel said earlier it had killed what it called a Hamas "terrorist" who it said had prevented the evacuation of another hospital in the north, which Palestinian officials have said is out of service and surrounded by tanks.

It said Ahmed Siam was killed along with other militants while hiding in the Al Burag school. Palestinian officials told Reuters on Friday at least 25 Palestinians had been killed in an Israeli strike at the school, which was packed with evacuees.

In London, at least 300,000 pro-Palestinian demonstrators marched and police arrested over 120 people as they sought to stop far-right counter-protesters ambushing the rally. Over 20,000 people joined a pro-Palestinian rally in Brussels.

Meeting in Saudi Arabia, Muslim and Arab countries called for an immediate end to military operations in Gaza, rejecting Israel's justification of self-defence. A communique issued at the summit urged the International Criminal Court to investigate "war crimes and crimes against humanity that Israel is committing."

Texas police officer, suspect killed in shooting; two other people found dead

Multiple officers opened fire, and the shooting will be investigated by both the Austin Police Department's internal affairs division and special investigation unit

TEXAS, Nov 12 (Agencies): A Texas police officer was killed Saturday in a shooting that left the shooter dead and a second officer wounded, authorities said.

Two other people were later found dead inside a home in Austin, according to interim Police Chief Robin Henderson.

An emotional Henderson, who paused often during a news conference and appeared to be choking back tears, said officers were called to the home shortly before 3 am Saturday by a woman screaming that

she was being stabbed. One person escaped the home before officers arrived, Henderson said, and told police the man in the home was

armed with a knife. Police then tried to enter the home and were met with gunfire, but did not return fire. retreated and called for a SWAT team, said Henderson, who did not take questions and was surrounded by about 10 other officers during her comments.

"SWAT officers arrived on scene and forced entry into the residence ... to rescue the victims," Henderson said. "As SWAT officers entered the suspect immediately fired his gun at the officers and the SWAT officers returned fire."

Two officers and the suspect were struck by the gunfire. The suspect was killed at the scene and the two officers were taken to a hospital, where one died and the second was in stable condition, Henderson

"Two apparent victims of the suspect were located inside of the residence with fatal injuries," Henderson said.

Multiple officers opened fire, and the shooting will be investigated by both the Austin Police Department's internal affairs division and the department's special investigation unit in conjunction with the Travis County District Attorney's Office, Henderson said. No names have been released.

"I'm praying for the


family of our fallen officer," Austin Mayor Kirk Watson said in a statement, and "for our officer who was shot and in surgery and his family."

"We rely on brave people who are in harm's way when they are serving us," Watson said. "This event jarringly brings home that truth." The Austin Police Retired Officers Association asked for prayers for both the slain and the wounded officer. "Our hearts are heavy this morning with the news of one of our brothers with APD having been shot and killed in the line of duty," the statement said on X, formerly known as Twitter.

Gov. Greg Abbott also issued a statement calling for prayers for the family of the slain officer, for the wounded officer and for the city's police department.

"This tragedy is a reminder of the great risks and selfless leadership our law enforcement officers exercise every day to serve and protect their communities," Abbott said.

PM Netanyahu rejects growing calls for cease-fire as Israel battles Hamas outside main Gaza hospital

DEIR AL-BALAH (GAZA STRIP), Nov 12 (Agencies): Prime Minister Benjamin Netanyahu pushed back against growing international calls for a cease-fire, saying Israel's battle to crush Gaza's ruling Hamas militants will continue with "full force."

A cease-fire would be possible only if all 239 hostages held by militants in Gaza are released, Netanyahu said in a televised address.

The Israeli leader also insisted that after the war, now entering its sixth week. Gaza would be demilitarised and Israel would retain security control there. Asked what he meant by security control, Netanyahu said Israeli forces must be able to enter Gaza freely to hunt down militants.

He also rejected the idea that the Palestinian Authority, which currently administers autonomous areas in the Israeli-occupied West Bank, would at some stage control Gaza. Both positions run counter to post-war scenarios floated by Israel's closest ally, the United States.

Secretary of State Antony Blinken has said the US opposes an Israeli reoccupation of Gaza and envisions a unified Palestinian government in both Gaza and the West Bank at some stage as a step toward Palestinian statehood.

For now, Netanyahu said, "the war against (Hamas) is advancing with full force, and it has one goal, to win. There is no alternative to victory."

Pressure was growing

on Israel after frantic doctors at Gaza's largest hospital said the last generator had run out of fuel, causing the death of a premature baby, another child in an incubator and four other patients. Thousands of war-wounded, medical staff and displaced civilians were caught in the fighting.

In recent days, fighting near Shifa and other hospitals in northern Gaza has intensified and supplies have run out. The Israeli military has alleged, without providing evidence, that Hamas has established command posts in and underneath hospitals, using civilians as human shields. Medical staff at Shifa have denied such claims and accused Israel of harming civilians with indiscriminate

Shifa hospital director Mohammed Abu Selmia said the facility lost power Saturday.

attacks.

"Medical devices stopped. Patients, especially those in intensive care, started to die," he said by phone, with gunfire and explosions in the background. He said Israeli troops were

"shooting at anyone outside or inside the hospital" and prevented movement between buildings.

The World Health Organisation later said it lost communication with its contacts at Shifa, according to a post on X, formerly known as Twitter.

Israel's military confirmed clashes outside the hospital, but Rear Adm. Daniel Hagari denied Shifa was under siege. He said troops will assist Sunday in moving babies treated there and said "we are speaking directly and regularly" with hospital staff.

Amos Yadlin, a former head of Israeli military intelligence, told broadcaster Channel 12 that as Israel aims to crush Hamas, taking control of the hospitals would be key but require "a lot of tactical creativity," without hurting patients, other civilians and Israeli hostages.

Six patients died at Shifa after the generator shut down, including the two children, spokesmen with the Hamasrun Health Ministry said.

The "unbearably desperate situation" at Shifa must stop now, the International Committee of the Red Cross director general, Robert Mardini, said on social media. UN humanitarian chief Martin Griffiths posted that "there can be no justification for acts of



war in health care facilities."

Elsewhere, the Palestinian Red Crescent said Israeli tanks were 20 metres from al-Quds hospital in Gaza City, causing "a state of extreme panic and fear" among the 14,000 displaced people sheltering there.

Israel's military released footage which it said showed tanks operating in Gaza. The images showed shattered buildings, some on fire, and destroyed streets empty of anyone but troops. A 57-nation gather-

ing of Muslim and Arab leaders in Saudi Arabia called in their communique for an end to the war in Gaza and the immediate delivery of humanitarian aid. They also called on the International Court of Justice, a UN organ, to open an investigation into Israel's attacks, saying the war "cannot be called selfdefence and cannot be justified under any means.'

Netanyahu has said the responsibility for any harm to civilians lies with Hamas, which denied it was preventing people in Gaza City from fleeing.

The spokesman of the Hamas military wing said militants were ambushing Israeli troops and vowed that Israel will face a long battle. The Qassam Brigades spokesman, who goes by Abu Obaida, acknowledged in audio aired on Al-Jazeera that the fight is disproportionate "but it is terrifying the strongest force in the region.

Israel's military has said soldiers have encountered hundreds of Hamas fighters in underground facilities, schools, mosques and clinics during the fighting. Israel has said a key goal of the war is to crush Hamas, which has

150 Bangladesh garment factories shut, 11,000 workers charged after clashes over minimum wage

Conditions are dire for many of the sector's four million workers, the vast majority of whom are women whose monthly pay, until recently, started at 8,300 taka (\$75 - Indian Rs 6300).

DHAKA, Nov 12 (Agencies): Bangladeshi garment manufacturers shuttered 150 factories "indefinitely", as police issued blanket charges for 11,000 workers in connection with violent protests demanding a higher minimum wage, officers said.

Bangladesh's 3,500 garment factories account for around 85 percent of its \$55 billion in annual exports, supplying many of the world's top brands including Levi's, Zara and H&M.

But conditions are dire for many of the sector's four million workers, the vast majority of whom are women whose monthly pay, until recently, started at 8,300 taka (\$75 -Indian Rs 6300).

Violent protests demanding better pay erupted last month, with at least three workers killed and more than 70 factories ransacked or damaged since, according to police.

A government-appointed panel raised the sector's wage by 56.25 percent to 12,500 taka, but garment workers have rejected the hike, instead demanding a 23,000 taka minimum wage.

15,000 workers clashed with police on a key highway and ransacked Tusuka, a top plant, along with a dozen other factories.

Moody's lowers US credit outlook, though keeps triple-A rating



WASHINGTON, Nov 12 (Agencies): The credit rating agency Moody's Investors Service lowered its outlook on the US government's debt to "negative" from "stable," citing the cost of rising interest rates and political polarization in Congress.

Moody's retained its

top triple-A credit rating on US government debt, though it is the last of the three major credit rating agencies to do so. Fitch Ratings lowered its rating to AA+ from AAA in August, and Standard & Poor's downgraded the US in 2011. A reduced outlook, however, raises the risk that Moody's could eventually strip its triple-A rating from the US as well.

A lower rating on US debt could cost taxpayers if it leads borrowers to demand higher interest rates on Treasury bills and notes. The yield on the 10-year Treasury has risen significantly since July, from about 3.9 per cent to 4.6 per cent Friday, an unusually sharp rise.

Some market analysts have said the August Fitch downgrade may have contributed to that increase, though most point to other factors as bigger drivers, such as the Federal Reserve's commitment to keeping its benchmark rate at a 22-year high to battle

inflation. "In the context of higher interest rates, without effective fiscal policy measures to reduce government spending or increase revenues, Moody's expects that the US's fiscal deficits will remain very large, significantly weakening debt affordability," the agency said in a state-

The Biden administration criticised Moody's decision.

"While the statement by Moody's maintains the United States' Aaa rating, we disagree with the shift to a negative outlook," Deputy Trea-

sury Secretary Wally Adeyemo said. "The American economy remains strong, and Treasury securities are the world's preeminent safe and liquid asset."

The federal government's budget deficit jumped to \$1.7 trillion in the budget year that ended September 30. up from \$1.38 trillion the previous year. Analysts have warned that with interest rates heading higher, interest costs on the national debt will eat up a rising share of tax revenue.

Separately, congressional lawmakers left Washington for the weekend without a plan to avoid a potential government shutdown that could occur by November 17. Moody's cited congressional dysfunction as one reason it lowered its outlook on US debt.

"Recently, multiple events have illustrated the depth of political divisions in the US: Renewed debt limit brinkmanship, the first ouster of a House Speaker in US history, prolonged inability of Congress to select a new House Speaker, and increased threats of another partial government shutdown," Moody's said.

'Telecom Dept doesn't make call threatening disconnection'

NEW DELHI, Nov 12 (Agencies): The Department of Telecommunications (DoT) clarified that it doesn't make calls to citizens threatening disconnection. In a press note, DoT, the nodal agency for formulating policies, programs, and regulatory frameworks for the telecommunications sector in India, also warned citizens that the DoT does not communicate disconnection warnings via phone calls.

Any such call should be treated as suspicious Lately, there has been surge in people getting calls claiming that



mobile numbers will be disconnected within two hours by the DoT. It also urged to people to exercise caution and not provide any personal information if they receive such calls.

"These calls are fraudulent attempts to deceive and potentially exploit individuals... Be aware that the DoT does not communicate

disconnection warnings via phone calls. Any such call should be treated as suspicious," said DoT in press note. It warned citizens not to share any personal information if you receive a call threatening disconnection. Also, the users need to verify the authenticity of such

calls with your service

India look to sustain momentum against Netherlands; Kohli has chance to get historic hundred

India have already qualified for the semifinals with eight victories in eight games

BENGALURU, Nov 12 (Agencies): The marauding Indians have not put a foot wrong in their authoritative run in the World Cup. It won't be a surprise if they go about plundering Netherlands in their final league game, where Virat Kohl would have a perfect opportunity to scale 'Mount 50' at his spiritual home.

India have already qualified for the semifinals while the eliminated Netherlands are on their way home, and this situation casts a perception of insignificance on their fixture.

But in reality, there are no academic-natured matches in a World Cup, where teams constantly try to better their best in the quest for ultimate glory.

India are no different as they look to maintain the momentum while ticking off a few team goals against the Netherlands, hence a large-scale change to the hosts playing 11 looks unlikely at this stage.

Since cricket is often a game of outcome and numbers, an approaching historic personal milestone gives this game an exciting undertone as well, which also carries importance from the team's perspective.

Kohli had equalled Sachin Tendulkar's record of 49 ODI hundreds against South Africa at Kolkata, and the wait now is on for his 50th ton.

Kohli may like to insulate himself from the outside noise and focus on the job at his hand – continue churning out runs but expectations have only grown that he gets the milestone hundred at his IPL home.

So far, he has amassed 543 runs, leading India's batting chart. This is also the first time Kohli is going past the 500-run



mark in the 50-over World Cup. He had made 282 runs in 2011, 305 in 2015, and 443 in 2019, while Tendulkar, Shikhar Dhawan, and Rohit Sharma played the lead roles with the bat in those editions.

Hence, Kohli will not want any slip up in India's last league game, using it as preparation ground to return to his sharp self ahead of the semifinals after a week-long gap following the

match against the Proteas.

From a team point of view, the management might just want to see some runs against Suryakumar Yadav's name. He has made 85 runs from four matches at an average of 21,25

at an average of 21.25.

He is the only missing individual piece in this Indian line-up where other frontline batters have made at least one fifty and the whole turn of events corroborates with his modest run in the ODIs as well.

Suryakumar got into the eleven after the injury-enforced absence of Hardik Pandya, but the Mumbaikar has not really cashed in on the opportunity yet. Netherlands gives him a good chance to correct that anomaly.

Similarly, the Indian batting upfront has a minor glitch, one that has gone a bit unnoticed in

the flow of their eight successive

wins in the tournament.

Openers Rohit and Shubman
Gill have stitched together three
fifty-plus stands in the tournament, but in five other matches
they were separated quickly.

But in those three games, they went off the blocks quite quickly, putting the opposition through the wringer.

They have made 88 runs in 12.4 overs against Bangladesh, 71 in 11.1 overs against New Zealand, and 62 in 5.5 overs against South Africa.

But on other times, their alliance was snapped at 5, 32, 23, 26, and 4. The think tank would like them to expand the footprint of those three matches, and Netherlands, no respect lost here, give them a perfect platform to do that.

India's bowling, on the other hand, remained largely troublefree with the three pacers and the two spinners delivering frequently.

Jasprit Bumrah, Mohammed Shami, and Mohammed Siraj have made run-making a hazardous option for opposition batters, but a bit more consistency in line and length from Siraj could be welcomed by the management.

But overall, this ultra-efficient five-man unit will be looking for one final rehearsal ahead of the last four match, potentially against New Zealand at Mumbai.

Turning to the Dutch camp, they will be a happy bunch to give at least a few rough moments to this red-hot Indian side.

They have some capable bowlers in Logan Van Beek, Bas de Leede, and Paul van Meekeren but on an often-smooth Chinnaswamy Stadium pitch they will be hard pressed to stop a strong Indian batting establishment.

Their top-order batters like Teja Nidamanuru, Max O'Dowd, and Wesley Barresi have struggled for runs in this tournament and tackling the well-oiled Indian bowlers could prove too hot a task for them.

World Cup 2023: England seal Champions Trophy spot with comprehensive win over Pakistan, end campaign on high



KOLKATA, Oct 12 (Agencies): England ended their World Cup 2023 campaign on a high as the Jos Buttlerled side produced an all-round performance to beat Pakistan by 93 runs and secure the Champions Trophy spot at the Eden Gardens in Kolkata.

On the other hand, Pakistan crashed out of the semi-final race when they failed to chase down the target of 338 runs within 6.4 overs. Despite having eight points from eight games, Pakistan had an opportunity to surpass New Zealand's net run rate if they could achieve the challenging task.

Chasing 338 for a win, Pakistan made a horror start as England pacer David Willey struck twice to remove both openers, Abdullah Shafique and Fakhar Zaman early, leaving them reeling at 10 for 2. Despite the early setbacks, Babar Azam and Mohammad Rizwan took on the responsibility of rebuilding the innings.

However, the momentum swung again when

Gus Atkinson removed Babar, who looked solid in his 38-run knock off 45 balls, to break the 50-plus 3rd-wicket stand. Rizwan then added 39 runs for the fourth wicket with Saud Shakeel before falling to Moeen Ali at 36.

Pakistan were 100 for

4 when Agha Salman joined Shakeel in the middle. Shakeel (29) wasted a good start while Iftikhar Ahmed (3) and Shadab Khan (4) fell in quick succession, leaving Pakistan at 150 for 7. Salman went on to hit his maiden World Cup fifty but could not save Pakistan from suffering another crushing loss in their final match. Salman Ali Agha's purposeful batting (scoring 51 off 45 balls) and the rearguard action from tail-ender Haris Rauf (with 35 runs off 23 balls) served as a valuable lesson for the toporder batsmen.

Earlier in the day, England showcased their formidable batting prowess with star performances from Ben Stokes, Joe Root, and Jonny Bairstow. Despite a shaky start, the 2019 champions managed to post an imposing total of 337 for 9 against a struggling Pakistan attack.

Ben Stokes, making a comeback after missing the first three matches due to a hip injury, stole the spotlight with a remarkable 76-ball 84. Jonny Bairstow (59 off 61 balls) and Joe Root (60 off 72 balls) also played crucial roles in fortifying England's innings. This marked England's second consecutive 300-plus total, following their 339/9 against the Netherlands in the previous match.

The imposing target set by England posed a daunting challenge for Pakistan, who now found themselves in the unenviable position of needing to chase it down in just 6.4 overs. The mathematical improbability of achieving this task became evident, as even hitting 40 sixes off 40 deliveries could only propel them to 240.

Despite a strong foundation, England's batting lineup struggled in the final overs, managing only 97 runs in the last 10, losing seven wickets in the process. The late-game slump highlighted an area of concern for England as they approach the crucial knockout stages of the tournament.

Cricket World Cup 2023: Mitchell Marsh Powers Australia To 8-Wicket Win Over Bangladesh

PUNE, Nov 12 (Agencies): Star all-rounder Mitchell Marsh displayed his six-hitting prowess on way to a magnificent 177 not out as Australia warmed up for the semifinals with an eight-wicket thrashing of Bangladesh in the World Cup in Pune on Saturday. Set a target of 307, Australia rode on Marsh's third ODI hundred and fifties from David Warner (53) and Steve Smith (63 not out) to complete the task with 32 balls in hand. The five-time champions will face South Africa in their semifinal in Kolkata on November

Bangladesh, on the other hand, ended their campaign with yet another loss and would hope India beat the Netherlands on Sunday so that they can hold on to their 8th position and qualify for the 2025 Champions Trophy in Pakistan.

Marsh, who had gone home after losing his grandfather, smashed as many as 9 maximums and 17 fours during his excellent knock, adding 120 off 116 and 175 off 136 deliveries with Warner and Smith for the second and third wickets respectively to take it away from the Asian team.

Marsh's innings was also the second highest individual score of this World Cup after Glenn Maxwell's 201 not out.

Earlier, Towhid Hridoy slammed a 79-ball 74, studded with five fours and two sixes, as Bangladesh produced their best batting effort of the tournament to post a competitive 306 for 8.



In response, Australia lost Travis Head (10) early but Marsh and Warner shrugged off the jittery start to take them to 100 for 1 in 15 overs. Marsh looked in solid

Marsh looked in solid form, making an attacking start as Warner seemed happy to play the second fiddle.

Marsh cracked three fours off Mahedi Hasan in the fourth over before depositing Taskin Ahmed over deep square leg. He then danced down the pitch to clobber another six off Nasum Ahmed and repeated the treatment to Mehidy Hasan Miraz in the 12th over.

The result was Marsh raced to his fifty in 37 balls.

Warner used his pull shot to good use and ran well between the wickets to keep ticking along. He picked Nasum for special treatment, sending him across the fence twice in the seventh over.

In the 19th over, Warner cut the bowler for another four through the covers to bring up the 100-run stand with Marsh, before reaching his fifty with another boundary.

Mustafizur Rahman returned to remove Warner in the 23rd over though Shanto almost dropped the catch, which reminded of Herschelle Gibbs' moment

from the 1999 edition.

Marsh continued unfazed, owning the off side, using his cover drives and off drives to score maximum runs there.

He notched up his ton in the 31st over and then went after Mehidy with another maximum over long-on. Then he turned his attention to Mustafizur, smoking him over the sightscreen in the 33rd over before adding another one in the 42nd over

One over later, Taskin was sent over mid-wicket as Australia galloped towards the target.

In the end, Smith knocked off the winning runs with a boundary off Mustafizur.

Opting to bowl, Josh Hazlewood (0/21) was on the money with the new ball, while Adam Zampa (2/32) scalped two to take the top position in the list of most wicket takers in this World Cup, and Sean Abbott (2/61), playing his first game, also took two wickets.

Litton Das (36) and Tanzid Hasan (36) gave Bangladesh a good start on a belter of a wicket as they were 76 for no loss at one stage. However, both frittered away their starts Pat Cummins, who conceded 10 runs in his first over, was taken to the cleaners by Tanzid in the sixth over, with two fours.

Litton joined the party with three boundaries in the eighth over as Tanzid brought up the team fifty with another four off Marsh, in 49 balls.

Abbott broke the partnership with Tanzid top-edging a short ball to hand the bowler a caught and bowl chance

Najmul Hossain Shanto (45) also looked in fine fettle, producing two hits to the fence off Marsh, as Bangladesh scored 100 for one in 15.1 overs.

However, Zampa had Litton caught by Marnus Labuschagne at longon.

Hridoy smashed two sixes en route to a 63-run alliance with Shanto, but Labuschagne produced a terrific throw to run out the stand-in skipper.

Mahmudullah (32) clobbered three sixes and a four during his 44-run stand with Hridoy as the 200 was up for Bangladesh in the 32nd over.

Mushfiqur Rahim (21) became the second victim of Zampa but Mehidy Hasan Miraz provided some impetus, blasting four boundaries before Abbott sent him back.

Bangladesh could add just 67 runs in the last 10 overs, but the total was enough to ensure that their net run rate wouldn't go below Sri Lanka in the race for the Championships trophy qualification.

The semi-final line-up was confirmed after the Babar Azam-led Pakistan got officially eliminated from World Cup 2023 after failing to chase a huge 338run target in 6.4 overs against England - which was always going to be an impossible task.

After New Zealand's win over Sri Lanka on Thursday, the 2019 Cricket World Cup runners-up had all but assured themselves a semi-final spot.

However, Pakistan

and Afghanistan still had mathematical chance to qualify for the last four. They both needed to win their last round-robin matches by humongous margins to have a shot at a semifinal spot.

However, Afghanistan lost their last round-robin stage match to South Africa on Friday. On Saturday, Pakistan also needed a miracle. After England put up 337/9, Pakistan needed to chase down the target in just 6.4 overs, which was impossible in all practical sense. Pakistan reached 30/2 in 6.4 overs against defending champions England.

In the 2019 Cricket World Cup, India lost to New Zealand in the semi-finals. However, this time India have looked a must greater force with all the play-

ers in form.

"The bowlers have enjoyed bowling under the lights. Like going into the semifinal, would you prefer having them bowl first over here and just to get accost to the conditions of the Wankhede?" Indian cricket team coach Rahul Dravid was

NIA files chargesheet in cross-border arms smuggling case in Punjab

JAMMU / NEW DELHI, Nov 12 (Agencies): The National Investigation Agency (NIA) has filed a charge-sheet against a man in a case linked to cross-border smuggling of arms and ammunition by drones in the border areas of Punjab's Gurdaspur district, an official said on Sunday.

The charge-sheet against Malkit Singh alias 'Pistol' was filed in the NIA special court in Mohali in Punjab, a spokesperson of the federal agency said.

The case was initially registered at the Dera Baba Nanak police station in Batala on March 24 following the seizure of firearms and ammunition, including five Austria-made pistols, 10 magazines and 91 live cartridges, by Border Security Force (BSF) personnel from a cremation ground at Bhagtana-Boharwala village.

On August 8, the NIA re-registered the case under various sections of the Arms Act, the Aircraft Act and the Unlawful Activities (Prevention) Act, the spokesperson said.

The official said investigations revealed connections between members of the proscribed terrorist organisation Khalistan Liberation Force (KLF) and individuals based in Pakistan.

"The accused identi-

fied in this terror network include Malkit Singh, Taranjot Singh alias 'Tanna' and Gurjit Singh alias 'Paa'. In addition, it was found that these operatives were in direct communication with Pakistanbased drug smugglers, Rehmat Ali alias 'Miyan', Pakistan-based KLF and International Sikh Youth Federation (ISYF) chief Lakhbir Singh Rode alias 'Babaji' and Ranjot Singh Rana," the spokesperson said.

The official said both the KLF and the ISYF were banned by the government in response to their orchestrated armed attacks on law enforcement personnel as well as for criminal intimidation, murder, extortion, fund-raising for terrorist activities and instilling terror among people, in furtherance of their violent campaign advocating the "secession of Punjab".


