The deceased has been identified as Showkat Ahmad Lone. son of Mohd Akber Lone from Lelhar Kakapora.

Further details are currently awaited.

Earthquake of magnitude 3.4 strikes Ladakh

LEH, Dec 2 (Agencies): An earthquake of magnitude 3.4 on the Richter scale struck Ladakh on Saturday.

The tremors were felt in the region at 8.25 am, according to the National Center for Seismology (NCS).

The epicentre was located at a latitude of 35.44 and a longitude of 77.36, with a depth of 10 km.

ED Raids 2 Ex-Punjab Ministers; Seizes Documents, **Mobile Phones**

NEW DELHI, Dec 2 (Agencies): "Incriminating" documents, mobile phones, and other electronic devices were seized by the ED after raids against two former Punjab forest ministers and Congress leaders Sadhu Singh Dharamsot and Sangat Singh Giljian and others as part of an alleged forest scamlinked money laundering probe.

The federal probe agency issued a statement on Friday, saying its investigation pertains to charges of "bribery" in the state forest department against the issu-

ance of a permit for tree felling and for transfer/ posting in the department, among some other allegations.

The raids were conducted on November 30 in Punjab, Haryana and Delhi at the residential premises of Dharamsot, Giljian, their associates, forest officers and some private individuals, the **Enforcement Director**ate (ED) said.

Dharamsot (63), has been a five-time MLA and he was arrested earlier this year by the Punjab Vigilance bureau as part of a case linked to alleged possession of disproportionate assets. Giliian has been an MLA from the Urmar seat in Hoshiarpur dis-

The money laundering case was filed under the provisions of the Prevention of Money Laundering Act and stems from an FIR of the Punjab Vigilance Bureau, the agency said.

The first information report pertains to alleged irregularities in the forest department and allegations of taking bribes by the concerned ministers and officers of the department against

ED officer 'caught red-handed' while taking bribe in TN, arrested

TAMIL NADU. Dec 2: An Enforcement Directorate officer was arrested for demanding and accepting a bribe of Rs 20 lakh from a a government employee, the Directorate of Vigilance and Anti-Corruption

(DVAC), said on Friday. After he was taken into custody in Dindigul, a team of the DVAC officials held 'enquiries' at the sub-zone ED office in Madurai, with state policemen standing guard outside the central government office.

An official release from DVAC identified the arrested official as Ankit Tiwari, "serving as an Enforcement Officer in the Madurai Enforcement Department office of the Union

Omar Abdullah targets ECI, **BJP** over delay in J&K assembly polls



Crime Branch Files Charge Sheet Against **Three Brothers In Land-Fraud Case**

JAMMU, Dec 2: The Jammu and Kashmir Police's Crime Branch on Saturday filed a charge sheet against three brothers accused of duping a man of Rs 43 lakh after luring him to enter a deal for the sale of 2.5 kanal of their land in Samba district, an official said. The Economic Offences Wing of the

Crime Branch (Jammu) filed the 253-page charge sheet in court against Narayan Singh, Suram Singh and Chain Singh for defrauding Manmohan Singh, a resident of Gandhi Nagar in Jammu, an investigating agency spokesperson

The official said the victim alleged that the accused approached him with an offer to sell



51 marlas (2.5 kanal) at Birpur for Rs 51 lakh on the pretext that the land was coming under acquisition.

They allegedly told Manmohan Singh that if he paid each brother Rs 17 lakh, he would be authorised to receive the compensation amount at the end of the acquisition proceedings.

The brothers had

claimed that the compensation for acquisition of the land would be higher than what he would be paying them to buy their land, the official said.

A special power of attorney was executed by the three accused in December 2021. An agreement to sell was also executed in favour of the complainant that acknowledged the receipt of the "consideration amount" and his rights, the spokesperson said.

He said the accused's plan to defraud the complainant was exposed after they approached the collector for land acquisitions with a written communication







Tomen are said to be the backbone of the rural ▼ economy. Their role is more important in developing countries. Rural women have an important contribution in the agricultural sector all over the world. They are meaningful parts of family, society and community. Which strongly influences the nature of the society. Because women have equal importance as men in the development of the nation. Seventy percent of our country's population still lives in rural areas. Most of them depend on agricultural activities. This is the reason why rural women, along with taking care of housework and children, also help in farming work. It is noteworthy that the contribution of women in India's GDP is only seventeen percent, which is less than half of the global average of thirty-seven percent. Yet, according to a World Bank report, if women's contribution to labor increases, India's growth rate will double. With this, poverty can be reduced rapidly. Rural women contribute sixty to eighty percent of the total labor in India's agricultural sector.Is of. While if we look at the data of the Food and Agriculture Organization, the contribution of rural women in the total labor in the agricultural sector is forty-three percent, whereas in some developed countries this figure is seventy to eighty percent. A research conducted by the Indian Council of Agricultural Research and DRAW in nine states shows that women's participation in the production of major crops has been up to seventy-five percent. Not only this, this figure is up to ninetynine percent in horticulture and fifty-one percent in post-harvest operations. women in animal husbandry Participation is up to fifty-eight percent and ninety-five percent in fish production. That is, it can be said

that almost half of the farming work in developing countries is done by women and India is no exception in this matter. Yet strategies for agricultural development are mainly made keeping men at the center. Barely five percent of the resources are spent keeping women in mind and no efforts are made in this direction. This also causes huge loss to agricultural production. According to a study by the Food and Agriculture Organization And if women get equal resources like assets, raw materials and services as men, then agricultural production in all developing countries can increase by two and a half to four percent. With this, the number of hungry people can be reduced by twelve to seventeen percent. This would also increase the income of the people, which would also increase the standard of living and life security. According to the Economic Survey 2017-18, due to migration of men from villages to cities for employment, the role of women in agricultural work is increasing. Therefore, women's participation in agricultural work increasedIs. At the same time, the contribution of women in preventing and managing today's current challenges such as climate change and degradation of natural resources cannot be denied. Women have been playing a multifaceted role in agriculture. They are involved in all the processes from sowing to transplanting, weeding, irrigation, applying fertilizers, plant protection, harvesting, storage etc. Apart from this, they are engaged in other agriculture related businesses like cattle rearing, fodder collection, dairy and agriculture related allied activities like beekeeping, mushroom production, pig rearing, goat rearing, poultry etc. She is also active in India. It is clear that if women get good opportunities and facilities, they can take the country's agriculture towards the second green revo-

lution and can also change the scenario of the country's development. On one hand, while urban women are engaged in the development of the country by working shoulder to shoulder with men in schools, colleges, offices, factories etc., on the other hand, rural women continue to make their invaluable contribution to the economic development of the country by working in the fields. Is. Despite this, women are considered inferior to men in the society. history of thisThis is a testimony to the fact that women have always been neglected in terms of their rights as compared to men, that is why there has been exploitation, injustice and oppression against women in every society. Women, especially in rural areas, are even more neglected. About seventy percent of the country's total population resides in rural areas, which suffer from extreme illiteracy, superstition and stereotypes. There is a need to ensure participation of women of rural India in the development of the country. If more than half of this population of women in India is not developed If this happens, then the country and society cannot develop. It is true that India's situation in terms of women empowerment is very unique in many ways. Here one third of the seats in Gram Panchayats are reserved for women. There are preparations to make similar arrangements in the Assemblies and Parliament also. Yet this political empowerment has generally not brought about substantial changes in the socio-economic structure of rural women. This is the reason that despite women's participation in agricultural enterprises, they do not get the respect they deserve from the society and the state. Are entitled. They are victims of neglect in every respect. In other words, men still dominate the rural socio-economic structure. Health and nutrition are the biggest concerns.

Women cook food for the entire household, but they usually remain hungry. The incidence of malnutrition among women in India is almost as high as the incidence of food crisis in some African countries. They are paid less wages than men for equal agricultural work. The ownership of land also generally belongs to men. This is the name. Most of the decisions related to farming are taken by men. It is worth noting that the entire social system is such that for every work done by a woman, she is told that her labor is not 'labour' but mere domestic help and this is the reason why most of the women who work in agriculture They are involved, even they themselves admit that they do not do any work. To save the villages of India, it is necessary to save farming, and to save farming it is equally necessary to empower women. According to government rules Currently, only those who have land in their name are considered farmers, hence many women are deprived of being recognized as farmers. Statistics also show that if women farmers get equal rights in agricultural work, then production can increase by up to forty percent. Besides, they will become financially self-reliant and will also be able to take the society forward. It is said that when you make a woman in the village socially and economically empowered and prosperous, that woman not only helps her family, her village, but soIt strengthens our country. This becomes the basic reason for the country's development and improvement in the economy. In such a situation, strong political will is needed.

JAMMU/NEW DELHI, Dec 2: Addressing the first-ever meeting of the BRIC Society after its registration on 10th November, 2023 after getting the Cabinet approval, Union Minister of State (Independent Charge) Science & Technology; MoS PMO, Personnel, Public Grievances, Pensions, Atomic Energy and Space, Dr Jitendra Singh said here today that time has come for defining "Bio-vision" for Bharat.

Dr Jitendra today said that the new Apex Autonomous Society called Biotechnology Research and Innovation Council (BRIC) will fulfil Prime Minister Narendra Modi's Vision for Atma Nirbhar Bharat in areas like healthcare, food and energy needs by scaling biotech research and innova-

He said, in the last eight years, the biotech sector has grown eightfold times.

The Minister quoted PM Modi as saying, "India is not too far from reaching the league of top-10 countries in Biotech's global ecosystem". He added that BRIC is going to be a testimony to this and again by inculcating the spirit of Sabka Prayas, the government is bringing together the best minds on a unified platform.

Dr Jitendra informed that the Department of Biotechnology (DBT), Ministry of Science and Technology is function-



ing as the nodal agency for promotion of Biotechnology in the country. It was accorded the Cabinet approval for rationalization of its 14 **Autonomous Institutions** (Als) by subsuming them under one Apex Autonomous Society viz. Biotechnology Research and Innovation Council (BRIC), for centralized and unified governance to maximize impact of biotech research across the country.

Dr Singh described

the BRIC meeting as a historical event in India's Biotech Ecosystem, where elite institutions are consolidating their efforts to impact the biotech R&D ecosystem. He expressed hope that BRIC will prospectively enrich India's progress in every front including economy and employment. The Minister said, as accomplished institution-builders, he would like to seek their views for defining the Bio-Vision for Bharat in this significant meeting, as they are supposed to bring in tremendous value to this noble mis-

Dr Jitendra also pointed out that this is one

of the first Departments in the Government of India to have successfully executed "Rationalization of Autonomous Bodies" for process and performance enhancement of its Autonomous

Dr Singh said, some of the significant changes that will be driven by BRIC include that each of the 14 subsumed BRIC Institutions will maintain their distinct research mandates, governed by one Governing Body, at BRIC. He said, Institutes would be allowed utilization of institutional lab space. not exceeding one third. for researchers from outside DBT institutes and their collaborators (from industry or other institutes) to carry out R&D for start-ups emerging out of institutional research.

Dr Jitendra also underlined that BRIC and its Institutes can engage in public-private research partnerships and receive endowments including funds from non-Governmental resources for researchrelated activities.

Dr Singh also added that new Ph.D programs across BRIC institutions

interactions and democratize resources. The compliance to governmental processes and administrative issues will be centrally managed in a coordinated effort thereby achieving "Minimum Government, Maximum Governance".

The 14 institutes to be governed by the Society of the new Apex Body of BRIC are: :i) National Institute of Immunology (NII, New Delhi); ii) National Center for Cell Science (NCCS, Pune); iii) Institute of Life Sciences (ILS, Bhubaneshwar); iv) Rajiv Gandhi Centre for Biotechnology (RGCB, Thiruvananthapuram); v) Centre for DNA Fingerprinting & Diagnostics (CDFD, Hyderabad); vi) National Brain Research Centre (NBRC, Manesar); vii) National Institute for Plant Genome Research (NIPGR, New Delhi); viii) Institute of Bioresources and Sustainable Development (IBSD, Imphal); ix) National Institute of Animal Biotechnology (NIAB, Hyderabad); x) Institute for Stem Cell Science and Regenerative Medicine (inStem, Bangalore); xi) National Institute of Biomedical Genomics (NIBMG, Kalyani); xii) Translational Health Science and Technology Institute (THSTI, Faridabad); xiii) National Agri-Food Biotechnology Institute (NABI, Mohali); xiv) Center of Innovative and Applied Bioprocessing (CIAB, Mohali), NABI and CIAB have been merged into one administrative unit with one Director.

of whether he is in a uniform or not. To crack that ... the spirit, the focus was on that a lot more than just his body language."


Did he take back some learning from Manekshaw?

All-party meeting convenes ahead of Parliament's Winter Session

NEW DELHI, Dec 2 (Agencies): The Union government on Saturday convened an allparty meeting to deliberate on a host of issues related to Parliament's Winter session which will start on December 4 and will continue till December 22.

The all-party meeting, which was convened in Parliament's library building, saw the participation of Parliamentary Affairs Minister Pralhad Joshi, Defence Minister Rajnath Singh, Congress MP Jairam Ramesh and several other leaders from different political parties. During the meeting,

members of the Trin-



amool Congress (TMC) demanded a discussion in the Lok Sabha on the Ethics committee's report on the "cashfor-query" allegations against TMC MP Mahua

In the meeting, they

also said that the report of the Ethics committee shouldn't have been made public.

"The (Ethics committee) report shouldn't have been made public so brazenly," a member of the TMC said in the

meeting.

The House will have to adopt the report before the expulsion recommended by the panel comes into effect.

During this session, three important bills aiming to replace the Indian Penal Code (IPC), Code of Criminal Procedure (CrPC), and the Evidence Act are likely to be discussed.

Another key bill pending in Parliament relates to the appointment of chief election commissioner and election commissioners.

Introduced in Monsoon session, the government had not pushed for its passage in the special session of Parliament amid protests from the Opposition and former chief election commissioners as it seeks to bring on a par the status of the CEC and ECs with that of the cabinet secretary.

CLP leader urges Birla to have the Ethics Committee procedure re-examined



NEW DELHI, Dec 2 (Agencies): Adhir Ranjan Chowdhury, leader of the Congress party in the Lok Sabha, has urged the Speaker Om Birla to have the process relating to the jurisdiction and procedures followed by the Ethics Committee of the Lok Sabha to investigate the complaint of misdemeanour by Trinamool Congress member Mahua Moitra "examined" and take remedial measures to "streamline" the committee's functioning.

The Ethics Committee is slated to lay its report on Moitra in the Lok Sabha on the inaugural day of the Winter Session of Parliament on Monday. This is expected to be followed by her expulsion from the Lok Sabha as recommended in the report.

In a three and half page letter to Birla, Chowdhury said Moitra's case was the first instance of the Ethics Committee recommending expulsion of a member from the Lok Sabha. "Expulsion from Parliament, you will agree Sir, is an extremely serious punishment and has very wide ramifications", Chowdhury wrote.

Chowdhury, leader of the largest opposition party in the Lok Sabha, said the purported act of misdemeanour on the part of Moitra (sharing her log-in credentials and passwords for the official portal of the Lok Sabha with Dubai based businessman Darshan Hiranandani to raise questions in Parliament in return for gifts/ favours) should not be compared with the 2005 case when 10 members of Lok Sabha were expelled for receiving cash for posing questions in Parliament or the case of HD Mudgal that dated back to 1951.

In the two abovementioned cases, the charges were examined and reported upon by separate committees of the House that were constituted for the specific purpose of examining and reporting on the charges against the members, the CLP leader said.

Choudhury added that the 2005 case was the fall out of a sting operation carried out by "Cobra Post" which showed the members accepting cash for posing questions.

All concerned in the 2005 case, including the media personnel who carried out the sting operation, and members accused of having indulged in acts of misdemeanour were examined on oath, their evidence recorded and made part of the report of the panel, Chowdhury wrote.

The CLP leader wrote that on the contrary, the Dubai based businessman was not asked by the Vinod Sonkar-led Ethics Committee of the Lok Sabha to depose before it.

Chowdhury added that accepting gifts and giving away gifts was a common social practice and should not be treated as a money trail for deriving favours.

Stating that it is not always possible for a member to operate the parliament portal oneself, Chowdhury wrote that it is on account of this factor that the staff attached to Members were imparted training on various aspects of the functions of the

The CLP leader also pointed out that a guestion that is placed or given notice of by a member is subject to scrutiny and becomes admissible only if it meets the "conditionalities" laid down in the Rules of Procedure

Amid Mahadev Book link-up, Bhupesh Baghel writes to PM seeking ban on betting apps

In his letter, Chhattisgarh Chief Minister Bhupesh Baghel pointed out that online betting is a nationwide business that is being run from abroad by certain individuals and interest groups.

RAIPUR, Dec 2 (Agencies): A day before the counting of votes in Chhattisgarh, state Chief Minister Bhupesh Baghel wrote a letter to Prime Minister Narendra Modi urging him to ban the apps, web platforms, APKs, Telegram channels, Instagram accounts and URLs that are linked to the "illegal business of online betting".

In his two-page letter, CM Baghel also pointed out that illegal betting is a nationwide business now that is being run from abroad by certain individuals and interest groups.

He also requested PM Modi to initiate steps to stop the illegal flow of money from the accounts of those who are running online betting apps.

Informing about his

letter, CM Baghel, in a post on micro-blogging site X, said, "By writing a letter to Prime Minister Shri Narendra Modi ji, I demanded a complete ban on the platforms. web, APK, Telegram, Instagram, URL related to the illegal business of online betting."

"In the past, illegal gambling and betting business has expanded nationwide through online betting and gaming and its operators and owners have been running the said illegal business from abroad," he added in his post.

In his letter, CM Bhaghel also mentioned the actions taken by the Chhattisgarh police in connection with online betting apps.

This letter comes days after the Enforcement Directorate (ED) claimed that it recorded



the statement of a 'cash courier' who alleged that Chhattisgarh Chief Minister Bhupesh Baghel received Rs 508 crore from the Mahadev app promoters based in the

Later, the BJP also released a video of a man named Shubham Soni saying he was the owner of the Mahadev app and had the "proof" of paying Rs 508 crore to CM Baghel.

Nursing student killed at hotel in Chennai; boyfriend posts picture on WhatsApp status

CHANDIGARH, Dec 2 (Agencies): In a shocking turn of events, a lifeless body of a 20-year-old nursing student was found at a hotel in Chennai's Chromepet

The incident came to light when an image of Fousia's lifeless body appeared as the WhatsApp status of her boyfriend, Ashiq, prompting mutual friends to alert the Chromepet police.

The police launched an investigation, ultimately locating her body at the aforementioned hotel.

Upon scrutinising CCTV footage in the vicinity, the police swiftly apprehended Ashiq at a nearby eatery, reports

Preliminary investigations revealed a disturbing sequence of events – an argument ensued between the couple after checking into the hotel, sparked by Fousia questioning Ashiq about photos of him with another woman on his phone. In a fit of rage, Ashiq allegedly assaulted and strangled Fousia to death, subsequently uploading a photo of her lifeless body as his WhatsApp

The police disclosed that the couple had been in a relationship for five years and had secretly married. They even had a child, who was given up for adop-



tion in Chikamagalur.

However, the relationship took a tumultuous turn two years ago when Fousia discovered Ashiq's involvement with multiple other women. She lodged a complaint with the Kerala police, leading to Ashiq's arrest under the Protection of Children from Sexual Offences Act and subsequent imprisonment. Following his release, Ashiq apologised and the couple reconciled.

Fousia's body has been sent for postmortem at the Chromepet government hospital, and a thorough investigation into the case is currently underway.

Fousia, who resided in a hostel at New Colony, was a second-year student at a college in Chromepet. She had not attended college for the past

9-year-old in Andhra VIJAYAWADA, Dec Akhil Vardhan Reddy

2 (Agencies): The sensational midnight abduction and murder of a nine-year-old student of a tribal welfare residential school in Eluru district by two students of the same school shocked Andhra Pradesh recently.

The accused, both students of class 10, not only killed the boy studying in class 4, but also left a letter in his hand threatening more such murders.

"Whoever wants to live, go away from here because these kinds of things will keep happening from now on," one of the accused wrote in Telugu.

They kept the letter to divert the course of attention but the handwriting proved to be a vital clue for the police and ultimately led to their arrest.

The gruesome murder of nine-year-old Gogula had rocked Government ST Residential School in Puli Ramannagudem, a forest area in Buttayagudem 'mandal' (bock) of Eluru district in July.

The boy was found murdered near the hostel on the school premises. The body of the victim had contusion marks around the neck and a small scratch near the right eye.

Son of daily wagers, he belonged to a village about 5 km from the school. His elder brother is also studying at the same school in class 6.

The family belonged to the Konda Reddi tribe, a Particularly Vulnerable Tribal Group (PVTG) in Andhra Pradesh.

The student's murder and the letter warning of more such killings had sent terror among the school inmates and the school administration. Police had formed 10 teams to crack the case.

Deputy Chief Minister Peedika Rajanna Dora, who also holds the tribal welfare portfolio, visited the school.

How two Class X students abducted, murdered

He handed over a cheque for Rs 10 lakh as ex-gratia to the parents of the deceased and assured a job to the boy's father in a government department on outsourcing basis and a housing plot to the family. The murder was ini-

tially suspected to be the handiwork of some outsider. The police also focussed on the role of teachers and other employees. However, the police investigations revealed the shocking truth that two students of the same school committed the ghastly crime.

The accused, both aged 15, plotted and executed the abduction and murder of the victim. Wearing masks, they gained entry into the hostel around midnight.

One of the accused entered the room through the window, which had no grills, and opened the latch of the main door to facilitate the other boy to enter the room. Before entering the hostel, they switched off the power supply.

The accused carried the boy away and strangled him to death on the school campus located opposite the hostel block.

Police matched the handwriting in the letter found with the handwriting of students and began questioning the suspect. He tried to run away and finally confessed that he, along with another boy, committed the murder.

"The two juveniles in conflict with law confessed that they killed the hostel inmate due to personal dispute," said Eluru Superintendent of Police (SP) D. Mary Prasanthi.

"They left a letter in the hands of the deceased to divert the course of investigation," she said.

The SP did not reveal what was personal about the dispute that had led to the murder.

However, it was learnt the prime accused had allegedly physically and sexually abused the deceased boy previously.

When the victim rejected his proposal for sexual favour, the prime accused with another classmate plotted the murder and executed it.

The case highlights that teenagers are committing murders not just in cities and towns but even in remote places.

Police officials say teenagers studying in residential schools away from their families need proper counselling to ensure that they don't develop bad habits.

Police arrest Mumbai DJ for repeatedly raping Mexican woman

MUMBAI, Dec 2 (Agencies): The Mumbai police have arrested a man for allegedly repeatedly raping a 31-year-old Mexican woman disc jockey (DJ), an official said on Saturday

The 35-year-old accused, who also works as a DJ, was arrested on Friday after the victim lodged a complaint against him last week, the official of Bandra police sta-

As per the complaint, the accused raped the woman on several occasions since 2019.

The woman currently lives in Mumbai and the accused is her

manager, he said. "The woman said in her complaint that she met the accused



through social media in 2017. He allegedly sexually assaulted her at his home in Bandra in July 2019, after which he raped her on multiple occasions," the police offi-

"The woman said that the accused used to force himself on her by threatening to kick her out of an assignment if she refused. He also allegedly blackmailed her through some of her intimate pictures," he said.

The victim complained that the accused used to send inappropriate pictures to her.

Despite getting married to another woman in 2020, he kept on texting her sexually explicit things and making sexual demands from her, he added.

Based on her complaint, the police filed a case under Indian Penal Code (IPC) sections 376 (rape), 377 (unnatural sex), 354 (assault or criminal force to woman with intent to outrage her modesty) and 506 (criminal intimidation) against the accused, the official said, adding that further investigation is underway.

TEL AVIV, Dec 2 (Agencies): Heavy fighting continued in Gaza on Saturday following a day after the temporary humanitarian truce collapsed in the besieged enclave, with the Israeli military claiming to have hit Hamas command centres.

In an update on X, the Israel Defense Forces (IDF) said on Saturday that it "struck operational command centers in Gaza, which Hamas terrorists were operating, as well as underground sites and a military compound from which anti-tank missiles were launched at soldiers" on Friday.

The IDF also said that it eliminated multiple terrorist cells throughout Gaza, including one with over 10 terrorists operating adjacent to ground troops

It further claimed of thwarting two additional terrorist cells -in joint IDF ground and aerial activities -- that launched mortar



shells toward IDF troops in Gaza.

The temporary ceasefire, which was initially reached on November 24, expired at 7 am on Friday morning, with Israel and Hamas blaming each other for the collapse.

According to the Hamascontrolled Health Ministry in Gaza, at least 178 people were

killed and 589 injured since the resumption of the hostilities.

Meanwhile, more than 260 Palestinians were detained by Israeli forces in the West Bank during the period of the nowexpired truce, according to the Palestinian Prisoner Society.

Under the Israel-Hamas truce, a total of 104 hostages -- 80 Israelis, 24 foreign nationals -- and 240 Palestinian prisoners were released in between November 24 to 30.

But the IDF has said that at least 136 hostages are still being held in Gaza, including 17 women and children.

The Israeli military has also said that a new interactive map showing Gaza divided up into numbered districts and "evacuation zones" is meant to reduce casualties when it carries out strikes in civilian areas.

Earlier on Friday, the IDF dropped leaflets in areas of southern Gaza which included a QR code that connects to the

But telecommunications and electrical infrastructure in Gaza suffered extensive damage over weeks of bombardment, leaving many residents with unreliable access to the internet and power.

South Korea successfully launches 1st spy satellite into orbit



SEOUL, Dec 2 (Agencies): South Korea successfully launched its first indigenous military spy satellite from a US military base in California, in a culmination of Seoul's quest for space-based intelligence capabilities amid growing North Korean threats, the Defence Ministry said on Satur-

The launch of the satellite atop a SpaceX Falcon 9 rocket from Vandenberg Space Force Base on Friday came after Pyongyang claimed success in its own spy satellite launch last week -- a move that underscored a growing inter-Korean security rivalry, reports Yonhap News Agency.

The Ministry said the

satellite was placed in orbit approximately four minutes after launch at 10.19 a.m., and succeeded in communicating with a ground station at 11.37 a.m., which means it is operating normally.

Beginning with an electro-optical and infrared (EO/IR) satellite, South Korea plans to send four more synthetic aperture radar (SAR) satellites into space by 2025 to better monitor North Korea.

The plan is expected to heat up a space arms race between the two Koreas as North Korea sent its first spy satellite in orbit on November 21 following two failed attempts earlier this year and vowed to launch more in a short span of time.

US senators ask Biden to impose China travel ban after respiratory illness cases

WASHINGTON, Dec 2 (Agencies): Five Republican senators led by Marco Rubio on Saturday asked President Joe Biden's administration to ban travel between the United States and China after a spike in Chinese respiratory illness cases.

"We should immediately restrict travel between the United States and (China) until we know more about the dangers posed by this new illness," said the letter signed by Rubio, the top Republican on the Senate Intelligence Committee, along with Senators JD Vance, Rick Scott, Tommy Tuberville and Mike Braun

The rise in cases became a global issue last week when the World Health Organization asked China for more information, citing a report on clusters of undiagnosed pneumonia in children by the Program for Monitoring Emerging Diseases.

A Biden administration official said the United States was closely monitoring the uptick in respiratory illnesses in China, but added, "We are seeing seasonal trends. Nothing is appearing out of the ordinary. ... At this time, there is no indication that there is a link



between the people who are seeking care in US emergency departments and the outbreak of respiratory illness in China."

The spokesperson for the Chinese Embassy in Washington, Liu Pengyu, said in response to the Rubio letter, "The relevant claims are purely illintentioned fabrications. China firmly opposes them." Maria Van Kerkhove, acting director of the WHO's department of epidemic and pandemic preparedness and prevention, said earlier this week the increase appeared to be driven by a rise in the number of children contracting pathogens that they had avoided during two years of Covid-19

restrictions. In recent months. the United States and China have been steadily increasing flights between the countries. though they remain far below 2019 levels. The

number approved rose on November 9 to 35 per week for each country, up from 12 per week in August.

In January 2020, then-President Donald Trump barred most non-US citizens who had recently been in China from entering the United States over Covid concerns, but did not restrict flights between the two countries.

The United States lifted the unprecedented travel restrictions for fully vaccinated international visitors starting in November 2021, including from China.

The U.S. rescinded a separate requirement that air travelers test negative before arriving in June 2022.

The United States in January had started requiring air passengers to get negative Covid tests after Beijing's decision to lift its stringent zero-Covid policies, but lifted the requirements in March.

TEL AVIV, Dec 2 (Agencies): In the wake of a devastating Hamas attack in Israel, a poignant ray of hope emerges as families grieving the loss of their loved ones find solace through an unexpected avenue--posthumous sperm retrieval (PSR), CNN reported.

Posthumous sperm retrieval (PSR) is a procedure that involves collecting sperm from a deceased person. The sperm can be used later to attempt pregnancy.

At Kaplan Hospital in

Israel, Professor Shir Daphna-Tekoah, a medical social worker, found herself grappling with an unprecedented crisis on October 7, the day of Hamas attack on Israeli farms, villages, and a music festival. Tasked with addressing the aftermath, she faced the immense challenge of supporting victims and their families.

Daphna-Tekoah, also head of the hospital's rape crisis centre, was initially called in due to reports of sexual assaults, but the emergency room quickly became overwhelmed with the injured.

"I've seen dozens of



people killed in accidents or shootings, but this was the hardest thing I've done in my life," Daphna-Tekoah recounted. The horror and grief were palpable as she assisted families bidding farewell to their young loved ones, some no older than 23 or 24. according to CNN.

In the midst of such tragedy, Daphna-Tekoah found a glimmer of hope when she posed an unconventional question to one grieving family: "Would you like me to find out about sperm preservation?" The suggestion aimed at exploring the possibility of PSR, a process that involves extracting sperm from the deceased.

The urgency and gravity of the situation prompted Daphna-Tekoah to swiftly approach hospital management. Within hours, legal approvals were obtained, and by the following morning, the sperm of several victims

from the Nova festival had been successfully retrieved. Over seven weeks later. Israeli hospitals have been inundated with requests for cryogenically freezing the sperm of those who lost their lives in the con-The Ministry of Health has played a pivotal role

in facilitating this process by cutting through red tape. The ministry's recent directive instructs hospitals to approve requests for PSR from the deceased's parents during the ongoing conflict, bypassing the need for family court interven-

Posthumous sperm retrieval involves retrieving live sperm from testicular tissue within a limited timeframe, typically 44 to 45 hours after death. Dr Noga Fuchs Weizman, the medical director of the sperm bank and male infertility unit at Tel Aviv's Ichilov Hospital, noted a surge in demand for the service since October 7. The Israel Defence Forces (IDF) actively propose this option to bereaved families when informing them of their loss, as reported by CNN.

The case of Israeli singer Shavlee Atary garnered attention after her husband was killed during the attacks. Atary, in her efforts to retrieve her husband's sperm, highlighted the emotional complexities surrounding such decisions.

The initiative for sperm retrieval is meticulously overseen by the Ministry of Health, which allocates cases to four hospitals. Timing is critical, with live sperm detection most likely within the first 24 hours after death. The pro-

cess involves freezing any viable sperm cells in liquid nitrogen for potential future use.

While science and technology offer a glimmer of hope for grieving families, ethical considerations loom large. Gil Siegal, head of the Centre for Health Law and Bioethics at Kiryat Ono College in Israel, acknowledged the country's pioneering role in reproductive medicine. However, he cautioned against hasty policy decisions and emphasised the need for thoughtful deliberation on the implications of posthumous parenthood.

As Israel navigates this uncharted territory, balancing grief, science, and ethics, the legacy of those lost in the conflict takes on new dimensions.

For Daphna-Tekoah, the imperative is clear, "If, as a country, we encourage people to donate organs after death, why aren't we giving people the right to donate sperm? It's their human right. It was a catastrophe, and we owe it to them," CNN reported.

North Korea Threatens To "Destroy" US Spy **Satellites If It Tries "Any Attack"**

SEOUL, Dec 2 (Agencies): North Korea warned Saturday it would "destroy" US spy satellites if Washington tries "any attack" on its space asset, after Pyongyang launched its first military eye in the sky last week.

A spokesman for the North's defence ministry said it would consider such a move a "declaration of war", according to a statement carried by the state-run Korean Central News Agency.

The statement came after a US official's remark that Washington "could deny an adversary's space and counterspace capabilities... using a variety of reversible and irreversible means", referring to the North's successful spy satellite launch in late November.

The US military could undermine the "effectiveness and lethality of adversary forces across all domains", Sheryll Klinkel, a spokesperson at



the US Space Command, told Radio Free Asia this week.

On Saturday, Pyongyang threatened to "destroy" US spy satellites if Washington "tries to violate the legitimate territory" of North Korea, referring to its satellite programme.

If the United States attempts to breach its space rights, the North's defence ministry spokesman said his country

"will consider taking responsive action measures for self-defence to undermine or destroy the viability of the US spy satellites".

North Korea is barred by successive rounds of UN resolutions from tests using ballistic technology, and analysts say there is significant technological overlap between space launch capabilities and the development of ballistic missiles.

Experts have said putting a working reconnaissance satellite into orbit would improve North Korea's intelligence-gathering capabilities, particularly over South Korea, and provide crucial data in any military con-

Since last week's launch, the North has claimed its satellite has already provided images of major US and South Korean military sites.

It has not yet disclosed any of the satellite imagery it claims to possess.

The North's launch of "Malligyong-1" was Pyongyang's third attempt at putting such a satellite in orbit, after two earlier failures.

Seoul has said the North received technical help from Moscow, in return for supplying weapons for use in Russia's war with Ukraine.

At least 12 people are missing after heavy rain triggers a landslide and flash floods in Indonesia

MEDAN, Dec 2 (Agencies): Torrential rain triggered flash floods and a landslide on Indonesia's Sumatra island, leaving at least 12 people missing, officials said Saturday.

Tons of mud, rocks and trees rolled down from a mountain late Friday, reaching a river that burst its banks and tore through mountainside villages, said Budiono, who heads the local search and rescue agency.

Worst hit was Simangulampe, a village near the popular Lake Toba in North Sumatra province, where several people were buried under tons of mud and houses were damaged, said Budiono, who goes by a single name

like many Indonesians. He said relief efforts were hampered by blocked roads covered with thick mud, debris and giant rocks, and rescuers were still searching for the 12 missing people Saturday.

National Disaster Management Agency spokesperson Abdul Muhari said a villager was rushed to a nearby hospital with serious injuries after the landslide hit his house.

He said at least 12 houses, a church, a school and a hotel were damaged by the disaster, forcing about 50 families in the village to flee to a temporary government shelter.

Photos released by the agency showed damaged homes, along with a church, a school and a hotel covered by tons of rocks.

Authorities were still collecting information about damage and possible casualties, Muhari said.

Adani Group to take call on Wilmar JV stake divestment in 3 months: Report

NEW DELHI, Dec 2 (Agencies): The Adani Group is set to decide on the divestment of its stake in the Adani Wilmar joint venture within the next three months, according to Jusgeshinder Singh, the group's Chief Financial Officer.

"We are currently studying the whether to keep or divest Wilmar stake," Singh was quoted as saying by news agency Reuters on the sidelines of an event in Mumbai.

A report last month indicated that the Adani Group is in talks with various multinational consumer goods companies to divest its entire 43.97 per cent stake in Adani Wilmar Ltd.

The joint venture is well-known for its ownership of the Fortune brand, particularly recognized for its edible oils and packaged



grocery products. Sources suggest that a deal could be finalized within a month.

The conglomerate, operating across diverse sectors from ports to renewable energy, is anticipating a sale price ranging between \$2.5 billion to \$3

billion for its stake in the joint venture with Singapore-based Wilmar International, which also holds an equivalent 43.97 per cent share in Adani Wilmar Ltd.

This is a part of Adani Group's broader plan to exit certain businesses to make more sub-

stantial investments in core focus areas, primarily centered around infrastructure.

Adani Wilmar is a significant player in the edible oil sector with a strong market presence. In the previous fiscal year, the company reported a net profit of Rs 607 crore and revenues of Rs 55,262 crore.

However, it faced challenges in the second quarter of FY24, reporting a net loss of Rs 131 crore. The company had also posted a loss in the first quarter of the ongoing financial year.

This development occurs as promoters within the Adani Group consider selling stakes in non-core assets to establish a liquidity cushion, following a valuation dip triggered by a critical report from US short seller Hindenburg Research.

Gold prices soar to lifetime high in India



MUMBAI, Dec 2 (Agencies): Gold prices rose to a lifetime high in India amid the peak wedding season and rising international rates of the precious metal

Chennai led the charge with the price soaring to Rs 64,530 per 10 gm for 24 carat gold in morning trade.

The price of the precious metal in Mumbai, Delhi, Bengaluru and Kolkata was hovering at Rs 63,760 per 10 gm, which was Rs 810 higher than the previous day

Gold prices in the international market have also shot up to a seven-month high as spot prices gained 1.6 per cent to \$2,069.10 per ounce on Friday.

India imports a large quantity of gold and rising global prices have a direct impact on the domestic market.

Gold prices have been rising in the global market as the dollar has continued to depreciate against a basket of major currencies and is currently close to a three-month low which makes gold cheaper to buy in other foreign currencies

There are also growing expectations that the Federal Reserve is likely to cut rates in the coming months.

Expectations of low interest rates makes financial instruments less attractive for investors compared to gold which is considered a safe investment.

The demand for gold in the domestic market remains firm amid the marriage season as the precious metal is gifted to brides and grooms in large quantities.

Car sales see a sequential decline in November

NEW DELHI, Dec 2 (Agencies): There was a dip in passenger vehicle (PV) sales (dispatches by manufacturers) in the festive heavy month of November 2023 when compared with October 2023 sales. As the festive season ended in the first half of last month, automakers reduced filling up dealer showrooms amidst a drop in buying interest from consumers

As per data shared by industry executives, PV wholesales in November came down to 3.35 lakh units as against 3.91 lakh units sold in October. On annual basis, however, November 2023 sales were up nearly 4% from 3.22 lakh units in November 2022. Maruti Suzuki (MSIL), India's largest carmaker, wholesales fell from nearly 2 lakh vehicles (domestic plus exports) in October 2023 to 1.64 lakh units in November 2023. Its domestic PV

sales came down from 168,047 units in October 2023 to 134,158 units in November 2023. It registered a drop in every segment, be it mini, compact or the fast growth SUVs.

Shashank Srivastava, executive director, sales & marketing at MSIL, said there has been a drop in retail and bookings, particularly after the festive season that ended mid-November, but bookings for MSIL rose by 7% last month. He said companies need to be careful and plan production accordingly in December to balance the situation.

Srivastava expects inventory level at dealer showrooms to come down in December due to aggressive schemes and offers by carmakers. Currently, stock levels in PV industry are pegged at 30-35 days inventory with a cumulative estimate of 330,000 units. Hyundai Motor India COO Tarun

Garg said the growth momentum continued but as industry players undertake stock correction ahead of the year-end, wholesales are expected to taper down. "Hyundai have three weeks of inventory at the moment and it will go down to two weeks by the end of December," he added.

Garg stated Hyundai's SUV contribution to total sales was the highest at 68% in November. Garg also said that the company is considering a price hike in near future. Hyundai's November 2023 sales stood at 49,451 units as against 55,128 units sold in October 2023. Tata Motors' November 2023 dispatches stood at 46,068 units as against 48,337 units in October 2023 while Mahindra & Mahindra's November sales came down to 39,981 units in November from 43,708 units in October.

Satyam case: SEBI asks Raju, 5 others to disgorge unlawful gains of Rs 624 cr

NEW DELHI, Dec 2 (Agencies): In the 14-year-old Satyam Computer Services case, markets watchdog SEBI has directed the erstwhile company's founder B Ramalinga Raju, four individuals and an entity to disgorge unlawful gains worth over Rs 624 crore.

SEBI has also barred Ramalinga Raju and Rama Raju from the securities markets for nearly five years but the directions will be subject to the Supreme Court's decision on the pending appeals filed by the two individuals.

The scam at Satyam Computer Services came to light on January 7, 2009, when Ramalinga Raju, then the company's chairman, admit-

to disgorge the unlawful gains totalling Rs 624.09 crore.

The amount has to be paid along with an annual interest of 12% from January 7, 2009 till the date of payment, according to the SEBI. SEBI's latest order came after the Securities Appellate Tribunal (SAT), in June this year, asked the regulator to pass a fresh order on or before November 30.

In February this year, SAT set aside two orders by SEBI in October and November 2018 in the case with respect to calculation of the unlawful gains and certain other aspects.

"I find that imposition of simple interest on illegal gains at the rate of 12% from January 7, 2009 till date of payment, is neither arbitrary nor excessive by any standard.

"On the contrary it is imposed judiciously in the facts and circumstances of this case and is consistent with past precedents," SEBI whole-time member Ananth Narayan G said in the order on November 30.

According to the latest order, Ramalinga Raju, Rama Raju, V Srinivas and G Ramakrishna shall continue to remain under restraint as directed by the Supreme Court till appeals in the case are decided.

Ramalinga Raju and Rama Raju have been barred from the securities market till July 14, 2028, as per the latest order.

Fasting for 14 hours increases sleep, hunger: Study

LONDON, Dec 2 (Agencies): According to new data from the largest UK community research study, eating within a 10-hour window gives health benefits regarding mood, energy, and hunger.

Researchers from King's College London presented the trial's findings at the European Nutrition Conference.

Intermittent fasting (IF), or restricting your food consumption to a set time frame, is a popular approach for losing weight. You limit your daily eating schedule to 10 hours and fast for the remaining 14 hours with a ten-hour window. For example, if you start eating at 9 a.m., you must finish by 7 p.m.

Those who maintained a regular eating window outperformed those who altered their eating habits.

Despite the fact, a certain intermittent fasting advocates frequently promote restrictive eating windows as short as six hours, data presented in the abstract suggest that eating within a less restrictive window of ten hours has beneficial health effects such as changes in mood, energy, and appetite.

Dr Sarah Berry from King's College London and chief scientist at



ZOE said, "This is the largest study outside of a tightly controlled clinic to show that intermittent fasting can improve your health in a real-world setting. What's really exciting is that the findings show that you don't have to be very restrictive to see positive results. A ten-hour eating window, which was manageable for most people, improved mood, energy levels and hunger. We found for the first time that those who practised time-restricted eating, but were not consistent day to day, did not have the same positive health effects as those who were dedicated every day." 37,545 people on the ZOE Health app completed the core intervention period of three weeks. Participants were asked to eat as normal for the first week and then a

ten-hour eating window for two weeks. More than 36,231 participants opted for additional weeks and 27,371 users were classified as highly engaged. Highly engaged participants were 78 per cent female, with a mean age of 60 and a BMI of 25.6.

Participants with a longer eating window before the intervention saw an even greater benefit to their health.

Kate Bermingham PhD, from King's College London and ZOE, said, "This study adds to the growing body of evidence showing the importance of how you eat. The health impact of food is not just what you eat but the time at which you choose to consume your meals, and eating window is an important dietary behaviour that can be beneficial for health. Findings show that we don't need to be eating all the time. Many people will feel satiated and even lose weight if they restrict their food to a ten-hour window."

organ donation has rapidly increased reaching every corner of the state. Between 2017 and 2019, there was an almost 20% increase in deceased organ donations in Gujarat. Marengo CIMS Hospital was still the only hospital performing heart transplants in Gujarat and the numbers were steadily growing. When COVID-19 struck in 2020 the spirit of organ donation was high. Even during the lockdown, Gujarat did India's first deceased organ donation during the pandemic where heart, liver, and kidneys were retrieved. Deceased donation has doubled in Gujarat compared to 36 donations in 2020 to 70 donations in 2021 and the number of organs donated increased from 110 to 223 organs in 2020 and 2021 respectively."

The Civil Hospital, Ahmedabad marked its 100 deceased organ donations within a period of two years with 77 livers, 152 kidneys, 23 hearts, and 18 lungs donated.

Vitamin D pills do not prevent bone fractures in kids: Study

LONDON, Dec 2 (Agencies): Vitamin D supplements do not increase bone strength or prevent bone fractures in children with the vitamin deficiency, claims a major clinical trial of over 8,000 kids.

Around one-third of children have at least one fracture before the age of 18. This is a major global health issue, as childhood fractures can lead to life years of disability or poor quality of life.

The findings, published in The

Lancet Diabetes & Endocrinology, challenges widely held perceptions relating to the effects of vitamin D on bone health.

"The absence of any effect of sustained, generous vitamin D supplementation on fracture risk or bone strength in vitamin D deficient children is striking," said Dr Ganmaa Davaasambuu, Associate Professor at the Harvard T.H. Chan School of Public Health.

Researchers from Queen
Mary University of London and

the Harvard T.H. Chan School of Public Health conducted the trial on children from Mongolia, a setting with a particularly high fracture burden and where vitamin D deficiency is highly prevalent.

Over the course of three years, 8,851 school children aged 6-13 living in Mongolia received a weekly oral dose of vitamin D

supplementation.
About 95.5 per cent of participants had vitamin D deficiency

at baseline, and study supplements were highly effective in boosting vitamin D levels into the normal range.

However, they had no effect on fracture risk or on bone strength, measured in a subset of 1,438 participants using quantitative ultrasound.

The findings are likely to prompt scientists, doctors and public health specialists to reconsider the effects of vitamin D supplements on bone health.

Axar Patel shines as India beat Australia by 20 runs to claim series

RAIPUR, Dec 2 (Agencies): Ignored for the upcoming assignment in South Africa, left-arm spinner Axar Patel responded with excellent figures of 3/16 as India got the better of Australia by 20 runs in the fourth T20I to win the fivematch series.

This was India's fifth consecutive T20I series on trot.

Rinku Singh blazed away to a 29-ball 46 while Jitesh Sharma smashed 35 in 19 balls before Australia pulled things back to stop India at 174 for nine after the visitors opted to bowl first.

Cruising at 167 for four in 18.3 overs, India lost five wickets for only seven runs in the last two overs, thanks to Ben Dwarshuis (3/40) and Jason Behrendorff (2/32).

In reply, Australia were restricted to 154 for seven in 20 overs as India took an unassailable 3-1 lead with a match to go. Matthew Wade remained not out on 36 off 23 balls.

Axar Patel (3/16) and Ravi Bishnoi (1/17) were magnificent, bowling eight overs for only 33 runs with four scalps to their credit. There was no dew and hence the target of 175 became defendable unlike Guwahati. Both spinners hit immaculate lengths and mostly bowled stump to stump which became Australia's undoing.

In the Indian Premier League, he has played 237 matches and amassed a staggering 7,263 runs at an average of 37.25. His prowess with the bat is highlighted by his seven centuries and 50 half-centuries, with a top score of 113.

In the 2023 season alone, Kohli scored 639 runs in 14 innings, boasting an impressive average of 53.25 and striking at 139.82. Kohli's consistent performances have made him a cornerstone of RCB's batting lineup and a formidable force in the league.

WPL Auction 2024: 165 players to go under the hammer on December 9

NEW DELHI, Dec 2 (Agencies): The Board of Control for Cricket in India (BCCI) on Saturday announced that 165 players have registered for the Women's Premier League (WPL) auction, scheduled to take place in Mumbai on December 9.

The auction list includes 104 Indians and 61 overseas players, 15 of whom are from associate nations. There are 30 slots available across the five teams, with nine reserved for international players. Only two players, West Indies star Deandra Dottin and Australia's Kim Garth, have established a base price of INR 50 lakh.

60 players were retained across five teams, including 21 overseas cricketers, while 29 players were released from their current squads. The 2023 WPL runners-up, Delhi Capitals, will enter the 2024 WPL auction with a purse of Rs 2.25 crore and hope to fill up to three spots. Gujarat Giants, who have dismissed more than half of their roster, have the greatest purse of



all five teams to fill ten vacancies, with Rs 5.95 crores.

Defending champions Mumbai Indians have up to five seats to fill in the auction, with a price of Rs 2.1 crore, while Royal Challengers Bangalore have seven unfilled slots and a purse of Rs 3.35 crore. At the auction, UP Warriorz will have a Rs 4 crore prize to fill five spots.

Dottin was purchased by Gujarat Giants in the WPL 2023 auction for Rs 60 lakh but was controver-

sially withdrawn from the competition before the season began. She was replaced in the Gujarat squad by Kim, although the 27-year-old Australian was one of 11 players released by the Gujarat franchise during the off-season.

Only four players, including Australian all-rounders Annabel Sutherland and Georgia Wareham, English wicket-keeper Amy Jones, and veteran South African pacer Shabnim Ismail, have set a base price of Rs 40 lakh.
