medico-legal formalities body was handed over to his family for last rites.


Day 2: Search ops to trace body of Sopore girl in Jhelum

NEW DELHI, Dec 7 (Agencies): As the Parliament convenes on Day 4 of the ongoing Winter Session on Thursday Union Home Minister Amit Shah will move the two bills the Jammu and Kashmir Reservation (Amendment) Bill, 2023; and the Jammu and Kashmir Reorganisation (Amendment) Bill, 2023 in the Rajya Sabha for consideration and passage. The two bills were earlier passed by the Lok Sabha on Wednesday.

The House saw a marathon debate over two days and passed the Jammu and Kashmir Reorganisation (Amendment) Bill,2023 and the Jammu and Kashmir Reservation (Amendment) Bill,2023.

"The Jammu and Kashmir Reservation(Amendment) Bill, 2023, Amit Shah to move the Bill further to amend the Jammu and Kashmir Reservation Act, 2004, as passed by Lok Sabha, be taken into consideration. Also to move that the Bill be passed," the Legislative agenda released

by the Rajya Sabha read. The Jammu and Kashmir Reservation (Amendment) Bill, 2023, was introduced in Lok Sabha on July 26, 2023. It



amends the Jammu and Kashmir Reservation Act of 2004. The Act provides for reser-

vation in jobs and admission in professional institutions to members of Scheduled Castes, Scheduled Tribes, and other socially and educationally backward classes.

The Jammu and Kashmir **Reorganisation** (Amendment) Bill, 2023 seeks to amend the Jammu and Kashmir Reorganisation Act, 2019.

The Act amended the Second Schedule of the 1950 Act to specify the total number of seats in the Jammu and Kash-

mir assembly. The proposed Bill increases the total number of assembly seats and reserves seven seats for Scheduled Castes and nine seats for Scheduled Tribes.

Meanwhile, a short-duration discussion on the "Economic Situation in the country will continue on day 4 of the Rajya Sabha.

"Further discussion on the "Economic Situation in the country" raised by Derek O' Brien on 5th December 2023," the legislative agenda read.

Earlier during a short-duration discussion on the 'Eco-

nomic situation in the country' in Rajya Sabha, Congress MP and former Union finance minister P Chidambaram on Tuesday said, "If India is growing at the fastest rate in the world, then why is the impact of the growth not felt on the ground? We are a large economy, we are growing at the fastest rate in the world & we have the largest FDI coming in, but why is it not seen on the ground? I specifically want to ask why is it not seen in the inflation and unemployment numbers?"

Taking part in the debate, the BJP MP Sudhanshu Trivedi weighed in on India's growth rate on the state of the national economy amid the prevailing global challenges in the Rajya Sabha in the ongoing Winter Session of Parliament and said that the country's robust GDP numbers reflect the "growth rate of Hindutva".

In a veiled dig at the previous Congress-led United Progressive Alliance (UPA) government at the Centre, Trivedi said the Indian economy was striving to go beyond 2 per cent, which was jokingly labelled as the "Hindu rate of growth".

Under the Agnipath scheme, which was introduced in 2022, soldiers are enrolled as Agniveers by the armed forces for four years. They can then go back to society and take up jobs in other sectors to pursue a career of their choice.

JAMMU, Dec 7: SOS International--an organization for PoJK Displaced Persons on Thursday strongly opposed to the decision of the Union Government to reserve a seat for the displaced PoJK people, saying it has "humiliated" and "insulted" the entire community having a population of 17 lakh people.

On behalf of the entire community, the organization while making a fervent appeal to the Centre to reconsider its three major demands including reservation of eight seats in J&K legislative assembly and grant of ST status to all the people of PoJK community cautioned that it would be compelled to launch a vigorous movement before Lok Sabha polls in case its demands are not met.

On Wednesday, the Lok Sabha passed the Jammu and Kashmir Reorganization (Amendment) Bill. which seeks to nominate two members from the Kashmiri migrant community including a woman and one representing the displaced persons from PoJK to the UT Legislative Assembly.

"The Lok Sabha passed the J&K Reorganization (Amendment) Bill and the PoJK DPs, who had been demanding eight seats in J&K legislative assembly since decades and strongly recommended by various Commissions and Committees over the years, have been given just one seat which is a cruel joke, a big humiliation and insult to them. The decision has rubbed salt into the wounds of PoJK people," the SOS International Chairman Rajiv Chuni in the presence of Prof. N. N. Sharma, V. K. JAMMU, Dec 7: Apni Party has demanded de-freezing of 8 Legislative Assembly seats out of 24 freeze seats in Jammu and Kashmir in favour of Pakistan

occupied Jammu and Kashmir (PoJK) - Displaced Persons.

In a joint statement to the press, Provincial President Jammu, Women Wing, Pavneet Kour and Provincial President Youth Wing, Jammu, Vipul Bali expressed grave concern over the negligence of the PoJK people who have been deprived of their representation in the Legisla-

tive Assembly. "For decades, our

population suffered after they were uprooted in 1947, 1965 and 1971 from their ancestral houses and agricultural fields. These Displaced Persons (PoJKs) were settled in the border belt of Jammu region on the Line of Control and International Border," they said.

They said that "The DPs were not given representation by reserving their seats in the Legislative Assembly. At the time, when the country has acknowledged different tribes and provided them reservation under the Indian Constitution, it becomes important to accept the political ignorance of the DPs and accordingly, 8 Legislative Assembly seats should be reserved for DPs in their respective constituencies across the Jammu region.'

"The nomination of one DP as legislator in the legislative assembly of J&K is not acceptable for the entire DP community. Therefore, the Govt must reconsider its decision, and grant political reservation on 8 Assembly seats in Jammu region," they

added. They said that the DPs have faced ignorance for decades and their issues could not be resolved by the traditional political parties even after assurances and re-assurances.

"The DPs used a vote bank, but they were not granted political reservation so that they could address their own problems. The DPs are socially, economically, and politically backward even after having a vast population in the region," they stated.

They said that the unemployment among young DPs has increased, and they are facing problems economically because of less scope of employment.



With Wonka lined up for release this week, here is a look at master storyteller Roald Dahl's works that have been adapted on to the screen

It's Roald Dahl's world and we are just living in it! At least that's what the last quarter of this year made us feel. First Wes Anderson pulled an ace with four shorts adapted into screenplay from the British author's short stories, and now director Paul King brings Willy Wonka's character (from Dahl's story Charlie and The Chocolate Factory) to life once more in theatres near you. We list some of the best adapted series/films of Dahl who is regarded as 'one of the greatest storytellers for children of the 20th century'. Wonka (2023)

Adapted by Paul King, who also co-wrote the screenplay with Simon Farnaby, it's the former's story on the origin of Willy Wonka, the character in Dahl's 1964 novel, Charlie and the Chocolate Factory. While Dahl featured early days of an eccentric Chocolatier, Wonka, King attempts to serve a prequel to the events of Charlie and the Chocolate Factory. The film titled Wonka is releasing on Friday, December 8.

In 1971, a film titled Willy Wonka & the Chocolate Factory was released, which had a screenplay by the author Dahl and starred Gene Wilder as the titular character. While Gene is still remembered for his historic portrayal of Wonka's character, thanks to Johnny Depp's role in



the 2005 film, Charlie and the Chocolate Factory, it won People's Choice Award for Favourite Family Film and Favourite Motion Picture Actor and BAFTA Kids' Vote for Best Film

In 2017, Warner Bros tried to revive the franchise with animation crossover titled Tom and Jerry: Willy Wonka and the Chocolate Factory, but it didn't create much buzz.

The Witches (2020) This dark fantasy comedy horror film directed by Robert Zemeckis is the second adaptation of Dahl's 1983 novel The Witches. The author, who had always loved to put child protagonist against evil adults, does the same, so just like Wonka, we have Grand High Witch in The Witches. In the 1990 adaptation, The Witches, academyaward winning actress Anjelica Huston elevates the screenplay with her performance. Whereas actress Anne Hathaway shone as Grand High Witch in the 2020's streaming edition. The BFG (2016) A fantasy adventure film

directed by Stephen Spielberg, The BFG is the second-highest grossing adaptation of Dahl. It starred Mark Rylance as the Big Friendly Giant (BFG) and Ruby Barnhill. Adapted from the 1982 novel, The BFG, it was previously made in 1989. Not many know that Dahl had dedicated the novel to his daughter Olivia Twenty, whom he lost to Measles virus, and the orphan girl's character was called Sophie after his granddaughter's name. Also, The BFG (1989) was the only adaptation of Dahl's works released during his lifetime and received praise from the author himself. It was an animated adaptation by Brian Cosgrove.

Matilda (1996)

Dahl's wife, Felicity Dahl served as a producer for the adaptation of the former's 1988 novel by the same name. The film is directed by Danny DeVito and starred Mara Wilson as the titular character, Matilda. Fantastic Mr Fox (2009)

Directior Wes Anderson's stopmotion animated comedy film is based on 1970 children's novel by Dahl. The star cast has some big names, including George Clooney, Meryl Streep, Jason Schwartzman, Bill Murray, Willem Dafoe and Owen Wilson. The film won New York Film Critics Circle Award for Best Animated Film. Netflix Ready

In September 2023, Anderson delved into the lesser-known stories of Dahl titled The Wonderful Story of Henry Sugar, The Swan, Poison and The Rat Catcher. The extensive universe of animated and live-action film that Anderson created received a lot of applause. Even the cast had names like Ralph Fiennes, Benedict Cumberbatch, Dev Patel, Ben Kingsley, Rupert Friend and Richard Ayoade. Another animated film The Twits, coming to Netflix in 2025, is helmed by Phil Johnston. It is the first screen adaptation of Roald Dahl's book by the same name.

Angelina Jolie says she wouldn't be an actress today, plans to leave Los Angeles

Oscar winner Angelina Jolie says she probably wouldn't pursue acting as a career if she was just starting out in the industry today.

Born to actor parents Jon Voight and Marcheline Bertrand, the 48-year-old said she "really has a social life" living in Los Angeles since every time she leaves her house, she is subjected to unwanted attention by the paparazzi, which is also one of the reasons why she eventually wants to move from Hollywood. "I wouldn't be an actress today.

When I was starting out, it wasn't as much of an expectation to be as public, to share so much," Jolie told the Wall Street Journal Magazine.

"It's part of what happened after my divorce. I lost the ability to live and travel as freely," she said referring to the high-profile and bitter separation from her 'Mr & Mrs Smith' co-star and former husband Brad Pitt.

In the interview, Jolie also noted that she hopes to spend more time at her home in Cambodia, from where her adoptive son Maddox (22) hails from. "I will move when I can," she added.

Jolie made her screen debut as a child alongside Voight in 1982's 'Lookin' to Get Out' and went on to carve her niche as a leading actor with films such as her Oscar-winning turn in 'Girl, Interrupted', 'Lara Croft: Tomb Raider', 'Salt', 'A Mighty Heart' and 'Maleficent'.

The actor, also known for her humanitarian efforts, admitted that she "was never very impressed" with Hollywood.

"I never bought into it



as significant or important. I grew up in quite a shallow place Of all the places in the world, Hollywood is not a healthy place. So you seek authenticity," she said, adding fame post her Oscar win led to depression and at times, suicidal thoughts. Being in the public eye for almost all her life, Jolie said the stress post her separation from Pitt in 2016 got so bad that during shooting of the Disney sequel 'Maleficent: Mistress of Evil' her voice had changed registers from when she first played the titular fairy tale villain. "My body reacts very strongly to stress. My blood sugar goes up and down. I suddenly had Bell's

palsy six months before my divorce," she added. Her last screen appearance was 2021's 'Eternals'.

PM Modi cites poll win data to assert BJP most preferred party for governance

Speaking at the BJP Parliamentary Party meeting, he credits 'team spirit' for the party's big win in the recent assembly polls

NEW DELHI, Dec 7 (Agencies): Prime Minister Narendra Modi on Thursday cited poll data to assert that the BJP has become people's most preferred for governance as its record of winning state elections while in power is much better than the Congress.

Speaking at the BJP Parliamentary Party meeting, he credited "team spirit" for the party's big win in the recent assembly polls, noting that besides winning in three states it has also grown in strength in Telangana and Mizoram.

Quoting Modi, Parliamentary Affairs Minister Pralhad Joshi told reporters that the Congress faced assembly polls 40 times while in power for one term in those states and could win only



seven of them, having a dismal success rate of 18 per cent. The corresponding figures for the BJP is 22 out of 39 times, a success rate of 56 per cent, Modi noted.

Regional parties have fared better than the Congress but not the BJP as they won 18 of 36 times when in power, notching up a success rate of 50 per cent. It shows the BJP is the most preferred party for running the government, he said.

Earlier, Modi was given a standing ovation at the meeting following the party's stupendous win in three assembly polls.

Party MPs raised slogans lauding his leadership as senior leaders, including BJP president JP Nadda, felicitated Modi at the first meeting of the BJP Parliamentary Party in Parliament's Winter Session.

The BJP scored a thumping win over the Congress in the assembly polls to three states of Madhya Pradesh, Chhattisgarh and Rajasthan.

Modi's leadership has been cited as the primary reason for its big win.

Live-in relationship 'dangerous disease', should be law against it: BJP MP

NEW DELHI, Dec 7 (Agencies): A BJP MP from Haryana on Thursday termed live-in relationships a "dangerous disease" that needs to be eradicated from society and urged the government to make a law against it.

Raising the issue in the Lok Sabha during 'zero hour', Dharambir Singh also said divorce rates in love marriages were high and the consent of the parents of the bride and groom should therefore be made mandatory for such alliances.

"I want to bring to the notice of the government and Parliament a very serious issue. Indian culture is known for its philosophy of 'Vasudhaiva Kutumbakam (world is one family) and brotherhood. Our social fabric is different from others in the world. The whole world is impressed by our unity in diversity,' the MP from Bhiwani-Mahendragarh said.

Noting that India has a long tradition of arranged marriages,

"Such relationships are very common in western nations but this evil is fast spreading in our society also and the consequences are horrible. Recently, the case of Shraddha (Walkar) and Aftab (Poonawala) had come to light in which both were in a live-in relationship," Singh said.

Such cases keep coming to the fore almost daily, he added while referring to the gruesome case in Delhi of a man allegedly killing his live-in partner and chopping her body to pieces. "Not only this is ruining our culture but also hatred and evils are spreading in the society. If this continues our culture will die and there will be no difference between us and others," he said

"I request the minister that a law be made against live-in relationships so that this dangerous disease can be eradicated from society,' Singh said.

NEW DELHI, Dec 7 (Agencies): The Supreme Court on Thursday asked the Centre why did it single out Assam and exclude West Bengal from grant of citizenship under section 6A of the Citizenship Act when the latter shares a much larger border with Bangladesh. Section A of the Citizenship Act relates to illegal immigrants in Assam.

Observing that illegal immigration is a serious problem, a five-judge Constitution bench headed by Chief Justice DY Chandrachud asked Solicitor General Tushar Mehta, appearing for the Centre, what is the Union government doing to safeguard the border.

"Why did you single out Assam when West Bengal shares a much larger border with Bangladesh? We want to know why was West Bengal excluded from the grant of citizenship. The argument cannot be that there was agitation in Assam. Why was West Bengal left alone. What is the position in West Bengal now? the bench also comprising Justices Surya Kant, M M Sundresh, J B Pardiwala and Manoj Misra said

As the hearing commenced the Centre clarified that examination of the constitutional validity of Section 6A of the Citizenship Act, has nothing to do with any other amendments in the Citizenship Act.

Mehta told the fivejudge constitution bench that the application of section 6A is limited to only a specific period of time.

"I would like to begin with some factual clarifications. Your lordships are examining a limited question of constitutional validity of Section 6A. This is confined to a very few individuals during a particular period of time. This examination has nothing to do with any other amendment to Citizenship Act," he told the bench.

Court questions singling out of Assam Mehta told the top court that so far as the contentions as pointed out by the petitioners are concerned like influx of immigrants from foreign countries, paucity of resources that were otherwise available to them, etc, all their con-

cerns are true. "Person is deemed citizen if his parents or any grandparents were born in undivided india. The category is very limited- it applies in Assam, a limited geographical area. The category from which persons are permitted is only Bangladesh, a very limited area," Mehta said.

During the hearing, the CJI remarked that there were people who benefited from the grant of citizenship under Section 6A.

"What happens to those who weren't granted the benefit of citizenship but are illegal immigrants. Nothing was done about them at all. Everyone who came between 1966-1971 did not get citizenship

because for citizenship they needed to be detected. So within that larger circle, there is a smaller circle of people who came to India but never got citizenship. What happened to those people?, the CJI asked. The hearing is currently underway.

Section 6A was inserted in the Citizenship Act as a special provision to deal with the citizenship of people covered under the Assam Accord.

It says those who came to Assam on or after January 1, 1966 but before March 25, 1971 from specified territories, including Bangladesh, in accordance with the Citizenship Act amended in 1985, and since then are residents of the northeastern state, must register themselves under section 18 for acquiring Indian citizenship. As a result, the pro-

vision fixes March 25, 1971 as the cut-off date for granting citizenship to Bangladeshi migrants in Assam.

Israel battles Hamas in south Gaza City; armoured tanks bulldoze into Khan Yunis

The Israeli army said it had pierced defensive lines and carried out "targeted raids" in the heart of the city", where they found and destroyed 30 tunnel shafts.

JERUSALEM, Dec 7 (Agencies): Israeli troops battled Hamas militants Thursday in the heart of southern Gaza's main city where a suspected mastermind of the October 7 attacks is believed to be hiding while pressing their offensive across the besieged territory. Breaking through Hamas's defences of Gaza's second largest city, Israeli troops, tanks, armoured personnel carriers and bulldozers rolled into Khan Yunis, forcing already displaced civilians to flee again, witnesses said.

Hamas said late Wednesday on Telegram its fighters were engaged in fierce battles against Israeli troops "on all axes of the incursion into the Gaza Strip", as it claimed they destroyed two dozen military vehicles in Khan Yunis and Beit Lahia in the north of the territory.

Earlier, the Israeli army said it had pierced defensive lines and carried out "targeted raids in the heart of the city", where they found and destroyed 30 tunnel shafts.

Ramaswamy calls Haley a "fascist", "corrupt"; she says responding to him "not worth her time"

WASHINGTON, Dec 7 (Agencies): Calling her "fascist" and "corrupt". biotech entrepreneur Vivek Ramaswamy launched a tirade against his Republican presidential rival and fellow Indian-American Nikki Haley, who refrained from a verbal duel, saying it is not worth her time to respond to him.

Ramaswamy launched the volley of charges against the former South Carolina governor and US ambassador to the UN in Arizona during the Republican Party's fourth presidential debate, which was attended by just four candidates, the other two being former New Jersey Governor Chris Christie and Florida Governor Ron DeSantis.

The front-runner for the Republican Party's nomination, former President Donald Trump, skipped the debate once again and held a fundraiser in Florida instead.

Participating in the debate, Ramaswamy, 38, accused Haley of having "a corruption problem" and held up a pad of paper with "NIKKI = CORRUPT" written on

UN chief Antonio Guterres invokes UN Charter article to appeal for humanitarian ceasefire in Gaza

This is the first time that Guterres has invoked Article 99 of the Charter since he became UN Secretary-General in 2017.

UNITED NATIONS, Dec 7 (Agencies): UN chief Antonio Guterres has invoked a rarelyused article in the United Nations Charter to appeal to the Security Council for a humanitarian ceasefire in the Israel-Hamas conflict and to avert a "humanitarian catastrophe", which he said has "potentially irreversible implications" for Palestinians and peace in the region.

Secretary-General Guterres issued a letter to the President of the Security Council for the month of December, Ambassador Jose Javier De La Gasca Lopez Dominguez, the Permanent Representative of Ecuador to the UN, writing under Article 99 of the UN Charter.

Article 99 was last specifically mentioned in a report on December 3, 1971, by then Secretary-General U Thant on the situation in East Pakistan, now Bangladesh.

India had emerged victorious against Pakistan in the 1971 war, which led to the creation of Bangladesh.

This is the first time that Guterres has invoked Article 99 of the Charter since he became UN Secretary-General in

2017. Article 99 states that the Secretary-General may bring to the attention of the Security Council any matter which in his opinion may threaten the maintenance of international peace and security. In the letter, Guterres

said that more than eight weeks of hostilities in Gaza and Israel have created appalling human suffering, physical destruction, and collective trauma across Israel and the Occupied Palestinian Territory.

Guterres urged members of the Security Council to press to avert a humanitarian catastrophe and appealed for a humanitarian ceasefire to be declared.

"We are facing a severe risk of collapse of the humanitarian system. The situation is fast deteriorating into a catastrophe with potentially irreversible implications for Palestinians as a whole and for peace and security in the region. Such an outcome must be avoided at all costs." Guterres said.

Underlining that the international community has a responsibility to use all its influence to prevent further escalation and end this crisis, Guterres urged members of the Security Council to press to avert a humanitarian catastrophe.

"I reiterate my appeal for a humanitarian ceasefire to be declared. This is urgent. The civilian population must be spared from greater harm," he said, voicing deep concern that "nowhere is safe in Gaza.'

The UN chief noted that with a humanitarian ceasefire, the means of survival can be restored and humanitarian assistance can be delivered in a safe and timely manner across the Gaza Strip.

Stephane Dujarric, Spokesperson for Guterres, said the UN Chief's invocation of Article 99 is a "very dramatic move" within the



constitutional context of the United Nations.

"We understand that the perception from the outside world may be a little different. But for us, it is a very powerful move on behalf of the Secretary-General. And we hope that members of the Security Council will be moved by it, and we hope the international community will be moved by it to push and put in place a humanitarian ceasefire," Dujarric said.

Responding to a question, Dujarric said Guterres is invoking "one of the few powers" that the Charter gives him.

"Constitutionally, it is 'the most powerful tool that he has.' It is a very dramatic constitutional

move by the Secretary-General of the United Nations," Dujarric said, noting that the actual invocation of Article 99 has not happened in decades. UN Director at non-

profit organization Crisis Group Richard Gowan told PTI that invoking Article 99 is primarily a "symbolic gesture" by Guterres and cautioned that it is "unlikely to have much real impact on the Council.' By citing Article 99, Guterres may hope that it gives some "extra energy" to a resolution by the UAE that demands an immediate humanitarian ceasefire,

Gowan said, adding that he fears the US is still likely to block the text regardless of what

Guterres says. "I think that Guterres used this language today to focus attention on his letter to the Council, which would otherwise have gotten lost in all the diplomatic noise over Gaza." Gowan said.

"The tragic reality is that the media and public have become increasingly accustomed to warnings of a humanitarian disaster in Gaza. Guterres has been consistent in sounding the alarm about threats to Palestinian civilians. This has angered Israel, but as the war has dragged on, I think his messages have lost impact, and almost become routine," Gowan said

He noted that it is rare for the Secretaries-General to explicitly invoke Article 99 in this way and said that neither former UN Chief Kofi Annan nor his successor Ban Ki-moon ever did so.

Ans: The presumption will be against you, unless you have opted out of the group or reported the group to the police authorities. It will be presumed you agree and approve the content shared in the group as a conspirator.

"If I am able to put what skills, experience, and understanding of public service broadcasting I have built up during my career to help this brilliant organisation meet the complex and diverse challenges it faces over the coming years, it would be an honour," he added.

"The BBC has a great place in British life and a unique duty to reach a wide audience right across the country and I will do all I can to ensure it fulfils this in an increasingly competitive market," Shah further said. Born in Aurangabad, Shah came to England in 1960 and has previously been the head of current affairs and political programmes at the BBC.

The CEO and owner of Juniper, an independent television and radio production company, Shah has also served as a nonexecutive director of the BBC between 2007 and 2010.

Besides, the Oxford University alumnus is a race relations expert who co-authored the government's Commission on Race and Ethnic Disparities report in 2021.

More recently, he was named on a threemember panel set up by the government to independently review the unrest that took place in the city of Leicester last year, as community groups clashed in the aftermath of an India-Pakistan cricket match.

As per the Centre's submissions to the lower House of parliament, a large part of the amount will be allocated to subsidies on fertilizers and food. Considering Apple's request against universal charging ports, says govt

NEW DELHI. Dec 7 (Agencies): India is still considering the request made by Apple not to mandate universal charging ports for its existing iPhones, said minister of state for electronics and information technology Rajeev Chandrasekhar.

The minister said the government took suggestions from all stakeholders on the issue, and it will soon come up with its decision.

"There is still consultation going on the issue of mandating universal charging ports for all smartphones in the country.

We have sought views from all stakeholders, and Apple has raised concern on it, and we said we will look into the matter," said the minister.

The American tech-giant Apple, in a meeting with Meity officials, urged officials to exempt existing iPhone models from the regulation. The company said that its local production goals might suffer due to this decision. Also, the company would not be able to meet its production targets set under the country's production-linked

incentive (PLI) scheme. The European Union (EU) has already given device manufacturers a deadline of December 2024 to add Type-C chargers in all electronic products. In India, a committee of the Ministry of Consumer affairs has given time till June 2025 to implement the common USB Type-C wired charging standard. As per the reports, the Minis-

try of Consumer Affairs sent its recommendation to the Ministry of Electronics and Information Technology information technol-

ogy (Meity). Now Meity will prepare a framework to implement the common USB Type-C wired charging standard. Most manufacturers, including Samsung, have agreed to comply with the rule, but Apple is yet to endorse the plan.

In FY23, India exported more than \$11.12 billion worth of mobile phones, of which Apple accounted for around \$5 billion, Samsung contributed about \$4.5 billion, with the remainder coming from Indian and Chinese brands.

HANOI/MANILA, Dec 7 (Agencies): The World Organisation for Animal Health (WOAH) is warning that more testing of African swine fever vaccines is needed, triggered by Vietnam's plans to export doses in coming months to fight a disease that regularly ravages pig farms worldwide.

In a world first, Vietnam authorised in July two attenuated livevirus vaccines against the disease, which is not deadly to humans but is extremely infectious among pigs and has caused repeated disruptions to the global pork market, which data provider Research and Markets said was worth about \$250 billion in 2022.

WOAH says AVAC Vietnam JSC, the producer of one of the two vaccines, has not shared sufficient data with international researchers and bodies.

Gregorio Torres, head of the science department at WOAH, urged countries interested in using AVAC's vaccines to conduct their own trials before approving it.

In October, as AVAC was about to announce deals with importers of its vaccine in the Philippines, Indonesia, Malaysia, India and Myanmar, WOAH warned of risks "from use of sub-standard vaccines".

Torres said that Vietnam's announcements led to the warning, but that it was not linked to concerns about specific vaccines. AVAC says that its vac-

cine is not dangerous and that widespread use will demonstrate it.

"We have proven our product is safe and effective and we need some time to prove that to all, including those showing concern," Nguyen Van Diep, AVAC's chief operating officer, told agency. He said the company had shared data. Nguyen Van Long, head of Vietnam's Animal Health Department, said on Wednesday data on trials had been discussed in international conferences and meetings.

Diep said that the vaccine had been safely used in farms in 17 provinces in Vietnam since its approval and that



for farms that become infected.

China has also developed several vaccines but none has gotten commercial approval. AVAC is producing between 2.5 million and 5 million doses a month and was planning to export 5 million, pending approval from the countries where the company signed commercial deals, Diep said, noting that a green light from the Philippines might come early next year.

Trade sanctions? Torres said the agency

was discussing a new global standard for evaluating ASF vaccines, with possible approval coming in May at the WOAH general assembly. The intergovernmental organisation, based in Paris, has 183 member states.

The standard would not be compulsory, as national regulators decide on approvals, but it could lead to trade restrictions against porkexporting countries that vaccinate pigs with substandard shots.

The AVAC vaccine was trialled in the Philippines with 300,000 doses. The Food and Drug Administration of the Philippines, which is in charge of the vaccine approval, did not reply to requests for comment.

Philippines Agriculture Undersecretary Deogracias Victor Savellano told Reuters his country had not approved or purchased the vaccine yet, noting the regulator's authorisation was critical to food security, as the country faces a national emergency caused by the spread of ASF. Regulators from India, Indonesia, Myanmar and Malaysia did not respond to requests for

comment. The second approved ASF vaccine, produced by Vietnam's Navetco Central Veterinary Medicine from a USDA platform, had shared positive trial data and is being tested in the Dominican Republic, the USDA said.

Researchers from Stanford University conducted an extensive study involving 22 pairs of identical twin adults to assess the impact of one twin adopting a vegan, devoid-of-animal-products diet compared to the other twin following an omnivorous diet rich in animal and

and lower insulin levels, as outlined in the study's findings.

"The findings from this trial suggest that a healthy plant-based diet offers a significant protective cardiometabolic advantage compared with a healthy omnivorous diet," the study's authors wrote.

The study's findings are an extension of previous research showing that plant-based diets are better than nonplant-based diets for cardiovascular health.

What is a vegan diet? A plant-based diet, commonly known as veganism, centres around consuming plant-derived sources like vegetables, grains, nuts and fruits.

People adhering to a vegan lifestyle abstain from consuming animalderived foods, which includes excluding dairy products and eggs from their diet.

Despite missing trials, Sameer Rizvi may set IPL auction on fire

CHENNAI, Dec 7 (Agencies): Sameer Rizvi impressed all and sundry with his powerpacked performances during the inaugural Uttar Pradesh T20 League in August-September this year. Kanpur Superstars, the team he was leading, might not have qualified for the knockouts but his show with the willow — he scored 455 runs from nine innings including two centuries (the second of which was the fastest of the tournament) was enough for scouts from various IPL teams to invite the right-hand batter from Meerut for the trials before the miniauction.

As luck would have it, Sameer, who turned 20 on Wednesday, had to miss those trials as he was asked to lead the Uttar Pradesh team in the Men's U-23 State A (ODI) Trophy. Incidentally, he was playing for the senior state team in the Syed Mushtaq Ali T20 Trophy in Mohali and scored 42 not out against Punjab in the losing cause when the UP Cricket Association asked him to join the U-23 squad playing its matches in Chandigarh. The next day, he scored 91 off 65 in the U-23 tournament against Rajasthan but the innings, which was laced with four 4 and 9 sixes, once again went in vain. However, that turned out to be the last blip in UP's campaign as Sameer scored two consecutive centuries to help the team in the pre-quarterfinals. After the team won those knock-out matches, he again hammered a 50-ball 84 as UP defeated Uttarakhand in the final to lift the title.

"He got calls for trials with almost all franchises after his good show during the UP T20 League but he had to skip them as he was given the command of the U-23 state team," Tankeeb Akhtar, Sameer's coach and maternal uncle, told this daily from Meerut.

Despite missing the trials, the coach is hopeful that he will be picked up by one of the IPL teams in the auction scheduled on December 19. "He has registered in the uncapped players' category and I am sure he will get the buyer," added Tankeeb, who is the sole reason why Sameer started playing cricket at the age of 6. "I shifted from my village to Meerut so that I could pursue cricket in 2004. I stayed with my sister Rukhsana Khatoon.

There I realised I was too late to play cricket professionally so I switched to coaching. It was at Gandhi Bagh Cricket Academy where Sameer started playing cricket in 2009. Earlier his father and my brother-in-law Haseen Rizvi used to get angry as Sameer was not focussing on his studies but once he started playing for Uttar Pradesh everything got sorted," recalled the coach.



Sameer made his Ranji Trophy debut in January 2020 when he was only 16 but the stint ended with only two matches. He then made a comeback to the state team, this time in the 50-over format, the next year and since then he has been an integral part of both the one-day and T20 squads.

Gram Sabha resolution for diversification of **Forest Land a must: Minister**

JAMMU / NEW DELHI, Dec 7: Minister of State for Tribal Affairs Bishweswar Tudu answering a question by MP Rajya Sabha Er. Gulam Ali Khatana on Forest Rights Act stated that Land and its management falls under the exclusive legislative and administrative jurisdiction of States as provided under the Constitution of India [Seventh Schedule -List ii (State List) - Entry No. (18)] 'The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (In short FRA) seeks to recognize and vest the forest rights and occupation in forest land in Forest Dwelling Scheduled Tribes and Other Traditional Forest Dwellers who have been residing in such forests for generations but whose rights could not be recorded. The Minister said as per FRA

and rules made there under State Governments / UT Administrations are responsible for implementation of various provisions of the Act. Sub-section (2) of Section 3 of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 provides that notwithstanding anything contained in the Forest (Conservation) Act, 1980, the Central Government shall provide for diversion of forest land for certain facilities managed by the Government, as specified in that Section, which involve felling of trees not exceeding seventy-five trees per hectare, provided that such diversion of forest land shall be allowed only if, - i. the forest land to be diverted for the purposes mentioned in the said sub-section is less than one hectare in each case; and ii. the clearance of such developmental projects

shall be subject to the condition that the same is recommended by the Gram Sabha.

However, the details regarding cases of land diversification is not centrally maintained in this Ministry. As per the guidelines issued by the Ministry dated 18th May 2009 in consultation with Ministry of Environment and Forest with regard to seeking prior approval for diversion of forest land for non-forest purpose under Section 3(2) of FRA, the user agency (a department of the Central or State Government or District Panchayat making a request for diversion of forest land for development project) is required to submit resolution adopted by the Gram Sabha to Range Forest Officer (RFO), who in three months time will record his views and submit to District Forest Officer (DFO) and DFO in turn, will have to communicate his decision in four weeks from the date of receipt of proposal from RFO, Minister replied.

MP Rajya Sabha Er Gulam Ali Khatana had sought details regarding the comprehensive update on the number of cases of land diversification processed under the Forest Rights Act (FRA) 2006 across India, specifying the progress made in each state; the details of copies of the pilot projects initiated under the FRA for land diversification, along with documented success stories, to offer insight into the effectiveness of these initiatives; and whether there is any predetermined time schedule for obtaining a clearance from the relevant agencies for land diversification projects under the FRA, if so, the details on established timelines and any measures taken to ensure timely approvals?
