Uri accident death count reaches 10 as 2 more succumb to injuries

SRINAGAR, Feb 1 (Agencies): Two persons, injured in a road accident in Baramulla's Uri. have succumbed to their injuries, taking the death count to 10.

Principal GMC Baramulla, Dr Ruby that two more injured persons succumbed to their injuries late last night.

She said that they were referred to SKIMS Soura last night, where they succumbed to their injuries

They have been identified as Shabir Ahmed son of Abdul Gani and Shabir Ahmed son of Mohammed Abdullah--both residents of Bujithallan.

Eight persons were killed, while seven were injured after a vehicle skidded off and fell into a deep gorge in Baramulla's Boniyar on Wednesday evening.

25 crore people came out of poverty in last 10 years: Sitharaman



NEW DELHI, Feb 1 (Agencies): Finance Minister Nirmala Sitharaman on Thursday said that the government believes in "empowering the poor" and in the last ten years, at least 25 crore people have been assisted to get freedom from multidimensional

poverty. Sitharaman said that fulfilling aspirations and needs of Garib (poor), Mahilave (women), Yuva (youth) and Annadata (farmers) are the highest priority of the government.

"When the poor become empowered partners in the development process, the to assist them also increases manifold," the Finance Minister said while presenting the

2024 Interim Budget in Lok Sabha.

She said that direct benefit transfer (DBT) of 34 lakh crore rupees using PM Jan Dhan accounts has led to saving of 2.7 lakh crore to the government, which has strengthened the welfare of the poor.

Sitharaman said that 78 lakhs street vendors were given credit assistance under PM Swanidhi scheme while end to end support was given to artisans and craftsmen under PM Vishwakarma Yojna.

"Under the PM Kisan Samman Scheme, every vear direct cash assistance was given to 11.8 marginal and small farmers," she said.

NEW DELHI, Feb 1 (Agencies): Jammu and Kashmir has been allocated Rs 37,277.74 crore in the interim union budget for 2024-25, which was unveiled by Union Finance Minister Nirmala Sitharaman in the Lok Sabha on Thursday

According to details available, Rs 37277. 74 crores have been allocated to J&K for the next fiscal year. Of this, Rs 35,619.30 crore alone have been kept for bridging resource gap in the Union Territory.

This was the last budget of PM Modi led government ahead of the Lok Sabha elections scheduled to be held in April-May this year.

Unruly delay in holding polls weakens democratic institutions in J&K: Manjit

VIJAYPUR, Feb 1: Apni Party Provincial President, Jammu, and Former Minister, Manjit Singh today expressed concern over unruly delay in holding elections for Legislative Assembly in Jammu and Kashmir that has weakened the democratic institutions.

He said that these institutions i.e., elected Govt, Panchayati Raj Institution (PRI), Block Development Council (BDC), Urban Local Body (ULB) should be restored because the people in both the regions of Jammu and Kashmir have been facing the brunt of the administrative rule that ignores the public view

and frame policies as per their wishes.

The Former Minister gave this statement during a monthly meeting of the Apni Party leaders here at Vijaypur to review the working of the Party and its units, besides, holding threadbare discussion regarding the existing political situation.

During the meeting, Manjit Singh referred to various development issues, widening work of Jammu-Srinagar Highway as a part of Expressway that has dented the business activities, and constantly posed threat of road mishaps with bad condition of highway from Vijaypur, Bari Brahmana up to Kunjwani.

"The shopkeepers in Vijaypur and adjoining areas along the national highway have suffered badly with the widening work, and more so with regard to the compensation that was insufficient," he said.

He said that had there been an elected Govt in J&K, the local issues would have been addressed as per the wishes of the people while keeping a balanced approach. However, the situation is opposite in the present form of Govt where the babus are not considering the public concerns and proceeding with their planned initiatives even if it compromises the interest of the public.

"Unfortunately, the

developmental works/ initiatives taken up by the administration in Jammu and Kashmir could not be completed in a time bound manner, and there was no accountability on the officials despite lapse of time, and passing of deadlines," he said.

He also referred to the exploitation of the local population as contractbased workers in industrial workers. "The industrial units

GOVERNMENT BUDGET

ith the emergence of welfare states, governments are paying attention to virtually every area of human life. They have to perform various types of tasks to protect their respective areas, to maintain law and order, and to implement schemes for economic and social betterment. Apart from this, they provide social services like education, health, employment and housing to the people.

Needless to say, the government requires adequate resources to perform these functions effectively. Where will this money come from and who will approve the money? The funds required for government expenditure are raised from the country's resources such as direct and indirect taxes and both long and short term loans. The main source of revenue in India is income tax imposed on individuals and companies, including customs and excise duties.

It is not that the government can impose taxes, take loans and spend money as per its wish. Since there is a limit to resources, there is a need for proper budgetary arrangement for allocation of resources to various government activities.

Each item of expenditure should be thoroughly considered and the total outlay for a given period should be arrived at. Prudent expenditure is essential for the stability of the government and the first requirement of prudent expenditure is adequate income. Therefore, planned expenditure and accurate estimation of income are essential elements of sound government finances.

Our parliamentary system of government is based on the Westminster model. Therefore, the Constitution has handed over finance related powers to the elected representatives of the people thereby proving the principle of "No taxation without representation". It is the constitutional responsibility of the Central Government and State Governments to prepare the budget for the approval of the Legislature.

Legislative prerogative over taxation, legislative control over expenditure and executive initiative over financial matters are some of the basic principles of the parliamentary financial control system.

Discussion on the budget begins a few days after it is presented. In a democratic framework, the government is keen to give Parliament full opportunity to discuss various proposals for budgetary provisions and taxation.

Generally, approval of Vote on Account is taken for two months. But if in an election year, or when it is anticipated that it will take more than two months to pass the main grants and appropriation bills, the vote on account may be taken for a period longer than two months.

The budget is discussed in two stages in the Lok Sabha. First, there is a general discussion on the full budget. This discussion continues for 4 to 5 days. In this stage, the broad outline of the budget and the principles and policies underlying it are discussed.

Will Modi's 'new era' end old conflicts?

he "pran pratistha" ceremony at the Ram Mandir in Ayodhya on January 22 had little to do with religiosity and was essentially an audio-visual spectacle.

Significantly, the event was conspicuous by erasing the lines between religion and the Indian State. This marked a big stride from the blurring of lines between religion and politics per se. The shadow of religion on politics, many would argue, always existed despite the founders of the Indian Republic choosing a secular character for the nation. This darkness became more ominous from the 1980s when the agitation for constructing the Ram temple was started by the Sangh Parivar. It has become all the more conspicuous from 2014 onwards after Prime Minister Narendra Modi took office ten months after emphatically declaring: "Yes, I am a Hindu nationalist".

The origins of this agitation followed the deeply revivalist 1983 Ekatmata Yagna, when waters from rivers considered holy by Hindus were paraded across the country by the Vishwa Hindu Parishad. Later, the movement gathered pace from late 1985 after protests by conservative sections among Muslims against the Supreme Court's Shah Bano ruling triggered a panic response from the Rajiv Gandhi government. He eventually passed a law to nullify the verdict. The VHP and leaders of its ideological fountainhead, the RSS, argued this was an instance of the Congress and the Indian State "appeasing" Muslims. Driven by myopic vision, Rajiv Gandhi opted to facilitate opening the lock on the Babri Masjid for Hindu devotees to enter and offer prayers without

restrictions.

Yet, although later Prime Ministers, especially P.V. Narasimha Rao, under whose watch the Babri Masjid was demolished, allowed the issue to remain a ticking timebomb, no one formally embraced the issue and the movement as thoroughly as Mr Modi has.

There is little ambiguity the central figure on January 22 was not Lord Ram or his idol(s). Instead, the spotlight was more on Mr Modi and the entire ceremony was more of an "event" than a religious consecration. The sheen from the function had earlier faded after the shankaracharyas decided to stay away and it became a celebrityheavy gathering. Carpet-to-carpet television coverage via video feeds by Doordarshan ensured that nothing else was telecast during the ceremony. Although in days prior to the ceremony, most TV channels had gone "ballistic" insofar as coverage from Ayodhya was concerned, few details were available on its run-order. Viewers were therefore all eyes because they knew little of what was to

Undoubtedly, viewer-interest was high in the live proceedings. In the absence of empirical evidence, there is no knowing whether the semi-constructed temple's inauguration was endorsed by the people. But, given the tumultuous gathering of devotees from the day it was opened to the public, it appears that they have accepted its "incompleteness" without much rancour. There is no indication that they are critical of Mr Modi for also enacting the role of a high priest of Hinduism while being the PM too. It must be recalled that the people have been prepped up for this as it wasn't the first time Mr Modi publicly performed a religious ritual. In 2014, when he first contested from Varanasi, Mr Modi was first denied permission by the district administration to perform Ganga aarti before the polling day. But after his victory, he did so with then BJP president Rajnath Singh and Amit Shah in full glare of TV cameras after prior intimation to TV channels. Thereafter, on almost every visit to the city, he repeated the act and even went to the Kashi Vishwanath temple, not just as a devotee but to perform religious rituals.

This practice continued throughout his first term as PM in several cities till the "climax" as polling was ending in 2019. At that time, he headed to the Kedarnath shrine and closeted himself alone, with the exception of a camera-person briefly, inside the "cave room" where he appeared to be meditating deeply. The impact this had on voters turning out during the last phase of polling was noted then. Subsequently, in December 2021, three months before crucial Uttar Pradesh Assembly elections, the PM addressed the gathering at the inaugural of his flagship Rs 800-crore Kashi Vishwanath Dham project in Varanasi. Mr Modi projected more of a "Baba" image than that of a Prime Minister, initially by a prolonged dip in the Ganga while performing religious rituals in a luminous hue of saffron. Later, after performing rituals, while delivering his mandatory speech, Mr Modi donned the role of chief of a monastic order. In the speech, he claimed that virasat (heritage) and vikas (development) go hand in hand. Significantly, whenever Mr Modi refers to Indian heritage, it is intrinsically Hindu, suggesting that the nation does not have any non-Hindu heritage worth its name.

Although Mr Modi merely continued with the past practice of turn-

ing out in Hindu religious attire, his performative act in Ayodhya is different as the temple inauguration came at the end of a watershed agitation, for close to four decades. Further, the event in Ayodhya drew greater public response and critical review because of the buildup, and the importance of the day being underlined by Mr Modi. He said it was "not just a date on the calendar" but "the dawn of a new era". January 22, he added, marked the beginning of "the expansion of consciousness from Dev (God) to Desh (country) and from Ram to Rashtra (nation)". On that day, he said, the foundation for India's "next 1,000 years has been laid".

It is true that on January 22, Mr Modi resembled to the core the high priest of Sanatan Hinduism. However, it must be noted that that scale of the event and the nature of the Ayodhya ceremony was more grandiose and significant. But if detailed scrutiny is made of the Prime Minister's public functions in the backdrop of temples or religious events from the time he assumed office, it would be evident he has been true to his style from the beginning. Significantly, the Supreme Court in November 2019 in its judgment called for a closure to the fierce conflict between Hindus and Muslims based on prejudice and distrust. In the 40 months since the foundation stone for the temple was formally laid, no progress was made towards bringing the curtain down on this bitter dispute. As the ruling party pushes towards another electoral victory even as the controversy surrounding the Gyanvapi Masjid in Varanasi and the Shahi Idgah in Mathura rages on, India stares at a new round of antagonism that may leave deeper scars on the nation's psyche.

The role of some alleged dubious agents and directors are under the probe scanner of the ED, they said.

An official comment from the company to a agency query is awaited.

Founded in 1946, the company said on its website that "while retaining cement over the years as its mainstay, India Cements has ventured into related fields like shipping, captive power and coal mining.



Enforcement Directorate arrests 2 in Delhi Jal Board-linked money-laundering case

NEW DELHI, Feb 1 (Agencies): The Enforcement Directorate has arrested a retired chief engineer and a contractor in connection with its money-laundering probe into the alleged irregularities in the tendering process of the Delhi Jal Board, official sources said on Thursday.

Jagdish Kumar Arora, a retired chief engineer, and contractor Anil Kumar Aggarwal have been taken into custody under the Prevention of Money Laundering Act (PMLA), sources said.

The federal agency had conducted raids in this case in July last year.

The ED is conducting investigation in two separate matters of irregularities in the tendering process of the DJB and its criminal case stems from an FIR of the CBI and from the Anti-Corruption Branch (ACB) of the Delhi government.

The CBI FIR alleged that officials of the DJB gave "undue advantage" to NKG Infrastructure Limited while



awarding tender to the company for supply, installation, testing and commissioning of electro-magnetic flow metres in connivance with officials of NBCC

The second allegation pertains to the ACB complaint of November 2022 where it was stated that the DJB awarded a tender for setting up automotive bill payment collection machines (kiosks) in its different offices for facilitating consumers in bill payment.

FIR against 4 persons after more than 100 tribal students suffer from food poisoning in Thane school

Students were served pulao and gulab jamun following which they experienced vomiting and other symptoms of food poisoning.

THANE, Feb 1 (Agencies): Police registered an FIR against four persons on Thursday, a day after more than 100 students of a private ashram school in Maharashtra's Thane district suffered from food poisoning after consuming the mid-day meal, an official said.

A total of 117 students, including 48 girls, were admitted to the Shahapur sub-district hospital after they suffered from food poisoning on Wednesday, Shahapur tehsildar Komal Thakur told PTI.

The Sant Gadge Maharaj Primary and Secondary Ashram School (residential school for tribal children), where the incident took place, is located at Bhatsai in Shahapur taluka on the outskirts of Mumbai.

The school houses 290 students from Classes 1 to 10 and 168 of them, who were present on Wednesday, were served the food brought from outside, Thakur said.

Students were served food (pulao) and a sweet dish (gulab jamun) following which they experienced vomiting and other symptoms of food poisoning, the official



They were immediately rushed to the hospital, she said.

The food was brought from outside on the occasion of the first death anniversary of a villager from Bhatsai, she added.

A case was registered against the school superintendent, headmistress of the primary school, headmaster of the secondary school and a person who brought the food from outside, an official from the district rural police control room said.

They have been booked under Indian Penal Code sections 284 (handling poisonous substance in a reckless or negligent manner, endangering human life), 336 (doing any act which endangers human life or personal safety of others), 337 (causing hurt to any person by committing an act, rashly or negligent-

ly, endangering human life or safety of others) and 34 (common intention), the police said.

Thakur said out of the 117 students admitted to the hospital, seven girls were still undergoing treatment while the others were discharged.

Samples of food items served to the children were collected and sent for laboratory examination, she said.

Senior officials visited the hospital and enquired about the condition of the students.

Families and relatives of the affected pupils also gathered outside the medical facility, prompting the deployment of police to maintain order.

The parents of the affected students and some social organisations demanded action against the school management for their failure to take proper care of the inmates.

After 30 Years, Hindu Priest Prays Inside Gyanvapi **Mosque Cellar**

NEW DELHI, Feb 1 (Agencies): Thirty-one years ago, a Hindu priest of the Vyas family stopped performing prayers inside Varanasi's Gyanvapi mosque. Today, Jitendra Nath Vyas, a member of the Vyas family, prayed for the first time inside the mosque next to the Kashi Vishwanath temple.

This became possible after a district court said a priest can perform prayers before the idols in a cellar of the Gyanvapi mosque, a significant development in the legal battle over the structure.

"Vyas ji's cellar was opened after 31 years for prayers," temple trust president Nagendra Pandey said, according to news agency. "It was necessary to follow the court's orders, so the district administration made all the arrangements with great promptness," Mr Pandey said, adding the cellar was opened at



10.30 pm on Wednesday. Ashutosh Vvas, another family member, said they did not enter the cellar, but only priests went

"We are very happy that the cellar opened yesterday after such a long time," Ashutosh Vyas told agency.

The court had told the local administration to make arrange-

ments within seven days to allow people to pray in the cellar. The order by judge AK Vishve-

sha came a day after an Archaeological Survey of India (ASI) report on the mosque complex was made public. The ASI survey, ordered by the

same court, in connection with a related case, suggested that the mosque was constructed

during Aurangzeb's rule over the remains of a Hindu temple. Wednesday's order was delivered on the petition of Shailendra Kumar Pathak, who said his

maternal grandfather Somnath Vyas offered prayers till December 1993, according to Madan Mohan Yadav, the petitioner's

The mosque committee refuted the petitioner's version. The committee said no idols existed in the cellar, so there was no question of prayers being offered there till 1993.

"We are very happy that we have got the permission to resume puja there," Jitendra Nath Vyas said, adding he, family members, and priests performed the puja in the presence of district officials.

The mosque has four 'tehkhanas' (cellars) in the basement, and one of them is still with the Vyas family.

SC to hear Friday JMM leader Hemant Soren's plea against arrest by ED

During the course of the hearing, Solicitor General (SG) Tushar Mehta, appearing for the ED, pointed out that Soren's arrest was challenged yesterday before the Jharkhand High Court, which is slated to hear the matter today.

Sibal replied and

told the SC that they would be withdrawing their petition from the Jharkhand HC. Soren was arrested

on Wednesday night in the case after resigning as the Jharkhand chief minister, and party loyalist and state transport minister Champai Soren was named as his suc-

Trump runs low on cash for campaign as legal fees drain him, Biden flush with funds

Trump has spent more than he has earned through his donations or self-financing schemes

WASHINGTON, Feb 1 (Agencies): Former President Donald Trump is literally roughing it out in the 2024 presidential race, despite being a front runner for the GOP nomination, as he is facing a cash crunch with legal fees draining him out and as he tries desperately to lock down the Republican nomination spending monies to eliminate Nikki Haley from the competi-

Trump has spent more than he has earned through his donations or self-financing

As a potential 2024 Trump-Biden general election rematch looms large, President Joe Biden appears money-flush.

Trump's campaign and super PAC both spent more than they raised in their most recent finance reports, while Biden built up more reserves, media reports claimed.

Campaign finance records filed Wednesday show the main super PAC supporting Trump's campaign, MAGA Inc., spent more than it raised in the last six months of 2023 - primarily by transferring back \$30 million to Save America, the main vehicle for paying the former president's prodigious legal fees.

Similarly, Trump's official campaign blew through more cash than it took in over the last three months of the year, NBC reported after perusing the campaign records of both candidates. .

That suggests that Trump's recent threats to blackball Republican donors who don't give money to him are about more than just loyalty: He also needs the money, media reports

President Biden's campaign in comparison ended the year with \$46 million in cash, far more than the \$33 million Trump's campaign held before the Iowa caucuses and the New Hampshire primary. Flash to the Future, the main super PAC backing Biden, held a little bit more in the bank than MAGA Inc., \$24 million to \$23.3 million, at the end of the year.

Democrats claimed on Wednesday night that Biden and Vice President Kamala Harris are stockpiling money for campaign purposes, rather than legal fights like Trump, and are in an advantageous position.

"While Donald Trump lights



money on fire paying the tab on his various expenses, Team Biden-Harris, powered by grassroots donors, is hard at work talking to the voters who will decide this election and building the campaign infrastructure to win in November," Biden's campaign spokesman TJ Ducklo said in a statement.

Though Trump's legal troubles make him a martyr before his republican supporters, he is also down in cash for the campaigns paying his legal fees through his various outfits. Trump is rallying GOP voters to his cause without a shred of evidence accusing Biden of using the Justice Department to target him and hamstring his campaign.

Trump that way is banking on the allegations he faces as a key part of his strategy to defeat Biden in November. They have also proved to be an aid in fundraising and in dispatching Republican opponents. The day Trump's mug shot was released in August, following his arrest in the Georgia election interference case, he raised \$4.2 million online, according to a fundraising report filed Wednesday by WinRed, the GOP's main online fundraising platform. It was the most Trump raised online in a single day last year.

Trump hopes his legal woes will energize the GOP faithfuls for the general election and help him to persuade persuadable voters to oust Biden. Trump continues to be a master of small-dollar fundraising. While 18 per cent of Biden's fourthquarter haul came from donors who have given the maximum amount to his campaign, only 6 per cent of Trump's cash came from donors who have given the \$6,600 limit reports said

That means Trump is wellpositioned to go back to the well for more contributions from donors who can still legally give. Spokespeople for Trump and MAGA Inc. did not respond to requests for comment on

their campaign finance filings

Wednesday night. Both Trump and Biden have enlarged their operations during the last quarter of the year as they transitioned from the startup size of nascent campaigns into more robust general election machines. Trump had 78 people on payroll and Biden had 74 people, according to their campaign disclosures.

Inside Trump's numbers: MAGA Inc., which as a super PAC can legally take in donations of unlimited size, raised \$47.8 million from July 1 through Dec. 31, including \$10 million in contributions from Timothy Mellon, who has also been a supporter of Robert F. Kennedy Jr.'s presidential ambitions, and more than \$5 million from former Trump administration Cabinet official Linda McMahon.

But the super PAC spent 55.4 million over the same period, leaving it with \$23.3 million in the bank at the end of the year. The \$30 million it spent on transfers to Save America - and, ultimately, Trump's lawyers - is nearly 50 per cent more than the \$20.4 million it paid for ads in the final six months of 2023, according to an NBC News analysis of Wednesday's campaign finance reports.

Trump's campaign took in \$19.1 million from October through December - less than 60 per cent of the Biden campaign's \$33 million haul - and shelled out \$23.6 million.

The campaign spent \$97,000 of that for facility rentals and catering at Trump's Mar-a-Lago club in Palm Beach, Florida. But the big-ticket items were \$7.6 million for advertising, \$3.7 mil-

lion for legal consulting, \$1.7 million apiece for air travel and staging events, and \$1.6 million for payroll, according to the NBC News analysis.

Since the disclosures of campaign expenditure cover till the end of last year, it's rather difficult to know how much Trump has raised and spent in the month. But he has added a series of high-dollar fundraising events to his calendar in recent days, including one this week near his Palm Beach home, and one at his Mar-a-Lago resort next month, according to an invitee.

Inside Biden's numbers: Without a serious primary challenger, Biden has been able to focus his money on communicating to voters about himself and Trump. Democratic Rep. Dean Phillips of Minnesota, who is running a long-shot bid for the party's presidential nomination, lent his campaign \$4 million last quarter and raised another \$1 million from donors.Biden spent \$19.3 million over the final quarter of the year, with about \$12 million of the total going toward making and placing ads. Add to it the \$2 million for text message outreach to voters, and communications dominated Biden's expenditures.

Aside from those costs, his biggest outlays were for payroll and payroll taxes, which amounted to about \$3 million combined. As an advantage of incumbency, Biden has been able to coordinate fundraising with his national party throughout the campaign season. The **Democratic National Committee** recently reported that it had \$21 million on hand at the start of this year, and big donors have been piling money into state Democratic Party accounts via the Biden campaign fundraising operation, too.

Because there is a primary campaign on the GOP side, Trump has not been able to use the Republican National Committee — which ended the year with \$8 million in the bank — as an arm of his campaign in the same way. The RNC is officially neutral in the primary campaign, although party Chair Ronna McDaniel has recently called on the GOP to unite around Trump, whom she described as the "eventual nominee."

Netanyahu says UN agency for Palestinians must close, Israeli warplanes strike Gaza

Israel has accused some UNRWA staff of involvement in the October 7 Hamas assault in southern Israel that triggered the war in Gaza.

JERUSALEM, Feb 1 (Agencies): Israeli Prime Minister Benjamin Netanyahu called for the closure of the UN Palestinian Refugee Agency (UNRWA) as his forces conducted more air strikes in Gaza amid diplomatic efforts for a ceasefire and the release of hostages in the enclave.

Israel has accused some UNRWA staff of involvement in the October 7 Hamas assault in southern Israel that triggered the war in Gaza. Donors including the United States have paused funding pending an investigation, but aid agencies say ending UNRWA operations would wreck humanitarian efforts in devastated Gaza.

The Palestinians have accused Israel of falsifying information to tarnish UNRWA, which was set up to help refugees of the war at Israel's founding in 1948 and to which more than half Gaza's population look to for day-to-day assistance.

"It's time the international community and the U.N. itself understand that UNRWA's mission has to end," Netanyahu told visiting UN delegates, according to his office. He said UNRWA should be

replaced by other aid agencies "if we are going to solve the problem of Gaza as we intend to do". Earlier, UN Secretary-

General Antonio Guterres described UNRWA as "the backbone of all humanitarian response in Gaza" and appealed to all countries to "guarantee the continuity of UNRWA's life-saving work".

In Gaza, witnesses said Israel had stepped up air strikes on Gaza City, in the north, and bombarded parts of Khan Younis, in the south, despite what appeared to be the most serious peace initiative for months in the Israel-Hamas war.

Hamas, the militant Palestinian group that runs Gaza, is currently studying the proposal, which envisages the release of all remaining hostages seized on Oct. 7. Israel says they number around 136. Hamas has demanded an end to Israel's offensive.

World powers hope to prevent a wider conflict, but tensions in the Middle East remain high after Yemen's



ing US and British warships in the Red Sea in solidarity with Palestinians.

Relations between Tehran and Washington are also tense after the deaths of three U.S. soldiers in a drone strike in Jordan that U.S. officials blame on Iran-backed militants. Washington has not yet outlined its response, but Iran's Revolutionary Guards said on Wednesday they would respond to any U.S. threat.

DEVASTATION

Much of the densely populated Gaza Strip has been devastated by almost four months of Israeli bombardment, and most of its 2.3 million residents have been uprooted by fighting that has caused the world's biggest humanitarian crisis.

Gaza health authorities said 26,900 Palestinians had been killed - including 150 over the past 24 hours - so far in the war that was triggered after Hamas fighters stormed into Israeli towns on October 7, killing 1,200 and taking 253 hostages.

Israel's military said its forces had killed at least 25 Palestinian militants in Gaza in the past 24 hours, and that three Israeli soldiers had been killed - taking to 224 the number of troops killed during Israel's ground offensive.

Smoke rose above Gaza City after the latest air strikes, some of which targeted the headquarters of the Hamas-run interior ministry, Hamas-run media and

residents said.

The Al-Nuseirat refugee camp in central Gaza came under fire and tanks pounded areas of Khan Younis around Nasser Hospital, the largest still functioning in the south, witnesses said.

As the health system deteriorates, Palestinian medics say they have formed field medical points to help reach front lines, as treating the wounded in Khan Younis has become increasingly difficult amid street battles and artillery strikes.

"There's a lot of injuries among the displaced who were in the industrial quarter and some schools," said Nassim Hassan, the head of the Emergency Unit at Nasser Hospital, adding that "many of the injured left loaded on carts, tuk-tuks, cars or even on foot."

THREE-STAGE TRUCE

A senior Hamas official told Reuters the Gaza ceasefire proposal involved a threestage truce, during which Hamas would release the remaining civilians among hostages captured on October 7, then soldiers, and

finally the bodies of dead hostages.

The proposal followed talks in Paris involving intelligence chiefs from Israel, the U.S. and Egypt, with the prime minister of Qatar.

The U.S. ambassador to the United Nations urged Hamas on Wednesday to accept the proposal, saying it would allow more vital food, water and medicine supplies to enter Gaza.

"(Hamas) can continue to dig tunnels, to plan for its next attack, to use civilians and civilian infrastructure as human shields, or it can lay down its weapons and accept the proposal on the table to release every hostage," Linda Thomas-Greenfield told a meeting of the U.N. Security Council.

Palestinians said the fighting in Gaza must end for good.

"Any ceasefire that doesn't end the war and return us to our homes in Gaza City and the north is not worth it," Ahmed, who fled his home in Gaza City for Rafah in the south, said by telephone. "We are exhausted."

The total budgetary allocation for the Election Commission in 2024-25 is Rs 321.89 crore, of which Rs 306.06 crore is for the expenditure to be incurred in conducting elections

The amount kept aside for public works is Rs 2.01 crore. The allocation made for adminis-



trative services is Rs 13.82 crore.

In 2023-24, the amount allocated for conducting elections was Rs 312 crore, which was revised upwards to Rs 385.67 crore. The revised total budgetary allocation in 2023-24 was Rs 466.04 crore.

A large part of the budgetary allocation for preparing for the conduct of the Lok Sabha elections was already

Sabha, which included an additional allocation of Rs 3,147.92 crore for election-related expenditure and Rs 73.67 crore for the Election Commission's administration.

A major chunk of the expenditure is on procuring and maintaining electronic voting machines. In the 2023-24 Budget, the Union government had originally made an allocation of Rs 1,891.8 crore for EVMs, and it was revised upwards by Rs 611.27 crore.

Experts laud govt move on vaccination of girls against cervical cancer

NEW DELHI, Feb 1 (Agencies): Union finance minister Nirmala Sithraman on Thursday made a slew of announcements related to healthcare, including vaccination of girl children. Presenting the interim budget for the year 2024-24, Sitharaman said the government plans to set up more medical colleges by utilising existing hospital infrastructure and will set up a committee to examine the matter.

The minister also said that the government will encourage vaccination for girls in the age group of 9-14 years for the prevention of cervical cancer.

"Our Government will encourage vaccination for girls in age group of 9 to 14 years for prevention of cervical cancer," she said, without revealing the details.

Cervical cancer is a type of cancer that begins in the cells lining the cervix, which is the lower part of the uterus (womb) that connects to the vagina. Most cervical cancers are caused by the human papillomavirus (HPV), a sexually transmitted infection. However, not



all women with HPV develop cervical cancer, and other factors like smoking, a weakened immune system, and certain genetic factors can increase the risk.

When diagnosed, cervical cancer is one of the most successfully treatable forms of cancer, as long as it is detected early and managed effectively, according to the World Health Organization.

WHO Representative to India, Dr Roderico H. Ofrin, applauded the government proposals saying initiatives to upgrade existing hospital infrastructure, harmonization of maternal and child care implementation, and introduction of HPV vaccination for cervical cancer prevention will further strengthen systems and healthcare services across the country

"WHO welcomes investments in these areas and will continue to support the Government of India in achieving health for all and meeting its disease elimination goals," he said.

Dr Naresh Trehan, Chairman and Managing Director, Medanta Medicity, lauded the emphasis on anganwadis, women's health, and the vaccination for young girls against cer-

vical cancer. "All these things are very important addition to what we have. But more importantly, offering of Ayushman coverage for Anganwadi workers and ASHA workers is a big move. I think that will go down very well and boost the morale of our frontline health workers," he said.

Gut microbiota influence

severity of respiratory viral

ing to researchers from Georgia State University's Center for Translational Antiviral Research and the Institute for Biomedical Sciences, the composition of the gut microbiota determines how vulnerable mice are to respiratory virus infections and the severity of these infections.

The findings, published in the journal Cell Host & Microbe, report that segmented filamentous bacteria, a bacterial species found in the intestines, protected mice against influenza virus infection when these bacteria were either naturally acquired or administered.

This protection against infection also applied to respiratory syncytial virus (RSV) and severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), the virus that causes COVID-19. To maintain this protection, the study noted that segmented filamentous bacteria required immune cells in the lungs called basally resident alveolar macrophages.

In this study, the researchers investi-

gated how differences in specific microbial species can impact outcomes of respiratory virus infections and how they might do so, which hasn't been well defined previously.

They studied mice with discrete microbiome differences and mice differing in only the presence or absence of segmented filamentous bacteria. Viral titers in the lung were measured several days after infection and varied significantly depending on the nature of the microbiome of the different animal groups.

"These findings uncover complex interactions that mechanistically link the intestinal microbiota with the functionality of basally resident alveolar macrophages and severity of respiratory virus infection," said Dr. Andrew Gewirtz, co-senior author of the study and Regents' Professor in the Institute for Biomedical Sciences at Georgia State.

The study found that in segmented filamentous bacteria-negative mice, basally resident alveolar macrophages were quickly depleted as respiratory virus infection progressed.

Is 36-hour fasting good for your health? What experts say about Rishi Sunak's weekly routine

NEW DELHI, Feb 1 (Agencies): UK PM Rishi Sunak's 36-hours fasting routine at the start of the week has aroused interest of fitness-conscious or those aspiring to lose weight. Sources close to Sunak told the Sunday Times that the PM starts his rigrous fast at 5pm on Sunday and continues it till 5am on Tuesday to reset and detox his system. In this fasting window, he is allowed to have water, tea or black coffee. Sunak in a recent interview that appeared on ITV's midmorning show on January 30 spoke about his weekly wellness routine, saying, "I wish I was as disciplined as has been reported. Like all of us, I start the week with the best of intentions and then you hit contact with reality at some point." Sunak further said that he loved his food and "eats a lot of sugary pastries the rest of the week."

What is the Monk Fast, the 36-hour fasting pat-

Experts say Rishi Sunak's diet pattern where he fasts for 36 hours every week is popularly known as the Monk Fast and it's a kind of intermittent fasting. In combination with exercise, the fasting



pattern can help cut fat and retain body muscle mass. Not eating for 36 hours at a stretch can help facilitate the removal of damaged cells and encourages regeneration of healthy cells. It also has a positive impact on hormone regulation, as per dietitians Experts say the Monk

fast could be especially beneficial for Rishi Sunak considering it can enhance decisionmaking skills and cognitive prowess. Fasting for extended periods is associated with boosting brain power.

Dr Priyanka Rohatgi, Chief Nutritionist, Apollo Hospital, sharing the benefits of the dietary pattern says it helps in weight loss, preserving lean body and also aids in regeneration of healthy cells, which has

anti-ageing benefits. "Engaging in the Monk Fast, a 36-hour fasting regimen, alongside resistance training

proves to be effective for weight loss, particularly in shedding fat while preserving essential lean body mass. This combination can contribute to a healthier body composition. Key to unlock potential

Rathour outlines the importance of being patient with the likes of Jaiswal, Gill and Iyer

VISAKHAPATNAM, Feb 1 (Agencies): The likes of Shubman Gill and Shreyas lyer deserve patience amid their current poor run, said India batting coach Vikram Rathour, urging his wards to tackle England's aggression with intelligence in the second Test here.

The Indians lost the opening Test in Hyderabad by 28 runs despite having a 190-run first-innings lead. England managed to shock the home favourites with their Bazball approach as Ollie Pope scored a match-winning 196.

The second Test starts here on Friday, with India looking to draw parity.

"There are young batters in our team who have not played much Test cricket. So, we need to be a bit patient with them. Batters like (Shubman) Gill, (Yashasvi) Jaiswal and (Shreyas) lyer will eventually start getting big scores, I'm sure of it," Rathour said.

Although Jaiswal played a knock of 80 in the first innings of his fifth Test, Gill and Iyer failed to fire, continuing their struggles in the format. While Gill has played 21 Tests, Iyer



has appeared in 13 games.
Gill hasn't scored a 50 in his
last nine Test innings, while lyer
also has been off-colour.

Rathour said he expects better application from the side's batters in the second Test, where the home team will once again miss the services Virat Kohli.

"There's a difference between playing with intent and playing attacking cricket. I want them to play with intent. If there is the opportunity to score some runs, they should take it," Rathour said. "They need to decide by looking at the surface and conditions. So, the batters need to

possess that intelligence as to which is the best or safest shot on the surface," he explained.

England used the sweep shot quite well to blunt the effectiveness of the Indian spinners, but Rathour said it's not a stroke that can be added overnight to a player's repertoire.

"...you need to be prepared for that by practising it. If you add more shots to your game, it's always beneficial. We played traditionally. The strength of strong areas is going straight when it comes to using our feet. We can keep doing that, and of course, if we can add more shots and score through the square of the wicket, that's always an addition," he said. Sarfaraz or Patidar?

Rathour said it "will be tough" to pick between Sarfaraz Khan and Rajat Patidar in the second Test against England.

After the first game, India faced injury concerns with all-rounder Ravindra Jadeja and KL Rahul being ruled out of the second Test.

This forced the selectors to add uncapped Sarfaraz Khan, Sourabh Kumar, Washington Sundar and Rajat Patidar to the squad.

"It will be a tough choice. What value they bring to the team, of course, is that they are superb players. We have seen how well they have done in domestic cricket in the last few years," Rathour said. "On these kind of wickets, I think they can really add a lot of value to the team."

The playing XI will be finalised keeping in mind the conditions. "It (pitch) is difficult to predict. It will turn, maybe not from the first day, but eventually, it will turn. That's how the wicket looks like," he said.

KOLKATA, Feb 1 (Agencies): In a big boost, opener Prithvi Shaw is set to make a return to the Mumbai squad in the Ranji Trophy 2024 season. Shaw was deemed fit to play again by the National Cricket Academy and was added to Mumbai's Ranji team ahead of the match against Bengal in Kolkata, that begins on February 2.

Shaw was on the sidelines from competitive cricket after he suffered a knee injury in August 2023. This happened when the youngster was representing Northamptonshire in England's domestic tournament, the One-Day Championship, against Durham. He went on to miss last year's Vijay Hazare Trophy as well as the Syed Mushtaq Ali Trophy for Mumbai.

Shaw underwent rehabilitation with the medical staff at the NCA in Bengaluru. The 24-year-old will return to cricketing action after 6 months and will look to fine-tune his batting skills ahead of the IPL 2024. Shaw will represent Delhi Capitals in the 17th edition of the league and will look to make an impact after a quiet season with the bat last year. The Mumbai batter made his international debut for India in 2018 and represented his team in 5 Tests, 6 ODIs and 1 T20I.

Ranji Trophy's most successful side, Mumbai, would look to retain the top spot in the group stage as they take on Bengal. Shaw, with attacking prowess



at the top of the order, would look to contribute with the bat as Mumbai looks to book the quarter-final berth.

BOOST TO MUMBAI SQUAD
The Mumbai team lead Group B in the points table with 20 points, having won 3 out of the 4 games they played with 1 loss. Sarfaraz Khan, who received his maiden India call-up for the 2nd Test match against England at Vizag, would not be part of the team. However, Shaw's inclusion will bolster Mumbai's batting attack as they face Bengal at the Eden Gardens on Friday.

Bazball is in England's blood, believes Crawley

VISAKHAPATNAM, Feb 1 (Agencies): England opener Zak Crawley said that most of his teammates have become better players since embracing the ultra-aggressive Bazball approach, which is way more compatible with their natural game than the traditional "take-your-time" strategy.

England are yet to lose a Test since pioneering Bazball under their New Zealand coach Brendon McCullum.

"I suppose it (Bazball) comes quite naturally as a lot of our teams are playing more aggressively. The mindset when I first came to England was to backlight or take your time and build a long innings and I didn't think that came naturally to me and a few of the others," Crawley said today. "A lot of us play a bit better under this regime," he added.

After India's loss in spin-friendly conditions in Hyderabad, there is a lot of chatter surrounding the possible nature of the



Vizag wicket. However, Crawley isn't much concerned about it.

"They're absolutely a top side in their own conditions. There are four games left, we have got to stick to what we do well and hopefully results come from there," he said.

Conditions apply

England's Ben Foakes feels the Indian wickets are among the hardest for wicketkeepers as they require frequent improvisation and a tough mind prepared to deal with things occasionally going wrong.

Foakes, who made a Test comeback after 11 months, effected the stumpings of a well-set Ravichandran Ashwin and Mohammed Siraj in the first Test. He also scored 34 in a crucial 112-run partnership with the star of the match Ollie Pope (196) that gave England the decisive lead.

"In conditions like this, it's about trying to think on your feet and learn because it's not natural conditions (for me)," the 30-year-old told a website.

"I've obviously kept away a lot and kept to spinners, but I find that Indian pitches, with the variable bounce, are up there with the hardest. The more extreme the conditions you know things are occasionally going to wrong so you just have to mentally strong enough to put it out of your mind," he added.

The 30-year-old is bracing up for extreme conditions in the rest of the series as well.

"There is a good chance the next one is going to be a tough one. You're in the game, so it's nice as a keeper. It's obviously a very hard place to keep, and you're aware of that. You're going to have some tough moments or a tough day. But you'd rather be in the game than watching the ball do nothing in front of you," he added.

Smooth sailing for Vishnu, books Paris berth



ADELAIDE, Feb 1 (Agencies): Asian Games bronze medallist Vishnu Sarvanan became the first Indian sailor to qualify for successive Olympics. A Subedar from the Mumbai-based Army Yachting Node, the 24-year-old secured qualification for the Paris Games by finishing 26th out of 152 participants in ILCA-7 at the World Championships here. He thus becomes the first Indian sailor to make the cut for the Paris Games.

Vishnu secured the top rank among the Asian countries. He concluded the competition with an overall score of 174. Following the standard rule, his lowest score of 49 was subtracted, resulting in a net score of 125.

The windy conditions made the race challenging. "I can't even hold my phone now, fingers have become numb, legs are destroyed. But it's all worth it. You get to go to the Olympics,"

Vishnu said.
Vishnu could not qualify from the

Asian Championships in Thailand in December and he took the setback in his stride. "Setbacks are always nice to have. It kept me focused," he said. "All the top-10 finishers here were in their 30s, more than 10 years older than me. I can learn from their experience. It's good for me," he added.

At Tokyo Olympics, Vishnu competed in the men's laser category and finished 20th in a field of 35. Vishnu hopes to make it to the finals at the Paris Olympics, while the ultimate target is to get a medal at Los Angeles 2028.

"In reality, a top-15 finish will be my goal, but if I make the top-10 and reach the medal race it will be very good. I know how difficult it is going to be. Let's see how it goes," he said. "For me, 2028 is the real chance where I can win an Olympics medal. I have age on my side and will have time to improve," he added.

Sailing may not be a followed sport in the country but he believes that it can be made popular by winning a medal. The sport requires heavy investment, something he could afford because his father Ramachandran Saravanan is a retired Army officer and former sailor.

After being initially coached by Alex Dennishook, Vishnu has been trained by Milan Vujasinovic under TOPS for the last two years. "I hope I can be the one who can inspire a generation," he said.

Hurt India eye sweeping changes in approach against England's 'Bazball' in second Test

VISAKHAPATNAM, Feb 1 (Agencies): An under-pressure and under-resourced India will need to think out of the box to counter England's fearless bunch of 'Bazballers' in the second Test beginning here on Friday.

India are seldom stretched at home but following a dramatic loss in Hyderabad, they have plenty to ponder and the absence of injured Ravindra Jadeja and K L Rahul has made their task tougher.

Three years ago, the mighty hosts found themselves in a similar situation having lost the opening Test to England at Chennai but bounced back to win the series.

However, the Joe Root-led side was a different breed then and this time India plan to fight-back against a team that has redefined the way Test cricket is played and defied all probability to win the series opener after conceding a 190-run lead on a turning track.

England batters, led by Ollie Pope, swept and reverse swept their way to success in the first Test, taking Rohit and his bunch by surprise, while making the most potent spin trio in the world look ordinary.

India won't have the luxury of fielding Jadeja in this game but Ashwin, four shy of the 500-wicket milestone in Tests, and Axar will need to redraw their plans to come back hard at their uber-aggressive opponents who are sure to employ the sweeping tactics irrespective of the conditions

"It's important that we respond and come up with some plans and some strategies and see how we can make him play those shots from probably even more difficult lengths and be even more disciplined and even more meticulous with our execution," India head coach Rahul Dravid had said after the 28-run defeat last week. "I thought a little bit of our execution went off. Not by much. Credit to him (Ollie Pope), but we were a little bit off and, hopefully, in the next Test match, if we get our execution right, then I hope he makes a mistake," he added.

Kuldeep Yadav is expected to play in Jadeja's absence and it remains to be seen if India go in with only one pacer in Jasprit Bumrah and play another spinner, possibly off-spinning all-rounder Washington Sundar. Uncapped left-arm spinner Sourabh Kumar has also been added to the squad.

Not just India's lethal spinners were tested against Bazball, their batters' struggles on turning tracks also came to the fore as left-arm spinner Tom Hartlev transformed a seemingly forgettable debut into a match winning one. Rohit, perhaps, was the only frontline batter who looked assured in the second innings while the young brigade, especially Shubman Gill, were guilty of playing the turning ball with hard hands. The defensive approach of Gill, who had a breakout 2023 in the shorter formats, contributed to his downfall. With Virat Kohli set to return in the third Test, there will be immense pressure on the likes of Gill and even Shreyas lyer to deliver here in Vizag.

The home team betters are

The home team batters are not as comfortable as their English counterparts in playing the sweep but they need to find a way to match the visitors' highrisk play. Rajat Patidar, who was also a part of the squad in Hyderabad, is likely to replace Rahul. After scoring a bagful of runs in domestic cricket, Sarfaraz Khan has finally got the selectors' nod and would be desperate for an India cap.

However, the management will have a closer look at conditions before taking a final decision on the playing 11.

England, on the other hand, might sense a golden opportunity to take a 2-0 lead in the fivematch series that can severely mount pressure on the Indians.

The way Stokes used and backed his resources in the opener was a captaincy masterclass. The call to give an extended spell to debutant spinner Hartley in the first innings despite Yashasvi Jaiswal's brutal assault and learning from how Ashwin and Co. bowled spoke a lot about the leadership style of Stokes, who calls himself a great observer of the game. The tourists also have a point of concern after experienced left-arm spinner Jack Leach has been ruled out of the match because of a knee injury.

Young off-spinner Shoaib Bashir might come in place for him but that also has ruled out coach Brendon McCullum's desire to field an all-spin attack. "If the wickets continue to spin as much as what we saw in the first Test as the series goes on, look, we won't be afraid to play all spinners or a balance of what we've got," head coach Brendon

McCullum had told SEN Radio. Pacer Mark Wood had failed to make an impact in Hyderabad and the visitors might think of giving a go to veteran James Anderson or younger names in Gus Atkinson or Ollie Robinson as their accuracy can bring higher value on a slow, low pitch. The ACA-VDCA stadium has staged two Tests till date and the pitch usually favours the batters in the first innings.

England have thrown down the gauntlet with a sensational result and it remains to be seen what kind of surface India go with as they seek to draw parity. A downright turner could backfire on the hosts, though they would be tempted to take that punt.
