### One dead, four injured in Srinagar road accident

SRINAGAR, Feb 4 (Agencies): One person lost his life while four more were injured in a road accident in Bemina area of Srinagar on Sunday.

A police official told news agency Kashmir Scroll that a car carrying five persons hit a divider at Bemina chowk, resulting in injuries to all five occupants.

He said that three injured were shifted to JVC hospital Bemina where one of them was declared brought dead and the rest were shifted to SMHS hospital for specialised treatment.

Three injured persons who were shifted to SMHS hospital were identified as Layat, son of Hilal Ahmad Shangloo, resident of Chattabal Srinagar, Zahid Zahoor son of Zahoor Ahmad Wani and Hashim Nazir, son of Nazir Ahmad Khanday.

### All flights cancelled at Srinagar **International** Airport

SRINAGAR, Feb 4 (Agencies): All the flights scheduled for today at the Srinagar International Airport have been cancelled due to fresh snowfall and bad weather. Director Srinagar Airport, Javed Anjum told that all the flights scheduled for today have been canceled due to bad weather. Meanwhile, seven trains have also been canceled since morning in the Valley in view of heavy snowfall.

The Kashmir Valley received fresh snowfall since late last night, disrupting normal life, besides affecting surface and air traffic.

## 4 of family killed in road mishap at Udhampur



SRINAGAR, Feb 4 (Agencies): A devastating car accident near Jajarkotli on the Jammu-Srinagar National Highway has left a family shattered, claiming the lives of four members and leaving one critically injured.

The accident took place around 12:15 A.M at Salora in Udhampur district, when a car driven by Nitin Dogra, was crushed between two trucks.

Reports suggest that the car, en route from Jammu to Udhampur, was struck from the rear by a truck, causing it to collide with another truck ahead. The impact of the

collision was severe, resulting in critical injuries to all five occupants

Emergency services rushed to the scene, swiftly transporting the victims to the Associated Hospital Government Medical College (GMC) in Udhampur.

Tragically, upon arrival

at the hospital, Nitin Dogra, his wife Ritu Dogra, and their daughters Khushi Dogra and Vani Dogra were pronounced dead. Their fifth child, Brinda Dogra, remains in critical condition and has been transferred to GMC Jammu for specialized medical care.

### Army **Shopping Complex** Fire: Eight shops

damaged,

injured

six soldiers

SRINAGAR, Feb 4 (Agencies): A major fire broke out at an Army shopping complex in Kupwara district, resulting in damage to eight shops and injuries to six soldiers.

The incident occurred at around 1 o'clock on the intervening night of February 3 and 4.

Quoting sources, Kashmir Scroll reported that the fire broke out at Shopping Complex 28 INF Div (Army Camp) Zangli, Kupwara. Fire and emergency services from district Kupwara promptly responded and were able to bring the fire under control after several hours.

It was revealed by official sources that six Army personnel sustained minor burn injuries in the mishap and were immediately provided with medical attention.

"The cause of the fire is currently unknown, and an investigation has been conducted to determine the exact circumstances leading up to the incident," they said.

## **Three Nationals of Myanmar** charge-sheeted by NIA In **Human Trafficking Case**

NEW DELHI, Feb 4 (Agencies): The National Investigation Agency (NIA) has filed a charge-sheet against three nationals of Myanmar in a case involving the illegal infiltration and trafficking of foreign nationals, primarily of Rohingya origin, into India through the India-Bangladesh border, an official said on Sunday.

The accused are Rabi Islam alias "Rabiul Islam", Shafi Alam alias "Sofi Alom" alias "Sayedul Islam", and Mohammad Usman all permanent residents of Maungdaw district in Myanmar — a spokesperson of the federal agency said. According to the NIA, they had entered India illegally, in collusion with traffickers and touts, without valid travel documents and were also involved in facilitating the infiltration of numerous other foreign nation-

als through unauthor-

ised and illegal border

routes. Part of a well-organised network of traffickers and touts involved in various illegal activities, they were also engaged in luring vulnerable Rohingya women, who had taken refuge in Bangladesh, into India on the false promises

of marriage to Rohingya

men, the official said.

The NIA said such women were then sold for forced marriages across various Indian states, including Uttar Pradesh, Rajasthan, Jammu and Kashmir,

Telangana and Haryana. The NIA's investigation uncovered instances and evidence of forgery of documents and established that Rabi Islam and Mohammad Usman had obtained Aadhaar cards fraudulently.

The duo had also used these cards to procure multiple SIM cards and open bank accounts, further concealing their true identities, the spokesperson said.

## **Policeman shoots** himself dead in Jammu

JAMMU, Feb 4 (Agencies): Apoliceman allegedly shot himself dead with his service rifle inside a police station here, officials said on Sunday. Selection Grade Constable Igbal Hussain, a resident of Poonch, was found dead

with a bullet injury at

police station Nowabad in the city late Saturday night, they said.

Prima facie, he used his service weapon to shoot himself, the officials said, adding the motive behind his taking such an extreme step was not known immediately.

### Thieves break into 9 shops in Mendhar Poonch, FIR registered

JAMMU, Feb 4 (Agencies): Thieves broke into nine shops including a medical store at Nakamanihari area of Gursai in Mendhar area of Poonch district and stole valuables, officials said on Sunday.

They said that the theft was carried out during

the intervening night of February 3 and 4. A police official told GNS that an FIR (case) has been registered and police are investigating the matter. Asked about the value of valuables stolen, the official said that the same is being

collected.

### **UP ATS** arrests Pak **ISI Agent** working at Indian **Embassy** in Moscow from Meerut

LUCKNOW, Feb 4 (Agencies): The Anti-Terrorist Squad (ATS) of Uttar Pradesh Police has arrested a person working in the Indian Embassy, Moscow, for his alleged involvement in anti-national activities with Pakistani intelligence agency ISI and providing them important confidential information regarding the strategic activities of the Ministry of Defence, the Ministry of External Affairs and the Indian military establishments, an official statement issued here on Sunday said.

## Kashmir draped in white after widespread snowfall



SRINAGAR, Feb 4 (Agencies): Most parts of Kashmir including Srinagar witnessed major snowfall of the season even as weatherman forecast more, officials said on Sunday.

They said it started snowing early in the morning, blanketing the plains while higher reaches saw more snowfall.

A meteorological department official said that plains received 3-6 inches of snowfall while 8-12 inches were recorded in the middle and higher reaches of Kashmir Division.

He said Srinagar recorded 5.3 cms snow till 0830 while it was snowing. Qazigund, he said, received 10cms, Pahalgam 12cms, Kup-

wara 21cms. Kokernag 11 cms and Gulmarg 20cms while Banihal and Batote received 11 cms and 0.5 cms respectively.

Regarding minimum temperature, he said, Srinagar recorded a low of minus 0.7°C against minus 1.7°C on the previous night and it was normal for the summer capital of J&K for this

## Ruling govt completely crushed our age-old movement for rights of PoJK refugees: Chuni

Accuses govt of 'taking away all their rights on land, property, job, political empowerment' under well-thought of plan

### **Top News Report**

JAMMU. Feb 4: Accusing "black-sheep" sitting in power corridors of reducing the problems of J&K people to a perception of 'mere Kashmir problem', the 'S. O. S. International'---a frontline organization of PoJK Displaced Persons--today blamed the ruling NDA government at the Centre for completely crushing the age-old movement of PoJK refugees under its illconceived intentions.

During a refugee awareness rally called by S. O. S. International, the only registered organization of refugees of Mirpur, Pallandri, Bagh, Kotli, Bhimber, Chhamb, Muzaffarabad and Gilgit under the chairmanship of Rajiv Chuni here on Sunday, it was alleged that the government has taken away all rights of refugees visa-vis land, property, job, language, clan, tribe, ethnicity, political empowerment, education under a well-thought of plan to crush their movement.

"In October 2014, the then cabinet of the Jammu and Kashmir government had approved a comprehensive package for the displaced persons of PoJK. The package was an outcome of the decades-long struggle of community leaders. We demand that the Government of India should religiously and inprinciple fulfill the package, announced for PoJK refugees before the formation of the BJP-led government at the Centre in 2014, without any further delay," Mr Chuni said while addressing a large rally.

He further said, "This package included Rs 25 lakh compensation for each PoJK community family, reservation in professional and technical colleges of the country for our youths and a provision of creation of 8500 jobs for the youths belonging to PoJK community. Unfortunately, the BJP leadership in Jammu and Kashmir has never bothered to utter a single word about this

package and they continue to



maintain a cryptic silence over

He also demanded that all 5,300 PoK displaced families settled outside Jammu and Kashmir should be brought into the ambit of the package passed for PoJK refugees by the then J&K government in October 2014. "We failed to understand the rationale behind the exclusion of these families from the ambit of the relief package. They have not committed any crime or sin and they need to be treated at par with other PoJK displaced persons staying in Jammu and Kashmir," Mr Chuni said.

The senior refugee leader also took a dig at the Centre for reserving a single seat for the displaced PoJK people and described it as "humiliating" and "insulting" for a community of 17 lakh people.

Mr Chuni termed it a "grave injustice" with the displaced PoJK people, saying "the people displaced from Kashmir has a total population of 1.57 lakh (as per the statement of Union Home Minister in the Parliament) and they have been allotted two seats while the PoJK community of 17 lakh people have been meted out to grave injustice and humiliation when only one seat has been reserved for them".

"Instead of ensuring political empowerment of PoJK

displaced persons who have remained the victim of decades-long turmoil, the Centre has tried to rub salt on their wounds by reserving a single seat for them in J&K Assembly. The PoJK DPs had been demanding eight seats in J&K legislative assembly for decades and it had been strongly recommended by various Commissions and Committees over the years but the ruling dispensation at the Centre played a cruel joke on PoJK displaced persons," the senior refugee leader said.

"In 1957, a total of 25 seats were reserved for the displaced PoJK community. One of the seats was taken away from us while the remaining 24 seats are still reserved. The Wadhwa Committee as well as Interlocutors report while considering the genuine and legitimate demand of PoJK DPs for reserving eight seats for them in J&K assembly. The K C Pant-led Interlocutor panel, NN Vohra-led Interlocutor panel and later a panel composed of MM Ansari and Radha Kumar as Interlocutors also made similar recommendations. Thereafter, the European delegation while assessing the plights and sufferings of PoJK people in the camps also favoured reservation of seats for us." Mr Chuni reminded the Central government.

The S. O. S. International chairman said, "A parliamentary standing committee headed by former vice president of India, Venkaiah Naidu, in its report submitted in December 2014, also recommended allotting eight out of the 24 seats reserved for PoJK community to the displaced people from PoJK living in Jammu and Kashmir to ensure their political empowerment even if it requires amendment in J&K Constitution. Recently, the Delimitation Commission has also advocated for an adequate number of seats for PoJK refugees for their political empowerment".

He added that these recommendations were strong evidence for the present dispensation at the Centre to reserve eight seats for the displaced PoJK people in the J&K assembly based on their population in the Union Territory and outside J&K. "It is unfortunate that we have been left politically disempowered despite these strong recommendations".

He also demanded that the displaced PoJK persons be provided equal facilities which are being given to the displaced people of Kashmir Valley.

The senior refugee leader also took a swipe at the Centre for denying Sched-

uled Tribe (ST) status to the displaced PoJK persons staying in Jammu, Samba, Reasi, Udhampur and Kathua districts.

"It is sheer mockery that the government has tried to create a divide among the displaced PoJK persons. Our people (PoJK refugees) living in Rajouri and Poonch districts have been given ST status under Pahari quota but the same is being denied in Jammu district and other parts of the country. How can the government justify this disparity if a section of the community gets some benefits and others are deprived of it? This is a deliberate attempt to create a wedge within the community," he said.

The refugee leader also demanded that the PoJK displaced persons living in Jammu and Kashmir be allowed to visit their religious shrines including temples and Gurdwaras in Pakistan-occupied Kashmir.

"An attempt is being made to give control of Sharda Peeth Shrine in PoJK to the people who had never been associated with the shrine before the migration in Kashmir Valley. The real stakeholders including the displaced PoJK persons from Mirpur, Pallandri, Bagh, Kotli, Bhimber, Chhamb and Muzaffarabad have kept out of the purview of Sharda Peeth Shrine which is quite unfortunate," he said.

He also asked the displaced PoJK refugees to get ready for a decisive battle for the fulfillment of their legitimate rights. He also warned the BJP-led Centre government to meet all genuine demands of the displaced persons before the Lok Sabha elections or else be ready to face wrath of lakhs of PoJK refugee voters.

## AGRICULTURAL INFRASTRUCTURES

ince the inception of Agriculture Infrastructure Fund (AIF) Scheme in July 8, 2020, Rs 152 crore was sanctioned by Banks and other lending institutions to create 144 infrastructure units sanctioned under the Scheme in the NER region. This includes 78 Primary processing Centres, 26 Warehouses, 5 Cold Stores and Cold chains, 2 Sorting and Grading Units and 33 other miscellaneous infrastructure projects.

In order to support farmers in adopting mechanization and modernizing Indian agriculture, Agriculture Infrastructure Fund Scheme provides for incentives by way of 3% Interest subvention on AIF Loans and reimbursement of guarantee fee on collateral-free AIF loans lent by lenders for Farm/Harvest Automation, setting up of Custom Hiring Centres, Purchase of drones, putting up specialized sensors on field, Block chain and AI in agriculture etc. Introduction of Remote sensing and Internet of Things (IOT) such as automatic weather station, Farm advisory services through GIS applications constitute other such initiatives in the category of Infrastructure for smart and precision agriculture. AIF also aims at improvising Supply chain services that includes creation of e-marketing platforms.

In order to give a fillip to the food processing units, under AIF scheme primary processing is encouraged and convergence of this Scheme with other Government Scheme is being facilitated to offer multiple Scheme benefits to beneficiaries. Other initiatives include creation and modernization of storage and Primary Processing activities and improving cold chain which include: Reefer Van & Insulated vehicles, Ripening chamber and Sorting and Grading units.

Mission for Integrated Development of Horticulture (MIDH), provides assistance for development of Post-Harvest Management (PHM) for perishable horticulture crops which includes establishment of pack house, Integrated pack house, pre-cooling, staging cold room, cold storages, controlled atmosphere (CA) storage, reefer transport, setting up of ripening chambers and Integrated cold chain supply system etc. This scheme also provides assistance for setting up of food processing units in North East and Himalayan States only. For Food Processing Units credit linked back ended assistance @ 50% of eligible project cost, in North Eastern and Himalayan States of the maximum project cost of Rs. 800.00 lakh/ unit is available.

Under Agricultural Marketing infrastructure (AMI) sub-scheme of Integrated Scheme for Agricultural Marketing (ISAM), since inception i.e. from 01.04.2001 and up to 31.12.2022, a total of 42164 storage infrastructure projects (Godowns) with capacity of 740.43 Lakh MT have been assisted in the country.

Agricultural Technology Management Agency (ATMA) Scheme has been implemented in 704 districts of 28 States & 5 UTs to educate the farmers. Under the scheme Grants-in-aid is released to the State Government with an objective to support State Governments' efforts to make available the latest agricultural technologies and good agricultural practices in different thematic areas of agriculture and allied sector (including boost up the production and educate the farmers) to farmers through different extension activities viz; Farmers Training, Demonstration, Exposure Visit, Kisan Mela, Mobilization of Farmers Group and organizing Farm Schools etc.

Under Sub-Mission on Agricultural Mechanization (SMAM) Scheme of Ministry of Agriculture and Farmers Welfare, a farm machinery training and testing institute at Biswanath Chariali was set up in 1990. The institute is imparting training to farmers, technicians, engineers, rural youths and women in the field of tractors and agricultural machines. The institute pays stipend to farmers @Rs.200 per day along with to & fro from their residence to attend training. Institute organizes field's demonstrations and training at villages also. Under this scheme, the training institutes organize demonstrations of advanced machines in the field and garden friendly tools and equipments. Besides, these institutes test the machines as per BIS codes to ensure supply of quality machines to farmers.

I welcomed him, too, in, and introduced Anthony and Abhay to each other. And then the friction started. "Are you too on your way to Kollur?" asked Anthony.

"The temple?" responded Abhay. "No way! I don't believe in such... Things."

I was relieved he didn't use a stronger word, but the contempt in his voice came through unmistakably. The function at the Sri Ram temple in Ayodhya was just over, and I knew that people had varied opinions about it. The atmosphere in the room grew chilly, but Anthony kept his cool. "Ah!" he said. 
AICWA slams Poonam

Cervical cancer didn't claim me, but tragically, it has claimed the lives of thousands of women who stemmed from a lack of knowledge on how to tackle this disease... Together, let's strive to put an end to the devastating impact of the disease and bring #DeathToCervicalCancer."

In a follow-up video, Poonam apologised for the stunt but said she wanted to spread awareness about the disease. "I am sorry I caused this tear and I am sorry to those I have hurt. My intention: to shock everyone into the conversation that we are not talking enough about cervical cancer," she said. The news of her death serve a "greater purpose", she added.

On Friday, the actor's team made the shock announcement on Instagram. As per news agency, when contacted for the confirmation of the death, the actor's publicist said she died in her hometown but was not forthcoming with details about her battle with the disease as well as when and where she passed away.

The post on her Instagram page on Friday read, "Deeply saddened to inform you that we have lost our beloved Poonam to cervical cancer. Every living form that ever came in contact with her was met with pure love and kindness." "In this time of grief, we would request for privacy while we remember her fondly for all that we shared," the statement read

"On OTT, every character has its own importance. If there's a strong character with a great personality, I would love to do it. Right now, if the shoot is well planned, it is not difficult to do both the things together. However, sometimes the channel only does not want you to be a part of any other project. But yes, I want to do both (OTT and television) things together. It can get taxing, but I will try my best," she signs off.

## PM Modi unveils projects worth Rs 11,600 crore in Assam

The second edition of 'Asom Mala' roads was also kick-started by the PM. This phase will comprise upgrading and constructing 43 new roads with 38 concrete bridges, entailing a total

investment of Rs 3,444 crore.

Besides, Modi laid the foundation stone for an integrated new building of the Gauhati Medical College and Hospital, to be constructed at a cost of Rs 3,250 crore.

He also laid the foundation stones for the proposed Karimganj Medical College and Hospital, which will be constructed at a cost of Rs 578 crore, and the Rs 297-crore Unity Mall

Modi inaugurated the four-lane road from Biswanath Chariali to Gohpur, developed at a cost of Rs 1,451 crore, and another four-lane

NEW DELHI, Feb 4 (Agencies): Crime Branch officials reached the residence of Delhi minister Atishi on Sunday to serve a notice in connection with allegations that the BJP was attempting to "poach" Aam Aadmi Party MLAs.

Sources said Atishi was not present at her residence. The minister, however, has given

directions to her office staff to receive the notice, sources in the AAP said.

"The team will go again to serve notice to Atishi. This morning she was not present at her residence," a senior officer of Delhi Police Crime Branch said.

This comes a day after Crime Branch officials served a notice to Delhi Chief Minister Arvind Kejriwal, asking him to reply within three days in a probe into his claims that the BJP attempted to poach seven AAP

MLAs.
Kejriwal and Atishi are scheduled to lay the foundation stones of two schools in Rohini later in the day.

On January 27, Kejriwal and Atishi had claimed that the BJP was trying to poach AAP MLAs by offering Rs 25 crore each and a ticket to contest next year's Assembly poll to topple the AAP Government.

The BJP had rubbished the allegations, terming them "false" and "baseless", and dared the chief minister to furnish evidence to back his claims.

## Arvind Kejriwal claims he's being forced to join BJP: 'Not going to bend'

NEW DELHI, Feb 4 (Agencies): Delhi Chief Minister Arvind Kejriwal on Sunday made a huge claim, saying he is being forced to join the BJP. His statement came amid a probe into the Aam Aadmi Party's MLA poaching allegations.

"They can hatch whatevery conspiracy against him, I am also firm. I am not going to bend. They are asking me to join BJP, then they are going to leave me alone. But I said that I will never go to BJP, I will never join BJP, not at all," the AAP supremo said after laying the foundation stone of a school in Rohini,

In his speech at the event, Kejriwal also alleged that the BJP-headed Centre only spends 4 per cent of the national budget on schools and hospitals as opposed to the Delhi government spending 40 per cent of its budget every year on these. The Delhi Chief Minister also mentioned his jailed AAP



colleagues Manish Sisodia and Saty-

"Today all agencies are after us. Manish Sisodia's fault is that he was building good schools. Satyendr Jain's fault is that he was getting good hospitals and mohalla clinics built. Had Manish Sisodia not been working for the betterment of school infrastructure, he would not have been arrested. They created all sorts of conspiracies, but couldn't deter us," Arvind Kerjiwal said.

## Congress stands for Jal-Jungle-Jamin of tribal people: Rahul Gandhi

DHANBAD, Feb 4 (Agencies): Congress leader Rahul Gandhi, on Sunday, said that his party stood for Jal-Jungle-Jamin (water, forest and land) of tribal people and employment of youths.

Gandhi was speaking during a roadshow in Jharkhand's Dhanbad district, as part of his Bharat Jodo Nyay Yatra.

After a night halt in Tundi block of the district, on Saturday, the yatra resumed at Govindpur in Dhanbad, the third day of his yatra in Jharkhand.

The main objective of the yatra is to save



public sector units from being sold to private parties, and ensure justice to employed youth and tribal people of the country, Gandhi said.

"Congress party stands for the Jal-Jungle-Jamin of the tribal people and works for education and employment of youth. Economic imbalance, demonetisation, GST and unemployment have ruined the future of youth in the country," he said.

Jharkhand Congress vice-president Brajendra Prasad Singh said the yatra which started from Govindpur, passed

through Saraidhela, IIT-ISM gate, Randhir Verma Chowk, Shramik Chowk near the railway station and reached Bank More where Gandhi addressed a public rally.

Thereafter, it proceeded towards Bokaro district.

Congress MP Jairam Ramesh said Bokaro is a steel city. "These are the monuments built by (former prime minister) Pandit Jawaharlal Nehru. When people say what we did in 70 years... Bhilai, Rourkela, Durgapur, Bhakra Nangal, Bokaro, Dhanbad, Barauni, Sindri

- these are all monuments to India's economic development", Ramesh said.

After the lunch break

in Bokaro, the yatra would again start from Jena More around 2 pm. Gandhi's night halt is scheduled in Ramgarh district on Sunday.

The yatra will travel 804 km, covering 13 districts of the state in over eight days in two phases.

In all, it will travel 6,713 km in 67 days, passing through 110 districts in 15 states before culminating in Mumbai on March 20.

### 'End of BJP has come': Samajwadi Party chief Akhilesh Yadav renews PDA pitch

LUCKNOW, Feb 4 (Agencies): Samajwadi Party chief Akhilesh Yadav on Sunday said it has come to the fore in a survey that 91 per cent of the backward people, Dalits and minorities will vote unitedly for the PDA due to which the BJP's equation and previous formulas have failed this time.

Yadav also said that the BJP has lagged far behind in the selection of candidates and it was not getting the candidates at all as no one wants to fight to lose.

PDA is the term coined by Yadav for "Picchde, Dalit and Alpsankhyak" (backward, Dalit and minorities) for which the Samajwadi Party is batting for in the upcoming Lok Sabha polls.

"Survey of those who believe in PDA: Overall 90% say-- 49 per cent backward people have faith in PDA, 16 per cent Dalits have faith in PDA, 21 per cent minorities(Muslims+Sikhs+Bu ddhists+Christians+Jains and others+Tribals) believe in PDA, 4 per cent 'agde' (upper caste) have confidence in PDA. (All the above include 'aadhi abadi' (women). Most of these 90% will

vote unitedly for PDA this time," Yadav said in a post on X.

"Due to this (PDA factor), the BJP is neither able to do any mathematics nor make any equation. This is why all the previous formulas of the BJP have failed this time and the BJP has lagged far behind in the selection of candidates. The BJP is not getting candidates at all. No one wants to fight to lose by taking the BJP ticket," he added.

The former Uttar Pradesh chief minister said even the women, who are among the main supporters of the BJP, will not vote for it this time.

"The women, who are among the main supporters of the BJP, are ashamed of because of the plight of the women wrestlers, the gruesome incident in Manipur, the incident of mother-daughter being burnt to death and countless other incidents of insult to women, they are not with BJP this time," he said.

Yadav said the youth, who were hopeful of getting a job or recruitment, are also disappointed under the BJP rule and they will vote this time only to defeat or remove it.



"At the same time, the youth who are hopeful of getting a job or recruitment and are disappointed under the BJP rule, will also vote this time only to defeat or remove the BJP. Those people in the societv who consider themselves intellectuals, who used to look towards the BJP in the name of so-called morality and political honesty are not only upset with the incidents of unethical and corrupt behaviour due to greed for power in Maharashtra, Bihar, Chandigarh Mayor elections and Jharkhand but are also distressed," Yadav said.

"There are too many such people, their inaction will also drastically reduce the votes of the BJP. The BJP will lose due to its own people," he added.

The former Uttar Pradesh chief

minister said that there was an anti-BJP wave among the farmers due to false promises of doubling their income, false guarantees of getting rid of animals damaging crops and rising agriculture costs.

Yadav said the GST mismanagement has already alienated the BJP's traditional business voters—shopkeepers, traders and small factory owners.

"The BJP is hitting at the money of hard workers by bringing anti-labour rules and laws for their billionaire friends, that is why the workers and farmers have also turned completely against the BJP," Yadav said.

"In this environment of allround opposition, the BJP has accepted defeat in Uttar Pradesh. Seeing the public anger, the BJP leaders are running away and the remaining selfish BJP supporters have gone underground following their old tradition," he said.

Yadav gave the slogan "Li ha PDA ne angdai, BJP ki shamat aayi" ('PDA' has taken a move, the end of BJP has come" to justify his assertion.

## Uttar Pradesh ATS arrests Pakistan's ISI agent working at Indian Embassy in Moscow



LUCKNOW, Feb 4 (Agencies): The Anti-Terrorist Squad (ATS) of Uttar Pradesh Police has arrested an Indian national working at the country's embassy in Moscow for allegedly spying for Pakistan's ISI, an official statement issued here on Sunday said.

Satendra Siwal, a resident of Shahmahiuddinpur village, was arrested in the Anti-Terrorist Squad (ATS) police station in Lucknow, it said.

Siwal, who is working in the Ministry of External Affairs and present-

ly posted in the Indian Embassy in Moscow, Russia, was providing them important confidential information regarding the strategic activities of the Ministry of Defence, the Ministry of External Affairs and the Indian military establishments, the statement said.

The ATS in its probe through electronic and physical surveillance found that Siwal, who was working as the IBSA (India Based Security Assistant) in the Indian Embassy in Moscow, Russia, from

2021, was involved in anti-India activities with the network of the ISI handlers and providing important confidential information regarding the strategic activities of the Ministry of Defence, the Ministry of External Affairs and the Indian military establishments is being made available to them for money, the statement said.

Siwal, who was called by the ATS Meerut field unit and interrogated as per the rules, could not give satisfactory answers and confessed to his crime during the interrogation, it said.

An FIR has been registered against Siwal at ATS police station, Lucknow, under Section 121A of the IPC (waging war against the country) and the Official Secrets Act, 1923, the statement said.

## 5 Arrested For Duping Hyderabad Woman Of $\square$ 3 Crore In Trading Fraud

HYDERABAD, Feb 4 (Agencies): Hyderabad Cyber Crime Police arrested five accused persons who were associated with a trading fraud case and cheated the complainant in the guise of getting high returns by investing in

the stock market.

The arrested accused have been identified as

Swayam Timaniya, Meet Timaniya, Brijesh Patel, Harsh Pandya and Shankar Lal. According to the Hyderabad police, "In November 2023 a complaint was received from victim, a resident of Hyderabad stating that accused person contacted her and insisted on investing in the stock market

with 100 per cent highest returns on a company named Unity Stocks and then asked her to deposit the amounts in the different stock market and gaming websites like Dafabet, Unity Exchange, T20 IPL etc. saying that if she invests maximum money and holds it for six months then she



can get minimum of 30 per cent returns of the invested amount."

The complainant invested an amount of ₹ 3,16,34,764 into the bank accounts which were provided by the accused. "Cyber Crime police, Hyderabad registered a case in Cr. No. 2495/2023 and investigated into," the police

said. "In this case, one accused, Ronak Tanna, who is an account supplier was arrested on December 31, 2023. Later it is found that the fraudulent money is again routed in the Indian accounts and then reaching the money in Angadia (Hawala). As such all the five accused persons who

were assisting the main accused person Arjun and Yug in converting the fraudulently gained money through hawala were arrested in Ahmedabad and Gandhi Nagar of Gujarat state," the police added.

## US, UK and allies conduct joint strikes on 36 Houthi targets in Yemen

Precision strikes conducted in response to Houthis' continued attacks against commercial shipping as well as naval vessels transiting the Red Sea

WASHINGTON, Feb 4 (Agencies): The US and the UK have conducted joint strikes on 36 Houthi targets across 13 locations in Yemen, in another wave of assaults intended to degrade the capabilities of the Iran-backed militia that has targeted international shipping vessels in the Red Sea in response to the Israel-Hamas war.

The Pentagon said the UK, Australia, Bahrain, Canada, Denmark, the Netherlands and New Zealand were involved in Saturday's strikes against Houthi targets.

The latest strikes, executed with fighter jets and ships, come after the US launched strikes on 85 targets in Syria and Iraq on Friday in response to a deadly drone attack on a US military base in Jordan last Sunday that killed three of its service members.

"Militaries from the United States and the United Kingdom conducted additional strikes against the Houthi-controlled areas in Yemen," Defence Secretary Lloyd Austin said in a statement.

This collective action sends a clear message to the Houthis that they will continue to bear further consequences if they do not end their illegal attacks on international shipping and naval vessels, Austin said.

"We will not hesitate to defend lives and the free flow of commerce in one of the world's most critical waterways," Austin said.

These strikes, he said, are intended to disrupt further and degrade the capabilities of the Iranian-backed Houthi militia to conduct their reckless and destabilising attacks against US and international vessels lawfully transiting the Red Sea.

Austin said that the coalition forces targeted 13 locations

This was in response to the Houthis' continued attacks against international and commercial shipping as well as naval vessels transiting the Red

These precision strikes are intended to disrupt and degrade the capabilities that the Houthis use to threaten global trade and the lives of innocent mariners.

The strikes are in response to a series of illegal, dangerous, and destabilising Houthi actions since previous coalition strikes on January 11 and 22, 2024, including the January 27 attack which struck and set ablaze the Marshall Islands-flagged oil tanker M/V Marlin Luanda, the statement added.

"Today's strike specifically targeted sites associated with the Houthis' deeply buried weapons

sile destroyers, fired the landattack cruise missiles during the operation.

F/A-18 fighter jets from the USS Dwight D Eisenhower aircraft carrier also took part in the strikes, officials said.

Earlier Saturday, the US struck six Houthi anti-ship cruise missiles before they were launched toward the Red Sea, US Central Command said.

US Central Command forces also conducted a strike in self-defence against a Houthi antiship cruise missile prepared to launch against ships in the Red Sea.

The strikes on consecutive days come as the Biden administration has adopted a "multitiered" response to a drone attack that killed three US service members and wounded scores more last weekend.

Saturday's strikes are the third time in recent weeks that the US and UK attacked Houthi targets as part of a joint operation. On January 11, the two militaries struck approximately 30 Houthi sites. Less than two weeks later, the US and UK struck another eight sites.

The previous strikes targeted Houthi weapons storage facilities and radar sites in an attempt to disrupt the ability of the Iranbacked rebel group to attack international shipping lanes in the Red Sea and the Gulf of Aden, some of the world's most critical waterways.

But the Houthis have remained defiant, vowing after the last round of US-led strikes they are "more determined to confront" what they called the US and the UK "aggressors."

### Namibian President Hage Geingob dies in a hospital where he was receiving treatment, his office says



CAIRO, Feb 4 (Agencies): Namibian President Hage Geingob died, on Sunday, while receiving medical treatment, his office announced.

In a post on the social media platform X, the Namibian presidency said Geingob's medical team at Lady Pohamba Hospital did its best to help him, but Geingob died with his wife, Monica Geingos, and children by his side.

Geingob was undergoing treatment for cancer.
The 82-year-old had a colonoscopy and a gastroscopy on January 8,

followed by a biopsy, his office said last month.

Angolo Mbumba, Namibia's acting president, called for calm, saying in the same post that the 'Cabinet will convene with immediate effect in order to make the necessary state arrangements in this regard.'

Geingob, who was president of the southern African nation since 2015, was set to finish his second and final term in office this year. In 2014, he said he had survived prostate cancer.

Namibia is set to hold elections to choose a new leader in November.

### President Biden wins South Carolina's Democratic primary as he gears up for his re-election bid

COLUMBIA (SOUTH CAROLINA), Feb 4 (Agencies): President Joe Biden easily won South Carolina's Democratic primary, clinching a state he pushed to lead off his party's nominating process after it revived his thenstruggling White House bid four years ago.

Biden on Saturday defeated the other long-shot Democrats on South Carolina's ballot, including Minnesota Rep. Dean Phillips and author Marianne Williamson. His re-election campaign invested heavily in driving up turnout in what it saw as a test drive of its efforts to mobilise Black voters, a key Democratic bloc central to Biden's chances in a likely November rematch against former President Donald

"In 2020, it was the voters of South Carolina who proved the pundits wrong, breathed new life into our campaign, and set us on the path to winning the presidency," Biden said in a statement.

"Now in 2024, the people of South Carolina have spoken again and I have no doubt that you have set us on the path to winning the Presidency again — and making Donald Trump a loser — again."

His win comes after he led a Democratic National Committee effort to have South Carolina go first in the party's primary, citing the state's more racially diverse population compared to the traditional first-in-the-nation states of lowa and New Hampshire, which are overwhelmingly white.

South Carolina is reliably Republican, but 26% of its residents are Black. In the 2020 general election, Black voters made up 11% of the national electorate, and 9 in 10 of them supported Biden, according to AP VoteCast, an expansive survey of that election's voters.

Biden pushed for a revamped primary calendar that will see Nevada go second, holding its primary on Tuesday. The new order also moves the Democratic primary in Michigan, a large and diverse swing state, to Feb. 27, before the expansive field of states voting



on March 5, known as Super Tuesday.

New Hampshire rejected the DNC's plan and held a leadoff primary last month anyway. Biden didn't campaign and his name wasn't on the ballot, but still won by a sizable margin after supporters mounted a write-in campaign on his behalf.

South Carolina, where Biden has long held deep relationships with supporters and donors, also played a pivotal role in his 2020 campaign, where a big win helped revive a flagging effort in other early-voting states and propelled him to the nomination.

Biden was aided by South Carolina Rep. Jim Clyburn, whose 2020 endorsement served as a long-awaited signal to the state's Black voters that Biden would be the right candidate to advocate for their interests.

Clyburn said on Saturday night that he believed New Hampshire's delegates should be seated at the party's convention this summer and that Democrats should avoid any further infighting. Both Biden and Vice

President Kamala Harris, the first Black woman and Asian-American to serve in the role, have consistently thanked the state's Democrats for their support. Biden a week ago told attendees at a state party fundraiser that "you're the reason I am president." He also argued to an audience of hundreds of party faithful that they were "the reason Donald Trump is a loser. And you're the reason we're going to win and beat him again," framing the likely General Election match-up with the GOP's current front-runner.

Earlier in the day, in South Carolina's capital of Columbia, Democratic National Committee Chairman Jaime Harrison said, "We all know that we, because of the colour of this, we, our great grandparents, our grandparents, could not always vote here." Harrison is a South Carolina

native who is Black. "For this president to say, Jaime, for the entirety of your life, we have started this process in Iowa and New Hampshire, and now, we're going to start it in South Carolina' - no other president before ever decided to touch that issue," he added. "But Joe Biden did, and I will always be grateful to the president for giving us a chance, for seeing us, and understanding how much we matter."

Black voters interviewed during the recent early voting period listed a range of reasons for supporting Biden, from his administration's defense of abortion rights to appointing Black jurists and other minorities to the federal courts. Some echoed Biden's warnings that Trump would threaten democracy as he continues to push lies that the 2020 vote was stolen.

"We can't live with a leader that will make this into a dictatorship. We can't live in a place that is not a democracy. That will be a fall for America," said LaJoia Broughton, a 42-year-old small business owner in Columbia. "So my vote is with Biden. It has been with Biden and will continue to be with Biden."

Some voters said they were concerned about the 81-year-old Biden's age, as many Americans have said they are in public polling. Trump is 77. Both men have had a series of public flubs that have fuelled skepticism about their readiness.

"They're as old as I am and to have these two guys be the only choices, that's kind of difficult," said Charles Trower, a 77-year-old from Blythewood, South Carolina. "But I would much rather have President Biden than even consider the other guy."

## Pakistan election commission disqualifies Shah Mahmood Qureshi from contesting polls for five years ISLAMABAD, Feb 4 (Agencies): PakiJanuary 30, 2024, the Election Commission

ISLAMABAD, Feb 4 (Agencies): Pakistan's election commission has disqualified Shah Mahmood Qureshi, a close aide of jailed ex-prime minister Imran Khan, from contesting elections for five years after the former foreign minister was sentenced to 10 years in prison for leaking state secrets.

The disqualification of Qureshi, 67, comes five days before the February 8 general elections, which Khan's Pakistan Tehreeke-Insaf party is contesting despite a state crackdown and without its famous election symbol, the bat.

The announcement comes days after a special court, established under the Official Secrets Act, awarded Qureshi 10 years imprisonment in the high-profile cypher case along with Khan.

Citing the special court's judgement dated

January 30, 2024, the Election Commission of Pakistan (ECP) said that any convicted individual, in accordance with the Constitution and the law, cannot participate in elections, The Express Tribune reported.

"As a consequence, Makhdoom Shah Mehmood Qureshi has become disqualified under Article 63(1)(h) of the Constitution of the Islamic Republic of Pakistan read with Section 232 of the Elections Act, 2017. Therefore, Makhdoom Shah Mehmood Qureshi is disqualified to contest General Elections-2024 and any subsequent elections for a period of five years," the ECP said.

The cipher case pertains to a piece of paper, purported to be a diplomatic cable—the cipher—that Khan had waved at a public rally on March 27, 2022, and naming the US, had claimed that it was "evidence" of



an "international conspiracy" to topple his government.

The case was filed against Khan, 71, and Qureshi on August 15 last year by the Federal Investigation Agency, which accused both of violating the secrecy laws while handling the cable sent by the Pakistan embassy in Washington in March 2022.

## 46 reported dead, 1,100 homes destroyed in Chile as forest fires move into densely populated central areas

VINA DEL MAR, Feb 4 (Agencies): Intense forest fires burning around a densely populated area of central Chile have caused at least 46 deaths, Chile's president said on Saturday evening, and officials said at least 1,100 homes had been destroyed.

In a nationally televised address, President Gabriel Boric warned that the death toll could worsen as four large fires burn in the region of Valparaiso, where firefighters have struggled to reach the most threatened neighbourhoods.

Boric urged Chileans to cooperate with rescue workers.

"If you are told to evacuate don't hesitate to do it," he said. "The fires are advancing fast and climatic conditions have made them difficult to control. There are high temperatures, strong winds and low humiditiy."

Interior Minister Carolina Tohá said earlier Saturday that 92 forest fires were burning in the center and south of the country, where temperatures have been unusually high this

The deadliest of the fires were in the Valparaíso region, where authorities urged thousands of people to evacuate their homes.

sands of people to evacuate their homes.
In areas farther away from the fires, meanwhile, residents were told to stay at home



so that fire engines, ambulances and other emergency vehicles can get about on the roads with greater ease.

Tohá said two fires near the towns of Quilpué and Villa Alemana had burned through at least 8,000 hectares (19,770 acres) since Friday. One of the fires was threatening the coastal resort town of Viña del Mar, where some neighbourhoods had already been hit hard

In Villa Independencia, a hillside neighbourhood on the eastern edge of the town, several blocks of homes and businesses were destroyed. Burned cars with broken windows lined the streets, which were covered in ash.

"I've been here 32 years, and never imagined this would happen," said Rolando

Fernández, one of the residents who lost

He said he first saw the fire burning on a nearby hill Friday afternoon and within 15 minutes the area was engulfed in flames and smoke, forcing everyone to run for their lives. "I've worked my whole life, and now I'm left

with nothing," Fernández said.

Three shelters were set up in the Valparaíso region, and 19 helicopters and more than 450

firefighters were brought into the area to help battle the blazes, Tohá said. The fires were burning on mountains that are hard to reach, such as neighbourhoods

built precariously on the edge of Viña del

Mar.

Officials reported power blackouts as a result of the fire, and Tohá said that in the Valparaíso region, four hospitals and three nursing homes for the elderly had to be evacuated. The fire also destroyed two bus

terminals, the interior minister said.

The El Niño weather pattern has caused droughts and hotter than usual temperatures along the west of South America this year, increasing the risk of forest fires. In January, more than 17,000 hectares (42,000 acres) of forests were destroyed in Colombia by fires that followed several weeks of dry weather.

## Salary, pension arrears eat into SBI Q3 profit, down 35% to Rs 9,164 crore

The quarter also sees the operating profit declining 19.36 per cent to Rs 20,336 crore from Rs 25,219 crore

MUMBAI, Feb 4 (Agencies): A steep Rs 7,100-crore one-time provision towards salaries and pensions ate into the profitability of State Bank of India to the tune of 35 per cent on-year at Rs 9,164 crore in the December quarter, the nation's largest lender said.

Had it not been for this onetime provision, which takes care of the entire additional provisions needed towards salaries and pensions arising out of the higher 17 per cent wage settlement reached with employee unions, net profit would have been Rs 16,264 crore, SBI chairman Dinesh Kumar Khara told reporters here.

On the back of a nearly 15 per cent growth in advances, the chairman guided towards better days ahead saying, "I am very confident of maintaining credit growth at this level or even bettering it as the fourth quarter is a busy season and given that the bank is sitting on a loan pipeline of Rs 4.5 lakh crore.

On the need to raise capital given the high-interest rate regime, he said, if need be we will look at an equity raising but with our profitability level, we can easily plough back Rs 40,000 crore to core capital for funding. Even without that we have the liquidity buffer to lend an additional Rs 7.5 lakh crore.

"Don't worry, we have enough capacity to fund the economy as of now and if the demand rises, we will look at funding options," the chairman said.

Explaining the impact of the

wage settlement, Khara said, "Of the Rs 7,100 crore total payout, Rs 5,400 crore is towards pensions, due to some anomalies in the way our pensions since 2002. Some of the employees were getting 40 per cent and some were getting 50 per cent and the matter has been subjudice since 2002.

"Now that there is legal clarity, we thought of clearing this at a go with this Rs 5,400 crore allocation. Following the court order, we have decided to pay every one of the 1.8 lakh pensioners at 50 per cent of the last drawn wage. This allocation takes care of the entire backlog till December 2023," he said.

Khara further said in fact the bank has been setting aside 10 per cent towards salary and pension arrears so far and this totals up to Rs 13,400 crore till December 2023. We will have to set aside Rs 5,490 crore more in the March guarter. Also, Rs 1,700 crore of the total Rs 7,100 crore has been made towards clearing dearness allowance dues, again arising from the wage hike.

In the reporting quarter, net profit declined by 35 per cent to Rs 9,164 crore compared to Rs 14,205 crore in the year-ago period.

The wage hike impact was so high, even a massive improvement in the asset quality, and the resultant gains from lower provisions did not help.

Its gross bad loans came down by 72 bps to 2.42 per cent or at Rs 86,749 crore, and net bad loan pile declined to over a 10-year low of 0.64 per cent, down 13 bps to Rs 22,408 crore, the chairman said and exuded confidence in further improving the same. Its provision coverage ratio stood at 91.59.

It can be noted that at 64 bps, State Bank's NPA level is better than the best private sector

The quarter also saw the operating profit declining 19.36 per cent to Rs 20,336 crore from Rs 25,219 crore, due to an increase in the wage bills, he said.

Due to the increase in interest rate, and the resultant jump in deposit cost, the key net interest income in the quarter edged up by 4.59 per cent, Khara said, adding the cost of deposit for the bank jumped by 40 bps, led by an increase in higher priced term deposits and a 330 bps fall in the low-cost Casa deposits to 41.18 per cent.

While whole bank NIM inched down by 1 bp to 3.28 per cent while domestic NIM declined by 8 bps to 3.41 per cent and the management is confident of maintaining it at 3.25-30 per

Gross advances rose 14.38 per cent to Rs 35.84 lakh crore. of which corporate advances rose 10.71 per cent to Rs 10.24 lakh crore, retail personal rose 15.28 per cent to Rs 12.96 lakh crore, of which home loans grew 13.16 per cent to Rs 6.94 lakh

Overall deposits of the bank gained 13.02 per cent to Rs 47.62 lakh crore. Of this domestic Casa declined by 330 bps to Rs 18.86 lakh crore but term

deposits rose 19.54 domestic to Rs 26.86 lakh crore.

Of the overall credit growth domestic advances grew 14.47 per cent. Of this corporate and SME loans crossed Rs 10 lakh crore and Rs 4 lakh crore respectively, clipping at 10.71 per cent and 19.24 per cent respectively; agri loan jumped 18 per cent and retail personal advances grew 15.28 per cent. Loans from its overseas offices grew 13.90 per cent.

Whole bank deposits grew at 13.02 per cent, of which Casa deposits grew 4.48 per cent and Casa ratio stands at 41.18 down 330 bps from year ago.

And Khara was very vocal about the asset quality of the unsecured book saying "my unsecured loans are more secure than the secured book. As much as 90 per cent of the personal loans are given to those who have salary accounts with us.'

Interest income for the quarter rose 23.23 per cent to Rs 1,06,734 crore, and interest expenses rose 37.84 per cent to Rs 66,918 crore, giving it the key profitability gauge of net interest income at 39,816 crore, which was only 4.59 per cent more than the year-ago period.

The bank has made a Rs 240 core provision towards its Rs 1,000-crore exposure to alternate investment funds following the mid-December RBI circular towards the same and Khara said the bank may have to make some more incremental provisions towards this going forward.

### Report discloses Zee's over Rs 700 Cr spend in merger fallout with Sony



NEW DELHI, Feb 4 (Agencies): Zee, in the midst of its ongoing tussle with Sony over the proposed merger, has incurred a hefty Rs 700 crore in costs to meet the agreements laid out by Sony, according to a report from

The report mentions that Zee is set to make its case, asserting that the expenditure covered various aspects.

Hindu Businessline.

These include divestment of businesses. settling claims that Zee believes were baseless but required attention, honouring guarantees, obtaining insurance tailored to Sony's preferences, and ceasing operations in line with Sony's directives in the upcoming sessions at the National Company Law Tribunal.

Zee plans to challenge Sony's termination notice, which alleges breaches by the Indian company and claims Rs 747 crores (\$90 million) in damages.

Zee firmly rejects any suggestion of a significant negative impact on the merger agreement, as stated in Sony's termination notice.

Legal insiders as mentioned in the report indicate that Zee will present evidence of extensive talks with Sony, including discussions on a joint business plan that included detailed monthly financial analyses provided to Sony.

The legal documents reveal that Zee was actively engaged with Sony over an extended period, following Sony's guidance on specific actions to expedite the merger.

Zee not only invested significant time and effort in following Sony's instructions but also incurred considerable monetary costs to meet Sony's requirements.

Furthermore, Zee informed Sony that certain actions needed for fulfilling conditions, such as divestments, were irreversible steps taken exclusively for the

As per the report, Sony went beyond the agreed terms by requesting actions outside the scope of the agreement, like accounting for losses related to Zee's deal with Disney Star, even before the formal agreement execution.

Sony was aware of this agreement through public disclosures, with detailed information provided. Sony also allegedly urged Zee to proceed with the agreement despite awaiting Star's waiver for the corporate guarantee from Sony's ultimate parent entity.

Legal experts predict that Zee's argument will centre on Sony's decision to terminate the deal at an advanced merger stage, not due to any lapse on Punit Goenka or the Zee group's part but rather coming from Sony's predetermined intention to call off the merger agreement.

### Slow market notwithstanding, Manyavar to pursue expansion plans aggressively

NEW DELHI, Feb 4 (Agencies): The Indian wedding market is experiencing a slight slowdown this year, with lower overall celebrations compared to the post-Covid rebound seen in 2023. Combined with an overall aversion by Indian middle class consumers towards discretionary expenses, this has translated into a no-growth year so far for India's largest ethnic wear retailer Vedant Fashions.

However, the company has no plans to go slow on its aggressive expansion plans, including its new market in

Visible Slowdown

Vedant Fashions, which sells occasion wear under brands such as Manyavar, Mohey and Mebaz and listed on the bourses in a Rs 3,100 crore IPO two years ago, has seen its revenue remain flat in the first nine months of the current financial year. Net profit slid 6.8%.

"It is a bumpy road in a long journey. What we kind of understand..that we are doing everything which is right for the business" said Vedant Modi, the company's Chief Revenue Officer after disclosing the company's quarterly

The company may be the victim of a unique trend seen in the Indian market in 2023: While the upper-middle class and the affluent have never had it so good, the lower middle class and the working class have found the going increasingly tough. This is also visible in a growing urban vs rural divide, with bigger cities remaining relatively cash rich, while smaller towns and rural areas are under pressure.

All this has meant that high-end designer brands, such as Ritu Kumar and Sabyasachi, continue to grow fast, but brands such as Manyavar and Mohey - which are aimed primarily at the middle class – have seen a deceleration in growth. Even within Vedant Fashions' portfolio, the company's newer categories - more of which target the value-conscious buyer - have been "more impacted" by the

This trend is also visible in other consumer product categories such as automobiles - where high-end SUVs are selling like hotcakes, but compact cars have slowed, and in personal care, where premium cosmetics are flying off the shelves, mass-market brands selling body lotion and face wash are

finding the going rough.

Even for Vedant Fashions, said Modi, "the major impact has actually been in tier two and tier three [cities]. Even in cities where we have good presence.. we have still felt that the overall number of consumers walking in was slightly lower." Things, he added, continue to look "relatively soft" in January and not "as per overall expectations".

Full Steam Ahead

All this does not mean that the company is having second thoughts as to its aggressive growth plans, including in the relatively new South Indian

It has already added 172,000 square feet of retail space in the first nine months of the year, taking its total to 1.64 million. This is up from 1.1 million square feet in March 2021.

Similarly, the number of stores has increased to 673 by the end of December 2023 from 530 outlets as of March 2021.

Vedant Modi emphasized that the long-term growth story remains intact despite the current issues. As India's middle class expands, more lavish weddings and rising fashion consciousness continue to drive ethnic wear purchases.

This has been made easier by the company's asset-light, franchisebased, exclusive brand outlet (EBO) model.

By decentralizing production across a network of third-party vendors, Vedant Fashions has scaled rapidly across India. This growth strategy helped Manyavar to become a household name associated with groom wear, particularly in northern, western and eastern India.

To round out its presence, South India will remain a key area of focus for the company's future expansions, said Modi.

Over the last four months, the company unveiled its South-focused collections under names such as "vivaham", "panchakacham" and "veshti". It also launched new regional marketing campaigns targeted at the South Indian market featuring Telugu actor Ram

Charan and actress Sobhita Dhulipala. "This strategic move not only allows us to cater to region specific unique preferences but also reinforces our brand's dedication to diversity and inclusivity," Modi said.

### Studies on infant mice offer a novel strategy to stop the flu from spreading to humans: Study NEW YORK, Feb 4 (Agen-

cies): It has long been known by scientists that many bacteria and viruses cause illnesses by first attaching themselves to sugar molecules on the cell surfaces lining mammals' sinuses and throats, including humans. For example, viral particles can cling to these molecules also known as siglic acids or SAs in a manner similar to that of keys inserted into locks.

Now, a new study in infant mice shows that keeping virus particles from attaching to SAs limits more than just the entry of influenza A viral infections, but also hinders their exit (shedding) and transmission from mouse to mouse. Such infections are the main cause of the seasonal flu that kills more than 36,000 Americans annually. While vaccines to guard against infection and symptom treatments exist, they are not foolproof, scientists say, and more strategies are needed to prevent infection from spreading.

Led by researchers from NYU Grossman School of Medicine, the study team stripped away, or desialylated, SA receptors by placing directly into mouse nasal cavities a neuraminidase enzyme known to loosen the acids' ability to remain attached to cell surfaces.

The infant mice were then infected with influenza A. Results showed treatment with the neuraminidase enzyme dramatically cut mouse-to-mouse transmission rates by more than half (from 51% to 100%) in a half-dozen influenza strains

Publishing in the American Society for Microbiology journal mBio online January 11, the work was conducted in infant mice, which unlike those even a few months older or adult mice, were found by the research team to have many sialic acids in the upper portion of their respiratory tract.

Specifically, the team blocked two SAs, technically called alpha-2.3 SA and alpha-2.6 SA receptors (the locks). These are known to be widely present in the human respiratory tract, which researchers say makes infant mice a strong comparable model for studying the spread of the infectious disease in children, who are also recognized as important "drivers" of flu transmission among people.

"If further experiments in humans prove successful. desialylating neuraminidase enzymes may prevent the flu from spreading," said Ortigoza, said lead study investigator and infectious disease specialist Mila Ortigoza, MD. PhD.

"While current approaches with vaccines and treatments target the virus, ours is the first study to demonstrate that treating the host, either infected mice or potentially infected humans, to prevent them from transmitting the virus to another host could be another effective strategy for combating pervasive infectious diseases," said Ortigoza, who is also an assistant professor in the Departments of Medicine and Microbiology at NYU Langone.

Ortigoza cautions that extensive clinical research is needed before neuraminidases can be considered for approval as a treatment in humans. She says the team already has plans for more experiments to examine why infants are more susceptible to infection from respiratory viruses and whether blocking sialic acids in children can also prevent the spread of influenza. Funding support for this study was provided by National Institutes of Health grants P30CA016087, S100D021747, K08AI141759, and R01AI150893. Ansun Biopharma of San Diego, California provided the experimental neuraminidase drug used in these experiments but was otherwise not involved in the study.

In addition to Ortigoza, other NYU Langone researchers involved in this study are Catherina Mobini; Hedy Rocha; Stacey Bartlett, PhD; Cynthia Loomis, MD, PhD; and Jeffrey Weiser, MD. Weiser is the Jan T. Vilcek Professor of Molecular Pathogenesis in the Department of Microbiology at NYU Langone Health and chair of the department.

## Polycystic ovary syndrome linked to memory, thinking problems

NEW YORK, Feb 4 (Agencies): Women suffering from polycystic ovary syndrome may be more likely to have memory and thinking problems in middle age, according to new research.

The study, published in the online issue of Neurology, does not prove that polycystic ovary syndrome causes cognitive decline. It only shows an association.

Polycystic ovary syndrome is a hormonal disorder that is defined by irregular menstruation and elevated levels of a hormone called

Androgen.

Other symptoms may include excess hair growth, acne, infertility and poor metabolic health.

It is a common reproductive disorder that impacts up to 10 per cent of women. While it has been linked to metabolic diseases like obesity and diabetes that can lead to heart problems, less is known about how this condition

affects brain health. "Our results suggest that people with this condition have lower memory and thinking skills and subtle brain

changes at midlife. This could impact a person on many levels, including quality of life, career success and financial security," said Heather G. Huddleston, from the University of California, San Francisco.

The study involved 907 female participants who were 18 to 30 years old at the start of the study. They were followed for 30 years, at which time they completed tests to measure memory, verbal abilities, processing speed and attention.

At the time of testing, 66 participants had polycystic ovary syndrome.

The results showed that people with polycystic ovary syndrome had an average score that was approximately 11 per cent lower compared to people without the condition.

Further, they also had lower scores on three of the five tests that were given, specifically in areas of memory, attention and verbal abilities, when compared to those without this condition. At years 25 and 30 of the study, a smaller group of 291 participants had brain scans. Of those, 25 had polycystic ovary syndrome, and they had

lower white matter integrity, which may indicate early evidence of brain ageing.

"Additional research

is needed to confirm these findings and to determine how this change occurs, including looking at changes that people can make to reduce their chances of thinking and memory problems," Huddleston said.

"Making changes like incorporating more cardiovascular exercise and improving mental health may serve to also improve brain ageing for this population."

### Mumbai Open 2024: India's Shrivalli Bhamidipaty and Zeel Desai cause major upsets in 1st qualifying round

MUMBAI, Feb 4 (Agencies): Indian challengers Shrivalli Bhamidipaty and Zeel Desai put on a fantastic show, causing major upsets in first round qualifying matches, as toplevel tennis returned to Mumbai after a hiatus of six years.

Shrivalli making her debut on the WTA Tour showed remarkable poise and confidence as she came from behind to knockout second seed Valentini Grammatikopoulou from Greece, winning in straight sets in the L&T Mumbai Open WTA 125K match

The 22-year-old Indian

The 26-year-old 117-ranked Greek player started powerfully and raced to a 3-1 lead. But Shrivalli, the Indian National champion in both singles and doubles, showed tremendous resilience and won the five games in succession to wrap up the first set.

That win further boosted her confidence as she started to serve stronger and dominated the rallies and went on to take the second for a satisfying 6-3, 6-2 win. In another contest,

brushed aside the challenge of another Greece's Sapfo Sakellaridi, winning in straight sets 6-2, 6-1.

Playing in conditions that were familiar to her, Desai was out of the blocks fast, and didn't allow her Greek opponent, who was seeded seventh, any scope for a comeback.

"Honestly, since it was my debut game, I was just keen, going out there and having a good game. I just wanted to play my best tennis and use my strengths to the best of my ability.
