#### **Dozens of** vegetable shops gutted in fire in Ramban

JAMMU, Feb 5 (Agencies): A fire broke out in a vegetable and fruit market with dozens of shops gutted in the Banihal area of Jammu and Kashmir's Ramban district on Monday, officials said. There was no loss of life in the blaze, they said.

Locals, police, fire tenders and army personnel rushed to the spot and launched an operation to control the fire, they said.

The fire began at a kiosk in the market and quickly engulfed the entire market, making the operation to extinguish fire very difficult, officials said.

The fire was subsequently brought under control but dozens of tin and wooden sheds used by vendors were gutted in the fire, they said.










### Will fasting help Sunak better his image? Greta got better of UK cops

ND so, we know - in India – people were blown away when it was revealed that Prime Minister Narendra Modi had fasted for close to eleven days before the inauguration of the Ram Mandir in Ayodhya. All he had was coconut water - and showed immense fortitude as he continued running the country and travelling. This kind of self-control is something we are used to hearing about where he is concerned – and so could other world leaders be far behind on the "fast" track? Thus, recently Prime Minis-

ter Rishi Sunak has impressed everyone by telling them that he regularly fasts for thirty-six hours starting on a Sunday evening and continuing till Tuesday morning. So, for those 36 hours he has only tea or coffee. In the UK, it was a very pleas-

ant diversion for all to discuss how this kind of fasting could have beneficial effects. There have been heated media discussions and advice from leading dieticians what it could do to your metabolism.

Of course, the 5:2 "fast diet" has become popular all over the world, for some years now, and "intermittent fasting" is a buzz word – but these are all meant as weight loss methods. What Mr Modi did was also for spiritual purposes - and we know he fasts every year during the Navratras as well.

We do not know the motivation for Mr Sunak's fasting but it was definitely a good strategy to reveal his habitual fasting, and change the

narrative – as it has shown him as being disciplined and able to continue working and remaining fit. These are always impressive qualities in a leader and it certainly has helped his image at a time when the Tories are sinking steadily in the opinion polls.

It is rare to have a political party into its fifth Prime Minister in a decade to seek yet another successor. But that is the fate that Mr Sunak faces. There are plots and plans on the back benches with WhatsApp groups forming to conspire to remove the Prime Minister.

Let us hope he manages to hold "fast".

JUST a few weeks ago we were all concerned about two royals undergoing surgery -the future Queen, Kate Middleton, and the present monarch, King Charles III. Fortunately, everything appears to be going smoothly for both -- and there has been no crisis that a firm "stiff upper lip" has not sorted out. But recent news is that Sarah Ferguson, the Duchess of York – who had been married to Prince Andrew – has been diagnosed with melanoma, that is, skin cancer. Unlike Kate, whose mystery surgery we still don't know about – Sarah has gone public with her own diagnosis, recovery, and treatment.

This has led to a remarkable surge in people going for checkups for their own suspected melanoma – and the NHS reports that hospital visits for melanoma is now eight times higher than what it was in previous weeks.

These kind of celebratory revelations of personal illnesses can lead to awareness for others -- and possibly save many lives, especially as she has encouraged others to constantly examine any change in the shape, size and colour of any moles they find on their skin.

Of course, it does not harm the profile and popularity of the celebratory sharing these personal facts as it draws more sympathy towards them. Suddenly, we were also hearing that Sarah Ferguson and Prince Andrew, who have shared a very cordial post-divorce relationship, may be getting together again... while the latter news may have no basis (like the "Poonam Pandey" stunt in India), at least the Duchess used her own illness to spread awareness of a cancer that often goes unnoticed.

GRETA Thunberg is now not only world famous for protesting against climate change but she is everywhere she can make trouble. She is also smart enough to know her rights and wrongs.

Thus, recently she was arrested for protesting outside a conference of oil companies in a five-star hotel in London.

But when presented before a court, she got away because the judge said the police neither gave clear instructions as to where she could protest if not at the hotel, nor where it was legal for her to protest from. So, it was the police who got a rap on the knuckles, not Greta. They obviously ought to

award her a special pass for improving the capabilities of

the police while doing their job. And she keeps climate change in the news, at the same time!

BUT Greta's getaway case is nothing compared to what is now going on across the English Channel in France.

The French farmers pay no heed to the police when they are out to protest, even dumping manure outside of government buildings. Scores of tractors are lined up on six-lane highways. It is more like a music festival rather than a protest, or rather a special Gallic version of protest a la mode.

Being a French protest, and that too by farmers, food is supplied along with drinks as vast areas are blocked off to accommodate farmers. By one count, there are 4,500 tractors spaced across 80 locations in France with nearly a million farmers being very angry over their inability to earn a decent living mainly due to pricing and cheap imports.

Of course, the anger is with Brussels, where the decisionmakers of the European Union meet. President Emmanuel Macron shares Prime Minister Rishi Sunak's fate and is not very popular either.

However, now with Brexit keeping us somewhat immune from these protests, we can only hope it will not impact the prices of France's best-known produce -- wine and cheese.

Why do Students Resort to Unfair Means?

Fear of Failure: The fear of is one of the top reason for some students to cheat in exams. Some' students anticipate a lot of problems if they fail the exams. Their fear dwells in their parents complain about bad grades, their friends mocking and a possible dark future too. They get stressed and the end result is cheating in exams.

Lack of Ability: There are few students who have no potential of taking up the challenge of exams. Low selfesteem and lack of self-confidence cause them to cheat. Instead of studying hard, paying attention to classes, reviewing lessons and doing exercises they cheat in exams.

Lack of Interest: Some students have no interest in studies at all. They find it useless as they know that they are going to take over their father's business or follow traditional family business after their studies. For them, school is just a formality and a pass time. They find no need to study and cheating seems to be an easy way out.

Cheating for Fun & Show-off: Some students cheat in exams is because enjoy taking risks. It sounds ridiculous but in reality, there are certain students who get thrilled and excitement in doing such malpractices. They want to be popular by showing-off their ability. For some, it is an ego issue and for some, it is a dare for a bet or otherwise.

Availability of Sources: Technology and money facilitated cheating tools in the form of elements such as ex-students, co-students, parents, teachers, examiners, invigilators, examination staff and outside elements. They are readily available either due to money or otherwise.

Easy Approach: Using unfair means in the form of chits, guides, paid candidate, question paper leak, bribed teachers or examiners etc. appears to be a

them the confidence to do it again. Such students just can't do without cheating in spite of the fear of getting caught as the fear is overshadowed by tasted success.

Poverty: Some students come from poor families and they are working too many hours in paid employment to cope with schoolwork. They can either study or work so an easy way out is using unfair means.

Substance Addiction: Some have developed an addiction to drugs or alcohol. Such students have only one thing in mind and that one thing sways them away from studies.

Anti-social Elements: Students from families having a history of violence and psychiatric problems tend to be influenced by their environment. They indulge in crime and other anti-social activities which alienates them from studies

Good Grades: Some students are ambitious and want good grades at all cost to get admissions in reputed college or university. Though many of them are bright students, they want to leave no chance to top and the temptation to cheat to get the coveted admission or scholarships becomes very powerful.

By Hook or by Crook: The prevalent attitude of getting things done either By Hook or By Crook in present times is becoming acceptable and sort of norm. Corrupt officials and governments are leading examples. In such an environment cheating is no big deal. How to deal with the Problem of Use of Unfair Means in Exam?

Purpose of Examinations: When the purpose of examinations becomes a method to gain grades rather than for it's learning value, there is degradation in the value of examinations in the eyes of the students. It becomes a formality then.

Legal Consequences: Strict laws regarding cheating should be imple-

Video Surveillance: Using cameras even if they are dummies instils a fear of being taped and 100 % chance of getting caught which itself will prevent cheating.

Tracking School Staff: School staff can be tracked bu hired detectives for the possible perpetrator.

Extra Stress on Policies and Guidelines Regarding Cheating: These need to be fully communicated to students in various ways like the bulletin board, verbal announcement before the exams, warning on the exam sheet etc. This induces a fear and rejection of cheating.

Fair Exams: There is a need to create a test that is fair to the students. Some students use an instructor's reputation for giving "unfair" tests as an excuse to cheat. "Fair" means that the exam tests the material that you said it would cover, that students have enough time to complete the exam and that there is a reasonable grade distribution.

Pre-coded Sheets: Use of Pre-code answer sheets and test booklets that use a numbering system so that the number on each test booklet matches the one on each student's answer sheet is also an effective way to prevent cheating.

Clever Marking: To eliminate cheating after the exam has been returned to students, mark the answer sheets in such a way that answers cannot be altered (such as using a permanent felttip pen).

Seating Arrangements: Number seats and tests and then assign students to sit in the seat with the same number as the number on their test.

# Grammys open with high-octane Dua Lipa performance and Miley Cyrus wins her first Grammy

Mariah Carey presented the first award of Grammy Awards, for best pop solo performance to Miley Cyrus for "Flowers," the singer's first ever Grammy.

Cyrus said she almost missed the start of the show because of driving rain that is pounding Los Angeles and said she was glad she didn't miss her chance to be onstage with Carey. Cyrus has been nominated eight times previously.

Afterwards, Luke Combs' performed "Fast Car" with Tracy Chapman – his cover of the Chapman classic has dominated country radio and won him song of the year at the 2023 CMAs. In 1989, Chapman won best pop vocal performance, female for the song.

Dua Lipa opened the show with a high-octane medley: first, a tease of her forthcoming single, "Training Season," then, her most recent single, "Houdini," and finally, her disco-pop "Barbie" hit "Dance the Night." From the stage at the Crypto.com Arena in Los Angeles, four-time Grammy host and two time nominee - Trevor Noah greeted an excited crowd, starting things off with a kiss on the cheek from Meryl Streep. "The Grammys are gonna win as Oscar," he joked about the moment.

Women outpace men in the major categories, so viewers can expect to see a spotlight on its female nominees as the night continues. SZA leads with nine nominations, followed closely by Victoria Monét and Phoebe Bridgers with seven. Bridgers' band boygenius has six, as does Taylor Swift, Olivia Rodrigo, Miley Cyrus, Eilish, Clark, Batiste and producer Jack Antonoff.

Other performers include SZA, a first-ever Grammys performance from Joni Mitchell, Billy Joel, Eilish, Rodrigo, Burna Boy and Travis Scott.

Bridgers took an early lead at the Grammys, quickly winning four trophies ahead of the main telecast, with her and her boygenius bandmates bringing an infectious energy to the Pre-



miere Ceremony. Songwriter Justin Tranter gave her the first award Sunday, best pop duo/group performance, which went to SZA and Bridgers for "Ghost in the Machine." She wasn't on stage for that but skipped her way up with her band boygenius — made up of her, Lucy Dacus and Julian Baker — clad in matching white suits, when they won their first Grammy as a group for best rock performance for "Not Strong Enough."

"Oh my God I want to throw up," said Dacus in their acceptance speech. "This isn't real. Thank you." "Music saved my life," Baker jumped in. "Anyone can be in a band." Minutes later, they walked back out on stage for best rock song and best alternative music album.

Newcomer Coco Jones won best R&B performance for "ICU" in a stacked competition where she was up against SZA's "Kill Bill" and Victoria Monét's "How Does It Make You Feel." SZA's second win of the night came in the form of the best progressive R&B album for "S.O.S." Jack Antonoff took home producer of the year, non-classical for a third year in a row, tying Babyface as the only other producer to do so consecutively. "You need the door kicked open for you," he said in his acceptance speech. "Taylor Swift kicked that (expletive) door open for me," referencing their work together. The first of three new catego-

ries in 2024, best pop dance recording, was given out shortly afterward and went to Kylie Minogue for "Padam Padam" ---her first win in 18 years.

About 80 Grammys were handed out pre-broadcast. Regional Mexican star Peso Pluma won his first Grammy for his first and only nomination, for best música Mexicana album for his "Genesis." Early on in the afternoon, "Barbie" took home two Grammys in quick succession: for compilation soundtrack for visual media and best song written for visual media.

Billie Eilish and Finneas arrived early in the afternoon to collect song written for visual media trophy for their "Barbie" ballad "What Was I Made For." "This is shocking to me," Eilish said. "I was expecting to turn right back around and leave." "I want to thank our parents, our dad, who worked as a construction worker at Mattel Corporation for much of our childhood to keep food the table," said Finneas.

Dozens of stars began arriving early, with Lipa and Monét among the stunning looks on the arrivals carpet.

Best African music performance, a new category which aims to highlight regional musical traditions and recognizing "recordings that utilize unique local expressions from across the African continent," went to South African singer Tyla for her ubiquitous hit, "Water."

It marks her first Grammy nomination and win. "I never

thought I'd say I won a Grammy at 21 years old," she said in her acceptance speech. "Last year God decided to change my whole life." Jimmy Jam presented the bulk of the R&B and rap categories, which included best traditional R&B performance. That one went to PJ Morton and Susan Carol for "Good Morning," — a sweet moment, but it meant Hazel Monét, Victoria Monét's 2-year-old daughter, lost her opportunity to become the youngest Grammy award winner of all time.

Best rap performance went to Killer Mike Featuring André 3000, Future and Eryn Allen Kane for "Scientists & Engineers." It meant Killer Mike won first Grammy in 21 years, since "The Whole World" won for best rap performance by a duo or group in 2003. It is also a first nomination and win for Eryn Allen Kane. And how could they not win: the standout song featured Future's hoarse vocals, Kane's superb crooning and fine verses delivered by Mike and Andre 3000.

Soon afterward, they won for "best rap song." Killer Mike also took home best rap album for "Michael," cheering, "It is a sweep! It is a sweep!" Naysayers might consider animation a kids' medium. But writer director Ishan Shukla whose film Schirkoa: In Lies We Trust won the NETPAC Award at International Film Festival at Rotterdam, dispels misconceptions associated with the fast evolving genre of animation. For one, his film was not part of the animation section, rather Rotterdam festival doesn't have any such classification. Hence, Schirkoa is and was seen as pure cinema and adjudged the best Asian feature film by a jury from the Network for the Promotion of Asian Cinema. In fact, Schirkoa is a rather complex film

which recreates what appears to be a futuristic dystopian world. Ishan, however, views it as a mirror image of both the worlds we inhabit and we as a civilisation may be headed towards.

Since his characters in the film wear bags and go by numbers, we wonder if they symbolise the death of individuality. He explains, "We are slowly being reduced to data. My film also points at how fast we are losing humanity.'

Ishan creates not one but two worlds, one of which is a free world. Ideally, he would like to dwell in one where there are no rules. But as a creator he can also see the cracks in both.

# 'Don't like state, stop payment' isn't possible': **Centre rebuts Congress charge**

Finance Minister Nirmala Sitharaman slammed senior Congress leader Adhir Ranjan Chowdhury over allegations that the Centre was discriminating against Karnataka in the disbursal of funds.

NEW DELHI, Feb 5 (Agencies): Union Finance Minister Nirmala Sitharaman on Monday rejected claims by senior Congress leader Adhir Ranjan Chowdhury over deprivation of funds to Karnataka, calling it a "politically vitiated narrative".

Responding to a question by the Leader of the Opposition in Lok Sabha over deprivation of funds to non-BJP-ruled states by the Centre during the Parliament Budget Session, Sitharaman said, "This thing that certain states are being discriminated against is a politically vitiated narrative."

"If you are suddenly spending at times your state's budget can't sustain, don't blame me," Sitharaman said.

She further said that no Union Finance Minister can play with the Finance Commission's recommendations.

"This is just not a possibility that any finance minister can intervene to say that 'I don't like this state, stop payment'. No way. It can't happen that way. The system is well-placed," she said.

Speaking during the Question Hour in Lok Sabha, Chowdhury asked Sitharaman the reason



behind the "indiscriminate and arbitrary attitude" of the Centre towards Karnataka.

"I would like to know whether the state government of Karnataka has been deprived of obtaining their legitimate due because a few months ago, this situation was not there. Everything was hunky-dory, but after the installation of a new government ...trouble started. What is the reason behind this," Chowdhury asked.

Responding to Sitharaman's comments, Karnataka Chief Minister Siddaramaiah said that "this had nothing to do with guarantees".

"When the interim report was submitted to the finance minister, there were no guarantees. Who rejected the special grant of Rs 11,000 recommended by the Finance Commission? She promised Rs 5,300 crore for the Upper Bhadra Project in her last Budget. Where is it?" he queried. In the past as well, the Congress government in Karnataka has accused the BJP-led Centre of discriminating against the state over the release of funds.

Accusing the Centre of delaying drought relief to farmers, Chief Minister Siddaramaiah announced in December 2023

that it would pay the first instalment of crop loss compensation. He had alleged that although the state's Revenue Minister Krishna Byre Gowda had spoken to Sitharaman about the release of compensation, there was no response from the Centre.

Sitharaman had countered Siddaramaiah's allegations, saying that nothing was pending with the Centre for Karnataka.

Just last week, Congress Lok Sabha MP DK Suresh courted a fresh controversy by claiming that Karnataka was not receiving "enough funds" from the Centre and there was no choice but to demand a "separate country" for South India. He made the comment just hours after the Union Finance Minister had presented the Interim Budget 2024-25 in Parliament on February 1.

The MP claimed that "injustice was being served to South India".

"Funds that were supposed to reach the South are getting diverted and distributed to North India." In response, DK Shivakumar, Karnataka's deputy chief minister and the MP's brother, said DK Suresh had only expressed "people's opinion".

# **Jailed Manish Sisodia Gets Court Permission To Meet Unwell Wife Once A Week**



NEW DELHI, Feb 5 (Agencies): Former Delhi Deputy Chief Minister Manish Sisodia, who remains in jail for over a year in the liquor policy case, has been allowed to meet his ailing wife and doctors once a week. Delhi's Rouse Avenue Court provided the relief to the AAP leader on Monday.

The last time he was granted custody parole to meet his ailing wife was during Diwali last November.

The former Deputy Chief Minister of Delhi has requested that the court allow him for custody parole to meet his wife weekly. Special Judge MK Nagpal at Rouse Avenue Court issued a notice to the Enforcement Directorate in the application on February 2.

While issuing notice, the court noted that the first application is for seeking his regular bail (second bail application), and the second is for seeking custody parole to meet his ailing wife for two days weekly.

Manish Sisodia was arrested and charge-sheeted in Delhi Excise policy cases of ED and CBI.

Former Deputy Chief Minister Manish Sisodia is in custody in connection with his alleged role in the Delhi Liquor scam.

The Supreme Court of India dismissed the bail petition of Manish Sisodia on October 30. His earlier bail applications were rejected by the High Court and the trial court on May 30 last year.

He was granted custody parole to meet his ailing wife on Diwali on November 10, 2023.

Manish Sisodia was arrested by the CBI on February 26. ED arrested him on March 9. The ED has alleged that proceeds of crime of around 622 crore have been generated due to the activities of the accused Manish Sisodia.

JUNAGADH, Feb 5 (Agencies): The Gujarat Police have arrested Islamic preacher Mufti Salman Azhari from Mumbai in connection with an FIR registered against him for allegedly delivering a hate speech and are bringing him back to the state, an official said on Monday. The speech was delivered at an event held on an open ground near the 'B' division police station in Gujarat's Junagadh city on the night of January 31.

After a video of it went viral, an FIR was registered against Azhari and local organisers Mohammad Yousuf Malek and Azim Habib Odedara under Indian Penal Code sections 153B (promoting enmity between different religious groups) and 505 (2) (making statements conducive to public mischief), police said.

Malek and Habib were arrested on Saturday, while the

police were searching for Azhari. The Gujarat Police traced Azhari to Mumbai and arrested him on Sunday. He was being brought back to Junagadh after securing a transit remand from a court in Mumbai, Junagadh crime branch police inspector J J Patel said.

The Junagadh police carried out the operation with the help of the Gujarat Anti-Terrorist Squad, Patel said. The accused was being brought to Junagadh where

he will be produced before a court on Tuesday, he said. As per officials, the arrested men had taken permission from police for the gathering stating that Azhari will speak about religion and spread awareness about de-addiction, but he allegedly delivered an inflammatory speech. The Junagadh local crime branch is investigating the case.

# 10 police personnel killed, 6 injured in attack on police station in Pakistan

#### Monday's attack occurred at 3 am local time, say police

DERA ISMAIL KHAN (PAKI-STAN), Feb 5 (Agencies): At least 10 police personnel were killed and six others injured in a pre-dawn attack on Monday by militants on a police station in northwest Pakistan, police said, as violence escalated ahead of general elections this week

At around 3 a.m. local time (2200 GMT Sunday) militants attacked the police station with sniper fire and then entered the building, said police officers in Pakistan's Draban region in Khyber-Pakhtunkhwa province. "After entering the building,

the terrorists used hand grenades which caused more casualties to the police," said Malik Anees ul Hassan, the deputy superintendent of police in Draban.



It was not immediately clear who was behind the attack and whether it was related to the election.

A national Assembly candidate was shot dead on Wednesday elsewhere in Khyber-Pakhtunkhwa. On the



leader was shot dead in his party's election office in Balochistan province.

On Tuesday, a bomb attack following an election rally killed four people in Balochistan. Islamic State claimed responsibility.

BEIRUT, Feb 5 (Agencies): Five fighters from the Kurdish-led Syrian Democratic Forces were killed in an overnight attack on an American base in eastern Syria, a war monitor said Monday.

"Five members from SDF special forces were killed and around 20 wounded by a drone attack after midnight on Al-Omar oil field," the largest US-led coalition base in Syria, said Rami Abdel Rahman, the head of the Britainbased Syrian Observatory for Human Rights. The Islamic Resistance in Iraq, a loose alliance of pro-Iran fighters opposed to

US support for Israel in Gaza, claimed a drone attack on Sunday "against the US occupation base in the Al-Omar oil field".

The Observatory's Abdel Rahman said the attack hit an SDF section inside the base, in "the first attack by pro-Iran groups against American bases after the US strikes on Syria and Iraq" late last week. On January 28, a drone slammed into a base in Jordan, killing three US soldiers and wounding more than 40, an attack Washington

blamed on Iran-backed forces. The US responded Syria and Iraq, and has said it would press on with its retaliation. The Observatory, which relies on a network of sources inside Syria, had said at least

Mohamed Ali al-Houthi, head of the Houthi's supreme revolutionary committee, told daily La Repubblica that Italy must be neutral in the Israeli-Palestinian conflict and put pressure on Israel to stop attacks on Gaza, adding that would be the only way to achieve peace in the region.

# **First group of Indian troops to be sent back** before March 10: Maldivian President Muizzu

MALE. Feb 5 (Agencies): Maldivian President Mohamed Muizzu on Monday said the first group of Indian military personnel will be sent back from the island nation before March 10, while the remaining Indians manning two aviation platforms will be withdrawn by May 10.

In his maiden address to Parliament, Muizzu, widely seen as a pro-China leader, said he believes a large majority of Maldivians support his administration with the expectation that they will remove foreign military presence from the country, and recover the lost oceanic territory.

He said his administration will not allow any State agreements that may compromise the country's sovereignty, The Edition newspaper reported.

Soon after taking oath as the President of Maldives on November 17, Muizzu formally



requested India to withdraw 88 military personnel from his country by March 15, saying the Maldivian people have given him a "strong mandate" to make this request to New Delhi.

"Diplomatic discussions with other nations that the President can conduct are ongoing. We have officially requested India to remove its troops stationed in the Maldives. Deliberations on this issue are ongoing. "As per the most recent discussions, military personnel on one of the three aviation platforms will be recalled before March 10, 2024. The military personnel on the remaining two platforms will also be recalled by May 10, 2024," Muizzu told Parliament.

After the latest round of bilateral talks, India said on Feb-

ruary 2 that a "set of mutually workable solutions" was agreed upon with the Maldives for continuing the operations of Indian aviation platforms in the island nation. Currently, Indian military personnel are in the Maldives primarily to operate two helicopters and an aircraft that have carried out hundreds of medical evacuations and humanitarian missions.

The Indian platforms have been providing humanitarian and medical evacuation services to the people of the Maldives for the last few years.

The President said his administration would not do anything that could in any way compromise the nation's sovereignty.

He asserted that he would remain steadfast and not give in to any external pressures under any circumstances if it posed a risk to the country's independence and sovereignty.

BEIJING, Feb 5 (Agencies): A Beijing court on Monday handed Australian writer Yang Hengjun a suspended death sentence, five years after he was first detained in China and three years after a closed-door trial on espionage charges.

Yang, a pro-democracy blogger, is an Australian citizen born in China who was working in New York before his arrest at Guangzhou airport in 2019. He had been accused of spying for a country China has not publicly identified and the details of the case against him have not been made public.

Sydney based scholar Feng Chongvi said a court on Monday delivered a suspended death sentence that would convert to life imprisonment after two vears

It was a "serious case of injustice", he said, adding that Yang had denied the charges. He urged the Australian government to seek medical parole for Yang

Yang's sentence was confirmed by another human rights lawyer in Beijing who has been following his case. "He was found guilty of all charges," the lawyer said, asking to remain anonymous because of the sensitivity of the matter.

Australia is "appalled" at the court's decision and has called in China's ambassador, Australian Foreign Minister Penny Wong said on Monday.

Wong said in a statement on Monday the Australian government understood the sentence can be commuted to life imprisonment after two years if the individual does not commit any serious crimes in that period.

"This is harrowing news for Dr Yang, his family and all who have supported him," she said. Yang's family was "shocked

and devastated by this news, which comes at the extreme end of worst expectations", said a family spokesman in Sydney. Australia had said it was troubled by repeated delays in Yang's case, and had advocated for his well-being, including access to medical treatment "at the highest levels"

The Chinese foreign ministry



did not immediately respond to a agency request for comment. A Beijing court heard Yang's trial in secret in May 2021 and the case against him has never been publicly disclosed. He has denied working as a spy for Australia or the United States.

Yang wrote about Chinese and U.S. politics as a high-profile blogger and also wrote a series of spy novels before his detention. His two sons, who live in Australia, wrote to Prime Minister Anthony Albanese in October on the eve of his visit to Beijing, urging him to seek Yang's release on medical grounds.

"The verdict casts a shadow over bilateral ties and will for some time, as it acts as a potent reminder of the opacity of the Chinese system and its imperviousness to reasonable for-

eign complaints," said Richard McGregor, senior fellow at the Lowy Institute in Sydney. His supporters have argued

Yang should be released on medical parole, and he was told last year he had a 10 cm (4 inch) cyst on his kidney that may require surgery.

Yang was detained as Australia-China ties deteriorated in 2019, and hopes of his release had been raised by the release of Australian broadcaster Cheng Lei shortly before Albanese visited China last year.

James Laurenceson, Director of the Australia-China Relations Institute at University of Technology, Sydney, said that Beijing had said it wanted to move beyond the stabilisation of ties with Australia, but that the sentence would make a thaw harder.

"This decision makes it extremely difficult for the Albanese government to do so in terms of managing the domestic politics. The strong language already used by foreign minister makes plain their disappointment," he said.

SAN FRANCISCO, Feb 5 (Agencies): Some board members at Tesla and SpaceX are aware of the "use of illegal drugs" by Elon Musk and regularly do drugs with him, "because they think refraining could upset the billionaire, who has made them a lot of money," the media reported.

They "don't want to risk losing the social capital that comes from being close to Musk, which for some feels akin to having proximity to a king," reports The Wall Street Journal (WSJ).

"Board members have reaped hundreds of millions from stock awards and separate investments, even as some have done drugs with Musk," the report mentioned

According to the WSJ, friends and others close to Musk were worried that his drug use was getting worse, and "some asked him to go to rehab".

Musk replied on Monday that no one has

ever mentioned rehab to him.

"First, no one has ever mentioned rehab to me ever," the billionaire posted on X.

"Second, if they are saying that I was able to lead Tesla to be by far the most valuable carmaker and SpaceX to be by far the most valuable space company simultaneously, that is the greatest compliment I have ever received," he wrote.

Last week, a Delaware judge in the US struck down Musk's \$56 billion pay package at Tesla, saying it is "unfair" and asked board members to come up with a new pay proposal

An angry Musk later announced that Tesla will move immediately to hold a shareholder vote to change its legal home from the US state of Delaware to Texas. The WSJ report also claimed that multiple

other directors of Musk's companies have "deep personal and financial ties to the billionaireentrepreneur, and have profited enormously from the relationship".

"Several current or former directors at Tesla and SpaceX attend parties with him, go on exotic vacations and hang out at Burning Man, the Nevada arts and music festival." the report alleged. Musk was yet to

respond to these allegations.

"Most members of Tesla's current eight-person board have amassed shares worth hundreds of millions of dollars from their seats over the years, significantly more than what board members at other companies make for their service," the report noted.

Some current and former Tesla and SpaceX directors have knowledge of Musk's illegal drug use but haven't taken public action, it alleged.

"The volume of drug use by Musk and with board members has become concerning," said the report, citing sources

Reports earlier surfaced that Musk had allegedly used drugs, including cocaine, ecstasy, LSD and magic mushrooms.

Leaders at Tesla and SpaceX were concerned about his drug use, "particularly his recreational use of ketamine, for which Musk has said he has a prescription".

# **Boeing Identifies New Problems With Fuselage Of** Flagship 737 Aircraft

NEW YORK, Feb 5 (Agencies): US aircraft manufacturer Boeing said that it has learned of new problems with the fuselage of its flagship 737 model which, while not posing an immediate in-flight danger, will require "rework" on dozens of planes

"This past Thursday, a supplier notified us of a non-conformance in some 737 fuselages," **Boeing Commercial Airplanes**  chief executive Stan Deal said in a statement to employees that was released to reporters. According to Deal, an employee working at the supplier "flagged to his manager that two holes may not have been drilled exactly to our requirements." "While this potential condition

is not an immediate flight safety issue and all 737s can continue operating safely, we currently believe we will have to perform rework on about 50 undelivered airplanes," an issue that "could delay some near-term 737 deliveries." Deal described it as "the only course of action" to deliver perfect aircraft to clients.

Boeing has struggled over the past year with difficulties on its star plane, the 737 MAX, culminating with a major inflight safety incident on Alaska Airlines in early January that prompted a sweeping investigation by the regulating body the Federal Aviation Administration. In his letter, Deal said employees offered suggestions on more than 1,000 improvements since a series of training events following the January 5 incident. Some have already been taken into account, Deal said, including a process to expedite the purchase of new tools and improve ease of access to certain parts of the plane.

#### FM presents JK interim budget 2024-25 & revised estimates for current fiscal in Parl

January 2024 in Ministry of Home Affairs and Ministry of Finance to review these demands of the UT Government. Union Home Minister and Union Finance Minister personally reviewed the fiscal management of the UT Government in recent months.

Accordingly, the Central Government has agreed to provide Rs. 41751.44 Cr to the UT Government in this financial year and Rs. 37277.74 Cr in the next financial year. These assistance figures have been duly captured in the Revised Estimates of 2023-24 and the Budget Estimates of 2024-25 of the Union Government. This assistance will be provided under the MHA's demand no 58 for assistance to the UT. This assistance includes the normal assistance (resource gap) to the UT Government, equity contribution for hydropower projects at Kiru, Kwar and Rattle, etc. These assistance figures are captured in the Union Budget which is already before the Parliament and the same will be taken up for discussion before the UT's interim budget.

Building on this, Government of Jammu and Kashmir drafted its Supplementary Budget for 2023-24 and Vote on Account for 2024-25. Finance Department also drafted the two Appropriation Bills (Supplementary Demands and Vote on Account) for placing before the Parliament. The revised estimates for 2023-24 is overall lower than the budgeted estimates 2023-24 as the UT government was successful in streamlining its expenditure. The supplementary demands for 2023-24 of Rs. 8,712.90 Cr pertain to the four Departments of Finance, Power Development, Hospitality and Protocol and Cooperatives. The supplementary budget is required by Finance department in view of the repayment of debt, while Power Development department needs to provide for power procurement. The Hospitality and Protocol department intends to develop the new J&K Bhawan at Dwarka, New Delhi for which land will be allotted from DDA. The Cooperative department requires the funding additionally for its new CSS, Assistance to Primary Agricultural Credit Societies (PACS). These additional demands are proposed to be catered with Supplementary Demands for the current year 2023-24. The interim budget for 2024-25makes provisions for the ongoing initiatives for infrastructure development, sustainable agriculture, new industrial estate, PRI level works, employment generation, developing tourism, and social inclusion. During preparation of the interim budget proposals, consultations were held with all the Departments and various stakeholders to provide for ongoing initiatives and arrive at realistic budgetary numbers. For finalizing expenditure proposals, assessment of financing needs of infrastructure projects, social and economic measures undertaken by Departments was undertaken. The budgetary exercise focused on the imperative of advancing the cause of the greater collective good within the realistically realizable resources. While the budgetary estimate for the next financial year 2024-25 is about Rs. 1,18,728 Cr, the UT Government has proposed the Vote on Account for Rs. 59,364 Cr. This interim budget for 2024-25 covers revenue expenditure of Rs. 40,081 Cr and capital expenditure of Rs. 19,283 Cr. # Samsung chief Lee Jae-yong is acquitted of financial crimes by South Korean court

### Lee served 18 months in prison after being convicted in 2017 over bribery charges

NEW DELHI, Feb 5 (Agencies): A South Korean court acquitted Samsung Electronics Chairman Lee Jae-yong who was accused of stock price manipulation and accounting fraud in relation to a contentious merger between two Samsung affiliates in 2015 that tightened his grip over South Korea's biggest company.

The ruling by the Seoul Central District Court on Monday could ease the legal troubles surrounding the Samsung heir less than two years after he was pardoned of a separate conviction of bribing a former



president in a corruption The court said the scandal that toppled a prosecution failed to sufficiently prove that previous South Korean government. the merger between Samsung C&T and Cheil Industries was unlawfully conducted with an aim to strengthen Lee's control over Samsung Electronics.

Prosecutors had sought a five-year jail term for Lee. It wasn't immediately clear whether they would appeal. Lee had denied wrongdoing over the current case, saying that the 2015 merger was part of normal business activity. Lee served 18 months

in prison after being convicted in 2017 over separate bribery charges related to the 2015 deal. He was originally sentenced for five years in prison for offering 8.6 billion won (\$6.4 million) worth of bribes to former President Park Geun-hye and her close confidante to win government support for the 2015 merger, which was key to strengthening his control over the Samsung business empire. Lee was released on parole in 2021 and pardoned by South Korean President Yoon Suk Yeol in 2022, in moves that extended a history of leniency toward major white-collar crime in South Korea and preferential treatment for convicted tycoons.

### 'Hyundai plans Diwali IPO in Indian stock markets; slated to be largest ever surpassing LIC issue size'

NEW DELHI, Feb 5 (Agencies): Hyundai IPO on the cards? Hyundai Motor Co, the South Korean automaker, is considering listing its local unit in India to take advantage of the country's booming IPO market, according to sources familiar with the matter quoted agency. This move, which comes after nearly three decades since the launch of Hyundai Motor India (HMIL), could potentially become India's largest initial public offering. HMIL was the second-largest passenger vehicle seller in India last year.

Marquee global investment banks such as Goldman Sachs, Citi, Morgan Stanley, JP Morgan, Bank of Amer-

ica, HSBC, Deutsche Bank, and UBS recently made IPO pitches to the leadership of Hyundai in Seoul. The company is estimated to have a value of \$22-28 billion and is exploring a 15-20% dilution to raise \$3.3-5.6 billion (Rs 27,390 crore to Rs 46,480 crore). Hyundai's global head of communications in Seoul has not responded to queries regarding the matter. In 2022, LIC of India established an IPO record with an issue size of Rs 21,000 crore. India has recently climbed to become the

fourth-largest equity market globally, surpassing Hong Kong. If priced at the upper band of \$28 billion (Rs 23.2 lakh crore), HMIL's

valuation will exceed that of Mahindra and Mahindra, Adani Power, and Bajaj Auto.

Among major Indian auto companies, only Maruti Suzuki and Tata Motors have higher valuations at current market prices.

Hyundai Motor Co, listed in South Korea with a market capitalization of \$39 billion, aims to improve the valuation of its underperforming stocks and reduce the 'Korea discount' in the financial markets through the listing of its Indian subsidiary, feel analysts.

South Korean automakers are currently trading at lower priceto-earnings (P/E) ratios compared to their Japanese and US counterparts.

# Income Tax notice coming your way? CBDT says some taxpayers will get notices soon for not filing their ITRs

NEW DELHI, Feb 5 (Agencies): The income tax department is set to send notices to individuals who have not filed tax returns, despite having tax deducted at source on their incomes, according to Central Board of Direct Taxes (CBDT) chairman Nitin Gupta. In an interview with ET, Gupta stated that there are approximately 15 million such taxpayers. Notices will be sent to a "few thousand".

The department is utilizing the extensive data it receives to identify inconsistencies and is urging taxpayers to update their returns if any details have been overlooked. With 5.1 million updated returns, the department has collected Rs 4,600 crore thus far.



# Cosmic symphony: The rhythmic alignment of planets in orbital resonance

NEW DELHI, Feb 5 (Agencies): Planets orbit their parent stars while separated by enormous distances in our solar system, planets are like grains of sand in a region the size of a football field. The time that planets take to orbit their suns have no specific relationship to each other.

But sometimes, their orbits display striking patterns. For example, astronomers studying six planets orbiting a star 100 light years away have just found that they orbit their star with an almost rhythmic beat, in perfect synchrony. Each pair of planets completes their orbits in times that are the ratios of whole numbers, allowing the planets to align and exert a



gravitational push and pull on the other during their orbit.

This type of gravitational alignment is called orbital resonance, and it's like a harmony between distant planets.

I'm an astronomer who studies and writes about cosmology. Researchers have discovered over 5,600 exoplanets in the past 30 years, and their extraordinary diversity continues to music of the spheres would be imperceptible to the human ear.

Four hundred years ago, Johannes Kepler picked up this idea. He proposed that musical intervals and harmonies described the motions of the six known planets at the time.

To Kepler, the solar system had two basses, Jupiter and Saturn; a tenor, Mars; two altos, Venus and Earth; and a soprano, Mercury. These roles reflected how long it took each planet to orbit the Sun, lower speeds for the outer planets and higher speeds for the inner planets.

He called the book he wrote on these mathematical relationships The Harmony of the World.

# **2nd Test: India bounce back against England's 'Bazballers' to level series 1-1**

India dismissed England for 292 runs in their second innings on day four to register a series-levelling 106-run win in the second Test.

VISAKHAPATNAM, Feb 5 (Agencies): Indian bowlers won an engrossing battle against England's firebrand batting for a series-levelling 106-run victory in the second Test here on Monday, blunting 'Bazball' with their resilience in a rollercoaster contest.

England began day four at 67 for one, chasing a record target of 399. They were bowled out for 292 in the extended afternoon session.

India dismissed England for 292 runs in their second innings on day four to register a serieslevelling 106-run win in the second Test.

The visiting team's no-holdsbarred approach, which has largely been successful, did not work on this occasion as India picked up nine wickets over the course of two sessions to bounce back in the five-match series

The third Test will be played in Rajkot from February 15.

Only Zak Crawley's (73 off 132 balls) strategy of mixing caution with aggression worked before the collective efforts of Jasprit Bumrah (3/46), R Ashwin (3/71), Axar Patel (1/75) and Kuldeep Yadav (1/60) yielded the desired results for the hosts who were under pressure going into day four.

After James Anderson claimed that India were nervous while batting in the second innings and did not know a safe target to counter 'Bazball', England walked the talk on Monday and went ballistic.

They would have been better



served taking a cue from Crawley, who saw out an intense morning spell from Bumrah before going for his strokes.

Night-hawk Rehan Ahmed (23) wanted to smash his first ball of the day out of the park while Hyderabad Test hero Ollie Pope (23) and Joe Root (16) were pushing their luck, frequently attempting sweeps and reverse sweeps on a pitch with variable bounce.

The visitors managed to make 127 runs in the opening session but the loss of five wickets effectively sealed their fate.

When skipper Ben Stokes (11 off 29balls) got run out via a brilliant direct hit from Shreyas Iyer post lunch, there was no coming back for England.

But Ben Foakes (36) and Tom Hartley (36) frustrated the visitors with a 55-run partnership for the eighth wicket.

Hartley could have been Ashwin's landmark 500th wicket but the TV umpire overturned the on-field decision of a catch

as the ball had ballooned after hitting the batter's arm and not the glove.

However, Rohit and Co. were not convinced with the DRS showing umpire's call for LBW. Since the appeal was only for a catch and not LBW, the umpire's call for the latter was not considered.

At stroke of lunch, Kuldeep Yadav dismissed Crawley while Bumrah trapped Jonny Bairstow (26) in front to deal a massive blow to England, who slipped to 194 for six at the break.

Crawley, by far the best batter on show, was adjudged LBW off Kuldeep with a close DRS call. On the sixth ball of his first over, Kuldeep got one to turn back in from middle stump.

It seemed the ball was going down leg but DRS showed that it was hitting the leg-stump.

India's standout bowler in the game, Bumrah, bowled his heart out in the two-hour session. For someone who was operating in four-over spells, Bumrah

bowled one extra in his opening burst before returning towards the end of the session to send back Bairstow. He also cleaned up Hartley to end the game. Root and Pope perished while

going for their strokes. Root, in particular, would be disappointed with his effort as he danced down the track and went for a wild slog without getting to the pitch of the ball to be caught at short third man, giving Ashwin his 499th wicket.

While Axar Patel found Rehan's pads with a straighter one, Pope offered a sharp catch to Rohit Sharma at first slip off Ashwin and the Indian skipper made no mistake in pouching it.

Crawley's play in the first session stood out. He was patient enough to leave balls in Bumrah's opening spell and when the champion fast bowler did for for a full ball, the England opener was quick to put it away with a straight bat.

His cover and straight drive off Bumrah were the standout strokes of his innings.

When Axar was bowling his first spell, India were a tad defensive and had both long off and long on in place for Rehan, who was promoted to bat at number three before stumps on day three.

Pope played a sweep, flick and stepped out to Axar in the same over for three boundaries.

Root, who had missed the last two sessions on Sunday due to an injured right little finger, was in full attack mode with his first two scoring shots being reverse sweep for four.

because the former PCB chairman, Zaka Ashraf, changed the venue of the first match from Lahore to Multan. The PCB is also making a case for the ACC to pay for the additional expenses as the

continental cricket governing body took the

decision to take away Pakistan's hosting rights and split the event.

A source in the know of things said that during the Bali meeting, ACC chief Jay Shah made it clear that it was the PCB which insisted on hosting four matches after the ACC board had decided to move the entire tournament to Sri Lanka.

# Supreme Court stays ex-IPS officer's sentence in Dhoni's contempt plea

NEW DELHI, Feb 5 (Agencies): The Supreme Court, on Monday, granted an interim stay on the 15-day simple imprisonment given by the Madras High Court to retired IPS officer G Sampath Kumar in a contempt of court case filed by former team India cricket captain Mahendra Singh Dhoni. A bench of Justices A S Oka and Ujjal Bhuyan issued notice on Kumar's plea against

the high court order. The matter has been posted for next hearing on March 8.

The high court on December 15 last year had found Kumar guilty of committing criminal contempt and sentenced him to 15-day simple imprisonment.

In his contempt petition, Dhoni sought to punish Kumar for the remarks made by him against the judiciary in his written statement filed in response to a Rs 100 crore defamation suit.

Dhoni had moved the court in 2014 against the former cop for having named the popular

cricketer in the Indian Premier League (IPL) betting scam.

In its order, the high court had said Kumar has consciously made an attempt to scandalise and to lower the authority of this court and the Supreme Court. It was established that an affidavit or any pleading that was presented by a party before the court was an act of publication.

The high court had said when a general statement was made against it for granting interim order describ-



ing the order as an abuse of process of law, it was not a fair comment. Similarly, accusing the Supreme Court that it failed to focus on

"Rule of Law" cannot be accepted as a fair expression of grievance of a party to the dispute, the bench added. The high court had said Kumar was a responsible police officer who had the occasion to investigate a crime.

The freedom of speech and expression cannot be extended to undermine the statutory limits as contained in the Contempt of Courts Act. Since maintenance of dignity of courts was one of the cardinal principles of Rule of Law, any publication or a public speech which results in undermining it cannot be permitted, as held by the Supreme Court in several precedents, the high court had said.

The high court had said the Contempt of Courts Act has been enacted to secure public respect and confidence in the judiciary as an institu-

tion. "If persons like Sampath Kumar were allowed to shake the confidence of the public in the impartial administration of justice, it should be treated as an attack on the judiciary. "In the present case, we are convinced that the statements made by the respondent in the additional written state-

ment is with an intention

to scandalise this court, to lower its authority, and to destroy the confidence of people in the administration of justice. "From the language and the context, this court has no hesitation

to hold that the respondent wants to convey a message in the additional written statement that the high court as well as the Supreme Court, while passing orders, either do not follow Rule of Law or pass orders which are nothing but abuse of process of law", the high court had said.
