



BJP, party in a hurry, puts allies at risk, not just Opposition

in a hurry. Not content with the tag of becoming the world's largest party, it still wants to spread far and wide in every nook and corner of the country. That too at breakneck speed. Like the late Dhirubhai Ambani's "Only Vimal" punchline for his textile brand, the world's largest democracy should have "Only BJP", or so goes the underlying understated argument.

This causes accidents, as happened in the Chandigarh mayoral election recently. The BJP won the controversial election, but the AAP and the Congress have alleged that it was rigged as eight of their votes had been declared invalid. The matter has gone to the Supreme Court, and the Chief Justice of India and other judges had some harsh things to say about the conduct of the returning officer. A hearing is coming up in the apex court later this month. The Opposition fears that if the BJP can go to such an extent in a mayoral election, what would it do in the Lok Sabha polls that is looming ahead. A tainted election has cast a shadow on the conduct of the Lok Sabha election. Trust goes for a toss when an election becomes tainted.

Interestingly, all accidents do not happen accidentally. Everything is fair in love, war and elections, or so goes the ruling party's belief ever since Narendra Modi emerged on the national scene a decade back.

A prominent Opposition party sought an appointment with the Election Commission on the EVM issue, but has yet to get time for the past four months. There are reports that a state-owned undertaking which makes EVMs has four leaders from the BJP as directors.

The Prime Minister needs a third term almost as a right. The Opposition looks like a babe in the woods caught in a deep dark web. The BJP's "bulldozer" strategy is aimed at seeing itself entrenched in power even till 2047, when India celebrates 100 years of Independence. The pot is being kept boiling after the inauguration of the Ayodhya Ram Mandir. The Gyanvapi Masjid is back in the news, and a puja is being allowed in some parts of it. The Uniform Civil Code issue is being hotted up in some BJP-ruled states, while the government says implementation of the controversial CAA will soon start. The PM will also inaugurate a temple in Abu Dhabi this month, which will be used as a booster to Avodhva.

Despite the ED, CBI, I-T department and other investigative agencies working overtime, the likes of Mamata Banerjee, Mayawati, Akhilesh Yadav and Arvind Kejriwal are busy protecting their turf, unconcerned or unaware about the big picture. Former Jharkhand CM Hemant Soren's forced resignation, and arrest by the ED, has given quite a few anxious moments to the Opposition.

Whether true or false, Arvind Kejriwal claims he is being harassed for not joining the BJP bandwagon. The BJP's dream of total domination is sought to be realised by tightening the screws on non-BJP governments.

Those who never participated in the freedom struggle now feel it is child's play to "divide and rule" till eternity. It is a strange and chilling thought in a parliamentary

democracy.

The Centre has spent over Rs 1.5 crore on setting up photo booths at railway stations where the public can take selfies with images of Narendra Modi, apparently aimed at showing to the world that there is only one leader around when India is at the cusp of change.

The media, especially television, is bent on virtually ignoring the Bharat Jodo Nyay Yatra, lest the message go out that an effort, however feeble, is on to build an alternative narrative.

At such a challenging time, Bihar, which has always stood with antiestablishment politics, has turned topsy-turvy. Known for its politically intense character, the state has now become the key base for the ruling establishment, with chief minister Nitish Kumar changing sides almost overnight. The Paltu Ram from Patna is poking fun at the Opposition, whose PM candidate he had sought to become not too long ago.

Mr Kumar, despite having the tag of the longest-serving Bihar CM, might go down in history as the slimiest character in socialist politics, who colluded with the ruling establishment when much was at stake for Indian democracy. His departure is a huge blow for the Opposition's INDIA bloc which, paradoxically, he had initially helped to establish.

Some claim that Mr Kumar, a loner, is unwell and that is affecting the health of Indian democracy. If true, that is a much deeper tragedy.

There is a method in the madness of what has happened in Maharashtra over a year back and still looks like a work in progress. Two regional parties in the state have been split to allow greater leverage for the BJP in the state. The BJP's problem is that despite catapulting from No. 4 position to No. 1 in the wake of the emergence of Narendra Modi on the national scene in May 2014, it has failed to come to power on its own in the state. The "Hindu Hriday Samrat" from neighbouring Gujarat is unable to make deep inroads in Maharashtra, which has long remained Congress-minded.

Hence, the Shiv Sena, the oldest ideological ally of the BJP, is sought to be decimated, decapitated and demolished bit by bit through the rebellion of Eknath Shinde, now chief minister. The fault of Uddhav Thackeray was that instead of remaining a satellite in the Modi-led BJP, he tried the experiment of tying up with the Congress through Sharad Pawar. Both are now marked men for the BJP in Maharashtra and so the situation is becoming messier by the day.

Bihar, like Maharashtra, has been a difficult nut to crack for the BJP despite getting substantial numbers in the Lok Sabha in the past decade. The inability to throw up a state leader so far has brought the BJP to the door of Nitish Kumar over the past two decades. Mr Kumar and his party are at their lowest ebb since the last Assembly polls and therefore it is time for the BJP to make the most of the situation through the new arrangement in the Lok Sabha polls.

It has long been the BJP's dream to turn Bihar and Maharashtra like their neighbours Gujarat and Uttar Pradesh. The "Mumbai-Chandigarh via Patna Express" shows that the battle for dominance is intensifying every day.

Atter long days, while listening to a touching song that cherishes the memories of letters, my mind also started wandering in the world of letters after long days. Before the era of communication revolution, the world of letters was very prosperous. It was through letters that we used to get news about the happiness and sorrow of our family members, friends and well-wishers living far away. At that time, phone facility was available only in the homes of very rich people. mail us allWas waiting for. The postman will come and bring the message. The newly married brides kept their ears glued to the main door of the house, eager to know the news of the happiness of their 'Pivji' sitting far away in Disawar, waiting to hear the call of the postman. Aged parents would wait for the postman with the hope of a money order with happy news of their earning son. In case of illness or illness, he would write a letter to his son, who had gone hundreds of kilometers away to earn money, asking him to come home early, then he would definitely write that 'Consider this letter as a telegram and leave immediately by the first train.'In the era of letters and letters, if a corner of a postcard got torn even by someone's mistake, then people would have been apprehensive that it would be a condolence news of some-

one's death, because at that time

lence news by tearing a corner of the postcard. Whenever a 'wire' arrived at someone's house, there would be a commotion in the entire neighborhood as to whether some untoward news would happen. At that time, anonymous postcards from such intimidating 'devotees' would also arrive every month or two, in which eleven or twenty one such postcards would be sent to other people, citing the miracles of some deity. There was an instruction to send the person and also a threat that if this was not done then there could be loss of life and property in the family and the business could be ruined. Fearful people used to write post cards out of fear of such instructions. The group of writers used to maintain friendly relations with the postman of their area. He kept waiting for the approval of his creations. On receiving the acceptance letter, he would show it to his writer friends for days, feeling proud and making them sad. Whenever any work was rejected and returned to the newspapers and magazines, a slip was attached. There used to be a feeling that we are not able to use this creation. Suggestions were also given to the writers. At that time, there was healthy communication between writers through letters. There was no formality in those letters, but a heartfelt feeling. In them, family matters were also shared and ideological issues were also discussed. The desire to read those handwritten letters again and again remains in the mind. Even today, there is a feeling of energy and warmth among the literature-loving new writers and others while reading the letters received from many famous litterateurs and personalities. Communication takes place. From the letters of writers we also get to know their mental state, we get acquainted with their feelings and thoughts as well as their personality. Actually, letters and literature are our literary heritage. The letters of many veteran litterateurs of Hindi along with other languages introduce us to the contemporary times and society and fill us with the fragrance of mutual relationships. The correspondence and debates between many self-respecting literatures and ideas have been presented to us through letters and have been presented to us through many collections. And we have been made to realize how lively the relationships used to be between the writers at that time. Now the medium of mutual communication has been replaced by letters, WhatsApp, messenger, e-mail etc. There is certainly a facility for instant communication through communication mediums with any person sitting anywhere in the country or abroad, but in this communication there is generally more of a sense of formality and the feeling of intimate joy is less. But earlier when he used to receive a check along with the letter, the writer used to read the check with excitement. UPA put family first during 2008 global financial crisis, sent economy nosediving: Sitharaman

The party which could not handle global financial crisis is now giving lecture to Modi Government'

NEW DELHI, Feb 9 (Agencies): Union Finance Minister Nirmala Sitharaman on Friday tore into UPA accusing it of economic mismanagement during the 2008 global financial crisis, saying the Congress put the "first family first" and brought the economy down to 'fragile

Initiating the debate on the 'White Paper on Indian Economy and its impact on the lives of people of India', Sitharaman said the Common Wealth Games (CWG), held during the UPA regime, brought "bad name" to the country, but India's G20 presidency under the Narendra Modi Government earned India global respect. Substitute motions were moved by Opposition members Saugata Roy (TMC) and NK Premchandran disapproving the White Paper. Sitharaman said the Modi gov-



ernment worked with sincerity and pulled the economy out of 'fragile five' and sent it to top five globally. It is now on the verge of becoming one of the top three global economies, she

"Ten years of one government with some crisis and 10 years of a different government with different crisis. The compari-

son shown in this 'White Paper' clearly says how if the government handles it with true sincerity, transparency and putting the nation first, the results are there for everybody to see," Sitharaman said.

She added, "When you don't put the nation first, when you put your first family first, and when you have other consideration than transparency, the results are out there for you to see. So what happened after 2008 when there was a global financial crisis and what happened post-COVID shows clearly that if the intent of the government is sincere results will be good."

Sitharaman said the Modi Government handled the much more "deadly" Covid crisis with sincerity and dedication, unlike UPA in 2008, which did not have "clean" intention.

The party which could not handle the global financial crisis and continued with corruption and scandal is now giving lecture to the Modi Government, the minister said, amid shouting by Opposition members.

If you have the courage, you should not interrupt my speech and instead give a reply, Sitharaman told them.

India Has Nearly 97 Crore Voters Now, Says Poll Body

NEW DELHI, Feb 9 (Agencies): The Election Commission on Friday said nearly 97 crore Indians will be eligible to vote in this year's Lok Sabha elections.

It also said over two crore young electors in age group of 18 to 29 years have been added in the voters' list.

There has been a six per cent increase

in registered voters from 2019, when the last Lok Sabha polls were held. "The largest electorate in the world -- 96.88 crore are registered to vote for the forthcoming General Elections in India," the EC said.

The gender ratio has increased from 940 in 2023 to 948 in 2024, the poll panel said. The Commission has put special emphasis

on purity and health of the electoral roll along with disclosures and transparency in the revision of electoral rolls, an official pointed out.

Chief Election Commissioner Rajiv Kumar had explained at a press conference in Pune the various tasks involved in revision of electoral rolls along with participation of political parties at every stage.

Uttarakhand Official Says Rioters Trying To "Terrorise Area", Cops On Alert

HALDWANI, Feb 9 (Agencies): Violence in Uttarakhand's Haldwani while officials were demolishing an illegal mosque and madrasa resulted in the deaths of 4 people. The clash led to injuries to over 50 policemen, with several administration officials, municipal workers, and journalists also caught in the crossfire. Shoot-at-sight orders have been issued in Haldwani and internet services completely shut down in a bid to control rioters.

Describing the gravity of the situation, Nainital District Magistrate said that rioters threw petrol bombs at a police station, and also set vehicles on fire.

"The demolition drive started peacefully, the force was deployed for prevention. Stones were pelted on our Municipal Corporation's team. It was planned that the day the demolition drive will be conducted the forces would be attacked," Vandana Singh said.

"The first mob with stones were dispersed and the second mob that came in had petrol bombs. This was unprovoked and our team did not use any force," she added.

She said that the rioting mob used "maximum force" while attacking the police station.

"Efforts were made (by the mob) to terrorise the area. Our priority was to protect the police station and then ensure that no loss of life or property occurred in Gandhi Nagar," Ms Singh

The madrasa and mosque had been declared illegal by the administration, leading to their demolition. Ms Singh emphasised that the demolition drive was taken in compliance with the High Court's orders, and notices were issued to all parties involved.

"After the High Court's orders, actions against encroachments were taken in various places in Haldwani. A task force has been formed at the district level to remove illegal encroachments on other government lands," she said.

The official said that due process was followed, notices were issued to all concerned parties, and a hearing committee was



formed to ensure a fair evaluation of each case.

However, some individuals resorted to violence, attempting to breach the High Court's

As the bulldozer razed the structures, enraged residents, including women, took to the streets in protest. As they broke barricades and clashed with the police, the situation escalated rapidly. Mobs then hurled stones at cops, municipal workers, and journalists, resulting in injuries and property damage. More than 20 motorcycles and a security bus were set ablaze.

The DM emphasized that the police force exercised maximum restraint and did not provoke or harm anyone. Tear gas and water cannons were only used to safeguard the police station. The primary goal was to protect public safety and prevent loss of

life or property. While the situation remains tense, authorities are actively working to restore order in Haldwani. The demolition drive, aimed at removing illegal encroachments, will continue as part of the ongoing efforts to safeguard government properties across the region.

"Detailed Probe Will Be Done": Ajit Pawar On Team Thackeray Leader's Murder



PUNE, Feb 9 (Agencies): Maharashtra Deputy Chief Minister Ajit Pawar on Friday described the murder of Shiv Sena (UBT) leader Abhishek Ghosalkar during a 'Facebook Live' as "wrong and unfortunate" and assured that a detailed probe will be conducted to find out what led to the crime.

A viral video of the incident, which took place at assailant Mauris Noronha's office in IC Colony in the northern suburb of Borivali (West) on Thursday evening, showed Ghosalkar being shot in the abdomen and shoulder. Within moments, Noronha also killed himself.

The probe has been handed over to the Mumbai Crime Branch.

"It was wrong and unfortunate. Such incidents should not happen in the state. The conversation between the two during the live-streaming seemed friendly. Looking at the conversation, their relationship also looked cordial," Pawar told reporters in

"A detailed investigation needs to be done about what exactly had

happened between

them," he said. Abhishek (40), son of former MLA Vinod Ghosalkar, a loyalist of the Uddhav Thackeray-led party, was also a former corporator. The fatal attack on him came days after a BJP MLA was caught on camera firing at a leader of the Eknath Shinde-led Shiv Sena inside a police station at Ulhasnagar.

Sena (UBT) MP Sanjay Raut has demanded Deputy Chief Minister and Home Minister Devendra Fadnavis' resignation over Ghosalkar's murder.

Pawar said the opposition is making an issue out of the incident, trying to defame the government and demanding the resignation of the home minister.

"They have got a chance (to target the government) now. But the background of the incident needs to be probed. It needs to be checked what exactly had happened (between them) in the past," he said.

Pawar said that Chief Minister and deputy CM Fadnavis have taken cognisance of the incident.

Asked about Mumbai Congress leader Baba Siddique's move to NCP, Pawar said he would join the party on Saturday evening.

"On February 11 (Saturday), some more people will be joining NCP. We are urging everyone to join NCP as the Election Commission of India has given its verdict in terms of the party name and symbol," he said.

The poll commission recently held that the faction led by Ajit Pawar is the real NCP and it is entitled to use the party's name and 'clock' symbol.

Ajit Pawar also responded to a question about workers from the Sharad Pawar faction damaging a board bearing his name outside the NCP office in Pune.

Referring to the then undivided NCP's Pune unit chief Prashant Jagtap, who is now with the Sharad Pawar group, Ajit Pawar said he made the former the mayor of the city. When nobody suppored Jagtap in the party, Pawar said he took the lead in making the NCP leader their city unit president.

"He (Jagtap) has resigned as party unit president. He had tendered his resignation accusing people in the party of harassing him. I did not accept the resignation then. We had counselled him," he said.

Telangana man kills girlfriend with axe after she opts for arranged marriage

HYDERABAD, Feb 9 (Agencies): A man allegedly killed his girlfriend with an axe as she started avoiding him after her family planned for her arranged marriage. The woman's sister, who was with her during the attack, was also injured in the incident that took place in Khanapur town in Telangana's Nirmal district.

The woman, Alekhya, was coming with her sister from a tailoring institute around 1.30 pm on Thursday when her boyfriend, Jukanti Srikanth, attacked her with an axe.

Alekhya died on the spot while her sister sustained injuries. Srikanth fled the scene after the attack and is currently on the run.



The duo were in a relationship, but Alekhya had started avoiding Jukanti after her family planned for her arranged marriage.

A case has been registered. A search is on to trace the accused and further investigation is underway, police today.

Odisha man arrested for raping, uploading obscene photos of daughter's friend

JAJPUR, Feb 9 (Agencies): Police arrested a 54-year-old man in Odisha's Jajpur district for allegedly raping his daughter's friend and uploading her obscene photos after she refused to have physical relationship with him, a police officer said on Friday.

According to the complaint filed by the victim at Panikoili police station, the accused happens to be the father of her friend. The accused was known her as she had visited her friend's house many times.

"I had gone to my friend's house to meet her last year. When I reached there, my friend and her mother were not at home. When I inquired about my friend, her father who was alone in the house



told me she had gone outside and would return after some time, so I waited in the house to meet her. Taking advantage of the situation he sexually assaulted me", the victim stated in her complaint.

However, she did not reveal it to her friend or anybody else as the accused apologised for the incident. The victim said the accused raped her again when she was in her relative's house in Cuttack a couple of months back. He also filmed the act on his mobile phone, she stated in her complaint.

The accused then threatened to make the photos of their intimate moments viral if she did not continue the physical relationship, as per the complaint.

Meanwhile, the marriage of the victim was finalised to a youth in the area. The accused came to know about the marriage and asked her to continue the relationship but the woman refused to have a relationship with him as her marriage was already finalised.

The accused then posted her obscene photos on social media last week.

The victim filed a complaint after learning from her friends about her obscene photos posted on social media on Tuesday, said Lizarani Biswal, inspector in-charge (IIC), Panikoili police station.

Based on the complaint, police registered a case under the relevant sections of the IPC and IT Act and arrested the accused, the IIC said.

BJP demands action against clearance of Rs 16,683 crore Budget in Delhi Assembly increasing the financial power by



NEW DELHI, Feb 9 (Agencies): A delegation of the Delhi BJP unit submitted a memorandum today to the office of Delhi's Lieutenant Governor, Vinay Kumar Saxena, demanding action against the illegal passage of the Budget in the Delhi Municipal Corporation by the ruling Aam Aadmi Party.

The Municipal Corporation of Delhi (MCD) House on Tuesday passed a Budget with proposals for expenditure of Rs 16,683 crore for 2024-25 amid a ruckus as Opposition BJP councillors accused Mayor Shelly Oberoi of

corruption. The chaos continued during the Budget's second representation on Thursday.

The BJP delegation which submitted the complaint before L-G Saxena included opposition leader Sardar Raja Iqbal Singh, along with councillors Shikha Ray and Yogesh Varma.

Sardar Raja Iqbal Singh stated the clearance of the Budget in the Delhi Assembly was a blatant attack on democracy that is underway within the Delhi Municipal Corporation. Mayor Shaili Oberoi passed a proposal from the house,

up to Rs 10 crore without discussion, ultimately approving a budget of Rs 1500 crore.

Sardar Raja Iqbal Singh emphasised that no municipality in the country grants the mayor such a power allocation of 1500 crore rupees. While constitutional committees, whether standing, education, or ward committees, hold their power, the Mayor has committed an attack on democracy, which the BJP strongly opposes.

BJP's Shikha Ray said, "In a democracy, no individual is given absolute power. Yet today, within the Assembly, the Mayor behaved as if they didn't feel the need to discuss with the opposition and passed the budget without any discussion, which we oppose.'

Yogesh Varma stated that a conspiracy of embezzlement of Rs 1500 crore annually by the Aam Aadmi Party was devised and illegally passed in the Delhi Assembly. We have lodged a complaint with the Lieutenant Governor regarding these matters, action on which will be taken soon.

Imran Khan's party claims victory in Pakistan's General **Election**; Nawaz Sharif's PML-N makes counterclaim

A party must win 133 seats out of 265 being contested to form the next government

ISLAMABAD, Feb 9 (Agencies): Jailed former Pakistan prime minister Imran Khan's party on Friday claimed victory in the General Election while alleging that results were being delayed to rig the outcome.

In a statement, the Pakistan Tehreek-e-Insaf (PTI) party also asked PML-N's supreme leader Nawaz Sharif, who was the favourite to win as he was backed by the powerful Army, to concede defeat.

The PML-N, however, rejected the demand and claimed that it was winning Thursday's elec-

Votes are still being counted in Pakistan after Thursday's General Election which was marred by allegations of rigging, sporadic violence and a countrywide mobile phone shutdown.

There were dozens of parties in the fray but the main contest was among Khan's PTI, whose candidates are running as independents, former threetime premier Sharif's Pakistan Muslim League (N) and Bilawal Zardari Bhutto's Pakistan Peoples Party (PPP)

In a statement on X from the PTI official handle, the party stated that it won more than 150 NA seats out of 265 open for contest as per the data received in Form 45s, which are the primary source of election results at the lowest level and show the



votes for each candidate at each polling station.

A party must win 133 seats out of 265 being contested to form the next government.

"Copies of these forms have been collected by PTI candidates' polling agents, which show them winning by a large majority. According to independent reports, PTI has won well over 150 National Assembly seats & is in a solid position to form government in Federal, Punjab & KP (Khyber-Pakhtunkhwa), with a clear majority," it stated.

"However, manipulation of the results in the late hours of the night is an utter disgrace & a brazen theft of the nation's mandate. The people of Pakistan vehemently reject the rigged results. The world is watching," it asserted.

In another statement, PTI alleged that its mandate was being stolen.

"Let the world know that the clear and overwhelming mandate of the people of Pakistan is being stolen. Despite unprecedented pre-poll rigging & oppression, there was a record, massive turnout on polling day," it stated The party said that every independent candidate backed by it was winning by a landslide.

It also said that Returning Officers are now manipulating the results using Form 47, which is a summary of Form 45 from each polling station.

"Furthermore, there are reports of the polling agents getting abducted & forced to sign fake Form 45s," it said.

It also referred to unspecified reports to claim that "PTI nominated candidates (were) losing suddenly in various constituencies now, after they had already won by a clear majority".

In another statement, the party asked Sharif to concede defeat.

"Show some grace @NawazSharifMNS, accept the defeat! The people of Pakistan will never accept you. This is a golden opportunity to regain some credibility as a Democrat. Daylight robbery is going to be rejected massively by Pakistan!" it said in a statement on X.

PML-N has countered the PTI claim about results and said that it was winning.

"Based on data compiled in PMLN Election Cell and results already in the public domain, PMLN has emerged as the single largest political party in the National Assembly and a clear majority party in Punjab Assembly," according to party leader Ishaq Dar.

He also said that "premature and biased speculations" must be avoided as the country awaits the official complete results from ECP.

Putin accuses West of 'prolonging Ukraine conflict', urges US to halt arms supply



MOSCOW, Feb 9 (Agencies): In his first media interview ever since the Russia-Ukraine war broke out, Russian President Vladimir Putin accused the United States and other Western countries of prolonging the war. He also said the US needed to stop supplying weapons to Ukraine.

During a conversation with former Fox News host Tucker Carlson, Putin claimed peace talks with Ukraine were almost on the finish line, when President Volodymyr Zelenskyy began obeying the instructions from the West.

The interview was aired on 'Tucker Carlson Tonight', a streaming service that Carlson launched in December 2023. Notably, Carlson was fired by Fox News in April 2023, for getting 'too big for his boots', a book claimed.

"Ukraine threw away all these agreements and obeyed the instructions of Western countries, European countries, and the United States to fight Russia to the bitter end," Putin told Carlson.

Though the Kremlin, in December last year, said that engaging in peace talks with Ukraine was 'unrealistic', Putin claimed Russia still speaks with the US 'through various agencies' about ending the war.

"If you really want to stop fighting, you need to stop supplying weapons. It will be over within a few weeks," Putin said, in a message to the United States.

Recalling his last conversation with Joe Biden, before Russia invaded Ukraine, Putin said, "I said to him, then, I believe that you are making a huge mistake of historic proportions by supporting everything that is happening there, in Ukraine, by pushing Russia away.'

The Russian President also particularly blamed former British Prime Minister Boris Johnson, who was forced out of the UK Parliament in June 2023, and said Johnson had dissuaded Zelenskyy from signing a peace deal in the early stages of the conflict.

"The fact that they (Ukraine) obey the demand or persuasion of Mr Johnson, the former prime minister of Great Britain, seems ridiculous," Putin said.

Putin also spoke about the Central Intelligence Agency - the civilian foreign intelligence service of the United States, revealing Carlson wanted to join the agency.

"The CIA, the organisation you wanted to join back in the day, as I understand," Putin told Carlson, adding, "We should thank God they did not let you in."

"Although it is a serious organisation, I understand," Putin remarked.

The entire interview was shared on X by Tucker Carlson, who has frequently criticised US support for Ukraine, and has referred to Zelenskyy as a 'Ukrainian pimp' and 'rat-like'.

Ahead of the interview, Carlson said he was driven to speak to Putin because the Americans had "no idea why Putin invaded Ukraine or what his goals are now".

'My memory is fine': Joe Biden hits back at special counsel over 'hazy' and 'poor' age jibe

WASHINGTON, Feb 9 (Agencies): A special counsel report released Thursday found evidence that President Joe Biden willfully retained and shared highly classified information when he was a private citizen, including about military and foreign policy in Afghanistan, but concluded that criminal charges were not warranted.

The report from special counsel Robert Hur resolves a criminal investigation that had shadowed Biden's presidency for the last year. But its bitingly critical assessment of his handling of sensitive government records and unflattering characterisations of his memory will spark fresh questions about his competency and age that cut at voters' most deep-seated concerns about his candidacy for re-election.

Beyond that, the harsh findings will almost certainly blunt his ability to forcefully condemn Donald Trump, Biden's likely opponent in November's presidential election, over a criminal indictment charging the former president with illegally hoarding classified records at his Mara-Lago estate in Florida. Despite abundant differences between the cases, Trump immediately seized on the special counsel report to portray himself as a victim of a "two-tiered system of justice."

Yet even as Hur found evidence that Biden willfully held onto and shared with a ghostwriter highly classified information, the special counsel devoted much of his report to explaining why he did not believe the evidence met the standard for criminal charges, including a high probability that the Justice Department would not be able to prove Biden's intent beyond a



reasonable doubt, citing among other things an advanced age that they said made him forgetful and the possibility of "innocent explanations" for the records that they could not refute

In remarks at the White House, Biden denied Hur's assertion that he shared classified information, saying, "I did not share classified information. I did not share it with my ghostwriter." He also angrily lashed out at the special counsel for questioning his recollection of his late son Beau's death from

"How in the hell dare he raise that?" Biden asked, saying he didn't believe it was any of Hur's business.

And in response to Hur's portrayal of him, Biden insisted to reporters that "My memory is fine," and said he believes he remains the most qualified person to

serve as president. Biden's lawyers blasted the report for what they said were inaccuracies and gratuitous swipes at the president. In a statement, Biden said he was "pleased" Hur had "reached the conclusion I believed all along they would reach — that there would be no charges brought in this case and the matter is now closed." He pointedly noted that he had sat for five hours of in-

person interviews in the immediate aftermath of Hamas's October attack on Israel, when "I was in the middle of handling an international crisis."

"I just believed that's what I owed the American people so they could know no charges would be brought and the matter closed," Biden said.

The investigation into Biden is separate from special counsel Jack Smith's inquiry into the handling of classified documents by Trump after Trump left the White House. Smith's team has charged Trump with illegally retaining top secret records at his Mar-a-Lago home and then obstructing government efforts to get them back. Trump has said he did nothing wrong.

Hur, a former US Attorney in the Trump administration, was appointed by Attorney General Merrick Garland as special counsel in January 2023 following an initial discovery by Biden staff of classified records in Washington office space. Subsequent property searches by the FBI, all coordinated voluntarily by Biden staff, that turned up additional sensitive documents from his time as vice president and senator.

Hur's report said many of the documents recovered at the Penn Biden

Center in Washington, in parts of Biden's Delaware home and in his Senate papers at the University of Delaware were retained by "mistake." Biden could not have been prosecuted as a sitting president, but Hur's report states that he would not recommend charges against Biden regardless.

"We would reach the same conclusion even if Department of Justice policy did not foreclose criminal charges against a sitting president," the report said.

But investigators did

find evidence of willful retention and disclosure of a subset of records found in Biden's Wilmington, Delaware house, including in a garage, office and basement den. The files pertain to a troop surge in Afghanistan during the Obama administration that Biden had vigorously opposed. He kept records that documented his position, including a classified letter to Obama during the 2009 Thanksgiving holiday.

Documents found in a box in Biden's Delaware garage have classification markings up to the Top Secret/Sensitive Compartmented Information Level and "other materials of great significance to him and that he appears to have personally used and accessed." Hur, though, wrote that there was a "shortage of evidence" to prove that Biden placed the documents in the box and knew they were there.

Some of the classified information related to Afghanistan was shared with a ghostwriter with whom he published memoirs in 2007 and 2017. As part of the probe, investigators reviewed a recording of a February 2017 conversation between Biden and his ghostwriter in which Biden can be heard saying that he had "just found all the classified stuff downstairs."

'Miracle' Rescue Of Child Nearly 60 **Hours After Philippine Landslide**

MANILA, Feb 9 (Agencies): The rescue of a child on Friday nearly 60 hours after a landslide hit a gold-mining village in the southern Philippines has been hailed as a "miracle" after searchers had given up hope of finding anyone alive.

The girl, whose age has not been disclosed, had been among the more than 100 people missing after the raininduced landslide hit the village, killing at least 11 people.

She was found as rescuers used their bare hands and shovels to look for survivors in Masara village on southern Mindanao island, disaster agency official Edward Macapili of Davao de Oro province told agency.

"It's a miracle." Macapili said, adding that searchers had believed the missing were prob-

ging. Rain has pounded parts of Mindanao on and off for weeks, triggering dozens of landslides and flooding that have forced tens of thousands of people into emergency shelters.

Massive earthquakes have also destabilised the region in recent months.

Hundreds of families from Masara and four nearby villages have had to evacuate from their homes and shelter in emergency centres for fear of further landslides.

Schools across the municipality have sus-

pended classes. The area hit by the landslide had been declared a "no build zone" after previous landslides in 2007 and 2008, Macapili said.

US and British forces have responded with strikes against the Houthis, who have since declared American and British interests to be legitimate targets as

The Red Sea attacks have raised insurance premiums for shipping companies, forcing many to avoid the Red Sea, a vital route that normally carries about 12 percent of global maritime trade.

What came as a surprise was that the domestic-focused broader market indices witnessed a bigger slide in comparison to the benchmark Sensex and Nifty.

While Nifty Bank and Nifty Financial Services rebounded after falling in early trade, the overall



sentiment was dragged down by weakness in metal, realty, IT and oil & gas stocks.

The top five gainers on the Nifty50 were ITC, ICICI Bank, Reliance, SBI and Sun Pharma. On the other hand, the top losers were ONGC, M&M, Hindalco, Coal India and BPCL.

Mandar Bhojane, research analyst at Choice Broking, said, "On the daily chart, the Nifty has formed a significant Bearish Engulf,

indicating bearish pressure."

"On the lower side, Nifty is expected to find strong support around 21,500-21,400 levels, and dips towards these levels can be considered for initiating fresh long positions, Bhojane noted.

"From current levels. in the short term, the upside will be limited, and the range of 22,000-22,200 will continue to act as a stiff supply zone for the index," he added.

Biocon expands Sandoz partnership to sell biosimilars in Australia

Sandoz will promote, sell and distribute two of Biocon Biologic's cancer biosimilars - Trastuzumab and Bevacizumab - in Australia

BANGALORE, Feb 9 (Agencies): Bangalorebased Biocon Biologics Ltd (BBL) announced a new partnership with Sandoz AG to promote, sell and distribute two of its cancer biosimilars - Trastuzumab and Bevacizumab - in Australia. The 5-year exclusive agreement provides Sandoz the rights to market these medications under BBL's brands OGIVRI and ABEVMY.

Trastuzumab biosimilar OGIVRI is a cheaper version of Roche's breast cancer drug Herceptin, while Bevacizumab biosimilar ABEVMY mirrors Roche's Avastin that treats several tumor types. Both biosimilars were previously distributed in Australia by another pharmaceutical firm before this deal.

A biosimilar is a biochemical compounds, logic medical product



that is almost an identical copy of an original product that is manufactured by a different company and are designed to have properties and effects highly similar to an already FDA-approved biologic, known as the "reference product." Biologics are complex medications derived from living organisms and are used to treat diseases like cancer or autoimmune disorders.

Unlike generic drugs made from simple biosimilars are much more structurally complex and made using living cells, making an exact replica impossible

Biocon Biologics said the agreement with Sandoz enables continued patient access to these vital cancer medicines by leveraging Sandoz's reach and capabilities in the Australian pharmaceutical market.

"This relationship is also a crucial step for patients in Australia, ensuring continued access to high-quality, affordable biosimilar medicines used in oncology," the company said.

As per estimates, Trastuzumab and Bevacizumab have a combined market value of AUD 80 million in Australia. By securing distribution through Sandoz, BBL aims to drive higher utilization of its biosimilars and expand patient access to these essential treatments.

The deal also expands the global Biocon-Sandoz partnership established last December for the Japanese market. For Sandoz, it bolsters their biosimilars portfolio for oncology while advancing patient access.

The commercialization of OGIVRI and ABEVMY by Sandoz in Australia has already commenced on 1st February 2024 after regulatory approvals. The expanded availability of these economical biosimilars is a promising development for cancer patients in Australia as costs have been a major barrier to treatment access over the years.

BBL now has 8 commercialized biosimilars across several advanced & emerging economies. According to BBL's executives, this deal aligns with their mission of transforming healthcare through high-quality biosimilars with expanded reach.

About 3.4 crore older Indians living with mild cognitive impairment, affecting daily lives: Study

NEW DELHI, Feb 9 (Agencies): In India, an estimated 3.4 crore older adults, aged 60 years and above, are living with mild cognitive impairment, affecting their daily lives and activities in some manner, new research has found.

It estimated that 2.4 crore and almost 1 crore older adults are living with mild and major neurocognitive disorders, respectively, impairing faculties like memory, attention, executive function and language, and signifying potential

Using survey data from nationally representa-India, researchers found a higher prevalence of these disorders in the older ones (over 80 years old) and in those with lower levels of education. The prevalence in women and men was found to be comparable and almost equal.

The team also found the prevalence to be higher in rural-living older adults than urban ones, and more in the illiterate than the literate.

About 13.4 crore adults in India are estimated to be aged 60 years and above, and are projected to constitute 20 per cent of the population by


international team of researchers, led by Johns Hopkins University, US, and including those at St. John's Medical College, Bengaluru, Karnataka, recruited almost 4,100 participants residing in 18 geographically and linguistically diverse states such as Jammu & Kashmir, Punjab, Delhi, West Bengal, Maharashtra, Karnataka, Tamil Nadu, among others. The majority of the group was aged 60-79 years.

For their analysis, the researchers relied on the Diagnostic and Statistical Manual of Mental Disorders (DSM-5), a widely recognised clinical diagnostic authority. It recognises that dementia typically involves cognitive decline severe enough to interfere with one's daily functioning, they

explained.

criteria for neurocognitive disorder entails documentation of cognitive decline and assessing now independent an individual performs their everyday activities. The criteria also describes exclusionary conditions, based on which the researchers excluded participants with active delirium, schizophrenia, history of stroke, and major depression, all of which were ascertained through interviews.

The DSM-5 diagnostic

Upon analysing all the data, the researchers found that the population prevalence of DSM-5 mild and major neurocognitive disorder was 17.6 per cent and 7.2 per cent, respectively.

They also found that the prevalence of major neurocognitive disorder was greater with older ages - from about 4 per cent among those aged 60-64 years to 15.2 per cent among those aged over 80 years.

Among the participant sample, the team found that 12 per cent reported severe loss in at least one ADL (activities of daily living) and 8.5 per cent reported impairment in any IADL (instrumental activities of daily living).

Major neurocognitive disorder was more prevalent among illiterate (9.3 per cent) than literate (5 per cent) and rural (10.3 per cent) than urban (4.9 per cent) participants, they found.

"These findings, coupled with a growing number of older adults in the coming decades in India, have important implications for society, public health, and families," the researchers wrote.

Research reveals surprising connection between body temperature and depression



WASHINGTON DC (US), Feb 9 (Agencies): People with depression have higher body temperatures, which suggests that reducing their temperatures may have a mental health advantage, according to a new UC San Francisco research.

The study, published in Scientific Reports, doesn't indicate whether depression raises body temperature or a higher temperature causes depression. It's also unknown whether the higher body temperature observed in people with depression reflects decreased ability to self-cool, increased generation of heat from metabolic processes or a combination of both.

Researchers analysed data from more than 20,000 international participants who wore a device that measures body temperature, and also self-reported their body temperatures and depression symptoms daily. The seven-month study began in early 2020 and included data from 106 countries.

The results showed that with each increasing level of depression symptom severity, participants had higher body temperatures. The body temperature data also showed a trend toward higher depression scores in people whose temperatures had less fluctuation throughout a 24-hour period, but this finding didn't reach significance.

The findings shed light on how a novel depression treatment method might work, said Ashley Mason, PhD, the study's lead author and associate professor of psychiatry at UCSF Weill Institute for Neurosciences. A small body of existing, causal studies has found that using hot tubs or saunas can reduce depression, possibly by triggering the body to self-cool, for example, through sweating.

"Ironically, heating people up actually can lead to rebound body temperature lowering that lasts longer than simply cooling people down directly, as through an ice bath," said Mason, who is also a clinical psychologist at the UCSF Osher Center for Integrative Health. "What if we can track the body tem-

perature of people with depression to time heat-based treatments well?" "To our knowledge, this is the larg-

est study to date to examine the association between body temperature - assessed using both self-report methods and wearable sensors - and depressive symptoms in a geographically broad sample," added Mason. "Given the climbing rates of depression in the United States, we're excited by the possibilities of a new avenue for treatment."

Study shows anticoagulants fail to prevent unexplained strokes

NEW YORK, Feb 9 (Agencies): A common practice of prescribing anticoagulants to people who have had unexplained strokes should stop, according to a study that shows it is not beneficial to prevent the risk. Anticoagulants were thought to pre-

vent additional strokes in people whose initial stroke has an unknown cause but who have a heart condition, atrial cardiopathy that resembles atrial fibrillation, a common cause of stroke. "We know these drugs work for people

with atrial fibrillation, so we thought that they would probably work for people with atrial cardiopathy as well," said Mitchell Elkind, Professor of neurology at the Vagelos College of Physicians and Surgeons.

However, the trial of 1,015 people, published in JAMA, found that patients with atrial cardiopathy who were given the anticoagulant apixaban had the same stroke rate, 4.4 per cent as patients who were given aspirin, the current standard of care.

"It's disappointing as a physicianscientist to not have your hypothesis proven, but this study is still providing really useful information.



"It tells neurologists that patients with this type of heart condition, atrial cardiopathy, should not get anticoagulants, which are riskier than aspirin and should be reserved for people with definitive evidence of atrial fibrillation,"

One-third of strokes have unknown causes, a challenge for neurologists trying to help their patients avoid subsequent strokes.

The team found that the unexplained strokes occur due to changes in heart that resemble changes seen in AFib.

They said there are several possible reasons why the trial did not support their hypothesis, including that they tested the right treatment in the wrong patients.

valve inside body LONDON, Feb 9 (Agencies): Replacement heart valves that grow inside the body may be a step closer to

reality. Researchers at the Imperial College London and Harefield Hospital in the UK have developed a novel treatment that harnesses body's natural repair mechanisms to build a living heart valve.

The results are published in the journal Communications Biol-

"The aim of the concept we've developed is to produce a living valve in the body, which would be able to grow with the patient," said Yuan-Tsan Tseng, a biomaterials scientist working at the Imperial's National Heart and Lung Institute and

the Harefield Heart Science Centre. Heart valve replace-

ment is a life-saving treatment, but it is rarely a long-term solution. Both mechanical and biological valves have their own drawbacks. Patients with mechanical valves must take drugs for the rest of their lives to prevent blood clotting.

Biological valves, on the other hand, only last between 10 to 15 years. The treatment is particularly challenging for children with congenital heart defects, as the valves do not grow along with their bodies and must be replaced several times before they reach adulthood.

The new procedure begins with a nanofibrous polymeric valve, but made from a biodegradable polymer scaffold rather than a

New heart treatment to help grow a replacement

durable plastic. "Once this is inside the body, the scaffold recruits cells and instructs their development, so that the body works as a bioreactor to grow new tissues," Tseng explained. "The scaffold gradually degrades and is replaced by our body's own tissues.

The scaffold material used to make the valve is the key innovation. "It has the capability to attract, house, and instruct appropriate cells from the patient's own body, thereby facilitating tissue generation and maintaining valve

function." The team transplanted the valve into sheep and monitored for up to six months.

"The valves performed well," Tseng said. "They continued to function for the six months of the trial, and also showed good cellular regeneration."

In particular, the study shows that the scaffold was able to attract cells from the blood stream which then developed into functional tissues, a process known as endothelial-to-mesenchymal transformation.

"We've also seen nerves and fatty tissues growing in the scaffold, as we might expect in a normal valve.'

Meanwhile, the polymer could be seen degrading to make way

for the new tissue. "If there was no regeneration, the valve would fall apart as the polymer degrades. But what we see is continuing functionality, and that means cell regeneration is taking place over time. That proves that our idea of in-vivo regeneration is working.'

More work is required to determine exactly which processes are causing the polymer to degenerate and how closely it is linked to tissue regeneration.

"But the tissue regeneration is definitely sufficient to cover the structural integrity and functionality of the valve," Tseng said.

The team aims to get regulatory approval for the first clinical trials. hopefully in the next five years or so.

Australia edge out Pakistan by one wicket, to face India in U19 World Cup final

The summit clash will be played at the same venue on Sunday

BENONI (SOUTH AFRICA), Feb 9 (Agencies): Tom Straker's six-wicket haul and Harry Dixon's fifty inspired Australia to a tense one-wicket victory over brave Pakistan in the semifinal here on Thursday, setting up their ICC Under-19 World Cup final against defending champions India.

The summit clash will be played at the same venue on Sunday.

Pakistan made a below par 179, built around two half-centuries by Arafat Minhas (52) and Azan Awais (52) as they struggled against pacer Straker (6/24).

Despite having their own struggles against spirited Pakistan bowlers, the Aussies managed to reach 181 for 9 in 49.1 overs to seal the final berth with Dixon (50, 75b, 5x4) and Oliver Peake (49, 75b, 3x4) leading their chase.

While India will be playing their ninth title match, the Aussies are appearing in their sixth final

appearing in their sixth final.

India have won a record five titles while Australia have bagged three, and the last time the Yellow Brigade lifted the trophy was in 2010 with a win over Pakistan. That edition was



held in New Zealand.

However, Australia's win was anything but smooth as a bunch of determined Pakistan bowlers made them stretch for every single run.

Australian openers Dixon and Sam Konstas (14) added 33 runs but they lost four wickets while adding 26 runs in 6.2 overs that pushed them into a tight corner.

Not many teams relish the pressure situation better than the Aussies and they brought out that quality to the fore here

Dixon, who made his third fifty of the tournament, and Peake milked 43 runs for the fifth

wicket in a shade over 10 overs that kept the Aussies firmly in the hunt.

But left-arm spinner Minhas snapped the partnership, castling Dixon with a sharply-spun ball that clipped the bails off.

But Peake and Tom Campbell (25, 42b, 2x4) guided the Aussies forward adding 44 runs in a little over 11 overs without taking any undue risks.

However, a moment of pure magic from Arafat ended the blossoming stand, as the Pakistan spinner rattled Campbell's off-stump with an arm ball.

Pakistan soon inflicted an even bigger blow through impressive 15-year-old pacer Ali Raza who

had Peake caught behind down the leg side.

Raza, who bowled through the cramps during his last spell, soon added Straker and Mahli Beardman to the list of victims in his last over as Australia slumped to 164 for nine.

They needed a further 16 runs to win from that point with a wicket in hand but Raf Mac-Millan (19 not out) and Callum Vidler (3 not out) dragged their team past the line in the final over.

In contrast to their lion-hearted effort with the ball, Pakistan, earlier, had dished out a shaky effort with the bat after the Aussies won the toss and elected

They lost openers Shamyl Hussain and Shazaib Khan inside the first Power Play segment itself as the Aussies pacers bowled the hard lengths to keep their opponents on the backfoot.

Straker, Beardman and Vidler bent their backs to hit the pitch hard and purchase a good amount of bounce and carry to trouble Pakistan batters as they could only manage 27 runs in the initial 10 overs.

"All I know is he is fine. He is spending a bit of time with his family, that is the reason he is missing the first two Test matches. I am not going to confirm anything else. I cannot wait to see him back. He is fine, he is doing well," AB de Villiers said in his YouTube show on Saturday.

"Let me just see what he said.
I just want to at least give you (fans) a little bit of love," he added.

"So I wrote to him 'Been want-



ing to check in with you (sic) for a while now biscuits. How are you?'. He said 'Just need to be with my family right now. I am doing well.'.

"Yes, his second child is on the way. Yes, it's family time and things are important to him. If you are not true and genuine to yourself, you lose track of what you are here for. I think most people's priority is family. You can't judge Virat for that. Yes, we miss him. But he has made absolutely the right decision," he added.

Ravindra Jadeja Provides Huge Injury Update Ahead Of Team Selection For England Tests



NEW DELHI, Feb 9 (Agencies): Indian cricket team all-rounder Ravindra Jadeja took to social media to provide a massive injury update ahead of the team selection for the remaining three Test matches against England. Jadeja suffered a hamstring injury during the first Test match and that resulted in him missing the second match that India won comprehensively in Visakhapatnam. With the five-match series placed perfectly at 1-1, India will benefit immensely from Jadeja making a comeback from injury. The cricketer posted a picture of himself from the National Cricket Academy along with the caption - "Getting better #NCA,". Meanwhile, Jasprit Bumrah became

the first Indian pacer to top the ICC Test rankings after a stellar performance against England in Visakhapatnam.

The 30-year-old's nine-wicket match haul has helped him leapfrog Pat Cummins, Kagiso Rabada and Ravichandran Ashwin, making him only the fourth from his country to attain number one position.

Ashwin, Ravindra Jadeja and Bishan Singh Bedi are the other Indians who have been at the top of the charts.

Bumrah, who was named Player of the Match after helping India level the five-match series with a 106-run victory, ended Ashwin's 11-month long reign. Ashwin, on 499 Test wickets, is now third in the standings.

Bumrah now has 881 rating points with Ashwin (904) and Jadeja (899) the only India bowlers to have aggregated more rating points. Ashwin and Jadeja also have the unique distinction of being jointly top-ranked in March 2017.

The batting rankings see left-handed opener Yashasvi Jaiswal progress 37 places to 29th after completing a fine double-century in the first innings and Shubman Gill go up 14 places to a career-best 38th after notching a century in the second innings.
