

#### **Driver dies** as tipper plunges into Dal Lake

SRINAGAR, Feb 15 (Agencies): A Tipper driver died after the vehicle he was driving plunged into the Dal Lake near Makaye Park in Srinagar, officials said. A police official said that reports were received that a tipper bearing registration number JK06-2692 plunged into the Dal Lake near Makaye point, following which a team was dispatched to the spot. "Body of the driver has been fished out and has been taken in procession for further medico-legal formalities,' the police official said. The driver has been identified as Tarig Ahmad Khatana, son of Muhammad Hussain of Kangan. According to the police officials, the prima facia seems to be the loss of control over the vehicle, adding that the investigation into the incident has been started.

#### **SIA conducts searches at multiple locations in Srinagar** in trans-national human trafficking case

SRINAGAR, Feb 15 (Agencies): The State Investigation Agency (SIA) Kashmir on Thursday conducted extensive searches at 18 locations in Srinagar city, as part of its investigation into a trans-national human trafficking case.

As per statement issued, special teams of the SIA, aided by the Srinagar police, started the searches in the early hours. During the operation, incriminating material and documents such as identity cards, bank documents, identity cards, and registers

#### 3.40 Lakh Central Forces to be deployed for upcoming Lok Sabha and Assembly Polls

NEW DELHI, Feb 15 (Agencies): A total of 3.40 lakh Central Armed Police Force (CAPF) personnel are likely to be deployed during the upcoming Lok Sabha elections as well as the assembly polls in Andhra Pradesh, Odisha and Sikkim, officials said.

The Ministry of Home Affairs (MHA) would decide to deploy the CAPF following consideration of a proposal sent by the Election Commission seeking the deployment of around 3.400 companies (3.40 lakh personnel) of the paramilitary wings in all states and Union Territories in a phased manner to ensure the conduct of free, fair and peaceful elections.

## Braces for moderate to heavy rain, snowfall as night temp continues

SRINAGAR. Feb 15 (Agencies): The night temperature at most places in Kashmir continues to settle below freezing, even as Kashmir is bracing up for possible heavy rain and snowfall from Monday.

An official said a couple of moderate-to-intense Western Disturbances (WD) are most likely to affect J&K and adjoining areas from Saturday afternoon onwards. Meteorological Centre

Srinagar said under the influence of WD, an extended wet spell from February 17 night onwards till February 21 afternoon is most likely to cause moderate rain and snow at many places over J&K and adjoining areas.

The main activity of the WD is likely to occur on February 19-20.

During this period, there is a possibility of light to moderate rain or snow at most places, including plains and lower reaches, with the possibility of heavy snowfall over the middle and higher reaches of Kupwara, Baramulla, Bandipora, Ganderbal, Badgam, Shopian, and Kulgam districts, the MeT office said.

It said that there is a possibility of light to moderate snow at many places till the afternoon or late afternoon and gradual improvement thereafter on February

A significant drop in daytime temperature is

also expected during the period, it said. An independent weath-

er observer, Faizan Arif, said a strong WD is going to affect Jammu and Kashmir from the night or morning of Sunday onwards, and under its influence, moderate to heavy rain and snow are expected in the region.

Initially, there can be rain only on the plains, which can transform into snow later on February 18 or 19.

"There is uncertainty about whether it will continuously snow in the plains as temperatures may again rise on February 19 afternoon. However, for higher reaches, it is going to dump heavy to very heavy snowfall Turn to page 9

## Needed: A less intrusive, more inclusive civil code

Uniform Civil Code (UCC) dealing with matters of personal law is a good idea in a multicultural country like India, given the rising number of cross-community marriages -- although still miniscule in proportion to total marriages. A UCC can be a framework to promote cross-community affinity by applying the benign principle of causing the least harm to any community, borrowing the best features from all personal laws, and ending practices rendered obsolete by time or plainly inequitable like gender inequality.

The Government of Uttarakhand notification dated May 27, 2022 setting up a committee chaired by Justice Ranjana Prakash Desai (Retd) merely states the desired end result of framing a common code for personal laws. It does not elaborate on the various laws which might be impacted or would need to be reconciled. The committee held 41 public meetings, including one in New Delhi, and had received 60,810 suggestions, which indicates the wide range of consultations.

These meetings could have been made more productive if the committee had shared a brief to inform stakeholders of "how" amalgamation across personal laws would be achieved and assured communities that the resulting common code would cause the least harm and reduce dissonance across the existing personal law legislation, thus promoting inter-community marriages, mixed community families and "ease of living" -- an oft repeated goal of the Narendra Modi government.

The success of the UCC will be assessed by a single metric -citizen satisfaction that the discomfort and uncertainty from the new legislation is minimal and that the burden of compliance with government regulations is reduced.

The UCC does well to recognise "live-in heterosexual relationships". These social arrangements are proliferating in cities, where the exigency of eye-wateringly expensive accommodation encourages the sharing of a house, albeit not always in the "nature of marriage". Recognising and defining such households also enables a new safeguard provision under Section 388, which provides maintenance rights for a woman deserted by a "live-in partner". Here the UCC falters by protecting only deserted women. Under Sections 33 and 34 of the code, maintenance rights are available to either spouse as per "good practice" gender neutral terms. In comparison, Section 388 errs in not reproducing this gender-neutral stance.

The code also errs in not using this opportunity to widen the scope of the landmark, ninebench verdict of the Supreme Court of India in Justice K.S. Puttaswamy (Retd) versus the Union of India (2017). The right to privacy is protected as a fundamental right under Articles 14, 19 and 21 of the Constitution of India. Indian laws do not recognise gay marriage. Extending provisions for livein arrangements to the LGBTQ community could have been transformative by bestowing some legitimacy on such relationships. The UCC would have made global headlines for its vision, sagacity, and social empathy.

There is little doubt that codifying "live-in" arrangements, increase state micromanagement of private affairs is an intrusion, which reduces the "ease of living" and enhances litigation. Uncertainties persist. How will the police enforce compliance with the onerous provisions for registration? Is house to house checking next? Will it become mandatory for house owners renting prop-

erty to couples to ask for marriage or "live-in" certificates? How will a court distinguish between a man and a woman who are just sharing a house for economic reasons, or as friends -- where desertion by one would not qualify for maintenance rights -- from a man and a woman "cohabiting in the nature of marriage" -- where maintenance rights would be attracted?

The UCC is tilting at shadows by implicitly seeking to "protect women", thereby painting modern Uttarakhand women in gullible, faintly derogatory, patriarchal terms. Around 80.7 per cent of Uttarakhand's women are literate, versus the national average of 70.3 (NSO 2017). Independent women are the backbone of Uttarakhand's economy.

Women led the forest preservation "Chipko" movement in the 1970s. They manage lands and business, settle disputes, and yet remain homemakers because working men often emigrate for economic reasons or are in the Army posted far away. The world was recently presented visuals of a new Indian womanhood -- column after column of women soldiers, officers, and students -marching down New Delhi's Kartavya Path on Republic Day -- confident, secure, serene -- more than at par with any developed country. The UCC does not internalise this sentiment.

There are good reasons why a uniform civil code makes eminent sense but force-feeding uniformity from the top is not one of them. Judicial law has already plugged loopholes and protected the right to privacy and women's rights. The rights of children are similarly protected with rights and responsibilities linked to parentage irrespective of the bond of marriage.

Conversely, consider the case of polyandry -- an ancient Indian practice mentioned in

the Mahabharata -- still practised under tribal law. Curiously, it has resurfaced as a coping strategy amongst poor, landholding families to prevent the fragmentation of land. The award-winning Punjabi film Kohrra, created by Sudip Sharma and directed by Randeep Jha for Netflix, documents this practice, illustrating the need for new laws to resonate with the prevailing economic and social circumstances.

There is much to be learnt from tribal law and striving to include tribal communities under a single code provides that opportunity. But that will never happen if tribal law remains a closed black box. The UCC chooses not to confront this vexed issue by exempting tribal communities from its provisions, thereby sheltering behind Part XXI of the Constitution, clause (25) of Article 366 read with Article 342. A plain reading shows that there is no constitutional bar in these provisions on a state legislature, after consultations with tribal communities, proposing to the President of India, a bridging device -- an appropriate, possibly lagged, procedure to merge non-conforming aspects of tribal law with the mainstream UCC provisions. Doing so would have provided other states with proactive, tested pathways for similar mainstreaming of tribal law.

The UCC was commendably legislated in record time. But it is error prone. Section 51 dealing with intestate succession, correctly uses the gender-neutral term "surviving spouse". But the supporting Schedule 2, mistakenly, mentions "widow", making male spouses ineligible for intestate succession. Sadly, what has been gained by haste is likely to be lost to higher costs during implementation and does not match the social cost of the lost opportunity, for Uttarakhand to showcase its time-honoured culture of open-minded scholarship, an open worldview and inclusive social relationships.

## New CM, new team: Mohan Yadav signals change in MP

he winds of change are sweeping through the administrative corridors of Madhya Pradesh as new chief minister Mohan Yadav is moving quickly to assemble his core team of officers. Mr Yadav's proactive approach hints at a shift in the state's governance dynamics, and an attempt, undoubtedly in close consultation with the Centre, to leave the legacy of his predecessor Shivraj Singh Chouhan behind.

In recent weeks, we've witnessed a flurry of appointments and reallocations, with senior babus, emblematic of Mr Chouhan's tenure, gracefully stepping aside to make room for fresh faces and new perspectives.

Sandeep Yadav's appointment as commissioner of public relations and Sameer Yadav's assignment as the head of the CM's security underscore the new CM's intent to infuse vigour and competence into critical positions. Additionally, the elevation of Raghuvendra Singh to the role of principal secretary in the Chief Minister's Office reflects a strategic move to blend experience with innovation. Others in the

new team include Bharat Tadav, Avinash Lavania, Chandrashekhar Walimbe, Aditi Garg and Anshul Gupta.

The chief minister's recent meeting with director general of police Sudhir Saxena signals an imminent reshuffle of IPS officers as well, sources have told DKB. With change comes opportunity, and Mr Yadav's administration appears determined to capitalise on it.

The 'paper' wars

The white papers and the black papers on the economy have sent a lot of bureaucrats scurrying around for data. Everybody recognises that these papers are almost political weaponising of data figures. Still, at the moment, both former bureaucrats and current bureaucrats are locked in an almost death-like struggle to thread out new figures that can justify the policy measures that they had initiated during their terms in office.

Amid this struggle, there came an extremely erudite data stream from ex-Tamil Nadu finance minister and current DMK IT minister P. Thiaga Rajan, hailed by some as a financial statesman, who was able to show how the Dravidian model has outdone the Gujarat model and any national model, especially the current flavour, the Uttar Pradesh model, as far as economic growth and its benefits are concerned.

Mr Rajan argues that the UP model is more a chimera than a fact, even with the continuous net transfer of tax revenues from better-off states such as Tamil Nadu to less developed Uttar Pradesh. He showed data that at an accelerated growth rate that is two per cent higher than Tamil Nadu's every year; it would still take 64 years for Uttar Pradesh's per capita net SDP to catch up with Tamil Nadu's!

But for the babus at the Centre, the UP success story is a great narrative to run with as we head into the poll season. Why let reality interfere with a dream?

Navigating the nexus

Serving and retired IAS officers, retired IPS and IFS officers, district judges and officials working in various departments are among the 370 people who have applied for the six posts of information commissioners in Karnataka.

The government issued a notification to fill six posts of information commissioners — five in Bengaluru and one in Belagavi — in November. Among the applicants are IAS officers Mamata B.R. and Richard Vincent D'Souza, and retired IAS, IPS, IFS officers A B Ibrahim, B Balagopal, Allappa R., M.G. Hiremath, Ashit Mohan Prasad, K.T. Balakrishna, M.V. Amaranath and Rajeev Ranjan. The list also has four district judges, over 30 retired officials who served in posts ranging from directors to joint secretary and first division assistants.

With a diverse pool of candidates, the process appears to be teeming with potential. However, beneath the surface lies a contentious issue that has plagued such appointments for years — the influence of political connections over meritocracy.

An activist who has revealed lapses in several departments through RTI said successive governments have ignored the basic principles during selection. Instances where individuals with dubious records or questionable integrity have been appointed to such positions undermine the very essence of transparency and erode public trust in institutions. The ramifications of such appointments are dire. How will Karnataka decide?

# Electoral bonds scheme unconstitutional, should be cancelled: Supreme Court's big verdict ahead of Lok Sabha election

Orders SBI to stop issuing electoral bonds forthwith

NEW DELHI, Feb 15 (Agencies): Ahead the 2024 Lok Sabha election, the Supreme Court on Thursday declared unconstitutional the electoral bonds scheme that allowed individuals and companies to make unlimited anonymous donations to political parties.

"It (Electoral Bonds Scheme) is violative of Article 19(1)(a)," said a five-judge Constitution Bench led by CJI DY Chandrachud, declaring it unconstitutional.

The Beach -- which also included Justices Sanjiv Khanna, BR Gavai, JB Pardiwala and Manoj Misra -- ordered the State Bank of India to stop issuing Electoral Bonds immediately and submit all details to the Election Commission by March 6.

It ordered the Election Commission to make all donations public within a week of the receipt of the information.

All Electoral Bonds within the 15-day validity period shall be returned by political parties to the purchasers, it ordered.

It also struck down certain amendments to the Companies Act in this regard.

The only purpose of amending



section 182(3) of the Companies Act becomes otiose after we hold that the EB scheme, IT Act making non-disclosures acceptable and RP Amendment as unconstitutional, it said.

The top court said that curbing black money can't be accepted as a justified reason for lack of transparency in political funding.

Electoral bonds scheme was not the only means available to curb black money in political funding, it said.

It said the Electoral Bonds Scheme violated the voter's right to know under Article 19(1) (a) of the Constitution.

Justice Sanjiv Khanna delivered a separate but concurring

iudament.

Welcoming the verdict, petitioner Association for Democratic Reforms counsel Prashant Bhushan said, "This is a salutary judgment which will enhance our democratic process."

Introduced through the Finance Act, 2017, an Electoral Bond is a bearer instrument like a Promissory Note which can be purchased by an Indian citizen or an Indian company whose identity would remain secret from everybody except the SBI from whom it has to be purchased. Once purchased, the buyer can give it to a political party, which can encash it using its bank account.

It was introduced through the Finance Act, 2017, which made amendments to several statutes, including the RBI Act, Representation of People Act, Income Tax Act and Companies Act to facilitate the scheme which was notified on January 2, 2018.

In its PIL filed in 2017, 'Association for Democratic Reforms' (ADR) alleged corruption and subversion of democracy through illicit and foreign funding of political parties and lack of transparency in their accounts. Besides ADR, CPI(M) and Common Cause have also challenged electoral bonds scheme.

Maintaining that several constitutional issues having a tremendous bearing on the sanctity of electoral process were involved in the petitions challenging the validity of Electoral Bonds Scheme, the petitioners had earlier urged the Supreme Court to refer the matter to a Constitution Bench.

The Centre maintained that the electoral bonds scheme was an "absolutely transparent" mode of political funding and it was impossible to get any black or unaccounted money through it.

## "We Have Objection To Farmers' Method", Says Haryana Chief Minister



CHANDIGARH, Feb 15 (Agencies): Haryana Chief Minister Manohar Lal Khattar on Thursday criticised the "method" adopted by farmers to press their demands, saying they are trying to march to Delhi like an army on the offensive.

He said the farmers are moving with tractor-trolleys, earth-movers and ration for a year --just like an army.

"We have an objection to their method," Mr Khattar said on the farmers' call for going to Delhi. "We do not have any objection to them going to Delhi. There are trains, buses and

their own vehicles. But a tractor is not a mode of transport. It is an agricultural equipment." Farmers from Punjab are camping at the Shambhu and Khanauri border points seeking to march towards Delhi to press the Centre to

The farmer leaders have said they will not make any fresh attempt to move towards the national capital till the meeting is held, asserting that the next course of action will be decided on the basis of the Centre's proposals.

accept their demands.

Mr Khattar also referred to the farm-

ers' previous agitation against the nowrepealed farm laws and said how they camped at Tikri and Singhu borders for a year and causes hardships to many people.

"Even today, there are several videos of people appealing that they (farmers) should be stopped as their businesses will suffer," said Mr Khattar, responding to a question on the farmers' call for 'Dilli Chalo'.

"We have an objection to their (farmers) method," said Mr Khattar on farmers' call for going to Delhi.

Mr Khattar said everybody has democratic right to visit the national capital. "But how to proceed, what is the motive? These things must be kept in mind." To a question on Thursday's meeting between the three union ministers and farmer leaders in Chandigarh, Mr Khattar said he is hopeful that some way out will emerge.

## Allahabad High Court Reserves Order On Plea Against Worship In Gyanvapi Mosque Cellar

PRAYAGRAJ, Feb 15 (Agencies): The Allahabad High Court on Thursday reserved its order on a plea challenging the Varanasi district court's decision to allow Hindu prayers in a cellar of the Gyanvapi mosque.

Justice Rohit Ranjan Agrawal heard the appeal filed by the Anjuman Intezamia Masjid committee, which looks after the affairs of the mosque adjacent to the Kashi Vishwanath temple in Varanasi, and reserved its order, committee's lawyer S F A Naqvi said.

"The hearing of the matter is complete and the court has reserved



its order," Naqvi added.
The Anjuman Intezamia Masjid committee moved the high court on February 2 within hours of the Supreme Court refusing to hear its plea against the Varanasi district court order and

asking it to approach the high court.

The Varanasi district court had ruled on January 31 that a priest can perform prayers before the idols in the southern cellar of the Gyanvapi mosque.

## Hope you will be with my family: Sonia Gandhi's emotional message to Rae Bareli voters

NEW DELHI, Feb 15 (Agencies): Former Congress president Sonia Gandhi on Thursday informed voters of her Rae Bareli constituency in Uttar Pradesh that she will not contest the upcoming Lok Sabha polls due to health and age issues.

In an emotional message to the constituents of the segment she has represented since 2004, the 77-year-old also threw subtle hints of a possible entry of a member of her family from the Rae Bareli segment.

"I am proud to say that whatever I am today, I am because of you and I have always done my best to honour your trust. Now on account of health and age issues, I will not contest the next



Lok Sabha election," she said in the message.

"After this decision, I will not have the opportunity to serve you directly but my heart and soul will always remain with you. I know that you will stand by me and my family in future, just as you have in the past," she said in the message written in Hindi.

The message to the voters comes a day after the former Con-

gress president filed her nomination for the Rajya Sabha seat from Rajasthan.

Speculation is rife that Sonia Gandhi's daughter Priyanka Gandhi Vadra could contest from the Rae Bareli Lok Sabha constituency this time

This is the first time that Sonia Gandhi would be entering the Rajya Sabha.

She will also be the

second member of the Gandhi family to do so, after Indira Gandhi who was a member of the upper house from 1964 to 1967.

In the message to voters, Sonia Gandhi further said, "My family in Delhi is incomplete without you. It completes when I come to Rae Bareli and meet all of you. My ties with you are very old. I have inherited these ties as a good fortune from my in-laws."

Noting that ties of her family with Rae Bareli are "very deep rooted", she said Rae Bareli sent her father-in-law Feroze Gandhi to Lok Sabha in the first general election held after Independence.

After that, you accepted my mother-in-law

Indira Gandhi, she noted.

"Ever since, our relationship grew stronger on the difficult road to affection despite the highs and lows of life and our faith in this bond grew stronger.

"You allowed me space to walk along on this shining path. I came to you after losing my mother-in-law and husband and you accepted me with open arms," the former Congress chief said.

"I can never forget your staunch support for me through the adverse circumstances through the last two Lok Sabha elections." Gandhi recalled.

Sending her respect to elders and love to youngsters, she said, "I will see you soon".

#### 'Trinamool leader BJP's target': Mamata Banerjee blames RSS for Sandeshkhali unrest

SANDESHKHALI, Feb 15 (Agencies): West Bengal Chief Minister Mamata Banerjee on Thursday blamed the RSS for Sandeshkhali unrest, alleging the BJP's target was a Trinamool leader. She also said her government will take strict action against those found accused in the case.

"We are looking into the Sandeshkhali situation, no one involved in any wrongdoing will be spared, the BJPs' target was a leader of the Trinamool Congress (Shajahan Sheikh)," Mamata Banerjee told the state Assembly.

"I have never allowed, will never allow any injustice to anyone," she said.

"We have sent the state women's commission, and have formed a police team for Sandeshkhali," the Chief Minister said, adding, "17 people have been arrested."

The West Bengal Chief Minister further said, "Our women's team is present there. A police team is visiting people at their doorsteps to listen to their grievances. We will definitely address the issues that will be reported. I need to know the matter to act on it. RSS has a base there. Riots took place there 7-8 years back. It is one of the vulnerable riot spots. We handled the situation strongly during Saraswati Puja or else there were other plans."

Mamata Banerjee's statement came

hours after the BJP MLAs staged a walkout from the assembly demanding a statement from the Chief Minister on Sandeshkhali, which witnessed protests over alleged atrocities on locals by ruling Trinamool leaders.

At the time, Banerjee was not present in the House.

Meanwhile, BJP leader Suvendhu Adhikari said that Banerjee's remarks proved that the RSS is on the right track. Adhikari also called for the National Investigation Agency (NIA) to probe reports of sexual exploitation in Sandeshkhali.

On Monday, six BJP MLAs, including Leader of the Opposition Suvendu Adhikari, were suspended from the House over protests regarding the Sandeshkhali issue.

Protests persisted in Sandeshkhali for the seventh consecutive day on Wednesday, with a significant number of women taking to the streets, demanding the arrest of Shajahan Sheikh and his followers.

The accusations against Shajahan and his aides include forcefully capturing land and sexually harassing women.

Sheikh has been absconding since January 5 when a mob attacked Enforcement Directorate (ED) officers during a raid on his residence in connection with an alleged ration scam.

#### Andhra woman found murdered, husband claims ex-lover hired goons to kill her

HYDERABAD, Feb 15 (Agencies): A 35-year-old woman named was found brutally murdered inside her home in Andhra Pradesh's Tenali on Wednesday night. Her husband has accused her ex-lover of being involved in the crime.

The victim, Ramisetti Alekya, lived with her husband, Bharat, who alleged that she was killed by goons sent by Annam Srinivas. Alekya had been in an extramarital relationship with Srinivas for seven

years, claimed Bharat.
The illicit relationship had led to legal disputes between the couple, culminating in a court case whose specifics are not known at present.

Alekya's body was discovered on Wednesday night in the downstairs room of her building, lying naked.

According to preliminary investigation, she was strangled.

Two Town police have cordoned off the scene and are conducting an investigation into the murder.



#### 'Electoral bonds medium for bribe': Rahul Gandhi's swipe at PM after court order



(Agencies): Hours after the Supreme Court order struck down the electoral bonds scheme, Rahul Gandhi on Thursday hit out at Prime Minister Narendra Modi, alleging, the scheme was a 'medium for bribes and commission'.

In an X post, the Congress leader said, "Another proof of Narendra Modi's corrupt policies is in front of you.

BJP had made electoral bonds a medium for taking bribes and commissions."

"Today this matter has been approved," a rough translation of Rahul Gandhi's post in Hindi suggested.

In a landmark judgment that delivered a big blow to the government, the Supreme Court on Thursday annulled the electoral bonds scheme, saying it violates the Constitutional right to freedom of speech and expression as well as the right to information.

The court ordered the State Bank of India (SBI) to disclose to the Election Commission the names of the contributors to the six-year-old scheme.

A five-judge Constitution bench headed by Chief Justice DY Chandrachud directed that the State Bank of India must disclose details of each electoral bond encashed by political parties.

The information should include the date of encashment and the denomination of the bonds and be submitted to the poll panel by March 6.

The Election Commission should publish the information shared by SBI on its official website by March 13, the bench said.

# Israeli airstrikes kill 10 Lebanese civilians in a single day, Hezbollah vows to retaliate

The fatalities marked a significant escalation in more than four months of daily cross-border exchanges triggered by the Oct. 7 outbreak of the Israel-Hamas war in Gaza

BEIRUT, Feb 15 (Agencies): The civilian death toll from two Israeli airstrikes in Lebanon has risen to 10, Lebanese state media reported Thursday, making the previous day the deadliest one in more than four months of cross-border exchanges.

The Lebanese militant group Hezbollah has vowed to retaliate for the strikes, which hit in the city of Nabatiyeh and a village in southern Lebanon, just hours after projectiles from Lebanon killed an Israeli soldier.

In Nabatiyeh, the strike knocked down part of a building, killing seven members of the same family, including a child, the state-run National



News Agency said. A boy initially reported missing was found alive under the rubble. Initial reports had said four people were killed.

In the village of Souaneh, a woman and her two young children were killed. The Lebanese civilian death toll included six women and three children.

Three Hezbollah fighters were also killed on Wednesday.

The fire from Lebanon earlier Wednesday struck the northern Israeli town of Safed, killing a female Israeli soldier and wounding eight people.

The fatalities marked a significant escalation in more than four months of daily cross-border exchanges triggered by the Oct. 7 outbreak of the Israel-Hamas war in Gaza. The war began with the surprise attack in southern Israel by the Palestinian militant group Hamas, an ally of Hezbollah.

Government institutions, schools and the Lebanese University were to close on Thursday in protest of the airstrikes.

#### US allies warn Israel against 'catastrophic' Rafah operation



SYDNEY, Feb 15 (Agencies): The leaders of Australia, Canada and New Zealand on Thursday warned Israel against a potentially "catastrophic" ground offensive in the southern Gazan city of Rafah, amplifying a growing chorus of international concern.

Urging Prime Minister Benjamin Netanyahu "not to go down this path", the trio of Commonwealth nations issued a rare joint statement expressing deep and growing worry about Israel's prosecution of the monthsong wa

"About 1.5 million Palestinians are taking refuge in the area, including many of our citizens and their families," the group of US allies said.

"An expanded military operation would be devastating. We urge the Israeli government not to go down this path. There is simply nowhere else for civilians to go."

In the face of mounting international pressure and a death toll that Gaza authorities say has now topped 28,000, Netanyahu has vowed to press ahead.

He has promised Israeli forces will soon conduct a "powerful" operation in Rafah -- a city filled with countless Gazans displaced by fighting elsewhere in the territory.

Israel believes that Hamas operatives responsible for the October 7 attacks that killed around 1,160 people in Israel are holed up in the area, along with some of an estimated 130 hostages seized by the Palestinian Islamist group.

#### **Bangkok Urges Work From Home As City Chokes Under Pollution**

Public health crisis is brewing over the problem, with at least two million people in Thailand needing medical treatment because of pollution in 2023.

BANGKOK, Feb 15 (Agencies): Bangkok city employees have been told to work from home to avoid harmful air pollution, as a layer of noxious haze blanketed the Thai capital on Thursday.

City authorities asked for cooperation from employers to help workers in the city of some 11 million people avoid the pollution, which is expected to last into Friday.

The air monitoring website IQAir ranked Bangkok among the 10 most polluted cities in the world on Thursday morning.

Levels of the most dangerous PM2.5 particles so tiny they can enter the bloodstream -- were more than 15 times the World Health Organization's annual guideline, according to IQAir.

Bangkok governor Chadchart Sittipunt said late Wednesday that all city employees would work from home

on Thursday and Friday.
"I would like to ask for cooperation from the BMA network of about



151 companies and organisations, both government offices and the private sector," he said in a statement, adding that more than 60,000 people were affected.

BMA is an abbreviation for the Bangkok Metropolitan Administration.

Chadchart said at least 20 of Bangkok's 50 districts were expected to have unhealthy levels of PM2.5 particles, and the problem would linger because of calm weather.

Air quality in Thailand regularly plummets in the early months of the year as smoke from farmers burning stubble in the fields adds to industrial emissions and vehicle exhaust fumes.

#### Police Seek Clues In Mass Shooting At US Super Bowl Rally, 3 Detained

KANSAS CITY, Feb 15 (Agencies): Three people were in custody in Kansas City, Missouri, on Thursday, facing questions about what led to a deadly mass shooting near the city's Super Bowl victory rally and who was behind it.

At least one person was killed and 21 others wounded by gunfire on Wednesday outside the city's landmark Union Station, where thousands of fans had gathered with the Kansas City Chiefs to celebrate the team's NFL championship triumph over the San Francisco 49ers, authorities said.

The bloodshed, which came at the end of the rally following a parade, turned the festive occasion into a scene of panic as throngs of attendees scrambled for cover at the sound of rapidfire gunshots.

Local radio station KKFI identified the dead victim as Lisa Lopez, one of its disc jockeys and host of the show "Taste of Tejano." Fifteen other victims suffered life-threatening wounds, Fire Department Chief Ross Grundyson said at a lateafternoon news conference.

Eleven of those hurt by gunfire or the ensuing pandemonium were children as young as 6, officials said.

None of the football team, their coaches or other staff attending the rally was injured, the team said.

Police Chief Stacey Graves told on Wednesday evening news conference three people



were detained "and under investigation" in connection with the shooting, but she said investigators had yet to determine a motive.

She said police were still unsure whether the Super Bowl victory celebration was targeted for attack, or whether the violence was incidental to the event and spilled over into it.

Authorities appealed to anyone who had information about the shooting or video that might help shed light on what transpired to share it with police.

Graves said she was aware of video purporting to show fans subduing a suspect, and that investigators were reviewing the footage to determine if the individual was one of the people taken into police custody.

Parade attendee Paul Contreras, told local television station KETV he was one of the fans who helped tackle the man, and saw him drop a gun when he was knocked down.

"The whole time he's fighting to get up and run away," Paul said, adding police arrived within moments. "We're fighting each other, you know. We're fighting to keep him down and he's fighting to get up."

Kansas City Mayor Quinton Lucas lamented that city authorities ultimately were unable to prevent such violence despite the presence of more than 800 law enforcement officers, including federal agents, on security detail for the event.

"Parades, rallies, schools, movies - it seems like almost nothing is safe," Quinton, a Democrat, told reporters, recounting how he was among those who ran for cover at the sound of gunfire.

The barrage of gunshots happened near a garage west of the station, whose front entrance was the backdrop to the stage for the victory rally, according to police and local media.

Union Station, a 109-year-old

Beaux Arts building that once served as a major U.S. rail hub for passenger and freight traffic, is home to a museum and visiting attractions today, and is a terminal for Amtrak passenger service.

The Super Bowl celebration featured Chiefs tight end Travis Kelce on stage with quarterback Patrick Mahomes and other teammates, but Kelce's pop superstar girlfriend, Taylor Swift, was back on tour in Australia at the time.

The governors of Missouri and Kansas were among the dignitaries present at the event but they, too, were unhurt.

The shooting came three days after the Chiefs defeated the 49ers in overtime to win the Super Bowl, 25-22, marking their fourth National Football League championship.

On June 17, 1933, Union Station was the site of an outdoor shootout and murder of four law enforcement officers and a criminal fugitive in a notorious incident known as the Kansas City Massacre.

Wednesday's violence took place on the sixth anniversary of one of the most notorious mass shootings in recent U.S. history, when 17 people were killed and 17 more were injured at Marjory Stoneman Douglas High School in Parkland, Florida. The shooter in that incident, a former student who was 19 at the time, pleaded guilty and was sentenced to life in prison.

## US Private Moon Lander Launched Half Century After Last Apollo Mission

FLORIDA, Feb 15 (Agencies): A moon lander built by Houston-based aerospace company Intuitive Machines was launched from Florida early on Thursday on a mission to conduct the first U.S. lunar touchdown in more than a half century and the first by a privately owned spacecraft.

The company's Nova-C lander, dubbed Odysseus, lifted off shortly after 1 a.m. EST (0600 GMT) atop a Falcon 9 rocket flown by Elon Musk' SpaceX from NASA's Kennedy Space Center in Cape Canaveral.

A live NASA-SpaceX online video feed showed the two-stage, 25-story rocket roaring off the launch pad and streaking into the dark sky over Florida's Atlantic coast, trailed by a fiery yellowish plume of exhaust.

The launch, previously set for Wednesday morning, was postponed for 24 hours because of irregular temperatures detected in liquid methane used in the lander's propulsion system. SpaceX said the issue was later resolved. Although considered an Intuitive Machines mission, the IM-1 flight is carrying six NASA payloads of instruments designed to gather data about the lunar environment ahead of NASA's planned return of astronauts to the moon later this decade.

Thursday's launch came a month after the lunar lander of another private firm, Astrobotic Technology, suffered a propulsion system leak on its way to the moon shortly after being placed in orbit on Jan. 8 by a United Launch Alliance (ULA) Vulcan rocket making its debut flight.

The failure of Astrobotic's Peregrine lander,



which was also flying NASA payloads to the moon, marked the third time a private company had been unable to achieve a "soft landing" on the lunar surface, following ill-fated efforts by companies from Israel and Japan.

Those mishaps illustrated the risks NASA faces in leaning more heavily on the commercial sector than it had in the past to realize its spaceflight goals.

Plans call for Intuitive Machines' Nova-C vehicle, a hexagonal cylinder with four legs, to reach its destination after about a weeklong flight on Feb. 22 for a landing at crater Malapert A near the moon's south pole. If successful, the flight would represent the

first controlled descent to the lunar surface by a U.S. spacecraft since the final Apollo crewed moon mission in 1972, and the first by a private company. The feat also would mark the first journey

to the lunar surface under NASA's Artemis moon program, as the U.S. races to return astronauts to Earth's natural satellite before China lands its own crewed spacecraft there.

China lands its own crewed spacecraft there. IM-1 is the latest test of NASA's strategy of paying for the use of spacecraft built and

owned by private companies to slash the cost of the Artemis missions, envisioned as precursors to human exploration of Mars.

By contrast, during the Apollo era, NASA bought rockets and other technology from the private sector, but owned and operated them itself.

NASA announced last month that it was delaying its target date for a first crewed Artemis moon landing from 2025 to late 2026, while China has said it was aiming for 2030.

Small landers such as Nova-C are expected to get there first, carrying instruments to closely survey the lunar landscape, its resources and potential hazards. Odysseus will focus on space weather interactions with the moon's surface, radio astronomy, precision landing technologies and navigation.

Intuitive Machine's IM-2 mission is scheduled to land at the lunar south pole in 2024, followed by an IM-3 mission later in the year with several small rovers.

Last month, Japan became the fifth country to place a lander on the moon, with its space agency JAXA achieving an unusually precise "pinpoint" touchdown of its SLIM probe last month. Last year, India became the fourth nation to land on the moon, after Russia failed in an attempt the same month.

The United States, the former Soviet Union and China are the only other countries that have carried out successful soft lunar touchdowns. China scored a world first in 2019 by achieving the first landing on the far side of the moon.

#### 'Malicious fabrication': Russia dismisses US warning on nuclear weapons in space



MOSCOW, Feb 15 (Agencies): Russian Deputy Foreign Minister Sergei Ryabkov has called reports about the deployment of Russian nuclear weapons in space a "malicious fabrication" of the United States, Russian stateowned news agency TASS reported on Thursday.

The development comes after the United States told Congress and allies in Europe about new intelligence related to Russian nuclear capabilities that

could pose an international threat.

The new capabilities, related to Russian attempts to develop a space-

based weapon, do not pose an urgent threat to the United States, a source told news agency.

Dmitry Peskov, a spokesperson for the Kremlin said he would not comment on the substance of the reports until the details were unveiled by the White House.

He also said Washington's warning was clearly an attempt to get Congress to approve more money.

"It is obvious that the White House is trying, by hook or by crook, to encourage Congress to vote on a bill to allocate money, this is obvious," Kremlin spokesman Dmitry Peskov was quoted as saying by TASS.

"We'll see what tricks the White House will use," Peskov said.

Russia's invasion of Ukraine - something Moscow calls a special military operation - has triggered the biggest confrontation between the West and Russia since the 1962 Cuban Missile Crisis. Both Moscow and Washington have warned of the risk of a conflict between NATO and Russia.

Russia and the United States, by far the biggest nuclear powers, have both expressed regret about the steady disintegration of arms-control treaties which sought to slow the Cold War arms race and reduce the risk of nuclear war.

#### **Farmers' Protest March** | Delhi Police orders 30.000 tear gas shells

Gwalior, an official said.

The freshly ordered shells are being brought to Delhi from Gwalior, he said.

A tear gas shell is an anti-riot equipment which is used by security forces to disperse crowd. The gas brings tears by creating irritation in the eyes.

A stock of tear gas shell was also ordered before the G20 Summit held in September 2023, the officer said, adding, a fresh order has been given in the wake of farmers' agitation.

Another officer said the age of each tear gas shell is three years after which their impact slowly weakens, but they are used upto seven years for practice purposes by

Under the Delhi Police norms, once a stock gets acquired, the shells are distributed to the district police and other units of the force

Another officer said that in view of the farmers' protest, the fresh stock may be distributed to the outer, outer-north and east district police — under whose jurisdiction the potential protest sites in the national capital fall.

The Delhi Police has made all logistical arrangements to stop the farmers at the Singhu (Sonipat side), Tikri (Bahadurgarh side) and Ghazipur (Ghaziabad side) bor-

Tikri comes under outer, Singhu under outer-north and Ghazipur in east district.

The security personnel deployed at these borders are already equipped with a large number of tear gas shells, water cannons and other anti-riot equipment.

The personnel deployed at the borders have been strictly asked to ensure not a single farmer or their tractor-trolley enters into the jurisdiction of the national capital.

The Delhi Police has issued prohibitory orders under section 144 of the Code of Criminal Procedure (CrPC) for a month banning an assembly of five or more people, processions or rallies and the entry of tractor-trolleys ferrying people.

On the farmers who have gathered near the Shambhu border between Punjab and Haryana near Ambala, the Haryana police has also used tear gas shells, some of which they air-dropped through drones on protesting farmers.

The farmers seek to march to the national capital to press the Centre to agree to their various demands including a legal guarantee on Minimum Support Price of crops, implementation of the Swaminathan Committee report, loan waiver among others.

Duing their protest in 2020, farmers from different states, mainly Punjab, Haryana and Uttar Pradesh, had staged a sit-in at the Singhu, Ghazipur and Tikri borders. They sat there from August 2020 to December 2021

Police had to rush logistics in 2020 to check the entry of the farmers moving in a procession of tractors.

Lashing out at the Government for using force against the protesting farmers to stop them from moving to Delhi, Tarigami said, "The attitude of the Government is unfortunate and authoritarian.

"Instead of holding purposeful and meaningful dialogue with the representatives of farmers, they are resorting to creating division among the peasants, workers and trade unions, and using authoritarian measures and police force to dislodge them," he said, adding "enough is enough as claims are not sufficient for addressing issues being faced by people".

Tarigami said more concrete measures need to be taken and this is what trade unions and the SKM have been demanding for long

He accused the central government of not keeping its promises and alleged there is a credibility gap as it is saying one thing and doing what it wants without taking people into confidence.

"We have only seen oppression, injustice and falsehood and nothing else. Those running the government should provide relief to the people and address their pain but what we are seeing is that they are only working for the corporate capitalists,' he alleged.

He said renowned scientist M S Swaminathan, who was recently bestowed with country's highest civilian honour - the Bharat Ratna — had recommended an MSP but the Government is hesitant to implement his recommendations.

Farmers were assured of withdrawal of all cases registered against them during their prolonged protest last year but more cases were filed against them, Tarigami said.


## **Association for Welfare of Senior Citizens meets Chief Secretary, submits memorandum**

They requested the formula-



tion and phased implementation of a comprehensive plan to address the provisions outlined in Section 19 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007.

They sought CS assistance in expediting necessary actions by concerned authorities to implement provisions such as separate queues for senior citizens, expanded facilities

for chronic diseases, and earmarked facilities for geriatric patients in every District hospital.

They urged the concerned authorities to take appropriate measures for widespread publicity and awareness of the welfare measures provided in the Act for the benefit of senior

We note a lack of visible

action on the ground regarding the responsibilities outlined for Deputy Commissioners in Rule 20 of the Jammu and Kashmir Maintenance and Welfare of Parents and Senior Citizens Rules 2021.

They proposed the establishment of a "Welfare Fund" to meet obligations arising from the provisions of the Act and Rules.

They requested the early establishment of a 'UT Council of Senior Citizens' to advise the UT Administration on the effective implementation of the Act.

Despite a government order allocating land at village Dhami (Nagrota), they have not received possession. They also requested a small piece of land within Jammu city for constructing an Association Office cum Recreation/Day Care Centre.

They also demanded Implementation of CGHS Facilities for Pensioners.

They said CS kind intervention in addressing these concerns will significantly contribute to the well-being and rights of senior citizens in our region.

NEW DELHI, Feb 15 (Agencies): The initial public offering (IPO) of **Esconet Technologies** Limited, a provider of high-end supercomputing solutions, and data center facilities that include storage servers, network security, virtualization, and data protection will open for public subscription on Friday (February 16). The anchor portion will be opened on Thursday (February 15), and the issue will conclude on Tuesday (February 20).

Discussing company's growth strategy and outlook; key orders and announcements; capex plan for coming 2-3 years; and upcoming IPO and utilization of the capital intended to be raised, Santosh Agrawal, Managing Director, told this journalist (Shri Ram Shaw), "IPO comprises a fresh issue of 33,60,000 Equity Shares with a face value of Rs. 10 each through the bookbuilding route. The company plans to raise Rs. 28.22 crore from the IPO and intends to utilize Rs. 16 crore to fund its long-term working capital requirements and Rs. 2.5 crore to invest in its whollyowned subsidiary Zea-Cloud Services Private Limited to fortify data backup capabilities."

"The company intends to raise approximately Rs. 28.22 crore (at upper band) from the offering and aims to be listed with NSE Emerge. The price band for the issue has been fixed at Rs. 80 - Rs. 84 per

share, and the lot size will be 1,600 equity shares. Corporate Capital Ventures has been appointed as the Book Running Lead Manager, and Skyline Financial Services Private Limited is the Registrar to the issue," he added.

Santosh Agrawal further said, "As many as 9.53 lakh equity shares have been reserved for anchor portion, 1.76 lakh equity shares for Market Maker, 4.78 lakh equity shares allocated for HNIs, 6.36 lakh equity shares for QIBs, and Retail (RII) portion accounts for 11.15 lakh equity shares.'

According to the RHP document, Esconet proposes to utilize Rs. 16 crore of the IPO proceeds towards funding its long-term working capital requirements, besides investing Rs. 2.5 crore in its whollyowned subsidiary, Zea-Cloud Services Private Limited, to reinforce its infrastructure by acquiring additional hardware and software, with a goal of bolstering capacity, elevating security measures, and enhancing overall monitoring capabilities.

#### **Bhan urges Home Minister to** address complexities of Kashmir

JAMMU, Feb 15: In an appeal to Home Minister Amit Shah, Ashok Bhan, Senior Advocate, Supreme Court of India andv Chairman, Kashmir (Policy and Strategy) Group said the intricacies of the Jammu and Kashmir issue have long been veiled by a dense fog of distorted historical narratives, selfserving myths, and conflicting political interests.

Yet, amidst this complexity, the current government has demonstrated a sincere commitment to fostering an environment conducive to peace and progress, aiming to break the cycle of violence perpetuated by adversaries,

Analysts specializing in Kashmir affairs have lauded the government's policy of zero tolerance towards terrorism, coupled with initiatives for economic empowerment and extensive development efforts. As we approach the assembly elections, the prospect of restoring legitimate democracy in Kashmir holds promise not only for the region but for the entire nation. Such a move aligns with the constitutional ethos of our country and could serve as a precursor to the envisioned concept of one nation-one election Bhan said.

He added in the historical and social context of the Kashmir Valley, the scars of past conflicts weigh heavily upon its people. The fallout from the 1947 turmoil and the prolonged insurgency has resulted in the displacement of indigenous religious minorities and the senseless loss of innocent lives at the hands of non-state actors and militant groups, he said.

"The people are victims of the 1947 conflict and the lingering aftermath of the armed insurgency that led to (a) the displacement of the entire indigenous religious minority and (b) the killing of innocent civilians by non-state actors, brutalised anti-people groups and other actors," he said.

Recognizing the urgency of addressing this plight, the Kashmir Policy and Strategy Group has tirelessly advocated for dialogue and societal healing, emphasizing the imperative of fostering peace, justice, and inclusivity in the region, he added.

The systematic ethnic cleansing perpetrated against them represents a dark chapter in Kashmir's history, recognized internationally as an act of genocide.

The National Human Rights Commission's condemnation of this tragedy underscores the gravity of the situation. Yet, for

three decades, the exiled Kashmiri Pandits have languished as refugees in their own country, longing to return to their ancestral homeland. The time has come for the government to demonstrate the political will and resolve necessary to facilitate their repatriation, thereby restoring the fabric of Kashmiri society and securing the region's stability

Addressing the generational trauma inflicted by decades of conflict is paramount to fostering reconciliation and social cohesion in Kashmir. The Supreme Court's recent pronouncements on Article 370 emphasize the need to look towards the future. rather than dwelling on the past. A commission tasked with investigating human rights violations in the region since the 1980s offers a crucial step towards acknowledging and redressing the grievances of all affected par-

As we navigate the complexities of Kashmir, it is imperative that we heed the Supreme Court's guidance and prioritize the restoration of communal harmony and respect for constitutional principles.

The Kashmir Policy and Strategy Group stands ready to support initiatives aimed at addressing the root causes of conflict and promoting a shared vision of peace and prosperity for all Kashmiris. Bhan said.

In conclusion, he urged Home Minister Amit Shah, to seize this moment as an opportunity to chart a path towards lasting peace and reconciliation in Kashmir. ## **ED quizzes Paytm executives** in preliminary probe into alleged FEMA irregularities



NEW DELHI. Feb 15 (Agencies): The **Enforcement Director**ate has questioned Paytm executives and sought more information regarding submitted documents as part of a preliminary probe into alleged FEMA (Foreign Exchange Management Act) irregularities flagged by the Reserve Bank of India.

The ED questioned the senior officials after they submitted certain documents in connection with the inquiry. The central agency will decide if a formal probe is needs based on the findings in the ongoing inquiry.

RBI had stopped Paytm's banking arm Paytm Payments Bank Ltd (PPBL) from accepting deposits or top-ups in customer accounts.

According to official sources, the ED has found no irregularities under FEMA so far. Meanwhile they are already carrying out an investigation under Prevention of Money Laundering Act (PMLA) involving the company, PTI quoted official sources as saying.

As for KYC non-compliance issues raised by the RBI, the ED cannot take any action as it comes under the purview of the central bank.

Paytm said PPBL does not undertake outward foreign remittances. "One 97 Communi-

cations Limited (OCL), its subsidiaries and its associate, Paytm Payments Bank Limited, have over time been receiving notices and requisition for information, documents and explanations from the authorities, including **Enforcement Director**ate (ED), with respect to the customers that may have done business with the respective entities, and provided the required information, documents and explanations to the authorities," Paytm said in a regulatory filing.

Paytm shares slumped 5 per cent and struck a new 52-week low on Thursday, hitting lower circuit at 325.05 around 11.30am. This comes after bourses revised the circuit from 10 per cent to 5 per cent on February 15.

RAJKOT, Feb 15 (Agencies): Rahul Dravid will continue to remain in the position of India's head coach till the upcoming T20 World Cup 2024 in June this year, confirmed BCCI secretary Jay Shah.

Dravid's contract ended after the ODI World Cup final last year, but he was asked to continue in his role along with other support staff for the December-January tour to South Africa without finalising the tenure.

But Shah said he held an initial talk with Dravid here before arriving at the decision to retain



the former captain's services till the ICC showpiece to be held in the West Indies and the US.

"After the (2023) World Cup, Rahul bhai had to leave for the South Africa tour immediately. We did not get to meet in between which finally happened today," Shah said here on the sidelines of the renaming function of the Saurashtra Cricket Association Stadium on Wednesday

"Why are you worried about a contract for such a senior person like Rahul Dravid? Rahul bhai will remain the coach in the T20 World Cup," Shah asserted.

However, Shah indicated that they will hold a few more rounds of discussions ahead of the marquee event.

"I will speak with him whenever there is time, there are back-to-back series happening right now. They were in South Africa, then there was a (T20I) series against Afghanistan (at home) and now England. We did not get to speak in between at all," he added.

Shah said the IPL franchises will have to comply with workload management guidelines set by the BCCI for the centrally contracted players.

"This is the BCCI's mandate. The BCCI is the supreme body and whatever it decides the franchises will have to follow — we are above the franchises," he said.

## Rohit to captain India in T20 World Cup



RAJKOT, Feb 15 (Agencies): India will be playing the T20 World Cup 2024, to be organised in the Caribbean and the USA, under the captaincy of Rohit Sharma, said BCCI secretary Jay Shah at the renaming ceremony of the Saurashtra Cricket Association Stadium after veteran cricket administrator Niranjan Shah here.

"I want to promise you that in 2024 (T20 World Cup) in Barbados (venue for the final), under Rohit Sharma's captaincy, we will hoist the Indian flag," Shah said in his speech.

# NZ vs SA, 2nd Test: David Bedingham's hundred sparks hopes of South Africa win despite batting collapse on Day 3

HAMILTON, Feb 15 (Agencies): Middle-order batter David Bedingham, who showed a lot of promise against India earlier in the year, hit his maiden Test hundred as he helped South Africa dream of a victory in the second Test against New Zealand in Hamilton. Bedingham's gritty hundred helped South Africa set New Zealand a tricky target of 267 at Seddon Park in Hamilton.

New Zealand openers Devon Conway and Tom Latham had a nervy hour to negate, but first-innings hero Dane Piedt gave South Africa a huge breakthrough, removing the Chennai Super Kings star with the last delivery of the day's play. New Zealand went to Stumps to 40 for 1, still needing 227 runs to win in an enthralling Test.

New Zealand have never beaten South Africa in a Test series and the BlackCaps were touted as favourites after they thrashed a hugely-weakened South African side in the first Test by 281 runs. However,



the Proteas have shown a lot of heart and grit in the 2nd Test to give themselves a chance of scripting a victory and draw the series.

David Bedingham embodied that fighting spirit of the South Africans as he hit 110 runs from 141 balls, hitting 12 boundaries and and two sixes during his 98-run partnership with Keegan Petersen.

The partnership between Bedingham and Petersen was the only positive in an otherwise sorry-looking South Africa batting card. The tourists, who sealed a 24-run first innings lead, failed to bat New Zealand out of the contest as the young side had too many men who failed to convert their starts.

WILL O'ROURKE SHINES FOR BLACKCAPS

Debutant paceman Will O'Rourke, the only New Zealander with less experience than most of the South Africans, took five for 34 as the last six Proteas wickets fell for 33 runs but the day belonged to Bedingham.

All-rounder Rachin Ravindra ensured that Clyde Fortuin's miserable series with the bat continued, while O'Rourke got the rewards for some fine bowling with the wickets of Raynard van Tonder and skipper Neil Brand (34).

Veteran South African-born seamer Neil Wagner finally got his chance with the ball after the break and made an immediate impact with a trademark short ball which Zubayr Hamza (17) only succeeded in pulling to Will Young at deep square leg.

Phillips then took over, removing Ruan de Swardt and Piedt cheaply with his right-arm spin and taking another fine catch at gully to finally send Bedingham back and give O'Rourke his fourth victim.

O'Rourke completed the skittling of the tail when he had Dane Paterson caught behind to secure his maiden test fivewicket haul and take his match tally to 9-93.

#### 'Wrestlers under threat again': Sakshee, Bajrang write open letter to UWW over revoking WFI suspension

NEW DELHI, Feb 15 (Agencies): Olympics medallists Bajrang Punia and Sakshee Malikkh wrote an open letter to the world wrestling body (United World Wrestling) on Thursday, two days after it revoked the suspension of the Wrestling Federation of India (WFI). The two wrestlers said the UWW lifting the suspension has put the wrestlers under threat again, saying that they will be subject to harassment from the elected members of the WFI.

The lifting of the WFI ban meant that Indian wrestlers would now be able to compete under the country's flag in international events. Notably, the UWW suspended WFI in August last year over a delay in holding general body elections.

Bajrang and Sakshee urged the world body to take necessary actions against the WFI, accusing Sanjay Singh, the newly-elected president of the WFI, of acting against the Sports Ministry's directives. Bajrang and Sakshee said that Singh-led WFI hadn't paid heed to the directives of the ad-hoc committee which was appointed to oversee the operations of WFI after



Notably, days after Sanjay Singh was elected as the WFI president, the Sports Ministry suspended the newly-elected WFI general body, highlighting Singh's close ties with former president Brij Bhushan Sharan Singh, who was accused of sexually harassing female wrestlers.

However, Sanjay Singh-led elected body has, time and again, rejected the Sports Ministry's decision.

"This decision has again put Indian wrestlers under threat and harassment by WFI members. This is to bring to your notice that this WFI was suspended by the Ministry of Youth and Sports (MYAS) dated 27

December 2023 due to serious anomalies after a couple of days of taking charge," Bajrang and Vinesh wrote in their open letter.

"MYAS also formed an Ad Hoc Committee to oversee and conduct wrestling activities. Even after this suspension, WFI members took blatant decisions to conduct sporting activities without any recognition from sports ministries under the same leadership. Wrestlers all over India have lost trust and belief in the functioning of Wrestling Federation of India. Because of this MYAS took diligent steps and issued a cir-

Committee. This elected body is still being run by same individual and their allies who serious charges against them and MYAS also took the same in consideration while suspending the body. For your reference we have attached the mentioned letters.

"We wrestlers request you kindly support Indian athletes against unfair practices and harassment through various means. Indian wrestlers are looking up to you for justice and their rights to fair and safe play.

"We are hopeful that you will consider our request to support clean and fair sports activities in India and take necessary actions against the WFI," it added.

WHY WAS WFI SUS-PENSION LIFTED? The United World Wrestling, in its statement on Tuesday, lifted the suspension of WFI, noting that the elections took place in December. However, it sought written guarantees from the WFI that it wouldn't discriminate against certain wrestlers while picking players for international tournaments.

"The WFI has to immediately provide UWW with written guarantees that all wrestlers will be considered for participation without any discrimination in all WFI events, in particular trials for the Olympic Games and any other major national and international events. This non-discrimination includes the three athletes who protested against alleged wrongdoings by the former President," UWW had

said in its statement.

The WFI has been locked in a turf war with the ad-hoc committee.

The two bodies held separate national championships recently, confusing within the wrestling community.

Notably, Sakshee Malikkh alleged that fake certificates were being handed out to wrestlers at the national championships held by the suspended WFI body.

## Klinsmann fate as coach in balance as South Korean FA meets

SEOUL, Feb 15 (Agencies): Jurgen Klinsmann's fate as coach topped the agenda as South Korean football bosses met Thursday, a day after revelations about an Asian Cup bust-up between players that left Son Heungmin with an injured finger.

The closed-door Korea Football Association meeting, which had been scheduled to take place no matter how the team fared at the Asian Cup, has taken on extra significance.

significance.
Yonhap news agency reported, citing unnamed sources, that the KFA would consider a temporary appointment for next month's World Cup qualifiers against Thailand if Klinsmann were to be sacked.

The KFA was due to hold a press conference later Thursday and a smattering of protesters gathered outside KFA headquarters in Seoul, demanding Klinsmann's removal.

The German former striker, who was appointed in February last year, is clinging to his job following a humiliating 2-0 defeat to Jordan in the semifinals of the Asian Cup. Klinsmann, who has never won over South Korean fans or media,

had promised to deliver the country's first Asian title in 64 years. He has refused to resign despite fierce pressure.

On top of that, details have now emerged about a brawl that took place the night before last week's game.

Paris Saint-Germain's Lee Kang-in on Wednesday issued an apology after Yonhap said the 22-year-old had tried to punch skipper and Tottenham star Son.

Lee's representatives have denied there was a punch.

The fracas was reportedly triggered by younger players -- including Lee -- rushing through their dinner so they could leave early and play table tennis.

This angered some of the older players, including Son, who wanted to honour long-standing tradition that the pre-game dinner be a team bonding experience, triggering the

Lee and Son both played in the Jordan defeat, the latter with two of the fingers strapped together.

He had the same dressing on his fingers when he came on at the weekend in Tottenham's 2-1 win over Brighton.

Blame game The incident has fuelled calls for Klinsmann to be sacked, with some saying it was more evidence of his weak management.

The fact the players fought on the eve of such a crucial match is "more shocking than the semi-finals elimination", sports outlet OSEN wrote.

"The 2024 Asian Cup will go down in history as the worst tournament, marked by incompetence of a smiling Klinsmann and a divided national squad," OSEN said.

The incident highlighted a generational and cultural shift in the South Korean team, Song Giseong, a sports journalist at broadcaster MBC, told agency.

It is partly due to a "cultural gap between Son, who went to Europe after finishing middle school, and Lee, who went to Spain to train at age nine", he said.

The fact that the bustup was leaked and then quickly confirmed by the KFA may indicate the KFA were trying to shift blame for the Asian Cup exit from the coaching staff to the players.

"Under normal circumstances KFA usually denies it or makes no comment, but on this topic they were so unusually quick in confirming it," said Song.

## Valmiki Community should be given 3 out of 7 reserved Assembly seats: Chandel

He added since the abrogation of Article 370 and the passage of legislation providing reservation benefits to Dalit communities in the Lok Sabha, the administration of Jammu and Kashmir has turned a blind eye, continuing to obstruct the process of issuing caste certificates to Valmiki community members.

While the central government has reserved seven assembly seats for Scheduled Caste communities in Jammu and Kashmir, the benefits will only reach the Valmiki community when they possess caste certificates, he said.

Additionally, reservation benefits will only be accessible to Valmiki community children when they possess caste certificates, he said, adding that the administration of Jammu and Kashmir continues to procrastinate in issuing caste certificates to Valmiki community members.

Chandel has written a letter

to the Prime Minister, Narendra Modi, demanding that out of the seven assembly seats reserved in Jammu and Kashmir, three seats should be allocated to candidates from the Valmiki community.

He emphasized that justice will only prevail for the Valmiki community, as they have borne the brunt of the most suffering and humiliation in Jammu and Kashmir.

Furthermore, urgent measures should be taken to expedite the process of issuing Scheduled Caste certificates in Jammu and Kashmir, ensuring that the benefits of reservation reach the Valmiki community and their children residing in the region, he added.
