ECI orders Odisha govt to transfer 2 DMs, 5 SPs

BHUBANESWAR, Apr 2 (Agencies): The Election Commission of India (ECI) on Tuesday ordered the Odisha government to transfer eight officers including two district magistrates, five superintendents of police and an IGP.

ECI secretary Rakesh Kumar in a letter to Odisha Chief Secretary Pradeep Kumar Jena directed him to transfer the officers to non-election related work.

"I am directed to state that the Commission has decided that the eight officers be transferred out to a non-election related post with immediate effect," read the letter.

IMD warns of heatwave spells lasting 10-20 days in April-June

BENGALURU, Apr 2 (Agencies): The India Meteorological Department (IMD) has forecast a harsh and arid summer over a majority of regions of the country during April- June, with a high probability of heatwave episodes lasting as long as 10 to 20 days during the

period. Summer begin on a warm note with day temperatures during April likely to remain significantly high over Madhya Pradesh, north and coastal Maharashtra, Karnataka, Kerala, Lakshadweep, Andaman and Nicobar islands, Telangana, Andhra Pradesh and Odisha. Heatwave spells lasting for 2 to 8 days (against a normal of 1-3 days) are most likely to affect Andhra Pradesh, Saurashtra-Kutch. Maharashtra and

Haryana IAS officer vacates 20-year-old stay on land deal, later husband and son buy it

NEW DELHI, Apr 2 (Agencies): A multi-crore land deal in Haryana involving a woman IAS officer, her state information commissioner husband and a former additional chief secretary rank IAS officer has been halted after Panchkula revenue officials flagged discrepancies.

Ambala Divisional Commissioner Renu Phulia, in a quasi-judicial order on September 13, 2023, vacated a 20-year-old stay on the sale and purchase of a land parcel of 14 acres near Panchkula, originally belonging to an erstwhile king. She took just 16 days to decide the petition filed by former additional chief secretary Shashi Gulati's brother Prithvi Raj Chhabra.

Within a few months of the order, Renu's husband S S Phulia, currently the state information commissioner, and son Nilanchal decided to buy five acres of this land. A former IAS officer, S S Phulia was appointed state information commissioner in 2022.

On March 28, Shashi Gulati and her brother approached revenue officials in Panchkula to register nearly 12 acres of land. They claimed they had sold the land to four individuals for a total value of Rs 5.26 crore. Five acres of land were sold to Phulia's family, and the remaining land was to be sold to Shubham Juneja, a resident of Manimajra, and the wife of a former Indian Forest Services officer.





West's disquiet about India: Meddling or friendly nudge?

The rumblings were audible in India for months as investigative agencies like the Enforcement Directorate and the income-tax department had been selectively targeting Opposition leaders and parties. It was expected that once the elections to the Lok Sabha were announced the Model Code of Conduct would compel balanced restraint till the elections were over. However, if anything, the arrest of Delhi chief minister Arvind Kejriwal on March 21 and exaggerated income-tax claims from the Congress, the main Opposition party, defied that logic. The un-levelling of the playing field continues under the very nose of the Election Commission.

Germany was the first country to express discomfort over this scenario. India reacted with calculated diplomatic ire, advising the Germans to mind their own business. But when the US state department expressed similar anxiety, the ministry of external affairs first strongly protested, although less stridently, and then followed up by summoning acting US deputy chief of mission Gloria Berbena. India's expectation was that the matter would end there, both sides having appeased public opinion in their respective countries.

However, US state department spokesman Mathew Miller, when asked about the summoning of their diplomat, in seniority next only to the ambassador, had no hesitation in reiterating that "we continue to follow these actions closely, including the arrest of the Delhi CM". Not stopping there, he added that the US was also aware of tax authorities hampering the electioneering ability of the Congress Party by freezing their accounts. Mr Miller concluded

that they "encourage fair, transparent and timely legal processes for each of these issues". Justice and fairness of the proceedings was also emphasised.

Amongst those who were trolled in India was an anchor of a major television channel when he simply tweeted the latest US reaction. This writer's comments a day earlier on a major business television channel, when posted on X and You-Tube, generated huge viewership and some acerbic comments. The main line of counterattack by pro-BJP elements was that comments on the fairness of Indian elections by foreign powers was a breach of Indian sovereignty and interference in India's internal affairs. All those reporting such criticism, and especially those pointing out the misuse of the agencies only against government's opponents were antinational.

This writer, in his social media response, pointed out that the "bhakts", or hardcore BJP supporters, failed to perceive the difference between the government and the nation. Mark Twain's quote captures it perfectly that "loyalty to the country always, loyalty to a government when it deserves it".

The fracas raises the broader question about the validity of the Indian defence that any criticism of the Indian electoral processes is a breach of Indian sovereignty. US President Joe Biden came into office in January 2021 promising a summit of democracies, intending thereby to globally advance the values that the liberal democratic model represents. But the United States has a poor record historically of such evangelism. Late US secretary of state Zbigniew Brzezinski had named his memoir Power and Principle, underscoring the conflict in the conduct of foreign

policy between ethics and realpolitik. A case in point is Pakistan. The minute the Soviet Union militarily intervened in Afghanistan in 1979, the US sidelined its ire over Gen. Muhammad Zia-ul Haq's military coup, the hanging of former Prime Minister Zulfigar Ali Bhutto and Pakistan's clandestine nuclear weapons programme. A similar long rope was offered again to military dictator Gen. Pervez Musharraf after Al Qaeda's 9/11 terrorist attack on the United States.

However, India presents a separate case. Even during the Cold War, the US was drawn to India as a citadel of democracy in Asia. Thereafter, India became additionally attractive for its economic rise, huge market, increasing military strength and as a counterfoil to China. But its basic relevance persists as an established democracy, which shares the American commitment to a global liberal democratic order. Prime Minister Narendra Modi has promoted this soft power of India by coinages like India as the "mother of democra-

Understandably, thus, India's friends among the Western nations get concerned about any democratic slippage in India. In the European Union itself, they have similar anxiety about democratic recession in member nations like Hungary. Brazil, as the 21st century opened, was seen alongside Germany, India and Japan as a natural candidate for permanent membership of the UN Security Council. But after the short and democratically destructive presidency of Jair Bolsonaro, that edge is gone.

On March 28, UN Secretary-General Antonio Guterres' spokesman also commented on the Indian elections, hoping in "India, as in any country that is having elections, that everyone's rights are protected, including political and civil rights, and everyone can vote in an atmosphere that is free and fair". India may tell the UN to stick to more pressing issues like the humanitarian crisis in Gaza and the protracted war in Ukraine. However, the fundamental question of partisan conduct by the investigative agencies cannot be ignored.

The Indian legal system is basically sound, but faces questions about its independence. One is symbolised by an anti-Opposition judge of the Calcutta high court quitting overnight to become the BJP's candidate in the forthcoming election. Similarly, an excessive number of sensitive political cases have gone to a Supreme Court judge with past Gujarat government links. This may be a coincidence but the Chief Justice must ensure, as the phrase goes, that "Caesar's wife must be above suspicion".

What can happen next? It is possible that, diplomatic demarches aside, the Indian government realises the damage that it is doing to India's reputation as a robust democracy. It may curb its inexplicable desire to overplay its winning hand, with possibilities of diminished gain. Separately, the highest court may freeze the income-tax orders and also start de-weaponising the Prevention of Money Laundering Act by restricting the detention powers of the ED. A warning signal was one member of the Election Commission suddenly resign-

Hopefully, like the US institutions defending the democratic framework when defeated incumbent President Donald Trump attempted to subvert the verdict, Indian institutions will not completely wilt. It would be a mistake to ignore warnings from the US and other Western powers as mere bluster. The people of India may be thinking analogously and vote accordingly.

Data Checking: It tests that how accurately and speedily you can find out errors in the given data. Mostly, you would be given two columns of data and you have to find the differences between the two. The data is not much meaningful. This type of test is done for clerical jobs, administrative jobs, or jobs related to banking and accounting.

Work Sample: In this, you will have to give the sample of the work you are expected to do after you get the job. Therefore, it will involve a specific skill.

What is the Importance of an Aptitude Test? The Aptitude Test can be used as a measure of the abilities of a person. These tests give the complete picture of a person's mind. He said that the Director of School Education Department has issued a circular and warned the schools violating the rules, but as far as the CEO of Jammu division is concerned, he has completely failed to implement this circular at the ground level, due to which the parents are

Take him, with a film-buff father, at the age of 16, he was part of a film society in Delhi. Introduction to world cinema, the likes of Rainer Werner Fassbinder and Ingmar Bergman, had already happened when he entered the Film Training Institute of India,

However, acting was never by conscious design. While his nuanced role of an abusive uncle in Mira Nair's Monsoon Wedding (2001) would be forever etched on our minds, at that point he was not looking at a career in acting. Today, he might agree that OTT has done wonders for actors, but on a platform where a star is born every other day, he is not looking for that one part which will define him. "I don't think there is one such role which will prove your mettle. Ultimately you want to be remembered for your entire

body of work," he says. And his impressive oeuvre includes much-lauded directorial endeavours like Ankhon Dekhi.

He specialised in film direction at his alma mater and remembers how much the guidance of stalwarts Mani Kaul and Kumar Shahani enriched him. With three National Awards under his belt, he is honest enough to admit that beyond honours and laurels, 'box office matters more'. But he also insists, "Ultimately one works neither for awards nor for money, but whether one has done something that will outlive you."

His drive to achieve that goal reflects in his film Everybody Loves Sohrab Handa, which was screened at MAMI Film Festival. For the actor in him, besides Amazon series Khauf, there is the next season of Tanaav, which he promises would be 'better than the first'. On unflattering comparisons with the original Fauda, which was a rage in India, he would not comment simply for he has not seen the Israeli series.

Actually, OTT where the space for Indie cinema is dwindling does not figure in his viewing experience; at least web dramas don't. But he would want viewers to catch up with Lootere, which among other things he says is 'fun'. His reflections on life and his journey may not come across as fun or funny, but candid, calm and collected he sure is.

The movie, adapted from Timeri N. Murari's bestseller The Arrangements of Love, is set against the backdrop of Chennai.



A student of medical stream in Jat College, Rohtak, like many of his peers, his aim was to get into the Armed Forces. But he couldn't crack the SSB exams, and it broke him completely. After watching the play Oedipus, which moved him to tears, he found his calling in theatre. The stage liberated him. "Plays became my mode of survival. Acting brought me happiness, I could eat and sleep again, and get out and meet friends," he says.

And this is source of happiness that propelled him to pursue a postgraduate course in FTII Pune. "I never thought of making money through acting. Even if you are an average actor, you can sustain yourself in Mumbai. So, it was always about good work."

For him, there is no compromise when it uct. Even if it means chopping of his own lines from the script, which could have made or marred his image in his debut film Aakrosh. Ahlawat recalls how he asked writer Aditya Dhar to cut down his eight-line scene to three, as those extra lines made no sense to him. "I do poetry recitation in Hindi and Urdu. Poetry is all about brevity. A poet expresses in two lines what a writer does in 200 words. So, I went to Aditya and told him that 'ye teen char linein to bakwas lag rahi hain'. And he said it was the first time a new actor was reducing his own lines. He was shocked by my suggestion, but we are friends till date because of that incident." Be it Khalid Mir in Raazi, Shahid Khan in Gangs of Wasseypur, Hathi Ram in Paatal Lok or Pradip Kamat in Three of Us, he enjoys every performance because 'acting is breathing' for him and everything else, money or expensive clothes just 'a bonus'.

BENGALURU, Apr 2 (Agencies): Union Home minister Amit Shah questioned how Congress after being involved in scams worth Rs 12 lakh crore during the ten year period of UPA government can compete with PM Narendra Modi who has zero charges of corruption against him.

Addressing party workers at Shakti Kendra Pramukh Sammelan organised on Tuesday in Bengaluru, Shah said that in the last 23 years as Chief Minister of Gujarat and Prime Minister of India, there have been no corruption charges against Modi. This is because he has displayed a transparent governance, he said.

"This time I want it to be 28 seats with 60 per cent vote share ' he demanded. He also mentioned that during the UPA government, they had given Rs 1.42 lakh crore grants to Karnataka in ten years, which was Rs 4.91 lakh crore during NDA's tenyear tenure.

'BJP approached me to join party or face jail': **AAP leader Atishi**

NEW DELHI, Apr 2 (Agencies): Delhi Minister Atishi said on Tuesday that the BJP approached her to join the party to "save my political career". The Aam Aadmi Party (AAP) leader also claimed that the Enforcement Directorate (ED) would arrest her in a month if she refused to join.

While addressing a press conference in Delhi, Atishi said she was approached to join the party via her close aides.

"The Prime Minister and BJP have made up their mind that they want to crush the Aam Aadmi Party and all its leaders and want to eliminate them," she said.

"The BJP intends to arrest four more AAP leaders before the Lok Sabha elections: me, Saurabh Bharadwaj, Raghav Chadha and Durgesh Pathak."

The AAP leader's revelation came a day after the Enforcement Directorate claimed that Delhi Chief Minister Arvind Kejriwal named Atishi

and Saurabh Bharadwaj while being questioned in connection with the excise policy case.

According to the probe agency, the AAP supremo told them that "Vijay Nair didn't report to him but to Atishi Marlena and Saurabh Bharadwaj and his interaction with Vijay Nair was limited [sic]."

Nair, the former communication-in-charge of the party, is one of the accused in the case. He is currently in jail.

On the probe agency's claim, Atishi said at the press conference that "yesterday the ED took Saurabh Bharadwai and my name in court, on the basis of a statement which has been with the ED and CBI for one and a half years".

"This statement is there in the ED chargesheet as well as in the CBI's. So what was the reason for raising this statement? The reason is that now the BJP feels that despite Arvind Kejriwal, Manish Sisodia, Sanjay Singh, and Satyendra Jain being in jail, the AAP remains united

and strong. Now they are planning to put the next line of leadership of the Aam Aadmi Party in jail," the Delhi Minister added.

When asked if Arvind Kejriwal would resign from his posts as Chief Minister and AAP national convenor as he is currently in Tihar Jail in connection to the Delhi liquor policy case, Atishi said, "There are two constitutional and legal provisions related to this in our country. Representation of the People Act says that if you have a conviction for more than two years, then you cannot remain a public representative".

"Arvind Kejriwal has not been convicted. Arvind Kejriwal enjoys the overwhelming majority of the Delhi Assembly, so there is no reason for him to resign. If Arvind Kejriwal resigns today then it will be a very simple and straightforward solution for the BJP to topple the opposition govern-

2 dead, several injured after bus collides with lorry on Chennai highway

TRICHY, Apr 2 (Agencies): Two people were killed, and 10 others suffered injuries in a collision between an Omni bus and a lorry near Paalpannai on the Trichy-Chennai highway on Monday night. The bus was travelling from Chennai to Kambam in Theni dis-

The Omni bus, carrying 34 passengers, collided with a truck loaded with bricks from the rear, resulting in the immediate deaths of the bus driver and an elderly woman.

Passersby and rescue teams managed to rescue 10 passengers, who were then shifted to Trichy Government Hospital for medical treatment.

Police have launched an investigation and are searching for the lorry driver, who fled the scene of the accident.

Further investigation into the incident are ongoing.

"Senseless": India Rejects China's "Invented Names" For **Arunachal Pradesh**

NEW DELHI, Apr 2 (Agencies): The Ministry of External Affairs today firmly rejected attempts by China to rename places in Arunachal Pradesh and asserted that assigning "invented names" will not alter the reality that the state "is, has been, and will always be" an integral and inalienable part

The statement was issued by the MEA in response to media queries in the wake of China releasing a fourth list of 30 new names of various places in Arunachal Pradesh amid Beijing's stepped-up assertions in recent weeks to re-emphasise its claim over the Indian state.

"China has persisted with its senseless attempts to rename places in the Indian state of Arunachal Pradesh. We firmly reject such attempts. Assign-

ing invented names will not alter the reality that Arunachal Pradesh is, has been, and will always be an integral and inalienable part of India," MEA Spokesperson Randhir Jaiswal was quoted as saying in the statement.

On March 28, India said that Beijing may "repeat its baseless claims" as many times as it wants but that is not going to change New Delhi's position that Arunachal Pradesh "was, is and will always remain" an integral and inalienable part of the country.

Mr Jaiswal had said this during his weekly press briefing, in response to a query on China continuing to harp on its claim over Arunachal Pradesh. His comments at the briefing had come days after Chinese Foreign Ministry spokesman Lin Jian had reiterated China's claim.

9 Naxalites killed in encounter with security personnel in Chhattisgarh's Bijapur; arms seized

RAIPUR, Apr 2 (Agencies): In a major antiinsurgency operation, nine Naxalites were killed in an encounter with security personnel in Bijapur district of Chhattisgarh on Tuesday, police said.

Bijapur district comes under the Bastar Lok Sabha constituency, which will go to polls in the first phase of general elections on April 19.

The gunfight took place at around 6 am in a forest near Lendra village under Gangaloor police station area, when a joint team of security personnel was out on an anti-Naxal operation, Inspector General of Police (Bastar Range) Sundarraj P told agency.

After the exchange of fire stopped, bodies of four Naxalites were recovered from the spot along with a light machine gun, barrel grenade launchers and other arms and ammu-



nitions, he said.

Later, five more bodies were found at the encounter site, the IG said, adding that search operation was still underway in the area

Personnel belonging to the District Reserve Guard, Special Task Force, Central Reserve Police Force and its elite unit Commando Battalion for Resolute Action (CoBRA) were involved in the operation, he said.

Notably, Naxalites carry out the Tactical Counter Offensive Campaign (TCOC) in the summer season between March and June every year and step up their activities. A large number of attacks on security forces have taken place in the Bastar region during this period.

On March 27, six Naxalites were killed in an encounter with security forces in Basaguda area of Bijapur, police earlier said.

With the latest incident, 42 Naxalites have been killed so far this year in separate encounters with security forces in Bastar region, comprising seven districts including Bijapur, according to police.

Assembly elections, repeats most sitting MLAs The Bharatiya Janata Party (BJP) on Tues-

Apr 2 (Agencies): day renominated 21 of its 22 sitting MLAs, except Bramhagiri legislator Lalitendu Bidvadhar Mohapatra for the upcoming Assembly election commencing on May 13.

Announcing candidates for 112 out of 147 assembly constituencies, the party has named Upasana Mohapatra, niece of Lalitendu and daughter of former Congress MLA late Lalatendu Mohapatra for the coastal seat of Brahmagiri under Puri parliamentary constituency.

After denying Lok Sabha ticket to sitting Bargarh MP Suresh Pujari, the central election committee of the BJP has nominated him for the Brajarajnagar assembly seat he had unsuccessfully contested three times.

Prominent faces on the list of candidates include state BJP president Manmohan Samal.



BJP announces 112 candidates for Odisha

from the Chandbali seat despite losing the last three elections in a trot. Of the nine elections Samal has so far contested, he was only successful in 2004 by winning the Damnagar seat. He was the revenue minister in the coalition government led by Naveen Patnaik.

The other notable nominations are leader of opposition Jayanarayan Misha and sitting MLA from Bhawanipatna Pradipta Kumar Nayak. The party has reposed faith in them despite serious health issues.

There were speculations that Mishra's daughter Subhashree and Nayak's wife may get the tickets for the respective

The party has not named any candidate for the Nilagiri seat after the resignation of sitting MLA Sukanta Nayak, who switched camps to BJD on Sunday.

With the nomination of only eight women candidates, the BJP seems to be far away from its commitment of ensuring 33 per reservation for the fairer sex in the legislature. Senior leader and former minister Surama Padhi has been denied a ticket for the Ranpur seat.

The major beneficiaries in getting tickets are those BJD leaders parachuted into the saffron party just before the election.

Arabinda Dhali, who recently rejoined the BJP after a stint with the BJD, has been named as the candidate for the Jayadev seat, which he currently represents in the assembly

Similarly, popular actor and former BJD MP from Berhampur, Sidhanta Mohapatra, has been named for the Digapahandi seat, replacing another cine artiste Pinky Pradhan, who was aspiring for the nomina-

tion. Another Odia actor and former BJD MLA from Korei, Akash Das Nayak, who joined the BJP two days ago, is now the saffron party candidate for this assembly seat. Priyadarshi Mishra is the other ex-MLA of BJD to get nomination from

Bhubaneswar North. The party has named Babu Singh for Bhubaneswar Ekamra and Jagannath Pradhan for Bhubaneswar Central seats, respectively.

While the saffron party's youth leader. Tankadhar Tripathy, will fight the Assembly polls from Jharsuguda, MLA Kusum Tete will contest from the Sundargarh Assembly seat, and Biswaranjan Badajena from Jatni.

Jagannath Pradhan has been fielded from Bhubaneswar Central, Babu Singh from Bhubaneswar Ekamra and Prithiviraj Harichandan from the Chilika Assembly seat.

The party also selected sitting MLA Suryabanshi Suraj, son of BJP leader late Bishnu Sethi, from Dhamnagar Assembly seat, Padmalochan Panda from Simulia, Rajendra Das from Soro, Gobinda Chandra Das from Remuna, Manas Kumar Dutta from Balasore, Braja Pradhan from Jaleswar, and Irasis Acharya from Bhatli.

North Korea has fired intermediate range missile into its eastern waters, says South Korea

There are concerns that North Korea could further dial up pressure in an election year in the United States and South Korea

SEOUL, Apr 2 (Agencies): North Korea on Tuesday test-fired a suspected intermediate-range ballistic missile toward waters off its eastern coast, South Korea's military said, adding to a series of weapons demonstrations that have raised tensions in the region.

South Korea's Joint Chiefs of Staff said the missile was launched from an area near the North Korean capital, Pyongyang, but it did not immediately confirm how far the weapon flew. The North had said last month that it tested a solid-fuel engine for its new-type intermediate-range hypersonic missile as it tries to expand its arsenal of weapons aimed at remote US targets in the Pacific, including the military hub of Guam.

It was the North's first known launch event since March 18, when North Korean leader Kim Jong Un supervised a live-fire drill of artillery systems designed to target South Korea's capital.



Japan's coast guard shared an assessment of the country's Defense Ministry that the missile has already landed but still urged caution for vessels passing the area. Japanese broadcaster NHK said the missile likely didn't reach the country's exclusive economic zone.

Tensions on the Korean Peninsula have risen since 2022 as Kim used Russia's invasion of Ukraine as a distraction to accelerate his testing of missiles and other weapons. The United States and South Korea

have responded by expanding their combined training and trilateral drills involving Japan and sharpening their deterrence strategies built around

strategic US assets.

The weapons North Korea have tested this year include an intercontinental ballistic missile designed to target the US mainland as well as cruise

missiles and "super-large" multiple rocket launchers aimed at the Seoul capital area.

The latest launch came two days after North Korea reaffirmed its plans to launch several reconnaissance satellites this year in violation of multiple UN Security Council resolutions. South Korea's military said Monday there were no signs that a satellite launch is impending at the North's main launch facility in the northwest.

Kim has described satellites

as crucial for monitoring U.S. and South Korean military movements and enhancing the threat of his nuclear-capable missiles. Last November, North Korea put a military spy satellite into orbit for the first time, drawing condemnations from the US, South Korea, Japan and others, which view the launch as a cover for testing the North's long-range missile technology. North Korea has argued it has the sovereign right to launch spy satellites.

Aid group says Israeli strike kills 7 of its workers in Gaza, including foreigners

DEIR AL-BALAH (GAZA STRIP), Apr 2 (Agencies): An apparent Israeli airstrike killed six international aid workers with the World Central Kitchen charity and their Palestinian driver, the aid group said Tuesday, hours after it brought a new shipload of food into northern Gaza, which has been isolated and pushed to the brink of famine by Israel's offensive.

Footage showed the bodies of the dead at Al-Aqsa Martyrs Hospital in the central Gaza town of Deir al-Balah. Several of them wore protective gear with the charity's logo.

The food charity founded by celebrity chef José Andrés said early Tuesday that the seven killed include citizens of Australia, Poland, the United Kingdom and a US-Canada dual citizen.

"This is a tragedy. Humanitarian aid workers and civilians should NEVER be a target. EVER," WCK spokeswoman Linda Roth said in a statement.

The source of fire late Monday could not be independently confirmed. The Israeli military said it was conducting a review "to understand the circumstances of this tragic incident."

"Despite coordinating movements with the (Israeli army), the convoy was hit as it was leaving the Deir al-Balah warehouse," in central Gaza, the group said in a statement. It said the team had unloaded more than 100 tons of humanitarian food aid brought to Gaza on the maritime route.

Three aid ships from Cyprus arrived earlier Monday carrying some 400 tons of food and supplies organized by the charity and the United Arab Emirates, the group's second shipment after a pilot run last month. The Israeli military was involved in coordinating both deliveries.

The US has touted the sea route as a new way to deliver desperately needed aid to northern Gaza, where the UN has said much of the population is on the brink of starvation, largely cut off from the rest of the territory by Israeli forces.

Israel has barred UNRWA, the main UN agency in Gaza, from making deliveries to the north, and other aid groups say sending truck convoys north has been too dangerous because of the military's failure to ensure safe passage.

The UNRWA said in its latest report that 173 of its "colleagues" have been killed in Gaza in the violence. The figure does not include workers for other aid organizations.

World Central Kitchen board member Robert Egger and the media reported that the Australian killed in Monday night's strike was 44-year-old Zomi Frankcom from Melbourne.

Australia's Department of Foreign Affairs and Trade said it was urgently seeking to confirm reports of an Australian death. The department said in a statement: "We have been clear on the need for civilian lives to be protected in this conflict."

Protests erupt in Pakistan over abduction of Hindu girl

DERA MURAD JAMALI, Apr 2 (Agencies): Amidst growing outrage, members of the Hindu community and traders in Dera Murad Jamali took to the streets to condemn the recent abduction of a young girl, Priya Kumari, and demanded urgent action for her recovery, Dawn reported.

Criticising the Sindh government's perceived incompetence, protesters voiced their frustration over the failure to locate and rescue Kumari, who was abducted from Sukkur just days ago.

Showing placards, demonstrators vehemently denounced what they described as the routine abduction of innocent children in Sindh and highlighted the deteriorating security conditions for religious minorities, as reported by Dawn.



Led by senior Hindu community figures Mukhi Manak Lal and Seth Tara Chand, the rally drew participants from various sectors of society.

Notable attendees included Taj Baloch, representing traders, Liaqat Ali Chakar from Jl's youth wing, Mir Jan Mengal, president of the wholesale market, Molana Nawabuddin Domki, Khan Jan Bangulazi, and Harpal Das.

The leaders urged Prime Minister Shehbaz Sharif and Sindh Chief Minister Murad Ali Shah to take immediate and decisive action to ensure the safe return of the girl and to deliver justice to the minority community. They issued a stern warning of nationwide protests if their demands go unheeded.

Human Rights Focus Pakistan (HRFP) has also strongly condemned the religious persecutions of minorities in Pakistan and urged the next government to bring legislation of equal status for all communities.

HRFP has highlighted that many people from Christians, Hindus, Ahmdiyya's, Sikhs and other communities have been victimised in different attacks during the last few months.

Judge expands Donald Trump's gag order after ex-president's social media posts about judge's daughter

NEW YORK, Apr 2 (Agencies): The judge in Donald Trump's April 15 hush-money criminal trial declared his family off-limits to the former president's rancor, expanding a gag order days after Trump assailed his daughter and made false claims about her on social media.

Manhattan Judge Juan M Merchan amended a week-old ban on Trump making public statements about witnesses, jurors and others connected with the case after the presumptive Republican nominee lashed out at Loren Merchan, a Democratic political consultant in several posts on his Truth Social platform

Truth Social platform.
Trump is still free to criticize Merchan and another key figure in the case, Manhattan District Attorney Alvin Bragg, an elected Democrat who's leading the hush-money prosecution. But under the revised gag order, the D A's family is now off-limits from his rhetoric, too.

"This pattern of attacking family members of presiding jurists and attorneys assigned to his cases serves no legitimate purpose," Merchan wrote.

"It merely injects fear in those assigned or called to participate in the proceedings that not only they, but their family members as well, are fair game,' for Defendant's vitriol."

A violation could result in Trump being held in contempt of court, fined or even jailed.

Trump's lawyer, Susan Necheles, declined comment. A spokesperson for the district attorney's office also declined comment.

Trump's hush-money

case, one of four criminal cases against him, centers on allegations that he falsely logged payments to his former lawyer Michael Cohen as legal fees when they were for Cohen's work covering up negative stories about Trump



during the 2016 campaign. That included \$130,000 Cohen paid porn actor Stormy Daniels on Trump's behalf so she wouldn't publicize her claim of a sexual encounter with him years earlier.

Trump pleaded not guilty last April to 34 counts of falsifying business records, a felony punishable by up to four years in prison, though there is no guarantee that a conviction would result in jail time.

He denies having sex with Daniels and his lawyers have said that the payments to Cohen were legitimate legal expenses, not part of any coverup.

Trump touched off a firestorm last Wednesday — the day after the original gag order was issued — when he suggested on Truth Social, without evidence, that Merchan's rulings were swayed by his daughter's political consulting interests and wrongly claimed that she had posted a photo on social media showing him behind bars.

Trump complained that the original gag order was "illegal, un-American, unConstitutional" and that the judge was "wrongfully attempting to deprive me of my First Amendment Right to speak out against the Weaponization of Law Enforcement" by Democratic rivals.

Trump's posts put Merchan in an extraordinary position as a judge and a father. Just two weeks before jury selection in the historic first-ever criminal trial of a former president, Trump's lawyers and prosecutors wrangled in a series of

court filings over the bounds of the original gag order and whether Trump had overstepped them.

"It is no longer just a mere possibility or a reasonable likelihood that there exists a threat to the integrity of the judicial proceedings," Merchan concluded Monday. "The threat is very real. Admonitions are not enough, nor is reliance on self-restraint."

Merchan responded after prosecutors asked him Friday to "clarify or confirm" the scope of the gag order and to direct Trump to "immediately desist from attacks on family members."

Assistant District Attorney Joshua Steinglass implored Merchan to "make abundantly clear" to Trump that the gag order protects the judge's family, Bragg's family and the family members of all other individuals it covers.

He urged Merchan to warn Trump "that his recent conduct is contumacious and direct him to immediately desist."

Trump's lawyers fought the gag order and its expansion, citing constitutional concerns about restricting Trump's speech further while he's campaigning for president and fighting criminal charges.

On Monday, they said they would soon ask again for Merchan to step aside from the case — promising a court filing in the coming days seeking his recusal based on what they said were "changed circumstances and newly discovered evidence."

Merchan refused the defense's demands to

exit the case last year when they first made an issue of his daughter's consulting work and questioned \$35 worth of donations he'd made to Democratic causes during the 2020 campaign, including \$15 to Biden.

Merchan said then that a state court ethics panel found Loren Merchan's work had no bearing on his impartiality. He ruled last September that he was certain of his "ability to be fair and impartial" and that Trump's lawyers had "failed to demonstrate that there exists concrete, or even realistic" reasons for recusal.

Trump's original gag order, issued last Tuesday, had barred him from either making or directing other people to make public statements on his behalf about jurors or potential witnesses in the hushmoney trial, such as his lawyer-turned-nemesis Michael Cohen and porn star Stormy Daniels.

The order, echoing one in Trump's Washington, D.C., election interference criminal case, also prohibits any statements meant to interfere with or harass the court's staff, prosecution team or their families. Those prohibitions still apply, along with the newly minted ban on comments about Merchan's and Bragg's families.

Merchan, in expanding the gag order, also warned Trump he'll forfeit his right to see the names of jurors — which are otherwise being kept from the public — if he engages in conduct that threatens their safety or integrity.

"Again, all citizens called upon to participate in these proceedings, whether as a juror, a witness or in some other capacity, must now concern themselves not only with their own personal safety, but with the safety and the potential for personal attacks upon their loved ones," Merchan wrote. "That reality cannot be overstated."

Crew of cargo ship Dali that took down Baltimore bridge to remain on board till probe is complete

NEW YORK, Apr 2 (Agencies): The crew of 20 Indians and a Sri Lankan of the crippled container vessel that collided with a key Baltimore bridge last week is "busy with their normal duties" and will remain on board until the investigation into the accident is completed, the company that owns the vessel has said.

The container vessel Dali collided with the 2.6-km-long fourlane Francis Scott Key Bridge over the Patapsco River in Baltimore in the early hours of March 26. The 984-foot cargo ship was bound for Colombo, Sri Lanka.

Just minutes before colliding with the bridge, there was a total blackout on the ship, indicating that the vessel lost engine power and electrical power, according to US media reports.

"It is confirmed there are 21 crew members on board. The crew members are busy with their normal duties on the ship as well as assisting the National Transportation Safety Board and Coast Guard investigators on board," a spokesperson of Grace Ocean Pte and Synorgy Marine told agency.

and Synergy Marine told agency.
On how long the crew would have to stay on board the ship, the spokesperson said: "At this time, we do not know how long the investigation process will take and until that process is complete, the

crew will remain on board."

The Singapore-flagged

The Singapore-flagged Dali is owned by Grace Ocean Pte Ltd and managed by the Synergy Marine Group. Earlier, the non-profit organisation Baltimore International Seafarers' Centre had said that the Indian crew on board the container vessel was "healthy".

The Ministry of External Affairs in New Delhi earlier said that there were 20 Indians on board Dali and the Indian embassy in Washington was in close touch with them and local authorities.

Last week, US authorities began interviewing personnel on board Dali. The Synergy Group had said in a statement that the NTSB boarded the vessel on Wednesday and collected documents, voyage data recorder extracts, and other evidence as part of their investigation.

Grace Ocean and Synergy confirmed the safety of all crew members and two pilots aboard the vessel. They, however, reported one minor injury and said the injured crew member had been treated and discharged from a hospital.

Six people, who were part of a construction crew repairing potholes on the bridge when the collision occurred, are presumed dead. Divers recovered the bodies of two

of the construction workers from a red pickup truck found submerged in the river and a search was on for the remaining four victims.

US President Joe Biden said that the crew on board Dali had alerted transportation personnel about losing control of the vessel, enabling authorities to close the Baltimore bridge to traffic before the devastating collision, "undoubt-

edly" saving lives.

Meanwhile, a temporary alternative route for ships is to be opened in the US city of Baltimore following the collapse, officials announced.

Efforts are underway to remove

debris from the water. A 200-tonne piece of the bridge was removed. Those involved in the clean-up have been cutting debris from the bridge into smaller pieces that can be removed and taken to a dis-

posal site.
The collapse of the bridge has effectively shut down operations at Baltimore's port, affecting about 8,000 jobs and about USD 2 million in daily wages for those workers, US Transportation Secretary Pete Buttigieg said last week.

Between USD 100 million and USD 200 million worth of trade went through the port daily before the bridge's collapse, and the port was America's largest for handling vehicle imports, Buttigieg said.

Udhampur among India's top 3 districts in rural road construction: Dr Jitendra

UDHAMPUR, Apr 2: Union Minister and BJP Candidate for Udhampur, Doda, Kathua constituency Dr Jitendra Singh said here today that Udhampur has emerged among India's top three districts in rural road construction under Central PMGSY scheme and this has been possible only because of the prioritisation given by the government headed by Prime Minister Narendra Modi in the last 10 years.

Dr Jitendra accused the Congress led governments in the past, including the UPA government from 2004 to 2014, of following a policy of regional discrimination as a result of which the upper hilly remote areas and far flung peripheral panchayats of district Udhampur remained unconnected by road because these did not receive the kind of attention deserved. Addressing a series of massive public meetings during his election tour of the upper reaches of district Udhampur including the areas like Basantgarh, Lati, Gordy, Landar, etc., Dr Jitendra said, Udhampur because of its typical topography with a large part of the district located on difficult terrains this road construction work should have been undertaken several decades ago but as a deliberate design it was not done in spite of the fact that the PMGSY scheme for the rural road construction was also introduced by NDA-1 under PM Atal Bihari Vajpayee but not carried forward with the same spirit by the successive governments till Prime Minister Narendra Modi took over in 2014 and Udhampur was given the top priority.

Thanking Prime Minister Modi for having given due attention to this region Dr Jitendra said, today the people in the far flung areas have not only received the benefit of connectivity but this has in turn also boosted their morale and

awakened their aspirations to engage in trade and business. Dr Singh said, significantly the lavender cultivation which for the first time in the country began from the small town of Bhaderwah in the same constituency has now been undertaken also in these areas of Udhampur district particularly Ladi and Basantgarh. This is going to be an important source of lucrative livelihood for the local youth, he said and added that the earlier governments led by Congress and its allies made false promises to the youth of giving government jobs to each individual, which he said could not have been possible. Though lavender and other means of livelihood were available in this region, but the Congress governments did not bother to explore the national resources available, he alleged.

According to local media reports, one of the accused, who was passing by Vinod's house,

threw a sandal at his German Shepherd dog when it barked at him from inside the gate.

On questioning this, Vinod was also brutally roughed up by the gang, the reports claimed.

Vinod was admitted to the Intensive Care Unit of a city hospital, but he succumbed to his injuries on Monday.

IMD warns of heatwave spells lasting 10-20 days in **April-June**

western regions of Madhya Pradesh this month. This month, performance of the premonsoon rainfall shall be below average mainly over coastal India, eastern and south peninsular India, thereby continuing the dry trend since February over these regions.

"Most regions in the country will experience above normal maximum temperatures during the summer season this year. Jammu and Kashmir, Himachal Pradesh, northern Odisha, adjoining Gangetic West Bengal and eastern India regions could experience normal or below normal temperatures," said Mrutyunjay Mohapatra, director general, IMD, during the release of the temperature outlook for April-June season on Monday.

There is a high probability of heatwave episodes lasting as long as 10 to 20 days (against a normal of 4 to 8 days) during the upcoming three months, the IMD said. Rainfall associated with pre-monsoon conditions are expected to be below normal over most regions; aridity and shortage of water will add to the overall increased heating forecast during the summer season this year.

Rajasthan, Gujarat, Saurashtra-Kutch, Maharashtra, north Karnataka, Andhra Pradesh and Odisha will experience extreme high day temperatures and heatwaves this summer. More importantly, there will be higher than normal heatwave spells during April to June, the Met department has warned.

The El Nino conditions — the abnormal warming of the sea surface recorded along the equatorial Pacific Ocean — had commenced last June. After peaking in December last year, El Nino conditions had begun to ease, but warm conditions continued to prevail and significantly drove up the global temperatures. El Nino conditions are known to suppress rainfall over India and increase temperatures, globally.

"We cannot attribute a single phenomenon for the prolonged heatwave spells. But during El Nino years, the number and intensity of heatwaves remain higher than normal," Mohapatra explained.

Multiple global climate models have forecast that the ongoing El Nino conditions will wane off completely and be replaced by El Nino Southern Oscillation (ENSO) neutral conditions by June, when India's southwest monsoon onset is realised.

During February and March, the southern peninsular India had experienced hotter than normal weather conditions. Heatwave conditions were reported from Maharashtra, northern Karnataka, Saurashtra-Kutch and parts of Rajasthan during late March. The maximum temperatures recorded during the past week reached 42.6 degrees Celsius in pockets of Akola in Maharashtra and Phalodi in Rajasthan.

SC refuses to accept apology tendered by Baba Ramdev, Patanjali MD in misleading ads case

A bench of Justices Hima Kohli and Ahsanuddin Amanullah, which pulled them up in the matter, finally agreed to give one more chance following Solicitor General Tushar Mehta's intervention.

The bench, which perused an affidavit filed by Balkrishna, took exception to it shifting the blame to the company's media department. "We are not willing to accept such an explanation... Your media department is not a standalone island in your office is it...that it wouldn't know what is happening in the court proceedings? And proceedings of such a serious nature. So your apology is not persuading this court really to accept it. We think it's more of a lip service," said Justice Kohli. Hearing a plea by the Indian Medical Association (IMA) accusing the company of allegedly violating provisions of the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954, and making statements critical of allopathy, the bench had on March 19 sought the personal presence of Acharya Balkrishna and Baba Ramdev before it. The duo had appeared before the court on Tuesday.

In the affidavit filed in response to the notice, Acharya Balkrishna said he "regrets

that the advertisement in question which was meant to contain only general statements inadvertently included the offending sentences... The same was bona-fide and added in routine course by the media department of the...Company," he said, adding "the personnel of the media department of the... Company were not cognizant of the order dated 21.11.2023.

Appearing for Balkrishna and the company, Senior Advocate Vipin Sanghi accepted that there was a mistake, but it did not convince the court. "But what did you do in November? What engages us is what you did and how you conducted yourself after you give an undertaking to this court in November. The whole thing follows from then — lapse by you, lapse by your company, and lapse by the third proposed contemnor (Baba Ramdev) who is the co-founder and promoter of the same brand. Conducting press conference the next day. You were all cognizant of the court proceedings. You can't feign ignorance. That's the point," the court said.

Balkrishna's affidavit had also said that the Drugs and Magic Remedies (Objectionable Advertisements) Act was passed when scientific evidence was lacking in Ayurveda research.

Justice Kohli also took exception to this and said, "Even today, one of the statements made by you in your so-called unqualified apology is that the Act itself is archaic. So shall we assume that every Act which is archaic shall not be implemented or enforced in law? An Act remains an enactment, which has to be enforced as a law of the land till it remains on the statute book"

As Sanghi agreed, Justice Kohli added, "For you to then say that there is scientific research and and therefore... When there is an Act that governs the field, how can you violate it with such impunity? That all your advertisements are in the teeth of that Act. And to top it all and that's adding insult to injury, that you had given an undertaking to this court, a solemn undertaking, and you violate it with impunity!"

Sanghi replied, "There has been a lapse." 'I herefore, be ready for the follow-up consequences is all we are saying. We are not willing to look at this apology which is perfunctory in every respect," said Justice Kohli. Sanghi said the company's motive was not

commercial benefit, but Justice Kohli remind-

ed that "you are a commercial organisation". Justice Amanullah added that such comments are for public consumption. "You are here for contemnor. Restrict yourself to that. You can't take this grandstanding. We will not give you this platform...that you are serving

the nation. Please do not". Appearing for Ramdev, Senior Advocate Balbir Singh also expressed his unconditional apology and said the response affidavit was ready but was not filed as it was felt that he should personally apologise to the court first before filing any reply.

Justice Amanullah, however, said the apology "is not coming from the heart".

"You are representing somebody who is in the teeth of an order of the court. And being a co-founder of the same organisation, we refuse to believe that he wasn't well aware of the consequences that will flow in the teeth of an undertaking given to this court by the managing director of the company," said Justice Kohli.

The judge added, "For you to...hold a press conference in 24 hours shows that you were cognisant (of the court order)... And despite that you floated it... And after two months, you come out with the advertisements... which also portray you as a promoter... How do vou explain this?

Balbir Singh said, "I'm not trying to defend any position. There is a wrong and we are not defending it."

About the press conference, he said, "That's not the way the court order should have been taken. I completely apologise. We have realised that there's a mistake which should not have been committed."

"Not just the Supreme Court, every court in this country, when an order is passed, has to be obeyed in letter and spirit...," responded Justice Kohli

Haryana IAS officer vacates 20-year-old stay on land deal, later husband and son

According to officials, the market value of the land was much higher than the cur-

On March 29, the state government stopped registering a piece of land after

Panchkula Deputy Commissioner Sushil Sarwan requested guidance from Additional Chief Secretary (Revenue) T V S N Prasad, who immediately instructed the revenue officials to stop registering any transfer deeds. According to officials, the Panchkula revenue officials are yet to determine the surplus area of the 1,396-acre land previously owned by the king Sardar Bhagwant

According to official records, Shashi Gulati and her family purchased 14 acres of land from the late king's legal heirs in the village of Beed Firozadi in Panchkula district. The late king owned approximately 1,396 acres of land in seven villages of Panchkula: Beed Babupur, Beed Firozadi, Bhareli, Sangrana, Barwala, Jaloli, and Fatehpur Viran.

Official sources say that there has been a stay on the land of some villages in Panchkula for the past 20 years as the officials wanted to know which parts of the land from the king's land fall under the category of surplus under the Haryana ceiling on land holdings Act, 1972, or which areas fall under the 'permissible area'. The surplus area goes to the state government while the permissible area can be sold and purchased by individuals.

On February 24, 2023, the Punjab and Haryana High Court directed Panchkula's SDM to redetermine the surplus area according to law. In compliance, the officials started the proceedings.

Meanwhile, in their petition to the Ambala Commissioner, Shashi Gulati's family sought to revoke the stay order claiming the land concerned did not fall under the surplus category. They also pointed out that the stay on the sale and purchase was vacated twice earlier: once by the then-Ambala Commissioner Alok Nigam in 2004 and again by the then-Panchkula deputy commissioner in January 2017.

Renu Phulia overturned the stay order, which was issued by the SDM in 2003 with a quasi-judicial order in September 2023.

When contacted by The Indian Express. Renu Phulia claimed that her family's talks to buy the land took place a considerable time after her order.

She said: "When they (Shashi Gulati family) filed a petition before her court, we had no talks regarding purchase of the land concerned. They filed the case in routine, I decided it in routine. They were given permission to sell the land concerned as it is a permissible area."

"Later, our talks took place in October-November 2023 when they said they wanted to sell the land. We decided to buy the land as it belonged to the permissible area. My husband made a deal to buy five acres of land for Rs 42.5 lakh. My husband informed the Chief Information Commissioner about it. I also took permission from the government to purchase land in the name of my husband and son. My husband gave an advance installment in December 2023. As per the collector rates, we have paid the stamp duty for a value of Rs 2.25 crore for five acres of land."

Nearly 19 lakh Pilgrims visit Shri Mata Vaishno Devi in 3

A Shrine Board official said that this year from January to March, over 19 lakh devotees visited the cave shrine, adding, "In 2023, 18,33,266 devotees paid obeisance at Bhawan, which means around 77,838 more pilgrims visited the Bhawan in the said period."

The official added that on the weekends, the figure is between 40,000 to 45,000. adding, "Expecting a huge rush in the coming days, the Shrine Board is making various arrangements to facilitate a smooth journey for the pilgrims."

Tuesday. The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index (PMI) surged to a 16-year high of 59.1 in March, from ing stronger growth of new orders, output and input stocks as well as

"India's March manufacturing PMI rose to its highest level since 2008. Manufacturing companies expanded hiring in response to strong production and new orders. On the back of strong demand and a slight tightening in capacity, input cost inflation picked up in March," Ines Lam, Economist at HSBC, said.

Manufacturing outp rose for the 33rd month running in March, and to the greatest extent since October 2020. Growth quickened across the ers in March. The pace of job creation was mild, but the best since September 2023, the survey said.

Low-fat vegan diet found to lower insulin needs in Type 1 diabetics, lower risk of heart disease

NEW DELHI, Apr 2 (Agencies): A low-fat vegan diet rich in fruits, vegetables, grains and beans can help reduce insulin needs in people affected by Type 1 diabetes, a new research has found.

It also found that changes in body weight, brought about by the plant-based diet, helped lower participants' resistance to insulin by improving sensitivity. Glycemic control, or glucose levels in the blood serum, was also observed to get better. The improvements were, in turn, found to correspond to lowering the risk of heart disease in these patients.

While Type 2 diabetes is more common, Type 1 diabetes is an autoimmune disease in which the body's immune system attacks the healthy pancreas, affecting its ability to produce insulin and regulate blood sugar. The patients, therefore, may require regular insulin injections.

"With the cost of insulin

remaining a concern for many, our groundbreaking research shows that a low-fat vegan diet that doesn't restrict carbs may be the prescription for reducing insulin needs, managing blood sugar levels, and improving heart health in people with Type 1 diabetes," said Hana Kahleova, the study's lead author and director of clinical research at the Physicians Committee for Responsible Medicine, US.

The study findings have been published in the Clinical Diabetes iournal

For the study, the researchers randomly assigned 58 adults with Type 1 diabetes to either a low-fat vegan group with no limits on calories or carbohydrates or a portion-controlled group reducing daily calorie intake for overweight participants and keeping carbohydrate intake stable over time.

During the study period of 12 weeks, the participants on the low-fat vegan diet were found to require 28 per cent lesser insulin, with their body's response or sensitivity to insulin improving by 127 per cent.

The researchers observed these effects to be associated with body weight, which fell by about five kilogrammes on an average. The body weight of individuals in the portion-controlled group, on the other hand, changed non-significantly.

They also associated the improved insulin sensitivity with increased carbohydrate and fibre intake.

The results support previous research that links a lower fat and protein intake with reduced insulin requirements and improved sensitivity in people with Type 1 diabetes, the researchers said.

The team further linked these improvements to lowering cardiovascular risks of disease and death, known to be higher in Type 1 diabetic patients.

They found the participants' reduced reliance on external insulin to correspond to a nine per cent lowered cardiovascular risk.

The lowered glucose levels in the blood serum corresponded to a 12 per cent and about 9-12 per cent reduced risk of heart attack and cardiovascular disease, respectively, they said.

The team also found that total cholesterol in the low-fat vegan group came down by 32.3 milligrams per decilitre (mg/ dL), compared to 10.9 mg/dL in the portioncontrolled group.

LDL cholesterol, or "bad" cholesterol, fell by 18.6 mg/dL in the vegan group, and corresponds to an almost 20 per cent reduced risk for a major cardiac event, including heart attack and stroke, the team said.

The levels did not change significantly in the portion-controlled group, they found.

The study authors, however, acknowledged that larger trials are needed to confirm these findings.

Researchers find how ketogenic diet improves severe mental illness

Main purpose of the small pilot trial is to help researchers detect signals that will guide the design of larger studies

STANFORD, Apr 2 (Agencies): The common antipsychotic medication used for severe mental illnesses such as schizophrenia and bipolar disorder might have unintended consequences. Although these medications aid in the regulation of brain chemistry, they frequently result in metabolic adverse effects, such as obesity and insulin resistance, which are so upsetting that many patients cease taking them.

According to a recent pilot study conducted by doctors at Stanford Medicine, a ketogenic diet helps these individuals' mental health in addition to restoring their metabolic health while they continue their drug regimen. The findings, which were released in Psychiatry Research, indicate that nutritional interventions can be quite effective in addressing mental health conditions.

"It's very promising and encouraging that you can take back control of your illness in some way, aside from the usual standard of care," said Shebani Sethi, MD, associate professor of psychiatry and behavioural sciences and the first author of the new paper.

The senior author of the

paper is Laura Saslow, PhD. associate professor of health behaviour and biological sciences at the University of Michigan.

Sethi, who is board certified in obesity and psychiatry, remembers when she first noticed the connection. As a medical student working in an obesity clinic, she saw a patient with treatment-resistant schizophrenia whose auditory hallucinations quieted on a ketogenic diet.

That prompted her to dig into the medical literature. There were only a few, decades-old case reports on using the ketogenic diet to treat schizophrenia, but there was a long track record of success in using ketogenic diets to treat epileptic seizures.

"The ketogenic diet has been proven to be effective for treatment-resistant epileptic seizures by reducing the excitability of neurons in the brain," Sethi said. "We thought it would be worth exploring this treatment in psychiatric conditions." A few years later, Sethi coined the term metabolic psychiatry, a new field that approaches mental health from an energy conversion perspective.

In the four-month pilot trial,



Sethi's team followed 21 adult participants who were diagnosed with schizophrenia or bipolar disorder, taking antipsychotic medications, and had a metabolic abnormality—such as weight gain, insulin resistance, hypertriglyceridemia, dyslipidaemia or impaired glucose tolerance. The participants were instructed to follow a ketogenic diet, with approximately 10 per cent of the calories from carbohydrates, 30 per cent from protein and 60 per cent from fat. They were not

told to count calories.

"The focus of eating is on whole non-processed foods including protein and nonstarchy vegetables, and not restricting fats," said Sethi, who shared keto-friendly meal ideas with the participants. They were also given keto cookbooks and access to a health coach.

The research team tracked how well the participants followed the diet through weekly measures of blood ketone levels. (Ketones are acids produced when the body

breaks down fat-instead of glucose—for energy.) By the end of the trial, 14 patients had been fully adherent, six were semi-adherent and only one was non-adherent.

The participants underwent a variety of psychiatric and metabolic assessments throughout the trial.

Before the trial, 29 per cent of the participants met the criteria for metabolic syndrome, defined as having at least three of five conditions: abdominal obesity, elevated triglycerides, low HDL cho-

lesterol, elevated blood pressure and elevated fasting glucose levels. After four months on a ketogenic diet. none of the participants had metabolic syndrome.

On average, the participants lost 10 per cent of their body weight: reduced their waist circumference by 11 percent; and had lower blood pressure, body mass index, triglycerides, blood sugar levels and insulin resistance.

"We're seeing huge changes," Sethi said. "Even if you're on antipsychotic drugs, we can still reverse the obesity, the metabolic syndrome, the insulin resistance. I think that's very encouraging for patients.'

The psychiatric benefits were also striking. On average, the participants improved 31 per cent on a psychiatrist rating of mental illness known as the clinical global impressions scale, with three-quarters of the group showing clinically meaningful improvement. Overall, the participants also reported better sleep and greater life satisfaction.

"The participants reported improvements in their energy, sleep, mood and quality of life," Sethi said. "They feel healthier and more hopeful." The researchers were impressed that most of the participants stuck with the diet. "We saw more benefit with the adherent group compared with the semi-adherent group, indicating a potential dose-response relationship." Sethi said.

There is increasing evidence that psychiatric diseases such as schizophrenia and bipolar disorder stem from metabolic deficits in the brain, which affect the excitability of neurons, Sethi said.

The researchers hypothesize that just as a ketogenic diet improves the rest of the body's metabolism, it also improves the brain's metabolism.

"Anything that improves metabolic health in general is probably going to improve brain health anyway," Sethi said. "But the ketogenic diet can provide ketones as an alternative fuel to glucose for a brain with energy dysfunc-

Likely there are multiple mechanisms at work, she added, and the main purpose of the small pilot trial is to help researchers detect signals that will guide the design of larger, more robust studies.

Riyan Parag reminds me of young Suryakumar at MI: Rajasthan Royals assistant coach Shane Bond

MUMBAI, Apr 2 (Agencies): Rajasthan Royals assistant coach Shane Bond has described in-form Riyan Parag as a player of "extreme talent" and likened him to a young Suryakumar Yadav who joined Mumbai Indians several years ago and went on to become one of the most explosive T20 batters in the world.

The 22-year-old Parag has brought his rich form from domestic cricket into the IPL, striking two high quality fifties to help Rajasthan notch up wins in all three games so far.

Parag's latest effort came against Mumbai Indians in his side's six-wicket win on Monday. He dropped anchor to spearhead Royals' chase of 126, scoring 54 not out off 39 balls with the help of five fours and three sixes.

"He (Parag) sort of reminds me a little bit of Surya (Suryakumar Yadav), who came to Mumbai a few years ago. He looks like that - he has got extreme talent. He has just matured as a cricketer, even though he is only 22," Bond, who is also the RR bowling coach, said at the postmatch press conference.

Bond played a crucial role in developing bowling talents at MI in his nine-year stint with the Mumbai-based franchise from 2015 onwards, before shifting base to Jaipur this year.

"He (Parag) has had an outstanding domestic season, obvi-



ously, batting up the order. The trade we made with Devdutt (Padikkal), bringing Avesh (Khan) in, that was to put Riyan up into a position which was probably better suited," the former New Zealand fast bowler added

Suryakumar, the world's number one T20 batter, joined MI in 2011 and spent four years at Kolkata Knight Riders from 2014-17 before he was brought back to the Mumbai side in 2018. He is recovering from a recent surgery.

Bond said Parag has had to play the role of a finisher in the IPL at a young age whereas other teams have experienced international players in that role.

"Riyan started so young, you forget that he was 17 or something, playing in one of the toughest spots in a batting lineup of No 6. You look at the characters who finish games around the IPL, they are generally pretty experienced guys," he said.

"(The) Tim Davids, (the) Dave Millers... these are high quality players who play international cricket. Riyan has been tasked with that for a number of years. He is still a very young man, but he has got this wealth of experience behind him now.

"We are getting the best of him. The investment that RR have made of him, it's starting to reap the rewards. It is pretty exciting what he could offer for the rest of the season for us."

Bond also felt "selfless" Yuzvendra Chahal, who produced a measly spell of 4-0-11-3 to set up Rajasthan's win on Monday, could be back in India reckoning if he continues to deliver.

"The competition is pretty tough, so one of the real challenges for any bowler coming into this tournament is to forget that there is a World Cup, and you start bowling to get into a World Cup team," he said.

"If your team is successful, you are in a winning team, selections and rewards come from that. That has more of been our focus, to forget about all that other noise from the outside and just work really hard for each

"If we do that, I have got no doubt people are going to start talking like you are now about Chahal and whether he will feature in a World Cup or not. He is bowling beautifully, and if he keeps doing that, then we have got a massive chance in this tournament," he added.

Bond said having knowledge about opposition players also helps in making strategies for his current team.

"When you have obviously spent so much time with certain players, watched them every day and talked to them about their game and the way that they see the game, that definitely helps," he said.

"It was quite fun being on the other side of the team. A couple of dismissals, you get a lot of satisfaction from that."

MI pacer Akash Madhwal said a fresh pitch at the Wankhede Stadium assisted bowlers in the first game but maintaining tight lines was equally crucial.

"We had to get our basics right and had to bowl in the line of the stumps. The pitch had some help for the fast bowlers," said Madhwal, who returned 3/20.

Mirabai Chanu ends third in World Cup, books Paris berth

Tamil Nadu Tennis Association's efforts in age-group tournaments yield success as Maaya Rajeshwaran achieves No. 1 ranking in Junior Under-18 category, fueled by ITF wins and rigorous training. Supported by family and coach Manoj Kumar, she aims for top-class status.

CHENNAI, Apr 2 (Agencies): The Tamil Nadu Tennis Association's initiative to have age-group tournaments on a regular basis and help its wards take part in ITF tournaments has paid rich dividends. Fifteen-year-old Maaya Rajeshwaran is the player to beat and scucceed in the girls Under-18 category in the country. She has now achieved the No 1 ranking in the Junior Under-18 category. "I am happy and thrilled on becoming the No 1 Junior Under-18 ranked player. A lot of hard work has gone in acheiving it. My recent wins in the ITF Juniors have helped me become the top-ranked player. Reaching the No 1 in Under-18 is a huge motivation and an accomplishment which I've always wanted to do," said the shy, yet confident, young-

Playing in ITF tournaments involves a lot of hard work, preparation, and travel.

Sometimes you have to be on your own without a travelling coach. In the ITF Juniors 2023 and 2024, Maaya won five ITF Juniors singles titles, three ITF Juniors doubles titles. She holds the record for the longest ITF Juniors winning streak and was second highest-ranked Indian in the ITF Juniors circuit. "A lot of hard work went behind it (to get the ranking). Me and my family put a lot of effort consistently and the results followed. Mainly, leaving the family behind for weeks while travelling for tournaments was really tough, but it was definitely worth it," insisted Maaya.

She is currently coached by Manoj Kumar. She practises at Proserve Tennis Academy, Coimbatore, for four hours every day. "Maaya is definitely an outstanding talent and has achieved a lot at a very young age. The fact that she played the qualifying of a Junior Grand Slam at 14



she is. I don't think any Indian has done this," said Manoj. "She has been with me for five years and has improved by leaps and bounds. She is an extremely aggressive player, likes to play early and is good off both flanks, absolutely fearless. The biggest strength is her belief in herself. She needs to work on her second serve, movement, and endurance," added Manoj. Maaya, in order to fulfill her goal of becoming a top class player, has made the right steps and is supported by her parents. "Maaya is having open school education. exposure is the key to her growth. "For the future, we are looking at her to play both the juniors, especially the higher grade J 200, J 300, the grand slams and the women's pro tour. I think with the right support and guidance, she will go places. We are looking to find a good base abroad where she can train in a competitive atmosphere which will help her achieve her goals," opined Manoj.

JAMMU, Apr 2: Hindu nationalist BJP leader Raju Chandel, while speaking to journalists in Jammu today, stated that the highest number of administrative officials and employees in Jammu and Kashmir are still working under the directives of Hurriyat Conference, National Conference, PDP, and Congress leaders, who do not prioritize the work of the Bharatiya Janata Party or other smaller parties, whether it is about providing security or implementing Prime Minister's housing development schemes and other initiatives.

Their actions are solely driven by the instructions of the leaders of the party that has been ruling Jammu and Kashmir for the past 70 years, which has resulted in the people of Jammu and Kashmir not receiving enough benefits. CPI(M) won't contest LS Polls in J&K to Consolidate Votes against BJP: Tarigami

SRINAGAR, Apr 2: Senior CPI(M) leader in Jammu and Kashmir M Y Tarigami on Tuesday accused the BJP of resorting to dictatorship and said his party would not contest in the Lok Sabha seats in the Union territory to consolidate votes and get rid of "tyrants"

He sought to downplay the reported bickering within the Peoples Alliance for Gupkar Declaration (PAGD) constituents over seat sharing for the Lok Sabha polls, saying it is not an electoral alliance and every constituent has their own political interests.

"We will not contest (the Lok Sabha polls in Jammu and Kashmir) directly. Our political approach in today's times would be to defeat the BJP, to stop them from forming government. They have already done a lot of damage to Jammu and Kashmir," Tarigami told PTI-Video in an exclusive interview here.

"We also appeal to other political parties to ensure that votes do not get divided. We hope we get rid of the tyrants soon," he said.

Asked about reports suggesting the coming together of the Ghulam Nabi Azad-led Democratic Progressive Azad Party, Altaf Bukhari's Apni Party and Peoples Conference headed by Sajjad Lone, Tarigami questioned the move and said, "We should have been loyal towards our people."

together a grand alliance. Against whom? I would have welcomed it had this alliance aimed at raising the genuine concerns of the people such as our statehood, and our land rights. What the present government did with us does not have a precedence in the history of

"Keeping differences aside, we should have been loyal towards our people at least. It should have been a fight for the rights of people," the CPI(M) leader said. He said it was unfor-

tunate that Jammu and Kashmir has always been in the crossfire and there has been restlessness among its people.

"Pakistan has been making its own claims and our country, India, has been making its own claims. There has been a restlessness among people. The successive governments have also not been loyal towards the people of Kashmir.

"Today's government left no stone unturned to demolish the very foundation of the pact between the Centre and the people. We have always been deprived of our constitutional rights. They (BJP) eroded Article 370 also," Tarigami

The CPI(M) leader said, "If BJP had a clear roadmap, they would not have resorted to dictatorship. They downgraded Jammu and Kashmir into a Union territory. Look at the plight of government employees here. They are not even allowed to protest... Do you think people will show support towards BJP?'

Tarigami, who is also spokesperson of the PAGD, said it is not an electoral alliance and every constituent has their own political interests.

PAGD is an alliance of five political parties — National Conference, PDP, CPI(M), Awami National Conference and CPI — seeking the restoration of the special status to Jammu and Kashmir which was revoked with the abrogation of Article 370 in 2019.

"The DDC (District Development Council) elections were fought together despite the differences... Jammu and Kashmir had its own constitution but that's gone now. Our flag is gone, our land rights are gone, our permanent residency rights are gone. State-

divided without taking

into consideration the aspirations of the people. Whatever statements the constituents have given do not change the very idea of PAGD. It will always be relevant," he said.

Tarigami said there are disagreements even among leaders of the

Terming electoral bonds a "big scam", he hit out at the BJP and said, "If you want to do corruption, do not do it in the name of law. We (CPI-M) have not taken even a single penny (through electoral bonds).

"In fact, we were the first ones to file a petition against electoral bonds in the Supreme Court. People should not take much time to understand what is going on in the country these days," he said.

On the arrest of Delhi Chief Minister Arvind Keiriwal and former Jharkhand chief Hemant Soren in different corruption cases, Tarigami said, "The constitution is under attack. There is an assault on democracy. If you want to weaken or break a party, ED and CBI are there. These agencies do the needful for the government. If a person is corrupt, he joins

the BJP." Asked about the recent statement of Home Minister Amit Shah that the Central government will consider revoking the Armed Forces Special Powers Act (AFSPA) in Jammu and Kashmir, he said the present government has been "relying on 'jumlas' (false promises) only".

"Shah had said that first there would be delimitation, then elections and then statehood. What happened to that chronology? If the environment (in J-K) is feasible for Lok Sabha elections, then why not for assembly polls? You must be knowing about the Pathribal, Machil and Shopian (fake) encounters. We all condemned the impunity that was given to the forces. We do not need these draconian laws in a democratic setup," he added.
