MeT says possibility of heavy rain on April 28

SRINAGAR, Apr 26 (Agencies): Amid the forecast for cloudy weather with the possibility of light to moderate rain in plains and snow over higher reaches during the next few days, night temperature recorded a rise and settled above normal at most places in Jammu and Kashmir on Friday.

A meteorological department official said that generally cloudy weather with light to moderate rain and light snow over higher reaches is expected at most places with thunder, lightning, hailstorm and gusty winds at few places till April 28. He said there is possibility of heavy rain over isolated places, particularly on April 28

From April 29-30, he said, weather is expected to be generally cloudy with light rain and thunder at scattered places. Generally dry weather is expected from May 1-4,

Regarding temperature, he said, Srinagar recorded a minimum of 10.5°C against 8.2°C on the previous night and it was 1.2°C above normal for the summer capital of JK for this time of the year.

Qazigund recorded a minimum of 7.8°C against 5.8°C on the previous night and it was normal for the gateway town of Kashmir, he said. Pahalgam recorded a low of 5.2°C against 2.8°C on the previous night and it was 0.8°C above normal for the famous resort in south Kashmir. Kokernag, also in south Kashmir,

recorded a minimum of 9.3°C against 6.7°C on the previous night and it was 1.2°C above normal, the official said. Kupwara town recorded a low of 8.5°C against 6.7°C on the previous night and it was 0.7°C above normal there, the official said.

Gulmarg recorded a low of 4.8°C against 2.7°C on the previous night and it was above normal by 0.6°C for the world famous skiing resort in north Kashmir's Baramulla district. Jammu, he said, recorded a minimum of 20.8°C against 19.2°C on the previous night and it was below normal by 1.1°C for the winter capital of J&K. Banihal recorded a low of 9.8°C, Batote 11.6°C Turn to page 9

Polling commences in Jammu Parliamentary Constituency on high note

JAMMU, Apr 26 (Agencies): The commencement of polling in the second phase of the Lok Sabha elections in Jammu Constituency began with enthusiasm, especially among the new voters.

Across various assembly segments of the parliamentary constituency, voters were seen standing in queues much ahead of the scheduled time for polling.

The Election Commission has put in place all necessary arrangements to ensure a fair and transparent electoral process.

The polling began at 7 am in all 2416 polling stations across the con-

stituency.

Earlier, mock poll was conducted successfully in all the polling stations. Incumbent MP Jugal Kishore Sharma of the Bharatiya Janata Party (BJP) is eyeing a third straight term in the Lower House of Parliament after he won the seat in the 2014 and 2019 elections.

This is the first major poll battle in Jammu and Kashmir after the abrogation of the provisions of Article 370 and bifurcation of the erstwhile state into Union territories on August 5, 2019. Voters were seen headed towards polling

2 terrorists killed, 2 Army personnel injured as gunbattle resumes in Baramulla



SRINAGAR, Apr 26 (Agencies): Two terrorists were killed while as many Army personnel got injured on Friday as a gunbattle between the militants and security forces continued for the second day in Jammu and Kashmir's Baramulla district, officials said.

The encounter began on Thursday at Check Mohalla Nowpora in the Sopore area of north Kashmir. After the night's lull, a fresh exchange of firing took place on Friday morning, they said.

Two terrorists have been killed so far, according to the officials. Two army personnel injured in the gunfight

Supreme Court rejects plea for full **VVPAT-EVM tally; Upholds EVM usage**

NEW DELHI, Apr 26 (Agencies): The Supreme Court has dismissed a plea requesting tallying all Voter Verifiable Paper Audit Trail (VVPAT) slips with Electronic Voting Machine (EVM) votes in elections, firmly rejecting any return to paper ballots.

The Bar and Bench reported that justices Sanjiv Khanna and Dipankar Datta, presiding over the bench, also declined the prayer to revert to paper ballots from EVMs.

In a pronounced order, the Court stated, "We have rejected the prayer



for paper ballot voting, complete EVM-VVPAT verification and physical deposit of VVPAT slips." Emphasizing the importance of fostering trust and collaboration to bolster democracy, the

Court highlighted the necessity of meaningful criticism over blind scepticism towards systems governing democracy, be it the judiciary or legislature.

Despite dismissing the

plea, the Court issued directives to enhance the security of EVMs, aimed at ensuring their foolproof functioning:

Symbol loading units are to be sealed after the completion of the loading process and stored in strong rooms for 45 days.

All candidates are

permitted to be present during verification, with district election officers certifying the authenticity of burnt memory.

A team of engineers is to verify the burnt memory in the microcontroller unit.

Omar, Mehbooba ask EC not to postpone polls in Anantnag-Rajouri Lok Sabha Seat



SRINAGAR, Apr 26 (Agencies): NC leader Omar Abdullah and PDP president Mehbooba Mufti on Friday asked the Election Commission not to postpone polls in Anantnag-Rajouri Lok

Sabha seat. The former chief ministers made the appeal after the EC sought a



report from Chief Secretary Atal Dulloo and the Chief Electoral Officer on representations submitted by some parties and three candidates seeking rescheduling of elections in the constituency due to adverse weather conditions, including snowfall on the Mughal road.

"I appeal to the EC that such a step should not be taken. The demand for postponement is not from all parties. The weird thing is that some of the people who have written to the EC are not contesting. If I write to the EC about constituencies in Tamil Nadu etc. will they take notice." he told a press conference in Srinagar.

Speaking to reporters in Surankote area of Poonch district, Mehbooba said, "They all have ganged up against me because they do not want to see me in Parliament. The people, cutting across religious and **Turn to page 9**



London resident arrested by **NIA** in Indian **Mission** attack case

NEW DELHI, Apr 26 (Agencies): In a major breakthrough, the National Investigation Agency (NIA) on Thursday arrested one person accused in the March 2023 case related to the violent attack on the High Commission of India in London and unlawful activities during the subsequent protests.

Inderpal Singh Gaba, a resident of the United Kingdom's Hounslow, was arrested in Delhi. He was allegedly involved in unlawful activities during the protests that took place on March 22, 2023.

"NIA investigations in the case so far have revealed that the incidents in London on March 19 and March 22 last year were parts of a larger conspiracy to unleash vicious attacks

Govt Initiates Process To Dismiss CRPF DIG Accused Of Sexual Harassment



NEW DELHI, Apr 26 (Agencies): The Union Government has initiated the process of dismissing a DIG ranked former chief sports officer of the CRPF on charges of sexual harassment levelled against him by some women working in the paramilitary force, official sources said Friday.

A notice for dismissal has been issued against Deputy Inspector General Khajan Singh after the Ministry of Home Affairs (MHA) accepted the recommendation of the Union Public Service Commission (UPSC),

they said. The final orders will be issued after taking into consideration the reply received from the accused officer within 15 days, the sources said.

Khajan Singh did not respond to PTI's query on the matter.

The notice for dismissal against the officer, currently posted in Mumbai, was was issued recently after a probe conducted by the CRPF found him "guilty" on sexual harassment

The CRPF headquarters accepted the probe report prepared by the internal committee and forwarded it to the UPSC and the MHA for taking appropriate disciplinary

action. The UPSC and the MHA have hence issued orders for dismissal against Khajan Singh, the sources said.

The officer is facing at least two such charges and the notice for dismissal has been issued in one case. The other case too is in progress, the sources said.

Khajan Singh served as the chief sports officer of the Central Reserve Police Force, the country's largest paramilitary force. He won a silver medal at the 1986 Seoul Asian Games in the 200m butterfly event which was India's first medal in swimming at the event since 1951.

He had earlier denied the allegations and said that the allegations of sexual harassment were "absolutely false" and made to "spoil his

The CRPF, which has about 3.25 lakh personnel, first inducted women in combat ranks in 1986. It has six all-female battalions at present with an overall strength of about 8,000 personnel in them.

It also has women personnel in sports and other administrative wings. (Agencies)

Is the absence of a 'big idea' hurting the BJP?

If the reports after the first phase of polling are to be believed, it boils down to one finding that Prime Minister Narendra Modi is not just an asset but sometimes a liability too.

The omissions and commissions of the Modi government are coming home to roost after ten long years, notwithstanding claims that he has turned India into a land of milk and honey.

This is not to say that the BJP is down in the dumps but that its slogan "ab ki baar, 400 paar" is just propaganda. Lal Krishna Advani, who was recently awarded the Bharat Ratna, famously said his prominent disciple is just an event manager par excellence. Nothing more, nothing less.

The failure to have a "big idea" is pulling down the BJP rhetoric. In 2014, the alleged misgovernance of UPA rule was well exploited by Mr Modi to project himself as the saviour. In 2019, the Pulwama incident and the Balakot airstrike put all other issues under the carpet for a better show by the BJP. It was shown as performance.

Now, the promise of a "Viksit Bharat" is not only proving a dud but also helping the Opposition to highlight the "failure of governance" over the past decade.

What has hit the BJP unexpectedly is the belief that "the Leader can do no wrong". The controversial Agniveer scheme is turning a section of the powerful Jats against the ruling party in Rajasthan, given that the youth from the martial community are among the largest who join the Army.

Despite the government being able to put a lid on the publication of a book by former Army Chief Gen. M.M. Naravane, which has not spoken glowingly about the controversial scheme, a section of the Jats are angry.

In western Uttar Pradesh, the BJP is facing anger among the Rajputs for not fielding anyone from the community in several seats. This was the last thing the ruling party could have bargained for given the fact that its new chief minister in the state is a Thakur and is a known poster boy of Hindutva.

Mr Modi is increasingly looking jaded. He has nothing new to say and harps constantly on the polarisation theme, feeling that it alone could deliver him a third term. As a commentator put it: the PM's recent remarks on Dr Manmohan Singh and Muslims are revealing of the BJP's "backto-basics" strategy. His biting attacks on his opponents, including Rahul Gandhi, are becoming more and more personal.

The Election Commission too has inadvertently added to the woes of the BJP. The long poll schedule was unveiled to help Mr Modi campaign at leisure in different areas, much to the discomfiture of the Opposition, but is now becoming a drag for want of issues

TMC supremo Mamata Banerjee has made "maach" a big issue in fish-loving West Bengal after Mr Modi's attack on an Opposition leader for allegedly eating non-vegetarian food on an auspicious day.

A battery of Opposition leaders, including Tejashwi Yadav and Uddhav Thackeray as well as veteran Sharad Pawar, have been their combative best and have sought to take the battle to

BJP territory.

Right or wrong, the two yatras have given Rahul Gandhi a lot of confidence and he can hardly be shaken off by the Modi diatribes. It is helping the Congress leader to realise he is on the right path and making the correct noises and that the "strong leader" is shaken. The detractors of Rahul, who dismiss him as a "Amul baby", may be in for a shock.

The AAP is shrewdly exploiting the arrest of Delhi CM Arvind Kejriwal to make the BJP nervous. With the AAP valiantly fighting the battle, it is helping the Opposition in general at a critical time. It has turned into a major issue, with some Western countries too raising questions.

Mr Kejriwal, earlier dubbed by detractors as "Chhota Modi", has turned the crisis into an opportunity by silently projecting his wife Sunita as the number two in the party and his natural heir. Even some BJP faithful feel the Delhi CM has been almost gifted a third term in office by seeking to make him a martyr. Assembly polls in Delhi are due in January 2025.

Paradoxically, the issue of dynasties is becoming a matter for the BJP to contend in states like Karnataka. In the middle of the elections, a section of leaders known as B.S. Yediyurappa's baiters are attacking the party leadership for promoting family rule by making his son state party chief.

In Maharashtra, the BJP and allies failing to resolve the vexed issue of seat-sharing despite the first poll phase being over tells its own story. The moves by Mr Modi and home minister Amit Shah to marginalise or sideline the allies during the seat allocation are leading to complica-

tions.

"Don't be under the impression that there is a wave", is the refrain of some BJP leaders from diverse states. It goes counter to the ruling party's boast "Modi hai to mumkin hain". The BJP's projections that the South is emerging as its new El Dorado must be taken with more than a pinch of salt. Pinarayi Vijayan's growing attacks on Rahul Gandhi show that the UDF could again be in a commanding position in Kerala, much to the embarrassment of the Left. The Marxist CM and Mr Modi have become strange bedfellows on the issue of Rahul bashing.

Elon Musk postponing his much-hyped meeting with the Prime Minister at the last minute speaks volumes of Mr Modi's projection as a powerful brand in the global arena suddenly being punctured amidst the elections. Mr Musk wouldn't have dared to do so if he hadn't thought of keeping away from a leader who is a lame duck till June 4. It also silently signals that the INDIA bloc is not such a dud as is being made out by Mr Modi and his bhakts,

The growing desperation of the PM indicates he fears that he could be in for "Ab ki baar, 2004", when Atal Behari Vajpayee suddenly lost power even though the BJP was proclaiming from the rooftops "Who against Atal?"

A redeeming feature for the BJP is the way the Modi-Shah duo go the extra mile when facing a crisis. It depends upon the Opposition how it would go about the advantage provided by the PM through his tirades. In the remaining rounds of voting, both sides need to devise their strategy minutely to change the game in their favour.



NEW DELHI, Apr 26 (Agencies): Prime Minister Narendra Modi on Friday took rare public swipes at a section of the media for challenging his previous remarks about predecessor Manmohan Singh advocating priority for Muslims in the national resource pie.

Referring to a new video of Singh, dated eve of the 15th General Election in April 2009, Modi said Singh is again heard reiterating his previous remarks that Muslims have the first claim on the resources of the country.

"When I exposed the Congress and discriminatory approach of the INDI bloc, some people were infuriated. Their whole ecosystem began targeting me. Today I dare them all to stop trying to scare me because for 25 years they could not scare me. These people went to the extent of spreading the lie that MM Singh never advocated that the first claim on national resources is of the Muslims.



Today one more old video of MM Singh has surfaced wherein he is heard reiterating that the first claim on national resources is that of the Muslims," Modi said.

Citing the video, Modi, in a rare public attack on mainstream media, dared it to show the evidence to the country.

"After this video's revelation, the Congress and its ecosystem is silent. The media which was calling my previous statement about the issue wrong is also silent. I watched these media people the other night. I do not wish to criticise them personally but I was watching how without fact checks they were out to gun for Modi. Today the video evidence is out. I urge the media to show this video to the country. But I know they will not do so because such is their ecosystem. They will shut this

video into a box by the evening," the Prime Minister said in West Bengal.

In an April 2009 video posted by the BJP and several handles sympathetic to the saffron forces shows Singh saying: "I said minorities, particularly Muslim minorities, if they are poor they have prior claim on resources of the country. I used the words all for all minorities and I added particularly Muslim minorities, if they are poor, they have the first priority on resources of the country. I stand by my statement."

PM Modi and the ruling BJP have whipped up a whole campaign narrative accusing the Congress-led INDI bloc of trying to "snatch the constitutionally mandated reservation rights of SCs, STs and OBCs and give these to Muslims" and of "ploys to redistribute wealth of Indian masses by launching surveys and subsequent policy action."

6 people killed as wedding pandal catches fire in Bihar's Darbhanga

The pandal caught fire during bursting of firecrackers, say eyewitnesses



DARBHANGA, Apr 26 (Agencies): Six people were killed in a massive fire that broke out at a wedding pandal in Bihar's Darbhanga district, police said on Friday.

The incident happened around 11.15 pm on Thursday in Alinagar in Bahera police station area, they said.

The pandal caught

fire during the bursting of firecrackers, eyewitnesses said.

It is suspected that a few inflammables kept inside the pandal helped the fire to spread rapidly, police said.

The deceased were identified as Sunil Paswan (26), Lila Devi (23), Kanchan Devi (26), Siddhanth Kumar (4), Shashank Kumar (3) and Sakshi Kumari (5).

Three cows were also killed in the fire, police said.

"I have ordered an inquiry to find the exact cause of the fire. In the meantime, the district administration is providing all possible assistance to the families of the victims as per disaster management guidelines," District Magistrate Rajeev Roshan told agency.

Senior Superintendent of Police Jagunath Reddy said fire tenders were sent to the spot immediately after information was received about the blaze.

"The fire was brought under control after some time. The bodies have been sent for post-mortem examinations," he said.


Policeman killed, another injured in accidental firing at former MLA's bungalow in in Chhattisgarh's Raipur

RAIPUR, Apr 26 (Agencies): A policeman was killed and another injured due to an accidental discharge of a firearm in the bungalow of a former Congress MLA in Chhattisgarh's capital Raipur on Friday, police said.

The incident occurred

"The two were shifted to a government hospital where Singh succumbed to the bullet wound. Dohare is undergoing treatment," he said.

While Singh belonged to Bijuri, Dohare hails from Bhind in Madhya Pradesh, he said.

The two were posted on security duty of

Ashish Karma, son of Devti Karma.

"Prima facie the incident seems to be a case of accidental firing. However, the investigation into it is underway", the official said.

"Your Lordship directed the Arvind Kejriwal matter to be listed in week commencing (April) 29, I suddenly find it....they (ED) have filed a reply...The case list is showing on 6th (May) now...There is urgency," senior counsel Abhishek Manu Singhvi told a Bench led by Justice Sanjiv Khanna on behalf of the Delhi Chief Minister.

While issuing notice to the ED on Kejriwal's petition challenging the Delhi High Court's verdict upholding his arrest in the case, a Bench of Justice Sanjiv Khanna and Justice Dipankar Datta had on April 15 posted the matter for further hearing in the week commencing April 29.

It had asked the ED to respond to Kejriwal's petition by April 24 and

given time till April 27 to Kejriwal to file his rejoinder the ED's reply.

Describing Delhi CM Arvind Kejriwal as "the kingpin and key conspirator of the Delhi excise scam", the ED in its reply has told the Supreme Court that his conduct in avoiding interrogation despite nine summonses led the investigating officer "to form the satisfaction" that he's guilty of money laundering.

Accusing the AAP of

being the "major beneficiary" of the proceeds of crime generated in the Delhi excise policy scam, the ED said the party had committed the offence of money laundering through its national convener Arvind Kejriwal.

"Kejriwal is the kingpin and key conspirator of the Delhi excise scam in collusion with ministers of the Delhi Government, AAP leaders and other persons," the probe agency said in its affidavit.

"Kejriwal was involved in the conspiracy of formulation of the excise policy, 2021-22, to favour certain persons and also involved in the demanding kickbacks from liquor businessmen in exchange for favours granted in the said policy," the ED said, urging the top court to dismiss Kejriwal's peti-

tion for being "devoid of merit".

"The accused, by his conduct, has himself contributed and aided the investigating officer regarding the existence of the necessity to arrest, apart from the material in possession of the IO, to form the satisfaction that the petitioner is guilty of the offence of money laundering," it said.

"Even on the date of the search during his interrogation while recording his statement under Section 17 of the PMLA, he was avoiding answering questions by being evasive and totally non-cooperative even with respect to simple non-incriminating questions," the probe agency said. The ED said AAP was the major beneficiary of the proceeds of crime generated in the Delhi liquor scam.

Seven Telangana students die by suicide after intermediate exam results

HYDERABAD, Apr 26 (Agencies): Seven students, including two girls, allegedly died by suicide hours after the Telangana state board released the results of the Intermediate Public Examination 2024 for the first (equivalent of Class 11) and second year (Class 12). Police said the deaths were reported in the last 48 hours after the results were released on Wednesday, agency reported.

Mahabubabad Super-

intendent of Police said the two girls who allegedly took their lives failed in the examination.

The cases were reported from Rajendranagar, on the outskirts of Hyderabad, Khammam, Mahabubabad, and Kollur.

According to a report in news agency, the first case was reported in Mancherial district where a 16-year-old hanged himself at his residence. The student had failed in four subjects

The students who died by suicide were aged 16 or 17 years. Police said they took their lives by hanging, jumping into a community well, or drowning in a pond.

More than 9.8 lakh students appeared for the intermediate exam that was conducted earlier this year. Around 61.06% of students (2.87 lakh) passed in the first year (equivalent of Class 11). The pass percentage was 69.46% (3.22 lakh) in the second

In 2019, 22 students died by suicide in Telangana after the intermediate results were released.

Telangana accounts for 5 per cent of student suicides in the country. The state ranked 11th among the 28 states in 2022 as per the National Crime Records Bureau. Maharashtra, Tamil Nadu, and Madhya Pradesh were the top three states with the highest number of student suicides.

PM is scared, may even shed tears on stage: Rahul Gandhi's fresh salvo at Modi

VIJAYAPUR, Apr 26 (Agencies): Congress leader Rahul Gandhi on Friday took potshots at Prime Minister Narendra Modi over his attack on the grand old party, saying he is scared and may even shed tears on the stage.

"You have heard the Prime Minister's speeches. He is scared. It's possible that he may shed tears on stage," Gandhi said, addressing a public gathering in this district headquarters town in the partygoverned state.

Modi has targeted the Congress on a variety of issues in recent campaign rallies, including "mangalsutra," "redistribution of wealth," and "inheritance tax" charges.

The former Congress chief accused Modi of 'diverting public attention' through various means.

"Modi tries to divert your attention. Sometimes he talks about China and Pakistan, and sometimes he will make you beat plates and ask you to switch on the torch light of your

He pointed out that there are three to four core issues in India, including poverty, unemployment and price rise. Gandhi claimed that

only Congress can eradicate unemployment, contain price rise and give people their due share.

"Modi has only snatched money from poor people. He has made some billionaires. There are 22 people who have wealth equivalent to the 70 crore people of the country. Just one percent of people are

controlling 40 percent of the wealth of the nation," he alleged.

Gandhi said in the present scheme of things, there is "no scope" for Dalits, OBCs, tribals, minorities and poor general category people.

"I will just tell you a clear thing in a simple one-liner. The wealth Modi has given to those billionaires, the same money we are going to give to the poor people of the country," he added.

The Congress leader also promised the youth that his party will scrap

the 'Agniveer' scheme if it is voted to power.

He dubbed the 'Agniveer' scheme in the armed forces offering three years services to the youth from 18 to 21 years old as an insult to the Army and soldiers.

"Narendra Modi snatched the Army jobs from the youth of India. He brought the Agniveer scheme, which is an insult to the Indian Army and soldiers. We will scrap it," Gandhi said.

Gandhi charged Modi with imposing a faulty GST where he introduced five different types of tax, which are hefty.

Alleging that the PM was doing injustice to Karnataka, he said the Congress will change the GST and rectify the injustice meted out to the people of the state.

According to Gandhi, the ongoing Lok Sabha election was not general in nature. "It is not an election that used to happen earlier because for the first time in the history of India, a party and a person want to destroy the Constitution and democracy."

South Africa will mark 30 years of freedom amid inequality, poverty and a tense election ahead

The country is gearing up for celebrations Saturday to mark 30 years of freedom and democracy.

JOHANNESBURG, Apr 26 (Agencies): As 72-year-old Nonki Kunene walks through the corridors of Thabisang Primary School in Soweto, South Africa, she recalls the joy she and many others felt 30 years ago when they voted for the first time.

It was at this school on April 27, 1994, that Kunene joined millions of South Africans to brave long queues and take part in the country's first democratic elections after decades of white minority rule which denied Black people the right

The country is gearing up for celebrations Saturday to mark 30 years of freedom and democracy. But much of the enthusiasm and optimism of that period has subsided as Africa's most developed economy faces a myriad of challenges.

Like many things in South Africa, the school that Kunene remembers has changed, and what used to be a school hall has now been turned into several classrooms.

"I somehow wish we could go back to that day, because of how excited I was and the things that happened thereafter," said Kunene, referring to Nelson Mandela becoming the country's first Black president and the introduction of a new constitution that afforded all South Africans equal rights, abolishing the racially discriminative system of apartheid.

For many who experienced apartheid, those years remain etched in their collective memory.

"I cannot forget how we suffered at the hands of whites. In the city at night, there were white bikers with hair like this

But 30 years later, much of that optimism has evaporated amid the country's pressing challenges. They include widening inequality as the country's Black majority continues to live in poverty with an unemployment rate of more than 32%, the highest in the world.

According to official statistics, more than 16 million South Africans rely on monthly welfare grants for survival.

Public demonstrations have become common as communitested elections in May. For the first time since the ANC

the country's most fiercely con-

came to power in 1994, polls are indicating that the party might receive less than 50% of the national vote, which would see it lose power unless it manages to form a coalition with some smaller parties.

For some younger voters like 24-year-old Donald Mkhwanazi, the nostalgia does not resonate. Mkhwanazi will be voting for the first time in the May 29 election and is now actively involved in campaigning for a new political party, Rise Mzansi, which will be contesting a national election for the first time.

"I had an opportunity to vote in 2019, and in local elections in 2021, but I did not because I was not persuaded enough by any of these old parties about why I should vote," he said.

"I didn't see the need to vote because of what has been happening over the past 30 years. We talk about freedom, but are we free from crime, are we free from poverty? What freedom is this that we are talking about?"

Political analyst Pearl Mncube said South Africans are justified in feeling failed by their leaders.

"More and more South Africans have grown skeptical of pronouncements from government due to its history of continuously announcing grand plans without prioritizing the swift execution of said plans," Mncube said.

She said while Freedom Day is meant to signify the country's transition from an oppressive past, it was important to highlight current problems and plans to overcome them.

"We cannot use the past, and any nostalgia attached to it, to avoid accounting for the present," she said.

US-China talks start with warnings about misunderstandings and miscalculations



BEIJING, Apr 26 (Agencies): The United States and China butted heads over a number of contentious bilateral, regional and global issues as U.S. Secretary of State Antony Blinken met Friday with Chinese Foreign Minister Wang Yi and both men warned of the dangers of misunderstandings

and miscalculations. The meeting, on the final day of Blinken's second visit to China in the past year, came as talks between the countries have expanded in recent months even as differences have grown and become more serious, raising concerns about the potential for conflict between the world's two largest economies.

Blinken and Wang each underscored the importance of keeping lines of communication open but they also lamented persistent and deepening divisions that threaten global security. Those divisions were highlighted earlier this week when U.S. President Joe Biden signed a massive foreign aid bill that contains several elements that the Chinese see as prob-

"Overall, the China-U.S. relationship is beginning to stabilize," Wang told Blinken. "But at the same time. the negative factors in the relationship are still increasing and building and the relationship is facing all kinds of disruptions."

"Should China and the United States keep to the right direction of moving forward with stability or return to a downward spiral?" he asked. "This is a major question before our two countries and tests our sincerity and ability."

Wang also outlined, without being specific, well-known Chinese complaints about U.S. policies and positions on the South China Sea, Taiwan, human rights and China's right to conduct relations with countries it deems

"China's legitimate development rights have been unreasonably suppressed and our core interests are facing challenges," he said, demanding the U.S. refrain from interfering in China's internal affairs.

Blinken responded by saying that the Biden administration places a premium on U.S.-China dialogue even on issues of dispute. He noted there had been some progress in the past year but suggested that talks would continue to be difficult. "I look forward to

these discussions being very clear, very direct about the areas where we have differences and where the United States stands, and I have no doubt vou will do the same on behalf of China," Blinken told Wang.

"There is no substitute in our judgement for face-to-face diplomacy in order to try to move forward, but also to make sure we're as clear as possible about the areas where we have differences at the very least to avoid misunderstandings, to avoid miscalculations, he said.

Blinken arrived in China on Wednesday, visiting Shanghai shortly before Biden signed the \$95 billion foreign aid package that has several elements likely to anger Beijing, including \$8 billion to counter China's growing aggressiveness toward Taiwan and in the South China Sea. It also seeks to force TikTok's Chinabased parent company to sell the social media platform.

China and the United States are the major players in the Indo-Pacific. Washington has become increasingly alarmed by Beijing's growing aggressiveness in recent years toward Taiwan and its smaller Southeast Asian neighbors with which it has significant territorial and maritime disputes in the South China Sea.

China has railed against U.S. assistance to Taiwan and immediately condemned the aid as a dangerous provocation. It also strongly opposes efforts to force TikTok's sale.

The bill also allots \$61 billion for Ukraine to defend itself from Russia's invasion. The Biden administration has complained loudly that Chinese support for Russia's militaryindustrial sector has allowed Moscow to subvert western sanctions and ramp up attacks on Ukraine.

U.S. officials have said China's ties with Russia would be a primary topic of conversation during Blinken's visit, and just before Friday's meetings began, Russian President Vladimir Putin announced he would visit China in May.

Elon Musk's X Says Australia Bishop Stabbing **Posts Don't Promote Violence**

SYDNEY, Apr 26 (Agencies): Elon Musk's social media platform X defended publishing posts showing a bishop in Australia being stabbed during a sermon as "part of public discussion", rejecting a regulator's order to take down the content on grounds it is offensive and violent.

In a post overnight, X's "global government affairs" account said the video taken by an "innocent bystander" should not have been banned under Australian law. which "permits content that can be reasonably considered as part of public discussion or

"The content within the posts does not encourage or provoke violence," the X account

The statement from the company formerly called Twitter, which the billionaire bought in 2022, clashes with Australian lawmaker claims that police feared the footage would be used to encourage people to join terrorist groups.

The e-Safety Commissioner ordered X to remove posts containing the video globally to stop Australians seeing them, but X has challenged the

order partly on grounds of "exhorbitant jurisdiction". A court this week temporarily upheld the takedown order until a hearing on May 10.

The order has sparked increasingly heated public exchanges between Musk, who calls himself a free speech absolutist, and Australian officials including the prime minister and one senator who Musk said should be jailed.

Overnight, Musk shared a series of posts by another user which described the takedown order as part of a World Economic Forum "plot



to impose eSafety rules on the world". "Accurate thread," Musk wrote to his 181 million followers. The e-Safety Commis-

sioner was not immediately available for comment.

The dispute follows an April 15 attack on an Assyrian bishop in Sydney, for which a

16-year-old boy has been charged with terrorist offences, according to the authorities.

After raids related to the incident this week. police charged five associates of the youth, also teenagers, with terrorism offences including possessing extremist material.

"He Helped Save Lives": Australia Mourns Pak Guard Killed In Sydney Attack

SYDNEY, Apr 26 (Agencies): Australian Prime Minister Anthony Albanese hailed as a hero Pakistani security guard Faraz Tahir, killed in Sydney while trying to stop a mass stabbing attack, in remarks delivered on Friday at a funeral attended by hundreds

Tahir, who would have turned 31 on Wednesday, was on the first day of his job when he became one of six killed this month during the stabbing spree at a busy mall in beachside Bondi.

"Running toward danger, to protect people he had never even met, without



doubt, he helped save lives that day," Albanese said. "Without question, Faraz Tahir died a hero." The ceremony was

held before a crowd gathered outside the city's Baitul Huda mosque, under a banner that read "Love for all -

hatred for none". Tahir arrived in Australia as a refugee from Pakistan, according to the Ahmadiyya Muslim community of Australia, to which he belonged.

Fellow security guard Muhammad Taha, injured while trying to stop the attacker, attended in a wheelchair after being released from hospital for the ceremony. He was the last to speak with Tahir as they ran towards the scene of the attack.

"We were trying to save people at that time and his last words were 'Let's find out what's going on,' so we rushed towards that area," he said in comments

reported by the Guardian newspaper. Tahir's brother,

Mudasar Bashir, told reporters the two had spoken the evening before and promised to call the next day. They never spoke again. "Even until now, we

couldn't believe that he's no more," he said at the funeral. "We are very proud of him because ... Islam, our religion, says that if you save even one human, you save all of humanity.'

Joel Cauchi, a 40-yearold who suffered mental health issues, killed five women and Tahir in the mall on April 13 before being shot dead by police.

Japanese Town To Block Mount Fuji View Because Of **Misbehaving Tourists**

TOKYO, Apr 26 (Agencies): A huge black barrier to block Mount Fuji from view will be installed in a popular photo spot by Japanese authorities exasperated by crowds of badly behaved foreign tourists.

Construction of the mesh net -- 2.5 metres (8 feet) high and the length of a cricket pitch at 20 metres -- will begin as early as next week, an official from Fujikawaguchiko town said Friday.

"It's regrettable we have to do this, because of some tourists who can't respect rules," leaving litter behind and ignoring traffic regulations, he told agency.

It is the latest direct action in Japan against overtourism after residents of Kyoto's geisha district banned visitors from small private alleys this year. Record numbers of

overseas tourists are travelling to the country, where monthly visitors exceeded three million in March for the first time

Mount Fuji, Japan's

highest mountain, can be photographed from many spots in the resort town of Fujikawaguchiko.

But this viewpoint is particularly popular because the majestic volcano appears behind a Lawson convenience store, which are ubiquitous in Japan.

Due to this visual juxtaposition, "a reputation has spread on social media that this spot is very Japanese, making it a popular photo location," said the town official who declined to be named.

The mostly non-Japanese tourists are overcrowding a stretch of pavement next to the Lawson shop, he said.

After traffic signs and repeated warnings from security guards fell on deaf ears, the town in Yamanashi region decided on the huge screen as a last resort.

The measure is also meant to protect a nearby dental clinic against the onslaught of tourists.

They sometimes park there without permission and have even been seen climbing on the roof of the clinic to get the perfect shot, the official said.

The town wishes it hadn't come down to this, he said, adding that the current plan is for the screen to be maintained until the situation improves.

Tourism to Japan has been booming since pandemic-era border restrictions were lifted, and the government has been working hard to boost visitor numbers. But this has not been

universally welcomed -including in Kyoto where locals have complained of snap-happy tourists harassing the city's immaculately dressed geisha.

And this summer, hikers using the most popular route to climb Mount Fuji will be charged \$13 each, with numbers capped to ease congestion.

Other top destinations worldwide are also struggling with visitor numbers, and on Thursday Venice began charging day-trippers for entry to tackle mass tourism.

Signs of multiple sclerosis show up in blood years before symptoms

NEW DELHI, Apr 26 (Agencies): In a discovery that could hasten treatment for patients with multiple sclerosis (MS), UC San Francisco scientists have discovered a harbinger in the blood of some people who later went on to develop the disease.

In about 1 in 10 cases of MS, the body begins producing a distinctive set of antibodies against its own proteins years before symptoms emerge. These autoantibodies appear to bind to both human cells and common pathogens, possibly explaining the immune attacks on the brain and spinal cord that are the hallmark of MS.

The findings were published in Nature Medicine on April 19.

MS can lead to a devastating loss of motor control, although new treatments can slow the progress of the disease and, for example, preserve a patient's ability to walk. The scientists hope the autoantibodies they have discovered will one day be detected with a simple blood test, giving patients a head start on receiving treatment.

"Over the last few decades, there's been a move in the field to treat MS earlier and more aggressively with newer, more potent therapies," said UCSF neurologist Michael Wilson, MD, a senior author of the paper. "A diagnostic result like this makes such early intervention more likely, giving patients hope for a better

Autoimmune diseases like MS are believed to result, in part, from rare immune reactions to common infections.

In 2014, Wilson joined forces with Joe DeRisi, PhD, president of the Chan Zuckerberg Biohub SF and a senior author of the paper, to develop better tools for unmasking the culprits behind autoimmune disease. They took a technique in which viruses are engineered to display bits of proteins like flags on their surface, called phage display immunoprecipitation sequencing (PhIP-Seq), and further optimized it to screen human blood for autoantibodies.

PhIP-Seq detects autoantibodies against more than 10,000 human proteins, enough to investigate nearly any autoimmune disease. In 2019, they successfully used it to discover a rare autoimmune disease that seemed to arise from testicular cancer.

MS affects more than 900,000 people in the US. Its early symptoms, like dizziness, spasms, and fatigue, can resemble other conditions, and diagnosis requires careful analysis of brain MRI scans.

The phage display system, the scientists reasoned, could reveal the autoantibodies behind the immune attacks of MS and create new opportunities to understand and treat the disease.

The project was spearheaded by first coauthors Colin Zamecnik, PhD, a postdoctoral researcher in DeRisi's and Wilson's labs; and Gavin Sowa, MD, MS, former UCSF medical student and now internal medicine resident at Northwestern University.

They partnered with Mitch Wallin, MD, MPH, from the University of Maryland and a senior author of the paper, to search for autoantibodies in the blood of people with MS. These samples were obtained from the U.S. Department of Defense Serum Repository, which stores blood taken from armed service members when they apply to join the military.

The group analyzed blood from 250 MS patients collected after their diagnosis, plus samples taken five or more years earlier when they joined the military. The researchers also looked at comparable blood samples from 250 healthy veterans. Between the large

timing of the samples, it was "a phenomenal cohort of individuals to look at to see how this kind of autoimmunity develops over the course of clinical onset of this disease," said Zamecnik. Using a mere onethousandth of a millili-

ter of blood from each

time point, the scientists

thought they would see

the before-and-after

a jump in autoantibodies as the first symptoms of MS appeared. Instead, they found that 10% of the MS patients had a striking abundance of autoantibodies years

before their diagnosis.

The dozen or so autoantibodies all stuck to a chemical pattern that resembled one found in common viruses, including Epstein-Barr Virus (EBV), which infects more than 85% of all people, yet has been flagged in previous studies as a contributing cause for MS.

Years before diagnosis, this subset of MS patients had other signs of an immune war in the brain. Ahmed Abdelhak, MD, co-author of the paper and a postdoctoral researcher in the UCSF laboratory of Ari Green, MD, found that patients with these autoantibodies had elevated levels of neurofilament light (Nfl), a protein that gets released as neurons break down.

Perhaps, the researchers speculated, the immune system was mistaking friendly human proteins for some viral foe, leading to a lifetime

"When we analyze healthy people using our technology, everybody looks unique, with their own fingerprint of immunological experience, like a snowflake." DeRisi said. "It's when the immunological signature of a person looks like someone else, and they stop looking like snowflakes that we begin to suspect something is wrong, and that's what we found in these MS patients."

Payment frauds rise by 70.64% to Rs 2,604 crore in October-March period

NEW DELHI, Apr 26 (Agencies): Payment frauds are rising sharply if the data from the Reserve Bank of India is any indication. Domestic payment frauds jumped by 70.64 per cent to Rs 2,604 crore during the sixmonth period ended March 2024 from Rs 1,526 crore in the same period of last year.

The volume of frauds also rose to 15.51 lakh during the March 2024 period from 11.5 lakh in the previous six-month period, RBI data shows.

While the RBI has considered only domestic financial transactions, the new format captures e-commerce transactions transactions using FASTags, digital bill payments and card-tocard transfer through ATMs, etc. However, failed transactions, chargebacks, reversals, expired cards/ wallets, are excluded. Data on domestic payment fraud statistics is as reported by scheduled commercial banks (excluding RRBs), non-bank PPI issuers and non-bank credit card issuers in CPFIR (Central Payments Fraud Information Registry), it said.

There were 2.57 lakh payment



frauds involving Rs 471 crore in March alone and 2.53 lakh frauds for Rs 503 crore in February.

Frauds lead to reputational, operational and business risk for banks and undermine customers' trust in the banking system with financial stability implications. Despite tough regulations

and improved technology, scamsters were finding new routes to game the system.

A recent RBI report said new technologies enhance the efficiency and effectiveness of banking operations. "With this, however, the risks of fraud and data breaches have also increased. Concerted efforts by all stakeholders including regulators, banks and customers are required to protect the system from these threats. On its part, the Reserve Bank has been striving to update the regulations to protect customers while ensuring that innovations are not stifled," it said.

On December 27, 2023, the RBI said banks have witnessed a sudden spurt in frauds in the credit & debit cards and internet segment. The average amount of involved in frauds declined by 85 per cent during the April-September of 2023-24 with the number of frauds rising sharply by 624 per cent in the card and internet segment based on the date of reporting, it said.

The number of frauds in the card and internet jumped to 12,069 cases involving Rs 630

crore during April-September of 2023-24 as against 2,321 cases for just Rs 87 crore in the same period of last year, according to the RBI. Overall, banks reported 14,483 fraud cases involving Rs 2,642 crore during April-September of 2023-24 as against 5,396 cases involving Rs 17,685 crore frauds in the same period a year ago.

According to RBI data, banks and NBFCs added 1.65 crore credit card users during FY24, taking the total number of card users to 10.18 crore. The value of credit card transactions was at a record level of Rs 164,223 crore during the month of March 2024 as against Rs 149,206 crore in February. Of this, point-of-sale transactions were Rs 60.378 crore in March 2024.

"With credit card usage rising sharply, banks were in a hot race to add new users. "They were offering attractive reward points, EMI facility and even offer personal loans on the basis of their credit cards. Card users are offered personal loans based on their credit rating score," said an official of a nationalised bank.

Target is to achieve \$1 trillion goods exports by 2030: Trade Ministry



NEW DELHI, Apr 26 (Agencies): The commerce Ministry has initiated an exercise to identify required infrastructure needs, potential sectors, and clusters which would help the country achieve the \$1 trillion merchandise exports target by 2030 but sustainability will be a major concern going forward, senior government officials said on Thursday.

This comes a day after the European Parliament voted on Wednesday for a new law that will require larger companies operating in the bloc to check if their supply chains use forced labour or cause environmental damage and act to take action if they do. EU lawmakers backed the Corporate Sustainability Due Diligence Directive (CSDDD) by 374 votes to 235 against, with 19 abstentions, Reuters

reported.
Prior to CSDDD, the European Union enforced the carbon border adjustment mechanism (CBAM), another environment related law that penalises products with high carbon footprints coming into the

27-member bloc. Notably, more than a fourth of India's exports of iron, steel and aluminium were to the EU and as per industry estimates, the EU tariffs could raise the costs of Indian exports by 20 to 35 per cent.

"In most major economies, sustainability issues will be a major concern. So how do we reduce our carbon footprint and how do we gear up our entire infrastructure to sustainably move goods and packaging is something that our business and trade needs to work on," Santosh Sarangi, Director General. Directorate General of Foreign Trade, said at the CII conference on logistics.

"The Asian Development Bank (ADB) is doing a study for us because what is more important is from where the \$1 trillion of exports is going to come from. That is very critical for us. Because unless we know about the clusters, and ports or airports from where this \$1 trillion of exports and \$1.5 trillion of imports is going to happen, we would not be able to do a baseline study to identify the gaps which exist and then enhance our infrastructure capabilities," Additional Secretary in commerce and industry ministry Anant Swarup said.

Sarangi said that the government is also focusing on ways to push India's integration into the GVCs as at present about 70 per cent of the global trade is happening through these chains. He further said that an infrastructure push is required at ports and airports to increase India's exports and to handle \$2.5 trillion of exports and imports, India needs to create a lot of infrastructure.

"As per rough calculations, we need to create an infrastructure which will support an additional 2,000 million tonnes of goods movement in the ports. Similarly in the railways, we need to create an infrastructure which will allow railways to carry on an additional 338 million tonnes of goods by 2030. Airports also need to create an additional 5 million tonnes of facilities for movement of goods. So these are big challenges but not insurmountable challenges," Sarangi added.

Above-normal monsoon rains to further ease food prices: Finance Ministry report

NEW DELHI, Apr 26 (Agencies): Further easing of food prices is "on the anvil" as India Meteorological Department (IMD) has predicted above-normal rainfall during the monsoon season, the Ministry of Finance said in its latest monthly economic review for March released Thursday.

This comes even as high food inflation remains a challenge in several major economies across the world and the Reserve Bank of India (RBI) sees food price uncertainties weighing on the inflation outlook, it noted.

"In India, food inflation declined from 8.7 per cent in February to 8.5 per cent in March. Food inflation is caused by certain specific food items like vegetables and pulses. Food prices have been a key challenge for the governments...further easing of food prices is on the anvil as IMD has predicted above-normal rainfall during the monsoon season, which is likely to lead to higher production, assuming good spatial and temporal distribution of the rain-

fall," it said.

The Ministry said retail inflation in FY24 witnessed a significant decline, reaching its lowest level since the Covid-19 pandemic, with core inflation dropping to 3.3 per cent in March 2024. The RBI in its latest 'State of the Economy' article in the March bulletin released Tuesday had said that food infla-



tion, despite some signs of moderation, remains elevated and a potential source of risk to the disinflation trajectory. Also, adverse weather conditions and extended geopolitical conflicts can result in volatility in crude oil prices and may pose a threat to inflation in the

near term, the RBI said. On the growth front, the Ministry said India continues to exhibit robust economic performance with factors such as strong domestic demand, rural demand pickup, robust investment, and sustained manufacturing momentum having contributed to India's resilience. Globally, there are fading fears of recession and rebounding growth in major economies, while some areas are experiencing subdued economic activity. Geopolitical tensions remain a concern but risk perceptions have softened,

the Ministry said.
"Overall, resilient growth, robust economic activity indicators, price

stability, and steady external sector performance continue to support India's promising economic performance amidst uncertain global conditions," it said.

Global slowdown and ongoing geopolitical tensions resulted in contraction of India's merchandise exports for four subsequent quarters, it said, adding that the slowing of trade has resulted in the merchandise trade deficit narrowing in FY24, as exports have shown a smaller contraction than imports. "However, there is evidence of a trend reversal in Q3 of FY24, with merchandise exports registering growth," it

said.

Merchandise exports in FY24 have been largely driven by rising exports of electronic goods and engineering goods, while exports of gems & jewellery and organic & inorganic chemicals have dragged the overall export growth down, the ministry said. Electronic goods have emerged

as a standout sector in the country's export basket amid a slowdown in global trade, with its exports accounting for 6.7 per cent of India's total exports in FY24, it said.

However, the non-petroleum and non-gems & jewellery merchandise exports have shown resilience with a sustained uptick in the last few months, it added. On the import side, apart from oil, non-oil-non-gold imports have been weak, with capital goods, chemicals and coal imports having led the way. Gold and electronic imports picked up pace, it said.

Services exports rose by 5.2 per cent in Q3 FY24, compared to a growth of 4.2 per cent in the previous quarter. "Structural change in the composition of services exports has given a fillip to the external sector, with software exports growing and non-software exports led by business services also rising at the same time," it said.

Without the burden of expectations, India went on to dismantle the world's best teams to script an unprecedented chapter in the history of the sport, and now they return to the 33rd edition with the arduous task of once again showing their might against the top echelons of the sport.

However, the underdog tag won't be there this time. In fact, all the teams will be gunning for the defending champions, who have retained the core of the 2022 side which had made history in Bangkok.

India will count on the experience of last edition as they have been put in the 'Group of Death', featuring multiple-time winners Indonesia, Thailand and England in Group C.

Indian men will begin their campaign against Thailand, who boost of reigning world champion Kunlavut Vitidsarn and young Panitchaphon Teeraratsakul.

But the most formidable will be third-seeded Indonesia, who have the likes of Jonatan Christie and Anthony Ginting—



the two played the finals of All England in March—and world number seven pair of Muhammad Rian Ardianto and Fajar Alfian.

"It will be tough this year. Based on current form, there are lots of teams with three strong singles and two doubles (players) like China, Denmark, Chinese Taipei, Japan, and Indonesia," HS Prannoy said.

A lot can happen in two years' time and none of the Indian players coming to China this week are the same.

Prannoy, who had delivered the goods under pressure in the deciding fifth singles, is coming into the tournament after struggling in the first half of the season, owing to a chronic stomach disorder which returned after troubling him in the past.

However, his 90-minute marathon battle en route to a morale-boosting win over China's Lu Guang Zu showed he is close to recovery and will carry the onus of giving the team a good start as he is the top-ranked singles player at world number nine now.

Lakshya Sen has found his

mojo just in time with successive semifinal finishes at the French Open and the All England

Championships after enduring

a difficult 2023 and early 2024. Kidambi Srikanth, who had won all six matches in 2022, has blown hot and cold in the last two years. He also endured tough losses in the team championships final at the 2022 Commonwealth Games and 2023 Asian Games.

Another player who could be entrusted with the third singles is young Priyanshu Rajawat, who was part the team which won the epic title in Bangkok, and since then has gone on to claim his maiden Super 300 title last year in Orleans.

While the rest had an inconsistent run, Satwiksairaj Rankireddy and Chirag Shetty have looked unstoppable and are coming into the prestigious event with four straight finals on the World Tour. The duo will be the spearhead of India's campaign.

Dhruv Kapila and Arjun MR, who will play the second doubles, have weaved a few title wins at the Uganda International Challenge and Orlen Polish Open, besides signing off with

a quarterfinal finish at the Spain Masters in March.

"As a team we have evolved in the last 2-3 years. Everybody has been able to keep aside their individual problems for a one-week time and has been able to push through emotional challenges in a much better way during the team events," Prannoy said.

It is likely that Prannoy and Srikanth could be rotated during the event, putting the onus more on Sen and Rajawat to deliver. There is also Kiran George, who has been in decent touch.

In Uber Cup, Ashmita Chaliha will lead a young Indian team with all the big guns skipping the tournament after competing in a series of tournaments to qualify for the Paris Olympics.

The greenhorns will look to test their mental and physical fortitude against the top international players when they open their campaign against Canada in Group A.

Top seeds and multiple-time winners China and Singapore are also in their group, making it improbable for the young women's team to go past the group stage.

Besides Ashmita, national champion Anmol Kharb, who was the star performer for India en route their maiden Asia Team Championships title, will also look to test their wares as will Isharani Baruah and 15-year-old Tanvi Sharma.

India, who have reached the semifinals of the Uber Cup thrice in 1957, 2014 and 2016, will also be served by the doubles pair of Shruti Mishra and Priya Konjengbam, and Simran Singhi and Ritika Thaker.

Jyothi Surekha Vennam, Abhishek Verma enter compound mixed team final; archers eye four gold medals in World Cup



SHANGHAI, Apr 26 (Agencies): The compound mixed team of Jyothi Surekha Vennam and Abhishek Verma assured India of a fourth medal in the ongoing Archery World Cup, advancing into the final here on Friday.

The world number two Indians dropped just five points to prevail over their Mexican opponents Andrea Becerra and Lot Maximo Mendez Ortiz 155-151 in the semi-final.

They will face lowerranked Estonia in the gold-medal clash on Saturday. Jyothi is also a member of the women's compound team, which had entered the final on Wednesday.

With Jyothi also securing a semifinal spot in the individual section on Thursday, the World number three and Asian Games gold medallist is in the hunt for a hat-trick of top podium finishes.

Overall, Indian archers have qualified in four finals, all in the team events, and are in the hunt for two medals in compound individual events—where Jyothi and Priyansh have made the semifinals.

The four events where Indian teams have made the gold-medal round are compound men's, women's, mixed categories and men's recurve.

The elimination round in the recurve individual category is slated to begin later in the day.

Having got an opening round bye, the second-seeded Indian pair of Jyothi and Verma started off by producing a flawless 160 out of 160 to knock out the lower-ranked Australian pair of Geogina Graham and Brandon Hawes by eight points.

Next up, 10th ranked Luxembourg's Mariya Shkolna and Gilles Seywert were also no match for the Indian pair, which dropped just five points from 16 arrows to storm into the semi-finals with a 155-151 win.

In the semi-final, the Indians started on a back-foot after Andrea and Mendez Ortiz capped three 10s and one nine to take the opening end 39-38.

But the Mexicans slipped in the next set of arrows as Jyothi and Verma snatched the lead by dropping one point.

The Indians then extended their lead by three points in the penultimate round after another slip-up by the Mexicans.

Jyothi and Verma sealed the issue with a perfect 40 in the fourth end.

Rafael Nadal cruises to straight-set win over American teenager in first round of Madrid Open

MADRID, Apr 26 (Agencies): Rafael Nadal couldn't learn much from his comfortable straight-set win over American teenager Darwin Blanch in the first round of the Madrid Open.

Nadal cruised to a 6-1, 6-0 victory over the mistake-prone 16-year-old Blanch on Thursday.

"I didn't test much my body today," the 37-year-old Nadal said. "I played a decent match doing the things that I had to do to be through, but at the same time I played against a player ... making more mistakes."

Blanch, playing only in his second ATP tour match, made 27 unforced errors. Nadal never faced a break point and was in control from the start against the wild-card entry, closing the match in just over one hour at the Caja Magica center court in the Spanish capital.

"I think today I played against an opponent with a great future," Nadal said. "But today, still making mistakes. I just tried to be there, be solid all the time without taking a lot of risks. It worked well. I'm happy to be through and I wish him all the very best for the future."

The encounter marked the largest age gap (21 years, 117 days) between two opponents at an ATP 1000 tournament.

Nadal looked in good form and showed no physical limitations in just his third competi-



tive match since returning from his latest injury layoff. He had made his return in Barcelona last week, losing in the second round to Alex De Minaur, who will also be his second-round opponent in Madrid on Saturday.

"I hope I can give my best and be competitive against De Minaur," Nadal said. "Every time I have the chance to be on court in this amazing stadium with an unconditional supportive crowd, it means a lot to me. Just trying to enjoy every moment. Tomorrow, one more day of practice here and then after tomorrow, on court again. That makes me feel great."

Nadal had arrived in Madrid saying he was not 100% fit, and that he was only going to play because the clay-court tournament was at home.

On Wednesday, the record five-time champion in Madrid said that in his current condition he would not play if this was the French Open, a tournament he has won

a record 14 times.

The Spaniard is trying to get back in shape for the tournament in Paris for what will likely be his last Roland Garros appearance. The French Open begins next month.

A 22-time Grand Slam champion, Nadal had hip surgery last summer and said 2024 would probably be his last year on tour. He had skipped Monte Carlo, and his last tournament had been in Brisbane in January, when he played three matches.

"The thing is before, most of the time, I was able to give my 100 per cent," Nadal said. "Today I'm able to give my sometimes 40 per cent, sometimes 60 per cent, sometimes 70 per cent, and if I am able to raise this percentage day after day or week after week, why not in the future what can happen? If not, it's

beat Richard Gasquet 6-2, 7-5 to set up a meeting against fellow Italian Jannik Sinner, the top seed in Madrid. Gasquet was playing in his 1,000th tour-level match.

Brazilian qualifier Thiago Monteiro will face Stefanos Tsitsipas after defeating Dusan Lajovic 6-4, 6-3, while fellow Brazilian João Fonseca rallied to beat American Alex Michelsen 4-6, 6-0, 6-2

Swiatek and Gauff advance

Top-ranked Iga Swiatek began her quest to win the Madrid Open for the first time with a comfortable 6-1, 6-4 win over Wang Xiyu to set up a third-round meeting against 27th-seeded Sorana Cirstea.

Madrid remains the only top European clay title that Swiatek is yet to win.

"I love this place. I got to know the city a little better last year," Swiatek said. "So this time I feel more comfortable around." American Coco Gauff eased to a 6-0, 6-0 win over Arantxa Rus in less than an hour for her first tourlevel, main-draw win without losing a game.

"Oh-and-oh, I've never done that before, I'll probably never do it again," Gauff said.

Former No. 1 Naomi Osaka lost 6-2, 4-6, 7-5 to 15th-seeded Liudmila Samsonova.

Osaka, who returned from maternity leave in January, had earned her first win on clay in two years on Wednesday.
