#### **Earthquake** of Magnitude 4.3 Hits Jolts Ladakh's Kargil

KARGIL, May 10 (Agencies): An earthquake of magnitude 4.3 on the Richter Scale hit Kargil, Ladakh on Friday, according to the National Center for Seismology (NCS). No injuries were reported.

#### Two soldiers injured after vehicle skids off road in Rajouri

RAJOURI, May 10 (Agencies): Two soldiers were injured after their vehicle skidded off the road in Rajouri district on Friday, officials

Official sources told news agency Kashmir Scroll that today an army vehicles met with an accident near sub grid station Dhanma PP Chingus PS Rajouri on NH 144A wherein one vehicle carryıng can teen supplies skidded off the road.

They said that two individuals, one critical were injured in the accident and have been taken hospital for treatment.

#### Dumper Driver **Electrocuted** in Kulgam Village

SRINAGAR, May 10 (Agencies): Tragedy struck the Kounserbal area of Damhal Hanjipora in South Kashmir's Kulgam district on Friday when a dumper driver suffered a fatal electric shock while unloading sand.

The victim, identified as Showkat Ahmad Parray, son of Abdul Hameed Parray from Yadder Pulwama, tragically lost his life on the

spot. Local residents have pointed fingers at the **Power Development** Department (PDD), alleging negligence. They claim that transmission lines, left dangerously low, pose a grave threat to lives in

the area. Police have initiated an investigation into the incident, while locals appeal to higher authorities to address the issue promptly to prevent similar tragedies in the future.

## **Covishield Side Effects: Doctors' Group urges Govt to review all Covid Vaccines**

SRINAGAR, May 10 (Agencies): In the wake of pharmaceutical giant AstraZeneca admitting in a UK court that its Covid vaccine can cause blood clots in rare cases, a group of doctors on Thursday expressed deep concern over the safety of the Covishield vaccine manufactured by the Serum Institute of India.

At a press conference, the doctors, under the banner of the Awaken India Movement (AIM), urged the government to review the science behind all Covid vaccines and audit their commercialisation as well as implementation of active surveillance and monitoring mechanism to ensure vaccine



adverse events are identified as early as possible.

"The government has wholly ignored the rising number of cases of tragic deaths post-Covid vaccination all the while and continues to promote Covid vaccines as 'safe and effective', without scientific investigation and invoking epidemiology," Dr Tarun

Kothari, a radiologist and an activist, said at the press conference.

The world is learning about a side effect of the Covid vaccine called Thrombosis with Thrombocytopenia Syndrome (TTS), he said.

When the COVID-19 vaccines were being administered, not many people were aware that it was being done without the completion of phase-3 trials. Administration of COVID-19 vaccines was started without the manufacturers having complete information and data on the possible short-term or long-term side effects, or fatalities, said Dr Sujata Mittal, a gynaecologist and oncologist.

There is an already low awareness around vaccine injuries, especially in India, she said.

Thousands of women reported abnormalities in their menstrual cycles, which was confirmed much later as a side effect of the vaccine in a study published in September 2022, she added.

#### Relief for Arvind Kejriwal, Supreme Court grants interim bail till June 1



NEW DELHI, May 10 (Agencies): In a major relief to Delhi Chief Minister Arvind Kejriwal, the Supreme Court on Friday granted him interim bail till June 1 to campaign in the ongoing Lok Sabha elections.

A bench of Justices Sanjiv Khanna and Dipankar Datta said Kejriwal, arrested in a money laundering case linked to the alleged

excise policy scam, will have to surrender and go back to jail on June 2. The bench refused the request of senior advo-

cate Abhishek Singhvi,

appearing for Kejriwal,

that the interim bail be granted till June 5. June 1 is the last day of the seven-phase elections. The votes will be

counted on June 4. The court said reasons for granting Kejriwal interim bail will follow. Solicitor General Tushar Mehta and Additional Solicitor General S V Raju, appearing for the Enforcement Directorate, opposed the granting of interim bail to the Aam Aadmi Party (AAP) chief on grounds of poll campaigning saying no such precedents are available.

Observing that granting Kejriwal interim bail for 21 days will not make much of a difference, the bench said the ED's **Enforcement Case Infor**mation Report (ECIR) was registered in August 2022 while the chief minister was arrested on March 21 this year.

#### **IGP Kashmir ensures full proof security** arrangements for elections



SRINAGAR, MAY 10: Inspector General of Kashmir VK Bhirdi on Friday said that elaborate security arrangements for Kashmir polls as inter-district checkpoints and area domination has been taken care of. Talking to a selected group of reporters in his office chambers,

the IGP, as per news agency—Kashmir News Observer (KNO), said that all arrangements have been finalized to ensure smooth polling and huge participation of voters. "Whatever mandatory security arrangements were needed, they have been taken care of," he said.

The IGP said that police along with the Central forces have upgraded the inter-district check points and area domination has been given a further push. "We will ensure a peaceful atmosphere during all three phases of elections in Kashmir," he said.

He said security deployment has been made as per the prescribed format of Election Commission of India (ECI). "We are following ECI guidelines and ensuing that security arrangements are fullproof," he said.

A meteorological department official here said that while generally dry weather is expected in the next 24 hours, there is possibility of "isolated light rain" in J&K.


"Partly to generally cloudy weather with light rain/snow (higher reaches) is expected at many places with thunder/ lightning/gusty winds at few places on May 11," he said.

## Lok Sabha Polls will convey J&K People's expression to rest of India: Aga Syed Ruhullah Mehdi

GANDERBAL, May 10 Conference candidate from the Srinagar parliamentary constituency, Aga Syed Ruhul lah Mehdi, has said he will not participate in the assembly polls in Jammu and Kashmir as the institution of the state assembly has been "undemocratically degraded" after the abrogation of Article 370.

Mehdi, an influential Shia leader, said the parliamentary elections are important means to convey the expression of the J-K people about Article 370 to the rest of the country.

"I do not accept the status of the state assembly which it has been degraded to. I consider it an undemocratically degraded institution which we can at the best call a glorified municipality," Mehdi told PTI in a freewheeling interview on his campaign trail in this central Kashmir district, which is a part of the Srinagar Lok Sabha constituency

The Srinagar constituency has been represented by three generations of the Abdullahs. Mehdi said by participating in the assembly elections and being part of "that degraded assembly", he would be "legitimising" that status.

"That is something I do not want to do. As an individual, I do not want to give that legitimacy to the assembly and the status quo. Therefore, I am clear I am not participating in any assembly elections," he

Mehdi, a former three-time MLA of central Kashmir's Budgam assembly segment, said he was not fighting elections for power or opportuni-

"Assembly elections for me are an easier and comfortable option and that gives more opportunities to me to be in the power corridors. But accepting that assembly and being part of it would amount to legitimising that degraded assembly. I do not want to be a part of that," he said

Referring to the abrogation of Article 370 on August 5, 2019, Mehdi said the parliamentary polls give him an opportunity to create a political space, to resonate "this sentiment" and take this expression to the institution (Parliament) where these decisions were

"Parliament should know that the decisions that it took were completely undemocratic and the people of J-K had no participation and no role to play in that decision-making. This is the institution where we need to take that sentiment, expres-

sion and opinion. Through that I intend to take this expression to the rest of India.

"So, this is completely a different thing from the assembly and I am sure that I am not going to participate in the assembly elections for these reasons," he added

The former minister said the Lok Sabha elections are important because they are happening for the first time after the decisions that were taken on in 2019

"The constitutional status that J-K enjoyed was taken unconstitutionally and undemocratically. The status of J-K was degraded and the rights and guarantees that were assured to us when we had acceded to the Union of India were snatched from us unilaterally and without the wish and

will of the people.
"This abrogation happened while the entire population was put into an open-air prison," he

The government had imposed a strict lockdown on August 5, 2019, restricting the movement of the people and snapping telephone service, including landline and internet services across J-K. Several mainstream leaders had been detained or were put under

elections provide an opportunity to express not only to Parliament of India but also to the rest of the nation "that we do not subscribe to the status to which we have been degraded"

We do not accept the decisions that were taken against us on August 5, 2019 and this status of being second-class citizens is not the reason that we had acceded to the Union of India " he said

The NC candidate said the parliamentary elections also provide an opportunity to create a political space for "dissent and expressing the opinion which was otherwise denied to us for the last fourfive years".

"The entire population was intimidated. The media fraternity which wanted to reflect the facts on the ground was intimidated and many of them were put in jails. The activists are still in iail

"No such atmosphere was allowed in which we would peacefully and democratically express our views. So this is an opportunity for us to express the anger and the sentiment which were otherwise denied to us," he added.

To a question about not contesting from his bastion

north Kashmir's Baramulla Lok Sabha seat which includes many Shia-dominated areas including his own assembly segment Budgam, Mehdi said at the moment the challenge that the people face is not local

"It is not district-wise. It is not a challenge to a district or to a constituency. The challenge that we face, the existential crisis that we have, is the same for everyone. It is as similar for the people of Srinagar as it is for the people of Baramulla or for Budgam or Anantnag. The issues are similar. The challenge is the same," he said.

The Shia leader said it does not matter who contests from where. He said he sees coming out of his bastion as an encouragement for him. "Standing and fighting for a cause and generating the kind of an opinion or support from areas 'which have not been my bastion' is an encouragement for me. It means that I am not doing localised politics. I am not doing politics for a particular sect or an area," he said.

Mehdi said he is doing politics for the nation. The people are understanding this and they are coming along, he added

### China's Xi: Divide or intimidate & conquer

President Xi Jinping's European Tour Amid China's Economic Slowdown and Geopolitical Tensions

China's President Xi Jinping has at last begun his structured foreign travel after his stay-at-home posture during and after the Covid-19 pandemic. This was partly due to a delayed Covid-19 surge in China as the movement restrictions were lifted, when the rest of the world had crossed peak infections. This week he began a six-day swirl through Europe, starting with France, and then mostly China-friendly nations such as Hungary. Serbia was included as it marked 25 years since the Nato forces mistakenly bombed the Chinese diplomatic premises in Belgrade in the late 1990s.

This happens when the Chinese economic slowdown is now broadly accepted. The International Monetary Fund in its February 2024 report observed that economic growth this year shall be 4.6 per cent, down from 5.2 per cent the previous year.

Even more worrisome for China should be their assessment of its drop to 3.4 per cent by 2028. This appears to be due to a combined effect of demographic shrinkage, Western sanctions on cutting-edge technology and restricted Western market access. President Xi's distrust of the private sector and entrepreneurship probably makes a turnaround difficult.

One obvious result is that talk about China catching up with the United States or even overtaking it has mellowed. In fact, it is generally accepted that even though the American economy is slowing, but at a lesser pace than China's, their gap is, if anything, widening. Analysts are speculating that when a rising power, desperate to catch up with the dominant hegemon, starts stalling, one of two things can happen. Its leadership may alter its aggressive behaviour towards the world, especially the neighbours, opting instead for diplomacy. Alternatively, it may get desperate and decide to use force to achieve its territorial objectives, realising its power-differential vis a vis its rivals will diminish over time.

Obviously, no sudden change in Chinese strategic posture can be expected.

China would not like its rivals to benefit from its perceived weakness. Its recent actions need to be viewed from this perspective. Before setting forth for Europe, China unveiled its third aircraft-carrier, the Fujian. A 80,000tonne vessel with electromagnetic catapults, on a rough calculation, would enable it to carry 70-80 aircraft. China is planning to have six such vessels by 2035. This still leaves the combined naval power of the US and Japan way ahead. The US Navy, with carriers of the Nimitz and Ford class, has more experience, better aircraft and greater firepower. The Japanese, with considerable experience of using aircraftcarriers since the Second World War, have opted for flat-top vessels with the possibility of being used as carriers for vertical take-off and landing F-35s.

Interestingly, the maiden voyage of the Fujian coincided with the May  $8\,$ Balikatan joint military exercise of the US and the Philippines. The Chinese have been muscling the Filipinos out of the Scarborough Shoal naval area. The Philippines had in 2016 got an award, under the UN Convention on the Laws of the Seas (UNCLOS), from the Permanent Court of Arbitration declaring the Chinese 9-dash line as illegal. China has nevertheless continued to thwart attempts by the Philippines to assert its sovereignty in that zone.

Even the territorial dispute between India and China has not seen China relenting yet. In fact, China has been increasing settlements all along the India-China Line of Actual Control (LAC). China also provocatively issued maps with habitations in India's Arunachal Pradesh shown with Chinese names. Meanwhile, military-level talks have repeatedly faced a stalemate with China unwilling to withdraw forces from the Depsang Plains and Demchok. It is likely that China did not wish to hand the Narendra Modi government a "win" on the eve of crucial Lok Sabha elections. This assumption aligns with China now naming its next ambassador to India, after a gap of a year and a half. At the very least, China may be preparing to use the diplomatic route for testing the next Indian government's willingness to engage. The problem is that China wants access to the Indian market to continue, if not increase, while it stalls on territorial issues. India has repeatedly asserted that normalcy requires the post-Galwan territorial intrusions to be addressed.

President Xi's European sojourn is similarly planned to test and exploit the fissures, on the approach to China, within the European Union and between them and the United States. The visit comes after the China visit by German Chancellor Olaf Scholz, which seemed to display European differences. Further demonstrating that dissension has been Mr Scholz's unwillingness to join French President

Emmanuel Macron in a joint meeting with President Xi. There are differences in the approach of France and Germany to taxing European imports of Chinese electric vehicles. While the Germans fear Chinese countermeasures against their automobile exports to China, the French want to protect their own manufacturers of smaller cars.

The Sino-European theatre is being enacted against the background of two other events. One is the November presidential election in the United States. The growing possibility of the re-election of Donald Trump sends shudders down the European spine. It can mean the degrading of Nato, trade disputes with the US and Russia's upper hand in ending the war in Ukraine on its own terms. The other factor is the commencement this week of Russian President Vladimir Putin's next six-year term, with a more united Russia behind him.

Regarding both these developments, China is a factor. While it has not transferred weapons to Russia, for its Ukraine campaign, it has kept Russia financially afloat by buying its oil and gas. It has also made available chips or other high-tech components crucial for the Russian armaments industry. China correctly surmises that a strategically divided and confused Europe is easy prey for its overtures. But China would have to alter its subsidies-based exports to satisfy Europe. It would also have to restore confidence regarding Chinese activities in illegally transferring high technology from European

While these larger forces are shadow boxing, India has been entrapped in an unnecessarily prolonged national election. A gap of almost a week between seven phases, many in the same state, cannot be justified on the grounds of security and expediency alone. No nation, and particularly one which aspires for Great Power status, can sign off from the world for well over a month while its leadership takes the low road to opportunistic and divisive electioneering.

## PM's jibe at Sharad Pawar and Uddhav Thackeray: 'All fake leaders should...'

Prime Minister Narendra Modi took aim at Nationalist Congress Party founder Sharad Pawar and Shiv Sena (UBT) chief Uddhav Thackeray and said "these fake NCP and Sena leaders" should join Ajit Pawar and Eknath Shinde.

NEW DELHI, May 10 (Agencies): Prime Minister Narendra Modi on Friday took a dig at Nationalist Congress Party (NCP) founder Sharad Pawar and Shiv Sena (UBT) chief Uddhav Thackeray and said that both should join Ajit Pawar and Eknath Shinde. He asserted that "fake NCP and Shiv Sena" have made up their minds to merge with the Congress after the Lok Sabha election results were declared on June 4.

"A senior leader from Maharashtra is very tensed after an election in Baramati. He made a statement that all the smaller regional parties should get merged in Congress. I am sure he would have made this statement after consulting with several leaders," PM Modi said at a rally in Maharashtra's Nandurbar without naming Sharad Pawar.

"He is so desperate and disappointed that he knows to remain relevant in social and political life after June 4, one needs to merge a bigger party with the Congress. This means that 'nakli' (fake) NCP and 'nakli' Shiv Sena have made their mind to merge with the Congress," he added.

"I should tell them than instead of dying in Congress, you should proudly join our Ajit dada (Pawar) and Shinde ji to fulfill your dreams respectfully,"



he said.

In an interview with agency, Sharad Pawar said, "In the next couple of years, several regional parties will associate more closely with the Congress. Or they may look at the option of merging with the Congress if they believe that is the best for their party."

Speaking at the rally, PM Modi also accused the Congress of conspiring to end 'Hindu aastha' (faith). In a dig at former Indian Overseas Congress chief Sam Pitroda and Congress leader Rahul Gandhi, he said, "The guru of Congress's 'shehzada' has told the US that Ram temple and Ram Navami festivities are against the idea of India."

Pitroda on Wednesday resigned after stoking controversy with his remarks that cited ethnic and racial identities like Chinese, Africans, Arabs and Whites to describe the physical appearance of Indians.

"Congress calls people with Lord Krishna's colour as Africans. So they didn't want Droupadi Murmu to be the President of India. Isn't it an insult of adivasis?" he asked.

PM Modi said that the Congress's agenda was so dangerous that if it terms Ram temple construction and Ram Navami celebrations against the idea of India. "They may say my going to the temple is anti-India. See the Congress mindset, that in the land of Ram, a temple is anti-India," he alleged.

These people organise 'sarkari iftar' and beautify graves of terrorists, he claimed

He said the Congress knows it cannot match the BJP over development. "So, it has opened a factory of lies on reservation and Constitution and their ecosystem is filled with rumours," he said.

"On the Constitution change rumour, it is nothing but a 'chor machave shor' (thieves creating noise) situation for Congress. It wants to introduce reservations based on religion which is against the Constitution. Making such an attempt is like stabbing the maker of the Constitution in the back," he said.

In Karnataka, PM Modi alleged, the Congress turned Muslims into OBCs overnight and now it wanted to snatch quotes from tribals and Dalits.

"In Maharashtra, the Maha Vikas Aghadi is running a 'maha abhiyan' (mega drive) to finish off quota while I am doing 'maha rakshan ka maha yagna' (grand ritual for protection) to save it," he said.

"I have been challenging the Congress to give in writing that it will not end the SC and ST quota and give it to Muslims. But the Congress is not replying. They have a hidden agenda to loot your rights. But they are spreading rumours by being hand in glove with anti-national elements," he said.

In the Nandurbar seat, the BJP has renominated incumbent MP Heena Gavi, who is pitted against Gowaal Padavi of Congress. The constituency will go to polls in the fourth phase of the general elections on May 13. Results are expected on June 4.

#### Pakistan, Russian connections detected in Ahmedabad school bomb threat case

AHMEDABAD, May 10 (Agencies): Crime Branch has uncovered a Pakistani link to the bomb threats which targeted 38 schools in Gujarat's Ahmedabad on May 6, officials said on Friday.

The officials said that this incident has links in Pakistan and a Russian server was used to create a sense of panic and fear in the city. The threat mail was sent from a Russian domain (.ru). More information is awaited.

The threatening emails received a day before the May 7 Lok Sabha polls caused widespread panic among the public.

The Crime Branch, Cyber Crime unit, Special Operations Group, and Ahmedabad Police launched an investi-



gation soon after the threats

Despite the alarming nature of the threats, no suspicious or explosive materials were discovered after thorough inspections by bomb disposal squads and

canine units. Director General of Police Vikas Sahav had said that the threats were a hoax and encouraged voters to proceed to the polls

without fear. This incident follows a trend of hoax threats similar to those received by over 130 schools in the Delhi-NCR area.

Officials said that the threatening emails which prompted heightened security measures across Delhi-NCR on May 1 originated from a Russian domain. The email address used, sawariim@mail.ru, indicated its Russian origin. However, officials said that the perpetrators may have used a masked IP address.

#### 28,200 mobiles suspected of being used in cyber fraud blocked

NEW DELHI, May 10 (Agencies): Attempting to stop ever-growing cases of cyber fraud in which citizens are losing hard-earned money, the Department of Telecom on Friday said directions have been issued to block 28,200 mobile handsets and immediate re-verification of 20 lakh mobile connections handsets has been ordered.

Failing re-verification of identity, the SIM card will be disconnected.

Mobile handsets are blocked on the basis of their International Mobile Equipment Identity (IMEI) number that is unique to each handset.

Telecom service providers have been asked to ensure a pan-India block on these 28,200 mobile handsets and to carryout immediate reverification of 20 lakh linked to these mobile handsets, the DoT said adding that these SIM cards would be disconnected if re-verification failed.

An analysis was carried out by Ministry of Home Affairs and State Police forces that identified these 28,200 mobile handsets were misused in cybercrimes. The DoT further analysed and found that a staggering 20 lakh numbers were used with these mobile handsets.

This is not the first such instance of the DoT stepping in.

KOCHI, May 10 (Agencies): Two men died on Friday when the two-wheeler they were travelling on got sandwiched between two Kerala State Road **Transport Corporation** (KSRTC) buses near Palarivattom here.

### Engagement called off, Karnataka man kills minor, flees with severed head

BENGALURU, May 10 (Agencies): A 16-year-old girl was bludgeoned to death and the accused fled with her severed head at Mutlu village in Somwarpet in Karnataka's Kodagu district. The victim and the accused, identified as Prakash (32), were supposed to get engaged.

However, the girl's engagement was stopped by officials of the Women and Child Development department on May 9. The officials convinced the girl's parents to call off the marriage. On Thursday, Prakash barged into the girl's home at 5:30 pm, dragged her out and chopped her head off. He then fled with the girl's severed head and is absconding.

The girl recently passed the state board exams. She obtained 52% marks in the SSLC exams. Police have launched a hunt for the accused.

The victim's mother sustained injuries and is receiving treatment at a hospital. The motive behind the murder is yet to be determined.

"The accused is absconding, we are looking for him. We have been told that child helpline officials from the Social Welfare department had stopped the engagement. We don't know the motive yet," a police officer said today.

### Molestation case against Bengal Guv: Woman to write to President Murmu to seek justice

KOLKATA, May 10 (Agencies): A day after West Bengal Governor CV Ananda Bose screened multiple CCTV footage from Raj Bhavan, in a bid to clear the air over allegations of molestation brought against him by a contractual woman employee of the governor's house, the victim on Friday said she will seek President Droupadi Murmu's intervention

into the matter. The employee raised her objections to the public screening of unedited footage where her identity was alleg-

edly disclosed since her face wasn't blurred.

Stating that she could not repose much hope on the Kolkata Police whose hands are tied on account of the constitutional immunity Governor Bose enjoys, the victim said she was going through severe depression and felt that writing to the President was the only recourse to justice.

"I know that because of Constitutional immunity nothing will happen to a sitting Governor. But what about the offence he committed? I have decided to write to

the President seeking her intervention in the matter.I am writing to her to get justice and nothing else," the alleged victim told agency.

Expressing her outrage over the screening of the footage without protecting her identity, the victim said she would also approach the police for redress.

She deemed that the act of screening of the May 2 CCTV footage was an "insult" and accused the governor of further violating her privacy and confidentiality while lamenting the "lack of cooperation from



the governor" throughout the investigation process

"How did the governor screen my footage without my permission? He committed a new crime today," she said.

Kolkata Police had earlier confirmed that

it would conduct an 'enquiry' instead of a full-fledged investigation which requires the filing of an FIR since the governor is protected under Clause 2 of Article 361 of the Constitution which grants him total immunity from criminal proceedings of any kind. The contractual woman employee of Raj Bhavan had on Friday lodged a complaint with Kolkata

Police alleging that she was molested by Bose in the governor's house on April 24 and May 2. She criticised Bose for orchestrating a "ridiculous drama" to deflect from his actions,

emphasising that he should have provided the footage to police at the outset of the investigation.

"He (the Governor) committed an ugly act. Then he staged a ridiculous drama to cover my permission before releasing the footage. This is in violation of our laws since my identity should have been kept confidential," she said.

The man was arrested on Thursday evening for domestic violence, as the BFMTV channel and the newspaper Le Parisien reported citing police sources.

He grabbed the weapon and shot the two officers while police were trying to search him at the station, according to the reports.

One of the police offi-



cers was hit in the upper body and the other in the thigh.

The attacker was also reportedly injured when police officers fired back.

All the injured were

taken to a hospital.

Police union UNSA said the staff at the affected station in the 13th arrondissement of Paris, on the left bank of the River Seine, were "in shock".

#### Vladimir Putin reappoints Mikhail Mishustin as Russia's Prime Minister

MOSCOW, May 10 (Agencies): Russian President Vladimir Putin on Friday reappointed Mikhail Mishustin as the country's Prime Minister after the previous stint on the job during which the low-key technocrat has shown a distinct lack of political ambitions.

In line with Russian law, Mishustin, 58, who held the job for the past four years, submitted his Cabinet's resignation on Tuesday when Putin began his fifth presidential term at a glittering Kremlin inauguration.

Mishustin's reappointment was widely expected by political observers, who noted that Putin has appreciated his skills and low political profile. Mishustin, the former head of Russia's tax service, has steered clear of political statements and avoided media interviews during his previous



tenure.

The speaker of the parliament's lower house, Vyacheslav Volodin, announced that Putin has submitted Mishustin's candidacy to the State Duma, which will hold a session to consider it.

Under the constitutional changes approved in 2020, the lower house approves the candidacy of the Prime Minister, who then submits candidacies

of Cabinet members.

Mishustin's approval is a mere proforma in the Kremlin-controlled parliament.

He and other technocrats in the Cabinet were credited for maintaining a relatively stable economic performance despite bruising Western sanctions.

Most Cabinet members are also expected to keep their jobs and reappointments are expected shortly.

However, after last month's arrest of his top associate, Timur Ivanov, the fate of Defence Minister Sergei Shoigu appeared uncertain.

Ivanov, who served as Deputy Defence Minister in charge of multi-billion military construction projects, was arrested on bribery charges and was ordered to stay in custody pending official investigation.

The arrest of Ivanov was

widely interpreted as an attack on Shoigu and a possible precursor of his dismissal despite his close personal ties with Putin.

Shoigu was widely criticised for Russian military's setbacks in the early stage of the fighting in Ukraine. He faced scathing attacks from mercenary chief Yevgeny Prigozhin, who launched a brief attempted march on Moscow last June to demand the ouster of Shoigu and the chief of the General Staff, Gen Valery Gerasimov.

After Prigozhin's death in a suspicious air crash two months after the rebellion that was broadly seen as a Kremlin revenge for his mutiny, Shoigu appeared to shore up his position, but Ivanov's arrest, seen as part of Kremlin's political infighting, again exposed Shoigu's vulnerability.

## Pakistan to seek rollover of US\$ 12 billion debt to meet budget targets before IMF team's arrival

ISLAMABAD, May 10 (Agencies): Pakistan has decided to seek a rollover of around US\$ 12 billion debt from key allies like China in the 2024-25 fiscal year to meet a whopping US\$ 23 billion worth of gap in its external financing as the federal government aims to achieve budget targets before the expected arrival of an IMF team to the cash-strapped country.

According to the Finance Ministry insiders, US\$ 5 billion from Saudi Arabia, US\$ 3 billion from the UAE and US\$ 4 billion from China will be rolled over, adding that the estimate of further new financing from China would also be included in the next financial year's budget, news agency reported.

Pakistan will receive more than US\$ 1 billion from the International Monetary Fund (IMF) under the fresh loan programme, whereas new financing from the World Bank and Asian Development Bank has also been included in the estimated budget.

According to the Finance Ministry

sources, new loan programme agreements will be made with financial institutions. The federal government aims to achieve budget targets before the anticipated arrival of the IMF review

mission in Pakistan.

Negotiations for a new loan programme with the global lender are expected to commence in mid-May ahead of the budget which will be presented in June.

The Finance Ministry sources said the ministries had been instructed to complete the targets before the negotiations on the new loan programme.

They added that the details would be given to the IMF delegation when all the important targets were met. It has also been decided to have the budget strategy paper approved by the federal cabinet before the IMF review mission arrives in the country.

According to the sources, the Finance Ministry has started preparing the budget to set the targets for debt repayment, defence budget and tax collec-

tions.

Besides, the development and ongoing budget targets will also be determined, according to the paper.

Pakistan has been suffering the chronic ailment of how to meet external liabilities. Traditionally, it depended on remittances, export proceeds and foreign loans to meet its liabilities.

But exports haven't increased to match the imports and avenues of foreign aid have gradually dried up, putting pressure on the rupee and essential imports.

Last year, it narrowly avoided default due to a timely short-term loan agreement with the International Monetary Fund which provided US\$ 3 billion during nine months.

The country is once again looking towards the global lender to provide a fresh loan to keep it moving.

In the trying economic conditions, Pakistan has been heavily supported by the remittances its workers living and working around the globe send.

The country received the second-highest remittances of the ongoing 2023-24 fiscal at US\$ 2.8 billion in April 2024.

According to the State Bank of Pakistan (SBP), the remittances increased by 3.5 per cent to US\$ 23.8 billion cumulatively in the first 10 months of FY24 compared to the same period last year.

Remittance inflows during April 2024 were primarily sourced from Saudi Arabia (US\$ 712 million), the United Arab Emirates (US\$ 542.3 million), the United Kingdom (US\$ 403.2 million), and the United States of America (US\$ 329.2 million), according to the bank.

The remittances earlier had peaked near US\$ 3 billion in the prior month of March 2024, marking a 23-month high.

Separately, the Dawn newspaper reported that Pakistan is engaging with the Chinese leadership for the revival of more than 1800-megawatt of hydropower projects (HPPs) and investment from fresh Chinese companies in the country's transmission and distribution network as part of the second phase of the China-Pakistan Economic Corridor (CPEC).


The authorities are trying to convene a meeting of the Joint Cooperation Committee (JCC) of the cabinet on May 22-23 so that Prime Minister Shebaz Sharif's upcoming visit to Beijing early next month will be a success.

A high-level delegation led by Planning Minister Ahsan Iqbal is currently in China to pursue existing investors and financial institutions and tap into more firms in the transmission and distribution network as part of CPEC's second phase.

In his meeting, Iqbal sought China's continued cooperation in the early implementation of the Azad Pattan and Kohala hydropower projects.

The two sides agreed to hold the next round of the Joint Working Group meeting on Energy (JEWG) soon.

## Hillary Clinton terms US campus protests 'propaganda', 'lack of knowledge'



WASHINGTON, May 10 (Agencies): Former US States Secretary of State, Hillary Clinton, has slammed campus protests across the country, over the Gaza war, saying the young people (students) do not know much about the history of the Middle East.

Clinton also termed students ignorant and alleged they were being misinformed by propaganda on social media. In an interview with MSNBC, Hill-

ary Clinton agreed with host Charles Joseph Scarborough, who said, "mainstream students were getting propagandised whether it's from their professors, or whether it's from the communist Chinese government, through TikTok, calling the President of the United States 'genocide Joe'."

In response, Clinton said, "I have had many conversations, as you've had, with a lot of young people over the last many months now, and... they don't know very much at all about the history of the Middle East, or frankly about history in many areas of the world, including in our own country."

"Propaganda is not education," she said, adding, "propaganda... whether it's TikTok, or in the classroom, is actually the opposite of education."

"Anybody who is teaching in a university or anyone who is putting content on social media should be held responsible for what they include and what they exclude. So much of what we're seeing, particularly on TikTok, about what's going on in the Middle East is wilfully false, but it's also incredibly

slanted, pro-Hamas, anti-Israel," Hillary Clinton said.

"With respect to the Middle East, they don't know that under the bringing together for the Israelis and the Palestinians by my husband (former US President Bill Clinton), then-Israeli prime minister Ehud Barak, the then-head of the Palestinian Liberation Organisation Yasser Arafat — an offer was made to the Palestinians for a state on 96 per cent of the existing territory occupied by the Palestinians with 4 per cent of Israel to be given to reach 100 per cent of the amount of territory that was hoped for," Clinton said.

"This offer was made and if Yasser Arafat had accepted it there would have been a Palestinian state now for about 24 years. It's one of the great tragedies of history that he was unable to say, 'yes'," Clinton laments.

"My husband has a book coming out later this year in which he talks about how Arafat kept saying that he intended to agree, he wanted to agree, but he was pretty sure he'd be killed because Sadat was killed by extremists when he made peace with Israel."

"Our dear, dear friend, Yitzhak Rabin was killed by a radical Israeli when he was pursuing the two-state solution."

"So... this is a very important piece of history to understand if you're going to take any kind of position with respect to what's going on right now," she said.

Students in both the United States and Europe have been holding demonstrations calling for an immediate permanent ceasefire and for schools to cut financial ties with companies they say are profiting from the oppression of Palestinians.

Israel's retaliatory campaign in Gaza has killed nearly 35,000 Palestinians, according to Gazan authorities, and triggered a catastrophic humanitarian crisis and famine threatening the enclave's 2.5 million residents.

The war began when the militant group Hamas attacked Israel on October 7, killing 1,200 people and taking more than 250 hostages, according to Israeli tallies.

## Countries struggle to draft 'pandemic treaty' to avoid mistakes made during COVID

GENEVA, May 10 (Agencies): After the coronavirus pandemic triggered onceunthinkable lockdowns, upended economies and killed millions, leaders at the World Health Organization (WHO) and worldwide vowed to do better in the future. Years later, countries are still struggling to come up with an agreed-upon plan for how the world might respond to the next global outbreak.

A ninth and final round of talks involving governments, advocacy groups and others to finalise a 'pandemic treaty' is scheduled to end on Friday. The accord's aim: guidelines for how the WHO's 194 member countries might stop future pandemics and better share scarce resources. But experts warn there are virtually no consequences for countries that don't comply.

WHO's countries asked the UN health agency to oversee talks for a pandemic agreement in 2021. Envoys have been working long hours in recent weeks to prepare a draft ahead of a self-imposed deadline later this month: ratification of the accord at WHO's annual meeting. But deep divisions could derail it.

US Republican senators wrote a letter to the President Joe Biden administration last week critical of the draft for focusing on issues like "shredding intellectual property rights" and "supercharging the WHO." They urged Biden not to sign off.

Britain's department of health said it would only agree to an accord if it was "firmly in the UK national interest and respects national sovereignty."

And many developing countries say it's unfair that they might be expected to provide virus samples to help develop vaccines



and treatments, but then be unable to afford

"This pandemic treaty is a very high-minded pursuit, but it doesn't take political realities into account," said Sara Davies, a professor of international relations at Griffith University

in Australia.

For example, the accord is attempting to address the gap that occurred between COVID-19 vaccines in rich and poorer countries, which WHO Director-General Tedros Adhanom said amounted to "a catastrophic moral failure."

The draft says WHO should get 20 per cent of the production of pandemic-related products like tests, treatments, and vaccines, and urges countries to disclose their deals with private companies.

"There's no mechanism within WHO to

make life really difficult for any countries

that decide not to act in accordance with the treaty," Davies said.

Adam Kamradt-Scott, a global health expert at Harvard University, said that similar to the global climate agreements, the draft pandemic treaty would at least provide a new forum for countries to try to hold each other

to account, where governments will have to explain what measures they've taken.

The pandemic treaty "is not about anyone telling the government of a country what it can do and what it cannot do," said Roland Driece, co-chair of WHO's negotiating board for the agreement.

There are legally binding obligations under the International Health Regulations, including quickly reporting dangerous new outbreaks. But those have been flouted repeatedly, including by African countries during Ebola outbreaks and China in the early stages of COVID-19.

Suerie Moon, co-director of the Global Health Centre at Geneva's Graduate Institute, said it was critical to determine the expected role of WHO during a pandemic and how outbreaks might be stopped before spreading globally.

"If we fail to seize this window of opportunity which is closing ... we'll be just as vulnerable as we were in 2019," she warned.

Some countries appear to be moving on their own to ensure cooperation from others in the next pandemic. Last month, Biden's administration said it would help 50 countries respond to new outbreaks and prevent global spread, giving the country leverage should it need critical information or materials in the future.

Yuanqiong Hu, a senior legal and policy adviser at Doctors without Borders, said it's unclear what might be different in the next pandemic, but hoped that focusing attention on some of the glaring errors that emerged in COVID 40 might halp

in COVID-19 might help.
"We will mostly have to rely on countries to do better," she said. "That is worrisome."

## **Egypt Urges Flexibility From Israel And Hamas In Ceasefire Talks**

CAIRO, May 10 (Agencies): Egypt has said Hamas and Israel must show "flexibility" if they are to strike a deal for a ceasefire and hostage-prisoner exchange in the seven-month war in the Gaza Strip, according to a foreign ministry statement released Friday.

The readout of a phone call between Egyptian Foreign Minister Sameh Shoukry and US Secretary of State Antony Blinken said both diplomats agreed on "the importance of urging the parties to show flexibility and make all the necessary efforts to achieve a ceasefire agreement and put an end to the humanitarian tragedy in Gaza".

Hamas said early Friday that its negotiators at ceasefire talks this week in Cairo had left the city for Doha, saying Israel had "rejected the proposal submitted by the mediators and raised objections to it".

The group added it stood by the proposal, saying that "the ball is now completely in the hands of the occupation".

State-linked Egyptian outlet Al-Qahera News reported Thursday that Israeli



negotiators had also left Cairo.

Friday's foreign ministry statement said the talks were in a "delicate phase", with Cairo expressing fears that a full-scale Israeli incursion into the crowded Gazan city of Rafah, which sits on Egypt's border, could threaten the "stability and security" of the region.

US State Department spokesman Matthew Miller said that during the same conversation, Blinken assured Shoukry "that the United States does not support a major military operation in Rafah" and rejects "any forced displacement of Palestinians from Gaza".

## AI based DBS surgery on Parkinson's patient performed

CHANDIGARH/ JAMMU, May 10: AI based deep brain stimulation (DBS) surgery on a Parkinson's patient was performed for the first time at Ivy Hospital, Mohali recently.

Talking to media here on Friday, Dr Jaslovleen Kaur Sidhu, consultant neurology at Ivy said that a 65 years old male patient with tremors from the last 10 years has undergone successful

The patient was taking multiple doses of levodopa and other medications. The surgery went successful and, after two sessions of programming his tremors have reduced down by 90%, informed Dr Jaslovleen.

With this Ivy has become Punjab's 1st hospital to do Al based DBS surgery for Parkinson's patients and till now we have conducted 5 such cases in the last 2 months, she said.

She further said," This



Al based brain sense technology can record the brain signals responsible for Parkinson's disease symptoms or side effects, even when the patient is at home or doing his routine activities. This helps the treating doctor in delivering personalized, data-driven treatment as per the patients' needs."

Till now patients from tricity used to travel to Delhi, Mumbai or Bangalore to get DBS surgeries done, now this procedure is being done routinely at Ivy, said Dr Jaspreet Singh Randhwa, consultant neuro surgery at Ivv.

He said that DBS surgery is like a pacemaker surgery for the brain which can control the symptoms by changing the electrical signals of the electrodes placed in the brain. Patients who need DBS surgery have to be screened by a Parkinson's specialist neurologist and have to undergo UPDRS on & off testing before they can be declared fit for surgery, he asserted.

Also, since this is an awake surgery, Parkinson's specialists have to monitor the patient during the whole surgery to confirm if the electrodes are put in the exact location in the brain, Dr Randhawa maintained.

### Stepfather convicted for murder of **Bollywood Actor Laila Khan, Five Others**

JAMMU / MUMBAI, May 10 (Agencies): A Mumbai sessions court on Thursday convicted the stepfather of Bollywood actor Laila Khan for the murder of the actor, her mother, and four others, including three of her siblings, thirteen years after they went missing.

According to police, the accused, identified as Parvez Tak, a resident of Jammu and Kashmir, was arrested in 2012. Another accused, who is also involved in the case, is still on the run.

The Court has held Tak guilty of murdering his stepdaughter and actor Laila Khan, her mother Shelina Patel, three of her siblings, and her cousin in February 2011.

Nearly 40 witnesses were

examined during the trial. The court will hear the defense and prosecution on the quantum of punishment on May 14.

According to officials, Laila and her family members were killed and buried at their farmhouse in Igatpuri in February 2011. Their bodies were exhumed by police after the arrest of Tak in 2012.

In 2011, Laila Khan, who had appeared in a few Bollywood movies, went missing along with her mother. three of her siblings and her cousin.

Her father, Nadir Patel, had approached the police and lodged a complaint about their disappearance. Following the complaint, police launched a probe, which continued for

months.

The Maharashtra Anti-Terrorism Squad (ATS) was also involved in the case suspecting a terror angle. However, in July 2012, the ATS announced that Khan's matter was a murder case and there was 'no terror angle' to it.

Their murder came to light a few months later. when Parvez Tak was arrested.

Tak was first apprehended by Jammu and Kashmir police and was later handed over to Mumbai police.

Later, during questioning, Tak revealed the murder and led the police to the remains of the deceased. which he had buried in a pit at the farmhouse in Igatpuri.

## Conditions in India shaping up for an upshift in real GDP growth: SBI Chairman

MUMBAI, May 10 (Agencies): State Bank of India (SBI) Chairman Dinesh Khara on Thursday said conditions in India are shaping up for an upshift in real GDP growth aided by robust investment demand and an improvement in business and consumer sentiments.

The lender expects to maintain a credit growth of 14-16 per cent in the financial year 2025, with momentum continuing in retail and corporate loans, he said.

"As far as India is concerned, conditions are shaping up for an upshift in the real GDP growth, backed by a strong investment demand and upbeat business and consumer sentiments," Khara told reporters after declaring the results for the quarter ended March 2024.

For the current financial year, the Reserve Bank of India (RBI) has projected a real GDP growth of 7 per cent.

Khara said consumer price index-based inflation (CPI) has already gravitated to 4.9 per cent in March after averaging at 5.1 per cent in the preceding two months. The CPI is expected to



moderate in the ensuing months and taper to 4.5 per cent in FY25 compared to an average of 5.4 per cent in FY24.

In FY24, scheduled commercial banks recorded a credit growth of about 20 per cent, while deposits grew at about 13 per cent. Khara expects the pace of growth in credit for the industry to continue in the current fiscal.

current fiscal.

The bank's gross advances grew by 15.24 per cent in FY24. Domestic loans rose by 16.26 per cent year-on-year (y-o-y) driven by SME advances (20.53 per cent year-on-year) followed by agriculture advances which grew by 17.92 per

cent y-o-y. Retail advances increased by 14.68 per

The bank is seeing a similar kind of trend in the growth in SME, retail and agriculture sector loans, going forward also, he

When asked about his expectation on credit growth for the bank in FY25, Khara said, "Much of it will depend on how the economy looks like. But yes, we are hoping that we would be in a position to maintain this growth trajectory which we have recorded in this year (FY2024), of around 15-16 per cent. I would still maintain that our (credit) growth (in FY25),

as far as the loan book

is concerned, would be in the 14-16 per cent range." In the quarter ended

March 2024, the lender's corporate loan book registered a y-o-y growth of 16.17 per cent. For FY25, the bank has a corporate loan pipeline of Rs 4 lakh crore, of which around 75 per cent is from the private sector and 25 per cent from the government

Khara said with the strong loan pipeline, he is quite hopeful that the bank would be in a position to see good traction in corporate loans.

"We are seeing growth (in corporate loans) coming in from conventional industries. The multiplier component of the infrastructure spending is almost four times, which actually means that once infrastructure is given a push, it gives a significant push to all other investments," Khara said, adding that he sees funding demand from various sectors, including batteries, electric vehicles (EVs) and semiconductors.

In the quarter ended March 2024, SBI's standalone net profit grew by 23.98 per cent to Rs 20,698 crore – highest ever quarterly profit. For fiscal 2024, the profit grew 21.59 per cent to a record high of Rs 61,077 crore

The net interest income (NII) grew 3.13 per cent to Rs 41,655 crore in the March 2024 quarter, as against Rs 40,393 crore in the year-ago quarter.

Net interest margin (NIM) declined by 37 basis points (bps) to 3.47 per cent from 3.84 per cent.

## Inflows into equity mutual funds decline 16% in April: AMFI data

NEW DELHI, May 10: Net inflows into equity mutual funds declined by 16 per cent to Rs 18,917.09 crore in April from Rs 22,633.15 crore in March, the latest data from the Association of Mutual Funds in India (AMFI) showed.

During the month, the systematic investment plan (SIP) contribution touched an all-time high of Rs 20,371.47 crore in April 2024 as against Rs 19,270.96 crore in the previous month.

In April, net asset under management (AUM) of the industry was Rs 57.25 lakh crore from Rs 53.4 lakh crore in the preceding month. Among the equity-

oriented schemes, sectoral/thematic funds received the highest amount of inflows at Rs 5,166.05 crore, followed by Rs 2,638.91 crore in large and mid cap funds.

After witnessing outflows to the tune of Rs 94.17 crore in March, small cap mutual funds saw inflows of Rs

2,208.7 crore in April.

"The data (stress test results) which we are disclosing regarding small and mid cap funds, and the kind of

control which are being put in place by us, are satisfying to the investors. They are getting confidence and so they are coming back to small cap space," said Venkat Chalasani, Chief Executive, AMFI.

Inflows into large cap funds slowed to Rs 357.56 crore in April from Rs 2,127.79 crore in March. Net inflows into mid cap funds increased to Rs 1,793.07 crore from Rs 1,017.69 crore in the previous month.

Debt oriented mutual funds, which saw outflows of Rs 1.98 lakh crore last month, witnessed inflows of Rs 1.89 lakh crore in April. Among the debt

Among the debt mutual fund schemes, liquid funds saw a maximum inflows of Rs 1.03 lakh crore. Net inflows into overnight, money market and ultra short duration funds stood at Rs 21,195.42 crore, Rs 34,084.11 crore and Rs 11,105.33 crore, respectively.

Inflows into hybrid schemes surged to Rs 19,862.94 crore in April from Rs 5,583.62 in March

Retail AUM (equity + hybrid + solution ori-

ented schemes) stood at Rs 32,82,225 crore in April.

The number of new SIPs registered in April 2024 stood at 63.65 lakh. The SIP AUM was highest ever at Rs 11.26 lakh crore in April compared to Rs 10.71 lakh crore in March.

The number of SIP accounts stood at highest ever at 8.7 crore in April as compared to 8.39 crore in the last month.

On the new Know Your Customer (KYC) norms, which came into effect from April 1, Chalasani said the mutual fund industry is addressing concerns for a smooth process.

"Together with AMCs (asset management companies), distributors and other stakeholders, we are committed to facilitating a seamless KYC validation process for all, thereby ensuring the integrity and accessibility of mutual fund investments across the board." he said.

He said 93 per cent of MF accounts have KYC Validated or KYC Registered status and only three per cent accounts have 'KYC Hold' status.

## Air India Express expects normal flight operations in next two days: Official

NEW DELHI, May 10 (AGencies) The operations of Air India Express slowly started improving on Friday as more cabin crew members are joining back for duty, after significant flight disruptions caused by cabin crew strike that has been called off.

The strike by a section of the cabin crew since Tuesday night that resulted in the cancellation of more than 170 flights was called off on Thursday evening and the airline also withdrew termination letters issued to 25 striking cabin crew.

The Tata Group airline, which operates around 380 flights daily, has curtailed operations in the wake of the strike and the



official on Friday said, normalcy is expected in the next two days.

Cabin crew who were on strike are joining back and the airline is extending support to them in getting the fitness certificate, which is required to resume duty, the official added.

The official also said that most international flights are in the evening

time and the operations on that front are expected to be better from Friday onwards with the avail-

ability of more cabin crew.

On average, the airline operates 120 international flights and 260 domestic services daily while there are fewer flights on some days.

Faced with cabin crew shortage, Air India Express on Thursday cancelled 85 flights or around 23 per cent of its total daily capacity.

After the strike was called off on Thursday, the airline had said it will help to swiftly restore flight schedule and also apologised to passengers who were impacted by the flight disruptions.

Many cabin crew members had reported sick to protest against alleged mismanagement at the airline and lack of equality in treatment of staff.

Air India Express, which is in the process of completing the merger of AIX Connect, formerly AirAsia India, with itself, has around 6,000 employees, including over 2,000 cabin crew.

It is important for bipolar persons to consume a diet rich in proteins and minerals. This diet includes whole grains, fish, eggs, meat, low-fat dairy, soy products, nuts, seeds, fresh fruits and vegetables. The amounts of nutrients included in these foods are sufficient to support overall health and prevent illness.

As per the study, abstaining from sweets, salt, and alcohol is essential for reducing

the prevalence of bipolar illness. The study also states that it is crucial for patients with bipolar disorder to reject Western diets that are heavy in red meat, trans and saturated fats, and carbs. This eating behaviour is linked to a higher risk of obesity, type 2 diabetes and heart disease. Lowering consumption of simple carbohydrates and saturated fats can improve human health.

Also, regular exercise is necessary to maintain a healthy weight. It's critical to discuss weight gain prevention strategies with your doctor when taking medication for bipolar disease.

## Cipla Q4 results: Profit rises 78.5% to Rs 939 crore, revenue up 7%

NEW DELHI, May 10 (Agencies): Pharmaceutical firm Cipla on Friday reported a consolidated net profit of Rs 939.04 crore for the quarter ended March 31 (Q4) of the financial year 2023-24 (FY24). This was a staggering 222 per cent growth in profit compared to Rs 5,407.79 crore reported during the same period last year. Sequentially, profit grew 49 per cent from Rs 11,666.07 crore in Q3

The company's revenue from operations was Rs 1.19 trillion, a 13.5 per cent increase year-on-year (Y-o-Y) from Rs 1.05 trillion. Sequentially, revenue rose 8.6 per cent from Rs 1.10 trillion.

In April, Tata Motors recorded a 12 per cent increase in total domestic dispatches, amounting to 76,399 units compared to 68,514 units in April 2023.

The company's subsid-

iary, Jaguar Land Rover (JLR), maintained its strong financial performance trajectory in the financial year, achieving another record-breaking quarter in Q4 FY24.

## BCCI can re-evaluate Impact Player rule after IPL 2024: Jay Shah

BCCI Secretary Jay Shah has said the board is open to reviewing the contentious 'Impact Player' rule in the Indian Premier League (IPL). The decision is likely to be made following the T20 World Cup.

NEW DELHI, May 10 (Agencies): BCCI Secretary Jay Shah believes the 'Impact Player' rule, which has divided opinion in the ongoing IPL 2024, can be reviewed if stakeholders wish, given that it was introduced as a 'test case'.

The impact player rule has significantly impacted the current edition, with teams exceeding the 250-run barrier eight times thus far. Players, coaches, and analysts have all pointed out the issues that the impact player rule presents to bowlers, claiming that it allows teams to have prolonged batting lineups.

India captain Rohit Sharma said the rule hurts all-rounders because they do not receive enough bowling opportunities. "Impact player rule was brought in as a test case.

On the bright side, it is providing additional playing opportunities to two Indian players," he said in an interaction with select



media at the BCCI office. "Isn't it important that two Indian players are getting a chance? The game is also becoming more competitive," he added.

Shah stated that all parties would convene to decide which will most likely occur after the T20 World Cup. "But still, if the players feel that this is not alright we will speak on it.

However, no one has said anything about it yet. After the IPL and the World Cup, we will

have a meeting and decide," he said. "After the World Cup, we will consult with players, franchise and broadcasters and decide about the future course. It's not a permanent rule nor am

I saying we will move past it,"

he added.

Jay Shah stated that India's T20 World Cup-bound players for the Caribbean and the United States, who are currently involved in the IPL, do not require rest because the com-

petition serves as ideal preparation for the mega event. "Why do you want to rest players? This is (as good as a) practice session, you cannot get any better opportunity (to prepare) than this," Shah said.

"There is a cosmopolitan team in front of you, one team has a bowler from New Zealand, the other has a bowler from Australia and the next one has a bowler from Sri Lanka," he added.

Shah believes that the IPL is

the ideal approach for Indian players to prepare for the World Cup because it allows Jasprit Bumrah to assess a marauding batter like Travis Head ahead of time. "If we rest a bowler he won't get a chance to bowl at Travis Head. When (Jasprit) Bumrah will bowl to Travis Head, he will understand where to bowl to him and how. There is no better opportunity," he said.

## Khaleel Ahmed happy after long-awaited return to India colours: Every day was like battle



NEW DELHI, May 10 (Agencies): DC pacer Khaleel Ahmed is delighted after returning to the Indian men's cricket team for the upcoming ICC T20 World Cup 2024 on the back of a splendid IPL 2024. Khaleel, out of the national side since 2019, said that every day felt like a battle as he missed playing for the country. Khaleel is enjoying a splendid run in the IPL 2024, having picked up 14 wickets in 12 matches thus far and made a well-deserved return to the national team, earning a spot as a standby for the upcoming ICC Men's T20 World Cup

"The way the past few months were going and the way the IPL started, I had the intuition that something good would happen. As the IPL matches progressed, my confidence continued to grow. I realised I was bowling well, and it has always been about moving

one step ahead. Finally, when the name came, I was so happy, and it's a step ahead for me," Khaleel said while speaking on DC Podcast. Reflecting on what was a challenging journey, the Delhi Capitals pacer said, "2019 was a long time ago. Every day, at the back of my mind, I missed that feeling of playing for the country. Every time I used to watch India play, I used to imagine what I would have done if I was there in the team. So, every day was like a battle and these kinds of conversations were going on inside my head."

Khaleel made a conscious effort to play all domestic matches after the last IPL, despite the challenges of being a fast bowler. The DC pacer emphasized the importance of mental strength in his journey, stating that he fought for it day and night, as his life has always been about cricket. "After the last IPL, I took only a week's break and embarked on this journey. I made sure I played all the domestic matches. It's tough as a fast bowler, but I made up my mind that irrespective of what happens to me, I'm going to play all the matches. I pushed myself mentally in the past year and have grown up with it. Mentally, you just have to fight for it, day, night or any time, because my life has always been about cricket. My thoughts have only been about cricket, nothing else bothers me." he added.

## GT host injury-ravaged CSK in must-win clash

AHMEDABAD, May 10 (Agencies): Injury-ravaged CSK, missing key bowlers due to injuries and international duties, aim to showcase their competitive edge as they face off against the struggling GT in the IPL 2024 match in Ahmedabad. ## IPL 2024: Bowlers complement Kohli, Patidar as RCB crush PBKS by 60 runs

DHARAMSALA, May 10 (Agencies): Virat Kohli and Rajat Patidar conjured up superlative fifties before the bowlers joined the party as Royal Challengers Bengaluru kept their slim playoff hopes alive with a huge 60-run win over Punjab Kings in the IPL here.

Kohli's 47-ball 92 was the cornerstone of RCB's innings as he starred in two partnerships -- 72 off 32 balls with Patidar (55 off 23 balls) and 92 off 46 balls with Cameron Green (46 off 27 balls) to propel RCB to 241/7.

In reply, Rilee Rossouw put up a show with a 27-ball 61-run knock but Karn Sharma's twin strike triggered a collapse as PBKS were all out for 181 in 17 overs.

This was a fourth successive win for RCB and it took them to 10 points, while PBKS (8) were knocked out of the playoff race as they can reach a maximum of 12 points from the remaining two games.

Swapnil Singh (2/28), Karn (2/36) and Lockie Ferguson (2/29) took two each, while Mohammed Siraj (3/43) claimed three wickets for RCB.

Chasing a stiff target, PBKS lost Prabhsimran Singh (6) early but Rossouw looked unstoppable as left-arm spinner Swapnil Singh was carted for two fours before Siraj was belted for three fours and a six.

Yash Dayal and Ferguson were then hit for 16 and 14



runs by Jonny Bairstow (27) and Rossouw as PBKS scored 75 runs in six overs.

Once Bairstow was removed by Ferguson, Rossouw turned his attention on Green, blasting two fours and a six on way to his fifty off 21 balls.

Jitesh Sharma was then cleaned up by Karn, while Swapnil got rid of Liam Livingstone (0) as Punjab slipped to 126 for 5 in 12th over.

They couldn't recover from those blows and it was all over when Shashank Singh (37), Sam Curran (22) and Ashutosh Sharma (8) returned to the dugout.

Earlier, Kohli, who was dropped on 0 and 10, timed the ball nicely, used his feet and wrists to bring up his sixth IPL fifty this season. He reached his mark in 32 balls, before slamming another 40 in his next 15

balls. He cracked seven fours and six maximums.

Patidar, who was also given two lives, provided the early momentum as he slammed six maximums and three fours during his 23-ball 55.

After Patidar's dismissal, Kohli and Green continued the onslaught to take RCB past the 200-mark. Green hit five fours and a six before being caught in the final ball as RCB scored 77 in last five overs.

Pacer Vidhwath Kaverappa (2/36) picked up two wickets in the powerplay on his IPL debut but his figures could have been much better had the fielders not dropped three catches off his bowling.

Kohli was dropped in the third ball but Kaverappa dismissed Faf du Plessis (9) and removed Will Jacks (12) but PBKS couldn't create pressure as Sam Curran (1/50) and Harshal Patel (3/38) leaked runs.

Patel, who had dropped Patidar, conceded three boundaries in his first over as RCB scored 56 in the powerplay.

It started raining sixes thereafter as Kohli and Patidar slammed a maximum each to spoil Kaverappa's bowling figures.

Patidar then creamed spinner Rahul Chahar for three mighty maximums before depositing Arshdeep and Sam Curran for two more sixes, the last one bringing up his fifty in 21 balls.

After resumption, Kohli completed his fifty and hit Livingstone for two fours.

Green brought up the 150 with a four off Patel. Kohli then went berserk as he slog swept Livingstone for a six, while Curran was deposited over mid-wicket for a 94-metre maximum. He sent one over long-on for another maximum.

Dinesh Karthik (18) played a cameo before Patel claimed three wickets in last over.

#### New Zealand's Colin Munro announces retirement from international cricket

New Zealand batter Colin Munro has decided to call time on his international career after appearing in 123 matches for the Blackcaps across all formats of cricket. Munro last featured for New Zealand in their T20 series against India at the Bay Oval arena back in 2020.

WELLINGTON, May 10 (Agencies): New Zealand left-handed batter Colin Munro announced his retirement from international cricket after a career spanning 123 matches for the Blackcaps across all formats. The 37-vear-old has featured in 65 T20Is, 57 ODIs and a single Test for New Zealand, with his last appearance coming in their T20I home series against India back in 2020. With New Zealand announcing their pick of players for the upcoming T20 World Cup, Munro was one of the lot who did not make the cut. The usually explosive batter went on to cite his exclusion from the squad as the ideal window of opportunity to finally call time on his illustrious career.

At the end of Munro's international career, the batter finished sixth on the list of New Zealand's all-time leading T20I run-scorer with his 1,724 runs at an average of 31 and a strike-rate of 156.4. His prowess in the shortest format of the game saw three brilliant centuries, which is also the highest by any batter to have played for his national side.

Taking to his social media handles, Munro reflected on his time representing New Zealand and how he deems the time fit for his ultimate retirement from national team duties.

"Playing for the BlackCaps has always been the biggest achievement in my playing career. I never felt prouder than donning that jersey, and the fact I have been able to



do that 123 times across all formats is something I will always be incredibly proud of. I am today announcing my retirement from International cricket." Munro's post

said.

Munro went on to give his take on his absence from New Zealand's recent T20I fixtures, while reflecting on

the reasons behind that.

"Although it has been a while since my last appearance, I never gave up hope that I might be able to return off the back of my franchise T20 form. I completely

understand the reasons why that never happened, but with the announcement of the BlackCaps squad for the World T20 now is the perfect time to close that chapter officially. I can't wait to watch the boys do their thing in the Caribbean. I look forward to continuing to ply my trade across the world in the franchise arena." Munro added.

New Zealand Cricket chief Scott Weenink also reflected on Munro's career with the national side.

"Colin was one of our first players to embrace the aggressive, 360-degree style batting that is now accepted all around the world as best practice.

He was one of the pioneers of the new game, an innovative batsman who took calculated risk-taking to a new level, and led what was to become a revolution in the way short-form cricket was played. We thank him for his amazing contribution in more than hundred international games, and wish him well in his future pursuits." Weenink said.

Before making his international debut in New Zealand's tour of South Africa in 2012-13, Munro was also a crucial part of the side's 2006 ICC U19 World Cup campaign. His batting prowess saw him emerge as one of the key elements in New Zealand's white-ball formats, specifically due to his big hitting abilities at the top-order for his side. Munro also had a crucial role in New Zealand's 2014 and 2016 T20 World Cup campaigns, and the 2019 ODI World Cup squad.
