NC Srinagar candidate claims party workers arrested ahead of polling

SRINAGAR, May 12 (Agencies): National Conference candidate for the Srinagar Lok Sabha constituency Aga Ruhullah Mehdi on Sunday demanded immediate release of workers of his party and rival PDP who he claimed have been arrested ahead of the polling.

Voting in the Srinagar Lok Sabha constituency is scheduled on Monday.

"Our workers are being picked up by the police since yesterday. I got a call from a senior colleague like A R Rather sb informing me about the arrests of our workers from Chrarsharif. Similar calls from the colleagues from Khansahab and Chadoora. Would the @ECIS-VEEP please care to explain these arrests," Mehdi, an influential Shia leader, posted on X.

ate release of his party workers and also those of the PDP.

PDP leader Firdous Tak also took to social media, calling for an end to the alleged arrests and harassment of his party workers. PDP candidate for Srinagar Lok Sabha seat Waheed Para on Saturday alleged that some officials in the Jammu and Kashmir administration were trying to manipulate the Lok Sabha polls.

Without naming anyone, Para — a youth leader of the People's Democratic Party (PDP) — said the events are akin to the "rigging" of elections in

The 1987 Jammu and Kashmir Assembly elections are widely perceived to have been rigged, with the Farooq Abdullah-led National Conference sweeping the polls.

In another post, Para alleged police had arrested his party's polling agents.

"Sad to see police arresting and unlawfully detaining polling agents of the Jammu and Kashmir People's Democratic Party in the central Kashmir parliament constituency," he said.

Officials have refused to comment on the allegations levelled by the NC and PDP leaders.



The opposition bloc, which has parties such as Aam Aadmi Party (AAP), Congress, Trinamool Congress, Dravida Munnetra Kazhagam among others as its members, was formed to take on the BJP-led National Democratic Alliance in the Lok Sabha

Voters will end domination of Amid unprecedented security NC, PDP in Kashmir: BJP



NEW DELHI, May 12 (Agencies): The BJP may not be contesting any of the three Lok Sabha seats in Kashmir but the party is confident that the elections in the Valley will end the domination of the National Conference and People's Democratic Party in the region.

A day before Srinagar goes to the polls, BJP national general secretary Tarun Chugh claimed on Monday that the Narendra Modi government's development initiatives following the abrogation of Article 370 coupled with peace in the region have ensured that people are looking beyond family-run parties like the two regional outfits besides the Conaress.

"These parties are responsible for all the turmoil Jammu and Kashmir went through right from the 90s when terrorism erupted and

lakhs of Kashmiri Pandits had to flee their homes.

"People know that be it the PDP, NC or the Congress, their concerns are not the priority of these parties as they only want to perpetuate their family rule," said Chugh, who is overseeing his party's campaign in the region besides in Ladakh and Telangana. The Congress had jailed NC founder Sheikh Abdullah for over two decades but his son and grandson, Faroog Abdullah and Omar Abdullah, have joined hands with the same party, he said, adding that this underlines their "hunger for power and desperation".

Asked why the BJP is not contesting any of the three seats in the Valley, he said the party

setup, Srinagar LS constituency goes to polls on Monday

SRINAGAR, May 12 (Agencies): The stage is set for the prestigious Srinagar Parliamentary constituency which goes to polls on Monday amid unprecedented security arrangements put in place A total of 17,47,810

lakh voters including 8,75,938 male and 8,71,808 female voters besides 64 third gender electorates are eligible to exercise their franchise at 2,135 polling stations across the five districts of Srinagar, Pulwama, Budgam, Ganderbal, and Shopian.

There are around 11682 Persons with Disability and 705 persons above the age of 100 years who will also be exercising their fran-



chise, read a communiqu received from the office of Chief Electoral Officer, J&K. A total of 24 candi-

dates are in the fray and among them the prominent ones are National Conference Candidate Aga Syed Rohulla Mehdi, Peoples Democratic Party youth leader Waheed-Ur-Rehman Parra, and Apni Party's Ashraf Mir who are contesting from the Srinagar parliamentary seat.

The seat is dominated by the Jammu and Kashmir National Conference party, which has won 10 out of the 13 Lok Sabha elections. The only national party to ever win the Lok Sabha elections in Srinagar is Congress, which emerged victorious in the 1996 elections.

The election staff including Presiding Officers has been stationed in every polling station. In total, more than 8,500 polling staff, including reserves, will be deployed on duty on the polling day.

The voting will take place from 7.00 AM to 6.00 PM and before that, there will be a mock poll in the polling stations in Turn to page 9 recovered from terrorist hideout in Reasi JAMMU, May 12

(Agencies): Security forces on Sunday unearthed a terrorist hideout in a forest area in Reasi district of Jammu and Kashmir, recovering a huge cache of arms and ammunition, including nine Improvised Explosive Devices (IEDs) and three pistols, officials said.

The hideout was unearthed by the joint troops of Rashtriya Rifles and police during search and cordon operation in Kot Budhan forest in Mahore area this morning, the officials said.

Besides nine IEDs fitted with electric detonators and three pistols along with three magazines and 20 rounds, the forces also recovered one kg explosive powder, seven explosive safety fuses, 21 batteries of various types, 50 metre electric wire, 15 Ak assault rounds, eight metre rope, one blanket and three dressing bandages, the officials said.

They said the operation was still continuing when last reports were received.





got from mom. I had taken a 10 paisa coin from her purse to buy a kulfi without permission. Stealing is a bad habit was a lesson learnt, the harder way at that tender age of five. Her supervision and concern for me hasn't abated even after half a century of my existence. As the saying goes, life doesn't come with a manual, but it does come with a mother.

Born in a middle class family in the mofussil town of Nabha, she disregarded the patriarchal societal diktats that discouraged girls from various outdoor activities. Be it playing hockey for college or attending NCC camps or pursuing her passion for music, she didn't let gender hamper her dreams. Later, she chose to teach instrumental music as a profession, something that wasn't common among girls from the so-called 'good families'.

Finally retiring as a college principal, she was an epitome of women empowerment in her times.

Our father being in the Army was mostly away, posted in field areas. The responsibility of bringing up children singlehandedly fell upon her. During my years in boarding school, she would look me up every fortnight, travelling all the way in a bus on Sundays — the only easy day, perhaps, a working woman gets. When both her sons got commissioned, mom got the smartest salute from them. No doubt, a mother can take place of all others, but whose place no one else can

take.

On entering teenage, I would get a pestering dose of lectures against drugs and juvenile vices to refrain from. 'I have raised him this far, now I entrust you with the responsibility of grooming him for ethical soldiering' — she wouldn't hesitate even to 'instruct' my first commanding officer, who had been my father's subordinate in the same regiment.

A house proud octogenarian, she still manages her kitchen. On my getting married, she packed a 'working kitchen' for my bride, with an advice that the 'lady who manages the kitchen, controls the house'. Even today, she is our supplier of pickles, pinnis, homegrown mangoes and homemade wine. Before travelling, she never forgets to hand

us an artistically packed meal for the journey. Love is invariably the secret ingredient in her cooking.

She taught me the concept of God and that faith has always kept me anchored. A silent prayer of gratitude is better than a prayer of request, is what I learnt from her. Whenever the sea of life got rough, and for some reason I found God missing, I looked upon my mother to help me steer the right course.

Now, in the evening of her life, we don't have much time left under her protective wings. I dread the deafening silence that will follow once she returns to her maker. To the world, she is our mother, but to her family, she is the world.

I feel blessed that she has held my hand for such a long time, a privilege that has been denied to many.

Prioritise students' mental health over their exam results

HE harrowing words of an 18-year-old in her suicide note — "Mummy, papa I can't do JEE. So, I suicide, I am loser. I am worst daughter. Sorry mummy papa. Yahi last option he" — reflect a stark reality. As school education and entrance exam results come out, we are inevitably approaching a familiar crisis of student distress, with suicide as its most devastating outcome.

Once again, eye-catching posters of academic centres boasting of unprecedented success will grab the attention of students and parents alike. Driven by the conviction that tuition is indispensable, these centres contribute to what an Asian Development Bank report terms the shadow education market. The coaching industry in India currently generates revenue of Rs 58,088 crore, as reported by the Infinium Global Research, a consultancy firm based in Pune. Projections indicate that the industry's growth will escalate significantly, reaching Rs 1,33,995 crore by 2028.

The academic choices of students are frequently overlooked, shifting from the earlier medicine-engineering divide to a focus on STEM (science, technology, engineering and medicine). Parents' aspirations for the success of their children have given a boost to a system that has led to a proliferation of urban coaching centres. However, as emphasised by a report of the Joint Implementation Committee governing the IITs (Indian Institutes of Technology), this rush has created an imbalance. The report reveals that over 76 per cent

of the students hail from urban areas, with few coming from state board-affiliated schools. The rise of shadow education creates divisions among students, hindering improvement in schooling as influential parents gravitate towards it. Consequently, at a societal level, it worsens social stratification.

It is not advisable for traditional schooling to prioritise or emulate private coaching institutes, as this would result in catering only to a select few students while neglecting the broader student population. Such an approach can further marginalise the average student.

In India, STEM education is intensely competitive. For perspective, the prestigious IITs accept only one in 50 applicants, while Harvard admits one in 19 and Oxford one in six. Exams like the JEE and NEET are designed to be highly selective, where losing even a single mark can drop a candidate thousands of ranks. Consequently, parents, often unwittingly, and coaching centres, with clear culpability, treat students as commodities — based on the financial resources that well-intentioned but misguided parents are willing to invest.

The results could be devastating. High school student surveys in India reveal a disturbing prevalence of suicidal thoughts, ranging from 6 per cent to 22 per cent, according to the Indian Journal of Psychiatry. Our education and societal structures reinforce the idea that success is easily attainable through hard work, thus normalising the notion that young people should shoulder the blame for their perceived 'failures'.

According to the NCRB (National Crime Record Bureau), in 2020, a student committed suicide every 42

minutes in India, totalling over 34 suicides daily. Alarmingly, this grave crisis is often viewed as an individual issue, which absolves society of responsibility and overlooks systemic failures. In 2020, farmers made up 7 per cent of all suicides, highlighting an acknowledged agrarian crisis. Yet, even though students accounted for 8 per cent of suicides, society fails to recognise this as a sign of academic distress — a troubling oversight given that education is meant to prepare the next generation of nation-builders. Another study in the journal YMER underscores a grim reality: 80 per cent of students experience stress from the pressure to meet parental expectations, while 55 per cent cite parental imposition of choices as a significant stressor. These findings highlight a critical oversight in recognising the pivotal role of parents and counselling in addressing student mental health challenges.

The prevailing myth of the Indian family's unconditional support warrants scrutiny. As the fundamental social unit, the family influences the aspirations and ambitions of youth. The alarming increase in student suicides prompts us to reconsider the true nature of familial support and its potential role as a significant factor in this troubling trend.

The installation of spring-loaded fans that can't bear more than 40 kg of weight and 'anti-suicide nets' in Kota hostels highlights a disturbingly shallow response to student suicides that is callous and dehumanising. Not addressing the root causes of student distress is a societal failure.

Capitalising on the promise of a brighter future, coaching centres have risen to prominence within the education sector. Yet, these establishments are increasingly perceived as confinements for the hopeful youth who enrol, where their aspirations, spirits and ambitions are stifled.

Shadow education has become deeply entrenched. Policymakers must now explore methods of coexistence and seek symbiosis rather than confrontation. Forming partnerships could be instrumental in advancing social justice. The Government of India's guidelines for regulating coaching centres in 2024 must be followed by states and rigorously enforced. Since the shadow education sector operates on a business model, it should be held accountable for corporate social responsibility, including subsidising fees for economically weaker students, girls and those from rural backgrounds.

Teachers and parents must acknowledge the abundance of professional opportunities. Our culture must prioritise student mental health over exam results and impart virtues like perseverance, determination and patience in addition to academic success. In a world that can be a gruelling test, every youngster requires a strong social support system. It is crucial to instil in them the notion that suicide is never a solution, especially when systems are paradoxically designed to reject rather than select. Establishing multidisciplinary helplines for students in distress could be a crucial starting point in addressing this press-

Imagine their audacity. Their courage. Who is supporting them?" the prime minister said in an all-out attack on the state government.

Earlier, TMC MLA Humayun Kabir made controversial comments during an election rally in Murshidabad and said that Hindus would be drowned in the Bhagirathi River within two hours or else he would leave

Modi said that the development of the states of eastern India was neglected by the Congress party which governed the country for decades.

"After independence, family members of the Congress party governed the country for decades. They neglected the development of the states of eastern India. Whether it was West Bengal, Bihar, Jharkhand, or Odisha, Congress did nothing to harness the capabilities of these states. From natural resources to blue economy, these states have huge potential for economic growth across fields," he added.

He further said that 'Modi' will make East India the growth engine of Viksit Bharat.

"Today, we are creating a network of roadways, railways, and waterways in the eastern states of India... Dedicated freight corridors have amplified industrialization in this area. The upcoming years will be dedicated to furthering the development of West Bengal and the surrounding states," he said.

Modi claimed that in the Lok Sabha elections 2024, the Bharatiya Janata Party will do better in Bengal as compared to 2019 when it bagged 18 seats. "West Bengal is an important state for us. The Congress ruled for 50 years, but the people of eastern India only got poverty despite the states being capable. These states have mineral resources, fertile land. These states also have tourism potential. I have decided to make these states an engine of growth for Viksit Bharat," the PM said at the rally.

a roadshow in Barrackpore. Voting will take place for eight Lok Sabha seats of West Bengal in the fourth phase of voting to be held on May 13. The constituencies are Baharampur, Krishnanagar, Ranaghat, Bardhaman Purba, Burdwan-Durgapur, Asansol, Bolpur and Birbhum.

In the 2014 Lok Sabha elections, the TMC won 34 seats in the state, while the BJP had to settle for 2 seats. The CPI (M) won 2 seats, while the Congress bagged 4.

sage on X. Mr Rathorre, who is the chief spokesperson of the Congress' Bihar unit, also shared a video to claim that the chief electoral officer of Bihar is herself monitoring the checking of

Kharge's helicopter in Samastipur.

The video showed a helicopter with officials, including from police, around it.

"The Election Commission (EC) should clarify whether such checking of choppers of Congress leaders is routine and whether similar checks were also conducted on top leaders of the NDA," Mr Rathorre said in his video message.

"The EC should make all such records public, otherwise it will be construed that it is only targeting opposition leaders to stop them, and is letting NDA leaders go freely," he said.

The Congress spokesperson said the EC should put out videos of all leaders who have been checked.



11 dead, mostly students, in Indonesia bus crash after brakes apparently failed, police say

The bus carrying 61 students and teachers was returning to a high school in Depok outside Jakarta



BANDUNG, May 12 (Agencies): A bus slammed into cars and motorbikes after its brakes apparently malfunctioned in Indonesia's West Java province, killing at least 11 people, mostly students, and injuring dozens of others, officials said on Sunday.

The bus carrying 61 students and teachers was returning to a high school in Depok outside Jakarta, the capital, on Saturday from the hilly resort area of Bandung after a graduation celebration, said West Java police spokesperson Jules Abraham Abast.

It sped out of control on a downhill road and crossed lanes, hitting several cars and motorbikes before it crashed into an electricity pole, he said.

Nine people died at the scene and two others died later in the hospital, including a teacher and a local motorist, Abast said. Fifty-three other people were hospitalised with injuries, including some in critical condition, he said.

"We are still investigating the cause of the accident, but a preliminary investigation showed the bus's brakes malfunctioned," Abast said. Local television footage showed the mangled bus in the darkness on its side, surrounded by rescuers, police and passersby as ambulances evacuated the injured.

Amid Tensions, Iran's Big Nuclear **Bomb Warning To Israel**

TEHRAN, May 12 (Agencies): An adviser to Iran's Supreme Leader Ayatollah Ali Khamenei has reignited concerns over the country's nuclear ambitions, particularly in light of escalating tensions with Israel. Kamal Kharrazi, the adviser, hinted at a shift in Iran's nuclear doctrine if its existence is perceived to be under threat by Israel.

"We have no decision to build a nuclear bomb, but should Iran's existence be threatened, there will be no choice but to change our military doctrine," Kharrazi said.

Tensions between Iran and Israel reached a tipping point when the former launched a barrage of explosive drones and missiles directly targeting Israeli territory, in response to the bombing of Iran's embassy in Syria's capital Damascus earlier in April.

the head of the IAEA, expressed

frustration over Iran's alleged

lack of cooperation, highlight-

ing the urgency for concrete measures to address outstanding concerns regarding Iran's nuclear activities.

Last year, Iran made commitments to assist in investigating uranium particles found at undeclared sites and reinstall monitoring equipment. However, the IAEA reports indicate that these assurances have not resulted in significant advancements.

"The present state is completely unsatisfactory for me. We are almost at an impasse and this needs to be changed," Grossi said, as quoted by news

During discussions between Grossi and Iranian officials, both sides acknowledged the 2023 agreement as a potential framework for cooperation, but implementation has been slow. Additionally, concerns were raised about external interference, particularly from Israel, which Iran views as a hostile actor.

Trump Could Owe Over \$100 Million In Taxes If He Loses Audit Case: Report

WASHINGTON DC, May 12 (Agencies): Former US President Donald Trump could owe more than USD 100 million in taxes if he loses years-long Internal Revenue Service (IRS) inquiry into his claims of huge losses on his Chicago skyscraper, the New York Times reported.

According to an Internal Revenue Service inquiry uncovered by The New York Times and ProPublica, Trump used a "dubious accounting maneuver" to claim improper tax breaks from his troubled Chicago tower.

The 92-storey, glasssheathed skyscraper along the Chicago River is the tallest and, the last major construction project by Trump.

But when Trump sought to reap tax benefits from his losses, the IRS. has argued, he went too far and. in effect, wrote off the same losses twice. The first write-off came

on Trump's tax return for 2008. With sales lagging far behind projections, he claimed that his investment in the condohotel tower met the tax code definition of "worthless," because his debt on the project meant he would never see a profit.

That move resulted in Trump reporting losses as high as USD 651 million for the year, the report stated.

But in 2010, Trump and his tax advisers sought to extract further benefits from the Chicago



project, executing a manoeuvre that would draw years of inquiry from the IRS. First, he shifted the company that owned the tower into a new partnership. Then, he used the shift as justification to declare USD 168 million in additional losses over the next decade.

7 security personnel killed in twin attacks in Pakistan's North Waziristan



PESHAWAR, May 12 (Agencies): At least seven security personnel have been killed and two injured in two separate militant attacks on security forces in Pakistan's Khyber Pakhtunkhwa province, authorities said on Sunday.

Local officials said five security personnel were killed and two injured during the first attack that took place in the Hassan Khel area of North Waziristan district, bordering Afghanistan, in when an improvised explosive device went off targeting a bomb disposal unit on Saturday.

Militants opened fire on the forces

soon after the blast triggered off, Dawn News quoted the official as saying.

In another incident, militants stormed a security post in the Seeman area of the same district, killing two security personnel on Saturday, local authori-

They said the bodies of the security personnel and the injured were airlifted to Combined Military Hospital in Bannu. Security forces cordoned off the areas immediately after the attacks and launched search operations in the

The two attacks come after a private girls' school was blown up by militants in Shewa tehsil of North Waziristan district on the night of May 8, police said.

The police said the militants first tortured the watchman and later blew up two rooms of the school.

Similar attacks took place in May last year when two government schools for girls in Mirali had been blown up. No loss of life was reported in the inci-

Meta Is "Super Greedy": Elon Musk Hits Out At Rival Over Ad Campaigns

SAN FRANCISCO, May 12 (Agencies): Tesla and SpaceX CEO Elon Musk on Sunday said that Mark Zuckerberg-run Meta is "super greedy" at taking credit for advertisers who run campaigns on its platform.

post, saying several of his advertisers noticed that while running campaigns on both X and Meta, nearly all conversions are attributed to Meta, "with X reporting almost no conversions."

A Musk follower raised this issue in a

"Interestingly, when X ads are turned off, total conversions significantly drop, including those reported on Meta. No research is needed to understand what's going on here," the follower commented

The X owner replied that "we are terrible at claiming credit, and Meta is super greedy at claiming credit.'

Another Musk follower posted that eventually, "Meta will need to revise their attribution model, revealing the



truth to advertisers who are already noticing a decline in results."

"For X, refining the attribution model to align more closely with reality is relatively straightforward. This will show even better outcomes for advertisers," the X user suggested.

The rivalry between Musk and Zuckerberg is well known.

They were apparently set for a "cage fight' some time back -- dubbed as the fight of the century.

However, the much-anticipated showdown between the duo was cancelled.

Wary of wars in Gaza and Ukraine, old foes Turkey and Greece test a friendship initiative

ANKARA, May 12 (Agencies): Old foes Turkey and Greece will test a five-monthold friendship initiative Monday when Greek Prime Minister Kyriakos Mitsotakis visits

The two NATO members, which share decades of mutual animosity, a tense border and disputed waters, agreed to sideline disputes last December. Instead, they're focusing on trade and energy, repairing cultural ties and a long list of other items placed on the so-called positive agenda.

Here's a look at what the two sides hope to achieve and the disputes that have plagued ties in the past:

FOCUSING ON A POSITIVE AGENDA Mitsotakis is to meet with Turkish President Recep Tayyip Erdogan in Ankara on Monday as part of efforts to improve ties following the solidarity Athens showed Ankara after a devastating earthquake hit southern Turkey last year.

The two leaders have sharp differences over the Israeli-Hamas war, but are keen to hold back further instability in the eastern Mediterranean as conflict also continues to rage in Ukraine.

"We always approach our discussions with Turkey with confidence and with no illusions that Turkish positions will not change from one moment to the next," Mitsotakis said last week, commenting on the visit. "Nevertheless, I think it's imperative that when we disagree, the channels of communication should always be open."

"We should disagree without tension and without this always causing an escalation on the ground," he added.

Ioannis Grigoriadis, a professor of political science at Ankara's Bilkent University, said the two leaders would look for ways "to expand the positive agenda and look for topics where the two sides can seek win-



win solutions," such as in trade, tourism and migration.

EASY VISAS FOR TURKISH TOURISTS Erdogan visited Athens in early December, and the two countries have since maintained regular high-level contacts to promote a variety of fence-mending initiatives, including educational exchanges and tourism.

Turkish citizens this summer are able to visit 10 Greek islands using on-the-spot visas, skipping a more cumbersome procedure needed to enter Europe's common travel area zone, known as the Schengen

"This generates a great opportunity for improving the economic relations between the two sides, but also to bring the two stable societies closer — for Greeks and Turks to realize that they have more things in common than they think," Grigoriadis said.

A HISTORY OF DISPUTES Disagreements have brought Athens and Ankara close to war on several occasions over the past five decades, mostly over maritime borders and the rights to explore for resources in the Aegean and eastern Mediterranean seas.

The two countries are also locked in a dispute over Cyprus, which was divided in 1974 when Turkey invaded following a coup by supporters of union with Greece. Only Turkey recognizes a Turkish Cypriot declaration of independence in the island's northern third.

The dispute over the exploration of energy resources resulted in a naval standoff in 2020 and a vow by Erdogan to halt talks with the Mitsotakis government. But the two men met three times last year following a thaw in relations and a broader effort by Erdogan to reengage with Western countries.

The foreign ministers of the two countries, Hakan Fidan of Turkey and George Gerapetritis of Greece, are set to join the talks Monday and hold a separate meeting.

RECENT DISAGREEMENTS

Just weeks before Mitsotakis' visit, Erdogan announced the opening of a former Byzantine-era church in Istanbul as a mosque, drawing criticism from Greece and the Greek Orthodox church. Like Istanbul's landmark Hagia Sophia, the Chora had operated as a museum for decades before it was converted into a mosque.

Turkey, meanwhile, has criticized recently announced plans by Greece to declare areas in the Ionian and Aegean seas as "marine parks" to conserve aquatic life. Turkey objects to the one-sided declaration in the Aegean, where some areas remain under dispute, and has labelled the move as "a step

that sabotages the normalization process." Grigoriadis said Turkey and Greece could focus on restoring derelict Ottoman monuments in Greece and Greek Orthodox monuments in Turkey. "That would be an opportunity" for improved ties, he said.

Brazil authorities warn of more floods, landslides as new rains hit south

PORTO ALEGRE, May 12 (Agencies): New rains in waterlogged southern Brazil are expected to be heaviest between Sunday and Monday, authorities have warned, bringing fresh misery to victims of flooding that has killed 136 people so far.

State authorities warned late Saturday of the risk of further rising waters and landslides.

"We are still experiencing an emergency situation," Rio Grande do Sul Governor Eduardo Leite said in a video on Instagram.

Heavy rains last week caused rivers in the agricultural state to overflow, leaving 806 injured and 125 missing in addition to those killed, the civil defense agency said.

"Many people see the rain and are traumatized. We've seen how scared people are," said Enio Posti, a firefighter in Porto Alegre, capital of stricken

Rio Grande do Sul state. Of the more than two million people affected by the flooding, more than 537,000 have been forced from their homes with 81,000 in shelters

17 companies to start making laptops, PCs

27 approved cos will lead to investment of Rs 3K cr, direct jobs of 50K, indirect jobs of 1,50,000

NEW DELHI, May 12 (Agencies): Nearly 17 companies selected under the PLI (Production Linked Incentive) for IT Hardware will begin production in this financial year (FY25), said S Krishnan. Secretary of Ministry of Electronics and IT (MeitY). Six-seven companies out of 27 had started production last year.

Krishnan also mentioned that the government has been periodically reviewing the progress of the PLI incentive scheme and is quite satisfied with its prog-

The government introduced a revised PLI scheme of Rs 17,000 crore for IT hardware in May 2023. The objective of this initiative was to boost the domestic production of laptops, tablets, all-in-one PCs, servers, and ultra-small form factor devices within the country.

"Out of the 27 companies, a majority are expected to start production during the current year, which is 2024-25. I think



if I recall the numbers correctly, about 17 companies are expected to start this year. About six or seven companies had started last year, and two companies are starting next year," said Krishnan.

In November 2023, the government had approved the applications of 27 companies, including Dell, HP, Foxconn, and Lenovo for the PLI schemes for IT hardware.

The minister for electronics and information, Ashwini Vaishnaw, while announcing the applicants, said this move will make India a major force in the manufacturing of PCs, servers, laptops, and tablets.

He added that these 27 companies will lead to investment of Rs 3,000 crore, direct employment of 50,000, and indirect employment of 1,50,000.

Companies approved under

the PLI scheme include Dell, Foxconn, HP, Lenovo, Flextronics, VVDL, Rising Stars Hi-Tech, India Sales, Padget Electronics, SOJO, VVDN, and others.

However, the government has not yet released any incentives under the scheme to any companies as the scheme took off in the last quarter of this financial year. Therefore, the companies need to complete audits and other requirements. "So, not yet (releasing incentives). We are awaiting... Because, you know, the PLI scheme started in the last quarter of last year. The companies have to get their audits and things completed," said Krishnan.

Nearly 44 major technology companies, including all significant players, applied for the scheme. According to Counterpoint Research firm, India's total laptop or PC market size amounts to close to \$8 billion annually, with approximately 65% of units being imported.

Social commerce platform Meesho raises \$275 million

NEW DELHI, May 12 (Agencies): Social commerce platform Meesho has raised \$275 million, a regulatory filing by the company with the Securities and Exchange Commission (SEC) in the US has revealed.

The fundraising, part of an ongoing round, came from existing investors like SoftBank, Prosus, Elevation Capital and Peak XV Partners

The latest funding valued Meesho at \$3.9 billion. Meesho may increase the ongoing round size to \$500-600 million, according to

The SEC regulatory filing also indicated a share transfer at Meesho's US parent firm.

The company did not divulge much information about further details about share transfer.

In January this year, global investment firm Fidelity had marked down the value of its holding in social commerce platform Meesho, to \$3.5 billion.

The e-commerce platform has Meta, Peak XV, Prosus Ventures, B Capital, and SoftBank among its investors.

Its current gross merchandise value (GMV) run rate is over \$5 billion, according to reports.

Study reveals who should take preventive treatment for TB

NEW DELHI, May 12 (Agencies): People with confirmed tuberculosis (TB) infection—that is a positive skin or blood test-should take the preventive treatment, regardless of age, finds a study.

Preventive treatment for tuberculosis (TB) can stop latent TB infections (with no symptoms) from developing into deadly diseases later.

Notably, researchers from Boston University in the US found that preventive TB treatment was not effective in most individuals who did not show evidence of infection, except for children

Among 439,644 participants, the team found that preventive TB treatment was 49 per cent effective among the 2,496 individuals who developed TB, but particularly among individuals with a positive skin or blood test (for which the effectiveness was 80 per

"While it is critical to find and treat people who are spreading TB in the community, the threat of global TB will never end until people with latent TB receive treatment. The results of this study show just how effective such treatment can be," said Dr. C. Robert Horsburgh, professor of global health at the varsity's School of Public Health.

"Tuberculosis affects tens of millions



of people every year and has longterm lasting effects, even after people recover. Finding ways to optimise prevention is really important to tackle the epidemic," said lead author Dr. Leonardo Martinez, assistant professor of epidemiology.

The team also estimated the number of needed-to-treat (NNT) to prevent one person from developing TB dis-

Regardless of infection status, the NNT was lower in high-burden settings (29 to 43 people) versus low-burden settings (213 to 455 people), the study showed

"Despite the fact that individuals with negative blood or skin tests do not seem to benefit from preventive treatments, the researchers say the overall low NNT may justify prioritising this treatment to all exposed contacts in areas where testing for TB infection is inaccessible," the team said.

A 30-year-long Harvard study reveals ultra-processed foods linked to early death

NEW DELHI, May 12 (Agencies): A recent study by Harvard University, spanning over 30 years and tracking 1,14,000 participants, has highlighted the risks associated with consuming ultra-processed foods (UPF).

Higher consumption of most ultra-processed foods is linked to a slightly higher risk of death, with ready-toeat meat, poultry, and seafood-based products, sugary drinks, dairy-based desserts, and highly processed breakfast foods showing the strongest associations.

Ultra-processed foods are those food items that contain additives and ingredients not commonly found in home kitchens, such as artificial sweeteners, colours, and preservatives. These are



foos that are high in saturated fats and lack nutrients and fibre.

The research, published in the BMJ, revealed alarming findings: people who regularly consumed ultraprocessed meats faced a 13% higher likelihood of premature death over the study period.

Moreover, those with diets high in sugary and artificially sweetened beverages saw a 9% increase in the risk of early death.

Overall, diets rich in ultra-processed foods were associated with a 4% higher chance of mortality.

During an average 34-year follow-up period, the researchers identified 48,193 deaths, including 13,557 deaths due to cancer, 11,416 deaths due to heart diseases, 3,926 deaths due to respiratory diseases. and 6,343 deaths due diseases.

Eating too much ultra-

processed food can be bad for your health, especially certain types. Ready-to-eat meats, sugary drinks, desserts, and breakfast foods are linked to a higher risk of death. So, it's best to limit these kinds of foods in your diet. The researchers

concluded, "The findings provide support for limiting consumption of certain types of ultra-processed food for long term health. Future studies are warranted to improve the classification of ultra-processed foods and confirm our findings in other populations.

Previous studies have also linked UPFs to a range of health issues, including cancer, mental health problems, type 2 diabetes, and premature

In Western countries, UPFs now make up a significant portion of the average person's diet, comprising as much as half of daily food intake. Among younger people and those with lower incomes, this pro-

portion can soar to 80%.

To combat these concerning trends, experts suggest focusing on unprocessed and minimally processed foods, which include fruits, vegetables, nuts, seeds, and unprocessed animal products like eggs, fish, and meat.

These foods, which make up about 30% of the typical UK diet, provide essential nutrients without the harmful additives found in ultraprocessed options.

This study highlights the importance of public health initiatives aimed at reducing reliance on ultra-processed foods for better overall health and longevity.

Colorectal cancer cases more than tripled among teens in just two decades

NEW DELHI, May 12 (Agencies): Colon cancer, also called colorectal cancer, occurs in the large intestine or the rectum. This type of cancer is highly treatable and often curable when localised in the bowel.

Though this disease was earlier witnessed in people over 50, more young people are getting diagnosed with colon cancer.

In a recent study, which will be presented at the Digestive Disease Week 2024, researchers have found that colorectal cancer incidence has increased steadily among young people in the US over the last two decades.

The research conducted between 1999 and 2020, found that the rate of colorectal cancers grew 500% among children ages 10 to 14, 333% among teens aged 15 to 19, and 185% among young adults ages 20 to 24.

"Colorectal cancer is no longer considered just a disease of the elderly population.

It's important that the public is aware of signs and symptoms of colorectal cancer," said lead researcher Dr Islam Mohamed, an internal medicine resident physician at the University of Missouri-Kansas City.

The most common symptoms for colorectal cancer identified in patients with early onset colon cancer were changes in bowel



habits in terms of either constipation or diarrhea, abdominal pain, rectal bleeding and signs of iron deficiency anemia, Mohamed said.

Colorectal cancer rates continue to rise across higher age brackets, with a 71% increase among those aged 30 to 34 and a 58% rise among those aged 35 to 39.

Risk factors for colon cancer, as per the study, include a family history of inflammatory bowel disease or colorectal cancer.

Other modifiable risk factors include obesity, tobacco use, alcohol consumption and dietary habits such as low fibre intake, consumption of processed meats or sugar-sweetened beverages

and a high-fat diet. The study cited inactive lifestyle, the presence of bacteria that tend to cause tumors, antibiotic usage, and dietary additives being potential causes but not firmly established contributors to colorectal cancer.

Even though the percentage increase was comparatively lower among those aged 40 to 44, this group exhibited the highest incidence rate, reaching 20 cases per 1.00,000 people in 2020.

These findings highlight the urgent need for awareness, early detection, and targeted interventions to combat the rising cases of colorectal cancer among younger generations.

In India, according to a 2023 study by the Delhi State Cancer Institute (DSCI), colon cancer is shifting to young people in the age group of 31 to 40 years.

Pressure to be perfect raising burnout in parents, anxiety in children: Study


Parent's mental health and behaviours strongly impact their children's mental health

NEW DELHI, May 12 (Agencies): Societal pressure to be perfect is increasing parental burnout and raising the risk of children suffering from stress, anxiety, and depression, a study revealed.

Researchers from The Ohio State University found that the pressure to try to be 'perfect' leads to unhealthy impacts on both parents and their children.

Their study, based on a month-long survey of more than 700 parents in the US, showed that 57 per cent of parents self-reported burnout.

The study defined "parental burnout as strongly associated with internal and external expectations, including whether one feels they are a good parent, perceived judgement from others, time to play with their children, the relationship with their spouse and keeping a



clean house."

"The illusion and expectations of 'perfect parenting' can be deflating," said Kate Gawlik, one of the lead researchers on the study and an associate clinical professor at the Ohio State College of Nursing.

"I think social media has just really tipped the scales. We have high expectations for ourselves as parents; we have high expectations for what our kids should be doing. Then, on the flip side, you're comparing yourself to other people and other families, and there is a lot of judgement that goes on. And whether it's intended or not, it's still there," said Gawlik, who pursued this research based on her experience as a working mother of four.

Notably, the parent's mental health and behaviours strongly

impact their children's mental health. If children have a mental health disorder, parents report a higher level of burnout and a greater likelihood for them to insult, criticise, scream at, curse at, and/or physically harm their children (that is, repeated spanking).

On the other hand, quality time spent with parents reduced children's mental health issues such as anxiety, depression, obsessivecompulsive disorder, attention deficit hyperactivity disorder, and bipolar disorder.

The study suggested parents boost their connection with children and become active listeners, while also "catching, checking and changing negative thoughts into positive ones; readjusting expectations for the parent and the child; and reflecting and acting on priorities".

Ranji Trophy likely to be played in two halves in **2024-25 season**

The BCCI is likely to split the prestigious Ranji Trophy into two halves with the white-ball tournaments Syed Mushtaq Ali Trophy and Vijay Hazare Trophy being held in between for the 2024-25 season.

NEW DELHI, May 12 (Agencies): The BCCI is likely to split the prestigious Ranji Trophy into two halves with the whiteball tournaments Syed Mushtag Ali Trophy and Vijay Hazare Trophy being held in between for the 2024-25 season.

It is learnt that a draft proposal for the restructuring of the domestic cricket calendar for the 2024-25 season has been sent to the the board's apex council.

The proposal has been made after consultation with BCCI secretary Jay Shah, India captain Rohit Sharma, chairman of selectors Ajit Agarkar, head coach Rahul Dravid and National Cricket Academy head VVS

Another proposal is the doing away with the toss for the CK Nayudu Trophy, which will also be organised with a new points

As per the new proposed format, five Ranji Trophy league matches will be followed by white ball tournaments -- Syed



Mushtaq Ali Trophy and Vijay Hazare Trophy. The remaining two Ranji league matches as well as the knockout stage games will then be held after the conclusion of the two white-ball tournaments.

'Increased gap between matches'

This has been done in order to meet the challenges posed by inclement weather in the northern part of the country in winter months as well as to ensure gaps between matches.

The BCCI has also taken into account the fact that last season's Ranji Trophy was organised with games having only three-day gaps in between including travelling, which did not give players adequate time

to rest and recover.

"There will be an increased gap between matches to allow players sufficient time for recovery and to maintain peak performance throughout the season," Shah informed the media.

As per the proposal, the domestic season will begin with Duleep Trophy, which will feature four teams to be picked by the national selectors.

The Irani Cup will follow the Duleep Trophy after which the Ranji Trophy will be held in two halves.

In the CK Nayudu Trophy which won't feature the toss of coin, the visiting team will have the right to decide whether to bat or bowl first.

"The CK Nayudu Trophy will implement a new points system aimed at promoting balanced performances. This includes awarding points for batting and bowling performances in the first innings, in addition to points for the first innings lead or outright win," said Shah.

The Board will also be assessing the effectiveness of the new point system employed for the CK Nayudu Trophy at the end of the season and a decision would be taken if the same has to be implemented for the Ranji Trophy as well for the following season.

England legend James Anderson to retire after Lord's Test against **West Indies**



LONDON, May 12 (Agencies): Legendary pacer James Anderson announced that the first Test against the West Indies this summer will be his final appearance for England, bringing down the curtains on an illustrious career spanning over 20 years.

Regarded as one of the greatest bowlers of all time, the 41-year-old is England's leading wicket-taker and one of only three bowlers to take over 700 Test scalps.

"Hi everyone. Just a note to say that the first Test of the summer at Lord's will be my last Test," Anderson wrote on his Instagram.

"It's been an incredible 20 years representing my country, playing the game I've loved since I was a kid. I'm going to miss walking out for England

so much. But I know the time is right to step aside and let others realise their dreams just like I got to, because there is no greater feeling," he added.

Anderson's announcement comes after England red-ball coach Brendon McCullum conveyed to the seamer that they are looking at the future, with an eye on the Ashes 2025-26 in

Anderson made his Test debut back in 2003 and has since claimed a remarkable 700 wickets in 187 Test matches.

He currently ranks third on the all-time list of Test wicket-takers, trailing behind spinners Muttiah Muralitharan of Sri Lanka and Australia's Shane Warne.

However, whether Anderson will continue playing for his county side Lancashire remains unclear.

"I couldn't have done it without the love and support of Daniella, Lola, Ruby and my parents. A huge thank you to them. Also, thank you to the players and coaches who have made this the best job in the world. Thank you to everyone who has supported me over the years, it's always meant a lot, even if my face often doesn't show it." Anderson wrote.

England are set to play a three-Test series against the West Indies, starting with the opener at Lord's on July 10.

KKR become 1st team to qualify for IPL 2024 playoffs after MI win

'Play Rohit Sharma at No.4': Hayden's startling swap for T20 World Cup, suggests new position for Virat Kohli

Matthew Hayden has come up with a fresh new idea around India's batting lineup for the T20 World Cup.



In response to the strike rate debate around Kohli last week, Hayden admitted that given the firepower present in the Indian lineup, the team does not need to alter the former India captain's usual batting position. And in conversation with his daughter and Star Sports presenter



Grace Hayden, he reliefated the same, stressing in the importance of a right-left combination at the top of the order.

"No they shouldn't do that. The reason why I say that is because you definitely need a left-right combination at the top. So I would definitely go with Jaiswal and Rohit," he said.

However, Hayden quickly suggested that contrary to the combination of captain Rohit Sharma opening alongside lefthanded Yashasvi Jaiswal, India



the order and put Kohli in his stead in the lineup. In a bid to maintain the left-right combination, the former Australia batter suggested that Kohli could open with Jaiswal, while Suryakumar Yadav could take the No. 3 spot in the line-up followed by Rohit at No. 4.

"If you have to make a change in that combination, I would be very happy...if you would tell me if I could open with Kohli and Jaiswal, I would have said

absolutely yes. Then I would slot Suryakumar Yadav at 3 and Rohit at No.4. And that top four, in my opinion, is the right combination. The reason I say that is Virat is a master of the first six. And once the power hitting comes into play, there are other great options including Rohit. Look at his figures at No. 4, they are superb. Those are better than his opening numbers," Hayden added. Out of his total appearance of

151 international matches for India in the 120 format, where Rohit has scored 3974 runs, he has batted outside the opening position in 27 innings, scoring 481 runs with five fifties. Eight of those innings came when he walked out at No. 4 for India, the last being in 2022, and smashed 188 runs at a strike rate of 122.87 with two fifties. In IPL, he batted at No. 4 in 91 innings, the last being in 2018, scoring 2565 runs at a strike rate of 130 with 20 fifties.

In-form RCB eye fifth win in a row against Pant-less DC

BENGALURU, May 12 (Agencies): Bengaluru. Pushed into a tight corner, Royal Challengers Bengaluru rose above their frailties to notch four wins on the trot to stay alive in the race to play-offs, but Delhi Capitals even sans their suspended skipper Rishabh Pant offer them a different challenge in the IPL match here on Sunday.

Pant was suspended for one match and handed a fine of 30 lakh for maintaining slow over rate against Rajasthan Royals at Delhi on May 7. It was DC's third offence

of the season; hence the suspension came in vogue immediately leading to Pant missing the match against RCB.

While the absence of Pant will certainly give RCB an edge, they can't get themselves lulled into a comfort zone.

In the run-up to this match, RCB defeated Gujarat Titans twice, Punjab Kings and Sunrisers Hyderabad once

While the victory over SRH was valiant, RCB did not face much challenge from the floundering Titans and Kings. But the Capitals are a team

unlike any other as they have oscillated between brilliant and ordinary in the span of a few days.

On April 27, the Pant-led side posted a hefty 257/4 in their 10-run win over Mumbai Indians and on April 29, they made a lowly 153/9 while capitulating against Kolkata Knight Riders.

The RCB, currently seventh with 10 points from 12 matches, will desperately hope not to run into that brilliant Capitals as a defeat can undo their good work in the last four matches.

But their confidence will be high, courtesy strong and consistent batting effort led by talisman Virat Kohli.

Kohli is the leading rungetter in this IPL with 634 runs but, more importantly, those runs have come at a



early momentum while setting or chasing targets.

Along with Kohli, additional runs from skipper Faf du Plessis, Rajat Patidar, Cameron Green and Dinesh Karthik have provided their bowlers, who have responded to the call splendidly, with a cushion.

The transformation of RCB bowlers in the last four matches have been nothing short of remarkable.
