The place of worship was found vandalised by a visitor in a village in the Dharmari area on Saturday evening, sparking tension and protests.





Three New Criminal Laws came into force: LG

New laws will ensure justice and equality for all, moving away from repressive colonial framework: Sinha

Top News Report

SRINAGAR, Jul 1: Historic Day in Indian Criminal Justice System as new Criminal Laws came into force today. To mark this momentous occasion, the Lieutenant Governor Manoj Sinha presided over the implementation ceremony of the new Laws in J&K, at Police Headquarters.

Chief Justice, J&K and Ladakh High Court Justice N. Kotiswar Singh also graced the occasion.

In his address, the Lt Governor expressed gratitude to the Prime Minister Narendra Modi and Home Minister Amit Shah for bringing the much-needed reforms in the Criminal Justice System of the country.

He said the commencement of 3 new laws- 'Bharatiya Nyaya Sanhita', 'Bharatiya Nagarik Suraksha Sanhita' and 'Bharatiya Sakshya Adhiniyam'- breaks the centuries-old shackles of colonial legacy.

"The new laws will ensure justice and equality for all, moving away from the repressive colonial framework. The reforms, rooted in the principles of liberty and fraternity, are a testament to our commitment to protect the vulnerable and ensure justice for all," the Lt Governor said.

The Bharatiya Nyaya Sanhita replaces the Indian Penal Code of 1860, focusing on restorative justice and victim rights. This law shifts the focus from mere punishment to rehabilitation and reintegration. It aims to address the root causes of crime and offer offenders a chance to reform and contribute positively to society.

The Bharatiya Nagarik Suraksha Sanhita replaces the Criminal Procedure Code of 1973, ensuring swift and fair trials. This law introduces



measures to reduce delays in the justice delivery system, ensuring that justice is not only done but seen to be done on time. It also emphasizes the protection of the rights of the accused while ensuring public safety.

The Bharatiya Sakshya Adhiniyam replaces the Indian Evidence Act of 1872, modernizing evidence collection and use. This law uses modern technology to ensure the accuracy and integrity of evidence. It introduces digital documentation and forensic advancements to strengthen the credibility of the judicial process.

Speaking on the overarching objectives of the new criminal laws, the Lt Governor said the new laws, based on individual freedom and human rights, reflect a major shift towards a more humane and just system.

"Designed to protect victim rights and ensure justice with a focus on human dignity, moving away from punitive colonial measures, new criminal laws acknowledge that every individual, regardless of their past, has the potential for change. New laws focus on restorative justice, where the emphasis is on repairing the harm caused by criminal behaviour and reintegrating offenders into

society," the Lt Governor said. Highlighting the new provisions incorporated to suit contemporary times and technologies, the Lt Governor said, the new Criminal Laws addresses the issues like terrorism, sedition, and mob lynching and ensures our system is just, humane, and future-ready.

By incorporating technological advancements, new laws will enhance the efficiency and transparency of our justice system. This includes the use of digital tools for evidence collection, case management, and communication among the five pillars of criminal justice system, he observed.

The Lt Governor underlined the need to remain vigilant about the potential misuse of technology, which could undermine the very justice we look to uphold. He also spoke on the substantial investment in infrastructure and training required with the integration of forensic technology, and digital procedures.

Ensuring data security and protecting the privacy of individuals is paramount. It is imperative to build robust systems that create a firewall against criminals, protect our citizens, and foster peace and development, the Lt Governor said.

On the occasion, the Lt Governor called for collective efforts to realize the full potential of the new reforms and ensure that justice is served efficiently and equitably.

He emphasised that all the stakeholders of the criminal justice system must nurture new laws collabora-

"We embark on a journey towards a more just and fair society. These reforms uphold the rule of law, protect human rights, and ensure justice. The major challenge of training our core personnel in all the verticals has been accomplished, including joint trainings. J&K Police has been instrumental in training their core IOs, augmenting the material and human resources, and adapting to the technological challenges and working on legal changes. Let's work together to implement these changes, ensuring trust in a fair, transparent, and just

legal system," the Lt Governor said. The Lt Governor further called for generating awareness on the new laws amongst the citizens, law enforcement agencies, stakeholders, legal fraternity, prosecutors, district administration officials, academia and students.

He also congratulated the Jammu Kashmir Police on registering the First F.I.R under the provision of the new Laws.

Chief Justice, J&K and Ladakh High Court Justice N. Kotiswar Singh, in his address, said the new Criminal Laws is the reflection of the Resurgent India, Confident India building on its own destiny based on its rich heritage.

AJKPC outlines key budget demands of J&K to Union Finance Minister

JAMMU, July 1: The All Jammu and Kashmir Panchayat Conference (AJKPC), a registered organization working for the welfare of the rural population and strengthening grassroots democracy in J&K, has put Union Finance Minister Nirmala Sitharaman on notice by presenting several demands ahead of the Union Budget.

During a press conference in Jammu, Anil Sharma, President of AJKPC, along with other members of the organization, urged the Union Government to fulfill its promises made to the people of Jammu and Kashmir. Sharma emphasized that for over a decade, the people of Jammu and Kashmir have been waiting for the promises made by Prime Minister Narendra Modi and the BJP to be realized.

Sharma demanded an increase in the MGN-REGA honorarium to Rs 400 per day and asked the Finance Minister to make provisions in the budget to clear

the pending liability of MGNREGA laborers and vendors from 2017 to date in Jammu and Kashmir. His demands also include starting the Jammu to Poonch Railway Project and laying the foundation stones for the Jammu and Srinagar Metro Projects.

The AJKPC President also highlighted that after the abrogation of Article 370, people

in Jammu and Kashmir were optimistic that all daily wagers in the state would receive justice and their services would be regularized. He stressed that it is high time for the Union Budget to include a substantial statement from the Finance Minister regarding this serious issue.

"Unemployment is a major problem here in J&K, and our educated youth are under stress and anxiety. Thus, it is the responsibility of the government to provide a minimum Rs 5000 per month stipend to professional degree holders until they get dignified employment," Sharma

AJKPC also demanded

the establishment of one technical university, one women's university, and one law university for Jammu and Kashmir, along with ITI colleges in every subdivision. Sharma called for the Union FM to increase the monthly honorarium of Anganwadi and ASHA workers to a minimum of Rs 10,000 with a 10% annual increment, showing sympathy towards these essential workers.

Additionally, Sharma urged the government to expedite pending tourism projects like Mubarak Mandi and the Lake on River Tawi with substantial funding. The list of demands also included the start of a Dogri TV channel and an exclusive Dogri radio station.

The AJKPC President warned that if their demands are not considered in the upcoming budget, the organization would decide on the next course of action after a meeting of all AJKPC office bearers including Senior Vice President Ram Saroop Sharma and Vice president Des raj Bhagat, Vice President Jitendra Singh.

Criminal Law Reforms

s of 2024, India has seen significant updates and reforms in its criminal laws aimed at addressing modern challenges while ensuring justice and protection for its citizens. These developments reflect evolving societal norms, international standards, and the need for more efficient and equitable legal frameworks. The rise in cybercrimes has prompted stringent measures. The Information Technology (Amendment) Act, 2024, enhances provisions related to data protection, online privacy, and penalties for offenses such as hacking, identity theft, and cyberbullying. This update aligns Indian law with global standards and addresses emerging threats in the digital age. The Criminal Law (Amendment) Act, 2024, introduces harsher penalties for sexual offenses against women, children, and vulnerable populations. As Pakistan lies on edge, can it dig itself out of extremist mess?

eligion envelops everything in Pakistan. That thing in random is not surprising for the only nation in the world to be created in the name of religion. Every institution -- the military, civilian politicians, judiciary, bureaucracy, and even onceflamboyant cricketers -- have been trying to outdo others in terms of displayed piety and toxic puritanism. Many attribute the regressive slide of religiosity to the late military dictator, Gen. Zia-ul Haq, and the Islamist era that he spawned, but many more since are equally complicit to turn the nation into an extremist tinderbox.

The perennial curse of Pakistan has been the consistent and misplaced belief of its leadership that it can somehow use religion to its advantage, without falling prev to its inevitable and pernicious outcomes. The nation's founding father, Mohammed Ali Jinnah, was the original believer in this failed logic of running with the hare and hunting with the hound. Today's retrograde Pakistan does not look anything like the one that was envisioned in Jinnah's "secular" speech to the Constituent Assembly in 1947 -- the recording of which has been conveniently "lost" and the spirit buried for posterity. Even the relatively modern and secular Pakistani "establishment", meaning the armed forces, now marches to its new moto of "Imam, Taqwa, Jihad fi Sabilillah" (faith, piety, holy war in the path of Allah)! Befittingly, Gen. Asim Munir is the first Pakistan Army Chief to be a "Hafiz Quran" (one who has memorised the Ouran).

Civilian politicians too have much to atone for fanning religiosity and the so-called secular elements like the Bhutto family have blood on their hands by initiating constitutional discrimination against the Ahmediyas in 1974, and the creation of the Taliban (by the PPP's interior minister Naseerullah Babar) -- later Zulfigar Ali Bhutto was hanged by an even more bigoted Zia-ul Haq and Benazir was to be assassinated by a radical extremist. The Sharif family's Nawaz was Gen. Zia's handpicked choice and the PML(N) led by the Sharif family was to make many alliances with many religious parties and clergy. Even former playboy-cricketer Imran Khan was to posit Riyasat-i-Madina as its idyll and was later infamous by his moniker of Taliban Khan. The more dire and desperate the Pakistani situation became, the more intolerant, extremist and violent the Pakistani society became.

Exporting religious fundamentalism (especially in the 1980s and 1990s) became an industry and India was an obvious market. Hillary Clinton's sage warning that "snakes in the backyard do not only bite the neighbours" remained unheeded, till the inevitable happened. Pakistan's own doings had created a Frankenstein's monster, and the unleashed genie of extremism refused to be put back in the bottle again, and terrorism became an inevitable outcome. Also, once on auto-pilot mode, terrorism can never be controlled, and it soon turned on its progenitor - the Pakistani State.

The creator of the Taliban is now ironically facing an existential crisis from its metastasised creation -- the Tehreek-e-Taliban Pakistan (TTP), one of the many self-goals. Over 80,000 Pakistanis have died in the last couple of decades owing to extremist forces from across the Durand Line, far more than the fatalities in all battles with India. The last 18 months have been particularly devastating, with over 700 recorded terror attacks, just last year. This despite various military operations like Operations Radd-ul-Fasaad, Khyber, Zarbe-Azb, Rah-e-Shahadat, etc, all singularly militaristic. Yet, terror thrived.

Finally, a belated and very vital realisation of conjoining terrorism with latent religious extremism has evolved with the conceptualisation of Operation Azm-e-Intehkam (strong resolve for stability), as a "multidomain, multi-agency, wholeof-the-system national vision for enduring stability in Pakistan". Seemingly, there is a realisation that you cannot be pandering to unrestrained religiosity and expecting it not to run amok, as it always does anywhere in the world. The telling differences between the multitude of previous military operations and Operation Azm-e-Intehkam seems to be in the comprehensive and expanded "scope" of the operation, that purportedly includes socio-economic-political imperatives, along with military operations.

It is premature to speculate on its operational efficacy for that will depend on the underlying intent, sincerity, and integration with which various levers of the Pakistani leadership -- the

military, politicians, judiciary and even the clergy -- are able to cleanse themselves from the instincts institutionalised over decades of religious-inspired impulses. This mandates a complete U-turn in sovereign narrative. Given that religion legitimises so many power centres within Pakistan, to expect a complete and unified reneging of the same is to be overly optimistic. Many even attribute this wholesomeness of course-correction to a "whitewash" to convince the likes of China, multilateral bodies and even the Arab sheikdoms, who are extremely wary of extending any more aid to bail out Pakistan, without substantial course-corrections.

But the sheer acceptance of the task to de-radicalise society (to be as important as military operations) is a fundamental break from the past. Religious extremism is the oxygen on which terror survives -- the moment the State restrains the relevance of religion (beyond it to be a private affair) in societal/ governance sphere, it to break from the shackles from the historical past that enflamed and imploded Pakistan from within. Oddly enough, the precariousness of the coalition government's public credibility and the unprecedented violence on the Pakistani military personnel bode well for creating a joint commitment to extricate themselves from this extremist mess. But Pakistan has traditionally remained incorrigible on some fronts, especially on religion, and therefore one must remain realistic (but hopeful too) for the success of "Azm-i-Intehkam". If nothing, it is a positive realisation.

New criminal laws to replace 164 year old colonial era laws

History and genesis of the new Indian Criminal laws being enforced today

n a landmark move to reform the criminal justice system in India, three new Criminal laws Bharatiya Nyaya Sanhita (BNS, 2023), the Bharatiya Nagarik Suraksha Sanhita (BNSS, 2023), and the Bharatiya Sakshya Adhiniyam (BSA,2023) respectfully replacing British era Indian Penal Code (IPC, 1860), Criminal Procedure Code (CrPC,1974) and Indian Evidence Act, 1872 will come into force from July 1.

The governments, the Union Home ministry and police departments are gearing up to roll out the new laws with the active role of the Bar associations across the country.

Brief history and genesis of the new criminal laws

The Law Commission of India in its various reports recommended specific amendments in the criminal laws. Besides, Committees like Bezbaruah committee, Vishwanathan Committee, Malimath Committee, Madhava Menon Committee etc also had made recommendation for section-specific amendments in criminal laws and general reforms in criminal justice system.

The Parliamentary Standing Committee on Home Affairs, in its 146th Report in 2010 ,111th report in 2005 and 128th report (2006) had also stressed upon the need to reform and rationalization of the criminal laws of the country by Introducing a comprehensive legislation in Parliament rather than bringing about piece meal amendments in the criminal laws

After writing letters to all the stake-holders including Governors, Chief Ministers, Lieutenant Governors, Chief Justice of India, Chief Justices of all the High Courts, Bar councils, Members of the Parliament, the Union Home ministry sought their suggestions, the process set into motion on September 07, 2019.

The Union Home minister Amit Shah chaired a meeting "Chintan Shivir" of Home Ministers at Surajkund, Haryana on October 27, 28, 2022 in which Prime Minister Narendra Modi spoke via video conferencing. Besides other issues, emphasis was laid on usage of new technology in criminal justice system.

In view of the recommendations of the Committee and other stakeholders, three new Bills, namely, the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhiniyam, 2023 were prepared. The Union cabinet in its meeting held on December 08, 2023 approved that three Bills may be introduced. The three Bills were passed by Lok

Sabha on December 20, 2023 and by the Rajya Sabha on December 21, 2023.

With the assent of the President on December 25, 2023, the three Acts have been notified in the Gazette of India on December 25, 2023 as the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhiniyam, 2023 and the three new Criminal Laws are now ready to the enforced in India from July 1, 2024

Bharatiya Nyaya Sanhita, 2023

The Bharatiya Nyaya Sanhita(BNS) will replace the British era 164 year old Indian Penal Code, 1860 (IPC) bringing in noteworthy changes in the new law like introduction of community service as a form of punishment etc. At many places the archaic expressions like 'lunatic', 'insane' and 'idiot' have been done away with. Colonial remnants like 'British calendar', 'Queen', 'British India', 'Justice for peace' etc have been deleted.

Chapter V of the Sanhita has been dedicated to offences against women and children. While sexual Intercourse on the pretext of promise to marry was covered under the provisions of rape--but under the Sanhita, a distinct provision (Section 69) has been created where in sexual Intercourse, not amounting to rape, is committed on false promise to marry or by deceitful means.

The offences against women, especially children viewed seriously and made more stringent under IPC but two distinct provisions relating to gang-rape with Women under 16 years and 12 years were present-same are amalgamated under Section 70(2) where in the same has been extended to women up to 18 years and death sentence has been added as a form of punishment.

There has been increase of 33 offences in the term of imprisonment whereas 83 offences have seen an increase in the fine imposable-further, 23 offences have seen introduction of mandatory minimum punishment.

Interestingly, Community service has been included as a punishment imposable in 6 offences (non-appearance in response to a proclamation, attempt to commit suicide to compel or restraint exercise of lawful power of public servant, public servant unlawfully engaging in trade, petty theft on return of theft money, misconduct in public by a drunken person, defamation.

A new provision under Section 73 of the Sanhita has been incorporated thereby making it an offence to report court proceedings without permission with respect to certain offences. However, the printing or publication of the judgment of any High Court or the Supreme Court does not amount to an offence within the meaning of this section.

As per the experience--minors/ children were used to commit offences--while they would get the benefit of being a child, the one hiring or motivating them to commit such act could only be made liable by way

of abetment--separate provision have been made under Section 95 which says, "Whoever hires, employees or engages any child to commit an offence shall be punished with imprisonment of either description which shall not be less than three years but which may extend to ten years and with fine."

Abetment of offence by a person outside India made punishable under BNS 48, Snatching has been incorporated and a distinct offence, Section 76 (assault with intent to disrobe) and 77 (voyeurism have been made gender neutral qua the offender,

The offence of theft has been expanded to include theft of vehicle, theft from vehicle, theft of government property and theft of idol or icon from any place of worship. In Section 305 of the BNS, 2023 such thefts have been made punishable with punishment up to 7 years.

The Section related to Sedition (rajdroh) was misused and hence has been deleted. A new section on acts of 'deshdroh' has been added as section 152 in BNS, 2023. The Acts of secession, armed rebellion, subversive activities, separatist activities or endangering sovereignty or unity and integrity of India, have been made punishable. In section 152 of the BNS, 2023, the offence of 'deshdroh' has been introduced wherein the exciting or attempt to excite any of the acts mentioned hereinabove is made punishable with imprisonment extendable to seven years or imprisonment for life.

Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023

Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023 is to replace Criminal Procedure Code (CrPC) of 1973 introducing key changes in the procedural law. Delivering judgments within 30 days of completion of arguments extendable up to 60 days, making forensic investigation mandatory for offences punishable by atleast 7 years of imprisonment and some of the important changes in the criminal justice system.

The post of Judicial Magistrate of the third class, Metropolitan Magistrate and Assistant session judges have been abolished to bring uniformity in classes of Courts and Judges across the country. There will be four kinds of Judges now ie Judicial Magistrate of the second class, Judicial Magistrate of the first class(including Chief Judicial Magistrate or Additional Chief Judicial Magistrate), Sessions Judge (includes Additional session judge judge) and Executive Magistrates.

In Section 35(7) the aged and infirm persons have been protected from arrest. It has been provided that no arrest shall be made in case of an offence punishable for less than three years if the person is infirm or above the age of 60 years, without prior permission of the officer not below the rank of Deputy Superintendent of Police. The rights of the aged and infirm have further been protected as witnesses in Section 179(1) of BNSS where no

person above the age of 60 years or a person with acute illness will be required to attend at any place other than where they reside.

Section 37(b) introduces that there shall be

one designated Police officer in every District and at every Police station, not below the rank of ASI who shall be responsible for maintaining and giving information to the general public about details of persons arrested etc. For clear visibility, the names, addresses, and charges against arrested persons can now be prominently displayed through digital means.

In Section 66, gender neutrality has been introduced and women have been included as an adult member of the family for the purpose of service of summons on behalf of the person summoned. The earlier reference to "some adult male member" has been replaced with "some adult member".

Bharatiya Sakshya Adhiniyam, 2023 Bharatiya Sakshya Adhiniyam, 2023 (BSA) replaced the Britsh era Indian Evidence Act,

The words like 'Parliament of the United Kingdom, Provincial Act, notification by the Crown Representative, London Gazette, any Dominion, colony possession of his Majesty, Jury. Lahore', 'United Kingdom of Great Britain and Ireland, Commonwealth, Her Majesty or by the Privy Council, Her Majesty's Government, copies or extracts contained in the London Gazette, or purporting to be printed by the Queen's Printer, 'possession of the British Crown', 'Court of Justice in England', 'Her Majesty's Dominions, Barrister have thus been deleted as they are no

longer relevant.

The definition of "documents" in section 2(1)(d) has been expanded to include an electronic or digital record on emails, server logs, document on computers, laptop or smartphone, messages, websites, cloud, locational evidence and voice mail messages stored on digital devices. This update acknowledges the shift from traditional paper-based documentation electronic forms of communication and data storage in contemporary India.

Similarly, the definition of 'evidence in section 2(1)(e) has been expanded to include any information given electronically. This will permit the appearance of witnesses, accused, experts and victims to depose their evidence through electronic means. It also establishes 'digital records as documentary evidence.

Section 61 brings parity in the admissibility of electronic/digital record and other documents. Now, electronic or digital records will have the same legal effect, validity and enforceability as other documents.

As the government is all set to enforce the new criminal legislations from July 1 with Bar associations and police departments respectively imparting training to the legal fraternity and the cops, it remains to the same how effectively these legislations are implemented on the ground.

"Technically, I started acting in my song Na Na Na Re, so I don't think it's that difficult for me or I'll have to work hard on it separately. I feel I have it in me. Baaki bhagwaan ne chaaha toh aur acting projects bhi aayenge, I am willing to grow more in this arena. I am hoping to balance both acting and music in the future," he wraps up.

"There are several challenges here in India. For instance, in the West, you never get a script at the last minute; you

Another difference is that in the West, actors never negotiate their fees directly; they have agents who handle that. Here, it's only now that I have an agent," he says.

When asked about being typecast based on his White heritage, Bennington says, "I usually get offered characters from the British Raj and have turned down several of them. Roles like the one I had in Saas Bahu Aur Flamingo (web show) are very rare."

He adds that his focus is on making the roles he takes on "as real and interesting as possible". Bennington also accepts that he might not be able to ever "break the ceiling" here, like foreign actors in the West do.

So, I am looking at getting into writing and directing, to be able to write and create stuff that is away from this typecasting," he signs off.



Addressing a press conference after the new criminal laws were implemented, Shah expressed hope of a reduction of crime in future as 90 per cent conviction was expected under the new laws. The Bharatiya Nyaya

Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS) and the Bharatiya Sakshya Adhiniyam (BSA) came into effect on Monday. The new laws replaced the British-era Indian Penal Code, Code of Criminal Procedure and the Indian Evidence Act,

respectively. "Justice can be received up to the Supreme Court within three years of the registration of the FIR," he said.

The Home Minister said with the implementation of the three criminal laws. India would have the most modern criminal justice system in the world.

"The new laws brought in a modern justice system, incorporating provisions such as Zero FIR, online registration of police complaints, summonses through electronic modes such as SMS and mandatory videography of crime scenes for all heinous crimes," he said.

Shah said first case under the new laws was about motorcycle theft registered in Madhya Pradesh's Gwalior at 10 minutes past midnight.

He said the new laws would give priority to providing justice, unlike the colonial-era laws that gave primacy to penal action.

North Korea test-launches 2 ballistic missiles, 2 days after end of new US-South Korea-Japan drill

Joint Chiefs of Staff said the missiles were launched 10 minutes apart in a northeastern direction from the town of Jangyon in southeastern North Korea

SEOUL, Jul 1 (Agencies): North Korea test-fired two ballistic missile Monday, South Korea's military said, a day after the North vowed "offensive and overwhelming" responses to a new US military drill with South Korea and Japan.

The Joint Chiefs of Staff said the missiles were launched 10 minutes apart in a northeastern direction from the town of Jangyon in southeastern North Korea.

It said the first missile flew 600 kilometres (370 miles) and the second missile 120 kilometres (75 miles), but didn't say where they landed. North Korea typically test-fires missiles toward its eastern waters, but the second missile's flight distance was too short to reach those waters.

South Korean media said an unidentified South Korean military source reported that it was highly likely the second missile crashed in an inland area of the North. Possible damages on the North's ground weren't immediately reported.

The reports said the first missile landed in the waters off the North's eastern city of Chongiin.

In recent weeks, North Korea has floated numerous trash-carrying balloons toward South Korea in what it has described as a tit-for-tat response to South Korean activists sending political leaflets via their own balloons. Last month, North Korea and Russia also struck a deal vowing mutual defense assistance if either is attacked, a major defence pact that raised worries that it could embolden Kim to launch more provocations at South Korea.

Meanwhile, North Korea opened a key ruling party meeting Friday to determine what it called "important, immediate issues" related to works to further enhance Korean-style socialism.

Japan launches advanced Earth observation satellite on its new flagship H₃ rocket



TOKYO, Jul 1 (Agencies): Japan deployed an upgraded Earth observation satellite for disaster response and security after it was launched on a new flag-

ship H3 rocket Monday. The H3 No. 3 rocket lifted off from the Tanegashima Space Centre on a southwestern Japanese island and released its payload about 16 minutes later as planned, the Japan Aerospace Exploration Agency, or JAXA, said during a livestream.

The Advanced Land Observation Satellite,

or ALOS-4, is tasked primarily with Earth observation and data collection for disaster response and mapmak-

ing.
It's also capable of monitoring military activity, such as missile launches, with an infrared sensor developed by the Defence Ministry.

by the Defence Ministry. The rocket appeared to fly as planned, and JAXA is expected to give further details at a news conference later Monday. The launch was initially planned for Sunday but was delayed due to bad weather at

the launch site

The ALOS-4 is a successor to the current ALOS-2 and can observe a much wider area. Japan will operate both for the time being.

The launch was the third of the H3 system, after the successful one on February 17. and the shocking failed debut flight a year earlier when the rocket had to be destroyed with its payload — a satellite that was supposed to be the ALOS-3.

Japan sees a stable, commercially competitive space transport capability as key to its space program and national security.

JAXA and its main contractor Mitsubishi Heavy Industries have been developing the H3 launch system as a successor to its current mainstay, H-2A, which is set to retire after two more flights. MHI will eventually take over H3 production and launches from JAXA and hopes to make it commercially viable by cutting the launch cost to about half of the H-2A.

UK, British Airways face lawsuit against 1990 Kuwait hostage crisis

LONDON, Jul 1 (Agencies): Passengers and crew of a British Airways flight who were taken hostage in Kuwait in 1990 have launched legal action against the UK government and the airline, a law firm said Monday.

People on BA flight 149 were taken off the Kuala Lumpur-bound plane when it landed in the Gulf state on August 2 that year, hours after Iraq's then leader Saddam Hussein invaded the country.

Some of the 367 passengers and crew spent more than four months in captivity, including as human shields against Western attacks on the Iraqi dictator's troops during the first Gulf war.

Ninety-four of them have filed a civil claim at the High Court in London, accusing Britain's government and BA of "deliberately endangering" civilians, said McCue Jury & Part-

"All of the claimants suffered severe physical and psychiatric harm during their ordeal, the consequences of which are still felt today," the law firm added.

The action claims that the UK government and the airline "knew the invasion had started" but allowed the flight to land anyway.

They did so because the flight was used to "insert a covert special ops team into occupied Kuwait", the firm added.

"We were not treated as citizens but as expendable pawns for commercial and political gain," said Barry Manners, who was on the flight and is taking part in the claim.

"A victory over years of cover-up and bare-faced denial will help restore trust in our political and judicial process," he added.

British government files released in November 2021 revealed that the UK ambassador to Kuwait informed London about reports of an Iraqi incursion before the flight landed but the message was not passed on to BA.

There have also been claims, denied by

The UK government refused to comment on ongoing legal matters.

British Airways has always denied accusations of negligence, conspiracy and a cover-up.

The airline did not respond to a request for comment from agency but said last year that the records released in 2021 "confirmed British Airways was not warned about the invasion".

McCue Jury & Partners had announced in September its intention to file the suit, saying then that the hostages "may claim an estimated average of £170,000 (\$213,000) each in damages".

In 2003, a French court ordered BA to pay 1.67 million euros to the flight's French hostages, saying it had "seriously failed in its obligations" to them by landing the plane.

Entry Fee Issued For Mount Fuji Hikers Amid New Crowd Control Measures

JAPAN, Jul 1 (Agencies): Mount Fuji's summer climbing season began on Monday with new crowd control measures to combat over-tourism on the Japanese volcano's most popular trail.

An entry fee of 2,000 yen (\$13) plus an optional donation is being charged for those taking on the Yoshida Trail, and numbers are capped at 4,000 per day.

Online reservations have also been introduced this year by authorities concerned about safety and environmental damage on Japan's highest moun-

"I really like the idea because if you respect the mountain, you have to limit the people," hiker Chetna Joshi told agency at the trail's Fifth Station -- a busy starting point for hikers that is reachable by car.

The 47-year-old from India compared the crowds seen at Fuji in recent years to the "traffic jam" of climbers at the peak of Mount



Everest.

Although windy and drizzly weather on Monday prevented hikers from reaching the summit, Joshi said ascending part way was still a "great experience".

"I love mountains. I think it is not giving me permission this time, that's OK. I accept it," she said.

Record tourist crowds are flocking to Japan post-pandemic, with many wanting to see or scale Mount Fuji.

The mountain is covered in snow most of the year but draws more than 220,000 visitors each July-September climbing period.

Many trudge through the night to see the sunrise from the 3,776metre (12,388-foot) summit.

Some sleep on the trail or start fires for heat, while others attempt to complete the hike without breaks, becoming sick or injured as a result.

'Crazy adventure'

Mount Fuji is about two hours from cen-

tral Tokyo by train and can be seen for miles around.

The mountain is a symbol of Japan that has been immortalised in countless artworks, including Hokusai's "Great Wave".

But as in other tourist hotspots, such as Venice -- which recently launched a trial of entry fees for day visitors -- the influx has not been universally welcomed.

In May, a town near Mount Fuji mounted a large barrier at a popular viewing spot for the volcano in an attempt to deter photo-taking by an ever-growing number of tourists.

Residents were fed up with streams of mostly foreign visitors littering, trespassing and breaking traffic rules in their hunt for a photo to share on social media.

Similar woes have befallen the country's ancient capital of Kyoto, where locals have complained of tourists harassing the city's famed geisha.

Ahead Of UK Polls, A Look At Rishi Sunak's Rise To The PM's Post

LONDON, Jul 1 (Agencies): The United Kingdom is gearing up for an intense election battle on July 4. The ruling Conservative Party, led by Prime Minister Rishi Sunak, and his rival Keir Starmer's Labour Party are locked in what's said to be one of the most high-profile electoral battles globally.

In October 2022, Mr Sunak, 44, became the first Indian-origin British prime minister and the youngest occupant of the 10 Downing Street in 210 years. This happened after the country went through a major political turmoil, witnessing back-to-back resignations of two former PMs Boris Johnson and his successor Liz Truss.

Ahead of the crucial polls this week, let's revisit the moment Mr Sunak came to power:

In 2015, Mr Sunak was elected as the Conservative MP for

Brexiter, he campaigned for leaving the economic bloc, and he got his first ministerial berth under Theresa May, as number three at the newly re-named Ministry of Housing, Communities and Local Government in 2018.

Richmond, Yorkshire. A lifelong

Later, he endorsed Borish Johnson for the post of Prime Minister.

2019 UK elections

The Conservative Party, under the leadership of Boris Johnson, emerged victorious in the 2019 elections, bagging 365 of the 650 seats. While Johnson continued as the Prime Minister, Mr Sunak was rewarded with the job of Treasury minister under then Chancellor Sajid

Later, when Mr Javid resigned from the post over a power battle, Mr Sunak was promoted



to the role of Chancellor. This made Sunak the first minister of Indian origin to hold one of the highest offices in the UK government.

Mr Sunak was praised during the COVID-19 lockdown for his series of mini Budgets that introduced measures such as the furlough scheme that went on to save many jobs and businesses. He was even pitted as a clear favourite to succeed Johnson as the Tory leader.

Rishi Sunak vs Liz Truss
In 2022, when Mr Johnson
announced his decision to
resign as the UK Prime Minister

following a mass revolt by ministers over his leadership that was sparked by major scandals, including Partygate, both Mr Sunak and Ms Truss started their bids to succeed Johnson.

Ultimately, Ms Truss went on

to win the Conservative Party leadership race and became the new British PM. However, after six weeks amid an open revolt, Ms Truss had to resign. Rishi Sunak becomes PM

Mr Sunak went on to create history and became the Prime Minister of the UK in October 2022 after Penny Mordaunt, the last remaining rival in the Tory leadership contest, dropped out of the race.

Back then, Mr Sunak report-

edly won the public support of around 200 of his Conservative MP colleagues and succeeded Truss as the new UK Prime Minister.

Veteran Sri Lankan politician and Tamil leader Sampanthan dies at 91



COLOMBO, Jul 1 (Agencies): R Sampanthan, a veteran Sri Lankan politician and a moderate Tamil leader, passed away last night while receiving treatment in a hospital, the Tamil National Alliance has announced.

Sampanthan, 91, led the Tamil National Alliance (TNA) from 2004 and became only the second Tamil to become the main opposition leader in the Sinhalamajority country.

He was ailing for a long time and was missing the current parliamentary sessions for a long time.

He was a moderate Tamil who had been leading the political movement to achieve a negotiated political settlement to the Tamil demand for political autonomy.

The Tamils put for-

ward their demand for autonomy since gaining independence from Britain in 1948, which, from the mid-70s, turned into a bloody armed conflict. He took office as the

leader of the opposition

in 2015 and was actively involved in the process of drafting a new Constitution until 2019. brilliant lawyer, Sampanthan entered Parlia-

panthan entered Parliament for the first time in 1977 from the eastern port district of Trincomalee.

BFDC protests against Archaeology & Distt Administration, urges to protect **Dogra's Historical Monument**

JAMMU, July 1: The Bahu Fort Development Committee (BFDC), led by President Rajeev Charak along with Vice Chairman BFDC Advocate Ishant Gupta, has launched a protest against the Archaeology and Museums Department of the Government of Jammu and Kashmir. as well as the District Administration of Jammu.

The protestors shouted slogans against the Archaeology Department, the Deputy Commissioner (DC) of Jammu, and the Jammu and Kashmir Police.

During the protest, Charak spoke to the media, expressing their anger over the lack of action against unauthorized construction within the protected Bawe Wali Mata Temple at Bahu Fort.

He revealed that they had informed the Archaeology Department two months ago about the illegal construction of a shed by unknown individuals.

Despite multiple complaints, the department has only passed the responsibility to the DC Jammu without taking

any concrete action. Charak further added that this type of incident is not happening for the first time. It has now become a habit to damage the protected monument, and every time the archaeology department plavs the game of passing responsibility to the district administration and others by writing letters but doing nothing and taking no appropriate



ago, they also informed the department that illegal construction was at its peak, but no action was taken, and the protected monument was damaged with multiple illegal constructions like Langar shed, multiple temples, concrete cement shelter shed, and other cemented constructions.

Charak highlighted a letter from the Directorate of Archives, Archaeology, and Museums, dated May 17, 2024, which was sent to the DC Jammu. The letter was about the erection of a shed on the main entry gate of the Bahu Fort within the prohibited area under the J&K Ancient Monument Preservation Act, 1920.

The letter emphasized that the Bahu Fort, a protected monument, is being encroached upon without any approval from the competent authority. The letter also referenced the J&K Ancient Monument Preservation Act. 1920, which prohibits new construction within 100 meters of the monument site. Violations of this act can lead to the removal of unauthorized structures and legal action against the offenders.

The letter also referred

to the Jammu and Kashmir Ancient Monument Preservation Rules, 2012, which require permission from the government for any construction or excavation within a protected area. Despite these regulations, the district administration has not taken any effective measures to stop the illegal construction.

Charak also questioned the role of the police, pointing out that there is a police post within the monument. He raised concerns about how construction materials could be transported and used without the police's knowledge and approval.

The Bahu Fort Development Committee urges the District Administration to take immediate action to halt the illegal construction, investigate the matter, and hold the culprits accountable under the law to protect this historic site.

NEW DELHI, July 1 (Agencies): Indians are spending a lot more on overseas travel. And with a rise in the number of those travelling abroad. the they took out (outward foreign exchange remittances) jumped to almost \$1.42 billion (around Rs 12,500 crore) a month on an average in 2023-24 compared with just \$400 million (about Rs 3,300 crore) a month on an average five years ago in 2018-19.

According to Reserve Bank of India data, Indians took out a total of \$17

"Over the last 10 years, there has been a significant change in the nature of outward remittances. Purpose wise, 'gifts' had the highest share in India's outward remittance in FY14, fol-

However, there has been a sharp decline in the share of gifts and education in this period," a report by Bank of Baroda

Resident Indians are also investing more abroad. In 2023-24, they invested on an average \$100 million abroad every month (\$1.51 billion for the full year) in foreign equity and debt as against \$1.25 billion in the full year 2022-23, RBI data shows. Remittances for 'maintenance of close relatives abroad' were \$4.61 billion and 'studies abroad' were \$3.47 billion in 2023-24.

Overall, total outward remittances under LRS were \$31.73 billion in 2023-24 as against \$ 27.14 billion in the previous year, a rise of 16.91 per cent. Five years ago in 2018-19, the total outward remittances under



Degree College Thathri working in Higher Secondary School Thathri: Rao

JAMMU, July 1: In his statement. Kuldeep Kumar Rao, a Senior AAP leader in Jammu and Kashmir, strongly criticized the government's approach to the allocation and sanctioning of Degree Colleges in the region, particularly highlighting discrepancies and alleged political

He expressed deep concern over the decision-making process in 2008, where Degree Colleges were sanctioned in certain Assembly constituencies without clear

Rao cited specific examples, such as the allocation of a Degree College in Chhatru for the Inderwal Constituency for Bhadarwah, which he claimed were politically motivated decisions favoring specific leaders.

Rao pointed out that Sub-Division Thathri, despite having a higher number of Higher Secondary Schools and serving a significant BPL, SC, and ST population,



was initially overlooked. He criticized the delay in sanctioning a Degree College in Thathri until 2012, attributing its eventual approval to public pressure and protests by the Thathri Development

Even after its establishment, Rao highlighted deficiencies in infrastructure and staffing at the current Degree College location within a Higher Secondary School in Thathri, which he deemed unfair to both school and college students.

Furthermore, Rao drew attention to similar issues in the health sector across the Chenab Region, where inadequate infrastructure forces residents to travel long distances for specialized treatment.

He criticized the lack of significant budgetary allocations for education and health, alleging that institutions were opened primarily for political gains rather than genuine development needs.

Rao concluded by appealing to the Lieutenant Governor of Jammu and Kashmir, Manoj Sinha, to intervene urgently.

He urged for immediate remedial measures to address the educational and healthcare challenges faced by the people of Sub-Division Thathri and the wider Chenab Region.

Rao also advocated for the inclusion of additional Tehsils under Thathri Sub-Division, arguing that this would facilitate better accessibility and make a compelling for elevation to district status.

He criticized the recent delimitation process for allegedly ignoring the genuine representation of Thathri Sub-Division in Assembly constituencies, reflecting a broader pattern of neglect by successive governments.
