Changes afoot as NSA Doval team expands with key posts

he National Security Council Secretariat has undergone several notable changes recently, while also maintaining some continuity. Previously secretary (west) in the external affairs ministry, Pavan Kapoor has been appointed deputy national security adviser (NSA). This move is part of a series of appointments that include Rajinder Khanna, who has been promoted from deputy NSA to the newly established role of additional NSA. Mr Khanna, a former chief of India's external intelligence agency, Research & Analysis Wing (R&AW), is stepping into a pivotal role that didn't exist before.

Another key appointment is T.V. Ravichandran, an IPS officer currently serving as special director in the Intelligence Bureau. He replaces Mr Khanna as deputy NSA. Mr Ravichandran's initial tenure is set to last until his retirement on August 31, 2024, after which he may continue on a contractual basis. This reshuffle follows the recent appointment of Vikram Misri as the next foreign secretary, effective from July 15.

These changes mean that under NSA Ajit Doval, who is now in his third term, there will be one additional NSA and three deputy NSAs. The appointments committee of the Cabinet has played a crucial role in arranging these appointments, ensuring a blend of fresh perspectives and experienced leadership within the NSCS.

these appointments might hint at potential future shifts within the NSA office itself. Delhi is currently abuzz with rumours of a major reshuffle of key secretaries and other significant positions, possibly in September. While these moves appear subtle, they could signal broader changes within India's national security framework.

WB Governor tussles with his top officials

West Bengal governor C.V. Ananda Bose has stirred up quite the controversy by writing to Union home minister Amit Shah, urging strict action against West Bengal's chief secretary Mr B.P. Gopalika and two senior police officers, Kolkata police commissioner Vineet Kumar Goyal and deputy police commissioner (central) Indira Mukherjee. These letters, sent last month, accuse the officers of serious misconduct, claiming they have blatantly violated All India Services (AIS) conduct rules and acted as "willing accomplices in the misdeeds of the ruling dispensation".

Sources have informed DKB that the Union home ministry has initiated disciplinary action against Mr Goyal and Mr Mukherjee for allegedly maligning the office of the state governor by "promoting and spreading canard".

notes have created quite a

outlined how the officers,
particularly Chief Secretary
Gopalika, have openly disrep
garded the Constitution and

failure to take action could

further deteriorate the integrity of the Services and harm national interests. The governor accused Mr Gopalika of aiding and abetting corruption and highlighted issues like job recruitment scandals and alleged lawlessness in the state.

Mr Ananda Bose also added allegations against Mr Goyal and Mr Mukherjee, linking them to an investigation into sexual misconduct allegations against him. These accusations seem to be part of a broader effort by Mr Ananda Bose to clear his name, as he has previously dismissed the sexual harassment claims as a "sinister plot".

Interestingly, Mr Ananda Bose's letters come amidst speculation about his potential removal from his post in Bengal. Factors such as dissent among state BJP leaders and the common practice of reshuffling Raj Bhavan after a new regime takes office in Delhi, fuel these rumours. Despite this, sources indicate that the bureaucratic followup on Mr Ananda Bose's letters has already begun, making his tenure's continuity less critical.

Gujarat HC dismisses babu's cadre transfer plea

The Gujarat high court has just thrown out the petition of Hitesh Kumar Makwana (IAS: 1995: TN), who was seeking a transfer from Tamil Nadu to his home state of Gujarat. The court pointed out that such a change at the tail end of his career would cause a domino effect on other appointments within the cadre.

Mr Makwana has been battling this issue legally since 1996, almost right after his cadre was assigned. He argued that based on the 2:1 ratio for cadre allotment favouring outsiders and insiders, he should have been placed in Gujarat as an insider. After being denied by the Centre, he took his case to the Central Administrative Tribunal (CAT) and then escalated it to the high court.

However, the Centre stood firm, stating that Mr Makwana had no inherent right to be placed in his home state's cadre. They emphasised that cadre allocation is an administrative matter and can only be subject to judicial review in clear cases of discrimination. So, after years of legal wrangling, the court's decision brings this long-standing fight to a close. It's a reminder that cadre allocations, while seemingly bureaucratic, have broader implications and are not easily overturned.

While I am sure many children and teenagers will still be attending brick-and-mortar school, alternatives will be well established for those who can't, as well as for adults and lifelong learners.

VR and AR technology will be far more accessible than it is today, with lightweight and affordable devices making it easy for anyone to interact with tutors and fellow learners as if they were in the same room. Highly immersive virtual classrooms and campuses will mean we can participate in sophisticated simulations, engage in complex scientific experiments or explore ancient civilizations first-hand.

The maturing of technologies that exist today will democratize access to education for those who aren't fortunate enough to live in areas with good schools and colleges. However educators will face the challenge of balancing this with concerns such as increased social isolation and the impact of extended screen-time on developing minds

AI-Driven Adaptive Learning

AI is going to change education (and everything else) in many ways, but over the next ten years, one of the most profound effects will be the rise of personalized learning. As the number of learners in both traditional classrooms (particularly in the developing world) and online environments climbs, teachers will have access to tools that accurately assess abilities and differentiate between learning styles to create hyper-personalized curriculums tailored to individuals' requirements.

Today's AI tutoring platforms will evolve into flexible AI mentors, able to understand psychological states and behavioral patterns to determine the best teaching strategies and even provide emotional support and encouragement. Students will have access to insights derived from biometric data to help them recognize the best time to learn and when they should rest. Adaptive gamification will challenge learners to improve themselves by dynamically engaging and assessing them throughout the education process, perhaps putting an end to the stress-inducing routine of cramming for end-of-term exams.

Personalization at this level has the potential to help us learn better and attain better educational outcomes. However, there will also be big challenges around privacy and questions over the role of human teachers as they find their role transitioning from information providers to learning facilitators. Biased data could lead to learners being inaccurately assessed, and care must be taken not to overlook the importance of human oversight and mentorship.

Neurotechnology And Accelerated Learning – Hacking The Human Brain For Better Learning

Here's where things get very science fiction. So, brain-computer interfaces (BCIs) are in development today – the most famous example being Elon Musk's Neuralink experiments. Don't worry; we probably won't all have to have chips implanted in our heads to benefit, though, as non-invasive forms of BCI have also been in development for some time.

The first use cases in education are likely to involve assisting students with disabilities, enabling them to control devices with thoughts. This will enhance their ability to communicate and take part in learning activities.

Within ten years, they could also be used to understand the brain's learning processes better, potentially speeding up our ability to ingest, retain and recall information. By monitoring the electrical feedback generated by the brain, researchers believe it may be possible to optimize our ability to learn information and even develop skills such as playing a musical instrument.

Will this really be mainstream within ten years? Well, a lot depends on the outcome of research that's going on today. And just as importantly, it will come down to how society is able to answer questions around the ethical and security implications of developing technology that can literally read our thoughts!

KDP Wing of DPAP demands rehabilitation of Kashmiri displaced Hindus in Valley

JAMMU, Jul 11: In a joint statement issued by the KDP Wing of Democratic Progressive Azad Party (DPAP) through its leadership including President Sanjay Dhar, Chairman Piaray Lal Pandita, General Secretary Raj Kumar Ticku, and Youth President Naveen Gosani, several demands and concerns regarding the resettlement and rehabilitation of displaced Kashmiri Hindus have been highlighted.

The leaders have criticized successive governments for their failure to implement a concrete

policy for the resettlement of displaced Kashmiri Hindus back to their birthplaces in the Valley. They accuse political leaders of using the issue of displacement as a mere tool during elections without delivering on their promises. Expressing serious concerns, the leaders have emphasized that

the assurances made by political leaders since 2014, including those reiterated during the 2024 election campaigns, have been hollow and disappointing to the displaced community.

the deep frustration of the displaced Kashmiri Hindu community, who despite being the original inhabitants and stakeholders of Kashmiriyat, are forced to visit their birthplaces as tourists rather than

residents. The leaders have called for the formulation of a one-time return policy for Kashmiri displaced people to the Valley, to be discussed and implemented in the next Parliament session in consultation with the real sufferers and stakeholders languishing in camps.

Additionally, they demand the early restoration of statehood to Jammu & Kashmir, along with the conduct of long-awaited Assembly elections to establish a public government that can inspire confidence among the masses. The leaders have

rejected the reservation of two seats in the State Legislature on a nomination basis and instead propose that two political seats in the Valley be specifically reserved for Kashmiri displaced people through regular election processes, ensuring true representation for their community.

Furthermore, they have urged both the Government of India and the Union Territory government to focus on creating employment opportunities for displaced Kashmiri Hindu youth, including special recruitment into three police battalions with relaxed norms, aiming to attract youth back to serve their own community and revive their lost cultural connections.

The statement concludes with a hopeful expectation that the present government will consider these demands seriously, ensuring a dignified rehabilitation process that does not repeat the failures of past attempts.

The success of Kalki 2898 AD and failure of Bade Miyan Chote Miyan underscore that mediocrity won't work at the box-office

Currently Kalki 2898 AD's success at the box-office is ringing cash registers, which forces us to look at the past six month's records of Hindi films. While many films like Fighter, Shaitaan, Crew, Muniya and Article 370 were able to pull above Rs 100-crore in worldwide gross collections, none made an impact like Kalki 2898 AD, which collected over Rs 219 crore in India alone in just 13 days since its release on June 27. We bring the box-office halfyearly report of Hindi films. Getting it right

6

January opened with the release of Katrina Kaif and Vijay Sethupathi-starrer Merry Christmas, but it barely surpassed Rs 18 crore at the boxoffice. To recover its budget of Rs 60 crore, makers sold its streaming rights to Netflix at the same amount. There were big expectations from Pathaan director Siddharth Anand, as he brought a new onscreen pair, Hrithik Roshan and Deepika Padukone, with his film Fighter. A Republic Day release, the film collected Rs 337.20 crore worldwide, but the amount did not match Pathaan's success. Although a hit, much more was expected of Fighter, considering it was made at a whopping budget of Rs 250 crore.

February's major hit was Teri Baaton Mein Aisa Uljha Jiya, starring Shahid Kapoor and Kriti Sanon, another pair seen together for the first time on screen. The first rom-com of the year, made at a budget of Rs 75 crore collected Rs 133.64 crore worldwide. Kriti Sanon has seen a successful year as her two films, the other one being Crew, are listed among top 10 grossers of 2024 so far. If Teri Baaton Mein... is placed at the fourth position, female-centric Crew is just one rank above with Rs 157.08 crore collection



worldwide. A heist comedy with catchy songs, Crew was made at a budget of Rs 75 crore.

Shaitaan, a supernatural horror thriller with a talented star cast, including Ajay Devgn, R Madhavan and Jyothika, made a profit of Rs 146 crore only in theatres. With Rs 211.06 crore worldwide collections, the film is at the number two position in highest grossers' list till June end.

Flop show

The much-anticipated Bade Miyan Chote Miyan, starring Akshay Kumar and Tiger Shroff, was an action film made at a cost of Rs 350 crore. Guess how much the makers could recover? Barely Rs 102 crore, making it the biggest multi-starrer failure of the year. Ajay Devgn-starrer Maidaan (Rs 250 crores budget) released on the same day as Bade Miyan Chote Miyan only recovered Rs 68 crores at boxoffice.

Even biopics didn't make much impact. Films like Maidaan, Main Atal Hoon and Chandu Champion drew much traction online, but looked like people were willing to wait for them to release on OTT rather than visit the theatres. Chandu Champion, starring Kartik Aaryan (Rs 100-140 crore budget), has grossed Rs 85.64 crores so far. Much like Chandu Champion, Srikanth also was based on a differently abled-man. Starring Rajkummar Rao in the titular role and made at a cost of Rs 45 crore, the film managed to collect Rs 62.92 crore. In other words, medium-budget films like Munjya (Rs 30 crore), Article 370 (Rs 20 crore), Madgaon Express (Rs 30 crore) and Srikanth (Rs 45 crore) turned out to be hits.

If some of the most-anticipated projects failed at the BO, then there were also a few films that performed beyond expectations. Munjya, from the makers of Stree and Bhediya, made at a cost of Rs 30 crore, earned over Rs 128.36 crore worldwide. Another sleeper hit was Kiran Rao's Laapataa Ladies, which was just made at a budget of Rs 3 crore. The film won critical acclaim and went on to mint Rs 25.26 crore in theatres worldwide!

Hear it from the expert

There wasn't any pronounced trend as such during the first half of the year. The only trend that I saw, and which one sees year after year, was that good content succeeded while weak one failed.

Films which deserved to do well, like Kalki, Article 370, Srikanth and Munjya, did well. I think our writers need to understand that mediocrity won't work. It is mediocre stuff that is failing. I have been saying from the beginning that this year, probably, the South Indian and Hollywood film industries will come to the rescue of the Hindi film world, and Kalki has proven that.

With the collections being what they are, it's going to cross Rs 250 crore, which is a huge figure for a dubbed film. Some Hollywood films are doing well, have done well, like Inside Out 2 etc. So, Hindi writers and directors need to pull up their socks. — Komal Nahta, Film Trade Analyst.

Supreme Court defers hearing on petitions seeking scrapping of NEET-UG to July 18

NEW DELHI, Jul 11 (Agencies): The Supreme Court on Thursday deferred hearing on the petitions seeking scrapping of NEET-UG 2024 for alleged paper leak and other malpractices to July 18.

A three-judge Bench led by CJI DY Chandrachud said the Union of India and the National Testing Agency (NTA) had filed their replies but some of the advocates had not got the e-copies of the replies.

In order to enable the parties to peruse the replies, the Bench posted the matter for next Thursday.

The Centre has asserted that there was no indication of mass malpractice or local set of candidates being benefited.

The NTA has also said that Telegram videos allegedly showing photos of leaked question papers were fake and manipulated.

Citing a technical analysis of NEET-2024 data carried out by experts from IIT Madras, the Centre has told the Supreme Court that there was no indication of mass malpractice or

In an affidavit filed in response to petitions seeking scrapping of NEET-UG 2024 for alleged paper leak and other malpractices, the Union Ministry of Education asserted that there was "very less likelihood of mass malpractice".

Citing the results of the analysis done by experts of IIT Madras, the Centre said, "The analysis shows that there is neither any indication of mass malpractice nor a localised set of candidates being benefited leading to abnormal scores." the Centre said scrapping the entire examination would seriously jeopardise lakhs of honest candidates who didn't adopt any unfair means.

In a separate affidavit, the NTA also opposed cancellation of the exam, saying it "would be hugely counterproductive and significantly harmful to the larger public interest, especially to the career prospects of the qualified candidates".

Around 24 lakh students appeared for NEET-UG 2024 Examination conducted on May 5 by the NTA across 4,750 centres in 511 cities and 14 centres abroad for admission to MBBS, BDS, AYUSH and other related courses in more than 700 government and private institutions to fill 1.08 lakh seats.

Highlighting several 'red flags' in the examination, the top court had on Monday made it clear that it would order a re-test, if it's found that the irregularities were widespread.

The Bench had also directed the CBI to submit a status report on the probe into the alleged paper leak.

NEW DELHI, Jul 11 (Agencies): Supreme Court judge Justice Sanjay Kumar on Thursday recused from hearing pleas of AAP leader and former deputy chief minister Manish Sisodia by which his bail petitions have been sought to be revived in the excise policy scam cases.

Sniffer dog led police to 3 schoolboys who killed Andhra girl, 8, after 'molesting' her

NANDYALA, Jul 11 (Agencies): A man had filed a missing complaint with the police after his eight-year-old daughter, who was playing in a park in Andhra Pradesh's Nandyala district, did not return home.

Police launched a search and questioned locals, but could not find her.

The girl was allegedly molested and pushed into a canal by three minor boys, said a police official on Thursday. According to the SP, a National Disaster Response Force team arrived on Thursday to search for the body.

He said it cannot ascertained whether the girl was raped until her body is found.

It was a sniffer dog that led police to the three boys, her seniors in school, who had allegedly molested her and then pushed her into the canal, reports. The boys, in the age group of 12 to 13, have admitted to the crime. The three

minors have been detained. They told the police that they disposed of the body in the canal. Two of them are Class 6 students, aged 12, and one is in Class 7 and is 13.

They told police that they saw the girl playing in the park and joined her.

They then took her to a secluded area near the Muchumarri dam and took turns in molesting her. Worried that the girl may tell her parents, they threw her into the canal, the boys told police.

Sub-Inspector Jayshekhar of the Muchumarri police station said they are still looking at it as a missing case because the body of the girl has not been found.

Delhi High Court lists for September 9 Arvind Kejriwal's plea against ED summons in excise case

NEW DELHI, Jul 11 (Agencies): The Delhi High Court on Thursday listed for hearing on September 9 Chief Minister Arvind Kejriwal's petition challenging the summonses issued to him by the Enforcement Directorate in connection with its probe into an excise policy-linked money-laundering case. A bench headed by Justice Prathiba M Singh granted four more weeks to the AAP leader to file a rejoinder to the reply submitted by

to the reply submitted by the ED. The senior counsel,

appearing for Kejriwal, sought more time



to file the rejoinder saying there are certain changes in the circumstances and they have not been given a proper legal interview, a plea for which is pending in the high court.

"Let the rejoinder be filed in four weeks," the bench, also comprising Justice Amit Sharma, said.

The counsel for the ED had earlier said the petition against the summonses was infructuous after Kejriwal's arrest by the agency on March 21 in the money-laundering case following the high court's refusal to grant him interim protection from coercive action. On April 22, the court had given two weeks' time to Kejriwal to file his rejoinder. On the next date of hearing in May, the court allowed him four weeks more to place his stand on record

The AAP national convenor had approached the high court in the wake of the ninth summons issued by the ED asking him to appear before it on March 21. The high court bench had on March 20 asked the ED to file its reply with respect to the maintainability of the petition. The next day, it asked the ED to also respond to Kejriwal's plea seeking protection from arrest, saying "at this stage" it was not inclined to grant him any interim relief. Kejriwal was arrested by the ED later that evening.

On June 20, the trial court granted bail to Kejriwal in the moneylaundering case but on June 25, the high court stayed the bail order following a challenge mounted by the ED. On June 26, the CBI

Can expect rapid implementation of AP reorganisation act now: Congress jab Modi

NEW DELHI, Jul 11 (Agencies): The Congress on Thursday claimed that the Modi government implemented the Andhra Pradesh Reorganisation Act 2014 at a "lackadaisical pace" but with Prime Minister Narendra Modi having "lost majority" on his own, a rapid implementation of the legislation can be expected. Congress general secretary, in-charge communications, Jairam Ramesh's assertion came over a media report which claimed that the Centre has acceded to a major demand of setting up an oil refinery and petrochemical hub in Andhra Pradesh with an investment of over Rs 60,000 crore.

"An oil refinery and petrochemical complex in Andhra Pradesh was originally a commitment made by Dr.Manmohan Singh's Government in the Thirteenth Schedule of the Andhra Pradesh Reorganisation Act 2014," Ramesh said.

"In fact, the 'one-third' Pradhan Mantri's government was legally obliged to deliver the project within the last ten years, and IOC/HPCL was obliged to examine the feasibility of the project within six months " he said.



The "one-third Pradhan Mantri's government", after failing to move for 10 years, has only initiated the feasibility study now, Ramesh said. Ramesh further said that this lackadaisical pace of implementation of the Andhra Pradesh Reorganisation Act was one of the reasons why Chandrababu Naidu garu famously withdrew from the NDA in 2018. "Perhaps now that the 'one-third' Pradhan Mantri has lost his majority and his ego, we can expect rapid implementation of the Act," Ramesh said. In the Lok Sabha polls,

the BJP with 240 seats fell short of a majority but the NDA secured the mandate with 293 seats. Whereas the Congress bagged 99 seats while the INDIA bloc got 234 seats. Following the polls, two Independents who

two Independents who won have also pledged support to the Congress, taking the INDIA bloc tally to 236. MP man claims wife left him as he is dark-skinned; cops call couple for counselling

Two workers crushed to death as heavy boiler falls on them in Thane factory

THANE, Jul 11 (Agencies): Two workers at a factory in Maharashtra's Thane district were killed when a heavy boiler being lifted with the help of a crane fell on them, police said on Thursday.

The incident took place on Wednesday evening at the dyeing unit located in Saravli MIDC (Maharashtra Industrial Development Corporation) in Bhiwandi town, an official from Kongaon police station said.

The boiler was being lifted with the

help of a crane when it slipped and fell on the workers standing below it, he said.

The two workers, Balaram Chowdhari (55) and Pandurang Patil (65), were crushed to death, the official said.

The bodies were later sent to a government hospital for postmortem, he said.

A case of accidental death has been registered as of now and a probe is on into the incident, the police added.

24-year-old beaten to death over affair with minor in Haryana's Rewari district

REWARI, Jul 11 (Agencies): A 24-year-old man from Rajasthan was allegedly beaten to death in Rewari by the family of a girl who suspected he was having an affair with her, police said on Thursday.

The incident happened Monday night in Chitradurga village of Rewari, they said.

Two uncles of the girl have been arrested in connection with the man's death, police said. They have been identified as Dinesh and Ravinder.

"We have taken them on two-day police remand on a city court order and are questioning them," Inspector Prahlad Singh, SHO Khol police station, said.



According to police, Mohit, a native of Alwar district's Giglana village, had gone to meet the 17-year-old girl at her house in Rewari on Monday night.

When the girl's grandparents saw him they raised an alarm and woke up the rest of the family that beat Mohit.

The victim was rushed to a hospital in Rewari by his family members who had come to the village after hearing about the incident. Mohit succumbed at the hospital.

Australian Father Charged With Triple Murder After **House Fire Kills Three**



SYDNEY, Jul 11 (Agencies): An Australian father faced triple murder charges Thursday, accused of setting his home ablaze and locking the door with his seven children and their mother inside.

Three of the children -- two boys aged two and six and a five-monthold baby girl -- died in the weekend blaze in western Sydney's Lalor Park, police said.

The four other young children are in a stable condition in hospital and their 29-year-old mother has been released after treatment, police added.

The 28-year-old father, who is in hospital under police guard after emerging from an induced coma, was refused bail in a Sydney court on three counts of murder and five of attempted murder, court documents showed.

"Police will allege this man is solely

responsible for setting fires inside the premises," New South Wales detective superintendent Daniel Doherty told a news conference after the court hearing

An accelerant had whipped up "a large amount of fire and smoke" in the home and the doors "had been locked" to prevent the family escaping, he said.

A neighbour "very courageously" forced his way inside, rescuing two boys aged four and seven and a nineyear-old girl, as well as the mother, Doherty said.

But the father allegedly prevented the neighbour from saving an 11-year-old boy.

Police then arrived, however, and "had to wrestle with this man and wrestle the boy from his grasp because he was holding on to him, allegedly, and the boy was then rescued", the detective said. A domestic dispute may have led to the "horrendous murderous act", Doherty said.

Most of the children were the accused man's biological children but in any case "they are his family, they are his kids", he said.

"It's not something that I will forget about very quickly."

11 killed as passenger bus collides with pickup truck in northern Philippines

TUGUEGARAO, Jul 11 (Agencies): A bus collided with a pickup truck killing 11 people and injuring six others in a northern Philippine town on Thursday. Those who died were riding the small truck as it was rammed on the side by the bus, causing it to lose control and smash into a roadside food stall in Abulug town, about 600 km (373 miles) north of Manila, said police chief Maj Antonio Palattao

The drivers of both vehicles were

injured, along with the owner of the food stall that was hit by the truck. An investigation is underway to determine who was responsible for the accident, he said.

Deadly road accidents are common in the Philippines because of weak enforcement of traffic laws, dilapidated vehicles and dangerous road conditions, including inadequate safety signs and barriers in mountain roads and farflung provinces.

Three people fatally shot in California home, suspect in police custody

ALAMEDA, Jul 11 (Agencies): Three people were fatally shot in California Wednesday night and a person of interest is in custody, according to the Alameda Police Department.

The APD said in a statement on Facebook that it received a call from an individual who reported that their neighbor had been shot in the 400 block of Kitty Hawk Road in the City of Alameda.

Upon arrival, Alameda police officers located the victim.

The UK mulls tighter crossbow laws after 3 women were slain in an attack, the suspect is in hospital

LONDON, Jul 11 (Agencies): A man suspected of killing the wife and daughters of a BBC radio sports commentator with a crossbow was being treated in a hospital Thursday after being found injured in a cemetery some 15 miles (22 kilometers) from the scene of the crimes.

Police had spent almost a day hunting for Kyle Clifford after the attack on Carol Hunt, 61, and her daughters Hannah, 28 and Louise, 25 at their home in Bushey, northwest of London. Police and ambulance crews called to the suburban cul-desac on Tuesday evening tried to save them, but they were pronounced

Footage from Sky News showed the suspect being carried on a stretcher out of Lavender Hill Cemetery. Crime Unit. Police did not say how or whether Clifford was connected to the women, but said they believed the attack was targeted. British media reported that Clifford was an ex-boyfriend of one of the victims.

Former Indonesian agriculture minister jailed for corruption

Indonesia's anti-graft court has sentenced a former agriculture minister to 10 years in prison for extortion, abuse of power and bribery involving ministry contracts with private vendors

JAKARTA, Jul 11 (Agencies): Indonesia's anti-graft court sentenced a former agriculture minister to 10 years in prison Thursday after finding him guilty of corruption-related extortion, abuse of power and bribery involving ministry contracts with private vendors.

The case has tarnished President Joko Widodo's credibility in fighting corruption. Five other members of Widodo's Cabinet have been sentenced to prison terms in corruption cases, casting a shadow over his efforts to clean up government while his term will end in October

The court in the capital, Jakarta, ruled that the former Cabinet minister, Syahrul Yasin Limpo, was guilty of abusing his power by enriching himself and other officials. It also ordered him to pay a 300 million rupiah (\$18,500) fine, and said he would be subject to another four months' imprisonment if he fails to pay

"The defendant has legally and convincingly been proven guilty of corruption." presiding Judge Rianto Adam Pontoh said. "He wasn't a good example as a public official, what he has done is counter the government's efforts to fight corruption and enriched himself by corruption."

Limpo had been arrested last October by the Corruption Eradication Commission, known as the KPK. He has denied wrongdoing. Several ministry officials testified during the trial that secretariats, directorates general and agencies within the ministry was required to give up 20% of their budgets to Limpo, as though they were indebted to him, and he threated their jobs if they rejected his demands. Vendors and suppliers were also asked to set aside money to fulfill the thenminister's demands, the trial revealed. Limpo used the money

on luxurious cars, gifts and apartments, char-



ter private jets, family parties and gatherings, and for religious observances and pilgrimages. Limpo also used the bribes to disburse humanitarian aid for disaster victims and to his Nasdem political party.

Prosecutors, who sought 12 years imprisonment for Limpo, said the politician accepted a total of 44.7 billion rupiah (\$2.7 million) between January 2020 and October 2023.

In their indictment, prosecutors accused Limpo of ordering his two subordinates, Kasdi Subagyono and Muhammad Hatta, to collect the illicit money.

They were each sentenced to four years in prison in separate cases.

During the trial, Limpo said he was the victim of political persecution and felt that he had been slandered by his subordinates in his ministry who fears of being replaced or removed from their position. "I never received any

information about their objection to any of my orders," Limpo said, "If they think it's wrong, they should consult and discuss with me first."

Widodo campaigned in part on a pledge to run a clean government in a country that ranked 115th out of 180 nations

in the 2023 Corruption Perceptions Index compiled by Transparency International.

Limpo, a former South Sulawesi governor, is the second politician from the Nasdem Party to face recent prosecution. Johnny G. Plate, a former communication minister, was sentenced to 15 years in prison over \$533 million in graft of the construction of mobile phone transmission towers in remote parts of the country. Corruption is endemic in Indonesia and the anti-graft commission,

one of the few effective institutions in the country of nearly 270 million people, is frequently under attack by lawmakers who want to reduce its powers. The KPK has arrested around 250 members

President Joe Biden's administration will resume shipping 500pound bombs to Israel but will continue to hold back on supplying 2,000-pound bombs over concerns about their use in densely populated Gaza, a US official said.

The US in May paused a shipment of 2,000pound and 500-pound bombs due to concern over the impact they could have in Gaza during the war that began with Hamas's deadly October 7, 2023 cross-border raid.

The administration's particular concern had been the use of such large bombs in Rafah, where over one million Palestinians had taken refuge.

"We have been clear that our concern has been about the end-use of the 2,000-lb bombs, particularly for Israel's Rafah campaign, which they have announced they are concluding," a US official said, speaking on the condition of anonymity.

One 2,000-pound bomb can rip through thick concrete and metal, creating a wide blast radius. The US official said the 500-pound bombs were put together in the same shipment with the larger ones that were paused and therefore got held up.

"Our main concern had been and remains the potential use of 2,000 Ib bombs in Rafah and elsewhere in Gaza. Because our concern was not about the 500 Ib bombs, those are moving forward as part of the usual process," the official added.

The US has notified Israel that it is releasing the 500-pound bombs but keeping the hold on the larger ones, a person familiar with the matter said.

In June, Israeli Prime Minister Benjamin Netanyahu claimed Washington was withholding weapons, and pleaded with US officials to remedy the situation. Biden's aides expressed disappointment and confusion over the Israeli leader's remarks. During his visit to Washington, Israeli Defence Minister Yoav Gallant said there had been significant progress on the issue of US munitions supply to Israel, adding "obsta-

cles were removed and bottlenecks were addressed".

Despite the pause on one shipment, Israel has continued to receive a steady flow of US weaponry.

Agency reported last month that between the start of the Gaza war last October and end-June, the US has transferred at least 14,000 of the MK-84 2,000pound bombs, 6,500 500-pound bombs, 3,000 Hellfire precisionguided air-to-ground missiles, 1,000 bunkerbuster bombs, 2,600 airdropped small-diameter bombs, and other munitions.

International scrutiny of Israel's military operations in Gaza has intensified as the Palestinian death toll from the war has exceeded 38,000, according to the Gaza health ministry, and has left the coastal enclave in ruins.

The latest bloodshed in the decadesold Israeli-Palestinian conflict began on October 7 when Palestinian Hamas terrorists attacked southern Israel, killing 1,200 people and taking 250 others hostage, according to Israeli tallies.

The Jammu and Kashmir Service Selection Board (JKSSB) sub-inspector recruitment exam was held on March 27, 2022 but the selected list of 1,200 candidates, along with 1,300 junior engineers and 1,000 finance account assistants. In the present matter, on May 24, 2022, a trial court here had sentenced Malik to life imprisonment after holding him guilty for offences under the stringent Unlawful

convicted and sentenced to life imprisonment.

Appealing against the sentence, the NIA has emphasised that a terrorist cannot be sentenced life term only because he has pleaded guilty and chosen not to go through trial.

While seeking enhancement of the sentence to death penalty, the NIA has said if such dreaded terrorists are not given capital punishment on account of pleading guilty, there would be complete erosion of the sentencing policy, and terrorists would have a way out to avoid capital punishment

A life sentence, the NIA has asserted, is not commensurate with the crime committed by terrorists when the nation and families of soldiers have suffered loss of lives, and that the trial court's conclusion that Malik's crimes did not fall within the category of the "rarest of the rare cases" for grant of death penalty is "ex-facie legally flawed and completely unsustainable".

The trial court, which had rejected the NIA's plea for death penalty, had said the crimes committed by Malik struck at the "heart of the idea of India" and were intended to forcefully secede Jammu and Kashmir from the Union of India.

It had, however, noted that the case was not the "rarest of rare", warranting death penalty.

India unlikely to travel to Pakistan for Champions Trophy, will ask ICC to hold matches in UAE or Sri Lanka

The ICC Champions Trophy will be held next year from February to March 2025 in Pakistan

NEW DELHI, Jul 11 (Agencies): The Indian team will not travel to Pakistan for the ICC Champions Trophy 2025 and will ask the International Cricket Council to hold its matches in Sri Lanka or Dubai, a BCCI source told agency.

The ICC Champions Trophy will be held next year from February to March 2025 in Pakistan. Since 2008's Asia Cup, India has not played any cricket tournaments in Pakistan due to tense relationships between both nations.

A bilateral series from December 2012 to January 2013 in India also marked the final bilateral series between the



two nations. Since then, both nations have only clashed at ICC tournaments and the Asia Cup. Uncertainty has been looming over India's participation in the upcoming event due to the

the two countries. The Pakistan Cricket Board had proposed to India to play all their matches in one city. ESPNcricinfo had reported that Lahore was chosen as the locarelationship between tion where India would

play all of their matches. However, the Indian board is not interested in the prospect of travelling to Pakistan. Talking about India's

participation in the Champions Trophy, a BCCI source told agency, "India will not travel to Pakistan for the Champions Trophy 2025. Will tell ICC to hold its matches in Dubai or Sri Lanka.' **BCCI Vice President** Rajeev Shukla, in May, said the Indian team would be sent to Pakistan for the tournament only if the central government permitted it. Speaking to the agency, Shukla said, "In

case of the Champion Trophy, we will do whatever the Government of India will tell us to do. We send our team only when the Government of India permits us. So we will go according to the decision of the Indian government."

It was the second consecutive time that Starc was left out of the playing XI against Afghanistan. Earlier, the 34-yearold was also benched in the group fixture against the same team in the 2022 T20 World

Cup

Speaking on his exclusion, the 2021 World Cup winner recently revealed that the team management went ahead with the spinner with the conditions favouring him.

"No -- two World Cups in a row. They saw previous games on that ground with spin playing a part and obviously Ash and the left-armer enticing them to make a change,' Starc said on the WillowTalk podcast.

Further speaking ahead, Starc criticized the pre-tournament seedings and the scheduling of the super 8 stages for the event.

Starc criticises Australia's scheduling "We finished ahead of England and end up where we were pre-seeded as the second side. All of a sudden, you're in a different group. We had the two night games and the third was a day game, so it wasn't the best preparation. We had a delayed flight out of St Vincent, a 90-minute drive from the airport to the hotel in St Lucia, our players got in late by night and then a 10 o'clock toss," he added. Starc didn't have a memorable tournament with the ball as he picked five wickets from as many games at an average of 30.80 and an economy of 8.55. The left-arm seamer was also smacked for 28 runs in a single over by India captain Rohit Sharma in their last Super 8 fixture.

Australia ended up losing the game 24 runs and Afghanistan's win in their last game against Bangladesh sent them out of the tournament.

Promised coach's job by Punjab CM Bhagwant Mann, Paramjeet working as groundsman

CHANDIGARH, Jul 11 (Agencies): Paramjeet Kumar's life had changed completely when he received an appointment letter from Punjab Chief Minister Bhagwant Mann early last year. Or so he thought!

After stories went viral that former international hockey player Kumar, who had played for the junior India team, was working as a labourer at the Faridkot mandi, he was invited by the CM to his house and promised a job as a coach with the state's sports department. A month later, the CM handed Kumar the appointment letter and asked him to join as coach in Bathinda.

For Kumar, it was the stuff of dreams. But reality hit soon when the department officials objected, saying that Kumar did not fulfil the educational requirements.

"They said that since I was not a graduate, my appointment could be challenged in court," said Kumar.

As he did not qualify for the coach's position, Kumar was hired as a contractual groundsman in Faridkot. "I get a salary of Rs 8,000. It is not much, but they also hired my wife so we get around Rs 20,000 every month," he said.



But Kumar is not willing to give up on his once-in-a-lifetime opportunity - the 31-yearold has taken up the endeavour to complete his graduation. "Working hard" towards his goal, Kumar hopes the government comes good on its word when he completes his graduation. "I hope they fulfil their promise or the government doesn't change by then," Kumar said

Till then, Kumar is also trying out for better opportunities. He was in Mohali on Wednesday for the trials to recruit contractual coaches for the state government's planned nurserv centres.

Lesson for young athletes

Kumar's plight is a lesson for young athletes, said a senior hockey coach with the sports department. "Most athletes don't pay attention to their studies during their playing days. They think that their sports achievements will be enough," the coach said. "But they don't factor in the possibility of injuries. They don't realise that graduation is a basic necessity. I don't blame them, most athletes do not get proper guidance," he added. Kumar, who trained at the NIS Patiala for five years, has won multiple national medals. In 2007, he was selected to play at the Junior Asia Cup alongside current India team star Manpreet Singh but the tournament was cancelled. After playing on contract for many departmental teams, Kumar suffered an injury in 2012, and could never return to his highest level.

The coach said that rather than waiting on the government's promise Kumar should try for jobs under the sports quota. "He has the accomplishments. He should get his certificates graded. He will get a government job through the sports quota. There are many openings in various departments," the coach said.

Indian athletics team to train at 3 overseas sites for final **Olympics** prep

NEW DELHI, Jul 11 (Agencies): The 30-member Indian athletics team for the Olympics will train at three different venues abroad in their last leg of preparations before assembling in Paris on July 28, four days before the start of track and field competitions. The Olympic Sports Center in Spala, Poland; Antalya in Turkey; and St Moritz in Switzerland are the three foreign destinations where Indian athletes will train in their last leg of preparations.

"The members of the national athletics team will be training at different venues to prepare for the Olympic Games, but will have to assemble in Paris on July 28," chief coach Radhakrishnan Nair said. Olympic and world champion javelin thrower Neeraj Chopra will be based in Antalya in Turkey." He (Chopra) has already reached Turkey and will reach Paris on July 28," Nair said.

Ankita Dhyani, based on their rankings in the World Athletics Road to Paris system. 


