#### Police begin probe after three bodies found in Dal Lake

SRINAGAR, July 28 (Agencies): Three bodies that were retrieved from Dal Lake near Foreshore Road in Srinagar yesterday have been identified as Ramban residents even as police said further investigation is going on.

A top police official said that the deceased include a woman and her minor kids and they were residents of Ramban's Gool area.

He said that the primary investigation suggests that this could be the case of suicide by drowning, but final conclusion will be made once probe is completed. "A special team of doctors, including forensic experts, are on job to ascertain details and further investigation is underway," he said.

The official said that as a professional force Srinagar police will conduct foolproof inquiry into the matter, while forensic experts are already on

# President Droupadi Murmu appoints New Governors in 9 States

NEW DELHI, July 28 (Agencies): In a significant reshuffle, the President of India Droupadi Murmu has announced the appointment of several Governors.

The appointments

which were made are Haribhau Kisanrao Bagde (Governor of Rajasthan), Jishnu Dev Varma (Governor of Telangana), Om Prakash Mathur (Governor of Sikkim), Santosh Kumar Gangwar (Governor of Jharkhand), Ramen Deka (Governor of Chhattisgarh), C H Vijayashankar (Governor of Meghalaya), C.P.



Radhakrishnan, currently the Governor of Jharkhand with additional charge of Telangana, has been appointed as the Governor of Maharashtra, Gulab Chand Kataria, currently the

Governor of Assam, has been appointed as the Governor of Punjab and Administrator of the Union Territory of Chandigarh.

Similarly Lakshman Prasad Acharya, currently the Governor of Sikkim, has been appointed as the Governor of Assam and will also hold additional charge as the Governor of Manipur. Additionally, the President has appointed K. Kailashnathan as the Lieutenant Governor of Puducherry.

The President of India has accepted Banwarilal Purohit's resignation as Governor of Punjab and Administrator of the Union Territory of Chandigarh. These appointments will take effect from the dates the appointees assume charge of their respective offices.

# Judges should use a sense of robust common sense in bail petitions: CJI D Y Chandrachud

BENGALURU, July 28 (Agencies): Chief Justice of India D Y Chandrachud on Sunday said the trial Judges prefer playing safe by not granting bail on important issues of crime when it is looked at with a degree of suspicion.

The Chief Justice underlined the need for a 'sense of robust common sense' to look at the nitty-gritty of each case.

"People who should be getting bail in the trial courts and not getting it there, as a result of which, they have to



invariably move the high courts. People who should be getting bail in the high courts will not necessarily get it, as a result of which, they have to move to the Supreme Court. This delay compounds

the problem of those who are facing arbitrary arrests," Justice Chandrachud said.

He was replying to a question at the end of a keynote address during the '11th Annual Conference of the Berkeley Centre on Comparative Equality and Anti-Discrimination'. The question was on the arbitrary arrests.

The questioner said we seem to live in a society where one acts first and seeks forgiveness later. This has become particularly true for

#### Joint search Op launched following suspicious movements in Poonch, Reasi



JAMMU, July 28 (Agencies): Security forces have launched joint search operations in the border and mountainous areas of Jammu and Kashmir's Poonch and Reasi districts after receiving information about suspicious movements, officials said on Sunday.

The forces are on high

alert and have urged residents to report any suspicious activities in their localities.

The officials said a massive joint search operation was initiated early Sunday in several areas along the Line of Control (LoC) near the Salotri-Mangnar forward area of Poonch district.

#### Punjab Police busts International Drug Network, arrests two with Rs 1 Crore Cash

CHANDIGARH, July 28 (Agencies): The Punjab Police on Sunday said it has busted an international drug network with the arrest of two persons and also recovered over Rs 1 crore cash from them

The accused were working for two drug smugglers based abroad, said Director General of Police Gauray Yaday.

"In an intelligence-based operation, @Pun-jabPoliceInd busts international drug network, seizes over Rs 1 crore drug money and apprehends 2 operatives of foreign-based top drug smugglers Gurjant Singh Bholu & Kinderbir Singh @ Sunny Dyal," Yadav said in a post on X.



The State Special Operation Cell, Amritsar has registered a case against the foreign-handlers and two operatives for running an organised crime syndicate, he said.

# Three students die after coaching institute basement flooded in Delhi's Rajendra Nagar

NEW DELHI, July 28 (Agencies): One more body was recovered from the flooded basement of a coaching institute in Delhi's Rajendra Nagar, taking the total tally of deaths to three.

The rescue teams recovered a third body from the basement. The search operation is still underway at the spot.

A group of students also staged a protest against the MCD at the spot after the recovery of bodies.

DCP Central, M Harshavardhan, urged all the students not to carry protests as it would hamper the rescue services.

"The bodies have been sent to the hospital for further legal action. Rescue operations are still underway. The water is being pumped out. There is still about seven feet of water in the basement. I request the student community to not come here and hamper the rescue services. We share their pain but coming here to the spot is not the solution. It will hamper the rescue services," he said.

Delhi Police said that due to very poor visibility and a flooded basement, divers and National Disaster Response Force (NDRF) are still searching the spot.

Reacting to the incident, Fire Officer Atul
Garg said, "A total of five



#### All PDS left out e-Shram registrants asked to contact respective AD, Tehsil Supply Offices for ration cards/inclusion: Dept of FCS&CA

SRINAGAR, July 28: The Department of Food, Civil Supplies and Consumer Affairs (FCS&CA) through an official communique has requested the e-Shram registrants who are left out in PDS to come forward and contact their respective Tehsil Supply Offices or Offices of the Assistant Directors for issuance of ration cards/ inclusion.

This is in line with the orders of the Supreme Court of India, to provide inclusion / ration cards to e-Shram registrants who are presently without ration cards, but are eligible to take foodgrains under PDS.

The Department towards its commitment to provide ration cards/ inclusion under PDS, as per the eligibility, to all left-out e-Shram portal registrants of J&K has also carried out special drives including camps organized on 2nd, 3rd February and 23rd, 24th of June 2024 across all the districts of Jammu & Kashmir in the respective Tehsil Supply Offices and in the offices of Assistant Directors

The Department has

such registrants in whose case e-Shram registration could not establish inclusion in the PDS database, after matching of respective data. In its effort, till now the Department has reached out to 20656 such registrants in Kashmir Division. Out of these 18136 were found already enrolled in the ration cards and 2555 registrants were found not having ration cards. Out of the 2555 registrants, 1876 have been included in the existing ration cards of their families and 154 have been provided new ration cards, besides for remaining registrants either there was a mismatch in Aadhaar details

produce requisite documents. In case of Jammu Division, till now 47297 such registrants have been reached out by the Department. Out of these 39213 were found already enrolled in the ration cards and 8084 registrants did not have ration cards. Out of the 8084 registrants, 6671 have been included in the existing ration cards of their families and 665 have been provided new

or they have failed to

ration cards, besides for remaining registrants either there was a mismatch in Aadhaar details or they have failed to produce requisite documents.

As per the official communique the Department has also been approaching these registrants, in whose cases a mismatch has come to fore, on their given phone numbers. however in many cases the contact numbers were either found to be unavailable or not in use or belonging to different

The Department has now again requested all such e-shram registrants, who do not have a ration card or have not been included in their entitled household ration card, to reach out to the nearest Tehsil Supply Office or the Office of Assistant Director along with the requisite documents including Aadhaar card, Domicile Certificate, Income Proof and e-Shram card for being considered for issuance of ration card or for inclusion in their family ration

card, as per eligibility. Additionally the Department has also asked all those PDS beneficiaries

and e-Shram registrants who are also PDS beneficiaries and who have not vet completed their eKYC with the Department of Food, Civil Supplies & Consumer Affairs. to complete this eKYC process at an earliest, to avoid any inconvenience they may face in future and to overcome any mismatch in their data details in PDS database. This EKYC process is required to be completed urgently as per orders of the Supreme Court.

As per the Department, around 83 per cent of the beneficiaries under NFSA and 65 per cent in Non Priority Households group have completed their eKYC so far. The remaining beneficiaries have been asked to complete their eKYC at their nearest FPS or Government sale centre urgently to avoid any inconvenience in future.

Further, it has also been informed that the PDS beneficiaries who are presently out of Jammu & Kashmir can also complete their eKYC from anywhere in the country at the nearest FPSs as that feature has also now been enabled in the system

# NATURAL CALAMITIES

'atural calamities in India pose significant challenges due to the country's diverse geographical and climatic conditions. India experiences a wide range of natural disasters, including earthquakes, floods, cyclones, droughts, landslides, and forest fires, each with varying impacts on human lives, infrastructure, and the environment. Earthquakes are a common natural disaster in India, primarily due to its location on multiple tectonic plates. Cyclones are frequent along India's eastern and western coastlines during the pre-monsoon and post-monsoon seasons. The Bay of Bengal witnesses cyclones such as Phailin (2013) and Amphan (2020), while the Arabian Sea experiences cyclones like Cyclone Tauktae (2021). These cyclones bring strong winds, heavy rainfall, storm surges, and widespread damage to coastal areas, necessitating evacuation efforts and relief operations. Droughts are another significant natural calamity in India, affecting agricultural productivity, water availability, and livelihoods, especially in arid and semi-arid regions. States like Rajasthan, Gujarat, Maharashtra, and Karnataka often face prolonged dry spells leading to water scarcity, crop failure, and distress migration. Droughts exacerbate poverty and food insecurity, requiring drought relief measures and long-term water management strategies. Landslides occur frequently in hilly and mountainous regions, triggered by heavy rainfall, deforestation, and seismic activity. Uttarakhand, Himachal Pradesh, and parts of the Western Ghats are

# **Growing Fears of Technological Disaster**

**¬**oday's world is of technology. Measures like computers, internet, artificial intelligence have made our work easier in many ways. During the Covid pandemic, the world had seen that due to these facilities there was no major disruption in its movement. But this is one aspect of dependence on technology, the other aspect is what was presented before 19. On July 2024, 5 lakh computers worldwide crashed due to a faulty technical update running on Microsoft Windows. ItsThe question is why this happened and whether the world can avoid such technological accidents. What happened after all that a minor update became a problem for the operation of computers. This data has been released by the Microsoft company itself that the problem that arose on July 19 caused a problem called 'Blue Death of Screen' (BDOS) on at least 85 lakh computers. The entire screen of computers is suddenly working due to this. The letters turned sky blue and an error message started appearing on them. Although such messages of errors remain local due to various activities on computers, but this time the problem was worldwide. That's why. This happened because CrowdStrike, another company to protect Microsoft computers from cyber attacks, had released an automatic 'software update' for all Microsoft computers, which kept on coming and leaving some flaws. As this software update begins, Microsoft WindowsThe computers running on it stopped operating. Since this Computers are equipped with automatic shutdown mechanisms

when an internal (such as a hardware or motherboard problem) or external problem (such as a virus attack or cyber attack) occurs, so they may stop working as soon as a faulty software update is introduced. . In particular, the blue screens of millions of computers connected to the 'Clyde Network' made it clear that their system had crashed. This software update, called CrowdStrike Falcon, is actually a cyber security tool, whichIt is designed to protect computers from various cyber attacks. But there was a technical flaw in it. Therefore, the operation of computers equipped with Microsoft Windows stopped suddenly. There is a need to consider that in the present world, when there is talk of handing over all the work to internet based technologies and devices, what will happen to the world if there is an immediate 'shutdown'. The artificial intelligence which is being touted as the cure for all diseases is not a blessing from the sky but it is also based on the Internet andThere is a system based on the network of computers, which is called Tuki Vhee Ki Ran' Bhi' Dha Dhawana Vadhna Method. There is also a possibility that some faulty system operating within it might do such a thing and the world would remain cheated. Today, the way hospitals are being run all over the world through the network of computers connected to the Internet, traffic control is being done, stock markets, reservation systems and even the security systems of countries are based on them - in such a situation, if there is any technical flaw, all the arrangements are being made. Can destroy in a single moment. It is noteworthy that There is

no dearth of factors causing such technical flaws. This can happen due to cutting of the 'cable' laying under the sea providing internet services. This situation can occur in case of server failure due to power failure. This is a recent example of a software glitch, but this can also happen due to a computer virus attack or a cyber attack by an enemy country. It is possible that the situation may worsen due to the satellites through which internet or cloud internet services are being provided, getting hit by a solar storm. to say-There are anti-viruses available to protect computers from viruses, there are many measures to prevent cyber attacks, but what about other technological disasters when a simple activity like a software update can create such a big crisis. Go. The latest digital tsunami occurred when a company implemented a legitimate and possibly tried and tested technique like a software update. But imagine what happens when a hostile country, hacker or terrorist group deliberately unleashes a technological disaster on the world. What will be the result if I join forces? This is aIt is a strange irony that the Texas (America) based cyber security company Crowd-Strike is responsible for protecting millions of computers running the 'Aapre Operating System' called Microsoft Windows from cyber attacks and keeping them running smoothly. A software update recently caused such a huge digital disaster. This company is considered an expert in cyber security. It is claimed that corporate networks and cloud networks of large companies, airlines, emergency services and This company plays an important

role in protecting connecting devices etc. from computer viruses, malware and hacking. Especially companies using cloud network services take the services of Crowd-Strike to keep their servers safe from cyber attacks and hacking. This company is said to play an important role in investigating cyber attacks around the world. But the latest incident has raised questions on the credibility of CrowdStrike company as well as Microsoft. Similarly, in 2010, antivirus manufacturing company McAfee was unaware of a mistake.Windows XP PCs were discontinued worldwide in 2015. There was a similar stir at that time also. It is not that this is the only incident of internet dependent cyber network being disrupted. Small technical accidents happen frequently. Sometimes the server of 'Meta', the company that operates WhatsApp, Instagram, Facebook etc. gets stalled, and sometimes Google's performance slows down. Cyber attacks and hacking have shocked the world. It is true that many tasks have become convenient with the Internet and computers, butAs our dependence on selected technology companies is increasing, we will have to be prepared for such technological disasters. How can a technological storm destroy a world which has turned into an island with the help of technological arrangements? The time has now come to remember this lesson and make arrangements to avoid it.

#### Rachel Leviss opens up about ADHD diagnosis: 'I always just thought i was stupid' diagnosed with inatten-

Rachel Leviss recently shared her story of being diagnosed with undiagnosed ADHD during childhood on her podcast, Rachel Goes Rogue. She explained that the change in status after receiving a diagno-

sis was profound for her. Leviss, 29 years old, reflected on her school years and pointed out that they were very difficult. She said, "I always just thought I was stupid because I couldn't pass my multiplication tables test, and I couldn't read as well as the other kids in class," the Vanderpump Rules alum said. "I just thought I wasn't intelligent."

It was not until college that Leviss was formally

tive ADHD, a common form of ADHD marked by problems with attention and concentration, the ability to complete tasks, and organization.

When Rachel Leviss found out that she had ADHD, she noted that getting a diagnosis felt like she had been living with a disability that was invisible to her her entire life. She found out that a diagnosis allowed her take charge of her situation, get appropriate support, and improve her life.

"I realized that I had been living with an invisible disability my whole life," she said. "Once I was diagnosed, I was able to take control of

my life a little bit more and to get the accommodations that I needed to succeed in school. That truly was life-changing for me."

During her podcast episode titled Rachel Goes Rogue, Leviss introduced listeners to the process of masking with the help of Paige Layle, an autistic and ADHD activist. Most people wear masks when interacting in public, and this could reduce the chance of an AS person being as he or she is.

"When you mask, you're unable to be authentically yourself," Leviss said. "You just process things a different way, and you've worked your whole life



taking in data from other people and figuring out what the social norms are and, you know, shifting things inside of yourself to present a certain way so that you could survive socially," Layle, author of But Everyone Feels This Way: How an Autism Diagnosis Saved My Life, explained about masking.

Leviss described how masking affects one's ability to be genuine, while Layle, author of But Everyone Feels This Way: Sharing their experience of masking, How an Autism Diagnosis Saved My Life, went deeper into explaining that masking is about constantly fitting into

society and changing oneself to survive in it. Rachel Leviss opens up about masking

Leviss explained that masking, although it is helpful to protect oneself and others, also erases people's true selves. She explained that masking puts you in front of a persona that you think people wish to meet, which, in essence, hinders them from addressing one

another. "When you do that, it does keep you safe, but it also takes away your authenticity," she said. "You become lost and, like, you're presenting yourself in the way that you think other people need to perceive you."

Leviss was aware of the fact that she was unable to be herself and pretended to be someone she was not for quite some time just to stay alive. For this reason, she lost touch with many of her friends because she was pretending to be someone she was not.

"And, like, to be safe, I needed to not be myself, whoever that person was. I'll just be what it looks like everyone wants me to be. Then how could I not be safe? But then I had so many connections that weren't real at all," she continued. "Because I wasn't real."

In a post in Hindi on X, Gandhi said,

"The death of students preparing for competitive exams due to waterlogging in the basement of a building in Delhi is very unfortunate. A few days ago, a student died due to electric shock during

He expressed heartfelt condolences to the bereaved families.

"This collapse of infrastructure is a combined failure of the system. The common citizen is paying the price of unsafe construction, poor town planning and irresponsibility of institutions at every level by losing his life," the former Congress chief said.

A safe and comfortable life is the right of every citizen and the responsibility of governments, Gandhi asserted.

The Delhi Police on Sunday arrested the owner and coordinator of the coaching centre where three students died due to flooding following heavy rains, officials said.

Police have booked them under charges of culpable homicide among others, they said.

#### Kerala woman shot at by masked female attacker

THIRUVANAN-THAPURAM, Jul 28 (Agencies): A woman was injured and admitted to the government hospital here after she was fired at allegedly by a masked female attacker. The injured was identified as Shiny, aged 39, of Vanchiyoor in the state capital city.

According to Bhaskaran Nair, father-inlaw of the victim, a woman, who was wearing a hood and had her face covered, arrived at their residence here on Sunday morning and enquired about Shiny.

The woman informed Nair that there was a



courier for Shiny and that it could be handed over only to her after getting her signature.

Shiny came out and when she was about to receive the courier, the woman fired at her and in a reflex she put out her right hand and was injured in the palm. The masked woman immedi-

ately fled from the spot. Thiruvananthapuram City Police Commissioner Sparjan Kumar, who reached the spot, told media persons that the firing was done with an air gun.

#### "Failure Of Basic Maintenance": Delhi Lt Governor **On Coaching Centre Deaths**

NEW DELHI, Jul 28 (Agencies): Delhi Lt Governor VK Saxena on Sunday directed the divisional commissioner to submit a report on the incident at a coaching centre in Rajinder Nagar where three civil service aspirants were killed due to raininduced flooding in the basement.

He said the incident points to "criminal neglect" and lack of "basic maintenance" by concerned agencies.

Mr Saxena said he is deeply anguished by the incident of death of the civil services aspi-



rants. "That this should happen in the Capital of India is most unfortunate & unacceptable," he said in a post on X.

"Reportedly 7 other citizens have died due to electrocution in the past few days. My deep-

est condolences to the families of those who have lost their lives. You are in my thoughts and prayers," he said.

Mr Saxena said he has been keeping a close watch over the situation and has monitored the

rescue operations by Delhi Police and the fire department personally.

"These incidents clearly points towards criminal neglect & failure of basic maintenance & administration by concerned agencies & departments," he said in another post.

"Drainage in the city and related infrastructure, as also required efforts and endeavours to address these have apparently collapsed, Mr Saxena said.

He added that the incident is indicative of the "larger malaise of misgovernance that Delhi has been subjected to during the last decade or so".

The role of coaching institutions and landlords in not ensuring basic safety of students, who pay hefty fees and rents, away from their homes needs to be looked into, the LG said.

"What has been happening is unpardonable and such issues can no more be glossed over. I have asked the Divisional Commissioner to submit a report, covering every aspect of the tragic incident by Tuesday," he added.

#### Tamil Nadu to open Mettur Dam for Kuruvai cultivation after Cauvery review meet



CHENNAI, Jul 28 (Agencies): Tamil Nadu Chief Minister MK Stalin held a review meeting on Sunday with authorities on Cauvery water management and decided to open the Mettur Dam for Kuruvai crop irrigation.

The release of water from the Mettur Dam, which was supposed to happen at the beginning of July, had to be postponed as water from Karnataka was not released. Tamil Nadu raised objections after Karnataka Chief Minister Siddaramaiah decided not to release the amount of water recommended by the Cauvery Water Management Authority (CWMA), citing a lack of

rainfall

The Tamil Nadu government held an all-party meeting and decided to approach the Supreme Court if necessary.

However, following heavy rainfall in the Cauvery water catchment areas, the water level in the Mettur Dam rose to 109.20 ft with 77.30 TMC of water. The Mettur Dam is receiving 1.48 lakh cusecs of excess water from four Karnataka dams, and as per weather predictions, rain is expected to continue in the areas, ensuring water availability for three more days. MK Stalin held a review

meeting with authorities and decided to open the Mettur Dam by 3 pm on July 28, initially releasing 12,000 cusecs of water. He also held a video conference with the concerned district collectors, instructing them to manage the water release and facilitate the 'Aadi Perukku' festival.

The water released from the Mettur Dam will be used for Kuruvai (long-term) paddy cultivation in 13 districts.

# Kamala Harris calls herself an underdog, touts her campaign as 'people powered'

Harris alleges that Trump was spreading lies against her

WASHINGTON, Jul 28 (Agencies): Kamala Harris, the presumptive presidential nominee of the Democratic party, has called herself the underdog in the race to the White House but expressed confidence that she would win in November due to her people-powered

In her first fundraiser since becoming her party's candidate for president, Harris told supporters that this year's election was a choice between two visions for the country — one looking toward the future and one that wants to undo the country's progress.

"We are the underdogs in this race. Level set, ok. We are the underdogs in this race, but this is a people-powered campaign," Vice President Harris said, addressing a group of 800 fundraisers in Pittsfield, Massachusetts.



"This is a people-powered campaign and we have momentum," Harris, 59 said. During the fundraiser on Saturday, she raised USD 1.4 mil-

lion as against the original goal

of USD 400,000.

Amidst loud applause from the audience, she said that her campaign has "earned the support of enough delegates to secure the Democratic nomina-

"What kind of country do we want to live in? Do we want to live in a country of freedom, compassion and rule of law or do we want to live in a country of chaos, fear and hate?" she asked as she continued to attack her Republican rival Donald Trump, 78. She hoped that former president Trump would agree to do a debate

"You may have seen he just pulled out of our debate. I hope he reconsiders because we have a lot to talk about," Harris, who has Indian roots, said. In her speech, she described her background as a prosecutor.

"In those roles, I took on perpetrators of all kinds. Predators who abused women, fraudsters who ripped off consumers, cheaters who broke the rules for their own gain. So hear me when I say, I know Donald Trump's type," she said.

She alleged that Trump was spreading lies against her. "You may have noticed; Donald Trump has been resorting to some wild lies about my record. And some of what he and his running mate are saying, well, it's just plain weird. I mean that's the box you put that in," she said.

#### Israel says Hezbollah 'crossed all red lines' after Golan rocket fire



JERUSALEM, Jul 28 (Agencies): Israel's foreign ministry on Sunday said that Hezbollah had "crossed all red lines" with a rocket strike blamed on the Lebanese armed group that killed 12 youngsters on the annexed Golan Heights.

"Saturday's massacre constitutes the crossing of all red lines by Hezbollah. This is not an army fighting another army, rather it is a terrorist organisation deliberately shooting at civilians," the ministry said in a statement.

Iran-backed Hezbollah, which on Saturday claimed multiple attacks on Israeli military positions following a deadly raid on southern Lebanon, has denied responsibility for the strike that hit the Golan Heights town of Majdal Shams.

The foreign ministry said "an Iranian rocket" caused the deaths of "our boys and girls".

"Hezbollah is the only terror organisation which has those (rockets) in its arsenal", it

"Israel will exercise its right and duty to act in self-defence and will respond to the massa-

The military said the rocket attack killed 12 people aged between 10 and 20 years when they were hit on a football field in Majdal Shams, a Druze town where many residents have not accepted Israeli nationality since the Golan Heights was seized from Syria in

Prime Minister Benjamin Netanyahu, who was returning early from a visit to the United States, vowed that "Israel will not let this murderous attack go unanswered".

He was due to head a security committee meeting later on Sunday, his office said.

#### 11 killed by mudslide in China as heavy rains from tropical storm Gaemi drench region

BEIJING, Jul 28 (Agencies): Eleven people were killed after a mudslide hit a house in southeastern China on Sunday as heavy rains from a tropical storm drenched the region, state media said.

Elsewhere in China, a delivery person on a scooter was killed Saturday after being hit by a falling tree in Shanghai, apparently because of strong winds related to the storm, according to The Paper, a digital news outlet.

The deaths were the first in China that appear linked to Typhoon Gaemi, which weakened to a tropical storm after making landfall on Thursday. Before reaching China, the typhoon intensified monsoon rains in the Philippines. leaving at least 34 dead, and swent across the island of Taiwan, where the death toll has risen to 10, authorities said late Saturday.

The mudslide struck the house about 8 a.m.



in Yuelin village, which falls under the jurisdiction of Hengyang city in Hunan province, state broadcaster CCTV said in a series of online reports.

An earlier report said that 18 people were trapped by the mudslide, and that six injured people had been rescued. It wasn't clear in the latest report if one other person remained missing. The reports didn't say who was staywas was rented for temporary stays

There was no information on whether the injuries were serious.

#### Bangladesh students vow to resume protests unless leaders freed

DHAKA, Jul 28 (Agencies): A Bangladeshi student group has vowed to resume protests that sparked a lethal police crackdown and nationwide unrest unless several of their leaders are released from custody on Sunday.

Last week's violence killed at least 205 people, according to an agency count of police and hospital data, in one of the biggest upheavals of Prime Minister Sheikh Hasina's 15-year tenure.

Army patrols and a nationwide curfew remain in place more than a week after they were imposed, and a police dragnet has scooped up thousands of protesters including at least half a dozen student leaders.

Members of Students Against Discrimination, whose campaign against civil service hiring rules precipitated the unrest, said they would end their weeklong protest morato-



The group's chief Nahid Islam and others "should be freed and the cases against them must be withdrawn", Abdul Hannan Masud told reporters in an online briefing late Saturday.

Masud, who did not disclose his location because he was in hiding from authorities, also demanded "visible actions" be taken against government ministers and police officers responsible for the deaths of protesters.

"Otherwise, Students

Against Discrimination will be forced to launch tough protests" from Monday, he said.

Islam and two other senior members of the protest group were on Friday forcibly discharged from hospital in the capital Dhaka and taken away by a group of plainclothes detec-

Earlier in the week Islam told agency he was being treated at the hospital for injuries police inflicted on him during an earlier round of detention and said he was in fear for his life.

Home minister Asaduzzaman Khan told reporters Friday that the trio were taken into custody for their own safety but did not confirm if they had been formally arrested.

Police told agency on Sunday that detectives had taken two others into custody, while a Students Against Discrimination activist told agency that a third had been taken on Sunday

At least 9,000 people have been arrested nationwide since the unrest began according to Prothom Alo, Bangladesh's largest daily newspaper.

Protests began this month over the reintroduction of a quota scheme reserving more than half of all government jobs for certain candidates.

With around 18 million young Bangladeshis out of work, according to government figures, the move deeply upset graduates facing an acute employment

Critics say the quota is used to stack public iobs with lovalists to the ruling Awami League.

The Supreme Court cut the number of reserved jobs last week but fell short of protesters' demands to scrap the quotas entirely.

Prime Minister Hasina has ruled Bangladesh since 2009 and won her fourth consecutive election in January after a vote without genuine opposition.

# Venezuelan election could lead to seismic shift in politics or give President Maduro six more years

CARACAS, Jul 28 (Agencies): The people of Venezuela are voting Sunday in a presidential election whose outcome will either lead to a seismic shift in politics or extend by six more years the policies that caused the world's worst peacetime economic collapse.

Whether it is President Nicolás Maduro who is chosen, or his main opponent, retired diplomat Edmundo González, the election will have ripple effects throughout the Americas. Government opponents and supporters alike have signaled their interest in joining the exodus of 7.7 million Venezuelans who have already left their homes for opportunities abroad should Maduro win another term.

Polls open at 6 a.m. local time. The number of eligible voters is estimated to be around 17 million.

Authorities set Sunday's election to coincide with what would have been the 70th birthday of former President Hugo Chávez, the revered leftist firebrand who died of cancer in 2013, leaving his Bolivarian revolution in the hands of Maduro. But Maduro and his United Socialist Party of Venezuela are more unpopular than ever among many voters who blame his policies for crushing wages, spurring hunger, crippling the oil

industry and separating families due to migration.

Maduro, 61, is facing off against an opposition that has managed to line up behind a single candidate after years of intraparty divisions and election boycotts that torpedoed their ambitions to topple the ruling party.

González is representing a coalition of opposition parties after being selected in April as a lastminute stand-in for opposition powerhouse Maria Corina Machado, who was blocked by the Madurocontrolled Supreme Tribunal of Justice from running for any office for 15 years.

Machado, a former lawmaker, swept the opposition's October primary with over 90% of the vote. After she was blocked from joining the presidential race, she chose a college professor as her substitute on the ballot, but the National Electoral Council also barred her from registering. That's when González,

a political newcomer, was chosen. Sunday's ballot also features eight other candidates challenging Maduro, but only González threatens Maduro's rule.

Venezuela sits atop the world's largest proven oil reserves, and once boasted Latin America's most advanced economy. But it entered



into a free fall after Maduro took the helm. Plummeting oil prices, widespread shortages and hyperinflation that soared past 130,000% led first to social unrest and then mass

Sanctions from U.S. President Donald Trump's administration seeking to force Maduro from power after his 2018 reelection which the U.S. and dozens of other countries condemned as illegitimate — only deepened the crisis.

In recent days, Maduro has crisscrossed Venezuela, inaugurating hospital wards and highways and visiting rural areas where he had not set foot in years. His pitch to voters is one of economic security.

which he underscores with stories of entrepreneurship and references to a stable currency exchange and lower inflation rates.

The capital, Caracas, saw an increase in commercial activity after the pandemic, bolstering an economy the International Monetary Fund forecasts will grow 4% this year — one of the fastest in Latin America — after having shrunk 71% from 2012 to 2020.

"They tried to subjugate our people," Maduro said of the United States during his closing rally Thursday in Caracas, "but today we are standing tall and ready for victory on the 28th of July."

But most Venezuelans have not

seen any improvement in their quality of life. Many earn under \$200 a month, which means families struggle to afford essential items. Some work second and third jobs. A basket of basic staples sufficient to feed of family of four for a month — costs an estimated

The opposition has tried to seize on the huge inequities arising from the crisis, during which Venezuelans abandoned their country's currency, the bolivar, for the U.S.

González and Machado focused much of their campaigning on Venezuela's vast hinterland, where the economic activity seen in Caracas in recent years didn't materialize. They promised a government that would create sufficient jobs to attract Venezuelans living abroad to return home and reunite with their families.

An April poll by Caracas-based Delphos said about a quarter of Venezuelans were thinking about emigrating if Maduro wins Sunday. The poll had a margin of error of plus or minus 2 percentage points.

Most Venezuelans who migrated over the past 11 years settled in Latin America and the Caribbean. In recent years, many began setting their sights on the U.S.

Both campaigns have distinguished themselves not only for the political movements they represent but also on how they have addressed voters' hopes and fears.

Maduro's campaign rallies featured lively electronic merengue dancing as well as speeches attacking his opponents. But after he caught heat from leftist allies such as Brazilian President Luiz Inácio Lula da Silva for a comment about a "bloodbath" should he lose, Maduro recoiled. His son told the Spanish newspaper El Pais that the ruling party would peacefully hand over the presidency if it loses - a rare admission of vulnerability out of step with Maduro campaign's triumphalist tone.

In contrast, the rallies of González and Machado prompted people to cry and chant "Freedom! Freedom! " as the duo passed by. People handed the devout Catholics rosaries, walked along highways and went through military checkpoints to reach their events. Others video-called their relatives who have migrated to let them catch a glimpse of the candidates. During a rally in mid-May,

González, 74, asked supporters to imagine "a country in which our airports and borders would be filled with our children returning home."

public authorities acting in a politically motivated manner by detaining activists, academics, journalists and even politicians, including the chief ministers of opposition parties, he said.

According to him, all of these actions are taken with deep trust in the face of justice coming very slowly.

In reply, Justice Chandrachud said the Supreme Court has been constantly trying to convey that part of the reason for it is that there is an inherent distrust in the institutions within the country.

"I think it's important that we learn to trust people who may be in a hierarchical legal system, like much below, which are the trial courts. We have to encourage trial courts to be more receptive to the need for accommodating concerns of people who are seeking liberty," the CJI said.

"Unfortunately, the problem today is this, that we look at any grant of relief by trial judges with a degree of suspicion. That means that the trial judges increasingly are playing it safe, not granting bail on

important issues of serious crimes," he explained.

According to the CJI, judges have to look at the nitty gritties and see the fine prints of each case

"You (judges) have to have a sense of robust common sense. Now, unless we, therefore, separate the grains from the chaff in criminal jurisprudence, it's very unlikely that we will have just solutions and to allow for decision makers to separate the grain from the chaff, it's important that we also place a great deal of trust," Justice Chandrachud noted

"I think that's my concern that you can't render courts as in the hierarchy as you go up dysfunctional, just by the number of very small cases that are placed before us".

According to him, most of the cases should not have come to the Supreme Court at all.

"The reason why we are prioritising bail is to send this message across the nation that those at the most incipient levels of the decision-making process have to do their duties without this feeling that. I've been disgusted that my career will be on the line," the CJI underlined.

# After outrage, government clarifies: Tax clearance certificate only for people with tax dues, high-value defaulters

Finance ministry, in the Finance Bill, 2024, has proposed to add reference of Black Money Act, 2015, under which any person should clear his liabilities to obtain tax clearance certificate

NEW DELHI, Jul 28 (Agencies): After social media outrage over a Budget proposal making it mandatory to get tax clearance certificates for going abroad, the government on Sunday clarified that the proposed amendment is not for all, and only those accused of financial irregularities or having substantial tax arrears need such clearance.

The finance ministry, in the Finance Bill, 2024, has proposed to add the reference of the Black Money Act, 2015, to the list of Acts, under which any person should clear his liabilities to obtain the tax clearance certificate.

"The proposed amendment does not require all the residents to obtain the tax clearance certificate," the ministry said in a statement.



As per section 230 of the Income-tax Act, 1961, every person is not required to obtain a tax clearance certificate. Only in the case of certain persons, in respect of whom circumstances exist, which make it necessary to obtain a tax clearance certificate will be required to obtain such a certificate.

The ministry said that the

Income Tax department through a 2004 notification has specified that the tax clearance certificate may be required to be obtained by persons domiciled in India only in certain circumstances.

These include - where the person is involved in serious financial irregularities and his presence is necessary in the investigation of cases under the

Income-tax Act or the Wealth-tax Act and it is likely that a tax demand will be raised against him, or where the person has direct tax arrears exceeding Rs 10 lakh outstanding against him, which have not been stayed by any authority.

The I-T department said that a person can be asked to obtain a tax clearance certificate only after recording the reasons for the same and after taking approval from the Principal Chief Commissioner of Incometax or Chief Commissioner of Incometax.

Such a certificate is required to be issued by the incometax authority, stating that such person has no liabilities under the Income-tax Act, or the Wealth-tax Act, 1957, or the Gift-tax Act, 1958, or the Expenditure-tax Act, 1987, it added.

### Mcap of 6 of top-10 valued firms jumps Rs 1.85 lakh crore; LIC, Infosys biggest winners



NEW DELHI, Jul 28 (Agencies): The combined market valuation of six of the top 10 valued firms jumped Rs 1,85,186.51 crore last week, with Life Insurance Corporation of India (LIC) and Infosys emerging as the biggest gainers.

Last week, the BSE benchmark climbed 728.07 points or 0.90 per cent.

The valuation of LIC surged Rs 44,907.49 crore to Rs 7,46,602.73

crore. Infosys added Rs 35,665.92 crore to its market valuation at Rs 7,80,062.35 crore.

ITC's valuation soared by Rs 35,363.32 crore to Rs 6,28,042.62 crore. The market capitali-

sation (mcap) of Tata Consultancy Services (TCS) jumped Rs 30,826.1 crore to Rs 15,87,598.71 crore and that of Bharti Airtel climbed Rs 30,282.99 crore to Rs 8,62,211.38 crore.

HDFC Bank's valua-

tion rallied Rs 8,140.69 crore to Rs 12,30,842.03 crore.

However, the mcap of Reliance Industries tumbled by Rs 62,008.68 crore to Rs 20,41,821.06 crore. The valuation of ICICI Bank declined by Rs 28,511.07 crore to Rs 8,50,020.53 crore.

State Bank of India's mcap declined by Rs 23,427.1 crore to Rs 7,70,149.39 crore.

Hindustan Unilever's valuation went down by Rs 3,500.89 crore to Rs 6,37,150.41 crore.

Reliance Industries remains the most valued firm followed by TCS, HDFC Bank, Bharti Airtel, ICICI Bank, Infosys, State Bank of India, LIC, Hindustan Unilever and ITC.

## Children at high type 1 diabetes risk if fathers have the condition: Study

NEW DELHI, Jul 28 (Agencies): A team of scientists has revealed that a child is almost twice as likely to develop type 1 diabetes if the father has the condition than the mother.

The study, the largest of its kind and published in the journal Diabetologia, suggests that exposure to type 1 diabetes in the womb confers long-term protection against the condition in children with affected mothers relative to those with affected fathers.

Understanding what is responsible for this relative protection could lead to opportunities to develop new treatments to prevent type 1 diabetes, said researchers.

"Individuals with a family history of type 1 diabetes are 8-15 times more likely to develop the autoimmune condition – however, studies have shown the risk is higher if the affected relative is the father rather

than the mother. We wanted to understand this more," said lead researcher Dr Lowri Allen from Cardiff University in the UK.

Previous studies have suggested that maternal type 1 diabetes is associated with relative protection against type 1 diabetes in offspring during early life.

The new study involved 11,475 individuals who were diagnosed when they were between 0 and 88 years old.

The results show they were almost twice as likely (1.8 times more likely) to have a father with type 1 diabetes as a mother with the condition.

"Taken together, our findings suggest the relative protection associated with having a mother versus father with type 1 diabetes is a long-term effect that extends into adult life," said Allen.

However, the timing of the parent's diagnosis

was important.

An individual was only more likely to have a father, rather than a mother, with type 1 diabetes, if the parent was diagnosed before the individual was born.

In other words, having a mother with type 1 diabetes only appears to provide a child with protection against the condition (relative to having a father with type 1 diabetes) if the mother has the condition during pregnancy, the findings

showed.
Further research is needed to determine what it is about exposure to type 1 diabetes in the womb that is most important.

# **UK's National Health Service uses toothpaste** for mouth cancer warnings

LONDON, Jul 28 (Agencies): Britain's National Health Service (NHS) announced a new supermarket partnership that will see toothpaste and mouthwash bottles caution users about the symptoms of mouth cancer to encourage early detection.

Starting in July, Asda's branded oral hygiene products in over 500 stores across the country will feature NHS advice on the symptoms to watch out for.

Millions of these toothpaste tubes and mouthwash bottles will encourage people to contact their general practitioner (GP) or dentist if they notice any potential signs of concern.

"Early detection is key in the fight against mouth cancers to save and improve lives," said Mahesh Kumar, the Indianorigin president of the Mouth Cancer Foundation and an Oral Maxillofacial Surgeon.

"Any cancer caught early usually incurs a less invasive treatment plan.

It is incredibly important to raise awareness of the signs and symptoms among the general public. The NHS advice on oral hygiene products will go a long way to highlighting the importance of looking after our oral health and acting sooner when something out of the ordi-



nary is discovered," he said.
England's state-funded health
service said its partnership with
Asda aims to raise awareness
of symptoms that could indicate
cancer such as an ulcer that
lasts for three weeks or more.

Symptoms of mouth cancer also include a white or red patch in the mouth that does not heal within three weeks, a lump or swelling in the mouth, jaw, or neck that lasts for more than three weeks, and difficulty swallowing, chewing, or moving the jaw or tongue. Numbness in the tongue or other areas of the mouth, a sensation of something being stuck in the throat, a chronic sore throat or hoarseness that persists for more than six weeks, and unexplained

loosening of teeth can also be possible signs of cancer.

"By placing health messaging on products like toothpaste tubes and mouthwash bottles that people use every day, we're encouraging people to be vigilant about potential symptoms of mouth cancer and to get checked early," said Professor Peter Johnson, National Clinical Director for Cancer at NHS England.

While symptoms are common and can also be caused by other conditions, getting them checked as soon as possible is vital. Figures from the Mouth Cancer Foundation show that it is the eighth most common type of cancer in the UK, with over 11,700 new cases diag-

nosed annually. The disease is twice as common in men as in women, and nearly eight in 10 cases (78 per cent) occur in individuals over the age of 55.

"Asda sells over 2 million of these everyday items each year, so making this small change to our packaging means we can make a big difference in encouraging shoppers to be more aware and to highlight what they should do if they find any new or unexplained changes," said Asda Vice President Sam Dickson.

The new NHS partnership was launched to mark World Head and Neck Cancer Day on July 27 and includes a drive to encourage young people to get the HPV vaccine, which can help reduce the risk of cancers caused by HPV including mouth cancer. The vaccine is offered on the NHS to all children aged 12 to 13 and is also available for free on the NHS for all girls and women under 25 and boys born after September 2006.

According to NHS England, the incidence of head and neck cancers has surged by over 60 per cent in the country in recent decades, with developed countries experiencing the largest increase in oropharynx cancer — which has one of the poorest five-year survival rates.

# Should you stretch before exercise? After? Never? Here's what to know

WASHINGTON, Jul 28 (Agencies): For many people of a certain age, high school gym class began with reaching for their toes. Then, over the years, we were told it was better to stretch after exercise.

It turns out, both those things can be true, but the differing advice has created some confusion.

Stretching can help make you more flexible, improve range of motion in your joints — and feel good. David Behm, who researches human kinetics at Memorial University of Newfoundland in St. John's, Canada, offers this advice on when to stretch and how to do it safely:

Warm up first

It's almost always good to stretch, but it's better if you warm up first, said Behm, author of "The Science and Physiology of Flexibility and Stretching". He recommends a light aerobic activity such as jogging, walk-

ing or cycling for five or 10 minutes.

Follow that with some static stretching, the traditional way of reaching and holding a position (think back to that gym class). You can then do activity-specific dynamic stretching, in which you warm up the muscles with repetitive movements like leg lifts.

Behm says one minute is "the magic number" for how long to do static stretching per muscle group without fatigue.

Expand your definition of 'stretching'

Should you always stretch before exercising? If it's traditional stretching, not necessarily. The better question, Behm says, is, "Should people increase their range of motion? Should people have better flexibility? And that is yes, because it helps prevent injuries. It helps with health. But you don't have to stretch to achieve that"

to achieve that."
Resistance training,



for instance, can be an effective form of stretching, he said. Doing a chest press increases range of motion in your deltoids and pecs, whether with barbells, dumbbells or machines, so there is no need to stretch beforehand. Just make sure to start with a small amount of weight to warm up and then add more to train. "You probably don't have to do extra stretching unless you're a gymnast, a figure skater, or even a golfer who needs a great range of motion through that swing," Behm said. Nor do you need to

stretch first if you're

going for a leisurely run.

Simply start with a slow

jog to warm up and then

increase the pace.

Don't do it if it hurts

After exercise, "lig

After exercise, "light stretching is OK, as long as you don't reach a point where you're feeling pain", Behm said. Since your muscles will be warm by that point, overdoing it makes you more likely to injure yourself.

Foam rollers can help with muscle recovery and have been shown to increases range of motion as well as stretching.

Do some static stretch-

Do some static stretching before sports

If you're playing a sport, Behm said, static stretching beforehand helps reduce muscle and tendon injury.

"If you're going to do

change of direction, agility, sprint, any of these explosive activities that involve your muscles and tendons," he said, "you're going to be stronger if you do static stretching".

People can especially get in trouble when they go back to a sport they used to play, whether it's tennis, surfing or any sort of team activity.

Also, stretch both sides equally. Lacking flexibility on one side also can lead to injury.

Sounds simple. Why all the confusion?

Different studies over the years have either encouraged or discouraged stretching before exercise. Behm says that partly because some studies didn't reflect real-life conditions, or were designed with elite athletes in

mind, not regular people.

"If you're Usain Bolt, it makes a difference," said Behm. Not so much for the rest of us.

# Twice-a-year anti-HIV injection shows 100 per cent efficacy, reveals study

NEW DELHI, Jul 28 (Agencies): An HIV-preventive drug showed 100 per cent efficacy and "no safety concerns" in women, according to a study published in The New England Journal of Medicine.

Lenacapavir, injectable twice a year, is developed by the US-based biopharmaceutical company Gilead Sciences, Inc. as a pre-exposure prophylaxis (PrEP) drug. These drugs prevent the spread of infection in people not yet exposed to the disease-causing agent.

The study, a phase-3 trial involving teenage girls and young women in South Africa and Uganda, showed that lenacapavir "demonstrated zero (HIV) infections" and "100 per cent efficacy," Gilead Sciences, Inc. said in a statement

HIV, or human immunodeficiency virus, spreads from the body fluids of an infected person. Untreated, the infection can progress to AIDS or acquired immunodeficiency syndrome over years.

In the PURPOSE 1 trial, 5,338 participants, who were HIV-negative, to begin with, were divided into three groups -2,134 receiving lenacapavir injections 26 weeks apart; 2,136 receiving the daily oral tablet Descovy (F/TAF); and 1,068 receiving the daily oral tablet Truvada (F/TDF).

Researchers, including those from the Desmond Tutu HIV Centre, University of Cape Town, South Africa, observed a total of 55 infections - zero in the Lenacapavir group, 39 in the Desovy group and 16 in the Truvada group.

"No participants receiving twice-yearly lenacapavir acquired HIV infection," the study authors wrote.

The most common adverse effects were injection-site reactions experienced by close to 70 per cent of the participants in the Lenacapavir group. However, there were "no serious injection-site reactions," according to the statement.

"These stellar results show that twice-yearly lenacapavir for PrEP, if approved, could offer a highly effective, tolerable and discreet choice that could potentially improve PrEP uptake and persistence, helping us to reduce HIV in cisgender women globally," first author Linda-Gail Bekker, Director of the Desmond Tutu HIV Center at the University of Cape Town, South Africa,

said in the statement.

Results of PURPOSE 2 trial, involving cisgender men, transgender men, transgender men, transgender women and gender nonbinary individuals in countries, including Latin American ones, South Africa and Thailand, are expected in late 2024 or early 2025, the statement said.

PALLEKELE, Jul 28 (Agencies): India T201 captain Suryakumar Yadav etched his name in the record books by matching stalwart batter Virat Kohli's record of most Player of the Match awards in the shortest format of cricket.

Gautam Gambhir and Suryakumar's era in T20I cricket began on a winning note as India clinched a 43-run win in the series opener.

The weight of the captaincy wasn't enough for Suryakumar to change his dynamic style of

With his usual swagger and out-of-the-box shot selection, the Indian skipper played a captain's knock and garnered 58 runs off 26 balls at a whopping strike rate of 223.08.

After India went one up in the series, the 33-year-old batter was adjudged Player of the Match for the 16th time in T20I format in 69 matches.

He equalled Kohli's haul, who also bagged 16 POTM awards



in 125 matches in his illustrious career. Suryakumar will look to go past him in the upcoming two games against Sri Lanka.

Zimbabwe's seasoned allrounder and T20I captain Sikandar Raza is in the third spot with 15 POTM awards to his name in 91 matches in the format

Kohli announced his retire-

ment from the format after playing a match-winning knock for the Rohit Sharma-led side in the final of the T20 World Cup in Barbados against South Africa.

He racked up 76 off 59 deliveries, which played a crucial role in propelling India's score to a competitive total of 176/7.

India went on to end their 13-year-long ICC World Cup trophy drought by lifting the T20 title for the second time since the beginning of the tournament. For his valiant knock against the fierce Proteas bowling set-up, Kohli was crowned the POTM in his final T20I game.

Kohli, along with Rohit Sharma and Ravindra Jadeja, announced their decision to retire from the shortest format of cricket.

In the absence of the stalwart trio, youngsters starred for India by putting up a 213/7 against Sri Lanka. However, while defending their total, India got off to a jittery start with Pathum Nissanka and Kusal Mendis going berserk in the powerplay.

After Arshdeep Singh managed to get the breakthrough, Sri Lanka batters started to lose the plot and tumbled like a house of cards.

After taking a 1-0 lead in the series, India will play the second T20I against the hosts on Sunday.

PARIS, Jul 28 (Agencies): Indian boxer Preeti Pawar picked up an unanimous decision win against Vietnam's Vo Thi Kim Anh to enter the women's 54kg category pre-quarterfinals at the Paris Olympics.

The Asian Games bronze medallist, competing in her maiden Olympic Games, opened the proceedings for India in the boxing arena as she won her first round by a 5-0 margin on Saturday

The 20-year-old from Haryana, who had been hospitalised for a few days ahead of the Games due to illness, was unimpressive in the first round as her Vietnamese opponent dictated the proceedings.

But the Indian made amends in the next two rounds, attacking and landing clear blows on her opponent.

"Happy that we started on a winning note! Despite falling ill before the Games, Preeti not only recovered but fought brilliantly and showed exceptional courage," Boxing Federation of India President Ajay Singh said.

Preeti will face second seed and world championships silver-medallist Marcela Yeni Arias of Colombia in the round of 16 clash on Tuesday.

On Sunday, two-time world champion Nikhat Zareen will open her campaign against Germany's Maxi Karina Kloetzer in the 50 kg round of 32.

Pathum Nissanka and Kusal Mendis gave the Lankans a fine start, scoring 84 runs for the first wicket before their chase started to fall apart. Riyan Parag, in just 1.2 overs, bagged the important wickets of Kmindu Mendis, Maheesh Theekshana and Dilshan Madushanka as India bowled out the hosts for just 170 runs, winning the match by 43 runs. After the dame. Parag revealed head coach Gautam Gambhir prepared him for different

situations in the match. In a video shared by the BCCI, Parag featured with skipper Suryakumar Yadav and all-rounder Axar Patel. It was in the video that Parag revealed the chat he had with Gambhir about his bowling, especially in certain zones of the game.

"I love bowling. I bowl as much as I can behind the scenes. At the nets,



there was a lot of communication regarding where to bowl and how to bowl. There were preparations for such situations with Gautam sir. Suryakumar also hailed Riyan's efforts with the ball, saying that the Rajasthan Royals star has an X-factor.

"This could be a Riyan Parag special only as I have seen him bowling earlier as well during the IPL, at the nets. During the press conference as well, I said that Riyan Parag has an 'X' factor," Suryakumar said in the video.

"If batters continue to bat like that and the bowlers will continue helping like that on the ground, then my job will get easier. What the situation was, I set the tempo of the game with my batting. We have so much depth in batting, they have so much skill that if our skill doesn't

take care of things." Suryakumar also lauded the batting unit, keeping his fingers crossed about such performances to continue.

"Not a captain, I want to be a leader. It is good to see so much support in this country as well. Sri Lanka is just twoand-a-half hours away only, feels like we are playing in India only. I hope we keep getting the support like this, and the rest we will take care," he added.

PARIS, Jul 28 (Agencies): Shooters lose by fine margins. Technique and mental conditioning are the other weapons in the armoury that usually separate them from the rest. In a competition like the Olympics, there is a third invisible force, just like quantum, called luck. More so in shooting.

The bullet can spray by tenth of a millimetre off the centre but would be enough to slip out of race. For some reason, this luck has been eluding Indian shooters at the Olympics. The day started with despair when the mixed team failed to qualify for the final and continued when the men faltered in the 10m air pistol individual round.

Manu Bhaker saved the day. The immaculate form she is in raises hope for India in the 10m air pistol final on Sunday. Bhaker confessed that she has started to enjoy shooting and it was reflected in her scores. She had the maximum 10s. One hand tucked in the pocket, she was firing with confidence.

Bhaker, who shot 580 to finish third in the qualifications, was the only bright spot on a gloomy day. While conversing with The New Indian Express after the trials in Bhopal, she had said that she had found joy in shooting. "Whether I win or lose, I don't take pressure anymore," she said and her coming together with Jaspal Rana was the pivotal point in her Bhaker

The Austerlitz area, where the parade for the opening ceremony began, was unusually quiet in the wee hours of Saturday. Arjun Babuta and Ramita Jindal and Sandeep Singh and Elavenil Valarivan were touted among India's medal hopes but by the time the qualification round ended, there was a sense of despair in the India camp. The best pair Babuta and Pramita finished sixth after reaching fifth before the penultimate series.

Pressure of the Olympics is different. Babuta, Ramita, Elavenil and Sandeep too learnt it. So did men's 10m air pistol shooters Sarabjot Singh and Arjun Singh Cheema. Sarab-

jot slipped out of the qualification bracket for missing out on a point in the inner 10. China's Huang Yuting and Sheng Lihao, the reigning world champions finished on top with a score of 632.2 while South Korea's Keum Jihyeon and Hajun Park tallied 631.4. Kazakhstan's Alexandra Le and Islam Satpayev (630.8) finished ahead of Germany's Anna Janssen and Maximilian Ulbrich (629.7).

We tried our best but were unfortunate to not qualify," said Babuta. Others echoed him.

With the individual rounds just about a day later, the shooters are trying to keep the setback behind and move on. Failing in the first competition of course doesn't give the necessary boost to excel and Babuta knows about this. He was quick to respond. "We have trained for all scenarios," he said.
