NEW DELHI, Aug 4 (Agencies): An amount of Rs 1 crore and "incriminating" documents were seized following raids against operators of a "fake" cryptocurrency investment company that cheated people in Ladakh and some other places, the Enforcement Directorate said Sunday. The searches were undertaken on August 2 in Leh, Jammu and Sonipat in Haryana under the provisions of the Prevention of Money Laundering Act (PMLA).

Officials had said this

was the first time that the



federal anti-money laundering agency carried out searches in Ladakh. The probe pertains to cheating of innocent people, including people of Leh, by assuring them of doubling their investment in a short period of 10 months through investment in fake cryptocurrency named Emollient Coin, the agency said in a statement. This "fake" cryptocurrency, as per the ED,

was represented and promoted by Naresh Gulia of Sonipat through a company named **Emollient Coin Limited** that was incorporated in September, 2017 in the United Kingdom. The business was pro-

moted at Leh by Ajay Kumar Chaudhary and Charanieet Singh alias Chunni of Jammu and Attiul Rehman Mir of Leh and investors were assured that their investment will be doubled in 10 months and they will get a fixed percentage commission through

JKTJAC holds monthly meeting, demands resolution of issues of Teaching Fraternity

JAMMU, Aug 4: A monthly meeting of Jammu Kashmir Teachers' Joint Action Committee (JKTJAC) held at Udhampur under the leadership of UT President Vinod Sharma and District President Udhampur Lekh Raj Parihar today on 04.08.2024.The meeting was attended by the JKTJAC representatives of JKTJAC from all the eleven zones of the district. While speaking on the occasion Mr. Vinod Sharma raised the resolution of various genuine and burning issues of the teaching fraternity and appealed the LG administration to resolve them for the welfare of thousands of teachers of the UT. Raising the issue of comprehensive transfer policy in favour of teachers appointed under ReT scheme he said that these teachers have been working in the same schools for last more than two decades and suffering badly including females due to non availability of transfer policy.

He appealed worthy Principal Secretary School Education for consideration of the genuine demand of transfer policy for the welfare of thousands of these teachers and include them in ATD. He also demanded conversion of headteachers posts into non plan posts of masters so that many headless middle schools get justice. While speaking he also

appealed the Director School Education Jammu to issue regularisation orders of ReTs who have completed 5 years ReT period as they are waiting for their regularisation for a long time and conversion of left out RRETs to Teachers Grade II/III who weren't included in the recent list. Regarding rationalisation of teaching staff Mr Sharma appealed Director School Education Jammu, Chief Education Officers, Cluster heads and ZEOs to strengthen the primary and Middle schools by providing adequate staff so that basic education of the students isn't compromised.

He said that every Primary teacher be provided two teachers and every Middle school be provided at least five teachers and each pay centre Middle school be provided at least six teachers. Other demands highlighted on the occasion included:- Raising Grade

of teachers at par with their counter parts in other UTs; Filling up of vacant posts ZEOs/ Principals/ Headmasters as many zones/schools are headless, Issuance of 2nd DPC list of teachers to master.

Speaking on the occasion Mr Lekh Raj Parihar demanded the earned leave in favour of teachers/masters who were engaged for summer/ winter camps and for other duties during summer/ winter vacation.He also demanded release of more than two years arrears (time barred) of teachers and masters as they are suffering badly and updating of service records of teachers in the zones of District Udhampur as teachers are facing lots of problems for getting them completed.



Burglars steal copper core coils from 250 kv transformer in Rafiabad

BARAMULLA, Aug 4 (Agencies): In a shocking incident, burglars in Jehama village of Rafiabad in north Kashmir's Baramulla district have stolen the copper core coils from a 250kv transformer, affecting the electricity supply in the area.

The news agency has learnt from the residents. who discovered the theft early in the morning, prompting them to report the incident to the authorities.

The bizarre incident has disrupted the electricity supply.

The incident occurred during night hours. The body of the transformer was left, while the copper core coils were meticulously extracted after cutting both power supply lines, they said.

The authorities have taken cognizance of the incident and initiated an investigation to arrest the culprits besides efforts are being made to restore the power supply in the area.

"This is an unprecedented and bizarre incident, it has never happened before. We are left in darkness, causing distress in the village" Sofi Ghulam Mohammed, a local resident said. "I haven't witnessed

BJP vs AAP tug-of-war killed students in Delhi

he death of three young IAS aspirants on July 27 due to drowning in the flooded basement of a coaching institute in Delhi is heart rendering. The basement was being used for purposes other than for what it was sanctioned for. It had, contrary to existing building laws, no provision to drain out water. The road outside lacked adequate drainage infrastructure. This was known to all the authorities concerned. Yet nothing was done, to prevent the tragedy waiting to happen. Yogi, Shivpal exchange jibes Advertisement Ever since, politicians have been indulging in the usual blame-game: the BJP blames the Aam Aadmi Party (AAP), and vice versa. This tragedy has become a football being kicked around all over the media and political landscape. Finger pointing comes easily to our political class, but no one wants to seriously – and collectively - resolve the systemic reasons underlying such tragedies. The fundamental problem is that nobody knows anymore who is running Delhi, and no one, therefore, can be held accountable for this disaster. Also Read - Shashi Warrier | How to make the most of rainy days The principle of federalism, as outlined in our Constitution, is to demarcate clear-cut lines on the responsibilities between the central government and the states. Within this framework, Centre-state relations are supposed to function on the basis of constructive cooperation, irrespective of where which political party is. However,

this is hardly the case today in our cut-throat and myopic politics. States where Opposition governments are in power complain about owed funds not being transferred by the Central government, and about governors who act like agents of the Central ruling party, sitting on legitimately passed bills by the state legislature for months and years. So much for the much-touted phrase "cooperative federalism". Also Read - Patralekha Chatterjee | Lessons from rain tragedy: Can we make cities safer? The case of Delhi, a Union Territory, is however sui generic, an example of the worst form of federal immaturity. The elected government, which is AAP, has no powers over the bureaucrats under it, because an unelected lieutenant governor (L-G), a nominee of the Central government, controls them. Administratively, this is obviously an unworkable situation. The people of Delhi elected the AAP, but neither chief minister (CM) Arvind Kejriwal, nor his cabinet ministers, have any control on the postings and performance of the bureaucrats working under them. True, as the national capital, Delhi is not a full state. But, even under this arrangement, the L-G had control of only three specific powers: Land, public order, and police. But in May 2015, a brazen usurpation was made, when by an executive order of the Union home ministry, control over officers was also taken away from the elected government and given to the L-G. Also Read - Farrukh Dhondy | Britain's NHS, the nation's pride, may be broken, but it's kind and caring... Understandably, the AAP government challenged this order in court. Eight year later, on May 11, 2023, a fivejudge Constitutional bench of

the Supreme Court (SC), in a landmark judgement, restored the department of services to the elected Delhi government. The SC based its verdict on the principles of federalism, whereby elected state governments must be able to exercise legitimate powers through a bureaucracy that is answerable to them. However, the BJP-led Central government decided to issue an ordinance to overrule the reasoned judgement of the SC's Constitutional Bench, and gave the control of Delhi government bureaucrats back to the L-G. I have been a bureaucrat myself, and know their psyche. If the chief secretary and senior officers of the Delhi government are not accountable to the elected government, and nor does their performance appraisal lie with it, why would they obey the elected government's orders? There is a video in circulation that shows a AAP minister literally pleading with a senior bureaucrat to come with him for a joint inspection, and the officer curtly saying that he will do so only if he has the time! The three youngsters, gasping for breath, would not have perhaps known that this complete and deliberate confusion on clear-cut executive accountability was the reason for their death. The L-G reports to the Union home minister, who is from the ruling BJP; the bureaucrats who run Delhi are controlled by the L-G; the people elected the Opposition AAP government in Delhi; but the government has highly truncated powers to fulfil their expectations. In the midst of all this, there are other multiple authorities like the Municipal Corporation of Delhi (MCD), first trifurcated in 2012, then reunited in 2022. In the MCD elections last year, AAP won, but for the 15 years before it

was led by the BJP. There is also the Delhi Development Authority (DDA), which reports to the Union government, and is chaired by the L-G. It is this administrative nightmare, riddled with rampant and verifiable corruption, that ultimately killed the three youngsters. To most objective observers, it appears that in the backdrop of the bitter political rivalry and animosity between the AAP and the BJP, the L-G is hardly playing a neutral and supportive role. In the past, this was not the case, at least not so overtly. Sheila Dikshit was the Congress CM of Delhi for 15 years starting 1998, serving under L-Gs appointed by the rival BJP-led Central government, but there was never such a situation of complete acrimony and lack of trust between the two. Perhaps, Arvind Kejriwal, and the AAP as a whole, lack her political finesse and ability to get along with the L-G, but the AAP does face an entirely different and far more difficult obstacle - which she did not - of not having control over the bureaucracy. I hold no brief for any party, but I do wonder if political differences can become so vicious as to imperil the lives of citizens? Do our politicians really no longer care about the consequences of their partisan actions? The AAP government may be guilty of administrative lapses, but is the BJP entirely innocent in its approach to AAP as the elected government? Was using an ordinance to overturn the verdict of a Constitutional Bench of the SC the correct decision? If so, to what purpose? Can a "doubleengine" sarkar work when the track lines are all entangled? Must the L-G and the CM have an adversarial relationship? Do lives not matter at the altar of who wins the next election?

Learning is a complex phenomenon with multiple layers

t needs judgement, sensitivity, foresight and a strong will to absorb new ideas

The real world can be tricky to negotiate. This is because a lot of early childhood learning needs substantive modification when it comes to real life. Illustratively, a child is taught many principles which are simply impracticable as he grows up. Typically, a child will be told never to do something without informing their parents, whereas in real life this is neither feasible nor practicable.

The truth is, that childhood learning is about basics; one learns to modify or calibrate it as one goes along. It has to do with a child's mind and establishing certain principles that life experiences may define or modify. Consider the case of teaching a child about parallel lines. The child is taught that parallel lines are lines that never meet. That's good enough for his purposes. As one matures and gains a few years, the child transitioning into adulthood learns that parallel lines do meet, but they meet at 'infinity'. Similar examples can be cited elsewhere. However, more to the point is a simple proposition, namely that learning has to do with the capacity and capability of the learner.

The same principle can undergo several modifications or even alterations. As one emerges into adulthood, one learns many

other intricacies about life, and several of them can only be re-learned only through experience. Here is the need to sharpen a person's capacity for continuous learning and absorption. Typically, the adult, as he goes through life, meets different types of people, and there is a clear need to coexist with several others. One's judgment becomes a crucible for deciding what the truth is and where one has to steer clear or walk through it.

This is what adult learning is about, and it is a lifelong necessity that is felt at each stage. Sometimes strange situations can occur, especially if one learns through aphorisms/proverbs/ folk sayings, and even the wisdom of elders.

An illustration of this could make the point clear. In Sanskrit, there is a saying "Satyam brooyat, priyam brooyat, na brooyat satyama priyam". "Broadly translated, it means, speak the truth, but speak it pleasantly. If a truth is bitter, it need not be spoken". Whether this is desirable or not is a moot point. What is more, is that other sayings can be found to be very different than the one quoted above. For example, there is another Sanskrit statement "Satyameva jayate" "A free translation into English would be that "truth alone triumphs". The two statements are clearly in two different contexts and mean two different things.

There is an element of contradiction between the two. It is here that adult learning acquires a special veneer of its own. What that special something is a matter of experience and exposure. Some people who repeatedly emphasised in their childhood that they must always tell the truth get so much in the habit of only telling the truth that they become offensive in conversations.

This is not because of their ill intention, but their style itself became 'offensive'. Such offensive behaviour can have a heavy price. After all, tact is something that is not an optional extra, it is essential to life.Being tactful does not end up lying or being untruthful. It only trains a person to be sensitive to another person's feelings and sentiments.

It also raises the importance of recognizing that all inputs contribute to better and improved behaviour. Creating a situation in which everyone gains and a better environment is established is essential. If bluntness causes hurt rather than improvement, it could lead to deterioration of quality of life, which cannot be the objective of any action.

The obvious conclusion is that learning is a complex phenomenon with multiple layers. It needs judgement sensitivity, and foresight. In the absence of any of the above relationships, they can become compromised.

After all, if the relationship itself is lost, one might ask: what is the input about?

This issue is fundamental to the act of living. This is so because man is a gregarious animal, and the act of living requires a collective experience. Learning therefore is a lifelong exercise requiring continuous involvement and the capability to evolve. External inputs to learning are of course critical, but internalization of the same is the core. Unfortunately, whereas much attention has been paid to teaching, an equal amount of attention is due to the ways of the learning process. There are indeed definite limits to the capacity to learn and methods of learning.

This is something that needs to be more widely recognized than before, especially since it does not seem to be integrated into the larger theories of learning. Indeed, one needs to pay attention to also when and how a revision of the learning process becomes seminal.

To sum up, it is important to recognize the continuous nature of learning and one's central role in keeping that learning alive. A teacher can only help the process but cannot substitute a learner's learning.


Alia Bhatt not just an 'astounding actor' but also 'great mother', says dad Mahesh; wants Raha to watch THIS film when she's 'sweet 16'

While recently speaking to agency, the Sadak director hailed Alia Bhatt as a mother and revealed which movie Raha should watch first.




Ranvir added, "My career is in acting, films, and series. I would like to go back to that now."



206 people still missing in Wayanad; rescuers to be deployed in spots where chances of recovery of bodies high, says minister

WAYANAD, Aug 4 (Agencies): Rescue operations will continue in the landslides-hit areas in this north Kerala district on the sixth day with more force and equipment being deployed in spots where chances of recovering bodies were high, state Tourism Minister PA Mohamed Riyas said on Sunday.

Riyas said search operations will continue in the 40-kilometre stretch of the Chaliyar river, which flows through Wayanad, Malappuram and Kozhikode districts, as many bodies and remains were recovered from it near Nilambur in Malappuram. In Mundakkai and Chooralmala areas, devastated by the landslides, that were segregated into six search zones, the operations will continue in the same way as in the last few days with more force and equipment being allocated to spots where chances of finding remains under the debris were high, the minister told a TV channel.

Regarding the rehabilitation of



the survivors, Rivas said discussions need to be held with everyone, especially to the views of those living in the relief hospitals," he said.

But the discussion will not be held now, it will take place once the survivors are in a state of mind to talk about it, he added. The minister said immediate interventions will be carried out to help those who have lost identification and other important records.

Steps will also be taken to ensure that the education of children in the landslides-hit areas is not hampered in any manner, Riyas said.

According to the district administration, till Saturday night, 219 bodies and over 143 body parts were recovered with 206 persons missing.

Advanced radars, drones and heavy machinery were used by rescue teams on Saturday, the fifth day of the tragic landslides that killed hundreds in Wayanad district, to locate survivors or deceased.

The state government had also announced plans to establish a new township to rehabilitate displaced victims.

Temple wall collapses in Madhya Pradesh's Sagar, 9 children feared dead

BHOPAL, Aug 4 (Agencies): Nine children were feared dead and several were injured after a temple wall collapsed amid heavy rainfall in Shahpur in Madhya Pradesh's Sagar district on Sunday.

The wall of the Hardayal temple was 50 years old. At the time of the incident, earthen shivlings were being made in the Hardayal temple as part of the Sawan festivities.

The rituals were underway when the wall of the temple premises collapsed.

Visuals from the site showed a



bulldozer involved in the operation to find survivors. Further details were awaited.

The incident came a day after four children were killed after a wall of an abandoned building collapsed on them while they were returning home from school in Madhya Pradesh's Rewa district, officials said. Chief Minister Mohan Yadav expressed grief over the incident and announced financial assistance of Rs 2 lakh each to families of the victims.

Police on Saturday arrested two owners of a building in Rewa following the wall collapse incident and registered a case against them under relevant sections of the Bharatiya Nyaya Sanhita (BNS).

National Archives of India to utilise AI for enhanced user experience

NEW DELHI, Aug 4 (Agencies): In a bid to enhance user experience and optimize search tools, the National Archives of India (NAI)-the repository of non-current Government records-may employ Artificial Intelligence (AI) and other cutting-edge technologies to upgrade its portal. Currently, approximately 5.92 crore digitized archival materials are available on the centralized server, accessible free of cost to scholars and history enthusiasts at www.abhilekh-patal.in.

The Archives have also embarked on a fresh round of restoration and conservation efforts to preserve 30 crore pages of rare historical records, including photographs, handwritten documents, maps, and treaties. Many of these documents are fragile, exhibiting stains, worm marks, and translucency due to aging. The conservation and digitization processes are expected to be completed by 2026.

Simultaneously with the ongoing phase of digitization, the NAI will explore the use of Al and other tools to enhance the search and viewing experience for future versions of its website. The current portal has had over 1.87 million unique visitors and approximately 28,000 registered users. In the first phase, the NAI completed the digitization of 4.5 crore pages of its records over a span of three years. The second phase, focusing on restoration and conservation, will cover records at the NAI's head office and Lahore Shed in Jaisalmer House, Delhi, as well as

regional offices in Bhopal and record centers in Jaipur, Bhubaneswar, and Puducherry. Established as the Imperial Record Department in 1891 in Kolkata, the then capital of British India, the NAI holds a vast collection of historical records. These include court orders and treaties signed by Mughal emperors and the British Empire, as well as private papers of eminent individuals who have significantly contributed to public life in India, such as Mahatma Gandhi, India's first president Rajendra Prasad, Dadabhai Naoroji, Maulana Abul Kalam Azad, and Sardar Patel. As one of the largest and most prestigious archival centers in the world, the NAI boasts records comprising 800 million pages, 5.7

million files, and 1.2 lakh maps.

Iran says short-range projectile killed Hamas' Haniyeh, reiterates vows of retaliation

TEHRAN, Aug 4 (Agencies): Iran's Revolutionary Guard said a short-range projectile was behind the killing of Hamas political chief Ismail Haniyeh and accused the United States of supporting the attack which it blamed on Israel, state TV reported.

The televised statement, which reiterated a call for retaliation. said a rocket with a seven-kg warhead was used to target the residence of Hamas' political leader in the capital Tehran on Wednesday, adding it caused heavy devastation. It didn't share details of the residence's location.

Haniyeh was in Iran to attend the inauguration of newly elected Iranian President Masoud Pezeshkian.

"The action was designed and carried out by the Zionist



regime and supported by the US," said the Guard's statement. It added that "the warmongering and terrorist Zionist regime will receive harsh punishment in the suitable time, place, and capacity."

Israel has not confirmed or denied its role in the killing of Haniyeh, but Israel earlier pledged to kill him and other Hamas leaders over the group's October 7 attack on southern Israel that sparked the war in Gaza.

The assassination has sparked fears of a wider regional conflict and of a direct confrontation between Israel and Iran if Tehran retaliates.

In April, Iran launched hundreds of missiles and drones at Israel, which said it intercepted 99 per cent.

The barrage came less than two weeks after a suspected Israeli strike in Syria killed two Iranian generals, and it marked the first time Iran had launched a direct military assault on Israel despite decades of enmity dating back to the country's 1979 Islamic Revolution.

Iran does not recognise Israel and supports anti-Israeli militant groups including Hamas and Lebanon's Hezbollah.

Suspected missile attack by Yemen's Houthi rebels hits container ship

DUBAI, Aug 4 (Agencies): A suspected missile attack by Yemen's Houthi rebels struck a container ship traveling through the Gulf of Aden. authorities said Sunday, likely the first assault by the group since Israeli airstrikes targeted them.

The Houthis have offered no explanation for the two-week pause in their attacks on shipping through the Red Sea corridor, which have seen similar slowdowns since the assaults began in November over Israel's war on Hamas in the Gaza Strip.

But the resumption comes after the assassination of Hamas leader Ismail Haniyeh in Iran, the Houthis' main benefactor, amid renewed concerns over the war breaking out into a regional conflict. The attack on Saturday happened some

Aug 4 (Agencies): JD Vance, Donald Trump's Vice President pick, recently revealed that he asked his son to "shut the hell up" about Pokemon Pikachu amid a phone call with the former President and moments before the **Republican** National Convention. The Ohio senator explained the circumstances on the Full Send podcast.

The politician was speaking to YouTube comedians the NELK Boys and said the incident occurred when Mr Trump called and asked him to be his running mate. Notably, the former president officially named the senator as his running mate during the Republican National Convention in Milwaukee last month.

Mr Vance was flying with his family to Milwaukee for the RNC when he realised that the airplane had no Wi-fi. He landed after an hour and had over a hundred messages. He said that he got one message from the Trump campaign which said, "Hey, you just missed a really important call." He then called Mr Trump and said, "Hey Sir, what's going on?" The 45th US Presi-



dent told him, "J.D., you missed a really important phone call, and now I'm going to have to go with someone else." Mr Vance continued, "My son, who is seven, is in the hotel room with me. And he is really into Pokemon cards right now. He's going through a Pokemon phase...he's really into it. So he's trying to talk to me about Pikachu and I'm on the phone with Donald Trump and I'm like, 'Son, shut the hell up for 30 seconds about Pikachu."

He added, "This is the most important phone call of my life. Please just let me take this phone call." Mr Vance said that because his son "doesn't get what the President of the United States means," he didn't care that Mr Trump was on the phone.

Lebanon marks four years since Beirut port blast as war fears loom

BEIRUT, Aug 4 (Agencies): Lebanon on Sunday marks four years since a catastrophic explosion at Beirut's port killed more than 220 people, with fears of all-out war between Israel and Hezbollah hanging heavy over the grim commemoration.

Several marches are set to converge on the port in the afternoon to remember the victims and demand justice.

Nobody has been held responsible for the August 4, 2020 disaster -- one of history's biggest non-nuclear explosions -- which also injured at least 6,500 people and devastated swathes of the capital.

Authorities said the explosion was triggered by a fire in a warehouse where a stockpile of ammonium nitrate fertiliser had been haphazardly stored for years.

An investigation has stalled, mired in legal and political wrangling.

"The complete lack of accountability for such a manmade disaster is staggering," United Nations Special Coordinator for Lebanon Jeanine Hennis-



Plasschaert said in a statement.

"One would expect the concerned authorities to work tirelessly to lift all barriers... but the opposite is happening," she said, calling for "an impartial, thorough, and transparent investigation to deliver truth, justice, and accountability".

In December 2020, lead investigator Fadi Sawan charged former prime minister Hassan Diab and three ex-ministers with negligence, but as political pressure mounted, he was removed from the case.

His successor, Tarek Bitar, unsuccessfully asked lawmak-

ers to lift parliamentary immunity for MPs who were formerly cabinet ministers.

In December 2021, Bitar suspended his probe after a barrage of lawsuits, while the powerful Hezbollah group has accused him of bias and demanded his dismissal.

But in January last year, he resumed investigations, charging eight new suspects including high-level security officials and Lebanon's top prosecutor, who in turn charged Bitar with "usurping power" and ordered the release of detainees in the case.

The process has since stalled again.

A judicial official, speaking on condition of anonymity, told agency that Bitar would "resume his proceedings, starting next week" and intends to finish "the investigation and issue his indictment decision... by the end of the year".

Bitar will set dates for questioning defendants who have not yet appeared before him, according to the official.

If the public prosecutor's office or other relevant judicial officials fail to cooperate, Bitar "will issue arrest warrants in absentia" for the defendants, the official added.

Activists have called for a UN fact-finding mission into the blast, but Lebanese officials have repeatedly rejected the demand.

Prospects of further disaster loom over this year's anniversary, with Hamas ally Hezbollah and the Israeli army trading cross-border fire since the Palestinian group's October 7 attack that triggered the Gaza war and fears that an all-out conflict could engulf Lebanon.

Two Arunachal Pradesh men missing for two years; last sighted along china border

Army authorities several times seeking information about his brothers.

"I am told that the issue was raised by the Indian Army with their Chinese counterparts. But no response has come so far." he said.

Aniaw MLA and State's Women and Child Development Minister Dasanglu Pul confirmed that the duo went missing along the border with China while looking for medicinal herbs.

and soon," he said. This is not the first time that residents of Arunachal Pradesh have gone missing along the border or been detained by China's PLA. However, in most cases, such people return home after a few days or weeks

This is for the first time that no whereabouts have been found of two missing persons for almost two years. In September 2020, the PLA allegedly abducted five youths from Arunachal Pradesh's Upper Subansiri district. The youths were released about a week later by the PLA. On January 18, 2022, a teenage boy, Miram Taron, was allegedly taken away by the Chinese forces from the Upper Siang district. Taron was handed over to the Indian side by the Chinese Army nine davs later.

The latest incident of the two missing cousins comes amid a continuing standoff between the Indian Army and the PLA in eastern Ladakh since April 2020.

India shares a 3,400 km-long Line of Actual Control (LAC) with China from Ladakh to Arunachal Pradesh. India has repeatedly rejected China's territorial claims over Arunachal Pradesh, asserting that the State is an integral part of the country.

China, which terms Arunachal Pradesh as South Tibet, routinely objects to Indian leaders' visits to the State to highlight its claims. Beijing has also named the area as Zangnan.

New Delhi has also dismissed Beijing's move to assign "invented" names to the area, saying it does not alter the reality.

MUMBAI, Aug 4 (Agencies): More than 100 countries, including India, face serious obstacles in becoming high-income countries in the next few decades, and New Delhi may take nearly 75 years just to reach one-quarter of US income per capita, a World Bank report said.

It will take China more than 10 years to reach one-quarter of US income per capita and Indonesia nearly 70 years, according to the World Development Report 2024: The Middle Income Trap.

Drawing on lessons of the past 50 years, the report finds that as countries grow wealthier, they usually hit a "trap" at about 10 per cent of annual US GDP per person - the equivalent of USD 8,000.

That's in the middle of the range of what the World Bank classifies as middle-income countries

New model boosts diagnosis accuracy for cardiac arrest treatment

NEW DELHI, Aug 4 (Agencies): Japanese researchers have developed a new model that can help predict the outcomes of patients who suffer from out-of-hospital cardiac arrest (OHCA). In cardiac arrest cases, immediate

action is crucial, as it can determine the patient's survival.

Timely intervention not only improves the chances of recovery but also minimises the risk of severe complications. Researchers from Osaka Metropolitan University developed the R-EDBy-US score, a scoring model that uses prehospital resuscitation data to predict outcomes in OHCA patients.

The R-EDByUS score comprises five variables: age, duration to return of spontaneous circulation or time to hospital arrival, absence of bystander CPR, whether the arrest was witnessed, and initial heart rhythm (shockable versus non-shockable). Cardiac arrest, which can result in death within minutes, is a critical emergency with low survival rates. Accurate early prediction models are crucial in OHCA cases, potentially saving lives and reducing unnecessary healthcare costs.

"Current prognosis prediction models require complex calculations and blood test data, making them impractical for rapid use immediately after patient transport," explained Takenobu Shimada, a medical lecturer at the University's Graduate School of Medicine.

The model demonstrated high predictive accuracy, with C-statistics values around 0.85, indicating excellent performance.

"The R-EDByUS score enables highprecision prognosis prediction immediately upon hospital arrival, and its application via smartphone or tablet makes it suitable for everyday clinical use," Shimada noted.

Neurodivergent children more likely to develop chronic fatigue as teen, study finds

NEW DELHI, Aug 4 (Agencies): Children more likely to be diagnosed with neurodivergence, such as autism or Attention Deficit Hyperactivity Disorder (ADHD), are at twice the odds of experiencing chronic disabling fatigue in late teenage, thereby "dramatically" affecting their quality of lives, a study has found. In ADHD, one has

shorter attention spans, along with displaying restlessness and impulsive behaviour.

Researchers explained that neurodivergent children often experience heightened stress levels. As a result, the increased inflammation could be contributing to



Other conditions can include the chronic pain condition, fibromyalgia, and digestive and gut issues. Fibromyalgia is marked by muscle pain throughout their body, often accompanied by fatigue and mood changes.

However, the researchers, including those at have shown that neurodivergent children experience higher levels of loneliness and are more likely to be bullied.

These children are also more vulnerable to pain, owing to differences in their pain perception when compared with the general population, along with malfunctions the British Medical Journal (BMJ) Open.

Therefore, they called for future research that could disentangle the complex mechanisms driving chronic fatigue in neurodivergent children. For the study, parents or caregivers of children aged seven or nine vears filled out questionnaires, the responses to which were used for developing an autism or hyperactivity score, respectively.

While a higher autism score indicated more chances of diagnosis, a higher hyperactivity score was indicative of greater behavioural issues, including conduct and emotional ones.

"These results show the importance of transdiagnostic screening for processes common across multiple disorders in children and the need for better support for neurodivergent children," lead researcher Lisa Quadt, a research fellow in psychiatry at BSMS, said.

This new tool is expected to be invaluable for healthcare providers, aiding in the prompt assessment and management of patients undergoing resuscitation.

Harvard study reveals which strains of tuberculosis are the most infectious

A Harvard study finds that tuberculosis infection risk is higher when the bacteria and the person share the same hometown, suggesting a link between local bacteria and human hosts.

NEW DELHI, Aug 4 (Agencies): A recent study led by Harvard Medical School scientists has found that the risk of contracting certain forms of tuberculosis (TB) depends on whether the exposed person and the TB bacteria share a common hometown.

Published in Nature Microbiology, this study compared different TB strains in mixed populations across cosmopolitan cities.

The research provides evidence that the interaction between the pathogen, place, and human host plays a role in infection risk.

It supports the idea that certain bacteria and their human hosts have evolved together over hundreds or thousands of years.

The study could influence new prevention and treatment strategies for TB, a disease that affects over 10 million people and causes more than a million deaths annually, according to the World Health Organisation (WHO).

Researchers built a unique study cohort by combining TB



case files from New York City, Amsterdam, and Hamburg. This allowed for the first controlled comparison of TB strains' infectivity in populations with mixed geographic origins.

Findings showed that close contacts of people with a geographically restricted TB strain had a 14% lower infection rate and a 45% lower rate of developing active TB compared to those exposed to a widespread strain.

Strains with narrow geographic ranges were more likely to infect people with roots in the bacteria's native region.

The study revealed that the odds of infection dropped by 38% when a person was exposed to a geographically restricted strain from a different region compared to a strain from their own region.

This applied to individuals who had lived in the region or had parents from that region.

"This large effect size indicates a significant public health impact," said Maha Farhat, Associate Professor at Harvard Medical School.

The research highlights the

importance of understanding the variations between different TB lineages and their interactions with human populations. It emphasises the need to consider genetic differences in TB strains and human hosts when developing treatments and vaccines.

In laboratory tests, human immune cells from donors matching the TB strain's native region were more susceptible to infection. This mirrors the epidemiologic study results and highlights the need for more research on the genomic differences between bacterial and host cells.

Farhat emphasised the importance of considering human and TB genetic diversity in treatment strategies.

By merging data from public health departments and using advanced computational tools, the researchers were able to analyse 5,256 TB cases and 28,889 close contacts.

This study could lead to better-targeted treatments and improved outcomes for people with TB.

Genetic, environmental factors in disease risk, new insights found



NEW DELHI, Aug 4 (Agencies): Environmental factors may play a larger role in disease risk than previously thought, overshadowing genetic contributions, a study by researchers at Penn State College of Medicine reveals.

Published in the journal Nature Communications, the research shows that lifestyle and environmental factors, such as air pollution, can significantly influence disease risk, offering more opportunities for mitigation.

For example, the genetic risk of type 2 diabetes was recalibrated from 37.7 per cent to 28.4 per cent, highlighting a greater role for environmental factors. Similarly, the genetic contribution to obesity risk decreased from 53.1 per cent to 46.3 per cent.

The study also distinguished the effects of specific pollutants, such as PM2.5 and NO2, on health conditions. NO2 was found to directly influence conditions like high cholesterol and diabetes, whereas PM2.5 impacted lung function and sleep disorders.

This research suggests that understanding the balance between genetic and environmental factors can enhance disease prevention strategies, particularly in precision medicine.
