J&K will pass resolution against ending **Article 370** after polls: **Omar Abdullah**

SRINAGAR, Aug 18 (Agencies): National Conference Vice President Omar Abdullah has called for the first order of business for the upcoming Jammu & Kashmir Legislative Assembly to be the passage of a resolution rejecting the changes imposed on August 5, 2019.

Abdullah stressed that this resolution should make it clear to both the people of India and the international community that the people of Jammu & Kashmir do not agree with the decisions made on 5 August 2019. He added that this is a crucial step before beginning to undo what was

done to the region.

In an interview with NDTV, he said "I believe the first order of business of the Legislative assembly of J&K should be to make it known (through a resolution) not just to the people of India but to the world at large that the people of J&K do not agree with what happened to us on August 5, 2019.

"And then we start undoing what was done to us," he said.

Apart from these three persons, the police have



also issued summonses to 57 others for spreading wrong information about the incident, he

These people have been accused of revealing the identity of the victim, spreading rumours and fake news. the officer said.

Doda to vote in first phase, last date for nomination filing on Aug **27**

JAMMU, Aug 18 (Agencies): Doda District Election Officer Harvinder Singh said that the code of conduct has come into force with the three constituencies of the district voting in the first phase on Septem-

ber 18. During a press conference on Saturday, Harvinder Singh said that the last date for the filing of nominations is August 27.

The Election Commission of India (ECI) announced the schedule for the election in the Union Territory of Jammu and Kashmir on August 16. The polling in the UT will be held in three phases on September 18, 25, and October 1.

Singh said that the notification of the polling will be issued on August 20 and the last date for withdrawing candidature will be on August 30.

"A model code of conduct was enforced when the date was announced. We have convened training and interactive sessions with political parties," the district election officer said.

According to the ECI, the counting of the votes will take place on October 4. The election body has directed the enforcement agencies to be impartial and transparent for smooth





Dimple leads protest against PDD, demands to cut short electricity charges

JAMMU, Aug 18: Under the leadership of President Sunil Dimple, Mission Statehood workers, along with a significant number of traders, staged a protest on Janipur High Court Road in Jammu. vehemently opposing the current operations of the Power Development Department (PDD) and the Public Health Engineering (PHE) depart-

The protesters voiced their grievances against the escalating electricity rates in Jammu and Kashmir. demanding an immediate reduction in the perunit price of electricity from Lieutenant Governor Manoj Sinha.

Sunil Dimple strongly criticized the PDD for issuing incorrect electricity bills that have burdened poor families, alleging that the privatization of the electricity department has led to a lack of account-

He highlighted the harassment faced by innocent, economically disadvantaged families, who are often subjected to disconnection of their power supply due to erro-

The protest also brought attention to the acute scarcity of drinking water in Jammu City, accusing the PHE department of failing to meet the water supply needs of the residents.

Dimple alleged that the situation is exacerbated by the PDD's imposition of long-duration power cuts during the peak of summer, which has left the public struggling in the heat without adequate water or electricity.

Additionally, Dimple criticized the defunct state of critical infrastructure, including transformers, jumpers, and street lights in various wards, particularly noting the poor condition of the Gladni Grid and Janipur infrastructures.

These issues, according to Dimple, have caused frequent electrical fluctuations, leading to damage to household electrical appliances such as fans, air conditioners, and other domestic devices.

Dimple further pointed out inefficiencies in the management of electricity billing, alleging that bills are being wrongly issued without proper SMS notifications, and that the system for uploading and tracking paid bills is flawed. This has led to residents receiving bills for amounts they have already paid, creating confusion and financial strain. In his demands. Dimple called for the return of major power projects like Salal, Uri, and Ratli to Jammu and Kashmir's control, asserting that local needs should be prioritized over supplying electricity to

other states. He also called for the government to waive electricity bills for poor families and provide 500 units of electricity per month free of charge to all residents of Jammu and Kashmir.

The protest, supported by other leaders including Biloo Pahlwan, Arun Verma, S Kala Singh, Sudershan Sharma, and Rinku Sharma, was a powerful demonstration of public dissatisfaction with the essential services in the region, highlighting the urgent need for reform and accountability in the PDD and PHE depart-

STUDENTS GUIDANCE

irst of all, the essential information or data concerning the individual, who needs personal or psychological guidance, should be collected. It may be concerned with his physical, intellectual, social and emotional development, academic or scholastic achievement; personality characteristics, interests and aptitudes, family and school background and other environmental conditions. Thus an adequate picture of the background and personality make-up of an individual should be drawn in the mind for the solution of the problems, faced by individual.

Now the problem of the individual is analysed in the relations with the collected information. The causes lying within the individual or his environment are detected. For having a correct diagnosis, a personal interview or other techniques may also be adopted and more information if needed may also be acquired.

In view of the detected possible causes the remedial measures are chalked out. The Guidance worker now thinks about the personal guidance that may be provided for the individual in gelling rid of his trouble.

By establishing proper rapport, the Guidance personnel makes the individual realize the main cause of-his difficulty or trouble sometimes, on this bases he is made to realise or even think about the possible change in his behavior or attitude. For this purpose so many valuable techniques like suggestion, initiation, sympathetic, affectionate advice, sublimation or catharsis, psychoanalysis or other psychological theory can be adopted. The sole purpose of such guidance is to help or assist the individual in getting rid of his difficulty either by modifying his behavior or bringing some changes in his environment.

After rendering personal guidance to an individual, it is essential to evaluate the progress or outcome of such guidance through personal interview, contact or any other suitable technique. It is such follow up programme that helps in knowing the strength and weakness of the administered personal guidance. It may also suggest the need of further guidance to him or any alternation in the proposed guidance.

The knowledge about the above mentioned process of personal guidance is not only needed by the guidance personnel specially appointed in the school, but the head-master and teachers also make themselves acquainted with it teachers with their unique position in the school, are able to develop close contacts with children and may be able to know the real cause of a trouble. With a little training, they learn the art of rendering personal guidance to their students.

Therefore our schools are acquired to play their due role in this direction. In every school, the head of the institution should try to organise a personal guidance programme with the active help of his staff and co-operation of the parent and state guidance services.

Guidance assists the students to understand him and it helps the student to get maximum out of the school, to become acceptable to other students, in making a careful choice of subjects and courses for himself, in developing good study habits in the student, to make a proper choice about occupation.

It provides for special provision for the education of gifted students, slow learners and handicapped students and it helps the students in developing better personal social and emotional relationships.

This was evident during the recent Budget Session of Parliament when Congress leader Sonia Gandhi and Samajwadi Party MP Jaya Bachchan were seen greeting each other which was followed by a combined protest by the two parties when there was an exchange of hot words between the celebrity film star and Rajya Sabha chairman Jagdeep Dhankhar. It was interesting to see Sonia Gandhi stand back while Jaya Bachchan held forth before the media after the Opposition walk-out. This renewed friendship has clearly baffled the Congress. The day the pictures showing Sonia and Jaya in the same frame came out, those in the party who had taken potshots at Amitabh Bachchan being ignored by Prime Minister Narendra Modi at the Ambani wedding were running for cover. Meanwhile, a discreet message has been conveyed to the Congress party's social media team to delete any such tweets against the Bachchans.

Ministers and party leaders kept a low profile, afraid to speak up or express their view publicly for fear of reprisal. But there has been a sea change after the BJP failed to get a majority on its own in the last Lok Sabha election. Party leaders are now feeling emboldened to air their grievances publicly as there is all-round acknowledgement that the BJP did not fare as well as it had hoped to do because of centralisation of power and the preference given to lateral entrants from other political parties. Dissidents in various state units are even feeling brave enough to call up media-persons to complain about the internal affairs of the party. Dr. MS Randhawa further said," UTIs are bacterial infections that can affect any part of the urinary system. Though they can occur at any age, the risk increases with age, particularly in post-menopausal women due to changes in urinary tract anatomy and hormone levels. UTIs are typically treated with antibiotics, hydration, and over-thecounter pain relief," Kidney and bladder

stones form when minerals crystallize in the urine. While they can occur at any age, the risk increases in older adults due to decreased kidney function and changes in diet and fluid intake. Prostate cancer is the second most common cancer in men, with the risk increasing with age. Early stages typically present no symp-

toms, but advar

toms, but advanced stages may cause difficulties in ger urination, blood in semen, erectile dysfunction, and discomfort in the pelvic area. Regular screening is vital as it can detect cancer early, improving treatment outcomes. Management includes watchful

waiting, radiation therapy,

hormone therapy, surgery, and chemotherapy, asserted Dr. MS Rand-

Sanjay Mishra, Director Neurology while speaking on 'Stroke: Symptoms & treatments' said that stroke is emerging as the new epidemic Worldwide with 1.5 to 2.0 million new stroke cases being reported across the Globe every year. The actual numbers are bound to be higher, as many of these patients never reach health care facilities.

"Everyday around 3000-4000 strokes happen in India and not more than 2-3% are treated. World100,000 population per year, whereas in India it is close to 145-145 cases per 100,000/year. India accounts for 60 % of all stroke patients globally. The reason for increased incidence in India is lack of awareness about the disease per se and the methods of prevention. He also shared that Stokes are responsible for more deaths annually than those attributed to AIDS, Tuberculosis and Malaria combined and yet it remains a silent epidemic,"

Stroke is of two types: ischemic and hemorrhagic. Ischemic stroke means that the blood supply to a portion of the brain is cut off due to a clot with resulting brain damage. It is similar to heart attack

where blood supply to a part of the heart is blocked and that's why it is also called brain attack. The other type is hemorrhagic in which there is bleeding in the brain, informed Dr Sanjay Mishra.

Treatment of ischemic

Ireatment of ischemic stroke is done by intravenous injection of a drug which can dissolve the clot. Although it is an excellent treatment, but it is effective only if the clot is small and if given within 4 and a half hours of the beginning of stroke. Earlier patients reaching after 4-5 hours had no definite treatment options and were managed conservatively with supportive care,

he maintained.

Meanwhile during the health check camp the free tests of PSA and uroflowmetry were also offered.

Trinamool MP summoned by cops over "sniffer dog" claim in rape-murder probe

(Agencies): The Kolkata Police today summoned Trinamool Congress MP Sukhendu Shekhar Ray for allegedly spreading misinformation about the details surrounding the brutal rape and murder of a post-graduate trainee doctor at the RG Kar Medical College and Hospital.

Mr Ray had claimed that a dog squad was sent to the crime scene three days after the body of the victim was found on August 9.

"The information that the sniffer dog was sent after three days is completely wrong. A sniffer dog was sent twice on August 9 and then on 12. A notice has been sent to Shri Sukhendu Sekhar Roy," the Kolkata Police said in a statement.

The summons follows closely on the heels of the Kolkata Police issu-

ing notices to actorturned-politician and BJP leader Locket Chatterjee and two doctors - Kunal Sarkar and Subarno Goswami over misinformation surrounding the incident.

Mr Ray, 75, barely 12

hours ago, had raised serious questions about the conduct of the investigation and expressed his dissatisfaction with the handling of the case by calling for the custodial interrogation of both the former Principal of RG Kar Medical College, Dr Sandip Ghosh, and Kolkata Police Commissioner Vineet Goyal.

"CBI must act fairly. Custodial interrogation of Ex Principal and Police Commissioner is a must to know who and why floated suicide story. Why wall of hall demolished, who patronised Roy to be so powerful, Why sniffer dog used after 3 days.



100s of such questions. Make them speak," Mr Ray posted.

The call for Commissioner Goyal's interrogation has, however, not been universally accepted within the party. Kunal Ghosh, another prominent Trinamool leader, strongly opposed the demand.

"I also demand justice in the RG Kar case but strongly oppose this demand regarding CP. After getting the information, he has tried his

best. Personally, CP was doing his job, and the investigation was in a positive focus. This kind of post is unfortunate. that too from my senior leader," Mr Ghosh said.

Mr Ray was one of the first TMC leaders to announce his participation in the nationwide midnight protest over the rape and murder. He made the announcement on X, expressing solidarity with the pro-

to join the protesters, particularly because I have a daughter and little granddaughter like millions of Bengali families. We must rise to the occasion. Enough of cruelty against women. Let's resist together. Come what may," Mr Ray posted.

Mr Ray's stance, however, led to speculation about his position within the party. When questioned by a user on X about the potential consequences of his actions, including the possibility of being expelled from the Trinamool Congress, Mr Ray responded: "Please need not worry for my fate. Blood of a freedom fighter flows in my veins. I'm least bothered."

Harbhajan Singh's open letter to Bengal government over rape-murder probe

NEW DELHI, Aug 18 (Agencies): Former Indian cricketer and Aam Aadmi Party (AAP) MP Harbhajan Singh today wrote an open letter to West Bengal Governor CV Ananda Bose and Chief Minister Mamata Banerjee, expressing his "deep anguish" over the delay in justice for the Kolkata rape and murder victim.

The letter came a week after a 31-yearold trainee doctor was raped and murdered at the seminar hall of the government-run RG Kar Medical College and Hospital in Kolkata.

The August 9 incident has sparked widespread outrage and protests across the country.

Mr Singh said the letter, which was also addressed to the citizens of India, was a call for "justice and introspection".

"This unspeakable act of violence, which shook the conscience of all of us, is not just a heinous crime against one individual but a grave assault on the dignity and safety of every woman in our society. It is a reflection of the deeply rooted issues within our society and a blatant reminder of the urgent need for systemic change and action by



the authorities," he said in the two-page letter, which was also shared on his official X (formerly Twitter) account.

"The fact that such an atrocity could occur within the premises of a medical institution, a place dedicated to healing and saving lives, is both shocking and unacceptable," Mr Singh said.

He said that more than a week has lapsed and we are yet to see any "concrete action", adding that it has led the doctors and the medical community to protest on roads.

"Their (doctors) protests are understood and I wholeheartedly support the medical community in their fight for their cause of jus-

tice," he said. "The medical community is already working in challenging conditions.

With such incidents, how can we expect them to perform their duties with dedication when their own safety is so gravely compromised?," the Rajya Sabha MP asked.

He urged the West Bengal government and the investigating agency, CBI, to take immediate and decisive action to ensure that the perpetrators of this "vile act" are brought to justice swiftly.

Mr Singh also said that such incidents are reported from different parts of the country and "have become regular columns" on newspapers and TV programmes.

"The governments must implement comprehensive measures to prevent such occurrences in the future," he

"There is only one suspect. The man who gave her a lift is suspected to be the rapist and our investigations are on,"

According to Mr Gupta, he and other police officers visited the spot and spoke to the victim and her relatives.

Usually, such posts are manned by the officers of all-India servicesthe Indian Administrative Service (IAS), Indian Police Service (IPS), and Indian Forest Service (IFoS)—and Group A services, among others.

"Reservation of SC, ST, and OBC classes is being openly snatched away by recruiting through lateral entry on important posts in various ministries of the central government," Gandhi said in a post in Hindi on X.

"I have always said



that the underprivileged are not represented in all the country's top posts, including the top bureaucracy. Instead of improving it, they are being pushed further away from the top posts through lateral entry," he

said. "This is a robbery of the rights of talented youth preparing for UPSC and an attack on the concept of social justice, including reservation for the underprivileged," he alleged

The SEBI is a vivid example of what representatives of a few corporates will do by sitting on decisive government posts, where for the first time a person from the private sector was made the chairperson, Gandhi said in an apparent reference to the conflicts of interest allegations

against SEBI chairperson Madhabi Buch.

The INDIA bloc will strongly oppose this "anti-national step" that hurts both the administrative structure and social justice, Gandhi said.

"Privatisation of the IAS is Modi's guarantee for ending reservation," he said.

The Union Public Service Commission (UPSC) on Saturday advertised 45 posts-10 joint secretaries and 35 directors pr deputy secretaries—to be filled through the lateral entry mode on a contract basis

It is the biggest tranche of lateral recruitment being undertaken by the Centre, an official said.

Paetongtarn Shinawatra becomes Thai prime minister after royal signoff

Paetongtarn Shinawatra, the third Shinawatra to hold the job, after her billionaire father and her aunt Yingluck Shinawatra, became Thailand's prime minister after receiving a royal letter of endorsement.

BANGKOK, Aug 18 (Agencies): Paetongtarn Shinawatra, daughter of the divisive former leader Thaksin Shinawatra, became Thailand's prime minister after receiving a royal letter of endorsement Sunday, two days after she was chosen by Parliament following a court order that removed her predecessor.

She replaces another leader from the same Pheu Thai Party, at the head of a coalition that includes military parties associated with the coup that deposed the party's last government.

Paetongtarn is the third Shinawatra to hold the job, after her billionaire father and her aunt Yingluck Shinawatra. Both were removed from office and forced into exile in coups, although Thaksin returned to Thailand last year as Pheu Thai formed a government.

She received the letter of appointment in a ceremony at the party's headquarters in Bangkok, attended by senior members of parties in the governing coalition and her father, who has no formal role but is widely seen de facto leader of Pheu Thai.

The father and daughter held hands as they walked in with beaming smiles. Both wore white civil servants' uniforms, which are used for royal and state ceremonies.

Paetongtarn thanked the king, the Thai people and lawmakers, saying she will perform her duties "with an open mind," and will "make every square inch of Thailand a space that allows Thai people to dare to dream, dare to create and dare to dic-



tate their own future."

Paetongtarn became Prime Minister days after the Constitutional Court removed Prime Minister Srettha Thavisin, after less than a year in office. The court found him guilty of a serious ethical breach for appointing a Cabinet minister who had been jailed for contempt of court after an alleged attempt to bribe a judge.

Paetongtarn is also Thailand's second female prime minister after her aunt, and the country's youngest leader at 37.

Speaking to reporters after the ceremony, Paetongtarn said she is determined to push forward key policies such as economic stimulus, improvement for universal healthcare and promoting cultural "soft power" on the global stage.

She did not initially mention Srettha's signature proposal for a digital cash handout of 10,000 baht (about \$275) to 50 million citizens to spend at local businesses in order to boost the economy.

The project has been criticized as an ineffective way to contribute to sustainable eco-

nomic growth, and has faced several hurdles that include its

When pressed by reporters, Paetongtarn said she still has an intention to push forward a major economic stimulus for Thailand, but she will need to "continue to listen to opinions."

sources of funding.

She also said she will ask for her father for advice when she needs, but insisted that she would make her own decisions. "I am my own person. I have my own things and my own goals that I have to achieve in the future, but of course all the comments from him (have) value to me," she said.

Pheu Thai is the latest in a string of populist parties affiliated with Thaksin, who was ousted in a 2006 military coup, which triggered nearly two decades of deep political divisions that pitted a mostly poor, rural majority in the north that supported Thaksin against royalists, the military and their urban backers.

Parties linked to Thaksin won the most seats in every national election from 2001 until 2023, when it lost to the more progressive Move Forward Party.

Pheu Thai was able to form a government after Move Forward was blocked by the military-appointed Senate, partnering with former rivals in what was widely interpreted as a political bargain with the conservative establishment to stop Move Forward from forming a government.

The same day, Thaksin returned from exile and briefly reported to prison to for an eight-year sentence on charges related to corruption and abuse of power. He was moved almost immediately from prison to the hospital on grounds of ill health, and about a week after that the king reduced his sentence to a single year. He was released on parole in February after spending six months serving time in the hospital.

Since his release, Thaksin has maintained a high profile traveling the country, making public appearances.

On Saturday, Thaksin's lawyer Winyat Chatmontree posted on Facebook that Thaksin was among the convicts granted a royal amnesty by the king on the occasion of his birthday in late July. It took effect Sunday, which means Thaksin is free ahead of his original parole schedule.

However, the amnesty does not protect Thaksin from an ongoing case for defaming the monarchy, which was indicted in June after being originally filed in 2016. It has been seen by some analysts as a warning from Thaksin's enemies that he should tone down his political activities.

Ukraine says it repelled Russian missile attack on Kyiv

KYIV, Aug 18 (Agencies): Ukrainian forces said they thwarted a Russian missile attack on the capital Kyiv where air raid sirens sounded before dawn on Sunday.

"This is the third ballistic missile attack on the capital in August with a clear interval of six days between each attack," the Kyiv City Military Administration posted on Telegram after the early morning barrage.

Simultaneous to the missile attack, drones were spotted heading to Kyiv. "All enemy drones were destroyed far outside the city," it added.

No damage or casualties were reported from the attack, which the administration said had "most likely used North Korean ballistic missiles of the KN-23 type".

The United States and Seoul have accused North Korea of providing ammunition and missiles to Russia for its war in Ukraine.

Kyiv has repeatedly called for its allies in the West to provide more airdefence systems.

Last weekend, a 35-year-old man and

his four-year-old son were killed in an overnight Russian missile attack near Kyiv. Three other people were seriously injured

injured.
Concern has deepened after Moscow vowed a "tough response" to the recent Ukrainian advance into Russian terri-

Two and a half years after Russia's invasion of Ukraine, Kyiv's troops last week launched a major counter-offensive into the Kursk region, sending more than 120,000 people fleeing.

Ukraine claims to have seized more than 1,100 square kilometres of Russian territory in the biggest attack by a foreign army on Russian soil since World War II.

On Saturday, Ukrainian President Volodymyr Zelensky said that his army was reinforcing its positions in the Russian region of Kursk with the operation "proceeding exactly as we expected".

On the other side of the front line, Russian air defences destroyed five Ukrainian drones in the Belgorod, Kursk and Rostov regions on Saturday night, the Russian Defence Ministry said.

7.0 magnitude earthquake hits off far east coast of Russia



PETROPAVOSK-KAMCHATSKY, Aug 18 (Agencies): A powerful earthquake with a preliminary magnitude of 7.0 struck in the Pacific off the far eastern coast of Russia near a major naval base early Sunday, but there were no early reports of damage or injuries.

The quake prompted a tsunami warning that

was later lifted.

The earthquake occurred 18 miles (29 kilometres) below the surface and its epicenter was about 63 miles (102 kilometres) east of Petropavlovsk-Kamchatsky, the US Geological Survey said.

Petropavlovsk-Kamchatsky is a port city of more than 1,81,000 people surrounded by volcanoes and sits across a bay from an important Russian submarine base.

The US National Weather Service's Pacific Tsunami Warning Centre in Honolulu initially warned that hazardous tsunami waves were possible for coasts within 300 miles (480 kilometres) of the earthquake epicentre, but later announced the threat had ended.

The centre said minor sea level fluctuations could occur in some coastal areas near the earthquake site for several hours.

UK plans to treat extreme misogyny as form of terrorism



LONDON, Aug 18 (Agencies): For the first time, the United Kingdom government is planning to treat extreme misogyny as a form of terrorism.

The Telegraph reported that UK Home Secretary Yvette Cooper has issued an order to review the country's counter-terrorism strategy to address violence against women, identify gaps in the current laws, and study emerging ideologies.

This move will put violence against women in the same bracket as far-right extremism.

Under the proposal, it would be compulsory for school teachers to refer students they suspect of extreme misogyny to the government's counter-terror program.

The local police will assess anyone who is referred to the program to see if they display signs of radicalisation and need to be deradicalised.

Speaking with The Telegraph, Cooper stated, "For too long, governments have failed to address the rise in extremism, both online and on our streets, and we've seen the number of young people radicalised online grow. Hateful incitement of all kinds fractures and frays the very fabric of our communities and our democracy."

The Labour MP added, "Action against extremism has been badly hollowed out in recent years, just when it should have been needed most.

"That's why I have directed the Home Office to conduct a rapid analytical sprint on extremism, to map and monitor extremist trends, to understand the evidence about what works to disrupt and divert people away from extremist views, and to identify any gaps in existing policy that need to be addressed to crack down on those pushing harmful and hateful beliefs and violence," he stated.

This comes after a senior police official warned last month that social media influencers like Andrew Tate could radicalise youth into extreme misogyny in the same way terrorists draw in their followers.

Calling it "quite terrifying," Deputy Chief Constable Maggie Blyth stated that the Online Safety Act needs to advance further and that rapid actions should be taken in order to protect children.

Earlier last month, the UK's National Police Chiefs' Council released a report on violence against women and girls, calling it a "national emergency."

Vietnam's new leader arrives in China on first overseas trip since taking the helm BEIJING, Aug 18 the state-owned Global overseas visit destina- guard ship recently took

BEIJING, Aug 18 (Agencies): Vietnamese leader To Lam started a three-day visit to China on Sunday in his first overseas trip since assuming his country's top post about two weeks ago.

Lam arrived in the morning in Guangzhou. an industrial and export hub near Hong Kong, Chinese state media reported. His agenda included visiting sites in the southern China city where former Vietnamese communist leader Ho Chi Minh spent time,

the state-owned Global Times newspaper said in a social media post.

He is to meet with Chinese leader Xi Jinping and other senior officials during his trip.

Lam was confirmed as general secretary of Vietnam's Communist Party, the top leadership position, on Aug. 3. He also has held the largely ceremonial title of the nation's president since May. Lam succeeded Nguyen Phu Trong, who died on July 19 after 13 years as general secretary



The new leader is expected to continue his predecessor's strategy of balancing ties with China, the United States and Russia, Yu Xiangdong, the director

of the Institute for Vietnam Studies at China's Zhengzhou University, wrote Saturday in the Global Times.

"The fact that Lam chose China as his first

tion since taking office is a sign that Vietnam attaches great importance to its relations with China," Yu said in an opinion piece. "But at the same time, judging from experience, the country is not by any means going to give the U.S. the cold shoulder."

Though they have long ties as one-party communist states, Vietnam and China have sparred repeatedly over territory that both claim in the South China Sea. A Vietnamese coast

part in joint drills in the Philippines, which has had a series of violent encounters with China over disputed territory in the same waters.

China also briefly

invaded parts of northern Vietnam in 1979.

Still, Vietnam has benefited economically from investment by Chinese manufacturers, which have moved production to the Southeast Asian country in part to skirt U.S. restrictions on solar panels and other exports from China.

Educational Institutions reopen after a month in Bangladesh

DHAKA, Aug 18 (Agencies): Bangladesh on Sunday reopened all educational institutions, including universities, secondary schools and colleges, across the country after more than a month of closure due to violence centring the student-led protests that led to the ouster of Prime Minister Sheikh Hasina.

The educational institutions in Bangladesh were closed indefinitely on July 17 to ensure the safety of students in the wake of clashes that erupted during the recent movement demanding reform of the job quota system.

The Ministry of Education on Thursday issued a directive to reopen the institutions under its jurisdiction.

All the educational institutions reopened on



Sunday, after a month of closure.

According to Somoy Television, a Bengali news channel based in Dhaka, "All concerned have been asked to take necessary steps to resume academic activities in all the educational institutions from August 18 following the instruction of Chief Adviser Muhammad Yunus," a notification signed by deputy secretary Mosammat Rahima Akhtar, said on

August 15.

In the morning, school students in uniform were seen going to their institutions, many accompanied by guardians, the Daily Star reported.

Many points of Dhaka city are witnessing severe traffic congestion due to the reopening of educational institutions.

The working week is from Sunday to Thursday in Bangladesh.

Initially, classes were scheduled to resume on August 4 in all government primary schools,

except in the 12 city corporations and Narsingdi municipality, but this was also postponed.

Meanwhile, the postponed Higher Secondary Certificate (HSC) and equivalent examinations will be resumed from September 11.

According to the revised routine, the exams will be completed on October 23.

Classes at public universities have been suspended since July 1 when teachers went on strike in protest of a new pension scheme.

After the fall of the Sheikh Hasina government on August 5, the educational institutions were declared open on August 7, but the academic activities could not be resumed fully due to the low attendance of students.

A crocodile attacks and wounds a zookeeper in Jerusalem



JERUSALEM, Aug 18 (Agencies): A crocodile attacked a zookeeper in Jerusalem on Sunday, leaving him hospitalized with severe injuries on his upper body, officials said.

Israeli police said a security guard at the zoo likely saved the man's life by firing stun bullets at the crocodile. It was not immediately clear if the animal was

iniured.

Jerusalem's Ein Kerem Hospital said the 45-year-old man was immediately taken into surgery.

The zoo first opened in 1939 in the city center as a petting zoo and moved to southern Jerusalem in 1992. Today it hosts dozens of species from around the world and an aquarium.

MUMBAI/JAMMU, Aug 18: With deposit growth slowing down, banks are racing to mobilise funds through special deposit schemes and other innovative plans to meet the credit demand in the system. Many banks have reported a decline in deposits during the quarter ended June 2024 as customers are now looking at alternative avenues like the capital markets to park their funds for better returns.

State Bank of India (SBI), India's largest bank, registered a fall in deposits to Rs 49.01 lakh crore in the June quarter of FY25, compared to Rs 49.16 lakh crore in the March 2024 quarter. Bank of Baroda reported a fall in deposits from Rs 13.26 lakh crore to Rs 13.06 lakh crore in the June quarter. Other banks also reported a similar trend during the June quarter.

Among private banks, HDFC Bank's deposit base remained flat at Rs 23.76 lakh crore on a sequential basis in June 2024.

CASA deposits and impact on bank strategies According to bank officials, current and savings bank (CASA) deposits declined during the quarter. SBI's CASA deposits fell to Rs 19.41 lakh crore from Rs 19.14 lakh crore in March 2024. "The decline in deposit growth has forced some banks to raise deposit rates in certain buckets. Credit growth is now outpacing deposit growth. Customers are now focusing more on the capital market where returns are far higher than bank deposits. They were seen breaking fixed deposits



to invest in mutual fund schemes," said a bank official

The Reserve Bank of India's (RBI) latest data shows that credit growth rose by 15.1 per cent as of July 2024, compared to 14.6 per cent on a year-on-year basis. However, deposit growth declined to 10.6 per cent from 12.9 per cent a year ago.

SBI Chairman Dinesh

Khara said that the current phase of credit growth outpacing deposits is temporary. "We have seen that when alternative options are available, people have gone to markets but bank deposits remain the channelling source. We had a similar situation in 2007 when loans outpaced deposits, but it was a temporary phenomenon which we should be able to navigate with our investment book," he said while unveiling the bank's quarterly results last week.

Banks launch special deposit schemes

In order to mobilise higher deposits, banks have been launching special term deposits. Recently, lenders such as SBI, Bank of Baroda, Bank of India, Bank of Maharashtra, RBL Bank, and Bandhan Bank have launched special retail deposit schemes. Banks are also focusing

bring back focus on mobilising "small deposits" and not just big deposits in order to reverse the slowdown in deposit growth rate.

"It's right that credit

is going through digital format and collection of deposits is not. Huge big deposits have always been a very lazy banker's job, but the trickles which come are going to be the bread and butter money to lend regularly. So that trickle (small deposit mobilisation) was the emphasis a long, long time ago...the requisite small deposits, that's also one of the very critical jobs of the bank. It might be grinding monotony but that's where your bread and butter lies."

However, slower growth in deposits has led to an increase in the cost of funds for banks, which has forced banks to raise their lending rates. Recently, SBI raised its marginal cost of funds (MCLR) by 10 basis points (bps) across all tenors. In the last three months, SBI has raised MCLR by up to 30 bps in

some of the tenors.

Mutual funds vs. bank
deposits

Analysts said equity schemes of mutual funds had given four to five times more returns than bank deposits, prompting people to focus on the capital market for higher returns. After adjusting for inflation, they were hardly getting two or three per cent returns from bank deposits. Mutual fund players said that the notion that the slowdown in bank deposits due to higher subscription to mutual

funds seems to be misinformed. They said that the shift of money from bank deposits to mutual funds will not affect banking system liquidity as the money remains in the banking system.

"Prima facie it seems that bank deposits and mutual funds are competing with each other, but there will be no impact on the banking system liquidity because of money flowing into mutual funds," said Sandeep Bagla, Chief Executive Officer (CEO) of Trust Mutual Fund.

He attributed strong returns, ease of investing, the ability to invest regularly in the market through systematic investment plans (SIPs), and growing awareness among retail investors as the primary reasons for higher retail participation in mutual funds.

"In the last seven years, the returns from equity markets and equity-oriented mutual fund schemes have been very strong and so people are looking to earn those returns and are investing in mutual funds. The fact that one can invest regularly in the market at all levels through SIPs has also resulted in a lot of savings moving into SIPs." Bagla said.

The data from the Association of Mutual Funds in India (AMFI) showed that the contribution of systematic investment plans (SIPs) touched an all-time high of Rs 23,332 crore in July. The net assets under management of the mutual fund industry grew by 6.23 percent to touch a record high of Rs 64.97 lakh crore as of July

"Yes, I have received the summons. But at the moment, I am out of town and have informed the Kolkata Police about that. I do not know why they have called me, but it seems that some of my comments on social media have elicited certain reactions nationally and internationally... maybe because of that," Sarkar told agency.

Dr Goswami, Deputy Chief Medical Officer of Purba Bardhaman district, said he is yet to receive the summons.

Speaking to agency, he said, "I am yet to receive anything. I do not know why Kolkata Police will issue summons to me when they are not investigating the case. I have been saying that I will cooperate with the probe in every possible manner. I didn't reveal the identity of the victim or spread any rumour."

Finance Minister calls for reforms in multilateral development banks at Global South Summit

NEW DELHI, Aug 18 (Agencies): Finance minister Nirmala Sithraman has called for views on actions needed to reform multilateral development banks (MDBs), and how the global south can collaborate better to raise the issue of debt distress faced by the low income countries.

She was addressing the finance ministers' (virtual) session of the 3rd Voice of Global South Summit. Sitharaman said high debt service costs have constrained resource available for financing developmental needs, particularly in low income countries.

"It is critical that the financing requests made to MDBs are met with speed and agility. This will require reforms at operational levels as



well as identifying new additional sources of finance," the minister said.

She reiterated that dedicated concessional windows should be made available for middle income countries to address climate-related challenges on private capital mobilization.

"MDBs need to engage with credit trading agencies and explore how to better incentivise the flow of private capital or development financing," said the finance minister.

Citing the World Bank's June 2024 report, which states that by the end of this year, one in four developing economies will be poorer than they were before the pandemic, she highlighted that growth remains insufficient to drive progress in development and poverty reduction.

Discount brokers' market share rises to 64.6% amid surge in new demat accounts



NEW DELHI, Aug 18 (Agencies): Discount brokers continue to chip away market share from traditional/full-service brokerages, with top five of them raising their market share to 64.6% in July, up from 58.1% in the year age period.

in the year-ago period. Meanwhile, brokerages added 4.5 million new demat accounts in July, taking the total to 167 million in the month, up 35% year-on-year at 123 million and 3% jump on a monthly basis. This has the average monthly account additions of 3.9 million so far in the current fiscal, as per the data from traditional brokerage Motilal Oswal sourced from the exchanges and NSDL and CSDL.

Top five discount brokers accounted for 64.6% of total NSE active clients in July, up from 58.1% in July 2022, increasing the number of active clients on the NSE by 3.2% to 45.7 million in July, the brokerage said.

Groww toppled Zerodha to become the top brokerage in terms of clients in August 2023, and continues to add more clients and market share in July, recording 4.9% month-on-month rise in its client count to 11.5 million, and increasing its market share 40 bps to 25.1%. In July 2023, Groww had 18.8% market share and toppled Zerodha next month with 19.9% market share.

On the other hand, Zerodha continued to lose share as it added only 1.7% more clients to 7.8 million in the reporting month, and lost 25 bps to 17.1%. Zerodha at its peak had a market share of 19.8% in July 2023 and since then has been losing.

Angel One saw a 3.8% growth in its client count to 7 million, adding 10 bps to market share to 15.3%, Upstox clocked a 2.7% rise in its client count to 2.7 million, and controlled 6% market share and 5Paisa lost 44 bps of its market share to 1.2%.

On the other hand, traditional brokers led by ICICI Securities, which is being delisted, reported client count at 1.9 million, and lost 10 bps to 4.2%. IIFL Securities added 0.5 million clients and had 1% market share.

while the proposed F&O curbs has had its impact on NSE volume, it did in fact help BSE raise its volume share. The market share of BSE in the total cash segment came in at 7.1% in July, up from 6% in July 2023.

IMF's Gita Gopinath shares key reforms India needs for economic growth

NEW DELHI, Aug 18 (Agencies): Dr Gita Gopinath, the First Deputy Managing Director of the International Monetary Fund (IMF) said that India will remain one of the fastest growing G20 economies in terms of major economies of the world.

She also shared her insights on the key reforms that India needs to focus on to achieve stronger economic growth,

In an exclusive interview, Dr Gopinath discussed various aspects of the economy and the steps the government can take to boost growth, particularly in light of the IMF's medium-term growth projection of around 6.5% for India.

Structural reforms for economic growth

Dr. Gopinath mentioned the importance of a broad spectrum of structural reforms, highlighting that while some may take longer to yield results, others can be implemented more quickly to spur growth.

One critical area she identified is improving the business environment in India. Simplifying regulations, reducing red tape, and making it easier for businesses to operate are crucial steps to encourage private sector investment, both domestic and foreign.

lomestic and foreign. She pointed out that



states like Gujarat and Tamil Nadu, which rank high in terms of business climate, are also the top destinations for foreign direct investment in India.

"The 2 bright spots in India are Gujarat and Tamil Nadu. And both of them also rank high in terms of business climate. So there's a strong correlation over there. That in implementing that, countrywide would be very helpful," she said.

This correlation, according to Dr Gopinath, underscores the need to implement such business-friendly environments across the country.

Labour and infrastructure reforms

Labour reforms also feature prominently on Dr Gopinath's list of priorities. India has introduced new labour codes, but their implementation remains a work in progress.

She highlighted the need for both central

and state governments to work together to enforce these reforms effectively. The aim is to create a more flexible labour market, which would make it easier for businesses to hire and manage workers, ultimately leading to job creation and economic

growth.
In addition to labour reforms, Dr Gopinath mentioned the importance of continued investment in public infrastructure, especially digital infrastructure.

"Public infrastructure investment, digital infrastructure investment, that's a lot that's been done, but a lot more is still, of course, needed, and that's another area," she added.

Trade policies and global integration

Trade restrictions are another area of concern for Dr Gopinath. She highlighted that this decade presents a significant opportunity for India, as the world is looking to diversify mar-

kets and supply chains.

To take advantage of this, India needs to be seen as a trade-friendly nation. Lowering trade barriers and integrating more deeply into global supply chains will be essential for India to attract investment and drive growth.

Dr. Gopinath cautioned against the rising tide of trade protectionism globally, noting that trade has historically been beneficial in reducing poverty, maintaining growth rates, and facilitating technology transfer.

"The only way you're going to get that is if you're also going to be seen as being trade friendly because that's usually the path to getting into global supply chains," she said.

Evaluating government incentives

When asked about the government's production-linked incentives (PLIs) and employment-linked incentives (ELIs), Dr. Gopinath acknowledged the government's focus on key sectors but urged caution.

She suggested that while these incentives are important, it is essential to conduct a thorough cost-benefit analysis to ensure that they deliver the desired outcomes without putting undue strain on public finances.

The success of these

incentives, according to Dr Gopinath, will depend on their implementation and the broader business environment.

For instance, coupling these incentives with labour market reforms could provide the flexibility needed to create more jobs. However, she noted that it is still too early to assess the impact of these policies fully.

Addressing job creation challenges

One of the most pressing challenges India faces is job creation. Dr Gopinath shared some concerning figures, noting that India will need to create between 60 million and 148 million additional jobs by 2030 to meet the demands of its growing population.

Achieving this will require a multifaceted approach, encompassing improvements in the business environment, private investment, labour market flexibility, and human capital development.

She underscored the importance of not limiting the focus to just one sector, whether it be manufacturing, services, or high-tech industries. Instead, a comprehensive strategy that supports all sectors will be necessary to generate the scale of job creation required.

Mid-tier banks boost fixed deposit rates to 8.50% to attract depositors

MUMBAI, Aug 18 (Agencies): Borrowing a leaf from their larger peers who have been wooing depositors with attractive pricing for medium-term fixed deposits of up to 7.30% return per annum, several mid-tier banks are now doing the same offering as much as 8.50% at the peak and over average 20-30 bps more than the larger banks.

Mid-sized banks, which have launched special deposit drive include RBL Bank, Bank of Maharashtra, Federal Bank, Bandhan Bank, and Tamilnad Mercantile Bank among others to increase in deposits.

Continuing slower growth of deposit mobilisation for more than two months had the regulator Reserve Bank and even the North Block mandarins getting worried about asset liability mismatch. People were pulling out money from banks and parking them in equities and mutual funds and even derivatives since the pandemic-induced crash in March 2020 and the subsequent recovery from June of that year. Since then the stock market and mutual funds

have been giving much higher returns on their money.

While credit growth has been averaging 15-16% system-wide, deposits accretion has been far lower averaging at 11-12% for the past few years. In FY24, credit growth was at 19.3% and deposit growth was 14.7%, forcing banks to offer higher prices for term deposits.

Kochi-based Federal Bank has unveiled a limited period fixed deposit scheme offering 7.35% for a 400-day money, 7.40% for 777 days, and 50-month tenor for callable deposits. It is offering an additional 0.50% to senior citizens. If you put in non-callable deposits above Rs 1 crore, it is offering 7.50% for 400 days; 7.55% for a 777 day money.

RBL Bank is offering 8.10% for 500-day money and 8.60% for senior citizens. Pune-based Bank of Maharashtra is offering 7.25% for 777 days tenor in a limited period offer. Turticorinbased Tamilnad Mercantile Bank is offering 7.50% on fixed deposits for 400-day tenor and 8% for senior citizens.

In June and July large lenders

like State Bank, HDFC Bank, Bank of Baroda, Union Bank of India, Canara Bank, Bank of India, Central Bank of India and Punjab National Bank, among others, launched special fixed deposit schemes to mobilise deposits at a faster pace to support credit growth.

Some of these large banks, in the meanwhile have also hiked their lending rates as well to protect their margins, which analysts war will fall by 25-30% this fiscal as deposit pricing keep on rising.

The banks, which have increased their loan pricing — so far only MCLR-based loans which are typically short term corporate loans include SBI which earlier this week upped the MCLR loan rate by 10 bps across tenors, Bank of Baroda, Canara Bank, and Uco Bank had also hiked their MCLR based loans by 5 bps.

Typically banks earn more when their interest expense, which is what they pay for their funds is lower. In a normal scenario, banks price deposits/liabilities lower than their assets/loans to protect their margins/

spreads.

In the current scenario, banks are forced to raise domestic deposits at higher prices, because even raising money from outside is no longer lucrative as the interest in the overseas markets are also at decadal high. According to rating agency Crisil, banks profitability is set to moderate due to higher cost of deposits given the continued re-pricing at elevated rates. Deposit costs are expected to increase 25-30 bps this fiscal after having risen 140 bps since the start of the rate tightening cycle in May 2022. As a result, net interest margin (NIM) is likely to compress 10-20 bps this fiscal to 3-3.1%.

In contrast, if the Reserve Bank cuts repo rate it would trigger faster repricing of loans downwards as over 40% of advances are linked to an external benchmark, primarily the repo rate. Together, these factors indicate a compression in net interest margin (NIM) in fiscal 2025 and transmission on the assets and liabilities sides will continue into fiscal 2026, the agency said.

Genetic connections between Alzheimer's disease, heart conditions found

NEW DELHI, Aug 18 (Agencies): A new study has uncovered genes that could be related to heart conditions and Alzheimer's disease, suggesting that the two

could have similar origins.

Researchers said that evidence increasingly links people having the heart condition with a quicker cognitive decline and a 26 per cent increased risk of dementia, affecting one's memory and thinking, and interfering with daily activities. Alzheimer's disease is the most common form of dementia.

Coronary artery disease is a condition in which blood flow to the heart is restricted due to narrowing of blood vessels.

Even as abnormal levels of fat in blood and inflammation could be possible shared risk factors between having coronary artery disease and developing Alzheimer's disease, the researchers at Edith Cowan University, Australia,

said that the processes underlying the link remain unclear.

In this study, they employed genetic methods to examine the intricate relationship between heart disease and Alzheimer's disease.

The team chose to study seven heart disease-related factors, such as coronary artery disease and angina, and 13 lipids, including cholesterol - both 'good' and 'bad'.

Previous studies have long suggested lipids to play a role in the development of Alzheimer's disease, they said.

"Our comprehensive analysis reveals a significant and positive global genetic correlation between Alzheimer's disease and three lipid traits: LDL ('bad' cholesterol), triglycerides, and total cholesterol," the authors wrote in the study published in the International Journal of Molecular Sciences.

This suggests that certain lipids,

not all, may have a more direct genetic link with Alzheimer's disease, they said.

However, many of the lipids that the authors studied were genetically related with coronary artery disease.

"Specifically, we found significant genetic correlations between coronary artery disease traits and lipid profiles such as HDL, LDL, triglycerides, and total cholesterol, aligning with the existing literature that underscores the genetic interplay in cardiovascular risk factors," they wrote.

By applying genetic approaches to gain a deeper understanding of the relationship between Alzheimer's disease and coronary artery disease, we have uncovered novel insights into the underlying mechanisms linking these conditions, corresponding author Emmanuel Adewuyi, from Edith Cowan University, said.

New algorithm analyses tongue to predict diabetes, stroke with 98 per cent accuracy

NEW DELHI, Aug 18 (Agencies): Researchers have developed a novel computer algorithm that can predict various diseases like diabetes or stroke, just by analysing the colour of the human tongue with 98 per cent accuracy.

The imaging system developed by Middle Technical University (MTU) and the University of South Australia (UniSA) in Australia can diagnose conditions such as diabetes, stroke, anaemia, asthma, liver and gallbladder issues, Covid-19, and other vascular and gastro-intestinal diseases.

"The colour, shape, and thickness of the tongue can reveal a litany of health conditions," said Ali Al-Naji, adjunct Associate Professor at MTU and UniSA.

"Typically, people with diabetes have a yellow tongue; cancer patients a purple tongue with a thick greasy coating; and acute stroke patients present with an unusually shaped red tongue," he added.

The breakthrough was achieved through a series of experiments using 5,260 images to train machine-learning algorithms to detect tongue colour.

Researchers received 60 tongue images from two teaching hospitals in the Middle East, representing patients with diverse health conditions. The AI model matched tongue colour with the correct disease in nearly all cases.

The paper published in Technologies describes how the system analyses tongue colour to provide real-time diagnoses, demonstrating that AI can advance medical practices significantly.

Al-Naji explained that Al is replicating a 2,000-year-old technique from traditional Chinese medicine, where the tongue's colour, shape,

and thickness are used to diagnose health issues.

For example, people with diabetes typically have a yellow tongue, while cancer patients show a purple tongue with a thick greasy coating. Stroke patients often present with an unusually shaped red tongue. A white tongue can indicate anaemia, severe Covid-19 cases are associated with a deep red tongue, and an indigo or violet tongue suggests vascular or gastrointestinal problems or asthma.

The study used cameras placed 20 centimetres from a patient to capture tongue colour, and the imaging system predicted health conditions in real time.

Co-author, UniSA, Professor Javaan Chahl noted that this technology could eventually be adapted for use with smartphones, making disease screening more accessible.

Let's leave it to gods: Chopra on 90m throw

NEW DELHI, Aug 18 (Agencies): Having missed out on breaching the elusive 90m mark at the Paris Games, two-time Olympics medallist Neeraj Chopra has left that widely debated matter "to the gods". After all, Chopra has been chasing that milestone for years and the wait got longer when his only legal throw of 89.45m got him a silver at the Paris Olympics earlier this month.

A back-to-back medal at the Summer Games was a monumental feat for an Indian athlete but Chopra's throw was way short of Arshad Nadeem's sensational 92.97m that comfortably secured a historic gold for the Pakistani.

Nursing a long-standing groin injury, Chopra managed to be on the podium and now he will be seen in the Lausanne Diamond League starting August

After a busy couple of days post the Olympics final on August 8, Chopra started training in Switzerland and is determined to finish the season on a high despite being restricted by injury.

"I need to leave it to gods now," he said when asked about his target throw in the foreseeable future. "I Just want to prepare well and see where the javelin goes. There has already been talk about 90m, now I feel just let it be. In Paris, I thought it would happen and it could have happened. Now I will give my 100 per cent in the next two or three events and see what happens," he said.

Following the season-ending Diamond League in Brussels on September 13-14, Chopra will consult the doctors on his groin injury with surgery being the most likely option. The 26-year-old has been managing the injury since winning gold in the World Championships last year.

With Arshad producing an Olympics record throw in the final, Chopra needed to up his game but he said he could not do that because of his physical state.

"I felt I could increase the distance. My two throws in qualification and final, they were second and third best throws and my season's best as well. To increase distance I need to be injury-free. In my mind I know I need to give a 100 per cent but because of the injury I am not able to do that. My body and mind stops me from making that extra effort. What is most important in training is throwing sessions which I have not been able to do as much as I would have liked to. If you can't throw regularly then you are not able to work on your technique. I need to throw as much as I can. The rest is all fine," he said.

Kamran Akmal bashes PCB for 'international mockery' due to no crowd in Karachi Test

KARACHI, Aug 18 (Agencies): Former Pakistan cricketer Kamran Akmal has lashed out at Pakistan Cricket Board (PCB) for hosting the second Test against Bangladesh at National Bank Stadium in Karachi. Notably, due to the ongoing construction work at the stadium as part of the preparations for the ICC Champions Trophy 2025, the PCB has not allowed the crowd the game.

However, the decision hasn't gone down well with Akmal who called it a joke for Pakistan cricket that matches are played without any crowd. The former wicketkeeper-batter said that the board could've arranged the game in some other stadium as Pakistan have many options.

"The second Test match will be played in Karachi. So I think you know that there is a renovation going on in Karachi. They are preparing a stadium for the Champions Trophy. So it will be a joke of Pakistan that Test matches are being played in Pakistan without a crowd. And we don't just have 2-3 stadiums; we also have Faisalabad Stadium. We could have played there too; it is a top-class stadium. So much cricket has happened there," Kamran said in a video uploaded from his You-

Tube channel

Further speaking ahead, Akmal suggested that Multan stadium would've been a good option calling PCB's decision an international mockery of their cricket.

Pakistan's unbeaten record over Bangladesh

"There is a stadium in Multan. And you know that Multan Stadium is very good. And the crowd also comes there. So you know that this is your stadium; you could have put another Test match at one of these two venues. So it would have been good. So I think it will be an international mockery of our cricket. These things should not happen," he

Meanwhile, Pakistan will take on Bangladesh in the first Test beginning from August 21 at Rawalpindi Cricket Stadium, Rawalpindi. Bangladesh arrived in Pakistan four days in advance to prepare for the series due to the ongoing political turmoil in their country. Notably, Pakistan have an unbeaten record over Bangladesh having beaten them in 12 out of the 13 matches played between the two teams. Hence, the Shan Masood-led side will be eager to continue their dominant record in the upcoming series as well.

Jaspal Rana blasts NRAI selection policy: 'No system to protect shooters'

NEW DELHI, Aug 18 (Agencies): Double Olympic-medallist shooter Manu Bhaker's coach Jaspal Rana has strongly criticized the National Rifle Association of India's (NRAI) "everchanging" Olympic selection policy, stating that it has harmed promising talents and will continue to do so if consistency is not maintained. Rana, a pistol legend with three Asiad gold medals, emphasized the need for a fixed policy, highlighting that the current system fails to support shooters and often leads to their decline.

Rana pointed out that the selection policy changes every six months, which creates uncertainty and makes it difficult for shooters to prepare. He suggested that the federation should decide on a policy and stick to it, regardless of whether it is right or wrong. This consistency, he believes, will significantly improve the performance of shooters.

"The (federation's) selection policy changes every six months. I met the sports minis-



ter and told him 'get the selection policy from the federation. Let them decide... whatever they decide, right or wrong, we are not discussing that, and then stick to it'.

"You will see the difference (in the performance of shooters)," said the decorated marksman. Rana cited examples of tal-

Rana cited examples of talented shooters like Saurabh Chaudhary and Jitu Rai, who faded away quickly despite their initial success. He also mentioned Arjun Babuta, who finished fourth in Paris and is now

struggling to regain his form. Rana questioned why there is no effort to support these shooters and help them regain their position.

The NRAI had amended its selection criteria in 2021, reducing bonus points for quota winners and reintroducing trials. However, Rana argued that even with these changes, there is no consistency, and the federation's approach remains unclear. He emphasized that Olympic and world medallists need protection and support to

continue performing at the highest level.

"Where is (pistol shooter) Saurabh Chaudhary, where is (Asian Games gold medallist pistol shooter) Jitu Rai? Does anybody talk about them? No. Are we talking about (10m air rifle shooter) Arjun Babuta, who finished fourth in Paris? He missed the medal by a fraction," the firebrand 48-year-old asked.

"Nobody is thinking how to get him back on the platform (again)," said Rana, who was allegedly told to leave the Karni Singh ranges by the federation's High Performance Director Pierre Beauchamp during the Paris Olympics Selection Trials.

Rana's concerns are particularly relevant for Manu Bhaker, who won two bronze medals in Paris but will have to fight for a place in the national squad once she returns from her break. He advocated for a system that allows Olympic medallists to compete in every trial, ensuring they receive the necessary facilities and support to continue their success.

Lifter Mirabai, coach Sharma eye Asian Games, CWG medals

Mirabai had won a bagful of medals including gold in the 2017 World Championships and CWGs but the Asian Games medal is missing from her trophy cabinet.

CHENNAI, Aug 18 (Agencies): Weightlifter Mirabai Chanu fell short of a bronze medal at the 2024 Paris Olympics just by a kilogram. The Tokyo Games silver medallist was the favourite to add to her tally in the recently concluded quadrennial event but that was not to be. The loss might be heartbreaking but it failed to break the 30-year-old weightlifter's spirit.

Quickly moving on from the Paris defeat, Mirabai and head coach Vijay Sharma have set their eyes on upcoming events including the 2026 Asian Games and Commonwealth Games. Currently, on a much-needed break, the duo is expected to reunite in a couple of months to chalk out future roadmap.

"It's been years since I have taken a long break so I have taken one month's leave. Similarly, Mira is on a two-month break. I will spend time with my family while she also plans to make up for the lost time by being with her family in Manipur," Coach Sharma told this daily from his hometown Modinagar, Uttar Pradesh.

She finished fourth in the women's 49kg last week as she could not lift 114kg in her third and final clean and jerk attempt. Mirabai lifted a total of 199kg



(88kg in snatch+111kg in C&J) at the South Paris Arena. It was 3kgs less than what she heaved at the Tokyo Olympics (202 kg) for a silver medal. Surodchana Khambao from Thailand bagged the bronze for her effort of 200kg (88 kg + 112 kg).

China's Hou Zhihui defended her title by smashing the cleanand-jerk Olympic record. She lifted an overall weight of 206kg (89kg + 117kg). Romanian Mihaela Cambei took home the silver with a total of 205kg (93kg + 112kg).

"I am not done yet. The same is true with Mirabai. The lifter might have taken a break but she will work on her fitness and strength. It will not be apt to talk

about the next Olympics in 2028 but yes we will prepare for the 2026 CWG and Asian Games. Both of us want to win more medals for the country and we will continue our quest for it," added Sharma.

Mirabai had won a bagful of medals including gold in the 2017 World Championships and CWG (2018 and 2022) but the Asian Games medal is missing from her trophy cabinet. It might have spurred her on to continue in the same vein leaving behind the Olympic failure.

As she won't, Mirabai was not dejected despite the medal slipping away from her. "It was going good, whatever the coach said I did. It is just destiny that

I did not get a medal, I did my best," she had said with a smile on her face. It looks like the former world champion will look to add another chapter to her glorious career when she returns to the weightlifting platform after a couple of months. Academy for future

Apart from coaching his trainees at the national camp, Sharma intends to produce world-class lifters at his yet-to-be officially inaugurated academy in Modinagar. While he was away on national duty, the facility started functioning with around 30 lifters training at the

place.

"It has been a dream to give top facilities to aspiring lifters and this academy will fulfill it. Although it has not been inaugurated yet but its been functional for a month now. It has all the facilities a weightlifting academy can offer including two coaches, a sauna and a steam bath. The equipment are world-class. My aim is to train lifters between the age group of eight and 11 as that is the perfect age to groom world beaters. But that doesn't mean I will not work with national campers. I hope to look after both jobs simultaneously," signed off the coach.

CA to celebrate 150 years of Test cricket with AUS vs ENG one-off match in 2027



NEW DELHI, Aug 18 (Agencies): Cricket Australia (CA) has announced to host a special Test between Australia and England to commemorate 150 years of Test cricket in 2027. Notably, CA released the men's hosting rights schedule for home Tests till 2031 on Sunday, August 18. While finalizing the schedule, CA revealed the hosting of the special Test between the oldest rivals of the game at the historic Melbourne Cricket Ground (MCG) to celebrate cricket's most respected format.

Notably, the first-ever Test match was played from March 15-19 between Australia and England in 1877 at MCG where Australia emerged victorious by 45 runs. CA CEO Nick Hockley expressed his excitement for the highly anticipated sesquicentenary calling it a wonderful celebration of the pinnacle format.

"The 150th anniversary Test match at the MCG in March 2027 will be a wonderful celebration of the pinnacle format of the game at one of the world's great sporting arenas and we can't wait to host England on that occasion," CA CEO Nick Hockley told cricket.com.au.

Notably, CA earlier hosted the cente-

nary Test between the two teams held from March 12-17 in 1977. It was a grand occasion at the MCG as every living men's cricketer who had played either Australia or England in an Ashes was invited to watch the game.

CA hosted centenary Test in 1977 In a major coincidence, Greg Chappel's Australia beat Tony Greig's England by 45 runs, the same margin by which Australia had won the maiden Test. Meanwhile, Australia and England will ignite their rivalry down under ahead of the sesquicentenary Test in Ashes 2025-26. Notably, Australia have retained the urn since 2017 with England last holding it in 2015.

Furthermore, the Three Lions are yet to win a Test in Australia since 2011 having suffered 0-5, 0-4 and 0-4 series losses in the last three Ashes tours. However, England have given tough competition to Australia at home with their last series loss coming in 2003 against their arch-rivals.

The Kangaroos managed to draw the series 2-2 on the last two occasions and hence will be hungry to continue their dominance at home in the upcoming

Sahai deliberates with C S Azad RD of RBI J&K, Ladakh in 63rd Empowered committee meeting

JAMMU, Aug 18: Rahul Sahai Chair PHDCCI Jammu expressed sincere gratitude to Chandra Shekhar Azad, Regional Director (RD), RBI J&K and Ladakh, for giving PHDCCI the opportunity to present various suggestions, recommendations, and issues concerning the trade and industry sectors in Jammu.

Rahul Sahai said PHD Chamber of Commerce & Industry has actively conducted numerous programs on crucial topics such as TReDS, Udyam registrations, and CGTMSE, serving as a vital bridge between the government and entrepreneurs in policy advocacy. However, as we move forward, we would like to highlight several pain areas that continue to affect trade and industry in Jammu.

Firstly, Sahai said that it has been observed that enterprises with slightly shaky CIBIL scores are facing significant challenges in securing loans. Many are compelled to seek funds from open markets at exorbitant interest rates. We urge that decisions be made based on the actual ground position of these entities, allowing for some calculated risk to be



taken. It's often seen that those in genuine need of financial support are overlooked, while those less in need are repeatedly offered loans.

Secondly, Sahai welcomed the introduction of a new assessment model for MSMEs in the recent union budget. This model will enable public sector banks to develop in-house capabilities for evaluating MSME businesses based on their digital footprint, rather than relying on external agencies. We would appreciate insights on how banks plan to implement this model in practice.

Rahul Sahai said, "The union budget also introduced a mechanism to support stressed accounts, ensuring continued bank credit for MSMEs during periods

of financial difficulty. This measure is crucial for preventing closures of small businesses during tough times, and we look forward to understanding how this will be operationalized."

Rahul Sahai appealed to banks, under their CSR mandates, to consider funding drug de-addiction centres in Jammu, such as the one established by JK Police in Sunjwan. This is a pressing social issue, and additional contributions are needed to support this cause.

Regarding TReDS, Sahai recommended that the RBI should suggest that government and semi-government departments, both at the state and central levels, be included on TReDS platforms. This would enable enterprises to access bill discounting facilities for payments due from the government.

Rahul Sahai said With the reduction in the turnover threshold for mandatory onboarding on TReDS from Rs 500 crore to Rs 250 crore in the budget, we request that all banks ensure compliance by requiring customers to declare their registration on the platform.

Sahai said Additionally, we seek clarification from SIDBI regarding the establishment of new branches in MSME clusters, as announced in the budget. This initiative aims to enhance the bank's reach, providing direct credit within three years, with 24 new branches scheduled to be opened this year alone.

opened this year alone. Sahai mentioned that Some other significant announcements in the budget include the introduction of a credit guarantee scheme for MSMEs involved in manufacturing, facilitating term loans for equipment and machinery without collateral. Another scheme aims to pool credit risks for MSMEs within clusters, offering guarantee covers of up to Rs 100 crore.

Furthermore, the limit for Mudra loans has been increased from Rs 10 lakh to Rs 20 lakh for those with a history of timely payments is also a welcome step.

Rahul Sahai said New business opportunities for banks have also been outlined, including financial support for setting up irradiation units within the MSME sector, the facilitation of NABH-accredited food quality and safety testing labs, and the creation of e-commerce export hubs to help traditional artisans access international markets. Banks should tap these new areas
