J&K parts likely to receive rains, thundershower till Sept 3: MeT

SRINAGAR, Aug 27 (Agencies): The parts of Jammu & Kashmir likely to receive rains and thundershower till September 3, officials of Meteorological Department said on Tuesday.

The officials said from August 27 to 30 there is a possibility of light to moderate rains and thundershower at many places of Jammu & Kashmir towards late night/early morning. Further a spell of rain and thundershower at many places towards afternoon is also expected, they said.

They said from August 31 to September 1 a brief spell of rain and thundershower at isolated places of Jammu & Kashmir is expected, while as during September 2 to 3 the weather will likely remain generally cloudy with possibility of spell of rain/thundershower

at many places. From September 4 to 5 the weather will remain generally dry,

the officials said. They added in past 24 hours Jammu received 64.2 mm rainfall, Kathua 65.2 mm, Udhampur 64.8 mm and Samba 53 mm.

The report suggested a progressive assessment framework for Classes 10 and 12. The new framework divides the academic year into two terms. The report also recommended that Class 12 board results to now include marks from Classes 9, 10, and 11.

The report mentioned, "The weightage of formative and summative marks will be adjusted progressively from class 9 to class 12, increasing the emphasis on summative assessment as learners advance in grades. Specifically, class 9 features a 7 per cent formative and 30 per cent summative split, class 10 an equal 50% formative and summative division,



Without fair defence, right to fair trial is meaningless

¬arlier this month, Chief ☐ Justice of India D.Y. Chandrachud decided to hear the matter related to the rape-murder at Kolkata's R.G. Kar Medical College and Hospital, taking "suo moto" cognisance of it. "Suo moto" is a Latin term that means "on its own motion". The CJI took cognisance of it based on the uproar in the mainstream and social media. Our Supreme Court has the power to take up cases on its own initiative, without a petition being filed. This power allows the court to address issues of public concern, especially those that involve public safety and fundamental rights. Given the passions and outrage the Kolkata rape-murder case generated, the CJI decided to hear it almost immediately and also to broadcast the hearings live on channels like YouTube. Senior lawyers Kapil Sibal and Menaka Guruswamy were appointed by the State of West Bengal to represent it in the Supreme Court in this matter. Also Read - Aakar Patel | Stop violence within India before bid for global peace Advertisement The brutal rape and murder of a trainee doctor on August 9 within the hospital premises was allegedly by a person known to frequent the premises and who was considered as known to the then principal, Dr Sandip Ghosh. It could have been an open and shut case but typically the state government's immediate response was ham-handed and gave rise to many apprehensions, much it well fuelled in the social media by political adversaries of the chief minister. It may not have been so, but it did appear that a coverup was underway, particularly as the hospital head was posted out

and appointed as head of another well-known institution within four hours. The court also pulled up the state government over the manner in which it was dealing with the agitating doctors and advised it to "sympathise with the doctors and their agitation, and also to appreciate popular feelings". But nevertheless, the Supreme Court decided to act, saying: "Why we decided to take suo moto (action) though the Calcutta high court was hearing it because this is not just a case of a horrific murder in a Kolkata hospital, but this is about the systemic issue about the safety of doctors across India." Clearly, the apex court was concerned about the much larger issue of the security of hospitals and their staff all over India. We can understand this concern as we read and hear with monotonous frequency about how doctors and nursing staff are belaboured and assaulted when some patients and their families are not satisfied with the medical outcomes. The drama of the SC's hearing broadcast live was further exacerbated by social media postings of habitual trollers. A popular post lists out the names and photos of 21 lawyers headed by senior counsels Kapil Sibal and Menaka Guruswamy, facing a team headed by solicitor-general Tushar Mehta with just five law-

yers by his side. The power and the majesty of the Union of India which he represents obviously doesn't matter? Besides, this particular post makes it out that 21 lawyers were appearing against the victim. These people don't seem to realise that under our judicial system, described as an adversarial system, the judge is expected to judge on the merits of the case and not general sentiments. The adversarial system is a legal system used in common law countries where two or more advocates represent their parties' case or position before an impartial person or group of people, such as a judge or jury, who attempt to determine the truth and pass judgment accordingly. It is in contrast to the inquisitorial system used in some civil law systems (such as those deriving from Roman law or the Napoleonic code) where a judge investigates the case. The adversarial system is a two-sided structure under which trial courts operate, pitting the prosecution against the defence. In free and democratic countries like India, the right to counsel is regarded as a constituent of the right to a fair trial. This right is often included in national constitutions. Of the 194 constitutions currently in force, 153 have language to this effect. The Constitution of India guarantees the right to counsel. In fact, without both sides being represented by recognised and registered legal counsel, the case cannot be conducted. In a case, legal counsel on both sides are regarded as officers of the court and their intellectual and legal jousting is only to establish the truth based on evidence. Lawyers are expected to provide counsel without prejudging their clients or pandering to public sentiment. True professionals are not expected to pick and choose sides. At any given time, a lawyer such as Menaka Guruswamy appears for all manner of clients. She appears for the defence and also for the State. When she appeared for a RSS-linked outfit, I was recipient of troll attention just as I am now a recipient of it because of the Kolkata matter. My late father-inlaw, whose senior counsel gown my daughter Menaka proudly wears, enjoyed a big reputation in the Andhra Pradesh high court for his judicial acumen and success. He appeared in some highly publicised cases, and when asked about defending the apparently indefensible, used to simply reply that it was up to the court to judge, his job was to ensure his client or sometimes the state, gets the best advocacy and the laws of the land are respected. My late grandfather, who was a famous lawyer of his time in Madras, once appeared for the hereditary mahant of the Tirupati temple, who was aggrieved for having been removed by the government for his extravagances and personal habits. When I asked him about it many years later, he simply replied that he was not defending the mahant's character but the manner in which he was removed. It was unlawful. The state had to later enact new legislation and got rid of the pernicious system of hereditary mahants. "The right to a fair trial is one of the fundamental guarantees of human rights and the rule of law, aimed at ensuring administration of justice. A fair trial includes fair and proper opportunities allowed by the law to prove innocence."

Stop violence within India before bid for global peace

Thile we are going to Ukraine and Poland to end violence all around the world, it is instructive to see what the world is saying about violence in India. On June 9, 2022, three United Nations Special Rapporteurs wrote to the Narendra Modi government on our bulldozer justice. Balakrishnan Rajagopal, Fernand de Varennes and Ahmed Shaheed wrote of their concerns on "forced evictions, housing and property demolitions directed against the Muslim minority communities in Khargone district of Madhya Pradesh state, in Anand district of Gujarat state and in the Jehangirpuri locality and other locations of New Delhi. These arbitrary housing and property demolitions were allegedly ordered by local governments arbitrarily to punish Muslim minorities and low-income communities for inter-communal conflicts between Hindus and Muslims that had broken out during and after religious processions". On July 12, 2023, the European Parliament passed a resolution on Manipur. It said that violence had left at least 120 people dead and 50,000 displaced and destroyed over 1,700 houses, over 250 churches and several temples and schools. The resolution said that "intolerance towards religious and belief minorities, including Christians, contributes to the violence"; that there had been "concerns about politically moti-

vated, divisive policies promoting

Hindu majoritarianism, and about an increase in activity by militant groups"; and that the European Parliament seeks "the utmost effort to promptly halt the ongoing ethnic and religious violence, to protect all religious minorities, such as Manipur's Christian community, and to pre-empt any further escalation". Also Read - Abhijit Bhattacharyya | Some historical lessons on old & new imperialist wars In response, India said this was a colonial mindset and was an intrusion into our internal matter. On March 7, 2024, more than two dozen United Nations human rights experts wrote to the Modi government to "sound the alarm over reports of attacks on minorities, media and civil society in India" and they called for "urgent corrective action". They said: "We are alarmed by continuing reports of attacks on religious, racial and ethnic minorities, on women and girls on intersecting grounds, and on civil society, including human rights defenders and the media." India did not respond to this (India does not respond to the United Nations though we are keen to be given a seat on its Security Council). Let us go further back. On June 13, 2021, the Group of Seven nations, which are advanced economies and liberal democracies, put out a sort of charter. The document was called the G-7 and Guest Countries: 2021 Open Societies Statement. The G-7 are the United States, Britain, Canada, France, Germany, Japan and Italy plus the European Union and the guest nations invited this time to the G-7 meet were South Korea, India, South Africa and

Australia. Also Read - Shreya Sen-Handley | The King's plumbing and other toilet tales The document says that all these nations reaffirm their shared belief in open societies, through democratic values and that they would embrace and encourage others to embrace these eight values, which are listed out. The first is human rights, both online and offline. The second is democracy, including "everyone's right to assemble, organise and associate peacefully, within a system of accountable and transparent governance". The third is social inclusion, and "full enjoyment of civil and political rights in both physical and digital spheres". Fourth is gender equality. Fifth is freedom of expression, "both online and offline". Sixth is rule of law and independent and impartial judicial system. Seventh is a multilateral system with free and fair trade and global collaboration. Eighth is the "importance of civic space and partnership with diverse, independent and pluralistic civil societies, including human rights defenders, in promoting human rights and fundamental freedoms". These eight apparently were "founding values" which "define our inclusive way of life". They would be promoted by the G-7 and guest nations through the following eight steps: First, "protecting civic space and media freedom, promoting freedom of expression, freedom of assembly and association, and freedom of religion or belief, and by tackling all forms of discrimination". Second, "to exchange information and coordinate effective responses to shared threats to human rights, democracy and the rule of law, such as

disinformation and arbitrary deten-

tion". Third, to promote economic openness "reasserting our shared economic model which is founded on open markets". Fourth, to prevent and tackle corruption. Fifth, to protect the digital civic space respecting human rights. Sixth, to prioritise gender equality and inclusion. Seventh, to collaborate on science. Eighth, to promote sustainable development goals, specifically to "promote just, peaceful and inclusive societies". The G-7 and its guests said they would build on these commitments in other multilateral fora. A few points arise from this development. Indian governments generally speaking and this government in particular are hostile to most of the things on the list. The Indian Prime Minister signed the statement and spoke in favour of the Open Societies charter, saying that India was a naturally ally. Perhaps we are, but the problem is that we cannot be signing these things and then doing the sort of actions that we do at home. Because if we do them, we will have to hear from the United Nations and the European Parliament. And even they are not the only ones. The US Congress (on Kashmir), the United States Commission on International Religious Freedom (on the "love jihad" laws in various BJP states) and the US state department (on various atrocities against minorities) have been vocal on India in this same period. For us to have basic credibility as a global leader which wants violence stopped elsewhere, we should first look at and acknowledge what we have done to ourselves. To not do so opens us to the accusation of rank hypocrisy and also reduces the stature of our globe-trotting peaceniks.





She, also the co-producer of recently released Netflix thriller Phir Aayi Haseen Dillruba, has found the responsibility of pleasing the fans of characters of the prequel, not just Rani and Vishu, but, more importantly, the invisible author Dinesh Pandit, doubly onerous. And if you are wondering who is Dinesh Pandit? Well, he is as much her 'alter ego' as a tribute to Hindi pulp fiction writers like Ved Prakash Sharma and Surendra Mohan Pathak. She says, "Pulp fiction writers really know the pulse of their audiences and offer you a window into real India." The beauty of 'becoming' Dinesh Pandit for her lies in, "I need not follow a structured narrative. I can defy all logic. Writing pulp is like dancing with the beast."

For someone who studied at St Stephen's College, New Delhi, and at the London School of Economics, she enjoyed reading Hindi pulp fiction writers as much as James Hadley Chase and Sidney Sheldon. She says, "I grew up in Amritsar. I may have studied at premier institutions, but I am as rooted in my soil." If her hometown figured in her career defining movie Manmarziyaan, it also cemented her creative partnership with her frequent collaborator Taapsee Pannu, for whom she has written in no less than five movies. Together, she laughs, "We call ourselves 'Sardarni & Company'. We are headstrong women who know and speak their minds. When I am writing for her, I know I can push the buttons."



Interestingly, when she writes the second draft of her films, she clearly has actors in her mind and taps into their strengths. "It's important to know which actor is playing what character so the synergy can happen." And that's why she takes pride in etching out some memorable parts for her actors, be it Sara Ali Khan in Kedarnath, Abhishek Bachchan in Manmarziyaan, Kangana Ranaut in Judgmentall Hai Kya, and Sunny Kaushal in Phir Aayi Haseen Dillruba.

She shares, "Our friends often tell us; put a camera in your house and you will have a ready sitcom." They both love to have the last word, tell stories and indeed there are many she is dying to tell. With Do Patti, starring Kajol and Kriti Sanon, she turns a full-fledged producer. Kanika's Katha Productions gives her the privilege and power to write the kind of stories that she wants to. For this beauty with brains, life is not made by chance but right choices.

"Discussed measures to further strengthen Special and Privileged Strategic Partnership. Exchanged perspectives on the Russia-Ukraine conflict and my insights from the recent visit to Ukraine," PM Modi tweeted.

Modi's visit to Ukraine, the first by an Indian Prime Minister, came six weeks after he held a bilateral meeting with Moscow. The visits by PM Modi are being viewed by experts as India's attempts to play a larger role in resolving the conflict, which has killed nearly a lakh soldiers on both sides.

Kolkata police lathi-charge, use tear gas, water cannons to stop 'Nabanna Abhijan' protestors



KOLKATA, Aug 27 (Agencies): Police on Tuesday lathi-charged, used water cannons and tear gas to disperse agitators at Howrah Bridge's Kolkata end and near Santragachhi Railway station on Kona Expressway as protestors attempted to break through police barricades in an effort to reach the state secretariat, Nabanna.

At Santragachhi, agitators threw bricks at police, injuring several officers, while protestors claimed that police action also injured several students.

The protestors were attempting to reach the state secretariat to demand the removal of West Bengal Chief Minister Mamata Baneriee over the rape-murder of a doctor at RG Kar Medical College.

Police said they began lathicharging and tear gassing after the agitators managed to breach the barricades at some locations and attacked the security personnel.

Trouble escalated when the student organisation, 'Paschim Banga Chhatra Samaj', and the dissident state government employees' platform 'Sangrami Joutha Mancha' began their 'Nabanna Abhijan' rally from various points.

Hundreds of processionists, mainly youths, participated in the 'Nabanna Abhijan' from two locations across the

The rally, organised by student platform 'Chha-

trasamaj' and 'Sangrami Joutha Mancha' of state government employees, began from two locations - College Square in north Kolkata and Santragachi in Howrah.

One processionist said, "We will reach Nabanna no matter what. We must get to the state secretariat to demand the resignation of the Chief Minister, whose administration has been trying to shield the perpetrators of this heinous crime and suppress the incident. We want to hear from her."

Chhatrasamaj spokesperson Sayan Lahiri emphasised that the rally is apolitical.

"Despite provocations, we intend to keep this a peaceful, democratic movement against the horrific crime committed against our sister at R G Kar hospital. We demand justice for her and her family. The call for justice by the people of Bengal and the country must be acknowledged by the Mamata Banerjee government," Lahiri said.

Delhi excise policy 'scam': Supreme Court grants bail to BRS leader K Kavitha

NEW DELHI, Aug 27 (Agencies): In a major relief to BRS leader K Kavitha, the Supreme Court on Tuesday ordered her to be released on bail in the corruption and money laundering cases linked to the Delhi excise policy 'scam'.

"The investigation is complete and a chargesheet has been filed. Custody of the appellant (Kavitha) is not necessary. She has been behind bars for five months. The likelihood of the trial being concluded in the near future is impossible. As said in various pronouncements of this court, undertrial custody should not turn into a punishment," a Bench led by Justice BR Gavai said, setting aside the

July 1 Delhi High Court order denying her bail. It took note of the fact that the trials in money laundering and corruption cases were unlikely to be completed soon as there were 493 witnesses to be examined and the documentary evidence ran into around 50,000 pages.

The Bench also ques-



tioned the fairness of the probe agencies — ED and CBI — for their alleged selective approach in making some accused as approvers.

"Prosecution has to be fair. A person who incriminates himself has been made a witness! Tomorrow you pick up anyone as you please? You cannot pick and choose any accused. What is this fairness?" it said.

Kavitha – who has denied all allegations – is the third prominent politician to be granted bail by the Supreme Court in the Delhi excise policy 'scam' after Aam Aadmi Party (AAP) leaders Sanjay Singh and Manish Sisodia.

On July 12, the top court had granted

interim bail to Delhi Chief Minister and AAP national convener in the money laundering case linked to the excise 'scam'. However, Kejriwal continues to be in jail following his June 26 arrest by the CBI in a corruption case linked

to the scam.

Arrested by the ED on March 15 from her Banjara Hills home in Hyderabad, the 46-yearold daughter of former Telangana chief minister K Chandrashekar Rao has been accused of being a key member of the "South Group", which allegedly paid the ruling AAP in Delhi kickbacks of Rs 100 crore in return for a big share of liquor licences in the national capital.

Subsequently, the CBI arrested her on April 11

from Tihar jail in connection with the corruption case.

The Delhi High Court had dismissed Kavitha's bail pleas in both cases, saying she was prima facie one of the main conspirators in the criminal conspiracy related to the formulation and implementation of the now-scrapped Delhi Excise Policy 2021-22.

The Bench – which also included Justice KV Viswanathan -- said Kavitha was entitled to special consideration available to a woman under the proviso to Section 45 of the Prevention of Money Laundering Act (PMLA).

The top court strongly disapproved of the Delhi High Court's remarks that an educated, sophisticated woman was not entitled to bail under the beneficial provision for women under PMLA.

"If this Delhi High Court order is allowed to become the law, these perverse observations would mean no educated woman can get bail. It would apply at least to all courts in the jurisdiction of Delhi. What is

this?! On the contrary, we say courts should not differ between an MP and common person, but here (Delhi HC is) finding an artificial discretion not there in the statute," the Bench said.

On behalf of the probe agencies, Additional Solicitor General SV Raju said Kavitha could not be extended the benefit of the proviso to Section 45 of the PMLA as she destroyed evidence by formatting her phone and that her conduct amounted to tampering with evidence.

Raju's submissions were countered by senior counsel Mukul Rohatgi on behalf of Kavitha. Rohatgi said that her iPhone was formatted since she had given it to her servant.

"Mr. Raju, a phone is such a private thing. There will be other things in it... There may be partial removal of messages in exchanging. Like I have a habit of deleting messages in school and college groups where so many things are put and it gets messed up," Justice Viswanathan said.

Man arrested for repeatedly raping neighbour, 13, beating her: Thane cops

THANE, Aug 27 (Agencies): A man has been arrested for allegedly repeatedly raping his 13-year-old neighbour and beating her up in Maharashtra's Thane district, police said on Tuesday.

The police on Monday arrested the 28-year-old accused, a resident of the New Azad Nagar locality in Bhiwandi, an official said.

The accused befriended the girl and started visiting her family frequently. When the girl's parents were away for work, he came to her house and allegedly forced her to enter into a physical relationship with him by promising to marry her, he said.



The abuse began in May, and on Monday,

when the girl refused to give in to his advances,

the accused beat her up and threatened her, the official said.

Based on a complaint lodged by the girl, a case was registered against the accused under relevant provisions of the Bharatiya Nyaya Sanhita and Protection of Children from Sexual Offences (POCSO) Act, he said.

Nursing trainee raped in Maharashtra, auto driver had spiked her drink

MUMBAI, Aug 27 (Agencies): A 19-yearold nursing trainee was raped, allegedly by an auto-rickshaw driver, in Maharashtra's Ratnagiri district. According to preliminary information, the victim had taken an auto-rickshaw ride home when the driver offered her drinking water. The water was spiked and the teenager lost consciousness. The driver then allegedly took the victim to a deserted place and sexually assaulted her.

On regaining consciousness, the victim informed her family and later registered a police complaint. An FIR has

been registered and police are scanning CCTV footage to zero in on the accused. The woman is recovering at a state-run hospital.

The incident has sparked protests in the area. Local residents blocked a road for hours last night, demanding swift action in the case.

The Ratnagiri incident comes amid nationwide outrage against crime against women in the aftermath of the horrifying rape and murder of a 31-year-old doctor in Kolkata's RG Kar Medical College and Hospital

Bharat Biotech launches Oral Cholera Vaccine after successful phase 3 trial

HYDERABAD, Aug 27 (Agencies): Bharat Biotech International Ltd on Tuesday announced the launch of Hillchol, a novel single-strain oral cholera vaccine. A press release from the vaccine maker said Hillchol (BBV131) was developed by Bharat Biotech under licence from Hilleman Laboratories (funded by Merck USA and Wellcome Trust) to combat Cholera.

Global demand for Oral Cholera Vaccines (OCVs) exceeds 100 million doses annually, making them crucial for cholera control. Globally, there is a shortage of OCVs as there is only one manufacturer.

BBIL has established large-scale manufacturing facilities in Hyderabad and Bhubaneswar with a capacity to produce up to 200 million doses of Hillchol, it further said.

A multi-stage, clinical evolution process, culminating in a Phase 3 study confirmed the vaccine safety, immunogenicity and non-inferiority to existing OCVs, establishing its potential for white spirit, and public health use.

The vaccine, a single dose respule, is administered orally on day 0 and 14 and is suitable for individuals older than one year.

2 Teen girls found hanging in UP village, family alleges murder

Akhilesh Yadav, Samajwadi Party chief, has demanded swift investigation into the incident and said such incidents create an environment of fear in the society.



LUCKNOW, Aug 27 (Agencies): Two girls, aged 15 and 18, were found hanging dead from a tree in Uttar Pradesh's Farrukhabad today. Family members have said the teenagers went to attend a Janmashtami programme last evening, but did not return. This morning, their bodies were found in a mango orchard.

Police have recovered a phone from the spot and also found a SIM card on one of the girls.

The father of one of the girls said they had gone to attend a programme at the nearly temple on the occasion of Janmashtami. "They went in the evening and returned around 9 pm because it had started raining. Later, in the night, they went again. The programme ended

around 1 am. When they did not return, we started looking for them. A child said they slept at their aunt's place. We went there, but did not find them. Many of our relatives stay there, so we thought they must have slept there and will return in the morning."

In the morning, he said, one of their acquaintances informed that someone is hanging from a tree in the orchard. "Around 6 am, we reached here and found the girls hanging. We think someone killed them and hanged them bodies," he said.

Chilling visuals showed the girls hanging dead with two dupattas tied together.

District police chief Alok Priyadarshi said the two girls were close friends. "The autopsy will reveal details about the case. We have found a phone and a SIM card. We are using them to gather information and speaking to the family members. The matter will be investigated in detail and action taken," he said.

The bodies have been sent for autopsy and a forensic team collected evidence from the spot.

Akhilesh Yadav, leader of Uttar Pradesh's main Opposition Samajwadi Party, has demanded swift investigation and said such incidents create an environment of fear in the society.

Calling the incident sensitive, Mr Yadav said in a post on X, "The BJP government should immediately conduct a fair investigation and clear the air on this suspected case of murder. Such incidents create an atmosphere of fear in the society and deeply hurt the women community."

"The time to rise above politics and treat women's safety as a serious issue has come," the Lok Sabha MP added.

Philippine defense chief says China is 'the biggest disruptor' of peace, seeks stronger censure

MANILA, Aug 27 (Agencies): The Philippine defense chief said Tuesday that China is "the biggest disruptor" of peace in Southeast Asia and called for stronger international censure over its aggression in the South China Sea, a day after China blocked Philippine vessels from delivering food to a Coast Guard ship at the Sabina Shoal

Defense Secretary Gilberto Teodoro Jr. spoke at an international military conference organized in Manila by the U.S. Indo-Pacific Command amid a spike in clashes between China and the Philippines in the disputed South China Sea and in its airspace.

China is "the biggest disruptor of international peace" in Southeast Asia, Teodoro told the conference, which was attended by military officials and senior diplomats from the U.S. and allied countries.

He later told reporters on the sidelines of the conference that international statements of concern against China's increasingly assertive actions in the disputed waters and elsewhere were "not enough."

"The antidote is a stronger collective multilateral action against China," Teodoro said, adding that diplomats and defense officials should determine those stronger steps.

Pressed by reporters to be more specific, Teodoro said a U.N. Security Council resolution condemning and ordering a stop to Chinese acts of aggression would be a strong step but acknowledged the difficulty of pursuing that. "The world is not that perfect," Teodoro said.

There was no immediate reaction from Chinese officials. China, like its geopolitical rival the U.S., is one of the five permanent members of the



U.N. Security Council and has power to veto such an adversarial step.

The Association of Southeast Asian Nations has paid "attention" to China's aggressive actions but should do much more, Teodoro said. The 10-nation Southeast Asian bloc includes the Philippines, Vietnam, Malaysia and Brunei, which have South China Sea claims that overlap with each other, as well as China's and Taiwan's

"ASEAN, to remain relevant and credible, cannot continue to ignore what China is doing in the South China Sea," Teodoro said.

In the latest incident in the South China Sea, Philippine officials said China deployed "an excessive force" of 40 ships that blocked two Philippine vessels from delivering food and other supplies to Manila's largest coast guard ship in the disputed Sabina Shoal in the latest flare-up of their territorial disputes in the busy sea passage.

China and the Philippines blamed each other for the confrontation on Monday in Sabina Shoal, an uninhabited atoll both countries claim that has become the latest flashpoint in the Spratlys, the most hotly disputed region of the sea passage that is a key global trade and security route.

China and the Philippines have separately deployed coast guard ships to Sabina in recent months on suspicion the other may act to take control of and build structures in the fishing atoll

The hostilities have particularly intensified between China and the Philippines since last year and Monday's confrontation was the sixth the two sides have reported in the high seas and in the air. The confrontations have sparked concerns of a larger conflict that could involved the United States, the longtime treaty ally of the Philippines.

Sabina is near the Second Thomas Shoal, another flashpoint where China has hampered the Philippine delivery of supplies for Filipino forces aboard a long-grounded navy ship, the BRP Sierra Madre. Last month, China and the Philippines reached an agreement to prevent increasingly hostile confrontations at the Second Thomas Shoal, allowing a Philippine vessel to deliver food supplies a week later without any hostilities.

The Philippine coast guard said Chinese coast guard and navy ships, along with 31 suspected militia vessels, illegally obstructed the delivery, which including an ice cream treat for the personnel aboard the BRP Teresa Magbanua as the Philippines marked National Heroes' Day on Monday.

The Philippine coast guard said it "remains steadfast in our commitment to uphold national interests and ensure the safety and security of our waters" and urged "the China coast guard to abide with the international law and stop deploying maritime forces that could undermine mutual respect, a universally recognized foundation for responsible and friendly relations among coast guards."

In Beijing, China's coast guard said that it took control measures against two Philippine coast guard ships that "intruded" into waters near the Sabina Shoal. It said in a statement that the Philippine ships escalated the situation by repeatedly approaching a Chinese coast guard ship. The Chinese coast guard did not say what control measures it took.

China has rapidly expanded its military and has become increasingly assertive in pursuing its territorial claims in the South China Sea, which Beijing claims virtually in its entirety. The tensions have led to more frequent confrontations, primarily with the Philippines, though the longtime territorial disputes also involve other claimants, including Vietnam, Taiwan, Malaysia and Brunei.

Japan's government also protested to Beijing on Tuesday, saying that a Chinese reconnaissance plane violated its airspace and forced it to scramble fighter jets.

Sabina Shoal lies about 140 kilometers (85 miles) west of the Philippine province of Palawan, in the internationally recognized exclusive economic zone of the Philippines.

Former Malaysian leader Muhyiddin charged with sedition for allegedly mocking former king



KUALA LUMPUR, Aug 27 (Agencies): Former Malaysian Prime Minister Muhyiddin Yassin was charged Tuesday with sedition over a speech he made that allegedly questioned the integrity of the country's previous kina.

Muhyiddin, who led Malaysia from March 2020 until August 2021, pleaded not guilty in a court in northeast Kelantan state. According to the charge sheet, Muhyiddin made the seditious remarks last month during a byelection campaign in Kelantan.

Nine ethnic Malay state rulers take turns as Malaysia's king for five-year terms under the country's rotating monarchy, which began when Malaysia gained independence from Britain in 1957. The monarchy plays a largely ceremonial role, but are revered by the nation's majority Mus-

In his speech on Aug. 14, Muhyiddin had questioned why then-King Sultan Abdullah Sultan Ahmad Shah didn't invite him to be

prime minister following a hung Parliament in November 2022. Muhyiddin had claimed he had the backing of majority lawmakers.

Muhyiddin's Islamic nationalistic bloc received stronger-thanexpected support from Malays, who account for two-thirds of Malaysia's 34 million people. Sultan Abdullah appointed then-opposition leader Anwar Ibrahim as prime minister after Anwar cobbled up support from rival parties to form a unity government.

Sultan Abdullah from central Pahang state. who ended his reign on Jan. 30 this year. didn't comment on the case. But his son issued a strong rebuke to Muhyiddin, saying his remarks were dangerous and could divide the people and undermine the royal institution.

Muhyiddin was questioned by police following complaints against him. He had denied insulting the royalty, saying his remarks were factual and that he had handed in sworn oath of support by 115 lawmakers in the 222-member parliament.

yers for Liberty, a human rights and law reform group, slammed the use of the colonial-era Sedition Act against Muhyiddin. He said questioning or criticizing the exercise of constitutional power by the king wasn't seditious.

The law, introduced by the British in 1948, criminalizes speech or actions with an undefined "seditious tendency," including that which promotes hatred against the government and monarchy or incites racial discord.

"The king is a constitutional monarch, and not a feudal ruler. His exercise of his power can thus be debated. questioned or criticized. This is the very bedrock of our system of constitutional monarchy," Zaid said. Anwar had backtracked on his pledge to repeal the Sedition Act, which has long been used to suppress dissenting voices, he added.

Muhyiddin, 77, faces

up to three years in

prison or a fine or both if found guilty. He is also still battling corruption and money-laundering charges that he claims are politically motivated. Muhyiddin was the second former leader charged with crimes after ex-Prime Minister Najib Razak, who received multiple charges after losing a 2018 general election. Najib began a 12-year prison term in 2022, with several more graft trials

underway.

Russian missiles and drones strike across Ukraine and kill at least 4 people

KYIV, Aug 27 (Agencies): Nighttime Russian drone and missile attacks struck across Ukraine, killing at least four people, President Volodymyr Zelenskyy said Tuesday, a day after a heavy barrage pounded energy facilities throughout the country.

Zelenskyy said the attacks included 81 drones, as well as cruise and ballistic missiles and that 16 people were injured. He did not say where the four deaths occurred, but two people died in a strike on a residential building in the industrial city of Kryvyi Rih, according to Oleksandr Vilkul, head of the city's military administration.

"We will undoubtedly respond to Russia for this and all other attacks. Crimes against humanity cannot go unpunished." Zelenskyy wrote on X.

In the Kyiv region, which had struggled with blackouts after Monday's onslaught, five air alerts were called during the night. The regional administration said air defenses destroyed all the drones and missiles but that falling debris set off forest fires.

After the Monday barrage across Ukraine of more than 100 missiles and a similar number of drones, Prime Minister Denys Shmyhal said "the energy infrastructure has once again become the target of Russian terrorists" and

urged Ukraine's allies to provide it with long-range weapons and permission to use them on targets inside Russia.

President Joe Biden called Monday's Russian attack on energy infrastructure "outrageous" and said he had "reprioritized U.S. air defense exports so they are sent to Ukraine first." He also said the U.S. was "surging energy equipment to Ukraine to repair its systems and strengthen the resilience of Ukraine's energy grid."

The Russian Defense Ministry said the attacks used "long-range precision air- and sea-based weapons and strike drones against critical energy infrastructure facilities that support the operation of Ukraine's military-industrial complex. All designated targets were hit."

In Russia, meanwhile, officials reported four Ukrainian missiles were shot down over the Kursk region, where Russian forces are fighting Ukrainian troops that made a surprise incursion this month.

The fighting in the region has raised concerns about the nuclear power plant there. International Atomic Energy Agency chief Rafael Grossi arrived in the Kursk region on Tuesday intending to inspect the plant, Russian news agencies reported.

Pacific Ocean rising at alarming rate: Antonio Guterres's 'SOS' warning

NUKU'ALOFA, Aug 27 (Agencies): United Nations Secretary-General Antonio Guterres voiced a global climate "SOS" at a Pacific islands summit on Tuesday, unveiling research that shows the region's seas rising much more swiftly than global averages.

"I am in Tonga to issue a global SOS -- Save Our Seas -- on rising sea levels. A worldwide catastrophe is putting this Pacific paradise in peril" he said.

Sparsely populated and with few heavy industries, the Pacific islands collectively pump out less than 0.02 percent of global emissions every year.

But this vast arc of volcanic islands and low-lying coral atolls also inhabits a tropical corridor that is rapidly threatened by encroaching oceans.

The World Meterologi-



cal Organisation has been monitoring tide gauges installed on the Pacific's famed beaches since the early 1990s.

A new report released by the top UN climate monitoring body showed seas had risen by around 15 centimetres in some parts of the Pacific in the last 30 years.

The global average was 9.4 centimetres,

according to the report. "It is increasingly evident that we are fast running out of time to turn the tide," said the forecasting agency's top official Celeste Saulo.

Some sites, particularly in Kiribati and Cook Islands, measured a rise that matched or was just under the global average.But other sites, such as the capital cities of Samoa and Fiji, were rising almost three times higher.

In low-lying Pacific nation Tuvalu, land is already so scarce that throngs of children use the tarmac at the international airport as their own makeshift playground.

Scientists have warned that, even under some moderate scenarios, Tuvalu could be almost entirely wiped off the map within the next 30 years.

"It's disaster after disaster, and we are losing the capacity to rebuild, to withstand another cyclone or another flood," Tuvalu Climate Minister Maina Talia told agency on the summit's sidelines. "For low-lying island states, it's a matter of survival for us.'

The plight of Pacific islands has been easily overlooked in the past, given their relative isolation and lack of economic might.

But the region is increasingly seen by scientists as a climate canary in the coal mine, hinting at the troubles possibly facing other parts of the planet.

"This new report con-

firms what Pacific leaders have been saying for years," Australian climate researcher Wes Morgan told agency

"Climate change is their top security threat. Pacific nations are in a fight for survival, and cutting climate pollution is key to their future."

Surrounded by millions of square miles of tropical ocean, the South Pacific is uniquely threatened by sea-level

The vast majority of people live within five kilometres of the coast, according to the United Nations.

Rising seas are swallowing up scarce land and tainting vital food and water sources.

Warmer waters are also fuelling more intense natural disasters, while ocean acidification slowly kills the reefs that nourish key marine food chains.

Dolphin bites surge at Japanese beaches, authorities warn beachgoers

TOKYO, Aug 27 (Agencies): Authorities in central Japan are urging beachgoers to steer clear of dolphins after a sharp increase in biting incidents, with one expert saying the culprit may be a single overly playful individual.

This year has so far seen 18 swimmers bitten at several beaches in the Fukui region, according to the local Tsuruga coastguard, which logged just a handful of injuries related to dolphins in each of the past two years.

Most of the bites were minor -- some were little more than scratches -- but in one recent incident. an elementary school child wound up requiring 20 to 30 stitches, coastquard official Shoichi Takeuchi told agency.

At Suishohama Beach -- also known as "Diamond Beach" -- a local tourism association is calling for vigilance, issuing warnings on its website and handing out fliers advising people not to approach or touch the animals.

"Dolphins are usually calm creatures, but they can make you bleed by biting you with sharp teeth, drag you underwater and, in the worstcase scenario, threaten your life," the association warns online.

The coastguard said it was unclear whether a single dolphin was behind the incidents or whether there were multiple culprits.

One expert, however, thinks one rogue dolphin may be responsible for the incidents, given identifying characteristics such as its dorsal fin and scars. "It is probably the work of the same individual," Tadamichi Morisaka, a professor of cetology at Mie University, told broadcaster NHK.

"Instead of trying to harm humans, it might be seeking to interact with humans the way it does with fellow dolphins.

Israeli strikes across Gaza kill 14, including children, Palestinians say ing civilians and accuses Hamas

GAZA, Aug 27 (Agencies): Palestinian officials say Israeli airstrikes across the Gaza Strip have killed at least 14 people, half of them children.

The Civil Defense, first responders who operate under the Hamasrun government, said three children and their mother were killed in an airstrike late Monday in the Tufah neighborhood of Gaza City. It said three other people were

missing after the strike. Another strike late Monday hit a building in downtown Gaza City,

killing a child, three women and a man, according to the Gaza Health Ministry.

In southern Gaza, a strike on a home early Tuesday killed five people, including a man, his three children as young as 3 years old and a woman, according to a casualty list provided by Nasser Hospital in Khan Younis, where the bodies were taken.

Palestinian health officials do not say whether those killed in Israeli strikes are civilians or fighters. Israel says it tries to avoid harm-

of putting them in danger by fighting in residential areas. But the military rarely comments on individual strikes, which often kill women and children.

Gaza's Health Ministry says Israel's offensive has killed over 40,000 people in Gaza.

The war began when Hamasled militants stormed into southern Israel on Oct. 7, killing some 1,200 people, mostly civilians, and abducting around 250 people.

The groups remain the same, with defending champion Australia clubbed alongside India, New Zealand, Pakistan and Sri Lanka.

Group B comprises South Africa, England, West Indies, Bangladesh and Scotland. Each side will play four group matches at the tournament, with the top two teams from each group progressing to the semifinals on October 17 and 18 ahead of the final in Dubai on October 20.

A reserve day has been fixed for both the semifinals and the final. If India advance, they will feature in the first semifinal

Sri Lanka and Scotland qualified for the tournament via the ICC Women's T20 World Cup Qualifier event held in Abu Dhabi earlier this year. There will be 10 warm-up matches held prior to the tournament from September 28 through to October 1.

She registered a 6-3, 6-3 win over Australian qualifier Priscilla Hon in the first round. The runner-up from last season holds a 7-0 record at the US Open in Round 1. Sabalenka will be aiming to become the first woman to win both hard-court majors in the same season since Angelique Kerber in 2016 after successfully defending her Australian Open title in January this year. Though, Sabalenka felt like she did not play her best tennis at the court and called her opponent a very tricky player.

"I think even though I didn't play my best tennis, I was fighting for every point and I was trying to use any shot that was working today. I'm happy even though I didn't feel my best on court today, I was

able to win in straight sets. Especially against someone like her.. very tricky player. She played really aggressive, great tennis today. It wasn't easy facing her in the first round," Sabalenka told the broadcasters after the win.

Sabalenka wins round

1 at US Open Sabalenka won her record 24th match on the hard court this year. Only two more players have recorded more wins on the surface, apart from Sabalenka. Emma Navarro has 26 and No. 1 seeded Iga Swiatek has 25 wins on same court this year. Sabalenka will face Italy's Lucia Bronzetti in the second round on Wednesday. The Italian player reached the next round after New Zealand's Lulu Sun was forced to retire after losing the first set 6-3.

Hon entered the contest aiming for a win in her first tour-level maindraw of the season. She

had qualified for her first Grand Slam main draw since the Australian Open 2022. The Australian looked in control but could find her way out against a confident and in-form Sabalenka. She recently won her 15th WTA Tour title last week at the Cincinnati Open.

Sabalenka's quest for US Open title Aryna Sabalenka

cruised through the opening set without facing a break point. In the second set, she secured an early break but Hon managed to convert her first break point of the match, bringing the score to 3-2. Despite this, Sabalenka remained composed. She clinched her sixth consecutive victory by breaking Hon's serve for the fourth time, with a series of clean return winners that put her ahead 4-2. Sabalenka then maintained her lead to secure her 40th win of the season, extending her winning streak to 12 consecutive sets.

The last time Aryna played a match at the US Open, she was 1 set away from winning the title. Now, she is back with a vengeance 6 consecutive wins, including 12 consecutive sets win as her trophy title hunt in New York is up and running.

J&K deserves its own national law university: Malik

JAMMU, Aug 27: Socio-Civic leader, legal advisor Muslim Rashtriya Manch (MRM) for Jammu and Kashmir and Ladakh UTs and Chairman The Social Welafre Organisation of India (TSWOOI) NGO, Adv. Malikzada Mohd Shahzad has said that the current unemployment situation in Jammu and Kashmir is alarming with many educated youth struggling to find jobs.

Meanwhile, he has observed that J&K equally deserves its own National Law University (NLU) and has demanded its early establishment.

"Given the sheer number of unemployed individuals, it is impossible for the government alone to provide employment to everyone. Instead of waiting for government jobs, young people should consider becoming entrepreneurs and start their own small business ventures," Malik

He, however added that for those with academic qualifications, especially law students, there are still opportunities and with their knowledge, they can excel in competitive exams or join various departments.

He further asserted that pursuing private practice after studying law can lead to a successful career as a top lawyer, filling a critical need in the legal field. "Twenty one states in

India have already established National Law Universities (NLUs), but J&K, despite being the 12th largest among the 28 States/ 08 UTs in terms of geographical area, institute of such repute ceases to exist here," Malik lamented.

He added that J&K has a total number of three government Universities and private law colleges which offer the law courses like L.L.B and B.A, L.L.B. "It is high time to improve legal education here in J&K. We need a National Law University to cater to the needs of the legal profession", Malik suggested.

Advocate Malik appealed the government of Union Territory of J&K to hasten up the process of recommendation to set up a National law University(NLU) here, in order to bring J&K at par with other states. He further demanded the Narendra Modi led NDA Government of the Union to accord early sanction to this much required institution in wake of the unemployment scenario of the region.
