### Earthquake of magnitude 5.7 recorded from Afghanistan; tremors felt in **Kashmir too**

SRINAGAR, Aug 29 (Agencies): An earthquake of magnitude 5.7 was recorded on Thursday, with its epicenter being Afghanistan even as the tremors were felt in Kashmir

As per the National Centre for Seismology (NCS), It had a depth of 255 Kilometers, occurring on 29/08/2024 11:26:38 IST, Lat: 36.51 N, Long:

71.12 E, Afghanistan. The tremors of this earthquake were felt over 710kms across in the valley of Kashmir.

The people in Kashmir said they felt mild vibrations which lasted for over 4-seconds.

However, no report of loss of life or property was reported till now. "Earthquake of Mag-

nitude: 5.7, Occured on: 29/08/2024 11:26:38 IST, Lat: 36.51 N, Long: 71.12 E, Depth: 255 Km, Region: Afghanistan," the NCS said.

### Light snowfall likely over higher reaches of **J&K** tonight: **MeT**

SRINAGAR, Aug 29 (Agencies): Meteorological Department on Thursday predicted fall in day temperature with possibility of light snowfall over isolated higher reaches during tonight.

"On August 29 the day temperature will likely fall with possibility of light snowfall over isolated higher reaches," the MeT officials said.

They said keeping the intermittent light to moderate rains and thundershowers in parts of J&K into account, there is a possibility of flash floods, landslides, mudslides and shooting stones over few vulnerable places in Jammu and Kashmir.

"There is a possibility of intense showers for a brief period at few places with heavy rain at isolated places during tonight/early morning," the officials said.

On August 29 the weather will likely be cloudy with light to moderate

## 3 terrorists believed to have been killed in operations along LoC in Kupwara: Army



SRINAGAR, Aug 29 (Agencies): Three terrorists are believed to have been killed in two separate anti-infiltration operations along the Line of Control (LoC) in Jammu and Kashmir's

Kupwara district, the army said on Thursday. Operations in the Machhal and Tangdhar areas were launched on Wednesday following intelligence inputs, it said.

In a post on X, the army's Srinagar-based Chinar Corps said, "Based on intelligence inputs with respect to likely infiltration bids, a joint operation was launched by the Indian Army and the Jammu and Kashmir Police on the intervening night of August 28 and 29 in the general area Machhal, Kupwara.'

### **Encounter breaks** out following search operation in Rajouri



RAJOURI/JAMMU, Aug 29 (Agencies): An encounter broke out between security forces and terrorists on the intervening night of Wednesday and Thursday in Jammu and Kashmir's Rajouri district after troops launched a cordon and search operation in response to suspected

militant movement, officials said.

"A search operation was launched by security forces in the general area of village Kheri Mohra Lathi and Danthal in Rajouri district at 2130 hours on Wednesday night (following suspected terrorist movement)," a police spokesperson

JAMMU, Aug 29 (Agencies): Over 300 additional companies of paramilitary forces will be deployed in Jammu and Kashmir ahead of the three-phase assembly elections commencing from September 18 in the union territory, officials said on Thursday.

According to the officials, Deputy Inspector General (DIG) of the Jammu-Kathua range, Shiv Kumar Sharma arrived at the Police Reception Centre (PRC) at Bari Brahmna Railway Station on Wednesday night to welcome the arriving forces.

DIG Sharma assessed the accommodation facilities for the paramilitary forces and briefed the officers on the sensitivity and importance of their duties, emphasis ing full cooperation with local police forces, the officials said.

Accompanied by senior officers, the DIG also addressed concerns raised by the security personnel, assuring them of prompt resolution, they added.

These paramilitary forces will be stationed across Jammu, Kathua and Samba districts to maintain security during the assembly elections

in the union territory.

### Tarun Chugh dares Omar, Mehbooba for 'open debate' on J&K situation post Aug 5, 2019



SRINAGAR, Aug 29 (Agencies): Senior BJP leader and party's General Secretary Tarun Chug Thursday dared Abdullah's, Mufti's and Gandhi's to have an open debate with BJP on the situation J&K witnessed post August 5, 2019.

"I am ready for an open debate with Omar Abdullah and Mehbooba Mufti and those from the Gandhi family. Let the media decide time and venue," Chug said while addressing a press conference in Jammu, as per news agency— Kashmir News Observer (KNO)

He said let Omar and Mehbooba debate with us on what has changed post abrogation of article 370. "We have the official figures on terror incidents, civilian killings, security forces' killings and stone pelting incidents before August 5, 2019 and post August 5, 2019," said Chug who was flanked by Union Minister GK Reddy, BJP MPs Jugal Kishore and Dr Jitendera Singh.

He said in 2018, 55 civilian killings took place and there were







The withdrawal was surprising on three counts. One, lateral induction had been resorted to in the past, including by this government without getting mired in debilitating controversies. Second, as the Opposition fired its precision-guided 'reservation' missile, some ministers launched a counterattack, not aware of the swift, embarrassing retreat being planned. Third, a government known to be tough buckled under a smoking gun. The irony was that ministers who should have known better were brandishing their swords even as the retreat was being sounded.

Before coming to the issues involved in the non-political endeavour of lateral recruitment, one cannot help but pity the language of the 'instrument of surrender', which could have been a straightforward official communication instead of a demi-official letter from the minister giving the impression that his ministry made a mistake, which the Prime Minister (who is in charge of the ministry) stepped in to correct. He even traduced the Opposition for overlooking the principle of 'social justice' it advocated while making lateral recruitment when in power.

Much has been written about previous governments inducting experts from the market into the bureaucratic system, the recommendations of the Administrative Reform Commission and the Group of Secretaries, the examination of

the proposal by the Department of Personnel from various angles, and the peaceful induction earlier. This was not the first attempt by the government, and hopefully it will not be the last, to draft outside talent to shore up its skill set.

It would be unfair to endorse lateral entry or dismiss it without understanding the context and the motivation for such a move. Let us look at some fundamental issues.

The Government of India (GOI) runs the affairs of the Central Government and other national-level bodies by recruiting officers to services such as income tax, Railways and Posts through the Union Public Service Commission (UPSC), following the reservation policy. It also takes on deputation All India Services (AIS) officers borne on state cadres recruited through the same process. The GOI has no cadre of AIS officers; the states maintain a deputation reserve as part of their sanctioned cadre strength. The GOI draws upon this reserve to fill positions at different levels in the ministries and other apex organisations through an empanelment process for joint secretaries and above.

Many GOI ministries have their specialised services to deal with their allotted subjects, as in the case of agriculture, commerce, civil and cost accounts, etc. In addition, the government has fruitfully drawn upon the expertise of outside talent occasionally without being bound by its reservation policy. While earlier governments selected eminent experts through an informal system, this government tried to institutionalise the selection through the UPSC. Also, there has never been an attempt at such large-scale lateral induction.

It would be interesting to understand how effectively is the expertise of the existing specialised cadres utilised by the government, especially when professional advice conflicts with short-term objectives of the government or the political interests of the ruling party.

If the government wishes a sprinkling of external experts in the bureaucratic system and treat it as quasi deputation, it must identify ministries needing such 'market borrowing' and simultaneously rationalise and redraw existing cadres. Further, it should be clear whether such induction is routine recruitment or contextual. In case it is contextual and need-based, experts could be hired as consultants who can give their opinion and make recommendations freely without being burdened with bureaucratic decision-making. It is one thing to give a professional view and quite another to be responsible for navigating through the system, especially if one is unfamiliar with the ropes and the eddies. Of course, being in the system, their advice could be either tempered or hindered by practical considerations. It would be useful to evaluate the contribution of the lateral entrants thus far in injecting 'fresh' ideas and approaches they were expected to bring and to assess whether the system utilised their expertise when it countered political judgment or allowed it to dissipate in the bureaucratic sea without making waves. Even if useful, sadly they have to leave after their contract or deputation ends.

The Indian Administrative Service is accused of being a 'generalist' service lacking in specialised knowledge of any discipline, a concern oft-repeated without any serious attempt at reforming its character. In 2004, I had written to the then Cabinet Secretary, suggesting that the existing system of empanelment be revamped. The proposed

system envisaged the departments of GOI divided into broad sectoral groups such as rural development, economic administration, social services and energy. AIS officers can be asked to opt for two or three sectors after completing 16 years of service, which entitles them to be considered as joint secretaries. Based on an examination, the UPSC can determine the suitability of the officers to be allocated to a specialised sector cadre. Selected officers can then serve the GOI in the area they have qualified for till retirement, acquiring experience in a special area of governance. Those officers that do not opt for serving the Centre continue to work in their original cadres. This system will not create a separate class of 'empanelled' officers serving the Centre for a limited period and returning to their cadres for 'cooling off'. It will also remove allegations of subjectivity in the current empanelment process and hopefully identify officers with special aptitude and governance experience.

It is at this stage of creating sectoral streams of officers that the government could consider inducting lateral entrants, depending on the shortfall of selected officers, the special needs of a ministry or for a unique priority area for the government.

To my mind, the government should keep a window for lateral entry and open it selectively for delivering a certain project or handling a specific assignment. However, a door for lateral entrants should remain open as part of building specialist cadres, as suggested above. Otherwise, the survival of outsiders in the inhospitable terrain of the civil services could be as difficult as for the cheetahs to roam free in the unfamiliar environs of Kuno National Park.

## 50 years of India's steady outperformance

T may not have seemed so at the time, but 50 years **▲**ago India reached a turning point. There was an economic crisis and political turmoil. The decisive action a year later was the imposition of Emergency rule by Indira Gandhi. But that was overturned in less than two years. What proved more longlasting was something barely noticed at the time: A new direction in economic policy, away from Mrs Gandhi's overtly Leftist phase. There followed in due course an end to India's longterm under-performance as an economy, and over time the birth of a new 'India story'.

International mention of India is now more likely to refer to it as a rising power rather than as a country of poor people.

Until the mid-1970s, India had been growing more slowly than the world economy. The transition in the second half of the 1970s followed some 15 years of crises in the form of wars, failed harvests and even famine, a traumatic rupee devaluation and two oil shocks. Many of these events had contributed to a loss of national self-belief after the early optimism under Jawaharlal Nehru.

But once the economy stabilised, what followed was a half century of steady outperformance. Growth outpaced both low-income and middle-income countries, as well as the world economy. The country consequently has an international heft today that it never enjoyed before. Yet, it has not been a 'shining' record, because of continuing poor socioeconomic metrics and rising inequality.

Prior to the transition, India's share of the global economy had been on the decline — from 2.7 per cent in 1960 to 1.9 per cent in 1975 before the decline slowed, stabilised and eventually improved. Even in 2013, India's share of the world GDP was slightly smaller than in 1960. Now, in 2024, it is 3.5 per cent of the global GDP. And since the economy is growing at twice the global average, India is the third-largest contributor to global growth.

Per capita income similarly improved. From 8.4 per cent of the global average in 1960, India's per capita income dipped to 6.4 per cent in 1974. The numbers improved to 13.5 per cent in 2011, and further to 18.1 per cent in 2023. That is a near-trebling over five decades. Yet people in most countries enjoy a much better standard of living. Indeed, there are hardly any countries outside of Africa and in India's own South Asian neighbourhood where per capita incomes are lower. A long road lies ahead.

What transforms the India story is the size of its population. Per capita income is modest, but when multiplied 1,400 million times it makes the Indian economy the fifth largest. Already, India is the second-largest market for mobile phones and motorcycles/scooters, and the third- or fourth-largest for aviation and cars. Growth in these product and service markets has been underpinned by a burgeoning middle class. Businesses catering to it have generated great wealth for investors, leading to the rise of dollar-billionaires (at 200, the world's thirdlargest tally), while the stock market ranks fourth by market capitalisation.

Ûp to the mid-1970s, close to half the population lived below a bare-bones poverty line. Today, less than 10 per cent of the people are officially poor. International mention of India is now more likely to refer to it as a rising power rather than as a country of poor people. Yet, India continues to feature as only a 'medium development' country in its human development, while countries like Vietnam have attained 'high development' status. India is unlikely to make it to the 'high development' category for another decade or more - beyond which lies the 'very high development' category comprising the developed economies, to which the country aspires.

Even here, though, the numbers are improving. The mean years of schooling have improved from 4.4 years in 2010 to 6.57 years now. India also has more than the WHO-prescribed ratio of a doctor per 1,000 population, and life expectancy has finally crossed the 70 threshold.

Higher incomes find reflection in a more varied and richer diet. Milk consumption has multiplied 10-fold. So has fish consumption, while the consumption of eggs has increased more than 20-fold. Add to this the rapid growth of horticulture — fruits and vegetables. Meanwhile, household savings as a share of the income have gone up 70 per cent, even as average incomes have multiplied six-fold in real terms.

More important than all these may be a change in mindset. India in the mid-1970s was still committed to socialist rhetoric.

Apart from large-scale nationalisation of several industries, there was also price and production control on everything, from paper to steel, and sugar to cement, even bathing soaps and cars! The inevitable result was shortages and black markets. State governments routinely sided with trade unions in industrial disputes. But things have changed. Indian politics is now more populist than socialist, the Communist parties are in the ICU, and governments want to change labour laws to facilitate business. Tax rates have become reasonable.

Indians have become enthusiastic share-market capitalists. In 1974, the biggest public issue of shares totalled all of

Rs 12 crore (about Rs 350 crore in today's money). In comparison, in the last couple of years, several companies have done public issues of Rs 15,000-21,000 crore (LIC, Adani, Vodafone, etc). As recently as a decade ago, mutual fund companies managed sums equal to less than an eighth of bank deposits; that share has doubled to more than a quarter. The next five years could see India add more to its GDP, in absolute numbers, than it has done in the last 10.

And yet, there is no story in India without a counter-story. The production of consumer durables has not increased at all compared to seven years earlier, and has gone up by an annual average of just 2.8 per cent for non-durables. Clearly, consumers are financially stressed, especially in the lower rungs of the income ladder — probably reflecting the lack of enough work on good wages. Only when that changes will the economy be able to get to the 7-plus per cent rate that once marked out the truly high-growth economies.

An FIR under IPC 376 (rape) was registered against the actor at Maradu police station in Kochi city on Wednesday night, a police officer said.

The case was registered under the IPC as the offence allegedly occurred before the new Bharatiya Nyay Sanhita came to force, he said.

This is the third FIR against a high profile

Malayalam film personality following allegations of sexual harassment against various directors and actors in the wake of revelations

in the Justice K Hema

Committee report.

On Wednesday, Thiruvananthapuram museum police had booked actor Sidhique for allegedly raping an actress in a hotel eight years ago.

The first case, under IPC Section 354 (assault or criminal force on woman with intent to outrage her modesty), was against director Ranjith on a complaint by a female actor from West Bengal regard-

ing an incident which occurred in 2009.

She had alleged that the director had touched her inappropriately with sexual intent after inviting her to act in the movie Paleri Manikyam. Following the allegation by the actor, Ranjith had resigned from his post as chairman of the state-run Kerala Chalachitra Academy.

Sidhique had also resigned as general secretary of the Association of Malayalam Movie Artists (AMMA) following the allegations against him.

The Justice Hema Committee was constituted by the Kerala government after the 2017 actress assault case and its report revealed instances of harassment and exploitation of women in the Malayalam cinema industry.

Amidst allegations of sexual harassment and exploitation cropping up against several actors and directors, the state government on August 25 announced the establishment of a seven-member special investigation team to probe them.

Subsequently, more complaints surfaced.

### Al Pacino credits his success to his mother who died from overdose

Hollywood superstar Al Pacino has given the credit for his Oscarwinning success to his troubled mother.

His mother died from an overdose when he was 22. He also revealed that his mother didn't want him to act, reports 'Mirror.co.uk'.

The 'Godfather' star, 84, was brought up by Rose and his grand-parents in The Bronx after his mom and dad divorced when he was two.

The actor said that she inadvertently shaped his career by taking him to the movies.

As per 'Mirror.co.uk', the actor recalled a suicide attempt by Rose when he was six and later her death from an overdose in 1962, in an excerpt from his new book 'Sonny Boy: A Memoir' published in The New Yorker this week.

The star also says he lost friends to drugs. Rose also saved him from a life of crime growing up in New York. He titled the book after the nickname his mom gave him, which came from the popular song by Al Jolson.

Al Pacino, whose other acclaimed movies include 'Scarface' and 'Dog Day Afternoon',



wrote, "My mother was a beautiful woman but she was emotionally fragile. She would occasionally visit a psychiatrist when Grandad had the money to pay. I wasn't aware that my mother was having problems until one day when I was six years old and getting ready to go out and play".

"I was sitting in a chair in the kitchen while my mother laced up my shoes and put a sweater on me, and I noticed that she was crying. I wondered what the matter was but I didn't know

how to ask. She was kissing me all over and right before I left she gave me a great big hug", he added.

He described how, from an early age, she would take him to the cinema and he began to run the characters' lines through his head. However, they eventually clashed over his desire to become an actor and he left home after dropping out of classes in favour of acting. He attended the High School of Performing Arts after getting in via an audition.

## **Chasing Godot**

With Hollywood star Keanu Reeves making his Broadway debut with Samuel Beckett's famous play Waiting for Godot, we look into why the charm of this play refuses to die

There are a few classics whose lure refuses to die and Samuel Beckett's Waiting for Godot is surely a part of that club! Premiered during the early 1950s, Godot is still going strong. So much so that Neo of Matrix, Keanu Reeves (or if you know him as John Wick) is going to make his Broadway debut in the fall of 2025 with the play. Getting into the shoes of Estragon, joining him will be his Bill & Ted co-star Alex Winter as Vladimir. The show will be directed by Jamie Lloyd, who has to his credit Romeo & Juliet and Sunset Blvd, among others.

Just like the West cannot have enough of Godot, closer home eminent theatre director Kewal Dhaliwal too is working on his next production — an adaptation of Beckett's famous play. "We have adapted Waiting for Godot into the setting of Punjab and titled it Intezar Hai," shares Dhaliwal. "It's not a translation but adaptation," he clarifies. The play, which has been one of the most successful ever, has been staged in different languages and different contexts, but is still relevant. "We wanted to do something that speaks about farmers' plight in Punjab. What better than Godot? The play opened right after the Second World War ended, when humanity had lost its meaning, especially after the bombing of Hiroshima and Nagasaki. "Isn't Punjab of today in a similar



listless state? Isn't the farmer eternally waiting for someone to turn up? What political party or government will value life is what we address in Intezar Hai," shares Dhaliwal. It bothers the theatre director that today we are in completely oblivious of social issues. "One doesn't think beyond their palatial house or big car. Punjab especially is in an absurd state and so we thought of doing this play," adds Dhaliwal.

Interestingly, during the early 2000s, another theatre veteran, MK Raina, did the same play in Kashmiri. "Do you know that this play, which has stood the test of time, was completely rejected by the French elite at its opening? Beckett then did it in a prison and there the 'hope in hopelessness' strand clicked with the prisoners. Since then, the

play hasn't looked back," shares Raina, speaking to us from Kolkata, where he is curating a special programme to celebrate the birth centenary of Habib Tanvir. He talks about his production of Godot. "Those were the most bizarre times, the state in social and political upheaval. When we did the play, the audience was moved to tears. I realised how people in that turmoil may not be able to articulate what they were going through but sure related to this drama of the absurd." For him, the play stands for God to arrive... who never does!

"For me, it's a play of hope and existence, of self-realisation and spirituality," shares Navdeep Kaur, chairperson, Department of Indian Theatre, Panjab University. Just like Vladimir and Estragon are waiting near the tree, Kaur believes we are still

waiting. "Even seven decades on, do we have answers to life and our existence? Yes, we have built homes that probably are the safe spaces where we hope to know what the ultimate journey of human life is. But we are as clueless as those two characters in the play." She mentions Covid times and how humanity clung on to hope. "Just like we passed those dark times, humanity will probably pass other tough times, but the eternal wait for answers remains... the wait is still on for Godot."

For theatre director Umesh Kant, the play stands for desire, hope and frustration. "I am so glad that the finest to come out of the theatre of the absurd is getting a Broadway outing," shares Kant, admitting plainly, "I have wished many times, but never dared to do Godot. To make theatre of the absurd accessible to common people, the director must have a crystal clear vision."

For Kant, the play is been more relevant today than ever before. "Aren't we all still waiting for things to fall in the right place? The wait, the hope and hopelessness is as relevant today as it was during the 50s, when this gem of a play was written," says the director, who is working on his next production, a Hindi adaptation of Agatha Christie's The Mousetrap.

## "Idea is to create safe, appealing environment": CJI Chandrachud after inaugurating creche **In Supreme Court**

NEW DELHI, Aug 29 (Agencies): The Chief Justice of India. DY Chandrachud on Thursday inaugurated a creche in the Supreme Court and said that it has a play area, feeding area, sleeping area and a dining area for the young children that will encourage more women lawyers to participate in the legal profession.

CJI Chandrachud said, "We have a large number of young lawyers who come here every day to work. We have a staff of almost 2500 members. The earlier creche was about 198m2. This creche is 450 m2. It can accommodate about 100 children of lawyers and the staff. The idea is to create a safe, very appealing environment."

"We have a play area, feeding area, sleeping area and a dining area for the young chil-



dren. This is to encourage more women lawyers to participate in the legal profession without any uncertainty about the safety of their children," he added.

The CJI further said that other organizations should take the cue from this as it will encourage more women enrolment.

"I hope other organizations

take the cue from us and create these facilities because this is a way we can encourage more women to come into the workplace and create safe working conditions for the children," he

After inaugurating the creche, when the CJI sat on the bench to hear the cases, he said, "So sorry we were all late. But we dedicated the new creche to benefit the young men and women lawyers. Earlier creche was about 200 sqm for 30 children but now it's close to 400 sqm for nearly 100 kids."

The Chief Justice of India also inaugurated a branch of the Bank of Maharashtra in the Supreme Court earlier today. The President of the Supreme Court Bar Association, Kapil Sibal also accompanied the CJI.

### Mamata Banerjee clarifies 'snake' remark, says it was aimed at BJP, not students



KOLKATA, Aug 29 (Agencies): West Bengal Chief Minister Mamata Banerjee, who was in the eye of the storm over her remarks at the Trinamool Congress rally, on Thursday clarified that she was not against medical students or their movements but referring to a popular parable by Hindu mystic Ramakrishna Paramahamsa on a "snake that refused to hiss".

As per the parable, a monk advised a snake "not to bite anybody but surely hiss when attacked," meaning that "while not harming is the principle, protesting against injustice is right."

On Wednesday, while addressing an event to mark the foundation day of Trinamool Congress' students' wing, the Chief Minister referred to the parable reportedly to energise the activists of the student wings to oppose "propaganda" against her government on the issue of the rape and murder of a junior doctor of state-run R.G. Kar Medical College & Hospital in Kolkata earlier this month. Soon after she made

the statement, scathing criticisms flooded both from the opposition parties as well as from different walks of society claiming the Chief Minister was "instigating" her party followers to adopt the "path of revenge" to silence the voices of protest against the rape and murder.

The Chief Minister said that her "hiss" remark was not aimed at silencing the protests by the medical fraternity or students but to counter the "negative politics" of the BJP and the Union government against the state government.

"Let me most emphatically clarify that I have not uttered a single word against the (medical etc) students or their movements. I support their movement. Their movement is genuine. I never threatened them, as some people are accusing me of doing. This allegation is completely false. I have spoken against the BJP. I have spoken against them because, with the support of the Government of India, they are threatening the democracy in our State and trying to create anarchy. With support from the Centre, they are trying to create lawlessness and I have raised my voice against them," read the statement from the Chief Minister posted on social media platform X.

She said that the phrase 'Phonsh Kora' (hissing), which she referred to, is a quote from Ramakrishna Paramahansa.

"The legendary saint had said that occasionally there is a need to raise one's voice. When there are crimes and criminal offences, a voice of protest has to be raised. My speech on that point was a direct allusion to the great Ramakrishnite saying, her post read.

### Mallikarjun Kharge slams Modi government over issue of women's safety

NEW DELHI, Aug 29 (Agencies): Congress president Mallikarjun Kharge on Thursday hit out at the Centre over women's safety, saying Prime Minister Narendra Modi has talked about the issue many times in his speeches from the Red Fort but his government has not done anything concrete that could prevent crimes against women.

Kharge asserted that crimes against women are a serious issue and preventing these crimes is a big challenge for the country.

"We all have to unite and find solutions to this by taking along every section of the society,"

the Congress chief said in a post in Hindi on X.

His remarks come amid uproar against the backdrop of the nationwide outcry over the rape and murder of a trainee doctor at the RG Kar Medical College and Hospital in Kolkata and also cases of rape of girls in other parts of the country.

Every hour 43 crimes against women are recorded in the country. Every day 22 crimes are registered against women and children of the most vulnerable Dalit-tribal class of our country.

Countless crimes are not even registered out of fear, intimidation, social reasons." the Congress chief said.

"Are we able to take preventive measures? Has our criminal justice system improved? Are the exploited and deprived sections of society now able to live in a safe environment?" he said.

Will painting "Beti Bachao" on every wall bring about social change or make governments' law and order competent.

Has the government and administration not tried to hide a crime. Has the police stopped forcibly cremating the victims so that the truth does not come out, the Congress chief further

### Delhi High Court extends till September 5 interim protection from arrest to IAS probationer Puja Khedkar

NEW DELHI, Aug 29 (Agencies): The Delhi High Court on Thursday extended till September 5 the interim protection from arrest granted to former IAS probationer Puja Khedkar, who has been accused of cheating and wrongly availing OBC and disability quota benefits.

Justice Subramonium Prasad deferred hearing on the anticipatory bail plea by Khedkar till then and granted liberty to the police to file a fresh status report in the meantime.

Both UPSC and the Delhi Police have sought dismissal of her plea for pre-arrest bail.

In a rejoinder filed to the stand of the authorities, Khedkar has denied the allegations levelled against her and asserted that she has neither misrepresented nor cheated in the process of successfully clearing Civil Services Examination 2022.

She also said UPSC has no power to disqualify her candidature.

"(Her) selection (was) on the basis of merit in the category of Persons with Benchmark Disability (PwBD) and has attempted fifth time



under the category whereas the available attempts are nine in the said category.

The attempts given prior to this from 2012 to 2017 was not under this category and cannot

### **Assam Assembly passes Bill to abolish** Muslim marriages, divorce Act

GUWAHATI, Aug 29 (Agencies): The Assam Assembly on Thursday passed a Bill to repeal a law to register marriages and divorces of Muslims.

Revenue and Disaster Management Minister Jogen Mohan had on August 22 tabled The Assam Repealing Bill, 2024, in the Assembly to abolish The Assam Mosiem Marriages and Divorces Registration Act, 1935, and the Assam Repealing Ordinance, 2024.

Taking part in the discussion, Chief Minister Himanta Biswa Sarma said: "Our aim is not only to abolish child marriages ... also to get away with the Kazi system. We want to bring registration of Muslim marriages and divorces under the government system."

He said that registration of all marriages has to be done as per a Supreme Court order, but the state cannot support a private body like that of Kazis for this

ment of Object and Reasons of the Repealing Bill said, "There remains a scope of registering marriages of intended person below 21 years (in case of male) and 18 years (in case of female).'

It hardly had any provisions for monitoring the implementation of the Act throughout the state and it attracted huge amounts of litigation in the court, he added.

"There is a scope of misuse by both authorised licensee (Muslim marriage Registrars) as well as by citizens for underage/minor marriages and forcefully arranged marriages without the consent of the parties," Mohan said.

Besides, the registration of marriages and divorces were not mandatory, and the registration mechanism was informal that left a lot of scope for non-compliance of the norms, he added

"It is a pre-independence Act adopted by British India government for the then Province of Assam for Muslim religious and social arrangements," the minister said.

The Assam Government on Tuesday introduced The Assam Compulsory Registration of Muslim Marriage and Divorce Bill, 2024.

Last month, the Cabi net had approved the Repealing Bill to abolish The Assam Moslem Marriages and Divorces Registration Act and Rules of 1935, which permitted underage marriages under specific conditions.

The Assam Cabinet had approved the decision to repeal the Act on February 23, in a bid to end the social menace of child marriage in the state.

The Opposition parties had decried the decision, terming it "discriminatory against the Muslims" brought in to polarise the voters in an election year.

### Two held, five booked for raping, trafficking Bangladeshi woman for sex racket

THANE, Aug 29 (Agencies): The Navi Mumbai police have arrested two persons and registered a case against five others for allegedly raping and trafficking a 24-year-old woman from Khulna district in Bangladesh and selling her for Rs 2 lakh for flesh trade, an official said on Thursday.

The arrested duo, including a woman, was identified as Amir Azam (27) and Shaifali Jahangir Mulla (34), both from

Nerul.

"Some agents tricked the victim into coming to India on the promise of a job.

After she arrived in India, a man allegedly raped her.

Later, some other accused took her to a lodge on Grant road in Mumbai and handed her over to those operating a sex racket," assistant inspector Nilesh Phule of Nerul police station said.

"The agents later took

the victim and sold her to two other accused for Rs 2 lakh. She was again forced to become part of a sex racket," he added.

The case against

them was registered under the Bharatiya Nyaya Sanhita (BNS) on charges of rape, human trafficking of person, voluntarily causing hurt, common intention, the Immoral Traffic (Prevention) Act, the Passport (Entry into India) Act

and the Foreigners Act.

The criminal complaint was filed against Tharoor in the trial court by Babbar, who had claimed that his religious sentiments were hurt by the Congress leader's statement.

In October 2018, Tharoor had claimed that an unnamed RSS leader had compared Prime Minister Modi to "a scorpion sitting on a Shivling". He termed it an "extraordinarily striking metaphor".

Tharoor was granted bail in the case in June 2019 by the trial court.

The complainant had said, "I am a devotee of Lord Shiva... However, the accused

(Tharoor) completely disregarded the sentiments of crores of Shiva devotees, (and) made the statement which hurt the sentiments of all Lord Shiva devotees, both in India and outside the country.'

The complaint was filed under sections 499 (defamation) and 500 (punishment for defamation) of the Indian Penal Code (IPC).

## **Typhoon Shanshan lashes Japan with torrential** rain, strong winds causing 3 deaths

The typhoon made landfall in the morning on the southern island of Kyushu and about 60 cm of rainfall had fallen in parts of Miyazaki prefecture

TOKYO, Aug 29 (Agencies): A typhoon lashed southern Japan with torrential rain and strong winds Thursday, causing at least three deaths as it started a crawl up the length of the archipelago and raised concerns of flooding, landslides and extensive damage.

Typhoon Shanshan made landfall in the morning on the southern island of Kyushu and about 60 cm of rainfall had fallen in parts of Miyazaki prefecture, Japan Meteorological Agency (JMA) said. That 24-hour total was more than the August rainfall average and swollen rivers were threatening floods, it

The typhoon was forecast to bring strong winds, high waves and significant rainfall to most of the country, particularly the southern prefectures of Kyushu. Around midday, Shanshan was moving north



at 15 kph and its winds had weakened to 126 kph, JMA said.

More than a dozen people were injured in Miyazaki, many of them thrown to the ground. One each was also injured nearby Kumamoto and Kagoshima prefectures on their way to shelters, Fire and Disaster Management Agency (FDMA) said.

Nearly a quarter million households were without power across Kyushu, most of them in the Kagoshima precture, Kyushu Electric Power Co. said.

Ahead of the typhoon's arrival, heavy rain caused a landslide that buried a house in the central city of Gamagori, killing three residents and injuring two others, according to the city's disaster management department. On the southern island of Amami, where the typhoon passed, one

person was injured by being knocked down by a wind gust while riding

a motorcycle, FDMA

Weather and government officials are concerned about extensive damage as the typhoon slowly sweeps up the Japanese archipelago over the next few days, threatening floods and landslides. The typhoon's impact was yet to be felt in the Tokyo region, where business

was as usual and heavy rain was predicted later this week.

Disaster Management Minister Yoshifumi Matsumura said the typhoon could cause "unprecedented" levels of violent winds, high waves, storm surges and heavy rain. At a task force meeting Wednesday, he urged people, especially older adults, not to hesitate and to take shelter whenever there is any safety concern.

Hundreds of domestic flights connecting south-western cities and islands were cancelled Thursday, and bullet trains and some local train services were suspended. Similar steps were taken Thursday in parts of the main island of Honshu that were experiencing heavy rain. Postal and delivery services have been also suspended in the Kyushu region, and supermarkets and other stores planned to close.

### Ex-Bangladesh Speaker, former Commerce Minister arrested in murder case



DHAKA, Aug 29 (Agencies): Former Bangladesh Speaker Shirin Sharmin Chaudhury and ex-Commerce Minister Tipu Munshi have been arrested for the killing of a goldsmith during the recent quota reform protests that led to the ouster of the Sheikh Hasina-led government, media reports said on Thursday.

Munshi, 74, was arrested by the Rapid Action Battalion in Gulshan, Dhaka, on Wednesday night in the murder case filed in Rangpur, the Dhaka Tribune newspaper reported.

The case was filed against 17 people, including Munshi and former speaker of Parliament Chaudhury, for the killing of Muslim Uddin Milon, a 38-year-old goldsmith.

Besides, many unnamed people were accused in the case.

Chaudhury, 46, served as the first female Speaker of the Bangladesh Jatiya Sangsad from April 2013 until August 2024.

Milon was shot dead on July 19 in

Munshi had also been hiding since August 5, according to the leading Bengali-language newspaper Prothom Alo.

He became the Commerce Minister during the third consecutive term of Awami League government led by Hasina, according to the report.

Hasina, who fled to India on August 5, is facing at least 75 cases, including murder charges, against her.

### EU's top diplomat ramps up pressure on Ukraine's backers to permit strikes on targets inside Russia

BRUSSELS, Aug 29 (Agencies): The European Union's top diplomat on Thursday ramped up pressure on Ukraine's international backers to lift restrictions on the use of weapons they provide the conflict-ravaged country to allow its armed forces to strike targets inside Russia.

The U.S. restricts the use of long-range ballistic missiles it provides to Ukraine and some EU members also limit the use of their weapons. Ukraine is desperate to target airfields and other military installations inside Russia that are used to stage attacks on its armed forces and civilians.

"We need to lift restrictions on the use of weaponry against Russian military targets, in accordance with international law." EU foreign policy chief Josep Borrell said as the bloc's foreign ministers gathered in Brussels to discuss Russia's invasion of Ukraine.

HONG KONG, Aug 29 (Agencies): A Hong Kong court convicted

two former editors of a shuttered news outlet on Thursday, in a sedition case that is widely seen as a barometer for the future of media freedom in the city once hailed as a bastion of free press in Asia. Stand News former

editor-in-chief Chung Pui-kuen and former acting editor-in-chief Patrick Lam were arrested in December 2021. They pleaded not guilty to the charge of conspiracy to publish and reproduce seditious publications. Their sedition trial was Hong Kong's first involving media since the former British colony returned to Chinese rule in 1997.

Stand News was one of the city's last media outlets that openly criticized the government amid a crackdown on dissent that followed massive pro-democracy protests in 2019.

The offense is punishable by up to two years in prison and a fine of 5,000 Hong Kong dollars (about \$640) under a colonial-era sedition law. Judge Kwok Waikin is not expected to hand down a sentence on the same day.



Best Pencil (Hong Kong) Ltd., the outlet's holding company, was convicted on the same charge. It had no representatives during the trial, which began in October 2022.

Chung appeared calm after the verdict was handed down, while Lam did not appear in court.

Stand News was shut down just months after the pro-democracy Apple Daily newspaper, whose jailed founder Jimmy Lai is fighting collusion charges under a sweeping national secu-

rity law enacted in 2020. Chung and Lam were charged under a colonial-era sedition law that has been used increasingly to crush dissidents. If convicted, they face up to two years in prison and a fine of

5,000 Hong Kong dollars (about \$640) for a first offense.

Dozens of residents and reporters lined up in the morning to secure a seat for the hearing, which was schedueld for 2:30 p.m. and began an hour late.

The delivery of the verdict was delayed several times for reasons including awaiting the appeal outcome of another landmark sedition case.

Resident Kevin Ng, who was among the first in the line, said he used to be a reader of Stand News and has been following the trial, Ng. 28. said he read less news after its shutdown, feeling the city has lost some critical voices. He said if the editors were found guilty, he would have "complex feelings."

"They reported the truth, they defended press freedom," said the man who works in risk management industry.

Their case is centered on 17 articles. That included stories featuring pro-democracy exlawmakers Nathan Law and Ted Hui, who are among a group of overseas-based activists targeted by Hong Kong police bounties; interviews with three participants in a primary election organized by the pro-democracy camp in 2020; and commentaries by Law and veteran journalists Allan Au and Chan Pui-man. Chan is also Chung's wife.

Prosecutors accused some of the articles of helping promote "illegal ideologies," as well as smearing the security law and law enforcement officers. They described Stand News as a political platform as well as an online news outlet.

Chung previously denied that Stand News was a political platform. and emphasized the importance of freedom of speech during the trial.

"Freedom of speech should not be restricted on the grounds of eradicating dangerous ideas, but rather it should be used to eradicate dangerous ideas," he said.

Stand News shut down in December 2021, following a high-profile police raid at its office and the arrests. Armed with a warrant to seize relevant journalistic materials, more than 200 officers participated in the operation.

Days after Stand News shut down, independent news outlet Citizen News also announced it would cease operations, citing the deteriorating media environment and the potential risks to its staff.

Hong Kong was ranked 135 out of 180 territories in Reporters Without Borders' latest World Press Freedom Index, down from 80 in 2021. Self-censorship has also become more prominent during the political crackdown on dissent. In March, the city government enacted another new security law that many journalists worried it could further curtail press freedom.

The Hong Kong government insists the city still enjoys press freedom, as guaranteed by its mini-constitution.

# APSCC apprehends many of Sikh voters may have been excluded from voter list in Kashmir Valley

SRINAGAR, Aug 29: The All Parties Sikh Coordination Committee (APSCC) has apprehended that many of the young Sikh voters may have been excluded from the voter list in Kashmir Valley as the census carried out in 2011 was not done in an organized manner. The Committee has also expressed concern over the scattering of Sikh voters saying that the sole aim of this exercise was to ensure that Sikhs did not put up a united front.

These concerns were raised by a delegation of APSCC during their meeting with the officials of the Chief Electoral Officer, Jammu & Kashmir. The delegation was led by APSCC Chairman, Jagmohan Singh Raina. The committee had planned to raise these issues with the team of Election Commission of India that visited Jammu & Kashmir some weeks back. As the committee could not meet the Election Commission of India due to the paucity of time of the later the poll body had directed Chief Electoral Officer of Jammu & Kashmir to get in touch with them and listen to their point of view.

Following this a delegation of APSCC met the higher-ups of Chief Electoral office here today.

In a statement APSCC

Chairman Jagmohan Singh Raina said that the committee had proposed to the government to take a team of the Sikh community while carrying out the census in Kashmir Valley in 2011. He said that since majority of the Sikh families had left villages and settled in city areas like Mehjoor Nagar, Aloochi Bagh, Jawahar Nagar and others it was necessary that community members were to be taken along while the census was carried out.

"We apprehend that many of the young Sikh voters may not vote in the coming assembly elections since their names might be missing in the voter list. This would lead to disenfranchise of the community and the consequences will be not less than a disaster," said

Raina.

The APSCC Chairman said that delimitation of the assembly constituencies has been done in such a manner that the voters of a particular assembly segment have been divided into two or three assembly segments. He said that Sikhs are no exception in this regard and as such community members have been divided and there is no unity.

"The government has accommodated each and every section of the society when it comes to giving the reservation but Sikhs have been left out. There is clear discrimination of the community as a whole and it does not augur well for the country's democracy," said Raina.

The APSCC Chairman said that the matters could have been resolved had the Election Commission of India taken some time out and met the committee members. He said that the other issues pertaining to the community have been put to backburner and there is no accountability.

### **Interactive Session on 'Impact** of AI on Creative Thinking' organised at MIER College

Professor Indurkhya provided intriguing examples of how artificial intelligence (AI) has been used to generate creative works, such as music, art, and literature. However, he was quick to point out that while AI can mimic certain aspects of creativity, it fundamentally lacks the intentions and emotions that drive human creativity. He elaborated on this by stating that artificial creative systems, though capable of producing novel outputs, do not possess the consciousness or purpose that characterises genuine creative thought. He also introduced the audience to

Rodari's techniques, a set of tools designed to stimulate creative thinking. He demonstrated how these techniques could be applied to both educational and professional contexts, encouraging participants to incorporate them into their teaching practices. He recommended several books on artificial intelligence and creativity, offering the faculty valuable resources to continue exploring the

The interactive session concluded with a Q&A segment, where faculty members had the opportunity to engage with Professor Indurkhya, asking questions and sharing their own perspectives on the impact of AI on creative thinking. The session was well-received. with participants expressing their appreciation for the depth of insight provided and the relevance of the topics discussed.

He further stated that the groundwater has become polluted in the surroundings of the industrial estate in Bari Brahmana, and other areas in Samba, and the situation has become alarming for the local residents in these areas.

'The Jal Shakti Department and the industrialists have not done anything to address the issue. The industries have also polluted the environment by not adhering to the guidelines of the pollution control board, and similarly, the said board is sleeping over the issue," he further stated.

He said that the Apni Party has committed to make revolutionary reforms in the industrial policy by holding accountable the industrial units, which violate the labour laws, do not employ local youth, and engage labourers/workers/skilled workers from the out of Jammu and Kashmir.

'These industries were opened to benefit the local economy, and the youth to generate employment. However, these industrial units take benefits of the Govt schemes, and subsidies and then close their units after several years, without clearing the dues of their workers/labourers. ### Manu Bhaker reveals PM Narendra Modi's words after Tokyo Olympics heartbreak that lifted her spirits

On the occasion of National Sports Day, Manu Bhaker reminisced about her interactions with Prime Minister Narendra Modi and offered her perspective on the inspiration he bestows upon athletes.

NEW DELHI, Aug 29 (Agencies): On the occasion of National Sports Day, Indian Olympic medallist pistol shooter Manu Bhaker reminisced about her interactions with Prime Minister Narendra Modi and offered her perspective on the inspiration he bestows upon athletes. The 22-year-old Manu created history at the 2024 Paris Olympics, becoming the first Indian to win two medals in a single Olympic edition post independence. She also became the first Indian woman to win a medal in an individual shooting event at the Games. Manu was just 16 when she first met PM Modi after her gold medal win at the 2018 Commonwealth Games when she was just 16 years old and taken aback by his genuine interest in her sporting career.



"During the interaction, he took me aside and said, 'You are very young. You will achieve even greater success and reach out to me whenever you need anything.' This was a great source of motivation for me," Manu recalled.

After her heartbreaking Tokyo Olympics campaign, where she fell short of winning a medal due to a pistol malfunction, the Prime Minister reached out with words of encouragement and discussed her future plans.

"PM Modi told me to be confi-

dent and focus on my goal. He keeps track of every detail about each player," Manu noted.

The pistol shooter believes that PM Modi's approach goes beyond merely celebrating victories; he focuses on nurturing and supporting every athlete, regardless of the outcome. Reaching out to athletes individually and taking the time to discuss their concerns, makes them feel valued and inspired.

After Manu bagged her first medal at the Paris Olympics, clinching the bronze medal in women's 10 m air pistol, PM Modi called upon the pistol shooter and congratulated her for the historic medal at the Games in Paris.

She later won the bronze in the Mixed 10m Air Pistol with Sarabjot Singh and finished fourth in the women's 25m Pistol event.

NEW DELHI, Aug 29 (Agencies): Newly appointed ICC Chairman Jay Shah extended his wishes to everyone on the occasion of the National Sports Day (Major Dhyan Chand's birth anniversary) on Thursday. Dhyan Chand celebrated as 'The Wizard' represented the Indian hockey team from 1925 to 1949, scoring over 1500 goals in the 185 matches he played as a centre forward during his international career, which includes three Olympic Gold Medal wins in 1928,1932 and 1936. He was felicitated with the Padma Bhushan in 1956 and his birth anniversary on August 29, is celebrated as National Sports

Day. "On this National Sports Day, I warmly commend our athletes, coaches, and everyone who has devoted their life to sports. As we honor the legacy of Major Dhyan Chand Ji on his birth anniversary, let's commit ourselves to making India a powerhouse on the global sporting stage, the newly elected ICC Chairman said in a post

on X. Earlier on Tuesday, Jay Shah was elected unopposed as the next Chairman of the International Cricket Council (ICC). Shah, who has served as the BCCI Secretary since October 2019 and Chairman of the Asian Cricket Council since January 2021, will assume this prestigious role on December 1, 2024.

Shah was the sole nominee for the chairmanship after current Chair Greg Barclay decided not to seek a third term, as per a media release by ICC. Upon his election, Shah expressed his intent to advancing the global reach and popularity of cricket, particularly with its upcoming inclusion in the LA 2028 Olympics--a moment he views as a pivotal opportunity for the sport's growth.

"I am humbled by the nomination as the Chair of the International Cricket Council,"

Shah stated as quoted by ICC.

"I am committed to working closely with the ICC team and our member nations to further globalize cricket. We stand at a critical juncture where it is increasingly important to balance the coexistence of multiple formats, promote the adoption of advanced technologies, and introduce our marquee events to new global markets. Our goal is to make cricket more inclusive and popular than ever before," Shah added.

"While we will build on the valuable lessons learned, we must also embrace fresh thinking and innovation to elevate the love for cricket worldwide. The inclusion of our sport in the Olympics at LA 2028 represents a significant inflection point for the growth of cricket, and I am confident that it will drive the sport forward in unprecedented ways," Shah concluded.

Jay Shah becomes the youngest person to lead the ICC. He joins the likes of Jagmohan Dalmiya, Sharad Pawar, N Srinivasan and Shashank Manohar as Indians who have led the ICC in the past. Shah's election marks a new chapter for the ICC as it seeks to expand the game's reach and continue its evolution on the global stage.

### Sumit, Bhagyashri lead 179-strong Indian contingent at Paralympic opening ceremony

PARIS, Aug 29 (Agencies): Javelin throw star Sumit Antil and shot-putter Bhagyashri Jadhav led the Indian contingent out in the athletes' parade of the Paralympic Games' opening ceremony, a four-hour long spectacle which began at the Champs-Elysees avenue and concluded at the Place de la Concorde here.

French President Emmanuel Macron declared the Games open. The 179-strong Indian contingent, which is the largest ever in the nation's Paralympic history, features 84 athletes in 12 different sports.

Antil, who won the javelin gold at the Tokyo Paralympics, had the honour of being the flagbearer alongside Jadhav, a silver-medallist in shot-put at the Asian Para Games in China.

The opening ceremony was an ode to diversity, resilience, and spirit of competition, and featured performances that highlighted French culture and the Paralympic values of determination and equality.

India had won 19 medals, including five gold at the previous edition of the Games, and the country is hoping to take the number to at least 25 with a double digit haul of gold medals.

Several proven performers are in the team, including rifle shooter Avani Lekhara (10m Air Rifle Standing SH1), who became the first woman to win a Paralympic gold in Tokyo.

Other podium contenders include para-archer Sheetal Devi, who shoots with her legs as she was born without arms, landmine blast survivors Hokato Sema (shot putter) and Narayana Konganapalle (rower).

India's ambition has been powered by the strong performance in the Asian Para Games in Hangzhou last year when the country won a record 111 medals, including 29 gold.

Over 4,000 athletes with various physical and intellectual disabilities will compete in the showpiece that will conclude on September 8.

"The Paris 2024 Paralympic Games will show what persons with disabilities can achieve at the highest level when the barriers to succeed are removed," International Paralympic Committee President Andrew Parsons said in his speech.

### "Just copy what India is doing": Ex-Pakistan star tells PCB after huge Bangladesh loss

ISLAMABAD, Aug 29 (Agencies): The disappointing loss against Bangladesh in the first Test match has sparked massive criticism for the Pakistan cricket team. It was the first time that Pakistan were defeated by Bangladesh in Test cricket and their performance has left both fans and experts fuming. Former Pakistan cricketer Basit Ali asked the Pakistan Cricket Board (PCB) to take ideas from India when it comes to hosting more red ball tournaments in order to create a bigger pool of players. He expressed his displeasure at PCB organising a One-Day tournament after the Bangladesh Tests and said that more focus should be on red-ball cricket as Pakistan lack a strong pool of cricketers when it comes to the format.

Basit went on to say

that Pakistan have copied systems from England, Australia and New Zealand in the past but right now, they should look at India and tic system.

"There will be a One-Day tournament called the Champions Cup after the Test series. Pakistan have copied the systems of England, Australia, and New Zealand. India is right next to us, please copy their system too. You need intelligence in copying as well. Just copy what India is doing. The Duleep Trophy is about to begin. Is it a T20 or One-Day tournament? It is a four-day tournament. They are focused on making their base stronger, which is why they are so successful," he said on YouTube.

Abrar Ahmed and Kamran Ghulam, who were previously released from the Pakistan Test squad against Bangladesh, have been recalled to join the team for the second Test scheduled to be played at the Rawalpindi Cricket Stadium from August 30 to September 3.

Both players had been contributing in a fourday match for Pakistan Shaheens against Bangladesh 'A' at the Islamabad Club, which took place from August 20 to 23.

Abrar, a leg-spinner known for his exceptional control and ability to extract turn on subcontinent pitches, is expected to provide Pakistan with additional spin options. Kamran, a middle-order batsman, brings depth and stability to the batting lineup.

Shaheen Shah Afridi, Pakistan's spearhead fast bowler, has also rejoined the squad after being released at the conclusion of the first
