JAMMU. Sep 22: The Green Revolution played a significant role in farmers' development, and so did the White Revolution. An increase in milk production will not only make milk available to the general public at lower prices but also benefit the farmers.

over the last few years.
"The two prime ministers warmly recalled their many interactions, especially since their first

Annual Summit in March 2022," the Prime Minister's Office said in a statement.

Both Modi and Kishida

noted that the India-Japan Special Strategic and Global Partnership is in its 10th year and expressed satisfaction at the progress made in the relationship.

"The two Prime Ministers reviewed the multifaceted relationship between the two countries and exchanged views to deepen cooperation further, including defense and security ties and B2B and P2P collaborations," the PMO further said.

The police personnel said a proper probe should be conducted into the alleged incident of sexual assault at Bharatpur police station. The police personnel said there was no need to suspend the cops before completion of investigation.

The Odisha police association condemned the suspension and said there is no reason to suspend the personnel. "As investigation is ongoing, there is no reason to suspend the five police personnel. They should not be suspended until proven guilty," said organising secretary Umesh Chandra Sahu, PTI reported.

On Saturday, a group

of retired police officers

also met Police Commissioner Sanjeeb Panda to voice concerns. Retired officer Suryamani Tripathy said, "There is no point in suspending police personnel before they are found guilty. We will approach the DGP, Home Secretary, and the Chief Minister to demand the withdrawal of the suspensions."







They were told that they should create jobs for thousands of people of J&K but they could not own any houses and had to live as tenants permanently, Mr Gupta

This put off many wouldbe investors who said if invest in J&K, they should at least be allowed small patches of land for their personal needs also as residences. Since Articles 35-A and 370 were in force, allotting land even for residential purposes to "outsiders" (as defined by the NC, Indians from other states) was not possible and would-be investors had to be turned away, Mr Gupta said. Today, investment proposals worth thousands of crores have been received and many industrial estates are being set up all over J&K,

he said. The NC should give up on its agenda of uselessly talking about restoration of these articles which have been buried forever. It should thank PM Modi and admit without hesitation that he has changed the ground realities and hence the perceptions about J&K, not only domestically, but also globally, he concluded.


Sawhney intensifies campaign, criticises implementation of Property Tax



CHANDRAYAAN-4 **MISSION**

'ndia's ambitious space program continues to make strides with the upcoming L Chandrayaan-4 mission, aimed at furthering lunar exploration. Following the success of Chandrayaan-1 and Chandrayaan-2, this mission is set to deepen our understanding of the Moon and its resources, building upon the knowledge gained from previous missions.

The primary objectives of Chandrayaan-4 revolve around exploring the lunar surface and studying its geology, mineralogy, and the presence of water ice in permanently shadowed regions. The mission aims to:

Investigate the Moon's Surface Composition: Chandrayaan-4 will carry advanced spectrometers to analyze the mineral composition of the lunar surface, focusing on areas that have not been extensively studied before. This will help in identifying potential resources that could support future lunar habitation.

One of the most exciting prospects of lunar exploration is the discovery of water ice, which is crucial for future manned missions. Chandrayaan-4 aims to map regions with potential water deposits, especially in craters that remain in perpetual darkness.

Utilizing high-resolution cameras, the mission will create detailed maps of the lunar terrain, which will be vital for understanding geological processes and planning future missions.

The mission will also focus on studying the thin atmosphere of the Moon, known as the exosphere, to understand its composition and dynamics.

Chandrayaan-4 will consist of an orbiter, a lander, and a rover, following a similar design to its predecessor, Chandrayaan-2. However, advancements in technology and design will enhance its capabilities.

The orbiter will be equipped with sophisticated scientific instruments, including a highresolution camera and various spectrometers. Its primary role will be to collect data from the lunar surface and relay it back to Earth.

The lander will be designed to touch down on the Moon's surface with precision. It will be equipped with instruments to analyze the soil and monitor seismic activity, providing insights into the Moon's geological stability.

The rover will be capable of traveling across the lunar surface, conducting in-situ analysis of soil samples, and looking for signs of water ice. It will be outfitted with various scientific instruments to perform chemical analysis and gather data on the Moon's surface conditions.

Chandrayaan-4 is scheduled for launch in late 2024, with the Indian Space Research Organisation (ISRO) planning to employ a GSLV Mk III rocket for this mission. After a journey of approximately four days, the orbiter will enter lunar orbit, followed by the deployment of the lander and rover.

Once on the Moon, the mission is expected to last for several months, during which data will be continuously transmitted back to Earth. Scientists will analyze this data to enhance our understanding of the Moon and to prepare for future human missions.

The Chandrayaan-4 mission holds significant importance for several reasons The mission is likely to attract international collaboration, as countries and space agencies around the world express interest in lunar exploration. This collaboration could lead to shared knowledge and resources, enhancing scientific outcomes.

The mission will showcase India's growing capabilities in space technology and engineering. Successful execution will enhance India's standing in the global space community.

Chandrayaan-4 will lay the groundwork for subsequent missions, including potential crewed lunar expeditions. Understanding the Moon's resources is critical for planning longterm human habitation on the lunar surface.

The data collected from Chandrayaan-4 will contribute to various scientific fields, including geology, planetary science, and astrobiology, helping scientists understand not only the Moon but also broader cosmic processes.

Chandrayaan-4 is poised to be a landmark mission in India's space exploration journey. By delving deeper into the mysteries of the Moon, it promises to unlock valuable insights that will not only benefit India but also contribute to the global understanding of our nearest celestial neighbor. As preparations continue, the excitement surrounding this mission reflects humanity's enduring fascination with the Moon and the possibilities it holds for the future.

India must be ready for a prolonged LAC standoff

peaking at the Geneva Centre of Security Policy, the Indian external affairs minister ostensibly stated according to reportage in the public domain that "those negotiations are going on, we have made some progress. Roughly, you can say about 75 per cent of the disengagement problems are sorted out... We still have some things to do, but there's a bigger issue - that if both of us have brought forces close up, in that sense the level of militarisation of the border has increased. How does one deal with it?" He further added: "I think there are larger issues in respect of India-China. We have a long struggle with the trade issue... The economic relationship with China has been very unfair. It has been very imbalanced that we don't have market access there. They have much better market access here in India. We have many concerns today in various areas, like technology, telecom, and digital." Also Read - Krishna Shastri Devulapalli | I don't know why the mediocre bird sings Advertisement If 75 per cent of the disengagement problems have indeed been sorted out along the Line of Actual Control (LAC) it is a welcome step as both India and China can move ahead and focus on the other aspects of the relationship including and not limited to the unfair and imbalanced trade relationship that he alluded to. However, there is a bigger challenge that the external affairs minister advertently or inadvertently flagged and that is the increased militarisation along the LAC. This is a portentous indicator for the simple reason that People's Republic of China (PRC) announced an annual defence budget of about \$236.1 billion for fiscal year 2024. India, by comparison, has a defence budget of \$74.3. billion in fiscal 2024-25. China spends more than the next 17 Indo-Pacific militaries combined. The US, by contrast, spends ten times more on defence than what China does. Also Read - Anita Katyal

Atishi, as CM, has tough times ahead; Kejriwal shouldn't be underestimated Military expansion along the LAC: The Line of Actual Control, a de facto border dividing India and China, has seen intensified military activity from the Chinese side. China has been aggressively expanding its military infrastructure in the region, including constructing roads, airfields and fortifications. A notable development is the construction of a 400-metrelong bridge across Pangong Lake in the Aksai Chin region — a territory occupied by China since 1960 but that falls within Indian sovereign territory. This bridge will significantly reduce the time required to move troops and equipment from 12 hours to about four, bolstering their logistical capabilities and consolidating its military presence. Increased troop deployments and military drills in high-altitude conditions suggest that China is not merely preparing for local skirmishes but is reinforcing its strategic positions. This military buildup includes advanced surveillance systems, missile platforms, and integrated defence networks, indicating that China's objectives extend beyond mere border disputes. Also Read - Claude Arpi | The India-China standoff: One border, two systems India's response to the military escalation: In response to Chinese military expansion, India faces a complex strategic dilemma. Countering China's rapid militarisation in these remote, high-altitude areas is both logistically challenging and comes at an unavoidable and inevitable defence expenditure. India has also enhanced its military presence along the LAC by deploying additional troops, air defence systems, and advanced weaponry. However, maintaining a robust mili-

tary posture in these isolated regions places a considerable strain on India's

defence budget. The economic impact of this military escalation is significant. With India's defence budget already under pressure, a prolonged arms race with China could hinder its ability to modernise its forces and address other pressing security concerns. Balancing immediate security needs with long-term strategic objectives, while avoiding an economically draining standoff, remains a critical challenge for India. Moreover, the increasing militarisation of the LAC carries broader geopolitical implications. The risk of miscalculations is high, and minor clashes between Indian and Chinese forces could escalate into more severe confrontations. Given that both nations possess nuclear capabilities, the potential consequences of such escalation are grave. India also faces a nuanced diplomatic challenge. Traditionally, it has sought to maintain a balance between relations with China and the United States. However, the growing militarisation of the LAC might push India closer to Western allies, as evidenced by initiatives like the Quad – a strategic alliance involving India, Japan, Australia, and the United States. While strengthening ties with the West could enhance India's military capabilities, it may also exacerbate tensions with China. Recent developments, such as China's construction of a new heliport 20 kilometres east of the LAC in the sensitive "Fishtails" region of Arunachal Pradesh, further complicates the situation. The dichotomy of engagement and militarisation: While the claim that 75 per cent of the disengagement process has been completed might suggest that tensions along the LAC are easing, the situation is far more complex. Disengagement involves the withdrawal of troops from closecontact standoffs in certain areas, but it does not address the broader issue of China's military buildup along the LAC. China's ongoing infrastructure development, including extensive road and airfield construction, and increased troop deployments indicate a long-term strategy of maintaining a

strong presence in the region, rather than de-escalating. This situation presents India with a complex diplomatic and strategic dilemma. On one hand, India remains committed to engaging China through military and diplomatic channels, aiming for a peaceful resolution to the border dispute. On the other hand, the reality on the ground necessitates a robust military response to counter China's aggressive posture. The militarisation of the LAC raises a critical question: Can diplomatic efforts succeed in the face of China's expanding military presence, or is militarisation becoming the new status quo along the border, fundamentally altering the dynamics of the India-China relationship? Navigating the path forward: Given the current situation, disengagement alone does not signify true de-escalation but rather a strategic repositioning. India must recognise the new reality and prepare for a potentially extended standoff. To address the militarisation of the LAC, India needs a comprehensive strategy that balances immediate military readiness with the long-term goal of a peaceful resolution to the border dispute. This strategy should include enhancing India's military infrastructure along the LAC while continuing diplomatic efforts with China. Additionally, India should seek to strengthen alliances with other Indo-Pacific nations to counterbalance China's expanding influence. While avoiding a prolonged military standoff remains the ideal objective, India must be prepared for such a scenario if necessary. In conclusion, the increasing militarisation of the LAC underscores the complexity of the India-China border dispute. Disengagement may offer temporary relief, but it does not resolve the underlying strategic shifts. India's approach must be multifaceted, combining enhanced military readiness with robust diplomatic efforts to navigate the ongoing tensions and work towards a sustainable resolution.



Gujarat AAP MLA, 20 others booked for attacking restaurant owner over bill settlement

RAJPIPLA, Sep 22 (Agencies): A case has been registered against an MLA of the Aam Aadmi Party (AAP) and 20 others for allegedly attacking a restaurant owner in Gujarat's Narmada district, police said on Sunday.

Based on a complaint, the police on Saturday registered an FIR against AAP MLA Chaitar Vasava, along with six identified and around 15 unidentified persons, for the incident that occurred in Dediapada on September 16, an official said.

Chaitar Vasava, who won the 2022 Gujarat election from the Dediapada constituency, and the other accused allegedly hurled verbal abuses and thrashed the complainant and restaurant owner Shantilal Vasava, the official said.

The FIR states that the legislator and others attacked the complainant on the night of September 16 after he was asked to settle a restaurant bill, he said.

The complainant alleged that he called



Chaitar Vasava on his mobile phone and asked him to settle the bill. This angered the MLA and he asked the latter to wait for him at his house, the official said.

He said the MLA allegedly reached the complainant's house along with a group of 20 people, slapped him and verbally abused him. The AAP leader's accomplices also thrashed him and threatened to kill him.

A case has been registered against the accused under various sections of the Bharatiya Nyaya Sanhita (BNS) pertaining to

rioting, unlawful assembly, voluntarily causing hurt, intentional insult, criminal intimidation and criminal conspiracy. No arrests have been made

so far, the official said.
Chaitar Vasava unsuccessfully contested the 2024 Lok Sabha election from the Bharuch constituency in a seatsharing agreement with Congress.

The MLA was arrested in December last year for allegedly threatening a forest official, firing in the air and extorting money. He spent nearly six weeks in jail before a sessions court granted him regular bail.

Mamata again writes to PM Modi on Bengal flood, says her govt not consulted on water release by DVC

KOLKATA, Sep 22 (Agencies): Chief Minister Mamata Banerjee wrote another letter to PM Narendra Modi on the flood situation in West Bengal, maintaining that Damodar Valley Corporation (DVC) released water from its reservoirs without consulting her government, inundating several districts.

Responding to Banerjee's earlier letter to the PM, Union Jal Shakti Minister CR Paatil had said the state's officials were informed at every stage about the release of water from DVC reservoirs, which was essential to prevent a major disaster.



Banerjee said, "While the hon'ble minister claims that the release from DVC dams was carried out by consensus and collaboration with the Damodar Valley Reservoir Regulation Committee, including consultations with representatives of the government of West Bengal, I may respectfully disagree."

"All the critical deci-

sions are made unilaterally by representatives of the Central Water Commission, Ministry of Jal Shakti, Government of India without arriving at a consensus," she added.

Banerjee claimed that sometimes water is released without any notice to the state government and the views of her government are not honoured.

LPG cylinder found on railway tracks in Kanpur in another train derailment bid

KANPUR, Sep 22 (Agencies): A major train accident was narrowly avoided early Sunday after an LPG cylinder was found on the rail tracks near Perambur Railway Station in Kanpur district of Uttar Pradesh. The cylinder was spotted ahead of a goods train, prompting the loco pilot to apply the brakes just in time.

This marks the fourth incident in September where unidentified miscreants have attempted to derail trains. On September 8, the Kalindi Express, traveling from Prayagraj to Bhiwani, struck an LPG cylinder placed on the tracks in Kanpur.

The train halted after hitting the cylinder, and the loco pilot also noticed other suspicious items, including a petrol bottle and matchboxes. Indian Railways

Indian Railways reported on September 10 that there have been 18 attempts to derail trains nationwide since August.

Between June 2023 and now, 24 such incidents have occurred, with objects like LPG cylinders, bicycles, iron rods, and cement blocks being found on tracks. According to the Railways, of the 18 incidents, 15 took place in August and four in September, including the latest train derailment attempt in Kanpur.

Tirupati laddu row: Jagan Reddy writes to PM Modi, wants CM Naidu to be reprimanded for spreading 'lies'



AMARAVATI, Sep 22 (Agencies): Dubbing the Andhra Pradesh Chief Minister as a "habitual liar", YSR Congress chief YS Jagan Mohan Reddy on Sunday sought Prime Minister Narendra Modi's intervention to reprimand Chandrababu Naidu over the Tirupati laddu adulteration issue.

In a letter addressed to PM Modi, Jagan alleged that CM Chandrababu Naidu has stooped so low as to hurt the beliefs of crores of people purely for political objectives.

Detailing the process undertaken at Tirumala Tirupati Devasthanams (TTD) the custodian of the super-rich shrine of Sri Venkateswara Swamy for accepting ghee, in an eight-page letter, Jagan alleged that Naidu's actions lowered not only the stature of CM but also that of everyone in public life, the sanctity of TTD and its practices.

"Sir, the entire country looks to you at this crucial juncture. It is very imperative that Mr Naidu be reprimanded in the severest way for his shameless act of spreading lies and the truth be brought to light. Sir, this would help allay the suspicions that Mr Naidu has created in the minds of crores of Hindu devotees and restore their faith in sanctity of TTD," Jagan wrote in his letter.

Explaining the sequence of events, he said it is crucial to note that the ghee allegedly adulterated was rejected and not allowed to enter the premises of TTD. However, Naidu with malafide intention raised the issue at a political party meeting on September 18.

During an NDA legislative party meeting a few days ago, the TDP supremo claimed that the previous YSRCP government did not even spare Sri Venkateswara temple and used substandard ingredients and animal fat for making laddus.

Two days later on September 20, TTD Executive Officer J Shyamala Rao in a press conference said Lab tests had revealed the presence of animal fat and lard in chosen samples and the board is in the process of blacklisting the contractor who supplied "adulterated" ghee.

Mayawati raises questions over rising crimes against women in country



LUCKNOW, Sep 22 (Agencies): BSP president and former Uttar Pradesh chief minister Mayawati expressed concern over "rising" crimes against women across the country and questioned governments' intentions and policies on women's

"It is very sad to indulge in narrow politics of allegations and counter-allegations on the increasing incidents of crimes against women across the country including UP, Bengal, Odisha, Karnataka, whereas this is the time for serious thinking whether there

is a grave flaw in the intentions and policies of governments regarding women's safety and respect?" the Bahujan Samaj Party (BSP) chief said in a post on 'X' in Hindi on Sunday.

She said that prima facie the "negligence" of governments and the "involvement" of police in such heinous crimes happening one after the other is making the situation even more serious.

"It is very important for everyone to abandon this negligence and be impartial and serious so that the state and the country can be saved from the disrepute caused by such heinous crimes," Mayawati said in her series of posts on 'X'.

Hezbollah fires over 100 rockets across a wider and deeper area of Israel as fears of war mount

NAHARIYA, Sep 22 (Agencies): Hezbollah launched more than 100 rockets early Sunday across a wider and deeper area of northern Israel, with some landing near the city of Haifa, as Israel launched hundreds of strikes on Lebanon. The sides appeared to be spiraling toward all-out war following months of escalating tensions.

The rocket barrage overnight set off air raid sirens across northern Israel, sending thousands of people scrambling into shelters. The Israeli military said that rockets had been fired "toward civilian areas," pointing to a possible escalation after previous barrages had mainly been aimed at military targets.

One rocket struck near a residential building in Kiryat Bialik, a community near Haifa, wounding at least three people and setting buildings and cars on fire. Israel's Magen David Adom rescue service said that a total of four people were wounded by shrapnel in the barrage.

Avi Vazana raced to a shelter with his wife and 9-month-old baby before he heard the boom of the rocket hitting in Kiryat Bialik. Then he went back outside to see if anyone was hurt.

"I ran without shoes, without a shirt, only with pants. I ran to this house when everything was still on fire to try to find if there are other people," he said.

Lebanon's Health Ministry said that one person was killed and another wounded in an Israeli strike near the border.

The barrage came after an Israeli airstrike in Beirut on Friday killed at least 45 people, including one of Hezbollah's top leaders as well as women and children. Hezbollah was already reeling from a sophisticated attack that caused thousands of personal devices to explode just days earlier.

The Israeli military said that it carried out a wave of strikes across southern Lebanon over the past 24 hours, hitting about 400 militant sites, including rocket launchers. Lt. Col. Nadav Shoshani, an Israeli

The low-level fighting has killed dozens of people in Israel, hundreds in Lebanon, and displaced tens of thousands on both sides of the frontier.

Neither side is believed to be seeking a war, and Hezbollah has so far stopped short of targeting Tel Aviv or major civilian infrastructure. But in recent weeks, Israel has shifted its focus from Gaza to Lebanon

On Friday, an Israeli airstrike took down an eight-story building in a densely populated neighborhood in Beirut's southern suburbs as Hezbollah members were meeting in the basement, according to Israel. Among those killed was Ibrahim Akil, a top Hezbollah official who commanded the group's special forces unit, known as the Radwan Force.

Lebanese authorities say at least seven women and three children were killed in Friday's airstrike on the building and that another 68 people were wounded, including 15 who were hospitalized.

It was the deadliest strike on Beirut since the bruising monthlong war in 2006 between Israel and Hezbollah, and the casualty count could grow, with 23 people still missing, a government official said. Israeli Defense Minister Yoav Gallant said that the attack broke up the group's chain of command while taking out Akil, who he said was responsible for Israeli deaths.

Akil had been on the U.S. most wanted list for years, with a \$7 million reward, over his alleged role in the 1983 bombing of the U.S. Embassy in Beirut and the taking of American and German hostages in Lebanon during the civil war in the 1980s.

TEHRAN, Sep 22 (Agencies): A blast caused by a gas leak at a coal mine in eastern Iran has killed at least 30 people, state media said Sunday, with more than 20 others reported missing.

"The death toll in the Tabas mine accident increased to 30", the official IRNA news agency said, revising an earlier toll of 19 killed.

Javad Ghenaat, governor of South Khorasan province where the mine is located, told state TV that rescue teams were working to recover 22 trapped workers.

According to IRNA, "17 others were injured" in the explosion at around 9:00 pm (1730 GMT) on Saturday, when 69 workers were present at the site.

It said a leak of methane gas led to the blast in two blocks of the mine State TV broadcast footage of ambulances and helicopters arriving at the scene of the incident to transport the injured to hospital.

Online footage carried by IRNA showed bodies of some of the victims, wearing their work uniform, carried out of the site on mining carts.

President Masoud Pezeshkian, in remarks carried state TV before departing for the UN General Assembly in New York, offered his condolences to the families of the victims and ordered a probe into the deadly incident.

"Unfortunately, we learned that an accident occurred in one of the coal mines in Tabas and a number of our compatriots lost their lives. I offer my condolences to their respected families," Pezeshkian said.

His first vice president, Mohammad Reza

Aref, spoke with cabinet members to ensure "emergency follow-up" and support for the victims and their families, IRNA said.

Iran's Red Crescent said search and rescue operations were underway in the mine, where some workers remained trapped.

But "gas accumulation in the mine" has made the search operations difficult, local prosecutor Ali Nesaei was quoted by IRNA as saying.

"Currently, the priority is to provide aid to the injured and pull people from under the rubble," Nesaei said.

He added that "the negligence and fault of the relevant agents will be dealt with" later on.

Last year, an explosion at a coal mine in the northern city of Damghan killed six people, also likely the result of methane leak according to local media.

In May 2021, two miners died in a collapse at the same site, local media reported at the time

German chancellor's Social Democrats seek to hold off far right in Brandenburg state election

BERLIN, Sep 22 (Agencies): A state election is taking place in Brandenburg on Sunday, three weeks after a far-right party made gains in two other states in eastern Germany

Around 2.1 million people are registered to vote for a new state parliament in Brandenburg, the state that surrounds the German capital, Berlin.

Sunday's election is being watched closely for signs about the country's political direction

The latest polls showed that the far-right Alternative for Germany is neck-and-neck with the Social Democrats, the party that has governed Brandenburg continuously since German reunification in

1990.
The Social Democrats, the largest party in Chancellor Olaf Scholz's three-way coalition government, are hoping to maintain control of their stronghold in the face of rising support for parties on the extreme right and

If the Social Democrats lose in Brandenburg, it would be seen as a bad omen for Scholz a year before a federal election that is due to be held on Sept. 28, 2025. Scholz lives in Potsdam, the capital of Brandenburg, and German political observers believe the chancellor's political future will be shaped by the results of Sunday's vote in Brandenburg.

The fate of the Brandenburg governor, Dietmar Woidke, is also hanging in the balance. He made it his goal for his Social Democrats to beat Alternative for Germany, or AfD, and vowed to resign should the AfD win.

"If I lose against the AfD, I am gone," Woidke said.

The Alternative for Germany won the most votes in the state of Thuringia and also did well in an election in Saxony on Sept. 1. A new party founded by a prominent leftist also made a strong impact, while the parties in Scholz's unpopular national government obtained extremely

weak results.

That was the first time the far right won an election in Germany since World War II, and it dealt a heavy blow to

Scholz's centrist coalition. It also generated concerns in Germany and abroad about the growing support for the extreme right in the largest European Union country, and a member of NATO.

The far-right party has gained support amid a growing backlash to large-scale migration to Germany over the past decade and several recent extremist attacks. Germany's economy, once a powerhouse, has been weakening, adding to a general feeling of malaise.

Sunday's vote follows a heated election campaign centered on the issues of migration, internal security and peace. Both the far right and the new leftist movement, the Sahra Wagenknecht Alliance, or BSW, want to end weapons deliveries to Kyiv as Ukraine tried to defend itself against Russia's full-scale invanien

Even if the Alternative for Germany wins in Brandenburg, it is unlikely to govern because other parties have refused to work with it.

Over 20 people wounded after Russia strikes apartment blocks in Ukraine's Kharkiv



KYIV, Sep 22 (Agencies): Russian strikes hit high-rise apartment blocks in Ukraine's Kharkiv, leaving dozens wounded in a second consecutive nighttime attack this week.

The bombs fell Satur-

day night on the district of Shevchenkivsky, in Ukraine's northeast, local Gov. Oleh Syniehubov said. Residential 16 and 9-storied buildings were destroyed, and seven more buildings were damaged, he added.

Twenty-one people were wounded, including an eight-year-old, two 17-year-olds and several older adults, according to Syniehubov and Kharkiv mayor lhor Terekhov.

The attack came after another late Friday that wounded 15 people,

including a 10- and 12-year-old, as Russian airstrikes hit three Kharkiv neighborhoods, Terekhov said.

According to Ukrainian officials, KAB-type aerial glide bombs were used in both attacks, a retrofitted Soviet weapon that has for months laid waste to eastern Ukraine.

Russia also launched 80 Shahed drones and two missiles at Ukraine overnight into Sunday, the Ukrainian air force said in an online statement.

Ukrainian air defense shot down 71 drones, and another six were lost on location due to electronic warfare countermeasures, the statement said.

Russia launched a full-scale invasion of Ukraine in Feb. 2022.

Sri Lankan Marxist leader Dissanayaka leads presidential vote

COLOMBO, Sep 22 (Agencies): Anura Kumara Dissanayake, the leader of the Marxist JVP's broader front National People's Power (NPP), on Sunday consolidated his lead in the Sri Lanka's presidential election.

On Saturday, Sri Lankans voted to elect a new president for the first election since the economic meltdown in 2022.

The voter turnout in the presidential election was around 75 per cent. Lower than the 83 per cent polled in the previous presidential election held in November

In the cumulative vote count declared by 7 am on Sunday, 56-year-old Dissanayake amassed 7,27,000 votes or 52 per cent against his nearest rival 57-year-old Sajith Premadasa, the main opposition leader who received 3,33,000 votes at 23 per cent.

The incumbent Ranil Wickremesinghe, 75, was trailing way behind with 2,35,000 votes at 16 per cent.

Dissanayake won 21 of the 22 postal district votes while bagging several results declared thus far from the 168 geographical parliamentary seats from different districts.

Wickremesinghe is yet to concede defeat but his Foreign Minister Ali Sabry on X congratulated Dissanayake for his win.

"After a long and

arduous campaign, the results of the election are now clear. Though I heavily campaigned for President Ranil Wickremasinghe, the



people of Sri Lanka have made their decision, and I fully respect their mandate for Anura Kumara Dissanayake. In a democracy, it is crucial to honour the will of the people, and I do so without hesitation," Sabry wrote on X.

"I extend my sincere congratulations to Mr. Dissanayake and his team," he added.

Premadasa camp senior Harsha de Silva too congratulated Dissanayake.

NPP sources said they would be visiting the presidential secretariat on Sunday to discuss the formalities of the transition in the morning hours.

The swing Dissanayake garnered was of unbelievable proportions despite pre-poll expectations of his victory which was considered foregone, analysts said.

Dissanayake's NPP had only garnered 3 per cent of the vote in the previous election - the 2020 August parliamentary election.

Sri Lanka's crisis has proven an opportunity for Dissanayake, who has seen a surge of support due to his pledge to change the island's "corrupt" political culture.

This time, the minority Tamil issue is not on the agenda. Instead, the nation's battered economy and its recovery have taken centre stage with all three front runners vowing to stick with the IMF bail-out reforms.

Dissanayake and Premadasa want to tinker with the IMF programme to give more economic relief to the public.

The polls were held on Saturday from 7 am to 4 pm local time at over 13,400 polling stations in 22 electoral districts in the election which had the highest number of candidates, 38, but no female aspirant for the top post.

Voters in Sri Lanka elect a single winner by ranking up to three candidates in order of preference. If a candidate receives an absolute majority, they will be declared the winner. If not, a second round of counting will commence, with second and third-choice votes then taken into account.

DFSS stages protest denouncing Er Rashid released on bail

JAMMU, Sep 22: Kashmiri Member of Parliament (MP) Engineer Rashid walked out of Tihar Jail on September 11, following a Delhi court's grant of interim bail in a terror-funding case, valid until October 2. His release comes just ahead of the assembly elections in Jammu and Kashmir, set to conclude on October 1, with results to be announced on October 8.

Rashid was arrested by the National Investigation Agency (NIA) in August 2019, shortly after the abrogation of Article 370, and faces charges related to a criminal conspiracy involving the collection of funds for separatist



activities through hawala channels. This case links him to proscribed terrorist organizations, including Hizb-ul-Mujahideen and Lashkar-e-Taiba.

In response to his release, workers from

the Dogra Front & Shiv Sena (DFSS), led by president Ashok Gupta, staged a rally in Jammu, denouncing Rashid as a "hardcore separatist" and a "voice of Pakistan"

in Kashmir. Gupta criti-

cized Rashid for defending the 26/11 mastermind Hafiz Saeed's actions as a "political cause," accusing him of perpetuating extremist narratives.

Gupta called for all

political parties to refrain from forming alliances with Rashid, stating that he promotes separatism and aligns with Pakistani agendas. He also appealed to the Election Commissioner of India, urging that individuals with anti-India cases against them should be barred from contesting elections, specifically referencing Rashid's situation.

The protest saw participation from various party workers, including Sandhya, Prem, Bantu, Kalu, Vivek, Abhishek, Geeta, Sunita, Rani, and Ashish, among others, underscoring local tensions surrounding Rashid's release and the ongoing electoral landscape in Jammu and Kashmir.

India to take retaliatory measures against EU's safeguard duty on steel

For India, these safeguard measures have been costly. India estimates that its steel exports to the EU have faced a cumulative trade loss of USD 4.412 billion from 2018 to 2023.

NEW DELHI, Sep 22 (Agencies): India is likely to impose higher import duty on specific goods from the European Union (EU) in retaliation to the EU's extension of safeguard duties on 26 steel items, significantly impacting India's steel exports. The safeguard duty will remain in place until June 2026.

India's steel industry is already struggling with cheap imports from China and is facing challenges in meeting the requirements of the EU's Carbon Border Adjustment Mechanism (CBAM), set to take effect in January 2026. The EU's safeguard measures, which have been in place since 2018 have drastically reduced India's export volumes to the EU, causing significant financial losses.

According to Ajay Srivastava, founder, Global Trade Research Initiative (GTRI), the EU's safeguard measures are designed to protect its domestic steel industry from an oversupply of cheaper imports. These measures apply to 26 categories of steel products, including non-alloy and alloy hot-rolled sheets, cold-rolled sheets,



metallic coated sheets, organic coated sheets, and other key steel products.

The EU has established import quotas for each steel product by country, with inquota imports facing a 0% duty. However, once imports exceed the quota, an out-of-quota duty of 25% is imposed. The quota amounts vary depending on the product category and the exporting country.

For India, these safeguard measures have been costly. India estimates that its steel

exports to the EU have faced a cumulative trade loss of USD 4.412 billion from 2018 to 2023. In this period, the EU has collected duties amounting to USD 1.103 billion on Indian steel exports.

In response, India has notified the World Trade Organization (WTO) on 17 September 2024 of its intention to take retaliatory action under Article 12.5 of the Agreement on Safeguards.

According to GTRI, India's proposed action involves suspending trade concessions

on selected EU products, with plans to raise tariffs on these imports. The tariff increases will be proportional to the trade losses incurred due to the EU's safeguard measures and may be adjusted in response to future developments. India's response comes after the EU extended its safeguard measures, which were originally set to expire in June 2024, for an additional two years until June 2026.

India had earlier imposed retaliatory tariffs on imports from the United States on 16 June 2019 after the US imposed tariffs on Indian steel and aluminium.

The US had imposed a 25% tariff on steel and a 10% tariff on aluminum imports from several countries, including India, citing national security concerns. In retaliation, India raised tariffs on 28 U.S. products, including almonds, apples, walnuts, chickpeas, and certain chemicals. India's retaliatory tariffs were aimed at offsetting the impact of the U.S. tariffs on Indian steel and aluminum exports.

OYO acquires G6 hospitality for 525 million dollars, expands US footprint

NEW DELHI, Sep 22 (Agencies): Oravel Stays, the parent company of the global travel technology firm OYO, announced that it is acquiring US-based G6 Hospitality from Blackstone Real Estate for \$525 million in an allcash deal. The transaction is expected to close in the fourth quarter of 2024, subject to customary closing conditions.

G6 Hospitality, a leading economy lodging franchisor, is the parent company of the well-known Motel 6 and Studio 6 brands. The franchise network of Motel 6 generates gross room revenues of \$1.7 billion, which provides a strong fee base and cash flow for G6.

OYO has been expanding its presence in the United States since its launch in the region in 2019. The company currently operates over 320 hotels across 35 states. In 2023, OYO added nearly 100 hotels to its

US portfolio and aims to add 250 more by 2024.

"This acquisition is a significant milestone for a startup company like us to strengthen our international presence. Motel 6's strong brand recognition, financial profile, and network in the US, combined with OYO's entrepreneurial spirit, will be instrumental in charting a sustainable path forward for the company, which will continue to operate as a separate entity," said Gautam Swaroop, CEO of OYO International.

Under Blackstone's ownership, substantial capital was invested to create value and enhance the Motel 6 brand, transforming the business into a leading asset-light lodging company with a franchise network of 1,500 hotels across the United States and Canada.

Rob Harper, Head of Blackstone Real Estate Asset Management Americas, stated, "This transaction is a terrific outcome for investors and is the culmination of an ambitious business plan that more than tripled our investors' capital and generated over \$1 billion in profit over our hold period. We believe G6 is extremely well-positioned for the future and we look forward to seeing its brands continue their success in the years to come."

This acquisition comes just a month after OYO reported its first-ever annual profit after tax (PAT) of ₹229 crores for FY24. OYO's Adjusted EBITDA grew by 215% to reach ₹877 crores in FY24, up from ₹277 crores in FY23.

The company also recently raised ₹1,457 crores from a consortium of investors in its latest funding round, giving OYO a valuation of \$2.4 billion. This funding came shortly after the company decided to withdraw its initial public offering (IPO) papers for the second time.

French media sue Google for \$1.1 billion over advertising

PARIS, Sep 22 (Agencies): Seven French media groups plan to sue Google seeking more than 1 billion euros (\$1.1 billion) for alleged anti-competitive practices in online advertising, a report said.

The professional information service Mind Media said the seven groups, representing a total of 22 companies, had either begun or were about to begin legal action.

The move comes after the French competition watchdog fined Google 220 million euros in June 2021 for favouring its own services in the online advertising sector.

"Google has clearly been found guilty of anticompetitive behaviour. The French competition authority has stated that Google has for years favoured its own solutions to the detriment of those of its competitors," said Figaro CEO Marc Feuillee, quoted in the report.

Feuillee said he believed that his group was "a victim of this with the technological system we were using" and was therefore seeking "compensation".

The plaintiffs are Le Figaro, SIPA/Ouest-France, Prisma Media, Les Echos-Le Parisien, Adevinta/Leboncoin, CMA Media and sports daily L'Equipe.

Initial hearings to set the trial schedule took place in early September at the Paris commercial court, and the proceedings could last two to three years. Google's advertising practices are also subject to investigations or proceedings in Britain, the EU and the United

Early in September, the UK's competition watchdog concluded in provisional findings that Google used "anticompetitive practices... which it believes could be harming thousands of UK publishers and advertisers".

Google's VP of Global Ads, Dan Taylor, argued that the case "rests on flawed interpretations" of the sector.

Its parent company Alphabet recently reported that revenue from online ad searches climbed to \$48.5 billion in the second quarter of this year.

iPhone 16 Pro series sees 25 per cent surge in opening sales in India

NEW DELHI, Sep 22 (Agencies): The Pro models of the iPhone 16 series performed well in India's opening sales. A few sellers reported 25 per cent higher opening-day sales for the iPhone 16 Pro series compared to last year.

According to Counterpoint Research's early estimates, first-day sales of the iPhone 16 and iPhone 16 Plus were 20 per cent higher than last year, while sales of the pro models were 25 per cent higher.

Industry leaders attribute the success to the accessible pricing of the iPhone 16 series pro-models, compared

to previous generations. "Our initial assessment suggests that the iPhone 16 series, particularly the Pro models,

has resonated well with the market. The more accessible pricing compared to previous generations has expanded its appeal, aligning with the ongoing trend of premiumisation in the Indian smartphone market. This favorable market dynamics is expected to drive significant upgrades, as evidenced by CyberMedia Research's projection of a 30% year-over-year growth in iPhone 16 sales during the launch quarter," said Prabhu Ram, VP - Industry Research Group (IRG),

standing, of all smartphones sold in India, around 30 per cent of them were iPhones, it includes not just the latest iPhone 16 series, but also other models. However, premium models like the iPhone 16 Pro and iPhone 16 Pro Max are emerging as clear winners," said Kawoosa.

Tarun Pathak, Research Director at Counterpoint, believes that with this momentum, Apple is likely to have a record iPhone sales quarter in India. The company is likely to reach 12 million iPhone sales in India.

"We believe Apple will have a record iPhone sales quarter in India, reaching our estimated 12 million sales," said Pathak.

"There are a couple of reasons. Apple is ready with its India-specific strategy, despite a later rollout. The new iPhone features significant hardware upgrades, including camera, battery, and Apple silicon, compared to last year's base model. Additionally, many people are upgrading their iPhone 11 or iPhone 12 models and are finding the iPhone 16 a great upgrade," added Pathak.

The highly anticipated iPhone 16 series went

on sale on September 20, 2024.

In India, long queues were formed outside stores in Mumbai and Delhi as people eagerly awaited getting their hands on the device.

Interestingly, this year quick-commerce platforms like Blinkit and BB Now have teamed up with Apple retailers like Unicorn to deliver the iPhone 16 directly to customers' doors within minutes of placing the order.

The iPhone 16 series is priced from Rs. 79,900 for the base model, Rs. 89,900 for the iPhone 16 Plus, Rs. 1,19,900 for the 128GB iPhone 16 Pro, and Rs. 1,44,900 for the 256GB iPhone 16 Pro Max, with pre-orders having started on September 13.

Triptan drugs found to be more effective against migraines than newer ones

NEW DELHI, Sep 22 (Agencies): Triptan class of drugs are more effective in treating migraine headaches, compared to newer and more expensive drugs, an analysis of nearly 140 clinical trials, involving about 90,000 participants, has suggested.

The analysis, published in The British Medical Journal, showed that eletriptan, rizatriptan, sumatriptan, and zolmitriptan were better in relieving pain than the relatively recently developed drugs—lasmiditan, rimegepant, and ubrogepant. All these drugs are marketed in India.

Commercially available since the 1990s, triptan drugs work by changing how blood is circulated in brain and by silencing overactive pain nerves, they change how pain is pro-

cessed.

While numerous antimigraine drugs are available, researchers, including those from



Copenhagen University Hospital in Denmark, said that there is clear consensus as to which performs best in treating the neurological condition affecting more than a billion around the world. It is also the leading cause of disability or poor health in girls and women aged 15-49 years.

The researchers said that triptans are widely underused and added that they should be "considered the treatment of choice for migraine episodes, owing to their capacity for inducing rapid and sustained pain freedom."

While some of the triptan class of drugs have been studied to lower menstrual migraines too, which can be more severe and last longer than non-menstrual migraines, women should be cautious and avoid overuse, according to the American Migraine Foundation.

The authors called for an improved access to triptan drugs worldwide by including them into the WHO Model List of Essential Medicines, along with updating international clinical guidelines for diagnosing and managing migraines.

For the study, the researchers identified a total of 137 randomised controlled trials, published up to June 24, 2023, and comprising 89,445 participants—who were aged 40 years on average and 86 per cent of whom were women.

"When the active interventions (drugs) were compared with each other, eletriptan was superior to almost all the other drugs for achieving pain freedom at two hours, followed by rizatriptan, sumatriptan, and zolmitriptan," the authors wrote.

Further, among the triptan drugs, eletriptan was found to be the most effective in bringing about a sustained freedom from pain for up to 24 hours.

The researchers said that the results "offer the best available evidence to guide the choice of acute oral drug interventions for migraine episodes."

Lancet study finds air pollution top risk factor for brain stroke akin to smoking

NEW DELHI, Sep 22 (Agencies): For the first time, a study on Thursday showed that ambient particulate matter air pollution is a top risk factor for subarachnoid haemorrhage—a type of brain stroke—at par with smoking.

The study, led by an international team of researchers from India, the US, New Zealand, Brazil, and UAE showed that air pollution contributed to 14 per cent of the death and disability caused by this serious stroke subtype, on par with smoking.

The study showed that coupled with air pollution, high temperatures as well as metabolic disorders, fuelled a significant rise in global cases and deaths due to stroke in the last three decades.

The number of people worldwide having a new stroke rose to 11.9 million in 2021 -- up by 70 per cent since 1990. Stroke-related deaths rose to 7.3 million—up by 44 per cent since 1990.

The study identified



23 modifiable risk factors responsible for 84 per cent of the stroke burden in 2021.

In 2021, the five leading global risk factors for stroke were high systolic blood pressure, particulate matter air pollution, smoking, high LDL cholesterol, and household air pollution, with considerable variation by age, sex, and location.

It also showed substantial progress made in reducing the global stroke burden by reducing particulate matter air pollution (20 per cent), and smoking (13 per

"With 84 per cent of the stroke burden linked to 23 modifiable risk factors there are tremendous opportunities to alter the trajectory of stroke risk for the next generation. Given that ambient air pollution is reciprocally linked with ambient temperature and climate change, the importance of urgent climate actions and measures to reduce air pollution cannot be overestimated," said co-author Dr Catherine O. Johnson, Lead Research Scientist at the University of Washington's Institute for Health Metrics and Evaluation (IHME).

While stroke is now the third leading cause of death worldwide (after ischaemic heart disease and Covid-19), the condition is highly preventable and treatable.

The researchers called for identifying sustainable ways to work with communities to take

action to prevent and control modifiable risk factors such as high blood sugar and a diet high in sugar-sweetened drinks.

There is a critical need for interventions focused on obesity and metabolic syndromes, Johnson said.

They also called for measures such as clean air zones and public smoking bans, which have been successful.

The findings based on the Global Burden of Disease, Injuries, and Risk Factors Study (GBD) showed that more than three-quarters of those affected by strokes live in low- and middle-income countries

(LMICs). The study also found that worldwide, the overall amount of disability, illness, and early death—a measurement known as disability-adjusted life years (DALYs)—lost to stroke increased by 32 per cent between 1990 and 2021, rising from around 121.4 million years of healthy life lost in 1990 to 160.5 million years in 2021.

Chennai Test: Ashwin scalps 6 wickets as India trump Bangladesh by 280 runs

Maintaining a clean slate against Asian neighbours, India now lead two-match series 1-0; second Test at Kanpur from September 27

CHENNAI, Sep 22 (Agencies): Veteran off-spinner Ravichandran Ashwin's mastery over his craft, underlined by a six-wicket haul, proved too immense for Bangladesh as India cantered to a massive 280-run victory in the first Test with five sessions to spare, here on Sunday.

Maintaining a clean slate against the Asian neighbours, India now lead the two-match series 1-0.

Starting from their overnight 158 for four, Bangladesh were bundled out for 234 in their second innings as Ashwin scythed through their line-up

Ravindra Jadeja supported him with a three-wicket haul

Skipper Najmul Hossain Shanto waged a lone battle for the visitors with a sparkling 82 (127b, 8x4, 3x6), but there was hardly any meaningful support for him from his colleagues.

The day, however, began on a bright note for the Bangladeshis with Shanto and Shakib Al-Hasan (25) extending their fifth-wicket stand to 48 runs, resisting the Indian bowlers in the first hour.

Mohammed Siraj was the standout bowler for India during this phase as he worked up good pace and hit fine lines, but luck was not in his favour as edges eluded him or fell short

It left the pacer a frustrated



man, evidenced in his constant tirade against Shanto, who remained unruffled.

Shakib, who played a lovely front foot pull off Siraj for a boundary, also received a reprieve as Rishabh Pant missed a stumping chance off Jadeja when the batter was on

At the first drinks break of the day, Bangladesh were 194 for four and they might have hoped to further stretch the home side.

However, the introduction of Ashwin immediately after the resumption of play changed the complexion of the proceedings.

There was nothing much on the surface for the spinners but Ashwin, who possesses a scientist's acumen, does not need such generosity from the deck or conditions.

The Chennai man put into use his ability to find acute angles from around the wicket to left-

handers to optimum effect

against Shakib.

Ashwin pushed the ball a bit deep and it hit the handle of Shakib's bat as he attempted a forward defence, and the resultant edge went into the eager hands of Yashasvi Jaiswal at backward short leg.

Soon, the star off-spinner completed his 37th five-wicket haul, equalling Australian legend Shane Warne, nipping the stay of Mehidy Hasan Miraz (8), who lobbed a catch to Jadeja at long-

In the process, Ashwin also went past New Zealand legend Richard Hadlee's five-wicket haul tally - 36. It was also the fourth time the veteran allrounder took five-wicket or more in a Test match alongside a hundred.

Jadeja, the long-time second

fiddle to Ashwin, too had his own moments as he scalped the wickets of Shanto and Litton Das, who edged the left-arm spinner to Rohit Sharma at first

However, Shanto's batting will give a speck of hope for Bangladesh ahead of the next match for the visitors. While the wickets were on a constant tumble at the other end, Shanto batted calmly and with purpose.

The left-hander swept, reverse swept and cut spinners and pacers to collect his runs from all corners of Chepauk. But the task was way beyond such a one-man show on this day. Given his cavalier methods at the crease, the dismissal was inevitable and it came in the 59th over.

Shanto tried to hoist Jadeja out of the park, but the shot lacked power and timing, and Jasprit Bumrah comfortably settled under the ball near mid-wicket.

The dismissal also ended Bangladesh's hopes to last at least beyond the first session, and now they will have to think of ways to regroup ahead of the second Test at Kanpur, beginning September 27. **Brief Scores:**

OTD 1986: India and Australia play historic tied Test in Chennai



CHENNAI, Sep 22 (Agencies): On September 22, 1986 Test cricket witnessed just the second tied match in its history as India and Australia played out a historic game at MA Chidambaram Stadium in Chennai. Heading into Day 5, Australia captain Allan Border declared their second innings on 170/5 setting India a target of 348 in a minimum of 87 overs.

Indian openers Sunil Gavaskar and Krishnamachari Srikkanth were up to the task as the latter came out with an attacking intent and scored 39 (49). On the other hand, Gavaskar played a magnificent innings of 90 (168) and took India's total past

Mohinder Amarnath (51), Mohammad Azharuddin (42), Chandrakant Pandit (39) also made valuable contributions to take India to 291/6 needing 57 more runs to win. With a well set Ravi Shastri and Chetan Sharma, India were cruising at 330/6 just 18 runs adrift of the target.

Just when India looked in complete control of the match, Ray Bright brought Australia back with a remarkable spell and picked three quick wickets to throw the match wide open. At 344/9, all three results were possible and the packed crowd in Chennai was on the edge of their seats witnessing one of the greatest matches ever in the 109-year-long history of the format.

A thrilling finish in last

The equation came down to four needed off

the last over and Ravi Shastri (48*) scored three runs off the first three balls to ensure that doesn't lose. However, the match was still to be won with no 11 Maninder Singh facing Greg Matthews with India one run away from the win. Matthews trapped Maninder in front of the stumps on the penultimate ball of the match and umpire V Vikramraju raised his finger to signal out, a decision he stands firmly on till date.

As a result. Test cricket had its second tied match ever after 26 years after the first one between Australia and West Indies in Brisbane in 1960. Kapil Dev was also adjudged Player of the Match for his brave first innings hundred. The next two matches of the series were drawn and the series ended 0-0.

OTD in 2007: Yuvraj 70 helps India beat Australia to reach **T20 World Cup final**

NEW DELHI, Sep 22 (Agencies): On September 22, 2007, Yuvraj Singh played a blistering 70-run knock to help MS Dhoni-led India thrash Australia in the semi-final and storm into the final of the inaugural ICC T20 World Cup. Under the leadership of MS Dhoni, India registered a thrilling 15-run win, setting up a historic final clash against arch-rivals Pakistan.

Fresh from his unforgettable six sixes in an over against England's Stuart Broad, Yuvraj continued his aggressive form. Right from the outset, Yuvraj took the Australian bowlers to task. His fluent driving, coupled with his trademark effortless pulls, sent the ball flying to all parts of the ground. Yuvraj's battle with Brett Lee and Stuart Clark was particularly enthralling. He smashed Lee for a monstrous 119-meter six, one of the biggest of the tournament, and continued to dominate the Australian pace



Australia, led by Adam Gilchrist, mounted a strong chase but eventually fell short, finishing at 173/7. Matthew Hayden (62 off 47) and Andrew Symonds (43 off 26) kept Australia in the game, but India's disciplined bowling attack, led by Sreesanth and Irfan Pathan, ensured they never got too far ahead. Sreesanth's crucial wicket of Hayden was the turning point, halting Australia's momentum and swinging the match in India's

India's journey to the final was nothing short of a fairytale. Having been written off after their early exit from the 50-over World Cup earlier that year, India entered the tournament as underdogs. Yet, under the inspiring captaincy of a young MS Dhoni, they played fearless cricket. The team, made up of a mix of young talents and experienced players, displayed exceptional resilience and confidence.

Two days after this iconic win, India went on to lift the inaugural ICC T20 World Cup trophy, defeating Pakistan in a nail-biting final at the Wanderers in Johannesburg. Yuvraj's matchwinning performances, especially his memorable 70 against Australia, remain etched in the minds of cricket fans as one of the key moments in India's remarkable T20 World Cup triumph.

Dubois beats up Joshua to retain IBF heavyweight title with brutal 5th-round knockout

Joshua's corner threw in the towel but that wasn't needed. There was no coming back for a boxer whose best days look behind him.

LONDON, Sep 22 (Agencies): Daniel Dubois is no longer an accidental world heavyweight champion.

With a brutal fifth-round knockout of Anthony Joshua in front of 96,000 fans at Wembley Stadium, Dubois showed he might be the real deal — and the future of boxing's marquee division.

"Are you not entertained?" Dubois roared to the crowd after dominating the all-British title fight to complete his quest to legitimize his status as a heavyweight titleholder, three months after gaining the IBF belt vacated by Oleksandr Usyk.

The 27-year-old Dubois entered the ring first — an unusual twist given he was the champion — to strengthen the feeling this was being treated as a homecoming for Joshua, the decade-long darling of British boxing who was bidding to emulate the likes of Muhammad Ali and Lennox Lewis as a threetime heavyweight champ.

Dubois left the ring as the heavyweight's next big thing, having floored Joshua in the first and third rounds before ending the fight 59 seconds into the fifth with a counter right that



sent Joshua face first into the canvas.

Joshua's corner threw in the towel but that wasn't needed. There was no coming back for a boxer whose best days look behind him.

"This is my time, my redemption story," said Dubois, who put himself in position to potentially fight the winner of the Dec. 21 rematch between WBA, WBC and WBO champion Usyk and Tyson Fury. "I'm not going to stop until I reach my full potential."

As for the outclassed Joshua, he vowed to continue boxing after a fourth defeat over the last five years. His promoter, Eddie Hearn, said he wanted to exercise the rematch clause.

This was the worst of all those losses, though, Joshua was saved by the bell in the first and third rounds after the knockdowns and put in a ragged performance throughout, with Dubois getting through his defense with ease.

Joshua never recovered from an overhead right late in the first round that knocked him down. He stuck out his tongue toward Dubois as he returned to his stool but he was clearly hurt, disorientated and vulnerable.

The knockdown late in the third, off a big left from Dubois, dumped Joshua onto his backside through the ropes.

"I had a sharp opponent, a fast opponent," Joshua said. "But a lot of the mistakes were mine.

Joshua has been a marketing phenomenon for the past decade, selling out U.K. stadiums and making hundreds of millions of dollars mainly because of his punching power. He might be back, but surely not as a realistic title contender after slipping to 28-4.

He said after the fight that he wanted another shot at Usvk, to whom he lost in Wroclaw, Poland, last year — but only after sending the Ukrainian to the canvas with a disputed low blow from which Usyk was given time to recover. "I'm a gladiator. I'm a warrior to the bitter end," Dubois said. "I want to go to the top level of this game."

CSK's IPL 2025 retention list: Gaikwad, Jadeja, Pathirana in, says report. No place for...

MS Dhoni's IPL future depends on BCCI's retention policy but Chennai Super Kings have already drafted their shortlist of players they wish to keep.

NEW DELHI, Sep 22 (Agencies): The clock is ticking as the Indian Premier League (IPL) franchises look to finalise their retention shortlist for the forthcoming mega auction. The Board of Control for Cricket in India (BCCI) is reportedly yet to convey the number of retentions a franchise can make ahead of the auction. The entire cricketing fraternity awaits BCCI's

call on the retention policy, but Chennai Super Kings are arguably more desperate to understand the retention guidelines than any other franchise, as the board's policy could decide whether the legendary MS Dhoni plays another season or not.

According to a report in RevSportz, CSK have already drafted a 5-man shortlist of players they wish to retain

ahead of the mega auction. Though there have been reports of the BCCI allowing franchises to retain as many as 6 players, including Right-To-Match, an official decision is yet to be conveyed.

The five players that top CSK's retention list include the likes of Ruturaj Gaikwad, Ravindra Jadeja, Shivam Dube, Matheesha Pathirana, and MS Dhoni.



Surprisingly, there was no place for Deepak Chahar, Devon

Conway, Daryl Mitchell, Maheesh Theekshana, etc. in the retention list

the franchise has reportedly drafted. Considering Dhoni might not play beyond the 2025 season, CSK really took a bold call by letting some of their top players go.

CSK's bosses had earlier also asked BCCI to bring back the old rule which allowed the franchises to retain a retired player in the uncapped category.

However, the board

hasn't yet announced its decision on the subject. Whether such categorisation is allowed or not, isn't yet known, but it is all but certain that Dhoni will be retained in the lowest-paying category.

The said rule allowed players who said goodbye to international cricket for more than 5 years to be treated as uncapped players. The rule started in 2008 and was in implementation till 2021, after which it was discontinued. Dhoni retired from international cricket in 2019. If the rule comes back, Dhoni and CSK would benefit.

Dhoni would be hoping to go on a high in IPL 2025 season, after CSK failed to qualify for the playoffs in the 2024 campaign.

But, his largely depends on the retention policy the BCCI drafts.
