Mirzapur road accident: LG Sinha expresses condolences to families of victims

JAMMU, Oct 4 (Agencies): Lieutenant Governor Manoj Sinha on Friday expressed his condolences to the families of victims died in road accident in Pradesh's Mirzapur.

In a post on X, LG Sinha wrote, "The news of the death of many people in a road accident in Mirzapur, Uttar Pradesh is extremely heartbreaking. I express my deepest condolences to the bereaved families and pray for the Speedy recovery of the injured."

Two soldiers injured in mine blast in Kupwara

SRINAGAR, Oct 4 (Agencies): Two soldiers were injured in a suspected mine blast in Jammu and Kashmir's Kupwara district, officials said on Friday.

They said the blast took place along the Line of Control (LoC) in Trehgam at around 3 am when soldiers were patrolling in the area.

"A Havaldar and a Naik of Army's 19 Sikh were injured in the blast, and both the injured were admitted to hospital in Kupwara." officials said, adding that now the condition of both is stated to be stable.

There is no official word from the army about the blast so far.

Home-Cooked meals become dearer in September as Onion, **Potato prices** shoot up: **Report**

MUMBAI, Oct 4 (Agencies): Homecooked meals became dearer in September compared to a year ago as prices of onion, potato and tomatoes shot up, a report said on Friday.

A vegetarian meal cost went up 11 per cent over year to Rs 31.3 in September from Rs 28.1 in September 2023, and inched up from Rs 31.2 in the preceding August, as per the report by domestic rating agency Crisil. Attributing the rise to firming up in the vegetable prices that account for 37 per cent of a thali cost, the "roti, rice, rate" report elaborated on the factors affecting the overall

Delhi drug probe finds kingpin's links with political party

NEW DELHI, Oct 4 (Agencies): Delhi Police on Thursday arrested another person in connection with the city's biggest-ever drug haul with investigators finding that the main accused had alleged links with leaders of a national political party, officials said.

The arrested accused, Jitender Gill alias Jassi, a UK resident but Indian national, was nabbed from near Punjab's Amritsar airport



He was intending to fly back to London, a senior police officer said.

Gill, aged around 40, had come to India to supervise the drug cartel's operations in the country but was planning to escape after the arrest of four members, the officer said. He said the accused had been living in the UK for the past 25 years but did not have a citizenship.

He is being brought to Delhi and will be produced before the court on Friday to seek custody for interrogation, the officer said.

On Wednesday, the police claimed to have seized over 560 kilograms of cocaine and 40

Supreme Court forms SIT to probe Tirupati laddu row



NEW DELHI, Oct 4 (Agencies): The

Supreme Court on Friday appointed a fivemember independent SIT to probe into alleged use of ghee adulterated with animal fat in preparing laddus offered as prasadam at the famous Tirumala Tirupati Temple in Andhra Pradesh.

A Bench of Justice BR Gavai and Justice KV Viswanathan ordered that the SIT appointed by it will take over the probe into the matter

from the SIT earlier appointed by the Andhra Pradesh Government.

It directed the CBI director to nominate two members to the SIT while the state government would nominate two other members and the fifth member would be nominated by the Food Safety and Authority of India (FSSAI). The **Turn to page 9**

AIIMS Jammu conducts first Clinical Grand Round



Top News Report

JAMMU, Oct 4: AIIMS Vijaypur, Jammu, successfully conducted its first Clinical Grand Round (CGR) as part of an interdepartmental academic activity, under the guidance of Prof. Shakti Kumar Gupta, ED & CEO of AIIMS Jammu, in the pursuit of clinical excellence. The Department of Ophthalmology, led by Dr. Bhavani Raina, Additional Professor, facilitated the CGR, during which two interesting cases were presented.

Dr. Asma Jabeen, Senior Resident, presented a case of Neuroophthalmology under the mentorship of Dr. Nitin Kumar, Associate Professor. The patient was diagnosed with nonarteritic anterior ischemic optic neuropathy and proliferative diabetic retinopathy. Dr. Nitin Kumar elaborated on the diagnostic clues for identifying and appropriately managing such cases. He also explained the investigative modalities available, such as visual

fields and fundus angiography. The possible differential diagnoses were discussed with an expert panel of neurologists.

The second case, presented by Dr. Gaveshna Garg, Junior Resident, was of Ocular Tuberculosis, under the mentorship of Dr. Ridham Nanda, Assistant Professor. The patient exhibited unique features of tubercular retinal vasculitis, which posed various diagnostic dilemmas. The management options were thoroughly discussed, and Dr. Nanda provided key

insights into distinguishing ocular tuberculosis from other similar condi-

Dr. Priya highlighted the various diagnostic techniques available for identifying ocular tuberculosis, while Dr. Taranpreet reviewed the treatment regimens available for the continuation phase in anti-tubercular therapy.

The CGR was an engaging session, offering valuable lessons for clinicians. Prof. Shakti Kumar Gupta emphasized the importance of such multidisciplinary engagements, stating that they foster efficient patient management and encourage interdepartmental research collaborations. He announced that AIIMS Jammu will hold these sessions regularly.

overlooked' PoJK displaced persons: Chuni

JAMMU, Oct 4: The S. O. S. International—the frontline registered organisation spearheading the struggle for the legitimate and genuine rights of displaced persons from Pakistan-occupied Jammu and Kashmir (PoJK) has urged the Lieutenant Governor Manoj Sinha not to nominate a political party candidate for the single seat reserved in the Legislative Assembly for a community of over 12 lakh refugees.

In a memorandum submitted to the Lieutenant Governor today, Rajiv Chuni, the chairman of



SOS International, said that any political appointment for this seat would make the PoJK displaced persons vulnerable to losing their rights which they have partially secured after nearly three decades of struggle. "The reserved seat in

J&K Legislative Assembly should not be treated as a political sanctuary for any individual. It must instead serve its intended purpose of genuinely representing the interests of the displaced community. If we truly want to address the needs of PoJK refugees, a non-political nominee should be considered. Many political figures have represented this community in both the assembly and the upper house, yet they have failed to deliver meaningful results," Chuni said while cautioning against the political appointment for the reserved seat.

The senior refugee leader said they have campaigned relentlessly to unite PoJK refugees both inside and outside Jammu and Kashmir during the struggle of nearly three decades.

"We raised our issues before various government panels including the Wadhawa Committee, constituted by Ghulam Nabi Azad as Chief Minister of J&K in 2007, the 183rd Rajya Sabha Committee led by Venkaiah Naidu, and the Delimitation Commission. While these bodies recommended eight assembly seats for PoJK refugees. their suggestions were overlooked, resulting in the allocation of only one seat for a community of over 12 lakhs displaced persons," he said. Chuni added that the

SOS International was the first organization to call for the political empowerment of PoJK refugees in the early 1990s, advocating for their nomination to eight of the twenty-four vacant assembly seats in the J&K Legislative Assembly.

"Our mission has been to politically empower the community, allowing these vulnerable refugees to voice their concerns freely and without political bias in the Legislative Assembly. We firmly believe that the plight of PoJK refugees is fundamentally a humanitarian issue, deserving of a compassionate approach that rises above party politics," he added.

The refugee leader expressed concern over reports suggesting a political figure may be nominated for this single assembly seat and warned that such a move would further alienate PoJK refugees who have been neglected by successive governments over the past three decades. Chuni said the inten-

tion behind reserving this seat was to empower members of the PoJK displaced community and provide them with a platform to advocate for their rights. "It, therefore, becomes imperative to ensure that the process of nominating a person reflects justice and empowerment for displaced persons from PoJK and it could be achieved only by nominating a non-political person from PoJK displaced persons for the seat," he said.

He hoped that the Lieutenant Governor would move cautiously and address the genuine concerns of PoJK refugees while making a nomination for this reserved seat.

Prime MinisterNarendra Modi: Living the ideals of Mahatma Gandhi

→n April 2024, Iwent and casted my vote and was therefore ■relieved when in June 2024, Shri Narendra Modi became Prime Minister of Bharat for the third time. Mahatma Gandhi or Bapuji as I call him was my grandfather. I lived with him till I was 19. This year, I turn 95 and I feel an urgency to compare Prime Minister Modi with Gandhiji and pen down my thoughts. Generations to come may want to know the views of a family member of Gandhiji who as an adult hadthe privilege of knowing both these human beings.

In my long years I have known many leaders. However, my association with Narendra Bhai stands out as extraordinary. It began during the challenging period of the 1975 Emergency. Though the exact moment can't be recalled, Narendra Bhai was then a young, dynamic pracharak of the RSS.

In the 1970s sectarianism was continuing to eat away at the national fabric. As a Rajya Sabha member from Gujarat, I was deeply worried about the demographic change

underway in the border districts due to heavy infiltration from Pakistan. The influx into Assam was even greater. No one in my Party, the Congress took serious note of this issue. But I clearly remember how Narendra Bhai even at that young age cared about such matters. He was clearly committed to national issues and the politics of the moment didn't diffuse his focus.

Even in those days he was fully seized with the challenges that women faced in rural Bharat personal hygiene; clean drinking water; primary health care for their families etc. Soon after becoming Prime Minister, he demonstratedexemplary courageand articulatedthe need for national cleanliness in his Independence Day speech. He launched the Swachh Bharat Abhiyan which improved sanitation and also the dignity and security of women across Bharat. My grandfather believed in 'Jan Andolan' - people's movement as a basis of sustainable social change. Narendra Bhai's unwavering focus on the word 'Sabka' as inSab ka saath, Sab ka vikas, Sab ka vishwas, andViksit Bharat is the same. These are not mere buzz words for him. Theyare his drivers. His 'humanity first' leadership during the Covid-19 pandemic did not stop at our border, but embraced the entire world. Then again, he swam against the tideto free us from the choking yoke of Article 370. He is systematically completing the agenda that should have been completed after gaining independence. CAA is a case in point.

In this great land of Sanatan Dharma, political freedom was won by the spiritual force of many Masters such as Sai Nath of Shirdi, Shri Ramana Maharshi etc., and Gandhiji became the instrument to spearheadthis. It is no coincidence that decades later, Narendra Bhai has become the instrument to free us from the colonial mind-set. A second struggle of independence.

My grandfather, always said, 'Be the change you wish to see in the world.' Having closely witnessed Narendra Bhai's journey from an RSS worker to the Prime Minister of Bharat, I can say without a doubt that Narendra Modi personifies the change we have all longed for in our beloved Bharat.

While I do not subscribe to hagiography, I must be impartial. The most striking similarity between Bapuji and Narendra Bhai is that their public lives are rooted in the spiritual core of Sanatana Dharma. They both are - Sthithapragnya unaffected by both, the bouquets and the brickbats. Such a person knows that Truth eventually prevails and therefore has no resistance to waiting patiently for that to happen. This would explain the characteristic silence of Narendra Bhai against relentless onslaughts by his political opponents. This is a sign of a Raja Rishi.

As per our scriptures before Dharma is restored, there is alwaysa churning. Negativity is the first output of such a churning, and these negative forces oppose Truth. Daily we are witness to the extentsof this negativity. Even national interests are compromised for political gains. In such circumstances, it takes a person who has absolutely no interest in power, and is incor-

ruptible - to put the interests of the poor and the nation above everything else. It is therefore our duty to acknowledge that even as we enjoy the fruits of Narendra Bhai's efforts, but did not give him the commensurate electoral mandate, he is unaffected and quietly continues with his duty. Let me state without hesitation that had Bapuji been alive today, he would have been a great supporter of Narendra Bhai. Bapuji would have been the first person to warn usabout those who have usurped his name and who have made it their life's mission to misuse itto divide us for their political gains.

It will come as a surprise to the many detractors of my grandfather, and those of Narendra Bhai, thatNarendra Bhai has rejuvenated Gandhiji's ideals by actually integrating them into modern Bharat's development agenda. Directive principles of State policy have become State policy. By doing so he hasensured that Gandhiji's legacycontinues to seep vigorously and ceaselessly into our nation's psyche.

Narendra Bhai just like my grandfather will also have to stand the test of public scrutiny. But, as Lord Krishna told Arjuna, what matters is to do your job and leave the result to Truth – which will prevail eventually. I have faith that history will finally judge both Bapuji and Narendra Bhai kindly.





After suffering a brain stroke in 2020 while shooting for his film LAC: Live the Battle in Kargil triggered by the harsh weather conditions, he had to spend a considerable time in the hospital. mother's milk. I saw that she would die, so I picked her up and brought her home," she recalls, adding that going to Masai Mara National Reserve remains one of her most memorable experiences. "There were so many different animals like cheetahs, lions, elephants, giraffes, various kinds of cows, and I was just silently watching them. It was just beautiful," she shares.

Ask the 31-year-old what makes animals better companions and she says, "I don't know about that, but I definitely find them better than humans as we have somewhere lost our innocence. Animals still possess that innocence and live with it, and I love that. I learn that from them and try to keep it alive in me every day." The actor also admits learning how to forgive and forget from animals: "It doesn't matter



if you have shouted at them or they have done a mistake, they won't hurt you in any way. The next time you call them, they will come back to you with as much love. It's such an impactful message that they teach you about letting go, forgiving and forgetting. All they want to do is love you and I just wish humans could understand that."

Being an animal lover, Gabbi feels hurt when she sees atrocities against animals, and calls for stringent action. "Since childhood, we have been taught to love and be kind and respectful. But as we grew up, we forgot all those important teachings. How would you feel if you saw a video of someone beating a child? That's how I feel when I see videos of humans' bad behaviour towards animals. India is a secular country, and I am sure none of the religions

teach us to be violent towards animals," she asserts, calling out the need for stronger laws: "If you don't consider violence against animals a crime, that's dangerous. If somebody can kill, beat or molest an innocent animal, how can you trust that person to be safer in our society or around children?"

The actor requests people to just "love animals". "Once you have love, you will automatically give them food, shelter during rain and clothes during winters," she says, admitting that she hopes to have an animal farm in future one day. "An image that keeps coming to me is that if I have an animal farm, I want to sleep with my head on a cow's tummy. That's an experience I really want to have in my life," she ends.

Congress wants to take youth to dark world of drugs: Amit Shah on Delhi drug bust



NEW DELHI. Oct 4 (Agencies): Union Home Minister Amit Shah on Friday accused the Congress of leading the nation's youth into the "dark world of drugs" following a recent drug bust in Delhi involving a consignment worth Rs 5,000 crore.

Tushar Goyal, the main accused, was arrested following the recovery of more than 500 kg of cocaine and 40 kg of hydroponic marijuana worth over Rs 5,600 crore in a raid conducted in south Delhi on Wednesday.

The Congress has denied any links with Tushar Goyal, the alleged kingpin behind Delhi's biggest drug

Amit Shah, in a post on X, claimed that while the Modi government is committed to a "zero tolerance" policy on drugs and is working to guide the youth towards education, sports, and innovation, Congress is allegedly using its political influence to enable drug trafficking.

"While the Modi government is adopting a zero-tolerance policy for a 'Drug-Free India,' the involvement of a prominent Congress leader in the Rs 5,600 crore drug consignment seized from North India is extremely dangerous and shameful," Shah posted.

He highlighted the impact of drugs on the youth in states like Punjab and Haryana during the Congress regime, contrasting it with the Modi government's efforts to steer the youth towards sports, education, and innovation. He further accused Congress of attempting to drag the youth back into "the dark world of drugs."

"The sin of Congress leaders using their political influence to push the youth into the quagmire of drugs will never be allowed to succeed by the Modi government," Shah stated, adding that the government is committed to dismantling the entire drug network, regardless of the political standing of those involved.

While the Congress has denied any link with Tushar Goyal, the latter reportedly admitted during questioning that he previously served as the chairman of the RTI cell for Delhi Pradesh Congress until 2022.

Nirmala Sitharaman says living standard of common man to rise steeply

NEW DELHI, Oct 4 (Agencies): Finance Minister Nirmala Sitharaman on Friday said India would achieve near doubling of per capita income in the next five years and witness the steepest rise in living standard of the common man in coming decades aided by structural reforms undertaken by the government in the last 10 years.

Addressing the 3rd edition of Kautiliya Economic Conclave here, the minister said, India's critical economic performance in the recent decade was underscored by its leapfrog from the 10th to the fifth largest economy in a matter of five years.

"While it took us 75 years to reach a per

capita income of USD 2,730, as per IMF projections, it will take only five years to add another USD 2,000. The upcoming decades will see the steepest rise in living standards for the common man, truly making it a period-defining era for an Indian to live in," she said.

She further said India seeks to double its per capita income in a matter of a few years for its 1.4 billion strong population (which makes up 18 per cent of the global total) in a fragmented and fractured world where several persistent conflicts may worsen, posing a threat to global peace that is the bedrock of prosperity.

This is being achieved with declining inequal-

ity, as the Gini coefficient (income inequality benchmark) for rural India declined from 0.283 to 0.266, and for urban areas, it declined from 0.363 to 0.314, she

"I expect these improvements to continue as the effects of the last ten years of economic and structural reforms manifest more thoroughly in the data in the coming years as the Covid shock fades from the economy," she said.

By 2047, as India crosses the 100-year mark of independence, she said, the new Indian era will have core characteristics similar to developed countries.

Viksit Bharat will usher prosperity not just to Indians but to the rest



of the world by becoming central to a vibrant exchange of ideas, technology, and culture, she

Speaking on the country's financial system she said the soundness and resilience of India's banking sector have been underpinned by a sustained policy focus on asset quality improvements, enhanced provisioning

for bad loans, sustained capital adequacy, and a rise in profitability.

NPA (non-performing asset) ratios are at a multi-year low, and banks now have efficient debt recovery mechanisms.

Ensuring that the financial system stays healthy and the cycle lasts longer is another of our core policy priorities, the minister said.

IAF looking at full indigenous inventory by 2047: Air Chief

NEW DELHI, Oct 4 (Agencies): The Indian Air Force (IAF) is looking at having the entire inventory produced in India by 2047, Air Chief Marshal AP Singh said on Friday.

At a press conference ahead of the Air Force Day, the Chief of Air Staff also said China was rapidly building infrastructure along the LAC, especially in the Ladakh sector, and India was also trying to match it.

Delving into geopolitical tensions and conflicts in various geographies, the IAF chief said it was important to have indigenous weapons systems to deal with any future security challenges.



To a question, the Air Chief Marshal said three units of S-400 missile systems were delivered by Russia and it had promised to deliver the remaining two units by next year.

"Today's Ukraine could be tomorrow's East Asia": **Newly elected Japan PM**

TOKYO, Oct 4 (Agencies): Japan's new Prime Minister Shigeru Ishiba warned in his first policy speech Friday that "today's Ukraine could be tomorrow's East Asia" while also dubbing the country's low birth rate a "quiet emergency".

"Many fear that today's Ukraine could be tomorrow's East Asia. Why did deterrence not work in Ukraine?" Ishiba told parliament.

"Combined with the situation in the Middle East, the international community is becoming increasingly divided and confrontational," the 67-year-old former defence minister said.

Ishiba made no direct reference to China but his country's relations with Beijing have deteriorated in recent years as it asserts its military presence around disputed territories in the region.

Of particular concern is Taiwan. Beijing claims the democratic island as part of its territory and has never renounced the use of force to bring the self-ruled island under its control.

Japan has also irked China with plans for a major increase in defence spending and by boosting security ties with the United States and its allies including the Philippines and South Korea.

In August, a Chinese military aircraft staged the first confirmed incursion by China into Japanese airspace, followed weeks later by a Japanese war-

Israel's offensive in Lebanon

BEIRUT, Oct 4 (Agencies): Nearly one quarter of the Lebanese population has been displaced by Israel's military campaign there, the country's caretaker prime minister said today.

Najib Mikati said 1.2 million people -- out of Lebanon's total 2022 population of 5.49 million, according to United Nations data -- have been forced from their homes by Israel's air and ground

"We are trying to cope with these problems, but to tell you the truth, securitywise, the most important thing now is to arrange for them shelter, food and how we can manage these displaced peoples," Mikati said during an online event Wednesday hosted by the American Task Force on Lebanon, a nongovernmental organization.

Mikati said that the number of displaced people is the largest in the nation's history, which has been punctuated by civil war and conflict with neighboring nations.

To date, 867 centers have been opened to receive displaced persons in public schools, educational complexes, vocational institutes and universities, Lebanese authorities said, with more than 200,000 Syrians and more than 76,000 Lebanese also crossing the border into Syria. Israel's bombardment has been especially intense in the south of the country, where Israeli troops are now engaged in heavy fighting with Hezbollah units per Israel Defense Forces battlefield reports.

The IDF has issued evacuation notices for some 90 villages there, warning residents to evacuate north of the Awali River around 37 miles from the Israeli border. Anyone using vehicles to cross from the north to the southern side of the Litani River -- around 18 miles north of the Israeli border -- is endangering their "personal safety," IDF spokesper-

Israel is demanding that Hezbollah withdraw its forces north of the Litani, as the militant group agreed to do as part of a 2006 United Nations Security Council resolution ending the last major cross-border conflict. Airstrikes are also still pummeling Beirut, particularly the densely-populated southern suburb of Dahiya -- known as a Hezbollah stronghold in the capital and described by author Hanin Ghaddar as "Hezbollahland." It was in a bunker under Dahiya that Hezbollah leader Hassan Nasrallah was killed by Israeli strikes on Sept. 27. Israel used bunker-busting bombs in the assassination, an Israeli official familiar with the strike told agency.

The IDF said it is hitting Hezbollah "terrorist infrastructure" and "weapons manufacturing plants" in "precise" strikes in the capital. Meanwhile, Hezbollah units continue firing rockets and drones across the border into Israel.

The IDF has issued multiple evacuation orders for residents of Dahiya. Another series of massive strikes rocked the suburb overnight Thursday. Many people are living on the street, in parks and sheltering under trees. Others sleep on the city's beaches to avoid the attacks. "Another sleepless night in Beirut," the United Nations special coordinator for Lebanon, Jeanine Hennis, wrote on X. "Counting the blasts shaking the city. No warning sirens. Not knowing what's next. Only that uncertainty lies ahead. Anxiety and fear are omnipresent."

Lebanese health officials say more than 1,900 people have been killed across the country since Oct. 8, 2023, when Hezbollah began firing into Israel across the shared border.

More than 9,000 others have been wounded, officials said.

EU tariffs on Chinese electric vehicles are part of an 'economic cold war,' Hungary's Orbán says

BUDAPEST, Oct 4 (Agencies): The European Union risks entering an "economic cold war" with China, Hungary's prime minister said on Friday, pledging to vote against an EU plan to impose higher tariffs on the import of Chinese electric vehicles.

EU countries are set to vote on Friday whether to finalize the tariffs, part of a broader trade dispute over Chinese government subsidies and Beijing's burgeoning exports of green technology to the 27-nation bloc.

The tariffs are expected to pass the vote. But Hungarian Prime Minister Viktor Orbán said on Friday that his country will oppose them, and warned that Europe's tendency toward economic protectionism would destroy the EU's economy.

"What they're making us do, what the European Union is doing, is an economic cold war," Orbán told state radio. "This is the worst thing that can happen to Europe. ... If this continues, the European economy will die," he said.

The EU in July imposed the provisional tariffs of up to 37.6% on EVs made in China, saying they unfairly benefit from government subsidies. Beijing, in response, filed a complaint with the World Trade Organization in August, saying the tariffs violate WTO rules and undermine global cooperation on climate change.

China also launched retaliatory investigations into French cognac exports and European pork in what some analysts fear could develop into an economically harmful trade war with the

Hungary under Orbán has pursued close ties with China and Russia while



its Western partners increasingly seek to distance their economies from those countries. Moscow's war in Ukraine and fears that a flood of inexpensive Chinese products could disrupt Western markets have accelerated those

Meanwhile, Hungary has sought major investment from Beijing, opening a series of Chinese EV battery manufacturing plants across the country. Late last year, it announced that BYD, one of China's largest EV makers, will open its first European production factory in southern Hungary.

Orbán on Friday said that EU protectionism represented a "huge danger" to Hungary's export-oriented economy. His government has declared a policy of "economic neutrality" that favors trade with all willing countries regardless of alliances or geopolitical considerations.

He said Western partners including the EU had "attacked" Hungary over its policies in order to "divert it from the path of economic neutrality."

"What's behind every attack is that they're trying to ... force Hungary into the bloc where they are, where I think there is no growth, no development, no future," he said.

North Korea's Kim threatens to destroy South Korea with nuclear strikes if provoked

SEOUL, Oct 4 (Agencies): North Korean leader Kim Jong Un threatened to use nuclear weapons and destroy South Korea permanently if provoked, state media reported Friday, after the South's leader warned that Kim's regime would collapse if he attempted to use nuclear arms.

The exchange of such rhetoric between the rival Koreas is nothing new, but the latest comments come during heightened animosities over the North's recent disclosure of a nuclear facility and its continuation of missile tests.

Next week, observers say North Korea's rubber-stamp parliament is expected to constitutionally declare a hostile "two-state" system on the Korean Peninsula to formally reject reconciliation with South Korea and codify new national

During a visit to a special operation forces unit on Wednesday, Kim said his military "would use without hesitation all the offensive forces it possesses, including nuclear weapons," if South Korea attempts



to use armed forces encroaching upon the sovereignty of North Korea, according to the North's official Korean Central News Agency.

"If such a situation comes, the permanent existence of Seoul and the Republic of Korea would be impossible," Kim said, using South Korea's official name.

Kim's statement was a response to South Korean President Yoon Suk Yeol's speech at his country's Armed Forces Day on Tuesday. Unveiling South Korea's most powerful Hyunmoo-5 ballistic missile and other conventional weapons that could target North Korea, Yoon said the day that North Korea tries to use nuclear weapons would be the end of the Kim government because Kim would face "the resolute and overwhelming

response" of the South Korean-U.S. alliance.

Kim responded that Yoon's address fully betrayed his "bellicose temerity" and showed "the security uneasiness and irritating psychology of the puppet forces.

In a derisive comment, Kim called Yoon "an abnormal man," saying that "the puppet Yoon bragged about an overwhelming counteraction of military muscle at the doorstep of a state that possesses nuclear weapons." On Thursday, Kim's sister and senior official, Kim Yo Jong, also ridiculed South Korea's showcasing of the Hyunmoo-5 missile, saying there there's no way for South Korea to counter the North Korea's nuclear forces with conventional weapons.

Since adopting an

packed Friday prayer

escalatory nuclear doctrine in 2022, Kim has repeatedly threatened to use nuclear weapons preemptively. But many foreign experts say it's still unlikely that he would use his nuclear arms first because his military is outmatched by the U.S. and its allied forces. In July, South Korea and the U.S. signed a defense quideline on integrating South Korea's conventional capabilities with the U.S. nuclear forces to better deal with North Korea's advancing nuclear program. South Korea has no nuclear weapons.

Animosities between the Koreas are at the worst point in years with Kim's provocative run of missile tests and the South Korean-U.S. military exercises intensifying in a cycle of tit-for-tat. All communication channels and exchange programs between the rivals remain stalled since 2019, when a broader U.S.-North Korea diplomacy on ending the North's nuclear program collapsed.

In January, Kim called for rewriting North Korea's constitution to eliminate the idea of a peaceful unification between the wardivided countries and to cement the South as an "invariable principal enemy."

He also reiterated that his country does not recognize the Northern Limit Line, a western sea boundary that was drawn by the U.S.-led U.N. Command at the end of the 1950-53 Korean War.

He called for the new constitution to include a clear definition of the North's territories. North Korea has traditionally insisted upon a boundary that encroaches deeply into waters currently controlled by South Korea.

On Friday, South Korea's military said North Korea was again flying balloons likely carrying trash across the border into South Korea. Since late May, North Korea has launched thousands of rubbish-carrying balloons toward South Korea, prompting South Korea to resume anti-Pyongyang propaganda loudspeaker broadcasts at border areas.

TEHRAN, Oct 4 (Agencies): Iran's Supreme Leader Ayatollah Ali Khamenei led Friday prayers and delivered a rare sermon, his first in five years, after Tehran launched around 200 missiles on Israel amid escalating tensions in the Middle East. But, not many know that Khamenei, then President, had survived a suicide attack while delivering a sermon in 1985 and resumed his speech after pausing for three

minutes Khamenei, who wields the highest authority as

in Iran, led Muslims in prayer at the Imam Khomeini Grand Mosalla mosque in central Tehran on Friday. The rare Friday sermon came three days before the one-year anniversary of the Israel-Hamas war, triggered by the Iran-backed group's attack on Israel on October 7 last year. The war has also given rise to regional conflicts, including the Israel-Hezbollah conflict and the Israel-Iran conflict.

Khamenei last led Friday prayers in Janu-

ary 2020 after Iran fired missiles at a US army base in Iraq, in response to a strike that killed Revolutionary Guards commander Qassem Soleimani at Baghdad International Airport.

Following an Israeli airstrike which killed Hezbollah chief Hassan Nasrallah in Beirut on September 27, Khamenei was shifted to a secure place. He was not seen in public for a couple of days before he met students and scientists on Wednesday, his first public appearance after he ordered mis-



sile attacks on Israel in retaliation for the Jewish nation's strikes on the Iran-backed Hezbollah, agency reported.

Despite warnings from Israel to attack Iran in response to Tehran's missile barrage, Khamenei appeared at the Imam Khomeini Grand Mosalla mosque and led the Friday prayers. The suicide bombing which had targeted him 39 years ago had not hurt him.

On March 15, 1985, a suicide bomber with explosives strapped on

session at Tehran University when Khamenei, then President, was delivering a sermon. The explosion had killed the bomber and several people, but Khamenei did not suffer any injuries. After pausing for three minutes, Khamenei resumed his sermon amid 'Allahu Akbar' (God is great) chants from the crowd. He then blamed Iraq for attempting to assassinate him and warned that Iran would "answer every fist with a

harder fist".

"We declare here and now that we are capable of retaliation against every action. If Iraq uses chemical weapons, we will give a firmer reply and be sure that we will do it," Khamenei had said shortly, agency reported.

According to state-run IRNA, anti-aircraft fire was heard in many parts of Tehran minutes before the explosion. The suicide bombing had happened during the height of the Iran-Iraq war that went on for eight years

from 1980 to 1988. Khamenei's assassination attempt coincided with fighting between Iranian and Iraqi forces around the Howeiza marshes east of the Tigris River, with both sides claiming the upper hand in the battles, according to The Los Angeles Times.

Fast-forward to October 4, 2024, Khamenei made a public appearance and delivered a sermon at the Friday prayer in front of thousands of people, apparently unshaken and undeterred about what had happened to him 39 years ago.

"Subsequently, it was alleged that the complainant arranged Rs 25 lakh and directed his relative to deliver the money after contacting the mobile number. The money was delivered to the recipient who arrived in Aurangabad, Bihar," a CBI spokesperson said. The CBI alleged that Singh was in contact with the accused middleman who along with another middleman was present in Aurangabad, Bihar, around 11:30 pm on the day of the incident, corroborating the reported delivery of the bribe.

Singh again summoned Yadav on October 1 where a demand of Rs 70 lakh was made with instructions to deliver half the amount the same day in Patna, the CBI alleged.

"The accused deputy SP again gave Yadav a handwritten note containing a mobile number. Later, the complainant contacted the given phone number and sought some time to arrange the money and assured that the money would be delivered on October 3 in Gaya," the CBI spokesperson said.

The CBI informed senior officers of the NIA about the entire episode.

After verification of the inputs, the CBI laid a trap in coordination with the NIA.

"The CBI today apprehended the accused investigation officer, Deputy Superintendent of Police (Dy SP) Ajay Pratap Singh, and his two agents while accepting an illegal gratification of Rs 20 lakh from the complainant," said a statement issued by

Apart from Goyal, the special cell on Wednesday arrested Himanshu Kumar (27) and Aurangzeb Siddiqui (23) of Delhi and Bharat Kumar Jain (48) of Mumbai. and confiscated the consignment weighing over 602 kilograms which were kept in sacks in the godown.

The officer said it also emerged during interrogation that all the four accused were planning to sell a large quantity of drugs in concerts, rave parties and upscale localities in Delhi and other metropolitan cities.

"We have formed several teams to nab the other members of the group," the officer said

Police officials said around a dozen people from India and abroad were allegedly involved in the international syndicate of smuggling of banned drugs from middleeast countries to India.

Supreme Court forms SIT to probe Tirupati laddu row

The Bench, however, clarified that its order was in no way a reflection on the independence or otherwise of the state government-appointed SIT.

"We are appointing an independent SIT just to assuage the feelings of crores of devotees of the deity residing across the world," the Bench said.

The top court had rapped Andhra Pradesh Chief Minister N Chandrababu Naidu for going public with allegations about use of adulterated ghee for preparing laddus at the Tirumala Tirupati Temple, saying it was inappropriate for him to make such a statement without waiting for outcome of a probe ordered by the state.

"At least, we expect the Gods to be kept away from politics," the Bench had said, as it sought to know if there was a need to make a public statement when a probe into the matter had already been ordered and the report was awaited.

"We are prima facie of the view that when the investigation was under process, it was not appropriate for the high constitutional authority (Naidu) to make a statement which can affect the sentiments of crores of people," the Bench said.

While hearing petitions seeking an independent probe into the alleged use of animal fat for preparing prasadam at the Tirupati temple, the top court sought to know what proof was there to indicate that contaminated ghee was used in making

The petitioners included senior BJP leader Subramanian Swamy; YV Subba Reddy – a Rajya Sabha MP and former Chairman of Tirupati Tirumala Devasthanam which manages Tirupati Temple; historian Vikram Sampath and spiritual leader Dushyanth Sridhar; and Sudarshan News Editor-in-Chief Suresh Chavhanke.

Mehta had submitted that it was a matter of faith and if contaminated ghee was used in preparing laddus at the Tirupati temple, it was unacceptable.

Naidu had alleged that animal fat was used in preparing Tirupati laddus during the previous YS Jagan Mohan Reddy-led government in Andhra Pradesh, triggering a massive political row even as YSR Congress Party accused Naidu of indulging in "heinous allegations" for political gains.

"Prices of onion, potato and tomato rose 53 per cent, 50 per cent and 18 per cent on-year, respectively, in September because of lower onion and potato arrivals, while heavy rainfall impacted tomato output in Andhra Pradesh and Maharashtra," it explained. Prices of pulses jumped 14 per cent on year due a drop in production, while fuel dropped 11 per cent due to a price cut earlier in the year, the report said. In the case of a non-vegetarian thali, the meal cost dropped by 2 per cent on year to Rs 59.3 on a 13 per cent decline in broiler prices which have a 50 per cent weightage.

A non-veg meal cost, which also includes the payouts on vegetables but dal gets replaced with broiler, was flat compared to the rate in August, the report said.

Impure drinking water supplied to Kishtwar residents: Ajeet Bhagat

KISHTWAR. Oct 4: Ajeet Bhagat, a senior leader and spokesperson for the Jammu and Kashmir National Conference in the Chenab Valley Zone, has raised serious concerns regarding the supply of unhygienic drinking water to the residents of Kishtwar by the Public Health Engineering Department (PHE).

Bhagat criticized the PHE for providing unfiltered water, which is contributing to the spread of waterborne diseases in the area

He pointed out that the primary sources of drinking water in Kishtwar are the Naigadh and Lahala water supply schemes. Despite the establishment of filtration plants by previous governments. these facilities have remained abandoned for decades, leading to the distribution of unfiltered and impure drinking water.

The situation is compounded by the fact that



water is being supplied through pipes without any filtration.

Additionally, Bhagat highlighted that many pipes have developed leaks while passing through various drains in Kishtwar. This results in contaminated water mixing with the drinking supply, further increasing the risk of waterborne diseases among residents.

In light of these issues, Bhagat has urged the relevant authorities to make the filtration plants operational again.

He emphasized that ensuring access to hygienic drinking water is essential for the health and wellbeing of Kishtwar's residents.

Their resilience and determination led to a solid 165-run partnership, which brought the side back into contention. Jurel and Easwaran looked set to achieve their individual milestones, but the fourth day of play brought heartbreak for both.

Dhruv Jurel fell agonizingly short of his century, dismissed for 93, and shortly after, Easwaran's brilliant knock came to an end at 191. Their dismissals were a crucial turning point for Mumbai, with Shams Mulani playing the role of the hero. Mulani, who has been in excellent form since the Duleep Trophy 2024, managed to dislodge both set batters, breaking the momentum that Rest of India had built.

Easwaran and Jurel's contributions were key to Rest of India's fightback, but the loss of their wickets made the task more difficult for the team. Despite missing their individual landmarks, both batsmen were instrumental in keeping the contest alive and ensuring that Rest of India remained competitive in this high-stakes encounter.

Delhi Capitals co-owner hints at 6 players team will retain, no place for Australia great

(Agencies): Delhi Capitals co-owner Parth Jindal has given a massive update about the team's retentions. He said that DC captain Rishabh Pant "will definitely be retained". Notably, the Board of Control for Cricket in India recently announced the rules ahead of the auction that is expected to take place in November this year. A franchise could retain a maximum of 6 players with Right-To-Match option included in it. The reported deadline for the franchises to submit their list of retentions is October 31.

"Yes, we definitely have to retain. We have some very good players in our team. The rules have come out now, so after discussing with GMR and our director of cricket, Sourav Ganguly, decisions will be made. Rishabh Pant will definitely be retained," Jindal said in a video shared by IANS on X, formerly Twitter.

"We also have Axar Patel, who is excellent, Tristan Stubbs, Jake Fraser-McGurk, Kuldeep Yadav, Abishek Porel, Mukesh Kumar, and Khaleel Ahmed. all very good players in our team. We'll see what happens in the auction. But first, as per the rule, we can retain six players. After discussions, we will proceed with the auction and see what happens," he added.

There was no place for Australia great David Warner in the list of players that Jindal took. According to the new retention rules, any player who has not played for India in the past five years will be considered 'uncapped' and can be retained for a significantly lower price. That is a good news for Chennai Super Kings who are likely to use this rule to retain former captain MS Dhoni.

An uncapped player could be retained for an amount as low as Rs 4 crore, say reports. This gives CSK a cushion to retain Dhoni that too while saving a capped player option.

Although Dhoni retired from international cricket in 2020, he last played for India in July 2019. His final game was against New Zealand in the 2019 ODI World Cup semi-final that India lost.

IOA president Usha calls meeting to discuss CEO appointment delay



NEW DELHI, Oct 4 (Agencies): Indian Olympic Association (IOA) president PT Usha has taken her fight for good governance to the general body. Usha has called for a Special General Meeting (SGM) on October 25 to discuss amongst other issues the appointment of a CEO and various charges against fellow executive committee members.

Raghuram Iyer was chosen for the CEO's role by the nomination committee headed by MC Mary Kom but the EC has not yet agreed to his appointment. The rift has ensured that Iyer has not been paid any money since his appointment was announced in January.

Usha has penned a

16-point agenda for the SGM. It includes IOA treasurer Sahdev Yadav writing off the Rs 1.75 crore that the Indian Weightlifting Federation (IWLF) owes the Olympics body. Yadav has been part of the IOA Finance Committee since 2017.

Pointing out that the CEO's role was vital and the continued resistance by the EC may derail India's bid for the 2026 Olympics, Usha has made lyer's appointment issue top of the agenda items.

"Firstly, as per the IOA's Constitution, the appointment of the CEO must be finalised within one month of the position becoming vacant. The entire process was undertaken in accordance with the provi-

sions contained in the IOA's Constitution and in a most transparent manner, with each and every step being documented and record of discussions confirmed by the three members of the Nomination Committee," Usha wrote.

"However, despite the constitutional mandate and the recognition of this appointment by both the International Olympic Committee (IOC) and the Ministry of Youth Affairs & Sports, Government of India, certain members of the Executive Council (EC) have been refusing to accept the appointment. We are now approaching almost two years since the election, and this continued resistance poses a significant obstacle to the functioning of the IOA and the broader interests of the Indian sports community," she added.

It is not only Yadav who is facing the heat. All India Tennis Association (AITA) caretaker treasurer and EC member Rohit Rajpal and joint secretary Kalyan Chaubey are all in the dock.

"Secondly, regarding corruption, I am committed to address and eliminate all such activities that have previously tainted our sporting community," she wrote.

India trio wins men's team gold in Junior Shooting World Championship, India stay top of medal tally
