JAMMU, Oct 6: The former president of Jammu University Research Scholars Executive Association (JURSEA), Dr Vikas Sharma today made a startling disclosure regarding the state of affairs in Directorate of Distance Education (DDE) of University of Jammu (JU) stating that the courses being run there sans approval of Distance Education Bureau (DEB) of University Grants Commission (UGC)

Addressing a press conference, Dr Sharma alleged that the DDE had failed to obtain necessary approval from the UGC to run Post Graduate and Undergraduate under distance mode which has put at risk the career of thousands of students who are pursuing their courses from JU's DDE.

He also highlighted that JU miserably failed to get approval to run Online Mode courses which was evident from the fact that it got approval only for two courses where University of Kashmir got eight courses in the list. "DDE Director Prof Pankaj Srivastava only went for two Online Courses i.e. MA English and M.Com and that too owing to his personal interest whereas, he could have secured 7-8 courses and made something remarkable for the students of Jammu region. It is pathetic that

only 5 students have got themselves enrolled for M.A English whereas M.Com has attracted zero. It means that these courses were not liked by students at all for online mode," he claimed.

Dr Sharma alleged that it was due to incompetence of the incumbent Vice Chancellor that affairs in DDE have gotten murkier and chaos was at its peak. "The Vice Chancellor is only worried about getting his term extended to enjoy the privileges of post whereas the career of hundreds of students pursuing their studies in JU has been compromised," he further said. The former JURSEA president demanded from the LG administration to immediately order an enquiry into this whole fiasco and get the DEB approval at the earliest to

JAMMU, Oct 6: Sunil Dimple, president of Mission Statehood, held a significant meeting today with Dr. Farooq Abdullah at his residence, focusing on pressing issues facing Jammu and Kashmir post-abrogation of Article 370, including the restoration of statehood and the dismantling of Jammu and Kashmir into union territories. The two leaders discussed the hardships faced by the people, particularly the youth, and outlined future strategies in light of upcoming assembly elections.

During the meeting, Dimple congratulated Dr. Abdullah on the potential for a National Conference-Congress alliance to form a majority government. expressing public support for Abdullah and his son, Omar, as chief ministers. Dr. Abdullah, however, declined the chief ministerial role, emphasizing the need to empower the younger generation.

Dr. Abdullah assured Dimple that restoring Jammu and Kashmir's statehood, initiating the darbar move, addressing unemployment, and reinstating Article 370 would be priorities for



the new government. He acknowledged the need for substantial work to get the state back on track and promised to address demands including the implementation of the Instrument of Accession, reduction of electricity tariffs, and provision of free electricity for the first

200 units Dimple criticized the BJP's alleged strategy to introduce five nominated MLAs into the assembly, calling it a conspiracy to undermine the democratic process and concentrate power in the hands of the Lieutenant Governor. He expressed concerns over the disproportionate powers given to the LG compared to elected officials. claiming this approach keeps the people of Jammu and Kashmir marginalized. Emphasizing the importance of a Jammu-Kashernment, Dimple highlighted the recent high voter turnout as a clear rejection of the BJP's actions since August 5, 2019. He argued that the significant voting percentage indicated widespread discontent with the abrogation of Article 370 and the division of the state into union territories.

Dimple called on the Election Commission of India to disclose the financial expenditures of the BJP in the assembly elections, alleging that the party has funded proxy candidates and spent approximately five thousand crores to manipulate the electoral landscape. He reaffirmed his commitment to the mission for statehood, including the restoration of Article 370 and 35A, pledging that the fight for rights will continue vigorously.

he votes are stacked in the EVM's and in a few days and L to be specific on 8th of October 2024 that is during the annual festival of Navratra ,the outcome of the crucial and historical assembly elections will be out .It is on the same date which will be the momentous occasion politically that it will be almost clear which combination of parties or which alliance will be in a position to form a coalition government. There has been a prepoll alliance between the NC and Congress and the two parties had fought polls jointly .However there is every scope and possibility of a post poll alliance as well to muster the majority support to form a coalition government .As far a political scenario of the Jammu and Kashmir is concerned ,at the end of the counting of votes ,no single party will get the majority to form a government at its own .Thus this time there is utmost need and necessity of coalition politics as coalition era has come to stay in India and J&K is no exception to this reality and thus all indications are there that at the end of the day a coalition government is hundred percent possibil-ity .In the murkier field of politics very thing is a possibility .There are strange bedfellows in politics and as they say everything is fair in politics ,love and war and thus there can emerge any equation , permutation and combination in J&K politics. In politics it is not uncommon to see that snakes marry rates and bulls chase lizard's .Thus anything can happen in politics and because of this politicians are different genre from statesmen. There are speculation a buzz in political circles that something is going on between two parties of NC and BJP which though are north pole and south pole, but in politics the opposite poles can meet .Even there are gossips in public

circles that something is being cooked behind curtains between the BJP and NC .Some opine that back channels diplomacy and talks are on between NC and BJP and at the end of political churning a coalition arrangement between the NC and BJP may be a possibility .When BJP and PDP has formed a coalition government in 2015, there seems no wrong in coming closer of BJP and NC and the two parties which were opposite to each other to cobble a coalition government .It follows that there is possibility of a post poll alliance between the NC and BJP to form a coalition government .In fact J&K government formation may come down to post-poll jockeying .Jammu is where BJP is formidable while Congress –NC alliance has a mere even geographic footprint .Independents are the wild card in this election , which may not throw up a clear winner on counting day .While the BJP has contested independently ,the Congress has a prepoll alliance with the NC ,making it a formidable force .Regional parties ,including NC and PDP ,along with other new political outfits ,were largely invisible in Jammu's electoral scene .Since 2014,the BJP has significantly increased its presence in Jammu ,a stark contrast to its single -seat win in 2002.In 2014 elections ,the party won 19 out of 24 assembly seats .Even in recent Lok Sabha polls, the BJP reinforced its dominance in Jammu by winning both seats of the Jammu and Udhampur constituencies . Analysts believe that BJP's success in Hindumajority region of Jammu can be attributed to Prime Minister Narender Modi's influence and the party's pro-Hindu policies and stance .It may continue in 2024 JK polls and the BJP will emerge a larger party in Jammu region giving it the handle to attract the independents which are in large numbers in this election and the BJP may attract its

bête noire the NC to its side and the two parties will emerge larger parties in these elections and may form a coalition government which will care for the people and try to address the main issues and concerns of the people of the UT .In fact since BJP could gain an advantage from the 2022 delimitation exercise , which raised the number of assembly seats in J&K from 83 to 90.Of the seven additional seats ,six were allocated to Jammu and only one to Kashmir .The voting rights granted this year by the government to 30,000 families of West Pakistan Refugees-WPR and those displaced by the 1965 Indo-Pak war in Jammu region -primarily from the Hindu community as well the vote to Valmiki community and Gurkhas will also benefit BJP as all these groups of people have voted for the saffron party .The introduction of nine reserved seats in J&K for Scheduled Tribes , coupled with new political parties seen as proxies of the BJP and the independent candidates ,could definitely enhance the BJP's chances of forming a coalition government similar to their success in 2014.Based on the election mood and past trends in J&K ,the outcome according to analysts could be either be a hung assembly or a coalition government. Traditionally NC is expected to get more seats in Kashmir region as against the BJP getting more seats in Jammu region .At the end no party will get a majority of seats on its own and therefore coalition is the foregone conclusion .As the electoral outcomes will emerge at the end of counting of votes, it seems that NC and BJP may emerge the two larger parties from Kashmir and Jammu regions respectively and in that case a post-poll alliance may be entered between the NC and BJP and they may form a coalition or alliance government in accordance with the fractured mandate of J&K people.

Meanwhile the stage is set for the nomination of 5MLA's from KP community and POJK refugees and the LG will nominate these MLA's before the government formation .Thus the nominated five MLA's will support BJP coalition in government formation .The Congress ,NC and PDP opposes the move to nominate MLA's before government formation as it will tilt the balance of power in favor of BJP .Political analysts opine that if NC will align with BJP, it will benefit the gullible people of the mountainous UT as the Modi government will give generous funds and allocations to Jammu and Kashmir and it will increase the tempo of development in J&K and it will definitely benefit the people of Jammu and Kashmir .There are speculations going in the public that some informal talks are going between the regional mainstream party NC and the national party BJP about the possibility of alliance between the two parties to stitch a coalition arrangement in Jammu and Kashmir to give the alienated people a responsive and transparent government which will care for the interests of the people. NC was an alliance partner in Vajpayee's NDA government and so there is no harm in NC and BJP entering into post -poll alliance to form a coalition government .Let the NC and BJP experiment a coalition government so as to keep away the unwanted governor Raj which is in no way in the interest of people as people's democratic government is the best alternative and let the political parties here learn the art of coalition government and give one to the UT so that J&K is saved from again falling in the ditch of governor's or LG's rule.

Chandel accuses China and Pakistan of dividing India along religious lines

Removal of women elected representative can't be treated lightly: Supreme Court

NEW DELHI, Oct 6 (Agencies): Removal of an elected public representative should not be treated lightly, especially when it concerns women belonging to rural areas, the Supreme Court has said as it set aside an order for removal of a woman sarpanch in a Maharashtra village.

A bench of Justices Surya Kant and Ujjal Bhuyan termed the matter as a classic case where the residents of the village could not reconcile with the fact that a woman was elected to the office of the sarpanch.

The top court observed that it was a case where villagers were unable to come to terms with the reality that a female sarpanch would make decisions on their behalf and that they would have to abide by her directions

"This scenario gets further exacerbated when we as a country are attempting to realise the progressive goal of gender parity and women empowerment across all spheres, including public offices and most importantly adequate women representative in elected bodies, such instances at the grass-root level cast a heavy shadow on any headway that we may have achieved," the bench observed in its September 27 order.

Underscoring that it must be acknowledged that these women, who succeed in occupying such public offices, do so only after significant struggle, the bench said. "All that we would like to reiterate is that the matter of removal of an elected

The Central government has cleared five semiconductor manufacturing proposals, visions and practically every device.

All the initiatives taken so far, whether it is the Digital India Mission or the telecom mission, have brought technology into the hands of common citizens.

According to the reports, India's semiconductor-related market will reach 64 billion dollars in 2026, nearly triple the size in 2019. Towards achieving this goal, the 'Semicon India' initiative allows financial support for front-end fabrication units, sensors, display manufacturing, display fabs, semiconductor packaging and compound semiconductors. As per the experts, "by expanding production capabilities, the country is poised to become a major player in the semiconductor sector. National initiatives, such as the Semicon India Programme and the India Semiconductor Mission (ISM), are focused on capturing a significant share of the global market, driving innovation, and stimulating economic growth through job creation and technological advancement."

Claims on economy conceal choke points that will strangulate growth, says Congress

NEW DELHI, Oct 6 (Agencies): Asserting that the last 10 years have seen "highly detrimental economic trends", the Congress on Sunday said the monsoon has receded but at least "three dark clouds" of languishing private sector investment, stagnating manufacturing and decline in real wages and productivity for labourers, still loom over the Indian economy.

Congress general secretary in-charge communications Jairam Ramesh said bombastic claims on the economy are being made by Prime Minister Narendra Modi, but what these claims conceal are the choke points that will strangulate growth in the years to come if not taken seriously now.

After a brief surge in private sector investment during 2022-23, new project announcements in the private sector fell by 21 per cent between FY23 and FY24, he pointed out.

In this context, rather than growing their businesses, companies are using profits to reduce debt burdens, he claimed.

"We are witnessing a growing financialisation of the Indian economy, with India Inc. - perhaps taking its cue from the government - focusing on stock market valuations rather than topline revenue growth," Ramesh said.

Secondly, ten years after the government's flagship Make in India scheme was launched, India's manufacturing is stagnating. As a share of GDP. manufacturing is the same as it was ten years ago," the Congress leader said.



Ramesh pointed out that as a share of total employment, manufacturing has marginally declined. The country's share in global merchandise exports has also largely stagnated. He further said that growth in India's share of global exports grew much faster in the 2005-15 period, largely corresponding to Dr. Manmohan Singh's tenure as Prime Minister. In labour-intensive sectors

like garments, exports have fallen from USD 15 billion in 2013-14 to USD 14. 5 billion in 2023-2024.

This shrinking of manufacturing is largely attributable to the PM's inexplicable trade policy - where it disincentivizes participation in global value chains (GVCs) through high tariffs while silently permitting Chinese dumping of mass imports, Ramesh alleged.

Decrease in labour productivity has impacted real wage growth Third, the latest Annual Survey of Industries (ASI) for 2022-2023 has revealed a decline in real wages and productivity for India's labourers. The growth in GVA per

worker slowed from 6. 6% in 2014-15 to 0. 6% by 2018-19, adding that this decrease in labour productivity has impacted real wage growth, especially amidst rising inflation. "These are merely the issues that have surfaced in the past few weeks but the last ten years have seen other highly detrimental economic trends, including rising oligopolisation, mass unemployment,

and high inflation," he

Two children killed in separate incidents of attacks by wild animals in UP's Lakhimpur Kheri



LAKHIMPUR KHERI, Oct 6 (Agencies): Two children were killed in separate incidents of attacks by wild animals in this district, police said on Sunday. The first incident took place in Shardanagar forest range of South Kheri forest division. A wild animal, alleged to be a leopard,

took away a 12-year-old child named Sajeb of Gangabehar village while he was pushing his father's bicycle on Saturday evening.

The animal killed the child and his dead body was later recovered from a sugarcane field, about 500 meters away from the village, on Saturday night, the police said.

The victim's father, Munavvar, said that he was carrying fertilizer sacks on his bicycle to his village while his son was pushing the bicycle to help him. The route passed through dense sugarcane fields.

A leopard hiding in a sugarcane field came out of its hiding and dragged Sajeb inside the cane fields, he added. After a hectic search, Sajeb's dead body was recovered from a cane field. Divisional Forest Officer (DFO), South Kheri, Sanjay Biswal, confirmed the incident and said that forest teams had been rushed to the spot and efforts were on to identify the wild animal, which might be a leopard.

The second incident took place in Kurtaiha village under Padhuva police limits, where a three-year-old Riza Bano was killed in a wild animal's attack.

Her dead body was recovered floating in the Ghaghra river on Saturday. The village falls under buffer zone of Dudhwa Tiger Reserve (DTR).

Her mother said that a wolf had entered her home on Friday night and took away the child from her. However, the officials suspected that a leopard had attacked the girl.

Field Director, Dudhwa, Lalit Verma, said the presence of wolves in the area had never been earlier reported.

24 killed as Israeli airstrike hits mosque in Gaza, claims Palestinian media

An Israeli airstrike on a mosque in central Gaza killed 24 and injured many. The Israeli military said in a statement it conducted a precise strike on Hamas terrorists who were operating within a command and control centre.

DEIR AL-BALAH, Oct 6 (Agencies): At least 24 people were killed and 93 others wounded when Israeli airstrikes targeted a mosque and a school sheltering displaced people in the Gaza Strip early on Sunday morning, the Hamas-run Gaza government media office said.

The strikes on the mosque and the school, near the Al-Aqsa Hospital in Deir al-Balah in the central Gaza Strip, came as the war between Israel and Palestinian militant group Hamas in the enclave approaches its first anniversary.

In its own statement, the Israeli military said it conducted "pre-



cise strikes on Hamas terrorists" who were operating within

The latest bloodshed in the decades-old Israeli-Palestinian conflict was triggered when Hamas attacked southern Israel on October 7, 2023, killing 1,200 people and taking about 250 as hostages, according to Israeli tallies.

Israel's subsequent military assault on Gaza has killed nearly 42,000 Palestinians, according to Gaza's health ministry. It has also displaced nearly all of the enclave's 2.3 million people, caused a hunger crisis and led to genocide allegations at the World Court that Israel denies.

'propaganda factory' and demand unbiased press

BUDAPEST, Oct 6 (Agencies): Thousands of protesters gathered outside the headquarters of Hungary's public media corporation to demonstrate against what they say is an entrenched propaganda network operated by the nationalist government at taxpayer expense.

The protest was organized by Hungary's most prominent opposition figure, Péter Magyar, and his upstart TISZA party, which has emerged in recent months as the most serious political challenge for Prime Minister Viktor Orbán since he took power nearly 15 years ago.

Magyar, whose party received nearly 30% of the vote in European Union elections this summer and is polling within a few points of the governing Fidesz party, has been outspoken about what he sees as the damage Orbán's "propaganda factory" has done to Hungary's democracy.

"What is happening here in Hungary in 2024, and calling itself 'public service' media, is a global scandal," Magyar told the crowd in Budapest. "Enough of the nastiness, enough of the lies, enough of the propaganda. Our patience has run out. The time for confrontation has come."

Both Hungarian and international observers have long warned that press freedom in the Central European country was under threat, and that Orbán's party has used media buyouts by government-connected business tycoons to build a pro-government media empire.

Media watchdog Reporters Without Borders estimates that such buyouts have given Orbán's party control of some 80% of Hungary's media market resources. In 2021, the group put Orbán on its list of media "predators," the first EU leader to earn the distinction.

Balázs Tömpe, a protester that traveled several hours to attend the demonstration, called the state media headquarters a "factory of lies."

"The propaganda goes out at such a level and is so unbalanced that it's blood boiling, and I think we need to raise our voices," he said. "It's nonsense that only government propaganda comes out in the media that is financed by the taxpayers."

A retired teacher from southern Hungary, Ágnes Gera, said dissenting voices were censored from the public media, limiting Hungarians' access to information about political alternatives. "It's very burdensome and unfortunate that the system works this way where the public only hears from one

SEOUL, Oct 6 (Agencies): The leaders of North Korea and China marked the 75th anniversary of their diplomatic relations on Sunday by exchanging messages that expressed hopes for stronger ties, as outsiders raised questions about their relationship.

The message exchange came as North Korea and Russia have been sharply expanding their cooperation while China apparently keeps its distance. Experts say that the level of exchanges and commemorative programs between North Korea and China in the coming months will provide a clue to the exact status of their ties.

In a message sent to Chinese President Xi Jinping, North Korean leader Kim Jong Un said his government will "steadily strive to consolidate and develop the friendly and cooperative relations" between the two countries, according to North Korea's official Korean Central News Agency.

Xi in his message to Kim said

Since North Korea and China established diplomatic ties on Oct. 6, 1949, their relationship has often been described as being "as close as lips and teeth." China, North Korea's biggest trading partner and main aid provider, has been suspected of avoiding fully implementing U.N. sanctions on North Korea and sending clandestine aid shipments to help its impoverished neighbor stay afloat and continue to serve as a bulwark against U.S. influence on the Korean Peninsula.

But many observers say China is reluctant to form a three-way, anti-West alliance with North Korea and Russia as it prefers a stable regional security environment to tackle numerous economic challenges and maintain relationships with Europe and its Asian neighbors. outside suspicions that North Korea has supplied conventional weapons to Russia for its war in Ukraine in return for military and economic assistance. During a meeting in Pyongyang in June, Kim and Russian President Vladimir Putin signed a pact stipulating mutual military assistance if either country is attacked, in what was considered the two countries' biggest defense deal since the end of the Cold War.

North Korea is locked in confrontations with the U.S., South Korea and their partners over its advancing nuclear program. Kim has said he was forced to expand both nuclear and conventional capabilities to cope with U.S.-led security threats.

On Sunday, KCNA reported that Kim oversaw a live artillery firing drill by cadets of a military academy. After watching the drill, Kim said training programs at the military academy must focus on "the guerrilla war tactics to wipe out the enemies through rapid mobile and surprise operations," according to KCNA.

Survivors grapple with aid cuts and the Taliban a year after massive Afghan earthquake

The devastating earthquake that hit western Afghanistan's Herat province a year ago was a major challenge for the Taliban

KABUL, Oct 6 (Agencies): People had just seconds to flee their homes when the terrifying sound of earth cracking open reverberated across western Afghanistan's Herat province.

Nobody knows for sure how many people died in a 6.3 magnitude earthquake on Oct. 7, 2023, or in the strong aftershocks that followed. The Taliban government estimated that at least 4,000 perished. The U.N. gave a far lower figure of about 1,500. Survivors stopped counting, exhausted after digging through dirt to save their loved ones or bury them.

It was the deadliest natural disaster to strike Afghanistan in recent memory.

It was also another major challenge for the Taliban since they seized power in 2021, a test of their readiness to lead a country beset by economic hardship, isolation, devastation from decades of war, and vulnerability to shocks like earthquakes and climate change.

"At that time, the government really cooperated in transporting patients and the dead," said Ismatullah Rahmani, from the quake's epicenter in Zinda Jan district, where every home, usually built of mud and timber, was levelled. His brother and nephew were killed, and he spent hours trying to free his wife from under 1 1/2-meter (60 inches) of soil. She survived.

"They opened hospitals and provided water and food to people for free," he told The Associated Press from his new home in Zinda Jan. He said the Taliban went to camps and helped survivors over several months, a blessing ahead of the harsh Herat winter.

"After that, our aid stopped," said Rahmani.

Charities had stepped in to build housing for survivors. But the accommodation they built lacks walls so there is no privacy, while the poor design leaves them vulnerable to storms or heavy rainfall. Houses either have no bathrooms or the bathrooms don't have a roof.

Rahmani's village, Naib Rafi, still doesn't have a health clinic or a school. Instead, children are learning in tents.

The government didn't pro-



vide financial assistance, he said. Senior officials and Islamic scholars visited communities a few times, listened to people's problems

and left. Ahmadullah Muttaqi, spokesman and member of the Herat Earthquake Commission, said authorities worked with charities and nongovernmental groups to provide shelter and medical assistance.

"People's problems haven't been solved, of course, but the first necessity is building houses until they stand on their own feet. They have been given food and hospitals are still working," he told agency. He said they were still working to rebuild mosques, schools, madrassas and parks. He did not answer questions about authorities' preparedness for future disasters.

Afghans were already struggling with displacement, food insecurity and poverty before the quake struck, and the tragedy put further pressure on public services. Aid agencies, which have been propping up Afghan health care and education for the past three years under the Taliban, became even more thinly stretched.

The International Rescue Committee set up feeding corners after the earthquake so mothers could safely breastfeed children and get nutrition counsel-

ling. The relief agency said it also fixed water systems, provided emergency cash, hygiene kits, medical and mental health support to tens of thousands of people. But, with other global crises raging, such support is finite. International funding for Afghanistan has received less than a third of its target. Changing political priorities, economic troubles and wars are hitting donors' pockets, especially those in the West. Widespread opposition to the Taliban's treatment of Afghan women and girls is also having an effect.

"There is donor fatigue, for sure, but perhaps the bigger problem is a nervousness from many donors about supporting anything but the most urgent life-saving aid," said Mark Calder from World Vision International.

The U.N. says international recognition of the Taliban as the legitimate government of Afghanistan is nearly impossible while restrictions remain on female education and employment.

The Taliban reject this position, demanding Afghanistan's seat at the U.N. and saying that sanctions and the country's continued isolation are hurting people.

Investment in quality development assistance would benefit Afghan women and girls disproportionately and it's sometimes in their name that a reduction in aid to Afghanistan is promoted, said Calder.

"It's difficult to imagine that Afghan communities are much better prepared for natural disasters than they were a year ago," he added. Herat authorities have been unable to fully meet humanitarian needs, while damaged infrastructure has hampered recovery efforts. A near-total reliance on aid organisations for basics like health care and shelter has left people exposed. Four of Gul Ahmad Osmani's children died in the disaster. He heard boys screaming under the soil in his village. It was impossible to pull them out, he said.

He and his surviving family members spent the winter in a tent. "The government took care of us, keeping my wife and children in a camp, but we didn't see anything from the government that was specifically from them, like flour, cooking oil or rice," Osmani said. "Our own people, the people of Afghanistan, brought food for several days."

The helping hands came from other cities, districts and provinces to clear away rubble, bury the dead, and distribute everyday items like clothing.

But it's been almost six months since NGOs or wellwishers came to help the residents of Zinda Jan. A kind doctor from northern Baghlan province donated money recently.

"There are still earthquakes and these new houses are heavy," said Osmani. "Children are afraid. The help for the earthquake did not help us."

Maldives president Muizzu arrives today for state visit; eyes bailout package to salvage sinking nation

NEW DELHI, Oct 6 (Agencies): Nearly a year since he took over as the President of the Maldives, Mohamed Muizzu will arrive in India on Sunday for a five-day state visit. The premier's first official visit to India is expected to reset ties with Delhi which soured after Muizzu's stormed into power riding on 'India-out campaign.

The President left for India at 12:06 pm local time on an Indian Defense Research and Development aircraft. The aircraft is operated by the Indian Air Force, reported Malebased Adhadhu.

Much has happened since Muizzu took over last year. India had to withdraw Indian military personnel from his country, replacing them with civilians. Muizzu, known for his pro-China, broke the long tradition of Maldivian presidents visiting New Delhi first to travel to Ankara, the capital of Turkey, for his first official visit. He later followed it up with his first bilateral visit to China, sending a message that the island



nation was reorienting its foreign policy

Things hit rock bottom after Prime Minister Narendra Modi's visit to Lakshadweep. The derogatorv remark made by three Maldivian officials about Narendra Modi triggered a backlash in the form of a 'Boycott Maldives' campaign. Indian tourists ditched the Maldives, hitting its tourism-driven economy badly.

However, External Affairs Minister S Jaishankar's visit suggested relations were being mended. In Male. Jais-

hankar assured the country's top leadership that the Maldives remains an important partner of India in maintaining peace, stability and prosperity in the Indian Ocean region.

Now, Muizzu's India visit is expected to reset ties in the wake of the financial crisis gripping the island nation. Already dependent on

external loans, including from India, for much of its development projects, the economy of the Maldives began to deteriorate further under Muizzu. High inflation, increasing

imports, and a reduction in fish exports and tourism revenues pushed the country to the edge of a sovereign default on a Sukuk.

At present, the foreign exchange reserves of the Maldives stand at \$470mn, just enough for two months of imports. Global agency Moody's too downgraded the Maldives' credit rating, saying that "default risks have risen materially". In this context, Maldives can't afford to overlook India. The Maldives owes the

Two stranded foreign mountaineers safely rescued after three-day ordeal in Uttarakhand

UTTARAKHAND, Oct 6 (Agencies): Both are safe despite their ordeal lasting three days. Though looking somewhat tired, the experienced mountaineers wore a smile when they were brought to the Jyotirmath (Joshimath) helipad by the Indian Air Force (IAF) and State Disaster Response Force (SDRF) personnel on Sunday morning.

A joint operation by the IAF, SDRF and the State Disaster Management Authority carried out over the past two days led to their safe evacuation. Two IAF helicopters began a search operation to trace them on Friday. The exit polls, which came out on Saturday, have put the National Conference-Congress alliance in the pole position with the regional party getting the lion's share of the seats.

The BJP is expected to slightly improve on its tally of 25 seats which it had won in the 2014 assembly polls while the PDP, which had won 28 seats in the polls held 10 years ago, is predicted to win less than 10 seats this time.

The action against the Hindu militant, whose followers were seen threatening to burn large effigies labelled as the holy Prophet (PBUH) and his dear cousin, Imam Ali (a.s) on a widespread video on the Internet, will serve a message to the people that "hate speech and incitement to violence will have no place in the civilised society,' the letter read.

"We hope that you will address this sensitive matter with seriousness, and we also hope that

Currently, the per capita income is at 2,730 USD.

panies, in addition to 111 that joined. Prominent firms such as Britannia, HDFC Bank, Mahindra & Mahindra, Max Life Insurance, and Alembic Pharma have already onboarded the PM Internship Scheme via the online portal solely dedicated for this initiative.

PwC and Godrej are exploring the PM internship scheme for their participation. Additionally, as per sources, state-owned Steel Authority of India Limited (SAIL) plans to onboard 977 interns across various trades in its plants, while Jindal Steel & Power (JSPL) is set to register for the scheme, aiming to enrol nearly 500 interns.

Public sector banks are also in the process of joining the initiative, further expanding the scope of available internship opportunities. The Ministry of Corporate Affairs (MCA) has developed the online portal, which is slated to open for candidates on October 12.

Hyundai seeks \$19 billion valuation for its mega India IPO, says report

NEW DELHI, Oct 6 (Agencies): Hyundai Motor Co. is reportedly targeting a \$19 billion valuation for the upcoming initial public offering (IPO) of its India unit, reported Bloomberg, quoting sources familiar with the matter. The South Korean automaker plans to offload a 17.5% stake in Hyundai Motor India Ltd. (HMIL), aiming to raise around \$3.3 billion at this valuation, said the sources. The IPO is expected to take place on October 22 in Mumbai, with several institutional investors, both local and foreign, showing interest. The sources indicated

that a mix of asset managers, insurers, pension funds, and sovereign wealth funds have already expressed preliminary interest in the



offering. Hyundai is expected to file updated documents with India's market regulator, the Securities and Exchange Board of India (Sebi), possibly as soon as Monday. However, details like the size, value, and timing of the IPO could still change as discussions are ongoing, the sourc-

es said. Hyundai's IPO could potentially surpass the record set by Life Insurance Corporation of India (LIC) in 2022,

which raised \$2.5 billion. If successful, this would also be one of Asia's largest IPOs in recent years

India's equity market has been buoyed by strong economic growth, and investor appetite remains high.

According to data compiled by Bloomberg, Indian companies have already raised more than \$9 billion through IPOs this year, doubling the amount raised during the same period in 2023.

Temasek eyes a bite of Haldiram's at valuation of \$11 billion: Report

NEW DELHI, Oct 6 (Agencies): Haldiram's has attracted interest from global investors once again as Singapore state investment firm Temasek Holdings Pte is in talks to acquire a minority stake in Haldiram Snacks Pvt Ltd, reported Bloomberg. Temasek is in preliminary discussions to buy a stake of 10% to 15% in the company, which is valued at approximately \$11 billion, as per the report. The potential investment is seen as a move that could lead Haldiram's towards a public listing in the future.

Global interest in Haldiram's This news follows a series of interests from other major private equity players, including Blackstone, Bain Capital, and others, who have shown interest in acquiring a stake in the iconic Indian snack brand.

In May 2024, media reports surfaced that Blackstone, in partnership with the Abu Dhabi Investment Authority (ADIA) and

Haldiram's business is divided into two main branches led by different factions of the Agarwal family—Haldiram Foods International, based in Nagpur, and Haldiram Snacks Pvt Ltd, based in Delhi.

Both branches are set to merge and form a new entity called Haldiram Snacks Food Pvt Ltd, which would streamline operations and increase efficiency.

In terms of financial performance, the Nagpur-based Haldiram Foods International reported revenues of Rs 3,622 crore for the financial year 2022. Meanwhile, the Delhibased Haldiram Snacks Pvt Ltd recorded sales of Rs 5.248 crore during the same period.



NEW DELHI, Oct 6 (Agencies): In a significant breakthrough to help patients battling both HIV and tuberculosis (TB), a study led by an Indianorigin scientist found a cancer therapy that can help control TB and not interfere with combined antiretroviral therapy (cART)

cART is a treatment that uses a combination of three or more drugs to treat HIV infection.

While many cases of TB can be controlled with months of antibiotics, the infection can return in people who are immunocompromised as a result of HIV. A resurging TB infection -responsible for more than 1.3 million deaths worldwide -- can often be deadly to these individuals.

"This is an important hurdle that this host-directed therapy had to clear in order to help patients battling both HIV and



TB," said Professor Smriti Mehra, from Texas Biomedical Research Institute (Texas Biomed)

In the study, published in the peer-reviewed journal JCI Insight, the scientist and her team focussed on the protein, called IDO (short for Indoleamine-2,3-dioxygenase) -- a

mation and organ damage. Blocking IDO for short intervals led to more successful cancer treatments.

Mehra's team previously showed that the same approach improves control of TB in conjunction with antibiotics.

They experimented with the therapy in the current study in nonhuman primates with both TB and simian immunodeficiency virus -- the nonhuman primate version of HIV.

The results showed the IDO inhibitor does not interfere with cART and is safe for patients with HIV.

Animals given cART and the IDO inhibitor showed no "increase in viral load" compared to those with only cART. The scientist also called for

longer-term studies to confirm there are no unintended side effects.



NEW YORK, Oct 6 (Agencies): Scientists revealed that a cholesterol regulator can become a surprising player in mental health research, helping treat depression and anxiety. Called LXRß, the nuclear receptor is known for its role in cholesterol metabolism and inflammation. It is now emerging as a crucial player in neuroscience and psychiatry.

In a review, published in the journal Brain Medicine, researchers Dr Xiaoyu Song and Professor Jan-Ake Gustafsson from the University of Houston and Karolinska Institutet (Sweden) shed light on the therapeutic potential of liver X receptor beta (LXRß) in treating depression and anxiety.

regulator in the amygdala exerts anxiolytic effects by rebalancing excitatory and inhibitory neurotransmission, it added. Its signalling also regulates neurogenesis and enhances cognitive function, which may

have implications for treating depression. The review also explores its role in autism spectrum disorder (ASD), suggesting potential connections between cholesterol metabolism, brain

development, and ASD

symptoms. Professor Gustafsson said the connection between the receptor, traditionally associated with metabolic functions, and complex psychiatric disorders like depression and anxiety, underscores the interconnectedness of biological systems.

It challenges us to think more holistically about mental health and its underlying molecular mechanisms, the professor added.

While the findings are promising, the authors caution that additional basic research and clinical trials are necessary to determine whether novel drugs targeting the receptor can be effectively utilised in treating neurological and neuropsychiatric diseases.

AI can analyse retinal images for cardiovascular risk: Researchers

NEW YORK, Oct 6 (Agencies): An international team of researchers on Friday said that by leveraging Artificial Intelligence (AI) to analyse retinal images for cardiovascular risk assessment, they aim to bridge a crucial gap in early disease detection.

A recent position paper in the Asia-Pacific Journal of Ophthalmology explores the transformative potential of AI in ophthalmology. The work represents a collaboration among researchers from Penn Engineering, Penn Medicine, the University of Michigan Kellogg Eye Center,

St John Eye Hospital in Jerusalem, and Gyeongsang National University College of Medicine in Korea.

With fundus photography enabling the visualisation of retina at the back of the eye, the potential of AI in providing systemic disease biomarkers is becoming a reality.

When fundus images are of sufficient quantity and quality, it becomes possible to train Al systems to detect elevated HbA1c levels — an important marker for high blood sugar. A pilot study trained AI models to predict HbA1c levels based

on fundus images.

The results of the case study highlight the importance of developing trustworthy AI models for assessing cardiovascular risk factors while addressing the challenges and problems that must be overcome prior to clinical adoption, as well as advancing reliable "oculomics" technology.

This method not only enhances our ability to identify atrisk individuals but also holds promise for transforming how we manage chronic conditions, such as diabetes. By focusing on practical applications of this technology, we are advancing towards more personalised and preventative healthcare solutions, the authors noted.

However, there is a gloomy side of social media that has affected the fans and athletes alike, especially the queer athletes. Australia pacer Megan Schutt is one of those players.

The 31-year-old has been a proud openly queer player and had to deal with inappropriate comments about her sexuality on social media. A firm believer in her thoughts, she has never shied away from voicing her opinions, however these days, she has decided to pick and choose who to reply to. "Firstly, I don't call them all out," Schutt told this daily.

"The ones that I feel are just trying to poke the bear. I don't engage with them. They're just using a derogatory comment because they can. Sometimes I feel like it can be in an uneducated way and that's when I'll probably react more because I feel like if we can have a civil conversation about something or engage in a conversation and change

someone's mindset, that's when things can change," she added.

Schutt is not the only queer athlete at the ongoing T20 World Cup in the United Arab Emirates. England's Natalie Sciver-Brunt and Danielle Wyatt-Hodge, New Zealand's Lea Tahuhu, and Scotland's Abbi Aitken-Drummond are some of the openly gay players of this edition. Most of them have faced similar harassment on social media, but Schutt has been vocal the most. "Sometimes it's even as simple as saying what's your problem? And then they'll divulge and then realise that it's not really a problem and it can lead to a decent discussion," Schutt said .

"I feel like there's a big education piece that's available to people out there and that's part of having a platform but also at the same time, people need to learn when something isn't okay. And that's when I'll call them out and. The ones that float in between, I'll let it slide obviously but now and again, some people need to be put in their place," she added.

"IPL rule changed for MS dhoni, will keep changing till he wants to play": Mohammad Kaif

NEW DELHI, Oct 6 (Agencies): The Indian Premier League (IPL) Governing Council brought back the old rule that allowed franchises to register players who have retired from international cricket or not played in a long time as 'uncapped'. The rule allowed all 10 IPL franchises to rethink their retention strategies, but many believe that the changes were brought in especially for the legendary MS Dhoni, with Chennai Super Kings now capable of retaining him as an uncapped player for a small price

of INR 4 crore. Though CSK claimed that they haven't had any discussion with Dhoni on the matter yet, former India cricketer Mohammad Kaif has no doubts that IPL rules were changed simply because the organisers wanted Dhoni to con-

tinue playing. "You will get the chance to see MS Dhoni again. He is fit, batting at a strike rate of 200, keeping well, and that is why I believe the rules will keep changing till he wants to play. If he wants to play in the IPL, he will play. He is such



a big player, such a big match-winner, and has been a leader for CSK," said Kaif during a chat on Star Sports. Though it's a bold claim, Kaif doesn't think the Board of Control for Cricket in India (BCCI) was wrong in

making alterations in the rulebook. Kaif also feels that IPL rules will keep on changing till Dhoni decides to continue playing. But, Kaif doesn't find anything wrong with it.

"I believe the rule has been changed rightly.

I believe if he is fit and playing well, why not, change the rule and let him play.

Everyone knows the rule has been changed for Dhoni sahab, and why not, you will want to change the rule for a player like Dhoni," the former India batter asserted.

Dhoni had hinted that his continuity as a player in the IPL would depend upon the league's retention rules. While the rules are officially out, the veteran wicket-keeper batter is yet to make his stance clear on the matter.

UDHAMPUR, Oct 6: The Jammu Kashmir Teachers' Joint Action Committee (JKTJAC) held its monthly meeting in Udhampur on Sunday, convened under the leadership of UT President Vinod Sharma and District President Lekh Raj Parihar.
