### **Police** arrests four drug peddlers in Srinagar; **Contraband** substances recovered

SRINAGAR, Dec 2 (Agencies): Police in Srinagar arrested Four drug peddlers and recovered contraband substances from their possession

A Police party of PS Ram Munshi Bagh intercepted three suspicious persons at a checkpoint established near CD Hospital Dalgate.

They have been identified as Yawar Bilal son of Bilal Ahmad Karni resident of Abi Buchwara, Maroof Bilal Kolu son of Bilal Ahmad Kolu resident of Indranagar, Srinagar and Shoib Hilal Lawaye son of Hilal Ahmad Lawaye resident of Drugjan, Dalgate. During search, 9.6 grams of Heroin was recovered from their possession.

Meanwhile, at another checkpoint established at Sozeith Bund, a Police team arrested a drug peddler identified as Abid Ahmad Bhat son of Ghulam Rasool Bhat resident of Sozeith Goripora.

During search, 430 grams of Charas and 750 grams of Bhang Powder concealed in a polythene bag was recovered from his possession.

Regarding the incidents, cases under relevant sections of law have been registered at respective police stations and investigations have been taken up.

J&K cautions those engaged in drug dealings that law would catch them up sooner than anticipated and every offender will face full force of law.

### Road accident at **Qazigund** leaves 6 injured

SRINAGAR, Dec 2 (Agencies): At least six people were injured after the vehicles they were travelling in met with an accident at Mir Bazar area of Qazigund in South Kashmir's Kulgam district, officials said on Monday.

An official said an accident took place between a Tavera vehicle (JK03D-7709) and an Alto car (JK09D-2698) at Al Stop, Mir Bazar, along the Jammu-Srinagar National Highway.

# India's manufacturing sector growth falls to 11-Month low of 56.5 in Nov on price pressures


NEW DELHI, Dec 2 (Agencies): India's manufacturing sector growth fell to a joint 11-month low of 56.5 in November, restricted by competitive conditions and inflationary pressures amid a softer increase in factory orders, a monthly survey said on Monday.

The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index (PMI) fell from 57.5 in October to 56.5 in November, signalling a softer improvement in the health of the sector. However, the pace of growth remained above its long-run aver-

In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"India recorded a 56.5 manufacturing PMI in November, down slightly from the prior month, but still firmly within expansionary territory," Praniul Bhandari, Chief India Economist at HSBC said.

Bhandari further noted that strong broad-based international demand, evidenced by a fourmonth high in new export orders, fuelled the Indian manufacturing sector's continued growth. At the same time, however, the rate of output expansion



is decelerating due to intensifying price pressures.

On the domestic macroeconomic front, the latest government data released on Friday showed India's economic growth slowed to a near two-year low of 5.4 per cent in the

July-September quarter of this fiscal due to poor performance of manufacturing and mining sectors as well as weak consumption.

According to the survey, the expansion in sales and output in the manufacturing sector during November was largely supported by positive demand trends, though firms indicated that growth was somewhat restricted by competitive conditions and price pressures.

"Goods producers experienced a weaker. albeit still robust, upturn in new business intakes during November," the survey said, adding that growth was "stymied by fierce competition and price pressures".

On the price front, Indian goods producers increased their selling prices to the greatest extent since October 2013. Survey participants suggested that

additional outlays on freight, labour and materials had been shared with clients.

"Input prices for a variety of intermediate goods — including chemicals, cotton, leather, and rubber rose in November, while output prices soared to an 11-year high as rising input, labour, and transportation costs were passed on to consumers," Bhandari said.

India's retail inflation soared to a 14-month high of 6.21 per cent in October -above the RBI's tolerance band, mainly on account of

The search led to the recovery of 211 kilograms of poppy contained in eight bags, they added.





# DFSS protests against atrocities on Hindus in Bangladesh

JAMMU, Dec 2: The Dogra Front & Shiv Sena (DFSS), led by their president, Mr. Ashok Gupta, staged a massive protest in Jammu City against the increasing atrocities on minority Hindus in Bangladesh. The protest included the symbolic burning of an effigy of Muhammad Yunus, condemning the ongoing violence and oppression.

Since the fall of Sheikh Hasina's Awami League government on August 5, Bangladesh has witnessed over 200 attacks on Hindus across 50 districts. Hindus, constituting just 8% of the 170 million population, have faced severe persecution, including violent attacks on homes, temples, and properties.

Prominent Hindu spiritual leader Chinmoy Krishna Das was arrested at Dhaka Interna-



tional Airport on sedition charges, further escalating tensions. Following his arrest, clashes erupted, leading to the death of lawyer Saiful Islam Alif, mistaken for a Hindu by an Islamist mob. His death sparked widespread violence, with mobs targeting Hindu-populated areas in Chittagong such as Patharghata Mathar Potti, Andarkilla, and Hazari Goli.

Gupta condemned these brutal attacks, stating that the Bangladeshi government must ensure the safety and dignity of its Hindu minority. He criticized the silence of international and local opposition groups on this humanitarian crisis and suggested that India use its economic leverage to pressure Bangladesh.

India should halt trade, par-

ticularly exports of cotton and essential commodities like medicines and onions, to send a strong message to Bangladesh's administration.

Merely issuing statements will not suffice; concrete actions are necessary to compel Muhammad Yunus's government to act against the violence.

Bangladeshi Hindus deserve to live with security in their homeland and must be protected by their government.

Gupta stressed that India's diplomatic and economic interventions could play a critical role in safeguarding Hindus in Bangladesh and urged New Delhi to adopt a firm stance.

# Technology Impact on Education

# Ties with Dhaka: Domestic politics & diplomacy clash

since Bangladesh's Prime Minister Sheikh Hasina was forced to flee her country and seek refuge in India on August 5, after escalating student-led protests, India-Bangladesh relations have frayed. Seeing Sheikh Hasina as a bulwark against Islamist forces, New Delhi kept backing her unquestionably, despite her rising authoritarianism. Endorsing of close allies, while disregarding their domestic politics, has a long history.

The United States often held its nose to back despicable authoritarian governments for geopolitical advantage. One US President justified it on the grounds that the ruler was, after all, "our son of a bitch". The US has as a consequence suffered occasionally. The 1979 ouster of the Shah of Iran by Islamist forces led by Ayatollah Khomeini, then exiled in France, is a prime example. It upended the "twin pillars" American policy, using Iran and Saudi Arabia to stabilise the Gulf, after the British exit in 1971. The US is still wrestling to achieve that.

Perhaps the Indian government got blindsided by its domestic majoritarian bias, which aligned with a Muslim majority nation battling Islamist elements. The irony of supporting secularism in the neighbourhood while ignoring it at home was missed. The US had been warning Bangladesh about democratic regression, sanctioning its elite police unit in 2021 and a former Army chief in 2024. India saw it as unnecessary meddling in a nation that it felt was on the right track.

Sheikh Hasina ruled for 20 of the past 28 years, including being in power continuously since 2009. During 2000-16, Bangladesh became a model of economic growth. The population in extreme poverty fell by two-thirds. Many indices topped India's, includ-

ing per capita at market prices. Sheikh Hasina also managed to defang the Jamaat-e-Islami, which opposed the nation's independence and collaborated with the Pakistani military. It was banned after independence in 1971, when Sheikh Hasina's father Sheikh Mujibur Rahman formed the first government. The citizenship of its leader Ghulam Azam was cancelled and he fled abroad. After the assassination of Mujib in 1975, the Jamaat resumed activities. The Bangladesh Nationalist Party (BNP) of Begum Khaleda Zia, widow of an assassinated former Army chief and President, aligned with the Jamaat.

This combination is now back in the reckoning with the interim government led by Muhammad Yunus unshackling the BNP and Jamaat leaders. Immediately after Sheikh Hasina's self-exile in India, her party Awami League's senior members and cadres were attacked and arrested, with nearly 1,000 dying. A threemember International Crimes Tribunal is now prosecuting those allegedly involved in killings of protesters, especially students. Amongst those arrested are 11 ministers, one judge and a senior bureaucrat. December 17 is the new deadline for the tribunal's award, which has issued warrants for Sheikh Hasina and 45 others on October 17. In fact, the tribunal explained the delay due to making the verdict compatible with the extradition treaty between India and Bangladesh. An extradition request may become a new bilateral dispute. Therefore, the arrest of Chinmoy Krishna Das Brahmachari, formerly belonging to Iskcon, on a sedition charge reflects popular anti-India sentiment, now metamorphosing into anti-Hinduism. The Indian government asking the Bangladesh government to protect minorities sits poorly alongside slogans in Maharashtra electioneering of "Katengay to Batengay". Prime Minister Narendra Modi correctly modified it but without condemning it. More Hindu priests have been arrested subsequently. Bangladesh has an estimated 10,000 Indian citizens, besides 14 million Hindus. Unlike in western India, where Punjabi Muslims abandoned their language and culture to dominate Pakistan, Bengali Muslims remained attached to their language and culture. The Awami League drew support from this vast majority. But in recent years, as Bangladesh's economic miracle faltered and Sheikh Hasina's authoritarianism worsened. the popular sentiment swung against her secular coalition. There are reports of Pakistan becoming more active, but China is best positioned after the exit of India-friendly Sheikh Hasina. While China is Bangladesh's largest trading partner, in South Asia India takes that credit. Over the last eight years, India extended four lines of credit, totalling \$8 billion. On March 18, 2023, the Prime Ministers of both countries inaugurated remotely the India-Bangladesh Friendship Pipeline, carrying high-speed diesel. On November 1, 2023, two rail connectivity projects and the Maitree Super Thermal Plant were also inaugurated. Five pre-1965 rail links were rehabilitated. Bangladesh is importing 1160 MW of power from India. Invited to the India-hosted G-20 summit in September 2023, Sheikh Hasina signed three memoranda of understanding on agricultural research, digital payments and cultural exchanges. Thus, the Indian strategy to help Sheikh Hasina's rule was to bolster Bangladesh economically and increase connectivity, power and military links. Internationally, Bangladesh is arguing that its government protects Hindus. Their permanent representative in Geneva, speaking at the 17th session of the UN Forum on Minority Issues, said: "The entire society of Bangladesh came forward to protect its minorities following our long tradition of communal harmony". The

security of every citizen remains, he added, "the cornerstone of the interim government of Bangladesh". However, following the death of a Muslim lawyer, in protests when bail was denied to Chinmoy by a Chittagong court, 31 Hindus have been named as suspects. If an interim government led by a pro-West Nobel laureate is unable to control the increasing communal polarisation, the situation under a likely BNP-Jamaat government may be worse. The United States still has leverage as Bangladesh needs the \$4.7 billion IMF bailout. The European Union can also lobby as it is Bangladesh's largest export destination. In addition, the tariff concessions offered by them end in 2029. Japan remains the biggest donor to a now beleaguered nation. Naturally everyone awaits the Donald Trump presidency to see what role, if any, the US plays to guide Bangladesh back to responsible and democratic governance. The BJP's own increasingly majoritarian and authoritarian regime is ill equipped to preach moderation, human rights and democracy in a nation that sees it as complicit in the Sheikh Hasina-created mess. A student leader from the protests reflects the dangerous polarisation, saying that Iskcon is an extremist organisation working with India to "plot against us". With the youth having turned against the ousted Awami League regime, India too faces their wrath. This writer has long maintained that foreign and domestic policies cannot be in separate silos. Their conflict last affected India's relations with the Maldives. Rudyard Kipling wrote that "East is East, and West is West, and never the twain shall meet". So far, the BJP has managed to keep diplomacy and domestic politics distinct. It seems the "twain" has again overlapped in Bangladesh, another South Asian nation.

# Women empowerment in the digital age

In today's digital age, improving women's access to the Internet is essential not only for their individual empowerment but also for overall social and economic development. Digital technology can provide women with new opportunities for education, healthcare, and financial independence, helping to reduce gender inequality in society. Although the Government of India has taken important steps to increase digital access through the Digital India initiative, it is not possible to ensure It is necessary that in these efforts, the weaknesses and security related problems of women should also be addressed. The 'digital divide' has emerged as a major problem in India, especially in the context of women and girls. According to data for 2022 and 2023 from the 'Global System for Mobile Communications Association' and 'Oxfam', it is clear that women's access to the internet needs improvement. For example, the gender gap in mobile ownership is expected to decline by 11 percent in 2022, but women are still at a disadvantage in mobile internet usage. The share remains stable at 130 1 per cent, widening the gender gap to 40 per cent. Moreover, mobile internet awareness among women is less than 60 percent. Inclusive development of digital technologies can provide opportunities for all sections of society to overcome barriers to economic opportunity, education and mobility. public service delivery and promote greater citizen participation. Internet usage in India has grown rapidly, but despite this progress, the digital divide is still a major challenge. National According to the sample survey 2020-21, only 26 percent of women in rural India own a smart phone, while 49 percent of men use smart phones. Inequality is deeper in rural areas. According to the 'Internet and Mobile Association of India's 2022 report', improvement in digital literacy and connectivity could increase India's GDP by 100 billion dollars by 2025. Women will benefit most from this potential growth, as digital platforms provide them with new opportunities for skill development, employment and entrepreneurship. in digital skills The number of trained women is increasing at the rate of about 2.5 percent every year. With this, not only are women participating in 'startups', but they are also promoting technological innovation by taking leadership roles. Under the

Digital India programme, rural women are being empowered through digitalisation. This has helped them expand their small businesses on online platforms and become financially independent., According to reports, women who have access earn approximately 140 percent more income. Are. Eliminating the 'digital divide' should be a priority in efforts to increase Internet consumption; these efforts should also consider the problems women and girls face due to the Internet. # Nikkhil Advani's latest web-series 'Freedom at Midnight' might have opened to mixed reviews, but has an IMDb rating of 8.4/10

National Award-winning director Nikkhil Advani's latest web-series 'Freedom at Midnight' might have opened to mixed reviews, but has an IMDb rating of 8.4/10. To those having issues with his historical saga, his tongue-in-cheek riposte is, "I am waiting to watch what they make and show what I have not shown... I read everybody's reviews and am often heartbroken and wonder where I went wrong."

Creator of 'Rocket Boys', 'The Empire' and 'Mumbai Diaries', one of the biggest challenges of recreating history for Advani was "to get it right". A history buff, he jokes how he spent most of the money he hoped to make through 'Freedom at Midnight' on books recommended by William Dalrymple and Anita Anand. Their podcast 'Empire' is often his go-to referral point. He adds, "There are far too many experts on Independence and Partition. Hence, the source material had to be correct."

Many feel the book by Dominique Lapierre and Larry Collins, on which the series is based, reads like a screenplay, a fact which served him tantalisingly well. Since his journey began with Kundan Shah, Sudhir Mishra, Saeed Akhtar Mirza and later coincided with the masters of mainstream like Karan Johar and Aditya Chopra, Advani's sensibilities were bound to be an amalgamation. He elaborates, "My voice tends to be closer to the Kundans, Sudhirs and Saeeds, but the treatment is more mainstream, highly dramatic." Precisely why, for the dialogues in 'Freedom at Midnight', he wanted the signature Salim-Javed touch - which his dialogue writer Divy Nidhi Sharma delivered on point.

# Telangana woman constable killed by brother, cops hint at honour killing

HYDERABAD,, Dec 2 (Agencies): A woman police constable was brutally murdered by her brother in a suspected case of honour killing near Telangana's Raipole village in Ibrahimpatnam mandal, Ranga Reddy district, on Monday.

The victim, Nagamani, was working at the Hayathnagar police station and had married Srikanth, a man from another caste, a fortnight ago. Her family had reportedly opposed the intercaste marriage.

The attack occurred while Nagamani was riding her scooter from Raipole to Manneguda. According to police, Paramesh, her brother, deliberately rammed her scooter with his car. When she fell, he attacked her with a machete, leaving her in a pool of blood. Nagamani died on the spot due to grievous injuries.

Upon receiving information, police rushed to the scene and confirmed Nagamani's death. "We suspect that her brother was enraged by her love marriage and killed her in an act of honour killing," a senior officer said.



Nagamani, 2020 batch police constable, had reportedly gone against her family's wishes by marrying Srikanth, which led to tensions within the family.

Police have registered a case and launched an investigation to apprehend the accused, who fled the scene after the attack. Police are also looking into other angles, including any property disputes.

## Navy Chief confirms India tested 3,500-km range nuclear-capable missile

With the K-4 missile test, India became part of a small group of countries that can fire a nuclear missile from land, air and undersea.

NEW DELHI, Dec 2 (Agencies): Navy Chief Admiral Dinesh K Tripathi today confirmed that India has tested the 3,500-km range nuclear-capable missile from a ballistic missile submarine believed to be the recently commissioned INS Arighaat. Speaking to the media ahead of Navy Day, he, however, said more data was awaited on the trajectory of the missile.

The K-4 missile was reportedly tested from submarine INS Arighaat - which was commissioned into the Indian Navy on August 29 - off the coast of Visakhapatnam on November 27.

According to reports, it was the first test of the



submarine-launched ballistic missile (SLBM) from a submarine.

With the K-4 missile test, India also became part of a small group of countries that can fire a nuclear missile from land, air and undersea.

India has significantly enhanced its overall military capabilities and test-fired a range of missiles with varying ranges in the past few years. Admiral Tripathi also said the government's approval for two SSNs (nuclear-powered attack submarines) indicated its "faith" in the country's indigenous capabilities to build such boats.

Fast attack submarines are used to target enemy ships and submarines and may launch cruise missiles against land and sea targets. These are different from SSBMs such as the INS Arighaat, which have a primary role of launching nuclear-tipped ballistic missiles

Admiral Tripathi said 62 ships and a submarine are currently under construction within the country as part of efforts to boost its naval power. A large number of platforms are waiting for induction in the next one year and at least one ship will be inducted into the Navy, he said.

"We have redoubled efforts to include niche technologies into the force," the Navy Chief said.

He also said the procurement of Rafale-M (naval variant) and the Scorpene submarines is likely to be finalised next month. Last year, the defence ministry approved the purchase of the Rafale-M jets from France, primarily for deployment on board the indigenously built aircraft carrier INS Vikrant.

Admiral Tripathi also said they have kept a "close watch" on the activities of extra-regional forces operating in the Indian Ocean region, including the Chinese Navy.

"Whether it is their warships or their research vessels, we know who is doing what, where and how," he said.

He also said they were aware of the "surprising growth" of the Pakistan Navy, which aims to become a 50-ship Navy.

"They have chosen weapons over the welfare of their people," he said.

### Mamata Banerjee wants UN force in Bangladesh, says PM Modi must intervene

KOLKATA, Dec 2 (Agencies): Bengal Chief Minister Mamata Baneriee on Monday called for a United Nations peacekeeping force be deployed in Bangladesh and demanded Prime Minister Narendra Modi's personal intervention to secure the safety of religious minorities in the violence-hit neighbouring nation.

Banerjee's Ms demands come amid reports that at least three Hindu priests from the International Society for Krishna Consciousness - have been arrested in civil unrest that has roiled Bangladesh since August, when a student-led rebellion forced Prime Minister Sheikh Hasina to stand down and the Army took over, before an interim government was installed.

"We have families... properties... and loved ones in Bangladesh. We accept whatever stance the Government of India takes on this...but we condemn atrocities on religious grounds anywhere in the world and appeal to the union government, and the Prime Minister, to intervene," she said.

Addressing the Bengal Assembly, Ms Banerjee said she had spoken to the chief of the ISK-CON's Kolkata unit

to extend her sympathies and support, and stressed, "If Indians are attacked in Bangladesh, then we cannot tolerate it. We can bring back our people... Government of India can take this matter up with the United Nations... so a peacekeeping force can be sent."

She also said she was not seeking to interfere with the internal affairs of another country, but pointed out that when Bangladeshi fishermen had mistakenly entered Indian waters, or when a Bangladeshi trawler had capsized, her government had "rescued them and treated them (well)".

Mr Modi last week met External Affairs Minister S Jaishankar to discuss this issue, after which the latter called on Bangladesh's temporary government to protect religious minorities. The Indian government also expressed serious concern over a surge of extremist rhetoric and increasing incidents of violence against Hindus, as well as attacks on temples, in that country.

After his meeting with the Prime Minister Mr Jaishankar also briefed Parliament, saying the Indian government had taken a serious view of the violence against minorities in Bangla-

desh.



"Primary responsibility for protection of life and liberty of all citizens of Bangladesh, including minorities, rests with the Government of Bangladesh," he said, adding the Indian High Commission in Dhaka is monitoring the situation related to minorities there "closely"

The Yunus government has reaffirmed "in the strongest terms" that every Bangladeshi, regardless of their religious identity, has the "right to establish, maintain or perform respective religious rituals and practices or express views without hindrance.

Two ISKCON priests were arrested by Bangladesh Saturday, according to the religious group's Kolkata unit spokesperson Radharamn Das. This, he claimed, was in addition to the arrest of two devotees and a third, the secretary of one of the arrested priests, going

The ISKCON row kicked off with the arrest

of Chinmoy Krishna Das Brahmachari last week. A former member,

he was arrested from Dhaka's Hazrat Shahialal International Airport, denied bail, and sent to jail on charges of sedition. His arrest, the interim Bangladesh government headed by Nobel Peace Prize laureate Mohd. Yunus, has been "misconstrued", Dhaka has said.

The arrest of Das and another Hindu priest, the leader of the Sammilita Sanatani Jote, triggered protests across Bangladesh, including in Dhaka and the port city of Chattogram. The protesters have been demanding stronger legal protection and a ministry dedicated to minority affairs.

Historically, Hindus made up around 22 per cent of Bangladesh's population during the 1971 Liberation War. But there has been a significant decline in recent decades, with the Hindu community now comprising only around eight per cent of the total population.

# SC asks Protesting farmer leaders not to cause inconvenience to people

NEW DELHI, Dec 2 (Agencies): The Supreme Court on Monday asked Punjab farmer leader Jagjit Singh Dallewal, who is on a fastunto-death at the Khanauri border point to press for the acceptance of farmers' demands, to persuade the protesting farmers not to obstruct highways and cause inconvenience to people.

A bench of Justices Surya Kant and Ujjal Bhuyan disposed of a habeas corpus petition filed on behalf of Dallewal, who was removed from the Khanauri protest site on the Punjab-Haryana border on November 26.

"We have seen that he has been released and he even persuaded a fellow protestor to end his fastunto-death protest on Saturday," the bench said, adding that the issue raised by the farmers has been noted by the court and is considered in a pending matter.

"In a democratic setup, you can engage in peaceful protests but do not cause inconvenience

to people. You all know that the Khanauri border is a lifeline for Punjab. We are not commenting on whether the protest is right or wrong," the bench told advocate Guninder Kaur Gill, appearing on behalf of Dallewal

Justice Kant said that Dallewal could persuade the protestors to organise peaceful protests under the law and without causing any inconvenience to people.

The bench said that at this stage. it was not entertaining Dallewal's petition but he could approach later.

Hours before beginning his fast-unto-death on November 26, Dallewal was allegedly forcibly removed from the Khanauri border and taken to a hospital in Ludhiana. He was discharged on Friday evening.

The plea was moved in the apex court on November 29 challenging his alleged illegal detention by the Punjab Police.

On November 30, a day after

he was released, Dallewal joined the fast-unto-death at the Khanauri border point to press for the acceptance of the farmers' demands

Farmers have been camping at Shambhu and Khanauri border points between Punjab and Haryana since February 13 after their march to Delhi was stopped by security forces.

The protesters have accused the Centre of not taking steps to address their demands, claiming that it has not held any talks with them on their issues since February 18.

Besides a legal guarantee for MSP, the farmers are demanding implementation of the Swaminathan Commission's recommendations, pension for farmers and farm labourers, farm debt waiver, reinstatement of the Land Acquisition Act, 2013 and compensation to the families of farmers who died during a previous agitation in 2020-21.

# **Gaza, Ukraine wars, regional tensions boosting arms sales: Report**

STOCKHOLM, Dec 2 (Agencies): Sales by major arms makers were boosted last year by wars in Ukraine and Gaza and tensions in Asia, with marked increases for manufacturers based in Russia and the Middle East, a report said Monday.

Sales of arms and military services by the world's 100 largest arms companies totalled \$632 billion in 2023, up 4.2 percent, according to a report by the Stockholm International Peace Research Institute (SIPRI).

Revenues had dipped in 2022 as global weapons makers struggled to meet the increase in demand, but many of them managed to increase production last year, the authors of the report noted.

In a sign of this surge in demand, all 100 companies tracked achieved sales in excess of \$1 billion last year for the first time.

"There was a marked rise in arms revenues in 2023, and this is likely to continue in 2024," Lorenzo Scarazzato, a researcher with the SIPRI Military Expenditure and Arms Production, said in a statement.

Sales from the world's top 100 arms companies "still did not fully reflect the scale of demand, and many companies have launched recruitment drives, suggesting they are optimistic about future sales," Scarazzato added.

Among the leading producers, US companies recorded a 2.5 percent increase in their sales last year and still account for half the world's arms revenues, with 41 US weapons producers in the world's top 100.

Lockheed Martin and RTX (formerly Raytheon Technologies), the world's two largest arms makers, on the other hand, reported a fall in revenue of 1.6 percent and 1.3

Sales by the two Russian groups in the ranking rose by 40 percent, mainly thanks to a 49 percent increase in sales for state-owned conglomerate Rostec, according to the report.

# German Chancellor Olaf Scholz is in Ukraine for his first visit in 2 1/2 years



KYIV, Dec 2 (Agencies): German Chancellor Olaf Scholz visited Ukraine for the first time in more than 2 1/2 years Monday, just weeks after he was criticized by Ukrainian President Volodymyr Zelenskyy for having a phone call with Russian President Vladimir Putin.

That call came at a time of widespread speculation about what the new administration of President-elect Donald Trump will mean for Ukraine as the incoming president has promised to end the conflict. In a major shift, Zelenskyy signalled Friday that an an offer of NATO membership to territory under Kyiv's control could end "the hot stage of the war" in Ukraine.

Scholz's visit comes ahead of an early German election expected in February. As the campaign gets under way, Scholz has pointed to Germany's status as Ukraine's second-biggest weapons supplier while also highlighting his "prudence" in working to prevent the war escalating and refusing to deliver Taurus long-range cruise missiles.

Scholz has been cautious about talk of fast-tracking NATO membership for Ukraine. In recent months, he has emphasized the importance of finding a path to peace, while stressing that it must not be chosen over Ukraine's head. Scholz said that in his meeting with Zelenskyy he will announce further military deliveries this month totaling 650 million

"I would like to make clear here on the ground that Germany will remain Ukraine's strongest supporter in Europe,"

Despite that, Scholz was criticized by Zelenskyy in November for speaking to Putin in what appeared to be the first conversation with the sitting leader of a major Western power in nearly two years. In that call, Scholz urged Putin to be open to negotiations with Ukraine but the Russian leader said any peace deal should acknowledge Russia's territorial gains and security demands, including that Kyiv renounce joining NATO.

Zelenskyy suggested the call to Putin risked opening "a Pandora's box" and would only serve to make Russia less isolated. He traveled to Berlin in October to meet Scholz to drum up support for his "victory plan" to end the war in Ukraine on a tour of European capitals.

The plan included a suggestion that Ukraine receive a formal invitation to join NATO and a request that Kyiv be given permission to use long-range Western missiles to strike at military targets inside

Western nations granted permission for Kyiv to carry out long-range strikes with their weapons in November. Following the decision, Putin said Russia launched a strike on Ukraine with an unstoppable intermediate range ballistic missile dubbed the Oreshnik. It marked the first time that such a missile was used in the war or in any other conflict.

### Impeachment complaint filed against **Philippine Vice President Duterte** after she threatened president

MANILA, Dec 2 (Agencies): An impeachment complaint was filed Monday against Philippine Vice President Sara Duterte, who is facing a legal storm over a death threat she made against the president, the alleged misuse of government funds by her office and other criminal accusations.

The impeachment bid filed by several prominent opponents and activists in the House of Representatives accuses Duterte of violating the country's Constitution, massive corruption and other "high crimes," including the death threats she made against the president, his wife and the speaker of the House of Representatives.

The vice president's threats showed the "extent of respondent's mental incapacity, her depravity and lack of mental fitness to continue holding the high office of vice president of the Philippines," said a copy of the complaint seen by The Associated Press. "The same constitute not only betrayal of public trust but also a high crime which would warrant her immediate impeachment from office."

Duterte, a 46-year-old lawyer, was also accused in the complaint of having unexplained wealth and of allowing extra-judicial killings of drug suspects begun by her father, a former mayor of southern Davao City, when she held that position in the past.

The vice president's legal troubles have unfolded with the backdrop of her increasingly bitter political feud with President Ferdinand Marcos Jr. and his allies. She said in online news conference on Nov. 23 that she has contracted an assassin to kill Marcos, his wife and Speaker Martin Romualdez if she were killed, a threat she warned was not a joke.

She later said she was not threatening him but was expressing concern for her own safety.

The impeachment complaint will be scrutinized by the Philippine Congress, which is dominated by allies of Marcos and his cousin and key backer, Romualdez, who also has been politically at odds with the vice president.

The process could take weeks or months. Congress is to start its Christmas recess on Dec. 20 and resume on Jan. 13. Many legislators will then start campaigning for reelection before May 12 midterm elections.

The House has been investigating the alleged misuse of 612.5 million pesos (\$10.3 million) of confidential and intelligence funds received by Duterte's offices as vice president and educa-



tion secretary. She has since left the education post.

She has refused to respond to questions in detail in tense televised hearings. Duterte also vehemently protested when her chief of staff, Zuleika Lopez, was ordered temporarily detained for allegedly hampering the inquiry. Lopez has been released from hospital deten-

Philippine police have filed criminal complaints against Duterte and her security staff for allegedly assaulting authorities and disobeying orders in an altercation in Congress over Lopez's

Duterte has accused Marcos, his wife and Romualdez of corruption, weak leadership and attempting to muzzle her because of speculation she may seek the presidency in 2028.

The National Bureau of Investigation subpoenaed Duterte to face investigators about her threats against them.

The police, military and the national security adviser immediately boosted the security of the Marcoses after the

The president has said an impeachment of Duterte would waste time while the country faces other challenges, but her opponents have said they will proceed to foster accountability and the rule of law.

Marcos and Duterte won landslide victories as running mates in the 2022 election but have since fallen out over key differences. The two offices are elected separately in the Philippines, which has resulted in rivals occupying the country's top political posts.

Marcos and Duterte differ on their approaches to China's territorial claims in the South China Sea and their views on the deadly anti-drug crackdown conducted by Duterte's father, Rodrigo Duterte, who was the previous president in addition to ex-mayor of Davao.

The brutal crackdown left thousands of mostly poor suspects dead in killings mostly by police that are being investigated by the International Criminal Court as a possible crime against humanity.

# Astronomers pinpoint origin of mysterious repeating radio bursts from space

PERTH, Dec 2 (Agencies): Slowly repeating bursts of intense radio waves from space have puzzled astronomers since they were discovered in 2022.

In new research, we have for the first time tracked one of these pulsating signals back to its source: a common kind of lightweight star called a red dwarf, likely in a binary orbit with a white dwarf, the core of another star that exploded long ago.

A slowly pulsing mystery

In 2022, our team made an amazing discovery: periodic radio pulsations that repeated every 18 minutes, emanating from space. The pulses outshone everything nearby, flashed brilliantly for three months, then disappeared.

We know some repeating radio signals come from a kind of neutron star called a radio pulsar, which spins rapidly (typically once a second or faster), beaming out radio waves like a lighthouse. The trouble is, our current theories say a pulsar spinning only once every 18 minutes should not produce radio waves.

So we thought our 2022 discovery could point to new and exciting physics - or help explain exactly how pulsars emit radiation, which despite 50 years of research is still not understood very well.

More slowly blinking radio sources have been discovered since then. There are now about ten known "long-period radio tran-

However, just finding more hasn't been enough to solve the mystery.

Searching the outskirts of the galaxy Until now, every one of these sources has been found deep in the heart of the Milky

This makes it very hard to figure out what kind of star or object produces the radio waves, because there are thousands of stars



in a small area. Any one of them could be responsible for the signal, or none of them.

So, we started a campaign to scan the skies with the Murchison Widefield Array radio telescope in Western Australia, which can observe 1,000 square degrees of the sky every minute. An undergraduate student at Curtin University, Csanad Horvath, processed data covering half of the sky, looking for these elusive signals in more sparsely populated regions of the Milky Way.

And sure enough, we found a new source! Dubbed GLEAM-X J0704-37, it produces minute-long pulses of radio waves, just like other long-period radio transients. However, these pulses repeat only once every 2.9 hours, making it the slowest long-period radio transient found so far.

Where are the radio waves coming from? We performed follow-up observations with the MeerKAT telescope in South Africa, the most sensitive radio telescope in the southern hemisphere. These pinpointed the location of the radio waves precisely: they were coming from a red dwarf star. These stars are incredibly common, making up 70% of the stars in the Milky Way, but they are so faint that not a single one is visible to the naked eye.

Combining historical observations from the Murchison Widefield Array and new

MeerKAT monitoring data, we found that the pulses arrive a little earlier and a little later in a repeating pattern. This probably indicates that the radio emitter isn't the red dwarf itself, but rather an unseen object in a binary orbit with it.

Based on previous studies of the evolution of stars, we think this invisible radio emitter is most likely to be a white dwarf, which is the final endpoint of small to medium-sized stars like our own Sun. If it were a neutron star or a black hole, the explosion that created it would have been so large it should have disrupted the orbit.

It takes two to tango

So how do a red dwarf and a white dwarf generate a radio signal?

The red dwarf probably produces a stellar wind of charged particles, just like our Sun does. When the wind hits the white dwarf's magnetic field, it would be accelerated, producing radio waves.

This could be similar to how the Sun's stellar wind interacts with Earth's magnetic field to produce beautiful aurora, and also lowfrequency radio waves.

We already know of a few systems like this, such as AR Scorpii, where variations in the brightness of the red dwarf imply that the companion white dwarf is hitting it with a powerful beam of radio waves every two minutes. None of these systems are as bright or as slow as the long-period radio transients, but maybe as we find more examples, we will work out a unifying physical model that explains all of them.

On the other hand, there may be many different kinds of system that can produce long-period radio pulsations.

Either way, we've learned the power of expecting the unexpected – and we'll keep scanning the skies to solve this cosmic mys-

# 'Treat Muslims as Equals', Farooq **Abdullah urges Centre to stop acts** that spark communal tension



SRINAGAR, Dec 2 (Agencies): National Conference President Farooq Abdullah on Monday said the Centre should put a stop to activities that can spark communal tension in the country, and treat Muslims as equals.

"There is a need to stop (incidents like Sambhal). I will tell the government of India to stop (such acts) because they cannot throw the Muslims (of India) into the sea. Where will they throw 24 crore Muslims? Treat Muslims as equals, that is what our Constitution stands for. If they fiddle with the Constitution, how will India survive," Abdullah asked while speaking to reporters here.

The National Conference (NC) president, who recently performed Umrah (minor Hajj pilgrimage) along with his son and chief minister Omar Abdullah and several of his colleagues, said no one was against the return of Kashmiri

Pandits to the Valley. "Who is stopping Kashmiri Pandits from coming back? Every political party has said they should return. It is their decision when they want to return. Our hearts are open for them. Even when I was the chief minister, when the situation was bad, we tried to bring them back," he said.

On demands seeking review of the reservation policy in Jammu and Kashmir, Abdullah said the government should review the same.

"We will tell the government to review it. Reservation is for the underprivileged sections so that they can come up as equals," he said.

The NC government has formed a Cabinet sub-committee to look into the demands for rationalisation of reservations, which have gone up to 70 per cent in the Union Territory.

On Lieutenant Governor Manoj Sinha last week firing two govfor their alleged terror links, Abdullah said the government "will keep an eye on everything and go into why the two employees were terminated".

The veteran politician also welcomed the Israel-Lebanon 'ceasefire', but called for an end to attacks on Gaza, Syria and Iran as well.

"It (ceasefire) is a very good step, but it is necessary to stop attacks jointly being carried out by Israel and America — in Gaza, Syria and Iran, which are continuing even today. This is dangerous. They should immediately resort to ceasefire.

"You must have watched the debates in the (UN) Security Council. If there is a purpose for (the existence of) Security Council, it should work on the directions given to Israel. They should enforce a ceasefire and allow humanitarian aid,"

Abdullah said. On his recent religious pilgrimage, Abdullah said he not only prayed for Kashmir, but for the entire Muslim world.

"The problems we are facing today, may Allah deliver us from these. May Allah guide us to the right path. I prayed that we stay away from evil and for the end of religious hatred that has spread in our country. I prayed for unity and harmony," he said.

Mission Statehood, he asserted, will continue its fight for Jammu and Kashmir's rights and constitutional safeguards.

In a press statement,



Bhagat called on Chief Minister Omar Abdullah to provide urgent financial compensation to the affected farmers. Bhagat criticized the Agriculture Department and the Saffron Development Department Kishtwar for their lack of proactive measures to support farmers, describing their negligence as "criminal," especially in a region where agriculture is the backbone of daily livelihood.

Bhagat also drew attention to the struggles of farmers burdened with loans under the Kisan Credit demanding loan waivers or reduced interest rates. He further criticized the failure of the Agriculture and Saffron Development Departments to set a standard market rate for saffron, a step he deemed crucial for ensuring fair returns for growers.

Card (KCC) scheme,

The neglect has discouraged many farmers, threatening the continuation of saffron cultivation in this only saffron-producing area of the Chenab Valley. Bhagat urged the gov-

ernment to prioritize measures to stabilize the industry, such as fixing market rates and improving farming facilities, to restore farmers' confidence and prevent the decline of this traditional and economically vital crop.

Expressing hope for justice for the farmers, Bhagat emphasized the critical role of saffron cultivation in the region and called for immediate action to safeguard their livelihoods and preserve the heritage of saffron farming in Kishtwar.

# India's road to WTC Final: What is the updated scenario ahead of Adelaide Test?

NEW DELHI, Dec 2 (Agencies): India spiced up the race for the World Test Championship Final with a resounding victory in the first Test match of the Border-Gavaskar Trophy. What seemed like a distant dream after their crushing 0-3 home series loss against New Zealand, is once again back in India's grasp.

There might still be a long way to go, but India can realistically make it to the final of the ICC tournament - which will be their third in a row. Here's are the updated qualification scenarios for the World Test Championship Final race - as South Africa, Sri Lanka, India and Australia vie for the final two spots in the tournament.

India's Potential Path to the WTC Final

India's chances of qualifying for the WTC Final are very much in their hands, with several potential outcomes based on their performance in the upcoming series against Australia.

India win 5-0, 4-0, or 3-0 vs Australia: If India manage to



win the series by any of these margins, they will directly qualify for the WTC Final. A dominant performance would all but seal their spot, making them the first team to qualify.

India win 3-1 vs Australia: If India clinch the series 3-1, they will also qualify for the final, but with one condition. South Africa must not beat Sri Lanka in the second Test. If South Africa wins that series, India's qualification could be in jeopardy.

India win 3-2 vs Australia: A 3-2 win for India will still keep them in the running for the final,

but the scenario becomes more complex. For India to qualify, Sri Lanka must win at least one Test against South Africa and then draw at least one game against Australia. This combination of results would ensure India's

India draw the series 2-2: A drawn series will also keep India's hopes alive, but several results must go in their favour. South Africa must beat Sri Lanka 2-0, and Sri Lanka must win at least 1 Test against Australia (in their upcoming home series). Additionally, Sri Lanka

spot in the final.

must not lose the series 0-2 to Australia, ensuring a narrow path to qualification for India.

What This Means for the Teams Involved?

The Adelaide Test, therefore, holds huge significance for both India and Australia. For India, their qualification scenario is heavily influenced by the results of Sri Lanka and South Africa's Test series. For Australia, their hopes remain strong, and they will look to keep up their pressure on India, knowing that every point counts.

In the context of the WTC race, other teams like South Africa and Sri Lanka are also playing pivotal roles. Sri Lanka, in particular, will need to secure key wins against South Africa and Australia to help India's qualification chances.

The Adelaide Test could very well be a turning point in this fascinating WTC cycle, with India needing to maximise their points to secure a direct route to the final, while Australia will be aiming to strengthen their position.

### IPL auction fame Vaibhav Suryavanshi scores 23 in U19 Asia Cup vs Japan



NEW DELHI, Dec 2 (Agencies): Vaibhav Suryavanshi showcased his batting prowess in the ACC U-19 Asia Cup match vs Japan. After a quiet outing in the previous match vs Pakistan u-19 team, Suryavnshi gave glimpses of what he is capable of. After becoming the youngest player to be sold in IPL auction, all eyes have been on the 13-year-old and his performances. Suryavanshi scored 23 runs during the India U19 vs Japan U19 match at the Sharjah Cricket Stadium in the UAE. However, his performance cannot just be judged by the scorecard, but by the shots which the teenager played.

While opening the batting for India U19, the left-hander played some glori-

ous drives and pull shots. His run-a-ball 23 included three fours and a six as Suryavanshi and Ayush Mhatre provided India U19 with an aggressive start. Suryavanshi's opening partner Mhatre scored a quick-fire 29-ball 54 which included six fours and four maximums. India U19 boys capitalised on the start as all top-order batters fired with the bat vs Japan.

However, he didn't have a memorable outing in his first appearance on the pitch after securing an IPL contract, getting dismissed for just 1 (9) against Pakistan during the Under 19 Asia Cup game in Dubai. The 13-year-old was dismissed for just 1 (9) by Ali Raza as he looked restless at the crease.

Notably, Suryavanshi scripted history as he was bought for a whopping Rs 1.10 crore by Rajasthan Royals after an intense bidding war with Delhi Capitals. 
## In Stats: Jayden Seales' spell vs Bangladesh puts him in elite record books

KINGSTOWN, Dec 2 (Agencies): West Indies pacer Jayden Seales delivered an extraordinary bowling performance in the first Test against Bangladesh in Kingstown, etching his name in Test cricket history with one of the most economical spells ever recorded.

Seales bowled 15.5 overs, including 10 maidens, conceding just five runs while claiming four crucial wickets. His economy rate of 0.30 is now the second-best in Test cricket history.

Seales's spell was pivotal in dismantling Bangladesh's batting lineup, limiting them to a first-innings total of just 164

His relentless line and length left the batters struggling to find scoring opportunities. The West Indies capitalised on his



brilliance, reaching 70/1 at stumps on Day 2, trailing by only 94 runs and firmly in control of the match.

Seales now ranks second on the all-time list for the best bowling economy rates in Test cricket, behind only India's Bapu Nadkarni. Nadkarni's iconic spell of 32 overs with 27 maidens conceded just five runs at an economy

of 0.15 against England in 1964. Seales joins an elite group that includes other notable bowlers such as India's Umesh Yadav and Australia's Nathan Lyon.

This historic spell not only showcased Seales's potential but also provided the West Indies with a commanding start to the series, demonstrating their intent to dominate.

# Rohit Sharma-led Team India depart from Canberra for Adelaide Test vs Australia

CANBERRA, Dec 2 (Agencies): After taking part in the two-day warm-up match against Prime Minister's XI, Rohit Sharma-led Team India on Monday departed from Canberra for the Adelaide Test, which will be starting from December 6. Earlier on Sunday in the warm-up match, a four-wicket haul by pacer Harshit Rana, along with commanding knocks from Shubman Gill, Nitish Kumar Reddy, and Yashasvi Jaiswal, helped India secure a five-wicket win against Australia's Prime Ministers' XI at Canberra's Manuka Oval. While leaving, skipper Rohit and star India pacer Mohammed Siraj were seen taking were waiting outside the team hotel in Canberra.

Top batter Shubman Gill and assistant coach Abhishek Nayar were



also captured leaving the team hotel for Adelaide along with other

players.
In the first Test match of the Border-Gavaskar Trophy, India staged a stunning comeback from a series whitewash against New Zealand at home, defeating Australia by 295 runs in Perth despite being bowled out for a mere 150 runs in their first innings.

Despite losing quick wickets, an unbeaten 100 by Virat Kohli (143 balls, eight fours and two sixes), supported by Washington Sundar (29 off 94 balls, one six) and Nitish Kumar Reddy (38\* off 27 balls, three fours and two sixes),

propelled India to 487/6 declared, setting Australia a daunting target of 534 runs.

Nathan Lyon (2/96) was the best bowler for Australia, with Cummins, Starc, and Hazlewood taking one wicket each.

At stumps on Day 3, Australia were 12/3, with Bumrah taking two wickets and Mohammed Siraj one. On Day 4, despite valiant efforts from Travis Head (89 off 101 balls, eight fours) and Mitchell Marsh (47 off 67 balls, three fours and two sixes), Australia were bowled out for 238, giving India a resounding 295-run victory.

Bumrah (3/42) and Siraj (3/51) led the bowling in the second innings, while Washington Sundar took two wickets, and Nitish Kumar Reddy and Harshit Rana picked one each.

### Dominant Sindhu, Lakshya clinch singles titles | Treesa & Gayatri shine in doubles

Lakshya's win comes as a balm after a disappointing loss in the bronze-medal playoff at the Paris Olympics. The victory will undoubtedly boost his confidence ahead of the new season.

Indian badminton had more to celebrate on the day as the women's doubles pair of Treesa Jolly and Gayatri Gopichand clinched its maiden Super 300 title with a convincing 21-18 21-11 win over China's Bao Li Jing and Li

the first Indian women's doubles team to win the title at this tournament. The Commonwealth Games bronze medallists, who had finished runners-up in 2022, went one step further this year with their solid performance.

In the men's doubles final, Pruthvi Krishnamurthy Roy and Sai Pratheek K put up a valiant fight before going down 14-21 21-19 17-21 to China's Huang Di and Liu Yang in a marathon 71-minute clash.

Meanwhile, in the mixed doubles final, fifth seeds Tanisha Crasto and Dhruv

Kapila started strong but couldn't sustain their momentum, losing 21-18 14-21 8-21 to Thailand's sixth-seeded pair of Dechapol Puavaranukroh and Supissara Paewsampran.

After her victory, Sindhu said she is "definitely" going to play for the next couple of years even as the 2028 Los Angeles Games remain at the back of her mind.

The 29-year-old former world champion, in the final stretch of her career,

# emphasised the need to stay injury-free. "This (win) will definitely give me a lot of confidence. Being 29 is an advantage in many ways because I have a lot of experience. Being smart and experienced is key, and I'm definitely going to play for the next couple of years,"

Sindhu said.

"My main goal is to stay injury-free, which is very, very important. Los Angeles (Olympics) is still too far away. I will definitely play, but the main thing is staying injury-free and enjoying the sport. If I stay fit, then why not?" she added.

Sindhu said she will need to be "smarter" in picking the tournaments she will participate in next season.

"I'm very happy that I'm finishing off with a win. Now it's time to just go back, relax, and start again from January. I hope this is a comeback, and I'm looking forward to many more victories," she added.

"I'll be playing the upcoming tournaments in Malaysia, India, Indonesia, and Thailand. Obviously, we'll have to pick and choose tournaments because I'll have to be smart enough to decide what to play and what not. I need to be much smarter in terms of that," she added.

Sindhu said that she was relieved to end her title drought. "Sometimes I was really close yet so far away. I had good matches in the past, but they didn't turn into wins. I came back, fought harder, and it was important for me to get this win. Yes, I am relieved. I mean, it's the end of the year, and finishing off with a win makes me really grateful," she said.

### Mohammed Shami to join team India for Border-Gavaskar Trophy? Report reveals BCCI's latest move

"Gone are the days when anti-national elements operated with impunity. We are determined to build an atmosphere conducive to development and nation-building."

The fresh BSF deployment will act as a "second line of defense" behind existing border forces, covering vulnerable areas in Jammu and its surrounding regions. Security officials revealed that multiple points equipped with 24/7 CCTV surveillance have been established along the International Border (IB) with Pakistan to curb infiltration, arms smuggling, and drug trafficking.

This strategic move will plug gaps in areas like Samba and other sensitive locations along the Jammu-Punjab boundary.

Raman Suri further highlighted the ongoing crackdown on "white-

collared terrorist sympathizers" embedded in government departments, businesses, and NGOs. "This government is committed to cleansing the system of anti-national elements operating under various disguises," he said.

"Such individuals misguide our youth and alienate communities, but their days are numbered.

Recent firing of employees from the jobs is indicative enough for anti-nationals to mend their ways or else face elimination. The enhanced secu-

rity grid comes after a spate of terrorist attacks in 2024 across districts like Rajouri, Poonch, Udhampur, and Kathua, which resulted in over 40 deaths, including 18 security personnel. Despite these challenges, security forces have neutralized several terrorists this year, reaffirming the government's resolve to ensure law and order in J&K.

The NSG commandos. along with advanced intelligence operations, are actively working to identify and neutralize threats, including cross-border tunnels and terror networks in dense forests and mountainous terrains. Officials noted that this integrated approach would not only prevent attacks but also secure the livelihoods of civilians in the region.
