#### acquired by illegal narcotic trade in Srinagar

SRINAGAR, Dec 5 (Agencies): Jammu and Kashmir Police have seized two vehicles of a drug peddler allegedly acquired through proceeds of illegal narcotic trade in Srinagar.

Srinagar Police on Thursday said that it has seized two vehicles Corolla and BMW in case FIR No. 36/2024 u/s 8/21 NDPS Act of Police Station Chanapora from the accused person identified as Mudasir Ahmad Wani, a resident of Stadium Colony, Chanapora.

"The seizure of vehicles acquired by illegal means through narcotics trafficking has been made under the provisions of the 68 NDPS Act," police said.

"J&K Police reiterates its commitment in eradicating the drug menace and dismantling the infrastructure supporting narcotics trafficking," police added.

SRINAGAR, Dec 5 (Agencies): the summer capital of Jammu and Kashmir, has recorded the season's lowest temperature again at minus 2.1 degree Celsius while Shopian in South Kashmir, was the coldest place at minus 5.5 degree Celsius.

The Meteorological department has shared the details of minimum temperature, revealing that Srinagar has recorded a low of minus of 2.1 degree Celsius, which is the season's lowest.

Similar temperature was recorded in J&Kashmir summer capital on November 28.

Furthermore, Shopian was the coldest place in Kashmir where the mercury settled at minus 5.5 degree Celsius.

# EDITORIAL

**SUGAMYA BHARAT** he Sugamya Bharat Abhiyan, also known as the Accessible India Campaign, is a pioneering initiative launched by the Government of India on December 3, 2015, to create a barrier-free environment for persons with disabilities (PwDs). The campaign aims to enhance accessibility across infrastructure, transportation, and digital platforms, ensuring that PwDs can lead independent and dignified lives. It aligns with India's commitment to the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and the Rights of Persons with Disabilities Act, 2016. This initiative underscores the government's resolve to build an inclusive society where accessibility is a fundamental right for all citizens.

The campaign focuses on three core areas: built environment accessibility, transportation accessibility, and information and communication technology (ICT) accessibility. Under the built environment component, the government prioritizes retrofitting government buildings and public spaces with ramps, elevators, tactile pathways, and barrier-free entrances. For transportation, measures include making buses, railways, and airports accessible by providing wheelchair-friendly facilities, Braille signage, and auditory announcements. In the digital domain, the campaign ensures that government websites and applications adhere to Web Content Accessibility Guidelines (WCAG), making them compatible with screen readers and accessible to individuals with visual and auditory impairments.

One of the campaign's standout features is its emphasis on awareness. Outreach programs, training sessions, and workshops are conducted to sensitize stakeholders, including policymakers, urban planners, and the general public, about the importance of accessibility. Airports in major cities now feature ramps, accessible toilets, and Braille instructions for visually impaired passengers. Additionally, more than 700 railway stations have implemented features like tactile flooring, reserved seating for PwDs, and ramps for easy access. In the digital space, over 900 government websites have been revamped to ensure accessibility, allowing PwDs to access critical online services without difficulty. The campaign has also made strides in ensuring accessible elections. The Election Commission of India introduced measures such as Braille-enabled Electronic Voting Machines (EVMs), wheelchair assistance at polling booths, and designated queues for PwDs. These efforts have allowed a larger number of disabled citizens to participate in the democratic process However, the Sugamya Bharat Abhiyan is not without challenges. Implementation gaps persist, particularly in rural and semi-urban areas, where infrastructure remains largely inaccessible. Awareness about accessibility among stakeholders in construction, transportation, and public services is often lacking, leading to incomplete or poorly executed projects. Financial constraints also pose a significant hurdle, as retrofitting existing infrastructure and building new accessible facilities require substantial investments. Moreover, the absence of a centralized system for monitoring and evaluating progress hampers the campaign's effectiveness. To address these challenges, the government must expand the campaign's scope to include private buildings, workplaces, educational institutions, and recreational spaces. Leveraging advanced technologies like artificial intelligence (AI) can enhance accessibility in public spaces and digital platforms. Training programs for architects, urban planners, and policymakers should emphasize inclusive design and the importance of accessibility standards. Collaboration with private sector organizations and NGOs can also amplify the campaign's resources, reach, and impact. Looking ahead, the Sugamya Bharat Abhiyan has the potential to transform India into a truly inclusive nation. By creating a society where accessibility is prioritized, the campaign not only uplifts the lives of persons with disabilities but also fosters a culture of inclusivity that benefits all citizens. While much work remains, the initiative has laid a strong foundation for achieving universal accessibility. The collective effort of the government, private sector, and civil society can ensure the success of this mission, making the dream of a barrier-free India a reality.

In India, people are suffering from many such diseases, by seeing whose symptoms the doctors would be able to understand what the disease is. For exam ple, 'Acanthamoeba keratitis' is a disease due to which a person becomes blind. Its proper treatment is not available in India. Similarly, 'Creutzfeldt-Jakob' is an incurable disease, which can lead to fatal brain attack. There are thousands of similar diseases based on the symptoms, for which there is a need to find cheap, easy and effective treatment. The central government should Incurable diseases. And first look at the treatment of rare diseases, which still need a lot of research. At present only 63 diseases have been included under the National Policy for Chronic Diseases on the recommendation of the Central Technical Committee (CTCRD). In this, financial assistance up to Rs 50 lakh is given per patient. The number of medical treatment centers in India is far less than what is needed. The situation is worse in villages. Therefore, proper attention is needed on this side. Similarly, the number of doctors is very less as per the population.In villages, only one doctor is available for every lakh population. , Therefore, now new treatments for future diseases will have to be discovered. At the same time, there is a need to think about providing easy and appropriate treatment to all the currently incurable, rare and very serious diseases.

If film industry is a 'gaon', filmmaker Sudhir Mishra considers himself to be its 'chacha'. "Everyone knows me, not necessarily likes me," he chuckles. Joyous, honest, and spirited, Mishra admits of throwing tantrums often, that are well tolerated by his friends and co-workers. "These days Applause Entertainment head Sameer Nair is at the receiving end," says the director of Tanaav as he opens up about its second season.

Each project for Mishra is like a roller-coaster ride. "It's a fun party. There is joy, excitement, fulfilment, tension, problems, and at times increased blood pressure - but all of it worth it!" He is happy about how Tanaav was received by audiences. When Mishra went back to Kashmir to shoot the second season. people who had watched the first season were happy about it. "Generally it doesn't happen this way. People say portrayal theek nahi tha, but when we went back to Kashmir to shoot, people seemed to have loved it, and that's a win," he says.

Tanaav is a remake of the Israeli TV series Fauda. Mishra believes remakes are great as long as someone has something to say. "In the original series, it's the conflict between two countries, here we have set it in Kashmir. One has to bring in their life, customs, shadi, tyohar,



gami, and rituals associated with it, and narrate the story through it all. It's an amazing process, to adapt a story and tell it your own way," he says. Now that Season 1 was received well, Mishra has doubled the efforts to present it in an interesting way.

# **Prez Murmu calls on scientists to deal with** agriculture sector challenges

BHUBANESWAR, Dec 5 (Agencies): President Droupadi Murmu on Thursday called on agriculture scientists to develop and disseminate technologies in a timely manner to deal with natural disasters, adverse effects of climate change and excessive exploitation of resources.

The President made the remarks while addressing the gathering at the 40th convocation of Odisha University of Agricultural and Technology (OUAT) here.

She noted that climate change-related issues such as rising temperatures and increase in greenhouse gases are affecting agricultural pro-

duction in the country. "Agricultural scientists have an important responsibility to deal with all such issues," she said, adding, excessive use of chemical fertilisers and pesticides has also emerged as new challenges for the sector.

"Their (fertiliser and pesticide) effect on soil, water and the environment are a matter

of concern for all. Young scientists would find solutions to solve these problems," the President said.

She, however, expressed satisfaction that over the past decade, India has achieved extraordinary success in agricultural production and exporting farm goods to other countries.

"This has been possible due to the guidance of our agricultural scientists and the tireless hard work of our farmers," Murmu said.

Murmu said India's economy can be strengthened by the development of agriculture, fishery production and livestock.

The President also urged the students to contribute to the goal of making India a developed nation by 2047 through their innovative ideas and dedicated actions.

NEW DELHI, Dec 5 (Agencies): External Affairs Minister S Jaishankar, speaking in Parliament today, reaffirmed India's longstanding support for a two-state solution to the Israel-Palestine conflict by calling for the establishment of a "sovereign, independent, and viable Palestinian state" alongside Israel.

Jaishankar, Mr responding to a claim during Question Hour in the Rajya Sabha on India allegedly abstaining from all United Nations resolutions on Gaza, said that since the onset of the Israel-Hamas conflict on October 7 last year, 13 resolutions concerning Palestine have been presented in the **United Nations General** Assembly (UNGA).

"Since the beginning of the Israel- Hamas conflict, 13 resolutions concerning Palestine and viable State of Palestine within secure and recognised borders, living side by side in peace with Israel," Mr Jaishankar said.

Recent shipments in October and November 2024 included 65 tonnes of medical supplies sent to UNRWA and the Palestinian Ministry of Health.

The Ministry of External Affairs in a statement said that India has undertaken extensive diplomatic engagements to promote peace in the region. Prime Minister Narendra Modi and Mr Jaishankar have communicated with leaders across the region and beyond, including highlevel discussions with Israeli and Palestinian counterparts.

On September 22, PM Modi met with Palestinian President Mahmoud Abbas during the Summit of the Future in New York, reiterating calls for a ceasefire, the release of hostages, and renewed diplomatic talks.

India has also advocated for its position in international forums. including the United Nations, BRICS, the Non-Aligned Movement (NAM), and the Voice of Global South.



### Man enters set of Salman Khan's upcoming film, threatens his bodyguard

MUMBAI, Dec 5 (Agencies): A man was detained after he entered the set of Bollywood actor Salman Khan's upcoming film here and threatened his bodyguard using the name of jailed gangster Lawrence Bishnoi, police said on Thursday.

Khan was not present on the set in Shivaji Park area on Wednesday when the incident took place, an official said.

The accused, against whom a noncognisable or 'NC' complaint was registered, is a junior artist working in the film industry, he said.

As he walked onto the set, a bodyguard stopped him and asked what was he doing there, said the police official.

They had an argument, and the accused threatened him using Bishnoi's name, as per the complaint.

Shivaji Park police took the man in custody and registered an NC case for alleged criminal intimidation under section 351(2) of the Bharatiya Nyaya Sanhita.

As per preliminary probe, the accused and the bodyguard knew each other and they had some dispute, the official said.

In a non-cognizable case, police can not register a First Information Report or arrest any person unless instructed by a court.

Salman Khan, 58, has received multiple threats from the Bishnoi gang in the past. Two members of the gang allegedly opened fire outside his residence here in April this year. Later, Panvel police also claimed to have uncovered a plot to attack Khan.

# **Akhilesh slams Centre over reports of GST hike** on several items

LUCKNOW, Dec 5 (Agencies): Samajwadi Party president Akhilesh Yadav on Thursday attacked the BJP Government at the Centre on reports that the GST on several items might be hiked, saying the BJP plans to "increase corruption" instead of increasing revenue

In a post on X, the former Uttar Pradesh Chief Minister said, "BJP was saying 'one country, one tax' but this statement of theirs also turned out to be a 'jumlaai jhoot' (rhetoric) because now they are bringing new slabs of tax."

"When there is 'one tax, many slabs' then the slogan of 'one tax' has proved to be a lie in the true sense. Actually, there is a big game behind increasing the tax rates. This is the BJP's plan to increase corruption instead of increasing revenue to do 'vasuli' (extort money) from shopkeepers and businessmen



through the officials by exerting more pressure on them," he charged.

His remarks come after reports that the GoM on GST rate rationalisation has suggested tax rate on sin goods like aerated beverages, cigarettes, tobacco and related products will be hiked to 35 per cent, from the current 28 per cent.

However, the Central Board of Indirect Taxes on Tuesday said the GoM on GST rate rationalisation is yet to submit its recommendations to the GST Council, which is the final decision making body in fixation of tax rates. Yadav said the rule of the world is that the higher the tax rate, the more tax is evaded.

"When the more tax is evaded, the more the corrupt ruling party earns," he said.

In the BJP government, backdoor ways are first prepared to evade tax and collect it, after that any new tax planning comes out from the front door, he charged.

In the end, the burden of paying every tax falls on the public, that is why it is the public which is crushed in the mill of tax, it is the public which is hit, he said.

# Sheikh Hasina mounts stinging attack on Muhammad Yunus over Bangladesh 'genocide'

Hasina claimed that there were plans to kill her and her sister Sheikh Rehana just like their father Sheikh Mujibur Rahman was assassinated in 1975.

DHAKA, Dec 5 (Agencies): Ousted Bangladesh Prime Minister Sheikh Hasina has mounted a stinging attack on the country's interim leader Muhammad Yunus over alleged persecution of minorities

In a virtual address at an event in New York, Hasina accused Yunus of perpetrating "genocide" and failing to protect minorities including Hindus. She also claimed that there were plans to assassinate her and her sister Sheikh Rehana just like their father Sheikh Mujibur Rahman.

Mujibur Rahman was assassinated in 1975.

It was Hasina's first public address after taking shelter in India following her resignation in August in the face of massive anti-government protests, though she had commented on



the overall situation in Bangladesh.

"The armed protestors were directed towards Ganabhaban. If the security guards opened fire, many lives would have been lost. It was a matter of 25-30 minutes, and I was forced to leave. I told them [guards] not to fire no matter what hap-



"Today, I am being accused of genocide. In reality, Yunus has been involved in genocide in a meticulously designed manner. The masterminds — the student coordinators and Yunus - are behind this genocide," she

said at the event. Hasina said the current ruling dispensation in Dhaka failed to protect the minorities.

"Hindus, Buddhists, Christians no one has been spared. Eleven churches have been razed, temples and Buddhist shrines have been broken. When the Hindus protested, the lskcon leader was arrested," she said in an oblique reference to the arrest of Hindu monk Chinmoy Krishna Das.

"What is this persecution of minorities for? Why are they being ruthlessly persecuted and attacked?" she said

"People no longer have the right to justice... I never even got the time to resign," she said speaking in Bengali

Hasina said she left Bangladesh in August with an aim to stop the violence, but that did not happen.

MANILA, Dec 5 (Agencies): Philippine police officials said Thursday they are checking reports that a kidnapped American died after being shot twice while resisting his Oct. 17 abduction by gunmen in the country's south.

Elliot Onil Eastman, 26, from Vermont, was shot twice with an M16 rifle while trying to fight off his four kidnappers, who posed as police officers, in the coastal town of Sibuco in Zamboanaa del Norte province, police said.

The kidnappers dragged him to a motorboat and sped off, according to earlier police reports.

A massive search for Eastman and his abductors led to the arrest of a number of suspects, but he has not been found. Three suspects were killed in a gunbattle with police in the south last month.

Regional police spokesperson Lt. Col. Ramoncelio Sawan said investigators received information from a relative of one of the suspects that Eastman died due to gunshot wounds in the thigh and abdomen while being taken away by his abductors.

The kidnappers decid-

napped. He had been posting Facebook videos of his life in Sibuco, a poor, remote coastal town, where the suspects spotted him, police earlier said.

They said the suspects appeared to be common criminals who did not belong to any Muslim rebel groups which have been accused of ransom kidnappings in the past. Security problems have long hounded the southern Philippines, the homeland of a Muslim minority in the largely Roman Catholic nation. The southern third of

the Philippines has bountiful resources but has long been hamstrung by poverty, insurgencies and outlaws.

A 2014 peace agreement between the government and the Moro Islamic Liberation Front, the largest of several Muslim separatist groups, has considerably eased widespread fighting in the south. Relentless military offensives have weakened smaller armed groups such as the Abu Sayyaf, reducing kidnappings, bombings and other violence.

The Abu Sayyaf has targeted Americans and other Western tourists and missionaries, most of whom were freed after ransoms were paid. A few were killed, including American Guillermo Sobero, who was beheaded on the southern island of Basilan, and a U.S. missionary, Martin Burnham, who was killed while Philippine army forces were trying to rescue him and his wife, Gracia Burnham, in 2002 in a rainforest near Sibuco.

# Experts believe study of 700-year-old handwriting unveils leading Byzantine painter's true identity

a professor of Byzantine

THESSALONIKI, Dec 5 (Agencies): Crimesolving techniques applied to a medieval illuminated manuscript in Paris may have solved a centuries-old puzzle — the true identity of a leading Byzantine painter who injected humanity into the rigid sanctity of Orthodox religious art.

A contemporary of Giotto, considered the father of Western painting, the artist conventionally known as Manuel Panselinos was equally influential in a totally different tradition that's largely overlooked in the West.

But nothing is known of his life, and scholars now believe Panselinos was just a nickname that eventually supplanted the real name of the man for whom it was coined - likely loannis Astrapas, from the northern Greek city of Thessaloniki

The art of Byzantium, that decorates churches across Greece, Serbia and other Orthodox countries, stands out for the stark formalism of its elongated, glowering saints, quasi-cubist mountains and doeeyed Madonnas.

Work attributed to Panselinos, from the late 13th and early 14th centuries, is considered the finest produced in an empire that straddled

Europe and Asia and endured from the fall of Rome until the capture of the imperial capital Constantinople by the Ottoman Turks in 1453. Art historians had long suspected that the name - Greek for "full moon" - could have originated as a nickname for some member of the so-called Macedonian School of painting, based in Thes-

saloniki Recent research by a Greek monk and linquistics scholar linked "Panselinos" with Macedonian School painter Astrapas. Now court handwriting expert Christina Sotirakoglou has matched lettering on a manuscript tentatively attributed to Astrapas with characters on a church painting in northern Greece, long seen as Panselinos' best work.

Father Cosmas Simonopetritis, a former senior administrator in Mount Athos, the semiautonomous monastic community where the Protato church stands, says Sotirakoglou's and his own research "clearly prove" Panselinos' real identity.

"Panselinos was a real person, and (the name) was just the nickname by which loannis Astrapas became known," he told The Associated Press Constantinos Vafiadis,

art in Athens who was not involved in the studies, said he found merit in the nickname theory and Astrapas link, even though it appeared more than one painter had undertaken the Protato project. "I agree with attribut-

ing part of the paintings to Ioannis Astrapas," he said. "But again there remains much ground for future research into that person, because other Mount Athos monuments from the same period have not vet been sufficiently published.3

"Panselinos" — a role model for generations of painters - and his contemporaries are associated with a renaissance of kinds in Orthodox art that revived forms and techniques inherited from antiquity. Facial expressions acquired a deeper humanity, and greater attention was paid to proportion and depth of field in composition.

Father Cosmas said Astrapas was an "extremely gifted painter ... with vast knowledge who harmonically combined the ancient, classical world with Orthodox Byzantine spirituality.'

"And that ... makes his work unique worldwide," he added. Artists' signatures

were not common at the time, although some survive from members of the Astrapas family. There are none by "Panselinos.'

The trail started with earlier research linking Astrapas with the artist and scholar who wrote and illustrated Marcian Codex GR 516, an early 14th century Greek handwritten text treating subjects from astronomy to music theory. Among the painted illustrations was a full moon. "For me ... that was the main proof," Father Cosmas said.

With a name found for the hand that produced the manuscript, the next step was to check its style against writing on the Protato painting, traditionally linked with "Panselinos.

"Mrs Sotirakoglou, who is a handwriting expert, filled in that blank," Father Cosmas said

To enroll in the next year or semester, learners need to fill and submit the IGNOU reregistration January 2025 form by the submission deadline which has been fixed for 31st January, 2025. The students who did not attempt the term-end examinations or did not submit their assignment can still apply for re-registration for January 2025, provided the minimum programme duration is achieved

and programme validity has not expired.

The learners can apply for IGNOU re-registration January 2025 by visiting the official website of the IGNOU www.ignou.ac.in. The direct link for online re-registration is https:// onlinerr.ignou.ac.in/ which can be accessed under the drop-down menu option "Register Online>>Re-registration" on IGNOU website home page. In case any learner has forgotten his/her User ID or password or has changed the registered mobile number at later stages and is not able to log in to re-register, he/ she must approach the Regional Centre or drop a mail on rcjammu@ignou.ac.in with the request to reset the password.

In case online payment made by any learner does not get updated, do not make the second payment immediately. Learners must

wait for a day, check the payment status and then decide further course of action. Learners are advised not to wait for the last date for submission of re-registration form since the servers get heavily overloaded towards the last date of online submission due to huge rush. "Learners must exercise due caution in making online transactions and as far as possible must use their own card/net banking to make payment and in case the learners are using third-party services (cybercafé or some other outlet) for submission of re-registration form, they must ensure that the courses have been correctly chosen and payment of programme fee has been made successfully. ## Hardik Pandya-less Baroda script history, achieve sensational record in T20 cricket

INDORE, Dec 5 (Agencies): Baroda scripted history by posting the highest team total in the history of T20 cricket during their Syed Mushtaq Ali Trophy encounter against Sikkim on Thursday. Baroda ended up scoring a mammoth 349 for the loss of five wickets and surpassed the previous record held by Zimbabwe (344/4 against Gambia in October 2024). This was also the first time that any team scored more than 300 in the SMAT with the previous highest total being 275/6 by Punjab. Baroda registered this huge total without Hardik Pandya in their side and captain Krunal Pandya not even getting a chance to bat. Batting first, Baroda were off to a flying start manyu completed his half-century and scored 53 off 17 deliveries.

It turned out to be the ideal platform for Bhanu Pania who scored an unbeaten 134 off 51 deliveries with the help of 5 fours and 15 sixes. It was a display of pure power as he ended his innings with a strike rate of 262.75 as Sikkim bowlers looked completely helpless against the onslaught.

That was not the end as Shivalik Sharma scored 55 off 17 balls while Vishnu Solanki scored 50 off just 16 balls to take Baroda's score to 349 and register a big record in the shortest format of the sport.

Earlier, India's T20 skipper Suryakumar Yadav smashed 70 tillating 37-ball-71 as Mumbai outplayed Services by 39 runs.

Mumbai scored 192 for 4 riding on the 130run fourth wicket stand between Surya and Dube.

# **Rishabh Pant has taken to Test cricket like a** duck to water: Rahul Dravid

MUMBAI, Dec 5 (Agencies): The void left by MS Dhoni's retirement in Indian cricket lineup was quickly filled by Rishabh Pant, who embraced Test cricket like a "duck to water", feels former head coach Rahul Dravid

The flamboyant wicketkeeper-batter, who returned after surviving a horrific car crash in December 2022, scored a match-winning 89 in the fourth Test at the Gabba and contributed 274 runs throughout the series, playing a key role in India's historic 2-1 triumph in the 2020-21 tour.

"It's hard to imagine that, after Dhoni left, you felt there might be some time for someone to come in and replace him," Dravid told Star Sports.

"I'm not saying he's replaced him, but certainly in Test cricket, his performances have been absolutely sensational, an incredible performance.

I think the way India has performed in Australia over the last two series in particular -winning series there - that counts for a lot.

"However great my performances or India's performances were, we couldn't actually win that series. We came close, but we couldn't get the wickets on the final day in Sydney that we needed.

"The last two teams that have gone to Aus-

tralia have done that. and that's a fantastic achievement - a terrific achievement - and there have been some absolutely sensational performances right through those." Dravid was joined by VVS Laxman when India were reeling at 85/4, especially after the hosts had posted a mammoth 556 in just a day and a half.

Ganguly run-out: My mistake

The 51-year-old reflected on the incident where he had accidentally run out his captain Sourav Ganguly and admitted it was his "mistake".

"I was thinking, 'I've got the captain run out. I better do something meaningful.' It was totally my mistake getting Sourav (Ganguly) run out. I will own up to that one - it was my mistake." "But, I think you're just trying to bat, you're just trying to build a partnership, you're just trying to get to the target.'

The thing with Laxman and me is that we had batted together a couple of really big partnerships before that. We did it once in Kolkata in 2001 and even in a domestic game when we first played South Zone against West Zone.

"So, we had kind of batted a lot together and built this partnership. Not that we were thinking about that when we got out there, but I think the idea was really just to bat and try and build partnerships, stitch something together." "It's always nice bat-

Meanwhile, India are yet to name their playing eleven for the upcoming pink-ball Test. The Adelaide test will

# Non-Gazetted police pensioners hold protest, project demands

JAMMU. Dec 5: A protest led by Ajit Singh, Chairman of the Non-Gazetted Police Pensioners Welfare Forum, was held at Hari Singh Park, Jammu, to address significant grievances of J&K Retired Police Pensioners and Fire Services personnel

The protest highlighted longstanding issues related to pay anomalies, healthcare, welfare benefits, and recognition of achievements, urging the government to act swiftly and justly.

One of the primary demands raised was the retrospective implementation of Govt. Order No. 229F of 2014. The forum stressed that the pay anomaly correction should be applied from 1996, the year the 5th Pay Commission recommendations were implemented across the state. Unfortunately, the Police Department was excluded from this correction at the time. Many affected personnel have since passed away, and the surviving pen-



sioners deserve to be compensated for the years of injustice. The protesters also demanded that healthcare facilities for J&K police personnel be brought on par with those provided to paramilitary forces. They called for the introduction of the Ex-Servicemen Contributory Health Scheme (ECHS) card to ensure affordable and accessible medical care for retired police personnel and

their families. To support the families of police personnel, the forum urged the government to implement a 10% reservation in professional colleges and recruitment processes for their children. This would provide a much-needed boost to the welfare and future of police families. Additionally, they called for the immediate release of pending Dearness Allowance (DA) installments to help alleviate financial hardships faced by retirees and state employees.

The forum emphasized the need for the state government to adopt the One Rank One Pension (OROP) scheme for the Police Department, in line with the central government ordinance implemented for the armed forces. Such a move would ensure equitable treatment for all ranks in their post-retirement benefits.

Another pressing issue raised was the delayed salaries of Special Police Officers (SPOs), which has caused financial strain on these personnel. The forum demanded that SPOs receive their salaries on time and according to a proper schedule. Additionally, they highlighted the achievement of Manpreet Singh, an SPO who won a gold medal in the World Strength Lifting Championship held in Kazakhstan in July 2024. The forum called for his recognition and appropriate rewards to encourage excellence among the force.

The protest shed light on these unresolved issues, urging the J&K government to address them without delay. The demands represent not only financial and professional justice but also the recognition and welfare that these personnel deserve for their dedicated service to the region.
