J&K and Ladakh **High Court** introduces uniforms for E-courts staff

JAMMU, Dec 6 (Agencies): The High Court of Jammu & Kashmir and Ladakh has prescribed new uniforms for its e-Courts and IT Section staff, following recommendations from the IT and Artificial Intelligence Committee approved by the Chief Justice. As per an order, male staff will wear blue suits (pants and coats) with white shirts and blue ties featuring the e-Court logo, while female staff can opt for blue salwarkameez with matching blue coats and name badges.

The uniforms will be replaced every two years, similar to the policy for other High Court employees, the order said.

Srinagar shivers at minus 4.1 degree Celsius, coldest so far

SRINAGAR, Dec 6 (Agencies): Temperatures plummeted further in Kashmir valley on Friday with Srinagar recording minus 4.1 degree Celsius, coldest in the season so far.

J&K LG vs Omar Abdullah govt: Jurisdictions clearly defined, say Home Ministry sources

JAMMU, Dec 6 (Agencies): Amid the growing friction over the division of powers between the Raj Bhavan and the elected government in Jammu and Kashmir, the Union Home Ministry has said that there is no question of overlapping powers as jurisdictions are very clear, said sources on Friday. Jammu and Kashmir tourism

This comes after a few instances where the Omar Abdullah government has cried foul.

Taking the brewing confrontation further, Deputy Chief Minister Surinder Choudhary on Friday said the Omar Abdullah government has enough powers to rise to the aspirations of the people.

The appointment of the advocate general is one point in question where the friction appears to have produced some

D.C. Raina had resigned as the advocate general of the UT immediately after the elected government took office. Chief Minister Omar Abdullah later 'rejected' Raina's resignation and asked him to continue as the

advocate general Despite the chief min-



ister's directive, Raina could not resume his duty as the advocate general reportedly because the approval from the Raj Bhavan did not come to confirm the chief minister's directive.

This is believed to be one 'clash of authority' between Raj Bhavan and the elected govern-

The other flashpoint was reportedly provided by the transfer of three IAS officers by the Raj Bhavan while the chief minister was away in Saudi Arabia performing the 'Umrah' (Pilgrimage to Mecca other than the annual Hai).

"If seen from the right perspective, there is no overlapping of jurisdiction. The right to appoint the advocate general

wrests with the Lieutenant Governor under the J&K Reorganisation Act 2019 read with the J&K Reorganisation Amendment Act 2023. There is no way this should be interpreted as any point of friction between the Lieutenant Governor and the chief minister. The chief minister, as long as he is the CM of J&K as a union territory, should have no confusion about his powers. The chief minister has all the powers except that the prerogative to transfer IAS/IPS officers lies entirely with the Lieutenant Governor as does his power over the UT police department. If the Lieutenant Governor ordered the transfer of

why should anybody try and interpret it as overlapping or overstepping of jurisdiction?" sources in the Union Home Ministry told IANS.

"Lieutenant Governor Manoj Sinha has made it amply clear that he stands to support and work together with the elected government. In fact, it was the tireless effort and commitment of the L-G that both Lok Sabha and Legislative Assembly elections were held peacefully and in the fairest manner that ensured that the will of the people was reflected in the elected government that we have in J&K today," the sources said.

"The L-G is constitution-bound to perform his duty as clearly defined in the Reorganisation Act. Yes, there is nothing called absolute power which lies either with the Lieutenant Governor or the chief minister. Both are constitutionally elected and appointed offices and each has to perform for the benefit of the people. Anybody trying to create a wedge between the offices of the Lieutenant Governor and the chief minister is neither a well-wisher of the people nor of the two August offices he/ she wants to bring into confrontation", sources in the ministry further told IANS.

The same sources added that the rules of business are being vetted by the Union Home Ministry and would soon be made public to put at rest all speculations of overlapping of jurisdiction in J&K.

In a nutshell, as long as J&K remains a UT, the members of the council of ministers must understand the limitations put by the Constitution on their right to freely exercise powers when these come into conflict with those vested by the Constitution in the office of the Lieutenant Gov-

3 notorious drug peddlers arrested with 21 grams heroin, 4 mobile phones, cash of Rs. 38770

SAMBA, Dec 6: Intensifying its drive against narcotics smugglers/ suppliers, J&K Police has arrested three notorious drug peddlers including two ladies, all residents of Rakh Barotian Vijaypur and recovered approximately 21 grams heroin, four mobile phones, one weighing machine and cash amounting to Rs 38,770.

A Police party of Police Station Vijaypur headed by SHO Vijaypur under the supervision of SDPO Vijaypur and under overall supervision of SSP Samba during special vehicle checking naka near Rakh Barotian Vijaypur, intercepted a bike without registration no. coming from Rakh Barotian side and moving towards Vijaypur for checking.

During checking, approx. 11.43 grams of heroin like substance, 04 mobile phones, one weighing machine and cash of Rs 24630 have been recovered from the possession of bike rider and lady pillion rider.

The accused identified as Bhag Ali alias Ashig Alim son of Gau and Meenu, daughter of Gau, both resident

of Rakh Barotian, tehsil Vijaypur, district Samba have been arrested and the contraband item alongwith other items recovered on the spot have been seized.

The arrested accused happens to be brother and sister who are involved in illegal narcotics trade and are operating in the Vijaypur area. Both are used to supply drugs to the addicts in the region.

A case FIR No. 155/2024 under sections 8/21/22/27-A/29 NDPS Act has been registered at Police Station Vijaypur and investigation started.

Similarly, in an another operation against narcotic smugglers, a female drug peddler namely Roshan Bibi alias

Lalu alias Alu, wife of Lal Hussain, resident of Rakh Barotian Vijaypur has been arrested with approximately 8.90 grams heroin and also recovered cash of Rs 14,140 from her possession by Police team of Vijaypur during special naka near Rakh Barotian Vijaypur.

Kapoor, President of the Parents Association Jammu, has expressed strong concerns over irregularities in the education system and the functioning of the Jammu and Kashmir Fee Fixation and Regulation Committee (JKFFRC).

Speaking at a press conference in Jammu, he raised questions about the department's policies, particularly regarding the refusal to admit children under six years old to the first class, despite them being enrolled in earlier grades like nursery or kindergarten.

Kapoor criticized the rule that bars children below three years of age from nursery, calling it unfair and inconsistent, especially when earlier enrolled students face

hurdles in promotion. Kapoor highlighted that orders aimed at reducing the burden on nursery children, such as banning heavy school bags, are being openly flouted.

He also accused private schools of charging admission fees and capitation fees, practices explicitly prohibited.

According to Kapoor, private schools have been allowed to arbitrarily increase fees

with the approval of JKFFRC, a decision he claimed needs thorough investigation. He further alleged a nexus involving the sale of books, notebooks, and uniforms, with schools forcing parents to make specific purchases at inflated prices.

Additionally, Kapoor criticized political leaders for participating in ribbon-cutting ceremonies at private schools, accusing them of indirectly legitimizing the alleged exploitation of parents by these institu-He argued that such

actions send the wrong message and embolden schools to act arbitrarily, especially during the admission season in March and April. To address these

issues, Kapoor has demanded a high-level investigation into the JKFFRC's operations and fee-related decisions

He also claimed to have evidence of a major scam within the committee and promised to expose it in the coming days. Kapoor emphasized the need for stricter enforcement of existing rules and immediate corrective actions against schools and regulatory bodies found guilty of wrongpolitical emancipation of India cannot

Dr B.R. Ambedker - was a multifaceted Personality & Messiah of downtrodden

■he grateful nation is commemorating / observing the death anniversary of the Dr B.R. Ambedkar today on 6 December 2024 and the best way of paying tribute to this great man on his death anniversary is to remember him and make serious and honest efforts to make India of his dreams which is free from the untouchability & injustice as well as social discrimination .This great man passed away after performing many great deeds which had left indelible imprint and legacy on 6 December 1956 and this irreparable loss was mourned by Indians . His death anniversary is celebrated annually on 6 December as Mahaparinirvan Din which serves as a solemn occasion for reflection and remembrance, prompting individuals to contemplate the strides made in upholding the ideals set forth by Dr B.R.Ambedkar ,while acknowledging the persistent challenges on the path towards a more just and equitable society. This year the nation is observing 68th death anniversary of the great hero .Dr Bhimrao Ambedker was the embodiment and epitome of multifaceted personality and will be remembered for his unmatched and unparallel taints of head and heart .He was the doyen of social change, harbinger and advocate of classless and casteless Indian society where people belonging to various castes will get equal opportunity for development .He is remembered for his selfless crusade for social change ,social reform and unity in the society .The contribution of Ambedker in the social and political life of India cannot be exaggerated .He had done much for the cause of the Dalits ,under privileged and downtrodden sections of the society .He was born as Hindu but he embraced Buddhism because he felt uneasy with the caste division of Hindu religion and worked hard throughout his life for doing away with casteism in the caste ridden society and worked tirelessly for the cause of abolishing caste division in society .His contribution towards the social and

be overlooked . His life and contribution was immense to social and political field and will remain to inspire future generations .Ambedker was highly educated and had a doctorate to his credit .He gave much importance to the education of the Dalits ,underprivileged and downtrodden sections of the society .He was of the view that weaker sections and those at the bottom of the society cannot develop without education and he thus gave much emphasis on their education .Ambedkar was the architect of the India's constitution and he was the chairman of the drafting committee of the constitution .His contribution towards the framing of the constitution cannot be under looked .Dr Ambedkar was a multi-faceted and multi-dimensional personality .Popularly known as Babasaheb ,Dr B.R.Ambedkar was an eminent educationist ,a great economist ,an able administrator and a radical political and social thinker of his time .He was a versatile personality wrote on such diverse subjects as anthropology, sociol ogy,economics,philosophy,religion,law ,history and politics .He had good command over all these varied and diverse subjects. He is also known as the father of Indian constitution .Ambedkar was born in the community of Mahars in the present Madhya Pradesh state . Throughout his childhood he faced the stigma of caste discrimination . Hailing from Hindu Mahar caste, his family was viewed as untouchable by the upper castes .He faced worst kind of discrimination and humiliation in his school and then in his future life as well .Ambedkar raised strong voice against this discrimination . . After completing higher education and coming back from USA ,Ambedkar was appointed as the defense secretary to king of Baroda, but here also he faced discrimination and thus humiliation being an untouchable .He fought against the two principal inhuman social evils prevalent in Hindu society- untouchability and casteism .His social thinking was the outcome of total discrimination and humiliation meted to his community by the upper caste Hindus and thus he raised strong voice against these social evils .This made him the savior and darling of the lower castes .He fought throughout his life for the cause of the lower castes which made him so dear to the lower castes .So his philosophy was the political emancipation and education of lower castes and also their role in participation in the politics. .He also worked for political enlightenment as well as and spiritual awakening of his community .He was of the view that political democracy will be fragile without the social democracy at its base .Ambedkar sought to eliminate the con-

tradictions resulting from equality in politics and inequity in social and economic life .Institution set up by him became vehicles of change such as Hitkarani Sabha and the Independent Labour Party of India .He stressed upon constitutional methods and means to achieve social justice. He believed in the path of non -violence and peace to attain social, economic and political freedom of the lower castes . Ambedkar was of the firm view that political freedom is meaningless without social emancipation and therefore all of us including those sitting at the top executive positions should work towards the social change and he also believed that regeneration of the country and its politics is not possible without social and economic freedom and therefore social and economic equality is of paramount for the country's development and for attaining social and economic freedom and for this all of us should work in cooperation to achieve social and economic liberty in the country .His plea for adoption of non -violent means is an important component of not only of his political philosophy but his moral and ethical view .He emphasized the need for economic and social emancipation of the underprivileged people .He floated the Bahishkrit Hitkarni Sabha in July 1924 .He became founder of Samaj Samata Sangh which was based on the principle of social equality .He is the architect of the constitution and while drafting the constitution ,he incorporated the principal of socio-economic justice along with political and civil rights .He sought to make the Indian constitution as an effective means for social change . According to him attainment of political freedom was not the sufficient condition for social change and social regeneration .He stressed for the economic emancipation of the under privileged sections of the society .Thus it was the firm view of Ambedkar that political independence has little meaning and significance without social freedom and social regeneration He laid foundations of two political organizations namely the Independent Labor Party of India in 1936 and Scheduled Caste Federation in 1942 which later on turned into Republic Party of India .He included principles of socio-economic justice along with political and civil rights in the constitution .Ambedkar sought to make the constitution of India as an effective means of social change .He gave immense importance to fundamental rights and incorporated these in the constitution to give the citizens these civil rights for their social and economic development and for making Indian society an egalitarian one having liberty and fraternity .Ambedkar wanted to make fundamental rights effective and for this it was thought necessary that every citizen should be in a position to claim and demand the fundamental rights .He wanted fundamental rights binding upon all the institutions of the government and private institutions also .He considered fundamental rights of paramount importance for the development of human personality .According to him ,these fundamental rights should not be absolute but should be checkmated by fundamental duties and these are interdependent on each other but the original constitution did not had the fundamental duties of the citizens in it and it was in year 1976 that fundamental duties were incorporated in the constitution .He did not thought the need to incorporate secularism in the constitution and the word secular was added to the preamble of constitution of India in 1976 by way of 42nd amendment to the constitution. Ambedkar was appointed the chairman of the drafting committee of the constituent assembly .Being a social revolutionary he championed the cause of the Dalits and other lower castes throughout his life and to the some extent he was successful in this regards as well .He was in fact the messiah of the downtrodden and weaker sections of the society and for their political ,social upliftment he worked very hard .day and night and got much for these classes of the society . Ambedkar championed the cause of Dalits and other untouchables who were oppressed from centuries and worked for their equality in social, economic and political life. He wanted to create a new social, economic and political order in which every citizen will feel equal and there will be no discrimination against any one on the basis of his caste ,creed ,color and faith .He asked the untouchables to organize, educate and agitate as this as per him will free these weaker sections from the chain and shackles of untouchability. Ramchandra Guha considered Ambedkar as a unique example of success and inspiration .His journey from being an untouchable to India's first Law Minister is not less than extra ordinary and no mean development. Gail Omvedit calls Ambedkarism as a living force in India. Ambedkar's philosophy will continue to inspire Indian's for generations. The best tribute to Ambedkar on his death anniversary today on 6 December, 2024 is to make India of his dreams. In brief his was a multifaceted personality which cannot be penned down in a small page.

Punjabi cinema is witnessing a shift—one that balances commercial appeal with deep, character-driven storytelling—and someone who embodies this evolution is Prince Kanwaljit Singh.

Known for his versatility and sincerity, Prince has earned comparisons to some of the finest actors in Indian cinema. And, it's not just because of his commitment to his craft, but also the way he blends humility with artistry.

Prince's preparation for a role is simple and effective. "I don't go too deep into the character's psychology beforehand," he admits. "I don't plan. I go with a fresh mind and let the director guide me."

He allows the character to evolve organically on set, trusting in the director's vision while contributing to the nuances of his role. This is why he calls himself "a director's actor". His collaborative spirit is what helps bring a film's vision to life in the most authentic way possible.

He admits that while he occasionally contributes ideas to set details—like the choice of a torn sweater for a character—he doesn't impose his vision. "My secret also is that I focus on one



film at a time. I am not greedy that way. I feel every character needs a certain look, behaviour and sincerity and when it's one point focus, it's so much easier to maintain consistency that way." he says.

Ask about his signature roles, and his reply is prompt — Pamma from his latest film, Sector 17. "Yes, Pamma is a character that sticks with you," he says, reflecting on the enduring impact of that role in Punjabi cinema.

Prince's rise to prominence didn't follow a conventional path. Unlike many of his peers, who had a clear plan for entering the film industry, Prince's journey was marked by serendipity and raw talent. "I didn't

always know I wanted to be an actor," he shares. "I grew up in a family where education was the focus. But when relatives came over and read magazines featuring movie stars, I got hooked on the idea of acting. One day, I pointed to a picture of a Tamil actor on a motorbike and said,

'I want to be like him'."

His early exposure to theatre and the connections he made in the industry were crucial in shaping his career. Even as a 10th grader, Prince would travel to Mumbai, spending a year at a time in the city, soaking in the creative energy.

Despite his success, Prince remains grounded. "I didn't know the procedure back then," he reflects on his early days in

theatre and film. "And that was the best thing. I was so ignorant. I just wrote plays, acted in dramas, and people liked it." His lack of formal training in writing and acting didn't hinder his progress; in fact, it allowed him to approach his work without the constraints of overthinking. "I didn't over-prepare or worry about the 'right' way to do things. I just did them."

This unassuming approach is something Prince attributes to his success. "If I had known the rules, I might have over-analyse everything. The fact that I didn't know allowed me to stay true to my instincts."

One of the most profound insights Prince shares during the interview is his philosophy on money and success. "Money is just a byproduct," he asserts. "As long as your body is working, you'll earn. So, my focus is doing good work itself, not the pay check."

Looking ahead, Prince has a packed slate of projects, including Panchi 2 and Punjabi Aa Gaye Oye, a romantic comedy. "Romance was tough for me at first, but it's getting easier," he admits, signalling his willingness to explore new genres and keep growing as an artiste.

Jodo Yatra, Priyanka said her brother walked 4,000 kms from Kanniyakumari to Kashmir for the unity of this country.

She also alleged that the BJP did not have the courage to discuss the Adani issue in Parliament.

"They don't have the courage to discuss the Adani issue (in Parliament). Why is there a problem in discussion... discussion happens in democracy only, they are afraid of it as well," she said.

On Thursday, Bharatiya Janata Party MPs K Laxman and Patra cited to the press a report published by French media outlet "Mediapart" to target Gandhi.

Patra claimed that billionaire investor George Soros and some USbased agencies, investigative media platform Organised Crime and Corruption Reporting Project (OCCRP) and Gandhi form a "dangerous" triangle trying to destabilise India and stoke public disaffection for a regime change in the country.

"I have no hesitation in saying that he (Gandhi) is a traitor of the highest order," Patra said.

Excise Policy | Delhi HC refuses to prepone hearing on Kejriwal's plea in money laundering case

NEW DELHI, Dec 6 (Agencies): The Delhi High Court on Friday refused to advance the hearing on a petition by A chief Arvind Kejriwal challenging a trial court's order taking cognisance of a chargesheet filed against him in a money laundering case.

Justice Manoj Kumar Ohri said, "matter will be heard on the same date . I have a lot on the board to hear."

Kejriwal had sought preponement of the date of hearing on his petition from Decem-

After the court declined to change the date, Kejriwal's counsel pleaded that the Enforcement Directorate be directed to a supply copy of its reply to the petition in advance.

"Whatever you file, give it to them also," the court told the ED's lawyer.

On November 21, the high court refused to stay at that moment the trial court proceedings against Kejriwal in the money laundering

The high court had issued notice and sought response of the ED on the plea by the former Delhi chief minister.

Kejriwal sought setting aside of the trial

court order and argued that the cognisance of the chargesheet was taken by the special court in the absence of any sanction for his prosecution, which was required, as he was a public servant when the alleged offence was committed.

However, Solicitor General Tushar Mehta, appearing for the ED, submitted that a sanction was obtained to prosecute Kejriwal and he would be filing an affidavit.

Besides seeking to set aside the trial court's July 9 order taking cognisance of the chargesheet, Kejriwal has also sought quashing of all proceedings in the case.

The plea contended that the prosecution of Kejriwal was bad in the eyes of law as it was done without obtaining the mandatory sanctions under Section 197 CrPC despite the allegations pertaining to the official acts performed by him.

According to Section 197 of the CrPC, when any person who is or was a judge or magistrate or a public servant not removable from his office save by or with the sanction of the government, is accused of any offence, no court shall take cognisance of such offence

except with the previous sanction.

On November 12, the high court sought ED's response on another plea filed by Kejriwal who challenged summons issued to him on the agency's complaint in the money laundering case.

The high court refused to stay the trial court proceedings at the moment in the criminal

While Kejriwal was granted interim bail by the Supreme Court on July 12 in the money laundering case, he was granted bail in the CBI case on September 13.

According to the CBI and the ED, irregularities were committed while modifying the excise policy and undue favours were extended to the licence holders.

The Delhi government implemented the policy on November 17, 2021 and scrapped it by the end of September 2022 amid allegations of corruption.

The money laundering case stems from a CBI case lodged after Delhi Lieutenant Governor V K Saxena recommended a probe into the alleged irregularities in the implementation of the excise policy.

Woman constable dead, 3 injured as police vehicle overturns in UP's Rampur

RAMPUR. Dec 6 (Agencies): A Police Response Vehicle (PRV) overturned into a drain in Rampur district of Uttar Pradesh. leaving a woman constable dead and three other personnel injured, officials said on Friday.

The PRV was on its way to attend a distress call when the incident took place in the Patwai police station late Thursday night, they said.

PRV Commander constable Akash Diwakar, constable driver Sumit Pawar, and women constables Pinky and Ruchi were on board the vehicle. Constable Ruchi, a native of Bijnor district, succumbed to injuries, while other three have been referred to Moradabad for better treatment, according to the



"Our PRV from the

Patwai police station area was on its way to an event when it met with an accident and overturned into a drain. Tragically, a woman constable has lost her life, and three others sustained serious injuries," Rampur Additional Superintendent of Police Atul Kumar Srivastava said.

"They were initially treated at the district hospital and later referred to Cosmos Hospital in Moradabad. All three are stable but are being sent for further treatment and investigation," he said.

The officer said that necessary actions were promptly taken and senior officers reached the site, and the injured were provided immediate care.

"Further investigations are ongoing. The deceased constable was a resident of Bijnor. Appropriate measures will follow," Srivastava added.

Farmers' protests received huge booster dose from no less than Vice President: Congress

NEW DELHI, Dec 6 (Agencies): The Congress on Friday reiterated its support for farmers' demands and said their protests have er dose" from no less a person than Vice Presi-

dent Jagdeep Dhankhar. The opposition party's assertion came ahead of a scheduled march by a group of farmers to Delhi from their protest site at the Shambhu border on the Punjab and Haryana border.

Also, the remarks come days after Dhankhar, speaking at a ceremony to mark the centenary of ICAR-CIR-COT in Mumbai, said, "Agriculture minister, I request you to please tell me, what was promised to the farmer? Why was the promise not fulfilled? What should we do to fulfil the promise? There was a movement last year, and there is a movement this year,



Congress general secretary in-charge communications Jairam Ramesh noted farmers are marching to Parliament Friday.

"Their protests received a huge booster dose from no less a person than the Vice President and Hon'ble Chairman of the Rajya Sabha himself," Ramesh said in his post on X.

"Farmers and their organisations have been agitating for the following demands - Legal guarantee for MSP, setting of MSP at 1.5 times the comprehensive cost of cultivation, as rec-

ommended by the MS Swaminathan Commission and one-time debt relief for farmers - just as banks have written off Rs 16 lakh crores of defaulting private companies," he said.

They are also demanding decisions on import and export of agricultural commodities be taken by an independent agency in which farmers are adequately represented, he said.

"The farmers want the PM Fasal Bima Yojana - currently geared towards benefiting insurance companies - to be restructured to

meet farmer interests and concerns," Ramesh said, adding, "The Indian National Congress fully supports these and other demands put forth tions."

Ramesh also shared the NYAY quarantees the Congress had promised in the run up to the Lok Sabha polls which included giving legal guarantee for MSP, fixing of MSP as per the Swaminathan Commission's formula and debt waiver.

The farmers are marching to force the Centre for a legal guarantee for minimum support price for crops.

A heavy deployment of security personnel has been made on the Haryana side of the border.

The Ambala district administration has already issued an order under Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), restricting any unlawful assembly of five or more persons in the district.

The farmers are gathered under the banner of Samvukta Kisan Morcha Mazdoor Morcha and have been camping at Shambhu and Khanauri border points between Punjab and Haryana since February 13 after their march to Delhi was stopped by security forces.

Besides MSP, the farmers are also demanding farm debt waiver, pension for farmers and farm labourers, no hike in electricity tariff, withdrawal of police cases (against farmers), and "iustice" for the victims of the 2021 Lakhimpur Kheri violence.

Reinstatement of the Land Acquisition Act, 2013, and compensation to the families of farmers who died during the previous agitation in 2020-21 are also part of their demands.

10 dead in two road incidents in Uttar Pradesh's Pilibhit, Chitrakoot

PILIBHIT/CHITRA-KOOOT, Dec 6 (Agencies): At least 10 people died and around a dozen were left injured in separate road crashes in Uttar Pradesh's Pilibhit and Chitrakoot districts early Friday, police said.

In Pilibhit, a car with 11 people crashed into a tree in an area under the Neoria Police Station, resulting in the death of five passengers, a senior police officer said.

"Some people from Khatima in Uttarakhand had come here to attend a wedding. They were on their way back in a Maruti Ertiga car with 11 people onboard. The car apparently lost control and crashed into a tree along the road," Superintendent of Police (Pilibhit) Avinash Kumar

Pandev told agency. "Doctors have informed us that three people were brought dead to the hospital while two succumbed during treatment — a total of five casualties,"

he said.

Pandey said four of the injured people were referred to a more advanced centre for better treatment while two were discharged after primary aid.

"All possible medical care is being provided to the injured," he added.

In Chitrakoot, Superintendent of Police Arun Kumar Singh said five people died when a Mahindra Bolero collided head-on with a truck, resulting in five deaths.

"The incident happened around 5.30 am in the Raipura Police Station area.

The Bolero was coming from Prayagraj while the truck from Raipura," Singh said.

"There were 11 people in the Bolero, of which, so far, five people have died while the remaining are undergoing treatment locally. They are being referred to the district hospital for better treatment," the SP said. Legal proceedings

South Korea's governing party head supports suspending Yoon's powers, making impeachment more likely

SEOUL, Dec 6 (Agencies): South Korea's governing party chief expressed support Friday for suspending the constitutional powers of President Yoon Suk Yeol for imposing martial law this week, in a bombshell reversal that makes Yoon's impeachment more likely.

Opposition parties are pushing for a parliamentary vote on Yoon's impeachment on Saturday, calling his shortlived martial law declaration an "unconstitutional, illegal rebellion or coup." But they need support from some members of the president's People Power Party to get the two-thirds majority required to pass the impeachment motion. The turmoil resulting from Yoon's nighttime martial law decree has frozen South Korean politics and caused worry among neighbours, including fellow democracy Japan, and Seoul's top ally, the United States, as one of the strongest democracies in Asia faces a political crisis that could unseat its leader.

During a party meeting, PPP leader Han Dong-hun stressed the need to suspend Yoon's presidential duties and power swiftly, saying he poses a "significant risk of extreme actions, like reattempting to impose martial law, which could potentially put the Republic of Korea and its citizens in great danger."

Han said he had received intelligence that Yoon had ordered the country's defense counterintelligence commander to arrest and detain unspecified key politicians based on accusations of "antistate activities" during the brief period martial law was in force.

"It's my judgment that an immediate suspension of President Yoon Suk Yeol's official duties is necessary to protect the Republic of Korea and its people." Han said.

In a closed-door briefing to lawmakers, Hong Jang-won, first deputy director of South Korea's National Intelligence Service, said Yoon called him on the phone after imposing martial law and read out a long list of politicians he wanted detained. They included Han, opposition leader Lee Jaemyung and National Assembly speaker Woo Won Shik, said Kim Byung-kee, one of the lawmakers who attended the meeting. Kim said Hong told lawmakers he ignored Yoon's orders

Speaking to reporters at the National Assembly, the



spy agency's director, Cho Taeyong, questioned Hong's account. Cho said such an order would have come to him, rather than Hong, and that he never received any orders from Yoon to detain politicians.

Han earlier said he would work to defeat the impeachment motion even though he criticized Yoon's martial law declaration as "unconstitutional." Han said there was a need to "prevent damage to citizens and supporters caused by unprepared chaos."

Thousands of protesters have marched in the streets Seoul since Wednesday, calling for Yoon to resign and be investigated. Thousands of autoworkers and other members of the Korean Metal Workers' Union, one of the country's biggest umbrella labor groups, have started hourly strikes since Thursday to protest Yoon. The union said its members will start on indefinite strikes beginning on Dec. 11 if Yoon was still in office then.

Impeaching Yoon would require support from 200 of the National Assembly's 300 members. The opposition parties who jointly brought the impeachment motion have 192 seats combined. PPP has 108 lawmakers.

In a televised statement, South Korean Vice Defense Minister Kim Seon Ho promised the ministry's "active cooperation" with an investigation by prosecutors into the military's role in Yoon's martial law enforcement. He said military prosecutors will also be involved in the probe. He denied media speculation that Yoon and his military confidantes might consider imposing martial law a second time.

"Even if there's a demand to enforce martial law, the Ministry of Defense and the Joint Chiefs of Staff will absolutely not accept it," Kim said.

Kim became the acting defense minister after Yoon's

office on Thursday accepted the resignation of Defense Minister Kim Yong Hyun, who has been hit with a travel ban and faces an investigation over his role in Yoon's imposition of martial law.

Opposition parties and Han allege that it was Kim Yong Hyun who recommended that Yoon take the step. During a parliamentary hearing on Thursday, Kim Seon Ho said Kim Yong Hyun also ordered troops to be deployed to the National Assembly after Yoon imposed martial law.

Han was previously regarded as a close associate of Yoon as they spent years working together as prosecutors and he served as Yoon's first justice minister. But after Han entered party politics and became PPP leader, their ties soured badly as they differed over how to handle scandals involving Yoon and his wife.

Han leads a minority faction within the ruling party, and 18 lawmakers in his faction voted with opposition lawmakers to overturn Yoon's martial law decree. Martial law ultimately lasted about six hours, after the quick overrule by the National Assembly forced Yoon's Cabinet to lift it before daybreak Wednesday.

If Yoon is impeached, he would be suspended until the Constitutional Court rules on whether to remove him from office or restore his presidential power. Prime Minister Han Duck-soo, the country's No. 2 official, would take over presidential responsibilities.

The main liberal opposition Democratic Party leader Lee Jae-myung said in a televised speech Friday that it was crucial to suspend Yoon as "quickly as possible."

Lee said Yoon's martial law enforcement amounted to "rebellion and also a self-coup." He said Yoon's move caused serious damage to the country's image and paralyzed foreign policy, pointing to criticism from the Biden admin-

istration and foreign leaders canceling their visits to South Korea.

Yoon has made no immediate response to Han's comments. He hasn't made public appearances since he made a televised announcement that his martial law decree was lifted.

Prosecutor General Shim Woo Jung told reporters Friday that the prosecution plans to investigate rebellion charges against Yoon following complaints filed by the opposition. While the president mostly enjoys immunity from prosecution while in office, the protection does not extend to allegations of rebellion or treason. It wasn't immediately clear how the prosecution plans to proceed with an investigation on Yoon.

Democratic Party spokesperson Jo Seoung-lae said Friday the party is considering filing a legal complaint against PPP floor leader Choo Kyung-ho, whom they accuse of attempting to facilitate Yoon's martial law enforcement.

Choo, a Yoon loyalist, had asked party lawmakers to convene at the party's headquarters rather than the National Assembly after martial law began. That meant fewer lawmakers were present for parliament's crucial vote on lifting martial law.

The Biden administration, which has worked closely with Yoon's government while strengthening trilateral security cooperation with Japan to counter North Korean threats and regional instability, has expressed deep concern about Yoon's actions.

In a telephone conversation with South Korean Foreign Minister Cho Tae-yul, U.S. Secretary of State Antony J. Blinken welcomed the lifting of martial law following the parliamentary vote and conveyed his confidence in South Korea's democratic resilience, the State Department said.

A U.S. defense official said U.S. Defense Secretary Lloyd Austin has canceled a planned visit to South Korea, determining that it would not be an appropriate time. The official, who spoke on condition of anonymity to discuss travel planning not usually made public, said the Pentagon consulted with Austin's counterparts in South Korea about the decision. Austin is leaving for California on Friday to speak at the Reagan National Defense Forum, and will then travel on to Japan.

Australia police search for 2 suspects over arson attack at Melbourne synagogue

SYDNEY, Dec 6 (Agencies): Australian police said on Friday they were looking for two people suspected of deliberately starting a fire at a Melbourne synagogue that injured one and caused widespread damage.

The fire at the Adass Israel synagogue in the city's south began in the early hours of Friday. Police said the suspects were wearing masks.

Prime Minister Anthony Albanese condemned the attack and said there was no place for anti-Semitism in Australia.

"This violence and intimidation and destruction at a place of worship is an outrage. This attack has risked lives and is clearly aimed at creating fear in the community," Albanese said in a statement.

Counter-terrorism police will liaise with the Victoria state police on the investigation, Albanese said.

The Victoria state police said a worshipper who was at the synagogue for morning prayers saw two people who appeared to be spreading accelerant inside the building before setting it on fire

before setting it on fire. "We believe it was deliberate. We believe it has been targeted. What we don't know is why and we'll get to the why," Detective Inspector Chris Murray said.

Dozens of firefighters and trucks doused the fire at the synagogue, built in the 1960s by Holocaust survivors in the suburb of Ripponlea.

"There was some banging on a door with some liquid thrown inside and was lit alight. The few people inside the synagogue ran outside the back door. One of them got burnt," Adass Israel Synagogue board member Benjamin Klein told the Australian Broadcasting Corp.

"The whole place took alight pretty quickly." Television footage showed firefighters at the scene and black soot on the walls, as congregants took Torah scrolls and prayer shawls that had escaped the fire to a car

The Australian Jewish Association said it was "outraged but not at all surprised" by the attack and that the Jewish community had felt abandoned under the incumbent government. Albanese's office

incumbent government.
Albanese's office did not immediately respond to a request for comment on the association's statement.

Australia has seen a rise in anti-Semitic incidents since Israel retaliated against an attack by militant Palestinian group Hamas on October 7, 2023 with an assault on Gaza that has left tens of thousands of people dead.

Major Australian cities have seen dozens of pro-Palestine protests over the last year. The Jewish community says the government has not done enough to tackle the rise of anti-Semitism.

Dozens of pro-Palestinian protesters on Wednesday gathered outside Sydney's Great Synagogue when some members of the Jewish community were inside, Australian media reported.

2 American climbers and Canadian believed to be dead on New Zealand's tallest mountain

LONDON, Dec 6 (Agencies): New Zealand Police say they don't believe two Americans and a Canadian who have been missing for five days survived a fall on New Zealand's tallest peak.

The three men -- 56-year-old Kurt Blair and 50-year-old Carlos Romero from the United States, along with one Canadian national -- were visiting New Zealand and were reported overdue from their planned ascent of Aoraki Mount Cook on Monday morning, said inspector Vicki Walker, the Aoraki Area Commander, in a statement.

"Due to a favourable break in the weather, a helicopter was deployed today as part of the search for the three climbers missing on Aoraki Mount Cook," said Walker in a statement on Friday. "The search for the men commenced on Monday, following a report that they were overdue."

The search was hampered by dangerous weather all week, but a helicopter crew discovered further climbing-related items on the mountain, including a top, energy gels, a jacket and a pick axe which authorities could not confirm to belong to the three missing men but strongly believe that they did, according to officials. "[On Friday] afternoon, a two-person drone team was deployed by helicopter to a safe area. Based on the footage from the drone, we can see evidence of where the climbers had begun to traverse the slopes beneath Zurbriggen Ridge," Walker continues in her statement. "This evidence includes footprints and the items we have retrieved. It's now five days since the trio was reported overdue."

"After reviewing the number of days the climbers have been missing, no communication, the items we have retrieved, and our reconnaissance today, we do not believe the men have survived," Walker continues. "We believe they have taken a fall. "This is certainly not the news we wanted to share today."

Police have been working with the U.S. and Canadian embassies to inform and support the families of the three men. "First and foremost, we're thinking of the men's families in the United States and Canada. We have spoken to them today and, as you'd expect, it's not the phone call they wanted to receive," Walker said. "I'm devastated for them - the entire search team wanted a positive result. We remain poised to reactivate our search if we receive fresh information or credible reports of sightings - especially from the climbing community."

Police will now launch a recovery operation but say that its feasibility will be carefully considered and managed.

"I know that finding the men will be what the family wants and deserves," authorities continued. "Police has now formally advised the Coroner of our belief that the climbers did not survive a fall. I would like to thank the teams who have given their all to this search. We all wanted this operation to be a success."

US, Japan and Philippine forces jointly patrol in South China Sea after hostilities involving China

MANILA, Dec 6 (Agencies): The United States deployed a reconnaissance aircraft while Japan and the Philippines sent navy ships in a joint patrol in the disputed South China Sea on Friday, two days after the allied forces condemned actions by Chinese coast guard vessels against Philippine patrol ships.

The U.S. Indo-Pacific Command said the joint patrol was conducted in the Philippines' exclusive economic zone by allies and partners to "uphold the right to freedom of navigation and overflight " and "other lawful uses of the sea and international airspace."

Those phrases are used by the U.S., Japan and the Philippines to oppose China's increasingly aggressive actions in the disputed waters.

Two Philippine security officials said the patrol was staged about 40 nautical miles (74 kilometers) from Scarborough Shoal, a fishing area hotly disputed by Beijing and Manila off the northwestern Philippines. The two officials spoke on condition of anonymity because they didn't have authority to discuss such details publicly.

China claims the South China Sea virtually in its entirety and has guarded it assertively with its coast guard, navy and suspected militia fleets. They have confronted forces from rival claimant states including the Philippines, Vietnam, Malaysia and Brunei.

Indonesia also has had faceoffs with Chinese coast guard ships escorting fishermen in the gas-rich Natuna waters in the southern fringes of the South China Sea.

The joint naval patrol, the latest in recent months by the Philippines, the U.S. and their security partners, was delayed by several typhoons that battered the region and was not in reaction to a confrontation on Wednesday that involved Chinese and Philippine ships off Scarborough Shoal, the two Philippine officials said.

The Philippine coast guard said Chinese coast guard vessels, backed by navy ships, fired powerful water cannons and blocked and sideswiped a much smaller Philippine bureau of fisheries vessel escorted by coast guard ships off Scarborough Shoal.

The Philippine vessels were delivering fuel, food and other aid to Filipino fishermen in the shoal, which has been closely guarded by the Chinese coast guard since a tense 2012 territorial standoff with Philip-

pine ships.
The Philippine Department of For-

eign Affairs protested the Chinese actions.

The Chinese coast guard provided another account of the incident. It said the Philippine vessels encroached on China's territory, prompting it to take action. It said, without offering proof, that a Philippine vessel maneuvered in a way that led to a collision.

The United States, Japan, the European Union and other Western allies expressed alarm over the hostilities, which have increased in frequency since last year.

Japan, which also has territorial conflicts with Beijing in the East China Sea, said the "use of water cannon and obstructive maneuvers undermine the safety of ship and crew." It's ambassador to Manila, Endo Kazuya, said "Japan upholds the rule of law and opposes any actions which increase tensions."

Japan is providing 1.6 billion yen (\$10.6 million) in security assistance this year to provide the Philippine navy with coastal radars, inflatable boats and other defense equipment to strengthen surveillance of Philippine sea lanes, including in the South China Sea.

Macron vows to stay on as French president, says will name new PM within days

PARIS, Dec 6 (Agencies): French President Emmanuel Macron pledged to remain in office until the end of his term in 2027 and announced plans to name a new prime minister within days, following the resignation of Michel Barnier after a no-confidence vote.

Macron struck a combative tone just a day after the historic vote in the National Assembly left France without a functioning government. He blamed far-right opponents for toppling Barnier's administration, accusing them of prioritising chaos over governance.

"They chose disorder," Macron

The president criticised both the far right and far left for uniting in what he termed "an anti-Republican front." Emphasising his resolve, he declared, "I won't shoulder other people's irresponsibility."

Macron confirmed that he would appoint a new prime minister within days but offered no clues about potential candidates.

While attacking his political adversaries, Macron acknowl-



edged his own role in the current political turmoil, which has unsettled financial markets.

Reflecting on his decision to dissolve parliament in June, which led to legislative elections and the resulting hung parliament, Macron admitted, "I do recognise that this decision wasn't understood. Many people criticised me for it. I know many continue to criticise me for it." However, he insisted, "I believe it was necessary" to let voters have their say.

Earlier on Thursday, the Élysée Palace issued a statement confirming Macron had "taken note" of Barnier's resignation. Barnier and his ministers will remain in charge of current affairs until a new government is formed.

The no-confidence motion passed with 331 votes, forcing Barnier to resign after just three months in office—the shortest tenure for any French prime minister in modern history.

Macron stated that the new prime minister would be tasked with forming a government of national interest that represents all political forces willing to commit to avoiding further no-confidence votes.

"The priority will be to pass a budget law for 2025," he said.

Macron criticised lawmakers for their actions, accusing them of focusing on personal political ambitions rather than the needs of the country. He highlighted the timing of the vote, which comes as year-end holidays approach.

"Why did lawmakers act this way? They're not thinking of you, of your lives, your difficulties," he said. "They're thinking of just one thing: the presidential election — to prepare it, to provoke it, to precipitate it."

Govt waives off Rs.58 Cr late payment surcharge

SRINAGAR, Dec 06:

Kashmir Power Distribution Corporation Limited (KPDCL) today raised final call to its domestic consumers urging them to come forward and claim waiver on late payment surcharge under the Government's Power Amnesty Scheme, which shall cease to exist on 01.04.2025.

In a statement released today, Chief Engineer, Distribution, KPDCL, Er. Aaquib Waheed Deva, said that the Power Amnesty Scheme will be available for domestic consumers only till March 31, 2025 and beyond that there will be no further extension. "Con-

sumers can either pay their principal amount due to Kashmir Discom in full or in equal instalments in the remaining 04 months to claim the waiver on late payment surcharge to settle their claims," she added.

As many as 1,09,648 domestic consumers have so far availed the scheme for waiver on late payment surcharge with KDPCL, which has collected a revenue of Rs.164.00 crore so far. The scheme has targeted a total of 1,50,907 consumers who had a substantial opening balance due to KPDCL.

The Government has also waived off an amount of Rs.58 crore on account of late payment surcharge, thus providing huge relief to the domestic consumers by clearing their opening balances.

Chief Engineer KPDCL advised the remaining consumers to approach their concerned Electric Subdivisions to settle their bills. "There are still a large number of domestic consumers with huge opening balances who are yet to approach their divisions to settle their dues," she added, while advising them to not waste this final opportunity offered under the scheme.

The Chief Engineer further stated that after the closure of the Scheme, KPDCL shall be left with no option but to opt for legal course of action & disconnection of those domestic consumers.

Chess World Championship: Gukesh, Ding play out sixth draw in a row

SINGAPORE, Dec 6 (Agencies): Game 9 of the World Chess Championship match between title holder Ding Liren and challenger Gukesh D ended in a draw after 54 moves in the Catalan Opening. Gukesh had the initiative again in the opening and toward move 20 it seemed he was winning a pawn on the queenside. However, he could not find the correct square for his queen, resulting in a massive trade of pawns and pieces to equalise the position.

Yet again, Gukesh failed to find a winning continuation and gave the advantage to Ding. However, the defending champion has looked more for draws in the games so far instead of showing aggression.

In the post-match conference, Ding, when asked to comment on his passive play, said, "I saw that I am always underestimating my position and my opponent is always overestimating his. I also saw someone say I



always make a draw even if I'm better, but this didn't affect me."

The game was so 'drawish' that the players ended with the same time — 38 minutes. 30 seconds — left on the clock for each of them. The chess engine analysis showed they had almost the same accuracy level too. Gukesh had 99.2 accuracy while Ding had 99.3. The accuracy level means the percentage of perfect moves

Grandmaster Anish Giri, commentating on chess24.com, said he was disappointed that Gukesh did not put pressure to win and missed some chances again.

However, Gukesh, in the post-match conference, was unfazed once again for missing an opportunity. "I think it was just a very precise game by both. I may have had the edge at some time but I guess I didn't play precisely," he said

Ding continued to play the underdog card despite being the defending champion. "I am always under some pressure in the opening. My opponent always has some ideas in the opening. Even today it was the same and at one point I forgot which knight goes where in this (particular opening)," he said.

The players are tied at 4.5 points each with six straight draws now. They meet again on Saturday after a day's break. Ding and Gukesh tried to set the tone for the upcoming games.

Ding said, "It is going to be tough to win. No one is clearly better in this match, so it's going to be tough to win."

Gukesh, who had chosen aggressive and even risky lines to try to win, still followed the same spirit in his prediction about the upcoming games. "We've both shown fighting spirit and entertaining chess... and five more exciting games to go,"

England all out for 280 after sizzling Brook century

WELLINGTON, Dec 6 (Agencies): Harry Brook smashed a century before England were dismissed for 280 on day one of the second Test against New Zealand in Wellington on Friday.

Brook top-scored with 123 after the tourists were put in to bat on a green Basin Reserve pitch and he put on a key partnership with Ollie Pope to rescue an England innings which was teetering at 43-4.

Brook was run out on the last ball of the second session after powering England out of trouble to 259-7, before the final three wickets fell quickly after

The in-form Brook registered his eighth century in just 23 Tests and his dismissal was a major boost for the home side after he and wicketkeeper Pope (66) counter-punched with a stand of 174 off just 158 balls.

The partnership was reminiscent of the first Test in Christchurch when the same pair combined for a rapid 151 to rescue their first innings and set up an

eight-wicket win for the tourists. Brook went on to score 171 at Hagley Oval and unfurled another sparkling knock at the Basin Reserve, where he scored 186 when the teams met here last year.

The lanky 25-year-old's power once again couldn't be contained by New Zealand's seam-heavy attack, striking five sixes and 11 fours from his 115 balls faced before his concentration slipped.

He set off for a single to short midwicket but Chris Woakes didn't respond and Brook was caught short when



bowler Nathan Smith hit the stumps in his follow-through.

It took Brook just 91 balls to bring up three figures, his second-fastest century, with his most notable shots being two towering sixes over extra cover in the first session.

Will O'Rourke (3-49) finally removed Pope, who mis-timed a pull shot, and the pace bowler struck again to dismiss England captain Ben Stokes for two, caught behind.

Smith (4-86) helped to wrap up the tail to cap an impressive start to just his second Test.

Matt Henry (2-43) and Smith claimed two early wickets each to put the hosts well on top.

New Zealand's poor catching was a major weakness in Christchurch but there was no repeat, with three batters falling to sharp chances in the field.

The impressive Henry had Ben Duckett caught by a diving Tom Latham at second slip without scoring before bowling fellow-opener Zak Crawley for

Smith had both Jacob Bethell (16) and Joe Root (3) caught behind, with Daryl Mitchell grabbing a flyer with one hand at first slip to remove Root.

Champions Trophy hybrid model finalised; India to play its matches in Dubai

NEW DELHI. Dec 6 (Agencies): The International Cricket Council has reached a consensus to conduct next year's Champions Trophy in a hybrid model, allowing India to play its share of matches in Dubai while agreeing "in principle" to a similar arrangement in multi-lateral events till 2027.

According to a top ICC source, the decision was more or less finalised during an informal meeting between the body's new President Jay Shah and the Board of Directors, including Pakistan, at its headquarters in Dubai.

"It's been agreed in principle by all parties that the 2025 Champions Trophy will be held in the UAE and Pakistan with India playing its matches in Dubai. It's a win-win situation for all stakeholders," the ICC source told agency.

The Champions Trophy is to be held in February-March next

Pakistan, while withdrawing its boycott



threat and agreeing to go hybrid in the previous ICC meet last week, had demanded a reciprocal arrangement for itself till 2031. However, the ICC has agreed to a hybrid model for all its events till 2027.

During this period, India will be hosting the women's ODI World Cup in October this year and the 2026 men's T20 World Cup jointly with Sri Lanka.

Given the hosting arrangement, Pakistan would not have been compelled to travel to India if they had insisted against it in 2026 even if a hybrid model was not

"During the 2026 men's T20 World Cup, Pakistan will play its matches in Sri Lanka. The compensation demanded by PCB for the Champions Trophy hybrid model is still under consideration," the source said.

Agreeing to this arrangement means that the Indian women's team will have to travel to a neutral venue to play their league match against Pakistan, should that be necessitated by the schedule which is yet to come out.

"Cricket should win, that's most important but with respect for all. We best for cricket. Whichever formula we go in for, it would be on equal terms," Pakistan Cricket

"Desperation to create controversy": Josh Hazlewood's manager slams media for misconstruing pacer's comments

SYDNEY, Dec 6 (Agencies): Australia pacer Josh Hazlewood's manager Neil Maxwell has lashed out at the nation's media for blowing the player's comment out of proportion. He also blasted Fox Cricket, the official broadcaster in Australia for the ongoing Border-Gavaskar Trophy. Hazlewood found himself in the middle of a controversy due to his comments during Australia's Perth Test against India last month. In a press conference at the end of play on Day 3 of the match,

Hazlewood was asked about how Australia would approach day four. His response to the query was, "You probably have to ask one of the batters that question. I'm sort of relaxing and trying to get a bit of physio and a bit of treatment, and I'm probably looking mostly towards the next Test and what plans we can do against these batters."

"I guess the batters are just sticking to what they do, their preparation. They'll have a hit in the morning and talk around plans of what happened in the first innings, how they can negate that and move forward and improve on that," he added.

At the end of Day 3 in the Perth Test, Australia were 12 for 3 in their chase of 534 runs. They were eventually bundled out for 238 and India went on to win the game by 295 runs.

The comments from Hazlewood gave rise to speculations of a potential rift in the dressing room. "It's taken so out of context and in a negative light," Maxwell told The Sydney Morning Herald. "You've never seen a closer bunch of players than the players in the last two years of Australian cricket.

"To draw that assumption from a comment from a No.11 batter saying, 'You better ask one of the batters' is so ridiculous. They lose complete and utter credibility."

"There's a desperation to create controversy when you've got 40. cricket media are all trying to get a daily story. I just think there's no incentive for players to provide any color in response," he added.

"Lose between 7 to 10 kgs": Prithvi Shaw sent 'complete overhaul message'



NEW DELHI, Dec 6 (Agencies): Prithvi Shaw is certainly going through the toughest time in his cricket career. The right-handed batter, once touted to be the "next Sachin Tendulkar", could not find any takers at the IPL 2025 mega auction in Jeddah, Saudi Arabia held last month. The 2018 U-19 World Cup-winning captain was seen as the next big thing in Indian cricket, but his downfall in the past few years has taken him out of consideration for the Indian cricket team. Shaw was even dropped from Mumbai's Ranji Trophy squad before going unsold at the IPL auction at a base price of Rs 75 lakh. He is currently playing for Mumbai in the ongoing Syed Mushtaq Ali Trophy but has failed to impress with his game so far.

Ex-BCCI selector Jatin Paranjape feels that the youngster needs a "complete overhaul of his mental thinking".

Paranjape shared his opinions in his column for Sportstar.

Paranjape, who also holds the experience of playing 4 ODIs for India besides appearing in 62 First-Class and 44 List A games, also pointed out that Shaw needs to lose some weight to get fitter.

"If I were Prithvi, I would quickly evaluate and conclude that fitness is a major missing piece in his game. Without it, his future in cricket is uncertain. I would stress this aspect: if he can lose between 7 to 10 kilograms of body weight without losing strength, that would be a crucial start," the former BCCI selector said.

"If I were in his position, I would camp in Chennai with Ramji Srinivasan for 10 days and completely dedicate the next two or three years to this transformation. The results would begin to show in the next 45 to 60 days," he added.

Paranjape further said that Shaw needs to improve his game against spin and make sure he doesn't lose his wicket easily.

"Let's move on to the skills part. I have often told him that he seems overly generous with his wicket, particularly against spinners. Almost every domestic spinner in India has managed to get him out. He needs to reevaluate his game against spin," he said.
