SRINAGAR, Dec 7 (Agencies): The Centre has approved establishment of 13 new Kendriya Vidyalayas (KVs) in Jammu and Kashmir to improve access to education in the region, Union Minister Jitendra Singh said today.

"The Cabinet Committee on Economic Affairs, chaired by PM Modi, has approved opening of 85 new Kendriya Vidyalayas (KVs) under civil/ defence sector across the country and expansion of one existing KV," read an official handout. The new KVs will be

set up in Gool, Ramban, Bani and Ramkote in Kathua district, Reasi and Kakriyal Katra, Mughal Maidan (Kishtwar), Gulpur (Poonch), Vijaypur (Samba), and Panchari (Udhampur). In the Kashmir valley,



Temperatures settle below freezing point across Kashmir

SRINAGAR, Dec 7: After recording the coldest night of the season, the night temperature improved in Kashmir on Saturday, although it still remained below the freezing point.

The meteorological centre in Srinagar said the Shopian in south Kashmir was the coldest place in the Valley, with the mercury plummeting to minus 4.5 degrees Celsius.

The tourist resort of Pahalgam in south Kashmir recorded a minimum of -4.3 degree Celsius.

MeT said that summer capital Srinagar witnessed the minimum temperature of -2 degree Celsius, against minus 4.1 degrees the previous night. Incidentally, on Friday Srinagar had recorded the coldest night of the season so far.

JAMMU, Dec 7: "Indian Army's initiative to fence over 50 border villages located on the Line of Control (LoC) in Rajouri will not only end infiltration but also rule out any possibility of smuggling of arms, ammunition, drugs, and other contraband.

This fencing work, started at the behest of the Ministry of Defence, will also end the woes of border villagers who used to find it hard to live because of infiltrators seeking forced sheltering in their homes, which now will not be possible."

This was stated by Bharatiya Janata Party (BJP) J&K Executive Member Raman Suri, who said that prior to the year 2003, Pakistan used to resort to indiscriminate firing to stop fencing work but now that the Indian Army and the Ministry of Defence have resolved to go ahead with the work firmly, guns have fallen silent and the border people are happy to see their villages getting permanent protection.

This fencing will also increase the accessibility of local administration, and people too will be able to move in their villages safely without fear of militants hiding in their homes.

Armed Forces Flag Day

rmed Forces Flag Day is celebrated every year on December 7 and the day has a special importance for not only the defense / armed forces but for the countrymen as well .The day is celebrated with great fervor and enthusiasm .The Armed Forces Flag Day or the Flag Day of India is a day dedicated to honoring the soldiers and veterans of India's armed forces .It has been observed annually in India on December 7 since 1949.Immediately after India achieved independence ,a need arose for the government to manage the welfare of its defense forces personnel .On August 28,1949 a committee set up under the defense minister decided to observe a Flag Day annually on December 7. The idea behind observing a Flag Day was to distribute small flags to general population and in return collect donations .Flag Day gains more significance as it considers that it is the responsibility of the civilian population of India to take care of the families and dependents of the armed forces personnel who fight for the country .The Flag of the Indian Armed Forces is similar to that of the United Kingdom's Ministry of Defense ,first utilized in 1956, and is a common color scheme in British-aligned territories ,used by fellow Commonwealth nations including Cyprus, Kenya and Nigeria .The Flag Day serves to promote three basic causes which are as follows -1-Rehabilitation of battle causalities 2-Welfare of serving personnel and their families and 3-Resettlement and welfare of ex-servicemen and their families .On this important occasion funds are collected from the people through distribution of flags and the money so collected is used for the welfare of army and their families .It is the time for Indian's to express its gratitude and appreciation to the current and veteran military person-

nel of India and to acknowledge those who died in service to the country .On the Flag Day all three branches of the Indian forces ,the Indian Army ,the Indian Air Force and the Indian Navy ,arrange a variety of shows ,carnivals ,dramas and other entertainment programmes to showcase to general public the efforts of their personnel to ensure national security. Throughout the country small flags and car flags in red ,deep blue and light blue colors representing the three services are distributed in return for donations .The original Flag Day Fund was set up in 1949, by the Defense Minister's Committee .In 1993, the Defense Minister of India consolidated related welfare funds into single Armed Forces Flag Day fund .Those funds include-Amalgamated Special Fund for War Bereaved ,War Disabled and other ex-servicemen / serving personnel.2 Flag Day Fund 3-St Dunstan's -India and Kendriya Sainik Board Fund. 4-Indian Gorkha EX -Servicemen's Welfare Fund .The fund collection is managed by the local arms of the Kendriya Sainik Board -KSB ,which is part of the Ministry of Defense .The collection is organized both by official and non-official means through voluntary organizations . Though welfare of the ex-servicemen and their dependents is the responsibility of the union government, and the governments of states and UT's ,majority of the problems have to be resolved only by the states and UT's .Like the Kendriya Sainik Board at the centre ,the Rajya /Zila Sainik Boards are responsible for policy formulation and implementation of resettlement and welfare schemes for ex-servicemen ,widows and their dependents residing in their respective states/UT's /Districts .To assist the central government in this regard ,there are 32 Rajya Sainik Boards and 392 Zila Sainik Boards in the country .The Secretary KSB advises the Department of Sainik welfare in the states/UT's on the policies for

resettlement and welfare of ex-servicemen ,widows and seeks reports from the Director, Department Sainik Welfare /Secretary RSB and Zila Sainik welfare officer/Secretary ZSB ,on implementation of policies and success in resettling ex-servicemen ,widows ,disabled personnel invalidated out from the Service and their departments .Advise is also rendered on the welfare schemes required for the clientele, which are financed from funds allotted by the governments of states/UT's and the Amalgamated Special funds .The Fund is operated by a Managing Committee presided over by the Defense Minister at the centre and by the executive heads of the governments in states and UT's .When the Armed Forces Flag Day programme was introduced, the fund collection was managed in such a way that the Central KSB headquarters is given only a very small share of the Flag Day Fund collections made by each state .The allotted funds for KSB is only half a paisa per individual in the state .The primary objective of Armed Forces Flag Day is to honor the sacrifices and dedication of the Indian Armed Forces Personnel .The objective is also to generate funds for the welfare of families of martyrs, ex-servicemen, and disabled soldiers .Objective also includes to foster a sense of responsibility among citizens to support their defenders .Armed Forces Flag Day is all about paying tribute to the members of the armed forces , including the Army ,Navy, and Air Force ,who selflessly dedicated their lives to safeguarding the country's freedom and peace and so protect its borders .A horizontal tricolor of red ,navy blue and sky blue represent the army ,navy and air forces of India .As already pointed above since 1949,7th December is observed as the Armed Forces Flag Day throughout the country to honor the martyrs and the men in uniform who valiantly fought and continue

Of gaps in history; and a remarkable absence of graffiti in India's big cities

n my recent sojourn of several Indian cities -- Mumbai, Bengaluru, Goa, Delhi and the city of eternal selfies, Agra, I noted, a couple of categorical absences -- pause and cause for thought. been when his name first circulated through the circuits of those workshops which led through Masaccio to Piera Della Francesca to Botticelli, Michelangelo, Leonardo and Raphael. Whew! In such company CAY loses all when graffiti of this sort -- or any non-commissioned sort -- is done. It's obvious that it's done at night when the streets and railway sidings and bridges are quiet and deserted. But how and even why do the grafitos (is that ritorial gang-murder that one sees in London, Manchester or New York. Or perhaps the Indian youth regard going out at night and expending the effort on painting graffiti to assert that they were there as unpaid hard work? The professional, commissioned artist graffitos don't do any writing. Even the notices that I used to see in my youth no longer exist. I recall the most prominent in Pune and Chennai (then Poona and Madras) were signs saying COMMIT NO NUISANCE, which didn't mean don't play drums on this spot or paint "Harish loves Ramaswamy" on these walls, but it clearly meant "do not urinate" here. The other absence I noted and take seriously concerns two of the museums that I visited. In the Mumbai Chhatrapati Shivaji Museum's miniature paintings gallery, there were perhaps just one or two of the dominant miniature style of the Mughal period, originals of which dominated the galleries in the past and reproductions of which could be seen in all history books. A gap in history is a gap in national identity? Some erasures, such as renaming The Mall, as the Raj named it, as Mahatma Gandhi Road appear to be just. But pretending that the Brits or the Mughals were never there doesn't.

The first notable absence in all these cities is that of graffiti on vacant spaces. None. Yes, there were commissioned pictures on the city walls, some possibly attempting to give pictorial expression to the supposed soul of the city, others historically or simply decoratively striking. Try London, Berlin or any Western city where every inch of available space, even the sides of bridges which one would imagine were impossible to access, plastered with names, abuse, crude slogans, undecipherable (to me and other non-members of some fraternity) codes and messages. They are all assertive in one sense or the other. It was Norman Mailer who first wrote a paean to graffiti in the magazine Esquire, calling it a tide of urban art. Mailer calls himself the Aesthetic Investigator (A-I) and his second paragraph reads thus: "A-I is talking to CAY 161. That is the famous CAY from 161 Street, there at the beginning with TAKI 183 and JUNIOR 161, as famous in the world of wall and subway graffiti as Giotto may have

name although he will not necessarily see it that way..." "Whew!" indeed. I recall that I read Mailer's ramblings in 1974 but at the time didn't consider sending that paragraph and, in the same vein, the rest of the article to the satirical British fortnightly Private Eye which runs a column called "Pseuds' Corner" and solicits pretentious quotes from readers who may have come across and noted them. At the time, in my short and happy innocence. I regarded Mailer as one of my literary heroes and publicly labelling it "pseudery" would have been the deepest sacrilege. But... one grows up? It is of course said that CAY and perhaps all the others who put their imprimatur on walls, on gravestones, on railway carriages parked in the sidings of railroad territory, on the sides of elevated highways and the girders of rail and road bridges, do so to mark out gang territory. It's the sort of thing dogs do on lampposts to claim them. I must admit, gentle

reader, that I have always

been intrigued as to how and

the proper word? Though I have heard them (called "taggers") brave heights and detection to do it? Yes, they mark their territory and some of them declare their affections and most of them do it in an internationally uniform black font. How did this almost mandatory graffiti font spread from one continent to the other? Despite Mailer's pretentiousness, very little graffiti now appeals as art, though some of the black lettering does give way, in appreciable instances, to illustrative art. In the case of the secretive Banksy, one can even see its distinctiveness and emotional appeal -- a girl flies a balloon as a symbol of hope or aspiration perhaps? So, why then is there no amateur graffiti in Indian cities? There certainly are nasty gangs of youth and of the not-soyoung but they don't seem compelled to mark out their territory. Perhaps the profits from selling Ganja, or even doctored cocaine, which has been smuggled into the country in condoms shoved up the smugglers' backside, hasn't caused the sort of ter-

Manoj Bajpayee on chasing dreams and being 'intelligently stubborn'

How does a farmer's son from a Bihar village reach the pinnacle of his dreams in starry Mumbai where a million hopes are dashed and met every day? Manoj Bajpayee has the answer - just be "intelligently stubborn". The actor has successfully owned both commercial and arthouse cinema as well as the big screen along with small roles as diverse as Bhiku Mhatre in 'Satya' and Srikant Tiwari in 'The Family Man'. He says that he soon understood that circumstances can break those not committed to their dreams


"You have to be intelligently stubborn and audacious. I say stubborn because otherwise circumstances and situations challenge you at every moment and make you doubt yourself," Bajpayee told agency in an interview.

"There is a saying, 'you take four steps back before you take a leap'. I have not been too much in love with myself. I understood the circumstances.", Baipavee said.

After the breakout role in the 1998 underworld drama 'Satya', directed by Ram Gopal Varma and still remembered for Bajpayee's portrayal of gangster Bhiku Mhatre, the offers came rolling in. All in the same mould, Bajpayee wanted none of it.

"I was very stubborn about not getting typecast... The industry didn't know what to offer me and thought if he is refusing, then offer a lot of money... but I knew I would not be a villain because if I do it then will not let me come out of it ever," the 55-year-old said.

Bajpayee, who will next be seen in the role of investigative journalist Joy Bag in director Kanu Behl's 'Despatch', slated for release on December 13, said he understands that people have different destinies and destinations.

Growing up with show business dreams as one of six siblings. Baipavee said his farmer father didn't have the resources to support his ambitions. Bajpayee travelled to Delhi when he was just 17, pursued a college education as his mother wanted, did theatre and then landed up in Mumbai.

He debuted with a small role in Govind Nihalani's 'Drohkaal' in 1994 and was first noticed in Shekhar Kapur's 'Bandit Queen' the same year. The big break was "Satya" where everyone noticed him

It propelled him into the big league, launching a threedecade career that is still strong. He did an easy segue into the small screen with 'Gulmohar', 'Sirf Ek Banda Kaafi Hai' and

whose dialogue "Mumbai ka king kaun" is now part of cinema history. Bajpayee had gone to audition for Ram Gopal Varma's 1997 Sanjay Dutt-starrer 'Daud'. This was after 'Bandit Queen', which had given him recognition but not a real break.

"When the film released every other actor got busy in the industry, only I didn't have any work.", says the actor.

"When Ramu got to know that I played Mann Singh's character in 'Bandit Queen' four-five years ago, he told me, 'I have been trying to find out about you for four-five years but nobody had any idea about you so I couldn't get any number'. Now that I have found you, don't do this ('Daud') role. I am making my next and you will be the main lead in that'."

Bajpayee insisted he had to be in the film. "I was like, 'Sir, give me this role and when that happens you can cast me in that later'. I am getting Rs 35,000 for this. This chance is very important for me at this time'." RGV stayed true to his promise.

'Satya' ended a tough journey though Bajpayee doesn't quite call it a struggle. "The real struggle is that of a rickshawwalla who will not have money if he doesn't pull his rickshaw one day. It is not his dream... We were chasing our dreams." From Bihar to almost a decade in Delhi theatre scene and then Mumbai, Bajpayee has belonged to different places at different times. But home will always be Belwa, his ancestral village.

"It is ironical that when I was there, I wanted to get out of the place. Now that god has given you a life and that you have made it, then you feel like going back.", said Bajpayee.

Allu Arjun breaks silence over 'Pushpa 2' screening stampede



Actor Allu Arjun announced a sum of Rs 25 lakh to the family of a woman who died due to asphyxiation at a theatre screening 'Pushpa 2' premiere show in Hyderabad.

In a video posted on X, the 42-year-old actor said he wants to assure the grieving family that they are not alone in this painful situation and he will meet the family personally.

A 35-year woman died and her son was hospitalised on Wednesday due to asphyxiation, as crowds jostled at a film theatre here during the premiere show of actor Allu Arjun's latest movie

The incident took place when a large number of fans thronged the Sandhya theatre to have a glimpse of the star.

"Whatever we do, this loss can never be covered. From our side, we want to say that we are emotionally there for you. Whatever help you need, we are there for you, and on my behalf, I would like to donate an amount of 25 lakhs just as a goodwill gesture to secure their future and especially children. I'll be there for them if they need any kind of support, I will try to be there," he said in the video, expressing condolences.

A case has been registered against Allu Arjun, his security team and the theatre management under sections 105 and 118(1) of Bharatiya Nyaya Sanhita (BNS) at the Chikkadpally police station based on the complaint by the deceased's family. He further said that he would bear the medical expenses of the boy,

who is currently undergoing treatment at a private hospital. Arjun said he came to know of the "tragic incident" only the follow-

ing day and the whole movie team was upset. "Deeply heartbroken by the tragic incident at Sandhya theatre. My heartfelt condolences go out to the grieving family during this unimaginably difficult time. I want to assure them they are not alone in this pain and will meet the family personally. While respecting their need for space to grieve, I stand committed to extending every possible assistance to help them navigate through this challenging journey," he said in a post.

He advised the public to be careful when they go to a cinema hall and return home safely after watching the movies.

Meanwhile, the eightyear-old boy remains in a critical condition, doctors at the hospital treating him said.

"(The) Child has persistent fever spikes necessitating higher antibiotics. Child has been started on NG (nasogastric tube) feeds which he is tolerating well with adequate urine output showing some glimpse of hope. However, the condition remains critical, and the patient is under intensive care and close monitoring as the medical team works to stabilise him further," the hospital said in a statement.

Currently he is on mechanical ventilator requiring minimal settings and minimal ionotropic support, neurologically (GCS E3VTM4) improving with no clinical seizures, it added. Akshansh Yadav, **Deputy Commissioner** of Police (central zone) told agency that the police are collecting more evidence regarding the incident. A proposed press con-



Man kills mother for objecting to marriage, makes it look like robbery NEW DELHI, Dec 7

(Agencies): A 22-yearold man in Delhi was arrested for allegedly killing his mother after she refused to let him marry the woman of his choice and threatened to disinherit him, police said on Saturday. The man, identified as Sawan, initially made the crime look like a robbery.

He called the Delhi police control room on Friday night, telling them that his mother had been killed and that her earrings had been stolen

However, upon investigation, the police did not find any signs of robbery. Other valuables were also found intact in the house, officials said. Further investigations revealed that Sawan,



the younger son of the victim, Sulochna, had killed her.

Sawan's elder brother, Kapil (27), was scheduled to get married soon. Sawan told his mother that he also wanted to get married to a woman he had known FOR a long time, the accused told the police. However, his mother scolded him and refused to let him marry the woman. She also warned that if

he ever brought up the topic again, she would cut him out of any share

in the property, officials said. Upset, Sawan allegedly made a plan to kill her. After committing the crime, he removed his mother's earrings to make it look like a robbery. Sawan, who drove a car for transporting goods, used to give all his earnings to his mother, the police said.

Man stabbed to death by neighbours after fight over not flushing toilet

NEW DELHI, Dec 7 (Agencies): An 18-year-old scrap worker succumbed to multiple stab wounds after neighbours in Delhi's Govindpuri came to blows over a common toilet not being flushed.

The fight broke out between the two siblings and a family that lives on the first floor of a building situated in the South Delhi area. Sudheer, his 22-year-old brother Prem and his friend Sagar got into a fight with Bhikam Singh, his wife Meena, and their three sons Sanjay, 20, Rahul, 18, and a minor boy.

Early on Saturday, Sudheer was rushed to the hospital with stab wounds on his chest, head and face, but died during treatment. Meanwhile, Prem was undergoing treatment, while Sagar was discharged.

Sagar Malik, a neighbour, told agency Videos that the victims were beaten up with rods and knives. "Bhikam's family called the police and told them that their mother was attacked," Malik said. A case of murder has been registered and Bhikam and his family have been apprehended for inves-



tigation, they said.

Sudheer, a native of Uttar Pradesh's Mainpuri, paid 3,000 per month in rent for the house which he shared with his brother, an e-rickshaw driver. Bhikam Singh works at a building materials shop and had shifted to the building around 45 days ago.

Mahadev App Betting Case: Probe Agency Attaches **Assets Worth 388 Crore**

NEW DELHI, Dec 7 (Agencies): The Enforcement Directorate on Saturday said it has attached fresh assets worth about 388 crore in its ongoing money laundering investigation into the Mahadev online betting case in which various high-ranking politicians and bureaucrats from Chhattisgarh are alleged to have been involved.

These include movable assets -- investment made by Mauritiusbased company Tano Investment Opportunities Fund related to Dubai-based "hawala operator" Hari Shankar Tibrewal through FPI and FDI -- and properties in Chhattisgarh, Mumbai and Madhya Pradesh in the name of

promoters of multiple betting apps and websites, panel operators and associates of the promoters, the federal agency said in a statement. A provisional order was issued under the Prevention of Money Laundering Act (PMLA) on December 5 to attach these assets with a total value of 387.99 crore, the Enforcement Directorate (ED) said.

Mr Tibrewal is being investigated by the agency in this case.

The ED has issued multiple such orders during this investigation and with the latest order, assets worth 2.295.61 crore have been either frozen, attached or seized so far. Eleven people have been arrested in this case and the ED has filed four chargesheets.

The agency has alleged in the past that its probe into the Mahadev Online Betting (MOB) gaming and betting app has shown the involvement of various highranking politicians and bureaucrats from Chhattisgarh. The app's two main promoters, Sourabh Chandrakar and Ravi Uppal, hail from the state. According to the ED, the MOB app is an umbrella syndicate arranging online platforms for enabling illegal betting websites to enrol new users, create user IDs and launder money through a layered web of benami bank accounts.

South Korean President apologises for martial law, but doesn't resign

Yoon Suk Yeol says martial law declaration born of desperation; People Power Party leader Han Dong-hoon calls him a danger to the country

SEOUL, Dec 7 (Agencies): South Korean President Yoon Suk Yeol on Saturday apologised for his attempt to impose martial law this week but did not resign, defying intense pressure to step down even from some in his ruling party and only hours ahead of a planned impeachment vote.

Yoon said he would not seek to avoid legal and political responsibility for his decision to declare martial law for the first time in South Korea since 1980. He said the decision was born of desperation.

The speech was the embattled leader's first public appearance since he rescinded the martial law order early on Wednesday, just six hours after it was declared and after parliament defied military and police cordons to vote against the decree.

"I am very sorry and would like to sincerely apologise to the people who were shocked," Yoon said in a televised address to the nation, during which he bowed

"I leave it up to my party to take steps to stabilise the political situation in the future, including the issue of my term in office,'




he said.

Han Dong-hoon, leader of Yoon's People Power Party (PPP), said after the address that the president was no longer in a position to carry out public duty and his resignation was now unavoidable.

On Friday, Han said Yoon was a danger to the country and needed to be removed from power, increasing the pressure on Yoon to quit even though PPP members later reaffirmed a formal opposition to his impeachment.

Han was scheduled to meet Prime Minister Han Duck-soo on Saturday, local Yonhap News



reported. Under the constitution if Yoon resigns or is impeached then the prime minister, who was appointed by Yoon, becomes South Korea's interim president. Lawmakers will vote on the main opposition Democratic

Party's motion to impeach Yoon later on Saturday. Yoon shocked the nation late on Tuesday when he gave the military sweeping emergency powers in order to root out what he called "anti-state forces" and overcome obstructionist political

opponents. Some PPP members urged Yoon to resign before the vote, saying they did not want a

repeat of the 2016 impeachment of then-President Park Geun-hye, who left office following months of candlelit protests over an influence-peddling scandal. Her downfall triggered the implosion of the party and a victory by liberals in presidential

In scenes reminiscent of those protests, thousands of demonstrators holding candles assembled outside parliament on Friday night demanding Yoon's impeachment. More demonstrations are expected on Saturday ahead of the vote.

Prosecutors, the police and the Corruption Investigation Office for High-ranking Officials have all launched probes into Yoon and senior officials involved in the martial law decree, seeking to pursue charges of insurrection and abuse of power, among others.

The officials face potential charges of insurrection, abuse of authority and obstructing other people from exercising their rights. If convicted, the crime of leading an insurrection is punishable by death or life imprisonment, with or without prison labour.

AMMAN/BEIRUT. Dec 7 (Agencies): Syrian rebels said they seized control of the southern city of Daraa on Saturday, the birthplace of a 2011 uprising against President Bashar al-Assad and the fourth city his forces have lost

in a week. Rebel sources said the military agreed to make an orderly withdrawal from Daraa under a deal giving army officials safe passage to the capital Damascus, about 100 km (60 miles) north.

Social media videos showed rebels on motorcycles and others mingling with residents on the streets. People fired shots into the air at the city's main square in celebration, according to the videos.

There was no immediate comment from the military or Assad's government, and Reuters could not independently verify the rebels' claim. With the fall of Daraa, Assad's forces have surrendered four important centres to the insurgents in a week.

Daraa, which had a population of more than 100,000 before the civil war began 13 years ago, holds symbolic importance as the cradle of the uprising. It is the capital of a province of about 1 million people, bordering Jordan.

Daraa's seizure followed the rebels' claim late on Friday that they had advanced to the edge of the central city of Homs, a key crossroads between the capital and the Mediter-

Syrian state media reported dozens of rebels were killed in the Homs countryside on Friday in an operation by Syrian and Russian air forces, artillery, missiles and armoured vehicles.

Capturing Homs would solidify a chain of powerful positions under the Islamic insurgents' control from Aleppo on the Turkish border in the north to Daraa on the Jordanian border to the south.

Gaining Homs would also increase the rebels' chances of isolating the seat of Assad's regime in Damascus with the ability to block the route northwest from the capital to the sea.

Rebels reenergised

As the rebels pressed their offensive, Russia and Jordan on Friday urged their nationals to leave Syria.

After years locked behind frozen front lines, rebel forces have burst out of their northwestern Idlib bastion to achieve the swiftest battlefield advance by either side since a street uprising against Assad mushroomed into civil

war 13 years ago. Syria's conflict killed more than 305,000 people between 2011 and 2021, the United Nations Human Rights Office said in 2022.

Assad regained control of most of Syria after key allies - Russia, Iran and Lebanon's Hezbollah came to his rescue. But all have recently been weakened and diverted by other crises, giving Sunni Muslim militants

a window to fight back. Tehran, which has been focused on tensions with arch-foe Israel since the Gaza war began last year, began to evacuate its military officials and personnel from Syria on Friday, a sign of Iran's inability to keep Assad

US President Biden considers preemptive pardons for officials, allies before Trump takes office

WASHINGTON, Dec 7 (Agencies): US President Joe Biden is weighing whether to issue sweeping pardons for officials and allies who the White House fears could be unjustly targeted by President-elect Donald Trump's administration, a preemptive move that would be a novel and risky use of the president's extraordinary constitutional power.

The deliberations so far are largely at the level of White House lawyers. But Biden himself has discussed the topic with some senior aides, according to two people familiar with the matter who spoke on condition of anonymity Thursday to discuss the sensitive subject. No decisions have been made, the people said, and it is possible Biden opts to do nothing at all.

Pardons are historically afforded to those accused of specific crimes - and usually those who have already been convicted of an offense - but Biden's team is considering issuing them for those who have not even been investigated, let alone charged. They fear that Trump and his allies, who have boasted of enemies lists and exacting "retribution," could launch investigations that would be reputationally and financially

costly for their targets even if they don't result in prosecutions.

While the president's pardon power is absolute, Biden's use in this fashion would mark a significant expansion of how they are deployed, and some Biden aides fear it could lay the groundwork for an even more drastic usage by Trump. They also worry that issuing pardons would feed into claims by Trump and his allies that the individuals committed acts that necessitated immunity.

Recipients could include infectious-disease specialist Dr. Anthony Fauci, who was instrumental in combating the coronavirus pandemic and who has become a pariah to conservatives angry about mask mandates and vaccines. Others include witnesses in Trump's criminal or civil trials and Biden administration officials who have drawn the ire of the incoming president and his allies.

Some fearful former officials have reached out to the Biden White House preemptively seeking some sort of protection from the future Trump administration, one of the people said.

It follows Biden's decision to pardon his

son Hunter - not just for his convictions on federal gun and tax violations, but for any potential federal offense committed over an 11-year period, as the president feared that Trump allies would seek to prosecute his son for other offenses. That could serve as a model for other pardons Biden might issue to those who could find themselves in legal jeopardy under Trump. Biden is not the first to consider such pardons — Trump aides considered them for him and his supporters involved in his failed efforts to overturn the 2020 presidential election that culminated in a violent riot at the Capitol on Jan. 6, 2021. But he could be the first to issue them since Trump's pardons never materialized before he left office nearly four years ago.

Gerald Ford granted a "full, free, and absolute pardon" in 1974 to his predecessor, Richard Nixon, over the Watergate scandal. He believed a potential trial would "cause prolonged and divisive debate over the propriety of exposing to further punishment and degradation a man who has already paid the unprecedented penalty of relinguishing the highest elective office of the United States," as written in the pardon

proclamation.

Politico was first to report that Biden was studying the use of preemptive pardons. On the campaign trail, Trump made no secret of his desire to seek revenge on

those who prosecuted him or crossed him. Trump has talked about "enemies from within" and circulated social media posts that call for the jailing of Biden, Vice President Kamala Harris, former Vice President Mike Pence and Sens. Mitch McConnell and Chuck Schumer. He also zeroed in on former Rep. Liz Cheney, a conservative Republican who campaigned for Harris and helped investigate Jan. 6, and he promoted a social media post that suggested he wanted military tribunals for supposed treason.

Kash Patel, whom Trump has announced as his nominee to be director of the FBI, has listed dozens of former government officials he wanted to "come after."

Richard Painter, a Trump critic who served as the top White House ethics lawyer under President George W. Bush, said he was reluctantly in support of having Biden issue sweeping pardons to people who could be targeted by Trump's administration. He said he hoped that would "clean the slate" for the incoming president and encourage him to focus on governing, not on punishing his political allies.

"It's not an ideal situation at all," Painter said. "We have a whole lot of bad options confronting us at this point."

While the Supreme Court this year ruled that the president enjoys broad immunity from prosecution for what could be considered official acts, his aides and allies enjoy no such shield.

Some fear that Trump could use the promise of a blanket pardon to encourage his allies to take actions they might otherwise resist for fear of running afoul of the law.

"There could be blatant illegal conduct over the next four years, and he can go out and pardon his people before he leaves office," Painter said. "But if he's going to do that, he's going to do that anyway regardless of what Biden does.'

More conventional pardons from Biden, such as those for sentencing disparities for people convicted of federal crimes, are expected before the end of the year, the White House said.

The plea claimed that Shakeel was detained without any application of mind and by flouting procedural safeguards such as informing him of his right to make a representation against his detention and reading out the detention order in a language known to him.

The issue of the preventive detention order was a sheer abuse of the process of law, his lawyer argued.

The government countered that Shakeel was a hardcore and habitual criminal who has been involved in various criminal offences, including stabbing, rioting and bovine smuggling.

To decide on whether Shakeel's preventive detention was justified, the Court relied on the Supreme Court's ruling in R Kalavathi v. State of Tamil Nadu (2006), in which it was held that the relevant factor is not the nature of the detenue's acts, but their potential to disturb community life or public order.

The Court found that Shakeel's alleged activities had potential to disturb public order and, therefore, upheld his preventive detention.

The Court also found no merit in the petition's allegation the procedural safeguards were flouted in detaining him. The Court found that the detention order was read out to Shakeel in Hindi/ Dogri, which he understood, and that only he was to blame for not filing any representation challenging his detention on time.

Therefore, the High Court dismissed the petition challenging his detention.

RBI reduces cash reserve ratio, launches Al-based model to detect mule accounts

CHANDIGARH, Dec 7 (Agencies): Detailing the outcome of the Monetary Policy Committee (MPC) meeting, RBI Governor Shaktikanta Das announced measures such as slashing the cash reserve ratio (CRR), raising the limit of collateral free agriculture loan and introducing AI solutions to identify mule bank accounts.

To ease potential liquidity stress, Das said it had been decided to reduce the CRR of all banks to 4 per cent from 4.5 per cent. CRR is the minimum amount commercial banks have to hold as a reserve with the central bank. According to experts, the lowering of CRR is an encouraging move as it would help inject significant liquidity into the banking system, enhance banks' lending capacity and improve credit accessi-



bility for individuals. The RBI has also decided to increase the limit for collateralfree agriculture loans from Rs 1.6 lakh to Rs 2 lakh per borrower.

This will further enhance credit availability for small and marginal farmers. The limit for collateral-free agriculture loans was last revised in 2019. To prevent and mitigate digital frauds. MuleHunter AL an inpo-

frauds, MuleHunter.AI, an innovative AI/ML-based model, has been developed by the Reserve Bank Innovation Hub (RBIH), Bengaluru. This will help banks deal with the issue of mule bank accounts, and reduce digital frauds.

The RBI has also decided to permit Small Finance Banks to extend pre-sanctioned credit lines through UPI. Credit line on UPI was initially launched in September 2023, and was made available through Scheduled Commercial Banks (SCBs). This will further deepen financial inclusion and enhance formal credit, particularly for 'new to credit' customers.

Furthermore, as part of RBI's consultative approach in framing regulations, a 'Connect 2 Regulate' programme will be launched under the ongoing RBI@90 commemorative event+.

A dedicated section of the RBI website will be made available for stakeholders to share ideas and inputs on specific topics.

Sufficient urea stock in Punjab to meet demand for current rabi sowing season: NFL

NEW DELHI, Dec 7 (Agencies): Stateowned fertiliser firm NFL on Saturday said there is sufficient stock of urea in Punjab to meet the demand of the current rabi sowing season and advised farmers not to hoard nutrients.

In a statement, the NFL said, "There are sufficient stocks available in Punjab for the Rabi season."

Out of the total requirement of urea in Punjab for the Rabi season, regular supplies are being arranged in the state by fertiliser companies.

"Accordingly, suf-

ficient quantity has already been supplied to Punjab from 1st October onwards on a pro-rata basis of the total requirement. This quantity is higher by more than a lakh tonne against the pro-rata requirement of urea,"

NFL said. The company said the fertiliser companies are supplying 60 per cent of urea in Punjab through Markfed and 40 per cent through private dealers. The company advised "farmers not to hoard stocks based on the rumours as there is a sufficient quantity of urea in the country for a sustained supply in Rabi season", NFL added. The company is one of the leading fertiliser manufacturers in the country.

Urea production has increased from 225 lakh tonne per annum during 2014-15 to a record 314.07 lakh tonne during 2023-24.

Urea is provided to the farmers at a statutorily notified Maximum Retail Price (MRP).

The difference between the urea MRP and the production cost is being paid to manufacturers.

A bag (45 kg) of urea is sold at around Rs 250.

Maruti Suzuki, Mahindra to hike vehicle prices from January

NEW DELHI, Dec 7 (Agencies): Maruti Suzuki India and Mahindra & Mahindra announced plans to hike vehicle prices from January in order to offset the impact of rising input costs and operational expenses. Maruti Suzuki, the country's largest carmaker, will hike prices of its model range by up to 4 per cent from January. Mahindra & Mahindra is increasing prices of its SUV models and commercial vehicles by up to 3 per cent.

Maruti Suzuki India in a regulatory filing said that in light of rising input costs and operational expenses, the company has planned to increase the prices of its cars from January 2025. The price increase is expected to be up



to 4 per cent and will vary depending on the model, it added.

"While the company continuously strives to optimise costs and minimise the impact on its customers, some portion of the increased cost may need to be passed on to the market," it stated.

Maruti Suzuki sells a range of models, ranging from Alto hatchback to Invicto multi-utility vehicles, in the domestic market. Mahindra & Mahindra said it will hike prices of its SUVs and commercial vehicles by up to 3 per cent from January next year.

The adjustment is in response to the rising costs due to inflation and increased commodity prices, Mahindra & Mahindra (M&M) said in a statement.

The automaker has made efforts to absorb as much of these additional costs as possible however, a portion of this increase will need to be passed on to customers, it added.

The extent of the price increase across different SUVs and commercial vehicles will be up to 3 per cent, the auto major stated.

Similarly, JSW MG Motor India said it will also increase prices of its entire model range by up to 3 per cent from

next month. The price increase is a result of continuously rising input costs and other external factors, the automaker said in a statement. "Our dedication to

NEW DELHI, Dec 7 (Agencies): Eating five servings of dark chocolate, and not the milk one, a week may help reduce the risk of type 2 diabetes, according to a long-term US study.

Published in the BMJ, the researchers also found that increased consumption of milk, but not dark, chocolate was associated with longterm weight gain.

Chocolate contains high levels of flavanols (a natural compound found in fruits and vegetables) which have been shown to promote heart health and reduce the risk of diabetes.

But the link between chocolate consumption and the risk of type 2 diabetes remains controversial due to inconsistent results.

In addition, most previous studies have not looked at whether eating dark and milk chocolate - which have different cocoa, milk and sugar content - might have different impacts on the risk of type 2 diabetes. To explore this further, researchers combined data from three longterm US observational studies of female nurses and male healthcare professionals with no history of diabetes, heart disease or cancer when they were recruited.

They analysed associations between type 2 diabetes and total chocolate consumption for

NEW DELHI, Dec 7 (Agencies): Over onefifth of deliveries in India are performed via caesarean section, with a higher proportion of these surgeries taking place in private facilities compared to public ones, according to a study published in The Lancet Regional Health-Southeast Asia journal.

A caesarean delivery is performed by surgically cutting through a pregnant woman's abdomen and uterus.

Researchers, including those from The George Institute for Global Health in New Delhi, analysed live birth data of over 7.2 lakh women aged 15-49 years across 28 states and eight union territories, collected during the fifth round of the National Family Health Survey (2019-2021).

"India's caesarean delivery rate of 21.5 per cent suggests adequate national access but may

Bihar, where much of the population belongs to lower wealth groups, there was a higher preference for vaginal deliveries due to their affordability and shorter recovery times, even when medical professionals recommended a C-section.

Neurons that suppress food intake found, may lead to new obesity treatments

NEW YORK, Dec 7 (Agencies): A team of researchers have discovered a previously unknown population of neurons in the hypothalamus that regulate food intake and could be a promising new target for obesity drugs, according to a study.

In the study published in Nature journal, researchers from the Laboratory of Medical Genetics at Rockefeller University in New York, the Institute for Genome Science (IGS) at the University of Maryland School of Medicine (UMSOM) in Baltimore, as well as New York and Stanford Universities, discovered a new population of neurons that is responsive to the hormone leptin.

Leptin responsive neurons are important in obesity since leptin is sent to the brain from the body's fat stores to suppress hunger. "We've long known that the hypothalamus—located deep in the brain—plays a role in hunger, hormone levels, stress responses, and body temperature," said Brian Herb, a scientist at IGS and a research associate at UMSOM. Through several experiments with mice, the researchers found that this previously unknown neuronal population that express both receptors for leptin and the BNC2 gene not only helps suppress hunger, but also responds to food-related sensory cues, such as food palatability and nutritional status.

For example, the researchers used CRISPR-Cas 9 gene technology to knock out the leptin receptor in these BNC2 neurons.

Those mice ate more and gained more weight than control mice. In addition, researchers added fluorescence to the BNC2 neurons and noticed when they fed mice after fasting, the BCN2 neurons activated, whereas previously known neuronal populations in the hypothalamus did not react.

"These findings add a critical new component to our understanding of how neurons impact appetite and obesity," Dr Herb said. "This could be a future target for obesity treatment, such as by activating these neurons to reduce weight or suppress hunger."

2nd Test: Australia ahead after fifties by Head and Labuschagne

Looking to fight their way back into the game, India got an early breakthrough through who else but Jasprit Bumrah

ADELAIDE, Dec 7 (Agencies): Marnus Labuschagne finally regained form with a composed half-century before being overshadowed by Travis Head's flamboyance as Australia negotiated the Indian pacers to reach 191 for four at tea on day two of the second Test here on Saturday.

Head picked the gaps with ease on way to an unbeaten 53 off 67 balls to keep Australia ahead in the contest after India grabbed three wickets in the first session. The hosts were ahead by 11 runs, having gone past India's first innings total of 180.

Labuschagne (64), whose place in the team was debated prior to this game owing to his prolonged lean run with the bat, registered his 26th half-century and then launched himself into a flurry of boundaries in what were worrying signs for India. But promising all-rounder Nitish Reddy cut short Labuschagne's innings as the batter tried to guide him through gully only for Yashasvi Jaiswal to hold



on to the catch.

Looking to fight their way back into the game after Australia's dominance on the opening day, India got an early breakthrough through who else but Jasprit Bumrah after four overs into play.

Playing in only his second Test after a forgettable debut in Perth, Nathan McSweeney had no answer to one of many excellent deliveries from Bumrah, which straightened a fraction after landing on the perfect length and all the batter could do was get a little nick while trying to defend after getting stuck on the crease.

McSweeney walked back after a hard-fought 39, a far better effort following his twin failures in the series opener, but Steve Smith's poor run of form continued as the former captain got out in the most unfortunate fashion after a brief stay at the crease

Smith looked to flick a Bumrah delivery tickling down the leg side but only ended up edging it to the keeper Rishabh Pant who completed a neat catch diving to his left.

As Ravi Shastri said on air, India got Smith in this fashion in the last tour as well, by attacking his middle and leg stump.

Unlike the first day, when they were guilty of bowling outside the off-stump way too often, the Indian pacers targeted the stumps in the initial phase of second day's play and they were also rewarded for it in the form of those early wickets.

Smith's dismissal, for two off 11 balls, brought into the middle Travis Head and Bumrah welcomed him with one that straightened off the deck and whizzed past the outside edge. Head, however, moved on

quickly from the close shave and got off the mark with a cracking boundary off the Indian pace spearhead, finding the gap between mid-off and extra cover.

Shah had vacated the position after three terms as ACC President. Silva previously functioned as the chairman of the organisation's Finance & Marketing Committee.



NEW DELHI, Dec 7 (Agencies): After a video of Vinod Kambli's recent public appearance came to the fore, an old clip of Rahul Dravid sharing his views on the definition of 'talent', while mentioning Vinod Kambli's name, has resurfaced on social media. Kambli, a childhood friend of the legendary Sachin Tendulkar, was one of the most-talked about cricketers when he arrived at the scene, but he failed to maintain the stature. Despite playing 104 ODIs and 17 Tests for India after making his debut in 1991, Kambli's international career could not last even a decade. In the viral resurfaced clip, Dravid, who played 509 matches for India besides also coaching the senior team later, gave the example of how Vinod Kambli had an incredible 'ball-striking ability' but probably "didn't have the talent in the other areas to understand what it took to be an international cricketer." "I think we judge talent wrong. What do we see as talent? And I've made the same mistake. We judge talent by people's ability to strike a cricket



ball. The sweetness or the timing of a cricket ball. That's the only thing we see as talent. Things like determination, courage, discipline, and temperament are also talents. When we judging talent, I think we've got to look at the whole package," he said in the video. "It's a hard thing

At stumps, England was 378-5 in its second innings with Joe Root 73 not out and captain Ben Stokes unbeaten on 35.

Root was among the historymakers Saturday, reaching his 100th score of 50 or more in tests. When he reached his 65th half century, which goes along with his 35 centuries, he became the fourth player after Sachin Tendulkar, Jacques Kallis and Ricky Ponting to achieve that feat.

Atkinson was not privy to Stokes' thoughts about a declaration.

"I'm not really sure what the plans are to be honest," he said. "We'll see tomorrow, assess what the conditions are and see from there."

India storm into U-19 Asia Cup final

SHARJAH, Dec 7 (Agencies): Vaibhav Suryavanshi was the star of the show again with a second successive half-century as India stormed into the U-19 Asia Cup final with a comprehensive seven-wicket victory over Sri Lanka here. The 13-year-old, who became the youngest cricketer ever to be bought at an IPL auction last month, smashed five sixes and six fours for his 36-ball 67 as India chased down a target of 174 with as many as 170 balls to

spare. India will face Bangladesh in the final on Sunday.

Bangladesh defeat-

ed Pakistan by seven wickets, completing a modest chase of 117 in 22.1 overs in the first semifinal in Dubai.

Opting to bat, Sri Lanka could only manage 173 in 46.2 overs despite a valiant effort from Lakvin Abeysinghe (69 off 110) and Sharujan Shanmuganathan (42 off 78).

Their innings struggled to gain momentum as Indian bowlers were in full control with Chetan Sharma (3/34), Kiran Chormale (2/32), and Ayush Mhatre (2/37) wreaking havoc in the middle overs.

India's chase was built on a solid foundation laid by Ayush Mhatre (34 off 28) as he put on a stand

of 91 with Suryavanshi for the opening wicket. The young left-hander from Bihar troubled the Sri Lankan bowlers from the beginning as he started with consecutive sixes and a boundary off Dulnith Sigera, who ended up giving away 31 runs in his opening

> over. Mhatre too played his strokes at the other end as the duo raced to 87 for no loss in eight overs before Vihas Thewmika gave Sri Lanka their first breakthrough by removing the batter.

But Suryavanshi showed remarkable maturity as he kept the run-rate ticking despite losing his opening partner, forging another cru-
