IED found on Srinagar-Baramulla **Highway**

SRINAGAR, Dec 11 (Agencies): Security forces on Wednesday detected and destroyed a suspected improvised explosive device (IED) on the Handwara-Baramulla highway in

Kashmir, officials said. A joint patrolling party of police and army found a suspicious bag by the roadside on the highway at Langate in Handwara area of Kupwara district, the officials said.

Officials said a bomb disposal squad was rushed to the spot and the suspicious object taken to an isolated place.

The squad destroyed the object in a controlled explosion, the officials said, adding there was no damage done.

Blaze renders four families **homeless** in south Kashmir's Kulgam

KULGAM, Dec 11 (Agencies): Three residential houses were completely gutted in a massive overnight blaze, rendering four families homeless in Nagam village of Damhal Hajipora in south Kashmir's Kulgam district, officials said Wednesday.

An official said the fire broke out from a residential house and later spread to two others, damaging three houses where four families were residing, along with two cow sheds.

He said that fire tenders were immediately dispatched to the spot; however, the houses were reduced to ashes before the fire was brought under control.

"The flames took everything we had in minutes. In this cold, we are left with nothing but the hope of support Turn to page 9

Two-Member UN Team meets Rohingya Muslims in Jammu

JAMMU, Dec 11 (Agencies): A two-member team of the United Nations High Commissioner for Refugees (UNHCR) met Rohingya Muslims at a slum here amid a heated debate whether the illegally settled immigrants be provided water and electricity.

Senior Protection Officer Tomoko Fukumura along with Protection Associate Ragini Trakroo Zutushi on Monday met the Rohingya Muslims and some local residents in the Kiryani Talab area of Narwal, an official said on Wednesday.

He said the head of the team would return to Delhi on Wednesday evening as their attempt to meet some police officials failed.

On December 7, Jammu and Kashmir Jal Shakti Minister Javed Ahmed Rana said



the water supply would not be snapped to the slums housing the immigrants, pending a call from the Centre on their depor-

Rana's statement came after Rohingyas living on three plots of land in the Narwal area of

Jammu claimed that their power and water supply were snapped recently despite being registered with the UNHCR.

Two days later, Chief Minister Omar Abdullah said the Centre should decide the fate of the Rohingya population settled in Jammu, asserting that they could not be allowed to die of starvation or cold.

"It is a humanitarian issue. The central government should decide about them (Rohingyas). If they are to be sent back, do that. If you can, send them back. If you cannot send them back, we cannot starve them to death. They cannot be allowed to die of cold," Abdullah had told reporters.

"The Government of India should tell us what we have to do with them. As long as they are here, we need to take care of them," he added.

Abdullah, the National Conference vice president, also asserted that they did not bring the Rohingyas to Jammu.

"They have been brought and settled here. If there is a change in policy Turn to page 9

NIA raids 9 locations in Punjab, Haryana in **Gangster-Terror Nexus case**

NEW DELHI, Dec 11 (Agencies): The National Investigation Agency (NIA) conducted searches at nine locations in Punjab and Haryana on Wednesday (December 11, 2024) as part of its ongoing investigation into the gangster-terror nexus case.

The raids are underway at eight locations in Punjab and one in Haryana since early Wednesday following a tip-off against suspects linked to the case.

The raids are reportedly aimed at cracking down on individuals and networks suspected of facilitating criminal activities linked to terrorist organizations.

This follows the agency's intensified efforts to curb the growing nexus between gangsters and terror groups operating in the region.

Last month, the agency in a massive crackdown on the terror-gangster nexus case had also conducted extensive searches at premises linked with associates of the Davinder Bambiha syndicate at nine locations in Punjab, Haryana and Uttar Pradesh.

NIA teams then conducted searches at the premises of suspects in

NEW DELHI, Dec 11 (Agencies): AAP supremo Arvind Kejriwal on Wednesday once again ruled out the possibility of an alliance with the Congress for the Delhi assembly polls, amid reports that the two parties could be jointly con-



testing the elections. In a post on X, Kejri-

wal said the Aam Aadmi Party (AAP) will be fighting the election on its own strength in Delhi.

"There is no possibility of any alliance with the Congress," the former Delhi chief minister said. His reaction comes amid media reports that the two parties were likely to have a tie up for the 70-member Delhi Assembly polls due in February.

44 Jammu Kashmir Residents evacuated from Syria

SRINAGAR, Dec 11 (Agencies): The Ministry of External Affairs (MEA) has announced the safe evacuation of 75 Indian nationals from Syria on Tuesday, including 44 residents of Jammu and Kashmir. This development comes two days after rebel forces overthrew the 14-year-long brutal regime of Syrian President Bashar al-Assad.

The stranded Indian nationals, including pilgrims (zaireen) from Jammu and Kashmir at Saida Zainab, were successfully transported to Lebanon. MEA stated that arrangements are underway for their return to India via commercial flights.

"The Government of India accords the highest priority to the safety and security of Indian nationals abroad," the ministry emphasised.

It advised remaining Indian nationals in Syria to maintain contact with the Indian Embassy in Damascus for updates.

The dramatic overthrow of Bashar al-Assad's regime, marked by rebel forces capturing the capital Damascus and other key cities, has plunged Syria into a period of uncertainty. Assad, who fled to Russia and is reportedly seeking asylum there, leaves behind a legacy marred by civil war and crackdowns on political dissent.


to spread across the Kashmir Valley, affecting regular activities. Temperatures hit -3 degrees Celsius in Srinagar.



MHA, Tourism Ministry in advance stage talks to allow satellite phones for trekkers: Director Tourism Kashmir

SRINAGAR. Dec 11 (Agencies): Director Tourism Kashmir, Raja Yaqoob, has announced that the Ministry of Tourism, in collaboration with the Ministry of Home Affairs (MHA), is in advanced discussions to allow trekkers the use of satellite phones in remote areas of Jammu and Kashmir.

This initiative aims to address the lack of network connectivity in high-altitude and inaccessible regions, ensuring the safety of tourists and trekkers, he said.

Speaking about the proposal, Raja Yaqoob stated, "The Ministry of Tourism has taken up with MHA across different states that tourists go there because the network is not available. Satellite phones should be allowed, and that is at the advanced stage of discussion. As it happens in Puducherry, we will get on with it.'

The move comes as Kashmir witnesses a surge in adventure tourism, with popular trekking routes such as the Kashmir Great Lakes and Tarsar Marsar



drawing significant numbers of domestic and international tour-

Raja Yaqoob also expressed optimism about this year's tourism season, noting, "Every day, we have 200-500 foreign tourists arriving, which gives immense pleasure and encouragement despite the delayed snowfall."

Kashmir's adventure tourism offerings have expanded significantly, with popular treks like the Kashmir Great Lakes and Tarsar

Marsar becoming major attractions for domestic and international tourists

The government has also initiated activities such as rafting in Gurez Valley, paragliding at multiple locations, and hot air balloon rides in Zabarwan Park.

Additionally, Yaqoob revealed that the region hosted its first international marathon this year. featuring participants from 13 countries and 59 international

The government is now work-

ing to bring global recognition to Kashmir's adventure tourism by engaging with the World Rafting Federation to organize an international rafting championship.

To support the growing demand for adventure activities, the tourism department has made significant investments in infrastructure and equipment. This year, the government allocated funds in the Capex budget for advanced trekking instruments, tents, skiing equipment, and a snow groomer machine to maintain slopes. Raja Yaqoob emphasized, "After 30 years, this machine will be procured, ensuring better facilities for winter sports.

As part of its commitment to sustainable tourism, Kashmir celebrated International Mountain Day on December 11. Raja Yaqoob stressed the importance of mountains, saying, "Mountains provide fresh water and are critical to our ecosystem. With climate change and overexploitation, it's essential to acknowledge their significance in our lives".

Man injured in alleged firing by night patrol troops in Poonch

J&K BJP demands immediate deportation of Rohingyas, Bangladeshis; Cites Security,



JAMMU, Dec 11 (Agencies): Senior BJP leader and chief spokesman for the party in Jammu and Kashmir Wednesday demanded immediate deportation of Rohingyas and Bangladeshis residing in

Labeling them as "illegal intruders" and "supporters of anti-national elements," Sethi claimed their presence poses a severe threat to the region's security, stability, and law and order.

Addressing a press conference in Jammu as per news agency KINS, Sethi alleged that these migrant communities had illegally participated in the Urban Local Bodies elections, accusing them of tampering with the democratic process. "Evidence has emerged of their involvement in casting votes, which is not only illegal but also a dangerous precedent," Sethi stated. He further alleged that members of these communities are engaged in organized criminal activities, such as drug trafficking and other offenses, which he

said were destabilizing the region.

Sethi took a sharp swipe at J&K Chief Minister Omar Abdullah, who had earlier advocated a humanitarian approach toward the Rohingyas and Bangladeshis.

In a provocative statement, he suggested that Omar's compassion for these groups might one day extend to terrorists as well. "A misplaced sense of humanitarianism should not override the safety and security of our people," he remarked, questioning the logic behind Abdullah's statements.

The BJP leader called for immediate action from the government, urging it to deport these individuals without delay. He also appealed for protests in Kashmir to draw attention to what he described as an "escalating security and social crisis.'

The controversy stems from earlier remarks by Chief Minister Omar Abdullah, who argued that the Rohingyas and Bangladeshis living in Jammu should not be treated inhumanely or left to die from hunger and cold. Abdullah had urged the central government to take a clear position on whether these migrants should be deported or allowed to stay with proper safe-

Three drug peddlers arrested in Baramulla or dial 112," the officials

SRINAGAR, Dec 11 (Agencies): Three drug peddlers in Jammu and Kashmir's Baramulla district have been arrested, police said on Wednesday.

A police statement said, "Continuing efforts to combat the menace of drugs in society, Baramulla Police have arrested three drug peddlers and recovered contraband substances from their possession."

The officials said that a team from Police Station Pattan, led by SHO intercepted a vehicle (Ertiga, registration number JK05M-8404) at a checkpoint near the Railway Crossing Pattan.

"The vehicle was occupied by three individuals who were identified as, Jhon Mohd Mir, son



of Gh Mohd Mir, resident of Nillah Palpora; Mohd Yaqoob Mir, son of Late Ab Aziz, resident of Nillah Palpora; and Faisal Ahmad Hajam, son of Gh Qadir, resident of Pushwari Anantnag. During the search, 78 grams of contraband Charas (in powder form) were recovered from their possession. The accused have been arrested and shifted to Police Station Pattan for

further legal proceedings," said the officials.

"Additionally, the vehicle used in the commission of the crime has been seized. A case under relevant sections of the law has been registered at Police Station Pattan and an investigation is underway. We urge the public to report any instances of drug peddling or other criminal activities to the nearest police establishment said further. The police have been

stressing that the cooperation of the community is vital in eradicating the drug menace. "Baramulla Police

reiterate their commitment to taking strict legal action against those involved in criminal activities," a police statement read. J&K Police have inten-

Hindus in Bangladesh

angladesh, a South Asian nation with a majority Muslim population, is home to one of the largest Hindu communities outside India. Hindus in Bangladesh account for approximately 8–10% of the country's population, making them the second-largest religious group. Their history in this region dates back thousands of years, but their journey has been marked by cultural contributions, social challenges, and efforts to maintain their identity in the face of changing political and social landscapes.

The region now known as Bangladesh has been a center of Hindu culture and civilization for millennia. Ancient Bengal was ruled by Hindu dynasties such as the Gupta and Sena empires, which fostered advancements in art, architecture, and education. Hindu temples like those in Puthia and Kantaji testify to this rich heritage.

With the advent of Islam in Bengal in the 13th century and subsequent Mughal rule, Hindu and Muslim communities coexisted, though tensions occasionally arose. During British colonial rule, Bengal became a hub for intellectual and social reform movements, with Hindus playing pivotal roles in movements like the Bengal Renaissance.

However, the partition of India in 1947 drastically altered the socio-political landscape. East Bengal (now Bangladesh) became part of Pakistan, leading to significant migration of Hindus to India due to religious tensions and fears of discrimination. The 1971 Bangladesh Liberation War brought hope for a secular state, but challenges for the Hindu minority persisted.

Hindus in Bangladesh have occasionally faced targeted violence, including attacks on temples, homes, and individuals. Such incidents often spike during political unrest or communal tensions. For instance, anti-Hindu violence erupted in 2013 following the sentencing of Islamist leaders during the International War Crimes Tribunal. Similarly, incidents during the 2021 Durga Puja celebrations highlighted the community's vulnerability. The 1965 Enemy Property Act (later renamed Vested Property Act) allowed the government to confiscate properties owned by individuals deemed "enemies of the state," primarily targeting Hindus. Though repealed, its legacy continues, with many Hindus struggling to reclaim their ancestral lands.

Hindus often face systemic marginalization in terms of education, employment, and political representation. Despite making significant contributions to the economy and culture, they are underrepresented in government positions and other influential sectors.

The percentage of Hindus in Bangladesh has steadily declined since partition, primarily due to migration to India and other countries, driven by economic challenges and fear of persecution.

While Hindus strive to preserve their traditions, cultural erosion is a concern. Temples, rituals, and festivals like Durga Puja, Saraswati Puja, and Rath Yatra remain central to their identity, but threats to religious freedom often disrupt these practices. Despite challenges, Hindus have made significant contributions to Bangladesh's socio-cultural and political fabric.

Hindu poets, writers, and musicians like Lalon Fakir, Jibanananda Das, and Alauddin Khan have enriched Bengali culture.

Hindus have been active participants in Bangladesh's independence movement and ongoing development. Leaders like Jogendra Nath Mandal played crucial roles in the nation's history.

Many Hindus are entrepreneurs and professionals contributing to sectors like trade, agriculture, and education.

upreme court of India gave an important and milestone judgment in the petitions filed by Congress requesting the highest Court of the country to direct the government to switch over to the old ballot paper system of polling .But the top Court struck down these write petitions and declined to order the political executive to go for ballot paper system of polling .The supreme Court made a startling revelation and said a spade a spade when it opined that the opposition parties including the Congress say that EVM's are good when they win any election and the same party say that EVM's are bad meaning thereby that they are tampered with and the results are made in favor of a particular party .The opposition parties used to state publicly that EVM are choor .But now the highest court of the land has favored use of EVM's in elections in the largest democracy of the world and the decision of the Supreme Court is a big setback to INDIA block especially Congress .In fact EVM's use in the polling is definitely better than the traditional ballot paper system of voting .But some parties are annoyed and uneasy over the use of EVM's in elections but selectively as they favor EVM's when they win and curse the EVM's when they lose and it is really a double standard of these parties .In a decision of far reaching importance and bearing ,Supreme Court rejected plea for reverting to ballots and said 'EVM' are fine if you win and tampered if you lose and this observation is very apt and true .The oral remark was made by Justice Vikram Nath before dismissing a petition filed by evangelist K.A.Paul ,who sought a judicial order to return to paper ballots .The top Court on November 26,2024 indicated a level of hypocrisy attached to criticism about Electronic Voting Machines – EVM ,saying "EVM's are tempered when you lose and fine if you win. "EVM's are best suited to the present day voting where the number of voters has raised significantly and

experientially as well as significantly and the RVM system of counting votes is best suited to the modern day voting and therefore there should be no confusion about it .But still there are political parties and politicians who have petitioned the Supreme Court to order switch over from EVM to ballot paper system of voting . However the top court has dismissed the concerned petition and allowed the use of EVM's in counting .The Supreme Court heard PIL that sought the reintroduction of ballot papers in place of EVM's. The Apex Court dismissed a PIL which sought re-introduction of ballot papers in place of EVM's remarking that the machines are blamed only when one loses an election." What happens is ,if you win the elections, the EVM's are not tampered with .When you lose elections ,EVM's are tempered with .When Chandrababu Naidu, lost ,he said EVM's can be tempered .Now this time Jagan Mohan Reddy lost, he said EVM's are tempered "said Justice Vikram Nath presiding over a two-Judge bench while dismissing the PIL by evangelist K.A.Paul .The comments came as Paul ,arguing in person cited tweets by Naidu from 2018 and some recent posts on X .The Supreme Court rejected petition seeking to revert to ballot papers instead of EVM's during elections in the country .As the petitioners pointed out that even prominent leaders like Chandrababu Naidu and YS Jagan Mohan Reddy had raised concerns about tampering with EVM's, the SC remarked,"When Chandrababu Naidu or Mr YS Jagan Mohan Reddy lost ,they said EVM's were tempered and when they won ,they did not say anything .How can we see this? We are dismissing this . This is not the place where you argue all this." Petitioners KA Paul referenced Elon Musk's remarks who had suggested that EVM's could be tempered with .He had also mentioned that he had visited over 150 countries and most foreign countries had adopted ballot paper voting and argued that India should follow the same approach .'Why you don't want to be different from the rest of the world ."The petitioner also requested

the formulation of a comprehensive framework to regulate the use of money and liquor during election campaigns ensuring that such practices are prohibited and punishable under the law .Additionally ,the plea sought a directive for a widespread voter education campaigns to raise awareness about the importance of informed decisionmaking .Congress has raised concerns regarding the electoral process and the use of EVM's in General Elections and recently concluded assembly elections in Haryana and Maharashtra, which it lost .The election commission dismissed all allegations saying that there was no evidence to suggest any compromise in the statutory electoral procedures .Thus SC said no return to ballot papers and backs 'secure ,user -friendly 'EVM's .It rejected plea for 100% verification of votes polled in EVM's with slips from VVPATs .Reaffirming its faith in the working of EVM's ,the Supreme Court rejected prayers for 100 percent verification of the votes polled in them with slips printed by the voter verifiable Paper audit trail -VVPAT machines or in the alternative, a return to the system of ballot papers . In separate but concurring judgments, the two-Judge bench of Justices Sanjiv Khanna and Dipankar Datta ,which "conducted an indetail review of the administrative and technical safeguards of the EVM mechanism ."said ,"To us ,it is apparent that a number of safeguards and protocols with stringent checks have been put in place ."It said "data and figures " placed before it "do not indicate artifice and deceit. "Justice Khanna said,"In our considered opinion, the EVM's are simple ,secure and user friendly .The voters , candidates and their representatives ,and the officials of ECI are aware of the nitty -gritty of the EVM system .They also check and ensure righteousness and integrity . Moreover ,the incorporation of the VVPAT system fortifies the principles of vote verifiability ,thereby enhancing the overall accountability of the electoral process ."Justice Datta said ,"It is of immediate relevance to note that in recent years, a trend has been fast developing of cer-

tain vested interest groups endeavoring to undermine the achievements and accomplishments of the nation ,ensured through hard work and dedication of its sincere workforce. There seems to be a concerted effort to discredit, diminish and weaken the progress of this great nation on every possible front .Any such effort ,or attempt ,has to be nipped in the bud .No constitutional court ,far less this Court ,would allow such an attempt to succeed as long as it has a say in the matter ."Rejecting the prayer for a return to ballot papers as "foible and unsound," Justice Khanna said," The weakness of the ballot paper system is well known and documented .In the Indian context ,keeping in view the vast size of the Indian electorate of nearly 97 crore ,the number of candidates who contest the elections, the number of polling booths where voting is held ,and the problems faced with ballot papers ,we would be undoing the electoral reform by directing reintroduction of the ballot papers ."Justice Khanna pointed out that ,"EVM's offer significant advantages .They have effectively eliminated booth capturing by restricting the rate of casting to 4 votes per minute ,thereby prolonging the time needed and thus check insertion of bogus votes."The bench rejected the apprehension that the machines could be hacked or tampered with as "unfound "and said "accordingly ,the suspicion that the EVM's can be configured /manipulated for repeated or wrong recording of votes to favor a particular candidate should be rejected "To sum up it can be construed that it has become now become crystal clear that EVM's reflect honesty and integrity and so EVM's are not choor and leveling of baseless charges on EVM's manipulation has been rejected by the Supreme Court.


When Dilip Kumar countered an aggressive Indira Gandhi in presence of Nehru

The matchless thespian of Hindi cinema. he is still remembered for his understated, yet intense roles of brooding and star-crossed lovers, a smitten Mughal Crown Prince, a rustic simpleton-turned-outlaw, boisterous prankster, and dutiful policeman, yet Dilip Kumar's most significant performance came in a private interaction when he-politely-rebuked a future Prime Minister in front of her father.

It would have remained a secret had not Dilip Kumar himself revealed the episode, involving him, Indira Gandhi, and Pandit Jawaharlal Nehru, in a speech at some public event decades later.

On the 102nd birth anniversary—December 11 -- of Muhammad Yusuf Khan alias Dilip Kumar, Indian films' abiding superstar, who left an unmatched legacy with just 57 films in a 54-year-long career, the story deserves to be retold.

As Dilip recalled, he had just been elected the President of the India Motion Picture Producers Guild, despite not running or being interested in the post, and had been invited to a breakfast meeting with



Pandit Nehru. While Dilip did not

reveal the exact time of this meeting, it most likely took place in 1963 soon after he took over the post. The association's welfare programmes had the twin aims of creating a social identity, civic consciousness, and credibility for the film industry, and telling the common people that people of the industry did not just inhabit a world of make-believe but had concerns about their fellow citizens too.

Or as he put it, "Apne waqar ko establish karna tha, ke nahi hoshmand hai, ham ko khayal hai, apni society se muttaliq hai, apni zameen se vabasta hai, apne culture se muttaliq hai..."

He said that Prime Minister Nehru was aware of

the special functions the film industry organised for disaster relief, education, and other social welfare objectives, and used to call him over to meet once in a while.

As the actor recalled, Mrs Gandhi was also present at this breakfast meeting and launched into a no-holds-barred broadside against the Hindi film industry, noting how she had visited Paris, Moscow, and London and seen their orchestras, plays, and films there, and how these were far advanced and better than their Indian counterparts. Furthermore, she said that there was "nothing Hindustani about Hindustani films".

Dilip said that he kept quiet for the nearly 15 minutes or so that Mrs Gandhi harangued him, though inwardly losing his equanimity as she "began to overstep the bounds of decorum" with her "total condemnation of an entire medium", which was "not justified at all". He then thought it would not be rude if he responded to her strident criticism.

The actor then said, with extreme politeness, that he had been listening to her for 10 to 12 minutes as she criticised Hindustani films, "and you said a lot, which I admit is valid and denying it will be folly. It will be stupidity to claim that Indian films are the best. But let me tell you that you ask where is the 'Hindustaniat in Hindustani films' and in the 12 minutes you have been speaking, there has been no 'Hindustaniat' in your criticism, for you have not used a single Hindustani word... you have been speaking entirely in English."

However, Dilip said that he did not stop Mrs Gandhi's counter-attack, telling her that in spite of a "dedicated man at the helm of affairs," the country had several problems.

".. we don't only have a film industry that is poor... we have roads, educational system, agriculture that are poor, and if I may put it to you, Madam, our administration also has several weak and even some ugly points," he said to her.

The superstar did not reveal Mrs Gandhi's response, but as quiet settled, feared that he had offended the Prime Minister. However, he recalled that it was Pandit Nehru who broke the silence, remarking, "You know, Yusuf, if I was you, I wouldn't have been so polite."

That was the prowess of the "shy 22-year-old son of a Pathan fruit merchant," renamed Dilip Kumar by Devika Rani when he entered films in 1944 and "single-handedly refined histrionics" and refined acting "to an art form of exalted brilliance," as per his wife Saira Banu.

Let alone his celluloid career, Dilip symbolised India's diversity, capable of quoting from the Quran as well as the Bhagavad Gita and the Bible, celebrating Diwali as fervently as Eid, and the ceremony marking the completion of Jain children's arduous 30-day fast, and equally fond of Josh, Firaq and Sahir as Sumitranand Pant, Bharti and Tagore.

Naxalites kill BJP worker in Bijapur; fifth civilian murder in one week

BIJAPUR, Dec 11 (Agencies): Naxalites have killed a 35-year-old BJP worker in Chhattisgarh's Bijapur district while claiming he was acting as a police informer, an official said on Wednesday. This is the fifth murder of a civilian by Naxalites in the district in the last seven days.

The latest incident took place on Tuesday night when the deceased. identified as Kudiam Mado, was at his house in Somanpalli village under Farsegarh police station limits, the official

A group of Naxalites stormed into Mado's house, dragged him outside and strangled him to death, the police official said.

In a pamphlet found at the spot, a national park area committee of Maoists took responsibility for the murder and claimed Mado was acting as a police informer, he said.

After being alerted on Wednesday

morning, a police team rushed to the spot and the body was sent for postmortem, the official said.

A search operation has been launched in the area to trace the assailants, he

On December 4, two former sarpanchs, one of them a BJP worker, were killed by Naxalites at separate places in Bijapur district.

On December 6, Naxalites killed a woman anganwadi assistant in the district. Another woman was strangled to death by Naxalites here on December

With Tuesday's incident, more than 60 persons have been killed in Naxal violence so far this year at separate places in Bastar division, which comprises seven districts including Bijapur, according to police.

Notably, nine BJP leaders were killed between January 2023 and April 2024 in separate incidents in the division.

Working on space activities bill: Jitendra Singh

NEW DELHI, Dec 11 (Agencies): The Government is working on a new law to govern the space sector which has witnessed reforms over the past four years with private players making a mark in building and launching satellites, Union Minister Jitendra Singh said on Wednes-

Singh said India's maiden human spaceflight programme --Gaganyaan — was also progressing well and the first uncrewed mission was expected to be launched early next

"We are working on that," the Minister of State in the Prime Min-



ister's Office (PMO) told a press conference here in response to a question on the timeline for the space activities bill, which would grant statutory cover to the reforms in the sector.

Singh said the Government had announced

space sector reforms in 2020 with the aim to increase India's share in the global space econ-"Indian Space Policy

was released in April 2023 as an overarching, composite and dynamic framework to implement the space reform vision approved by the Union Cabinet," he said.

The Minister said there has been an exponential increase in the space sector start-ups and two private sector companies have already undertaken sub-orbital flights.

"Several other startups have significantly progressed towards launch vehicle and satellite development and space applications," the Minister said.

Singh said the number of space sector start-ups have gone up, from just one in 2014 to around 266 in 2024

He said the Government had also created Indian National Space Promotion and Authorization Centre (IN-SPACe), under the Department of Space, which has been functioning as a single window agency to promote, regulate and authorise the space activities of non-

governmental entities. Singh said Prime Minister Narendra Modi has also set a target for India's space sector to undertake the Gaganyaan mission to create the first module of the Bharatiya Antariksh Station, Chandrayaan-4 to bring back samples of lunar rocks, launch a mission to study Venus and build the next gen-

SC relaxes bail conditions for Manish Sisodia in excise policy cases

NEW DELHI, Dec 11 (Agencies): The Supreme Court on Wednesday relaxed the bail conditions for Aam Aadmi Party (AAP) leader Manish Sisodia, which had required him to report to the investigating officer twice a week in connection with the corruption and money laundering cases related to the Delhi

excise policy. A bench comprising Justices B R Gavai and K V Viswanathan deemed the conditions unnecessary, stating, "The petitioner shall regularly attend the trial."

The apex court had previously agreed, on 22 November, to hear Sisodia's pleas, issuing notices to the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED) to seek their responses on the applications.

Sisodia, the former Deputy Chief Minister of Delhi, had been granted bail by the Supreme Court on 9 August in both cases. The court

had highlighted that his 17-month incarceration without trial violated his right to a speedy trial. It imposed conditions, including the requirement for Sisodia to report to investigating officers every Monday and Thursday between 10 am and 11 am. During the 22 Novem-

ber hearing, senior advocate Abhishek Singhvi argued that Sisodia had already appeared before investigating officers on 60 occasions, making the frequent reporting



conditions excessive. Sisodia was initially arrested by the CBI on 26 February 2023 for alleged irregularities in the formulation and implementation of the now-scrapped Delhi excise policy for 2021-

Subsequently, on 9 March 2023, the ED arrested him in a money laundering case stemming from the same CBI FIR. He resigned from the Delhi Cabinet on 28 February 2023.

Denying all allegations,

Sisodia maintained his innocence throughout the legal proceedings.

In its 9 August verdict granting bail, the Supreme Court stated: "We find that, on account of a long period of incarceration running for around 17 months and the trial even not having been commenced, the appellant (Sisodia) has been deprived of his

right to speedy trial." The court reiterated the principle that "bail is the rule and jail is the exception," while directing Sisodia to furnish a bail bond of 10 lakh with two sureties of the same amount.

Additionally, he was required to surrender his passport and refrain from influencing witnesses or tampering with evidence.

The Supreme Court's order had overturned the Delhi High Court's 21 May decision dismissing Sisodia's bail pleas. Both the CBI and ED had opposed his bail applications at every stage.

Israeli strikes on Gaza kill at least 26, **Palestinian medics say**

DEIR AL-BALAH, Dec 11 (Agencies): Israeli strikes on the Gaza Strip killed at least 26 people overnight and into Wednesday, including one that hit a home where displaced people were sheltering in the isolated north, killing 19, according to Palestinian medical officials.

The Israel-Hamas war has raged on with no end in sight, even after Israel reached a ceasefire with Lebanon's Hezbollah and attention shifted to the overthrow of Syrian President Bashar Assad. Both the outgoing and incoming U.S. administrations have said they hope to end the war before the inauguration but months of ceasefire talks have repeatedly stalled.

The strike that killed 19 occurred in the northern town of Beit Lahiya near the border with Israel, according to the nearby Kamal Adwan Hospital, which received the bodies. Hospital records show that a family of eight were among those killed, including four children, their parents and two grandparents.

Another strike in the built-up Nuseirat refugee camp in central Gaza killed at least seven people, according to the Awda Hospital. The dead included two children, their parents and three relatives, it said.

There was no immediate comment from the Israeli military. The military says it tries to avoid harming civilians and accuses militants of hiding among them, putting their lives in danger.

Israel says it has killed over 17,000 militants, without providing evidence.

Thousands more Palestinians have gone missing during the war, some after encounters with Israeli troops.

Kaag said she and other U.N. officials keep repeatedly asking Israel for access for convoys to northern Gaza and elsewhere, to allow in commercial goods, to reopen the Rafah crossing from Egypt in the south, and to approve dual-use items.

The Israeli military says it allows in enough humanitarian aid and blames U.N. agencies for not distributing it, saying large amounts of aid have accumulated just inside Gaza's borders. U.N. officials say Israeli restrictions, the breakdown of law and order and ongoing fighting make it difficult to access the aid and distribute it, and have repeatedly called for a ceasefire.

The United States, Egypt and Qatar have been mediating talks between Israel and Hamas for nearly a year, and diplomats say those efforts have recently gained momentum.

But Hamas has said it will not release the remaining hostages without an end to the war and a full withdrawal of Israeli troops. Israeli Prime Minister Benjamin Netanyahu has pledged to continue the war until Hamas is destroyed and all the hostages are returned, and has said Israel will maintain a lasting military presence in some areas.

Taiwan demands that China end its military activity in nearby waters



TAIPEI, Dec 11 (Agencies): Taiwan demanded Wednesday that China end its ongoing military activity in nearby waters, which it said is unilaterally undermining peace and stability in the Taiwan Strait and disrupting international shipping and trade.

The Foreign Ministry, in a statement posted on its website, said it was responding in part to the activities of a "large number" of Chinese naval and coast guard ships in the first-island chain, the Pacific archipelago off the Asian continental mainland that includes Japan, Taiwan and part of the Philip-

"The Ministry of Foreign Affairs solemnly demands that the Beijing authorities immediately stop military intimidation and all irrational activities that endanger regional peace and stability," the statement said.

Taiwan defense officials say they have detected Chinese ship s since Monday, both off Taiwan and farther out along the first-island chain. They described the formations as two walls designed to demonstrate that the waters belong to China.

China restricted airspace off its southeast coast from Monday to Wednesday, an indication that it was planning to hold drills, but the country's People's Liberation Army has not confirmed whether it is doing so.

Taiwan has been expecting drills following stops by its president, Lai Ching-te, in Hawaii and the U.S. territory of Guam during an overseas trip last week. China claims

self-governing Taiwan as its territory and opposes any official contact with America and other foreign governments.

A Chinese spokesperson didn't comment directly on any military exercises but said in a statement posted online Wednesday that the government would not let provocations by Taiwan in collusion with external forces go unchecked.

"We will take necessary measures to resolutely defend national sovereignty and territorial integrity, maintain peace and stability in the Taiwan Strait and safeguard the fundamental interests of compatriots on both sides of the Taiwan Strait," said Zhu Fenglian, a spokesperson for the government's Taiwan Affairs Office.

The Taiwan Strait is a 160-kilometer- (100mile-) wide body of water between China and the island of Taiwan.

China's military held major exercises around Taiwan following both Lai's inauguration in May and his national day speech in October. It also held a major drill after Nancy Pelosi, then the speaker of the U.S. House of Representatives, visited Taiwan in 2022

Philippine vice president skips hearing into threats she made against the president

MANILA, Dec 11 (Agencies): The Philippine vice president on Wednesday skipped the first hearing into threats she made against President Ferdinand Marcos Jr., saying she did not believe the investigation will be fair.

Vice President Sara Duterte was subpoenaed to appear before the National Bureau of Investigation but instead sent her lawyer, who submitted a letter saying their client vehemently "denies having made any threat constituting grave threat" under the law.

Duterte has tried to walk back her comments in a Nov. 23 online news conference where she publicly threatened Marcos, his wife and House Speaker Martin Romualdez with death. She later said it was rather an expression of concern for her own safety, claiming to have received death threats.

Marcos and Duterte have fallen out since winning the 2022 election. The two offices are elected separately in the Philippines, which has resulted in rivals occupying the country's top political posts.

Ex-Defense chief in South Korea tried to kill himself after being arrested over martial law case

SEOUL, Dec 11 (Agencies): South Korea's former Defence Minister Kim Yong Hyun was stopped from attempting suicide while in detention over last week's martial law, officials said, as police were trying to search President Yoon Suk Yeol's office Wednesday in their intensifying investigation.

The main liberal Opposition Democratic Party also plans to submit a new motion to impeach Mr. Yoon for his December 3 declaration that imposed martial law in South Korea for the first time in more than 40 years. Its first impeachment attempt against Mr. Yoon last Saturday failed, with ruling party lawmakers boycotting a floor vote.

Mr. Yoon's ill-conceived power grab has paralyzed South Korean politics, frozen its foreign policy and rattled financial markets, greatly reducing his chances

of completing his fiveyear term and casting a turbulent shadow over one of Asia's most robust democracies.

Shin Yong Hae, commissioner general of the Korea Correctional Service, told lawmakers Wednesday (December 11) that Kim tried to kill himself the previous night at a detention center in Seoul. He said that Kim's suicide attempt failed after centre officials stopped him and that he is in a stable condition now.

At the same parliament committee meeting, Justice Minister Park Sung Jae confirmed Kim's failed suicide attempt.


Kim was arrested early Wednesday after a Seoul court approved a warrant for him on allegations of playing a key role in a rebellion and committing abuse of power. Kim became the first person formally arrested over the Dec. 3

martial law decree.

Kim, one of Mr. Yoon's close associates, has been accused of recommending martial law to Yoon and sending troops to the National Assembly to block lawmakers from voting on it. Enough lawmakers eventually managed to enter a parliament chamber and they unanimously rejected Mr. Yoon's decree, forcing the Cabinet to lift it before daybreak on Dec. 4.

Later Wednesday, National Police Agency Commissioner General Cho Ji Ho and Kim Bong-sik, head of the metropolitan police agency of the capital, Seoul, were detained over their actions during martial law, police said. They were accused of deploying police forces to the National Assembly to block lawmakers' voting together with troops.

The country's main law enforcement institutions are focusing on

South Korean police said they sent officers to search Mr. Yoon's office on Wednesday to look for any evidence related to the martial law introduction. Local media reported the search was underway, but police and the presidential office couldn't immediately confirm the

Some observers earlier said the presidential security service won't likely permit searches of Mr. Yoon's office, citing a law that prohibits searches of sites with state secrets without approval from those in charge of those areas.

Mr. Yoon on Saturday apologized over the martial law decree, saying he won't avoid legal or political responsibility for the declaration. He also said he would leave it to his party to chart a course through the country's political turmoil, "including matters related to my term in office."

In his martial law announcement, the conservative Yoon stressed a need to

rebuild the country by eliminating "shameless North Korea followers and anti-state forces," a reference to his liberal rivals who control parliament. Since taking office in 2022, Yoon has had near-constant friction with the Democratic Party, which introduced motions to impeach some of his top officials and launched a political offensive over scandals involving Yoon and his

many experts say the martial law decree was unconstitutional. They say a president is by law allowed to declare martial law only during "wartime, war-like situations or other comparable national emergency states" and South Korea wasn't in such a situation. They argue that deploying troops to seal the National Assembly to suspend its political activities amounted to rebellion because the South Korean Consti-

Opposition parties and

tution doesn't allow a president to use the military to suspend parliament in any situation.

During a parliamentary hearing Tuesday, Kwak Jong-keun, commander of the Army Special Warfare Command whose troops were sent to parliament, testified that Yoon called him and asked for the troops deployed at parliament to "quickly destroy the door and drag out the lawmakers who are inside." Kwak said he didn't implement Yoon's

order. At the same hearing, senior officer Kim Daewoo of the military's counterintelligence agency said his commander, Yeo In-hyung, asked him if an army bunker in Seoul had space to detain politicians and other figures after martial law was imposed. Yeo is considered a close associate of Kim Yong Hyun.

If Yoon is impeached, his presidential powers would be suspended until the Constitutional Court decides whether to restore his powers or remove him from office. If he is dismissed from office, a new presidential election would be required.

The leader of Yoon's conservative party pledged to arrange his stable exit from power, saying the party will coordinate with Cabinet members over state affairs and that Yoon will be sidelined from duties during a transition to an early election.

However, the plans have been widely criticized as unrealistic and unconstitutional. The constitution explicitly states that impeachment is the sole method for suspending presidential powers and that the authority to command the military rests solely with the president. The Defense Ministry said this week that Yoon remains in charge of the country's military forces.

Ponting says 'he got worried for Siraj' after his fiery send-off to Head in Adelaide

DUBAI, Dec 11 (Agencies): Former Australia captain Ricky Ponting believes the incident between Travis Head and Mohammed Siraj during the second Border-Gavaskar Test in Adelaide was all down to a "misinterpretation" and said it was "accidental" the way the whole thing was played.

The incident took place in the 82nd over of Australia's first innings, when Siraj castled Head, on 140, with a crushing yorker and gave him a fiery sendoff and aggressively gestured to walk back towards the direction of the stands. To this, Head replied back to the pacer before walking off to a standing ovation from his home crowd.

Afterwards, the Adelaide crowd made constant boos whenever Siraj was fielding in the deep or came on to bowl, to express their displeasure over how



he behaved with Head. "Looking back at it now, I think it was accidental the way that whole thing played out. I don't think there was any malice meant at the start. Then the way it started and almost like the misinterpretation of what had actually gone on, I think, led to how it ended," Ponting said in the latest episode of the

ICC Review.
While Siraj's reaction was swift and fiery,
Ponting believes it was
an expected response
from a fast bowler under

pressure, who had taken only one wicket at that point.

"I know Travis has gone and said that he said, 'Well bowled' at the start. Siraj obviously wasn't happy about being hit over the deep backward square for six the ball before," he said.

"Rohit (Sharma) I'm sure would expect these fast bowlers to react like that. When they're under the pressure and they're getting hit and then they've just got a wicket, you'd expect that they'd be up and about."

However, the duo were seen having a friendly chat when Siraj came to bat during the second innings of the Test on Sunday, seemingly clearing the issue. Ponting was all praise for the duo for the swift manner in which they brought the matter to a close.

"Both players have

"Both players have now had their say on what they thought happened. It was great to see them actually chatting. When Siraj came out to bat and Travis was at short leg, they were actually clarifying what had happened out there. They were talking amongst themselves as to what had actually happened," he said.

Both Siraj and Head, however, had one demerit point added to their disciplinary code for breaching the ICC Code of Conduct, with the Indian pacer also being fined a 20 percent penalty on his match fee.

Funds being mismanaged in DDCA: Azad



NEW DELHI, Dec 11 (Agencies): World Cup winner Kirti Azad has raised the issue of mismanagement of funds in the run-up to the Delhi & District Cricket Association (DDCA) elections. Azad, who is the TMC Member of Parliament from Bardhaman-Durgapur, is fighting against sitting DDCA president Rohan Jaitley in the elections that will be held from December 13 to 15. teams.

Speaking to the media

ahead of the polls, the former all-rounder, who was a member of the 1983 World Cup winning team, alleged that funds have been mismanaged by officials. "It may cost Rs 1 crore maximum (on the outer side) to install a lift. But there is a request for Rs 29 crore," Azad said before questioning the DDCA officials for some lopsided selections of the Delhi

He also highlighted

that the DDCA needs a proper audit after suggesting grants and funds from the BCCI have been wasted.

"The members of the DDCA have long been denied their rightful status. The grants that the association has been receiving have been mismanaged. There is no proper auditing of the books of accounts. Members of the association have borne the brunt of facilities being denied which is rightfully theirs. More importantly, the DDCA, under Rohan Jailed, has failed to upgrade the stadium infrastructure as was promised," he said.

There are three groups fighting the elections this time. Apart from the Kirti Azad-Sanjay Hardwar panel and the one led by Jaitley, the other panel is being led by Vinod Tiara, who has not filed nomination for the president's post.

"Virat Kohli ki kamzori...": Ex-India star's blunt advice ahead of 3rd Test

NEW DELHI, Dec 11 (Agencies): Former India cricketer-turnedpundit Mohammad Kaif has advised Team India to take inspiration from the way Australia targeted Virat Kohli's weakness in their own plans to get Travis Head out cheaply. Kaif stated that even a player like Scott Boland - who isn't a regular in the Australia first XI - knew exactly that Kohli's weaknesses can be targeted by bowling in the outside off-stump region. Similarly, Kaif said that India should also be able to target Travis Head's weakness in playing balls outside

the off-stump.
"Virat Kohli ki kamzori log pakad ke rakhe huye hai. Off-stump ke bahar ball dalo, wahan out honge (People know Virat Kohli's weakness and hold on to it. Bowl outside the off-stump, he'll get out there)," said Kaif in a video posted on his own X account.

"Someone like Scott



Boland plays only two or three Tests in a year, but even he knows exactly where you need to bowl to Kohli. You know that Kohli will mess up around the off stump and send a catch to the wicket-keeper or slip cordon" Kaif said.

"So why can't the Indian bowlers target Travis Head's weakness consistently with proper planning? Why can't we pinpoint Head's weakness and keep bowling outside the off-stump or target him with short balls? Every batter has weaknesses, why can't we plan properly against

Travis Head and trap him?" Kaif added further.

Head sent the India bowling to the cleaners in the second Test in Adelaide, scoring a sensational 140 in just 141 balls to set the foundation for Australia's win. Australia recovered from a big 295-run loss in the first Test to deliver a thumping 10-wicket win in the second.

With the series poised at 1-1, both sides are eyeing victory with a place in the World Test Championship (WTC) 2025 final at stake.

'Losses galore for PCB if it pulls out of Champions Trophy over hosting deadlock'

KARACHI, Dec 11 (Agencies): The Pakistan Cricket Board could face revenue losses, lawsuits and also risk international alienation if it decides to withdraw from the ICC Champions Trophy over a deadlock on the mode of organising the 50-over event scheduled in February-March next year.



A senior cricket administrator here, who is well-versed with the organisation of ICC events, told PTI on Wednesday that it would not be an easy decision for the PCB to pull out if the hybrid model is not accepted in entirety by the ICC and the BCCI.

"Pakistan has not only signed a host agreement with the ICC but like all other participating nations in the event, it has also signed a mandatory Members' Participation Agreement (MPA) with the ICC," the administrator explained.



"It is only after a member nation signs the MPA for playing in an ICC event that it is eligible to get a share of revenues earned from ICC events.

"Most importantly when the ICC signed a broadcast deal for all its events, it has given a guarantee that all ICC members are available to play in their events including the Champions Trophy," he said.

Last week, the ICC reached a consensus to conduct the eight-team competition in a

hybrid model, allowing India to play its share of matches in Dubai while agreeing "in principle" to a similar arrangement in multi-lateral events till 2027. However, a formal announcement

is awaited.
The agreement means that Pakistan will not be obligated to travel to India for ICC events till 2027.

As part of the broadcast deal, at least one India-Pakistan match has to be scheduled in all ICC events, said the administrator. "The estimated bid a broadcaster makes for a long-term deal with the ICC is only after he has calculated the stimated value of all matches involving all countries.

"It is no surprise that the broadcaster offsets his loss of revenues from other matches with the estimated earnings from selling commercial spots and other rights for the Pakistan and India fixtures."

The administrator said that if Pakistan were to withdraw from the tournament, it could face potential lawsuits from the ICC and even some of the 16 other member boards on the ICC's executive board. The broadcaster may also exercise a similar option as the country's withdrawal will hit the estimated revenues of all stakeholders.

"PCB Chairman Mohsin Naqvi has to come clean on the whole issue. MPAs are the same for all countries and unless the PCB has kept some safeguard clauses in their host agreement with the ICC for the CT, they face a tricky situation," the administrator stated.

The administrator also disclosed that the PCB didn't have solid support from other members on the executive board.

"The truth is the ICC kept on sweeping the issue of whether India would send its team to Pakistan for the Champions Trophy, under the carpet or ignoring it even when this elephant in the room was brought to their notice several times since the board granted hosting rights to Pakistan." he added.

"Even the signing of the hosting rights was delayed until late last year within the PCB because they wanted a clear answer from the ICC and BCCI on this issue," said the administrator.

CHENNAI, Dec 11 (Agencies): A Greco-Roman wrestler employed with Indian Railways was asked to withdraw after winning his first bout at the recently-concluded Senior National Championship in Bengaluru. He was representing Rajasthan in the tournament.

Besides, two Railway wrestlers — both had won the state championship in their respective weight categories to qualify for nationals — didn't turn up thus forcing Chandigarh to go unrepresented in the event.

These are only a few cases which came to light as the rift between the Railway Sports Promotion Board (RSPB) and the Wrestling Federation of India (WFI) had devoid many more wrestlers to take part in the nationals. Paris Olympic bronze medallist Aman Sehrawat is one among them.

The championship might be over but the federation, whose secretary-general Prem Chand Lochab is incidentally also the secretary of the RSPB, is not in the mood to ignore the issue. The member units already discussed it in the annual general body meeting and authorised the WFI president Sanjay Kumar Singh to initiate an action.

It is now learnt that the WFI pres-



ident has decided to issue a showcause notice to the RSPB asking it the reason for skipping the championship. "The federation will ask the RSPB its reasoning behind skipping the nationals. The board is affiliated with the WFI and it has to send its athletes for events like nationals," Sanjay Kumar told this daily. He also said the WFI will decide the future course of action once it receives the response from the RSPB.

Meanwhile, the Rajasthan and Chandigarh Wrestling Associations also decided that it will not allow the Railway wrestlers to represent the state units in future events unless they submit no objection certificates from the RSPB.

"We will not let the Railway wrestlers to represent the state unit unless they submit NOCs," Darshan Lal from Chandigarh association told this daily. Ummed Singh, president of Rajasthan association, echoed the sentiments and said, "We have put forth our views in the AGM on Sunday.

Now the WFI president will decide on the issue and take necessary action."

Notably, once Sanjay Kumar arrives at a conclusion, the same will be presented before the executive committee members. They then will ratify it before forwarding it to the AGM for approval. Ummed Singh is also a member of the WFI

executive committee.

Lochab had said that the WFI has been suspended by the sports ministry and the Delhi High Court too has held that an ad-hoc committee should be formed by the Indian Olympic Association to manage the day-to-day affairs of the federation. "In such a situation, it would not be in fittest of things to send Railways team Officially in an unrecognised event," Lochab had replied to a text message from this daily.

Given the situation, the stalemate looks to continue in future and it's the wrestlers who have to bear the brunt unless an agreement is reached between the two warring entities.
