MeT predicts Rain, **Snow from** Monday in J&K

SRINAGAR, Jan 19 (Agencies): The Meteorological Centre Srinagar predicted threeday wet weather from Monday with rain and snow over Jammu and Kashmir, officials said.

The MeT office said the weather will remain dry over the plains with the possibility of light rain or snow over the higher reaches of Jammu and Kashmir on Sunday.

During January 20 and 21 there is a possibility of light snow at isolated to scattered places while light rain over the plains of Jammu and on January 22 there is a possibility of light to moderate rain over the plains of Jammu and snow at many places of Jammu and Kashmir, it said.

Higher reaches of Chenab valley and Pir Panjal Range may also receive light to moderate

JAMMU, Jan 19 (Agencies): The trial run on the Katra-Budgam railway track of Udhamraising day pur-Srinagar-Baramulla Rail Link (USBRL) was completed on Sunday as the 18-coach trial train

started at 8 a.m. from Katra railway station towards Kashmir "The trial 22-coach train has reached Budgam now and this completes the final trial run on the USBRL", officials of the railway monitoring the trial run distress.

said here. The ambitious USBRL was completed for Rs 41,000 crore. The track covers 326 Km out of which 111 Km section is in tunnels with the T-49 tunnel being 12.77 Km long, which is the longest railway tunnel in

the country. Indian Railways has made the world's highest railway bridge over the Chenab River in the Reasi district of Jammu and Kashmir.



Train To Kashmir: 22-Bogie Train's Trial Run

The iconic Chenab Bridge is 1,315m long having an arch span of 467m and a height of 359m above the river bed. The Chenab Rail Bridge is a steel and concrete arch bridge carrying a single-track railway line, located between Bakkal and Kauri in the Reasi district of Jammu Division.

The bridge spans the Chenab River at a height of 359 m (1,178 ft) above the river, making it the world's highest rail bridge and the world's highest arch. It is built between the Sangaldan Railway Station and the

Reasi Railway Station. Indian Railways has also built its first cablestayed bridge over the Anji Khad. This bridge features a deck 331 meters above the riverbed and a main pylon height of 193 meters. Perched over the Anji Khad river that swells every monsoon season, the bridge is supported by a single pylon, a large vertical tower-like structure soaring 1,086 feet from the river bed similar to the height of a

Surrounded on both sides by mountain peaks, the construction

77-storey building.

site is subject to billowing, and gusty winds. The entire USBRL is the most challenging task completed successfully by the Indian Railways. It is probably the most challenging rail link ever built in the world over such a long distance between treacherous mountains, rivers and difficult topography and weather.

The USBRL will boost the horticulture, agriculture, tourism, trade, and education of students and also make travel easy and affordable for the average citizen between Kashmir and the rest of the country.

This project is also one of the most powerful infrastructures integrating J&K with other parts of the country. The Vande Bharat train will chug between Katra and Baramulla the day the inauguration is done by Prime Minister Narendra Modi, the final date of the inauguration is yet to be officially announced.

Army deploys Black Hornet Nano Drone to Boost Border Security in J&K



SRINAGAR, Jan 19 (Agencies): The Indian Army has added the Black Hornet Nano drone to its fleet, a tiny

yet advanced surveillance tool aimed at enhancing border security, especially along the sensitive areas near

Pakistan. The drone, which was showcased during the 9th Veterans Day event at the Tanda Artillery Division in Akhnoor, Jammu, is designed to help thwart infiltration attempts and keep a close watch on enemy movements.

Weighing only 18 grams and measuring just 16 cm in length and 2.5 cm in width, the Black Hornet Nano is one of the smallest military drones in use today.

The area was immediately cordoned off and the explosive device is being safely defused.

Fraudulent complaint filed by senior JKAS officer exposed, FIR Lodged Balvinder demands stringent action

JAMMU, Jan 19: Balvinder Singh, a prominent RTI activist and President of the Sikh Progressive Front, has exposed a shocking case of fraud and impersonation involving a senior JKAS officer. Addressing the media, Singh revealed that a false complaint was lodged against another JKAS officer using a fabricated email ID cre-

ated in Singh's name. Singh shared his disbelief upon being summoned by the Anti-Corruption Bureau (ACB), Jammu, regarding the complaint. Upon investigation, it was discovered that his identity had been fraudulently used to file a baseless complaint, aiming to defame a fellow officer and tarnish Singh's own credibility as a social activist.

On October 4, 2023, Singh filed a formal complaint at the Cyber Police Station, Gandhi Nagar, seeking to identify the person behind the fake email ID. After relentless efforts spanning over a year, an FIR (No. 25/2024) was reg

istered on December 24, 2024, at the Cyber Police Station, Jammu, under Sections 66C and 66D of the IT Act, along with Section 356 of the Bharatiya Nyaya Sanhita (BNS).

The investigation, supported by evidence from Google Inc. and telecom service providers, revealed the accused as Sh. Kulraj Singh, a JKAS officer currently serving as Joint Handloom Officer, along with Joshi Kumari, wife of Romesh Kumar of Dogra Hall. The digital and electronic evidence conclusively established their guilt in impersonating Singh and filing the false complaint. Both accused surrendered to the court and obtained interim anticipatory bail from the Hon'ble Chief Judicial Magistrate, Jammu, effective until January 31, 2025.

Singh strongly condemned this grave misconduct, emphasizing that such actions by public servants undermine public trust and tarnish the reputation of the administrative system. "This unethical and illegal behavior

must be met with strict administrative action to set a strong precedent," Singh asserted.

He appealed to Lieutenant Governor J&K, Sh. Manoi Sinha. Chief Secretary J&K, and Commissioner Secretary GAD to initiate stringent action against Sh. Kulraj Singh to uphold the integrity of the administrative services.

Don't dare to touch sole seat reserved for PoJK displaced community: Chuni warns pol parties

BATHUNI (Rajouri), Jan 19: The SOS International, a frontline organization spearheading the struggle for the rights of 12-lakh refugees from Pakistanoccupied Jammu and Kashmir (PoJK), has warned the political parties against interfering with the sole reserved seat for PoJK refugees.

It passed a unanimous resolution that any attempt to politicize this seat would not be tolerated and the PoJK refugees would be forced to launch a district-level agitation to oppose any such move.

Thousands of people from PoJK while braving the biting cold gathered under the banner of SOS International in Bathuni area of Rajouri district today to demand political empowerment for their community.

Addressing the rally, Rajiv Chuni, Chairman SOS International, regretted the long-standing neglect of PoJK refugees by political parties, saying "Politicians, whether PM. CM, MPs, Ministers or MLAs, have failed to address our plight and bring us out of the current morass," he said.

He issued a stern warn



ing to political parties, urging them to refrain from interfering with the reserved assembly seat. "We have passed a unanimous resolution that any attempt to politicize this seat will not be tolerated. Our agitation, which started in Rajouri today, will extend to Jammu, Samba, Kathua, Poonch, Udhampur, Reasi and eventually other district headquarters across the region if any attempt is made to reap political benefits out of this sole seat reserved for PoJK refugees. We are determined to reach every household and mobilize against any such moves,"

Mr Chuni declared. Mr Chuni threw light on the community's efforts to gain representation in the legislative assembly,

stating, "It was resolved that at least eight seats out of the 24 reserved for PoJK must be allocated to our people who fled PoJK in 1947. We achieved a small success in 2006 when the WadhwaCommission recommended reserving eight seats for PoJK refugees living in Jammu and Kashmir and elsewhere.

The senior refugee leader also pointed to the 2014 report of the Parliamentary Standing Committee, chaired by the former vice president of India and former BJP national president VenkaiahNaidu, which endorsed the demand for eight seats, even suggesting constitutional amendments if necessary. "The report was tabled in both the House of the Parlia

ment in October 2014 but remains unimple-

mented," he said. While criticizing the amendment in J&K Reorganization Act of 2023 for allocating only one seat to PoJK refugees, Mr Chuni said it was grave justice with the community of 12 lakh people.

He accused political parties of exploiting the sole reserved seat for their own gains, warning them to stay away. "This seat should be provided to a non-political person who can effectively represent and empower our community in the legislative assembly. He must be free from party affiliations and is committed to the cause of the community," Mr Chuni said.

He further argued that existing representatives

ty who had risen to positions such as Ministers had failed to address the community's concerns. "If they had been competent enough, there would have been no need to reserve a seat for our community," he said.

"This seat was envisioned to empower the PoJK community and should be nominated for a non-political individual who can rise above party politics to serve the interests of PoJK refugees. Those associated with political parties and their organisationswill prioritize party agendas over community welfare," MrChuni asserted.

The rally concluded with a fervent appeal for the government to honour its commitment to the PoJK refugee community by ensuring that the reserved seat serves its intended purpose-uplifting the lives of those displaced and empowering the commu-

Rautela later issued an apology on Instagram, which read, "Dear Saif Ali Khan sir, I hope this message finds you in strength. I am writing with a deep sense of regret and heartfelt apology. Until now, I was completely unaware of the intensity of the situation you are facing.



I feel ashamed that I allowed myself to be consumed by the excitement surrounding Daaku Maharaaj and the gifts I was receiving, instead of pausing to acknowledge and understand what you are going through."

"Please accept my sincerest apologies for being so ignorant and insensitive. Now that I know the gravity of your case, I am deeply moved and want to extend my unwavering support. Your grace, dignity, and resilience during such a challenging time are truly admirable, and I have nothing but immense respect for your strength," she

The actor promised to prioritise compassion and understanding in the future. However, her decision to delete the post soon after only amplified the criticism.

Social media users called her actions "a publicity stunt". One user commented, "Why apologise if you're just going to take it down? Looks like she's not even taking her own apology seriously."

The stabbing incident occurred on Thursday morning when an intruder broke into Saif's house, leaving the actor with injuries near his spine and neck. 
'Building wale itna paisa lete hai, aur CCTV bhi nahi laga sakte': Rakhi Sawant reacts to attack on Saif Ali Khan

NEW DELHI, Jan 19 (Agencies): A day after an alleged attack on his vehicle during election canvassing, AAP supremo Arvind Kejriwal on Sunday said his life was dedicated to the country, but asserted Delhi has never witnessed such campaigning when a "murderous attack" was attempted on a former chief minister.

The AAP has alleged that New Delhi BJP candidate Parvesh Verma's "goons" attacked Kejriwal during campaigning in the constituency on

Saturday. "The people of Delhi have never witnessed such campaigning and violence in which a murderous attack was attempted on a former chief minister. This is

their way of campaigning because they are badly losing," Kejriwal said, targeting the BJP. He also laughed off

Verma's claim that Kejriwal is going to lose the New Delhi seat by 20,000 votes. "Let him live in dreams for some days," he told the media.

Kejriwal also said he has written to Prime Minister Narendra Modi about a housing scheme for government employees, proposing the Delhi government will build houses if the Centre provides land.

He said the scheme could be started with sanitation workers as beneficiaries and later other government employees can be provided houses on easy terms.

Modi govt converted ease of doing business to unease in doing business: Cong

NEW DELHI, Jan 19 (Agencies): The Congress on Sunday claimed that the Modi Government's "retrograde policies" have broken the confidence of investors in India and converted the ease of doing business to "unease in doing busi-

Ahead of the Union Budget, the opposition party said that to fix this, the upcoming budget must eliminate "raid raj

and tax terrorism". It also called on the government to take action to protect Indian manufacturing jobs and take decisive action to shore up wages and purchasing power.

Congress general secretary in-charge communications Jairam Ramesh said the Modi Government has long proclaimed its desire to improve the "ease of doing business" in India but yet in the past decade "we have only seen an easing of private investment which has fallen to record lows and the easing out of businesspersons who have departed India in large numbers for foreign shores".

"A byzantine, punitive, and arbitrary tax regime covering both GST and income tax - which amounts to sheer Tax Terrorism -is now the greatest threat to India's prosperity and has contributed to an 'unease of doing business'," he said in a statement.

The biggest component of investment private domestic investment has been weak since 2014, Ramesh said, adding that it was solidly in the 25-30 per cent of GDP range during Manmohan Singh's tenure as PM.

"In the last ten years, it has collapsed to the 20-25 per cent of GDP range. This sluggish investment has been accompanied by a mass exodus of highnet-worth individuals. More than 17.5 lakh Indians have acquired the citizenship of another country over the past decade," he said.

An estimated 21,300 dollar millionaires left India between 2022 and 2025, he claimed.

"All this is happening for three reasons. Firstly, a complicated GST. According to former Chief Economic Advisor Arvind Subramanian, the GST which was proclaimed by the PM to be a Good and Simple Tax has up to a 100 different tax rates, including cesses," he said.

The multiplicity of rates and confusion has facilitated alarming GST evasion of Rs 2.01 lakh crore, almost double the Rs 1.01 lakh crore reported in FY23, he said.

Ramesh claimed that 18,000 fraudulent entities have been uncovered with many more likely undetected.

"Secondly, despite claims to the contrary, Chinese imports into India continue unabated with a record trade deficit of \$85 billion in 2023-24.

This has damaged Indian manufacturing, especially in labour intensive sectors,"

Ramesh said. Thirdly, weak consumption and stagnant



wages have reduced India's consumption growth despite the free availability of personal debt, he said.

"According to Ministry of Agriculture data, real wages for agricultural labour grew 6.8 per cent per year under the UPA, and declined 1.3 per cent per year under the Modi government,"

Citing the Periodic Labour Force Survey data, he said it shows that average real earnings stagnated between 2017 and 2022 across all workers -? salaried, casual and selfemployed.

"These retrograde policies have broken the confidence of investors in India. To fix this, the

budget must eliminate raid raj and Tax Terrorism, take action to protect Indian manufacturing jobs and take decisive action to shore up wages and purchasing power, which in turn will incentivise Indian business to invest. Nothing less will do," Ramesh asserted.

Sharing his statement on X, Ramesh said, "The 2025/26 Union Budget will be presented thirteen days from today. Here is our statement on how the Modi Government has converted the ease of doing business to unease in doing business – thereby depressing private investment sentiment. Radical action is necessary to fix the damage."

The bus en route to Parbhani from Beed, hit the three men as they trained on the roadside. Two others in the group managed to escape unhurt, he added.

The trio died on the spot, and their bodies were taken to the district hospital in Beed for further formalities, he said, adding that the bus driver was apprehended and a case was being registered against him.

Following the accident, angry villagers vandalised the state transport bus and demanded jobs for family members of the deceased men in the state transport department, the official said.

Three dead, four missing as boat capsizes in Ganga in Bihar's Katihar

Pedestrian killed after rod from flex banner structure falls, pierces his neck in Madhya Pradesh



JABALPUR, Jan 19 (Agencies): A 64-year-old man was killed after a rod from a flex banner structure fell and pierced his neck in Madhya Pradesh's Jabalpur, an official said on Sunday.

A contractual employee of the local civic body was fixing the flex banner structure in Allahabad Bank Chowk on Saturday when a rod fell on a pedestrian, Civil Line police station in-charge Nehru Khandate

He said the rod fell on Kishan Kumar Rajak and pierced his neck.

The man was taken to a hospital, where the doctors declared him dead, the official said, adding that a case has been registered and a probe is underway to find out if the employee had followed safety protocol.

Delhi man, on way to distribute his wedding card, dies as car catches fire to death inside the car.

The victim's body has been sent for post-mortem and the investigation is underway, officials said.

South Korea's impeached president is arrested over martial law declaration and his supporters riot

Decision to arrest Yoon ignited unrest at Seoul Western District Court, where dozens of his supporters broke in and rioted

SEOUL, Jan 19 (Agencies): Hours after South Korea's impeached President Yoon Suk Yeol was formally arrested, triggering rioting by his supporters, his lawyers said on Sunday that he remains defiant in his refusal to answer questions over the probe into his declaration of martial law last month.

Yoon was formally arrested early on Sunday, days after being apprehended at his presidential compound in Seoul. He faces possible imprisonment over his short-lived authoritarian push, which set off the country's most serious political crisis since its democratization in the late 1980s

Yoon's arrest could mark the beginning of an extended period in custody, lasting months or more.

The decision to arrest Yoon ignited unrest at the Seoul Western District Court, where dozens of his supporters broke in and rioted, destroying the main door and windows. They used plastic chairs, metal beams and police shields that they managed to wrestle away from officers. Some were seen throwing objects and using fire extinguishers, destroying furniture and office machines, smashing glass doors and spraying water on computer servers. They shouted demands to see the judge who had issued the warrant, but she had already left.

Hundreds of police officers were deployed and nearly 90 protesters were arrested. Some injured police officers were seen being treated at ambulance vans. The court said it was trying to confirm whether any staff members were injured and assess the damage to its

Court describes Yoon as threat to destroy evidence

In granting law enforcement's request for an arrest warrant for Yoon, the court said he was a threat to destroy evidence. Yoon and his lawyers on Saturday appeared before the court and argued for his release.



The Corruption Investigation Office for High-Ranking Officials, which is leading a joint investigation with the police and the military, can now extend Yoon's detention to 20 days, during which they will transfer the case to public prosecutors for indictment.

Investigators are examining whether Yoon's Dec. 3 martial law decree amounted to an attempted rebellion. While South Korean presidents have wide-ranging immunity from prosecution while in office, the protection does not extend to allegations of rebellion or trea-

Yoon's lawyers could also file a petition to challenge the court's arrest warrant. Yoon Kab-keun, one of the president's lawyers, said he will not attend a questioning by the anti-corruption agency set for Sunday afternoon and will remain at the detention center.

Yoon Suk Yeol's appearance in court caused chaotic scenes in nearby streets, where thousands of his fervent supporters rallied for hours calling for his release. Even before the court issued the warrant for Yoon's arrest, protesters repeatedly clashed with police. At least two vehicles carrying anti-corruption investigators were damaged as they left the court after arguing for Yoon's arrest.

Yoon's defense minister, police chief and several top military commanders have already been arrested and indicted for their roles in the enforcement of martial law.

Yoon's lawyer decries his

The crisis began when Yoon, in an attempt to break through legislative gridlock, imposed military rule and sent troops to the National Assembly and election offices. The standoff lasted only hours after lawmakers who managed to get through a blockade voted to lift the measure. The opposition-dominated assembly voted to impeach him on Dec. 14.

His political fate now lies with the Constitutional Court, which is deliberating whether to formally remove him from office or reinstate him.

Seok Dong-hyeon, another lawyer representing Yoon, called the court order for his arrest "the epitome of anti-constitutionalism and anti-rule of law." He pointed to the riot and said Yoon's arrest would inspire more anger from his supporters.

Yoon's People Power Party regretted his arrest but also pleaded for his supporters to refrain from further violence.

The liberal opposition Democratic Party, which drove the legislative effort to impeach Yoon, said his arrest would be a "cornerstone for restoring the collapsed constitutional order." It also called for stern punishment of the rioters.

The country's acting leader, Deputy Prime Minister Choi Sang-mok, expressed "strong regret" about the riot, saying it "directly undermines democracy and the rule of law." He asked for heightened security at the sites related to Yoon's case,

also including the Constitutional Court, and measures to ensure order during protests.

After its investigators were attacked by protesters later on Saturday, the anti-corruption agency asked media companies to obscure the faces of its members attending the hearing.

Yoon insists his martial law decree was legitimate

Yoon and his lawyers have claimed that the martial law declaration was intended as a temporary and "peaceful" warning to the liberal opposition, which he accuses of obstructing his agenda with its legislative majority. Yoon says the troops sent to the National Election Commission offices were to investigate election fraud allegations, which remain unsubstantiated in South

Yoon has stressed that he had no intention of stopping the functioning of the legislature. He stated that the troops were sent there to maintain order, not prevent lawmakers from entering and voting to lift martial law. He denied allegations that he ordered the arrests of key politicians and election officials.

Military commanders, however, have described a deliberate attempt to seize the legislature that was thwarted by hundreds of civilians and legislative staff who helped lawmakers enter the assembly, and by the troops' reluctance or refusal to follow Yoon's orders.

If prosecutors indict Yoon on rebellion and abuse of power charges, which are the allegations now being examined by investigators, they could keep him in custody for up to six months before trial.

If the first court convicts him and issues a prison term, Yoon would serve that sentence as the case possibly moves up to the Seoul High Court and Supreme Court. Under South Korean law, orchestrating a rebellion is punishable by life imprisonment or the death penalty.

Netanyahu warns again that Gaza ceasefire will not begin until Hamas provides hostage list



DEIR AL-BALAH (GAZA STRIP), Jan 19 (Agencies): Israeli Prime Minister Benjamin Netanyahu said early Sunday that the ceasefire in Gaza will not begin until Hamas provides the names of the three hostages it is set to release later on Sunday in exchange for scores of Palestin-

Israel meanwhile announced that it had recovered the body of Oron Shaul, a soldier who was killed in the 2014 Israel-Hamas war, in a special operation hours before the ceasefire was set to begin.

ian prisoners.

The bodies of Shaul and another soldier, Hadar Goldin, remained in Gaza after the 2014 war and had not been returned despite a public campaign by their families.

In a statement, Netanyahu said he had instructed the military that the ceasefire, which was to come into effect at 8:30 a.m., "will not begin until Israel has in its possession the list of hostages to be freed, which Hamas committed to provide." He had issued a similar warning the night before.

Hamas blamed the delay in handing over the names on "technical field reasons." It said in a statement that it is committed to the ceasefire deal announced last week.

The exchange raised doubts about whether the ceasefire would begin as planned, the first step in a long and fragile process aimed at winding down the 15-month war.

The 42-day first phase of the ceasefire should see a total of 33 hostages returned from Gaza and hundreds of Palestinian prisoners and detainees released. Israeli forces should pull back into a buffer zone inside Gaza, and many displaced Palestinians should be able to return home.

The devastated territory should also see a surge in humanitarian aid.

This is just the second ceasefire in the war, longer and more consequential than the weeklong pause over a year ago, with the potential to end the fighting for good.

Negotiations on the far more difficult second phase of this ceasefire should begin in just over two weeks. Major questions remain, including whether the war will resume after the six-week first phase and how the rest of the nearly 100 hostages in Gaza will be freed.

Israel's Cabinet approved the ceasefire early Saturday in a rare session during the Jewish Sabbath, more than two days after mediators announced the deal.

The warring sides were under pressure from both the outgoing Biden administration and Presidentelect Donald Trump to achieve a deal before the U.S. presidential inauguration on Monday.

The toll of the war has been immense, and new details on its scope will now emerge.

Over 46,000 Palestinians have been killed, according to Gaza's Health Ministry. The Oct. 7, 2023, Hamasled attack on southern Israel that sparked the war killed over 1,200. Hundreds of Israeli soldiers have died.

Some 90% of Gaza's population has been displaced. The United Nations says the health system, road network and other vital infrastructure have been badly damaged. Rebuilding - if the ceasefire reaches its final phase - will take several years at least. Major questions about Gaza's future, political and otherwise, remain unresolved.

Taliban deputy tells leader no excuse for education bans on Afghan women, girls

KABUL, Jan 19 (Agencies): A senior Taliban figure has urged the group's leader to scrap education bans on Afghan women and girls, saying there is no excuse for them, in a rare public rebuke of government policy.

Sher Abbas Stanikzai, political deputy at the Foreign Ministry, made the remarks in a speech in southeastern Khost province.

He told an audience at a religious school ceremony there was no reason to deny education to women and girls, "just as there was no justification for it in the past and there shouldn't be one at all.'

The government has barred females from education after sixth grade. Last September, there were reports authorities had also stopped medical training and courses for

women. In Afghanistan, women and girls can only be treated by female doctors and health professionals. Authorities have yet to confirm the

medical training ban. "We call on the leadership again to open the doors of education," said Stanikzai in a video shared by

his official account on the social platform X. "We are committing an injustice against 20 million people out of a population of 40 million, depriving them of all their rights. This is not in Islamic law, but our personal choice or

Stanikzai was once the head of the Taliban team in talks that led to the complete withdrawal of foreign troops from Afghanistan.

It is not the first time he has said that women and girls deserve to have an education. He made similar remarks in September 2022, a year after schools closed for girls and months and before the introduction of a university ban.

But the latest comments marked his first call for a change in policy and a direct appeal to Taliban leader Hibatullah Akhundzada.

Ibraheem Bahiss, an analyst with Crisis Group's South Asia programme, said Stanikzai had periodically made statements calling girls' education a right of all Afghan women.

"However, this latest statement seems to go further in the sense that he is publicly calling for a change in policy and questioned the legitimacy of the current approach," Bahiss said. In the Pakistani capi-

tal, Islamabad, earlier this month, Nobel Peace Prize laureate Malala Yousafzai urged Muslim leaders to challenge the Taliban on women and girls' education.

She was speaking at a conference hosted by the Organisation of Islamic Cooperation and the Muslim World League.

The UN has said that recognition is almost impossible while bans on female education and employment remain in place and women can't go out in public without a male guard-

No country recognises the Taliban as the legitimate rulers of Afghanistan, but countries like Russia have been building ties with them.

India has also been

developing relations with Afghan authorities. In Dubai earlier this month, a meeting between India's top diplomat, Vikram Mistri, and Foreign Minister Amir Khan Muttaqi showed their deepening cooperation.

Army deploys Black Hornet Nano Drone to Boost Border Security in J&K

EPFO members can now change personal details, transfer EPF online without employer's intervention

Around 27 per cent of grievances filed by members are related to member profile/KYC issues

NEW DELHI, Jan 19 (Agencies): Over 7.6 crore members of retirement fund body EPFO can now change personal details like name and date of birth online without any verification by the employer or approval by EPFO with the rollout of a new facility.

Besides, the Employees' Provident Fund Organisation (EPFO) members with e-KYC EPF accounts (Aadhaar seeded) can file their EPF transfer claims online with Aadhaar OTP (one time password) directly without any need for intervention of the employer.

Union Labour & Employment Minister Mansukh Mandaviya introduced the two new services.

The minister said around 27 per cent of grievances filed by members are related to member profile/KYC issues and that would see a significant drop after the rollout of the facility.

He also stated that large employers having a huge workload of such requests will also benefit.

The minister stated that the EPFO has simplified the process of joint declaration on the EPFO portal by allowing employees to self-correct most common errors in personal details like name, date of birth, gender, nationality, father/ mother's name, marital status, spouse name, date of joining and date of leaving, without any verification by employer or approval by EPFO.

This facility will be available for members, whose UAN (universal account number) was issued after October 1, 2017 (when Aadhaar matching was made mandatory).

Requirement of supporting document has also been simplified for such cases.

Only where UAN is not linked with Aadhaar, any correction would have to be submitted physically to employer and after verification forwarded to EPFO for approval, he explained.

UAN registration is done by employer for the employee at the time of joining. For many employees, mistakes were committed by employers in recording father/spouse name, marital status, nationality and service details during the registration process or later.

In order to correct these errors, the employee had to make a request online with supporting documents.

The request would have to be verified by the employer and then forwarded to EPFO for approval before any change could be effected. This process was called Joint Declaration.

cent claims (1.2 crore) will instantly reach EPFO.

The turnaround time of EPF transfer claim processing will be considerably reduced since it does not require approval by the employer.

If any member has already filed his transfer claim which is pending with employer, the member can delete the already filed request and submit claim directly with EPFO.

The simplification will also greatly reduce the member grievances considerably (presently 17% of the total grievances pertain to transfer-related issues) along with the corresponding rejections.

Large employers who have a large workload of approving such cases will have significant improvement in the ease of doing business.

The internal processes of EPFO are also being simplified for transfer claim processing within this month which will further smoothen this process.

At present, any online request for transfer of PF account in case of any change of job has to be verified by the employer before submitting to EPFO.

In this process on an average 12 to 13 days are taken by employers before the claim reaches EPFO for verifying transfers.

During the last nine months, almost 20 lakh claims remained pending with employers for more than 15 days.

The minister also said that many initiatives are being taken to improve delivery of services by the EPFO aiming bring those at par with banking system.

RBL Bank net income plunges 86% in Q3 amid higher provisions for bad loans



NEW DELHI, Jan 19 (Agencies): Higher provisions for bad loans on a prudential basis pulled down the earnings of the mid-tier private sector lender RBL Bank, with its net income plunging by a massive 86% onyear to Rs 32.6 crore in the December quarter. Sequentially, earnings were 85% less than the previous guarter.

The bottom line was hit badly as it made an additional provision of Rs 414 crore on gross NPAs of the joint liability group portfolio, taking total NPA provision on this portfolio to 85 percent despite an improvement in overall asset quality.

Its gross non-performing assets (NPAs) improved to 2.92% in the reporting period from 3.12% a year ago but inched up marginally from 2.88% in the September quarter. Similarly, net NPAs also improved to 0.53% from 0.80% on-year and from 0.79% sequentially, the bank management told reporters in a con-call.

In absolute terms,

gross NPAs of the bank stood at Rs 2,701 crore compared to Rs 2,581.08 crore in the September quarter and Rs 2,551.05 crore in December 2023, while net NPAs stood at Rs 481.64 crore for the quarter compared to Rs 635.64 crore a year ago and Rs 697.51 crore in the September quarter.

Expecting a spike in bad loans from the microfinance book, the bank chose to make an additional provision, on a prudential basis, of Rs 414 crore on gross NPAs of the joint liability group portfolio, taking total NPA provision on this portfolio to 85%. This had the bank's overall provision coverage ratio including technical write-offs at

93.46%.

Credit cost, including above additional provision on GNPAs in the JLG loans, was 139 bps for the period.

The total provisions of the bank including specific, general and contingent provisions are at 110% of GNPA.

Net interest income grew 3% on-year to Rs 1,585 crore, while net interest margin stood at 4.90% and other income rose 38% to Rs 1,073 crore; core fee income for the quarter rose 19% to Rs 871 crore.

Deposits grew 15% to Rs 1.07 trillion, of which the low cost Casa grew 12% to Rs 35,022 crore which is 32.8% of overall deposits.

Advances grew 13% to Rs 90,412 crore, of which retail loans grew 19%, housing loans grew 33%, vehicle finance grew 30% and commercial banking grew 21%.

Kotak Mahindra Bank net income up 10% to Rs 3,305 crore in Q3

MUMBAI, Jan 19 (Agencies): The fourth largest private sector lender Kotak Mahindra Bank has reported a growth of 10% in standalone net income to Rs 3,305 crore in the December quarter. On a consolidated basis, the net profit increased to Rs 4,701 crore as subsidiaries, barring the microfinance arm, reported better

The interest income rose 14.75% to Rs 16,633.14 crore from Rs 14,495 crore, the bank management told reporters in a concall. In the second quarter, the interest earned stood at Rs 16,426.97 crore.

Gross non-performing assets (NPA) inched up to 1.51% from 1.48% in the September quarter but declined from 1.68% in the December 2023 quarter. Similarly, net NPAs stood at 0.44% in the reporting quarter compared to 0.45% in the September 2024 period, and 0.36% in December 2023.

In absolute terms, gross NPAs stood at Rs 7,218.17 crore compared to Rs 6,834.74 crore in September 2024, and Rs 6,981.15 crore in December 2023, and net NPA stood at Rs 2,070.42 crore compared to Rs 2,066.51 crore in September, and Rs 1,487.03 crore

in December 2023.

BSS Microfinance, its micro lending arm, reported a Rs 50 crore net loss in the reporting quarter as against Rs 104 crore profit in the year ago period. Net interest income increased 10%

Deposits grew 15% to Rs 4.59 trillion from Rs 3.99 trillion. Of this, current deposits grew 12% to Rs 66,589 crore and savings deposits were almost flat at Rs 1.24 trillion compared to Rs 1.23 trillion a year ago and term deposits rose 24% to Rs 2.68 trillion from Rs 2.16 trillion.

The capital adequacy ratio stood at 22.8 of which the CET-1 ratio was 21.7.

PSU steel manufacturer RINL gets Rs 11,440-crore lifeline from government

NEW DELHI, Jan 19 (Agencies): The debt-laden Visakhapatnam-based public sector company -- Rashtriya Ispat Nigam Limited (RINL) -- has got a new lease of life after the Central government on Friday approved a revival package of Rs 11,440 crore for the company. Of the Rs 11,440 crore, Rs 10,300 crore will be in the form of fresh equity infusion and Rs 1,140 crore will be for converting the working capital loan into preferred share capital.

"With this revival package, many of the historical legacy problems that RINL used to face will be resolved. Simultaneously, a lot of effort is going to be put in securing the raw material for RINL and the modernisation of the plant," said Ashwini Vaishnaw, Minister of Railways, Information & Broadcasting, and Electronics & Information Technology.



The minister said that very soon RINL will start functioning with two glass furnaces, and by August this year, all the three glass furnaces would be operational. Vaishnaw further said that RINL has a very special position in the entire steel industry -- it is one of those plants, which is located at the coastal Andhra Pradesh in Vizag, and is very important for

the overall steel sector of the country.

RINL has been under financial distress for quite some time, reporting losses and mounting debt for almost a decade now. In FY24, the company posted net losses of Rs 4,850 crore compared to Rs 2,850 crore in the previous year. The company's total debt at the end of FY24 was at Rs 17,000 crore.

The Navratna PSU company has over 13,000 employees. The company has a total capacity of 10.8 million tonnes of manufacturing capacity. The Union government, which was once considering privatisation of RINL but had to stall the process after political opposition, had last year infused Rs 1,650 crore to help it tide over financial and operational issues.

According to Vaishnaw, the revival package would immensely benefit all employees of RINL and all the people connected with the economic activities of the company.

Revival package

In a post on X, PM Narendra Modi said the Visakhapatnam Steel Plant has a special place in the hearts and minds of the people of AP, and the revival package has been given "understanding the importance of the steel sector in building an Atma Nirbhar Bharat".

Scientists find sepsis molecule, to boost treatments for critically ill patients

NEW DELHI, Jan 19 (Agencies): A team of US scientists has uncovered how a molecule found on certain bacteria may drive blood clotting in sepsis -- a life-threatening condition that causes about eight million deaths per year.

The team at Oregon Health & Science University (OHSU) focused on the role of specific blood clotting mechanisms in sensis

The findings may pave the way for enhancing treatments for critically ill patients. They found that lipopolysaccharide, or LPS -- a molecule found on the surface of certain bacteria like E. coli -- can directly activate proteins in the blood that trigger clotting.

This process can both block blood flow and damage vital organs in a chain reaction where proteins in the blood work together to form clots. The researchers



found a specific type of LPS, called O26:B6, that is particularly good at setting off this reaction, making it more likely to cause clotting problems

The research, published in the Journal of Biological Chemistry, is based on a study conducted in nonhuman primates. The team found that when bacteria containing LPS entered the bloodstream, it quickly activated the clotting system.

This included coagulating proteins like factor XII, which seems to initiate the clotting process,

causing a chain reaction. "People who are born without factor XII are healthy and don't bleed abnormally," said Joseph Shatzel, a physician-scientist at OHSU.

"That makes it a great target for therapies -- blocking it might help stop dangerous clots without causing bleeding."

Andre L. Lira, Postdoctoral scholar and lead author of the study, said his research focuses on how the physical properties of bacterial surfaces trigger the clotting system. Sepsis can arise from bacterial, viral, or fungal infections.

"Even when we know the bacteria causing the infection, different strains can behave differently," he said. "By understanding this, we hope to develop precision therapies." The team is working on experimental treatments targeting factor XII, including antibodies designed to block its activity.

Study decodes why sickle cell patients suffer cognitive problems

NEW DELHI, Jan 19 (Agencies): An ageing brain in people with sickle cell disease may be responsible for cognitive problems, finds a study.

Sickle cell disease is a genetic blood disorder characterised by the presence of abnormal haemoglobin (Hb).

People with the illness are also likely to face trouble in remembering, focusing, learning, and problem-solving.

The patients face these conditions even without brain stroke. To understand, researchers and physicians from Washington University School of Medicine in St. Louis examined more than 200 young adults with and without sickle cell disease.

They participated in brain MRI scans and cognitive tests. Each person's brain age was calculated using a brain-age prediction



tool that was developed using MRI brain scans from a diverse group of more than 14,000 healthy people of known ages.

The estimated brain age was compared with the individual's actual age. The results, published in JAMA Network Open, showed that participants with sickle cell disease had brains that appeared an average of 14 years older than

their actual age. Sickle cell participants with olderlooking brains also scored lower on cognitive tests. Further, the study showed that people experiencing economic

people experiencing economic deprivation, who struggle to meet basic needs, even in the absence of sickle cell disease, also had more-aged-appearing brains, the team said.

On average, a seven-year gap

was found between the brain age and the participants' actual age in healthy individuals experiencing poverty.

"Sickle cell disease is congenital, chronically depriving the developing brain of oxygen and possibly affecting its growth from birth.

Also, children exposed to longterm economic deprivation and poverty experience cognitive challenges that affect their academic performance," explained Andria Ford, Professor of neurology at Washington University Medicine.

Rishabh Pant, Shubman Gill and Mohammed Siraj amongst others, played a starring role as India would win the match by 3 wickets to hand Australia their first loss at the Gabba in 32 years. With this, they would also win the series 2-1.

India were given a target of 328 runs in the second innings when Pant and Gill stepped up with memorable knocks as the visitors achieved the 5th highest run chase on Australian soil. The match started with Marnus Labuschagne giving Australia the upper hand with a well-made 108. A fifty from then-captain

including the captain Mayank Agarwal for their impressive performance in the tournament," DK Shivakumar expressed happiness as quoted by the Karnataka CMO press release.

Recap of the final: Vidarbha won the toss and chose to bowl first. However, their decision did not work to their advantage in the first innings.

Openers Mayank Agarwal (32 runs from 38 balls, 5 fours) and Devdutt Padikkal (8 runs from 19 balls, 1 four) failed to provide a strong start, managing only a

23-run partnership.
The credit for Karnataka's success goes to their middle order, which propelled them to a commanding 348/6 in the first innings. Smaran Ravichandran (101 runs from 92 balls, 7 fours, and 3 sixes), Krishnan Shrijith (78 runs from 74 balls, 9 fours, and 1 six),

and Abhinav Manohar

(79 runs from 42 balls, 10 fours, and 10 sixes) were the standout performers.

Vidarbha's bowlers struggled in the first innings, failing to make early breakthroughs. Darshan Nalkande and Nachiket Bhute picked up two wickets each, while Yash Thakur and Yash Kadam claimed one wicket apiece.

In the run chase, opener Dhruv Shorey shone with a remarkable knock of 110 runs from 111 balls, including 8 fours and 2 sixes. However, he lacked support from other batters.

Vidarbha skipper Karun Nair could only manage 27 runs from 31 balls at a strike rate of 87.10. Harsh Dubey played a valiant knock of 63 runs from 30 balls, including 5 fours and 5 sixes, but Vidarbha fell short by 36 runs.

Karnataka's bowlers played a crucial role, with Vasuki Koushik, Prasidh Krishna, and Abhilash Shetty each claiming three wickets to dismiss Vidarbha for 312 runs.

Smaran Ravichandran was named the 'Player of the Match' for his century in the final. Meanwhile, Vidarbha skipper Karun Nair was awarded the 'Player of the Series.'

"Wish I was chairman of selectors": Surinder Khanna on not including Karun Nair in CT 2025 squad

NEW DELHI, Jan 19 (Agencies): Former India cricketer Surinder Khanna shared his thoughts on the omission of Karun Nair from the Champions Trophy squad despite an exceptional performer in first-class cricket.

Ajit Agarkar and skipper Rohit Sharma held a press conference on Saturday to announce the 15-member squad for the upcoming Champions Trophy 2025 and ODI series against England.

"I think Karun Nair is a bit unlucky. I wish I was the chairman of selectors. He hit 300 in the test match, and after that he disappeared. Now suddenly the moon has come out again, so that moon should shine for 2-3 years and how many 35-36 year olds can you have in the team? It's a one-day format, you require quick movers in the fielding," Surinder Khanna said while speaking to agency.

Nair was the top-run-getter not only for Vidarbha but also in the Vijay Hazare Trophy 2024-25, having accumulated a massive 779 runs in seven matches at a mind-boggling average of 389.50 as he has remained unbeaten in six innings. Even after his stupendous performance in domestic cricket, the 33-year-old failed to find a spot in the 15-member squad.

In six Tests for India since his debut in 2016, he made 374 runs in seven innings at an average of 62.33, with best score of 303*. Nair also played two ODIs for India, scoring 46 runs with best score of 39.

Further, the 68-year-old raised questions on Rohit and stalwart batter Virat Kohli's fitness and said that they both should get "mentally fit" and focus on their games to come back to form.

"The captain is also weak. I mean, if you make Rohit Sharma's field on the boundary, then two runs will be easily taken. Virat Kohli also fields in slips and only does fields inside the circle. Kohli is not making runs in the fielding, he is putting in a lot of effort. the circle. I hope they all get fit mentally and focus and come back to their form," Surinder Khanna added.

Skipper Rohit Sharma and star batter Virat Kohli came under fire for an underwhelming Border-Gavaskar Trophy campaign and overall a very disappointing 2024/25 season of Test cricket. Sharma (31 runs in three matches and five innings at an average of 6.20) and Virat Kohli (190 runs in five matches and nine innings at an average of 23.75 with a century) lacked big time with the bat. Virat fell for the outside-off-stump trap throughout the series, most notably by pacer Scott Boland who dismissed him four times.

The 2024-25 season of Tests has been miserable for 'Ro-Ko' (Rohit and Kohli). While Rohit scored just 164 runs in eight matches and 15 innings at an average of 10.93 with best score of 52, Virat scored a shambolic 382 runs in 10 matches and 19 innings at an average of 22.87, with just a century and fifty each.

In the end, the former cricketer lauded the management's decision to elect Shubman Gill as the vice-captain of the Men in Blue for the Champions Trophy 2025.

"It is a very good and positive development. The new generation who want to take captainship from Rohit Sharma, have been given leadership roles. When Shubman Gill was sent to Zimbabwe as a captain, he went to a couple of places.



The youngster has shown promise. Gill has to get his form, that's the main thing," Surinder Khanna concluded.

The freshest challenge awaiting India is the ICC Champions Trophy, starting from February 19 till March 9. It will be hosted by Pakistan and UAE, with India playing its matches in UAE under a hybrid model.

The eight-team tournament will feature 15 50-over matches and will be played across Pakistan and in Dubai. The biggest match of the tournament between two arch-rivals India and Pakistan will be played on February 23. India will start its campaign against Bangladesh on February 20. India's last league match will be against New Zealand on March 2. The Rohit Sharma-led side will play all their matches in Dubai.

Australian Open: Coco Gauff downs Belinda Bencic to storm into quarterfinals

MELBOURNE, Jan 19 (Agencies): Coco Gauff advanced to the quarterfinals of the Australian Open 2025 with her stunning win over Belinda Bencic in the fourth round fixture at the Rod Laver Arena on Sunday, January 19. Gauff made a remarkable comeback in the game after losing the first set and dominated her Swiss rival in the next two sets to seal a magnificent 5-7, 6-2, 6-1 victory.

Bencic managed to break Gauff twice in the first set and became the first player to win a set against the American in the ongoing season. However, the opening set loss seemed to have awaked the sleeping beast inside of last year's semi finalist as she came back strongly to dominate Bencic in the next two sets winning them comfortably to extend her winning streak to nine matches in the ongoing season.

Following her stunning win, Gauff acknowledged the challenge posed by Bencic in the first set. However, the 20-year-old revealed how aggressive gameplay in the second set turned

things in her favour.

"I thought in the first set she played great tennis, it was tough for me to be more on offence. Overall I'm happy with how I played, the first set could have gone my way with a few more points and I played more aggressively in the second set then reset to play my best



in the third. We worked very hard in the offseason, obviously there's still a lot for me to go to accomplish my goal," said Gauff in her on-court interview.

Furthermore, the 2023 US Open Champion recalled his father's words and mentioned that her sole focus was to be in a position to be proud of herself after leaving the court.

Badosa and Pavlyuchenkova also progress ahead

"Maybe a couple of years ago, if I lost the first set I might lose the match and I remember my dad said, 'we've got to toughen you up'. I was just trying to put myself in the position where I could leave the court and feel proud of myself," she added.

Gauff will next face-off with Spain's Paula Badosa in the quarterfinal, who beat Olga Danilović 6-1, 7-6 (7-2) at Margaret Court Arena to progress ahead in the tournament. Meanwhile, Anastasia Pavlyuchenkova also beat Donna Vekić 7-6 (7-0), 6-0 in straight sets at John Cain Arena to progress ahead in the competition.

Rishabh Pant likely to take captaincy role of Lucknow Super Giants for IPL 2025

NEW DELHI, Jan 19 (Agencies): Star India wicketkeeperbatter Rishabh Pant is likely to be named the skipper of the Sanjika Goenka-owned Lucknow Super Giants (LSG) franchise ahead of the Indian Premier League 2025 edition as reported by ESPNcricinfo.

Right-hand batter KL Rahul was not retained by the Lucknow franchise ahead of the IPL 2025 mega auction despite taking the team to the playoffs in their first two editions of the cash-rich league.

After not retaining Rahul, the LSG team had two options to select for the role between Pant and Shreyas lyer, so the franchise and management opted to go with the former.

Pant became the most expensive player in the history of the Indian Premier League (IPL), being bought by Lucknow Super Giants (LSG) for a massive Rs 27 crores during the IPL 2025 mega auction at Jeddah. The LSG franchise would be the second team in this tournament after Delhi Capitals (DC).

He beat compatriot Shreyas lyer, who had just become the most expensive player in the league's history, going to Punjab



Kings (PBKS) for Rs 26.75 crores a few minutes back. He had beat Australia's Mitchell Starc, who marked his return to IPL after years with a recordbreaking bid of Rs 24.75 crores. Initially, there was a bidding war between LSG and Royal Challengers Bengaluru (RCB),

with the latter giving up.
Sunrisers Hyderabad (SRH)
entered the bidding war, trying
to bolster their explosive batting

attack and DC tried to use the 'Right To Match' card, but they could not match the value LSG put for Pant, breaking the bank for him and going beyond lyer's value.

Pant has represented Delhi Capitals for his entire IPL career since 2016, scoring 3,284 runs in 110 matches at an average of 35.31, with a century and 18 fifties. He was appointed as the team's captain in 2021 and led

them to playoffs in the same

Ahead of the IPL 2025 mega auction, LSG retained Nicholas Pooran, Mayank Yadav and Ravi Bishnoi alongside uncapped stars Mohsin Khan and Ayush Badoni.

The Lucknow-based franchise finished their IPL 2024 voyage in the 7th place in the standings with 14 points after winning seven of 14 matches.
