Army troops open fire on pakistani drone along LoC in **Poonch**

MENDHAR/JAMMU, Jan 22 (Agencies): Army troops opened fire to bring down a Pakistani drone which entered into the Indian side from across the Line of Control (LoC) in Poonch district of Jammu and Kashmir early Wednesday, officials said.

However, the drone returned to Pakistanoccupied Kashmir (PoK) after hovering briefly over an area near the border fence in Mendhar sector, they said.

The troops picked up the movement of the drone around 1 am and fired nearly a dozen rounds.

A search operation was launched with the first light of the day on Wednesday to ensure there was no airdropping of weapons or narcotics by the drone, the officials

said. The search operation was continuing when last reports were received.

Rusted **Mortar shell** defused in Kathua

JAMMU, Jan 22 (Agencies): A rusted mortar shell was defused in a forest area in Hiranagar sector of Jammu and Kashmir's Kathua district on Wednesday, officials said.

The mortar shell was noticed by a shepherd, who had gone to Mayan Kannah forest to graze his sheep this morning, the officials said.

They said Shawar informed the local police following which a bomb disposal squad was rushed to the scene and the mortar shell was defused.

Army soldier killed in accidental fire in Kupwara

SRINAGAR, Jan 22 (Agencies): An army soldier was killed in an accidental discharge of fire in the Kalaroos area of north Kashmir's Kupwara district on Wednes-

Official sources told news agency JKNS that army personnel died after his service rifle went off accidentally, resulting in grievous injuries to him.

He was immediately rushed to the hospital for treatment where doctors on duty declared him brought dead on arrival. Meanwhile, police have registered a case in this

"Common factor in all deaths is involvement of the brain, damage to nervous system": Principal of GMC Rajouri on 'Mysterious Illness'

RAJOURI, Jan 22 (Agencies): A mysterious illness has struck the Rajouri district in Jammu and Kashmir, resulting in 17 deaths. Medical authorities have rushed to the area to investigate the cause of the illness. According to Dr Amarjeet Singh Bhatia, Principal of Government Medical College Rajouri, a common factor among the deaths is the involve-

He also emphasised the recovery rate of the people affected by this

'unidentified disease.' "Out of 9 patients that were admitted to GMC Rajouri, 5 recovered. We have conducted preventive CT scans also, but recovery becomes tough once the brain gets involved," Bhatia said.

"We are hoping to find the cause (behind the illness) soon. We will educate the people and raise awareness among them like not to exchange foods," he added.

Mysterious Deaths | J&K's Rajouri village declared containment zone

JAMMU, Jan 22 (Agencies): Unable to reach a conclusive finding as to what caused 17 mysterious deaths in Jammu and Kashmir's Rajouri district, authorities on Wednesday declared the Budhaal village as a containment zone under section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS).

District Magistrate of Rajouri has declared Badhaal a containment zone following recent health concerns in the area. Acting under Section 163 of the BNSS Act (previously Section 144 of the CrPC), strict measures have been implemented to ensure public safety and prevent the spread of any potential issues.

As part of the containment plan, Houses of affected families have been sealed. The entire area has been divided into three zones for efficient management. All public and private gatherings have been prohibited.

To ensure the wellbeing of the residents, designated officers and officials have been tasked with monitoring the preparation and distribution of meals provided to families within the containment zones.

The administration has assured residents that further details and updates will follow as the situation develops.

At least 17 locals, including 11 children. have died since December 8, 2024, in Budhaal village of Kotranka subdivision in Rajouri district. The last death was reported on January 17.

The people have lost lives because of a mysterious disease, claim the locals. Samples analysed at various premier laboratories of the country have returned negative results for viral or bacterial infection

EDITORIAL

LEARNING FROM BADHAAL

he recent health crisis in Badhaal Rajouri, Jammu and Kashmir, has left the nation in shock and underscores the vulnerabilities in India's public health system. Over the past month, the region has witnessed 17 mysterious deaths and several children falling gravely ill. Despite efforts by medical teams and government authorities, the root cause of this crisis remains elusive. This incident is a stark reminder of the need to strengthen our healthcare infrastructure, enhance rapid response mechanisms, and build public trust in times of health emergencies.

The crisis began with reports of children and adults experiencing severe symptoms, leading to sudden deaths. Despite the intervention of central medical teams, local healthcare systems have struggled to diagnose the illness. Families have reported cases of individuals being referred to hospitals in Jammu, only to return as fatalities. This has led to growing panic, with some residents choosing to migrate to safer areas.

Adding to the distress is the slow pace of government action. The affected families are demanding answers, compensation, and immediate medical relief. The crisis has exposed glaring gaps in the healthcare system, including inadequate diagnostic facilities, insufficient communication between health agencies, and a lack of preparedness for public health emergencies.

The time taken to deploy expert medical teams and establish a coordinated response has amplified the crisis. A streamlined mechanism for rapid deployment of resources and specialists is critical to contain the spread of illnesses and reassure the public.

Public mistrust has grown as families witness repeated failures to diagnose or treat the illness. The lack of clear communication from health authorities has fueled rumors and panic, further destabilizing the region.

The fear of falling victim to the illness has led many families to migrate, disrupting lives and livelihoods. Such migrations often exacerbate socioeconomic inequalities, as displaced individuals struggle to find stability in new locations.

The Badhaal Rajouri incident is not an isolated event. Similar public health crises have occurred globally, from the Ebola outbreak in West Africa to India's own struggles with the Nipah virus. These events highlight the importance of proactive measures, robust healthcare systems, and public awareness.

Rural areas must be equipped with modern diagnostic tools, well-trained medical staff, and efficient referral systems. Mobile health units and telemedicine can bridge the gap between rural populations and specialized healthcare services.

The government must invest in the creation of multidisciplinary rapid response teams that can be deployed immediately in the event of a health crisis. These teams should include epidemiologists, virologists, toxicologists, and public health experts.

Misinformation and fear often worsen health crises. Transparent communication from health authorities, coupled with awareness campaigns, can help dispel rumors and provide communities with actionable information.

Mystery illnesses often emerge due to new pathogens, environmental toxins, or zoonotic diseases. A robust surveillance system, combined with increased investment in medical research, can help detect potential threats early and prevent their spread.

Health crises require a collaborative approach involving multiple stakeholders, including government agencies, healthcare providers, NGOs, and international organizations. Coordinated efforts can ensure a more comprehensive and effective response.

Policy interventions play a pivotal role in preventing and managing public health crises. The government must prioritize health spending, particularly in underserved regions. Initiatives like the Ayushman Bharat scheme have made healthcare more accessible, but more targeted programs are needed to address the unique challenges of rural areas.

Additionally, policymakers must consider enacting laws that mandate the timely investigation of unexplained deaths and illnesses. These investigations should involve expert panels and provide clear timelines for reporting findings.

The tragedy in Badhaal Rajouri is a wake-up call for India's public health system. It highlights the urgent need for a multi-pronged approach to prevent and manage health crises, particularly in rural and remote areas. Strengthening healthcare infrastructure, enhancing diagnostic capabilities, and fostering community trust are essential steps in this direction.

As the nation mourns the lives lost in Rajouri, it is imperative to turn this crisis into an opportunity for systemic change. By learning from this incident and implementing the necessary reforms, India can build a more resilient and equitable healthcare system, ensuring that no community is left vulnerable in the face of future health challenges.

Nail Care in Winters

o you have dry, cracked, splitting brittle fingernails during the winter months?

It's not just your skin that dries out during the winter months; your nails do too! As soon as there's even a hint of chill in the air, your nails start to chip and flake.

If you are experiencing slow nail growth, brittle nails, nail breakage, nail splitting, and other nail problems nowadays, winter is to blame here as well. People often take special care of their hair and skin during chilling weather, but forget to take care of their nails.

Nails are part of the integumentary system (skin) of your body and they develop from the outer layer of your skin called the epidermis. The exact same cells that form the outer layer of your skin also form your nails. These cells harden more in your nails, but structurally they share many common features and needs.

Natural oils hold together the different layers of your nails, so cold and dry winter months and lots of hand washing with harsh soaps will dry out this natural "glue." It's very similar to the dry skin you experience during the winter months.

The same concept to fix dry skin can be used for dry nails, but different formulations are recommended because of the unique structural properties of your nails.

Here are easy winter nail care tricks to make sure your nails stay long and strong.

One easy way to counteract cold weather? With a nice warm pair of gloves

Protect your nails by wearing a nice warm pair of rubber gloves for your washing chores. This is when you are gardening, house cleaning, washing dishes, or using harsh chemicals.

When you wear gloves, you protect your nails from getting dry and at the same time, keep dirt out of your nails. Massage a cream, oils, or ointments to damp nails and the skin around the nails after washing chores.

Doing so can protect your nails from breakage and help locking in moisture to help preserve the cuticle seal and strengthen the nail itself.

For dry hands and nails, massage almond oil on the hands and around the nails too, in order to soften the cuticles. The cuticle (skin surrounding the nail) should be kept soft and smooth. Otherwise, it sticks to the nail and gets dragged as the nail grows. This causes the skin to get stretched and torn. The skin can even become infected if this happens. Daily massage is even more important during the dry winter season.

For moisturizing your nail, take 1 tablespoon of almond and castor oil, and mix a little hand cream in it. Massage the mixture into your hands. Follow up with moisturizer and treat yourself to a weekly hand at-home treatment mask.

Never cut, push back, or try to get rid of cuticles altogether. In fact, the cuticle is the nail's natural protective seal. Moisturizing the cuticles with cream or oil helps protect and strengthen your nails helping stimulate nail growth, and bringing blood and nutrients to maintain healthy nails.

Cuticle oils will penetrate into the deeper layers of the skin and hydrate the cuticle, skin, and nail area, and help in preventing breakage of the nails.

Once a week soak the nails in lukewarm water for a few minutes and afterwards apply the cream to the nails. Massage them, so that it helps to soften the skin and lock in the moisture by wearing cotton gloves for at least an hour. Then push the cuticles back gently using a cotton bud. Never use sharp instruments to clean under the nails.

For strong and healthy nails, include adequate protein and calcium in your diet. Take skimmed milk, yoghurt, cottage cheese (paneer), fish eggs and sprouts. Follow a ten-day programme of taking gelatin. Dissolve one teaspoon of gelatin in a little boiling water. Cool the water and add it to fruit juice. Have this daily for ten days.

A weekly manicure keeps nails in good condition. For a home manicure, first, remove old nail varnish. To cut nails, use a nail clipper. Then shape them with an emery board. File in one direction only. Soak the hands in lukewarm water for 5 min-

utes after adding a few drops of shampoo. Use a soft brush to clean your nails.

If you have nails which break easily, avoid frosted nail polish. If there is any infection or pain, avoid filing the nails and using nail polish. Get medical attention first. Fungal infection of the nails is quite common.

Sometimes, the nails acquire a yellowish tinge, due to wearing nail polish constantly. Sun exposure and some pastel colours can leave a yellowish tinge.

For protection, use clear, transparent nail polish as a top coat. UV-resistant top coats are also available. To protect the nails apply a transparent base coat first and then apply the colour of your choice.

To get rid of the yellowish tint on the nails, scrape the surface of the nail with the finest-grain side of an emery board so that the nail is not damaged. Then apply UV-resistant or clear polish for protection. The nails can also be "buffed" or rubbed with a piece of chamois leather.

According to the actress, after a busy day at a studio in Andheri East, she returned home to her ecstatic dog, Lily, and proceeded with her nightly routine.

"My very last task before I could surrender to sleep was to take my blood pressure medication," Zeenat wrote.

However, things took an unexpected turn when the pill got stuck in her throat. "I popped the pill into my mouth, took a sip of water, and then felt my breath catch. There it was, this little pill lodged in my throat. Too far down to regurgitate and too far up to swallow."

As panic began to set in,



Zeenat was left alone at home with only her pets for company. Despite multiple attempts to drink more water, the pill remained stuck.

"There was nobody at home with me other than the dog and the five cats, and panic began to set in," she shared.

In a desperate attempt to get help, she made frantic calls to her son, Zahaan, who abandoned his plans to rush to her

Once Zahaan arrived, they managed to reach the doctor, who reassured them that the pill would eventually dissolve. "We finally got through to the doctor who said it would dissolve in time, and I spent the next few hours sipping warm water and waiting," Zeenat recalled.

The experience left her reflecting on the importance of patience in difficult situations.

"I woke up this morning feeling a little sheepish about the ordeal. But having been through it, I feel the need to contrive a metaphor from the experience," she wrote.

And the opening line goes: "Aaj khush toh bohot honge tum."

"I do remember the premiere of 'Deewaar' and there was actually a snigger and a gentle laughter in the audience. That was so unexpected and they thought it was some kind of a joke. But within a couple of seconds after that, they just froze," Bachchan said.

For many years, the screenplay of "Deewaar" was taught as the perfect screenplay at Pune's Film and Television Institute of India.

In 1976. Salim-Javed won all Filmfare Awards in the writing categories - best story, best dialogue and best screenplay — for "Deewaar".

Josh Gad reveals why he was denied a role in 'Avatar'

And "one of the first things" he tried out for was a "new James Cameron movie called 'Avatar'," reports vari-

"I put myself on tape and shortly thereafter got a call that Cameron wanted to fly me to Los Angeles for a final callback at his Lightstorm production offices," he said.

If cast, Gad would've essayed "the role of Jake Sully's (Sam



Worthington) best friend and translator to the alien race known as the Na'vi."

Revealing the reason as to why he did not get the movie, Gad said: "I apparently did not get (the role) because, while James Cameron was said to be thrilled with my audition, when I was turned into a digital Avatar I supposedly looked like a tall, overweight Smurf."

The role appeared to be scooped up by Joel David Moore, who plays Norm Spellman in "Avatar," a close confidant to Jake Sully and an expert on the Na'vi language.

"Avatar" was first released in December 2009. It became the highest-grossing film of all time, raking in \$2.9 billion worldwide to date.

The sequel, "Avatar: The Way of Water," currently sits in third place with a lifetime gross of \$2.3 billion. At the 2024 D23 Expo, Cameron revealed the title of the third "Avatar" film: "Avatar: Fire and Ash," which is set to release on December 19, 2025.

The movie, which is based on the life of prominent Sikh human rights activist Jaswant Singh Khalra, was proposed to be named as "Ghalughara" initially, which means massacre, but after the objection of the Censor Board the movie title was renamed to "Punjab 95" with



120 scene cuts.

Sikh religious body, Shiromani Gurdwara Parbandhak Committee (SGPC), intervened, and the Censor Board relented with the cuts but asked the title to still be changed. According to reports, the film's trailer was launched on YouTube the same year but was removed a day later.

Uttar Pradesh Cabinet meets in Kumbh Mela area, approves key projects, policies



MAHAKUMBH NAGAR, Jan 22 (Agencies): The Uttar Pradesh Cabinet met in the Maha Kumbh Mela area on Wednesday following which Chief Minister Yogi Adityanath announced several key decisions on development projects and policy changes aimed at boosting the state's growth.

Addressing the media, the CM highlighted the wide range of topics discussed at the meeting, including the development of Uttar Pradesh, policy matters, and specific issues related to Prayagraj.

One of the major announcements was related to the state's aerospace and defense policies. The CM said the aerospace and defense policy, initially implemented in 2018, has completed five years and will now be revamped.

"The revised policy will include new incentives to attract large investments into the sector," Adityanath announced.

The cabinet also discussed the distribution of incentives under the Foreign Direct Investment (FDI) and Fortune 500 investments made in Uttar Pradesh.

"New investment proposals were presented, and Letters of Intent (LOIs) will be issued. Among the key investments, a Rs 10,000 crore investment in Mirzapur and additional proposals in Moradabad were discussed. There are two more such projects," he said.

Additionally, the CM shared details of a scheme to provide smartphones and tablets to youths in the state. The government has allocated funds for this programme and it is expected to roll out in the coming months, he said.

After the cabinet meeting held at the Triveni complex located in Arail of Mahakumbh Nagar, the CM said the construction of two new bridges in Prayagraj was approved at the cabinet meeting.

Another important decision was the establishment of a medical college in Balrampur, which will be named after former prime minister Atal Bihari Vajpayee. The KGMU Lucknow's Satellite Center in Balrampur will be converted into a medical college, and it is set to begin operations in the next academic session, he said.

The cabinet also approved the construction of three new medical colleges in Baghpat, Hathras and Kasganj districts under the Public-Private Partnership (PPP) model.

In collaboration with Tata Technologies, the state government has also decided to establish 62 Industrial Training Institutes (ITIs) and five Centers of Innovation, Invention, Incubation, and Training.

This initiative aims to

provide modern education and skill development to the youth of Uttar Pradesh through a hub-and-spoke model. "Furthermore, the Cabinet approved the establishment of a Directorate of Prosecution in the state." the CM announced.

The chief minister also spoke about the issuance of bonds by municipal corporations of Prayagraj, Varanasi, and Agra.

"This follows the successful issuance of bonds for Lucknow and Ghaziabad, which had yielded positive results. The issuance of bonds is seen as a way to brand these municipalities and boost their development," he said.

Highlighting the importance of Prayagraj, the CM spoke about the city's global significance. He praised the record number of pilgrims who visited the Sangam for the holy bath, with over 9.25 crore devotees participating in the event.

He also said the Prayagraj Municipal Corporation will issue bonds to fund the construction of a superspecialty hospital.

In addition to this, bonds will also be issued for Agra to address its specific needs, and for Varanasi, with particular focus on the Kashi Vishwanath Dham, inspired by Prime Minister Narendra Modi's vision for the city, he said.

Cabinet approves continuation of National Health Mission for another 5 years

NEW DELHI, Jan 22 (Agencies): The Union Cabinet on Wednesday approved continuation of the National Health Mission for another five years. Briefing reporters about

the decisions taken at the Cabinet meeting, Union minister Piyush Goyal said the Mission has met historic targets in the last 10 years. Goyal pointed out that nearly 12 lakh health-

care workers joined the National Health Mission (NHM) between 2021 and 2022 and India fought the COVID-19 pandemic under the Mission.

Kejriwal unveils 7-point 'manifesto' for middle class, says they are victim of 'tax terrorism'

NEW DELHI, Jan 22 (Agencies): Anational convenor Arvind Kejriwal on Wednesday announced a seven-point "manifesto" for the country's middle class, saying they have been neglected by successive governments and are a victim of "tax terrorism".

In a video message on Wednesday, he said the middle class is the real superpower of the Indian economy but has long been ignored and exploited solely for tax collection.

Kejriwal announced the seven-point charter aimed at addressing the concerns of the

The demands included raising the education budget from the current 2 percent to 10 percent and capping private school fees. He also proposed subsidies and scholarships for higher education to make quality education

The A chief stressed the need for an increase in healthcare spending, suggesting a rise to 10 percent of the GDP, along with the removal of taxes on health insurance

Kejriwal also called for an increase in the income tax exemption limit from 7 lakh to 10 lakh, citing the heavy financial burden on the middle class.

Another demand was the removal of GST on essential goods, which Kejriwal argued disproportionately affects middle class households. He also advocated for more robust retirement plans, including free healthcare for senior citizens in both private and government hospitals.

Additionally, he urged the central government to reinstate the 50 percent concession on train fares for senior citizens, which was discontinued in recent years.

Kejriwal criticised political parties for reduc ing the middle class to what he described as a "slave mindset" since independence. He



pledged that A MPs would raise the voice of the middle class in upcoming parliamentary sessions, vowing to make their issues a central focus of the political discourse

The announcement comes just weeks before the Delhi Assembly elections scheduled for February 5, with results to be declared on February 8.

The Aam Aadmi Party, which won 62 of the 70 assembly seats in 2020, is seeking a third consecutive term.

13 people killed in 2 road accidents in Karnataka

BENGALURU, Jan 22 (Agencies): Thirteen people were killed and 19 injured in two early-morning road accidents in Karnataka on Wednesday.

A truck carrying fruit vendors, fell into a 50-metre-deep valley in a forest area of Savanur-Hubballi Road killing nine people and injuring nine others, police

The victims were transporting fruit to a local fair being organised in a place called Yellapura.

The driver of the truck swerved to the extreme left in a bid to allow a vehicle that was trying to overtake it around 5.30 am, Uttara Kannada Superintendent of Police M Narayana told agency.

"As the road in the section doesn't have barrier walls on the edge, the truck fell into the valley.

The injured have been shifted to KIMS Hospital in Hubballi," the officer said.

In the second accident, four people, including three students, were killed and 10 others injured when the vehicle they were travelling in overturned near Araginamara Camp in Sindhanur, Rai-

The students of Mantralaya Sanskrit Pathashala were on a pilgrimage to Hampi to offer prayers at Narahari

The deceased students have been identified as Aryavandan (18), Sucheendra (22) and Abhilash (20). Driver Shiva (24) also died in the accident. The 10 injured have been admitted to a local hospital.

Sindhanur Traffic Police Station registered a case.

5 men sentenced to death for rape-murder of Chhattisgarh girl Children from Sexual Offences KORBA, Jan 22 (Agencies): (POCSO) Act and sentenced

A fast-track court in Korba district of Chhattisgarh has sentenced five men to death for gang-raping and killing a 16-year-old girl and murdering her two family members in 2021.

The Fast Track Special Court (FTSC) sentenced another accused to life imprisonment.

Additional sessions judge Mamta Bhojwani convicted Santram Majhwar (49), Abdul Jabbar (34), Anil Sarthi (24), Pardeshi Ram (39) and Anand Panika (29) under Sections 302 (murder), 376 (2) G (gangrape) and other sections of the IPC, the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act and Protection of them to death, said special public prosecutor Sunil Mishra on Wednesday.

The court sentenced another accused. Umashanakar Yadav (26), to life imprisonment, he said.

While delivering the judgement on January 15, the court said this inhuman and cruel act of the accused is extremely perverted, heinous, brutal and cowardly, he said.

The copy of the order was made available on Monday.

On January 29, 2021, the teenage girl was allegedly raped and bludgeoned with stones before she was dumped

in a forest leading to her death near Gadhuproda village under Lemru police station area of Korba district.

The accused also killed the girl's father, aged around 60, and his four-year-old granddaughter who were with her.

The incident came to light a few days later when the deceased man's son lodged a missing person report at Lemru police station, following which the cops swung into action and rounded up six accused following their interrogation.

Mishra said that the police found in their investigation that the main accused, Manjhwar, who had employed the victim's family as his cattle grazer, was pressing the girl to become his second wife.

When she and her family opposed this, Manjhwar and his five associates raped and killed her and also murdered her two family members.

The victims belonged to the Pahadi Korwa tribal community, a Particularly Vulnerable Tribal Group (PVTG).

The court has said in its judgment that this inhuman and cruel act of the accused is extremely perverted, heinous, brutal and cowardly, because they have killed three innocent and weak people to satisfy their lust. This has shocked the collective conscience of the entire society, the lawyer said.

24-year-old NEET aspirant dies by suicide in Kota, fifth case in three weeks

JAIPUR, Jan 22 (Agencies): A 24-yearold student from Gujarat, preparing for NEET, allegedly died by suicide in Rajasthan's Kota on Wednesday.

This is the fifth such incident this year that has been reported from Kota, a coaching hub for National Eligibility Cum Entrance Test (NEET) and Joint Entrance Examination (JEE) aspirants.

The incident came to light at 9 am when she failed to respond or open the door, police officials said. After the door was forced open, the authorities found the girl's body hanging from a ceiling fan in her hostel

Further investigation will be done once the student's family reaches

Kota, the police added. The police noted that no suicide note was left in the room.

This incident comes barely a week after an 18-year-old NEET aspirant, a resident of Odisha, died by suicide on January 17.

However, this was not the only case of suicide that was reported from

Kota last week. On January 16, a JEE aspirant, hailing from Odisha, was found hanging in his room.

In two separate incidents, two students preparing for JEE died by suicide in their hostel rooms two weeks back. One belonged to Madhya Pradesh while the other hailed from Haryana.

Two Maoists, including area commander, killed in Jharkhand's Bokaro

RANCHI, Jan 22 (Agencies): Two Maoists were killed in a gunfight with security forces during an anti-Naxal operation in Jharkand's Bokaro district on Wednesday morning. Among those killed in the encounter are area commander Shanti from Chatro village in Giridih district and Manoj from Dhavatar village of the same district. According to the information received so far. Shanti is the wife of hardcore Maoist Ranvijay Mahato, who is wanted by the police, with a reward of Rs 15 lakh. Ranvijay Mahato was arrested from Bermo on Tuesday. During

the search, AK-47 rifles and INSAS were recovered from the Maoists.

The incident took place in the Penk Narayanpur police station area near the jungles of Banshi Jarwa.

The operation, led by Jharkhand Police in coordination with 209 CoBRA Battalion, was backed by accurate intelligence inputs from the Intelligence Bureau and local authorities that six hardcore Maoists were hiding in the Banshi Jirwa forests. As soon as the joint team of security personnel reached there, the Maoists started firing on them. Responding to that, the security

forces also fired back in retaliation leading to heavy firing from both sides. Two policemen are reported to be injured in this encounter. The security personnel have cornered the Maoists from all sides and combing operation is on to locate the Maoists. This strategic effort also resulted in the recovery of a significant cache of weapons, including an AK-47 and two INSAS rifles.

Authorities are currently analyzing the seized firearms and working to gather further intelligence to strengthen their ongoing efforts against Maoist activity in the region.

US: Donald Trump calls Bishop Budde "nasty" after her mercy plea during inaugural prayer service

WASHINGTON DC, Jan 22 (Agencies): US President Donald Trump on Wednesday slammed the Bishop who during her sermon for the inaugural prayer service urged him to have "mercy" on people in the US who she said are "scared now." Calling Bishop Mariann Edgar Budde "nasty and "Radical Left hard line Trump hater," Trump said that her sermon was "very boring and uninspiring" and added that she and her church "owe the public an apology."

In a post shared on his social media platform Truth Social, Trump said that Bishop Budde failed to speak about the large number of illegal migrants that entered the US and killed people.

"The so-called Bishop who spoke at the National Prayer Service on Tuesday morning was a Radical Left hard line Trump hater. She brought her church into the World of politics in a very ungracious way. She was nasty in tone, and not compelling or smart," Trump posted on Truth Social.

He added, "She failed to mention the large number of illegal migrants that came into our Country and killed people.



Many were deposited from jails and mental institutions. It is a giant crime wave that is taking place in the USA. Apart from her inappropriate statements, the service was a very boring and uninspiring one. She is not very good at her job! She and her church owe the public an apology!"

Bishop Mariann Edgar Budde, the leader of the Episcopal Diocese of Washington, during her sermon for the inaugural service on Tuesday, looked directly at Trump and urged him to have mercy as the "vast majority of immigrants are not criminals," The New York Times reported.

She said, "I ask you to have

Bishop Budde said, "The vast majority of immigrants are not criminals." It was the direct appeal to Trump at the start of the first

full day of his presidency. Her remarks came 24 hours after Trump returned back to the White House and issued several executive orders focused on transgender rights and immigration.

Donald Trump, who sat in the first row of pews in the towering Washington National Cathedral, looked down and away. US Vice President JD Vance raised his eyebrows and looked several times at his wife, Usha Vance, who kept looking at the Bishop, The New York Times reported.

When Bishop Budde finished, Trump said something to Vance, who shook his head. Members of the Trump family seemed to look at one another and they were noticeably disturbed. Donald Trump's son, Eric Trump, shook his head, as per the report.

When asked on what he thought of the service, Trump responded, "I didn't think it was a good service, no."

Bishop Budde is not the only prominent clergy member to express concern over Trump's stance on immigration. Earlier on Sunday, Pope Francis termed Trump's plans for mass deportations "a disgrace."

"Prime Minister Narendra Modi is Boss Sahab," says Fijian PM Sitiveni Ligamamada Rabuka



SUVA, Jan 22 (Agencies): Prime Minister of the Republic of Fiji, Sitiveni Ligamamada Rabuka, has termed Prime Minister Narendra Modi as the real "Boss" of the world.

In a meeting with Member of Parliament (Rajya Sabha) and Indian Minorities Federation (IMF) Convener Satnam Singh Sandhu and IMF Founder Prof. Himani Sood in Fiji, Rebuka said PM Modi is a top global leader.

Praising PM Modi's mantra of 'Sabka Saath Sabka Vikas' for ensuring everybody develops and prospers together, the Prime Minister of Fiji said, "I believe Sabka Saath Sabka Vikas is a great governance model that PM Modi is practising, which ensures inclusive development for all. I think the world should adopt it for making it a better place to live".

"My friend (PM Modi) had been reelected (as PM) after we met (in 2023), so congratulations again and I would like to make sure that he gets the message that Fiji is still here. We are still committed to our journey of peace, on which he has been on that journey for long. Oneness' in our development, oneness in our progress and all these are great ideals for all world leaders," Fiji PM added.

The Fijian PM said PM Modi has become an icon for peace and Hindus all over the world. "Having the confidence of those in India is a big number. So, I congratulate him for that. The oneness in that journey of Hindus in the world will eventually translate into oneness in the peoples of the world," he said.

Prime Minister Narendra Modi had met Rabuka in May 2023 in Port Moresby during his visit to Papua New Guinea on the sidelines of the third Forum of India-Pacific Islands Cooperation (FIPIC) Summit.

On behalf of the Fijian President, Ratu Wiliame Maivalili Katonivere, Prime Minister Rabuka had then bestowed Prime Minister Modi with the highest civilian honour of the Republic of Fiji-the Companion of the Order of Fiji (CF).

This is not the first time that any world leader has praised the leadership of Prime Minister Narendra Modi. Earlier in 2023, Prime Minister of Australia Anthony Albanese had called him (Modi) Boss. The former President of the US, Joe Biden, had described PM Modi as a fantastic and globally powerful leader and expressed a desire to take his autograph.

The Prime Minister of Italy Giorgia Meloni also described PM Modi as the most loved of all around the world. The Prime Minister of Denmark Mette Frederiksen had said that PM Modi is an inspiration for the world and the President of Guyana said that they owe him a debt of gratitude.

Top Hezbollah commander Sheikh Hamadi shot dead in front of house in Lebanon

BEIRUT, Jan 22 (Agencies): Senior Hezbollah commander Sheikh Muhammad Ali Hammadi, who was on FBI's most-wanted list, was shot dead in front of his house in eastern Lebanon, according to reports.

Hammadi died on the spot on Tuesday night as unidentified assailants opened fire and shot the senior Hezbollah official six times.

Ruling out any political angle, local reports claim that Hammadi was killed over a years-long family feud.

Hammadi came under FBI's radar after he had hijacked a West German plane in 1985, carrying



153 passengers. He was reportedly involved in the torturing and killing of an American national on the flight.

The incident comes amid the ongoing cease-fire deal between Israel and Lebanon. In 2023, Hezbollah had joined Hamas' war against Israel.

sraei. Last year, Israel infiltrated Hezbollah's supply chain, causing several walkie-talkies and pagers to explode across Syria and Israel. Upping the ante, Israel eliminated at least seven top-ranked Hezollah commanders, including Hassan Nasrallah, and invaded southern Lebanon in the weeks leading to the ceasefire deal.

Rare winter snowstorm paralyses US, 10 dead, over 2,100 flights cancelled

FLORIDA, Jan 22 (Agencies): Many southern states in US are witnessing a "rare winter storm" that has left at least 10 dead. Record snowfall in several areas in the region has led to the closure of schools and government offices.

Many places on the southern coast, including New Orleans, Louisiana, Alabama, and Pensacola in Florida, have received record snowfall.

Earlier, the National Weather Service (NWS), a US government agency, warned that a "rare winter storm" will bring "heavy snow, sleet, and freezing rain to the Gulf Coast and Southeast, with widespread travel impacts expected."

Several states, including Mississippi, Alabama, Florida, Georgia and Louisiana, had declared emergency after the NWS alert.



With roads shut and over 2100 flights cancelled, life has come to a standstill in the southern US stretching from South Texas to Jacksonville in Florida.

NWS has stated that it will take days, even after the snowfall stops, before roads are open and flight operations resume.

"The Arctic Air Mass will create

widespread sub-freezing overnight lows along the Gulf Coast and throughout the Southeast. The cold weather will exacerbate power outages," the NWS added.

Saying that the affected places will slowly return to their normal temperatures by the end of the week, the NWS stated, "Dan-

gerously cold temperatures and wind chill values will linger for much of the South and eastern US."

Louisiana received its first ever blizzard warning. A blizzard warning means that a region is expected to receive heavy snowfall and strong winds up to 60 kmph, reducing general visibility below 500 meters.

30 million people in Virginia were under a snowstorm warning. By Tuesday night, many areas in Louisiana received up to 10 inches of snow, while a few places in Mississippi and Alabama received more than 4 inches of snow.

A vehicle crashing on a highway in Texas led to the death of five people, according to reports. Two storm related deaths have also been reported in Alabama. In Georgia, one person purportedly died of hypothermia.

Qatar announces successful facilitation of detainee swap between US, Afghanistan

DOHA, Jan 22 (Agencies): The State of Qatar announced the successful facilitation of a detainee swap between the United States of America and Afghanistan.

In a statement to Qatar News Agency, Qatari Minister of State at the Ministry of Foreign Affairs, Dr Mohammed bin Abdulaziz bin Saleh Al Khulaifi, stated that the good offices of the State of Qatar have resulted in the release of two American citizens who had been detained in Afghanistan, in exchange for the release of an Afghan citizen detained in the United States of America, stressing that all of them arrived in Doha, and the necessary arrangements were made in preparation for their return to their respective countries.

He expressed Qatar's gratitude to both the Afghan Caretaker Government and the Government of the United States of America for their positive response to the State of Qatar's efforts and their cooperation in facilitating the detainee swap process. He

expressed the State of Qatar's hope that this agreement would pave the way for achieving further understanding as a means to resolve disputes through peaceful means.

The Minister of State for Foreign Affairs pointed out that Qatar's foreign policy is based on constructive dialogue as a strategic option to bring viewpoints closer, pointing in this regard to the successes of Qatari diplomacy in a number of important files, emphasizing Qatar's pivotal role in the field of

mediation, including humanitarian efforts and the reunification of families.

He also pointed out that the State of Qatar has emerged as an effective party in providing innovative diplomatic and humanitarian solutions aimed at addressing crises, and its continuous efforts have been able to alleviate the suffering of those affected, the latest of which is its efforts with partners to reach a ceasefire deal in the Gaza Strip and the swap of detainees and prisoners there.

Turkiye: Nine detained in connection with ski resort fire that killed 76



ISTANBUL, Jan 22 (Agencies): Turkiye has detained nine individuals in connection with a deadly fire at a ski resort hotel that claimed the lives of 76 people, as reported by Al Jazeera on Wednesday.

According to Al Jazeera, the arrests, confirmed by Turkiye's Interior Minister Ali Yerlikaya, include the hotel's owner, as concerns over the building's safety measures continue to grow.

Six prosecutors have been appointed to investigate the incident, which is believed to have originated in the restaurant area of the 12-story Grand Kartal Hotel, located at the Kartalkaya ski resort in the Bolu Mountains.

The Turkish government is facing mounting criticism as witnesses and reports indicate that the hotel's fire detection system failed to activate during the blaze, with survivors among the 238 registered guests saying no fire alarms went off and they had to navigate the smokefilled corridors in total darkness, as reported by Al Jazeera.

Guests described scenes of panic, with some jumping from windows to escape.

dows to escape.

Minister Yerlikaya
shared that 45 victims' bodies had been
returned to their families, while DNA testing

is underway to identify the rest.

"Our hearts are broken. We are in mourning," the minister told reporters outside the hotel, as quoted by Al Jazeera. "But you should know that whoever is responsible for causing this pain will not escape justice."

The hotel expressed

its condolences and vowed full cooperation with authorities.

"We are cooperating with authorities to shed light on all aspects of this incident," it said in a statement as quoted by Al Jazeera. "We are deeply saddened by the losses and want you to know that we share this pain with all our hearts."

Turkiye's President Recep Tayyip Erdogan declared a national day of mourning on Wednesday following the incident.

The incident occurred during the peak winter tourism season at Kartalkaya, a popular ski destination located about 295 km east of Istanbul.

Bangladesh Airport on high alert after bomb threat

Airport Executive Director Group Captain Kamrul Islam confirmed the matter to reporters. He said that flight BG-356 was threatened with bomb attack on its way from Rome to Dhaka.

This positive step has been appreciated and has expected that the pending 2% House Rent Allowances (HRA) also will be released shortly. The members have discussed the pressing concerns of government employees in Jammu & Kashmir. The committee raised serious concerns and demanded immediate action from the government on the

following issues: Khan, Chairman J&K EJCC, has strongly urged the government to immediately release the pending General



Provident Fund (GPF) of employees. The GPF is a crucial savings tool that is maintained in the public account and cannot be utilized for other development purposes. The delay of over six months in the disbursement of these funds has caused significant hardship to employees, who rely on these savings for emergencies, medical needs, or important family events such as weddings. The nonrelease of these funds is causing severe anxiety among employees and disrupting their financial planning. The non disbursement of the GP fund raises serious concerns and puts spotlight on the government's financial management practice. The situation has raised question about the whereabouts of the fund, which are supposed to be securely held in the Public Account for the benefit of the employees. Khan also demanded

for Release of Gratuity and Post-Retirement Benefits for Retired Employees, raisedthe issue of delayed payments to retired employees. There are pending bills in the treasury for

cerning the disbursement of gratuity and post-retirement benefits. Retired employees, who have given decades of service to the government, are now facing considerable hardships due to the non-release of these payments. The committee has urged the government to expedite the disbursement process to alleviate the difficulties faced by these retired employees.

While addressing the gatheringJ&K EJCC has demanded the regularization of all temporary employees, including FP shop dealers, Anganwadi workers, Hamals, casual laborers, Aayas, contingent paid workers in the education department, needbased workers, and employees engaged in various centrally sponsored schemes. These employees have been serving the government for many years, often on minimal wages. Despite their invaluable contribution, they remain in a precarious employment situation. The committee has called for their regularization and, until the process is completed, has urged the them under the Minimum Guarantee Wages Act. and the wages under this act needs to be enhanced up to Rs. 20000.00 monthly keeping in view the day to day inflation. They also demand-

ed for Restoration of SRO-43 Rules in its original provisions. The committee has expressed its strong opposition to the recent amendments to SRO-43, a rule that had been in place since its inception. The changes made to this rule are deemed unacceptable and harsh, particularly as it impacts the empowerment of the families of deceased employees, who rely on compassionate appointments as their only source of livelihood. The JCC has urged the government to restore the original provisions of SRO-43.

Sr Spokesperson of J&K EJCC raised the issue and demanded for Abolition of the New Pension Scheme and Restoration of the Old Pension Scheme. The J&K EJCC has called for the immediate abolition of the New Pension Scheme (NPS) and the restorascheme. The NPS has raised concerns among employees who are now demanding the return of the old pension system, which provided a more secure and predictable future for them after retirement.

General Secretary of J&K EJCC demanded for Policy for Regularization of Sessional Teachers. He demanded that a policy be framed for the permanent regularization of sessional teachers. Additionally, it has been observed that during winter vacations, teachers are often engaged in various official duties such as online classes, census work, awareness campaigns, training, surveys, and BLO tasks. The JCC has urged that their leave salary be released, comparable to other government employees who perform such duties.

J&K EJCC also demanded for release of border allowance for employees working in border areas, recognizing the unique challenges and risks they face in providing essential services in these regions.

The J&K EJCC emphasizes that these issues are of urgent importance and must be addressed promptly to ensure the well-being and financial stability of both current and retired employees. The committee has called on the government to take immediate action and fulfill these demands at the earliest.

Cricket is set to make its return to the Olympic Games in the 2028 Los Angeles edition. This marks the sport's re-entry into the Olympics after a hiatus of 128 years. Cricket last featured in the 1900 Paris Olympics, where Great Britain won the gold medal by defeating France in the final.

The decision to include cricket in the 2028 Olympics was made during the 141st International Olympic Committee (IOC) session held in Mumbai in October last year.

The format for the competition will be T20, a fast-paced and popular version of the game, that is expected to attract a global audience.

Cricket's reintroduction to the Olympics follows its successful return to the Asian Games in Hangzhou last year, where it was included for the first time since 2014.

The Asian Games featured

The conditions suited our style, and the decision to bowl first proved crucial in setting up this victory. The team demonstrated great character in bouncing back from our recent setbacks."

The Dubai Capitals will look to maintain their winning momentum when they face Abu Dhabi Knight Riders in their next fixture at the Dubai International Stadium on Sunday. With this crucial victory boosting team morale, the Capitals aim to climb higher in the tournament standings and secure their position in the playoff race.

There was a sense of fear during rehab, but I've crossed that phase: Shami

KOLKATA, Jan 22 (Agencies): Seasoned India pacer Mohammed Shami has revealed that he was gripped by a sense of fear when he began his rehabilitation after a long injury layoff, but managed to overcome that phase by training his mind to stay focused on the national comeback.

Shami was sidelined after the ODI World Cup final against Australia in November 2023 due to an ankle injury that required surgery. The recovery from that was followed by a swelling on his left knee during the domestic comeback some weeks back.

Following his inclusion in India's Champions Trophy squad, his return has garnered national attention. He is also in the squad for the five-match T20I series against England beginning here later this evening.

"I waited for an entire year and I worked very hard (to get back to full fitness). There was a sense of fear (of getting injured during rehabilitation) even while running," Shami said in a video posted by BCCI.

"It is difficult for any player to get injured after being in full flow, go to the NCA (National Cricket Academy) for rehabilitation and then make a comeback," he added.

The cricketer, however, said an athlete is far more determined after dealing with an injury.

"When you go through injuries, I feel you grow stronger as an athlete, this is what I feel. Because you have to repeat a lot of things while being mentally strong." Shami went through the domestic grind, representing his home state Bengal in the Ranji Trophy, Syed Mushtaq and Vijay Hazare but a swelling in his knee finally ruled him out of the five-match Border-Gavaskar Test series in Australia.

On his competitive return in the Ranji



Trophy, he guided Bengal to their first win of the season with a seven-wicket haul. He followed it up with impressive performances in the Syed Mushtaq Ali Trophy (11 wickets) and the Vijay Hazare Trophy (five wickets).

Shami's T20I career has been sporadic, with just 23 appearances since his debut in 2014. His last outing in the format was against England in the 2022 T20 World Cup semifinal.

The 34-year-old said he has overcome the setbacks and is raring to go.

"Whatever is done, is done. I have crossed that (injury) phase. If you work hard you will get the results. That's what I believe in. If you get injured you have to make a comeback for your team for your country. So fight and grow," he said.

"If you are strong and believe in yourself and you have confidence in your abilities, have self-belief, then I don't think you will find any difference. Confidence is important for any task," he

Shami said he concentrated on improving his skills with a lot of focus on fitness during his rehabilitation.

"The rhythm is very important. Everything in life has a flow. Whatever it is, your fitness, mindset and skill is important for bowling," he explained.

Rohit Sharma leads star parade as Ranji Trophy resumes

MUMBAI, Jan 22 (Agencies): A rare congregation of stars will be on display when the Ranji Trophy resumes on Thursday with big names such as Rohit Sharma and Rishabh Pant agreeing to show up for their respective sides, nudged primarily by the BCCl's stern diktat on respect for domestic cricket.

Rohit will be turning up for defending champions Mumbai after nearly a decade when action resumes in the second half of the country's premier red-ball competition across different venues.

For the first time this season, the two biggest white-ball competitions—Syed Mushtaq Ali T20 Trophy and the Vijay Hazare Trophy—split the Ranji Trophy into two halves with each state side playing five matches apiece in the first leg.

With every team to play two more matches in the second round, a lot will be at stake not only for the sides involved but also for various national players, who have been clearly told that they cannot ignore domestic cricket anymore following crushing defeats to New Zealand at home and Australia in an away series.

Even though batting superstar Virat Kohli will take a few more days to recover from a neck strain before joining his Delhi teammates for the final round of group stage matches from January 30, Rohit is set to play for Mumbai under the leadership of Ajinkya Rahane.

In all likelihood, Mumbai will



pair him with Yashasvi Jaiswal at the top, replicating the India combination, when they will face a formidable Jammu and Kashmir, currently placed second in Elite Group A.

At the top is Baroda, who beat Mumbai in the season-opener, but the Rahane-led side can be backed to find their mojo and get back in the saddle to aim for a record-extending 43rd title.

The outing with Mumbai is expected to benefit India's outof-sorts Test and ODI skipper Rohit, who has endured a horror run with the bat over the last three months.

How Rohit responds to the fresh challenge could also determine India's fate in the Champions Trophy next month, which could well be his last shot at winning another major event. Pant vs Jadeja in Rajkot

At Rajkot, Delhi will face twotime winners Saurashtra where the mercurial Rishabh Pant will face off against his teammates Ravindra Jadeja and Cheteshwar Pujara. The contest is a must-win for both the teams in Group D.

Both Delhi and Saurashtra, placed fourth and fifth respectively, have just one win each in the last Elite Group and they have a lot of ground to cover against table-toppers Tamil Nadu and Chandigarh.

Only top two teams from each of the four groups will advance to the quarterfinals stage.

Gill adds punch to Punjab vs Karnataka

Punjab have one win to show from five matches which leaves them fifth in Group C, but the focus will be on India's new ODI vice-captain Shubman Gill who too has endured a challenging phase with the bat.

Punjab will face Karnataka, who are high on confidence

coming off their title-winning campaign in the Vijay Hazare Trophy, in their backyard of M Chinnaswamy Stadium in Bengaluru.

Gill's return makes up to some extent for the unavailability of Abhishek Sharma and Arshdeep Singh, who are on national duty for T20Is against England, in the Punjab squad.

Karnataka will be bolstered with the return of Devdutt Padikkal and Prasidh Krishna who both played a part at various stages in India's tour of Austra-

In another big match, Bengal will miss the services of pacer Akash Deep and Abhimanyu Easwaran at Kalyani, who both picked up injuries during the Border-Gavaskar Trophy, in the Group C clash against Haryana. Mohammed Shami, who proved his fitness during the Syed Mushtaq Ali Trophy, has already linked up with the Indian team for the T20Is against England which means his state side Bengal will have to make do with available resources to move up

Last year's Ranji Trophy runner-up Vidarbha, who lost to Karnataka a few days ago in the final of Vijay Hazare Trophy, will be confident of their chances as they take on a fourth-placed Rajasthan in Jaipur in Group B.

NEW DELHI, Jan 22 (Agencies): Former cricketer Mohammad Kaif showered praise on stalwart Indian batters Rohit Sharma and Virat Kohli, calling them "great white-ball cricketers". Kif was speaking in a video on his YouTube channel.

Kaif also mentioned that Team India will need Rohit and Virat in the forthcoming Champions Trophy 2025.

Kohli made his debut in the ODI format in 2008 against Sri Lanka.

Following that he has scored a whopping 13906 runs from 295 50-over matches at a strike rate of 93.54. He also has an average of 58.18. Meanwhile, Rohit played his maiden ODI match in 2007 against Ireland. In 265 ODIs, the skipper scored 10866 runs at a strike rate of 92.43 and an average of 49.16.

Speaking on his official YouTube channel, Kaif said that both Rohit and Virat will not be playing for a long since they are in their late 30s. He added that the two experienced Indian batters will contribute a lot to the Men in Blue squad during the Champions Trophy 2025.

"You need Rohit Sharma and Virat Kohli. Rohit is 37 years old and Kohli is 36 years old. They are not going to play for a long time. Pray for them, back them. They are two great white ball players. They are not going to play for a long time. I believe that
