J&K Police recovers 290 bottles of codeine phosphate during searches in Srinagar

SRINAGAR, Jan 23 (Agencies): Jammu and Kashmir Police on a tip off recovered 290 bottles of Codeine Phosphate during a search operation from a house and arrested the accused at Panthachowk area of Srinagar.Jammu travel guide

Police on Thursday said based on credible information, a search operation was conducted by the Panthachowk Police Station at the residence of Irfan Ahmad Ganie, a resident of Athawajan during which 290 bottles of Codeine Phosphate were recovered.

The search operation was carried out in the presence of the Tehsildar Panthachowk.

A case has been registered under FIR No. 05/2025 under Sections 8/21 of the NDPS Act, and further investigation is currently in progress.

Body found in 1000-ltr water tank in **Pampore**

SRINAGAR, Jan 23 (Agencies): An unidentified dead body was found inside a 1000-litre water tank at a residential house in Khrew area of Pampore town on Thursday.

Sources told news agency KDC that the body was recovered from a water tank at the residence of Gh Nabi Shah, son of Gh Mohiud-Din, in New Colony, Khrew, Pampore.

Police have launched an investigation to ascertain the identity of the deceased and the circumstances surrounding the incident. Further details are awaited.

Almost all Ideological Tasks completed in last ten years: Amit Shah



AHMEDABAD, Jan 23 (Agencies): Union Home Minister Amit Shah on Thursday said "almost all" pending ideological tasks including the abrogation of Article 370 have been completed by the Narendra Modi government, and it will continue on the same path in its third tenure.

The senior BJP leader was speaking after inaugurating the Hindu Spiritual & Service Fair, also known as `Hindu Adhyatmik Seva Mela', at the Gujarat University grounds here.

There was a time

when Hindus hesitated to disclose their identity in their own country, he

claimed.

"In ten years, the situation has changed. Now, almost all the pending works as per our ideology have been completed, be it the abrogation of Article 370 from Jammu and Kashmir, construction of Ram Temple in Ayodhya, abolition of triple talaq and implementation of Uniform Civil Code (UCC)," he said.

Notably, while the UCC has not been implemented at the national level, BJP-ruled Uttarakhand has introduced it and Shah had told the Raiva Sabha last month that it would be implemented in all the states.

While the Modi government completed these unfinished works in ten years, earlier governments had not touched them for 70 years, Shah further said in his speech





JAMMU, Jan 23: Deputy Chief Minister, Surinder Chowdhary, on Thursday assured that both the Jammu and Kashmir and the Central government are making serious efforts to uncover the cause of the unexplained deaths in Rajouri.

At least 17 people have died so far in the Badhaal area, but the exact cause of their deaths remains unclear.

Chowdhary also highlighted the government's proactive response, noting that the Chief Minister personally visited the area, The Home Ministry sent the team and the district commissioner has been stationed in Rajouri to manage the crisis. DEVELOPING RAILWAY

he development of railway infrastructure in Jammu and Kashmir (J&K) has become a transformative initiative aimed at connecting the region to the rest of India. The project, which has gained significant momentum over the past few decades, holds immense importance for the region's economic growth, social integration, and strategic security. This stretch serves as a lifeline for the Kashmir Valley, connecting the region with Jammu and facilitating the transport of passengers and goods. The Katra-Banihal section, currently under construction, includes the iconic Chenab Bridge, which is set to be the highest railway bridge in the world at 359 meters above the riverbed. The completion of this section will provide seamless rail connectivity from Jammu to the Kashmir Valley, further enhancing travel efficiency.

The engineering feats involved in the railway development in J&K are nothing short of extraordinary. The region's challenging geological conditions, including frequent landslides, earthquakes, and heavy snowfall, have necessitated the use of cutting-edge technologies. The Chenab Bridge, for example, is designed to withstand extreme weather and seismic conditions. Similarly, the Pir Panjal Tunnel, which spans over 11 kilometers, is equipped with advanced safety and ventilation systems to ensure smooth operations even in harsh winter conditions.

The economic impact of the railway network in J&K has been profound. One of the most notable benefits has been the boost to tourism, as the improved connectivity has made it easier for tourists to visit popular destinations like Srinagar, Gulmarg, and Pahalgam. os Angeles in California America is in news these days not for any good thing ,but for the wild fires that occurred woods there and caused enormous loss to men, materials and jungles .It is the nature's fury and the nature is angry with the humans because they are greedy and have degraded environment and nature's and are damaging nature' ecology .Thus nature in its turn is punishing people in various parts of the globe. The wild forest fire that is still continuing in Los Anegels in California is one of the worst forest fires in the American history. The fires are already among the most destructive in LA's history when measured by the number of buildings destroyed. Rebuilding work will cost "tens of billions" of dollars, US former president Joe Biden has said. At least 25 people have died in the Los Angeles fires as two major blazes continued to burn across the sprawling US city as on 15th January but now the forest fire which had engulfed the residential areas and caused huge loss to the buildings, vehicles, infrastructure and also resulted in human loss besides the material loss is now receding with the slowing of winds there .The catastrophic LA wildfires have ravaged entire neighborhoods, claiming at least 27 lives and destroying over12,000 structures. Economic losses have soared to a staggering dollar 275 billion .A red flag warning -indicating a high level of fire danger -is in place until 18.00 -02.00 GMT on Wednesday, with strongest Santa Ana winds expected on Tuesday .Nearby ,the largest fire in the Palisades area, and has burnt through more than 23,000 acres .It is still only about 14% contained ,despite the efforts of thousands of firefighters. The blaze is moving east, threatening the exclusive neighborhood of Brentwood, home to the Getty Center, a world famous art museum that has evacuated its staff. The house of the son of former president of US has burnt and Kamal

Nature's Fury in Los Angeles

Harris's had left his house because of the danger of devastating fire which has caused enormous loss in Los Angeles to properties, vehicles and other paraphernalia. The overall destruction is immense, with more than 12,000 structures -homes outbuildings ,sheds ,mobile homes and cars -destroyed .Celebrities Mel Gibson and Paris Hilton are among those who have lost their homes .Tens of thousands of homes were also without power which seems unthinkable in the most developed country. The fires could turn out to costliest in US history, with damage projected at up to dollar 150 billion ,according to a preliminary estimate by AccuWeather .There were three active fires in the wider area, while a smaller fire is nearly contained as per California fire officials. The fires were in the following places—1-Palisades—The first fire to erupt a week ago and the biggest in the region .It has scorched more than 23,000 acres including the upmarket Pacific Paliscades neighborhood and is only 14% contained.2—Eaton—Affecting the northern part of LA ,blazing through areas such as Altadena .It is the second biggest fire in the area ,burning more than 14,000 acres .It is now 33% contained.3-Hurst-Located just north of San Fernando it began burning last Tuesday .It has grown to 799 acres, but is almost contained.4-Auto-Broke out on Monday ,it has reportedly been stopped from moving forwards after spanning 56 acres . The earlier Kenneth ,Archer ,Sunset ,Lidia ,Woodley and Olives fires have been contained .Fire officials have not publicly identified the cause of the blaze. However, multiple lawsuits allege the fire started by utility department owned by Southern California Edison ,the largest power provider in Southern California .The question which haunts the mind of the people is was Los Angeles fire man made? While no definitive answers have emerged yet, experts believe a combination of natural and man-made factors could be behind the wildfires. The fires ,including the massive Palisades and Eaton Blato zes begun

few days before 13 January and have scorched over 62 square miles of land, fuelled by strong Santa Ana winds. The pertinent question is why is Los Angeles prone to wildfires? There is a lot of fuel on the landscape to burn. This time last year, LA was plagued with flooding and landslides that broke an extended longterm draught across the region. The burst of moisture led to plant growth , which has been steadily drying over the past year of very dry conditions .But one thing is not clear why have these Los Angeles fires spread so fast and ferociously? The answer to this question depends partly on whether you look at the immediate proximate cause -high "Santa Ana winds" and drought or longer -term trends in ecology, fire suppression and land use. In the first instance ,LA is experiencing a climatological phenomenon called "Santa Ana winds" that leads to strong and very dry winds that create dangerous fire weather conditions .This happens regularly in Southern California in the late autumn and winter, driven by high pressure over interior and temperature gradients [between Southern California's comparatively warm coast and much cooler areas of high desert at higher elevations in Nevada and Utah].which create strong and very dry winds that blow out of the mountains and towards the warmer coast .These winds are further accelerated by the topography of the narrow mountain valleys leading down to LA and coast. High Santa Ana winds fuel any ignitions making them burn hotter, spread, faster and farther ,and greatly complicate fire suppression efforts ,since it is hard to deploy air assets like tanker planes and helicopters to spread water and fire retardant. In these conditions, the Eaton fire burning the San Gabriel Mountains east of Pasadena reportedly grew twentyfold in size within hours, according to the New York Times. This has become possible because the vegetation is exceedingly dry .The last even moderate rainfall recorded at LAX airport was in April 2024. Since then , precipitation was

recorded at LAX on just five other dates, totaling a meager 0.15."The landscape is tinder dry ,and so any ignition source, whether from errant cigarette butts or sparks from power lines blown over in the strong winds is much more likely to take hold, and spread .The Los Angeles Fire in Palisades erupted in the morning of January 7,2025 in a Pacific Palisades ,a LA neighborhood east of Malibu as a brush fire .The blaze ,which had grown to 23,713 acres, was 52% contained within few days .There was enormous loss to life and property in Los Angeles and the wildfire was a worst catastrophe and it devastated LA .Thousands of the inhabitants of LA fled from their places and were displaced and are the worst sufferers .The causes that sparked the fires are under investigation, and scientists noted that because there was no natural ignition sources this time of the year ,the fires were almost certainly started by human activity in some way -whether sparks from power line, fireworks ,arson or some other cause .An extremely warm summer and fall, an unusually dry winter, hillside covered with bone-dry vegetation and strong Santa Ana winds all played their part in the devastating wildfires in Los Angeles history .In the mix of conditions that have contributed to the most destructive fires in LA history scientists say one single significant ingredient is human –caused climate change .In brief humans should learn a lesson or two from the January wildfire in LA and try to protect environment and never try to damage nature's balance and then and only then people will be saved from the natural fury like wildfires or otherwise we should remain ready to face such natural tragedies. Therefore we should resolve to preserve and conserve natural environment and wildlife as well as jungles, rivers, mountains etc. for our own good. (The author is a

Kashmir Industry Body Criticises Exclusion from Key Industry Boards, Demands Stakeholder Representation

SRINAGAR, Jan 23 (Agencies): The Federation of Chambers of Industries Kashmir (FCIK) has expressed deep disappointment over the exclusion of its representatives from the boards of key industry-related public sector undertakings (PSUs), including SICOP and SIDCO, following their reconstitution on Wednesday. This decision has been criticised as a missed opportunity to engage key stakeholders in shaping the industrial policies of Jammu and

In a statement, FCIK noted that, before the state reorganisation in 2019, it played an integral role in representing the industrial community, directly engaging with the government and influencing policy decisions. The exclusion of both FCIK and the Federation of Industries Jammu (FOIJ) from these boards undermines the role of stakeholders who have historically contributed to the region's industrial develop-

FCIK highlighted its disappointment given the industrial community's expectations of the new government's commitment to fostering growth through public-private partnerships. It emphasised that the exclusion risks creating policies disconnected from the realities faced by industries on the ground.

"Stakeholders like FCIK and FOIJ bring invaluable insights, experience, and knowledge. Their representation ensures that policies are well-informed and aligned with the sector's needs," the statement read, adding that decisions without such input often prove

ineffective or counterproductive. The organisation also stressed the need for fair and transparent evaluation of PSUs like SICOP and SIDCO, which play a crucial role in developing industrial infrastructure and providing services to industries. It called for greater accountability and collaboration to ensure these PSUs meet the highest

standards. FCIK has demanded the immediate restoration of its and FOIJ's representation on the boards of industry-related PSUs and high-level decision-making committees. It believes such representation is vital for fostering transparency, accountability, and sustainable growth, as well as for attracting investment to the region.

FCIK President Shahid Kamili has personally raised the issue with Deputy Chief Minister Surender Kumar Choudhary and Advisor to Chief Minister Nasir Sogami. Both have assured Kamili that FCIK will be included in the boards of relevant PSUs. The chamber remains hopeful that the government will act promptly to address these concerns and incorporate authentic representatives of the industrial community in

decision-making processes.

R Madhavan says he is okay with his film Hisaab **Barabar dropping directly on OTT**

Throw any question at him and he has an instant, logical answer. Nothing catches the intelligent actor off guard. National Award-winning actor R Madhavan, known for superhits like Tanu Weds Manu, 3 Idiots and more, who will soon be seen in the lead role in Zee 5's Hisaab Barabar, is okay with his film dropping directly on OTT.

Web platforms are a familiar turf for the actor, who has been part of web series like Breathe and The Railway Men. During the days of pandemic, his film Maara too had a direct to OTT release. Today, he believes, "There is a firm line between what works on streamers and which films deserve a theatrical release." If visual grandeur is what delineates a theatrical outing, on OTT, he states, "What you need are good performances and an intriguing storyline. On that count, Hisaab Barabar is an OTT film." Since the film champions a common man's crusade, we wonder if stardom too can be put to effective use to further societal causes. He says, "It is easy for me to play it like a star, but then the empathy for the character would be lost. Stories of underdogs, of those who make it against all odds, say a rickshawallah's son becoming an Indian Air Force pilot, are more potent than superhero sagas. These are Herculean efforts that surpass all other achievements and even stardom."

Content is king now

Of course, what made him say yes to Hisaab Barabar was also its unusual premise of banks surreptitiously cheating its cus-



tomers of small, almost paltry amounts, yet making a killing for themselves in the process. Prior to signing the film, he had this uneasy feeling of not having any control over his accounts. In real life, however, he is not obsessed with numbers like his reel character. But yes one hisaab he would like to settle is recognition in consonance with his talent. And to those who dub him 'Akshay Kumar of South', his repartee is laced with annoyance, "Some figment of a foolish mind which puts one's credibility at stake.'

Indeed. For someone who has given us many blockbusters in Hindi cinema too, what is his take on the much-talkedabout north-south alchemy. He says, "Content is now the king. Earlier, stardom was all that mattered. Now a well-intended story, whether it comes from North or South, works wonders. Besides, OTT has made us privy to cinema in all languages, especially from the South and built a fan base. So, Pushpa 2 in Hindi does more business than

the one in its original language." No magic in remakes

With more and more viewers becoming language agnostic, expectedly, remakes have lost relevance. Take his successful Tamil film Vikram Vedha, which failed to enthuse viewers when remade in Hindi with big stars like Hrithik Roshan and Saif Ali Khan. He observes, "Gone are the days when pan-Indian audiences would not have seen Ghajini before its remake in Hindi hits the screens. The only excitement today remakes can generate is comparison with the original." But the real competition, he feels, is not from within, but outside. As Korean content is gaining much currency, he quips, "My son knows more about Korean stars than Indian, which is not right."

Director's eye As president of the FTII, 'a position of honour and responsibility' he hopes to make a difference and, "Ensure taxpay-

ers' money is well-spent, and

students stick to the industry

and make it more relevant."

What effective changes he will bring about during his tenure he does not reveal right away. One day he would also like to talk at length about the uniqueness of his directorial debut, Rocketry: The Nambi Effect, which won a National Award. The director in him would likely surface again, only if he finds yet another passion project like Rocketry, which he understood inside out. Besides, he feels there is much in him to give us as an actor.

Thinking man's actor For now, watch him play an overzealous common man for whom every penny counts, and one who makes those who rob him and others of it accountable. Apart from an aam aadmi picking up cudgels, the film also celebrates the collective power of society coupled with vast reach

of social media. He reasons, "There was a time when you heard the stories of an angry crusader through articles etc. Now it can gain momentum in real time and involve all of us." Interestingly, during the shooting of one of the climactic scenes in the film, he shares how the crowds, which had gathered, actually started debating the issue. Whether the film, which drops on January 24, will be a conversation-starter. he assures, "It will make you rethink." As does this thinking man's actor. When not acting, he could be seen lined-up on the golf course or posting his son Vedaant's swimming achievements, for which he takes no credit. But for being the man and the actor he is, he deserves all plaudits.

Actress Ahsaas Channa says acting is a deeply personal journey



Actress Ahsaas Channa, who is known for Kota Factory, Modern Love Mumbai, Mismatched and others, has said that acting is a deeply personal journey, and for an actor to

Monali's recent controversy

Earlier this month. Monali issued a statement after she walked off the stage midperformance during her Varanasi concert in Uttar Pradesh on December 22. The incident took place when Monali exited the stage



after performing for just around 45 minutes.

In videos that went viral on the internet, Monali was seen addressing the audience, saying, "I am disheartened that my team and I were so excited to perform here. Let's not talk about the infrastructure and its condition, as that is the management's responsibility. I can't explain what they have done to the stage just so they

can steal money." The singer took to her Instagram account on Monday where she shared details about

the alleged mismanagement, and mistreatment against her and her team by the event organisers. "I had hoped not to end 2024 or begin the new year 2025 by addressing the horrific and negative incident my team and I faced in Varanasi. However, after much reflection, I feel it is important to share these unfortunate truths-not only to raise awareness but also to call for reforms in how such matters are handled. Attached is a confession and apology letter issued by the founder of the event-

organizing company. Hope this letter is sufficient to clear any confusion anyone might have had about the credibility of any of the false defamatory accusations made against my team and me, as well as the treacherous and unethical conduct of the organizers," wrote Monali.

Monali also shared that her team faced "severe negligence" in basic infrastructural safety that forced her to leave the stage in the middle of her performance. "It has been deeply troubling for me to process the reckless and irresponsible behavior of the event management company's team. Especially, their misuse of laws designed to protect against sexual harassment-laws that are vital for safeguarding people, specially women in our society-is both appalling and unacceptable. Weaponizing such laws for personal vendetta, ego satisfaction, or retaliation against those who refused to comply with unethical practices is not only a gross abuse

of rights but also deeply disrespectful to genuine survivors of these heinous crimes," the singer wrote.

"Thise reckless behavior undermines the credibility of survivors who show immense courage in seeking justice and hampers the hard work of those fighting to eradicate such crimes. It is particularly disheartening to see young women participating in such actions, as it damages the cause and creates distrust around an issue that should always be treated with the utmost seriousness," she added.

Monali also criticised the "treatment of vendors" and those "working behind the scenes" at the event. "It is absolutely unacceptable to treat vendors poorly, cheat them of their hardearned money, or con them in any way," she said. "Disrespecting and harassing those working behind the scenes... is not the way forward. Such behavior should never be tolerated or entertained."

Divyanka Tripathi calls her first TV show traumatic: Didn't know I was depressed

Actor Divyanka Tripathi has been in the industry for over two decades. She recently confessed that she was struggling with depression in the initial stage of her career, calling her first show "traumatic show of her life".

In an interview with agency, Divyanka looked back at her journey in the industry.

The Yeh Hai Mohabbatein actor said, "Mera first show was the traumatic show of my life. Tab yeh depression ka concept nahi pata tha (My first show was the traumatic show of my life. At that time, I didn't know the concept of depression)."

The actor shared that people are

nowadays more aware of the situation because of exposure on social

Divyanka added, "Kehte hain na ignorance is bliss. Shayad kyunki mujhe pata nahi tha ki main depression se guzar rahi hun, isiliye maine usko itna seriously nahi liya aur main nikal gayi. But woh mera ek phase tha jab meri aur doston ke saath mein baatein hoti thi ek kamre mein aur jaise hi woh ek do logon ke naam nikalte the, rona shuru ho jaati thi. (They say that ignorance is bliss. Maybe because I did not know that I was going through depression, that is why I did not take it seriously, and I came out of it. But that was



a phase of mine when I and my friends used to talk in a room, and as soon as she would mention the names of one or two people, I would start crying)".

She said that venting out helps, and hence, one should have a good therapist or friend who can listen patiently.

In 2004, she participated in India's Best Cinestars Ki Khoj and ended up being in the top 8 from Bhopal zone.

Divyanka rose to fame after she played Vidya Pratap Singh in her debut TV show Banoo Main Teri Dulhann (2006). She also played Dr Ishita Iyer Bhalla in the widely popular show Yeh Hai Mohabbatein (2013). In 2017, she participated in the dance reality show Nach Baliye 8 and emerged as the winner. She also participated in Khatron Ke Khiladi 11 and was the runner-up.

The actor was last seen in The Magic Of Shiri. Set in 1996 in Delhi, the show follows a woman who faces financial struggles and decides to reinvent herself as a stage magician. Jalgaon train accident toll rises to 13; 8 bodies identified: Police

JALGAON, Jan 23 (Agencies): The death toll in the Jalgaon train accident has gone up to 13 with the recovery of a headless body along the railway tracks, police said on Thursday.

Some passengers of the Mumbai-bound Pushpak Express, who got off the train after an alarm chain-pulling incident, were run over by the Karnataka Express heading from Bengaluru to Delhi on the adjacent tracks in Maharashtra's Jalgaon district on Wednesday evening.

"Of the 13, we have identified eight bodies so far, including two from their Aadhaar cards," Special Inspector General of Police Dattatraya Karale told PTI.

The eight identified deceased include four hailing from Nepal, Jalgaon district information officer Yuvraj Patil told agency.

Out of the 15 persons

injured in the incident, 10 were currently undergoing treatment – nine at the Pachora civil hospital and one at a medical facility in Jalgaon city- while the others who suffered minor injuries were discharged, he said.

Meanwhile, the Lucknow-Mumbai Push-pak Express reached the Chhatrapati Shivaji Maharaj Terminus (CSMT), its final destination in the Maharashtra capital, at around 1.20 am on Thursday, a railway spokesperson said.

The Central Railway's general manager and other senior officials also reached the accident spot at night and inspected the site, he said.

They also visited the hospitals where the injured persons were taken for treatment.

The tragedy unfolded on Wednesday eve-

ning when passengers onboard the Pushpak Express, fearing a blaze, hastily jumped onto the adjacent tracks and were run over by

tive Director, Information and Publicity, Railway Board, however, denied that any spark or fire inside the coach caused passengers to pull the alarm.

In a video message from Davos in Switzerland, Maharashtra Chief Minister Devendra Fadnavis on Wednesday said, "Some passengers in the train mistakenly assumed that smoke is

coming out of the train and they jumped. Unfortunately, they were run over by another train."

The CM announced a financial assistance of Rs 5 lakh each to the next of the kin of the passengers who died in the tragedy.

The Railway Board separately announced an ex-gratia of Rs 1.5 lakh each to the kin of the deceased, Rs 50,000 for grievous wounds and Rs 5,000 for simple injuries.

Andhra college student walks out of classroom in session, dies after jumping off 3rd floor

CHANDIGARH, Jan 23 (Agencies): A firstyear student at a college in Andhra Pradesh died by suicide after jumping from the third floor of the building.

The shocking incident was captured on a surveillance camera.

The Narayana college student walked out of the classroom at 10:15 a.m., stood on the ledge, and jumped off the third floor.

He also took off his slippers before jumping. A video from the classroom shows the boy leaving the room while the class was in session.

The video also shows his classmates walking

out of the room shortly after they realised he had jumped.

Anantapur Rural sub-

divisional police officer T Vekateshulu said the 16-year-old had just returned to college from Sankranti holidays on Thursday morning and died by suicide at 11:55 am. "After the holidays, this boy came to the college around 9:30 am on Thursday. While the class was going on, around 11:55 am, he suddenly came out from the classroom and jumped from the third floor," Venkateshulu told

agency.
Immediately, the college management shifted the injured boy

to a local hospital where doctors examined him and declared that he was dead. Police said the intermediate student hailed from Ramapuram village of Batthenapalli mandal in Sri Sathyasai District.

The suicide of the boy pursuing intermediate first year at Narayana Junior College was captured on CCTV cameras. The recording shows him rising from his bench and straightaway proceeding to jump from the third floor unperturbed, police said.

Meanwhile, police are taking a complaint from the boy's parents to register a case and investigate further.

Delhi wants Sheila Dikshit's development model, not 'false propaganda' of PM Modi, Kejriwal: Rahul

NEW DELHI, Jan 23 (Agencies): Congress leader Rahul Gandhi on Thursday said Delhi now wants the "real development model" of former chief minister Sheila Dikshit and not the "false propaganda and PR model" of Prime Minister Narendra Modi and AAP convenor Arvind Kejriwal.

Gandhi shared on Facebook a video montage highlighting issues such as inflation, unemployment, pollution and corruption.

"Bad construction, dirt, inflation, unemployment, pollution and corruption – the truth of Delhi is in front of the public," the former Congress chief said in his Facebook post in Hindi.

"Delhi now wants the same real development model of Sheila Dikshit ji, not the false propaganda and PR model of Modi and Kejriwal," Gandhi said ahead the Assembly polls.

Gandhi could not address a public meeting in the Sadar Bazar Assembly constituency on Wednesday as he was unwell and appealed to people via a message read out at the rally to ensure the party's victory in the polls.

Due to his ill-health, Gandhi could also not travel to Karnataka's Belagavi for the 'Jai Bapu, Jai Bhim, Jai Samvidhan' rally on Tuesday and earlier, his political programme in the New Delhi constituency could not be held.

Earlier this month, Gandhi had



launched a blistering attack on Prime Minister Narendra Modi and former Delhi chief minister Arvind Kejriwal, saying there is no difference between the two leaders and they do not want backwards, Dalits, tribals and minorities to get their due share.

Specifically targeting Kejriwal at his first public meeting for Delhi assembly polls, Gandhi had said that the AAP convenor was following "Modi's strategy of propaganda and false promises" despite rising pollution, corruption and inflation in the national capital.

He also promised a caste survey in Delhi if the Congress formed the Government in the national capital.

Gandhi had hailed the work done under three successive Sheila Dikshitled Governments and asserted that neither Kejriwal nor the BJP can match the Congress' track record.

Amid crow deaths due to bird flu, 4,200 chicks found dead in Maharashtra's Latur

LATUR, Jan 23 (Agencies): Nearly 4,200 chicks were found dead in a poultry farm in Maharashtra's Latur district, days after about 60 crows succumbed to bird flu, an official said on Thursday.

The five-to-six-day-old birds died in the Dhalegaon village, Ahmedpur tehsil, and samples of the carcasses have been sent to the State Animal Disease Diagnostic Laboratory in Aundh, Pune, on Wednesday, he said.

Deputy Commissioner for Animal Husbandry Dr Shridhar Shinde said their team had visited the site. Officials said the baby chickens died over two to three days. The poultry farm owner did not immediately alert the authorities about the deaths, which caused the infection to spread and kill 4,200 of the 4,500 chicks he had bought, they said.

Dr Shivaji Kshirsagar, deputy commissioner of the Ahmedpur veterinary hospital, has appealed to owners to get their poultry farms registered and keep the local officials informed in case of such incidents.

Earlier this month, nearly 60 crows were found dead in Udgir city in the district. Tests by the Pune-based Regional Disease Diagnostic Laboratory and the ICAR - National Institute of High Security Animal Diseases, Bhopal, confirmed that bird flu was the cause of the deaths, officials had said.



Money disbursed under Ladki Bahin scheme won't be recovered from anyone: Ajit Pawar



MUMBAI, Jan 23 (Agencies): Maharashtra Deputy Chief Minister Ajit Pawar on Thursday assured that there would be no recovery of funds disbursed under the 'Mukhyamantri Majhi Ladki Bahin Yojana' scheme.

The Ladki Bahin scheme, launched before the 2024 state assembly election, provides eligible women from financially disadvantaged sections a monthly allowance of Rs 1,500.

Maharashtra has over 2.43 crore beneficiaries of the programme, costing the state exchequer approximately Rs 3,700 crore per month.

Pawar's assurance comes amid opposition claims that the government will trim the list of beneficiaries, take back the money disbursed to ineligible persons and eventually stop the scheme.

"Last time, we had limited time for the verification of documents of potential beneficiaries. We wanted to link the Aadhaar of every beneficiary to the scheme but could not do so. However, there will not be any recovery of the given money," Pawar said.

The NCP chief was speaking at an event at the Vasantdada Sugar Institute in Pune where he shared the dais with Sharad Pawar, who now heads NCP (SP).

The Ladki Bahin programme was credited as one of the major reasons for the Mahayuti alliance's resounding victory in the state elections last year. It has promised to raise the monthly amount to Rs 2,100.

Asked about his discussions with Sharad Pawar, the NCP chief said, "We talked about sugar-related matters. Cooperation, excise, agriculture, and power departments are linked to the sugar business. We also discussed issues concerning the Vasantdada Sugar Institute."

The deputy CM said he had reviewed the functioning of the agriculture department and highlighted potential misuse of government schemes.

"When the government introduces schemes for people's benefit, there are always some unscrupulous elements trying to take undue advantage. Similar cases seem to have occurred with the Re 1 crop insurance scheme," Pawar said.

Earlier, Maharashtra Agriculture Minister Manikrao Kokate had said there were irregularities in the implementation of the Re 1 crop insurance scheme for farmers, noting places of worship were shown as agricultural lands to claim benefits.

On the reported friction between the Shiv Sena and the NCP over district guardian ministers, Pawar said, "It is the prerogative of the chief minister (Devendra Fadnavis) to assign the responsibility of district guardian ministers to his cabinet colleagues. He will make a decision upon his return from Davos."

Trump says he chose not to pardon himself, defends clemency to Capitol rioters

WASHINGTON DC, Jan 23 (Agencies): US President Donald Trump revealed on Thursday that he declined the option to pardon himself before leaving office in 2021 as he believed he had done nothing wrong.

In his first Oval Office interview since assuming the presidency again, Trump told Fox News host Sean Hannity that the suggestion of self-pardon was made as he was departing the White House after losing the 2020 election.

"I was given the option. They said, 'Sir, would you like to pardon everybody, including yourself?' I said, 'I'm not going to pardon anybody. We didn't do anything wrong," Trump said during the hour-long interview, during which he often touched on past grievances.

Trump also took potshots at his predecessor, Joe Biden, for not issuing himself a pardon before leaving office, hinting that it was a mistake the Democrat may come to regret.

"This guy went around giving everybody pardons," the President said, referring to Biden granting clemency to criminal



offenders, Trump critics and family members in his final days as commander-in-chief.

"And you know, the funny thing, maybe the sad thing, is he didn't give himself a pardon. And if you look at it, it all had to do with him." Trump said.

The conversation then turned to Trump issuing "full, complete and unconditional" pardons for around 1,500 people involved in the January 6, 2021, attack on the US Capitol. The group included individuals convicted of violent acts. The move saw Trump fulfilling a campaign

promise within the first few hours of his second term.

Hannity pressed the President on his decision to pardon convicts who had been violent toward police officers during the insurrection. He downplayed the incidents, describing them as "very minor."

"They were protesting the vote because they knew the election was rigged, and you should be allowed to protest the vote," Trump claimed, continuing to falsely assert that the 2020 election was stolen, despite repeated court rulings, official findings, and the conclusions of his own attorney general to the contrary.

He added, "Some of those people with the police – true – but they were very minor incidents, OK. You know, they get built up by that couple of fake guys that are on CNN all the time."

When Hannity objected, noting that protesters should not invade the Capitol, Trump defended his decision, asserting that most of those pardoned were "innocent" and going through a tough time in prison. He added that going over every single case would be a long and laborious process.

"These people have served, horribly, a long time," he said. "It would be very, very cumbersome to go and look – you know how many people we're talking about? 1,500 people."

Trump's mass pardons sparked immediate controversy, with judges who sentenced the rioters stating that the move won't change the truth about the mob's attack on a bastion of American democracy. On the other hand, Trump's supporters viewed the clemency as justified for what they believe was an overreach in prosecutions.

Thailand's first Olympic champion sentenced for attempted rape



BANGKOK, Jan 23 (Agencies): A Thai court on Thursday sentenced the country's first Olympic gold medallist to just over three years in prison for the abduction and attempted rape of a teenager.

Somluck Kamsing, now 52, became a national hero when he won featherweight boxing gold at the 1996 Olympics in Atlanta.

The Khon Kaen pro-

vincial court found Somluck guilty of child abduction for molestation and attempted rape, before granting him an appeal and bail.

"For attempted rape by force and taking a person over the age of 15 but not over 18 for the purpose of indecency, the first defendant's actions constitute a single offence that violates multiple laws," a court statement said.

Somluck filed a request for bail, which the court granted at 300,000 baht (\$9,000) while he pursues his appeal.

The court ordered him to pay \$5,000 in damages.

A 17-year-old girl filed a complaint in December 2023 against Somluck saying he had assaulted her in a hotel in Khon Kaen, a city in the kingdom's northeast.

Somluck, who also won boxing titles at the 1994 and 1998 Asian Games in Hiroshima and Bangkok respectively, denied the allegations.

Police confirmed local media reports at the time that Somluck met the teenager at a bar, where they stayed until 3:00 am, before the incident took place.

Taiwan plans to cull up to 120,000 green iguanas due to negative agriculture impact

PINGTUNG, Jan 23 (Agencies): Taiwan plans to cull up to 120,000 green iguanas, with supporters urging humane methods to bring down the animal's population, which is wreaking havoc on the island's agricultural sector.

Around 200,000 of the reptiles are believed to be in the island's southern and central areas, which are heavily dependent on farming, according Chiu Kuo-hao of the Forestry and Nature Conservation Agency.

Specially recruited hunting teams killed about 70,000 iguanas last year, with bounties of up to \$15 each. Local governments have asked the public to help identify iguana nests and they recommend fishing spears as the most

humane means of killing the animals.

"A lot of people bought them as cute little pets, not realizing how big and long-lived they would become, so they set them free in the wild, where they've really taken to the Taiwanese environment," said Lee Chi-ya of the agricultural department in the southern county of Pingtung. "That's allowed them to reproduce at a considerable rate, necessitating us to cull them and restore the balance of nature."

Green iguanas have no natural preda-

tors in Taiwan and have moved into areas that can be difficult to access, mostly forests and the edges of towns.

Males can grow to 2 feet (6.6 feet) long, weigh 5 kilograms (11 pounds) and live up to 20 years, while females can lay up to 80 eggs at a time.

Mainly native to Central America and the Caribbean, they are not aggressive despite possessing sharp tails and jaws and razor-like teeth. The reptiles subsist on a diet of mostly fruit, leaves and plants, with the occasional small animal thrown in.

Though popular as pets, they are difficult to keep healthy in captivity and many die within a year.

Hsu Wei-chieh, secretary general of the Reptile Conservation Association of Taiwan, said his group wants to teach farmers how to stay safe, protect their property and treat the iguanas in a humane manner.

"We're here to help see that this project is carried out smoothly," said Hsu.
Tsai Po-wen, a vegetable farmer in Pingtung, said the training was paying

"We used to attack them, but it wasn't any use. Now we're learning more effective, safer methods," Tsai said.

South Korean investigators call for indictment of detained President Yoon

SEOUL, Jan 23 (Agencies): South Korean investigators asked prosecutors to indict the country's detained President Yoon Suk Yeol over his short-lived imposition of martial law last month, as it accused him of rebellion, abuse of power and obstruction of parliament on Thursday.

The Corruption Investigation Office for High-Ranking Officials said that Yoon staged a "riot" and sought to undermine the constitution when he declared martial law on Dec. 3 and sent troops and police officers to seal the National Assembly.

Lee Jae-seung, deputy chief prosecutor at the CIO, told a televised briefing that Yoon also abused his power by mobilizing troops for an illegitimate purpose and attempted to obstruct parliament's right to vote on ending martial law.

Despite the presence of armed troops, lawmakers managed to enter the assembly chamber and called for an end to the emergency decree in a unianimous vote. The



assembly later impeached Yoon, suspending his presidential powers, and the Constitutional Court is now deliberating to determine whether to formally throw Yoon out of office or reinstate him.

Yoon has steadfastly maintained that his actions were intended to issue a warning to the opposition-controlled parliament over its obstruction of his agenda, rather than to disrupt its work.

The Corruption Investigation Office has been leading a probe into Yoon with police and military authorities, and detained him last week.

"As you know, despite facing a nationally grave allegation as ringleader of a rebellion, the suspect has been constantly maintaining uncooperative stance and defying criminal judicial proceedings," Lee said.

Yoon rebuffed efforts to question him for weeks and used the presidential security service to repel a first attempt to detain him.

Yoon argues that the investigation and his detention are

illega

Yoon's defense team issued a statement accusing the CIO of "humiliating" Yoon by trying to pressure him to speak to investigators and abusing his human rights by preventing him from contacting family members. Yoon has refused to participate in questioning since being detained, citing his right to remain silent.

Appearing at a Constitutional Court hearing for the first time on Tuesday, Yoon denied that he ordered the military to drag lawmakers out of the National Assembly to prevent them from voting. Commanders of military units that were sent to the assembly have testified that Yoon ordered them to pull lawmakers out.

Yoon's martial law decree has shaken South Korean politics and financial markets and hurt its international image. Yoon's subsequent defiance and the opposition's push to oust him have also intensified South Korea's already-serious internal divide.

Lunar New Year giveaway of cash, food leaves 4 dead in Cambodia as crowd surges

PHNOM PENH, Jan 23 (Agencies): Four people died and five others were injured Thursday as a crowd scrambled for a handout of food and cash from one of Cambodia 's richest people as a Chinese Lunar New Year gift, officials said.

The victims were crushed as the crowd of hundreds surged forward when the gates to Sok Kong's walled compound in Phnom Penh opened to start the distribution of \$10 in cash and two kilograms (4.5 pounds) of rice, police spokesperson Sam Vichhika said.

The victims, who all fainted in the crush and fell to the ground, were taken to hospital but two women and two men, aged between 37 and 71, could not be saved, he said.

It was not immediately clear whether they were killed in the initial crush of the crowd or from injuries they sustained once on the ground.

Following the incident the authorities cleared the crowd and suspended the rest of the give-away. Sok Kong has multiple investments, including in the hotel, casino and oil industries, and is also known to have a close personal relationship with former longtime Prime Minister Hun Sen.

He and other wealthy residents of the capital traditionally give gifts to the poor annually for Chinese New Year, which begins next week.

Pakistani government proposes sweeping controls on social media ISLAMABAD, Jan 23 (Agencies): release. Khan has been behind b

Pakistan's opposition said Thursday the government is seeking to further suppress freedom of speech a day after it proposed sweeping controls on social media that could include blocking platforms and sending users to prison for spreading disinformation.

The Prevention of Electronic Crimes Act, introduced in the National Assembly by Law Minister Azam Nazeer Tarar on Wednesday, would create an agency with the power to order "unlawful and offensive content" blocked from social media, and to ban individuals and organizations from social media

Social media platforms would be required to register with the new Social Media Protection and Regulatory Authority, and those failing to comply with the law could face temporary or permanent bans.

The law also makes spreading disinformation a criminal offense, punishable by three years in prison and a fine of 2 million rupees (\$7,150).

The move comes nearly a year after Pakistan blocked the X platform ahead of an election that the opposition party of imprisoned former Prime Minister Imran Khan says was rigged. X is still blocked in the country, although many people use virtual private networks to access it, like in other countries with tight internet controls.

Khan has a huge following on social media, especially X, where supporters frequently circulate demands for his

release. Khan has been behind bars since 2023, when he was arrested for graft. Khan's party also uses social media to organize demonstrations.

The leader of the opposition denounced the proposed legislation, saying it was aimed at further suppressing freedom of speech. Omar Ayub Khan, who is not related to the imprisoned former premier, said the bill could "lay a foundation for the suppression of voices advocating for constitutional rights".

The new agency would be able to order the immediate blocking of unlawful content targeting judges, the armed forces, parliament or provincial assemblies. The law also forbids uploading remarks from parliament that have been struck from the record.

Pakistani media has faced growing censorship in recent years. Journalists have said they face state pressure to avoid using Imran Khan's name, and most TV stations have begun referring to him only as the "founder of the PTI"

Human rights defenders and journalists' unions have vowed to oppose the law, but with the government holding a majority, its passage is all but assured.

Afzal Butt, president of the Federal Union of Journalists, said the law was an attempt to suppress the media, social media and journalists.

The government says the law is necessary to limit the spread of disinformation.

TV host and ex-pop star Masahiro Nakai retires amid sexual assault allegations

TOKYO, Jan 23 (Agencies): Masahiro Nakai, one of Japan's top TV hosts and a former pop star, said Thursday he was retiring to take responsibility over sexual assault allegations that are part of a wave roiling Japan's entertainment industry and have triggered an avalanche of lost advertising at one of the networks where he worked.

Weekly magazine Shukan Bunshun reported in December that Nakai had reached a 90 million yen (\$580,000) settlement with a woman over the alleged sex assault at a 2023 dinner party that Fuji TV staff allegedly helped to organize. He acknowledged "a trouble" and a settlement, while denying any violence, in a statement earlier this month. The magazine has also alleged that Fuji TV has long exploited its female announcers to entertain stars like Nakai.

"I, Masahiro Nakai, is retiring from entertainment activity as of today," Nakai said in a statement distributed to his paid fan club and posted on social media by apparent members. Japanese media also confirmed and reported his



retirement. "I am truly sorry for causing trouble and losses to so many people," Nakai said, and repeated his "sincere apology" to the woman. "I'm really, really sorry for saying good-bye this way ... Sayonara." Japan's entertainment industry is in the midst of a wave of sexual assault cases, including the abuses of hundreds of boys and young men by late talent mogul Johnny Kitagawa, whose now-defunct agency Johnny & Associates managed many boy bands, including the one to which Nakai belonged, SMAP.

Last Friday, Fuji TV President Koichi Minato acknowledged the company had been aware of the problem six months before the magazine

report and hadn't disclosed it. Minato apologized and said Fuji TV would investigate the case but also said he believed his employees had not done anything wrong. After dozens of commercials were withdrawn, Fuji TV apologized for causing trouble to advertisers and agencies but declined to disclose details. Following shareholders' demands for further clarification about the scandal and steps the company had taken and what measures are planned, Fuji was set to have a special board meeting later Thursday.

Nakai said in his statement that he has sorted out all negotiations of terminating his shows and contracts with television, radio and sponsors. He said he has yet to taken all his responsibility and promised to "face various problems and respond sincerely." Fuji Television Network's vice-chairperson Ryunosuke Endo, who is also head of Japanese commercial broadcasters' association, in a televised live news conference Thursday noted Nakai's retirement was his "personal decision" but said Nakai was part of the upcoming investigation and that he hoped for his sincere cooperation.

Rohit Sharma's struggles continue with a 3-run knock in Ranji Trophy



MUMBAI, Jan 23 (Agencies): Team India captain Rohit Sharma's poor form with the bat continued as he was dismissed for just 3 runs on the opening day of the Ranji Trophy match against Jammu & Kashmir at Mumbai on Thursday. Rohit faced 19 deliveries before falling to pacer Umar Nazir Mir, extending his run of disappointing performances.

Rohit's last Ranji Trophy appearance for Mumbai was in November 2015 when he scored a blazing 113 off 140 balls against Uttar Pradesh in a match that ended in a draw.

In Test cricket, Rohit's recent performances have raised concerns about his form. During India's tour of Australia,

the seasoned opener managed just 31 runs in five innings across three Tests.

The 2024-25 Test season, in particular, was disappointing for Rohit. He accumulated only 164 runs in eight matches and 15 innings at an average of 10.93, with his highest score being 52, a solitary halfcentury against Bangladesh.

As captain, Rohit faced some significant challenges. Before the Test series against Australia, India suffered their first home Test series defeat in 12 years, losing 0-3 to New Zealand. This was also India's first-ever whitewash in a home

Test series since 2000. After India's 295-run victory in the first Test against Australia at Perth under the leadership of Jasprit Bumrah. Rohit rejoined the team following the birth of his second child.

The Mumbai Cricket Association (MCA) announced the senior selection committee's decision regarding Rohit's inclusion on January 20.

Young southpaw Yashasvi Jaiswal who is Rohit's batting partner in red-ball cricket for India was dismissed early as well, he managed only 4 runs before being trapped LBW by Auqib Nabi. The duo's dismissals left Mumbai reeling during their first innings.

Meanwhile, Shubman Gill, captaining the Punjab team in their clash against Karnataka, also endured a tough outing. The star batter could score just 4 runs before being dismissed by Abhilash Shetty, further highlighting the challenging day for India's prominent cricketers in the domestic tournament.

It was far from an ideal start for the Indian stars in their respective Ranji Trophy matches, raising questions about their current form as the domestic season unfolds.

Gukesh becomes highest-ranked Indian at 4th in latest FIDE rankings, displaces Erigaisi

NEW DELHI, Jan 23 (Agencies): Continuing his rapid rise, world champion D Gukesh dethroned compatriot Arjun Erigiasi to become the highestranked Indian chess player, at fourth, in the latest FIDE rankings on Thursday.

Gukesh, 18, achieved the feat when he logged his second victory in the Tata Steel Tournament in Wijk Aan Zee (Netherlands) defeating Vincent Keymer of Germany.

Gukesh, who was awarded the Dhyan Chand Khel Ratna recently, has amassed 2784 rating points, while Erigaisi, who was the highest-ranked Indian for a long time, has slipped to fifth with 2779.5 rating points.

Norway's Magnus



Carlsen continues to be the undisputed world No.1 with 2832.5 points, followed by United States' Grandmaster Hikaru Nakamura (2802) and countrymate Fabiano Caruana (2798).

Gukesh has been in sublime form ever since he beat China's Ding Liren to clinch the world title in Singapore in December last year.

He took a break from the game to attend to functions and festivities back home and skipped the World Rapid and Blitz Championship in New York.

> On his return to the board, Gukesh has not lost a single game in Wijk Aan Zee. He has two victories and three draws so far in the tournament with eight rounds still to go.

Abhishek Sharma smashes record for most sixes by an Indian in T20I chase

KOLKATA, Jan 23 (Agencies): Abhishek Sharma delivered a stunning performance in the first T20I against England, smashing a blistering 20-ball halfcentury while hitting the most sixes by an Indian in a T201 run chase, according to Wisden.

The match, held at the Eden Gardens in Kolkata, saw India's spinners dominate the first innings, bundling England out for just 132. Varun Chakravarthy (3/23), and Axar Patel (2/22), kept England's batters under pressure, with only England skipper Jos Buttler offering resistance. Buttler played a lone hand with a 44-ball 68 before falling to Chakravarthy.

Chasing a modest target, India cruised



to victory in just 12.5 overs with seven wickets in hand. Leading the charge was Abhishek Sharma, who hammered 79 off just 34 balls. His explosive knock included eight

sixes, setting a new record for the most sixes hit by an Indian in a T20I chase. Sanju Samson (26 off 20) and Tilak Varma (19 off 16) provided valuable sup-

port as India comfort-

ably overhauled the target. Abhishek's six-hitting

spree featured three maximums off Adil Rashid, two against Mark Wood, and one each off Jofra Archer, Jamie Overton, and Gus Atkinson. His tally of eight sixes surpassed the previous Indian record of six sixes in a T20I chase, a mark jointly held by Rohit Sharma (achieved twice), Suryakumar Yadav, Virat Kohli, Tilak Varma, Yashasvi Jaiswal, and Axar Patel.

Globally, the record for most sixes in a T20I chase stands at 18 by Estonia's Sahil Chauhan. Among players from Full Member nations, South Africa's Richard Levi holds the record with 13 sixes against New Zealand.

Indian left-handers bashing English bowlers in the T20I format has been a love affair that became famous with Yuvraj Singh's exploits in the 2007 T20 World

Mentored by Yuvraj, Abhishek put his power-hitting ability on exhibition in the series opener against English tearaways. It was the second-fastest fifty by an Indian against England in the T20I format.

Abhishek's mentor, Yuvraj, holds the record for hammering the fastest fifty, brought up in just 12 deliveries in Durban in 2007, KL Rahul's heroics in Manchester, in 2018 saw him celebrate his fifty in 27 deliveries.

Maharashtra's Ankit Bawne suspended for dissent in Ranji Trophy

NASHIK. Jan 23 (Agencies): Maharashtra batter Ankit Bawne has been handed a one-match suspension for showing dissent during a Ranji Trophy match. The decision was conveyed to the team ahead of their sixth-round Group A clash against Baroda in Nashik, reported ESPNcricinfo.

The incident in question occurred during Maharashtra's fifthround game against Services, prior to the white-ball season. Bawne, serving as the stand-in captain, refused to leave the field after being declared out despite clear evidence suggesting the ball had bounced before Shubham Rohilla completed the catch at slip off spinner Amit Shukla. With no Decision Review System (DRS) available as the match was livestreamed rather than televised. Bawne was unable to challenge the umpire's decision. Ankit Bawne's pro-

test delayed the game for nearly 15 minutes before play resumed following intervention by match referee Amit Sharma and Maharashtra coach Sulakshan Kulkarni. The situation drew further attention when regular Maharashtra captain Ruturaj Gaikwad, who was in Australia with India A at the time, shared replays of the controversial dismissal on social media.

"Players are subject to fines and reprimand, what about proper assessment of umpires,"



Kulkarni said, as quoted from ESPNcricinfo.

"Why do the same erring umpires continue to officiate and play spoilsport? When there are blunders of this nature, the anger is justified," he added.

Bawne has been a key performer for Maharashtra this season, amassing 361 runs in five matches at an average of 51.57, including a century and two halfcenturies. However, his

absence for the Baroda match will be a significant setback for the

India will adhere to ICC's dress code at Champions Trophy: BCCI

NEW DELHI, Jan 23 (Agencies): The Indian cricket team will adhere to the dress code set by the ICC during the upcoming Champions Trophy, BCCI secretary Devajit Saikia told agency, rejecting speculation that the Board had objected to host Pakistan's name on the side's official jersey.

The Champions Trophy will be held from February 19 and India will play its share of matches in Dubai after citing security concerns as the reason for refusing to travel to Pakistan.

"BCCI will follow every uniformrelated ICC rule during Champions Trophy," Saikia told agency.

"Whatever the other teams will do regarding the logo and dress code, we are going to follow in true letter and spirit," he added.

However, Saikia said that whether national captain Rohit Sharma participates in the ICC's pre-tournament engagements, including a press conference and an official photo shoot in Lahore, is something that is still being discussed.

"Whether Rohit Sharma travels to Pakistan for ICC media engagements is something that's still not decided," Saikia added.

There were some unconfirmed media reports that the BCCI had objected to the host nation's name being embossed on their jersey, which is an established practice for all ICC events, owing to the tense political ties between the two countries.

It is understood that there was never any doubt about following the logo guidelines and the BCCI did not raise concerns with the global body.

When Pakistan came to India in 2023 for the 50-over ICC World Cup, Babar Azam and his men duly sported the host country's name on their jerseys as part of

the tournament protocol. The Champions Trophy is being conducted under a 'Hybrid Model' for the first time as BCCI didn't get permission from the Indian government to travel to Pakistan.

India will play all its matches,

including the marquee league match against the arch-rivals from across the border, in Dubai. In case, the Indian team reaches the semi-final and subsequently final, the two matches will be played in Dubai as well.

As far as Rohit Sharma visiting Pakistan is concerned, the matter is still under consideration and there are certain issues that the Indian cricket board needs to consider if its captain visits Pakistan for a customary photo-shoot and pre-event press conference.

It remains to be seen if the ICC decides to hold these events in Pakistan or shift the pre-tournament captains' engagements to the UAE.

Even that would be a massive logistical task for all other teams, which are playing in Pakistan.

The opening match of the tournament between hosts Pakistan and New Zealand will be held in Karachi on February 19. India will start their campaign against Bangladesh a day later.

Dimple meets Dr Farooq abdullah, demands to intensify efforts for restoration of J&K statehood

JAMMU, Jan 23: Sunil Dimple, President of Mission Statehood, on Thursday held a meeting with Dr. Farooq Abdullah, National Conference President and leader of the INDIA bloc, to discuss pressing issues concerning the people of Jammu and Kashmir, including development, employment, and the challenges faced by traders and youth.

Dimple congratulated Dr. Farooq Abdullah on the successful completion of three months of the Omar Abdullah-led National Conference government.

Dr. Abdullah reiterated his party's commitment to restoring Jammu and Kashmir's statehood, special status, and Article 370, stating that these were integral to the region's identity and rights, originally granted by Maharaja Hari Singh to

protect the land and jobs of its people.

Dr. Abdullah criticized the Bharatiya Janata Party (BJP) for dismantling the state into two union territories and for transferring J&K's power projects to other states, which he claimed had led to increased unemployment since August 5, 2019.

conditions.

He urged Dr. Abdullah to intensify efforts to coun-

ter the BJP's decisions of August 5, 2019, which he described as unconstitutional and unacceptable to the people of Jammu and Kashmir.

Dimple also called for practical measures to alleviate the hardships faced by residents, including resuming the Darbar Move from April 2025, providing free solar lights to poor families, allocating 200 units of free electricity, 12 LPG cylinders, and double rations to the public.

The two leaders discussed strategies for addressing unemployment and resolving issues related to various worker categories, including daily wagers, SPOs, vocational trainers, land donors, contractual lecturers, home guards, and others.
