PTI flag, **balloons** found hanging on walnut tree in Doda

DODA, Feb 9 (Agencies): A flag of Pakistan Tehreek-e-Insaf (PTI), the party led by former Pakistani Prime Minister Imran Khan, was found entangled with a cluster of balloons on a walnut tree in Gurekhra village of Gandoh, in Jammu and Kashmir's Doda district, on Saturday

evening, officials said. Images and videos from the scene show the PTI flag suspended among the tree branches, caught with colorful balloons, as per visuals available. The incident has raised concerns, prompting local authorities to initiate an investigation into its origin and significance.

A police official, speaking on condition of anonymity, confirmed that security agencies are verifying all aspects of the case. "We are assessing whether this was an intentional act, cross-border mischief, or merely an airborne object carried by the wind," the official said.

Instances of Pakistani political symbols appearing in Jammu and Kashmir have been reported in the past, often leading o security alerts. Author ities remain vigilant to prevent any potential unrest or misinterpretation of the event.

Further details will be shared following the investigation, officials added.

J&K Police intensify inspections to curb misuse of SIM cards by Terrorists

SRINAGAR, Feb 9 (Agencies): Police have ramped up efforts to curb the misuse of Subscriber Identity Module (SIM) cards by terrorists and criminal elements and carried out extensive inspections in Jammu and Kashmir, officials said.

Police on Sunday said extensive inspections have been carried out across multiple districts, including Srinagar, Ganderbal, Anantnag, Budgam, Pulwama, Shopian, Bandipora, Samba, and Kishtwar, to ensure strict compliance with Know Your Customer (KYC) norms

by SIM card vendors. Over the past year, more than 30 individuals have been arrested for procuring SIM cards in their names and passing them on to terrorists for unlawful activities,

police said.

These measures aim to prevent unauthorised issuance and misuse of SIM cards, maintaining the security and integrity of communication networks.

Liquor, Non-Veg Food prohibited around Vaishno Devi Shrine for two more months

JAMMU, Feb 9 (Agencies): Authorities have extended by two more months the ban on the sale, possession and consumption of liquor and non-vegetarian food in Katra, the base camp for pilgrims visiting Mata Vaishno Devi shrine in Jammu and Kashmir's

Reasi district, officials said on Sunday.

The prohibition will be enforced on the 12-km track from Katra to the holy cave on the Trikuta hill and adjoining areas, they said and added that the order would remain in force for two months from the date of its issuance, unless revoked earlier.

Katra sub-divisional magistrate Pivush Dhotra has prohibited the sale, possession and consumption of liquor and non-vegetarian food, under Section 163 of the Bharatiya Nagarik



Director Agriculture Jammu inspects developmental activities at RS Pura Sub Division

JAMMU, Feb 9: The Director of Agriculture Production & Farmer Welfare Jammu, Shri Arvinder Singh Reen, conducted a comprehensive inspection of the ongoing developmental activities in the RS Pura Sub Division today. The visit aimed to assess various field activities and highlight the advanced farming techniques being implemented in the region. On this occasion, Ex-Sarpanch Balbir Kour, SDAO RS Pura Surinder Gupta, Subject Matter Specialists, Agriculture Extension Officers and the staff of the Sub-Division Agriculture Office RS Pura were also present. The tour began with a demonstration of drone technology for foliar spraying of Nano Urea and Sagrika in the Panchayat Trewa area of RS Pura. Wheat crops were sown using a super seeder, and the fertilizers were precisely applied using drones, ensuring uniform distribution and minimal wastage. Nano Urea, which enhances nitrogen use efficiency. and Sagrika, a growthpromoting fertilizer, were the key inputs. Director A.S. Reen emphasized the revolutionary approach to modern farming and the potential to improve crop yield and

reduce labor costs with this technology. "The use of drones in this demonstration is a game-changer for farmers," said Director Agriculture. "It not only highlights an innovative method for crop management but also shows how technology can reduce costs and enhance productivity in the agricultural sector. Later, Director A.S Reen visited the Polycarbonate Structure (Nursery Unit) of Beneficiary Tilak Raj in Village Puro Bhana. This nursery, with a size of 111 sq. meters, is part of the Promotion of Commercial Floriculture (HADP) initiative. The Director also inspected a Green Shade Net House (148 sq. meters) under the same program, where he discussed the advantages of these structures in promoting commercial floriculture in the region. Further, the Director visited the Potato Seed Village at Arnia, where he examined the ongoing harvesting operations. He also inspected a Hi-Tech Polyhouse (500 sq. meters) under the Promotion of Exotic Vegetables (HADP), belonging to

Beneficiary Raman Gupta in Village Badyal Brahmina. Director highlighted the immense benefits of the poly house for cultivating exotic vegetables, including employment generation for local communities

Continuing his tour, Director A.S Reen visited the Micro Irrigation Unit (Drip Irrigation) of Beneficiary Rajinder Kumar in Village Badyal Brahmana, Zone Kirpind. He underscored the importance of microirrigation in enhancing water use efficiency, particularly in dry and waterscarce regions.

Death may be just an illusion..... nothing else....!

Then it comes to the mysteries of our universe and human life, the biggest mystery that many are curious, but also clueless about, is death. Religions have called death the only truth and afterlife as the gift (or curse) that we get depending on our conduct on this planet.

But none of this has been proven -- no one really knows what lies ahead. However, one American medical doctor and scientist, Robert Lanza, in his book, Biocentrism, states that death could actually be a door to an endless number of universes.

Einstein said "Now Besso has departed from this strange world a little ahead of me. That means nothing. People like us ... know that the distinction between past, present and future is only a stubbornly persistent illusion."

New evidence continues to suggest that Einstein was right, death is an illusion.

Most fundamental law of Nature. Conservation of energy. Energy can neither be created nor destroyed; rather, it can only be transformed or transferred from one form to another.

When star ends its life, turn into dust, and by gravity into another star. Even 100% of momentum is conserved. Energy is conserved in 100%, only changes form. There is no "death" in this Universe.

When one ends life, only make space for other forms of life. All carbon, nitrogen, hydrogen, oxygen, and other elements that build human being and any other life on Earth, do not change in moment of death. Nothing happens. Same elements will be used to build other form of life very soon.

We don't come into this world, we come out of it. Like a mushroom coming to the surface. In fact the mushroom is only the fleshy fruit body of the much bigger fungal network in the soil. If the mushroom gets eaten or cut off it doesn't affect the fungal network underground. Similarly we could be seen like a fruit growing out of this world. We identify with this "fruit" and we say we are a separate being. Therefore many people are terrified by the thought of death and disappearing into nothingness forever. Because we are just this little mushroom on the surface, isolated, fragile and helpless against all the predators and dangers, standing there alone not knowing where we came from and where we're heading, not knowing that we are connected with the giant fungal network in the ground, that we in fact are this whole network. Another example is golden jewelry. There are all kinds of forms, rings, chains, crosses etc. made from gold. But in fact the nature of all these different items is not its form but the gold itself. The form of the gold is just in our minds, our minds give meaning to it. But it can be molten and remodeled into other shapes and it remains just gold.

The state we are in now, thinking of ourselves as separate beings that have a start and an end, would be fake and the state after and before it would be the reality. So if that was true, the question of what happens after death would be irrelevant as we were never this separate being in the first place. One could say we were never born and will never die.

We believe in death because we've been taught we die. Also, of course, because we associate ourselves with our body and we know bodies die. End of story. But biocentrism, a new theory of everything, tells us death may not be the terminal event we think. Amazingly, if you add life and consciousness to the equation, you can explain some of the biggest puzzles of science. For instance, it becomes clear why space and time—and even the properties of matter itself—

depend on the observer. It also becomes clear why the laws, forces, and constants of the universe appear to be exquisitely fine-tuned for the existence of life.

Until we recognize the universe in our heads, attempts to understand reality will remain a road to nowhere.

Consider the weather 'outside': You see a blue sky, but the cells in your brain could be changed so the sky looks green or red. In fact, with a little genetic engineering we could probably make everything that is red vibrate or make a noise, or even make you want to have sex, as it does with some birds. You think its bright out, but your brain circuits could be changed so it looks dark out. You think it feels hot and humid. but to a tropical frog it would feel cold and dry. This logic applies to virtually everything. Bottom line: What you see could not be present without your conscious-

In truth, you can't see anything through the bone that surrounds your brain. Your eyes are not portals to the world. Everything you see and experience right now, even your body, is a whirl of information occurring in your mind. According to biocentrism, space and time aren't the hard, cold objects we think. Wave your hand through the air-if you take everything away, what's left? Nothing. The same thing applies for time. Space and time are simply the tools for putting everything together.

Consider the famous two-slit experiment. When scientists watch a particle pass through two slits in a barrier, the particle behaves like a bullet and goes through one slit or the other. But if you don't watch, it acts like a wave and can go through both slits at the same time. So how can a particle change its behavior depending on whether you watch it or not? The answer is simple, reality is a process that involves your consciousness.

Or consider Heisenberg's famous uncertainty principle. If there is really a world out there with particles just bouncing around, then we should be able to measure all their properties. But you can't. For instance, a particle's exact location and momentum can't be known at the same time. So why should it matter to a particle what you decide to measure? And how can pairs of entangled particles be instantaneously connected on opposite sides of the galaxy as if space and time don't exist? Again, the answer is simple: because they're not just 'out there'-space and time are simply tools of our mind.

Death doesn't exist in a timeless, space less world. Immortality doesn't mean a perpetual existence in time, but resides outside of time altogether.

Our linear way of thinking about time is also inconsistent with another series of recent experiments. In 2002, scientists showed that particles of light "photons" knew, in advance, what their distant twins would do in the future. They tested the communication between pairs of photons. They let one photo finish its journey—it had to decide whether to be either a wave or a particle. Researchers stretched the distance the other photon took to reach its own detector. However, they could add a scrambler to prevent it from collapsing into a particle. Somehow, the first particle knew what the researcher was going to do before it happened, and across distances instantaneously as if there were no space or time between them. They decide not to become particles before their twin even encounters the scrambler. It doesn't matter how we set up the experiment. Our mind and its knowledge is the only thing that determines how they behave. Experiments consistently confirm these observerdependent effects.

Hi! Is Election Commission Really Dead?

t is height of moral bankruptcy of the Smajwadi Party chief and former chief minister of UP that he has stooped abysmal low and equated Election Commission as Dead perhaps saying that the ECI does not take cognizance of the election malpractices by the ruling BJP in Milkipur Ayodhya by polls .It is very unfortunate, disturbing that SP Supremo Akhilesh Yadav leveled serious accusations against the BJP ,alleging electoral misconduct and also declaring the Election Commission "dead. "It is nothing beyond ideological and moral bankruptcy and it can be termed as dirty politicking through and through. He claimed that the ruling party ,with police assistance ,engaged in widespread voter suppression and malpractices in Milkipur by polls. "This is the manner in which BJP contests elections. The Election Commission is dead . We will have to gift them white cloth ,"the SP Chief told ANI ,criticizing what he described as deliberate manipulation of electoral proceedings. Akhiles Yadav is leveling baseless and unsubstantiated allegations and accusations on ruling BJP and election commissions silence and has used most un -parliamentary and bad language to describe the election commission which in fact is the independent, impartial and non-partisan institution of the country. To call ECI dead is absurd and amounts to dishonor of this autonomous agency of the country. Election commission is up and doing and its activism is worth appreciating and again it is energetic and living and to call it dead is absurd and grossly incorrect and misleading. The former UP chief minister stated that police officials were illegally checking voters ID at polling stations, which he viewed as voter intimidation .Ayodhya Milkipur went to polls on Wednesday and saw 57.13% voter participation .In a post on X ,he said, "The election Commission should immediately take cognizance of the pictures related to this news that Ayodhya police is checking the ID cards of voters in Milkipur ,in which senior police officers are also involved . This is

a democratic crime of indirectly influencing voting by creating fear among voters .Such people should be removed immediately and punitive action should be taken. "He alleged that BJP supporters caused disturbances at several locations under police protection, with officials deliberately overlooking violations of electoral conduct. Yadav also pointed out issues with EVM's mentioning that disruptions at locations like Kutta Amaniganj lasted over two hours, preventing voter participation. However Ayodhya police countered these claims, clarifying that they were only verifying booth agents credentials and accused Yadav of spreading false information.BJP Spokesperson Rakesh Tripathi dismissed these allegations as unfounded and indicative of SP's anxiety over anticipated defeat ."The Samajwadi Party is spreading lies out of frustration after its imminent loss in Milkipur,"he stated, accusing Yadav of using propaganda to deflect responsibility .It is very absurd and obnoxious that the former UP CM called the Election Commission "dead" for failing to perform duty ."The Election Commission is completely dead ,the EC has killed its conscience and has mortgaged it to the BJP .We will have to get them white cloth.The election commission helps the BJP and not acted upon the overwhelming evidence of foul play and large-scale rigging in Milkipur ,"Mr. Yadav said outside parliament in New Delhi. Traditionally ,bypolls have witnessed a much reduced voter turnout than the assembly elections but this time there was significant rise in voter participation and Akhilesh is nerved on this increased voter turnout and he smell the victory of BJP in this bypoll .Milkipur Assembly seat in Ayodhya ,UP recorded a voting of 65.35% in the bypoll conducted on February 5—a remarkable jump of more than 5% turnout from 2022 -amid allegations of voting irregularities ,intimidations of opposition booth agents ,bogus voting and attempts by police to influence the voting in favor of the BJP. The ECI said they found no irregularities in voting. After the BJP suffered an embarrassing defeat in the Faizabad Lok Sabha last summer ,the party cannot afford to lose Mal-

kipur. The Opposition also views Malkipur as its opportunity to balance its defeat in the bypolls held in November last when the BJP won seven out of nine seats ,amid large scale complaints of communally -targeted voter suppression and misuse of administrative power by the ruling party. After Adityanath dismissed Avadesh Prasad's emotional breakdown as "nautanki" [theatrics], the senior SP leader launched a massive counter -attack to have the final say before Milkipur braces itself to vote." They have called me a dog, referred to me as the tail of a dog. My heart is aching .The ministers of this [Uttar Pradesh] government have said that since people here elected a Dalit as their MP, the dignity of Ayodhya has fallen ,"said Prasad. The 79 year -old veteran leader ,who has won nine Assembly elections since 1977, was reflecting on the personal hurt he was feeling due to insults by Adityanath –led BJP. It is conventional for politicians to make emotional appeals during elections ,but Prasad's assertion of his Dalit identity and evocation of caste-linked insults truly launched the question of caste to the centre stage of the February 5 election. This appears detrimental to saffron party, which has tried to communalize the election on religious grounds . However, the micro issues have been overshadowed by Awadhesh Prasad's emotional reaction to the murder of a young Dalit women whose body was found in a field in Ayodhya on February 1.Accussing the central and UP government of rigging Milkipur bypoll ,SP Chief Akhilesh Yadav said the Election Commission was" dead" and should be covered with" white cloth" [as coffin] because it failed to ensure free and fair election despite innumerable complaints from SP on the polling day and earlier as well. "I had come to Parliament else I would have brought a white cloth to cover the Election Commission,"Akhilesh said .Later ,the SP leader along with all party MP's ,staged a protest carrying a white sheet of cloth in hand .with Chunav Ayog written on it .In response ,the BJP strongly criticized Yadav's remarks .Party MP Sambit Patra condemned Yadav's statement about EC, calling it an attack on a constitutional institution

.Patra noted that the opposition has a history of targeting institutions when electoral outcomes do not go their way ."This is a new low .The SP has no respect for constitutional bodies .Such language has never been used in the parliament proceedings before ,"Patra said.BJP MP Praveen Khandelwal also condemned the remarks, saying that the opposition repeatedly attacks constitutional institutions after losing elections .He called for an apology from Yadav and SP, saying their words were an insult to democracy .In fact the ECI is performing its constitutional responsibility and duty very well .It is ensuring free and fair elections anywhere and everywhere in the country and thus to accuse it of silence and inertia is absolutely worng .it is in fact the EC which manages the elections in the country and to call it dead is politics at its very low..The opposition calls EVM's choor when they fail to win an election and when they win .EC is doing its job well. It is indeed double speak of Opposition .Calling EC dead is very unfortunate and absurd and it is insult to the constitution as ECI is an constitutional body which is entrusted to manage elections across the country. MAHAKUMBH NAGAR (UP), Feb 9 (Agencies): A section of the sadhus are unhappy with the chatter around viral sensations at the Maha Kumbh, saying they divert attention from what the festival is

really about - spiritual-

ity and faith of devotees. "Mahakumbh is not a hub of glamour and five-star culture, it is the centre of sadhus, devotees and the Sanatan faith," said Mahant Dharmendra Das, head of Udasin Akhara Bandhua Kala Cantonment and chairman of All India Udasin Communal Sangat.

Since the beginning of the Maha Kumbh last month, many influencers, models and actors have had their brief moment in the sun of virality: modelturned-sadhvi Harsha Richaria, garland seller Mona Lisa, 'IIT baba' Abhay Singh and actor Mamata Kulkarni to name a few.

"If the media promotes such people instead of serving so many sadhus, then the fault lies with the media. Why are media houses doing this? You people should think about it yourself," Das told agency in an interview at Sector 20 of Triveni Road Mela Sthal in Prayagraj Mahakumbh.

Das said many devotees come to the Sangam to spend the night under the open sky and bathe in the Ganga. They are unbothered by arrangements made for them and uninterested in "glitz and glamour" or "big tents".

He said this referring to the stampede on Mauni Amavasya, considered to be the most auspicious day of the festival, in which many people were killed.

"The officials were more interested in giving special facilities to their relatives and friends and they spoiled the efforts of Yogi Adityanath," he

When asked if the tragedy could have been averted had there been better facilities for the devotees, Das said "Some devotees have such faith that they come here and sleep on the sand. You can build as big a tent city as you can, make all the arrangements but there is some faith and love for Ganga in some people — they stay on the sand and spend the night under the open sky and go home after bathing in the morning." If 50 crore people are expected at the Maha Kumbh, 15-20 crore are of this type, he said. According to the UP government, nearly 39 crore pilgrims have visited the Maha Kumbh till February 6.

On the stampede, he called for an investigation into who ordered the closure of pontoon bridges "due to which a huge crowd gathered at the Sangam Nose" where the stampede occurred.

UP government has formed a judicial commission and now it is their responsibility to find who is at fault, he said. Police blamed abrupt overcrowding for the incident.

When asked about Samajwadi Party chief Akhilesh Yadav's allegations of "mismanagement" at the Kumbh, he said, "This is a 'mela', not a five-star hotel. Those who spend time on the banks of Ganga, sing bhajans in the morning and return after their 'snan' are not troubled. Those who want five-star service are troubled." Opposition parties have decried the stampede as Adityanath's mismanagement of the mega gathering.

The Maha Kumbh in Prayagraj began on January 13 and will continue till February 26.

Akhilesh demands toll fee waiver for vehicles in UP during Maha Kumbh

be made toll free on the grand festival of Maha Kumbh?"



31 Naxalites, 2 cops killed in encounter in Chhattisgarh's Bijapur

BIJAPUR. Feb 9 (Agencies): In a major operation against Left Wing Extremism, security forces gunned down 31 Naxalites during an encounter in Chhattisgarh's Bijapur district on Sunday, police said.

Two security personnel were also killed and as many others injured in the face-off, they said. With this incident, 81 Naxalites have been gunned down by security forces in separate encounters in the state so far this year.

The latest gunfight took place at a forest in Indravati National Park area in the morning when a joint team of personnel from different security forces was out on an anti-Naxalite operation, Inspector General of Police,

Two security personnel, one belonging to the state police's District Reserve Guard and the other from the Special Task Force, were also killed in the gunfight and two others suffered injuries, he said. The two injured jawans, report-

Reinforcement has been rushed to the spot and search operation is still underway in the area, he added.

Out of the 81 Naxalites gunned down in the state so far this year, 65 were killed in the Bastar division comprising seven districts, including Bijapur.

Last year, 219 Naxalites were neutralised by security forces in separate encounters in Chhattisgarh, according to police.

Hazare happy at Kejriwal's defeat, silent on allegations against Modi govt, claims Raut

MUMBAI, Feb 9 (Agencies): Veteran social activist Anna Hazare is happy at the defeat of Arvind Kejriwal in the Delhi Assembly polls, Shiv Sena (UBT) leader Sanjay Raut said on Sunday.

The BJP ended the Aam Aadmi Party's reign in Delhi by winning 48 seats in the 70-member Assembly there. Among the prominent losers was Kejriwal from New Delhi constituency. Raut also questioned the silence

of Hazare on corruption allegations made over the past some years against the Narendra Modi government at the Centre.

"Where was Hazare when corruption occurred during Modi's rule? Hazare is happy over Kejriwal's defeat. The country is being looted with wealth concentrated in the hands of a single industrialist. How can democracy continue in such a situation? What could be the secret behind Hazare's



silence at such a time,'

Raut questioned. "There was a similar pattern regarding voters' list confusion in Maharashtra as well as in Delhi. However, Hazare chose to remain silent

on such issues. Similar complaints were made in Haryana as well. These will come up in the Bihar polls too," the

Manipur police arrest three militants in Imphal West; two from UNLF-Pambei, one from PLA

IMPHAL, Feb 9 (Agencies): Manipur Police arrested three militants from Imphal West district, an officer said on Sunday.

Police arrested two militants of the banned United National Liberation Front (UNLF-Pambei) group from Narankonjil area of the district on Saturday.

The two militants were involved in extortion activity and also in illegal smuggling of arms and ammunition, the officer said.

One .32 pistol and Rs 3,120 in cash was seized from their possession, he said.

One militant of the banned outfit People's Liberation Army (PLA) involved in extortion activity was arrested from Kangjabi Leirak Machin area on Saturday, the officer added.

Trump is signing up local law officers to help with immigration enforcement

Advocates for immigrants, meanwhile, are raising alarm about new pacts that put local law officers on immigration enforcement

WASHINGTON, Feb 9 (Agencies): For years, the Hamilton County Sheriff's Office in suburban Indianapolis has wanted to partner with federal immigration authorities to identify and detain immigrants who are in the US illegally and facing charges.

President Joe Biden's administration never returned its calls, the sheriff's office said. But as President Donald Trump cracks down on illegal immigration, Hamilton County deputies soon could become the first in Indiana empowered to carry out federal immigration duties and one of many nationally that Trump's administration hopes to enlist.

"We definitely are joining," Chief Deputy John Lowes told agency. "We want to collaborate with ICE to make sure we keep our community safe."

Under Trump, US Customs and Immigration Enforcement is reviving and expanding a decades-old programme that trains local law officers to interrogate immigrants in their custody and detain them for potential deportation. The 287(g) programme — named for a section of the 1996 law that created it currently applies only to those already jailed or imprisoned on charges.

But Trump's border czar, Tom Homan, recently told sheriffs that he wants to expand it to include local task forces that can make arrests on the streets, reviving a model that former President Barrack Obama discontinued amid concerns about racial profiling. It's unclear whether that could allow local officers to stop people solely to

check their immigration status. Florida Gov. Ron DeSantis announced that the Florida Highway Patrol had struck an agreement with ICE to interrogate, arrest and detain immigrants suspected of being in the country illegally and deliver them to federal authorities.



The arrangement will help "fulfill the president's mission to effectuate the largest deportation program in American history." DeSantis said.

Advocates for immigrants, meanwhile, are raising alarm about new pacts that put local law officers on immigration enforcement.

"All of these agreements, in practice, have the same track record of racial profiling, of sweeping in US citizens or people who have lawful status, of having a chilling effect in terms of communities reporting crime to local law enforcement agencies," said Nayna Gupta, policy director at the nonprofit American Immigration Council.

In the early 2000s, many of the initial participants in the 287(g) programme had agreements that allowed them to enforce immigration laws in their communities, not just their jails. But problems arose in several places, including Arizona.

In 2011, a civil rights investigation by the US Department of Justice found that deputies in Maricopa County, which includes Phoenix, had engaged in a pattern of racial profiling, unlawful stops and arrests of Latinos. The Department of Homeland Security ended its agreement with the county.

The program became "the hallmark of far-right, anti-immigrant sheriffs" as a means "to feed people on the basis of

their ethnicity into the deporta-

tion machine," asserted Lena

Graber, senior staff attorney at

the nonprofit Immigrant Legal

Resource Center. In recent years, ICE has offered two types of 287(g) agreements to law enforcement agencies. One model requires four weeks of training and allows local officers to question suspected noncitizens who are jailed on other charges and detain them for ICE. The other model, which Trump launched during his first term, requires just eight hours of training and only allows local officers to serve federal immigration warrants.

As of December, ICE had 135 agreements with sheriff's offices, police departments and prison systems in 21 states, with requests pending from 35 others. Two-thirds of the agreements were in just three states - Florida, Texas and North Carolina. But no agreements had been signed during Biden's four years as president, according to ICE data.

On his first day back in office, Trump ordered the Department of Homeland Security to maximize 287(g) agreements for local law officers to investigate, apprehend and detain immigrants. At a recent National Sheriffs' Association conference, Homan said the administration is looking to lighten detention facility regulations and shorten the training to encourage greater collaboration with federal immigration officials. The association's president,

Kieran Donahue, applauded the announcement.

"There's going to be local sheriffs' offices throughout the country, no question, they're going to sign onto this program," Donahue told the AP.

But Donahue is not planning to sign up his own department in Canyon County, Idaho.

"I don't have that kind of manpower," he said, adding: "I have no bed space in my facility. Zero."

The Florida Department of Law Enforcement in 2002 was the first to sign a 287(g) agreement with the federal government, running a task force for immigration enforcement. Twenty years later, Florida became the first state to require all local agencies with county jails to join the program or inform the state why they couldn't.

After a Venezuelan man who was illegally in the U.S. killed University of Georgia student Laken Riley, Georgia passed a law last year requiring local law enforcement agencies to apply for the programme.

This year, Republican lawmakers in about a dozen states are seeking to require or incentivize cooperative agreements with ICE. One measure is sponsored by Texas state Rep. David Spiller, a Republican who also authored a law allowing any law enforcement officer to arrest migrants suspected of entering the country illegally. That law is on hold amid a legal challenge. Spiller said mandatory participation in ICE programs is

essential. "President Trump and border czar Homan cannot remove and deport all the people that are a public safety threat to our state and our nation over the next year and a half without the help

of our local law enforcement,"

Spiller said.

N Korea blames US, Japan, **South Korea for tensions** in region; vows to bolster nuke forces

SEOUL, Feb (Agencies): North Korean leader Kim Jong-un, whom American President Donald Trump says he shares a good relationship with, has blamed the United States, Japan and South Korea for escalating tensions in the region, saying the allies' military cooperation has destabilized the security environment, as per state media of the nucleararmed country.

In his speech during his visit to North Korea's Ministry of National Defence, Kim referred to a series of new plans for bolstering "all deterrences" and reaffirmed the country's "unshakable policy of more highly developing the nuclear forces," Yonhap reported citing the Korean Central News Agency (KCNA).

Further, the North Korean leader criticizdc the United States for "standing in the centre behind the scene of the war machine," Japanese news outlet Kyodo report cited KCNA.

US nuclear strategic assets deployed on the Korean Peninsula. the US-led nuclear war simulation exercises and the US-Japan-South Korea military cooperation are "inviting military imbalance" on the peninsula and in Northeast Asia, causing "a new conflicting structure" and posing a grave challenge to North Korea, Kim was quoted as saying.

While stressing the need for vigilance against the trilateral "military alliance," Kim also voiced concern that their collaboration could bring about the formation of a "NATO of Asian version," the Korean news agency further said.

The development came after the first inperson summit between Donald Trump and the Japanese Prime Minister Shigeru Ishiba in Washington on February 7.

Kim also blamed the US for the Russia-Ukraine war, expressing "serious concern" that the US and Western countries are prolonging the war with the "unrealizable dream to deal strategic setbacks to Russia.

Notably, North Korea is an active participant in the war in Ukraine with having deployed over 11,000 troops to assist Russian President Vladimir Putin's war effort.

After White House released a statement saying that Washington will seek "complete denuclearization of North Korea," under Trump, North Korea said Saturday its nuclear weapons are not a "bargaining chip" but designed for combat use against any attempts by its enemies to invade the North, reaffirming its stance to further develop its nuclear arsenal.

Meanwhile, Trump said that the US "will have relations with North Korea" at a joint press conference with Japanese PM Shigeru Ishiba.

"We had a good relationship and I think it's a very big asset for everybody that I do get along with him. I get along with him, he gets along with me. And that's a good thing, not a bad thing," Trump said.

In his first term as US President, Trump had held two summit meetings with Kim in Singapore in June 2018 and a second summit in Hanoi, Vietnam in 2019.

Sam Nujoma, Namibia's fiery freedom fighter, first president, dies aged 95



WINDHOEK, Feb 9 (Agencies): Sam Nujoma, the fiery freedom fighter who led Namibia to independence from apartheid South Africa in 1990 and served as its first president for 15 years, and was known as the father of the nation, has died. He was 95.

Nuioma's death was announced Sunday by current Namibian President Nangolo Mbumba. Mbumba said Nujoma died on Saturday night after being hospitalised in the capital, Windhoek.

Nujoma was revered in his homeland as a charismatic father figure who steered his country to democracy and stability after long colonial rule by Germany and a bitter war of independence from South Africa.

He was the last of a generation of African leaders who led their countries out of colonial or white minority rule that included South Africa's Nelson Mandela, Zimbabwe's Robert Mugabe, Zambia's Kenneth Kaunda and Mozambique's Samora Machel.

Many Namibians credited Nujoma's leadership for the process of national healing and reconciliation after the deep divisions caused by the independence war and South Africa's policies of dividing the country into ethnically based regional governments, with separate education and health care for each race.

Even his political opponents praised Nujoma — who was branded a Marxist and accused of ruthless suppression of dissent while in exile — for establishing a democratic Constitution and involving white businessmen and politicians in government after inde-

Despite his pragmatism and nation-building at home, Nujoma often hit foreign headlines for his fierce anti-Western rhetoric. He claimed AIDS was a man-made biological weapon and also occasionally waged a verbal war on homosexuality, calling gays "idiots" and branding homosexuality a "foreign and corrupt ideology".

Army should return to its constitutional limits: Imran Khan

9 (Agencies): Jailed former Pakistan premier Imran Khan on Sunday penned an open letter to Army chief Gen Asim Munir in which he criticised the military's unlawful actions and its engagement in politics and urged it "to return to its constitutional limits".

In the letter posted on X, the Tehreek-i-Insaf (PTI) founder alleged mistreatment in prison, including placing him in solitary confinement in a death-row cell for 20 days with no access to sunlight or electricity.

Khan has been incarcerated in Adiala Jail Rawalpindi for over a year.

This follows his first letter on February 3, which urged the military to review its approach towards national security and governance.

After the first letter, security sources said it had not been received by the military and dismissed reports in the media about its existence. They claimed that the establishment was not interested in receiving such a letter.

In his latest letter, Khan said the response to "my (first) letter was dismissive and irresponsible", adding that his concern "is purely for the reputation of our armed forces and the dangerous consequences of the widening gulf between the military and the public. This is why I wrote this letter".

He highlighted six points that have deepened the rift between the people and the mili-

These points included the manipulation of election results through prepoll rigging orchestrated by intelligence agencies, the forced passage of the 26th Constitutional Amendment in Parliament at gunpoint to take control of the judiciary and appoint handpicked judges and the imposition of draconian legislation like the amendments to PECA (Prevention of Electronic Crimes Act) to silence dissent.

Khan noted that political instability and the "might is right" policy plunged the country's economy into chaos. Khan regretted that the country's "largest political party" was being targeted and all state institutions were being used for political engineering and revenge.

He mentioned that if a public referendum were held on the six points he highlighted, "I believe that 90 per cent of Pakistanis would support them".

He said these alleged actions were not only harming public sentiment but also worsening the rift between the people and the army.

"For Pakistan's stability and security, it is imperative to bridge the growing gap between the military and the public," he wrote in the



letter.

"The only way to achieve this is for the military to return to its constitutional limits, disengage from politics and fulfil its designated responsibilities," he said.

The letter came after several leaders of Khan's party were arrested on Saturday as it held rallies to mark February 8 as 'Black Day' over the alleged rigging of the general elections last year.

"The army is a vital institution of the country, but a few black sheep within it are causing severe damage to its reputation," Khan said. Khan also accused a

military officer stationed at Adiala Jail of orchestrating harassment and rights viola-

tions against him.

pying' force," he alleged. Khan claimed that he was kept in complete isolation for 20 days in a dark cell with no access to sunlight. Electricity to his cell was cut off for five days, leaving him in darkness, and even his exercise equipment, television and newspapers were confiscated and access to books was arbitrarily restricted.

He claimed that he was allowed only three phone calls with his sons in six months, despite court orders permitting more. PTI workers travelling from distant areas were denied meetings with him.

He also accused the authorities of violating court orders by denying him meetings with his wife, Bushra Bibi, whom he alleged was being kept in solitary confinement.

He claimed that four

were politically motivated, with judges allegedly forced into issuing predetermined verdicts.

Khan said that one judge allegedly suffered severe stress-related health issues due to the pressure of ruling against him and that the PTI was being targeted through pre-poll rigging and forced electoral outcomes.

Khan said that on May 9, 2023, and Nov 26, 2024, the government allegedly brutally cracked down on peaceful PTI supporters.

"Live ammunition was fired at peaceful citizens. Under the guise of political retaliation, raids were conducted on the homes of hundreds of thousands of citizens over the past three years. More than 20,000 of our workers and supporters were arrested, while hundreds were abducted and subjected to torture," Khan alleged.

"Thousands of innocent people were imprisoned for months on false charges. Due to pressure from intelligence agencies, over 2,000 of our workers, supporters and party leaders have had their bail petitions indefinitely delayed by high court judges," he added.

He said the treatment of PTI's female supporters over the past three years had been shameful and deeply concerning. "Never before in politicians' female family members been targeted in this manner," he said.

"This goes against our traditions and has fuelled growing resentment against the military. If corrective measures are not taken immediately, the consequences for both the military and the country could be irreversible," he cautioned.

Khan warned that continued actions against PTI were deepening public resentment towards the military. He alleged that a few individuals within the institution were harming its reputation and causing lasting damage.

"Our soldiers are making sacrifices for Pakistan, and for success in the war against terrorism, it is essential that the nation stands behind its military," Khan wrote.

"However, it is deeply concerning that due to the establishment's policies and unlawful actions, public resentment towards the military is continuously increasing. This is a violation of the military's oath. No national army treats its own citizens this way," he alleged.

If corrective measures are not taken, the widening divide between the military and the Public will become a dangerous fault line in terms of national security, he said.

NEW DELHI, Feb 9 (Agencies): India's real estate sector is poised for massive expansion, projected to grow to USD 5.8 trillion by 2047, contributing 15.5 per cent to the country's GDP, up from the current 7.3 per cent, according to CIRIL report.

By 2030, the market size is expected to reach USD 1 trillion, a sharp rise from USD 200 billion in 2021. The retail, hospitality, and commercial real estate segments are also witnessing significant growth, providing crucial infrastructure for India's expanding economy.

The real estate market is set to maintain strong investment momentum in 2025, backed by robust domestic economic fundamentals and a strategic focus on technology and ESG (Environmental, Social, and Governance) integration in investment decisions. The government is expected to extend infrastruc-



ture development beyond metro cities to achieve its Vision 2047.

The sector has shown remarkable performance in 2024, with residential, office, logistics, hospitality, and retail segments expected to grow at a CAGR of 9.2 per cent between 2024-

2028. Urbanization, rental market growth, and steady price appreciation are key factors driving this upward trajectory.

Vijay Sarathi, Chairman of CIRIL, said, "We expect 2025 to continue its strong growth momentum with new invest-

ment avenues emerging in tourism and hospitality, retail, warehousing, co-working, and co-living projects."

India's economic growth is projected at 6.6 per cent in 2025, driven by private consumption and investment, according to a United Nations report. Increased capital expenditure on infrastructure is expected to have strong multiplier effects on economic expansion.

Investment in real estate remains strong, with Domestic Institutional Investors (DIIs) reaching a record-high 16.46 per cent market share in September 2024, up from 16.25 per cent, with net inflows of Rs1.03 lakh crore.

Despite foreign institutional investor (FII) outflows in October 2024, DII investment remained at record levels, a trend expected to continue in 2025.

Another rate cut expected by April if inflation remains favourable: SBI



NEW DELHI, Feb 9 (Agencies): The Reserve Bank of India's commitment to long-term price stability and sustained economic growth remains unwavering, with analysts anticipating another rate cut as early as April - provided inflation continues to trend favourably, according to SBI research.

SBI stated, "April could see the next rate cut again."

The policy's clear communication and data-driven approach reinforce market confidence while keeping regulatory scrutiny intact.

The central bank has acknowledged that food inflation remains a key factor, influenced by positive indicators like strong kharif production and easing vegetable prices, but also mentioned risks such as adverse weather events.

A key highlight of the policy statement is the emphasis on flexible inflation targeting (FIT). The RBI reaffirmed that FIT effectively combines rules with discretionary decisions, ensuring that

regulatory measures evolve based on economic conditions.

Reflecting this approach, the RBI has deferred the implementation of draft norms for the Liquidity Coverage Ratio (LCR), Expected Credit Loss (ECL), and provisioning guidelines, allowing for further assessment before enforcement.

The introduction of forward contracts in government securities (G-sec) is expected to enhance price discovery and liquidity. Allowing physical settlement alongside cash settlement will make bond trading more efficient.

The RBI has retained its FY25 inflation forecast at 4.8 per cent, with Q4 inflation projected at 4.4 per cent. For FY26, CPI inflation is estimated at 4.2 per cent.

As anticipated, the MPC has unanimously voted to adjust the repo rate for the first time in two years, lowering it by 25 basis points to 6.25 per cent.

The committee also reaffirmed its commitment to a neutral monetary policy stance, maintaining a clear focus on ensuring sustained alignment of inflation with the target while fostering economic growth.

The RBI Governor highlighted the effectiveness of the flexible inflation targeting (FIT) framework, emphasizing how the central bank has successfully managed to keep inflation within the prescribed range.

Union Bank of India sees lower inflation for FY25 and FY26 than MPC estimates

NEW DELHI, Feb 9 (Agencies): The Union Bank of India highlighted that inflation for FY25 could be lower than the Monetary Policy Committee's (MPC) revised forecast of 4.4 per cent, with Q4 FY25 Consumer Price Index (CPI) inflation likely tracking at 4 per cent. For FY26, the bank projects inflation at 4.0 per cent, slightly below the MPC's estimate of 4.2 per cent.

It has raised concerns over downside risks to India's growth and inflation projections for the coming years.

The UBI stated, "MPC revised FY25 growth projection to 6.4 per cent from 6.6 per cent previously even as it projects recovery to 6.7 per cent in FY26. We see downside risk to 6.4 per cent growth forecast for FY25 as it assumes Dec'24 quarter growth above 6.5 per cent while its tracking close to 6 per cent as of now."

It added, "However, we are still pencilling in FY26 growth at 6.5 per cent from 6-6.2 per cent this



year; 7 per cent growth in Q2 FY26 looks optimistic to us in the current global environment."

Looking ahead, the bank maintains an FY26 growth estimate of 6.5 per cent, though it remains cautious about the MPC's optimism regarding a 7 per cent growth rate in Q2 FY26 amid global economic challenges.

Union Bank of India maintains its view of a shallow rate cut cycle, initially expecting a total reduction of 50 basis points, with 25 basis

points already implemented.

Given the ongoing global uncertainty, the bank expects the Reserve Bank of India (RBI) to assess further rate cuts around April. It notes that with the MPC's 4.2 per cent CPI forecast for FY26, the repo rate is likely to settle at 6 per cent, while inflation risks will continue to be monitored closely.

The RBI-led MPC unanimously decided to reduce the policy reporate by 25 basis points to 6.25 per cent—the first rate cut in five years.

However, it maintained a neutral stance to retain policy flexibility amid global financial volatility, trade uncertainties, and potential climate-related disruptions. The committee emphasized that while growth is expected to recover from Q2 FY25 lows, it remains lower than the previous year.

Inflation is expected to moderate further in FY26, aligning with the 4 per cent target, supported by a favourable food inflation outlook and the transmission of past monetary policy actions.

Lab Grown diamonds will drive \$ 1 billion global diamond certification market by 2028: Report

NEW DELHI, Feb 9 (Agencies): The global diamond certification market is projected to grow to USD 1 billion by 2028, up from USD 600 million currently, driven by a 25 per cent increase in lab-grown diamond (LGD) certifications, according to Morgan Stanley.

In December, India's LGD imports surged by 50 per cent month-onmonth, while exports rose by 26 per cent, indicating inventory buildup and market share expansion.

India is a key player in the global LGD industry, ranking first in LGD exports with a 29 per cent market share. Alongside China, India accounts for nearly 80 per cent of global LGD production.



IGI is the secondlargest global diamond certification provider, holding a 33 per cent market share. It dominates 65 per cent of the LGD certification market and has a 42 per cent market share in studded jewellery certification.

In India, IGI enjoys
a 50 per cent market
share in certification
services, benefiting from
the country's position as

a hub for diamond cutting and polishing.

Certification is a defensive business with high barriers to entry, similar to credit rating agencies in the financial sector. The industry is largely controlled by Gemological Institute of America (GIA) and International Gemological Institute (IGI), which together account for 80 per cent of the global certification

market.

IGI, a key player in this industry, is well-positioned to benefit from this surge. The company is projected to enhance its EBITDA margins from 54.6 per cent in 2024 to 56.9 per cent in 2026, reinforcing its strong market presence and operational efficiency.

IGI is set for robust earnings growth, driven by rising demand for diamond certification services, particularly in the lab-grown diamond (LGD) segment, according to Morgan Stanley.

The company is expected to deliver a 14 per cent revenue CAGR over 2024-28, supported by strong growth in India (14 per cent), the Netherlands (16 per cent), and Belgium (13 per cent).

Some species are susceptible to broad range of viruses: Study

LONDON, Feb 9 (Agencies): A study on fruit flies revealed that certain species are extremely vulnerable to a variety of viruses.

In the study - by the

University of Exeter - 35 fruit fly species were exposed to 11 different viruses of diverse types
As expected, fly species that were less affected by a certain virus also tended to

viruses.
But the findings also show "positive correlations in susceptibility" to viruses in general. In other words, fly species that were resistant to one virus were generally resistant to others - including very different

respond well to related

types of virus.

"Large-scale tests like this help us understand how pathogens shift to new host species, with findings broadly applicable to other animals including humans," said Dr Ryan Imrie, now at the MRC-University of Glasgow Centre for Virus Research.

"These flies shared a common ancestor 50 million years ago, giving them equivalent diversity to mammals, and so we are asking questions over the evolutionary distances which host



shifts typically occur. Lots of people are trying to predict the next pandemic.

"It's impossible to test every virus, so we need to try and understand general rules about how viruses behave in new hosts."

Professor Ben Longdon, of the Centre for Ecology and Conservation on Exeter's Penryn Campus in Cornwall, added: "Information about new viruses can partly be inferred from their relatedness to existing viruses."

"However, a small number of mutations can change that - giving new viruses very different properties than their close relatives."

"Studies like this can help reveal the fundamental processes behind this."

Susceptibility in the study was measured by

"viral load" - how much a virus had replicated and persisted two days into an infection.

Explaining why some fly species might be generally poor at resisting viruses, Dr Longdon said: "Immunity is very costly, so the highly susceptible species in our study may be ones that evolved in an environment with relatively few viruses, or species that viruses are particularly well able to hijack and successfully infect."

"We found no negative correlations (where high resistance to one virus came with low resistance to another)."

"This could suggest that, as fruit fly immune systems have evolved in response to infection, they have not resulted in 'trade-offs' where increased resistance to one virus has decreased resistance to others."

More screen time may lower language development skills in toddlers: Study

NEW DELHI, Feb 9 (Agencies): Increased exposure to screens, such as television and smartphones, may lead to lower language development skills in toddlers, according to an international study.

The findings led by researchers from 20 Latin American countries found that book exposure and shared screen time with adults could boost language skills in toddlers

The researchers analysed data from 1,878 toddlers aged 12 to 48 months across Latin America between August 2021 and March 2023. The toddlers were evaluated based on parent-reported surveys of screen use, shared media engagement, book exposure, language skills, and developmental milestones.

The team also screened the socio-economic status of the participants to understand basic needs, parental education, and occupation.

The results, published in the journal PLOS ONE, showed that TV and background TV were the most frequently used media, with average daily exposure exceeding one hour. These lowered language development skills in toddlers.

The team also found that entertainment content was the most consumed by toddlers. It was followed by music and educational programming. Further, families with lower socio-economic status reported less use of books and fewer educational resources.

Children with more screen exposure had lower lexical density and delayed language milestone achievement. On the other hand, those with more exposure to books or had screen engagement with adults had better language skills.

The relationship between screen use and motor development was not significant.

The findings support previous research that excessive screen use negatively impacts early language development. Shared engagement with adults and appropriate content types may mitigate some of these effects.

With screen use poised to increase and become more complex, the researchers suggest future experimental designs control variables and isolate their impact.

Exposure to air pollution can affect one's cognition, daily task performance: Study

NEW DELHI, Feb 9 (Agencies): The short-term exposure to air pollution can cloud one's judgment, affecting emotional intelligence and focus and potentially making routine activities more challenging, according to a new study.

Researchers, including those from the University of Birmingham, UK, compared the performance of 26 adults divided into two groups — one exposed to high levels of air pollution, using candle smoke, and the other to clean air.

The team found that brief exposure to high levels of particulate matter (PM) pollution could affect the participants' higher-order cognitive functions, including self-control and sustained attention, which are critical for work and other aspects of life.

Air pollution has been studied as a major risk factor for neurological diseases, including Alzheimer's and dementia, where cognition and memory are affected.

The long-term exposure to PM2.5 air pollution has also been linked with poor learning and memory among children.

However, the study, published in the Nature Communications journal, showed that "even short-term exposure to particulate matter can have immediate negative effects on brain functions essential for daily activities, such as doing the weekly supermarket shop," co-author Thomas Faherty from the University of Birmingham said.

For the study, the cognitive abilities of the participants, including attention and emotion recognition, were tested before exposure to polluted air and four hours after.

"Results showed significant reduc-

tions in selective attention and emotion expression discrimination after enhanced PM exposure versus clean air exposure," the authors wrote.

Working memory, which serves as a 'temporary workspace' for storing and manipulating just-learned information, was also measured and found to be unaffected.

Therefore, the researchers suggested that inflammation in the brain triggered by pollution could be responsible for the deficits in focusing and recognising emotions.

The results also indicated that certain brain functions could be more resilient to short-term exposure to pollution, they added.

Cognitive functioning, including attention and controlled behaviour, is crucial for accomplishing everyday tasks both at work and in other aspects of life.

For example, selective attention — focusing on what is important and ignoring what is not — is known to help with decision-making and achieving goals.

Recognising one's own and others' emotions helps in understanding how to behave in a socially acceptable manner.

"Poor air quality undermines intellectual development and worker productivity, with significant societal and economic implications in a high-tech world reliant on cognitive excellence," co-author Francis Pope from the University of Birmingham said.

"Reduced productivity impacts economic growth, further highlighting the urgent need for stricter air quality regulations and public health measures to combat the harmful effects of pollution on brain health, particularly in highly polluted urban areas," Pope said.

Shuttler Sindhu pulls out of BAMTC 2025 due to hamstring issues

Badminton Asia Mixed Team Championships is set to be played in China's Qingdao from February 11-16

NEW DELHI, Feb 9 (Agencies): Two-time Olympic medallist shuttler PV Sindhu has pulled out of the Badminton Asia Mixed Team Championships in China due to a hamstring issue, dealing a huge blow to the country's chances of improving the colour of their medal in the prestigious edition.

The tournament is set to be played in Qingdao from February 11-16 with the Indian shuttlers currently undergoing training at a camp in Guwahati.

Besides Sindhu, the other leading players in the camp are Lakshya Sen, and HS Prannoy, along with the formidable doubles pair of Satwiksairaj Rankireddy and Chirag Shetty.

Sindhu was a part of the squad that won bronze in the previous edition of the tournament.

"It is with a heavy heart that I



share I won't be travelling with the team for BAMTC 2025. While training on the 4th (February) in Guwahati, I felt a twinge in my hamstring. Despite my efforts to push through with heavy taping for our country, an MRI has revealed that my recovery will take slightly longer than I initially expected," said the 29-year-old Sindhu in a post on 'X'.

Sindhu has grappled with injuries since winning her maiden women's singles gold medal at the 2022 Commonwealth Games in Birmingham.

However, the star shuttler sustained a left foot stress fracture injury during the Games, which kept her out of all remaining tournaments in 2022, including the World Championships and the World Tour Finals.

India are placed in a tough Group D alongside runnersup South Korea and Macau. They will begin their campaign against Macau on February 12, which will be followed by a tough outing against South Korea on February 13.

Sindhu wished the team luck, saying she would be "cheering from the sidelines".

Smith, Lyon, Kuhnemann shine as Australia secure first series win in Sri Lanka after 14 years



GALLE, Feb 9 (Agencies): An excellent performance from Australian spinners Matthew Kuhnemann and Nathan Lyon complemented fine centuries from Steve Smith and Alex Carey as visitors defeated Sri Lanka by nine wickets in the second Test at Galle on Sunday.

After 14 years, Australia has finally managed to secure a series win in Sri Lanka and for the first time since 2006, they have clean

swept a series in Asia. Sri Lanka won the toss and opted to bat first. Half-centuries from Kusal Mendis (85 in 139 balls, with 10 fours and a six) and Dinesh Chandimal (74 in 163 balls, with six fours and a six) took Sri Lanka to 257 in 97.4 overs. Sri Lanka lost their wickets regularly, but a 65-run seventh wicket stand between Kusal and Ramesh Mendis (28 in 94 balls, with two fours) stretched SL past the 200-run mark.

JKTJAC holds monthly meeting, demands resolution of genuine and burning issues of teaching fraternity

JAMMU, Feb 9: A monthly of Jammu Kashmir Teachers' Joint Action Committee (JKTJAC) held at Udhampur today on 09.02.2025 under the leadership of UT President Vinod Sharma and District President Lekh Raj Parihar.

The meeting was attended by executive and apex body members of JKTJAC from all the eleven zones of the district.

Speaking on the occasion Mr Vinod Sharma raised the genuine and burning issues of the teaching fraternity and appealed the Government to resolve them for the welfare of thousands of these teachers especially teachers appointed under ReT scheme.

Raising the burning issue he appealed the Education Minister for implementation of Govt Order No.469 Edu of 2014 Dated 25.06.2014 regarding inclusion of 5 years ReT period for seniority benefits and transfer of the said cadre.He said that even Hon'ble CAT has given clear cut directions that after regularisation ReTs are equivalent to general line teachers and they can't be differentiated on the basis of mode of their recruitment and they can be transferred within the district. He appealed the Govt to implement the said order.

Raising the genuine and

burning issue of Old Pension Scheme in favour of employees appointed on or after 01.01.2010 Mr Sharma appealed the Government to implement it.

Highlighting the genuine issue of release of MDM dues Mr Sharma said that teachers have managed money from their own pockets for smooth functioning of Mid Day Meals but the funds are released only for 2 to 3 months in the year 2024-25 and still 7 to 8 months funds are pending. He appealed the authorities concerned to look into the matter and get released the pending dues otherwise they will be forced to stop Mid Day Meals.

He also appealed Director School Education Jammu for issuance of Regularisation orders of ReTs who have completed 5 years ReT period, Conversion of RRETs to Teachers Grade II/ III so that they may get their salaries and one more DPC of teachers to masters to clear the backlog. He also demande Benefit of Cash in Lieu in favour of teaching fraternity; Conversion of headteachers posts into non plan posts of masters; Release of time barred arrears of Teachers/masters; Raising Grade of teachers at par with their counter parts in other UTs; Earned leave in favour of teachers engaged during summer/ winter vacation

for summer/ winter camps

and for other duties; Filling up of vacant posts of ZEOs/Principals/Headmasters in headless zones/schools.

Speaking on the occasion Lekh Raj Parihar urged the Chief Education Officer Udhampur to intervene in the matter of completion of service records of the teachers in many zones of the district besides release of dues of the teachers which is matter of great concern. He also demanded the release of carriage charges under Mid Day Meals which have not been released for many years and teachers are facing lots of problems for the transportation of rice and other ingredients.
