### **Five Pakistani Militants** Killed in Landmine **Blast in J&K**

SRINAGAR, Feb 7 (Agencies): Five Pakistani militants were killed in a landmine explosion while attempting to infiltrate the Line of Control (LoC) in the Battal sector of Poonch, officials said.

Official sources confirmed that five Pakistani militants attempted to infiltrate the LoC at the Battal sector in Poonch.

"One of them allegedly stepped on a landmine, triggering a huge explosion that killed all five militants," they said.

Sources further added, "The militants were carrying an IED with them, which also exploded."

### **J&K Police** seize over 10 **Kg of Charas** and Cash in Anantnag, Two held

SRINAGAR, Feb 7 (Agencies): In its continuing war against the drug menace, Police have seized more than 10 Kgs of Charas and cash in two separate incidents from the drug peddlers in Jammu Kashmir's Anantnag district.

Police on Friday said that on a specific information received through reliable sources that one person Identified as Farooq Ahmad Kumar a resident of Khul Chohar Mattan has hoarded a large quantity of narcotic substance in his residential house.

Accordingly a case under relevant sections of Narcotic Drugs and Psychotropic Substances (NDPS) Act got registered in Police station Mattan and investigation taken up, police said.

On receipt of this information, a team comprising Anantnag Police and **Executive Magistrate** concerned was constituted, who carried out the search of the said house during which about 10 KGs of Charas powder and cash of Rs. 2, 16, 650 was recovered.

The owner of the house was arrested and contraband seized. Further investigation in the instant case continues.

Police also arrested a person identified as Shahrukh Ahmad Sheikh a resident of Sheikh Mohalla Sallar during checking at Langabal Pahalgam and recovered 120 grams of Charas from his posses-

## RBI cuts repo rate by 25 bps to 6.25% in first policy review under Governor Sanjay Malhotra

NEW DELHI, Feb 7 (Agencies): In his first Monetary Policy announcement on Friday, Reserve Bank of India (RBI) Governor Sanjay Malhotra stated that the Monetary Policy Committee (MPC) had unanimously decided to reduce the policy rate by 25 basis points (bps) from 6.5 per cent to 6.25 per cent.

Malhotra highlighted the challenges posed by the global economic landscape, noting that while high-frequency indicators suggest resilience and expansion



in trade, overall global growth remains below historical averages. "Progress on global disinflation is stalling, hindered by services price inflation," Malhotra said.

financial market dynamics, Malhotra pointed out that expectations regarding the size and pace of rate cuts in the United States had led to

a strengthening of the US dollar.

He said, "The global economic backdrop remains challenging. The global economy is growing below the historical average, even though high-frequency indicators suggest resilience, along with continued expansion in trade. Progress on global disinflation is stalling, hindered by services price inflation."

This, in turn, resulted in hardened bond yields and significant capital outflows from emerging Turn to page 9

### SC refuses to entertain PIL of Former **Army Officer on 1999 Kargil War**

NEW DELHI, Feb 7 (Agencies): The Supreme Court on Friday refused to entertain a PIL filed by a former Army officer alleging lapses on the part of Army in acting on information with regard to Pakistan's incursions before the 1999 Kargil

"The judiciary normally does not go into the matter of national defence...what happened in 1999 in the war is the internal matter relating to executive

decision," a bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar said.

The bench was hearing

a PIL filed by Panchkulabased former Army officer Manish Bhatnagar. He alleged that he had provided credible

information about Karqil incursions much before it was officially taken note of and acted upon.

"There are certain things where the judiciary should not enter. It will be wrong on our part," the CJI said, adding,

"vou participated in the war and now leave the issues as they are".

Sensing the outcome, Bhatnagar, who argued the case, sought withdraw of the PIL which was permitted.

Bhatnagar, a former officer of the 5th Battalion of the Parachute Regiment, had earlier raised questions regarding the discovery of the intrusions and the manner in which these were handled subsequently in the conduct of **Turn to page 9**

### JK High Court defers final hearing to March 20 in case concerning LG's power to nominate MLAs

JAMMU. Feb 7: The Jammu and Kashmir and Ladakh High Court has scheduled the final hearing on March 20 for a PIL challenging the authority of the J&K Lieutenant Governor to nominate five members to the Legislative Assembly of the Union Territory.

A division bench comprising Justice Sanjeev Kumar and Justice Rajesh Sekhri directed both parties to complete the pleadings, including replies and counter-replies, by March 20 when the final hearing takes place.

During the proceedings, Solicitor General Tushar Mehta appeared for the respondents, while Senior Supreme Court lawyer Dr Abhishek Manu Singh, along with D K Khajuria, represented the petitioner Ravinder Sharma.

The court said that the bench will be

available for the entire day on March 20. Chief Justice Tashi Rabstan had last October constituted a special division bench to hear the public interest litigation concerning the nomination of the five MLAs.

On October 14, the Supreme Court declined to entertain the plea and directed the petitioner to approach the high court.

The petition challenges the provisions of the J&K Reorganisation Act, which empowers the LG to nominate five MLAs.

According to the petition, the LG is required to seek the aid and advice of the council of ministers before making such nominations, otherwise, the provisions are considered ultra vires to the basic spirit and structure of the Turn to page 9

### Delhi HC reserves order on Er Rashid's plea for custody parole to attend Parliament

NEW DELHI, Feb 7 (Agencies): The Delhi High Court on Friday reserved its order on a plea by jailed MP Rashid Engineer, facing trial in a terror funding case, seeking custody parole to attend the ongoing

Parliament session. Justice Vikas Mahajan heard the counsel appearing for the Baramulla MP as well as the National Investigation Agency (NIA) and said, "Judgement reserved.

The counsel appearing

for the NIA opposed the grant of custody parole, saying Rashid had no vested right to attend Parliament.

It was further said that he did show any "specific purpose" while seeking the relief and there were security concerns as well

Rashid's counsel emphasised that his constituency was not being represented in Parliament and he ought to be allowed to attend the session.

"I represent the larg-

est constituency of J&K. Don't prevent the representation when the process of inclusion has started... Don't stifle the voice of the constituency," the counsel argued.

The court was hearing Rashid's petition alleging that he had been left without any remedy after the NIA court dealing with his bail application left him in a limbo post his election to the Lok Sabha last year on account of it not being a special MP/MLA court.





However, despite his persistent efforts to relax the service experience requirement for promotions from Executive Engineer (Xen) to Superintending Engineer (S.E), the file remains pending.

The delay in promotions has disrupted the hierarchy within the department, which in turn is hampering the execution of key projects, including various Jal Jeevan Mission (JJM) water supply schemes.

If the three-year service experience condition for promotions is not relaxed, the department will continue to face a leadership crisis for the next two years.

The association further informed the Minister about the pending approval of the Cadre Review proposal submitted by JSD, aimed at streamlining its functioning and rationalizing the roles of engineers.

Additionally, the Assured Career Progression (ACP) scheme, which had been approved by the government after sustained efforts by the association, has not yet

been implemented as the required SRO has not been issued by the Finance Department.

The Minister Javed Rana attentively listened to all the concerns raised and immediately directed his OSD to draft a detailed note highlighting the key issues, particularly the relaxation of qualifying service requirements for promotions from Xen to SE and SE to CE.

He assured the deputation that he would escalate the matter to the highest level for a logical and swift resolution.

The Minister further stated that he aims to take the department to new heights and expects dedicated efforts from engineers to achieve this goal. He reaffirmed his commitment to addressing the concerns of the engineering fraternity and ensuring their issues are resolved at the earliest.

The meeting concluded on a positive note, with strong assurances from the Minister.

Vipul Goel criticizes the Delhi government for its failure to clean the Yamuna river and says Arvind Kejriwal is making baseless allegation to save his image ahead of the Assembly elections. Haryana minister Vipul Goel said that the government has filed a case against AAP chief Arvind Kejriwal in Sonipat chief judicial magistrates court under the Disaster Management Act over his statement that there was "poison" in the Yamuna water coming from Haryana. Hearing the case Sonipat CJM Neha Goyal issued a notice to Kejriwal and asked him to appear in person on February 17." If he does not appear before this court on the next date of hearing, it is deemed that he had nothing to say in the matter and further proceedings shall be conducted in accordance with law." said chief Judicial Magistrate in her order. An executive engineer of Haryana Water Services ,Ashok Kaushik has filed a complaint against Kejriwal for the alleged offences under Section 54 of the Disaster Management Act ,2005 and Section 353 and 356 -defamation of BNS.The revenue and disaster management

minister said the water supplied to Delhi is the same water consumed by the president, prime minister and union ministers. He accused Kejriwal of spreading fear among the people of not only Delhi but also Haryana with his false claims. Section 54 of the Act deals with the punishment for creating a false alarm or warning about a disaster. "Whosoever makes or circulates a false alarm or warning as to disaster or its severity or magnitude, leading to a panic, shall on conviction, be punishable with imprisonment which may extend to one year or with a fine. Goel also urged the Election Commission of India to take strict cognizance of such baseless claims as Delhi is set to go to the polls on February 5.Goyal criticized the Delhi government for its failure to clean the Yamuna river and said Kejriwal is using poison remark with an eye on Delhi polls. Kejriwal is caught in the self woven cobweb of his allegation of poisonous Yamuna water. The Election Commission of India-ECI on Thursday ,January 30, questioned AAP chief Arvind Kejriwal's complete silence on his claims that Haryana government was poisoning the Yamuna river. The commission has given the AAP national convener another opportunity to explain why no action should be taken in response to his serious claims of promoting disharmony,the enmity between different, overall public disorder and unrest. The commission has prima facie found your allegation about poisoning of river Yamuna as promoting disharmony and enmity between different groups, and overall public disorder and unrest even by the most sober interpretation, "the ECI said. Kejriwal alleged that Haryana chief minister Nayab Singh Saini pretended to drink Yamuna water and then spat some into the river. Kejriwal says that "EC is doing politics and dares Rajiv Kumar to drink Yamuna water. Amid controversy over his claim that Haryana poisoned the Yamuna ,AAP chief Arvind Kejriwal challenged Chief Elec-

tion Commissioner Rajiv Kumar and his team to drink the Yamuna water.AAP chief Kejriwal accused CEC Rajiv Kumar of politicizing the controversy over his claim that BJP-led Haryana government "poisoned" the Yamuna water to disrupt Delhi's water supply. Alleging that Kumar was seeking a post-retirement job, Kejriwal said he would send three bottles of Yamuna water to Kumar and the other Election Commissioners ,challenging them to drink it. Kejriwal made the statement just hours after the ECI issued a letter to him regarding his comments. The poll panel demanded that the former Delhi chief minister provide factual evidence and answer five specific questions raised by the EC by 11 am on Friday or face potential action. In response to the ECI's request, Kejriwal was asked to provide specific details regarding the nature and manner of the alleged poisoning of the Yamuna water, including the type, quantity ,and location of the contamination as well as the methodology used, by Delhi Jal Board engineers to detect it.HM Amit Shah termed Mr. Kejriwal's accusations against Haryana as 'petty politics', alleged the AAP government could not fulfill Kejriwal's promise of cleaning the Yamuna during his 10-year rule due to 'corruption.'The home minister alleged that AAP Supremo Kejriwal allowed the Yamuna river to get polluted and forced the people of Delhi to drink its water. In short AAP and its chief Arvind Kejriwal and other leaders of his party are accusing Haryana government of poisoning Yamuna in order to make the people of Delhi to consume the same water. Arvind Kejriwal has now been caught in the cobweb of his own making and he has stooped too low to win the poll battle in Delhi.

### **KDP Wing of DPAP** demands comprehensive return and rehabilitation policy for displaced **Kashmiri Hindus**

JAMMU, Feb 7: The Kashmiri Displaced People (KDP) Wing of the Democratic Progressive Azad Party (DPAP) has issued a statement demanding a comprehensive return and rehabilitation policy for displaced Kashmiri Hindus.

The organization, through its leadership—including President Sanjay Dhar, Chairman Piaray Lal Pandita, Vice President R.K. Koul, General Secretary Raj Kumar Ticku, and Youth President Naveen Gosani—has urged the Government of India and the Union Territory administration to formulate a concrete resettlement plan.

They emphasize that after 35 years of displacement, the situation has become intolerable for the community, and immediate action is required to address their grievances.

The leaders have called upon all well-wishers of the community to unite in pressing for their return to the Kash-

They stress the need to reclaim their lost cultural heritage, properties, birthplaces, and even ancestral cremation grounds.

In addition, they have appealed to the majority Muslim community in the valley to support and demand the repatriation of displaced Kashmiri Hindus, which would help restore the centuries-old harmonious culture of the region, historically known as Reshiwari.

With the establishment of an elected government in the Union Territory, the leaders expect a renewed focus on their rehabilitation

They have urged the government, led by the Chief Minister, to include the return and rehabilitation policy in its priority list. Furthermore, they have expressed hope that statehood will be restored to Jammu & Kashmir, representation.

One of the key demands is political representation, with the leaders calling for the nomination of reserved seats in the Parliament and Assembly.

However, they insist that these seats should be filled through elections among the displaced community rather than by nominations from select sections. Additionally, they propose reserving two seats per district in the Valley for displaced Kashmiri Hindus in Panchayat, Local Bodies, and Municipal elections.

Until rehabilitation is completed, they suggest reserving one seat per migrant camp in Jammu, along with the establishment of Panchayat or Town Area Committees in each migrant camp.

The leaders have also stressed the need for improving living conditions in migrant camps by conducting monthly meetings with residents to address their concerns.

Recognizing the economic struggles of overaged, unemployed youth, they have proposed a compensatory scheme where available land in camps is leased to them for business and entrepreneurial ventures, supported by special subsidized loans. This, they believe, would prevent economic distress and frustration among the youth.

A crucial demand is the introduction of a special employment package, including the recruitment of 20,000 youth and the creation of five new battalions in the police department with relaxed eligibility norms.

This, they argue, would not only provide economic stability but also facilitate the return and rehabilitation process.

The leaders have further demanded the merger of Prime Minister's Package employees with regular U.T. government employees, removing their supernumerary status. They highlight that 23,700 gazetted and non-gazetted

employees were forced to flee the valley, leaving vacan-

cies that should have been filled by displaced Kashmiri Hindu youth. Instead, these posts have been allocated to local valley residents, leaving the displaced youth jobless and strug-

gling for survival. In conclusion, the DPAP leaders have made an urgent

appeal to both the Central and Union Territory governments to take decisive steps toward their rehabilitation.

They emphasized that only through a structured and well-implemented return policy can the community reclaim its rightful place in Kashmir and contribute to restoring the region's rich cultural and social fabric.

### 'No irregularities found' in BookMyShow Coldplay tickets row, Mumbai police closes case

The Economic Offences Wing (EOW) of the Mumbai Police has closed its investigation into ticketing platform BookMyShow regarding the Coldplay concert ticketing controversy, stating that no irregularities were found.

Police said that the probe was launched following a complaint by a lawyer who alleged that tickets originally priced at Rs 2,500 were being resold for as much as Rs 3 lakh.

The complainant accused BookMyShow of fraudulent practices, including price inflation and unfair ticketing mechanisms, and demanded legal action.

There were also allegations that Book-MyShow had used ticket bots to manipulate the ticketing process, preventing genuine fans from purchasing tickets at the original price,

police said.

However, after a thorough investigation, the Mumbai Police found no evidence to support these claims.



The controversy arose after Coldplay concert tickets were sold via BookMyShow on September 22, 2024, and reportedly sold out within 30 minutes. Many users claimed they were logged out before the sale began, while others reported seeing tickets on resale platforms at significantly higher prices, sometimes 30 to 40 times the original cost.

Despite these concerns, the Mumbai Police concluded that there was no wrongdoing or illegal activity on the part of Book-MyShow. With no concrete proof of ticket manipulation, fraud, or price gouging, the case has been officially

closed.

BookMyShow recently clarified in a statement that it does not collaborate with any ticket-selling or reselling platforms, nor does it engage with third-party individuals for resale purposes.

After an eight-year pause, Coldplay, the renowned British rock band, performed in India as part of their 'Music of the Spheres' World Tour, with concerts held in Mumbai and Ahmed-

abad.
The band comprises four core members: Chris Martin, Jonny Buckland, Guy Berryman, and Will Champion, along with their manager Phil, who serves as a fifth member.

NEW DELHI, Feb 7 (Agencies): Prime Minister Narendra Modi will attend a host of events, ranging from an Al Summit to a CEO roundtable, during his jam-packed twoday visit to France on February 10-12, diplomatic sources told India Today. The second leg of the visit will see PM Modi travelling to the United States for a much-anticipated meeting with US President Donald Trump amid tariff threats and the illegal immigration issue.

Sources said PM Modi's visit to France, his second in nearly two years, is likely to see key announcements in the defence sector, small modular reactors.

The Prime Minister is expected

to land in Paris on February 10 evening and attend a VIP dinner hosted by French President Emmanuel Macron. On Febru-

## Fire at camp in Maha Kumbh Mela, none injured



MAHAKUMBH NAGAR, Feb 7 (Agencies): A fire broke out at the ISKCON camp in Mahakumbh Nagar on Friday and quickly spread to over a dozen nearby camps, officials said. No casualties have been reported.

Chief Fire Officer Pramod Sharma told PTI, "Upon receiving information about the fire at the ISKCON camp in Sector 18, fire tenders were immediately dispatched. The fire has been fully contained." The fire spread to over a dozen nearby camps, causing significant damage.

Officials said the cause of the fire

and the damage incurred due to it were being ascertained, officials said. DIG (Maha Kumbh) Vaibhav Krishna said the fire incident has "completely been controlled" by the fire brigades. "There is no one injured in it," he posted on X.

This is the third time that a fire incident has been reported in the Kumbh

On January 19, a massive fire broke out in the Maha Kumbh Mela area's Sector 19 due to a cylinder blast. While no casualties were reported, the blaze had left over a dozen camps gutted.

Earlier on January 25, two cars caught fire in Sector 2 of the Maha Kumbh fair area, but no casualties were reported. Short circuit in one car led to the fire which then spread to the other vehicle standing next to it, according to officials.

The Maha Kumbh, which started on January 13, will continue until February 26.

## More voters in Maharashtra than total adult population of state, claims Rahul

NEW DELHI, Feb 7 (Agencies): The Congress, Shiv Sena-UBT and NCP-SP on Friday alleged irregularities in the voter lists of Maharashtra, claiming that a total of 39 lakh voters were added between the Lok Sabha and assembly elections in the state.

Addressing a joint press conference here, Congress leader Rahul Gandhi claimed that the total number of voters added in Maharashtra was equivalent to the population of a state like Himachal Pradesh, and urged the Election Commission to provide them list of voters and come clean on the issue.

He claimed the majority of the voters added had gone in the BJP's favour as the opposition parties had maintained their vote share in the assembly polls.

Flanked by NCP-SP's Supriya Sule and Sena's Sanjay Raut,



Gandhi said the adult population of Maharashtra is 9.54 crore as per government data while the voter population of the state is 9.7 crore.

There are more voters in Maharashtra than total adult population of the state, alleged Rahul Gandhi.

He said while 39 lakh voters were added in Maharashtra in five months after the Lok Sabha polls, 32 lakh votes were added in the state in the previous five years between 2019 and 2024

He said if the EC does not provide the voter

lists of the assembly and Lok Sabha polls in Maharashtra, it poses a serious question.

"We are now heading towards complete destruction of the Constitution. But, we are in the business of protecting the Constitution," Gandhi told reporters.

He said the next step would be to knock at the doors of the judiciary.

"It is surprising to me that the EC is not ready to give us voter lists and the only reason possible is that there is something wrong and they know it," Gandhi claimed.

## Relief to CM Siddaramaiah: HC dismisses petition seeking transfer of MUDA case probe to CBI

BENGALURU, Feb 7 (Agencies): In a relief to Chief Minister Siddaramaiah, Karnataka High Court on Friday dismissed a petition filed by RTI activist Snehamayi Krishna seeking a direction to transfer investigation into the MUDA site allotment case to the CBI.

Siddaramaiah is facing allegations of illegalities in the allotment of 14 sites to his wife Parvathi B M by the Mysuru Urban Development Authority (MUDA).

In his petition, Snehamayi Krishna had contended that an impartial investigation is not possible since Siddaramaiah, being the Chief Minister, wields immense power and influence over the state departments, especially the state investigating agencies such as the police authorities and the Karnataka Lokayukta police.

"The material on record on its perusal nowhere indicates that the inves-



tigation conducted by the Lokayukta is partisan, lopsided or shoddy for this court to refer the matter to the CBI for further investigation or reinvestigation. As a result, the petition would necessarily meet its dismissal and is accordingly dismissed," Justice M Nagaprasanna said.

Siddaramaiah, his wife, brother-in-law B M Mallikarjun Swamy, Devaraju—from whom Swamy had purchased a land and gifted it to Parvathi—and others have been named in the FIR registered by the Lokayukta police establishment, located in Mysuru on September 27, following the order of the Special Court that exclusively deals with criminal cases related to former and elected

had dismissed the CM's petition challenging Governor Thaawarchand Gehlot's approval for a probe against him in the case, observing that the gubernatorial order nowhere "suffers from want of application of mind".

Siddaramaiah had challenged the legality of Gehlot's sanction for the investigation against him in the alleged irregularities in the allotment of 14 sites by MUDA in a prime locality.

Following the High Court order, a Special Court here on the very next day had ordered directing the Lokayukta police in Mysuru to initiate an investigation on the complaint filed by RTI activist Snehamayi Krishna.

On September 30, the ED filed an enforcement case information report (ECIR) to book the CM and others taking cognisance of the Lokayukta FIR.

Parvathi, meanwhile, had written to MUDA to

cancel 14 sites allotted to her and the MUDA had accepted it.

In the MUDA site allotment case, it is alleged that 14 compensatory sites were allotted to Siddaramaiah's wife in an upmarket area in Mysuru (Vijayanagar Layout third and fourth stages), which had higher property value as compared to the location of her land which had been "acquired" by MUDA.

The MUDA had allotted plots to Parvathi under a 50:50 ratio scheme in lieu of 3.16 acres of her land, where it developed a residential layout.

Under the controversial scheme, MUDA allotted 50 per cent of developed land to the land losers in lieu of undeveloped land acquired from them for forming residential layouts.

It is alleged Parvathi had no legal title over this 3.16 acres of land at survey number 464 of Kasare village, Kasaba hobli of Mysuru taluk.

## Three killed in blast in Bareilly kite string manufacturing unit

BAREILLY, Feb 7 (Agencies): Three people were killed in a blast at a kite string manufacturing unit in the Quila area of this Uttar Pradesh district, police said on Friday.

The factory owner was among those killed in the blast that occurred around 10 am, they said.

Superintendent of Police (Traffic) said the explosion occurred when sulphur, potash and glass were being mixed for coating kite strings. Two people died on the spot while a third succumbed in hospital.

The victims have been identified as factory owner Atiq Raza Khan



(45) and his employees Faizan (25) and Sartaj

Circle Officer (Second) Sandeep Kumar said the police were investigating the matter. The explosion was so strong that it sparked panic in the area. Kumar said the bodies had been sent for post-mortem.

restroom in a bid to lock herself but he pursued and pushed her out of the train, a police official said. She sustained fractures on her hand and leg.

Passers-by who noticed her fall from the train admitted her to the Government Medical College Hospital in Vellore.

Police said Hemraj, from K V Kuppam, who was arrested based on CCTV footage, was recently let out on bail

in connection with the murder of a woman in Chennai. He was booked under the Goondas Act in 2022, the police official added.

The woman has been living with her husband, a tailor, and son in Tamil Nadu's Tirupur for several years. She had decided to go to her mother's home in Chitoor as she was pregnant and accordingly boarded the Coimbatore-Tirupati Intercity express alone on Thursday night.

## 10 killed, 16 injured in separate road accidents in Madhya Pradesh

MHOW, Feb 7 (Agencies): Six persons, among them two women, were killed and 16 sustained injuries in an accident involving a two-wheeler, a private minibus and a trailer truck in Madhya Pradesh's Indore district on Friday morning, police said.

The accident occurred in the Manpur area of Mhow tehsil when a motorcycle and a minibus rammed into a trailer truck negotiating

a slope, an official said. Two men on the motorcycle and as many women on the minibus died on the spot, while two others succumbed to their injuries at the government-run Maharaja Yeshwantrao Hospital, Additional Superintendent of Police (Indore Rural) Rupesh Dwivedi told agency.

He said 16 persons were undergoing treatment for their injuries, and two of them were in critical condition.

The official said passengers on the minibus were returning to Belgaum, Karnataka, after visiting the famous Mahakal Temple in Ujjain.

In another road accident late on Thursday, four young men were

killed when their motorcycle fell into a well while negotiating a blind turn in Madhya Pradesh's Dhar district.

The incident occurred

between Choti Umarband and Mundla villages, nearly 60 km from the district head-quarters, around 11.50 pm on Thursday.

Four persons riding a

single bike fell into an unprotected well along a sharp curve, Manawar police station in-charge Ishwar Singh Chauhan said.

The victims, identi-

fied as Sandeep (19), Anurag (22), Manish (20) and Rohan (19), were returning to their Mundla village from Choti Umarband after attending a programme, the official said.

Police removed the bodies from the well and sent them for autopsy, the official said, adding that an investigation is underway.

## Vandalism, arson spread across Bangladesh as protesters attack houses of Awami League leaders

Unrest sparked after live online address of Hasina

DHAKA, Feb 7 (Agencies): Protesters in Bangladesh have attacked and torched houses of leaders of Sheikh Hasina's Awami League across the country and murals of the country's founder Sheikh Mujibur Rahman were demolished and defaced in nearly two dozen districts, according to media reports.

The unrest sparked after a live online address of Hasina. A fire has been set at the house of Awami League Presidium Member Sheikh Selim in Dhaka's Banani on Friday.

The fire was set around 1:30 am on Friday, but due to a lack of police protection, the Fire Service was delayed and was not able to reach the scene until 2:45 am.

Unruly crowds set the fire at Selim's residence in Banani. Security concerns prevented the Fire Service vehicles from accessing the site immediately, the Fire Service control room duty officer was quoted as saying by the United News of Bangladesh (UNB).

A day after the Dhanmondi-32 residence of Sheikh Mujib was torched and torn down, protesters attacked, ransacked, and set fire to the house of Obaidul Quader, general secretary of Awami League (AL) and former road, transport and bridges minister, in Noakhali's Companiganj, the Daily Star reported on

During the attack on the house in the Bora Rajapur Mohalla area around 1:00 pm, the two-storey building and tin-roofed rooms of Quader's younger brother Abdul Quader Mirza, president of Companiganj AL, and Shahadat Mirza, former mayor of Basurhat municipality, were also ransacked.

in the Muktijoddha Complex, Municipality Park, Shaheed Minar areas in the town, and in Mongla Upazila Parishad Complex, Mongla Children Park, and Muktijoddha Bhaban on Thursday.

Protesters also demolished a mural of Sheikh Mujib at the Barishal Press Club.

Demonstrators also set fire to several properties, including the Feni district AL office and the houses of ex-MPs Lt Gen (retd) Masud Uddin Chowdhury, and Alauddin Ahmed Chowdhury Nasim.

In Thakurgaon, protesters defaced five murals of Sheikh Mujib, Sheikh Russel, and Sheikh Moni in the town.

The student movement earlier promised to scrap Bangladesh's 1972 Constitution as they promised to bury the "Mujibist constitution" while some far-right groups also suggested a change of the national anthem adopted by Mujib-led post-independence government.

Hasina, 77, has been living in India since August 5 last year when she fled Bangladesh following a massive student-led protest that toppled her Awami League's 16-year regime.

Hasina's father is widely viewed as an independence hero, but anger at his daughter has tarnished his legacy.

In a Facebook livestream, Hasina condemned the attack and demanded "justice".

"They can demolish a building, but they can't erase history," she said.

Bangladesh's International Crimes Tribunal (ICT) has issued arrest warrants for Hasina and several former Cabinet ministers, advisers, and military and civil officials for "crimes against humanity and genocide".

# Iran supreme leader says US talks 'not intelligent' but doesn't rule them out



DUBAI, Feb 7 (Agencies): Iran's supreme leader said Friday that negotiations with America "are not intelligent, wise or honorable" after President Donald Trump floated nuclear talks with Tehran.

Ayatollah Ali Khamenei also suggested that "there should be no negotiations with such a government," but stopped short of issuing a direct order not to engage with Washington.

Khamenei's remarks to air force officers in Tehran appeared to contradict his own earlier remarks that opened the door to talks.

The 85-year-old Khamenei always has carefully threaded his remarks about negotiating with the West

and after the U.S. election that saw Trump
reclaim the White
House, Iranian officials appeared to be
signaling that they are
waiting for a message
from Trump on whether

he wants to negotiate over Tehran's rapidly advancing nuclear program. At stake are potentially billions of dollars withheld from Iran through crushing sanctions and the future of a program on the precipice of enrich-

uranium.

For his part, even when signing an executive order to reimpose his "maximum pressure on Iran" on Tuesday, Trump suggested he wanted to deal with Tehran.

ing weapons-grade

"I'm going to sign it, but hopefully we're not going to have to use it very much," he said from the Oval Office. "We will see whether or not we can arrange or work out a deal with Iran."

"We don't want to be tough on Iran. We don't want to be tough on anybody," Trump added. "But they just can't have a nuclear bomb."

Trump followed with another online message on Wednesday, saying: "Reports that the United States, working in conjunction with Israel, is going to blow Iran into smithereens, ARE GREATLY EXAGGERATED."

"I would much prefer a Verified Nuclear Peace Agreement, which will let Iran peacefully grow and prosper," he wrote on Truth Social. "We should start working on it immediately, and have a big Middle East Celebration when it is signed and completed."

Trump did not elaboate.

Earlier in the week, Trump also said that displaced Palestinians in Gaza could be permanently resettled outside the war-torn territory and proposed the U.S. take "ownership" in redeveloping the area into "the Riviera of the Middle East."

While not directly linking Trump's comments on Gaza, Khamenei appeared to be referencing them in his remarks as well.

"The Americans sit, redrawing the map of the world — but only on paper, as it has no basis in reality," Khamenei said. "They make statements about us, express opinions and issue threats. If they threaten us, we will threaten them in return. If they act on their threats, we will act on ours. If they violate the security of our nation, we will, without a doubt, respond in kind."

## Russian embassy appeals to Argentina over Kiev enlisting mercenaries Ambassador

BUENOS, Feb 7 (Agencies): The Ukrainian diplomatic mission in Argentina published a notice for the recruitment of mercenaries to fight for Kiev, but after the Russian embassy appealed to the Argentine Foreign Ministry, it disappeared, Russian Ambassador to Argentina Dmitry Feoktistov told Sputnik on Friday.

"Some time ago, there was a notice on the website of the Ukrainian diplomatic mission about the recruitment of 'soldiers of fortune' for combat operations against the Russian armed forces. We sent a note to the [Argentine] Foreign Ministry explaining that such activities seriously violate the provisions of the 1961 Vienna Convention on Diplomatic Relations. Although there was no



formal response, the notice disappeared from the website of the Ukrainian diplomatic mission," Feoktistov said.

There are not many mercenaries from Argentina fighting in Ukraine, the diplomat added.

"Overall, quite many mercenaries from Latin America have fought in the Ukrainian militant groups, but Argentina is not the biggest contributor. Such cases are quite rare and are

closely monitored by the competent Russian bodies," Feoktistov said.

The Russian Defense Ministry has repeatedly accused Kiev of recruiting foreign mercenaries. Many foreign fighters have confessed in interviews that the Ukrainian military provides little coordination and that the intensity of combat far exceeds what they experienced in Afghanistan and the Middle East, making survival extremely difficult.

# Philippine vice president preparing for impeachment battle but silent on option to resign MANILA, Feb 7 (Agencies): Chilippine Vice President Sara

MANILA, Feb 7 (Agencies): Philippine Vice President Sara Duterte said Friday that her lawyers were preparing for a legal battle in her upcoming impeachment trial but refused to say if resignation was an option so she could preempt a possible conviction that would bar her from running for president in the future.

Duterte was speaking for the first time since the House of Representatives impeached her Wednesday on a raft of criminal charges, including plotting to have President Ferdinand Marcos Jr. assassinated, which she again denied. Marcos was her running mate in the 2022 elections but they have had a bitter falling out.

At the news conference, she underscored economic hardships and said the lives of Filipinos have become "much worse" due to skyrocketing costs of living.

"God save the Philippines,"
Duterte said and asked her
supporters to turn to social
media to express their senti-



ments instead of holding street protests to avoid disrupting their

A potential conviction and ban on Duterte holding office would be a major setback to one of the country's most prominent political families that has been perceived as veering toward China.

The impeachment complaint focused on the alleged threats to Marcos, irregularities in the use of office funds and Duterte's failure to stand up to Chinese

aggression in the disputed South China Sea, according to proponents of the petition. The Senate is to take up the case when it reconvenes in June.

Marcos has boosted defense ties with Washington, Manila's longtime treaty ally, as the Philippines faced China's increasing aggressive actions in the contested waters.

The vice president's father, former President Rodrigo Duterte, nurtured cozy ties

during his term with Chinese President Xi Jinping and Russian leader Vladimir Putin while threatening to end U.S. military engagements in the Philippines.

Asked if she was considering to resign, a move that would preempt a possible conviction, which would block her from seeking to succeed Marcos in the 2028 presidential elections, Duterte refused to give a categorical reply.

"We're still too far from those matters," she said vaguely and added that a large number of lawyers have signified to join her impeachment defense.

She restated that she was open to seeking the presidency in 2028 in response to a question but added that she has to assess her chances. The vice president's popularity rating has declined in independent surveys but she remains regarded as a leading presidential contender.

"We're seriously considering that but it's difficult to decide without the numbers," she said.

## US Plane with 10 aboard goes missing in Alaska, search on

WASHINGTON DC, Feb 7 (Agencies): US officials on Friday said a search is underway in rural Alaska after a plane carrying 10 people, including the pilot did not arrive in Nome at the scheduled time, as per local media.

The Bering Air Caravan flight, from Unalakleet to Nome, was reported overdue to Alaska State Troopers at 4 pm local time, as per Alaska Department

of Public Safety as cited by NBC News.

The Coast Guard has been notified, and there is also an active ground search, the Nome Volunteer Fire Department said in a statement on social media.

The official Coast Guard account on X for the Alaska maritime area said that that the plane was 12 miles offshore going from Unalakleet to Nome when its position was lost. "The US Coast Guard District 17 responded to an aircraft emergency notification from Alaska Rescue Coordination Center at 4:30 p.m. today for a Cessna Caravan that reported to have 10 people aboard," the USCGAlaska said.

Meanwhile, CNN had reported that a UScontracted surveillance plane crashed in the Philippines on Thursday morning, killing all four personnel on board, including one US military service member, according to US Indo-Pacific Command.

Also on January 29, an American Airlines flight from Wichita, Kansas, collided with a Black Hawk helicopter near Ronald Reagan Washington National Airport. Sixty-four people, including four crew, aboard a commercial airliner of American Airlines died in the mid air crash.

## **Non-Gazetted Police Pensioners Welfare Forum** holds protest, projects demands

JAMMU, Feb 7: The Non-Gazetted Police Pensioners Welfare Forum, under the chairmanship of Ajit Singh, held a protest at Hari Singh Park, Jammu, to highlight the pay anomaly and discrimination faced by retired police personnel and fire service employees in Jammu & Kashmir. The forum raised several key issues and demanded immediate redressal from the government.

One of the primary concerns was the pay anomaly issue. The Government Order No. 229-F of 2014, issued on October 17, 2014, corrected the anomaly but was implemented prospectively, meaning only from the date of the order.

The forum argued that this correction should have been retrospective, dating back to 1996, when the 5th Pay Commission was implemented across the state. Unfortunately, the police department was left out at the time, causing financial hardship for many retired personnel.

Several affected retirees have already passed away, while the surviving pensioners continue to struggle. The forum demanded that the government

extend full benefits from 1996 onwards.

Another major issue raised was the inequality in health benefits. Retirees who left service before 2019 do not receive the ECH (Ex-Servicemen Contributory Health) Card benefits, whereas those retiring after 2019 do.

The forum strongly urged the government to extend these health benefits to all retired personnel, ensuring equal access to medical facilities.

The protest also highlighted the difficulties faced by retired police officers. Many of them are required to appear in court as witnesses but do not receive any travel or daily allowance (TA/DA) for such duties. This creates an additional financial burden

Additionally, the forum emphasized the need for higher wages for Special Police Officers (SPOs), bringing their salaries in line with those of Punjab Police

It also called for benefits such as uniforms, mess facilities, and a clear policy for their regularization. Similarly, Village Defense Committee (VDC) members should receive equal pay and benefits as SPOs, recognizing their role in security operations. Furthermore, the risk allowance, medical benefits, and ration money of J&K Police personnel should be made equal to those of the Central Armed

Police Forces (CAPFs). Another demand put forth was the revision

During the meeting, the Advisor reviewed the status of various ongoing and completed projects under PHE & I&FC. He took stock of the preparation of Detailed Project Reports (DPRs), tendering processes, and the implementation of 24x7 Water Supply Schemes.

Special attention was given to the challenges in ensuring a continuous and sustainable water supply to Leh and Kargil towns, considering the region's unique climatic and geographical conditions.

A detailed discussion was held on groundwater management in Ladakh, covering aspects such as groundwater extraction levels, categorization of both Leh and Kargil districts, and assessments conducted by the Central Ground Water Board (CGWB).

Reports from the Central Ground Water Authority regarding groundwater availability and sustainability in the region were also analysed.

Dr. Kotwal issued strict directives that no groundwater shall be used for construction purposes, emphasizing the importance of conserving groundwater resources for drinking and essential needs.

The Advisor also instructed the concerned departments to conduct water testing and sampling in both districts, especially in tour-



ist destinations, to ensure safe drinking water for both residents and visitors. He stressed that maintaining water quality in high-tourist footfall areas is crucial for public health and tourism sustainability.

In a significant move to promote Ladakh's natural water resources, Dr. Kotwal directed the officials to identify ten equidistant spots in Domkhar village, known for its clean water in UT Ladakh. He said that the village has a potential for tourist attraction footfall.

He further said that practical measures will be taken to convert Dhomkhar as a tourism village by testing of water and other basic amenities which are required for the visitors

He emphasized the need to highlight the pristine quality of Ladakh's water sources and instructed that water testing should be conducted carefully along the entire stretch from the highway to the last village of Domkhar to ensure its purity.

The meeting also reviewed the utilization of surface water resources and irrigation canal projects, focusing on their role in meeting the agricultural and drinking water needs of the region.

Mission was assessed, with discussions on the progress made in providing functional household tap connections in rural areas. The functioning of the State Water

## Khawaja again leads Australia in spin-friendly 2nd test against Sri Lanka



GALLE, Feb 7 (Agencies): Fresh off a double hundred in the first test, Usman Khawaja once again underlined why he is Australia's finest batsman in Asian conditions as he led the tourists past an early wobble to reach 85-2 at lunch on Day 2 of the second test against Sri

Khawaja was unbeat-

en on 34 at the interval Friday, with Steve Smith on 23, as Australia trailed the hosts by 172 runs.

The 38-year-old veteran, playing his 80th Test, batted masterfully last week to register his maiden double century. He looked equally assured against spin this time, rarely troubled by Sri Lanka's slow bowlers, who had struck early to remove Travis Head (21) and Marnus Labuschagne

From a precarious 37 for two, Australia recovered as Khawaja and Smith stitched together an unbroken 48-run stand for the third wicket to have the tourists wellplaced at lunch.

Smith wasn't entirely convincing, enduring a few nervy moments, but Khawaja was a picture of composure. He played with soft hands, used his feet expertly, and again deployed the reverse sweep to great effect.

On a surface offering sharp turn, Australia will need a substantial knock from their in-form opener if they are to gain the upper hand.

Earlier, Sri Lanka were bowled out for 257 after resuming from their overnight score of 229-9.

Kusal Mendis top scored for the hosts with an impressive 85 not out, but eventually ran out of partners when Lahiru Kumara (2) became Matt Kuhnemann's (3-63) third wicket of the innings.

### Legend 90 League: Gurkeerat powers Chhattisgarh Warriors to a thrilling win over Delhi Royals

RAIPUR, Feb 7 (Agencies): The Legend 90 League got off to a thrilling start as home side Chhattisgarh Warriors edged past Delhi Royals in a dramatic five-wicket victory in the final over at the Shaheed Veer Narayan Singh International Cricket Stadium in Raipur.

Delhi Royals posted 172/7 in the allotted 15 overs but Chhattisgarh Warriors chased down the target with two balls to spare. A mix-up led to Perera's run-out, but Gunathilaka took charge, smashing a 73-run knock off just 33 balls with nine fours and four sixes.

Veteran New Zealander Ross Taylor added crucial runs at the end, remaining unbeaten on 39 off 24 balls\*, helping the Royals post a formidable 172/7 in 90 balls.

Chasing 173, Chhattisgarh Warriors were rocked early when Lakhwinder Singh dismissed Vishal Kushwah in the third over, with Shikhar Dhawan taking the catch and celebrating with his iconic "Thigh Five". Parvinder Awana then got rid of the dangerous Martin Guptill, leaving the home side struggling at 40/2.

However, the Warriors fought back through a brilliant third-wicket partnership between skipper Gurkeerat Singh Mann and Pawan Negi.

The duo added 106 runs together, taking the chase deep. Both batsmen reached their half-centuries, but the match took a dramatic turn in the 13th over when Lakhwinder Singh dismissed Negi (51) with a sensational catch by Praveen Gupta

The tension escalated as Jerome Taylor struck twice in the next over, removing Gurkeerat (64) and Peter Trego, leaving 20 runs needed off the final eight balls.

With 15 required off the last over, Abhimanyu Mithun turned the game in Warriors' favor, smashing 6, 4, and another six off Praveen Gupta, sealing the win with two balls to spare. The Warriors' thrilling five-wicket victory gave the home crowd plenty to celebrate.

## Kohli's knee swelling is not serious, will be back for 2nd ODI: Gill

CUTTACK, Feb 7 (Agencies): India vicecaptain Shubman Gill has allayed fears around Virat Kohli's fitness, saying the batting stalwart is fine and should be fit for the second One-Day International against England here on Sunday.

Kohli, 36, was forced to miss the ODI series opener in Nagpur due to swelling in his right knee, leaving the team in a spot of bother as it went into the final dress rehearsal for the ICC Champions Trophy, beginning in Pakistan and Dubai on February

Gill, who scored a clinical 87 in India's fourwicket victory against England in Nagpur, told Disney-Hotstar: "It's nothing serious. He (Kohli) was fine during Wednesday practice,



but he woke up with some swelling in his knee on Thursday. He'll definitely be back for the second ODI."

The top-order batter said he did not get carried away while approaching his century, adding that he would have played the

shot, which ultimately got him, even if he was in his 60s.

Jos Buttler took a diving catch at mid-on off Saqib Mahmood's bowling as Gill, trying to pace the innings, mistimed a shot to leave India at 235/6.

"No, I wasn't think-

ing about my century. I was focused on the field placements and played my shots accordingly. I wanted to dominate the bowler, and I would have played the same shot even if I was in my 60s," Gill said.

Gill, who usually opens the innings in ODIs. said he had no problem coming in at No.3 in the series against England.

"I play at No. 3 in Tests, so it wasn't a big adjustment. It's always a challenge at that position because you have to adapt to the game situation. If the team loses quick wickets, you need to play sensibly. If the team starts well, you need to carry the momentum. My approach was simple - play according to the situation." On young Indian players frequently

choosing the sweep and reverse sweep shots against spinners, Gill said it was not a team strategy. "It's an individual

choice, not a team strategy. Every batsman has a plan to target specific areas. Many players are practicing sweeps and reverse sweeps in the nets to have more options while batting." On his 94-run partnership with Shreyas Iyer (59) for the third wicket, Gill said once they had sized up the field, scoring runs became easy.

"We lost two early wickets, but the plan was to play according to the field and not hold back. After a few overs. the line and lengths became predictable. which helped us score


### South African team arrives in Lahore ahead of ODI tri-series against Pakistan, New Zealand

The English batters were marauding runs off his overs, with his figures standing at 37 conceded with the new ball in his first three in the powerplay.

But Harshit refused to go down without putting up a fight. He continued to back his strengths and scythed three key wickets for India, which played a massive part in England succumbing to 248.

The 23-year-old's seven-over spell ended with figures of 3/53 with an economy of 7.60, the most expensive in the Indian bowling unit.

"Its never really about economy. Harshit Rana was the most expensive Indian bowler, but he got three crucial wickets and in many ways, sealed the game for India to win at the halfway stage." Manjrekar wrote on X.

Harshit appeared out of his depth when Philip Salt ruthlessly hammered him in the sixth over by tonking three sixes and two fours to take 26 runs from the over.

But Harshit showed he had more to his craft when he returned to the attack in the 10th over. With a short-length delivery, Harshit took Ben Duckett by surprise and forced a top edge out of his pull shot. With a stunning peice of fielding, Yashasvi

Jaiswal sprinted backwards to complete the catch, handing Harshit his maiden ODI scalp.

Just two deliveries later, Harshit roared to celebrate his second scalp. His second victim was none other than England's young prodigy Harry Brook, who gloved it away to KL Rahul for a three-ball duck.

Harshit, who has excelled in the death overs in the T20Is, was entrusted to deliver in the middle overs. His third and final scalp of the day was of Liam Livingstone.

The explosive allrounder gave into his itch to break free. In his attempt to go big, he lost his shape and gave away a thick edge to Rahul.
