#### J&K govt extends tenure of panel for OBC reservation in Panchayats/ **ULBs till Feb 28**

SRINAGAR, Feb 15 (Agencies): In a significant move, the Jammu & Kashmir Government has extended the term of the Local Bodies Dedicated Backward Classes Commission, which was constituted last year to work out reservation for Other Backward Classes (OBCs) in the Panchayats and Urban Local Bodies, up to February 28.

Sources told the news agency—Kashmir News Observer (KNO) that the J&K government has extended the term of the panel up to February 28. The Commission's term had expired on December 31, 2024. This is the first time the elected government has granted an extension to the panel headed by Justice (retd.) Janak Raj Kotwal, and comprising Raj Kumar Baghat (retired IAS officer) and Prof. (Dr.) Mohinder Singh Badwal (former Dean, SKUAST, Jammu).

"The commission is likely to submit its report by the end of this month," sources said. The submission of the report by the panel would set the ball rolling for conducting Panchayat and Municipal elections.

#### Arms and ammunition recovered during search operation in **Kupwara**



SRINAGAR, Feb 15 (Agencies): Indian army on Saturday recovered arms and ammunition during search operation in north Kashmir's Kupwara district, officials said.

"Acting on specific intelligence inputs, a joint search operation was launched by the Indian Army and Jammu and Kashmir Police in Bandi Mohalla, Channipura Pain, Kupwara", said an army spokes-

man, in a post on X. "During the search, security forces recovered two pistols, four pistol magazines, and ammunition. The operation is still ongoing", he added.

## **Vice President of India Jagdeep Dhankhar Presides Over 10th Convocation Ceremony of SMVD University**



KATRA, Feb 15 (Agencies): Vice President Jagdeep Dhankhar on Saturday attended the Shri Mata Vaishno Devi University (SMVDU) convocation here, emphasizing that national interest is bigger than any political or individual interest.

Lt Governor Manoj Sinha, Chief Minister Omar Abdullah, Educational minister Sakeena Firdous also attended the 10th convocation at Matrika Auditorium of the SMVDU campus.

"We are Indians and

being Indian is our identity. Nationalism is our religion and it is our duty to keep nationalism at the highest level whatever the situation," the vice president said, addressing the convocation.

"No political or individual interest can be bigger than the national interest," he said, highlighting India's progress under the leadership of Prime Minister Narendra Modi over the past 10 years.

He also termed the abrogation of Article 370 that granted special status to Jammu and Kashmir by the BJP-led central government in August 2019 as "historic" and said the constitutional provision was temporary in nature. Jammu travel guide

SRINAGAR, Feb 15 (Agencies): A resident from Jammu and Kashmir is among the 119 Indians being deported from the United States as part of the latest mass deportation effort, reports said on Satur-

This is the second such flight in less than two weeks, following the February 5 repatriation of 104 Indians from the

The second flight includes 67 deportees from Punjab, 33 from Haryana, 8 from Gujarat, 3 from Uttar Pradesh, two each from Goa, Maharashtra, and Rajasthan, and one each from Jammu and Kashmir and Himachal Pradesh.

#### Kiren Rijiju reiterates Centre's resolve to restore Statehood to J&K in due course



SRINAGAR, Feb 15 (Agencies): Union minister Kiren Rijiju on Saturday said Prime Minister Narendra Modi and Home Minister Amit Shah have made it clear that statehood to Jammu and Kashmir will be restored in due course of time.

However, Rijiju, who holds the parliamentary affairs and minority affairs portfolios, declined to give a timeline for the restoration of statehood to the Union Territory.

"The prime minister and the home minister made clear indications in the past that in due course of time, statehood will be restored (to Jammu and Kashmir) and the powers and functions will be demarcated very clearly," Rijiju told reporters here.

The Lok Sabha MP from Arunachal West said he would not like to comment on the timeline for restoration of statehood or division of powers between the lieutenant governor and the elected chief minister at this time as his visit to Kashmir was confined to the Union Budget.



JAMMU, Feb 15 (Agencies): The Jammu and Kashmir administration, led by Lieutenant Governor Manoj Sinha, has ordered the termination of three government employees for their alleged involvement in terror-related activities. The employees—police constable Firdous Ahmad Bhat. teacher Mohammad Ashraf Bhat, and forest department orderly Nisar Ahmad Khan—are currently lodged in jail in separate cases.

Official sources said that the decision was taken under Article 311(2)(c) of the Constitution, which allows the government to dismiss employees without an inquiry in the interest of

limate change is one of the most pressing challenges of our time, affecting every corner of the globe. ## PM Modi's France & America Tour

rime minister Narendra Modi paid a visit to France and US to further strengthen and develop bilateral relations and friendship .In this connection Modi first visited France and then after wrapping his Paris tour he embarked on a two day visit to US.PM Modi's sixth visit to France was high on optics as it included wide-ranging engagements during his jam-packed two day trip .At the invitation of the president of the French Republic, H.E,Mr.Emmanuel Macron, the prime minister of India Shri Narendra Modi paid a visit to France on 10-12 February 2025. On 10 and 12 Feb 2025 ,France and India co-chaired the Artificial Intelligence Action Summit ,gathering the Heads of state and government, leaders of international organizations ,small and large enterprises ,representatives of academia ,NGO's ,artists, and members of civil society, in order to build on the important milestones reached during the previous meeting of 2023. Following the AI summit which Macron co-chaired with Modi ,the bilateral part of the visit began with the two leaders jointly addressing the India-France CEO's forum. The forum brought togetherleadingbusinessesfromsectorssuch as aerospace, defense, innovation, en ergy,infrastructure,agro-processing ,and consumer goods. Modi at the meeting encourage French companies to explore new opportunities particularly in defense, civil nuclear, insurance, and advanced manufacturing sectors. After the meet, the two leaders travelled together to Marseille in the French presidential aircraft, a rare occurrence. "It is emblematic not only of the deep personal trust between the two leaders but also of the remarkable confidence that they have in each other ,and characterize the relationship as well," said Foreign Secretary Vikram Misri .The prime minister and the president held discussions on board the aircraft. In fact India-France relations touched new heights. The discussions on various issues continued aboard the aircraft and continued upon landing in Marseille, where the two leaders were joined by their larger delegations.

These talks extended into a dinner hosted by president Macron in honor of prime minister Modi. The two leaders exchanged views on recent geopolitical developments in Europe ,West Asia and the Indo-Pacific ,and discussed issues of global and regional importance. Modi and Macron on Tuesday co-chaired the Al Action Summit in Paris.PM Modi began his itinerary with a visit to Mazarques War Cemetery on Wednesday where Modi and Macron honored the Indian soldiers who sacrificed their lives in the 1 and 11 world wars. Modi said that Marseille has special significance for India, as this is the city where Veer Savarkar attempted a courageous escape and the people of Marseille and French activists of those days demanded that he not to be handed to British custody. The two leaders also inaugurated the new Indian Consulate General in Marseille. The two leaders visited the International Thermonuclear Experimental Reader Facility, ITER, in Cadarache, together .The experimental campaign at ITER was vital for advancing fusion science and paving the way for the fusion power plants of the future. India-France focused on nuclear cooperation through joint development of small Modular Reactors -SMR's and Advanced Modular Reactors-AMR's and advancing safe .open and secure Artificial Intelligence collaboration. Modi and Macron also agreed to enhance cooperation in the Indo-Pacific ,with a joint declaration of intent for triangular development ,aimed at providing solutions to support economic growth and development of the countries in the region. Misri said the demand for SMR's and AMR's has been identified as crucial ,particularly as AI ,as underlined by the International Energy Agency Director General Fatih Birol will require vast amounts of electricity. As far as the trilateral cooperation is concerned, India and France will look at delivering projects in a whole host of areas in third world countries. The bilateral roadmap on AI envisions that the norms reflect democratic values and promote human development. A commitment to safe ,secure ,and trustworthy AI systems, advancing the 2030 Sustainable Development Agenda, fostering international coop-

eration on AI capacity -building respecting international law and human rights are at the core of India-France Declaration on Al. An extensive joint statement issued after the meet mthat the leaders mentioned that the leaders commended the progress in a collaboration in the construction of Scorpene submarines in India, including indigenization. On the bilateral front ,the PM met with the president of Estania, President Alar Karis, and also with the vice-president of the united states ,His Excellency JD Vance. Joint declaration was also done and joint statement was issued which encapsulated all important things agreed upon.PM Modi wrapped up his France visit on 12 Feb,2025 and President Macron attended a departure ceremony at Marseille Provence airport in Magrigane and left for his second leg of visit to USA. PM Modi and president Donald Trump discussed key bilateral issues including trades, tariffs ,extradition of 26/11 accused and Russia-Ukraine war ,purchase of F-35 fighters and India's border dispute with China. Setting the tone of the 'MEGA partnership ',PM Modi highlighted India and US's shared commitment to economic growth and global leadership. President Trump often talks about MAGA in India ,we are working towards a Viksit Bharat , which in American context translates into MEGA .And together, the India-USA have a MEGA partnership for prosperity ,Modi said. India and the US set a bilateral trade target of dollar 500 billion by 2030 in an effort to ensure joint development ,joint production and transfer of technology. The terms of the agreement would be decided soon ,said Modi ."The people of America are well aware of president Trump's motto MAGA - Make America Great Again'. The people of India too are focusing on heritage and development as they move forward at a fast pace and with a firm resolve towards the goal of Viksit Bharat 2047, Modi said. Making a significant boost to defense cooperation, Trump said that the US would sell F-35 stealth fighter jets to India ,placing the country among an elite group operating the advanced aircraft. "Starting this year ,we will be increasing military sales to India by many billions of dollars. We are also

paving the way to ultimately provide India with the F-35 stealth fighters, "Trump said.PM Modi meets US president Trump at White House.In a significant boost to the energy sector ,India is set to buy US energy of almost dollar 25 billion in the near future. The talks between the two leaders focused also on increasing energy purchases, which would pay a key role in balancing the trade deficit between India and US.US offers to mediate on India-China boarder dispute. ## Journalists should get a uniform pension across the country

o get a pension, you must be recognized by the Haryana government for a period of five years. Under this order, journalists working in this field for twenty years will get a pension. After reporting for a newspaper for 30 to 40 years, journalists who have not been recognized by the Haryana government for five years will not get any benefit. To ensure that all journalists get government recognition, the Haryana government should give journalist pensions to all journalists who reach the age of sixty. To do this, there should be a consensus on recognizing journalists at the tehsil level. Therefore, in relation to social security and pension, the government should form a national team. Which will research the policies of the states and the Center and provide a decent pension to all journalists instead of giving a piecemeal amount. Which will study the schemes of the Center and the states and give a respectable pension to all journalists instead of giving something to some in a piecemeal manner.

The government still considers pensions as its responsibility. It has not abolished pensions. It gives many types of pensions. Both MLAs and MPs get pensions. After becoming an MLA, MP, and Rajya Sabha member, you are entitled to get three types of pension. Some people get three types of pension, and some do not get any. In some states, award winners also get pensions. What kind of justice is this? The voice of the poor and oppressed people has been raised through journalists. These people have done many things with the power of their words. Now it is important that other public representatives and communities also raise their voices for journalists. They should raise the issues of journalists and fight for fundamental rights to improve their standard of living. It is sad that our journalists advocate for the rights of the deprived. They risk their lives to do their work. They run from morning to evening to avoid the worries of their loved ones.

They do not stop working until they resolve a problem. However, they are unable to write about their issues. So far, the Labour Resources Department has not included journalists in the list of skilled workers. Specifically, there are three important issues facing journalists that need to be resolved. The rules regarding work experience for pensions should be relaxed to eliminate the need for government recognition. Also, the government should include blocks after district and subdivision in its gazette to recognize rural journalists. Journalists should also be part of the Labour Resources Department. The list of skilled workers includes skilled workers who prepare content. Journalists work round the clock in hot, cold, and rainy conditions. There is a working time for a worker, but the working hours of a journalist are not fixed. Both journalists and journalism are going through a transitional period.

The Government of India as well as the state governments should take steps to protect the interests of journalists. The government should formulate a plan to address journalist harassment, as it is a serious issue. All journalists working today urgently need medical facilities, security for journalists, pensions, and press accreditation for desk workers. Rural journalists should be recognized as journalists by the government. The Department of Labour Resources should publish a list outlining the status of skilled workers and amend its gazette. The journalist community should soon be able to avail itself of benefits such as insurance and other worker-provided facilities. Journalists are also competent professionals. They contribute content, which is later converted into a newspaper. A newspaper is a product, and our journalists play a role in creating it as expert workers. Therefore, the government should consider it immediately. The Journalist Pension Scheme and Journalist Insurance Scheme are two important programs for the welfare of journalists that the government should also implement properly.

Some journalists get the benefit of the Journalist Pension Scheme. However, many journalists are not eligible for the pension scheme. For this, the rules of the Journalist Pension Scheme need to be relaxed. At present, different states have different conditions for those receiving journalist pensions. For example, in Haryana, apart from twenty years of work experience, five years of government recognition are required. A large number of senior journalists have to suffer the brunt of this. As a result, if this rule is relaxed, journalists should get pensions on the basis of affidavits like the Journalist Insurance Scheme. Pension eligibility should be based on the senior journalist's ten years of work experience, with an age limit of 60 years. According to the Journalist Pension Scheme, they should get a pension on the basis of their affidavit and sixty years of age. Regarding the work experience certificate, the government should provide a list from the District Information Public Relations Department of each district. Whenever journalists go to the election, they submit the identity card issued by the District Election Officer through the Election Commission.

Apart from this, journalists cover the Prime Minister, Chief Minister, and other major events. Various major political parties and district governments issue special identity cards during news coverage. As a result, the government keeps a record of news coverage and election-related work experience. Journalists should get a pension from

the government based on their performance. Apart from offering free trans portation in government buses and insurance programs for journalists, media centers should be established in each district so that media persons can do their work without any hassle. The government runs many types of social security programs. Some federal and state-level programs are running. Some are giving 6,000 to farmers; some are giving 10,000. Some give unemployment allowance; some give something else. Some have an old age pension of one thousand, some two thousand. Some are organizing pilgrimages; some are organizing aarti.

Many senior journalists write that they are not able to earn a regular living. They will somehow control their expenses after retirement. If children are unable to help, then God is the only option. Not every child is able to earn enough money to support everyone. This results in family discord. Therefore, the government should form a national team for social security and pension. Which will research the schemes of the Center and the States and provide a good pension to all journalists instead of giving only a few to some journalists.

The journalist in him puts out facts in great detail. The emotional human being that he is breaks down in his own documentary. And the passion of the filmmaker makes him pursue his story with dogged tenacity. National Award-winning filmmaker Amitabh Prashar brings to us the harrowing reality of female infanticide in his home state Bihar in his latest documentary The Midwife's Confession, a subject he followed for 28 long years.

And when he says 'I don't abandon my stories or my characters', his BBC documentary stands as testimony to the labour of passion and conviction. To those who believe the issue of missing girl child is no longer alive, he shares, "Days before the release, there were at least two incidents reported by mainstream media—of a father burying his twin daughters alive and the other of a mother strangulating her fifth female child." Hailing from Bihar, though he belonged to a family with progressive values, male child fixation and dowry deaths were something he had seen all around him.

Taking up a cause

As a young journalist back in 1995, he decided to follow a case where a father had strangulated his 11-month-old daughter. It also brought him face-to-face with Anila, who runs an NGO in Katiyar and has been instrumental in saving many



NEW DELHI, Feb 15 (Agencies): Congress leader Rahul Gandhi on Saturday said while India has the talent, it needs a strong production base, and not empty words, to build industrial prowess in new technology to give its youth jobs.

## Kejriwal's 'Sheesh Mahal' to be probed over renovation of 'lavish' bungalow: BJP

NEW DELHI, Feb 15 (Agencies): The Central Vigilance Commission has directed the Public Works Department of Delhi Government to conduct a detailed probe into the alleged merger of properties to expand the 6, Flagstaff Road bungalow and the expenditures incurred on its interiors, BJP leader Vijender Gupta said on Saturday.

The bungalow labelled as "Sheesh Mahal" by the BJP for alleged corruption was occupied by Arvind Kejriwal as the chief minister of Delhi from 2015 till the first week of October last year.

No immediate reaction was available from the Aam Aadmi Party (AAP) or its convenor Kejriwal on the matter.

Gupta said the Central Vigilance Commission (CVC) took cognisance of his two earlier complaints and sought factual reports from the Public Works Depart-



ment (PWD) based on which it has now directed to conduct a detailed probe.

In his first complaint to the CVC, the newlyelected BJP MLA from Rohini alleged that Keiriwal flouted building regulations to construct a lavish mansion covering 40.000 square vards (8 acres) of land.

Government properties, including plot Nos. 45 and 47 on Rajpur Road (previously housing senior officials and judges in Type-V flats) and two bungalows (8-A and 8-B, Flag Staff Road) were demolished

and merged into the new residence, violating ground coverage and floor area ratio norms and lacking proper layout plan approvals, Gupta alleged.

> In his second complaint, Gupta alleged "extravagant spending" on the renovation and interior decoration of the bungalow on 6, Flag Staff Road.

> He also claimed "massive financial irregularities" and expenditure of crores of rupees from the taxpayers' money on luxurious amenities in the bungalow.

## Mamata Banerjee govt failed to stop atrocities against women: BJP leader Amit Malviya

KOLKATA, Feb 15 (Agencies): Senior BJP leader Amit Malviya on Saturday accused the Mamata Banerjee government in West Bengal of failing to prevent attacks and atrocities against women, citing the incidents in Sandeshkhali and RG Kar hospital as examples.

When reporters asked him about the state government not increasing the monthly amount under its flagship 'Lakshmir Bhandar' financial assistance scheme for women in the 2025-26 budget, the BJP IT cell head did not give a direct reply.

Instead, he chose to focus his attack on the "dichotomy between the TMC government's claim to support the cause of women through such projects and its aiding and abetting perpetrators of atrocities against women in the

"While the chief minister gloats in public about her government's monthly dole to women and claims to be concerned for their welfare, she looks the other way when horrific incidents



like the Sandeshkhali sexual abuses come to light. Instead, she and her party rushed to protect perpetrators like Shahjahan Sheikh," Malviya said at Asansol in West Bengal's Paschim Bardhaman dis-

Referring to the rape and murder of a woman medic of R G Kar Medical College and Hospital, which sparked national outrage, Malviya accused the chief minister of shielding the culprits.

"Even after such a heinous crime shook the conscience of the entire nation, the woman CM tries to protect those responsible," he said.

This proves her concern for women's empowerment and bragging about their cause is hollow, he alleged.

Speaking on the arrest of TMC leaders and ministers on graft charges, Malviya said, "The ruling party activists and leaders are becoming part of syndicates and mafias and the common man is reeling under their intimidation.'

"Why are MPs and MLAs of the ruling party accused of taking cut money in state projects? TMC and cut money culture are synonymous in West Bengal. People in the state will vote out this corrupt regime and elect the BJP to power in 2026," he said.

Malviya said the BJP will usher in good governance, weed out corruption at all levels and ensure a safe, secure environment for women. He alleged around 4,000 industrial units both under public and private sectors have closed down in West Bengal, while 1.5 lakh migrant labourers have gone out of the state for employment opportunities elsewhere.

"This is not the Sonar Bangla we had dreamt about. The state government has failed to chart a road map for the revival of the 4,000 listed industrial units – both in private and central sectors - and present any plan to the Centre as the ruling TMC does not have any plan," he said.

This is reflected in the lack of any strategy or plan for industrial growth in Bengal in the state budget, Malviya claimed, adding the state's charge about discrimination in the Union budget is false as "this government itself failed to utilise central allocation and instead the money was siphoned by its party leaders".

Next year once BJP assumes power in the state, a conducive environment will be created for investment opportunities with the improvement in law and order, he said.

Speaking on the issue of the Calcutta High Court on Friday granting conditional permission to RSS to hold a rally in Purba Bardhaman district on February 16, Malviya said, "Any programme, events of BJP, RSS and other organisations in West Bengal are facing hurdles under the Mamata Banerjee regime which necessitates the intervention of the HC."

"Mamata Banerjee is trying to curb the alternative space, which is required for the functioning of the opposition. Her brand of politics to stifle other voices will not be accepted any more. It is over," he said.

He also said the apprehension expressed by Banerjee over the inclusion of bogus names in electoral rolls is based on falsehood and "stems from her fear of losing the 2026 assembly polls as her rigging, strongarm tactics will not be allowed by the Election Commission".

## President's rule in Manipur symbolic of PM, HM's collective failure: Gaurav Gogoi



NEW DELHI, Feb 15 (Agencies): Congress leader Gaurav Gogoi on Saturday termed the imposition of President's rule in Manipur "symbolic of the collective failure" of Prime Minister Narendra Modi, Union Home Minister Amit Shah, and the BJP's leadership in the Northeast.

President's rule was imposed in strife-torn Manipur on Thursday and the state assembly put under suspended animation, days after Chief Minister N Biren Singh resigned from his post.

"The imposition of President's Rule in Manipur is symbolic of the collective failure of the Prime Minister and Home Minister and the party leadership in Northeast," Gogoi wrote on X.

The Congress deputy leader in the Lok Sabha also said that there is still no roadmap for sustainable peace and reconciliation in Manipur.

"Therefore, it can be said that the President's Rule is only there because the state BJP is in total disarray. People of Manipur and India deserve better," he said.

The ethnic violence, which began in May 2023, saw brutal clashes between the majority Meitei community in the Imphal Valley and the Kuki-Zo tribal groups in the surrounding hills, resulting in over 250 deaths besides displacing thousands of people.

## 3 hostages are with Israeli forces after Hamas released them to Red Cross in Gaza

Red Cross delivered three - Iair Horn, 46, dual citizen of Israel and Argentina; American-Israeli Sagui Dekel Chen, 36; and Russian-Israeli Alexander (Sasha) Troufanov, 29 — to Israeli military

KHAN YOUNIS, Feb 15 (Agencies): Hamasled militants released three male Israeli hostages Saturday, parading them before a crowd in the southern Gaza Strip before handing them over to the Red Cross as part of a shaky ceasefire deal that requires Israel to release hundreds of Palestinian prisoners in exchange.

The Red Cross delivered the three - lair Horn, 46, a dual citizen of Israel and Argentina; American-Israeli Sagui Dekel Chen, 36; and Russian-Israeli Alexander (Sasha) Troufanov, 29 — to the Israeli military, which said they were being taken for medical treatment and to be reunited with their relatives.

All were abducted in the October 7, 2023, attack that ignited the war. They appeared pale and worn, but seemed to be in better physical condition than the three men released last Saturday, who had emerged emaciated from 16 months of captivity.

The truce that began nearly four weeks ago had been jeopardised in recent days by a tense dispute that threatened to renew the fighting.

**US President Donald** Trump's controversial proposal to remove more than 2 million Palestinians from Gaza and settle them elsewhere in the region has cast even more doubt on the future of the ceasefire

But Hamas said Thursday it would move ahead with the release of more hostages after talks with Egyptian and Qatari officials. The group said the mediators had pledged to "remove all hurdles" to ensure Israel would allow more tents, medical supplies and other



essentials into Gaza.

It is the sixth swap since the ceasefire took effect on January 19. So far, 21 hostages and over 730 Palestinian prisoners have been freed during the first phase of the truce.

As with previous

exchanges, the hostage release was heavily choreographed, with the captives made to walk onto a stage and make remarks into microphones before the crowd. Dozens of masked, armed Hamas fighters lined up near the stage festooned with Palestinian flags and the banners of militant factions while music blared from loudspeakers.

In Tel Aviv's Hostages Square, a huge cheer went up as the hostages were transferred to the Red Cross. "lair, Sagui, and Sasha are on their way home!" an announcer said.

Who are the hostages and prisoners being released?

The three hostages were abducted from Kibbutz Nir Oz, one of the hardest-hit communities in southern Israel during the Hamas-led October 7, 2023, attack that ignit-

ed the devastating war. Horn was abducted along with his brother, Eitan Horn, who had been staying with him at the time. Eitan remains

in captivity. Dekel Chen had been working outside when

militants stormed the

kibbutz. His wife hid in a safe room with their two daughters. She gave birth to their third daughter two months later.

Troufanov was taken hostage along with his grandmother, mother and girlfriend. The three women were released during a brief ceasefire in November 2023. Troufanov's father was killed in the October 7

attack. The Hamas-linked Prisoners' Information Office said Friday that 369 Palestinians were set to be released from Israeli prisons on Saturday. It said 36 of those were serving life sen-

Among the most prominent Palestinian prisoners set to be released is Ahmed Barghouti, 48, a close aide of Marwan Barghouti, a militant leader and iconic Palestinian political figure.

Israel sentenced Ahmed Barghouti to life on charges that he dispatched suicide bombers during the Second Intifada, or Palestinian uprising, in the early 2000s to carry out attacks that killed Israeli civilians. He was arrested alongside Marwan

Barghouti in 2002. Concerns are high about the remaining hostages' condition. Of the 251 people abducted, 73 remain in Gaza, around half of whom are believed to be dead. Nearly all the remaining hostages are men, cent of Gaza's population of 2.3 million. Hundreds of thousands have since returned to their homes as the ceasefire took hold, though many found only rubble, buried human remains and unexploded ordnance.

Trump later assured Ukrainian President Volodymyr Zelenskyy that he, too, would have a seat at the table. The war was sparked by Russia's invasion of Ukraine three years ago.

Already Friday, the

Ukrainian leader said that his country wants security guarantees before any talks with Russia. Shortly before meeting with Vance in Munich, Zelenskyy said he will only agree to meet in-person with Putin after a common plan is negotiated with Trump.

After a 40-minute meeting with Zelenskyy, Vance said the Trump administration wants the war to end.

Beforehand, Vance lectured European officials on free speech and illegal migration on the continent, warning that they risk losing public support if they don't quickly change course.

"The threat that I worry the most about vis-à-vis Europe is not Russia. It's not China. It's not any other external actor," Vance said in a speech that drew a tepid response. "What I worry about is the threat from within—the retreat of Europe from some of its most fundamental values, values shared with the United States of America."

On the sidelines of the event, Vance met with Alice Weidel, coleader of the far-right and anti-immigrant Alternative for Germany party, nine days before a German election.

Mainstream German parties say they won't work with the party—in a longstanding stance to shun the extreme right in a country scarred by Nazism.

Vance later headed back to Washington.

Among other speakers set to take the dais in Munich were NATO chief Mark Rutte and foreign ministers from countries including Canada, France, Germany, Saudi Arabia and from Syria's new government.

## Iran's vice-president orders probe into killing of university student during a robbery

DUBAI, Feb 15 (Agencies): Iran's vice-president on Saturday ordered a probe into the killing of a university student after a protest gathering at Tehran University, state media reported.

A report by the official IRNA news agency said First Vice-president Mohammad Reza Aref ordered security officials to probe the case "imme-


The move came a day after angry students gathered in protest at a Tehran University dormitory seeking more safety measures. The protest briefly turned violent and police deployed forces to the gate of the dorm, according to videos on social media. The Associated Press could not independently verify the footage.

Protesters, chanting "Shame on you," demanded more safety measures at the dorm and its neighborhood, complaining about occasional robberies.

On Wednesday, 19-year-old business administration student Amir Mohammad Khaleghi was stabbed by two unknown robbers who stole his backpack in front of the dorm. Khaleghi died in the hospital.

Peace returned to the dorm late Friday after authorities vowed to pursue the case with a "special" order.

Though the protest was not politically motivated, such events can ignite unrest as Iranian people under U.S. economic sanctions are dealing with the high price of meeting their daily needs, as well as widespread mismanagement.



Iranian universities have a history of protest over the past decades.

Most recently, in 2022, universities were major sites of protest over the death of a 22-year old woman, Mahsa Amini, who died in police custody after she was detained by the morality police for allegedly not wearing the Muslim headscarf correctly.

The protests that followed Amini's death started first with the chant "Women, Life, Freedom." However, the protesters' cries soon grew into open calls of revolt against the incumbent theocracy. The monthslong nationwide protests, which shook the establishment, ended in early 2023 after a security crackdown during which more than 500 people were killed and over 22,000

## WPL 2025 season opener rewrites record books as RCB thrash Gujarat Giants

VADODARA, Feb 15 (Agencies): The Women's Premier League (WPL) 2025 season opener between Gujarat Giants Women and Royal Challengers Bengaluru rewrote record books as Smriti Mandhana's side clinched a six-wicket win over the Gujarat-based franchise.

A half-century by Ellyse Perry and audacious ball-striking in death overs by half-centurion Richa Ghosh and Kanika Ahuja helped defending champions Royal Challengers Bengaluru (RCB) kickstart their Women's Premier League (WPL) campaign with a massive six-wicket win in Vadodara.

The chase of 202 runs by the Bengaluru-based franchise against the Giants was the highest target successfully chased in the WPL. Earlier, Mumbai Indians held the record when they chased a 191-run target against Gujarat in 2024.

The WPL 2025 season opener also had the highest match aggre-

gates in the tournament, with 403. Previously, the record was held by the match between Gujarat Giants and Royal Challengers Bengaluru in 2023, with an aggregate of 391.

The unbeaten partnership of 93 runs between Kanika Ahujaa and Richa Ghosh also registered the third-highest for the Bengaluru-based franchise in WPL.

A total of 16 sixes were smashed in the game between RCB and GG in Vadodara, which is the second-most hit in a WPL match. Earlier, RCB's match against DC in 2024 held the second spot with 19 sixes.

Summarizing the match, RCB won the toss and elected to field first. After being put to bat first, GG's opening pair of Beth Mooney and Laura Wolvaardt took their time picking up speed, with Mooney hitting some boundaries. However, Laura was cleaned up by Renuka Thakur for 6 (10 balls, with one four) by Renuka Singh.

It was captain Ashleigh Gardner's unbeaten 79-run knock and Mooney's 56 runs from 42 balls, which powered the Gujarat-based franchise to 201/5 in the first inning.

Renuka was the pick of the bowlers, conceding just 25 runs and getting two wickets. Kanika, Wareham and Prerna got one wicket each.

During the run-chase of 202, RCB openers Mandhana and Danni Wyatt-Hodge started with three fours in the first over, but Gardner pushed them back by removing both the openers in the next over.

Later in the second inning, Ellyse Perry (57), Richa Ghosh (64\*) and Kanika Ahuja (30\*) played a stupendous knock and chased down the target in just 18.3 overs, helping RCB clinch a 6-wicket triumph on Friday.

Gardner led the Giants' bowling attack with her

two wickets.

Richa Ghosh was named the 'Player of the Match' following her magnificent knock.

# Axar Patel: How spinner's ability to counter spin with bat makes him valuable

NEW DELHI, Feb 15 (Agencies): As Team India gears up for the start of their ICC Champions Trophy campaign, one player that is really worth watching out is the spin bowling all-rounder Axar Patel.

While his performances over the years and improvements in batting have been under the radar of many and he is just one of many options in a country that has no shortage of spin bowling all-rounders, a deep dive into his role can really help one understand that he is a rare specie as far as Indian cricket is concerned: A spinner, who bashes spin with his bat too!

In the 2020s, Axar's numbers with the bat across all formats have undergone a huge upgrade. In 99 matches and 81 innings, Axar has scored 1,606 runs at an average of 26.76, with eight half-centuries and best score of 84. With these numbers. he has been able to place himself as a serious competitors for a spot against premier all-rounders, Ravindra Jadeja and now-retired Ravichandran Ashwin.



During this decade, Axar also played several knocks during which he saved India from jaws of defeat, guiding his team out of troubled waters, with one well-timed drive at a time. These knocks often saw him take on world-class spin bowling really well. Being a practitioner of this art, he could read them really well.

Be it his 47 in 31 balls, which took India from 34/3 to 176/7 in T20 World Cup final against South Africa at Barbados, his 84 against Australia at Nagpur Test in 2023 that took India to 400 from 240/7 and 74 in the next Test in Delhi against Aussies during which he helped India reach within reach of Australia's first innings total of 262 from a troublesome scoreline of

135/6, these are some notable gems against world-class spinners like Keshav Maharaj, Nathan Lyon, Tabraiz Shami, Matthew Kuhnemann that prove "Baapu (Axar's nickname), thaari batting kamaal che!" (Baapu, your bat-

ting is great!)

Axar is among the best spin players in the current Indian set-up and his additional skills as a bowler and a solid fielder makes him a rare talent. Axar has an average of 40.38 since January 2021 in Tests and 525 runs. Only four more batters, Yashasvi Jaiswal (81.75), Rishabh Pant (55.15), Shreyas Iver (41.84) and Shubman Gill (41.04) have more average against spin than Axar, as per Wisden.

Axar has batted every-

where from number four to nine across all formats, though he is not a very frequent player at two-down spot. His ability to counter-attack against spin, especially in Asian conditions, makes him valuable. In white-ball cricket, this ability makes him a valuable floater who can be used in various tactical match-ups against spinners.

Coming to ODIs, he averages 37.75 against spin and strikes at 101 against spin since January 2021. Six batters, Gill (80.00), KL Rahul (69.40), Shreyas lyer (60.00), Virat Kohli (45.22), Ishan Kishan (45.09) and Rohit Sharma (45.07) have better average against spin. Only four of these batters strike at above 100 against spin, Rohit (117), Ishan (101.8), Axar himself and lyer (100.6)

Except for Kishan, all of these batters are India's first choice ODI batters and Axar is putting up a fine fight against them. But the interesting thing is, none of these other batters bowl and only Rohit has a considerably

better strike rate against spin.

Coming to T20Is, Axar has a strike rate of 148.1 and an average of 40.00 against spin. His average against spin is bettered by Ruturaj Gaikwad (76.00), Shivam Dube (49.00) and Suryakumar Yadav (58.67), while Yashasvi Jaiswal, Sanju Samson and Abhisek Sharma lag behind. Though his strike rate is bettered by Abhishek (208.7), Jaiswal (182.5), Samson (171.3), Gaikwad (159.4), Dube (150.5) and only Suryakumar lags behind with SR of 147.7, it is Axar's ability as a spinner that makes him a valuable asset. Out of these batters, only Dube and Abhishek bowl part-time pace and spin respectively.

As a bowler, he still averages below 20 in Tests and can run through teams on spin bowling friendly wickets. In white-ball cricket, he goes at an economy rate of 4.50 in ODIs and 7.30 in T20Is, making him a brilliant all-round option due to his striking abilities against spin and bowling greatness.

# Mark Butcher questions England's 50-over experience ahead of Champions Trophy

LONDON, Feb 15 (Agencies): Former England cricketer Mark Butcher has raised concerns about whether England possess enough experience in the 50-over format to compete effectively in the upcoming Champions Trophy. His remarks came after England suffered a humiliating 3-0 series defeat against India, exposing significant weaknesses in their ODI setup.

Speaking on the Wisden Cricket Weekly podcast during England's third ODI loss in Ahmedabad, Butcher highlighted the lack of match experience among the squad. England fielded several inexperienced players in the series, including Jacob Bethell, who had played just 16 List A games before making his ODI debut last summer. Gus Atkinson, who made his

international debut in 2023 after featuring in only two List A matches, endured a difficult tour, conceding 139 runs across two ODIs. Following Bethell's injury, England recalled Tom Banton, who hadn't played a single 50-over match since his last ODI appearance in 2020.

"The first thing that sprung to my mind during the first two ODIs was just how naive most of our cricket is in the 50-over format," said Butcher, as quoted from Wisden.

"I thought 'why might that be?'. It's because we don't play any. There is a world of difference in terms of the tempo that the game needs to continuously be played at. I don't mean that the tempo is a rigid graph that only goes up, the tempo needs to fluctuate in 50-over cricket in a way that it doesn't

need to in 20-over cricket. Having that skill and nous and game awareness to know when to put the foot down and when to ease off a little but, when to sit in and when to go hard, is something that only comes with playing lots of it," he added.

"I remember back in the 90s when England would play three Texaco Trophy matches during the course of the summer, the sum total of England's 50-over cricket would be three to six matches per summer. They'd be playing against Indian sides, or West Indian sides or Australian sides, the difference in number of caps between them and our players was three times more on the other team. We're kind of back in that situation now whereby the India players will out number the number of caps of

even someone like Jos Buttler for example, by at least two to one or three to one," he said.

"A lot of our guys will be a lot better for the run. Gus Atkinson has had a pretty chastening trip and that's not a bad thing. He's basically found the game far too easy up to this point and has run into the first road block. Being a very talented boy and somebody who has the hunger and desire to be the very best, he will be better for the experience of a flogging in India. But if you're talking about winning a Champions Trophy in a couple of weeks time, it's not likely is it? That our team and the make-up of it and the experience of it is going to have the skill and the nous and the know-how to win what is a very difficult form of cricket, 50-over cricket. It requires more than

just putting your foot to the floor and keeping it there," he noted.

In stark contrast, India's young players have considerably more experience in the format. Shubman Gill, at just 25, has already played 50 ODIs and over 100 List A matches. Yashasvi Jaiswal, who made his ODI debut in the second match of the series in Cuttack, has already featured in 30 List A games despite being in the early stages of his professional career.

To stop her, Lord Shiva threw Himself under her feet. Shocked at this sight, Maa Kali stuck out her tongue in astonishment, and put an end to her homicidal rampage, Kaith added.

## Dimple leads protest against worsening traffic crisis in Jammu

JAMMU, Feb 15: Sunil Dimple, president of Mission Statehood Jammu Kashmir, led a protest against the deteriorating traffic situation in Jammu city, alleging that the roads have become "death traps" due to increasing accidents and lack of government intervention. Addressing the protesters, Dimple criticized the administration for focusing on revenue collection through e-challans instead of implementing effective traffic management measures.

Dimple demanded that Lieutenant Governor Manoj Sinha and former Chief Minister Omar Abdullah take immediate steps to address the crisis by constructing an exclusive four-way ring road and initiating a metro train project. He proposed a metro route from Amphalla Manda to Janipur High Court, Roop Nagar, Bantalab, and Akhnoor as a long-term solution to ease congestion. Additionally, he stressed the need for a flyover at Rehari Chungi and Jewel Chowk to improve traffic flow.

"Jammu city roads have turned into accident-prone zones due to poor infrastructure. Instead of solving the traffic crisis, the administration is only busy issuing e-challans through photographs, harassing the public," Dimple stated.

He further alleged that traffic police officers are more focused on capturing vehicle images for challans rather than regulating traffic smoothly. The issue of VIP movement blockades was also highlighted, with Dimple claiming that during the visits of high-ranking officials, common citizens are forced to wait for long hours at major intersec-

Dimple also raised

concerns over the poor condition of city roads, citing open and broken sewerage manholes as a major cause of accidents. He demanded immediate blacktopping of roads and improvements to Jammu's drainage infrastructure.

In addition to traffic woes, he criticized the Jammu Municipal Corporation (JMC) for forcefully removing traders' establishments and seizing goods worth lakhs of rupees, calling it an unfair approach to solving congestion issues.

Dimple warned that if the government fails to take decisive action, an agitation will be launched against the authorities. The protest was attended by several prominent figures, including Bharat Bhushan Bhat, Ashok Kumar, Sameer Gupta, Narinder Sharma, Suresh Jamwal, Vinay Kumar, Vishal Kapoor, and others.

## **KPs** demand special permanent employment package for educated youth

JAMMU, Feb 15: Prominent Kashmiri Pandit (KP) activist Vinod Pandita has urged the Prime Minister, Home Minister, and Lieutenant Governor of Jammu and Kashmir to address the issue of unemployment among displaced Kashmiri Pandit youth by creating and advertising at least 20,000 permanent government jobs exclusively for them.

Highlighting the community's long-standing grievances, Pandita pointed out that the forced migration of Kashmiri Pandits in 1990, due to threats from terrorists and anti-

social elements, led to the loss of over 20,000 government jobs that had been held by Pandits in the Kashmir Valley.

He alleged that these positions were later filled through a deliberate conspiracy by officials in power at the time, depriving the community of its rightful employment and livelihoods.


