He expressed displeasure over this stating that this tantamounts to breach of privilege as per the prescribed rules and directed the Members to desist from this, read the document.

A spokesperson of the Legislative Assembly was quoted by news agency KNO as saying that the Speaker has issued a directive to ensure strict compliance of the prescribed rules, exhorting the members to observe and honour parliamentary conventions and refrain from premature disclosure of the business to be carried out in the House.

Pertinently, the second leg of the Khelo Indian Winter Games 2025 that was scheduled to be held in Gulmarg earlier this month was postponed due to less snowfall.

Talking to the reporters on the sidelines of an inaugural function of a year-round helicop-

ter service in Gulmarg, Omar, said, "The administration is monitoring the snowfall situation.

Experts from the Ski Federation will assess the slopes in the coming days, and if they approve, the games could be held in the first week of March." If we receive adequate snowfall, the games will take place in early March; otherwise, it won't be feasible due to the approaching summer."

The Chief Minister said that the helicopter service will promote heli-skiing and also offer tourists a unique sightseeing experience. "Soon, Gulmarg will be recognized as a premier destination for heli adventures alongside the famous Gondola

"The helicopter service will operate throughout the year, allowing visitors to enjoy scenic aerial views," he added.

Mehbooba slams Assembly Speaker, Accuses him of imposing a form of 'Martial Law'

SRINAGAR, Feb 23 (Agencies): PDP chief Mehbooba Mufti on Sunday said the role of the assembly speaker is to safeguard the rights of members of the legislature and not to act as a censor.

Her remarks came after Jammu and Kashmir Assembly Speaker Abdul Rahim Rather took a serious note of publicity of the House business notices ahead of the Budget session.

The Speaker has asked the members to desist from the breach of privileae.

The former Jammu and Kashmir chief minister accused Rather of imposing a form of "martial law" while occupying a constitutional position.

"While Rathar Sahab may be concerned with preserving the sanctity of legislative proceedings, as Speaker, his primary role is to safeguard the rights of members,

not to act as a censor." she said in a post on X. She said transparency

and public awareness of legislative activities should not be seen as an infringement on parliamentary practices. "On the contrary.

informing the public about notices, questions, and resolutions in advance promotes accountability. Many significant parliamentary bills, such as the recent Waqf Bill, are debated publicly for months.

"Regrettably, it appears that Rathar Sahab, a seasoned politician, is imposing a form of martial law while occupying a constitutional position," she added.

The Budget session of the Jammu and Kashmir Assembly is scheduled to begin on March 3.







Organized by the Science Club (Utsaah) in collaboration with the Institute of Human Genetics, Department of Zoology, Department of Pediatrics (SMGS Hospital, GMC Jammu), Department of Journalism and Media Studies, and the Mission Program on Pediatric Rare Genetic Disorders, the event also marked the 10th anniversary of Racefor7. The 7-kilometer run/walk symbolized both the 7,000 known rare diseases and the 7-year average delay in receiving a diagnosis.

Prof. Neelu Rohmetra, Dean Research Studies, University of Jammu, inaugurated the event, calling it "a beacon of hope for underserved communities in Jammu." She emphasized the importance of educating society about rare diseases that often run

in families.

Every two weeks a language disappears taking with it an entire cultural and intellectual heritage. UNESCO estimates that there are 8,324 languages ,spoken or signed. Out of these ,around 7,000 languages are still in use. Only a few hundred are genuinely been given a place in education systems and public domain, and less than a hundred are used in the digital world. Multilingual and multicultural societies exist through their languages, which transmit and preserve traditional knowledge and cultures in a sustainable way. International Mother Language Day is observed every year to promote linguistic and cultural diversity and multilingualism. it was on 16th May 2007, the UNGA in its resolution A/RES/61/266 called upon Member States "to promote the preservation and protection of all languages used by peoples of the world. "By the same resolution, the General Assembly proclaimed 2008 as the International Year of Languages, to promote unity in diversity and international understanding, through multilingualism and multiculturalism and named UNESCO to serve as the lead agency for the year. Today, there is growing awareness that languages play a vital and pivotal role in development ,ensuring cultural diversity and intercultural dialogue, but also in strengthening cooperation and attaining quality education for all ,in building inclusive knowledge societies and preserving cultural heritage, and in mobilizing political will for applying the benefits of science and technology to sustainable development. This day is observed also in India to celebrate linguistic diversity and preserve mother tongue globally, with a special focus on multilingualism in India. India's linguistic diversity is highlighted with languages being more than just a means of communication but also reflecting the country's rich cultural heritage. The idea to celebrate International Mother Language Day was the initiative of Bangladesh .It was approved at 1999 UNESCO General Conference and has been observed throughout the globe since 2000.UNESCO believes in the importance of cultural and linguistic diversity for sustainable development and societies. Globally 40 percent of the population does not have access to an education in a language they speak or understand. UNESCO is calling on the international community as a whole to promote multilingualism, making the richness and diversity of linguistic heritage an instrument of lasting peace. In India our government ,NGO's ,political parties and the public at large should strive to preserve, promote and develop languages and preserve linguistic diversity amid the ambit of total diversity as India can remain in peace and tranquility through the promotion and preservation of its diverse languages. Let us give education to children in their mother language for good learner outcome and comprehension as well as understanding. We should not only observe 21st February as the International Mother Language Day as a formality but make sincere resolve to foster the idea and need of promoting, preserving and protecting all the languages of India so that linguistic diversity and cultural heritage is preserved and is transmitted through the means of the mother language.

ith Rekha Gupta taking over as the CM of Delhi, a new chapter has been added to politics. After becoming a councilor for the second time in 2012, she became the chairperson of the Education Committee of Delhi Municipal Corporation. 

The day will begin with a Guard of Honour followed by discussions with French Army chief Gen Pierre Schill. The two will look to foster stronger military ties between the two nations.

The itinerary includes a visit to the French Military School and Institution Complex in Paris, where Gen Dwivedi will be briefed on future combat command. He will be briefed at the technical section of the French Army and visit the 'battle lab' at Versailles.

He will also travel to Marseille, where he will visit the 3rd Division of the French Army and will be briefed on the mission and role of the 3rd Division, the bilateral exercise Shakti, India-France training cooperation, and the French Army modernisation programme (Scorpion).

Gen Dwivedi will visit Carpiagne to



witness a dynamic demonstration of the Scorpion division with live firing exercises

The Army chief will also visit the Neuve Chapelle Indian War Memorial to lay a wreath in honour of the fallen Indian soldiers who participated in World War I. Later in the day, he will deliver a talk at the French Joint Staff College, highlighting the evolving nature of modern warfare and India's strategic vision.

The Ministry of Defence said on Sunday, "General Dwivedi's visit aims to strengthen the military collaboration between India and France, exploring new avenues of cooperation and enhancing strategic partnerships between the two nations' armed forces."

Rescue teams inch closer to workers trapped in Telangana tunnel

HYDERABAD, Feb 23 (Agencies): Rescuers have inched closer to the engineers and workers trapped inside a tunnel after a section of the Srisailam Left Bank Canal project collapsed 24 hours ago, with operations under way to extricate them, officials said on Sunday.

The teams at the accident site in Nagarkurnool district, about 150 km from here, called out the names of the trapped people, but there was no response, sources said.

The rescue personnel were able to reach up to the 13th km inside the tunnel, a short distance from where the mishap occurred around 8.30 am on Saturday.

According to official sources, state Ministers N Uttam Kumar Reddy and J Krishna Rao have left for the site to oversee the rescue operations.

"Rescuers will have to clear the debris filled with iron, muck and cement blocks. The teams were able to reach up to the 13th



km where the collapse occurred. They are assessing the situation at the place where the Tunnel Boring Machine was last placed on Saturday," sources told PTI.

"The (rescue) teams have reached almost up to the last point (till the machine). We are assessing the situation," a senior police official said on Sunday.

Of the eight, six (two engineers and four labourers) belong to

Jaiprakash Associates and two are employees of a US com-

Prime Minister Narendra Modi on Saturday called up Telangana Chief Minister A Revanth Reddy to enquire about the incident and assured all possible assistance for the rescue

On Sunday, the rescue operation was on, involving the NDRF, SDRF, Army personnel and the company's employees.

After the construction work resumed recently, as many as 50 people went inside the tunnel in the first shift along with the tunnel boring machine which is 200 metre long, on Saturday

They went up to 13.5 km inside the tunnel when the roof collapsed suddenly. Eight members including two engineers, who were ahead of the machine got trapped while 42 others ran towards the outside gate of the tunnel and came out.

Uttam Kumar Reddy had said the work on the "world's longest tunnel of 44 km" began to draw water from the Srisailam project to irrigate four lakh acres in Nalgonda district. Of the 44 km, work on about 9.5 km remains to be carried out, he said.

Revanth Reddy was constantly reviewing the situation and he instructed the officials to expedite the rescue operation to save those trapped, the government said.

Bangladeshi artistes break ice, perform at Maha Kumbh

PRAYAGRAJ, Feb 23 (Agencies): While politics and diplomacy struggled to mend the bridge, faith seems to have pulled off the job with elan.

In what looked to be the first official cultural exchange between India and Bangladesh since the fall of the Sheikh Hasina government in August last year and the subsequent unrest in the neighbouring nation where minority Hindus were allegedly targeted, a group of Bangladeshi artistes were partly sponsored by the Muhammad Yunus regime to perform at the Maha Kumbh.

A six-member dance troupe from Bangladesh performed at the Kumbh's 13,000-seater Ganga Pandal, the makeshift central cultural hub, on Saturday evening at the inaugural session of the 10th India International Dance and Music Festival.

The event was hosted jointly by the UP government and the Indian Council for Cultural Relations (ICCR), which works under the Ministry of External Affairs.

The participation followed Bangladesh's absence from key cultural events in India, such as the recently concluded International Kolkata Book Fair 2025 and the 30th Kolkata International Film Festival in December last year. Bangladesh had been a consistent participant in these events until recently. The troupe, part of a 107-member delegation of foreign artistes representing 10 nations, was led by Rachel Priyanka Persis, an assistant professor at Dhaka University's dance department.

The troupe showcased the Gaudiya dance, a Vaishnava form based on religious stories, poetry and music.

Following their twoday performance at the Mahakumbh on February 22 and 23, the delegation is scheduled to perform in Gujarat, Jammu and Kashmir, Jharkhand, Bihar, Assam and Meghalaya before their final show in Delhi later this month.

"I feel fortunate to be able to perform amid this sea of humanity. The Maha Kumbh carries a spiritual legacy of 144 years. I would thank the Indian High Commission for its invitation. We had no problems in obtaining our visas," Priyanka said and introduced the other members of her team --Mousumi, Laboni, Rini, Raisa and Pinki.

Participating alongside India and Bangladesh were artistes from Russia, Mongolia, Rwanda, Kyrgyzstan, Maldives, Vietnam, Malaysia, South Africa and Fiji, officials said. The event was part of

the Cultural Exchange Programme Agreement (CEPA) between India and several nations, aimed at promoting Indian culture abroad and exposing local artistes to international art and culture, they said.

"According to CEPA, the ICCR shoulders the financial burden of the visiting artistes in terms of their accommodation, local transport and visa arrangements. The

respective foreign government, on the other hand, pays for their airfare. The arrangement was honoured by the Bangladeshi government like all other foreign nations," said ICCR Director General K Nandini Singla. She highlighted the

role of culture and spirituality in building bonds between people where relations have strained on account of changing politics. "Culture never stops to connect," she said, "Governments may come and go, politics and leaders may change but the heart-toheart bonds don't fade because they are built on emotions. No political leader may come and change the way you look at another country or a different culture. That's why our connections with countries have endured for millennia." The DG built on the

theme of the evening's performance, Vasudhaiva Kutumbakam the Upanishadic phrase meaning 'the world is one family', to elaborate her point.

"The theme reflects the 'sangam' of culture. Performing at the Maha Kumbh, where the confluence of three rivers creates divinity, would entail the core message that we are one. The Kumbh is a great equaliser. True, one could be a Bangladeshi and face political difficulties, but at the end of the day, we are all humans with the same aspirations, needs and fears. Those emotions of the heart always overpower the thought processes of the brain," she said. A joint performance of all artistes has been choreographed by renowned Kathak exponent Rani Khanum to form the evening's crescendo on stage following the showcasing of individual cultures by the nations, officials said. "This is the first time

that ICCR is holding the inauguration of the international dance festival outside Delhi," ICCR's **Deputy Director General** Anju Ranjan.

"After all, this opportunity has come to us after 144 years and we could not let it go," she added.

Centre 'studying' legal provisions to regulate obscene digital content media content.



NEW DELHI, Feb 23 (Agencies): Amid an advisory to OTT platforms against transmitting obscene content, the Ministry of Information and Broadcasting has said that there is a need to revisit the existing laws on the subject.

The admission was made before the Parliamentary Standing Committee on Communications and Information Technology this week.

Making a deposition

before the panel, the ministry said it was in the process of reviewing existing statutory provisions and considering requirements for a reworked legal framework on regulation of harmful content on digital platforms.

The move follows the controversy over vulgar remarks made by You-Tube influencer Ranveer Allahbadia during a show on the digital platform. The Supreme Court had issued directions on the regulation of such content.

Presenting its stand to the panel, which took up the agenda this week, the ministry cited growing social concerns around freedom of expression being misused to peddle obscene, vulgar, violent content on digital platforms.

It said certain provisions existed in the current laws but equally there was a growing chorus for a stricter and more effective legal framework on social

"This ministry has taken note of these developments and is in process of examining current statutory provisions and need for a new legal framework," said the Ministry of Information and Broadcasting representatives citing directions of the SC and several high courts on the issue besides references by parliamentarians and the National Commission for Women.

Allahbadia is facing criminal cases in Assam and Maharashtra for his remarks that were pulled off YouTube.

The SC this week stayed fresh FIRs against the influencers while castigating his remarks as "perverted".

Even the Rashtriya Swayamsevak Sangh (RSS), the ruling BJP's parent body, has been demanding fresh legislation to regulate OTT platforms. RSS chief Mohan Bhagwat had, in his Vijayadashami address on October 12 last year, called for an urgent legislation to regulate OTT content.

TEL AVIV, Feb 23 (Agencies): Israel says the release of hundreds of Palestinian prisoners is delayed "until the release of the next hostages has been assured, and without the humiliating ceremonies" at handovers of Israeli captives in Gaza.

The statement by Prime Minister Benjamin Netanyahu's office came early Sunday as vehicles apparently carrying prisoners left the open gates of Ofer prison, only to turn around and go back in.

The release of 620 Palestinian prisoners had been delayed for several hours and was meant to occur just after six Israeli hostages were released on Saturday. It was meant to be the largest one-day prisoner release in the Gaza ceasefire's first phase.

Five of the six hostages freed Saturday were escorted by masked, armed militants in front of a crowd — a display that the UN and others have criticised as cruel after previous handovers.

The Israeli statement cited "ceremonies that demean the dignity of our hostages and the cynical use of the hostages for propaganda purposes". It was likely a reference to a Hamas video showing two hostages who have yet to be released watching a handover in Gaza on Saturday and speaking under

Hamas had released the last six living hostages expected under the ceasefire's first phase, with a week remaining in the initial stage.

Israel's announcement abruptly put the future of the truce into further doubt.

Later, Israel's military said Hisham Al-Sayed, 36, was released. The Bedouin Israeli entered Gaza in 2015. His family has told Israeli media he was previously diagnosed with schizophrenia.

Niva Wenkert, Omer's mother, told Israel's Channel 12 that "on the surface, he looks OK, but there's no telling what's inside".

Families and others rallied again Saturday night in Tel Aviv to pressure Netanyahu's government for a deal.

Hamas later released a video showing two hostages still held, Evyatar David and Guy Gilboa Dallal, as they sat in a vehicle and spoke under duress at the handover for Shem Tov, Cohen and Wenkert. A group representing hostages' families called the video "sickening".

The 620 Palestinian prisoners meant to be freed include 151 serving life or other sentences for attacks against Israelis. Almost 100 would be deported, according to the Palestinian prisoners' media office.

Also meant to be released are 445 men, 23 children aged 15 to 19, and a woman, all seized by Israeli troops in Gaza without charge during the war.

PoGB: "Education department's failures have been repeatedly exposed", says civil society representative



GILGIT. Feb 23 (Agencies): Pakistanoccupied Gilgit-Baltistan's education system is facing a serious crisis, with alarmingly high failure rates exposing deep-rooted issues in the region's administration. Civil society representative Faheem Akhtar has raised concerns over the repeated failures of the education department, stating, "This is not the first time that the education department's failures have been exposed. Previously, during the intermediate exams, a large number of students were unable to pass. Similarly, this year, around 60 to 70 per cent of students in fifth and eighth grade have failed."

One of the key issues affecting education in Gilgit-Baltistan is the frequent transfer of experienced teachers into administrative roles. "As soon as someone gains even a little teaching ability, they shift into administrative roles," Akhtar said. "Most of the competent teachers have moved into positions such as directors and other administrative posts, which has disrupted the education system." These roles come with additional benefits but take qualified teachers away from classrooms, leaving students without proper

instruction. Budget allocation for education in the region remains inadequate. "Compared to other provinces, the allocation for education in Gilgit-Baltistan is the lowest," Akhtar pointed out. He added that while a significant portion of the non-development budget--over 10 billion rupees--is spent on salaries for education department employees, there is little accountability regarding how resources are used. Meanwhile, students in many areas are forced to study outdoors in extreme weather conditions due to the lack of proper school infra-

structure.

The examination system in the region has also failed to ensure quality education. "If only 28 per cent of students pass, that means the entire department has failed," Akhtar stated. "If an individual student scoring below 40 per cent is considered a failure, then when

the overall pass rate is below 28 per cent, the department itself should be held accountable."

A lack of clear policies and curriculum planning further adds to the problem. Akhtar noted that civil society had proposed including local languages in the curriculum, but despite developing frameworks, there was no implementation. "Education is not just about language but understanding. Yet, we have an education system that relies on rote learning rather than conceptual understanding," he said.

He also pointed out the hypocrisy in the system, where government officials send their children to private schools while public schools continue to decline. "They drop their children off at private schools and then go to work in government schools, expecting others to teach there," he remarked.

The situation is even worse in remote areas, where limited access to education affects students' overall learning outcomes. The lack of proper infrastructure, combined with the absence of vocational training and higher education opportunities, further hinders the region's development. "Education is a long-term process that requires sustained efforts, but instead, we see shortterm projects with no lasting impact," Akhtar emphasised.

Without immediate intervention, the future prospects of young people in Gilgit-Baltistan will continue to suffer, leaving the region further behind in development.

Meloni slams Left's double standards, saying when Trump, Milei, Modi and I talk, it's called threat to democracy


WASHINGTON, Feb 23 (Agencies): Italian Prime Minister Giorgia Meloni has slammed the Left "double standards" in perceiving conservatives globally, saying when leaders like herself, US President Donald Trump and Prime Minister Narendra Modi collaborate they are called a "threat to democracy" while leftist leaders are praised for similar alliances.

Meloni's remarks came as she addressed the Conservative Political Action Conference (CPAC) in Washington via video link from Rome.

During the address, Meloni praised Trump and said the Left is nervous about Trump's victory.

"Their irritation has turned into hysteria, not only because conservatives are winning, but because conservatives are now collaborating globally."

"When Bill Clinton (former US president) and Tony Blair (former British prime minister) created the global leftist liberal network in the 90s, they were called statesmen.



Maloni, (President of Argentina Javier) Milei or maybe Modi talk, they are called a threat to democracy. This is the last double standard, but we are used to it, and the good news is people no longer believe in their lies, despite all the mud they throw at us. Citizens keep voting for us," said Meloni.

She said people vote for them as "we defend freedom, we love our nations, we want secure borders, we preserve businesses and citizens from the green leftist insanity and we defend family life."

family life."
"We fight against wokeism...and we stand for common sense," she

said.

People are not as naive as the Left considers them, she said.

United States and Europe would remain close under Trump, despite soaring tensions between the allies including over Ukraine.

BEIJING, Feb 23 (Agencies): China's Defense Ministry said Sunday that Australia had made "unreasonable accusations" and deliberately hyped the situation after three planes headed to New Zealand changed course in midflight because of live-fire drills by the Chinese navy.

Wu Qian, the ministry's top spokesperson, said China had issued safety notices in advance and that the activity was in compliance with international law and did not affect aviation safety.

"The relevant remarks from the Australian side are completely inconsistent with the facts," he said in a response posted on the Defense Ministry website.

Three passenger flights from Sydney to Christchurch and Queenstown were in the air Friday when they were first warned by a Chinese warship of a

The flights diverted and no one was put in danger, Australian Defense Minister Richard Marles told Australian Broadcasting Corp. radio. But he also said the Australian navy would typically give 12 to 24 hours' notice of a live-fire exercise to give airlines time to plan around it.

Australian Foreign Minister Penny Wong said she sought an explanation from her Chinese counterpart, Wang Yi, when the two met in Johannesburg on Saturday following a gathering of foreign ministers from the Group of 20 nations.

"I raised Australia's expectations around safe and professional military conduct, consular cases, human rights and other issues of concern," Wong said in a post on the social plat-

form X. "I also sought an explanation for Chinese naval vessels conducting live fire drills without advance notification."

The presence of the three Chinese warships in the region — a frigate, a cruiser and a replenishment vessel — had gotten the attention of the Australian and New Zealand militaries earlier last week. Marles described the activity as unusual, though not unprecedented.

New tax regime: 3 deductions that can help taxpayers maximise savings

NEW DELHI, Feb 23 (Agencies): The government, with the aim of simply personal taxation, introduced the new tax regime. Out of the total 7.28 crore ITRs filed, 5.27 crore were under the new regime, while 2.01 crore were filed under the old tax regime for AY 2024-25, indicating nearly 72% of taxpayers have shifted to the new system.

Though the new regime offered concessional tax rates, it reduced several popular deductions and exemptions, like the house rent allowance (HRA), leave travel allowance (LTA), interest on home loans, Section 80C, and more. However, taxpayers can still claim the following three deductions.



STANDARD DEDUC-TION

Now taxpavers can claim an enhanced standard deduction benefit under the new tax regime. Budget 2024 has increased the limit of standard deduction from Rs 50,000 to Rs

75,000 for FY2024-25 onwards

NPS CONTRIBUTION Employers' contributions towards the National Pension Scheme (NPS) have been exempted under the new income tax regime under Section

80CCD(2). However, no such exemption is given to an employee's own contribution to NPS.

GRATUITY Certain retirementrelated benefits such as gratuity and voluntary retirement remain tax-exempt under the

new regime. Gratuity is exempted under Section 10(10), while exemption for voluntary retirement scheme can be claimed under Section 10(10C) by the taxpayers.

Moreover, deductions such as leave encashment under Section 10(10AA) are also available to taxpayers under the new regime.

Meanwhile, as the tax structure evolves, taxpayers must review their tax-saving plans. Although the new regime makes tax-filing easier, it also removes several deductions and exemptions.

However, being informed about the available deductions can help taxpayers maximise savings and minimise tax burden.

EV start-up River eyes exports to 11 countries



BENGALURU, Feb 23 (Agencies): Bengaluru-based electric scooter startup River, which is backed by marquee investors such as Yamaha Motor and Toyota Ventures, plans to export to about 11 countries soon. "We have an investor- Al Futtaim Group of Middle East Dubai. They are Toyota distributors in Dubai. We have an agreement with them to help us scale to around 11 countries globally because they already have local presence in those countries. We will export out of Bengaluru starting at the end of this year or early next year," Aravind Mani, co-founder and CEO of River, told this newspaper.

The company will start with Sri Lanka

or Myanmar and then will scale to Southeast Asia, Europe.

The start-up has an R&D centre in Bengaluru where it employs about 400 people. "We develop the entire vehicle from scratch, starting from designing the vehicle, making the battery technology, the battery management system, the vehicle control units. The cell is imported, but the battery pack is made by us. We don't make cells at scale in India," he said, adding in the next 2 to 3 years, India will start producing it at a large scale.

Founded in 2021 by Aravind Mani and Vipin George, the start-up last year raised \$40 million (Rs 335 crore) in Series B round, led by Yamaha Motor Co., Ltd. River started selling its first product Indie, the SUV of scooters in October 2023. The first River store was opened in Bengaluru in January 2024.

"We will close the year with maybe around 6000-7000 vehicles in FY25. Next year, we are targeting to sell around 30,000 to 40,000 vehicles," the co-founder added. By March 2025, it is planning to open 25 stores and by next March, it plans to expand to 100 stores.

Tesla recalling more than 375,000 vehicles due to power steering issue

NEW DELHI, Feb 23 (Agencies): Tesla is recalling more than 375,000 vehicles due to

a power steering issue. The recall is for certain 2023 Model 3 and Model Y vehicles operating software prior to 2023.38.4, according to the National Highway Traffic Safety Administration.

The printed circuit board for the electronic power steering assist may become overstressed, causing a loss of power steering assist when the vehicle reaches a stop and then accelerates again, the agency said.

The loss of power



could required more effort to control the car by drivers, particularly at low speeds, increasing the risk of a crash.

Blood pressure drug could be safer alternative for treating **ADHD symptoms: Study**

LONDON, Feb 23 (Agencies): A blood pressure medication may be a safer choice for treating symptoms of attention-deficit/ hyperactivity disorder, according to a study whi. Repurposing amlodipine, a commonly used blood pressure medicine, could help manage (ADHD) symptoms

According to an international study published in Nuropsycopharmologyy, involving the University of Surrey, researchers tested five potential drugs in rats bred to exhibit ADHD-like symptoms. Among them, only amlodipine, a common blood pressure medication, significantly reduced hyperactivity.

To confirm its effects the team tested amlodipine in zebrafish, an important model for studying brain function sharing about 70% of genes with humans.

The results showed that amlodipine also reduced hyperactivity and impulsivity--core symptoms of ADHD--in these fish. Further analysis of the fish revealed that amlodipine crosses the blood-brain barrier for the first time, meaning it can directly influence brain function.

The researchers then turned to human genetic data and found that, remarkably, ADHD is linked to the same calcium channels in the brain as the targets for amlodipine. This suggests a potential target brain pathway for treatments.

Finally, an analysis of UK-wide patient data showed that people taking amlodipine reported fewer mood swings and less risk-taking behaviour, further supporting its potential as a new ADHD treatment.

Dr Matthew Parker, co-author of the study from the University of Surrey, said, "Repurposing amlodipine, a well-established blood pressure medication, offers a promising and swift pathway to address ADHD symptoms.

Our research indicates that. due to its existing approval and safety profile, amlodipine could be rapidly redeployed as a treatment option for ADHD, potentially providing relief to patients sooner than developing new medications.'

Current ADHD medications are effective but come with significant side effects: from appetite loss, high blood pressure, headaches and sleep disturbance and carry a risk of misuse. Amlodipine, which is already widely used and well-tolerated, could offer a new, safer treatment option for ADHD.

Around 25% of patients do not respond well to any current ADHD medication, highlighting the urgent need for new treatment options.

Brain perceives unexpected pain more strongly: Study



TSUKUBA, Feb 23 (Agencies): Researchers used visual threat manipulation and thermal stimulation in the virtual reality environment to investigate how the brain perceives pain. They found that the brain perceives pain more strongly when the perceived pain is out of alignment with reality. In particular, pain was amplified when unexpected events occurred.

Pain perception can vary greatly. Sometimes, we feel pain more intensely than expected due to an injury or physical ailment but may feel less intense pain in

other similar instances. This variability indicates that our perception of pain is highly dependent on our expectations and uncertainty

In this study, the mechanism underlying the perception of pain was investigated.

Two hypotheses have been proposed to explain how the brain perceives pain. One is the Estimate Hypothesis, where the brain estimates the intensity of pain based on predictions.

The other is the Surprise Hypothesis, where the brain perceives pain as the difference

between prediction and reality, otherwise known as the prediction error.

In the experiment, healthy participants received painful thermal stimuli and reported feeling pain intensity while observing painful or non-painful visual stimuli in virtual reality.

The researchers found that the participants strongly perceived pain when the prediction error was large

The study further confirmed that pain was amplified when unexpected events occurred. People with chronic pain often experience vague pain-related fears and anxieties.

Possibly, this uncertain gap between expectation and reality further increases the perceived intensity of pain. Therefore, reducing the gap between pain expectation and reality or "surprise" is important in reducing pain.

This study has resulted in a better understanding of pain perception. It would help to facilitate the development of new treatments that would enhance recovery from chronic pain and trauma

Lifestyle and Environmental factors affect health and ageing more than genes: Study

LONDON, Feb 23 (Agencies): A new study led by researchers from Oxford Population Health has shown that a variety of environmental factors, including lifestyle choices (such as smoking and physical activity) and living conditions, have a more significant impact on health and premature death than our genes.

The study, which analysed data from nearly half a million UK Biobank participants, examined the influence of 164 environmental factors and genetic risk scores for 22 major diseases on ageing, age-related diseases, and premature death. The findings were published today in Nature Medicine.

As per the key findings, the

environmental factors explained 17% of the variation in risk of death, compared to less than 2% explained by genetic predisposition (as per the present).

Of the 25 independent environmental factors identified, smoking, socioeconomic status, physical activity, and living conditions had the most impact on mortality and biological ageing. Smoking was associated with 21 diseases; socioeconomic factors, such as household income, home ownership, and employment status, were associated with 19 diseases; and physical activity was associated with 17 diseases.

The early life exposures, including body weight at 10 years and maternal smoking around birth, were shown to influence ageing and risk of premature death 30-80 years later.

Environmental exposures had a greater effect on diseases of the lung, heart and liver, while genetic risk dominated for dementia and breast cancer.

Professor Cornelia van Duijn, St Cross Professor of Epidemiology at Oxford Population Heath and senior author of the paper, said 'Our research demonstrates the profound health impact of exposures that can be changed either by individuals or through policies to improve socioeconomic conditions, reduce smoking, or promote

physical activity.

The research shows that whilst many of the individual exposures identified played a small part in premature death, the combined effect of these multiple exposures together over the life course (referred to as the exposome) explained a large proportion of premature mortality variation.

The insights from this study pave the way for integrated strategies to improve the health of ageing populations by identifying key combinations of environmental factors that shape the risk of premature death and many common age-related diseases simultaneously.

Whereas Pakistan has come to Dubai after losing in Pakistan, and they have played on better pitches, but here they will get a little slow pitch, and adjusting to a slow pitch will be difficult for them. India is the favourite in my point of view, and India will win this match because India's team is

the best," he said. With the world's eyes on this marquee clash, India will look to continue their dominance against Pakistan in major ICC events.

Speaking about the performances in the post-match presentation, Smith said, "I thought the guys were outstanding from the outset. (Matthew) Short played beautifully up top. Travis (Head) and I were the only two to miss out and the middle order did a tremendous iob. Really pleased. Regardless of what



team we have, we would have bowled first, knowing how wet it (grass) got when we trained the other night and this evening. Looked easiest to bat at the back end. I thought it slowed up in the end in the first innings and I thought 350 was chaseable."

"For a moment it looked like they (England) were probably gonna get over 400, we were pleased by that effort and knew we could chase this if we batted 50 overs. Trusting each others' skills, the boys did a really good job, took pace off at the right times, hit hard lengths and controlled at the back end of the game. Marnus (Labuschagne) bowled nicely at the back end. The two keepers have been batting beautifully for a while now. They are both in great form. Josh hits the ball all along the ground and has all the shots, Was an amazing effort from Inglis and Alex played beautifully as well. Really pleased with the team effort," he

added. Australia opted to bowl first and looked set for a fine outing when England was reduced to 43/2, with a move to promote voung wicketkeeper-batter Jamie Smith at off. However, Ben Duckett and Joe Root (68 in 78 balls, with four boundaries) responded with a well-compiled counter-attack, helping England cross 200 runs with a 158-run stand. With wickets falling at the other end, Duckett kept swinging mercilessly his way towards 165 in 143 balls, with 17 fours and three sixes. England scored 351/8 in their 50 overs.
