SRINAGAR, Mar 3 (Agencies): Gulmarg is set to host the second leg of the 5th Khelo India Winter Games from March 9 to 12 after the event was postponed due to inadequate snow, officials said on Monday. An official said that the

event will feature over 300 athletes from across the country, competing in various winter sports, including alpine skiing, Nordic skiing, ski mountaineering, and snowboarding.

#### **Snowfall in** Kashmir higher reaches as rain lashes J&K

SRINAGAR, Mar 3 (Agencies): Rain lashed the plains, while higher reaches received fresh snowfall on Monday in Jammu and Kashmir.

The Meterological (MeT) office has forecast light to moderate rain and snow in higher reaches on Monday. adding that a few higher reaches in north and central Kashmir might receive moderate to heavy snowfall.

The weather is expected to remain mostly dry from March 4 to March 9, while a fresh spell of rain and snow is expected between March 10 and March 12.

Rain and snow during the last seven days has set at rest the fears of a prolonged dry spell resulting in drought in the union territory this year.

The water level in rivers, streams, lakes, springs and other water bodies has improved considerably. Some of the perennial springs that had dried up due to the prolonged dry spell for 50 days in January and February have again started flowing with water.

The weather woes had started when Kashmir witnessed just one major snowfall during the 40-day long period of harsh winter cold called the 'Chillai Kalan' that starts each year on December 21 and ends on January 30.

It is this snowfall during the 40-day long period of harsh winter cold that replenishes the perennial water reservoirs in the mountains and provides abundant water.

He highlighted that, for the first time, the Chief Minister personally chaired meetings for all twenty districts, directly engaging with elected representatives to understand their aspirations, regional needs,

Addressing the paramount aspiration of the people, Lt Governor Sinha reaffirmed the government's unwavering commitment to restoring full statehood to Jammu and Kashmir.

stability, and progress."

Sinha also emphasised the government's commitment to preserving the unity in diversity that defines Jammu and Kashmir and to maintaining peace and harmony, protecting the aspirations of the people from divisive influences and cultivating an inclusive society built on mutual respect.

Lt Governor Sinha outlined the government's commitment to fulfilling its promises, focusing on political empowerment, employment creation, sustainable development, social inclusiveness, and economic expansion. He emphasized the importance of balancing economy, ecology, and equity for a better future. He stressed that the government's interventions would prioritize youth. women, and farmers, striving to make Jammu and Kashmir a progressive and inclusive economy, working towards the welfare of every section of society, especially the poor and marginalised.

The Lt Governor highlighted significant advancements in infrastructure, including the inauguration of the Sonamarg Tunnel (Z-Morh) and the completion of segments of the Jammu-Srinagar National Highway. He stressed the commitment to fast-tracking major connectivity projects, including expressways, national highways, and ring

the Pradhan Mantri Gram Sadak Yojana (PMGSY).

The Udhampur-Srinagar-Baramulla Rail Link (USBRL) project is poised to transform connectivity, integrating Jammu and Kashmir more closely with the rest of the nation. To enhance air connectivity, evening flights have been made operational, and the expansion of Jammu Airport is underway.

Recognising the untapped potential of Jammu and Kashmir's water resources, the Lt Governor stated the government's commitment to harnessing their full potential to enhance people's lives and the region's financial position. Key hydropower projects like Pakal Dul, Kiru, Kwar, and Ratle are expected to significantly strengthen the region's energy security, with other projects like Dulhasti-II and Kirthai-I in the pipeline. The government is also committed to solarizing all government buildings in a phased manner and is implementing the PM-Surya Ghar Muft Bijli Yojana.

# Jammu Kashmir Assembly: Mubarak Gul pushes for free services for former MLAs

(Agencies): Former Speaker and MLA Eidgah, Mubarak Gul, on Monday demanded free medical treatment and transportation services for former legislators of Jammu and Kashmir. He urged the government to extend these benefits on par with those provided to former parliamentar-

Gul made these remarks during obituary references on the first day of the budget session.

islators of Jammu and Kashmir, after completing their tenure, struggle to resume normal life due to prevailing uncertainties, unlike their counterparts in other







# NC acting as extension of BJP in Jammu and Kashmir: Mehbooba Mufti



SRINAGAR, Mar 3 (Agencies): Peoples Democratic Party (PDP) Chief Mehbooba Mufti on Monday accused the Omar Abdullah-led National Conference (NC) government of acting as an extension of the Bharatiya Janata Party (BJP) in Jammu and Kashmir.Jammu tourism

The former Chief Minister suggested that the NC was attempting to legitimize the BJP's actions over the past six years, including the abrogation of Article 370 in August 2019.

"Unfortunately, it seems that the BJP's agenda, their policy regarding Jammu and Kashmir, has become an extension of the ruling government that was elected with a massive majority. The things for which we used to raise our voices, which are unconstitutional, it seems that the people of the National Confer-

ence are in a race to legitimize those things that happened in recent years," Mufti told a press conference in Srinagar. She criticized the

Lieutenant Governor's address on the opening day of the Budget Session, expressing disappointment that it did not address the issues of disempowerment faced by the people of Jammu and Kashmir.

"There was no mention of a resolution which NC claims they brought for restoration Article 370-in the Lt Governor's address. This cabinet has not even dared to bring it up. What else can we say?" she said.

Mufti took a jibe at Omar Abdullah, stating that no one was asking him to become Delhi former Chief Minister Arvind Kejriwal, but that he should at least stand up for the rights of his people.

"Our Chief Minister Omar Abdullah says that I do not want to become Kejriwal. No one is asking him to be Kejriwal, but for God's sake, stand up for the rights of

your people," she said.
Mufti said that the BJP
had been raising the
issues of Article 370
abrogation even when
it had no power.

"Omar sahib says how he will get it (Article 370) from the BJP. When BJP could talk on abrogating Article 370 for 70 years, at least you (Omar) can speak on this and say this was done illegally," she said.

She said that people voted for Omar Abdullah hoping the government would address issues of disempowerment, as well as concerns over property, minerals, and

"I did not expect miracles from the NC in four months, but at least they should have raised their voice on such issues," she said.

Mufti said that besides Article 370 and Statehood restoration, several issues were being faced by the public.

She said they have brought several bills and expect that there would be unity among political parties to address these critical issues facing Jammu and Kashmir.

Speaking in the legislative assembly, Sinha highlighted the crucial role of the media in shaping public discourse, holding institutions accountable, and keeping citizens informed.


He said that the administration is dedicated to creating a secure and transparent environment for journalists to operate without fear or restrictions.

"With 24x7 digital banking services already available and most government and corporate offices working five days a week, this should be implemented in the banking sector with immediate effect. This will only lead to an increase in customer service and productivity," said a UFBU spokesperson.



The union leaders emphasised that a strong workforce not only ensures better customer service but also reduces workload on existing employees, ultimately improving the quality of banking operations. They also highlighted several other concerns, including the urgent need to address the increasing work

load in branches due to shortage of staff, ensuring fair and transparent policies with regard to promotions, transfers and employee welfare, and opposing unfair labour practices and any attempt at further privatisation in the banking sector. Today's dharna is part of a wider agitation programme, with the union leaders saying that if their demands are not heeded, they will intensify their protests in the coming weeks and there will be a nationwide strike on March 24 and, 25, 2025.

Increasing the number of MPs from more populous states would draw attention to developmental inequalities, ensuring that policy interventions are targeted towards underdeveloped regions. For states like Madhya Pradesh and Rajasthan, a higher number of MPs could lead to better infrastructure planning and better allocation of investments.

The diminished role of progressive states harms federalism and fair political representation. Southern states with effective governance may lose influence, reducing the incentive for sound policy management. Growth driven by Kerala's high literacy rate may not translate into adequate seat allocations, discouraging other states from adopting similar strategies. Greater representation for more populous states may lead to a tendency towards centralized policymaking, which may restrict regional governance autonomy. Legislative adjustments favoring agricultural states may neglect the needs of industrial sectors, disrupting economic balance. This political realignment may affect the allocation of taxes by the Finance Commission, which could potentially favor states with larger populations.

#### From Rote to Wonder: How science education evolved from facts to Curiosity

hile science was, and still is, seen as a career-oriented subject, there were never cases of students being taught why something is happening or why they are studying it.

H2O is water. CO2 is carbon dioxide. Gravity pulls everything down. Decades ago, science was often taught as a collection of facts to memorise — definitions, formulas, and rigid laws that left little room for wonder. A teacher would write equations on the blackboard, which students would copy, and the lesson would go on. But over the years, science became more about questions.

Today, science education is not just about learning concepts but experiencing them — through

exploration and a sense of curiosity that makes students see the world differently. This transformation, experts say, was not just about teaching but a fundamental shift in how science was perceived.

For the longest time, it was seen as a subject perfect for securing a job, promising stability rather than excitement. Senior scientists recall that many pursued science degrees primarily for career opportunities, rather than a genuine interest in understanding the subject. But over the years, that mindset changed. Science became a topic of passion, a discipline for those who wanted to learn, explore and teach, rather than just a stepping stone to employment.

"Science is no longer just a subject people study to get a job — it

has become a field of curiosity, learning and teaching," Over the years, science has grown into an area of genuine interest, attracting those eager to understand its concepts, Garg said.

Even the way science has evolved in terms of accessibility has changed, thanks to technology, Garg said, adding that decades ago, researchers spent years during their Ph.Ds learning what can now be grasped in less than two months with the vast amount of information available online.

While science was, and still is, seen as a career-oriented subject, there were never cases of students being taught why something is happening or why they are studying it.

Garg said that over the past decade, students' interest in sci-

ence has shifted — not just as a subject, but as a field rooted in real-world principles and discoveries. This growing fascination is largely driven by advancements in space science, satellite technology, and other scientific breakthroughs. "Children are naturally curious about the world around them. When they see, read and hear about these developments, it leaves an impression on their minds and sparks a desire to explore and contribute,"

JAMMU, Mar 3: As the festival of Holi approaches, the period of Holashtak holds special significance in certain regions of India.

This year, Holashtak begins on March 7 (Friday) and ends on March 14 (Friday). According to Mahant Rohit Shastri, Jyotishacharya, and President of Shri Kailakh Jyotish Avim Vedic Sansthan Trust, these eight days leading up to Holi are considered inauspicious for important ceremonies such as weddings, housewarming rituals (Griha Pravesh), fire rituals (Yajna-Havan), engagements, and tonsure ceremonies (Mundan Sanskar). It is believed that starting any auspicious activity during this period may not yield favorable results.

Holashtak is not observed across all of India but is particularly followed in regions near the Vipasha (Beas), Iravati (Ravi), and Shutudri (Sutlei) rivers, as well as in the Pushkar

region. This means that the tradition is prevalent in Punjab, parts of Himachal Pradesh, and Ajmer-Pushkar in Rajasthan. In contrast, South India, West Bengal, and Maharashtra do not observe Holashtak, and people in these regions continue to hold auspicious ceremonies as usual.

The origins of Holashtak can be traced back to the story of Bhakt Prahlad and King Hiranyakashipu. According to mythology, Prahlad, a devout follower of Lord Vishnu, faced immense suffering at the hands of his father, Hiranyakashipu, for eight days leading up to Holi. Despite multiple attempts to harm him, Prahlad remained unharmed due to divine protection. Finally,

Hiranyakashipu ordered his sister, Holika, who was immune to fire, to sit in flames with Prahlad on her lap. However, in a divine turn of events, Prahlad survived, and Holika was burned to ashes. This mythological tale is believed to be the reason why Holashtak is considered an unfavorable time for new beginnings.

While Holashtak is seen as inauspicious for starting new ventures, it is considered a spiritually significant period. People are encouraged to engage in fasting, prayers, and acts of charity. Donating essentials such as food, clothes, and money is believed to bring good fortune and help in overcoming obstacles. Many also spend this time in devotion and meditation, seeking divine blessings for a prosperous future.

As Holi nears, Holashtak serves as a reminder of faith, perseverance, and the triumph of good over evil. It is a time to reflect, perform charitable acts, and prepare for the iovous celebrations of Holi that follow.

appeal to the authorities, the Kashmiri Displaced People (KDP) Wing of the Democratic Progressive Azad Party (DPAP) has called for reserved budgetary support and seat reservations in the upcoming Urban Local Bodies (ULB), Panchayat, and Municipal elections.

In a joint statement issued by President Sanjay Dhar, Chairman Piaray Lal Pandita, General Secretary Raj Kumar Ticku, Youth President Naveen Gosien, Publicity Secretary Charanjeet Singh, and other leaders, they emphasized that the Legislative Assembly's upcoming budget session is a historic event, being the first of its kind in over eleven years.

Given this, the KDP leaders have urged the government to allocate a reasonable share

of budgetary funds from the state exchequer for the developmental rights of displaced Kashmiri Hindus in exile as well as for those still residing in the Valley.

The leaders highlighted that since their forced exodus in 1990, not a single penny has been allocated from the State/ UT Budget for the welfare of displaced Kashmiri people. Instead, their survival has solely depended on Central Government funds under security and relief measures.

They strongly criticized this step-motherly treatment and demanded that Kashmiri Displaced People, who have always been an integral part of the Valley's population, be granted constitutional and financial rights as equal citizens of Jammu & Kashmir.

The KDP leaders have urged that a special budgetary allocation be announced and passed during the ongoing budget session to support the developmental needs of Kashmiri Displaced People.

Additionally, they demanded two reserved seats per district in the Valley for displaced Kashmiri Hindus in the upcoming Panchayat, Municipal, Local Bodies, and District Development Council (DDC) elections. They further proposed that the displaced Kashmiri Hindu camps in Jammu be granted the status of Town Areas or Panchayats and receive full budgetary support based on the registered population of these camps. This, they believe, would improve living standards and end the hazardous conditions faced by displaced communities.

A key demand put forth by the leaders is that the already announced three Assembly seats for the displaced community should be filled through

elections rather than nominations. They argued that in the past, nominated MLCs failed to represent the community effectively, leading to further marginalization.

Lastly, the leaders called for the formation of district committees consisting of displaced Kashmiri Hindus from each respective district to act as caretakers of temples and shrines in the Valley. They demanded that trusts formed by individuals from other districts or outside J&K be abolished to prevent the misuse of financial resources belonging to temples and shrines.

With these demands, the KDP Wing of DPAP hopes to bring justice, financial security, and political representation to the displaced Kashmiri Hindu community, ensuring that their rights are safeguarded and their voices heard.

# How stage was set for designers

As India's first fashion week marks its silver jubilee, a look at how the event kickstarted the growth of a billion-dollar industry

WHEN the Lakme Fashion Week starts in Mumbai on March 26, it will mark the silver jubilee of India's first marquee fashion event, a trendsetter.

In these 25 years, the fashion industry has stitched a mega success story. According to an industry report by Statista, the revenue in the apparel market in India is projected to reach \$109.45 billion (over Rs 10 trillion) in 2025. Women's apparel holds the largest share, with a market volume of \$53.13 billion (over Rs 5 trillion).

However, in the early 1990s, the established names today were just starting out. "JJ Valaya, Ashish Soni, Rajesh Pratap Singh, Ritu Beri, Rina Dhaka, Rohit Bal, Rohit Khosla, Tarun Tahiliani and many others were just about beginning their careers. There was a great momentum and more designers were coming out of the National Institute of Fashion Technology (NIFT). But there was no one platform for designers to showcase their vision," recalls designer Narendra Ahmed, who graduated from NIFT in 1990 and was ELLE India's first fashion editor.

The Apparel Export Promotion Council (APEC) had facilitated some designers to present their work at fashion shows in New York, London and Paris. With that in mind, most designers were feeling the need for a fashion week in India, says Rajesh Pratap Singh, who was one of the designers to showcase his collection in the first fashion

The Fashion Design Council of India (FDCI) had been set up in 1998, in response to an urgent requirement to organise the Indian fashion industry under a formal structure. Sumeet Nair was appointed the executive director of the FDCI.

"Most designers felt that an Indian fashion week will provide the right platform to bring all designers together. Most of them were already holding individual shows but such an event could provide a collective platform for both the designers and the buyers," says Ahmed.

While most industry stakeholders felt the need for such an event, two persons came together to conceptualise and create India's firstever Fashion Week in 2000 - FDCI's Nair and Zubin Sarkari, fashion director at IMG (International Management Group), India, a global sports and culture company (now known as RISE Worldwide Limited, a subsidiary of Reliance Industries Limited).

"It was all very exciting. Some of the nitty-gritty of the first fashion week was thrashed out in our office where Nair and Sarkari would hold meetings with us, my partner Asha Koch-

har and I, seeking inputs on various logistics — from the size of the ramp to the number of green rooms for models to the music to be played, and much more," remembers Vidyun Singh, co-founder, Media Makers. Vidyun, part of the journey of Indian fashion since its first hesitant steps in the 1980, and Asha had already been working with designers in

The FDCI and IMG then approached Lakme for the title sponsorship, convincing its then CEO Anil Chopra to steer the fashion week.

"The initial years were really wonderful. We were doing everything ourselves, whether it was designing the sets or sourcing the music. I used to create music sequences while editing on spool tapes. I remember a crazy incident from one of the early fashion weeks. It was a Rohit Bal finale, and set designer Sumanth Jayakrishnan had crushed mica and mixed it with sand to create a sparkly set. We felt proud at our innovation but when the models walked on the ramp, the hems of their long lehengas blew the micasand mix right into the eyes of people sitting in the first row! Those were challenging but fun times. The best part was that the event literally

put India on the global fashion map. Though it is still not as big as other international weeks in Paris or London, designers got access to both international and Indian buyers," says Vidyun.

The week became the catalyst that not only sparked the fashion boom in India, but created a large number of new jobs. "Apart from models and modelling agencies, many ancillary professions evolved and grew exponentially over the years because of the fashion week, including stylists, makeup artists, scenographers or scenic designers, production and set designers, show directors, music

creators and many more backstage jobs. Sound and light vendors invested in special equipment because they realised that this is a recurring business. Everything grew organically from there,' adds Vidyun.

In the earlier seasons, most designers did ethnic wear. This brought back the focus on traditional weavers and artisans. Hand embroideries like zardozi, chikankari, kantha and phulkari came back in vogue through elaborate wedding wear, emphasises designer Sonam Dubal, the first designer from the Northeast to create a stir in mainstream Indian fashion. His first fashion week collection was a blend of cultures weaving Pali calligraphy onto eri silk and using Banarasi silk and Chanderi to contemporise the Sikkimese honju and bakhu dress

"India has a vast heritage of traditional techniques, be it in weaving or block printing. As the industry grew, it provided support to a lot of craftspeople around the country," says designer Rakesh Thakore of Abraham & Thakore.

As the market grew, so did the awareness and understanding about fashion. "People realised fashion could be a full-fledged career," says Ritu Kochhar, founder director, Inter National Institute of Fashion Designing.

"This led to the expansion of fashion education institutes. NIFT opened more centres all across India," adds Dubal.

As more and more young designers emerge out of these institutes, the fashion week, too, has expanded its scope to provide a platform to these emerging voices in its GenNext show. "It has given us talented designers like Rahul Mishra, Nachiket Barve and many more," says Ahmed, one of the brains behind the show.

While social media and fashion influencers may have taken some sheen away from these fashion weeks, most stakeholders across the industry agree that that one event 25 years ago changed the landscape of Indian fashion forever.

# **PM Modi chairs National Wildlife Board meet in Gujarat, announces lion census**



# Disability no bar to become a judge: Supreme Court

The top court strikes down Rule 6A of Madhya Pradesh Judicial Services Rules which didn't allow visually-impaired candidates and those with low visibility to join the judiciary

NEW DELHI, Mar 3 (Agencies): Holding that disabled candidates were eligible for appointment to judicial services, the Supreme Court on Monday ruled that no person can be denied consideration solely on account of their physical disabilities.

"Any indirect discrimination that results in the exclusion of Person with Disabilities, whether through cut-offs or procedural barriers must be interfered with in order

to uphold substantive equality...No candidate can be denied such opportunity (appointment to judicial service) solely on account of disability," a Bench of Justice JB Pardiwala and Justice R Mahadevan

The top court struck down Rule 6A of Madhya Pradesh Judicial Services Rules which didn't allow visually-impaired candidates and those with low visibility to join the judiciary. It also

quashed the rule which required three-year law practice for visually impaired candidates to become a judge.

The judgment came on petitions highlighting the denial of reservations to such candidates in judicial services of certain states, including Madhya Pradesh from where the mother of a visually-impaired candidate wrote to the top court last year against a rule in the MP Judicial Services (Recruitment

and Service Conditions) Rules that prevented visually impaired candidates from seeking appointment in the state judicial services.

The letter was converted into a PIL by the top court.

Pronouncing the verdict, Justice Mahadevan said, "We have treated it as the most important case...We have touched upon constitutional framework also and institutional disability jurisprudence...

Persons with disabilities must not face any discrimination in judicial services and the state must take affirmative action to provide an inclusive framework. It gave similar relief to candidates from Rajasthan.

"A right-based approach necessitated that persons with disabilities must not face any discrimination in the pursuit of judicial service opportunities," Justice Mahadevan said.

## Jharkhand government tables Rs 1.45 lakh crore budget for FY 2025-26 in assembly

RANCHI, Mar 3 (Agencies): Jharkhand government on Monday tabled a Rs 1.45 lakh crore budget for the financial year 2025-26 in the state assembly.

Presenting the first budget of the Hemant Soren-led government after it retained power in Jharkhand following the assembly elections last year, Finance Minister Radhakrishna Kishore said the state's economy is expected to grow at a rate of 7.5 per cent in the financial year

2025-26. "I lay on the table of the House a budget of Rs 1.45 lakh crore for



year," the finance minister said in the assembly. He said that the fiscal deficit in the budget for the upcoming fiscal is estimated to be at Rs 11,253 crore.

He stated that the budget provides for an outlay of Rs 62,844 crore for the social sector and Rs 13,363 crore for Maiyan to women.

"The budget will meet the aspirations of every section of the society, including the poor, farmers, tribals and women," he said.

#### Infant branded with hot iron 40 times to cure disease in Odisha

BHUBANESWAR, Mar 3 (Agencies): A one-month-old baby boy was branded with a hot iron rod about 40 times to cure a disease in Odisha's Nabarangpur district following which he was admitted to a government hospital, officials said on Monday.

The child is a resident of Phundelpada village under Gambhariguda panchayat in the Chandahandi block of the district.

He was admitted to the Umerkote Sub-Divisional Hospital for treatment.

Nabarangpur Chief District Medical Officer (CDMO) Dr Santosh Kumar Panda visited the hospital and said the infant's health condition is now stable.

"There are about 30 to 40 branding spots on the belly and head of the child. There is a superstition that if a child is branded with hot metal, then the child would be cured of diseases." he said.

The doctor said that the child was down with a fever, running a high temperature ten days ago and was crying a lot.

The family members believed that the child was under the influence of some evil spirit. Instead of seeking medical help, the family

branded him 30-40 times with hot metal, in the belief that it would cure him, the CDMO said.

When the child fell seriously ill after the branding, he was admitted to the Umerkote Hospital. Such practices have been going on in remote areas for a long time, the CDMO said.

He also said that the health department has decided to focus on Chandahandi block and create awareness among the people to bring children to hospitals for treatment instead of branding them with hot metal.

# Meghwal calls for safer digital space for women, urges vigilance against cyber crimes

ment's efforts to address emerging challenges in the digital space, including artificial intelligence (AI)-driven misinformation campaigns, cyberbullying, fake profiling and video manipulation. "The new laws we have enacted address these ward," he said. issues comprehensively. We have incorporated provisions to deal with Al-based misinformation, digital arrests and other cyber-related offenses," he said.

The minister stressed the need to create a safer digital environment for women, ensuring

their dignity and participation in nation-building. "Cyber security is a critical issue and it is essential to understand its relationship with women. Women must continue to contribute to the country's progress without fear. Cyber crimes should not deter them from moving for-

Meghwal also unveiled a book titled 'Cyber Saheli', aimed at educating families about cyber safety.

# Renowned Kerala doctor found dead in farmhouse

KOCHI, Mar 3 (Agencies): Prominent nephrologist and senior surgeon Dr George P Abraham was found dead at his farmhouse near the Cochin International Airport.

The 77-year-old, one of the leading kidney transplant surgeons in the country, was found hanging in his farmhouse, and a suicide note was recovered.

In the note, he mentions that due to his failing health, he is not able to carry out his duties.

Abraham, in his nearly five-decade career, has done more than 2,500 kidney transplants, a record in Kerala.

On Saturday, he was active at the private hospital here, where he met patients.

Abraham had recently undergone a spine surgery. A resident near his farmhouse said that every Sunday, he made it a point to visit his farmhouse and spend time there.

"He was here on Sunday (March 2). His

brother was also there," said the local, who on Monday morning was startled to hear the news that the doctor had committed suicide.

Dr Abraham had arrived at the farmhouse with his younger brother on Sunday evening and later sent him away. He was later found hanging in the farmhouse.

In his long career as a renal transplant specialist, Abraham wrote himself into medical history when he became just the third surgeon to harvest a kidney from a

donor using the laparoscopic method. Among the other path-

"I am grateful to all our friends and partners for their efforts in bringing about a stable and guaranteed peace in Ukraine. Joint strength can protect our future," he said.

# Zelensky's "gratitude" video message after Trump's "not thankful" charge



KYIV, Mar 3 (Agencies): Days after a row with President Donald Trump over not being "thankful" for the United States' support in the war against Russia, Ukraine's Volodymyr Zelensky on Monday said he "understands the importance of America" and is "grateful" for all the assistance.

His video message on X came two days after he was shouted down at the White House by Trump and Vice President JD Vance for not being "thankful" and refusing to accept their proposed truce terms.

"Of course, we understand the importance of America, and we are grateful for all the support we've received from the United States. There has not been a day when we haven't felt gratitude. It's gratitude for the preservation of our independence - our resilience in Ukraine is based on what our partners are doing for us - and for

their own security," he said after attending a key summit on the Russia-Ukraine war in London.

"Everyone is united on the main issue - for peace to be real, we need real security guarantees. And this is the position of all of Europe - the entire continent, the United Kingdom, the European Union, and Turkey," he added.

The security summit was hosted by UK Prime Minister Keir Starmer. France's Emmanuel Macron, Canada's Justin Trudeau, and Italy's Prime Minister Giorgia Meloni were among the 18 leaders who attended the meeting on the war, which broke out when Russian President Vladimir Putin ordered the invasion of Ukraine in 2022.

"What we need is peace, not endless war. And that's why we say security guarantees are the key to this," Zelensky said.

#### Former Pak Interior Minister Rana Sanaullah alarms, 'armed groups could seize control of Balochistan'

BALOCHISTAN, Mar 3 (Agencies): Pakistan Muslim League-N (PML-N) leader and former Federal Interior Minister Rana Sanaullah has sounded the alarm on the deteriorating security situation in Balochistan, warning that armed groups could seize control of the region if security measures aren't strengthened, according to The Balochistan Post.

Sanaullah described the situation as "alarming" and emphasized the need for strict action against militants. He also stressed the importance of bolstering the military presence to preserve national security and counter potential threats.

However, his remarks have drawn mixed reactions from political figures and the public,



with some analysts suggesting they reflect broader political and law-and-order issues in Balochistan. There was no immediate response from other Pakistani officials, reported The Balo-

The warning comes amid a surge in armed attacks in Balochistan, with Baloch "pro-independence" groups

intensifying operations against Pakistani security forces, government installations, and Chinese-backed projects.

In a significant development, the Baloch Raji Aajoi Sangar (BRAS) a major restructuring of its military and diplomatic strategy, reported The Balochistan Post.

The alliance, which

comprises groups like the Baloch Liberation Army (BLA), Balochistan Liberation Front (BLF), Baloch Republican Guards (BRG), and the Sindhu Desh Revolutionary Army (SRA), plans to merge into a single military entity called the Baloch National Army.

This new force aims to escalate attacks against Pakistani and Chinese targets, seeking to form a more "organized, coordinated, and decisive force" against Pakistan, reported The Balochistan Post.

BRAS believes this strategic shift will make Baloch national liberation an "inevitable reality," marking a "decisive phase" of increased intensity and innovation in their movement. The situation in Balochistan

remains volatile, with far-reaching implications for regional stability and security.

Balochistan - Pakistan's largest but least populous province - has a long history of marginalisation. The province was annexed by Pakistan in 1948, soon after its partition from India, and there has been a separatist movement since, as per Al Jazeera.

Balochistan faces numerous challenges, including state oppression, enforced disappearances, and the extrajudicial killings of activists, scholars, and ordinary citizens. The region is characterized by economic neglect, lack of development, poor infrastructure, and limited political autono-

# Taiwan considering immigration law changes to curb China's influence from Hong Kong, Macau

TAIPEI, Mar 3 (Agencies): The government is considering changes to immigration laws for residents of Hong Kong and Macau to prevent influence from China, Taipei Times reported.

According to a source, the government may remove an optional path to citizenship for these residents and extend the time required for them to qualify for permanent residency.

The proposed changes aim to prevent the Chinese Communist Party (CCP) from influencing Taiwan through immigration from Hong Kong and Macau, as per Taipei Times.

An official familiar with the matter speaking on condition of anonymity said the government could amend immigration laws for residents of the territories who currently receive preferential treatment.

The move was part of "national security-related legislative reform," they added.

Under the proposed amendments, individu-

als from Hong Kong and Macau would need to live in Taiwan for four years before being eligible for permanent residency, up from the current one-year requirement. Additionally, they would no longer be able to apply for citizenship after gaining permanent residency, the official said.

According to the source, the proposal was being considered in response to the changing situation in Hong Kong, to which more than two million mainland Chinese have migrated since the 1997 handover of the territory, the source said.

According to Taipei Times, Taiwan's relaxed immigration policies for Hong Kongers have become a major national security loophole, especially after Beijing imposed the territory's National Security Law in 2020, which significantly altered Hong Kong's landscape and enhanced the authori-

ties' power, they said. "Whether they arrived



through marriage with a Taiwanese, investment immigration or obtained residency through a professional skill, Hong Kong migrants almost always apply for permanent residence in the

second year," they said. "No country in the world has an immigration policy like Taiwan, with such relaxed terms," they added.

Higlighting the strict rules, the official stated, under the proposed amendments, residency applicants from Hong Kong or Macau who have worked for the

CCP, the Chinese military or Chinese public institutions would be strictly scrutinised and potentially have their applications denied.

"The original purpose behind allowing Hong Kong and Macau residents to easily apply for permanent residency in Taiwan is no longer applicable given the changes to those territories caused by CCP policies," they said.

The government's proposed changes to immigration laws would align the rules for Hong Kong and Macau residents

with those for immigrants from other countries. However, the new rules would still be more lenient than those for applicants from mainland China, who must stay in Taiwan for six years before applying for a national ID card.

The option of "longterm residence" for applicants from the two territories is similar to the permanent residency option available to other foreigners, with the key exception being that the "long-term residence" option does not allow a path to citizenship, the source said.

"We have found that some migrants from Hong Kong and Macau are not interested in Republic of China citizenship anyway, and only want some form of permanent residence. So, we do not anticipate the change being a problem," they said.

Authorities would review the proposal, and would communicate with Hong Konger groups in Taiwan before amending the laws, they said.

Despite numerous court orders, implementation has been sluggish, often hindered by a lack of commitment from concerned officials. However, the proactive stance taken by the NGT, including imposing significant fines, has begun to foster some hope for enforcement."

VC IUST Prof. Romshoo highlighted the paradox of climate change as a global phenomenon disproportionately affecting regions like Jammu and Kashmir, which contribute minimally to global greenhouse gas emissions. He expressed concern over how major industrial powers and nations, responsible for significant emissions, have left vulnerable communities in the Himalayas to confront severe climatic consequences. Prof. Romshoo pointed out worrying trends, including altered autumn seasons that are critical for agriculture, exemplified by unprecedented dry spells such as the seven-month drought that disrupted local water resources and agriculture. The pointed out that the decline in saffron productivity, a cornerstone of Kashmir's culture and economy, reflects the tangible impacts of these shifting climatic patterns. He also noted alarming weather extremes, including the heavy snowfall of 2019 and recordbreaking cold temperatures during the harsh Chilai Kalan winter period. He said that with global temperatures rising by 0.8°C in the past century, the Kashmir region is experiencing an even sharper increase of 1.3°C, underscoring the urgent need for global awareness and action to address these local challenges.

Arjumund Hussain Talib, an International Development Specialist and Founder of Ziraat Times, presented on virtual mode and revealed that Jammu & Kashmir is projected to be 60% food-deficient due to changing climatic conditions. He added that this stark projection underscores the immediate need for comprehensive funding and resources dedicated to environmental conservation. He further said that the time has come to consider an Environmental Cess in J&K. He pointed out that J&K must strengthen its Social Environmental Impact Assessment regime. He said that lately, we all know that this Regime has become lax, and

diate action to regulate these activities and restore our natural water sources, or we risk forcing entire communities to migrate due to uninhabitable conditions," he warned.

Maajid Farooq, a scientist from the Department of Environment, Ecology & Remote Sensing, delivered a power point presentation on regional climate trends supported by data analysis. He stated, "Our research indicates not just shifts in temperature but also significant changes in precipitation patterns that threaten our traditional farming calendars. It is crucial that we use this data to inform our adaptive strategies, ensuring that farmers are equipped with the knowledge and tools needed to sustain their livelihoods amidst changing climates."

Dr. GN Qasba, Former Commissioner of Srinagar Municipal Corporation, emphasized the urgent need for urban planning that considers climate resilience.

ience. Altaf Ahmad Andrabi, Former Director, concluded the event with insightful recommendations focusing on grassrootslevel actions. He remarked, "To mitigate the impacts of climate change, we must engage with communities directly, promoting the cultivation of alternate crops that are better suited for a changing climate. The knowledge and resources must be shared with farmers so they can adapt and remain productive in their fields, ultimately contributing to sustainable development

in the region."

and the abrogation of Article 370.

Dimple criticized Lieutenant Governor Manoj Sinha for once again failing to provide a timeline for the restoration of statehood in his address during the budget session.

He accused the LG of avoiding the issue, which remains a major concern for the region.

In addition to his demands on statehood, Dimple also called for the Darbar move to be reinstated starting in April 2025.

He further demanded a CBI inquiry into the

liquor mafia, alleging that certain businessmen in Jammu, along with an external liquor mafia, have gained control over the liquor industry in Jammu and Kashmir with the help of BJP leaders, corporators, and mayors.

Dimple also urged the Chief Minister to direct the Excise Department not to issue tenders for wine shops in March 2025, and to immediately halt the sale of liquor across Jammu and Kashmir.

Among his other demands, Dimple called for the Jammu and Kashmir government to pass a bill in the Assembly to provide free 200 units of electricity, twelve free LPG cylinders, and double ration to the people of the region starting this March. Additionally, he sought the nomination of four Rajya Sabha members, including one from Jammu's Dogra community.

The protest highlighted significant public concerns, with Dimple emphasizing the need for accountability and change in policies that impact the welfare of the people.

# **CT semifinal: India look to spin a new tale against Australia in ICC knockouts**

Last time India triumphed against Australia in knockout stage of any ICC event was way back in 2011 World Cup quarterfinal

DUBAI, Mar 3 (Agencies): History weighs heavily against them but India would rely on a potent spin battery and familiarity with the conditions to break the knockout iinx against an undermanned Australia when the two formidable cricket forces clash in the Champions Trophy semifinal here on Tuesday.

It will not be a straightforward task, though, as the Aussies are a resilient beast in global tournaments even without their lead cast of Pat Cummins, Josh Hazlewood and Mitchell Starc.

Their stunning chase of 352 against England at Lahore a few days back validates the thought.

The last time India triumphed against Australia in the knockout stage of an ICC event was way back in the 2011 World Cup

India lost to Australia in the semifinals of the 2015 ODI World Cup and in the title clash of the 2023 ODI World Cup before succumbing to them in the World Test Championship final in 2023.

This Indian side will realistically hope to rewrite that largely melancholic script over the last 14 years and the primary reason for that optimism is the presence of some top of the line spinners in their ranks.

Their pre-tournament decision to fill the squad with five spinners drew a lot of flak from all corners, but it is now proving to be a masterstroke on the slow pitches in Dubai.

The easiest explanation of their dominance is the knowledge of the conditions having had the luxury of playing all



their matches in Dubai. But that is only partially true. They have made an effort to tweak their craft as per the needs of the surfaces here.

Since there was no fast or spitting turn on offer here like in a dustbowl, the Indian spinners were made to play the waiting game.

Patience, rather than magic is the key in bowling on these decks, as revealed by Varun Chakravarthy.

"The pitch here is not a rank turner as such, which people were projecting it to be, but definitely it was holding on a bit, and it was deviating a little bit to create the doubt. So basically, you had to play around it," said Chakravarthy.

The Indian spin quartet of Chakravarthy, Kuldeep Yadav, Ravindra Jadeja and Axar Patel walked away with nine New Zealand wickets, but they applied the pressure consistently to earn their rewards.

They delivered 128 dot balls in the 39 overs bowled between them as the Kiwis struggled to break free, a sequence eventu-



ating in a flurry of wickets.

Even the dismissal of an otherwise stoic Kane Williamson had a touch of desperation as his shimmy against Axar ended in a stumping by KL Rahul.

On the other hand, Australia have only one genuine spinner in Adam Zampa, while hoping for part-timers Glenn Maxwell and Travis Head to deliver the

Matthew Short has been ruled out of the tournament with a calf injury and it has also robbed the already creaking Australian bowling unit of a handy spin option.

The absence of premier names was felt in the previous matches as the Aussie bowlers conceded 352 and 273 against England and Afghanistan respectively, albeit in better batting condi-

Hence, the likes of Virat Kohli, Rohit Sharma, Shreyas Iyer and Shubman Gill will be eager to go full throttle at them here.

They have found the perfect rhythm of batting on these sluggish tracks here.

Skipper Rohit hoped as much.

"It is going to be a good game. Australia has a rich history of playing well in ICC tournaments. Now, it's about us to do things right. We have to be focussed on what we need to do on that day. Looking forward to that. hopefully we can stitch one towards us," he said after the match against New Zealand.

But he will not be unaware of the batting might the Aussies possess as the latter hunted down a 350-plus target without any meaningful contribution from Head and captain Steve

India will certainly want to evict them at the earliest, particularly Head as he has been the team's nemesis in recent years.

It is also a chance for Rohit and his company to mitigate the still lingering pain of losing to Australia in the 2023 World Cup final in Ahmedabad.

This match could be slowburner but brace for a cracker nonetheless.

## **Shastri backs Chakravarthy** for semi-final, calls it "Right time to unleash him"



DUBAI, Mar 3 (Agencies): Former India head coach Ravi Shastri has strongly backed Varun Chakravarthy's inclusion in the semifinal of the Champions Trophy against Australia, stating that it is the perfect time to unleash the mystery spinner

Chakravarthy produced a sensational five-wicket haul (5/42) to power India to a 44-run victory over New Zealand in their final Group A match at the Dubai International Stadium on Sunday.

"Very impressed with him (Chakravarthy), and full marks to the think tank and the team management for making the right choice because he's someone who will get you wickets in the middle overs," Shastri said in an ICC video posted on Instagram.

"It's the right time to unleash him. They brought him into the side; he's got a fivewicket haul, and I think he's there to stay. His current form, body language, and confidence make him a key asset, especially against teams like New Zealand, Australia, and South Africa. who haven't faced him much," Shastri added.

India fielded a fourpronged spin attack against New Zealand, with Chakravarthy, Ravindra Jadeja, Axar Patel, and Kuldeep Yadav exploiting the sluggish Dubai pitch. Shastri believes India should continue with the same XI against Australia.

"I think I would go with the same eleven now because the turnaround time is less than 48 hours. The pitch is worn out, and spinners will play a crucial role again," he said.

Former India captain and legendary leg-spinner Anil Kumble also lauded Chakravarthy's performance and supported the idea of retaining the same combination for the semi-final.

"Varun has been exceptional over the last 1-1.5 years, whether for Tamil Nadu, KKR, or

India. His performance today proves that this four-pronged spin attack will be a huge challenge for Australia on this pitch," Kumble told ESPNcricinfo Match Day.

Former India batter Ambati Rayudu also praised Chakravarthy's evolution as a bowler, highlighting how his deceptive variations trouble batters.

"Varun was great today. Earlier in his career, he struggled with consistency, but now he is very difficult to face. His action makes it seem like he's bowling left-arm spin, but most of his deliveries are googlies, making it tricky for batters unfamiliar with him," Rayudu said on JioHotstar.

Rayudu added that Chakravarthy's performance has created a selection dilemma for India ahead of the semifinal.

"India will have a tough time deciding, with so many quality players to choose from, but Varun has been brilliant. Jadeja was amazing, and all four spinners bowled exceptionally well," he said.

With Chakravarthy's match-winning performance and the pitch conditions favoring spinners. India may stick to the same XI as they take on Australia in the high-stakes semi-final on Tuesday.

#### I was nervous ahead of first spell: Varun Chakravarthy

DUBAI, Mar 3 (Agencies): Varun Chakravarthy erased his painful Dubai memories with a match-winning five-wicket haul against New Zealand but the India spinner admitted feeling "nervous" ahead of his opening spell due to the "emotions" running through his mind.

The 33-year-old had given 33 runs in his four overs in a 10-wicket drubbing by Pakistan during the 2021 T20 world Cup here, but four years later he registered 5 for 42 as India defeated New Zealand by 44 runs in the Champions Trophy to top group A here on Sunday.

"In 2021, I didn't have a great tournament here. But it looks good right now. I was a little nervous ahead of my first spell (vs NZ). The emotions were playing (in mind) because of whatever happened three years before at this ground," said Chakravarthy in the postmatch press conference.

Chakravarthy, who replaced rested Harshit Rana in the playing eleven, said a chat by the senior pros helped him to "calm down". "They (emotions) were playing with me and I was trying to keep it down, control it. But



Virat bhai, Rohit and Hardik were telling me to calm down. They were coming and talking to me. That really helped," he added.

Once settled down, Chakravarthy, who made his ODI debut against England last month, had to find a way to shift through the spells unlike in T20Is where he largely bowls four overs on the trot.

"In T20s, my sequencing of balls as in how I construct an over is totally different compared to the 50-over format. I was able to figure it out when I played the last two years in the Vijay Hazare Trophy.

"It really helped me to understand when I can bowl my incoming delivery or outgoing delivery or the straighter one or the top spin. It is completely different from what I do in the T20s," he said.

The DICS pitch had considerable assistance for spinners, and Chakravarthy said he was judicious in using his bottomless bag

"It was not a rank turner which people were projecting it to be. But definitely it was holding on a bit, and it was deviating a little bit just to create the doubt.

"So, basically, you had to play around it. I would also dedicate my five wickets to the other bowlers as the way they bowled helped me pick wickets," he noted.

Patience was another key component for Chakravarthy while bowling on such pitches. "It is a patience game. You just need to wait on such slow wickets as the ball doesn't turn fast. So, you need to wait," he said.
