MLAs express concern over rising drug addiction in J&K, Speaker Rather orders discussion

JAMMU, Mar 5 (Agencies): Cutting across party lines, the Jammu and Kashmir Assembly members on Wednesday expressed grave concern over the rising drug addiction in the region, prompting Speaker Abdul Rahim Rather to order a discussion to seek suggestions from the House on anti-drug measures.

Several MLAs questioned the effectiveness of existing mechanisms to combat the drug menace. They called for the establishment of an expert panel and a House committee to examine the issue in depth.

Minister for Health Sakina Itoo acknowledged the severity of the problem but highlighted the impact of the 'Nasha Mukt Abhiyan' launched in September 2022.

"There has been an alarming increase in drug addiction among the youth of J&K. However, after the launch of 'Nasha Mukt Abhiyan', records indicate a slight decline in new registrations," Itoo said in the House while responding to a question by National Conference (NC) MLA Mubarak Gul during the Question Hour.

She informed the House

that 25,402 drug addicts have been receiving treatment at various centers in Jammu and Kashmir over the past

9,775 in 2022, 8,702 in 2023 and 6,925 in 2024. The minister said while outpatient (OPD) drug addiction cases have shown a declining trend over the past three years, inpatient (IPD) cases have significantly increased. She attributed this rise to the expansion of inpatient

services in de-addiction cen-

ters, leading to better access

three years. This includes

CPI (M) MLA M Y Tarigami, Congress MLA Nizamuddin Bhat, AAP MLA Mehraj Malik, BJP MLAs Arvind Gupta and Yudhvir Sethi, and NC MLA Justice Hasnain Masoodi raised supplementary questions, demanding answers on the alleged failure of agencies tackling the crisis.

"It is a very important issue. Over the last several years, drug addiction has drastically increased. Who ruled this region for the past ten years? They must answer for this rise. What measures have they taken to address

it?" asked Tarigami. Calling for a review of the current mechanisms, he

urged the formation of an expert team and a House committee to assess and respond to the crisis effectively.

BJP MLAs Yudhvir Sethi and Arvind Gupta also sought details from the government on its efforts to combat drug addiction and called for a full discussion on the matter.

AAP MLA Mehraj Malik criticized the administration for its "utter failure" in handling the menace and said "there has

been a large-scale increase in drug addiction in the region and the government has completely failed to address it".

Congress MLA Nizamuddin Bhat supported the demand for a House committee, while NC's Justice Hasnain Masoodi called for enhanced infrastructure to strengthen the de-addiction framework.

Despite the minister's initial opposition to further discussion citing her detailed response, Speaker Rather insisted on a half-hour debate to allow members to present their suggestions.

The minister outlined various initiatives taken to curb drug addiction, including adoption of a drug de-addiction policy, formation of a state-level policy, Implementation Committee and massive awareness campaign — Nasha Mukt J&K Abhiyan.

She informed the House that 11 Addiction Treatment Facilities (ATFs) are functional in Kashmir and 9 in Jammu.

"OPD services are operational in all 20 districts, while inpatient services are available in all nine Government Medical Colleges (GMCs), catering to both male and female patients. Psychiatrists are available in all GMCs in J&K," she said.

She said that 25 medical officers (12 from Jammu and 13 from Kashmir) have been trained at NIMHANS, Bengaluru, and deployed to de-addiction centers across the UT.

To enhance monitoring and intervention, real-time surveillance using Google Sheets has been introduced to track trends and measure the effectiveness of interventions, she added.

The minister highlighted the ongoing awareness efforts, including seminars, workshops and programs in schools, colleges and universities, in collaboration with district administrations, NGOs and volunteers.

She also emphasized the TeleMANAS initiative, a helpline set up across all 20 districts to provide mental health support and addiction counseling.

Under 'Project Najaath', launched in November 2023 in Jammu and Pulwama, the government has partnered with J&K Bank to combat drug abuse. The initiative aims to educate communities ■Turn to page 9





BJP members walkout of J&K Assembly after speaker expunges remarks of Opposition Leader



JAMMU, Mar 5 (Agencies): All 28 BJP members on Wednesday walked out from the Jammu and Kashmir Assembly after Speaker Abdul Rahim Rather announced expunging of "derogatory remarks" of the Leader of Opposition on the July 13, 1931 "martyrs".

Leader of the Opposition Sunil Sharma made the remarks against the "martyrs" in response

to the speech of PDP legislator Waheed-ur-Rehman Para, who demanded restoration of the public holidays on July 13 and the December 5 in honour of National Conference founder Sheikh Mohammad Abdullah. CPI(M) member M Y Tarigami and Congress leader Nizamuddin Bhat also joined the chorus and demanded expunging of

the remarks against the

1931 "martyrs" and an apology from the Leader of the Opposition. Later, the Speaker announced expunging of the "derogatory remarks" following which the entire 28 members of the BJP staged a walkout.

July 13 was observed as a public holiday in Jammu and Kashmir to commemorate the 22 men who fell to the bullets of Dogra Maharaja's soldiers outside Srinagar central jail in 1931.

The holiday along with the December 5 holiday in connection with birth anniversary of Sheikh Abdullah were, however, scrapped by the Lt Governor Administration post 2019 following abrogation of Article 370 and bifurcation of the erstwhile state into two Union Territories.

July 13 martyrs fought for democracy, constitution: Deputy **CM Surinder Choudhary**



JAMMU, Mar 5 (Agencies): Jammu and Kashmir's Minister for Industries and Commerce, Surinder Kumar Chaudhary on Wednesday criticized the opposition for its remarks on July 13 martyrs, saying the language were inappropriate.

"Martyrs should be respected, no matter from which community they belong. They fought for upholding democracy, safeguarding constitution and the rights of the people,"

Chaudhary said, insisting the need to honor those who made sacrifices for the people of Jammu and Kash-

JAMMU, Mar 5 (Agencies): Bharatiya Janata Party (BJP) leader Sunil Sharma on Wednesday said those who rebelled against Maharaia Hari Singh's rule in J&K were anti-nationals, adding that "traitors cannot be called as martyrs." Speaking to reporters

in Jammu, Sharma, who is the Leader of Opposition in Legislative Assembly, said martyrs day cannot be celebrated in the name of traitors and anti-nationals. He said July 13 should be remembered in the name of Maqbool Sherwani, Major Somnath Sharma, Brigadier Rajinder Singh and others who rendered their services to the nation and protected J&K from the enemy.

"We are saying it in and outside the assem



bly and we will continue it that traitors cannot be accorded with the title of martyr," Sharma said.

He said those killed on July 13, 1931 outside Central Jail Srinagar were arsonists. "I want to tell you today that those killed on July 13 set a Hindu area on fire first, and then started resistance against Maharaja's rule. These people were made martyrs by the Congress party, but under Narendra Modi

rule they cannot be considered as martyrs," Sharma said.

He also accused the Speaker of acting biased and the representative of a particular party.

Earlier, the Legislative Assembly on Wednesday witnessed uproarious scenes over remarks made by BJP leader Sunil Sharma, who called the July 13 martyrs as "traitors".

During the discussion on the Motion of Thanks on the Lieutenant GoverDemocratic Party leader Waheed-ur-Rehman Parra, demanded the restoration of the July 13 Martyrs Day holiday. As Parra concluded his speech, Leader of Opposition Sunil Sharma stood up and objected to his demand.

"They were not martyrs but traitors," Sharma said, evoking widespread protests from the Treasury benches as well as from Kashmir-based opposition parties. The leaders demanded that the remarks should be expunged from the

records of the House. "These remarks are

humiliating and divisive and should be withdrawn or expunged from the records." demanded MLA Bandipora Nizamud-Din Bhat. Amid continuous slogan shouting between the Treasury Benches and BJP, Speaker Abdul Rahim Rather announced that the remarks had been expunged from the records of the House.

Afterwards all the BJP MLAs staged a walkout from the House in protest against the expunging of Sharma's remarks.

NMC urges Govt to hike medical allowance, release pending DA Arrears

JAMMU, Mar 5: The National Mazdoor Conference (NMC), under the leadership of President Subash Shastri, has urged the Jammu and Kashmir Government to increase the medical allowance for employees and pensioners from Rs 300 to Rs 1,000 per month.

The demand aligns with similar provisions in other Union Territories, including Ladakh, which implemented the hike in

April 2020. Speaking at an NMC workers' meeting, Shastri emphasized that the cost of medicines and medical expenses has skyrocketed, making the current Rs 300 medical allowance outdated and inadequate. He urged the JKUT administration to address this issue in the upcoming 2025-26 budget.

Shastri also demanded an increase in the House Rent Allowance (HRA) by 2%, as the Dearness Allowance (DA) has now crossed 50%. He insisted that J&K UT employees should be granted this increase to cope with rising inflation and living costs

Another critical issue raised by Shastri was the release of 18 months' pending DA/

DR arrears from January 2020 to June 2021, which was withheld by the Central Government. He emphasized that the salaried class and pensioners are struggling financially due to rising prices, and releasing these arrears is necessary to provide them with much-needed relief.

Additionally, he called for the immediate release of the 4% DA due from January 1, 2025, and urged the authorities to merge 50% of DA with the basic pay and pension, a step that would significantly improve the financial stability of employees and retirees. Shastri also reiter-

ated the long-pending demand for the regularization of daily wage workers employed under SRO-64, stressing that these workers have been waiting for their rights for years and deserve permanent employment

Today, learning mate-



rials are available in 22 Indian languages," Modi said.

He added that India's education system now meets the requirements of the 21st century.

Since 2014, 30 million youths

have received skill training, the Prime Minister said, adding that 1,000 ITIs will be upgraded and five Centers of Excellence will be established.

"Youth should be trained to meet the requirements of our industries. We are ensuring that our youth compete at a global level. Industries and educational institutions should understand each other's requirements and fulfill them. We have launched the PM Internship Scheme to provide new opportunities to youth," Modi said.

Speaking on the healthcare sector, the Prime Minister said that 75,000 medical seats will be added over the next five years.

"This year's budget announced the addition of 10,000 medical seats with a target of adding 75,000 seats in five years. The telemedicine facility is being expanded. Through day-care cancer centers and digital healthcare infrastructure, we want to bring healthcare to the last mile," he said.

"Will work as per our agenda, not theirs": Delhi CM slams AAP over poll promises

NEW DELHI, Mar 5 (Agencies): Chief Minister Rekha Gupta Wednesday hit out at AAP, asserting the opposition party cannot dictate her government's agenda while reiterating the BJP dispensation's commitment to fulfilling its poll promises.

Row over Abu Azmi's remarks: UP CM Adityanath slams Samajwadi Party for 'idolizing' Aurangzeb



LUCKNOW, Mar 5 (Agencies): Uttar Pradesh Chief Minister Yogi Adityanath on Wednesday launched a scathing attack on the Samajwadi Party, accusing it of glorifying Mughal ruler Aurangzeb while disregarding India's cultural and spiritual heritage.

"It is unfortunate that the Samajwadi Party considers Aurangzeb as its ideal. Even Aurangzeb's father, Shah Jahan, wrote in his autobiography that he wished no one would ever have such a wretched son," Adityanath said in the Legislative Council.

His scathing attack comes amid an ongoing controversy in Maharashtra over Samajwadi Party (SP) MLA Abu Azmi's remarks.

Azmi was on Wednesday suspended from the Maharashtra Assembly till the end of the ongoing Budget Session over his remarks eulogising Mughal emperor Aurangzeb.

The chief minister criticized the Samajwadi Party's deviation from the principles of socialist leader Dr Ram Manohar Lohia, who upheld India's cultural unity despite being a political rival of the

"I want to tell my friends in the Sama-jwadi Party –even if you do not take pride in India's heritage, at least follow the ideology of the leader whose name you use for political gain," Adityanath said.

Congress.

Quoting Dr Lohia, Adityanath added, "Lohia believed that India stands on three pillars — Lord Ram, Lord Krishna and Lord Shiva. As long as Indians revere these great figures, no power in the world can stop India from remaining India."

The chief minister alleged the Samajwadi Party's purpose now seems to be to oppose India's cultural traditions.

"Today the Samajwadi Party has strayed so far from Lohia's ideology that attacking the legacies of Lord Ram, Lord Krishna and Lord Shiva has become its primary goal," he said. Referring to Aurangzeb's reign, the chief minister said, "Aurangzeb imprisoned his own father Shah Jahan in Agra Fort, depriving him of water and left him to suffer."

"If the Samajwadi Party feels proud of Aurangzeb, they should visit a library in Patna and read Shah Jahan's autobiography, where he laments that even a Hindu son is better than Aurangzeb because a Hindu serves his elderly parents in their lifetime, performs their last rites with devotion, and offers water for their souls. Meanwhile, Aurangzeb left his own father to die of thirst," Adityanath said.

"No civilized Muslim today names their son Aurangzeb because they know that a person's deeds define them. 'Yatha naam tatha kaam' (as the name, so the deed)," he added.

Demanding the Samajwadi Party to clarify its position, the chief minister asked why it venerates a ruler, who imposed jizya tax, persecuted non-Muslims and attempted to Islamize India.

"The SP must answer whether it truly considers a tyrant like Aurangzeb its role model, a ruler who attacked India's faith and traditions," Adityanath said.

Will put across porters' demands to govt, fight for their rights: Rahul

NEW DELHI, Mar 5 (Agencies): Congress leader Rahul Gandhi on Wednesday said porters at the New Delhi Railway Station risked their lives to help people during the stampede last month but their voices were not being heard as they face financial diffight for their rights. Former Congress president Gandhi posted a video on his YouTube channel of his recent interaction with porters at the New Delhi Railway Station. "A few days ago, I reached New Delhi Railway Station and met the porter brothers there again. During the interaction, they told me how everyone together made every possible effort to save people's lives on the day of the stampede," Gandhi said in his post accompanying the video.

"Whether it was trying to remove people from the crowd, ensuring that the injured reached the ambulance and administration, or taking out the bodies of the dead – using their physical abilities, handcarts or spending money from their own pockets, they helped the passengers in every way," the Leader of Opposition in the Lok Sabha said.

Gandhi thanked them for saving many lives and helping in the relief work during the stampede that took place at the station on February 15.

At least 18 people were killed in the stampede at the New Delhi Railway Station, which was witnessing a surge of passengers waiting to board trains



for Prayagraj.

The Congress leader said, "I am very impressed to see the compassion of these brothers who come to earn daily wages".

"They are still living in financial difficulties – but are full of passion and goodwill. They need help, about which they conveyed their demands. I will definitely make every possible effort to help them," Gandhi said.

In a post in Hindi on X, the Congress leader quoted a porter as saying, "Some days we don't even have money to eat. We either send money home or eat food." Our porter brothers are forced to live in such difficulties, he said in his post on X.

"During the stampede at New Delhi Railway Station, these people risked their lives to help people, but their voice is not being heard. I will put their demands before the government and fight with all my might for their rights!" Gandhi said.

In the video, the porters tell Gandhi that their demand is that they get Group D employment.

Equity in technology needed for true gender parity: Smriti Irani

NEW DELHI, Mar 5 (Agencies): Former Union minister Smriti Irani on Wednesday underscored the urgent need for ensuring equity in technology for true gender parity.

Speaking at the Indo-American Chamber of Commerce Conference on Women Empowerment, Irani highlighted the systemic biases embedded in Al systems and called for a collective effort to address these disparities.

She urging the stakeholders to prioritize digital equity as a cornerstone of women's empowerment.

"In the age of AI, it is not man confronting woman or woman confronting man. It is humanity confronting what AI will do to us," Irani said.

She pointed to a research, which revealed that out of 133 Al systems around the world, 44% of Al sys-



tems are not gender-inclusive.

Irani shared a striking example of gender bias in Al-driven financial systems.

"A woman with the same income, tax returns and financial standing as her husband was offered a credit limit 10% lower than his. Another woman's credit limit was set 20 times lower than her husband's despite identical financial profiles," she said.

The former minister also drew attention to the psychological manipulation of women

through Al-driven con-

sumer behaviour.

"Seventy-two per cent of content purchased by women is algorithmically designed to encourage higher spending on consumer durables and perishables, while they are 33% less likely to receive investment advice online," she noted.

Irani urged for a deeper study of consumer behaviour in the digital age, particularly its impact on women.

The former minister praised India's strides in financial inclusion, citing initiatives like

the 'Jan Dhan Yojana' and the 'Mudra' loan scheme, which she said has empowered millions of women.

"Bankers say that the non-performing asset (NPA) for women owned businesses are about 1.8 to 1.9 per cent as compared to men which stands at 2.3 per cent," she said.

Irani, however, highlighted the lingering disparities.

"While there is no gender gap in bank account ownership, women receive only 27% of the credit equivalent to their deposits, compared to 52% for men. So we have better NPA records, but we have moderately okay credit records," Irani said.

Irani urged India to lead the way in ensuring equity in technology.

"This is a nation that gave the world zero and is a global leader in IT services. Let us also be the country that shows the world how to achieve equity in technology," she said.

Irani pointed out that only 22% of AI professionals globally are women, with just 17% in leadership roles.

"We need to ensure that the digital world is gendered for the purpose of equity. Women's contributions to health and education, which account for 80-90% of their earnings, must be recognized and supported by inclusive technol-

ogy," she said.

The former minister made a call for action, urging to focus on tangible outcomes before the next International Women's Day.

"Between this eighth of March and the next, let us work towards equity in technology. If we can achieve this, we will truly be harbingers of change, equality and gender justice," she said.

Two earthquakes including one of 5.7 magnitude strike Manipur, tremors felt across northeast

IMPHAL, Mar 5 (Agencies): Two consecutive earthquakes, including one of 5.7 magnitude, rocked Manipur on Wednesday and the tremors were felt across the Northeast, officials said.

The earthquake of 5. 7 magnitude struck the state at 11.06 am.


Its epicentre was 44 km east of Yairipok in Imphal East district, and at a depth of 110 km,

A second earthquake of 4.1 magnitude hit Manipur at 12.20pm. It struck the Kamjong district of the state, at a depth of 66 km, they added.

"We are confirming the reports of the damage," an official in Imphal said. No damage was reported so far in other states of the region.

Strong signals from Russia it is ready for peace, Ukraine ready to come to negotiating table: Trump

Says Zelenskyy went on to write in the letter that his team and him 'stand ready to work under President Trump's strong leadership to get a peace that lasts'

NEW YORK/WASHINGTON, Mar 5 (Agencies): US President Donald Trump said he has received "strong signals" from Russia that it is ready for peace and that Ukrainian President Volodymyr Zelenskyy has written to him saying his country is ready to come to the negotiating table and also sign an agreement on minerals and security.

Trump made these remarks an address to the Joint Session of Congress, the first of his second term in the White House.

"I'm also working tirelessly to end the savage conflict in Ukraine. Millions of Ukrainians and Russians have been needlessly killed or wounded in this horrific and brutal conflict with no end in sight," Trump said.

He told Congress that he received an "important letter" from Zelenskyy, in which he said that "Ukraine is ready to come to the negotiating table as soon as possible to bring lasting peace closer. Nobody wants peace more than the Ukrainians," Zelenskyy wrote in the letter, Trump said.

Trump said that Zelenskyy went on to write in the letter that his team and him "stand ready to work under President Trump's strong leadership to get a peace that lasts. We do really value how much America has done to help Ukraine, maintain its sovereignty and independence. Regarding the agreement on minerals and security, Ukraine is ready to sign it at any time that is convenient for you.'

Trump said he appreciates the letter and added that "simultaneously we've had serious discussions with Russia and I've received strong signals that they are ready for peace. Wouldn't that be beautiful? Wouldn't that be beautiful?" he said amid applause.



"... It's time to stop this madness. It's time to halt the killing. It's time to end the senseless war. If you want to end wars, you have to talk to both sides," Trump said.

In a post on X, hours before Trump's address to Congress, Zelenskyy said Ukraine is "ready to work fast to end the war, and the first stages could be the release of prisoners and truce in the sky — ban on missiles, long-ranged drones, bombs on energy and other civilian infrastructure — and truce in the sea immediately, if Russia will do the same. Then we want to move very fast through all next stages and to work with the US to agree a strong final deal."

Zelenskyy said that Ukraine really does value how much America has done to help Ukraine maintain its sovereignty and independence.

"And we remember the moment when things changed when President Trump provided Ukraine with Javelins. We are grateful for this."

In the post, Zelenskyy also referred to the disastrous meeting between him and Trump in the Oval Office last week and said "Our meeting in Washington, at the White House on Friday, did not go the way it was supposed to be. It is regrettable that it happened this way. It is time to make things right. We would like future cooperation

structive. Trump said that the United States has sent hundreds of billions of dollars to support Ukraine's defence with no security, with no anything and asked lawmakers if they want to keep it going for another five years.

Trump said that more than 2,000 people are being killed every single week in the conflict that is now in its third year.

"They are Russian young people, they're Ukrainian young people. They're not Americans, but I want it to stop," Trump said.

Trump added that meanwhile, Europe has sadly spent more money buying Russian oil and gas than they've spent on defending Ukraine, by far.

"Think of that. They've spent more buying Russian oil and gas than they have defending. We've spent perhaps USD 350 billion, like taking candy from a baby. That's what happened. And they've spent USD 100 billion. What a difference that is. And we have an ocean separating us, and they don't. But we're getting along very well with them and lots of good things are happening," he said.

"Biden has authorised more money in this fight than Europe has spent by billions and billions of dollars. It's hard to believe that they wouldn't have stopped it and said at some point. Come on, let's equalise. You've got

to be equal to us. That didn't happen," he said.

A day before Zelenskyy wrote to Trump about Ukraine being ready to come to the negotiating table, the US President had temporarily suspended, with immediate effect, the delivery of all American military aid to

A report in The New York Times had quoted a senior administration official as saying that Trump had temporarily suspended the delivery of all US military aid to Ukraine and that the order takes effect immediately, affecting "more than USD 1 billion in arms and ammunition in the pipeline and on order.'

This setback for Ukraine had come just days after Trump and Vice President J D Vance had a heated verbal exchange in the Oval Office with Zelenskyy, who was visiting the White House last Friday, and the two countries were all set to sign a rare mineral deal. But talks between Trump and Zelenskyy unravelled in a stunning exchange that played out in front of the global media.

Vance told the Ukrainian leader, "I think it's disrespectful for you to come to the Oval Office to try to litigate this in front of the American media... you should be thanking the president for trying to bring you into this conference."

As the conversation grew heated, Trump said to Zelenskyy "You're gambling with the lives of millions of people. You're gambling with World War Three. You're gambling with World War Three, and what you're doing is very disrespectful to the country, this country that's backed you far more than a lot of people say they should."

Trump and Vance also criticised Zelenskyy for not being grateful enough for the support that the US had given so far to Ukraine in its war with Russia.

Australia pushing for 25% tariff exemption: Foreign **Minister Penny Wong**



SYDNEY, Mar 5 (Agencies): Donald Trump's second presidency is already more disruptive than his first, Australia's foreign minister said on Wednesday, although she held hopes the country might still get an exemption when it comes to tariffs.

Foreign Minister Penny Wong said there was "no doubt" from Trump's flurry of executive orders since taking office just over six weeks ago that Australia was dealing with a "very different American administra-

"President Trump and his administration envisage a very different America in the world," she said at the Australian Financial Review Business Summit in Sydney.

"We saw that in the first Trump administration, but I think it's clear that the scale of change in this administration, the second term of the Trump administration is even more so."

Wong said tariffs had been a major focus for Trump and that Australia was still pushing for an exemption with 25% tariffs on steel and aluminium set to start next

"I wouldn't concede

that (we will not get a tariff exemption) ... we are still, putting our case very clearly and our case, I think is a strong case," she said. She added that the US was Australia's most important strategic partner and that alliance had endured people, administrations and governments of all political persuasions.

"There will be areas where our position and the US position might differ. That's always been the case. We have to navigate that sensiblv. We have to remember the value of the alliance," she said.

Indian national jailed seven months for molesting woman in Singapore

SINGAPORE, Mar 5 (Agencies): An Indian national was sentenced to seven months' jail on Wednesday after pleading guilty to one count of molestation, with one count of housebreaking taken into consideration for his sentencing.

Erakkodan Abinraj, 26, climbed into his neighbour's condominium unit and molested a 36-year-old woman who cannot be named due to a gag order.

She was asleep in the master bedroom with her husband, and her daughter was in another room, when Abinraj, who entered the house through the balcony around 4.50 am on September 22 last year, entered her room and proceeded to touch the victim's underwear

as he saw her asleep. The victim woke up as she felt someone touching her, a Channel News Asia report said, adding that she turned to the accused holding up his handphone with the torchlight on after she

got puzzled seeing her husband sleeping next to her. The victim screamed,

waking her husband who confronted Abinraj and asked him to leave the room. The accused then

urinated in fear and pleaded with him not to call the police, the court heard. The victim called

the police and Abin-

raj stayed in the unit until the police arrived, before admitting to trespassing. However, he denied touching the victim and

lied that his handphone had dropped on the victim, claiming that was when she had woken

prosecution The sought a jail term of six to eight months as a punishment.

The prosecution said it was aggravating that Abinraj had broken into the victim's home, which is a "private place" where the victim should expect to feel safe. She added that the victim was also

vulnerable because she was asleep.

She said Abinraj had caused further inconvenience by urinating in her unit.

Abinraj's lawyer Ambalavanar Ravidass asked for seven months' jail, saying his client comes from a humble family in

He added that Abinraj's grandmother had died by suicide, suggesting that his client had been mentally disturbed during the time of the offences.

In response, the prosecution said an Institute of Mental Health report had not diagnosed Abinraj with any mental condition.

Ravidass accepted that his client had no mental condition, but had been undergoing "normal depression" that anyone would go through given the circumstances.

For molestation, Abinraj could have been jailed for up to three years, fined and caned.

China accuses US of spreading all kinds of false information on fentanyl issue

Chinese Foreign Ministry Spokesperson Lin Jian expressed China's opposition to US pressure, threats and blackmailing under the pretext of the fentanyl issue.

BEIJING, Mar 5 (Agencies): China has accused the US of spreading all kinds of false information on the fentanyl issue, smearing and scapegoating China and raising tariffs on Chinese imports over fentanyl, terming these moves "unjustified."

In a statement on March 5, Chinese Foreign Ministry Spokesperson Lin Jian expressed China's opposition to US pressure, threats and blackmailing under the pretext of the fentanyl issue. He said that China's position is "clearcut" and expressed Beijing's readiness for practical cooperation with the US based on equality and mutual respect.

In a post on X, Lin stated, "The US is spreading all kinds of false information on the fentanyl issue, smearing and scapegoating China, and hiking tariffs on Chinese imports over fentanyl. Such moves are unjustified and will do no one good. China's position is clear-cut. We stand ready for practical cooperation with the US based on equality and mutual respect. We firmly oppose the US pressuring, threatening and blackmailing China under the pretext of the fentanyl issue. We urge the US to respect facts, bear in mind its own interest and make the

right choice.' Lin Jian also highlight-

ed some takeaways from the white paper "Controlling Fentanyl-Related Substances--China's Contribution." According to the white paper, China has imposed full control of fentanylrelated substances from May 1, 2019. China has implemented integrated measures like expanding the list of controlled substances, bolstering regular supervision, boosting inspection and seizure, and implementing innovative controls.

In a post on X, Lin wrote, "Some takeaways from the white paper "Controlling Fentanyl-Related Substances--China's Contribution": China imposed full control of fentanyl-related substances from May 1, 2019, making it the first country in the world to do so. China has enumerated fentanyl-related medications in the List of Controlled Narcotic Drugs and exercises

list of controlled substances, strengthening regular supervision, stepping up inspection and seizure, and implementing innovative controls. China has expanded the control list of precursors of fentanyl-related substances and supervise their production, sales, purchase, transportation, and export. China has

been promoting China-US cooperation on drug control. Since 2024, with more than 100 instances of information exchange, China and the US have achieved breakthrough progress in the collaborative investigations of multiple transnational cases," he added. The Chinese Foreign

Ministry spokesperson's statement comes after **US President Donald** Trump doubled the tariff on all Chinese imports from 10 percent to 20 percent, CNN reported. The Trump administration stressed that the tariffs were necessary to stop the flow of fentanyl into the United States.

China retaliated on Tuesday by announc-

ing 15 per cent tariffs on chicken, wheat, corn, and cotton imports from the US, according to a statement from the State Council Tariff Commission. In addition, a 10 per cent tariff was imposed on "sorghum, soybeans, pork, beef, aquatic products, fruits, vegetables, and dairy products," it said.

Separately, China's Ministry of Commerce said it included 15 more American companies, including drone maker Skydio, to its export control list, which would ban Chinese companies from exporting dual-use equipment to them, as per CNN.

Alfredo Montufar-Helu, head of the China Center for the Conference Board, said, China's retaliatory tariffs followed a "restrained, targeted approach aimed at causing pain to those industries that matter the most to the supporters of the Trump administration." He noted that China's tariffs allow negotiations to potentially avoid even more damaging tariffs down the road.

On Tuesday, China announced more measures targeting the US, including stopping lumber imports from the US, suspending permits given to three US companies for exporting soybeans to China and an anti-dumping probe into some imports of American fiber optic products.



India trounce Australia by 4 wickets in the first semifinal

DUBAI, Mar 5 (Agencies): Not the one to be easily pleased, India head coach Gautam Gambhir said his team is still searching for that "perfect game" despite entering the Champions Trophy final with an all-win record and he is hopeful that it would come in the summit clash on Sunday.

India trounced Australia by four wickets in the first semifinal here on Tuesday, with senior batter Virat Kohli making a well-paced 84.

"See, in international sport, you want to keep improving. You don't say that you've ticked all the boxes. We still haven't played a perfect game. I will never be satisfied with the performances," Gambhir said in the post-match press confer-

Gambhir hoped that India can produce that "perfect game" in the Champions Trophy title clash on March 9.

"We still have one more game to go. Hopefully, we can play a perfect game. We want to keep improving, we want to be ruthless on the cricket field but



absolutely humble off the field," he added.

India have taken some bold calls such as playing four spinners, promoting Axar Patel to No 5 and pushing down KL Rahul to No 6 to suit the team's needs.

It may look illogical from outside but for Gambhir they were minor pieces in the grand plans of keeping the players "out of the comfort zone" to extract the best out of them.

"I think cricket is all about being out of your comfort zone, and that is how you grow. If everyone is in their comfort zone, then there is stagnation. So I believe, and you've seen the results. I know you guys will keep going

"But everyone in the dressing room is staying out of the comfort zone, be it the coaching staff, be it the players and hopefully we continue to do what is important for Indian cricket," he said.

At some stage in the near future, Gambhir will have to sit down with some senior players to know their future plans.

But for now, the former Indian opener is focusing on the Cham-

"And then obviously there's a long-term vision, there's a long-term plan as well, but at the moment, it's only the 9th but after the 9th we can sit down and plan," he added.

Gambhir also lauded the side for the effortless manner in which it chased down a stiff 265-run target against the Aussies here.

"I think it was very professional and the reason why I say that is because we had wickets in hand and that was the plan because we know that obviously pitches here in the second half can actually get a little slower.

"We actually planned the chase really well. If you see after 40 overs, we were only four down. We had two set batters in. So, we knew that the kind of quality we have, the kind of depth we have, we were always in control," he noted.

BCCI extends Indian team SOPs to IPL franchises ahead of 2025 season: Report

NEW DELHI, Mar 5 (Agencies): The BCCI has partially extended its recently implemented SOPs on the Indian team to the 10 IPL franchises ahead of the 2025 edition, covering players' travel only by team bus and barring the entry of families in dressing rooms even on non-match days. Following India's loss in the Test series in Australia, the BCCI came up with a set of rules that barred personal managers from travelling in the team bus besides limiting the presence of players' families on tours.

The exact same SOPs can't be applied in a multi-team competition like the IPL, but some of them have made their way to the world's premier T20 league.

"Players to use the team bus while coming for practice. Teams may travel in two batches," read a BCCI note that was shared with the team managers of all IPL sides recently. As for as the families of players, they won't be allowed in the dressing room even on training days.

"On practice days (during pre-tournament & tournament), only accredited staff is allowed in the dressing room and on the field of play. Player family members and friends to travel in a different vehicle and can watch team practice from the

hospitality area.

"For extended support staff (throw down specialist/net bowlers) list need to be submitted for approval to BCCI. Once approved, non- match day accreditations will be issued for the same," read the BCCI note further.

"In our franchise, the families and even the team owners were not permitted in the dressing room even on non-match days. Having said that, some of the players used to travel separately and not in the team bus after a game. It won't be be allowed from this season onwards," the official told agency.

Additionally, fines will be levied on players if they forget to bring their accreditation card at the venue or show up at the post-match presentation wearing loose and sleeveless clothes.

"It is mandatory for PMOA (players and match officials) accredited staff to bring their accreditation on match day. On the first instance failure of not carrying the accreditation, warning will be issued. On second instance, monetary fine will be issued to the team. "...In the post-match presentation, floppies and sleeveless jersey are not allowed. Failure to do so will result in warning on the first instance. On the second instance, there will be a financial penalty," the BCCI said.

The board also warned the batters to not hit the advertising LED board outside the boundary ropes.

"Despite providing hitting nets, player keep hitting on the LED boards. We request teams to adhere to it

"Players and support staff are not to sit in front of the LED boards. Sponsorship team will mark places across the FOP where substitutes carrying towels and water bottles can be seated," the board added.

"I always keep it simple": Mohammed Shami on adapting to conditions

DUBAI, Mar 5 (Agencies): After India's crucial four-wicket win against Australia in the first semifinal of the ICC Champions Trophy in Dubai, fast bowler Mohammed Shami shared his insights on adapting to the conditions and his approach to bowling in challenging situations.

Shami, who played a key role in India's victory with figures of 3/48 in 10 overs, has now climbed to the top wicket-takers list alongside New Zealand's Matt Henry, both have eight wickets in the tournament.

With all their matches in the tournament being played at the same venue, Shami emphasized the importance of understanding the pitch conditions and preparing accordingly.

"See, the main thing is that you have to know the conditions very well. You have to know the



behaviour of the pitch because you are playing in the same venue. So, you can know it very well. If you want to know.

So, my effort is that you should practice in the same way according to the wicket, you should bowl in the nets as per the wicket. So, there is not much. I always keep it simple," Shami told reporters.

When asked if playing multiple matches at the same venue had bene-

fited him, Shami agreed. "Of course. You get

familiar with the conditions, the pitch behaviour, and other factors like the weather. Today, for example, it was colder, so you have to adjust accordingly. It's definitely a plus point to play all matches at the same venue," he said.

In a tournament where fast bowlers have struggled to make an impact, Shami has found ways to succeed. When asked about his strategy and the captain's expectations, he explained his approach.

"I am doing my best. The captain always wants wickets, but as a bowler, it's my responsibility to hit the right areas. We have enough experience in our team, and the results speak for themselves. In

for themselves. In white-ball cricket, you don't need to overthink early on. The real skill adjustments come after 30-35 overs, when the demands of the game change," he noted.

Shami also acknowledged the workload that comes with being a strike bowler but takes pride in handling the pressure.

"There is always a load when you are the main fast bowler because you have to take wickets and then come back for crucial spells. It can be challenging, but I've gotten used to it. I try to

make things easier for the team by putting in more than 100% effort on my end," he noted.

Despite the physical demands of fast bowling, Shami remains focused on his effort rather than dwelling too much on fitness concerns.

"Trust is built when you're selected in the team. I don't believe in overthinking fitness. What matters is how much effort you put in and how your body responds. As far as the workload is concerned, I am a labourer," he chuckled, highlighting his work ethic.

With India securing a hard-fought victory over Australia, they now move into the final of the Champions Trophy. Shami's ability to adapt to the conditions and maintain his wickettaking form has been a crucial factor in India's campaign.

KL Rahul masters middle order: adapting, excelling, delivering for India

DUBAI, Mar 5 (Agencies): Since becoming a full-time number 5 in ODIs, KL Rahul has expanded his range as a middle-order batter. Since 2020, he has averaged 61.52 in that position--higher than anyone else with a minimum of 20 innings, including Heinrich Klaasen, whose average is nearly seven points lower. However, leading up to the Champions Trophy, India wanted to introduce variety in their right-hand-heavy lineup and decided to promote Axar Patel to No. 5. As a result, Rahul shifted down to No. 6 but has quickly adapted, working extensively on his power-hitting

"Yeah, I do [enjoy batting at the top], I mean I won't lie," Rahul told Star Sports, as quoted from ESPNcricinfo.

"It's after opening the batting in Australia in Test matches and having to face that attack in Australia and you know how red-ball [cricket] is much harder. I opened the batting there and then to come here and bat low seems a bit different, but this is how I've played whiteball cricket in the last four-five years," he added.

"So, I'm quite used to

going up and down the order so I'm just happy getting a chance to play in the middle and whatever role is given, I think it's really helped me understand my game a lot more and I've had to work on boundary hitting a lot more in the last year or so because the last ODI we played in Sri Lanka I batted at No. 6, so I knew that's where I'll be batting and [we] needed a left-hander in the top order," he noted. Before the Champions Trophy, there was a debate over whether Rahul or Rishabh Pant should take the wicketkeeper-batter slot, but

the team ultimately stuck

with Rahul. On Tuesday,



he walked in after Axar's dismissal, with India needing 86 runs from 15 overs and six wickets on a challenging Dubai surface. When Virat Kohli fell for 84, Australia sensed an opportunity, but Rahul shut the door with an unbeaten 42 off 34 balls, striking two fours and two sixes to steer India into the final. When asked about the uncertainty surrounding his role, Rahul reflected on his approach.

"Honestly, I mean it's since I think 2020 I've batted at No.5 and a lot of times people forget that that's where I've been batting," Rahul said, as quoted from ESPNcricinfo.

"And every time I perform in a series and then there's a break from ODI series, ODI cricket and then we come back after four or five months there's a question mark again about 'oh well will he play in the XI, where does he fit' and sometimes I'm sitting there thinking what more can I do. Everywhere that I've been asked to play I've played and I feel like I have performed my role. Whatever's been told to

me by Rohit [Sharma], Rohit's been the captain for the last four-five years," he added.

"And whatever he's told me I feel like I've done that to the best of my ability. And I know that Rohit feels the same and he's always supported me and backed me with that. So, there's that confidence going into the game that the captain has my back," he said.

Although Dubai had prepared a fresh pitch for the semi-final, it remained slow and spinfriendly, making strike rotation difficult. Recognizing this, Rahul decided it was worth taking a calculated risk in every over, particularly with Kohli in imperious form at the other end. He took on Tanveer Sangha, Ben Dwarshuis, and Adam Zampa, finding boundaries in quick succession before Kohli was caught at long-on. Hardik Pandya followed soon

after, but Rahul kept his

composure, finishing the job alongside Ravindra Jadeja.

"When I walked in and when I played 10-12 balls, I told him [Virat Kohli] that you're the batter that needs to go on and be there till the end," Rahul said.

"And let me try and hit or let me try and take one chance over. Because like you said, we only needed 6 runs and over. But 6 runs and over on that wicket seemed like 8-8.5. So, you had to take one chance and over, one boundary or one six," he said.

"So, I told him that I will do that and why don't you just rotate the strike and be there because you're the set batter and it might be harder. If you get out another set batter comes it becomes a lot more harder. But yeah, he felt like it was in his range to hit and yeah he didn't time it well," he noted.

Steve Smith retires from ODI cricket after Australia's Champions Trophy exit



DUBAI, Mar 5 (Agencies): Australia's stand-in skipper and batting mainstay Steve Smith on Wednesday announced his retirement from ODIs after his team's semifinal loss to India in the Champions Trophy here.

The 35-year-old, who top-scored in the match with a 96-ball 73, informed his teammates of the decision after the four-wicket loss on Tuesday night, according to a statement from Cricket Australia. He will continue to play Tests and T20 Internationals.

"It feels like the right time to make way. It has been a great ride and I have loved every minute of it," Smith

"Test cricket remains a priority and I am really looking forward to the World Test Championship Final, the West Indies in the winter and then England at home. I feel I still have a lot to contribute on that stage," he

After making his debut in 2010 as a leg-spinning allrounder, Smith evolved into one of Australia's finest ODI batters, amassing 5,800 runs in 170 matches at an average of 43.28, with 12 centuries.

J&K Retired Police Pensioners protest against pay anomaly

facilities, and a regularization policy.

Village Defense Committee (VDC) members should receive wages equivalent to SPOs, given their contribution to security.

Risk allowance, medical benefits, and ration money for police personnel should be brought on par with CAPFs.

Retired police personnel should be provided a comprehensive health care policy, similar to those available to Army and paramilitary personnel. The forum also pointed out that Leh UT has increased medical allowances to $\Box 1000$, while J&K UT personnel still receive only $\Box 300$, despite both becoming UTs at the same time.

Many retired personnel have not received their leave salary and gratuity for the past year. The forum urged the government to release these pending funds immediately to ease financial

hardships.
Chairman Ajit Singh emphasized that these disparities must be addressed at the earliest, as retired police personnel have served with dedication and now face injustice and financial distress. The protestors vowed to continue their struggle until their demands are met.

FPS dealers of J&K UT demand resolution of long-pending issues

JAMMU, Mar 5: The Fair Price Shop (FPS) Dealers Association of Jammu and Kashmir UT has urged the Department of Food, Civil Supplies & Consumer Affairs (FCS&CA) to address their long-pending demands, which have remained unresolved since 2019. Despite multiple reminders, the authorities have failed to take any concrete action. leading to growing frustration among FPS dealers.

The association alleged misappropriation of funds by the department, stating that despite the availability of funds in 2024-25, they are being misused for self-interest instead of clearing the long-overdue liabilities of FPS dealers.

FPS dealers have been awaiting commission payments from the Centre Share and Mid-Day Meal Scheme since 2019. The delay has caused severe financial hardships.

FPS dealers demand a minimum fixed consolidated amount of Rs 50,000, equivalent to government salesmen working under the ration department. They argue that they perform the same duties and should receive equal compensation.

In their final request to the Minister of FCS&CA, J&K UT, the association has warned that if their demands are not met, they will be forced to take stern action to protect their rights and prevent further harassment by the department.

Association President Ajay Gupta reaffirmed their commitment to fighting for justice and ensuring that FPS dealers receive their rightful dues.
